The Bidding Documents shall be available at the Office of the Philippine Army Bids and Awards Committee Secretariat, Fort Andres Bonifacio, Metro Manila starting October 29, 2009 upon payment of non-refundable fee at the AFP Finance Center, Camp General Emilio Aguinaldo, Quezon City.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre Bid Conference/s, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Revised Implementing Rules and Regulations of RA 9184, as amended.

The bidding is open to **Local** and **Foreign** bidders. However, Foreign bidders must be represented by a Philippine-based company with **at least one (1) year experience** in the importation or supply of **ammunition** with current and valid license to deal in firearms and ammunition (for the sale to the AFP) issued by the Philippine National Police (PNP).

The **Pre-Bid Conference/Receipt and Opening of Bid Envelopes** shall be held at Philippine Army Officers Clubhouse, Fort Andres Bonifacio, Metro Manila.

During the **ROBE**, the bidders or their duly authorized representative shall submit their bids using the forms specified in the Bidding Documents in two (2) separate sealed bid envelopes, and which shall be submitted simultaneously. The first shall contain the technical component of the bid, including the eligibility requirements under section 23.1 of IRR, and the second shall contain the financial component of the bid.
