

Pinoys to Manny: You've done us proud

People in cinemas, gymnasiums and military bases across the country burst into applause and shouts yesterday as they watched Manny Pacquiao floor American Timothy Bradley before regaining the WBO welterweight crown in Las Vegas

Shortly after Pacquiao bested Bradley, Malacañang led the nation in sending congratulatory messages to the Filipino

boxing icon.

"Manny Pacquiao has done the Filipino nation proud again by winning decisively against Timothy Bradley. We applaud and thank him for demonstrating anew that the Filipino has the courage and skill to compete in the global arena," Presidential Communications Office Secretary Herminio Coloma Jr. said.

Pacquiao did not disappoint his legions of fans watching the match in the Philippines, knocking down Bradley twice and dominating the fight as all three judges

scored it 116-110 in his favor.

The fight in Las Vegas is Pacquiao's last Turn to Page 6

bout before retiring from boxing.

With his retirement, Pacquiao, a congressman of Sarangani, is looking forward to winning a seat in the Senate in the May 9 elections.

"We are truly happy because our prayers that Manny will win were answered," James Morena, a 67-year-old retiree said.

Vice President Jejomar Binay hailed Pacquiao's victory over Bradley.

"I join the nation in congratulating Manny Pacquiao in his victory against Timothy Bradley," Binay said.

"Manny has again shown the Filipino

traits - determination to face life struggles, ability to rise against the odds, and win over trials," Binay said in Filipino. Pacquiao is running under the United Nationalist Alliance (UNA) with Binay as its standard bearer.

Binay's rival, Davao Mayor Rodrigo Duterte, congratulated Pacquiao for an

"emphatic win."

"I am congratulating Manny Pacquiao for his emphatic win over Timothy Bradley. Manny did the Filipinos proud once more, "he said

Duterte also wished Pacquiao well in

his political career.

I hope he will find time to concentrate

on his political career," he said.

Duterte added Pacquiao has nothing to prove any more with his achievement in boxing:

"He is a true champion in the hearts of the Filipino people," Duterte added.

Manila Mayor Joseph Estrada also joined the nation in congratulating Pac-

quiao

"On behalf of all Manileños, I extend my congratulations to our Pambansang Kamao, Manny Pacquiao, for another very convincing win versus Timothy Bradley in their just-concluded bout in Las Vegas, Nevada," Estrada said. Congressmen-colleagues of Pacquiao also congratulated him yesterday for his latest victory over Bradley.

"Pacquiao has solidified his legend as our country's greatest boxing icon. Yet, it is his humility and generosity that make him larger than life to our people," Speaker Feliciano Belmonte Jr. said

Majority Leader Neptali Gonzales II said Pacquiao's newest win "will further inspire Filipinos to persevere in life."

"Congratulations to him. He makes us very proud of our race," he said

Senators also congratulated Pacquiao

on his victory

Sem Ferdinand Marcos Jr. said Pacquiao's win "has given the Filipino people a new radiating source of honor

and pride."

"The deeper meaning of his win over Bradley is a message of our ability to prevail once we put our heart, mind, and soul to whatever test we are facing," he said. Sens. Nancy Binay and Juan Edgardo Angara said Pacquiao is leaving a legacy that makes every Filipino proud of his roots.

"As he exits the ring for possibly the last time, we thank Manny for the thrills and excitement he provided us in the sport which made him well-known," Binay added.

Morale booster

On the other hand, Pacquiao's comrades in arms in the military did not lack in enthusiasm while watching the Sarangani fighting congressman floor Bradley

Atwice during the bout.
\ Shouts of "Pacquiao pa rin! Manny! Manny!" were heard from the 400 troops and officers watching the bout at the Armed Forces of the Philippines (AFP) Gymnasium and Wellness Center

AFP chief Gen. Hernando Iribetti and the senior staff were not around at Camp

Aguinaldo to watch the fight.

Iriberri led the top brass in flying to Zamboanga City yesterday to oversee the military operation in Basilan that left 18 soldiers dead and 53 wounded.

"We only watched the last three rounds of the fight because we are busy attending to our ongoing operations," said Army chief Lt. Gen. Eduardo Año.

Año said everybody was jubilant over Pacquiao's defeating Bradley yesterday. He also suggested to the congressman and military reservists to focus on teaching other Filipinos the sport, with Pacquiao as trainer upon his retirement.

Col. Benjamin Hao said Pacquiao's victory further boosted the morale of troops despite what happened in Basilan

the other day.

"The Philippine Army expresses its happiness on the win of Army reserve Lt. Col. Manny Pacquiao that at least compensates for the loss of our troops in the Basilan operations," Hao said Some of the troops said Pacquae has

ZAMBOANGA CITY -At least 18 soldiers and five Abu Sayyaf members, including a Moroccan terrorist, were killed in a battle that grew so close since Friday it included handto-hand combat at a village in Tipo-Tipo town, Basilan province, a military spokesman confirmed.

Western Mindanao Command (Westmincom) spokesman Major Filemon Tan Jr. said that some soldiers were beheaded, but he declined to give the exact numbers as ground forces continue to validate the allegation. He Isnilon Hapilon.

noted, though, that the clash wounded 56 soldiers and 20 Abu Sayyaf members.

The battle erupted after 120 Abu Sayyat terrorists ambushed troops sent for an offensive at Sitio Bayoko in Barangay Baguindan, he added. The gunfight lasted 10 hours.

"Naunahan sila," Tan said, explaining that the terrorists initially had the up- hadist who was unifying per ground and were using high-powered weapons and explosives to stop the troops whose mission was to capture Abu Sayyaf leader

The first volley, he reported, immediately left several soldiers dead.

Armed Forces chief of staff Gen. Hernando Iriberri confirmed that Moroccan bomb expert Mohammad Khattab and Ubaida Hapi-Ion, son of the Sayyaf leader, were among those killed.

Khattab is an Islamic jithe Abu Sayyaf with international terrorist groups. His companion, Malaysian jihadist Mohammad Najib Hussein alias Abu Anas, was killed by the military

last Dec. 15.

The military has yet to officially release the names of the fatalities pending notification of their next of kin. Tan said they were from the 44th Infantry battalion, 4th Special Forces battalion and 4th Cavalry troops.


Although craters were seen on the ground, he explained that these were not caused by land mines but by mortars and M203 rounds fired by the Sayyaf fighters led by Isnilon Hapilon and Furuji Indama.

"But the troops managed

to retaliate and repel the Abu Sayyaf militants from seizing the momentum," Tan said.

18 soldiers killed in Sayyaf ambush

ZAMBOANGA CITY—Government forces battled Abu Sayyaf gunmen in Basilan on Sunday, a day after the bandits who had sworn allegiance to the Islamic State (IS) jihadist group in Iraq

and Syria killed 18 soldiers and wounded at least 56 others in a clash on the island.

Gen. Hernando Iriberri, chief of staff of the Armed Forces of the Philippines, ordered nonstop operations against the Abu Sayyaf after Saturday's clash, which

came after an April 8 ransom deadline set by the bandits, who had threatened to behead three Westerners and a Filipino woman they had been holding hostage since September last year.

"Even as we speak, there is an encounter going on in the same place," said Iriberri, who flew to the military's Western Mindanao Command base in Zamboanga City on Sunday with Defense Secretary Voltaire Gazmin to visit the wounded and assess the situation.

"We are mourning. The whole armed forces is mourning," Iriberri told reporters, referring to the deaths of the 18 soldiers, one of the military's biggest battlefield losses in a single day in recent years.

He said Saturday morning's clash with the Abu Sayyaf in Baguindan village, Tipo-Tipo town, lasted for 10 hours.

At least four soldiers were reportedly beheaded in the fighting, which involved about a hundred Abu Sayyaf bandits led by Isnilon Hapilon, for whom the US state department has offered a bounty of \$5 million, and Furuji Indama. But Maj. Filemon Tan, spokesperson for the Western Mindanao Command, denied reports that the soldiers were beheaded, explaining that the soldiers' heads were blown off by the bandits' heavy firepower

Tan described the fighting as close-quarter combat, with the government troops and the bandits just 10 meters from each other.

There was no immediate statement from the Abu Sayyaf, a small but violent group known for extortion, kidnappings for ransom, beheadings and bombings in the south.

Ambushed

The spokesperson for the military unit involved in the clash said the soldiers were on their way to attack an Abu Sayyaf hideout when they were hit.

"Our group was heading to attack them. On the way, they were ambushed," Col. Benedict Manquiquis told radio station dzRH.

"The enemy had the high ground so no matter where our soldiers fled to seek cover, they could still be hit by the heavy firepower and improvised explosive devices of the members of the Abu Sayyaf group," he said.

But Iriberri said the troops, from Charlie Company of the 44th Infantry Battalion, were in an encounter and were not ambushed.

"It was really an encounter," he said, but added that details remained unavailable because the fighting was going on.

"We cannot get a clear picture of what happened, but rest assured that once everything is settled, we will give a statement," he said.

Iriberri praised the soldiers for their gallantry in battle.

"Despite heavy enemy resistance and advantage, with their familiarity with the terrain in Basilan, our troops fought gallantly. We salute our troops, as they displayed the finest traditions of soldiery and bravely fought the bandits with utmost valor," he said.

But the accounts of two survivors suggested the government forces were ambushed by the bandits.

Sgt. Erico Paglinawan, one of the wounded, told the INQUIRER from his hospital bed that about 30 soldiers from the Charlie Company of the 44th Infantry Battalion, supported by troops from the

4th Special Forces, were going through Baguindan on foot at about 7 a.m. Saturday when somebody in the frontline stepped on a landmine, setting it off.

Five soldiers were killed outright in the explosion, Pagli-

nawan said.

Then fighting broke out and Paglinawan said he was hit in the chest. "Blood was oozing from my wound. It was like water coming from a faucet," he said.

He said that while waiting to be evacuated, which did not happen until three hours later, he drank his own blood, think ing this would prevent him from dying due to loss of blood.

Capt. Kilbas Mauricio, who was hit in the left leg, said the fighting started with an explosion then "followed by a ball of fire," indicating an ambush.

The fighting went on for hours and among the troops who were wounded were the commander of the 44th Infantry Battalion, Col. Tommy Crosby, and three other officers.

Moroccan bombmaker

Major Tan said five bandits, including a Moroccan, Mohammad Khattab, and Ubaida, son of Hapilon, were killed in the fighting.

He said 20 other bandits were wounded in the fighting.

Iriberri said Khattab was an instructor in making improvised explosive devices and an "Islamic jihadist preacher."

"He wanted to unify, organize all kidnap-for-ransom groups to be affiliated with an international terrorist organization," he said.

Iriberri would not identify the international group Khattab was working for, but he could be referring to IS, to which the Abu Sayyaf pledged allegiance last year.

IS has captured vast areas of Iraq and Syria since its rise more than a year ago. It is believed to be recruiting fighters in Asia.

Besides the Abu Sayyaf, the Bangsamoro Islamic Freedom Fighters, a splinter of the Moro Islamic Liberation Front, the largest Muslim rebel group in Mindanao, has also pledged allegiance to IS, although the military believes the militant groups are only riding on the increasing popularity of IS in the jihadist community.

Lt. Gen. Eduardo Año, Philippine Army chief, said Khattab had been in the Philippines for three years and had been under military surveillance for a year until his death on Saturday.

"He was serving as the Abu Sayyaf's conduit, trying to link them up to a Middle East international terrorist group," Año said without identifying the international group.

Iriberri said the operation against the Abu Sayyaf, which had been going on since December last year, was aimed at preventing further kidnappings for ransom.

The bandits are believed to be behind the kidnapping in recent days of foreigners in the

southern waters.

They are still holding Canadians John Ridsdel and Robert Hall, Norwegian Kjartan Sekkingstad and Filipino Maritess Flor, whom they seized from a resort on Samal Island, Davao del Sur province, in September last year.

Last month, they threatened to kill the hostages unless ransom of P1 billion for each was paid within 30 days With reports from Julie M. Aurelio and Inquirer Research in Manila, AFP and Reuters

Wounded soldier sips own blood to survive during clash

ZAMBOANGA CITY -Fearing he might bleed to death, a soldier wounded while battling the Abu Sayyaf in Basilan sipped his own

Sgt. Erico Paglinawan of the 44th Infantry Battalion narrated that while waiting for medical help to arrive, he saw blood oozing from a wound in his left chest. Worried about hemorrhage, he began sipping the oozing blood.

Paglinawan disclosed this after his right hand was seen still stained with blood while confined at the Camp Navarro General Hospital in the Western Mindanao Command (Westmincom). He was in the hospital along with 50 other soldiers wounded in the fierce gun battle on Saturday in Basilan.

He disclosed that they were pursuing a high-value target when their lead pla-

toon hit a landmine set up by Moroccan bomb expert and jihadist Mohammad Khattab in Barangay Baguindan, Tipo-Tipo town.

The landmine exploded at about 7:55 a.m., immediately killing five soldiers and wounding several others.

The explosion was followed by a volley of gunfire and M203 grenades that filled the soldiers' routes with smoke. This vulnerable posi-

tion led to the wounding of more soldiers, including Lt. Remigio Licena.

Paglinawan said he was wounded after he was hit by direct fire in his i left chest.

"I saw blood oozing. I was afraid I might succumb to hemorrhage, so I sipped my blood," Paglinawan said.

He added that despite his wound, he still managed to fight and repel the Abu Sayyaf group from completely

obliterating them.

Maj. Filemon Tan Jr., Westmincom spokesman, said despite being wounded, Lt. Licena still managed to fend died


"It was almost a closequarters combat since the firefight occurred about 10 meters away," Tan said, citing accounts from the wounded soldiers.

Staff Sgt. Eduardo Capalac, said the attackers were already positioned even before they approached the area.

Freed Italian hostage now at Zambo hospital

ZAMBOANGA CITY (PNA) - The Western Mindanao Command (Westmincom) has transferred the newlyreleased former Italian priest to a military hospital in this city.

Maj. Filemon Tan, Westmincom information officer, disclosed that Rolando del Torchio arrived around 7 a.m. Saturday at Camp Navarro General Hospital (CNGH).

Tan said Del Torchio was transported by the Navy's Multi-Purpose Attack Craft (MPAC) from Jolo, Sulu.


"He (Del Torchio) was transferred to Camp Navarro General Hospital this morning for medical and psychological check-up and was later found to be in good health by the attending doctors," Tan said.

He said the former priest will be handed over later to the Philippine National Police' (PNP) Anti-Kidnapping Group (AKG) after physicians give him a clean bill of health.

Del Torchio was released late Friday by his captors who are suspected by be members of the Abu Sayyaf Group after six months and one day in captivity in the hinterlands of Sulu.

Government operatives recovered Del Torchio around 7:30 p.m. Friday aboard M/V Beatrice, which was set to sail to Zamboanga City from the port of Jolo, Sulu.

Tan said the operatives decided to bring Del Torchio to Camp Gen. Teod-

ulfo Bautista Trauma Hospital in Barangay Busbus, Jolo "due to assessed poor medical health and was taken cared of by military doctors."

Kidnap-for-ransom-group gunmen seized Del Torchio on Oct. 7, 2015 while the victim was attending his pizza parlor, Ur Choice Bistro Café, at Quezon Avenue, Barangay Miputak, Dipolog City, the capital of Zamboanga del Norte.

Tan identified Del Torchio's kidnap-

pers as the Muloc Group led by Julmin Muloc alias Commander Red Eye. They later handed over Del Torchio to the group of ASG sub-leader Idang Susukan.

Del Torchio, who was born in Angera, Italy, was ordained as a priest in 1984. He served as a missionary of the Vatican's Pontificio Instituto Missioni Estere (PIME) or the Pontifical Institute of Foreign Missions.

Gazmin files libel raps over AFP helicopters

Defense Secretary Voltaire Gazmin has filed three counts of libel against an employee of the Bureau of Internal Revenue (BIR) who had accused him and other defense and military officials of graft.

Gazmin filed charges against Rhodora Alvarez, the BIR employee who claimed the defense chief and other defense and military officials rigged the bidding for the purchase of helicopters from a US dealer in 2013.

Alvarez made the statements at an interview with ABS-CBN on May 22, before a televised Senate investigation on the issue on July 7, and a news article in December last year.

Áside from Alvarez, Gazmin also filed a case against Thach Hoang Nguyen, the agent of Rice Aircraft Service Inc. (RASI), for falsification of documents in connection with the bid submission for the contract of the UH-1H helicopters.

Alvarez testified last year in a

Senate investigation on alleged irregularities surrounding a P1.2-billion contract for the supply of 21 "Huey" helicopters.

She accused Gazmin and

She accused Gazmin and the military officials of violating the Government Procurement Reform Act and the Revised AFP Modernization Program.

Alvarez filed the complaint before the Office of the Ombudsman, asking it to further investigate Gazmin and the other respondents for the administrative offense of gross dishonesty.

"When the news came out regarding the alleged irregularities, as head of agency, I ordered an investigation. The result of the investigation showed that the Department of National Defense-Armed Forces of the Philippines (DND-AFP) personnel who handled this project, in various stages, complied with the mandated procedures and no irregularities were committed," Gazmin said.

Gazmin files libel raps vs accuser

DEFENSE Secretary Voltaire Gazmin has filed libel and other charges against a former country representative of the company supplying helicopters to the military who had accused him of rigging the P1.2-billion contract to purchase the 21 refurbished Huey choppers.

Gazmin filed three counts of libel against Rhodora Alvarez, who is also a Bureau of Internal Revenue employee, in the Quezon City prosecutor's office last Friday.

Gazmin's charges stemmed from Alvarez's statements made in a live radio interview on May 22, 2015; a televised Senate

hearing on July 7, 2015, and in an article published on Dec. 13, 2015, in the Manila Times.

Alvarez had accused Gazmin and other defense and military officials of rigging the contract to purchase the 21 Bell UH-1 helicopters in 2013.

She said the officials violated the Government Procurement Reform Act and the Revised Armed Forces of the Philippines Modernization Program.

Alvarez filed a plunder complaint against Gazmin and several others in the Office of the Ombudsman last month.

In his libel complaints, Gazmin maintained that no irregularities were committed in the acquisition of the helicopters as shown by the investigation he himself ordered.

"When the news came out regarding the alleged irregularities, I ordered an investigation.

The results of the investigation showed that the personnel who handled this project, in various stages, complied with the mandated procedures and no irregularities were committed," he said.

Gazmin also charged Alvarez, and Rice Aircraft Services Inc. (Rasi) agent Thach Hoang Nguyen, with falsification and use of falsified documents.

This was for the submission of alleged fake or otherwise spurious documents in the bid of Rasi and Eagle Copters in 2013 to supply 21 UH-1 helicopters, including spare parts.

Gazmin said he stood by the defense and military officials who were just doing their duty and advancing the AFP Modernization Program.

"We know that public service suppliers, Rice Aircraft Services entails a lot of sacrifices, even lnc., in exchange for a 7-percent being exposed to untruthful commission.

and malicious accusations," Gazmin said.

Alvarez's accusations stemmed from the purchase contract entered into by the Department of National Defense with the Rasi and Eagle Copters.

The contract called for delivery of all 21 helicopters to the AFP within 180 days up to Sept. 21, 2014, but the contractor delivered only 10 choppers.

Of the 10 units, the AFP accepted only two because the others had defective engines and lacked spare parts and accessories. The DND ended up terminating the contract for failure to deliver the units on time.

During a Senate hearing, Alvarez alleged that DND officials intended to favor one of the suppliers, Rice Aircraft Services Inc., in exchange for a 7-percent commission.

US rocket launchers won't stay in Palawan

The two M142 High Mobility Artillery Rocket System (HIMARS) airlifted in by the American military for "Balikatan 2016" (BK16) will not stay in Palawan after the exercise, but could come back if needed.

Earlier, reports quoting unnamed sources said that after the BK16, the HIMARS would be retained at the Antonio Air Base in Palawan and "would form part of the repositioning of troops and assets of the US in the country under the Enhanced Defense Cooperation Agreement (EDCA), other than aiding the military against China's aggressive military activities in the South China Sea."

However, U.S. Marine Lt. Col. John Lehane, inspector instructor with 2nd Battalion, 14th Marine Regiment, US Marine Corps Forces Reserve, stressed that the rocket launchers are in the country purposely for the on-going

interoperability training between Filipino and American troops.

"At the conclusion of Balikatan Exercise... both the HIMARS launchers that we have here in the Philippines are going back to the US," he told reporters in an interview during the BK16 static display in Clark Air Base, Pampanga.

Lehane said: "HIMARS is a 21st century artillery for the US Marine corps and so it's important for us to be able to bring that system out here and demonstrate its capability to our Filipino brothers in arms."

He said US troops are showing members of the Philippine armed forces the capabilities of the system, as well as its limitations, and what it could do if there is ever a conflict.

Another member of the US Marine Corps interviewed by the Manila Bulletin also said the HIMARS will go back to Oklahoma City in the US immediately after BK16.

US defense chief opens Asia trip to talk defense

WASHINGTON—US Secretary of Defense Ashton Carter headed Saturday to India and the Philippines for talks on increasing regional defense cooperation, after calling off a planned trip to China amid tensions over Beijing's expansionist ambitions in the South China Sea.

Carter will fly out of Washington and travel to India and then the Philippines, where he is scheduled to meet with President Aquino and Defense Secretary Voltaire Gazmin.

China lays claim to almost all of the South China Sea, which is important to international shipping and is believed to

hold valuable mineral and energy deposits.

Neighboring countries and Washington fear China could impose military controls over the entire South China Sea, and Beijing has in recent months built massive structures, including radar systems and an airstrip over reefs and outcrops.

The Philippines is among several regional countries that have claims to the strategic zone.

"Almost all the nations there are asking us to do more with them... bilaterally and multilaterally," Carter told the Council on Foreign Relations think tank in New York on Friday.

"Many of those countries are reaching out anew to the United States to uphold the rules and principles that have allowed the region to thrive."

In India, where Carter will stay through Wednesday, he will discuss new partnerships and modernizing old alliances, according to the Pentagon.

"We are now doing things that could not have been imagined 10 years ago," a senior US defense official said.

In the Philippines, Carter will visit the Antonio Bautista Air Base on the island of Palawan, which faces the South China Sea and the islands claimed by Beijing.

The Philippine base is part of five that the US military can use temporarily to rotate soldiers, following a military cooperation agreement that came into effect in January.

No China stop

Access to the five bases will "enhance our ability to operate within the Philippines... and in the South China Sea—and of course, reinforce our deterrent message," a senior US defense official said.

The agreement marks a return of the US military to the Philippines, which was a US colony from 1898 to 1946. Until 1992 the Philippines was also home to Subic Bay Naval Base and Clark Air Base, two of the largest US military bases abroad.

Carter, however, chose to not stop in China during his Asian tour, even though he had earlier accepted an invitation to visit.

The decision to skip China was made just a few weeks ago, highlighting tensions between Beijing and Washington over the South China Sea.

Carter "did officially accept an invitation to travel to China in the spring," said Pentagon spokesperson Bill Urban. However, "scheduling problems" prevented that visit from happening.

"We are actively looking" for another date to visit "this year," Urban said. AFP

Military official: Pacman win 'a source of comfort' for battle-hardened soldiers

Amid its setback in Basilan on Saturday, the Armed Forces of the Philippines (AFP) yesterday branded as "a source of comfort" the victory of Sarangani Rep. Manny Pacquiao who dominated American Timothy Bradley en route to a unanimous decision win.

Brig Gen. Restituto Padilla Jr., AFP spokesman, said that Pacuiao's victory came as a comfort to "battle-hardened" soldiers following the killing of 18 government troops and wounding of 53 others during a clash with the terrorist Abu Sayyaf group in Basilan.

An Army reservist with the rank of lieutenant colonel, Pacquiao floored Bradley twice during the 12-round bout and scored 116-110 in all of the three judges.

"We were in Mindanao when Lt. Col. Manny Pacquiao's victory was passed on to us. It was a most welcomed news, a consolation and a source of comfort for many of our battle-hardened warriors," said Padilla.

Defense Secretary Voltaire Gazmin and AFP Chief of Staff Gen. Hernando Iriberri and other senior military officers were in Zamboanga yesterday to monitor the ongoing military operations

against the Abu Sayyaf in Basilan

"Just like Manny, our warriors' determination and tenacity in seeking the enemy and prevailing over the forces of evil are clearly manifest in their undeterred operations against the enemies of the state," said Padilla.

For his part, Army chief Lt. Gen. Eduardo Ano, who was also in Zamboanga, expressed elation over Pacquiao's victory.

Ano said that since Pacquiao is seeking a Senate seat, the Army would have to wait until after the elections to recognize him for his dominant performance against Bradley.

"He is a political candidate and we are ban from doing it. Perhaps we can recognize his feat and success after the election period," Ano said.

Army spokesman Col. Benjamin Hao echoed Padilla's pronouncement expressing hope that Pacquiao's win would somewhat bring comfort to the soldiers.

"The Philippine Army expresses its happiness on the win of Army Reserve Lt. Col. Manny Pacquiao," said Hao.

"We are proud of him. We hope that this will at least compensates the loss of our troops in the Basilan operation that happened during the Araw ng Kagitingan," he added. April 2016

As I was writing this piece at 5


Sunday, there was no statement rom the commander-in-chief of he Armed Forces of the Philipines. I texted his spokespersons at didn't get any reply.

Does the President know of the tagedy in Basilan?

An ABS-CBN report quoting Vestern Mindanao Command pokesperson Major Felimon Tan aid at least 23 were killed and nore than 70 others were wounded when the 44th Infantry Battlion and the 4th Special Forces attalion engaged in a 10-hour un-battle against at least a hunred armed members of the Abu ayyaf group.

Tan said of the 23 dead, 18 were oldiers while 53 others were ounded. At least five bandits ere killed including a Morocan-based terrorist identified as Iohammad Khattab, as well as ne of the sons of ASG top com-



mander Isnilon Hapilon, identified as Ubaida Hapilon.

Will this be another April 1 Kidapawan tragedy where three farmers died and many were wounded including policemen when the latter tried to disperse farmers rallying for rice because of poor harvest due to El Niño that was met by a deafening silence by the President.

After a week, Aquino said he didn't know about the Kidapawan tragedy. No one told him, he said. It is not funny.

If Aquino is again doing a Mamasapano for the 18 dead soldiers, at least two presidential candidates issued statements of outrage over the massacre.

Sen. Grace Poe condemned the "the brutal and treacherous mur-

der of our troops."

"These terrorists should be immediately pursued and crushed by the full might of our military and police forces, with due regard for the safety of the innocent civilians," she said.

She also urged the public "to be vigilant in reporting to authorities those groups and individuals, including public officials, who support and coddle the Abu Sayyaf and other armed groups for their selfish gains at the expense of peace and security. They should be exposed and answer for their criminal acts."

Even Mar Roxas, through his spokesperson, Rep. Barry Gutierrez, said something about the tragedy.

He noted that the tragedy hap-

pened as the entire country was commemorating the Day of Valor, (Araw ng Kagitingan).

"The Daang Matuwid Coalition celebrates their courage, and wishes to extend our deepest condolences to the family and friends of our fallen soldiers. We are one with those who honor their sacrifice, grieve for their demise, and seek justice for their deaths at the hands of the bandits of the Abu Sayyaf. To all the soldiers who took part in the battle in Basilan, thank you for your service, your heroism will not be forgotten, "Roxas statement said.

Vice-Presidential candidate Ferdinand "Bongbong" Marcos Jr. called on the AFP to disclose the details of the Basilan encounter.

"Here were go again. We are again in the dark of what happened," he said noting of the country's experience with the ill-fated Mamasapano operation which led to the killing of 44 members of the Special Action Force.

He said, "We need a full picture of the encounter. We should not hide these details. The Filipino people and most especially the families of the soldiers killed and wounded deserve to know the whole truth."





What's magnificent about withdrawal of US bases?

WO ITEMS stood out in the March 19, 2016, ssue of the INQUIRER—the report titled "US fears hinese buildup on Panatag" (Front Page) and he column by Mahar Mangahas titled "The vinlication of Jovito Salonga" (Opinion). Both tems are related to the removal of US bases

rom the Philippines in 1992.

The 12 senators led by then Senate President salonga who voted in 1992 for the removal of he US bases were thereafter referred to as the Magnificent 12." In the light of what has since appened in the West Philippine Sea, it is time we posed the question: What is magnificent about the ousting of US bases from the country? National survival is the primordial consideration in the conduct of a country's foreign relations. On this basis, the removal of US bases from the country is an unmitigated disaster.

In 1992, Panatag Shoal was a target range of the US Navy Had the US bases not been removed, we would still be in possession of Panatag. Moreover, with the connivance of America, we could also have designated as target ranges all the areas on which China has built artificial islands. In 1992, nobody had effective possession of these disputed areas. They were terra nullius, and using them as target ranges would have amounted to effective possession by the Philippines.

Like all bullies, China picks on the weakest prey first. In the current dispute, China has bullied only the Philippines and Vietnam, and has not grabbed areas claimed by Taiwan and Malaysia. The major reason is this: Taiwan and Malaysia have modern weapons ("A neutral foreign policy will not work," Opinion, 7/4/15). China would not have confronted the

United States on this issue.

The most devastating outcome of China's construction of these artificial islands is the impact on the defense of our national territory. In 1992, the nearest Chinese airfield was 900 kilometers away, on Hainan island. Now, Chinese airfields are a scant 200 km away. The significance of this is that the distance of 900 km is not within the combat range of jet fighters. But that is not the

case at 200 km. Our problem will get worse the day China installs missiles on those islands. We will need batteries of Patriot missiles to defend our country, which of course we cannot afford.

The constant argument of those who worked for the removal of the US bases from Philippine soil was that the bases' presence was an affront to our national sovereignty. And yet we can, after due notice, always terminate the presence of US bases, which we in fact did in 1992. Instead, what we have now is China's permanent presence on our front yard, and the only way we can remove it is by waging World War III.

In 1992, the US bases provided employment for as many as 80,000 Filipinos. Conversely, a big number of our fishermen have lost their livelihoods; Chinese fishermen are exploiting the marine resources that our own fishermen used to harvest. On top of that, rare sea life which our Navy and Coast Guard had safeguarded for years are being harvested illegally by the Chinese. In due course, they will exploit all the natural resources of these areas.

We are not speaking here with the benefit of hindsight. These events are foreseeable. It is taught in any course in diplomacy that we live in a lawless world. A country must have adequate arms to defend its territorial integrity. A defenseless country invites aggression. When the 12 senators voted to oust the US bases in 1992, they should have taken the compensatory step of increasing the defense budget. Given our limited means, this would undoubtedly have caused a decline in our living standards. But then, we have a model on this issue.

When India started developing nuclear weapons, Pakistan said in response that it would do the same even if its people ended up eating grass. Pakistan got its nuclear arms, but at great

privation to its people. But Pakistan's officials who said this were true statesmen; they had the courage to tell their compatriots what it would take to preserve their national sovereignty.

We cannot say the same of the 12 senators who voted to oust the US bases. They constituted a majority in the Senate; it was within their power to increase the defense budget, although this would have meant cutting the outlays for education, health and social services. That would have been an unpopular move and they could have been voted out of office. In this respect, the "Magnificent 12" behaved as politicians: They were thinking of the coming elections, not the future of our country. Had they behaved as statesmen, they should have, like their Pakistani counterparts, increased the defense budget even if our people had to eat grass.

The problem is that we still see this happening in our country now. We see a considerable number of our politicians still calling for the abolition of the Visiting Forces Agreement and the Enhanced Defense Cooperation Agreement but without telling the public that this would require increasing the defense budget, which would in

turn depress our living standards.

It is difficult to see how the removal of the US bases in 1992 constituted a magnificent episode in our history. In fact, this early it is evidently a catastrophe. From here on, we have to live under the shadow of Chinese weapons, including nuclear arms in due course. There is also something wrong when a country overlooks a failure in public policy, in this case the closure of US bases, and pass it off as a success.

The great hoax on the Marcos burial

THE NARRATIVE has always been that the body in the glass coffin in Batac, Ilocos Norte, lying there since 1993, is yet to be buried because the state refuses burial. As a result, the body lies embalmed until God knows when. There is an irreverent twist to it, sacrilegious even, that appeals to most cultural norms barring the desecration of the dead. In short, the message is: The state is cruel to disallow proper burial.


I have had two opportunities to visit the crypt of Ferdinand Marcos. The tourist gazer is usually led to an inner chamber inside the mausoleum just beside the family's "ancestral house." I enclose that in quotation marks because the house is anything but old; it is a new building designed to have fake, exposed "paletadas" so as to conjure antiquity; this is also part of the narrative. This first visit had an Imeldific air to it—the sound of

choral cantatas filled the chamber.

The second visit some years later was unexpectedly and surprisingly revealing. A close Marcos family friend escorted us to the crypt. There in the stillness of the chamber (no choral cantata this time), looking down on the finely chiseled body of the deposed president—you could clearly see the veins on his hands, or so I thought—the family friend whispered: This body is just a wax replica, the real corpse had already been buried underneath. End of the narrative.

It has become customary for most of those who have personally seen the Marcos crypt to say that "the body lies preserved in a refrigerated glass crypt" or "his body is on display in a glass case" because it is yet to be "interred in a manner befit-

ting a former president." It is time we disabused ourselves of that colossal lie. Marcos has already been buried and that is the truth. There is no more need of a burial. This issue comes on the heels of the last presidential debate held the previous month in Cebu. A novel feature of that debate was the "taas kamay" portion. The four candidates were asked if they were in favor of a Marcos burial at



the Libingan ng mga Bayani. Jejomar Binay and Rodrigo Duterte raised their hands.

Transactional politicians are never far from a quid pro quo arrangement. Duterte makes no secret of his admiration for Ferdinand Marcos. Having come myself from that intimation of the Marcos family friend, Binay and Duterte raising their hands was a comical sight. They looked like poor

ignoramuses.

The Libingan ng mga Bayani is the national pantheon provided by Republic Act No. 289 for departed former presidents and commanders in chief, secretaries of national defense, AFP chiefs of staff and general flag officers, active and retired military personnel of the AFP veterans of the Philippine revolution of 1896, World War I, World War II and recognized guerrillas, government dignitaries, statesmen and national artists. The entitlement can also be extended to former first ladies.

Section 1 of that law avers the creation of the national pantheon: "to perpetuate the memory of all Presidents of the Philippines, national heroes and patriots for the inspiration and emulation of this generation and of generations still unborn." A despot deposed by a popular uprising does not qualify. Even in the absence of popular disapprobation or a chorus of consternation in this day and age of historical dementia, that fact of history alone disqualifies him from being an inspiration worthy of emulation.

Marcos' martial law statistics are chilling even when compared to the record of dictatorships elsewhere in the world. Its tally of 3,257 extrajudicial killings exceeds the 2,115 extrajudicial killings in

Chile under Gen. Augusto Pinochet, or the 266 extrajudicial killings during the regime of the Brazilian junta. Some 2,520 or 77 percent of those killed were tortured, mutilated and dumped on a roadside for public display. A huge number, 70,000, were incarcerated, and those tortured numbered 35,000.

Alfred McCoy says that under Marcos, "Military murder was the apex of a pyramid of terror. Instead of an invisible machine like the Argentine military that crushed all resistance, the Marcos regime intimidated by random display of its torture victims, becoming thereby a theater state of terror. Seeing these mutilated remains, passers-by could read in a glance a complete transcript of what had transpired in Marcos' safe houses, spreading a sense of fear."

The 9,539 human rights victims who filed a class suit against Marcos already won \$2 billion in damages in a Honolulu court, later affirmed in 2011 by a ruling of a US circuit court in Hawaii. It is not about uniting a nation. It is, and continues to be, accountability for the errors committed in the pursuit of public trust.

At the Libingan's entrance, one finds the poignant words, "I do not know the dignity of his birth, but I do know the glory of his death," a quote from Douglas MacArthur taken from a speech delivered during his 1961 sentimental journey to the Philippines. A Libingan burial for the deposed dictator is an insult to the thousands of martial law victims who are the ones who deserve a Libingan burial.

We must also take note that of all the dead Philippine presidents, only Carlos P. Garcia, Diosdado Macapagal and Elpidio Quirino are buried at the Libingan. The graves of Sergio Osmeña, Manuel A. Roxas and Ramon Magsaysay are till this day at the Gementerio del Norte, and Jose P. Laurel's in Tanauan, Batangas.

While the grim reminder of the Marcos terror must remain, and while we know all these protocols about who gets to be buried at the Libingan, the script must be changed for the sake of truth: Marcos has already been buried in Batac. Let him rest in peace.

"Soldiers of Joint Task Group Basilan conducting military operations in Basilan province encountered more or less 120 Abu Sayyaf bandits under Isnilon Hapilon and Furuji Indama."

Full military honors will be accorded to these soldiers in line with the time honored tradition of the AFP. Also, all military camps will fly the flag at half-mast as the nation mourns their death and in recognition of their ultimate sacrifice for the country.

The AFP assured the families of the bereaved soldiers of the benefits that they will be receiving.



The next and final round of the Commission on Elections-organized presidential debate will be held in Pangasinan on April 24.

The reelectionist senator said that the Aquino administration has reduced the number of Abu Sayyaf attacks, but that recent kidnappings — including four foreign nationals who were grabbed from a resort on Samal island in the Davao region last September — show they are still a threat.

In recent weeks, the group is also believed to have abducted 10 Indonesian and four Malaysian sailors in separate incidents.

"Before their hostages become a United Nations of kidnap victims, they must be stopped. We know the lessons of the past: Ransom payments fuel more kidnappings and finance more terror activities," Recto said.

On Saturday, at least 18 soldiers were killed and more than 50 were wounded in a daylong firefight with from 100 to 150 Abu Sayyaf bandits in Al-Barka and Tipo Tipo towns in the island province of Basilan.

The Associated Press, citing security officials, reported that the soldiers had been deployed to kill or capture Abu Sayyaf commander Isnilon Hapilon, who has publicly pledged allegiance to the Islamic State group and has been hunted for years for his alleged involvement in several terrorist attacks.

"We commend the bravery of our fallen soldiers. We condole with their loved ones, but above all, let us assure them that justice will be served soon," Recto said.

US-Philippines Alliance to Reach 'New Level': US Defense Chief

Ash Carter offers praise for bilateral ties in a think tank speech ahead of a visit to Manila.

Recent progress in U.S.-Philippine relations will take the capability of the alliance to a "new level" not seen in decades, the United States' defense chief told an audience in New York Friday before departing for a trip which includes stops to the Philippines and India.

The Philippines, long belittled as one of Asia's weakest militaries and Washington's laggard regional alliance, has become a critical part of the United States' rebalance to the region with ratification of a new defense pact known as the Enhanced Defense Cooperation Agreement (EDCA) in January as well as its involvement in a Pentagon capacity-building program known as the Southeast Asia Maritime Security Initiative (MSI), which is just getting underway.

"EDCA and MSI will take the U.S.-Philippines alliance capability to a new level, one not seen in decades," U.S. Defense Secretary Ash Carter said in a speech on Asia at the Council on Foreign Relations (CFR), a New York-based think tank.

EDCA, which was inked in April 2014, but only upheld by the Philippine Supreme Court this January, gives U.S. troops and equipment wide access to Philippine military bases on a rotational basis. Carter said that the announcement of the initial slate of five locations under the agreement would allow U.S. forces to conduct regular rotational training, exercises and activities and better support the modernization of the Philippine military as well as mutual defense.



"We recently announced an initial slate of five EDCA Agreed Locations for the alliance activities, locations arrayed throughout the archipelago that will offer the opportunity for increasingly complex bilateral engagements," Carter said.

As part of his trip to the Philippines, Carter is expected to visit two of the five locations next week – Fort Magsaysay and Antonio Bautista Air Base. EDCA, Carter said, would enable the allies to augment prepositioned disaster relief supplies at Fort Magsaysay that had supported the response to Typhoon Haiyan, the deadliest typhoon ever recorded in Philippine history that killed over 6,300 people. New stocks would also be added to Bautista Air Base to enhance allied ability to respond to future disasters.

The Diplomat understands from officials that while initial efforts under EDCA will focus on areas like humanitarian assistance and disaster relief, over the longer term the agreement will allow the United States to station more troops, ships, and planes more frequently, thereby enhancing Washington's rotational presence in the region more generally amid a range of threats including China's growing assertiveness in the South China Sea.

Regarding MSI, a \$425-million-dollar, five-year maritime security capacity-building initiative for Southeast Asian states near the South China Sea, which Carter first announced last year at the Shangri-La Dialogue in Singapore, Carter said that most of the funding for the first year of the program would go to the Philippines.

"We have just released the first tranche of this money, nearly 80 percent of which is going to the Philippines," he said.

The funding, he said, will help modernize the technology and train staff at the Philippine National Coast Watch Center, enhance an information network to enable classified information sharing between U.S. Pacific Command in Hawaii and key Philippines maritime command centers, provide an aerostat reconnaissance platform, and outfit Philippine navy patrol vessels with better sensors.

This would be a much-needed boost for Manila, which has struggled to counter Beijing's assaults against it in the South China Sea, including the seizure of Scarborough Shoal in 2012 and the continued harassment of Philippine aircraft, vessels, and fishermen. The Philippines also has a pending South China Sea case against China with the Permanent Court of Arbitration (PCA) at the Hague, with a verdict expected in May or June.

"[O]ur having the initiative and the funding that goes with it that makes it possible, particularly for a country like the Philippines... it's a very positive thing," Carter told *The Diplomat* in response to a question on board Boeing 737-700 flight from New York back to Washington following his CFR speech.

Carter will also become the first U.S. defense secretary to observe the Balikatan exercises, the premier bilateral U.S.-Philippine military exercise that has grown to involve Australia as well as a number of additional observers this year including Japan. This year's exercise, which runs through April 15 and includes over 7,000 personnel from all military services from both countries, features a simulated oil and gas platform recovery raid in the South China Sea and the deployment of two units of the U.S. M142 High Mobility Artillery Rocket System (HIMARS) for the first time.



"Balikatan signals our shared resolve. It enhances our shared capabilities. And it demonstrates, once again, America's dedication to standing shoulder-to-shoulder with the Philippines," Carter said, referring to the U.S. translation of the term Balikatan in the local Tagalog language.

Carter also reiterated U.S. President Barack Obama's statement that the U.S. commitment to the Philippines is "ironclad." Some continue to call on the administration to clarify its commitments under the U.S.-Philippine defense treaty as they might apply to the South China Sea to serve as a deterrent to Beijing.

Korean manufacturer to provide PH Marines 8 new Amphibious Assault Vehicles


Hanwha Techwin, previously Samsung Techwin, was declared as the winning bidder for the Department of National Defense's Amphibious Assault Vehicle (AAV) acquisition project, according to MaxDefense. MaxDefense said that the Notice of Award was already provided.

The contract price for the acquisition of eight brand-new AAVs is PhP2.423 billion. These amphibious vehicles will render service to Philippine Marine Corps of Philippine Navy when delivered. Approved budget for the said acquisition was PhP2.5 billion.

South Korean Hanwha Techwin and American BAE Systems are producing AAV7A1 vehicles. Amphibious vehicles produced by the South Korean manufacturer are designated as KAAV7A1 (KAAV).

This project was among the seven multi-year contract projects that President Aquino approved. The approval also included two frigates, two anti-submarine helicopters for Philippine Navy; two long-range patrol aircraft, six close-air support aircraft, munitions for FA-50 and three air surveillance radars for the Philippine Air Force.

Meanwhile, units of Philippine Marines have conducted AAV familiarization training event with their American counterparts April 4, during the conduct of Balikatan 2016.
