





### 6 killed in raid on Espinosa house

PALO, Leyte – Six armed men, said to be part of the private army of Albuera Mayor Rolando Espinosa and his son Kerwin, were killed in a shootout with police in their hometown early yesterday.

Acting police regional director Chief Supt. Elmer Cruz Beltejar said the lawmen returned fire at the armed group in Sitio Tinago, Barangay Ben-

Beltejar said the policemen were on routine patrol in the area when the armed group opened fire from one of the houses.

"These members of the Espinosa group were occupying one of the Espinosas' houses, specifically where the rooster

farm is located. They fired first, so our policemen were forced to fire back," Beltejar said.

Beltejar said the six fatalities have yet to be identified.

Initial reports identified two of the slain suspects as Ricky Gravello of Ormoc City and Teresito Paderangga of Zamboanga City. Three others were only known as "Tatay," "Edgar" and "Intsik."

Beltejar said the policemen initially encountered around 12 men armed with automatic weapons.

After the firefight, some of the suspects escaped, leaving behind several high-powered assault rifles, automatic handguns and rifle grenades.

The clash came a day after Mayor Espinosa surrendered to Philippine National Police (PNP) chief Director General Ronald dela Rosa.

Authorities alleged Espinosa has been protecting drug dealers, including his son Kerwin, who has not surrendered.

Espinosa surrendered with-

in the 24-hour deadline given to him by President Duterte to yield or a "shoot-on-sight" order would be issued against him and his son. Dela Rosa has warned the younger Espinosa "will die" if he elects to shoot it out with police.

PNP spokesman Senior Supt. Dionardo Carlos said the armed men are believed to be part of the Espinosa

"There was no reason why policemen would open fire (first). The shots came from inside one of the houses, so after the exchange of gunfire the policemen went inside the house after the threat was neutralized. They entered only in the aftermath of the operation," Carlos said.

Two of the slain suspects were found near the foyer of the mayor's house, two were shot in the area where fighting cocks are bred and two others lay dead by the gate of Kerwin's compound.

Carlos clarified the policemen were not on a mission to raid the Espinosa houses but they were on routine patrol when they figured in a firefight with the group.

"It is normal duty to conduct patrol operations in the community. The operation did not specifically target the compound of the mayor. Unfortunately, they were fired upon," he said.

Carlos said the mayor will be asked by the police Criminal Investigation and Detection Group (CIDG) about the presence of armed men in his house.

"We will trace the guns, the guns registered under his name should be at his house," Carlos said.

Espinosa appeared before the CIDG yesterday, with his lawyer Romeo Esmero speaking on his behalf.

Esmero denied the armed men killed in the mayor's house were his bodyguards.

The mayor never tolerated his son Kerwin's forays into illegal drugs, the lawyer said.

Esmero also denied the mayor was involved in drug trafficking.

An emotional Espinosa, for

his part, pleaded to his son to surrender, saying the PNP chief has given assurance to assist them.

"Kerwin please surrender PNP chief Dela Rosa promised to help you," Espinosa told reporters after he gave his statement before the CIDG in a closed-door meeting.


Carlos said authorities are looking into reports the younger Espinosa has already fled the country. There were reports that Kerwin underwent plastic surgery to change his facial appearance to evade arrest.

Reports said Kerwin left for Kuala Lumpur, Malaysia last June 21 on Cebu Pacific flight 51501.

The Espinosas have been linked to major drug trafficking in Eastern Visayas.

Dela Rosa said Mayor Espinosa had been listed in police records as a "drug protector" whose son controlled the narcotics trade in the region.

The mayor was the second high-profile drug suspect to turn himself in after being accused of drug-related crimes by Duterte.

Another local official, Daanbantayan, Cebu Mayor Vicente Loot, was one of five police generals linked by Duterte to the illegal drug trade.

Loot is a retired police general who served as anti-narcotics unit chief of the Central Visayas regional police.

Loot denied the allegations of Duterte as well as reports linking him to Kerwin.

"I never knew him. I heard

about him when I was Central Visayas (anti-narcotics) chief. I did not use him as an asset in illegal drugs," he said.

Loot said that in 2011, he learned the regional police were hunting Kerwin. He said he even furnished a copy of the warrant of arrest for the younger Espinosa to policemen. – Lalaine Jimenea, Cecille Suerte Felipe, Evelyn Macairan, AP, AFP

# Military ready to pull out of lumad communities if NPA does the same

DAVAO CITY – The military is willing to pull out its troops stationed in indigenous peoples' (lumad) communities to allow residents to return home, according to 10th Infantry Division Commander Maj. Gen. Rafael Valencia.

But Valencia was quick to add that the New People's Army (NPA) should also leave the vicinity of these communities.

In a press conference yesterday, Valencia said the Armed Forces of the Philippines (AFP) was willing to support calls to put a stop to the militarization in IP communities, but on the condition that forces of the Communist Party of the Philippines (CPP), National Democratic Front (NDF), and NPA do the same.

"He who is the cause of the cause is the cause of them all," Valencia said, quoting President Duterte, in reference to CPP-NPA-NDF insurgents.

He underscored that what was keeping the military from pulling out its troops from these areas was the presence of the rebel groups, who were causing all the trouble in these communities.

"It is not only the AFP which should

pull out but all armed groups because they are the cause why we are there in the area. The NPA is causing trouble in the mountains," he said.

He alleged that the NPAs were keen 'on driving a wedge between the government and the people.

He said the military holds operations in these communities to "bring the people closer to the government.

Eastern Mindanao Command (East-Mincom) commander Maj. Gen. Rey Leonardo B. Guerero said that military and NPA encounters have resumed after Duterte lifted last Saturday the unilateral ceasefire with the CPP-NPA-NDF.

### Another CAFGU killed in **NPA** attack

AVAO CITY - Another member of the Civilian Armed Forces Geographical Unit (CAFGU) was killed in a firefight with New People's Army (NPA) rebels in Cotabato, Monday, less than a week after the death of a militiaman in an ambush by insurgents put in peril peace talks between the government and the leftist group.

Oscar Emba, 53, died from six gunshot wounds after he shot it out with communist rebels. His assailants even took his motorcycle after the encounter that started at 7 p.m. Monday.

Emba was assigned at the Balabag CAFGU Active Auxiliary (CAA) Detachment at Crossing Birada, Kidapawan.

His death came less than a week after another militiaman was killed in

an NPA ambush in Barangay Gupitan, Kapalong, Davao del Norte in the morning of July 27, or less than 48 hours after President Duterte declared a unilateral ceasefire with the Communist Party of the Philippines (CPP), National Democratic Front (NDF), and NPA.

The incident was later denounced by an irate Duterte, who lifted the ceasefire order Friday.

"We shall use and deploy all our

available forces, continue offensives and support law enforcement operations," Maj. General Rafael Valencia, 10th Infantry Division, said of the Cotabato incident...

Another attack happened at 9:50 p.m. also last Monday when the NPA reportedly attacked the Sallab detachment in Magpet, North Cotabato. There was no casualty reported from both sides.

### 4 Army soldiers face discharge for drug use

#### BY VICTOR REYES

FOUR Army soldiers are due for dishonorable discharge from military service after confirmatory tests showed them positive for illegal drug use, the Army said vesterday.

Nine other soldiers, including three officers, tested negative in the confirmatory test, said Army spokesman Col. Benjamin Hao.

All 13 soldiers were placed under Army custody last month after initially testing positive in a random drug test that covered 2,500 personnel at the Army headquarters in Taguig City.

Hao said the four - a staff sergeant and three corporals - will remain under Army custody pending their separation from the service.

"They will be discharged dishonorably and they are not going to receive any benefits," he said.

Hao said the nine others were cleared "based on basic reasons - they were taking up maintenance medicines." The nine cleared were two lieutenant colonels, a major, two staff ser-

geants, a sergeant, a corporal, a private first class, and a private. Hao said the Army leadership is dead serious in ridding the organization of personnel hooked on illegal drugs. The Army has about 85,000 officers and enlisted personnel.

"The commanding general (Army chief Lt. Gen. Eduardo Año) clearly said that we will rid the organization of drug users. They have no place in our organization," he said.

Hao also said will order random and mandatory drug tests "when he feels there are still drug users" in the Army.

### 4 soldiers positive for drugs

Meanwhile, four Army personnel are facing dismissal from service after they tested positive for drug use.

Army spokesman Col. Benjamin Hao said the four were among the 2,500 officers and enlisted personnel who underwent random drug tests at the Army headquarters at Fort Bonifacio in Taguig last month.

They were among the 13 officers and men who were brought to a medical facility in Quezon City for confirmatory drug testing, according to Hao.

### AFP eyes rehab centers in Bislig, Malaybalay camps

BUTUAN CITY - Officials of the Army's 4th Infantry (Diamond) Division (4th ID) are eyeing two military camps in northeastern and northern Mindanao regions that could be used as rehabilitation centers for drug dependents who have surrendered to the government and volunteered to be rehabilitated.

The 4th ID, the largest maneuvering Army division in Mindanao, is planning to temporarily establish rehabilitation centers for surrendered drug dependents in the camps of Butuan City and Malaybalay City.

To date, 25,582 drug users and 634 pushers have surrendered to local officials and police authorities in northeastern Mindanao (Caraga region) alone, while nearly the same number of drug

offenders have given themselves up in northern Mindanao (Region 10).

Top officials of the 4th ID yesterday began conducting ocular inspections, looking for available buildings at Camp Bancasi (Butuan City) and Camp Osito Bahian (Malaybalay City) to house surrendered drug personalities.

The command group of the 4th ID directed field commanders to closely coordinate with local government units and concerned line agencies of the government to make the treatment and rehabilitation centers available as soon as possible.

Maj. Gen. Benjamin R. Madrigal, Jr., commanding general of the 4th ID, said this was in response to President 'Duterte's call for military camps to be utilized as rehabilitation centers for willing drug dependents. (Mike U. Crismundo)

# Military camp, island readied for NBI inmates

JUSTICE Secretary Vitaliano Aguirre II said military camps across the country will soon become detention centers for inmates in the maximum security at the National Bilishid Prison (NBP).

Retired Marine Maj. Gen. Alexander Balutan, the incoming director of Bureau of Corrections (BuCor), has inspected the Caballo Island in Cavite to check the facilities for inmates.

The overwhelming number of drug suspects who surrendered to the police has prompted the government to look for more facilities to serve as detention centers.

"Because we don't have (enough) rehabilitation facilities, we will use military camps," said Aguirre in an interview on Wednesday.

He said Balutan and Enan Orceo, incoming justice undersecretary recently inspected Caballo Island to check on the possible transfer of inmates.

"My initial assessment is that we can easily transfer 160 inmates and 40 support personnel from BuCor to Caballo Island," said Gen. Balutan in a text message to secretary Aguirre. The text message was forwarded to reporters.

Gen. Balutan also said that the facilities in the Caballo island will only require minimum repair.

"We will just repair some facilities to suit our needs with minimum expenses," said Balutan.

### Rody kids troops: No coup, please

HE NEVER promised the troops a rose garden. But just the same, if they don't like his face anymore, they don't have to shoot up Malacañang to drive him out. All they need to do is call.

"I am here with a specific duty: to serve the Republic. I promised you a clean government. It will be a clean government," President Duterte told wounded soldiers at AFP Medical Center in Quezon City on Tuesday night.

A month after taking office, Mr. Duterte is making the rounds of military camps and facilities across the country to introduce himself to the troops and to rope the Armed Forces of the Philippines into his war on drugs.

He said he hoped the military would not be displeased with his actions, as many people would be affected along the way.

"I hope you won't get mad if we're doing the right thing. You might launch a coup d'etat and I would be out of a job. Do not launch a coup d'etat, just call me in Malacañang and say, Hoy, Duterte, leave your office, we will take over," he joked.

"OK. Then come here and I will announce: 'My countrymen, these are the new [leaders] of our country. This is the chairman, this would bring the new government. Goodbye. It's all yours. I will go home," he added.

But Mr. Duterte has said going to human rights advocates would not save drug dealers and pushers from death, and Sen. Leila de Lima, who has called for a Senate inquiry into the drug killings, has been threatened with investigation by the President's allies in the House of Representatives.

### Involving military

Mr. Duterte told the wounded troops that his intention was to serve the people and improve their lives and he would do so without tainting his administration with corruption.

He said the military should have teams that would go after drug traffickers.

"Every military unit should have one team—not all of them-that would be an antidrug group," he said.



### AFP hospital gets ₱500-M funding

President Duterte on Tuesday night announced that the government is allocating P500 million for the modernization of the Armed Forces of the Philippines Medical Center (AFPMC) on V. Luna Avenue, Quezon City.

According to the President, the money will be used to acquire state of the art medical equipment and to construct a new hospital building for the  $\blacktriangleright \Lambda$

country's soldiers.

Duterte announced this during his visit to battle casualty patients at the AFPMC.

"Magpasalamat tayo kay (Budget) Secretary (Benjamin) Diokno. Binigay niya lahat ng gusto ninyo na equipment pati isang building," he told injured troops doctors, and nurses.

Among the items to be purchased will be a magnetic resonance imaging (MRI) equipment and Gamma ray which is used for the non-invasive treatment of tumors.

He said these as he expressed surprise upon hearing that a national institution under the AFP does not even have an MRI.

He also noted that one of the buildings of the AFPMC is "not suitable anymore for the confinement of soldiers who are hospitalized," so that he promised to give them a new building.

Construction of the new building would start two months from now, he said. And as for the equipment, Duterte said it should be of best quality to make sure that soldiers and their families get the best medical care.

"Basta ang binigay ni Sec. Diokno sa inyo ay half a billion (pesos) and it will be released soon," said the President.

"There will be no compromise in the life of soldiers... Binigay niyo buhay niyo sa bayan, the least the country can do through me is to give you a state of the

art (medical facility) pati equipment sa giyera," Duterte said.

The President added: "Everything will be quality and fast," as he also assured that "it will be strictly in accordance with the law."

In his speech, Duterte also said that "in the fullness of God's time," he would implement a program that will provide free education to the children of soldiers.

The President took time to personally interact with and give medical assistance to soldiers currently confined at the said hospital.

The President even became emotional when he hugged young officer, 2Lt. Jerome Jacuba, 28, who sustained major injuries when an improvised explosive device went off as they were conducting clearing operation in March.

As a result of the blast, Jacuba is now totally blind in his right eye, while his left eye, which suffered retinal detachment, can only see light perception.

AFP doctors said there is no more chance for the young officer to be able to see again. He is currently undergoing visual rehabilitation at the AFPMC and would soon learn how to use the Braille system.

Jacuba, who is married with two children, is due for promotion to 1st Lieutenant.

## Duterte admits not finishing ROTC course

If you haven't completed your Reserved Officers Training Corps (ROTC)

requirement, don't despair.

Even President Duterte, commanderin-chief of the 125,000 strong Armed Forces, admitted that he did not finish the course, which used to be mandatory for

college students.

"You know I am not from the military. I did not even finish ROTC but I'm not into delays. Let's be frank. I don't want delays and corruption," he told soldiers during his visit to the Armed Forces of the Philippines Medical Center in Quezon City last Tuesday.

Duterte is pushing for the revival of mandatory service to the ROTC program, believing this would promote patriotism and keep the youth away

from drugs.

He expressed support for the mandatory military training during a Cabinet meeting in Malacañang last Tuesday.

"It's interesting what was mentioned, especially the President's comment regarding ROTC. How it's going to help in the building up of discipline and values, especially in this generation, and how we expect ROTC to be able to help build a sense of patriotism among the next generation," presidential spokesman Ernesto Abella said.

Efforts to push for the revival of mandatory ROTC are now being discussed, Abella added.

ROTC is one of three components of the National Service Training Program

(NSTP). Other courses offered are Civic Welfare Training Service, which deals with community programs, and the Literacy Training Service, which seeks to provide basic skills to public school pupils.

The mandatory ROTC program was abolished after then president Gloria Macapagal-Arroyo signed the NSTP law in 2002. Congress passed the measure following the murder of Mark Chua, a University of Santo Tomas student who bared irregularities in his ROTC unit.

Chief presidential legal counsel Salvador Panelo said in an earlier interview that the executive would ask allies in Congress to file a bill that would revive the mandatory ROTC program.

Youth group Anakbayan, however, has

thumbed down the proposal.

Anakbayan national chairman Vencer Crisostomo said they would wage a strong campaign against the proposal because ROTC is an abusive and burdensome program.

The youth leader noted that ROTC has a tainted record of stimulating power-tripping, corruption, hazing and mindless violence. It would also mean additional fees and more burden to students.

"ROTC should be abolished, not made mandatory. The program has never instilled nationalism, social responsibility or discipline. It is a training ground for fascist repression and corruption," Crisostomo said.

### China excluded from AFP, PNP procurement deals

President Duterte is looking at government-to-government procurement as a means to modernize the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP), but indicated any deals would not include China.

"We purchased from China before... The police got China M-16s," he said, fearing the

country's defense program might be sabotaged.

### Notorious drug dealer in Compostela Valley dead in joint militarypolice ops

MANILA, Aug. 3 (PNA) -- A notorious drug dealer in Laak town, Compostela Valley province died during a joint military and police operation last July 31.

In a statement on Wednesday, 10th Infantry Division public affairs office chief, Capt. Rhyan Batchar, confirmed the death of Pablo Namanig in a shootout with soldiers and policemen serving him an arrest warrant in Barangay Concepcion in Laak.

Namanig had been listed by the Philippine National Police (PNP) as one of the leading illegal drugs personalities in the area.

He also had a pending arrest warrant for murder at the Regional Trial Court Branch 3 in Nabunturan town. Batchar said that as the soldiers and policemen were about to serve Namanig his warrant of arrest, the latter pulled out a .38 caliber revolver and fired several shots at the government forces, who fired back.

Namania died at the COMVAL Provincial Hospital.

Recovered from his possessions were the .38 caliber revolver, three spent .38 caliber shells, PHP100 marked money, and "six heat-sealed cellophane containing marijuana fruiting tops." (PNA)

### Military launches own war vs drugs in Northern Mindanao

CAMP EVANGELISTA, Cagayan De Oro City, Aug. 3 (PNA) -- The government troops in this largest military camp in Northern Mindanao are launching a "new war" as the government is set to end the 40-year-old armed conflict with the communist insurgents in the country, a military official announced Wednesday.

Capt. Patrick Martinez, the Army's spokesperson of the 4th Infantry Division here, said that the 6,000 government soldiers in the region would undergo another "specialized warfare" - the one against drugs - in anticipation of a successful peace talk with the communist insurgents in the coming months.

"We are preparing our soldiers to undergo a comprehensive training in the war against illegal drug trade in Northern Mindanao," Martinez said.

He said that the 4ID has initially worked out with the Philippine National Police (PNP) on a crash course that would equip the military the needed know-how in intercepting illegal drugs and arresting pushers.

Martinez said that the Philippine Drug Enforcement Agency (PDEA) would become the lead partner in the training of the military in "the war against illegal drugs" in the region.

He said that the 4ID has yet to set the number of days of the training and whether it would be done on a daily or weekly basis.

Martinez also said the 4ID expects that each of the division's approximately 6,000 government troops would undergo the training.

He noted that the government troops currently attached to the division are spread out in three brigades, seven organic battalions, three attached battalions and the three more battalions on loan from the Special Operations Command.

The government soldiers are assigned in the provinces of Misamis Oriental, Misamis Occidental, Bukidnon, Agusan Del Norte, Agusan Del Sur, Surigao Del Norte, Surigao Del Sur and Dinagat Island. (PNA) LAP/CD/MARK FRANCISCO



On his visit, the President also reiterated his promise to increase their salary this month.




He also gave a stern warning against corrupt activities such as bid rigging. The president lamented the current bidding process being implemented by government which is open to corruption.

### Duterte refuses to acquire substandard equipment for AFP

MANILA, Philippines — President Rodrigo Duterte on Tuesday stressed he would not follow the rules of the Commission on Audit (COA) in acquiring equipment for the Armed Forces of the Philippines as it would lead to procuring substandard gears.

The current COA rule requires the government to buy equipment from the lowest bidder.

"Yang lowest bid kasi kung may bilhin ka ito lowest bid bibigay sayo barat. Kaya lahat ng equipments ninyo sabi ko, pinaalam ko na sa COA hindi ako susunod d'yan," Duterte told soldiers during his visit at the AFP medical center.

The president added that the lowest bidder policy is the source of corruption and hinted that the winners of public biddings usually acquire equipment made in China.

Duterte cited the branded patrol cars that police in Davao City use which last for three to five years.

The president added that equipment usually acquired from the lowest bidder are substandard.

MANILA, Aug. 3 (PNA) — Defense leaders of the Philippines, Indonesia and Malaysia have reiterated their commitment to encourage the "operationalization" of Standard Operating Procedures (SOP) needed for meeting current security concerns in their common waters.

This was stressed during the Tuesday meeting of Philippine Defense Secretary Delfin N. Lorenzana, Indonesian Defense Minister General (R) Ryamizard Ryacudu and Malaysian Defense Minister Dato' Seri Hishammuddin Tun Hussein in Bali

In the same meeting, the three reiterated their commitment to the Trilateral Cooperative Arrangement signed in Jakarta last July 14.

They also "agreed to encourage the operationalization of the SOP for Maritime Patrol and Rendering Immediate Assistance; Operating Guidelines on Information and Intelligence Sharing; and Combined Communication Plan."

"Recognizing the mutual trust and high responsibility from all parties, the defense chiefs agreed to further explore coordinated activities among the Armed Forces of the three countries, a trilateral database sharing mechanism, and the concept of the Malacca Strait Patrol to address maritime security concerns, among others," said Defense public affairs service chief Dr. Peter Paul Galvez.

During the meeting, the leaders also reiterated their stand against violent extremism and terrorism, and concern over the repeated incidents of armed robbery and kidnapping at sea in the maritime areas of common concern to the three countries.

This is an obvious reference to the Sulu Sea, the maritime area bordering the three nations where Abu Sayyaf Group bandits have infiltrated and launched several kidnapping attacks against Malaysian and Indonesian seafarers.

The defense ministers reaffirmed their commitment to address such threats.



The Trilateral Meeting was conducted in accordance with the ASEAN's principles of equality, mutual trust and respect for sovereignty, territorial integrity, non-interference in the internal affairs of one another, and good neighborliness.

The August meeting follows the first meeting held in Manila last June 20 where the three defense chiefs discussed the possibility of conducting trilateral air and maritime patrols in common areas of concerns by the three nations. (PNA)

### CA orders reinstatement of sacked Ombudsman Chief Special Prosecutor

MANILA, Aug. 3 (PNA) -- The Court of Appeals (CA) ordered on Wednesday the reinstatement of the Office of the Ombudsman Chief Special Prosecutor Wendell Barreras-Sulit after she was dismissed by the Aquino administration in connection with the plea bargaining agreement (PLEBARA) entered into with former Armed Forces of the Philippines (AFP) comptroller Maj. Gen. Carlos F. Garcia.

In a 29-page decision written by Associate Justice Zenaida T. Galapate-Laguilles, the CA Special 10th Division ruled that the Office of the President (OP), during the term of President Benigno S. Aquino III and Executive Secretary Paquito N. Ochoa Jr., committed an error with its order dismissing Sulit from her post as top prosecutor of the Ombudsman.

"In view of the foregoing, We Grant the instant petition for review. The Decision dated July 18, 2013 and Resolution dated December 6, 2013 of the Office of the President, dismissing Petitioner Wendell Barreras-Sulit from the service, are hereby Reversed and Set Aside," the CA ruling said.

Garcia was the former AFP comptroller who was charged with plunder by the Ombudsman after a lifestyle check was conducted against him and discovered millions of pesos and properties under his name and his family members, including that of the Trump Plaza Condominium in New York City.

He was also charged with money laundering and the Anti-Money Laundering Council (AMLC) even moved to freeze the assets of Garcia and his family members.

The CA did not agree with the findings of the OP that the plea bargaining deal with Garcia which allowed the general to enter a plea to a lesser offense was unlawfully executed.

It said that the PLEBARA executed by Sulit was lawful because she carried out the same under the direct supervision of then Ombudsman Marceditas Gutierrez, who happened to be the rightful persons to enter into the agreement as representatives of the people.

Gutierrez and Sulit entered the PLEBARA with Garcia, asking to return the properties to the Philippine government and allowing his plunder case to be downgraded to direct bribery charges.



Garcia was able to return PHP135,433,387.84 to the Philippine government with the PLEBARA with Gutierrez and Sulit.

Gutierrez and Sulit believed that the PLEBARA is the most advantageous way for the government because it is impossible to sustain a conviction since the information filed by then Ombudsman Simeon Marcelo and Special Prosecutor Dennis Villa-Ignacio for plunder were weak. These findings were affirmed by the Sandiganbayan.

However, when Aquino assumed the presidency, he forced Gutierrez to resign from her post to be able to appoint a new Ombudsman and then dismissed Sulit by using this case as a threat.

However, the CA said that the PLEBARA was also approved by the Sandiganbayan which made the agreement above board and within the process mandated by law.

The CA ruled that Malacanang had no authority to determine whether or not the evidence presented before the Sandiganbayan was strong to sustain a conviction.

"The act of the OP (Office of the President) in determining the probative value of the evidence presented in the cases of plunder and money laundering in this administrative proceedings is not only misplaced and uncalled for but also constitutes an encroachment of judicial power. The authority rests solely upon the appropriate court — the Sandiganbayan in this case," the CA ruling said.

With this, the CA said that Malacanang "was unable to present substantial evidence consistent with petitioner Sulit's administrative liability in relation to the execution of the PLEBARA. Our exposition below expounds further the OP's failure to overcome the burden of proving their claim that petitioner Sulit committed acts and/or omissions constituting betrayal of public trust and graft and corruption."

"We find it unfair to accuse petitioner Sulit of gross inexcusable negligence and bad faith in the performance of her function as Special Prosecutor as there was no substantial evidence that she was remiss in protecting the interest of the state. We believe that the PLEBARA was the outcome of a prudent, reasonable and practical evaluation of the cases against Maj. Gen. Carlos Garcia, a solution that would best serve the interest of the nation and its people," the CA ruling said.
