



### Cops in Espinosa jail raid charged with murder

Albuera Mayor Rolando Espinosa initially greeted the police team. Then he pleaded with them not to frame him: Moments later, the lights in his jail cell went out and gunshots were heard.

Yesterday, the National Bureau of Investigation (NBI) announced that Espinosa was executed by members of the police Criminal Investigation and Detection Group (CIDG) in Eastern Visayas who went to his jail cell ostensibly to search for guns and drugs.

"It was a rubout." NBI spokesman Ferdinand Lavin told reporters yesterday "There was criminal intent and a conspirary It was a premeditated killing the victims were helpless."

The NBI has filed murder charges against the CIDG team that served the search warrant on the mayor, who was then detained at the sub-provincial jail in Baybay, Leyte

The serving of the search warrant before dawn last Nov 5 resulted in an alleged exchange of gunfire and the death of Espinosa and another druglinked inmate, Raul Yap.

NBI assistant director for Eastern Visayas Rugy de Vera said based on statements of inmates at the jail's Cell 2, they heard Espinosa greeting the

police team from his cell, Cell 1, then pleading for his life and asking not to plant anything against him at around 3 a.m.

Cell 2 inmate Donald Palermo said moments before gunshots were heard from Cells 1 and 7, lights at Espinosa's cell were switched off by the policeman who shot him Palermo later identified the officer as Chief Insp. Leo Laraga

At the Senate hearing on Espinosa's killing, Laraga admitted that he fired shots at

Espinosa

Some policemen were also allegedly positioned in front of Cells 2 and 3 and signaled thumbs down, after which no more gunshots were heard.

NBI's De Vera added that based on the inmates' statements, before the shots were fired, some inmates were instructed to go out, with some going to the quarantine area, except for Yap, who was left inside Cell 7 and was later found dead

The investigator said based on the inmates' testimonies, a policeman wearing surgical gloves and holding an unidentified caliber weapon was seen entering the detention tacility after the gunshots, and no longer held any gun when he came out

" Jerry Abiera. NBI director in the Eastern Visayas region. maintained that the NBI's investigation found that only the policemen fired shots inside Espinosa's cell

Based on the sketch of Espinosa's detention cell, gunshots came from the entrance of the cell

Also, two bullet holes were found behind the place where Espinosa was supposedly killed

Abiera explained that one hole was found on the wall of Cell 1's comfort room, which was 3.15 meters away from where one gunshot came, and another was found on a wall near the double-deck bed, around 23 meters away from. Docil, SPO1 Mark Christian where another gunshot had originated \*\*\*

There were even hair strands on the hole near the double-deck," Abiera noted "Based on the bullet holes, it would be impossible that Espinosa fired a single shot "

Lavin added the NBI agents were never able to identify the types of guns used in the shooting and which Espinosa allegedly used, nor retrieve closed-rircuit television (CCTV) footage from inside the jail, since they went to the area four days atter the incident

Lavin, however, said there were no indications that the CCTV footage was tampered with

He said "the pieces of evidence, both forensic and testi-

NBI has a strong case.

The findings prompted the NBI to file multiple murder charges against Supt Marvin Marcos, relieved head of the Criminal Investigation and Detection Group (CIDG) in Eastern Visavas, and his 17 subordinates namely Laraga, Supt Santi Noel Matira, police Senior Inspectors Deogracia Diaz and Fritz Blanco; Senior Police Officers (SPO) 4 Juanito

Duarte, Melvin Caboyit and Eric Constantino, SPO2 Benjamin Dacallos and Aphinor Serrano Ir, PO3 Johnny Ibanez, Lloyd Ortiguesa and Norman Abellanosa, PO2 Niel Centino, PO1 Bernard Orpilla and Jerlan Cabiyaan, civil officers Cristal Jane Briones and Divine Grace Songalia; as well as six members of the police Regional Maritime Unit - C/Insp. Calixto Cabillas, Insp. Lucresito Candelosas. SPO2 Antonio Cadilo and PO2 John Ruel Doculan and Jaime Bacsal

Marcos and his men served the search warrant against Espinosa for illegal possession of firearms and against Yap for possession of illegal drugs

Lavin said charges of malicious procurement of search warrant would be filed against Laraga and Abellanosa, who had applied for the warrant, and perjury charges against Paul Olendan, who testified for the application of the document.

The charges were filed before the Department of Justice (DOJ) at 4 p.m. last Friday, Lavin said.

### **Duterte to critics:** Don't question my decision on Marcos

President Duterte has asked his critics not to question his decision to reinstate CIDG's Marcos, who was relieved after he was accused of being involved in the narcotics trade

Duterte stressed that as president, he has control over the executive department

"I do not have to explain to you, the whole Republic of the Philippines and the critics, why I made the order for him just to sit down and do not remove him Well, actually, Marcos was eventually removed I said place him there, there is a purpose. I said 'Do not ask questions," the President said during the lighting of a 12-toot Christmas tree in Malacañang last Sunday.

"When there is absolute control and supervision, I can modify and mend, revoke any order in this executive department," he added

Marcos' unit was tagged in the death of Espinosa, who was one of the politicians with alleged ties to illegal drugs.

Marcos' subordinates claimed that Espinosa was shot dead inside his cell at the

The party of the same Baybay City sub-provincial in danger, kill them. And that is jail while resisting arrest. But the statement was contradicted by testimonies of some jail officers and inmates and some photos, creating suspicions that Espinosa might have been a rubout victim.

Espinosa's son and suspected drug lord Kerwin has accused Marcos of receiving millions from him.

Despite accusations that he was involved in illegal drugs, Marcos was reinstated to his post supposedly "for humanitarian reasons."

Philippine National Police chief Director General Ronald dela Rosa claimed that a friend had called him to request the reinstatement of Marcos

Duterte eventually admitted that he was the one who asked Dela Rosa to reinstate Marcos, which was before the Nov. 5 incident.

Last Saturday, Sen. Leila de Lima said the President could be the top drug coddler in the country because he reinstated a police official with supposed ties to drug lords.

Duterte denied the allegation and maintained that his brutal drive against drugs would continue

"So, they are questioning my motive. Now, they are assuming that maybe I knew about the operation then now they claimed I was the one who ordered (the killing of Espinosa) inside (his prison cell)," he said

"Whatever the reason, that's my discretion. I promise the police and the military: do your duty, go out and find these criminals, arrest them if possible But if they offer violent resistance, and you think that your life is my order until now."

### **Gag order** on local media

The Regional Trial Court judge who heard the case against Espinosa's contact in Iligan City in 2014 issued a gag order on local media at the time, it was learned yesterday

The judge had also detained a lawyer-radio commentator, who was cited for contempt, for three days, sources said

Local police records showed that in 2014, Espinosa's contact. Lovely Impal, was arrested when she claimed a package from forwarder LBC.

Agents from the Philippine Drug Enforcement Agency who had prior intelligence information about the package, arrested her. The package allegedly turned out to contain some three kilos of shabu.

A case was filed in court, but was eventually dismissed.

When the case was being heard in court, judge Arthur Abundiente issued a gag order on local media because some radio commentators commented on the case.

A lawyer-radio commentator identified as Rejoice Subejano was cited for contempt and imprisoned for three days.

Former congressman Vicente Belmonte, then chairman of the House committee on dangerous drugs, asked for a review of the case after its dismissal.

Impal reportedly surrendered recently to authorities in the Autonomous Region in Muslim Mindanao and was brought to PNF chief Dela Rosa. - With A exis Romero, Lino de la Cruz

# NBI: Espinosa rubbed out

24 CIDG, Maritime cops conspired to murder Albuera mayor

Ibuera, Leyte Mayor Rolando
Espinosa was a victim of rubout
and not a shootout, the National
Bureau of Investigation (NBI)
said vesterday

With the findings of criminal intent and conspiracy, the NBI recommended to the Department of Justice (DOJ) the filing of multiple murder and perjury charges against 18 Philippine National Police-Criminal Investigation and Detection Group (PNP-CIDG) police officers and six officers from the PNP Regional Maritime Unit 8 involved in serving a search warrant that led to the killing of Espinosa inside the Leyte sub-provincial jail in Baybay City last November 5.

"It was a rubout We believed that there is a criminal intent. There was a conspiracy behind it," NBI spokesman.

## BI: Espinosa rubbed out

Ferdinand Laym said during a press briefing vesterday

"The pieces of evidence and the forensic examinations conducted bythe NBI had matched. We have a strong... case," Lavin added

 Facing multiple murder are CIDG Region 8 chief Superintendent Marvin Marcos, Superintendent Noel Matira, Chief Inspector Leo Laraga, Senior Inspectors Deogracia Diaz and Fritz Blanco, Senior Police Officers Melvin Cayobit, Eric Constantino, Benjamin Dacallos, Juanito Duarte and Alphinor Serrano Jr, police officers Johnny Ibanez, Norman Abellanosa, NielCentino, Bernard Orpilla, Lloyd Ortiguesa, Jerlan Cabiyaan, Cristal Gisma and Divine Grace Songalia Likewise facing the same charges are PNP Regional Maritime Unit 8 personnel Chief Inspector Calixto Canillas Jr., Inspector Lucresito Candelosas, and police officers Antonio Docil, Mark Cadilo, John RuelDaculan, and Jaime Bacsal

Perjury charges

Laraga, Abellanosa, and Paul Olenadan are also facing perjury charges for

allegedly lying under oath during court proceedings for the issuance of a search warrant.

The NBI debunked all of Olendan's claim.

Olendan had testified that he saw Espinosa holding a gun while sitting on his bed, and Raul Yap repacking shabu at cell No 2 on October 28, 2016 Yap was likewise killed

An "OplanGalugad" on the cells was conducted on Oct. 30, 2016, which yielded nothing but cell phones from the cells

"It was, therefore, impossible for Espinosa and Yap to possess these firearras and illegal drugs inside their respective cells on the night of the supposed implementation of the search warrants," the NBI stated.

The NBI further said that the application for search warrant was maliciously obtained by the applicants since the deponent's affidavit was perjured

The NBI found out that Olendan's claim that he entered the Levte-subprovincial jail never took place on Oct 28, 2016.

The supervisor and co-workers of Olendan at the Leyte National High

School testified before NBI agents that on the day Olendan allegedly saw Espinosa and Yap, he had reported for work that whole day. His daily time record and raw data of biometric also revealed the same

Other inmates also claimed that Yap had never, even once, left his cell to go to cell No. 2 to repack shabu.

#### No shootout

Based on the findings revealed by NBI Region 8 Director Jerry Abiera, the bursts of gunfire heard in the early morning of November 5 emanating from the cell No. 1. where Espinosa was detained. was not due to a shootout.

Abiera said an inmate, Donald Palermo, who was at cell No. 2, told NBI agents that police officers, prior to the killing, entered the cell of Espinosa. turned off the lights, and then "simultaneously gunshots followed."

The NBI investigation also revealed that a police officer was seen positioned OFF near the cell No. 2 and No. 3, and giving a thumb-down signal to other operatives after the bursts of gunfire.

the operatives were standing."

NBI agents elaborated that if Espinosa initiated a shootout, he could have fired toward the door.

Police claimed that upon entering the cell, Espinosa fired shots at the operatives.

But NBI findings showed that it was impossible for Espinosa to retaliate by firing at the walls away from the police officers.

"Because he knew his cell, he could have known where to fire his shots if he retaliated," Lavin said.

Bullet hole No.1 was seen on the left side wall of the cell which is 2.30 meters away from the door. While another bullet hole (No.2) was seen near the comfort room at the back portion of the cell.

It was also disclosed that a hair strand of Espinosa was found on the bullet holeNo. 1.

Abiera further disclosed that the bullet wounds on Espinosa's body wasfired within a seven-inch distance.

since he promised he will make himself available we will just allow him to go back home," Lacson added.

The senator said Dayan was escorted back to Pangasinan, together with his wife and children who were also at the Senate

"We advised him to compose himself, to rest his mind so that he can remember the things he's supposed to remember. I think that's the proper approach to help reboot his memory because it's clear he is getting confused," Lacson told reporters.

He said Dayan wanted to say a lot of things during Monday's proceedings but he had no opportunity to do it.

"If there would be another hearing, I'm sure he would reveal some more information," the senator said.

Lacson said they are convinced that Dayan is having a hard time recollecting the transactions and activities he had with de Lima when he was still working under the former Department of Justice (DOJ) secretary.

Both De Lima and Dayan have admitted they were in a relationship for seven vears.

After a briefing with him last night at the Office of Sen (Vicente) Sotto III with (Sen Gringo) Honasan, we agreed that, At the fourth hearing into the Eschance to testify before the Senate and face off with Kerwin to whom he collected the Psmillion in protection money and campaign funds for De Lima

After insisting the exchange of money happened in 2014, Dayan was forced to agree with Kerwin's testimony it transpired in 2015, after he was shown a photo of De Lima together with the younger Espinosa and his wife taken on Nov 19, 2015 that was uploaded on Facebook

"I think he's so tired I think in due time he'll be able to recollect . I hope after having fully rested marami pa siyang ma-recall," he said

Asked if Dayan can recall if he and Do Lima went to Levte during those times to campaign, Lacson said the witness said ves.

## RIT gunmen kill Army officer, 4 drug suspects

MOTORCYCLE-RHDING gunmen killed a retired Army officer and four drug suspects in separate shooting incidents Monday and yesterday in Pasay and Makati cities.

Killed were retired Army
Lt Reynaldo Ferrer, 61, of
Corregidor St. Bgy Guadalupe Nuevo, Ace and
Randy Goroyon, both 18, of
Bgy San Isidro both in
Makati City, Christopher
Dalantan, 31, tricycle driver and Leonora Donina,
52, of 2297, FB Harrison
St., Bgy 13, both of Pasay
City

Police said Ferrer died
while being treated at Saint
Luke's in Bonifacio Global
City due to two cal 45
bullet wounds. The gunmen
quickly escaped after the
incident

SPO2 Rico Caramat,

officer-on-case, said the incident took place at 11.38 a.m. at the corner of Urdaneta Street and Magraysay Avenue. Bgy Guadalupe Nuevo

Police said the victim was standing on the adewalk when a gunnain suddeudly appeared and shot him at close range

The gunman then run towards a waiting motorcycle and sped away Police said the killing

Police said the killing could be related to the victim's security agency business but refused to give details.

Earlier at 1 a.m., Ace and Randy, who were both on the police drug watchlist, were shot dead on Rocyfeller St., Bgy San Isidro, by four alleged members of the Deadly Death Squad (DDS) riding on two maturewise

riding on two motorcycles. The victims' head and bodies were riddled with bullets. Police recovered 20 empty shells for unknown

caliber of gun at the scene
Witnesses told police
that the victims were just
standing or the sidewalk
when the suspects came and
for no apparent reason fired
at them successively, then
sped away

Relatives of the victims, who admitted that both were using drugs, rished them to San Juan de Dios Hospital where they were declared dead on arrival

At 8:30 pm Monday, Dalantar was shot dead at the corner of Chico and Guyabano Sts in Pasay City

Police said Dalantar suffered gunshot wounds in the head and body

Residents in the area told police that they heard six successive gunshots and when they checked, they found Dalantur sprawled dead in a pool of his own blood on the ground

Evelyn Viscarrabago, mother of the victim, told golice that her son, who already surrendered to the police "Oplan Tokhang," was fetched from their house by a certain Nike and John for still unclear reasons

Earlier at 2:20 p.m. police said Donina, an alleged drug pusher, was shot in the head at close range by DDS gunmen in front of s convenience store at the corner of FB Harrison and Arnaiz (former Libertad) Avenue, Pasay City.

Donina was declared dead on arrival at Pasay City General Hospital.

Domingo, husband of the victim, told police that they were talking to a friend, Fernando Salazar, when the suspects arrived

He said the back rider alighted, approached his wife from behind and shot her He added that the suspects sped away after the shooting incident.

## Army ranger killed in clash with Maute group

ZAMBOANGA CTTY – An Army ranger was killed in a firefight with around 20 members of the Maute group on Monday afternoon.

Maj Filemon Tan Jr., spokesman for the Western Mindanao Command, said the soldier was the lone fatality from government forces since the clashes started last week.

Tan said 38 soldiers were wounded while 63 were killed and 17 wounded from the Maute group as of yesterday.

A police commando was wounded when the militants fired at police and

military personnel during a raid on the house of Farhana Maute, mother of the leaders of the Maute group, at around 1.30 a.m. yesterday

War materials and explosives were reportedly seized from the house.

Meanwhile, security sources said Abdullah Makaapar, alias Commander Bravo, former commander of the Moro Islamic Liberation Front 102nd base command, and his followers were monitored to have visited the camp of the Maute group in Butig on several occassions.

## AFP chief retires today; successor still unnamed

GEN. Ricardo Visaya is stepping down today as chief of the Armed Forces but Malacañang still has not announced his successor as of press time yesterday.

President Duterte will lead the turnover rites at the AFP's general headquarters in Camp Aguinaldo.

Among the reported top contenders are Army chief Lt. Gen. Eduardo Año, Eastern Mindanao Command chief Lt. Gen. Rey Leonardo Guerrero, and AFP vice chief Lt. Gen. Glorioso Miranda.

Año and Miranda are class-

mates of Visaya at the Philippine Military Academy Class of 1983 while Guerrero is from the PMA Class 1984.

Visaya is retiring a day ahead of the mandatory retirement age of 56.

The first AFP chief to serve during the Duterte administration, Visaya assumed command last July 1.

It is not the first time an incoming AFP chief remained unknown a day prior to his assumption. Gen. Hernando Iriberri's appointment as military chief was announced on the turnover day itself. Iriberri assumed the post of as AFP chief in July 2015 and

retired last April.

"As in previous changes in the AFP leadership, announcements are usually made at the last hour and adds to the anticipation and excitement of all our men and women in the AFP," said AFP spokesman Brig. Gen. Restituto Padilla

Visaya's designation as AFP chief was announced by the camp of Duterte a few weeks prior to his assumption of the presidency on June 30.

All the 10 three-star generals and flag officers of the Armed Forces are qualified to succeed Visaya, the military said.

# Troops recover gun, explosives from Maute mother's house

oint law enforcement operations launched early Tuesday morning by the military and police against the mother of the Maute brothers, leaders of a terrorist bearing their name, led to the recovery of a firearm and several war and explosive materials in Butig, Lanao del Sur.

According to Maj. Filemon I. Tan Jr., spokesman of the Armed Forces of the Philippines (AFP) Western Mindanao Command (WestMinCom), members of the Regional Public Safety Battalion (RPSB), the Criminal Investigation and Detection Group (CIDG) of the Philippine National Police (PNP), and supported by the 65th Infantry Battalion under the

Joint Task Force ZamPeLan, served a search warrant on Farhana Maute

Tan said the government team encountered stiff resistance from an armed group posted at Farhana's residence that resulted in the wounding of a policeman

The military report did not say if Farhana was at the residence when the search warrant was served.

The operation led to the recovery of a firearm and several war and explosive materials from the side of the enemy

On Monday soldiers from the First Scout Ranger Company, while conducting combat operations, engaged about 20 members of a local terrorist group. Tan said soldier was killed in the encounter that erupted at 1 p.m. Government troops were able to recover an rocket propelled grenade (RPG) launcher, several RPG ammunition, and a steel chainsaw.

The body of the slain soldier was brought to the 103rd Brigade Tactical Command Post and will later be transported to St Peter Funeral Homes.

As of 7 a.m. yesterday, Tan said fire missions were delivered to enemy locations.

So far, 63 terrorists have been killed, and 17 wounded, as against the government side which suffered one casualty and 38 wounded-in-action

Tan said the military continues to intensify the conduct of focused military operations to neutralize members of the lawless terrorist group.

# Firearms found in house of Maute brods' mom

Several firearms as well as war and explosive materials were discovered inside the house of Farhana Maute, mother of two notorious bandits, during a raid by a joint military and police operation.

According to Army Major Filemon I. Tan Jr., the spokesman of the Armed Forces of the Philippines (AFP) Western Mindanao Command (WestMinCom), soldiers and policemen recovered two homemade bombs and other firearms as well as vital documents that will prove the terror

activities of the Maute Group.

Farhana is reportedly a chief financier of the terror group headed by his sons Abdul and Omar.

The Maute matriarch is known in their community as a former government contractor who was wealthy enough to send his children to the Middle East for their education.

The move however was believed to have led the Abdul and Omar to be radicalized and form the bandit group.

The town of Butig was freed from the control of the Maute group after several days of constant attacks and bombardment by the military last week, leaving part of the town in rubble because of mortar fire.

More than 2,000 families fled their homes following the series of fighting between the terrorists and the government troopers.

An estimated 62 Maute group members have been killed while 37 troopers have been wounded in the military operation against the radical group.

Butig has been cleared of all Maute group elements Wednesday but civilians are not yet allowed to return as the area is still being cleared of improvised explosive devices and other traps laid by the bandits.

Troop slain in intensified ops vs Maute

The military suffered its first fatality in the ongoing operation against the Maute group in Lanao del Sur after elements of the elite Scout Ranger caught up with a terrorist band in Butig town on Monday afternoon, reports said yesterday. The killing of a member of the Army's elite 1st Scout Ranger Company (SRC) happened a day after the Armed Forces of the Philippines leadership declared it has regain 100 percent control of Butig after more than a week of intensified assault against the Maute group. The identity of the stain Ranger was not made available. He was the first fatality suffered by the military after the launching of intensified combat operations against the homegrown terror group. Maj. Filemon Tan Jr., spokesman for the Western Mindanao Command, said that elements of the 1st SRC were conducting combat operations at around 1 p.m. when they were engaged by more or less 20 members of the Maute group in Butig. Relatedly, various war and explosive materials were seized by combat police and military operatives during a raid at the house of Farhana Maute, mother of Omar and Abdullah Maute who are the leaders of the Maute terror group in Lanao del Sur. Armed with a search warrant, combined elements of the Army's 65th Infantry Battalion, Regional Public Safety Battalion, Criminal Investigation and Detection Group and Joint Task Force Zampelan raided the house of Farhana in Butig at around 1:30 a.m. yesterday. The raid led to a brief firefight that resulted in the wounding of one policeman, whose identity was not revealed. Seized from the house were two 81 mm mortar ammo, high explosive with fuse, tail and pin and a shot gun. Mario J. Mallari

## Rody on communist prisoners: No ceasefire, no release

President Duterte has instructed government peace panel chairman Silvestre Bello III to secure a ceasefire deal with the National Democratic Front (NDF) before he orders the release of detained communist rebels.

"Produce to me a signed bilateral ceasefire agreement and I will release them within 48 hours. You can take my word for it," Bello said in a statement vesterday, quoting Duterte

"The President told us that once he

receives even just a facsimile copy of the signed agreement, he would immediately order the release of communist rebels," added Bello, who is also labor secretary.

Duterte made a campaign promise to reopen peace negotiations with the NDF, which is representing the Communist Party of the Philippines (CPP) and its armed wing, the New People's Army (NPA)

Bello and panel member Angela Librade-Trinidad sought instructions from

The NDF said 454 rebels are still being held in different detention centers all over the country.

"Lest the government's use of the political prisoners as trump

cards in the peace process will be seen as its vile attempt to set the stage to renege on its commitments and obligations, they should release all of them now

"Office of the Presidential Adviser on the Peace Process Secretary Jesus Dureza said that President Duterte has walked the 'extra mile' on the peace process, unlike past administrations which didn't even move an inch to comply with their commitments and obligations Sadly, Dureza and the government can't keep up with the pace and thus seems to be stalling both parties' peace efforts," she added.

Karapatan pointed out that the government under the Duterte administration upheld all previously signed agreements, including the Comprehensive Agreement on the Respect for Human Rights and International Humanitarian Law, which explicitly states the obligation of the government to uphold the rights of citizens against unwarranted and unjustified arrest and detention and to correct the injustice against them

"We also remind President Duterte and Secretary Dureza that peace efforts, specifically on the release of political prisoners, are not charity cases. It is an immediate obligation to render justice to the political prisoners by releasing them. So while President Duterte has taken bold steps to pursue peace talks with the NDF, these steps won't become significant if his people are taking their sweet time," Palabay said.

Both the government and the NDF have declared their own unilateral ceasefires, but the two camps are complaining about reported violations in the field.

For Bello, until both panels agree to a set of guidelines, "there are technically no violations."

He said it is to the best interest of combatants from both sides, specially the civilians caught in the middle of the armed conflict, that a "formal ceasefire is in place so that we can monitor any claims of violations." – With Rhodina Villanueva, Perseus Echeminada


"In course of the meeting, [Deputy Defence Minister Anatoly Antonov] Anatoly Antonov noted that Russia and Philippines were facing common threats, main of which was international terrorism. He also informed Rodrigo Roa Duterte about fighting of the Russian Armed Forces against terrorism in Syria," it added.

During the meeting both parties confirmed that development of military cooperation between the countries is to promote strengthening of security in the Asia-Pacific region.

SULTAN KUDARAT, Philippines — The Philippine Marine Corps on Sunday has augmented its forces securing coastal towns in Sultan Kudarat and Maguindanao provinces with an additional battalion to help local authorities address fanatical Islamic militants.

The 2nd Marine Battalion, comprised of more than 500 Marines, was welcomed on Sunday by residents of Kalamansig town led by Mayor Ronan Garcia.

The unit will join four other battalions under the 2nd Marine Brigade based in nearby Lebak town also in Sultan Kudarat.

Gen. Alvin Parreño, brigade commander, was also present in the welcome honors that local officials extended to the Marines.

Parreño said the battalion will be engaged in peace-building and humanitarian activities while also performing security duties in local communities.

The Marines are popular in Central Mindanao for having driven away more than a hundred Khilafa Islamiya militants from Palimbang, Sultan Kudarat in late 2015.

That operation resulted in the deaths of seven jihadists and the restoration of government control over their enclave.

The outlawed Khilafa Islamiya used the black flag of the Independent State of Iraq and Syria while it operated a "shadow government" from its camp southwest of Palimbang.

## Maute group taking refuge near MILF areas in Butig

The Moro Islamic Liberation Front (MILF) has expressed "concern" that the military offensive against the Maute group in Butig, Lanao Del Sur has gotten dangerously too close to its camps inside the town.

"That is a concern," chief MILF peace negotiator Mohagher Iqbal told Rappler. MILF has several camps in the town where the local terror group inspired by the Islamic State (ISIS) raised the black flag of the global terror group.

The military claims the members of the Maute group have been attempting to take refuge near MILF areas to take advantage of the peace process, confident that the military will not attack MILF areas.

"We saw that. They feel safe. Baka hindi namin galawin (They think we will not touch them) because of the peace process. Maaring ganoon (It is possible). Gusto nila (They want to) drag [the] group na yun sa gulo na 'to (in the clashes)," said Colonel Rosseler Murillo, ground commander in Butig.

The MILF concern was raised on Saturday's (December 3) special session of the Municipal Peace and Order Council (MPOC), that gathered the town's residents. A local official sent by Butig Mayor Dimnatang Pansar to talk to the MILF relayed their concerns.

"Medyo malapit na bomba kagabi. Huwag masyado ilapit sa kanila. Pinakita nila sa akin mga tumama (The bombs were dropped their areas. It should not be too close. They showed me where they hit)," the emissary reported during the special session.

The International Monitoring Team (IMT), a mechanism under the peace process, sent its monitors to Butig the following day to check the situation.

### Mistrust vs MILF

Some of the residents present at the special session claim some MILF members are helping the Maute. A resident complained how the MILF had prior knowledge about the military offensive against the Maute, citing how one of its members announced details of the attack on the radio.

Iqbal maintained that MILF commanders are not involved, but he cannot give an assurance that all their members have stayed away from the clashes.

"Commanders none. Elements, I don't know," Iqbal told Rappler. "Of course, we are not allowig our members to join the Maute group," he said.

The situation highlights the complicated situation in Butig, where most of the residents are relatives but are members of different groups. Blood ties may prevail when clashes erupt.



The MILF also asked the military not to pounce on houses in barangay Sandeb, where many of its members reside, especially when they are not meeting resistance there.

Murillo sought the assistance of the residents to guarantee that Maute members have not taken refuge in the barangay.


"Ang request ng Sandeb, huwag tirahin. Pero kung may magbabaril sa Sandeb, pwede. So siguraduhin natin na wala. Kailangan namin tulong niyo," said Murillo. (Sandeb is requesting that we don't hit the barangay. But if we are fired upon, we can respond. So let's make sure that there will be no resistance. We need your help.)

### PNP, AFP raid Maute compound in Marawi City

MANILA, Philippines (2nd UPDATE) – The Maute compound in Marawi City was raided Tuesday morning, December 6, as troops continued pursuit operations against the leaders of the local terrorist group that has pledged allegiance to the Islamic State (ISIS).

One Special Action Force (SAF) trooper was wounded in the joint operation of the police and military.

The military's 65th Infantry Battalion, and the Autonomous Region in Muslim Mindanao (ARMM) Police Regional Office's Regional Public Safety Battalion (RPSB) and Criminal and Investigation Detection Group (CIDG) implemented search warrants against several members of the Maute family.

Search warrants for the violation of the country's firearms and illegal drugs laws were issued by a Maguindanao court against the homes of Farhana R. Maute, Abdullah R. Maute, Mohammad Khayam, Abdulrhaman R. Maute, Mahater R. Maute, Abdul Azis R. Maute, Hamsa R. Maute and Mahater R. Maute.

By 2:15 in the morning, government forces "dominated the area of operation and immobilized all persons inside the target houses without any resistance," according to a report from the Philippine National Police (PNP) Special Action Force (SAF), which provided tactical support for the operation.

One SAF trooper, PO2 Rolando Redondo of the 103rd Special Action Company, was injured when an improved explosive device set off at target 4 of the area. He was brought to an Army ambulance right away.

Government forces also recovered the following: two 81-mm mortar cartridges and a Romeo-Suarez shotgun.

The Maute brothers – Omar and Abdullah – grew up in Marawi City. The town of Butig in Lanao del Sur, where they camped out and recruited locals to their organization, is the hometown of their mother. It is less than 2 hours away by land from the city.

Clashes first erupted between the military and the Maute group in February this year, prompting the local government to abandon the municipal hall and hold office at the neary building of the National Irrigation

Authority. The military launched a massive offensive against the group in late November, that killed 49 alleged Maute group members and wounded 21 soldiers.

The terrorists have since retreated, occupying areas close to the camps of the Moro Islamic Liberation Front (MILF) in Butig. This prompted the MILF to raise concern.

The military claims the members of the Maute group have been attempting to take refuge near MILF areas to take advantage of the peace process, confident that the military will not attack MILF camps. But some residents said they suspect MILF members are coddling Maute members. — Carmela Fonbuena/Rappler.com

# Trooper killed in offensive vs Maute Group in Lanao del Sur

A trooper was killed following an encounter with an estimated 20 members of the Maute Group in Lanao Del Sur Monday afternoon, Western Mindanao Command Spokesperson Major Filemon Tan said.

During the firefight, Tan said one soldier from the 1st Scout Ranger Company was killed while an undetermined number of terrorists were killed or wounded.

Government forces continue to pursue the Maute Group for its attack on Butig which started Nov. 26. A six-day military offensive drove the terrorists from the town Dec. 1.

Tan said troops recovered a rocket-propelled grenade, an undetermined number of RPG munition, and a steel chainsaw.

"As of Dec. 6, 7 a.m., fire missions were delivered to enemy locations. The enemy has, to date, incurred 63 killed and 17 wounded, while the troops suffered one killed and 38 wounded in action," he added.

In a related development, a firearm, assorted war and explosive materials were seized by joint police and military operations against Farhana Maute, the mother of the founder of the Maute Group, during operations in Butig town, Lanao Del Sur 1:30 a.m. Tuesday.

Tan said the Regional Public Safety Battalion and the Criminal Investigation and Detection Group supported by the 65th Infantry Battalion under the Joint Task Force ZamPeLan participated in the operation.

An armed confrontation ensued, resulting in the wounding of a police officer, while undetermined on the enemy, he added.

## Soldier slain in clash with Maute Group

MANILA, Philippines -- A soldier was killed in a clash with suspected members of the Maute Group in Lanao Del Sur Monday afternoon, Western Mindanao Command Spokesperson Major Filemon Tan said.

Aside from the slain member of the 1st Scout Ranger Company, Tan said an undetermined number of the gunmen were also killed or wounded.

The clash happened as government forces continue to pursue the Maute Group after dislodging the extremists from the town of Butig following a weeklong offensive.

"As of December 6, 7 a.m., fire missions were delivered to enemy locations. The enemy has, to date, incurred 63 killed and 17 wounded, while the troops suffered one killed and 38 wounded in action," Tan said.

Meanwhile a police officer was wounded in a firefight during a joint operation on the home of Farhana Maute, mother of Maute Group's founder, in Butig early Tuesday morning.

## President Duterte sets conditions for release of political prisoners

President Rodrigo Duterte has said he will only order the release of 130 political prisoners if the government peace panel and the National Democratic Front (NDF) sign a bilateral ceasefire deal during talks in Oslo,

Norway this week.

"Produce to me a signed bilateral ceasefire agreement and I will release them within 48 hours. You can take my word for it," Government peace negotiator Silvestre Bello III quoted the president as saying. In a press statement released by the Office of the Presidential Adviser on the Peace Process (OPAPP) Tuesday, the president (said) the government has already conceded far enough to the NDF. But he also promised to release a number of elderly and sick detained rebels before Christmas Day.

"The president told us that once he receives even just a facsimile copy of the signed agreement, he will

immediately order the release of communist rebels," Bello said.

Bello sought instructions from Malacanang after the president met with top rebel leaders Benito and William Tiamzon in Davao City on Friday evening.

In that meeting, the president said he would keep his campaign promise to release detained communist rebels.

The president, however, gave his latest instructions during the break of the cabinet meeting at the Palace

Monday evening. The government panel holding peace talks with the NDF has submitted a list of 200 prisoners who are eligible for release under the new guidelines of the Presidential Committee on Bail, Recognizance and Parole

(PCBREP).

Twenty-five (25) of them are elderly, sick and women. The NDF claimed 434 rebels are still being held in different detentions all over the country.

Four rebels convicted for murder and kidnapping were already given presidential pardon as announced by the Secretary Bello Friday last week.

They were identified as Martin Villanueva, Bonifacio Suyon, Dindo Absalon and Rico Bodina.

They have served sentence ranging from 18 to 26 years. All are farmers.

Although both the government and the NDF have declared their own unilateral ceasefires, the two camps have been complaining of reports of violations from the field.

But Bello said until both panels agree to a set of guidelines, "there are technically no violations."

The labor secretary said it is to the best interest of combatants from both sides and especially the civilians caught in the middle of the armed conflict that a "formal ceasefire is in place so that we can monitor any claims of violations."

"Remember, one life saved is one more happy family," the government chief negotiator said.

During the formal opening round of the peace negotiations, both the GRP and NDF panels agreed to submit drafts on bilateral ceasefire. But the NDF later said the ceasefire is tied to the release of 'political prisoners'. President Duterte earlier ordered the release of 21 rebel leaders who are now acting as consultants of the NDF panel holding peace talks with the government.

The president made a campaign promise to reopen peace negotiations with the NDF, which is representing the

Communist Party of the Philippines (CPP) and its armed wing the New People's Army (NPA).

The Philippine government and the NDF will resume formal peace talks in January, possibly in Rome, Italy. "The weather is a bit better in Rome than in Oslo, Norway," Bello cited the reason for the change of talks' venue. The first two rounds of formal peace negotiations with the NDF under the Duterte administration were held in Norway whose government is facilitating the talks to put an end to nearly 50 years of armed rebellion in the Philippines.

The guerrilla war being waged by the CPP-NPA-NDF is now Asia's longest running active insurgency

movement.

# No bilateral ceasefire, no release of political prisoners — Duterte

There will be no release of a substantial number of detained communist rebels unless a bilateral ceasefire agreement with the National Democratic Front of the Philippines, President Rodrigo R. Duterte said. "Produce to me a signed bilateral ceasefire agreement and I will release them within 48 hours. You can take my word for it," a press release from the Office of the Presidential Adviser on the Peace Process quoted the president as having instructed government (GRP) peace panel chair Silvestre Bello III and panel member Angela Librado-Trinidad.

But the president vowed to work on the release of a number of elderly and sick political prisoners before Christmas Day.

In an interview last Sunday, Anakpawis Rep.. Ariel Casilao he said some 165 political prisoners, of whom 25 are elderly and 140 are sickly, will be released before Christmas Day.

"The president told us that once he receives even just a facsimile copy of the signed agreement, he will immediately order the release of communist rebels," Bello said.

Bello and Librado sought instructions from Duterte after he met with NDFP consultants Benito and William Tiamzon here Friday evening where the president reaffirmed his promise to release political prisoners. The OPAPP press release said about 20 prisoners are eligible for release under the new guidelines of the Presidential Committee on Bail, Recognizance and Parole.

The NDFP claimed that 434 political prisoners are still being held in different detentions all over the country. Last December 2, the OPAPP announced that Duterte had signed an order granting pardon to four rebels convicted for murder and kidnapping.

They were identified as Martin Villanueva, Bonifacio Suyon, Dindo Absalon and Rico Bodina.

Villanueva and Suyon were convicted for kidnapping while Absalon and Bodino served time for murder,. The NDFP said they have already served at least 18 years.

"These rebels have long been recommended for pardon but the previous government did not sign the draft order to release them," Bello said.

The third round of formal peace negotiations will resume on the third week of January 2017 in a neutral venue. Presidential Adviser on Peace Process Jesus Dureza said he has reaffirmed the government's commitment to "walk the extra mile for peace" and assured that efforts have been undertaken for the release of the political prisoners.

But Dureza, in a statement, explained that necessary legal processes take time as the cases are within the jurisdiction of the judiciary which, he noted, is "an independent and co-equal branch."

"Earnest efforts have been ongoing on the releases of prisoners.... We understand their angst and impatience but we are all forgetting that these efforts were never possible nor even imaginable in the previous times," he

He said the Duterte administration has made the releases of political prisoners possible.

He added he is appalled by some sectors who criticized the GRP panel for "not delivering enough and for the perceived delay," although he said they serve as good reminders that they need to do more.

"But putting undue public pressure on the government which has already taken unprecedented steps may not yield their intended results. President Duterte has exercised bold political will to quickly resuscitate the peace process from where it was. And he does so also mindful that there is a need to balance things taking into account the processes that must be observed and the whole citizenry that he must also engage and serve," he said.
