





S destroyers sail close to Sino-held reefs

ANG KONG—US desmoyers ave sailed close to Chinese deld reefs and islands in the disputed South China Sea in recent weeks, US naval officials said on Thursday, patrols likely to fuel tensions ahead of an international court's ruling on Beijing's sweeping maritime claims.

The destroyers Stethem, Spruance and Momsen have been patroling near Chineseheld reefs in the Spratlys archipelago and Panatag (Scarborough) Shoal, which is near the Philippines, the officials said.

The patrols were first reported by the Washington-based Navy Times newspaper.

Pressure has been rising in the region ahead of a July 12 ruling by the United Nations Permanent Court of Arbitration on the dispute between China and the Philippines over the South China Sea in the Dutch city of The Hague.

China has refused to participate in the case and vowed to ignore the ruling, which the United States insists is binding and an important test of Beijing's willingness to adhere to international law.

While not close enough to be within 21.6 kilometers—a so-called freedom-of-navigation operation that would require high-level approval—the destroyers operated within 25.2 to 36 km of the Chinese-occupied features, the Navy Times reported.

US carrier patrol

The USS Ronald Reagan and its escort ships have also been patroling the South China Sea since last week.

Lt. Clint Ramsden, US Pacific Fleet spokesperson, said he could not go into operational or tactical details but that the patrols were part of a "routine presence."

"All of these patrols are conducted in accordance with international law and all are consistent with routine Pacific Fleet presence throughout the Western Pacific."

US Navy officials said Chinese naval ships, and sometimes fishing vessels, frequently track US ships in the South China Sea but it is not yet known if the presence of the destroyers attracted particular attention.

Manila is challenging the legality of Beijing's actions and claims to almost all of the South China Sea—the first legal case involving the South China Sea.

With legal experts expecting the ruling to go Manila's way, nullifying the basis for Beijing's territorial claims, US and other regional naval officials are

bracing for tensions in the weeks and months after the ruling.

Peaceful resolution sought

China frequently blames the United States for stirring up trouble in the South China Sea, where its territorial claims overlap in parts with Vietnam, the Philippines, Malaysia, Brunei and Taiwan.

Speaking in Beijing following a meeting with Chinese Foreign Minister Wang Yi on Thursday, UN Secretary General Ban Ki-moon said that while he could not comment on the Philippines' legal case, he called for a peaceful resolution of differences.


"I did stress to Minister Wang, as I have with all other countries involved, the need to resolve their differences in a peaceful manner and to avoid any escalation or misunderstandings that could put security and development in the region at risk," Ban said.

Forced arbitration

Wang repeated China's position that it also wanted a peaceful resolution, but that it could not accept forced arbitration.

"This approach will not help bring about a peaceful resolution of disputes. On the contrary, it would only escalate the disputes and tension and should be resisted by all countries and people who uphold justice," he said.

China has accused the United States of militarizing the waterway with freedom-of-navigation patrols, while Washington has expressed concern about China's building of military facilities on artificial islands it controls in the South China Sea.

US NAYY

In an editorial published on Wednesday, China's Communist Party newspaper People's Daily warned that there would be a "price to pay" if the United States crossed China's "bottom line" by meddling in the South China Sea disputes.

"If the United States, regardless of the cost, chooses the path of brinkmanship' that pressures and in-

timidates others, there will be only one result, that is, that the US bears all the responsibility for possibly further heightening tensions in the South China Sea," the editorial said.

On Tuesday, Chinese state-run newspaper Global Times wrote in an editorial that China should prepare for military confrontation over the South China dispute, but foreign ministry spokesperson Hong Lei played down the comment on Wednesday, saying China was committed to peace.

Hong said China would work with Southeast Asian countries "to safeguard the peace and stability of the South China Sea."

US response

US officials say the US response should China stick to its vow to ignore the ruling could include stepped up freedom-of-navigation patrols close to Chinese-claimed islands in what is one of the world's busiest trade routes.

In a telephone call on Wednesday, Wang told US Secretary of State John Kerry that the United States should do nothing to harm China's sovereignty and security in the South China Sea.

China's foreign ministry said in a statement that Wang told Kerry, who initiated the phone call, that the United States should stick to its promises not to take sides in the dispute.

China hopes the United States "speaks and acts cautiously, and take no actions that harm China's sovereignty and security interests," the statement paraphrased Wang as saying.

Wang also said relations between China and the United States were generally on a sound track and that the two sides should further focus on cooperation while managing their differences.

Issues of mutual interest

The US state department confirmed that Kerry had spoken to Wang, without providing details.

"The two discussed issues of mutual interest. We are not going to get into the details on this private diplomatic conversation," said state department spokesperson Gabrielle Price.

US officials say they fear China may respond to the ruling by declaring an air defense identification zone in the South China Sea, as it did in the East China Sea in 2013, or by stepping up its building and fortification of artificial islands.

Ironclad commitment

On Wednesday, US Ambassador to the Philippines Philip Goldberg reiterated that the US commitment to stand side by side with the Philippines was "ironclad" and extended to bringing legal, diplomatic and peaceful resolution to the South China Sea dispute.

"As allies, we stand together whenever the other is threatened and we will always continue to do so," Goldberg said in a speech during the celebration of the 240th anniversary of US independence in Manila.

In an interview with reporters after his speech, Goldberg said that while the United States was neither a party nor an observer in the arbitration case, it supported the Philippines and hoped parties would abide by the arbitral tribunal's ruling.

"We hope that it's observed, because the rule of law ... is always the best way [to deal with sea disputes]," Goldberg said. Reports from Reuters and Estrella Torres . E.



After two meetings, President Duterte has had a change of heart and offered Vice President Leni Robredo a Cabinet post, as head of the Housing and Urban Development Coordinating Council (HUDCC).

He immediately got "yes" for an answer.

Justice Secretary Vitaliano Aguirre II announced in an early evening press conference at Malacañang that Duterte called the Vice President yesterday to offer her a Cabinet post to address "persistent questions" on whether Robredo would be part of the official family.

In a statement, Robredo welcomed the decision of Duterte to appoint her as HUDCC chairperson, saying this would enable her to serve Filipinos who do not have shelter and at the same time fulfill her promise to support those in the fringes of society.

While Duterte was on a live broadcast over government station PTV-4, he instructed his special assistant Vice President.

"He asked the Vice President if she would accept a Cabinet post, that of HUDCC. We did not hear the answer of the Vice President, but from the face of President Duterte, we knew that the Vice President accepted the offer," Aguirre said.

Duterte used the phone of Go during the call aired on PTV-4.

"Pwede ba housing, ma'am? Can you be the housing secretary? Tanggapin mo, ma'am?" the President was heard to have said.

"The executive secretary will hand you the appointment. Mahinto na ito (questions) ma'am, kai tanggapin mo kaya?"

Cabinet meeting on Monday. The date of her oath-taking, however, was not announced.

The HUDCC and other housing-related agencies were also given to former vice presidents: Jejomar Binay during the time of former president Benigno Aquino III, and Noli de Castro under the Arroyo administration.

"Many of the Cabinet members are happy (about) the development. At last the Vice President is no longer an elected officer without a Cabinet

post," Aguirre said.

He attributed the change of heart to the two "amiable" meetings that Duterte and Robredo had – first at the change of command ceremony at the Armed Forces of the Philippines in Camp Aguinaldo, Quezon City on July 1 and then at the Palace where the Vice President paid a courtesy call on Duterte on Monday.

Reminded that Duterte was previously opposed to Robredo's appointment to the Cabinet because of his closeness to former senator Ferdinand Marcos Jr., who was Robredo's closest opponent in the vice presidential race, Aguirre said "it was a reason given by the President at that time."

"With the passage of time, there must have been a reconsideration of that decision,"

Aguirre added.

Reacting to her appointment, Robredo noted that addressing the problems concerning lack of housing had been an advocacy of her late husband, former interior sec-. retary Jesse Robredo.

"Maisasakatuparan ito at mabibiyayaan ang mga nasa laylayan sa pakikipagtulungan ng lahat (We will be able to fulfill this and help those who are in the fringes with the help of everyone)," she added.

Following their first meeting, Robredo said she was no longer expecting an offer of a Cabinet post from the President.

"I am ready that I won't have a post. In fact, we already have a lot of discussions with the private sector," she said in Naga City on Saturday.

She said it would be a bonus if given a Cabinet post, "but if there won't be, we are also

ready."

On Tuesday, Robredo said she informed the President during her courtesy call that he would get her full support with or without a Cabinet post.

Against death penalty but for federalism

Earlier in the day in Marawi City, Robredo said she was against the revival of the death penalty being pushed by Duterte but stressed that any disagreement with the policies of the current administration would not affect her support for the President.

"Ever since, I have been an advocate against death pen-

alty," she stressed.

But Robredo said she was open to the proposal to change the system of government to federalism, noting that her late husband was an advocate for were initiated in the province local autonomy.

However, the Vice President said some questions about the

proposal must be answered, particularly on the readiness of some regions to stand on

"A lot of municipalities are heavily dependent on IRA (Internal Revenue Allotment). The locally generated funds are small. I want to know how will that be resolved," she said.

"The benefits that Lanao del Sur has received in the past five years, we can expect that (to continue) at least in the next three years," she said in Filipino.

"The challenge to our local officials is how to maximize those that we receive," she

added.

Paying homage to Aquino, Robredo said a lot of projects during the past administra-

"There is no reason for us not to expect (that progress will continue) because the new president is from Mindanao,"

she added.

The Vice President went to Marawi City to lead the ceremonial oath taking of local officials and attend the celebration of 57th Araw ng Lanao.

It was the first trip of Robredo to Mindanao following her assumption of the second highest post in the land.

She thanked her supporter for helping her win in the prov ince in the recent elections.

The office of the Vice Pres dent is always here to suppor you," she said, expressing cor fidence that the local leade: would work together for th benefit of the people.

"I will never forget th when I was in need, you we there to support me," sl added. "We will pay it off wi service that you will not l ashamed of. You will not regi that you chose me."

Top drug traders operating from jail'

Top drug traders

In a Malacañang briefing aired over the government-owned People's Television network, Duterte named Wu Tuan alias Peter Co, Peter Lim alias Jaguar, and Herbert Colangco alias Ampang as leaders of big drug syndicates operating in the Philippines:

Co and Colangco are in jail and allegedly directing illegal drug operations from the New Bilibid Prison, while Lim is out of the country.

Duterte warned the inmates they risked death if they tried to escape.

"They destroy the country, they're destroying the youth of the land. My appeal to them, since they are beyond redemption, they can stop and commit suicide because I will not allow these idiots to run their show not during my watch," Duterte told reporters two days after revealing the names of five police generals involved in the illegal drug trade.

Duterte specifically pointed to retired Philippine National Police (PNP) deputy director general Marcelo Garbo Jr. as a protector of drug syndicates. A diagram provided to reporters linked Garbo to Co and Lim.

Duterte bared that Colangco was a member of the Kuratong Baleleng kidnapping syndicate-.

Co is the head of "Bilibid 19," a group of convicted drug traffickers detained at the New Bilibid Prison, he said.

Co's operations, he added, cover Luzon and Metro Manila.

Lim, who is reportedly behind the drug trade in the Visayas, goes in and out of the country based on information from PNP chief Director General Ronaldo "Bato" de la Rosa, Duterte said.

"The moment he lands at NAIA [airport], he will die. That is my assurance to the Filipino people," he declared.

Solicitor General Jose Calida, who briefed reporters after a Cabinet security cluster meeting, said Garbo was the "coddler" of the top drug dealers.

"According to briefing we received earlier, he's level five associate/protector. In short, coddler," Calida said of Garbo.

13 soldiers assigned to Fort Bonifacio found positive for drug use

Thirteen Army soldiers are now under custody after they were tested positive for illegal drug use after—a random drug testing ordered by Army chief Lt. Gen. Eduardo Ano on troops assigned to Fort Bonifacio.

Col. Benjamin Hao, Army spekesman, said the 13 soldiers are currently under custody of the Philippine Army Custodial Centerpending confirmatory testing by Department of Health (DoH)-accredited testing center.

According to Hao, about 3,000 Army troops assigned to various post units at Fort Bonifacio were required to undergo the random drug testing after the morning exercise on Tuesday.

Hao said Ano himself took the drug test.

"The 13 failed the initial screening test and were immediately required to undergo confirmatory testing in a DoHaccredited drug testing establishment," Hao said.

"They are currently placed under custody at the Custodial Center," he added.

Hae, however, refused to identify or at least give the ranks of the 13, citing due process and pending the results of the confirmatory test and investigation.

"Everybody was required to undergo the drug test led by our

Army commanding general," Hao said.

According to Hao, the drug test was unannounced and was done after the troops' regular Taebo exercise.

"The Philippine Army is very serious in its anti-drug campaign," Hao said. "Since we started this campaign, 204 soldiers nationwide were already discharged from the service because of cases related to illegal drugs (131 soldiers nationwide were discharged in 2013; 38 in 2014; 30 in 2015, and five so far this year)."

"If the confirmatory test is positive, it is enough evidence for us to discharge our personnel," Hao explained.

"But we emphasized that due process is given to all our personnel based on existing laws and regulations about illegal drugs," he added.

Section 36, Article 3 of Republic Act (RA) 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, mandates the conduct of random drug testing to public and private officers for purposes of reducing the risk in the workplace. This same section of RA 9165 also mandates the conduct of annual mandatory drug test to all members of the military.

Hao stressed the drug test among Army soldiers has been ongoing since 2012 as part of the efforts of the military leadership to keep its ranks from drug users.

Top Abu leaders lead attacks in Basilan

ZAMBOANGA CITY—At least 200 members of the terror group Abu Sayyaf, led by two of their highest-ranking leaders, attacked an Army headquarters surrounded by civilian communities in Basilan province on Sunday, sending residents fleeing to safety and starting a gun battle that was still going on as of late yesterday afternoon.

Joel Maturan, former mayor of Ungkaya Pukan town in Basilan, said the terrorists, armed with .50 cal. machine guns, had positioned themselves on four hills surrounding the community of Punoh Butigan in the village of Sungkayot where the 18th Infantry Battalion headquarters is located.

The terrorists, said Maturan, "seemed to be determined to get the headquarters." He said he and his rubber plantation workers had armed themselves and prepared to fight alongside government soldiers.

He said false reports that the town of Tipo-Tipo was the one under attack, not Ungkaya Pukan, sent residents there fleeing in panic.

The terrorists launched the attack on Ungkaya Pukan around 7:30 p.m. on Wednesday until 2 a.m. yesterday. They resumed the attack around 7 a.m. yesterday.

"It's on and off," said Maturan. "I wonder why these bandits are not running out of ammunition and food."

Maturan said the terrorists repositioned themselves in the community of Punog Al-

ibasa, which falls within the jurisdiction of Tipo-Tipo, Ungkaya Pukan and Al Barka.

"But the volley of fire is landing on us,"
Maturan said. At least 400 families had almeady fled, he said.

Tong Isarul, former Tipo-Tipo mayor, said classes in all eight elementary and high schools in his town had been canceled.

"We were all caught by surprise," said Isarul. "We were winding down our Eid (end of Ramadan) celebration when the attack happened."

"People are afraid to move around," Isarul added.

The attack took place as a Tausug trader was freed by his Abu Sayyaf captors on Wednesday after almost a year in captivity.

Maj. Filemon Tan Jr., spokesperson of the Western Mindanao Command, said Araji Maani, who is into money-lending, was freed in the village of Wanih Piyanjihan in Parang, Sulu.

Maani was kidnapped on July 27 last year

10 slain, 19 wounded in Sulu firefight

Government troops yesterday clashed with two main bands of the terrorist Abu Sayyaf Group (ASG) in Basilan and Sulu provinces, resulting in at least one soldier and nine bandits killed while six troopers and 18 terrorists were wounded, the military's Western Mindanao Command (Wesmincom) said.

Maj. Filemon Tan Jr., Wesmincom spokesman, said that elements of the Army's 45th Infantry Battalion (IB) encountered the band of ASG senior commander Radulan Sahiron in Patikul, Sulu at around 3 p.m.

Tan said that the troops were conducting focused military operations along Barangay Kabuntakas where they clashed with the group of Rahiron, composed of about 150 bandits.

Fighting was still ongoing as of press time yesterday.

Tan said that initial results showed that one soldier was killed in action while six others were wounded.

On the other hand, Tan said that intelligence report showed that at least nine Abu Sayyaf bandits were killed while 13 others were wounded during the clashes.

Han said that elements of the Air Force provided indirect fire support to the engaged ground troops while members of the Army's 32nd IB were sent to reinforce the 45th IB.

In Basilan, elements of the Joint Task Force-Basilan engaged the group of ASG leader Isnilon Hapilon and Furuji Indama in a series of encounters in Ungkaya Pukan and Al Barka towns.

Tan said that the initial firefight erupted at around 8 p.m. Wednesday which lasted for five hours.

"This morning 7 a.m. (Thursday), firefight resumed in different sitios in Ungkaya Pukan and Magcawa, Al Barka, Basilan," Tan said.

"Continuous indirect fire support and air strikes are being done and additional troops deployed in the area of operations as firefight still ongoing as of this time," he added.



2 lumads shot dead in Davao del Norte

DAVAO CITY – Two lumads were shot and killed by suspected New People's Army(NPA) rebels at around 4 p.m. on Wednesday, after attending a forum organized by the National Commission for Indigenous People (NCIP) in Panabo City, Davao del Norte.

Datu Ruben Labawan, 42, tribal leader of the Ata tribe of Paquibato District and his companion Romeo Tanio, 49, were shot from behind by armed men on board two motorcycles.

Capt. Rhyan B Batchar, chief of Di-

vision Public Affairs Office of the 10th Infantry Division, said that the two victims joined the convergence forum and consultation organized by the NCIP in Brgy Gredu, Panabo, along with other lumad leaders and representatives of the national and local government agencies.

The meeting supposedly discussed pilot areas within lumad communities for the Slope Agriculture Land Technology, a farming method implemented by the Department of Agriculture, Department of Environment and Natural Resources, NCIP and Technical Education and Skills Development Authority, Municipal Agrarian Reform

Office and the City Environment and Natural Resources Office of Panabo.

Col. Ricardo Nepomuceno, 1003rd Infantry Brigade commander, linked the killing to the communist rebels and questioned the group's sincerity in the resumption of peace talks.

But he added he is not also discounting the possibility that it could be due to "pangayaw," or tribal war, between the families of the two victims.

He vowed that the military will do its part to prevent further bloodshed involving lumads.

The Philippine National Police, meanwhile, echoed the condemnation of the death of the Lumad leader.

Davao City bracing for possible ISIS attacks

By YAS D. OCAMPO

AVAO CITY – The city government here remains unfazed amid reported threats from the terrorist group ISIS, but warned the public to be vigilant and coordinate with authorities.

Security has been beefed up along the city's entry and exit points after City Hall on Thursday revealed that terrorist group ISIS has targeted the hometown of President Duterte.

Acting Mayor Paolo Z. Duterte said that the military and police have been informed of the report.

The acting mayor also ordered the intensification of intelligence – gathering to avert possible attacks from the international terror group.

Intelligence-gathering He said he has already some information about the whereabouts of the group but refused to give specific details.

The information, he said, must be validated first.

"We are intensifying the gathering of information. We cannot disclose details or confirm anything as of yet," he said.

Duterte said that he has already coordinated with the city's anti-terrorism group, Task Force Davao, the Davao City Police Office, and the Eastern Mindanao Command of the military to get more information about the said threaf

The main entry points of Davao City are manned by personnel from the TF Davao, who ask passengers of public transport to step out of their vehicles while the personnel scan the vehicles using K9 units.

"I already instructed Task Force Davao commander Col. Henry Robinson and Davao City Police Office director Sr. Supt. Michael John Dubria to intensify their intelligence gathering efforts and double their security operations especially in the boundaries of the city," Duterte said.

"Be vigilant," he added. "If there is someone acting suspiciously who is not a member of your community, you can inform the PNP TF Davao, or even your Barangay Officials."

Coastal security muscle

Meantime, the Philippine Coast Guard-Davao will get one of the 10 brand new 44-meter multi-role response vessels (MRRV) from Japan that will be assigned off the shore of the "Malacañang of the South" at the Department of Public Works and Highways (DPWH) compound in Pandacan, this city where President Duterte holds office.

PCG-Davao acting station commander LCDR Restituto Concio Jr. said that the new sea asset is expected to arrive in

the region in September this year which would also boost their rescue capabilities, maritime patrol, and marine environmental protection efforts.

He said that all 10 vessels will be delivered in two years, and the PCG-Davao is expecied to get another unit since Davao is the priority area to ensure the safety of the president while the rest will be distributed to 12 other coast guard stations in the country. About three hours before Maani was freed, an Abu Sayyaf gunman was killed in an encounter with government troops in Barangay Maligay in Patikul town.

Tan said fighting erupted in Al-Barka town in Basilan on Wednesday night and early yesterday when around 200 bandits attacked military camps.

He said Abu Sayyaf gunmen stormed the headquarters of the 18th Infantry Battalion and its detachment in Barangay Magcawa.

A village official said another group attacked a school in Tipo-Tipo, damaging some classrooms.

The official said the attack could be a diversionary tactic of the Abu Sayyaf.

There was no immediate report on the number of casualnes.

Attacks threaten Duterte town

AUTHORITIES have tightened security in Davao City – hometown of President Rodrigo Duterte – following intelligence reports that the Islamic State (IS) may launch tenoratiads there.

Acting mayor Paolo Duterte, the president's son, ordered police and military to stay alert and tighten secunity in all entry points to Davao City.

He urged residents to be vigilant while the authorities were verifying the reported threat.

AFP Eastern Mindanao Commander, Lt. Gen. Leonardo Guerrero, has directed army commanders to coordinate closely with the police authorities and intensify intelligence gathering and conduct anti-terrorism and counter-terrorism activities not only in Davao, but the whole region.

Guerrero pointed out that the military's posture on the matter remains the same as the threat leveled against Davao increased being the President's hometown.

The heightened security in Davao also coincided with on-going military operations in Basilan and Sulu provinces.

Army Major Ezra Balagtey, spokesman for the Eastern Mindanao Command based in Davao City, said they have intensified support to law enforcement and strengthened antitenorism operations.

The threats came following recent ISIS attack on a night club in Puchong, Selangor in Malaysia just outside the capital Kuala Lumpur that wounded eight people, and a suicide attack on a police station in central Java in Indonesia that injured an officer.

ISIS has also threatened the Philippines and, in one of its latest propaganda, called for jihadists around the world to go to the largely Catholic country and wage holy war.

However, Armed Forces of the Philippines Chief of Staff Lt. Gen. Ricardo Visaya on Thursday said they have not received any information on the alleged threat as revealed by the younger Duterte.

"I haven't received any similar report, but as always terrorist threats are part of our intelligence units' monitoring efforts," he said.

Asked about the presence of ISIS in the country Visaya said that the same was not validated.

"Only groups like ASG (Abu Sayyaf Group) that have publicly declared support to the said group," he added.

Just recently, suspected jihadists ambushed a convoy of the 65th Infantry Battalion and 51st Mechanized Company in Marawi City in Lanao del Sur, killing an army soldier and wounded three others.

More IS killings loom in Mindanao

ORE atrocities are threatening Mindanao after several attacks in Lanao del Sur and Basilan provinces in the Autonomous Region in Muslim Mindanao (ARMM) have been claimed by the Islamic State (IS or ISIS) which hinted ties with local jihadists groups in the country.

The IS recently boasted to have carried out attacks during the last week of the Islamic holy month of Ramadan, a few days after IS Asian fighters in Syria surfaced in a video ordering its supporters in Southeast Asian countries, such as

Malaysia, Indonesia and the Philippines, to wage more attacks and unify under one umbrella group.

Security forces confirmed the separate incidents in Al-Barka town in Basilan and Marawi City in Lanao del Sur but pro-

vided no further details. Marawi police said they were tracking down the suspects.

But in its bulletin on July 2, the IS's Amaq news agency website claimed that "2 Filipino soldiers [were] killed in the municipality of Tugaya, in addition to the destruction of an armored vehicle, killing those inside, near a Filipino army base in the city of Marawi in the Southern Philippines."

On June 29, the news agency also reported that "15 Filipino soldiers [were] killed, as Islamic State fighters carried out 2 attacks during the last 2 days in the city of Marawi."

The Amaq reports were being shared online by IS Ranao, known to the military as "Maute group" or "foreign and local ter-

ronist organization (FLTO)" in the remote town of Butig in Lanao del Sur and a jihadist group previously known as Khilafah Islamiyah Movement (KIM).

Meanwhile, Brig. Gen. Restituto Padilla Jr., Armed Forces of the Philippines spokesman, downplayed the threat, calling it a propaganda of the local jihadists to get the attention of the foreign terror group for support.

"They are part of the propaganda of these groups. They sensationalize and twist the atrocities like claiming that at least 200 of their armed members attacked a military detachment.

"Parang may nangyari tapos papalakihin nila at babaluktutin yung katotohanan para ma suit yung purpose nila para maisulong yung propaganda nila at maipakita na malakas sila (If something happened they will blow it out of proportion, twist the truth to suit their purpose and push their propaganda to show their might), "Padilla said.

Since June the military temporarily stopped its operation against Abdullah Maute's group in respect to the sacred month of Ramadan while continuous military offensive was on-going in Basilan and Sulu against another local jihadists, the Abu Sayyaf Group (ASG) led by Isnilon Hapilon. The two groups had both pledged allegiance to the IS.

The ASG, know for kidnapping, bombing and beheading activities, is still holding several hostages in Sulu including Norwegian Kjartan Sekkingstad, who was snatched in Samal Island, Davao del Norte province last September 21, 2015 along with Robert Hall and John Ridsdel and a Filipina, Maritess Flor:

The group released Flor without ransom but decapitated Hall and Ridsdel after deadlines lapsed to pay the P300-million ransom they were demanding for each of their hostages.

The ASG has warned that Sekkingstad might have the same destiny of Hall and Ridsdel if the government fails to pay the ransom or express intent to negotiate.

Earlier reports said that private negotiations are taking place for the safe release of Sekkingstad under the Duterte administration.




Davao under threat from ISIS, says **Duterte son**

The hometown of President Duterte is reportedly facing threats from international terror group Islamic State of Iraq and Syria, according to his son, acting Mayor Paolo Duterte, but government security forces maintained that there is no IS-

affiliated group in the region or Mindanao.

"We are intensifying the gathering of information. We cannot disclose details or confirm anything as of yet," he told a press briefing.

The acting mayor also advised the public to remain calm and vigilant.

nti Eastern Mindanao Command Chief Lt. Gen. Leonardo Guerrero said they have no information yet regarding any terror threat but they are now in communications with the mayor regarding the specific threat of the ISIS.

He, however, stressed his troops are on alert so that they can immediately put a stop to any form of terrorism.

Davao City police chief Senior Supt. John Michael Dubria also downplayed Duterte's information but called on the public to remain vigilant.

He said the information he got was that there is threat against Cotabato region but not Davao City.

But Dubria was quick to defend Disterte in revealing the supposed threat to the public.

The Davao City police chief said such move prompted further intensification of security operations there.

Dubria said he already ordered intensified conduct of checkpoint operations, additional deployment of troops and doubling of beat and foot patrols around the city.

He said coordination with other government security agencies like the AFP and the Coast Guard was also strengthened.

Dubria also admitted that here are other threats the city is facing from lawless armed groups.

NDF links solon, gov to drug trade

North Samar congressman, uncle deny being drug protectors, blast Reds

TACLOBAN CITY—A newly elected congressman and his uncle, who is governor in Northern Samar, were accused by the National Democratic Front (NDF) in Eastern Visayas of involvement in

illegal drugs in the province.

On its website, the NDF, an umbrella group of underground Leftist organizations, including the Communist Party of the Philippines, identified Rep. Ed-

win Ong as the "biggest drug lord" in Northern Samar, one of the country's poorest provinces, who is being supported in the illegal trade by his uncle, Gov. Jose Ong.

But Governor
Ong, who is now on
his second term,
brushed aside the allegation raised by
NDF through its
spokesperson Fr.
Santiago Salas.

"I don't know where the (NDF) got that information," said the governor.

"It's their practice to accuse anybody without any basis," he said.

The governor insisted that he had been fighting illegal drugs in Northern Samar.

Northern Samar as rated as the poorest province in Eastern Visayas where six out of 10 people are classified as poor, according to the survey of the Philippine Statistics Authority during the first quarter of 2015.

The other provinces in Eastern Visayas are Samar, Eastern Samar, Leyte, Southern Leyte and Biliran.

The statement issued by the NDF on its website and distributed to media outlets here, was made apparently in response to the call of President Duterte for the communist group to help him in his campaign to rid the country of the illegal drug menace.

In a one-page statement, the NDF claimed that the two officials were behind the "widespread illegal drug trade in the province."

The rebels expressed concern over the alleged proliferation of illegal drugs in Northern Samar that "these are even sold to elementary students and in remote

towns,"

NDF also alleged that the Ongs were using the local police to arrest drug pushers who were not under their protection.

The communist group, however, did not cite specific cases or present evidence to back its claim.

Rogelette Urgel, information officer of the regional Philippine Drug Enforcement Agency (PDEA), in a phone interview, said that the agency did not have any information on the alleged involvement of the Ongs on the illegal drug trade in Northern Samar.

Asked if the PDEA is monitoring local officials in Eastern Visayas who are involved in drugs, Urgel said yes.

"We consider them as highvalue targets," she said.

Urgel, however, declined to provide other details.

But in Cebu, a brother of a town mayor did not wait for police to arrest him for his involvement in drugs.

Jover Jusay, brother of Catmon town Mayor Dan Jusay, is the first drug suspect to present himself at the police station in the town in northern Cebu and promise to stop selling drugs.

Senior Insp. Roberto Hugo, chief of the Catmon police precinct, said the mayor's younger brother was No. 2 on the police list of drug personalities. With a report from Carmel Loise Matus, Inquirer Visayas

China envoy visits Duterte 5 days before UN ruling

PRESIDENT Duterie met with Chinese Ambassador to the Philippines Zhao Jianhua in Malacañang yesterday, five days ahead of an international court's ruling on Manila's challenge to Beijing's claim to almost all of the South China Sea.

Zhao went to the Palace to convey a message from Chinese President Xi Jinping congratulating Mr. Duterte on his election as the Philippines' 16th President, according to the presidential spokesperson Ernesto Abella.

Asked if the South China Sea dispute was discussed, Abella said no further information was available.

Foreign Secretary Perfecto Yasay was also present at the meeting.

July 12 ruling

The UN-backed Permanent Court of Arbitration will hand down its ruling on the Philippine case on July 12, with international officials and experts expecting the decision to go against China.

China has refused to take part in the arbitration and says it will not accept the court's ruling.

Mr. Duterte on Tuesday said he was optimistic that the ruling would be in the Philippines' favor. And if it is, he said he was willing to talk with China.

'War' a dirty word

"If it's favorable to us, let's talk. We are not prepared to go to war. War is a dirty word now, but we will proceed accordingly after we shall have the copy of the arbitral judgment," he said.

Zhao was one of the first few diplomats with whom Mr. Duterte met after the May 9 elections, with partial returns showing him on the way to being elected President.

Zhao was also among the diplomats present at Mr. Duterte's inauguration on June 30.

Decision nears but China opts to snub case

BELIING—Five judges and legal scholars from around the world presided over a hearing last fall in an elegant, chandeliered room in The Hague.

Arranged before them on one side of the chamber were lawyers for the Philippines, armed with laptop computers and notepads.

On the other side were three empty chairs.

For more than three years, China has refused to participate in the proceedings of an international tribunal considering a challenge to its expansive claims in the South China Sea, arguing that the panel has no jurisdiction to rule on the dispute with the Philippines.

But with a decision scheduled to be announced next week, Beijing seems to be getting nervous.

Show of strength

In a show of strength, it kicked off a week of naval exercises in the South China Sea on Tuesday near the disputed Paracel Islands, where the Chinese military has installed surface-to-air missiles.

And in recent months, it has mounted an arduous campaign outside the courtroom to rebut the Philippines and undermine the tribunal, enlisting countries from Russia to Togo to support its claim to waters that include vital trade routes and may hold oil and other natural resources.

The flurry of activity is a sign of how much is at stake in what was once an obscure legal case before an obscure arbitration panel.

Respect for int'l law

The outcome could alter the dynamics of the South China Sea conflict, shifting it from a race to establish physical dominance over the waters to a conspicuous test of Beijing's respect for international law and multilateral institutions.

China has pulled ahead in the physical race, dredging sand to build one island after another over the objections of its neighbors and the United States, and equipping many of the islands with airstrips and radar.

But if the tribunal rules in favor of the Philippines on key issues, it could put President Xi Jinping of China on the defensive—or, some worry, push him into a corner.

"This is a matter of wider significance ihan the South China Sea," said Bilahari Kausikan, a Singaporean ambassador at large, noting that China has signed the United Nations Convention on the Law

of the Sea (Unclos), which is the basis of the Philippine complaint and the tribunal's deliberations.

"The importance of the issue is whether international rules will be obeyed," Kausikan said.

China, he added, "cannot pick and choose which rules to follow or only comply when convenient."

US diplomatic push

Sensing an opportunity, the Obama administration has begun a diplomatic push of its own, backing the tribunal and persuading allies to speak out for a "rules-based order at sea" and the use of international law to settle territorial disputes.

Neither Washington nor Beijing paid much attention when the Philippine foreign secretary, Albert del Rosario, began the case before the Permanent Court of Arbitration in 2013, not long after China wrested control of an atoll known as Panatag (Scarborough) Shoal from the Philippines.

The US state department's senior diplomat for East Asia, Daniel R. Russel, has said he was unaware of the Philippine case at the time.

The Chinese leadership quickly dismissed the tribunal without extensive consultation with the foreign policy establishment, according to several Chinese scholars.

Beijing's position has not changed. Because the sovereignty of scattered reefs, rocks and islands in the South China Sea is in dispute, it argues, the tribunal cannot rule on competing claims to the waters surrounding them.

Unclos says nothing about the sovereignty of land.

No question of sovereignty

But the Philippines has been careful to frame its complaint in a way that sidesteps the question of who has sovereignty over the islands and reefs.

For example, Manila has asked the tribunal to declare that nine specific reefs and rocks, including some that China has built into artificial islands, are too small to be used to assert economic rights to the waters around them, regardless of who controls them.

Unclos allows a nation to exercise sovereignty over waters up to 21.6 kilometers from its coast, and it grants economic rights over waters on a nation's continental shelf and to 360 km from its coast.



not be used to justify any maritime rights.

Philippine officials have asked the tribunal to find that China has violated the treaty by building islands in the Philippines' economic waters, interfering with its fishermen, endangering its ships and damaging the marine environment.

Void 'nine-dash line'

The Philippines' most sweeping demand is for the tribunal to reject China's claim to sovereignty over waters within a "ninedash line" that encircles almost all of the South China Sea.

China seeks to justify the ninedash line by citing what it calls historical evidence, including maps published in the 1940s and 1950s that show the dashes.

But it has never drawn a continuous line clearly marking its claim, nor has it been specific about what rights it is asserting in the area.

Critics say the Chinese goverriment gave up any special claim to the sea when it signed the UN treaty in 1996, during a period when it sought respectability on the global stage.

Beijing's clout

Now, Beijing may believe it has enough clout to ignore the treaty. It has labeled the arbitration court a "law-abusing tribunal" and its proceedings a "farce."

Chinese diplomats have suggested that the government may even renounce the treaty.

"We will not accept it or recognize it," a Chinese foreign OFFICE OF T ministry spokesperson, Lu Kang, said of the coming ruling.

That position has made some in China uncomfortable, including foreign nolicy experts

who have privately criticized the government's position, saying that China has ceded the moral high ground in its rivalry with the United States.

The United States signed the UN treaty but never ratified it.

US challenge

The Obama administration has struggled to deter Beijing from building islands and military outposts in the South China Sea, with increased naval patrols and stronger alliances in the region having little effect.

But it concluded last year that the tribunal case presented an opening to push back in a different way

When President Park Geunhye of South Korea visited Washington in October last year. Obama said he expected Seoul to speak out on the need for China to "abide by interna" tional laws and rules.'

Russel, the assistant secretary of state for East Asia, was sent to Germany, where he made the case at a prominent public policy school in Berlin.

"The Chinese are fond of saying that the Pacific is big enough for both of us," he told the audience. "What that does not mean is that they can draw a line in the center of the Pacific and say, You stay on the east, and we'll have control over everything west of the nine-dash line,' That's unacceptable."

The administration also persuaded the Group of 7 nations to issue two joint statements on the South China Sea, drawing a complaint from Beijing that the group should stick to economic policy.

A state department official,

Robert Harris, even traveled to landlocked Laos to explain the Philippine case.

Chinese propaganda

China's foreign ministry says that dozens of countries have endorsed its position, and reports about foreign politicians denouncing the tribunal appear in the state-run news media almost daily

But Beijing has adopted a broad interpretation of what it means to have won over a

country.

Russia, for example, agrees that the tribunal should not resolve the dispute, but it has been silent on the Chinese buildup, in part because of its close relationship with Vietnam, which also claims part of the sea.

At a contentious meeting it hosted last month, China pressured the 10-member Association of Southeast Asian Nations not to issue a joint statement on the subject. (In a fit of pique, Malaysia leaked the draft statement anyway.)

President Duterte, who favors closer ties with China than his predecessor said on Tuesday that he was ready to open talks on maritime cooperation.

Hard to back down

But it may be difficult for Xi to back down. He has used his defense of China's territorial claims to fan nationalist sentiment, bolstering the ruling Communist Party, and to strengthen his authority over the Chinese military.

Some analysts have suggested that Xi might respond to a ruling against China by moving even more aggressively in the South China Sea and taking steps to transform Panatag Shoal into an artificial island.

Doing so would give Beijing its first outpost on the eastern side of the sea, more than 720 km from the Chinese island province of Hainan and just 216 km from the Philippine coast.

Paul S. Reichler, the Washington lawyer retained by the Philippines as chief counsel in the case, said that if China refused to accept the tribunal's ruling, other countries would line up against it.

"China's choice would be to 285, 5295 reach an accommodation, or embitter its neighbors and endure a prolonged period of chaos and instability in the region," he said.

Ban said that while he could not comment on the Philippines' legal case, he called for a peaceful resolution of differ-

"I did stress to Minister Wang, as l have with all other countries involved, the need to resolve their differences in a peaceful manner and to avoid any escalation or misunderstandings that could put security and development in the region at risk," he said.

China says the court has no jurisdiction and it will neither participate in the case nor accept its decision.

Wang repeated China's position that it also wanted a peaceful resolution, but that it would not accept forced arbitration.

"This approach will not help bring about a peaceful resolution of disputes. On the contrary, it would only escalate the disputes and tension and should be resisted by all countries and people who uphold justice."

Last Wednesday, Wang told US Secretary of State John Kerry the United States should do nothing to harm China's sovereignty and security in the South China Sea ahead of the court ruling on China's claims in the disputed waterway.

Speaking by telephone on Wednesday, the Chinese foreign minister told Kerry the US should stick to its promises not to take sides in the dispute.

Gaming the generals

OOD FOR President Duterte for taking the campaign against illegal drugs right to the highest ranks of the Philippine National Police. If only he hadn't taken shortcuts in doing so. If history—our own, still-recent history—teaches us anything, it is that, in the long run, shortcuts work against our own best interests.

Even during the campaign period, candidate Duterte had

already suggested that some police EDITORIAL generals were involved in big-time illegal drugs trade. During the transition,

President-elect Duterte called on three police generals to resign; he did not name them, but during his thanksgiving rally in Davao City on June 4, he issued a clear warning.

"Corruption must stop. I would have to ask about three generals diyan sa Crame (there in Camp Crame, the PNP headquarters) to resign. Do not wait for me to name you in public because I will only humiliate you." Reporters working the police beat had an inkling about who the three were, but could not get confirmation.

And then last Tuesday, July 5, the President, at a ceremony marking the anniversary of the Philippine Air Force, dropped a bomb. "I am compelled by my sense of duty to tell you [the names of] the police who contributed to deterioration of law and order in this country." He then proceeded to name three generals in active police service and two recently retired generals.

He tagged Marcelo Garbo, former deputy director general of the PNP, and Vicente Loot, now a mayor of a town in Cebu province. He also named active-duty generals Bernardo Diaz of Police Regional Office 6, former National Capital Region Police Office chief Joel Pagdilao, and former Quezon City Police District chief Edgardo Tinio.

These officers are among the highest ranking policemen in the country, holding prime positions. That the President himself accused them, and the two who have already retired, of "protecting drug syndicates" is not only unprecedented; it is shocking.

Perhaps the shock will do wonders for the system; if some of the highest ranking police officials are involved in illegal drugs, we certainly join the public in supporting the Duterte administration's fight to flush them out, and then to hold them to account. But part of the shock is that, despite the lapse of time since Mr. Duterte raised the specter of high police involvement in the drugs trade in February, in spite of the full month that separated his thanksgiving rally from the PAF anniversary, he did not offer any evidence to support his accusation.

. We do not necessarily mean evidence that would stand legal scruting beyond the customary measure of reasonable doubt; we only mean evidence to satisfy the in-

evitable public curiosity.

But aside from the admittedly powerful passage about the sense of betrayal we feel when we discover that the police we expect to protect us are themselves involved in crime-"It hurts to hear because you spent money on them, you sent them to school, you paid for even socks and shoes; then they commit [these crimes], by any language, it is treason"-the President did not explain why he thought these menhad in fact committed treason.

Shouldn't investigation proceed accusation, especially when the accuser is the official designated as the Constitution's chief executive? The President could have offered one instance when one of the police generals was discovered in the act of protecting drug syndicates, or described one situation where a police general was compromised.

Instead, he gave a blanket accusation, and then called on the police generals named to prove their innocence. "I would like to talk to them and certainly, I would expect the [National Police Commission] to do their thing; imbestigahan ninyo ito at 'wag ninyo akong bigyan ng zarzuela (investigate this and don't play pretend)."

This turns the justice process upside down. The Constitution guarantees each citizen, police generals included, the right to be presumed innocent. What would it have cost the President to wait until the administration had gathered the necessary evidence? We wish to stress the point: The public would fully support the new administration's crackdown on the illegal drugs trade if it did not violate the law in the process. If police generals are involved, then, yes, "it is going to be a dirty fight, it's going to be a bloody fight," as the President said. Would that he had both law and the public on his side.

Fighting ISIS as it shifts tactics

The Islamic State extended its bloody rampage with a suicide bombing in Baghdad on Sunday that killed more than 200 people, the deadliest attack on the city since the 2003 American-led invasion. On Monday, three smaller attacks on the Saudi Arabian cities of Jidda, Medina and Qatif were also linked to the terrorist group. The recent violence, including in Turkey and possibly in Bangladesh, may indicate some adjustment in the group's tactics as its fortunes decline on the battlefields.

The multipronged assault reflects the Islamic State's growing desperation as it loses the territory it seized in Iraq and Syria. An American-led coalition has recaptured 20 percent of the ISIS-held land in Syria and 47 percent in Iraq, including Falluja, which was taken back by Iraq's beleaguered government last month.

After the Baghdad attack, the government's response was not encouraging. Prime Minister Haider al-Abadi announced plans to speed up the execution of ISTS members and some weak security measures. If Mr. Abadi cannot find ways to secure Baghdad, pressure may grow to move army units to the capital from the battlefield, where they are fighting ISIS. This would undercut plans by the American-led coalition, including the Iraqi Army, to intensify efforts to retake Mosul, a major city in the north that has been in ISIS' hands for two years.

The latest attacks reveal an enemy that is adapting, becoming more sophisticated than Al Qaeda, and nurturing a far-flung network of operations, including in the West. A complex response is needed, but John Brennan, the Central Intelligence Agency director, said last month that "we still have a ways to go before we're able to say that we have

made some significant progress against them."

Bombing isn't the only recourse. Improved intelligence, coordinated operations to find terrorists before they strike and better strategies to counter extremist propaganda are equally needed. A central problem remains the tensions among countries in the region that have prevented a fully coordinated response to the Islamic State threat. The recent attack on Istanbul's airport, which killed 44 people and authorities said was the work of ISIS, should persuade Turkey, a NATO member, to get more involved in the anti-ISIS fight, especially in Syria.

The Americans need to work more closely with Iran, the leading Shiite Muslim country, against the Islamic State in Iraq. Iran on Tuesday condemned the attacks against Saudi Árabia, its Sunni-majority rival, as well as those against Shiite Muslims, and called for a united response to terrorism. Testy relations between Iraq and Saudi Arabia have also undercut a coherent regional response to the Islamic State, which wants to destabilize both governments. The risk is especially acute for Mr. Abadi, who has long struggled to hold on to power against challenges from other Shiite leaders. Sunday's attack brought calls for his resignation from a population fed up with violence

Experts say the Islamic State will wither as it loses more territory. But even then, it will no doubt continue to stage occasional attacks in Iraq and elsewhere. If Mr. Abadi and other Iraqi leaders are to protect their people, they will need the support of fraq's Sunni population, which remains marginalized and susceptible to Islamic State propaganda. That is a central political and security problem traq's leaders have persistently failed to remedy.

SWIMMING AGAINST THE CURRENT

The Navy's Board of Advisers

N a crisis and while in a period of relative decline, the usual items that get thrown overboard are the research and development capabilities of an organization. In the case of the Philippine Navy (PN), during its long period of benign neglect, and when naval assets were simply allowed to deteriorate, its Research and Development units and offices were de-acvtivated. No funds could be found to keep them going.

Under the Sail Plan, with the Navy's "vision" to become a "strong and credible Navy for a maritime nation," this sad state of affairs could not be allowed to continue. The Philippine Navy simply had to think strategic and long-term, taking into account the maritime character of the nation it serves. Outside of the internal core processes which it had to bring up to global standards, it also had to focus on developing systems and assets that would take advantage of the geographical characteristics and maritime contours of our national territory. This may require a research and development program,

which would take years to pursue; but it is a program that would have to be started immediately.

Indeed, the Board of Advisers of the Philippine Navy was profuse with its encouragement in re-activating the Navy's research and development units and offices. The interest was deep, and there were Navy officers - at least a few - who were enthusiastic about the recommendation. Thus, even while the CNLE was still in the process of finalizing Book Π of the Navy Sail Plan, the Flag Officers in Command (FOIC) made the decision to re-activate the Office of Naval Strategic Studies; the Fleet Marine Warfare Center, and the Naval Research and Technology Development Center. Moreover, the commitment was formalized to include re-activation of these offices among the breakthrough results that should be delivered by 2015.

The PN action teams were quick to respond. Thus, when the external auditors were sent in August, 2015 to check on whether this specific performance commitment had been delivered, they came back with this report:

— The offices and units – specifically the three that had been identified and committed – were already operating. Moreover, they were rated "mission capable"

 Although a few final outputs remained pending, the re-activated offices and units already could show "emerging results" indicating "sufficient progress (towards) eventually meeting the targets set in their performance scorecards." Furthermore, they were well on the way towards the "project milestones that would indicate "the attainment of their breakthrough goals." External auditors are not known for their diplomatic language, but their statement indicated that these newly re-activated offices were still below the performance targets they had set. Nonetheless, they showed promise that given a bit more of time and perhaps of budget and other types of support - they are likely to deliver their breakthrough goals in the foreseeable future.

— Moreover, the external auditors noted that these offices and units need to be more strongly coordinated with each

other. Although all these offices and units were linked together through the FOIC, still the external assessors found the need for "creating formal linkage" that would strengthen and tighten "cooperation of their activities and outputs."

Based on the above observations, the PN was given a passing mark of "6" out of ten, in recognition of the actual re-activation of these research and development units and offices, which a "strong and credible Navy" would most absolutely need, sailing forward.

The impact assessment of these newly re-activated offices, however, based on testimony from directly affected stakeholders was more positive. Typical comments are the following:

Regarding the Office of Naval Strategic Studies, from a N5 officer: "for N5, the ONSS has significant impact (since) they are "focused, and they were able to link up with other strategies... and to partner with other think tanks and academic institutions." I give them a rating of "8.7" out of 10."

 Regarding the Naval Research and Technology Development Center (NRTDC), from another Navy officer.

NRTDC is "a must especially for a Navy aspiring to be better, stronger, and more capable." I give them a "rating of "9.8" out of ten."

— Regarding the Fleet Marine Warfare Center, from an N8 officer: "Satisfied, giving a rating of "8" out of ten, especially with regard to planning; but the Unit may consider involving subject matter experts in formulating doctrines and manuals."

The external auditors finally came to their conclusion that these newly reestablished offices and units would need more time to mature. In the meantime, the auditors assessed them to have made a good positive start, and with their initial activities they already were receiving a favorable impact assessment from their stakeholders. The auditors gave a final rating of "8" out of ten for the positive impact of this breakthrough initiative.

Thus, despite the over all reticence of the CNLE when it made a "health check" on where the Navy was with respect to its governance and transformation program, these three re-activated offices and units of the Navy represented points of light indicating progress with the Sail Plan.



ANTI-DRUG CAMPAIGN | Army assures due process for 13 soldiers found positive for illegal drug use

MANILA — Due process will be given to the 13 Philippine Army (PA) personnel who were initially found to have failed the initial screening of the mandatory drug test conducted in Fort Bonifacio, Taguig City on Tuesday.

"If the confirmatory test is positive, it is enough evidence for us to discharge our personnel. But we emphasized that due process is given to all our personnel based on existing laws and regulations about illegal drugs," PA spokesperson Col. Benjamin Hao said in an interview by DWDD-Katropa Radio 1134KHz AM.

He added that the 13 Army personnel are now undergoing investigation and were immediately required to undergo further confirmatory test in a Department of Health-accredited drug testing establishment.

"Everybody was required to undergo the drug test led by our Army commanding general," he stressed.

The drug test, which was conducted in coordination with the Philippine Drug Enforcement Agency, was unannounced.

It was implemented during the conduct of the Army's morning Taebo exercise on Tuesday.

"The PA is very serious in its anti-drug campaign. Since we started this campaign, 204 soldiers nationwide were already discharged from the service because of cases related to illegal drugs (131 soldiers nationwide were discharged in 2013; 38 in 2014; 30 in 2015; and five so far this year)," Hao added.

Section 36, Article 3 of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, mandates the conduct of random drug testing to public and private officers for purposes of reducing the risk in the workplace.

It also mandates the conduct of annual mandatory drug test to all members of the military.

These soldiers are now under custody of the Philippine Army for further investigation while waiting for the confirmatory test result.

10 killed, 19 wounded as military, ASG bandits clash anew in Sulu

From the Philippine News Agency (Jul 7):

Nine Abu Sayyaf Group (ASG) terrorists were believed to have killed while another 13 were wounded in the ongoing "focused military operations" (FMO) in Sulu Thursday afternoon.

In the said operations, a trooper from the 45th Infantry Battalion was killed while six others were injured.

The series of firefights started 3 p.m. at Barangay Kabuntakas, Patikul, of the above-mentioned province, said Western Mindanao Command spokesperson Major Filemon Tan.

He added that government troops were conducting FMO when they encountered an estimated 130 ASG bandits reportedly headed by Radulan Sahiron.

In the ensuring gun battles, nine of the terrorists were reported by intelligence reports with another 13 wounded, Tan stressed.

Government losses were placed at one soldier killed and six wounded.

"Firefight is still ongoing A/8FAB (Alpha Company of the 8th Field Artillery Battalion)provided indirect fire support to the engaged troops white 32nd Infantry Battalion was directed to close in with the enemy and provide reinforcement and was engaged in by the same ASG group:" Tan said:

Meanwhile, in Basilan, a series of clashes between troops from Joint Task Group Basilan and an estimated 300 ASG bandits headed by Isnilon Hapilon and Furuji Indama clashed 8 p.m. Wednesday.

The firefight lasted for five hours with undetermined losses on the bandit side and no casualties for government forces.

This 7 a.m. firefight resumed in different sities in Ungkaya Pukan and Magcawa, Al-barka, Basilan Continuous indirect fire support and air strikes are being done and additional troops deployed in the area of operations as firefight still ongoing as of this time." Tan added

No ISIS in PHL -- Visaya

There are no members of the jihadist terror group Islamic State in Iraq and Syria (ISIS) in the Philippines.

This was stressed by Armed Forces of the Philippines (AFP) chief-of-staff Lt. Gen. Ricardo Visaya Thursday in a message to the PNA.

"There are no ISIS here. Only groups like ASG (Abu Sayyat Group) that oublicly declared support to the said group are in Mindanao but they are not ISIS." he added

Visaya made this statement in response to claims made by acting Davao City mayor Paolo Duterte who earlier said that ISIS militants are threatening the city.

"I haven't received any similar report but as always terrorist threats are part of our intelligence units monitoring efforts," the AFP chief stressed.

The younger Duterte said that he has already alerted the local military and police to avert the plot.

But he did not elaborate on the threat which he said still being validated by authorities.

Nevertheless, he asked the public to be vigilant and report individuals who are acting suspiciously.
