President Duterte's plan to name the mayors with alleged links to drugs.

Duterte is set to identify the mayors, according to Philippine National Police chief Director General Ronald de la Rosa, and might ask the Department of the Interior and Local Government to take action against them.

Quezon City Mayor Herbert Bautista, LCP national president, said the problem on illegal drugs was already widespread but stressed he was not privy to the identities of the 23 local executives.

Bautista expressed belief though that Duterte would not release the names without due investigation and validation coming from various intelligence sources.

Bautista added it would be up to the President to decide when the public should know about the list.

The Quezon City mayor said the move to reveal top government officials linked to the illegal drug trade helps reaffirm the boldness and determination of the President to put an end to the drug menace.

Members of the LCP will make recommendations on what steps can be taken against mayors facing allegations related to drugs once they meet next week, Bautista said.

He said the problem of illegal drugs was ruining the youth, society and image of the country. He lamented that even the innocent, like the children of those being linked to drugs, were affected.

For his part, LMP national president, Javier, Leyte Mayor Leonardo "Sandy" Javier Jr. said the mayors suspected to have drug links comprised only a small percentage of their ranks.

Javier said it was very disappointing that they were sullying the good reputation of the mayors but conceded that as with any organization, "there are really scalawags."

Javier, who ran under the Liberal Party, was all praises for Duterte, saying he was doing a "fantastic thing."

"We are all behind him," Javier said, adding he himself was surprised that in their small town, at least 90 people had surrendered to the police because of drugs.

"I hate drugs because they destroy families, the very fiber of our nation," he said. - With Non Alquitran, Alexis Romero, Delon Porcalla, Edith Re-

Duterte renews call for death penalty

President Duterte made a renewed pitch for the restoration of the death penalty as a means to boost his administration's campaign against drugs and criminality.

The President made the pitch

during a casual meeting with several lawmakers and other government officials at a bar in Davao City over the weekend.

"It was a casual gathering with some officials, mostly congressmen and a few governors and we discussed many things since it was only a casual gathering with no set agenda," Senator Juan Edgardo Angara said in a text message to the Manila Bulletin yesterday.

"The President mentioned he thought we should bring back the death penalty especially for drug traffickers," Angara added.

Shortly after his victory >16

in the May elections, Duterte declared that he prefers to hang convicted criminals instead of killing them via lethal injection amid plans to suppress crimes during his first six months in office. To critics claiming it does not deter crimes, Duterte argued that the death penalty will be more of retribution against persons who committed crimes.

Angara, pressed for his position on capital punishment, said he is ready "to listen to the several proposals for the return of the death penalty."

The senator said the President also gave them a tour of the emergency center of Davao including the city's crime and traffic management system.

Apart from Angara, other law-makers who reportedly met with the President were Senator Alan Peter Cayetano, Citizen's Battle Against Corruption (CIBAC) Partylist Rep. Sherwin Tugna, Palawan Rep. Franz Josef Alvarez, Masbate Rep. Scott Davies Lanete, and Marinduque Rep. Lord Allan Jay Velasco.

Duterte, a former mayor of Davao City, was back in his hometown last weekend for some personal time, a practice he apparently intends to keep during his term. The country's new

president took a commercial flight to Davao and opted for an economy seat last Friday, ditching his previous practice of riding a private plane. It was the first time Duterte took a commercial flight as president.

Earlier, the tough talking President Duterte has publicly accused five police generals for their alleged involvement in the country's illegal drugs operations. He has ordered them relieved from their posts and ordered the National Police Commission to probe their alleged wrongdoing.

A few days later, the President unmasked the alleged Chinese triad involved in the multi billion peso drugtrade in the country. Baring the "level 5" or top tier of the drug hierarchy, Duterte named a retired police general for supposedly coddling two Chinese drug lords and a local drug dealer.

He also linked many local government executives mostly mayors in the drug network but declined to identify them last week. He said some of the mayors were from Mindanao, including a female local executive.

Duterte said he may release the names of the drug coddlers in government once he has reviewed their documents against them.



Thousands flee as Basilan conflict escalates

Thousands have been displaced by the ongoing clash between government troopers and Abu Sayyaf bandits in Basilan, according to the humanitarian office of the Autonomous Region in Muslim Mindanao.

Myrna Jo Henry of the ARMM's humanitarian emergency action and response team said over the weekend that at least 1,312 families or 7,078 individuals from the municipalities of Tipo-Tipo, Al Barka and Unkaya Pukan have been affected by the firefight.

The off and on skirmish between the Army troops and around 200 bandits have been ongoing in these municipalities for almost a week now.

The firefight escalated when the bandits launched counter attacks on the headquarters of the 18th Infantry Battalion in

Thousands have been Tipo-Tipo and on several Army splaced by the ongoing positions.

As of Saturday, the military has yet to release updates on the clash.

Armed Forces of the Philippines spokesman Brig. Gen. Restituto Padilla said on Friday night that the troops were still conducting operations against the bandits.

Henry said the affected individuals were sheltered in one of the evacuation centers in Tipo-Tipo.

The clash started on July 2 in Baragangay Magcawa, Al Barka and spread to the nearby villages of Bohe Piang and to Baguindan in Tipo-Tipo town.

Maj. Filemon Tan, spokesman for the Western Mindanao Command, said the troops have been fighting the group of Abu Sayyaf leaders Isnilon Hapilon and Furuji Indama since Wednesday night.

Three Indonesians kidnapped off Sabah

KUALA LUMPUR. — Gunmen kidnapped three Indonesian members of a tugboat crew off Malaysia's eastern state of Sabah, police said on Sunday, the latest in a string of abductions in a region noted for kidnappings by Islamist militants.

It was not immediately clear whether the men were seized by the Abu Sayyaf, a group linked to Islamic State that is responsible for recent beheadings of Western hostages and notorious for the extortion of millions of dollars in ransoms.

In Manila, Brig. Gen. Restituto Padilla, spokesman of the Philippine military, said the report is undergoing verification.

The Abu Sayyaf is still holding about a dozen foreign and Filipino captives, including seven Indonesian tugboat crew members who were abducted last month in the Sulu Sea. In April and May, the Abu Sayyaf seized 14 Indonesian tugboat crew members between Sulu and Indonesian waters but they were later freed after reportedly paying ransom. The series of kidnappings prompted the Indonesian navy in April to instruct all commercial vessels to

avoid piracy-prone waters near the southern Philippines. Also in April, port authorities in some areas of Indonesia stopped issuing permits to ships taking coal to the southern Philippines.

In the latest incident, the tugboat with a crew of seven, was in waters off the east coast of Sabah on Borneo island, about 3.6 nautical miles

from a nearby Kampung Sinakut beach, Sabah police commissioner Abdul Rashid Harun said, when it was attacked by armed men in a white boat late on Saturday.

He said that based on early investigations, the three men kidnapped were 34-year-old Lorens Koten, 40-year-old Teo Dores Kopong, and a 46-year-old identified only as Emanuel.

Abdul Rashid said they are likely

to be in the southern Philippines now but did not elaborate. Four other crew members were left behind by the kidnappers who came in a speedboat.

"Victims released also said while the kidnappers were on their tugboat for nearly 30 minutes, no violence took place," he told reporters at a press conference in Lahad Datu.

The five abductors were armed

with rifles and also had a grenade launcher, the police added.

In Jakarta, the Indonesian foreign ministry said it had no information yet on the abductions.

The Abu Sayyaf militant group has beheaded two Canadian nationals recently after its ransom deadlines expired. It is still holding men from Japan, the Netherlands and Norway. – Reuters and Victor Reyes

AFP chief cites Rody order: Rescue hostages, get Abus

ZAMBOANGA CITY—President Duterte has ordered the military to rescue Norwegian Kjartan Sekkingstad and all other kidnap victims still held by the Abu Sayyaf—and then exterminate the group.

Armed Forces of the Philippines (AFP)
Chief of Staff Gen. Ricardo Visaya said here
on Saturday the President "asked us to exert all efforts to rescue the Norwegian and the other victims."

Mr. Duterte, he said, ordered him to use all available resources, logistics and manpower to secure the hostages—numbering over a dozen including 10 foreigners—and eradicate the Abu Sayyaf.

"As much as possible, we will add more troops and more resources, more augmentation—meaning all resources will be poured here. This is what President Duterte wants. [Our forces] will be focused here, meaning logistics, personnel," Visaya said.

On Friday, Mr. Duterte said he did not consider the Abu Sayyaf a criminal group, but a band of people who had been pushed to the wall by circumstances.

"That's why I am not including Abu Sayyaf [activities] in criminality. You've never heard me say [they are] criminal(s). It is a different setup there because these are guys who were driven to desperation," the President had said during the recent Eid al-Fitr celebration in Davao City.

Duterte said he knew all about the situation "from Nur to the ARMM."

"There was no sufficient semblance of governance and that was why they were pushed to the wall," he said. "Then they became radicalized."

Visaya said the details of the rescue effort were confidential and no deadline had been set for the extermination of the Abu Sayyaf.

'There's no IS here'

As for fears the Islamic State (IS) international terror group had reached Mindanao, Visaya said this was not so.

He said the IS did not exist in Basilan or any part of the Autonomous Region in Muslim Mindanao and any claims were based on rumors and had not been validated.

"As far as we are concerned, this is raw information. We need to evaluate this information, but as of now there is no IS here," he said.

He admitted, however, that what there were in the ARMM were groups claiming to support IS. Visaya once served as a Philippine Army brigade commander in Basilan.

Earlier, former Ungkaya Pukan (Basilan) Mayor Joel Maturan said IS existed in Basilan and its members had merged with the local Abu Sayyaf. He cited instances when black flags similar to the ones exhibited by IS in the Middle East had been seized in the province.

But like Visaya, ARMM Gov. Mujiv Hataman dismissed claims IS had arrived in Basilan.

"There may be IS-inspired groups. For example, Isnilon Hapilon was seen in a video pledging allegiance to IS," Hataman, a native of Basilan, said.

Rody urged to study UN ruling carefully

CONFIDENT that the Philippines would get a favorable ruling from an international tribunal on its dispute with China over the South China Sea, Sen. Leila de Lima on Sunday said she hoped the Duterte administration would study the decision carefully before deciding what action to take so that Manila's 20-year effort to resolve the conflict would not go to waste.

The United Nations Permanent Court of Arbitration in The Hague will hand down a ruling at 11 a.m. (5 p.m. in Manila) tomorrow in the increasingly bitter dispute between the Philippines and China, in a closely watched case that risks ratcheting up

tensions in Southeast Asia

Most legal experts expect the ruling to go in favor of the Philippines, but the Duterte administration is not aflutter about that prospect.

It is up to Solicitor General Jose Calida to decide what the government should do if the ruling comes out in favor of the Philippines, Malacañang said yesterday.

President Duterte said last week his administration was willing to talk with China about sharing natural resources in the West Philippine Sea—South China Sea waters within the Philippines' 360-kilometer exclusive economic zone (EEZ)—if the arbitral tribunal found for the Philippines.

Unclos case

Invoking the UN Convention on the Law of the Sea (Unclos), Manila lodged the suit against Beijing in January 2013, saying after 17 years of negotiations it had exhausted all other political and diplomatic avenues.

Angered by the Philippine move, China refused to participate, saying it would not comply with the ruling by a tribunal with "no jurisdiction" over the dispute.

The Philippines asked the court to void China's claims to almost all of the South China

Sea, including waters within Manila's EEZ and those close to the shores of other claimants in the strategic waterway—Brunei, Malaysia, Vietnam and Taiwan.

Manila also demanded respect for its right to fish and explore resources within its EEZ.

The case does not involve questions of sovereignty, an issue handled only by the International Court of Justice.

Speaking in a radio interview, De Lima said she was confident the Philippines would get a favorable decision from the court.

"We have international law as support for our position and recognition of the rule of international law, which was pointed out by the previous administration," said De Lima, who served as justice secretary to then President Benigno Aquino III and who supervised the Office of the Solicitor General, which represented the Philippines in the case against China.

Aware of Mr. Duterte's openness to bilateral talks with China, De Lima said the administration should first wait for the ruling to come down then study it well "before determining its next actions."

"The ruling will be put to waste if we just surrender what is supposed to be ours," she said, adding that joint exploration means both the Philippines and China have the same rights to resources in the West Philippine Sea.

National interest

"The primordial consideration should always be national interest," De Lima said.

Foreign Secretary Perfecto Yasay on Friday said the administration hoped to quickly begin direct talks with China after tomorrow's ruling.

The President and Chinese Ambassador to the Philippines Zhou Jinhua met last week in Malacañang and discussed joint exploration.

Malacañang reiterated yesterday that it would wait for the ruling before making any move toward talks with China.

"Once we have the decision, what we will do is to study [it]. Then that's the time that we shall explore our next move," Presidential Communications Secretary Martin Andanar told public broadcaster dzRB.

Andanar said the government would take all matters pertaining to the dispute with China "legally."

Legal experts agree that after three years of deliberations, two hearings and nearly 4,000 pages of evidence, the arbitral court is likely to find in Manila's favor—in a decision with farreaching ramifications.

"An award from the tribunal

that rejects some of China's more dubious claims would provide support for the mainstream views of other states in the region," Cecily Rose, assistant law professor of public international law at Leiden University, told Agence France-Presse (AFP).

"China is bound to comply with the award. But should it refuse to do so, the tribunal has no enforcement mechanism to which it can turn," Rose said.

Regional tensions

The ruling comes against a backdrop of frequent military brushes between China and its rival claimants, whose EEZs ring the waters believed to hold untapped oil and gas reserves.

The tensions have also drawn in the United States, which has defense treaties with the Philippines and other regional allies.

In a show of strength last week, the US Navy sent warships to patrol close to some of the artificial islands that China built in the Spratly archipelago to bolster its claims to nearly all of the 3.5-million-square-kilometer South China Sea.

The US destroyers Stethem, Spruance and Momsen have been patrolling near Panatag Shoal (Scarborough Shoal), a rich fishing ground in the West Philippine Sea near the coast of Zambales province, which China seized in 2012 after a twomonth standoff, forcing Manila to bring the law of the sea case against Beijing early the following year.

The aircraft carrier USS Ronald Reagan is currently patrolling the South China Sea.

Manila and Washington have also concluded an Enhanced Defense Cooperation Agreement (Edca) that allows greater access by US troops to Philippine military bases, including one near Philippine islands in the Spratlys that China insists are parts of its territory, and to store weapons and equipment in those bases.

Comply with ruling

Washington on Friday urged the Philippines and China "to comply with the ruling" and appealed to "all claimants to avoid provocative actions or statements."

"Whatever the outcome, the case will not contribute to improved relations between China and other claimants in the South China Sea," Frans-Paul van der Putten, a senior researcher at the Clingendael think tank, told AFP

China's state-run media on Friday said that Beijing would not take "a single step back" if the United States and the Philippines "act on impulse and carry out flagrant provocation."

Facing international pressure to comply with the arbitral

court's ruling, China, according to the state-run Global Times, will "fight back."

China, the paper said, could turn Panatag Shoal "into a military outpost" and "tow away or sink" the BRP Sierra Madre, an old and rusting hospital ship that Manila grounded on Ayungin Shoal (Second Thomas Shoal) in 1999 to mark Philippine territory in the Spratlys, to "resolve the standoff once and for all."

Beijing insists it has "undisputed sovereignty" over almost all of the South China Sea, basing its arguments on Chinese maps dating back to the 1940s marked with a nine-dash line that encompasses waters within the EEZs of the other claimants.

Expert Joris Larik from The Hague Institute for Global Justice said "China's position and credibility will be weakened if the arbitral panel finds against it."

But Chinese President Xi Jinping said China was "not afraid of trouble" and state-run newspaper People's Daily urged Beijing to prepare for a "military confrontation" in the South China Sea.

China launched military drills in the South China Sea on Friday, with its Navy carrying out combat exercises with live missiles, according to the PLA Daily, the Chinese military's official newspaper. With a report from AFP

Alarms not needed on sea dispute

SECURITY officials yesterday said there is no need to raise the level of alert of forces in connection with Tuesday's anticipated ruling that will be issued by a United Nations arbitral court on the South China Sea or West Philippine Sea dispute.

"There is no need to raise the alert. We don't think China will take violent actions," said Gen. Ricardo Visaya, AFP chief of the Armed Forces whose personnel are assigned in nine Philippine-occupied islands, shoals and reefs

in the disputed waters.

National security adviser Hermogenes Esperon Jr., former Armed Forces chief, he is hopeful that China would not do violent actions if the Philippines gets a favorable ruling from the tribunal.

Esperon said security officials will meet "about the ruling once it comes out and come up with courses of action."

Nevertheless, he said the Duterte administration has come up withscenarios once the Hague-based court issues the ruling. However, he declined to discuss the scenarios for security reasons.

A military official, speaking on condition of anonymity, said the AFP "will not raise its alert, we will be on normal alert."

"We know that we are going to win and hopefully they (China) will not do violent activities because that will work against them. They will be on the losing end if they do that," the source said.

The source also dismissed that China will harass Filipino troops in the Philippine-occupied areas in the South China Sea. "What

for, why would they do that? As of now, international opinion is already against them," the source said.

Many countries have criticized China's excessive nine-dash-line claims and its effect on freedom of navigation.

The Philippines lodged the complaint against China's claim before the UN tribunal in January 2013, several months after the Chinese gained control of the Scarborough Shoal or Panatag Shoal – about 124 nautical miles from Iba, Zambales.



US air contingent ends training operations

A SECOND contingent of United States aircraft has completed security and training missions in the Philippines and has been redeployed to Misawa Air Base in Japan "to resume a previously-scheduled deployment to the western Pacific," according to the US military which implied that similar missions are about to take place.

The first air contingent was part of the Balikatan exercises conducted last April. It completed its mission last April 28. It was composed five A-10 Thunderbolt II jet aircraft, three HH-60Gs Pave Hawk helicopters, an MC-130H transport plane and 200 personnel.

The second contingent, the US Navy Electronic Attack Squadron (VAQ) 138, is composed of four electronic warfare EA-18G Growler aircraft and 20 personnel. It arrived in Clark Air Base in Pampanga last June 15 for training with Filipino counterparts and regional maritime domain awareness operations.

"Routine operations such as these air contingents and exercises like Balikatan will continue to be scheduled in order to promote

egional security and foster the istorically strong relationship between the US and the Philippines," the US military said in a statement.

The contingent had subject matter exchanges (SME) with their Filipino counterparts "to provide insight for our Filipino partners into how the US military conducts operations at home and downrange," said US Navy Cdr. Aaron Tabor, the VAQ 138 com-

manding officer.

"This allows them to see what has worked for us and potentially apply it to their existing military procedures," he said.

AFP not expecting China to do anything violent should ITLOS ruling favor PHL

"(And whatever the ruling), the President announced that he is willing to start to restart bilateral talks so we take our cue from there," Andolong stressed.

Hataman issued the statement after he disclosed that there were Sulu-based ASG brigands who had fied to this province to escape from the continuous military offensive in the province of Sulu.

"I'm sure there are no hostages, we have information there are no hostages here. They (ASG brigands) transferred here due to (the military) pressure in nearby Sulu," Hataman said.

The ASG brigands are still holding captives nine foreigners and three Filipinos in the province of Sulu.

The foreigners included a Dutchman birdwatcher, a Norwegian, and seven Indonesian sailors.

Maj. Filemon Tan Jr., Western Mindanao Command (Westmincom) spokesman, said the Joint Task Force Sulu continued to conduct focused military operations.

Westmincom received intelligence report that nine ASG brigands were killed while 13 wounded when the troops pounded on Thursday the ASG position in Barangay Kabuntakas, Patikul, Sulu.

Hataman said based on reports he received, there were about 200 ASG brigands operating in this province.

"Ang nagparami sa kanila ay yon taga Sulu, Zamboanga Sibugay, and Marangan, Zamboanga City," Hataman said.

Marangan is a sitio in Barangay Muti, Zamboanga City, which Hataman said around 30 ASG brigands came from the area and joined their comrades in this province.

He disclosed they learned there were some ASG brigands from Zamboanga Sibugay here since one of them was arrested by the military in the nearby town of Al-Barka.

He said the ASG brigands staged the attack on Wednesday in Tipo-Tipo as they wanted to instill fear among the residents in the area.

"Hindi namin papayagan at hindi namin hahayaan na gagawin nila yon," he said.

Hataman met with the provincial, city, and municipal officials of this province and discussed measures to address the problem on peace and order of this province.
