Netizens raise call on eve of UN ruling

IT IS TIME for China to do a #CHexit from the West Philippine Sea, social media users and activists in the Philippines said on Monday on the eve of a crucial UN tribunal ruling.

Inspired by the Brexit term coined for Britain's vote to leave the European Union, the catchy new reference for China has quickly gained currency on Facebook, Twitter and protest placards ahead of the verdict of the Permanent Court of Arbitration in The Hague on Beijing's claims to most of South China Sea, including Philippine territorial waters.

protested with a small group of people outside the Chinese Consulate in Manila. "China should stop bullying its neighbors."

On social media, some of the messages were more blunt. "China, get out of Philippine territory! #CHEXIT," wrote @emiletabiar on Twitter.

"The West Philippine Sea is not for you to own. #CHexit," said @rmcocoba.

Other Filipinos were not amused. "CHexit'?!?!? Cringing on this one," said @titobabis.

China claims nearly all of the strategically vital sea, even waters approaching the coasts of the Philippines and other Southeast Asian nations.

Challenging China claim

Manila filed a case in the arbitral tribunal in The Hague in 2013 challenging China's claim. China refused to participate in the hearings and vowed to ignore Tuesday's verdict.

Experts have said that the ruling is likely to be in Manila's favor.

Department of Foreign Affairs (DFA) spokesperson, Charles Jose, said the ruling would clarify the maritime entitlements of coastal states like the Philippines based on the 1982 United Nations Convention on the Law of the Sea.

In a statement on June 29, the court said it would not rule on questions of sovereignty over the land territory and would not delimit any maritime boundary between the parties.

China has repeatedly announced it will not abide by the arbitration court, saying the Philippines failed to exhaust negotiations to settle disputes.

Former Foreign Undersecretary Lauro Baja Jr. said "China will use every excuse to justify (its moves). They (Chinese) are worried that the tribunal panel will rule against them."

"The decibels of China's rhetorics is increasing. If we analyze the statements coming from China, they look like people who are losing," Baja said.

Comply with ruling

The Philippines has called on China to respect and comply with the decision.

The DFA said it was confident that the arbitration ruling would be favorable to the Philippines, but maintained it would "respect and comply" if ever the ruling was favorable to China.

A key factor that could change the equation of the consequences of The Hague ruling is how President Duterte decides to respond.

His predecessor, Benigno Aquino III, filed the case, straining Manila's relations with Beijing, but Duterte has shown readiness to mend frosty ties with China.

Mr. Duterte has pointed out the benefits of nurturing friendly relations with Beijing, including a Chinese offer of financing railway projects in the Philippines. His rise has given China an opening to make inroads in one of America's closest security allies.

Last week, Mr. Duterte said

his administration stood ready to talk to China if the Philippines gets a favorable ruling.

"When it's favorable to us, et's talk," he said. "We are not prepared to go to war, war is a lirty word."

It remains to be seen, however, how far Mr. Duterte can stray rom Manila's critical stance on Beijing's territorial assertiveness, given his country's close ies with Washington and growing nationalist sentiment gainst Chinese actions.

The decision of the arbitral

court would test the mettle of Mr. Duterte as the country's chief diplomat, said Chester Cabalza, a professor at National Defense College of the Philippines.

Jay Batongbacal, an expert on South China Sea issues at the University of the Philippines, said Manila should avoid revealing its cards ahead of potential negotiations with Beijing, "otherwise you lose the leverage that you have."

Experts say the outcome of the dispute could provide am-

munition for other countries involved in disputes with China.

Six states have overlapping territorial claims in the South China Sea—China, Vietnam, the Philippines, Taiwan, Malaysia and Brunei.

In addition, China's ninedash line overlaps waters that are part of Indonesia's internationally recognized exclusive economic zone.

"This is a time for China not to keep pushing forward too aggressively because they could embolden Vietnam and Indonesia to file a case as well," said Bonnie Glaser, senior adviser for Asia at the Center for Strategic and International Studies in-Washington.

Regardless, the ruling is unilikely to stop China from continuing to pursue more effective control over the sea space and airspace of the South China Sea, Glaser said.

US exercises

Over the last few months, the United States has held combined exercises by two Navy aircraft carrier strike groups off the coast of the Philippines and freedom of navigation cruises near China's man-made islands to assert its presence in the Western Pacific.

Chinese state media have accused Washington of trying to turn the South China Sea "into a powder keg" and warned it not to underestimate China's determination to defend its territorial claims.

Chinese warships, fighter jets and submarines have held live-fire war games as part of what the People's Liberation Army Navy called routine exercises in the week running up to the tribunal's ruling, drills that were seen at least in part responding to the US presence.

"There's a real game of nerves going on here with China perhaps assuming that the US is bluffing and the US hoping that China will actually not test American resolve," said Hugh White, professor of strategic studies of Australian National University. China urged to respect UN arbitral court ruling

Netizens called for #CHexit or a Chinese exit from contested waters, while Manila urged Beijing to respect whatever ruling is issued today by a UN-backed tribunal on the two countries' dispute in the South China Sea.

With over 40 nations – including the richest and most powerful ones – voicing support for arbitration to settle the maritime row, the Philippines said the world expects China to respect and uphold the verdict of the Permanent Court of Arbitration on the case filed by Manila contesting Beijing's expansive claim in the South China Sea and West Philippine Sea.

The tribunal will issue its ruling today at approximately 11 a.m. in The Hague (5 p.m. in Manila).

"We are calling on China to also do the same thing, to respect and comply with the decision especially when the decision is not in favor of China," said Foreign Affairs spokesman Charles Jose.

Victoria Bataclan, ambassador to Belgium and Luxembourg and head of the Philippine Mission to the European Union, said Manila has made clear its readiness to abide by any ruling of the arbitral court.

"Since under UNCLOS an impleaded party is bound by a tribunal's ruling whether it

participates or not, it therefore behooves China, as a law-abiding member of the community of nations, to do likewise," Bataclan said, referring to the United Nations Convention on the Law of the Sea, which both countries have ratified.

"The issue of the South China Sea must be raised as widely as possible, because it involves a country whose ability to affect the lives of everyone in the planet has increased along with its economic clout," Bataclan said.

"China is indeed on the rise, and the rest of the world, including the European Union, expects her to respect and uphold the basic principles which the international order is based," she added.

The Philippines is hopeful the tribunal would not give China the "golden key" to a scenario of Beijing's ninedash line becoming a "Berlin Wall of the Sea" and a "giant fence" owned exclusively by China.

Ahead of the ruling, Filipinos in China this weekend received mobile phone text messages from their embassy, warning them not to discuss politics in public and to avoid engaging in discussions on social media. They were advised to carry their passports and residency permits with them at all times and to contact the embassy or Chinese police if there are any untoward incidents.

China says much of the

building and reclamation work it has been doing in the South China Sea is to benefit the international community, including for civilian maritime navigation.

The official China Daily said yesterday that China will soon start operations of a fifth lighthouse in the South China Sea, on Mischief Reef.

Taiwan is also watching the case closely.

Its single holding of Itu Aba is the biggest feature in the Spratlys and the one some analysts believe has the strongest claim to island status and an exclusive economic zone.

"If the ruling touches on our sovereign rights we will respond strongly," said deputy foreign minister Leo C.J. Lee to lawmakers in a parliamentary committee session yesterday.

The coast guard, which directly oversees Itu Aba with the support of the military, will not "soften" its defense of the island, coast guard chief Lee Chung-wei added.

Arbitration backers

The Washington-based think tank Center for Strategic and International Studies (CSIS) said 40 countries have voiced support for the arbitral proceedings. They are Albania, Australia, Austria, Belgium, Bosnia and Herzegovina, Botswana, Bulgaria, Canada, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland,

Italy, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Moldova, Montenegro, Netherlands, New Zealand, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, United Kingdom, United States, Vietnam and members of the European Union. While the last may not have issued individual statements, their support is based on EU statements presented as the position of all members.

Countries supporting China's position included Afghanistan, Gambia, Kenya, Lesotho, Niger, Sudan, Togo and Vanuatu.

At a US congressional hearing last week, Abraham Denmark, deputy assistant secretary of defense for East Asia, urged both parties to comply with the ruling. Denmark said it was a chance to determine whether the region's future will be defined by adherence to international laws or by "raw calculations of power."

China might use strong rhetoric but not take aggressive action to avoid having the topic dominate the agenda at upcoming multilateral forums, said Bonnie Glaser, senior adviser for Asia at the Center for Strategic and International Studies in Washington.

Glaser said Chinese officials she's spoken to say privately they hope the case would not rule entirely in the Philippines' favor so that Beijing can say in internal discussions that Chinese interests have not been "irreparably harmed."

Rody factor

3 Indonesian fishers seized-AFP

CITY-Sulu-ZAMBOANGA based bandits on Sunday kidnapped three Indonesians in the waters of Lahad Datu, Malaysia, the military said here yesterday.

Maj. Filemon Tan Jr., Armed Forces of the Philippines West-Command Mindanao spokesperson, said the victims-Lorence Koten. Teo Dorus Kopong and one identified only as Emanuel-were crew members of a fishing boat.

Tan said the suspects originally took all eight crew members

of the vessel hostage but later tors as Salim Susulan. freed five. He identified the vessel owner as Chia Tong Lim.

In Sulu, soldiers on Saturday morning rescued a 23year-old school teacher who had been abducted by armed men last month.

Tan said members of the 41st Infantry Battalion rescued the teacher of Kanlagay Elementary School in Kalingalan Caluang town in Sulu.

The victim, who was held in Barangay Tagbak in Indanan town, said she was taken by armed men while on her way to school on June 20. She identified the leader of her abduc-

The other suspects were identified as Lauril Susulan, Basar Saudan, Jipy Susulan and Salma Saudan.

Tan said the victim told him she was forced to marry Salim on June 27.

He said the teacher was res-

cued when she screamed while the vehicle she was riding in stopped at a military checkpoint, prompting the soldiers to ask the passengers to alight and come inside the camp of the 12th Light Armored Cavalry.

The suspects are in the custody of the Indanan police.

Gov't troops in Surigao clash with NPA

BUTUAN CITY – A fire fight between government forces and New People's Army (NPA) rebels erupted Sundaymorning in Barangay Amontay, in San Francisco town, Surigao del Norte, First Lieut. Ryan D. Layug, Civil Military Operation (CMO) officer of the Army's 30th Infantry Battallion (30th IB) yesterday said.

According to Layug, troops from the 30th IB were responding to complaints by villagers about the presence of unidentified armed men in the vicinity when the encounter took place. The encounter lasted 10 minutes before the armed men retreated and left behind an M16 Armalite rifle and live ammunition.

"There was no casualty on our operating troops in the area," he added.

Meanwhile, a soldier from the 36th Infantry Battallion (36th IB) was wounded in a clash on Sunday with another lawless armed group (LAG) at Sitio Hitaob, Barangay Awasian, Tandag City, Surigao del Sur.

An initial report reaching this city said the wounded soldier was Pfc.

Marjun Bayo, who sustained wounds in his right arm and left leg due to a landmine blast. He was declared in stable conditionon Monday.

The gun battle took place after the command section of the 36th IB received a report from a concerned villager of the presence of suspicious armed men in their barangay, who were allegedly extorting money from the residents, claimed 36th IB Civil Military Operations (CMO) officer Capt. Francisco Gallero, Jr., in a press statement yesterday. (Mike U. Crismundo)

Soldier hurt in pursuit against NPA abductors in Surigao del Sur

Butuan City – A soldier of the Philippine Army 36th Infantry battalion was wounded at the weekend while conducting hot pursuit operation against members of the New People's Army (NPA) at a hinterland village in Tandag City, Surigao del Sur after the abduction of the police officer.

Last July 5, 2016, members of the NPA abducted PO1 Richard Yu Jr., of the Carmen Municipal Police Station at around 6:25 in the morning in Sitio Hubason, Barangay San Vicente, Carmen town, Surigao del Sur to investigate allegations about drug trafficking in the area.

Lt. Col. Randolph P. Rojas, commanding officer of the 36th IB based in Tandag City, said that at around 8:00 in the morning, Pfc Marlojun Bayo was wounded when an improvised explosive device (IED) went off, fracturing his left arm and then suffering a gunshot wound on his right thigh from the ensuing firefight.

Bayo was immediately brought down from the scene of the encounter at the hinterland area of Sitio Hitaob to Tandag City, where he was rushed to Adela Serra Ty Memorial Medical Center for initial treatment before being airlifted to the army hospital at 4th Infantry Division headquarters in Patag, Cagayan de Oro City.

"Our soldiers were conduction a hot pursuit operation at the farthest part of Barangay Awasian to confirm reports that elements of the NPA band who abducted PO1 Yu were in the area. The NPA rebels might have been alerted to the arrival of our troops under Bravo Company, and then took advantage of their familiarity of the terrain as our troops were approaching. They had set up the explosive device along the route, and the 15-minute firefight immediately followed the explosion," said Rojas.

Captain Joe Patrick Martinez, spokesman of the 4th ID, confirmed that the soldier has been brought to Cagayan de Oro City after a quick stop at Butuan City. The soldier is out of harm's way and is now recovering from his wounds.

Ka Sandara Sidlakan, spokesperson of the NPA's Front 21 operating in Surigao del Sur confirmed the incident and described it as "an ambush".

"We used the controlled detonated device to suppress the firepower and ability of the soldiers since we acknowledge that they have superiority in arms. But it was not a landmine or an explosive device that we just leave on the ground that might endanger anyone who passes by. We buy the line that the military operation was connected with the abduction, since the military campaign has been going on long before we abducted the police officer. We think the Army is just using the abduction as a pretext to intensify their operation even though we've already indicated that we have plans to release PO1 Yu," said Ka Sandara, adding that the military operation could further complicate the release of Yu back to his family.

Kidnapped teacher rescued in Sulu

ZAMBOANGA CITY – A public school teacher kidnapped on June 20 was rescued by government troops in Indanan, Sulu on Saturday, an official said yesterday.

Ratina Abubakar, 23, of Kanlagay Elementary School in Kalingalang Caluang town, was in a vehicle with her captors when they were pulled over at a checkpoint in Barangay Tigbak, said Maj. Filemon Tan Jr., spokesman for the Western Mindanao Command.

"While the troops were checking the vehicle, the victim screamed and told the troops she had been kidnapped," Tan said.

The soldiers seized the vehicle and brought the passengers to the 12th Light Armored Calvary Troops headquarters for questioning.

Abubakar was turned over to her family.

The victim said she was on her way to school at around 6 a.m. when she was taken by a group of men led by Salim Susulan.

Abubakar said Susulan brought her to a barangay hall and forced her to marry him.

The other suspects were identified as Lauril Susulan, Basar Saudan, Jipy Susulan and Salma Saudan. They are being held at the Indanan police station.

Soldiers rescue teacher forced to marry captor

A TEACHER who claimed she was abducted and forced to marry a Muslim man was rescued on July 9 while government security forces were conducting a routine checkpoint in Barangay Tagbak, Indanan, Sulu.

Major Felimon Tan Jr., spokesman of the Western Mindanao Command (Westmincom), identified the rescued kidnap victim as Ratina Abubakar, 23, a teacher

at Kanlagay Elementary School.

Tan said Abubakar screamed for help while inside a Mitsubishi Strada just as troops of the 41st Infantry Battalion were manning a checkpoint.

He said Abubakar told the soldiers she "was forcibly taken by her captors, identified as Lauril Susulan, Basar Saudan, Jipy Susulan, Salim Susulan and Salma Saudan."

"During the initial debriefing, Abubakar disclosed that at around 6 a.m. on June 20 she was on her way to school when she was forcibly taken by the group of Salim Susulan and later brought to the Barangay Hall in Kanlagay, Kalingalan Caluang, Sulu," Tan said.

"Abubakar further disclosed that she was held captive by Salim for several days and that she was forcibly married to him according to Muslim rites on June 27, 2016," he added.

After the interview, the military turned over the victim to her family. The suspects were brought to the Indanan Municipal Police Station for the filing of appropriate charges.

18 Sayyaf men killed, 9 hurt in Basilan

ZAMBOANGA CITY – Eighteen Abu Sayyaf bandits have been killed and nine others wounded in firefights with government troops in Basilan since last week, an official said yesterday.

Maj. Filemon Tan Jr., spokesman for the Western Mindanao Command, said two of the fatalities were identified as Julkifli Sariul and Kussien Pallam Seong while among those wounded

were Boy Indama, Abdul Karim, Hakim Jalul, Bong Assam, Albert Tuason and Gapul Melling.

Tan said ground forces are validating the identities of the other slain bandits.

The group is led by Isnilon Hapilon and Furuji Indama.

"Military operations are ongoing in coordination with the police and local governments of Basilan and Sulu to neutralize the Abu Sayyaf," he said. He said three bandits tagged in the kidnapping of broadcast journalist Ces Drilon in Sulu in 2008 were killed in separate encounters in Sulu on Wednesday last week. The bandits were identified as Sabtola Mahalli, Mallah Sangkula and Bas Sariyul.

THE Armed Forces of the Philippines has launched an "all-out war" against the terrorist Abu Sayyaf Group (ASG) in the South, the AFP Western Mindanao Command (Westmincom) announced on

The military vowed to defeat the ASG in response to President Rodrigo Duterte's order for an the intensified conduct of focused military operations launched by the Joint Task Forces Zambasulta in Zamboanga, Basilan, Sulu and Tawi-Tawi.

Earlier, Gen. Ricardo Visaya, AFP chief of staff, met with top military officials and soldiers of the Westmincom, telling them about the intensive campaign against the use of illegal drugs.

Visaya spoke before troops of the Philippine Army's 104th Brigade, in Barangay Tabiawan, Isabela City, Basilan, and troops of the 2nd Marine Brigade in Barangay Busbus, Jolo, Sulu, during his official visit on Sunday (July 10) to discuss operational measures taken by ground troops in defeating the Abu Sayyaf.

The AFP chief of staff then inspected facilities and equipment in Kuta Heneral Teodulfo Bautista Station Hospital stationed in Jolo, Sulu.

Brig. Gen. Retituto Padilla Jr., AFP spokesman, said Visaya conducted assessment and examination of the ongoing operation against the jihadists, lawless elements and other terrorist groups in southern Mindanao to know if there is a need to adjust operational requirements.

AFP: 40 Abu Sayyaf dead in Sulu, Basilan clashes

THE military yesterday said soldiers have killed around 40 members of the Abu Sayyaf since last week in skirmishes in the provinces of Basilan and Sulu, based on intelligence reports gathered by troops,

At least 25 other members of the group notorious for kidnapping for ransom were wounded.

On the government side, the fatality remained at one, said Maj. Filemon Tan, spokesman of the military's Western Mindanao Command. Six other soldiers were wounded in the Sulu clashes.

"Focused military operations are intensified, in coordination with the police and the local governments of the provinces of Basilan and Sulu, to neutralize the Abu Sayyaf Group," said Tan.

Tan said "heavy firefight" was ongoing in Basilan as of 4:30 p.m. yesterday, "involving armored vehicles, artillery fires and close-air support."

The fighting in Basilan, particularly in the towns of Unkayan Pukan and Albarka, broke out last Wednesday. The criminals were under Isnilon Hapilon and Furuji Indama, the military said.

In Sulu, the fighting erupted last Thursday in Patikul town, against the group of Abu Sayyaf leader Radulan Sahiron. Artillery rounds were de-

Tan said the breakdown of Abu
Sayyaf casualties is 18 dead and
nine wounded in Basilan, and 22
killed and 16 wounded in Sulu.

He said some of the reported slain bandits were Julkifli Sariul, Kussien Pallam Seong, Sabtola Mahalli, Mallah Sangkula, and Bas Sariyul.

Tan said Mahalli had a standing warrant of arrest for involvement in the kidnapping of ABS-CBN reporter Ces Drilon in June 2008 and Filipino-Chinese businessman Nelson Lim in April 2011.

In his assumption speech last July 1, AFP chief Gen. Ricardo Visaya vowed non-stop operations against the Abu Sayyaf, in keeping with the thrust of President Duterte to crush the group.

Visaya said the military will be unrelenting in the operations against

the Abu Sayyaf and its allied groups. Army chief Lt. Gen. Eduardo Año has said the goal is to end the Abu Sayyaf within the term of Visaya who is retiring in December.

The Abu Sayyaf is still keeping a dozen foreign and Filipino hostages in Sulu, including seven Indonesian tugboat crew members abducted from the Sulu Sea last June 22.

Authorities are still in the process of validating if the Abu Sayyaf was also responsible for the kidnapping of three more Indonesian tugboat crew members in Malaysian waters last Saturday.

Tan said the military is not "discounting the fact that the said abduction may have been perpetrated by the Abu Sayyaf Group, but the probability is low based on proximity and the intelligence reports gathered by troops."

Malaysian authorities did not directly link the Abu Sayyaf to the kidnapping but said the victims were likely brought to the southern Philippines. The three were abducted off the east coast of Sabah on Borneo island.

AFP spokesman Brig, Gen. Restituto Padilla also said the military is still validating the report.

"We cannot confirm it up to now. We are still collating information to determine if this really took place or if a group from our country is involved," Padilla told a briefing in Camp Aguinaldo.

Told that Malaysian authorities suspect the victims may have been brought to Sulu, Padilla said: "Yes, they mentioned it but they didn't confirm if the group is from there (in Sulu)... This could be the result of their speculation."

"On the part of the Philippines, unless we have clear proof that they are within our territory and they are within some of our islands, we cannot confirm it," said Padilla.

Indonesia urges action from RP as high-seas kidnappings surge

Philippines and Malaysia to do more to secure their "unsafe" waters after the weekend abduction of sailors by suspected Islamist militants.

Armed men in a speedboat kidnapped the three sailors late Saturday from a Malaysian-flagged trawler in Malaysian waters off Borneo island and took them toward the strife-forn southern Philippines, officials said.

"Serious efforts, I repeat, serious efforts, must be taken immediately both by the Philippine and Malaysian governments."

3 Indonesians kidnapped by suspected ASG members

Group (ASG) kidnapped three Indonesian fishermen on the weekend in the latest in a series of incidents highlighting weak security in the Cerebes Sea that borders Malaysia, Indonesia and the Philippines.

The head of Indonesia's intelligence agency said on Monday that the men were working on a Malaysian fishing boat off Lahad Datu in the Malaysian part of northern Borneo. Sutiyoso, who goes by one name, said the kidnappers fled with their hostages into Philippine waters.

Several crew on the fishing boat escaped

and are now in Malaysia.

Indonesia, Malaysia and the Philippines agreed in May to carry out coordinated patrols in border waters, following kidnappings of Indonesian tug boat and barge crews by ASG militants based in the southern Philippines. The three governments are concerned that unchecked kidnappings, piracy and other crime could undermine commerce in the region.

The Indonesians, who were held captive in the jungles of Sulu province in the southern Philippines, were later released. The Indonesian government denied it had

been involved in paying a ransom.

"We are still investigating this case and continue to coordinate with the related institutions in the Philippines to find the location where the three hostages are being held," Sutiyoso told The Associated Press. "We suspect that the hostages are held by a militant group, which is part of the Abu Sayvaf network."

The Philippines, meanwhile, has stepped up its military offensive against Abu Sayyaf, which earlier this year beheaded two Canadians it had held hostage since September. AP

Air Force wants HQ near Iloilo Airport

ILOILO CITY-To be able to operate more efficiently during calamities and beef up military operations, the Tactical Operations Group of the Philippine Air Force (PAF-TOG6) is reviving the proposal to acquire a headquarters adjacent to the Iloilo Airport.

Col. Rey Bes, PAF-TOG6 commander, said there's a need for the Air Force to be near the airport located in

Cabatuan and Sta. Barbara towns.

Since the June, 2007 closure of the old airport in Iloilo City, PAF-TOG6 relocated to Dingle town, where the Philippine Army's 301st Infantry Brigade (301 IB) is based.

However, this has posed challenges when carrying out both civic and military operations as the 301 IB headquarters can only accommodate helicopters and not a C-130, the military transport aircraft.

Speaking at the regional celebra-

tion of the Air Force's 69th anniversary, Bes said too much money is spent for logistical costs to shuttle personnel and other equipment between the 301 IB headquarters and the airport.

PAFTOG6 is still negotiating with Civil Aviation Authority of the Philip-

pines (CAAP).

It is also tapping the assistance of Department of Environment and Natural Resources (DENR) as the adjacent lots near the airport are privately-owned.

ASG death toll in Basilan, Sulu military offensives now placed at 40 By Priam F. Nepomuceno

MANILA, July 11 (PNA) --- In the almost week-long military offensive against Abu Sayyaf Group (ASG) terrorists in Basilan and Sulu, a total of 40 terrorists were believed to have been killed and another 25 wounded.

This was disclosed by Western Mindanao Command (WESMINCOM) spokesperson Major Filemon Tan in an interview Monday.

ASG casualties can be broken into two military offensives, with the first one in Basilan which started July 6 and still ongoing as of this posting.

In this operation, 18 bandits were reported killed and other nine wounded.

In the Sulu offensive, which started July 7, terrorists reported killed reached 22 and 16 wounded, Tan added.

Focused military operations are intensified, in coordination with the police and the local governments of Basilan and Sulu, to neutralize the bandit group. (PNA) RMA/PFN

Abducted teacher rescued by soldiers in Sulu

ZAMBOANGA CITY — Soldiers rescued on Saturday morning a school teacher who was abducted in Sulu last month.

Major Filemon Tan Jr., spokesperson of the Western Mindanao Command, said members of the 41st Infantry Battalion rescued the 23-year-old teacher, who had been working at the Kanlagay Elementary School of Kalinggalang Caluang town.

The victim, who was rescued in Barangay Tagbak in Indanan town, said she was taken by armed men while she was on her way to school on June 20. She identified the leader of her abductors as Salim Susulan. The other suspects were identified as Lauril Susulan, Basar Saudan, Jipy Susulan and Salma Saudan. Tan said the victim claimed she was forced to marry Salim on June 27.

Tan said the teacher was rescued when she screamed while the vehicle she was riding in stopped at a military checkpoint, prompting troops to invite its passengers to the camp of the 12th Light Armored Cavalry Troops. The suspects are now in the custody of the police in Indanan town. **SFM/rga**
