



# 17 senators back Koko for Senate presidency

LP, NPC align with majority led by PDP-Laban

#### By Christine O. Avendaño

WITH the Liberal Party (LP) and the Nationalist People's Coalition (NPC) joining emergent Partido Demokratiko Pilipino-Lakas ng Bayan (PDP-Laban), a "supermajority" has emerged in the Senate, giving President-elect Rodrigo Duterte control of Congress and assuring support for his legislative agenda that includes a shift toward federalism and the return of the death penalty.

Sen. Aquilino "Koko" Pimentel III, president of the PDP-Laban that fielded Duterte as its standard-bearer in the May 9 elections, is likely to be voted Senate President in the 17th

Congress.

Pimentel, Senate President Franklin Drilon of the LP and Sen. Vicente Sotto III of the NPC have decided to join forces to form the supermajority of 18 senators, Sotto told the INQUIRER yesterday, two months before the new Congress convenes on July 25.

Only 13 members are required to form the majority in the 24-member Senate.

"We are elevating the coalition arrived at the House of Representatives to the Senate," Sotto said, referring to the alliance of political parties forged in the lower chamber under incoming House Speaker Pantaleon Alvarez of PDP-Laban.

Yesterday, an LP delegation led by Speaker Feliciano Belmonte Jr., flew to Davao City, seat of the government in waiting, to discuss a deal with Duterte and Alvarez to bring President Aquino's disintegrating Daang Matuwid coalition into the PDP-Laban fold, which had only three representatives elected last month.

Duterte, whose campaign promise was "radical change," snubbed a joint session of Congress last week that convened as the national board of can-

vassers to proclaim him winner of the May 9 balloting to become the 16th President of the Republic, as lawmakers began leapfrogging to abandon the ruling coalition and join the new regime in the season of turncoatism.

Under the deal outlined by Sotto to the Inquirer, Drilon will be the Senate President Pro Tempore, while Sotto will be the majority leader.

Sotto and Drilon, along with Pimentel, had earlier served notice they wanted to be the Senate President in the 17th Congress.

Others in the supermajority are Senators Ralph Recto, Bam Aquino, Francis Pangilinan, Leila de Lima, Joel Villanueva, Risa

Hontiveros—who all run under the LP ticket—Juan Edgardo Angara, Panfilo Lacson, Grace Poe, Loren Legarda, Francis Escudero, Gregorio Honasan II, Nancy Binay, Sherwin Gatchalian and Manny Pacquiao.

The rest of the senators are either from the United Nationalist Alliance, Laban ng Demokratikong Pilipino and independents.

#### Minority of none

In a Twitter message, Lacson put the number of the supermajority at 20.

He told the Inquirer everyone was welcome to the group. "We want to experience a Senate mi-

nority of none, for a change,"
Lacson said.

"We are looking at a working and cooperative relationship with the incoming President without sacrificing the independence of the Senate," Sotto said.

Duterte has vowed tough measures against criminality, including the return of the death penalty, as the centerpiece of a program to spur economic growth.

He has also announced he wanted to amend the Constitution and adopt the federal system of government.

Ejercito, Richard Gordon, Miguel Zubiri and Antonio Trillanes IV were welcome to join the group.

#### Commitment

Cayetano is also contesting the Senate leadership. He earlier said he had the support of 15 senators.

Villar has openly declared support for Cayetano's bid. While Pacquiao had signed a resolution supporting Cayetano, he ended up in the supermajority.

Sotto last week said he was in talks with 18 senators on building a new majority in the incoming Senate and this included Pimentel.

Pimentel had earlier said the Senate presidency could not be formed without talking to the groups of Sotto and Drilon.

Sotto had said he had nine senators who were solid for him while Drilon said he had seven senators supporting his own bid.

Villar said it was too early to predict the outcome of the race for the Senate presidency. She said she remained committed to Cayetano's bid for the post.

"That's the commitment. It would not be good if you would always change your commitment,", she told reporters yesterday.

Both Villar and Cayetano belong to the Nacionalista Party, which had forged an alliance with PDP-Laban.

#### Tradition

Villar's son, Rep. Mark Villar, has been drafted by Duterte to be secretary of the Department of Public Works and Highways, an appointment that has been roundly criticized on grounds of conflict of interest. The Villar family is one of the country's largest real estate developers.

Asked if she would be ready to be a member of the Senate minority, Villar said that would be OK with her. But she said she wanted to keep her chairmanship of the agriculture committee, as she believed she could do a lot to improve agriculture in the country.

"That's my wish and I don't think I will lose it. Even if you're a member of the minority, you're entitled to your previous committee if you had not left it," she said.

This is a Senate "tradition," she said. She also noted that there would be a lot of committee chairmanships to be vacated by the lawmakers leaving the legislature, which the Senate newcomers could get. With a report from Leila B. Salaverria

# Metro anti-crime drive on

#### By NON ALQUITRAN

In Caloocan City, bodies of apparent victims of summary executions have turned up. Elsewhere, drug suspects are being rounded up, people drinking in the streets picked up and curfews on children enforced.

As police prepare to welcome a new president, a crime drive is sweeping Metro Manila, with men being apprehended for merely going shirtless outside their homes to cool down in the muggy weather.

Eight more drug suspects were arrested in separate sting operations in Parañaque and Quezon City on Monday night.

Three kilos of shabu, with an estimated street value of P18 million, were confiscated by members of the Criminal Investigation and Detection

The three were nabbed in a parking lot along Bradco Avenue, Macapagal Boulevard, Parañaque at around 11 p.m., Senior Supt. Joel Pernito, CIDG

Region 4-A chief, said.

Pernito said an informant tipped off police about the drug pushing activities of the suspects.

He said an undercover police officer arranged the sale of a kilo of shabu with the suspects for P5 million.

Pernito said the suspects earlier agreed to conduct the drug sale in Cavite but decided at the last minute to hold the payoff along Macapagal Avenue.

The suspects were arrested after handing over a kilo of shabu to the undercover officer in exchange for P5 million, Pernito said.

He said a search of the suspect's black sports bag yielded two more kilos of shabu.

The suspects are being held at the CIDG Region 4-A head-quarters on drug charges.

In Quezon City, police arrested five people for alleged possession of marijuana bricks worth P63,000.

The suspects were nabbed after police received information of illegal drug trade in Barangay Old Balara at around 6:30 p.m. on Monday.

Operatives of the Batasan police station anti-illegal drugs

unit arrested Ronna de la Calzada, 25; Nelbert Villanueva, 33; Ian Pua, 42; John Adrian Balisi, 24 and a 16-year-old boy.

They will be charged with violation of Republic Act 9165 or the Comprehensive Dangerous Drugs Act, police said.

Prior to their arrest, police apprehended a group of men playing "cara y cruz" in the area. They were Alexander Enriquez, 24; Louie Matas, 20; Ricardo Tuliao, 30; Richard Lancebal, 33 and a minor.

Police also recovered a .38-caliber revolver from Enriquez.

The suspects will be charged with illegal gambling. A separate complaint for election gun ban will be filed against Enriquez.

### Summary executions

Meanwhile, a vigilante group is believed to be responsible for a spate of killings of suspected criminals in Caloocan City.

A source did not confirm or deny that the group was composed of active police officers, but admitted that the killings had "clearance from above."

The bodies of two men,

said to be victims of summary executions, were found in Barangay 171, Bagumbong, Caloocan last week.

One of the fatalities was identified as Ryan Vincent Modesto, 19. He bore bullet wounds, his mouth gagged

with masking tape and his hands tied.

A cardboard with markings, "Huwag ninyo akong tutularan, holdupper ako!" was placed on

his body. The body of a man – burned beyond recognition – was discovered by a tricycle driver in front of St. Mary's Academy in Grace Park, Caloocan on

Friday. On Saturday, the bodies of a man and woman were dumped under the Sampaguita Bridge in Barangay 171, Bagumbong

Scene of the crime operatives said the fatalities bore gunshots to the head and strangulation marks.

Police said Richard Guiab, a former member of the Bulacan police allegedly involved in illegal drugs and carjacking, was shot dead by two men on a motorcycle while he was walking along Jasmine street in Camarin.

In Valenzuela City, a tattooed man described as being between 19 and 25 years

old was found dead along Sto. Rosario street, Barangay Mapulang Lupa

Last month, the mutilated bodies of a man and woman were found stuffed in sacks in Barangay Tugatog, Mala-

"Maybe law enforcers have had enough of crime and illegal drugs in the Camanava (Caloocan, Malabon, Navotas, Valenzuela) area. But until such time that a group comes out and owns up to these killings, all we can do is to speculate," the source said.

#### 'Shabu cop'

Meanwhile, the National Bureau of Investigation (NBI) has asked the Anti-Money Laundering Council (AMLC) to look into the bank accounts of a policeman earlier caught with shabu and around P7 million in cash in a raid on his house in Sampaloc, Manila.

The NBI said Police Officer 2 Jolly Aliangan, whose home was described in television reports as fit for a general, allegedly has P30 million in bank deposits.

The NBI is considering filing money laundering charges against Aliangan, who was reportedly engaged in reselling drugs seized from previous raids on the New Bilibid

Prison.

The bureau also asked the AMLC to forfeit Aliangan's

properties.

Aliangan, who was assigned at the National Capital Region Police Office Regional Anti-Illegal Drug unit, reportedly owns three homes, including a three-story house on Palawan street in Sampaloc

He also owns a Mitsubishi Montero and a Toyota Altis.

NBI agents recovered from Aliangan 300 grams of shabu and a vault containing P6.9 million in cash.

#### 4 cops nabbed for drugs, extortion

Meanwhile, four policemen tagged in illegal drugs and extortion were arrested in separate operations in Davao Oriental and Bulacan on Mon-

Senior Police Officer 4 Nollo Barsaman and PO2 Jesus Mante Jr. tested positive for drug use, according to Chief Inspector Noel Asumen, officer-incharge of the Mati City police

Asumen said Barsaman was found in possession of drug

paraphernalia.

Supt. Harry Espela, Davao Provincial Police Office director, said Barsaman and Mante would be slapped with administrative charges.

In Bulacan, members of the Criminal Investigation and Detection Group (CIDG) apprehended PO3 Winston de Leon Mariano and PO1 Benjamin Sauban for allegedly extorting money from a couple whom they nabbed during a shakedown.

MAGUINDANAO - A soldier was wounded when an improvised bomb went off along the road in Datu Unsay town yesterday.

Capt. Joann Petinglay, spokesperson for the Army's 6th Infantry Division, said the unidentified soldier was brought

to a hospital and declared out of danger.

Members of the Bangsamoro Islamic Freedom Fighters were believed to be behind the explosion to prevent soldiers from going to a village, where the bandits extort money from residents.

"There are continuing patrols in the area to maintain tranquility there, particularly this time when peace is needed to ensure an undisrupted observance of the Ramadan," said Petinglay.

# Troops repulse attempt to attack construction site in Zambo del Norte

ZAMBOANGA CITY (PNA) — Military forces are now tracking down a group of lawless elements that harassed a construction firm undertaking a government project in a remote area of Zamboanga del Norte.

Supt. Rogelio Alabata, Police Regional Office-9 (PRO-9) spokesman, said the harassment occurred around 2:30 p.m. Monday in Sitio Nasal, Barangay Puliran, Sibuco, Zamboanga del Norte.

Alabata said the workers of a local construction firm were constructing a concrete bridge when a group of lawless elements opened fire.

Alabata said a brief firefight ensued as the squad of soldiers from the Army's 42nd Infantry Battalion

providing security to the workers returned fire:

He said the lawless elements led by Jamaruddin Alih alias Boy Taka fled towards northeast direction heading to Barangay Puliran, Sibuco, upon sensing the arrival of government reinforcements.

He said no one among the construction workers and the security forces were either killed or injured during the brief firefight.

He said the troops have uncovered an encampment of the lawless group around 500 meters away from the project site.

He said the troops have strengthened the security measures to ensure the completion of the government project.

#### TROOPS CLASH WITH BANDITS, CAMP SEIZED IN ZAMBOANGA

ZAMBOANGA CITY: Government troops captured an encampment of suspected bandits following a firefight in the town of Sibuco in Zamboanga del Norte province in southern Philippines. Superintendent Rogelio Alabata, regional police spokesman, said they have alerted their forces in the town after

troops clashed with bandits who attacked soldiers guarding a government bridge project in Puliran village. Alabata said oldiers from the Army's 42nd Infantry Battahon seized the bandit's encampment about 500 meters from the construction site. Police said armed groups have been extorting money from construction companies in the province. It was not immediately known if the armed men were affiliated with other rebel groups actively operating in the Zamboanga Peninsula.

# Army soldier hurt in Maguindanao blast

COTABATO CITY, Maguindanao: A soldier of the Army's 34th Infantry Battalion (34IB) sustained shrapnel wounds when members of the outlawed Bangsamoro Islamic Freedom Fighters (BIFF) set off an improvised explosive device (IED) along a road in Barangay Meta in Datu Unsay town, early Tuesday.

Capt. Jo-Ann Petinglay, spokesperson of the Army's 6th Infantry Division (6ID), said the BIFF rebels were trying to prevent patrolling Army troops from getting close to a village whose residents they subject to rebels' taxation.

Datu Unsay is an impoverished town located in the second district of Maguindanao. Its for-

mer mayor, Datu Andal "Unsay" Ampatuan, Jr., is now detained as the principal suspect in the Maguindanao massacre.

Army officers of the 34IB said they were surprised with the bombing, something they never thought the BIFF would perpetrate at a time when its leaders and members are observing Ramadan.

"There are continuing community patrols by soldiers in the area to maintain tranquility there, particularly at this time when peace is needed to ensure an undisrupted observance of Ramadan by local folks," Capt. Petinglay said.

Muslims fast from dawn to dusk during Ramadan, which lasts for one lunar cycle. They avoid creating trouble or hurting their fellowmen and instead focus on good deeds and charitable acts as atonement for sins and as a religious obligation.

Warfare is strictly prohibited during the Ramadan, regarded by Muslims as a "holy month," during which they reach out and reconcile even with their enemies.

But the recent explosion in Datu Unsay indicates the BIFF no longer respect or do not care to follow the spirit of the holy month.

Capt. Petinglay said the wounded combatant is now confined in a hospital here in this city and is now out of danger.

### 2 soldiers wounded in Maguindanao blast

TWO soldiers were wounded yesterday when an improvised bomb exploded while they were on patrol in Datu Unsay town in Maguindanao.

Authorities were still determining the identities of the perpetrators and their motive, said Capt. Jo-ann Petinglay, public affairs officer of the Army's 6th Infantry Division.

Petinglay said authorities are still left with no suspects, noting armed lawless groups in Maguindanao have been "quiet" for some time now.

Several armed groups are known to operate in the province, including the Bangsamoro Islamic Freedom Fighters, a faction of the Moro Islamic Liberation Front which signed a peace accord with government in

March 2014.

Petinglay said the incident occurred at 5:55 a.m. in Barangay Meta, involving troops from the Army's 34th Infantry Battalion.

Wounded were a sergeant and a private first class, Peringlay said but declined to name them.

A police report said four soldiers were wounded in the blast, and identified them as one Sgt. Felix Pisngot, Pfc. Marlon Bacnotan, Pfc. Sany Devalleres and Pfc. Danny Varon.

The report said the wounded soldiers were brought to the Maguindanao Integrated Provincial Health Office.

### 'Duterte must honor EDCA comm

The incoming Duterte administration must honor its commitment to implement the Enhanced Defense Cooperation Agreement (EDCA) signed by the Philippines and the US, former foreign secretary Albert del Rosario said yesterday.

Speaking at a forum at the National Defense College of the Philippines, Del Rosario, chairman of the Albert del Rosario Institute (ADRi), said EDCA is a significant component for the Phl-US alliance to move forward.

Asked if the Philippines stands to lose face should it not implement EDCA, Del Rosario said the new administration has accepted the treaty.

"We're trying to move forward with it. It's a very imBy JAIME LAUDE

portant mechanism in terms of moving forward with our treaty alliance," he said.

President-elect Rodrigo Duterte, while saying that EDCA will be honored, wants to deepen ties with China. He has also expressed openness to dealing with China bilaterally to settle the country's maritime row with Beijing in the South China Sea and West Philippine Sea, but only if multilateral talks prove futile after four years.

Del Rosario said he is not opposed to bilateral talks. He said that timing is a factor if the new administration would enter into bilateral negotiations with China.

"We favor negotiations but the timing must be geared toward the conclusion of the

arbitration because of so many reasons, the most valid is the tribunal. We must await the decision before we can start talking to China. Otherwise the judges are going to think twice about what we're doing," Del Rosario said.

He was referring to the arbitration case the Philippines filed against Beijing before the Permanent Court of Arbitration in The Hague, wherein the country questioned the legality and validity of China's nine-dash-line in the South China Sea.

# US, PH urged to commit to EDCA

A Washington-based think tank said it is critical for both the Philippines and the United States to fulfill their commitments under the Enhanced Defense Cooperation Agreement (EDCA).

Gregory Poling, director, Asia Maritime Transparency Initiative (AMTI) and fellow with the chair for Southeast Asia Studies at Center for Strategic and International Studies (CSIS), said this yesterday at a forum held at the National Defense College

of the Philippines (NDCP) in Camp Aguinaldo, Quezon City.

"I think it's critical for both countries to commit that EDCA be fulfilled. Washington has a responsibility here too," said Poling, noting that "(incoming President Rodrigo) Duterte seems legitimately skeptical of how the US is willing to go in its commitment."

"If that's his position then it makes sense for him to recognize our limits to the use of EDCA, that's leverage for the Chinese, but I think in Washington there is a very broad consensus in government that they will really go to... for the Philippines if China really uses force in the South China Sea," Poling told reporters.

"Clearly more work needs to be done by Washington to convince Duterte of that," he added.

The Philippines' next step under EDCA was among key points discussed at yesterday's forum, dubbed as "Asia-Pacific Perspectives on Implementing the Enhanced Defense Cooperation Agreement."

# France calls for EU patrols in Spratlys

France has called for more European naval patrols in the South China Sea to defuse the growing conflict between China and the United States and its allies in Asia, according to a report by for-

eignpolicy.com.

French Defense Minister Jean-Yves Le Drian, speaking at a three-day security conference in Singapore on Sunday, said European navies must have a "regular and visible" presence in the disputed area to uphold the law of the sea and freedom of navigation.

"If we want to contain the risk of conflict, we must defend this right and defend it ourselves," he said.

While Le Drian did not mention China, his remarks were apparently aimed at Beijing, which has constructed military facilities on artificial islands.

"If the law of the sea is not respected today in the China seas, it will be threatened tomorrow in the Arctic, in the Mediterranean, or elsewhere," Le Drian said during the Shangri-La Dialogue, hosted by the International Institute for Strategic Studies.

France's stance marked the latest international pushback against China's tough tactics in the strategic waterway, where more than \$5 trillion worth of goods pass through annually, foreign-policy.com reported

Le Drian said he would provide more details on his proposal.

Last year, Japan said it would consider conducting naval patrols in the South China Sea even if it and China have their own dispute in the East China Sea

This year, India has been airing its concern over China's challenge to free navigation in the Western Pacific region, the website said.

The Permanent Court of Arbitration in The Hague is set to rule this month on the sea row between China and the Philippines and Beijing said it will not recognize the tribunal's authority.

The international court is expected to rule against China, the website said, and the US has called on the Chinese government to abide by the decision.

Mira Rapp-Hooper, a senior fellow at the Center for a New American Security, says the timing of Le Drian's remarks may mean that European Union governments may "come out in vocal support of the Hague decision in a few weeks," foreignpolicy. com reported.

France has forged a \$40-billion deal to sell submarines to Australia, citing fears over the region's security, and called for greater French presence around its colonies in the Southern Pacific.

# NOLCOM gets replica of 1743 Murillo Map

AMP AQUINO, Tarlac City

— The framed replica of
the 1743 Murillo Map of the
Philippine Archipelago which
depicts the Panacot Island (Scarborough Shoal), was received Monday by
the Northern Luzon Command (NOLCOM), here.

Mr. Mel Velarde, President and CEO of Now Corporation and Chairman of the Board, Asian Institute of Journalism & Corporation, handed over the framed replica of the 282-year-old document to Lieutenant General Romeo T. Tanalgo, NOLCOM commander

Velarde also donated copies of the map to other NOLCOM Field Units, which were all received in bulk by Tanalgo.

Known as the Fr. Pedro Murillo Velarde Map, the centuries-old document originally called "Carta Hydrographica y Chorographica de las Islas Filipinas" was first published in 1734 in Manila by Fr. Pedro Murillo Velarde, a Jesuit priest.

The map shows islands that are now known as Scarborough Shoals or Bajo de Masinloc, marked (in the Murillo Map) as Panacot Island, as part of Philippine's territory. They are shown around 120 miles off the west coast of the main Philippine island of Luzon


Acquired at Sotheby's auction in London for P12 million, Velarde said he was very eager to buy the map because. this could be the solid evidence that constitute the veracity and accuracy of our claim to the (disputed) islands.

"Why is the replica of the Murillo Map being donated at Northern Luzon Command? The Northern Luzon Command is the protector, watcher, caretaker, defender of Bajo De Masinloc under Northern Luzon Command's direct jurisdiction," Velarde said.

The Philippine government has been using this map as proof of its claim over the South China Sea. It also locates Scarborough Shoal, then known as "Panacot," also called "Panatag" by Filipinos, off the shores of Luzon, then known as Nueva Castilla. Scarborough Shoal has been a National issue between the Philippines and China that needs to be addressed.

# '3 PAGTS WILL BE SIGNED IN OSLO'

CPP's Sison expects immediate truce, prisoners freed

#### **By Joyce Pangco Pañares**

COMMUNIST Party of the Philippines founding chairman Jose Ma. Sison said he expects to conclude three agreements—including one paving the way for an immediate ceasefire—during the two-day exploratory talks in Oslo on June 15 and 16 with incoming peace adviser Jesus Dureza and incoming government chief negotiator Silvestre Bello III.

"There will be agreements on the release of the political prisoners, an interim ceasefire and a plan to accelerate the peace negotiations," Sison told **The Standard** in an interview from Utrecht.

"The interim ceasefire will take effect with the release of all political prisoners through a general amnesty until the successful conclusion of the peace negotiations. The formal peace talks will include a comprehensive and detailed agreement on the permanent end of hostilities," he added.

Sison will be joined by National Democratic Front chief negotiator Luis Jalandoni and Fidel Agcaoili, while Dureza and Bello will bring with them incoming government peace panel member Hernani Braganza.

"We will discuss confidencebuilding measures during the exploratory meeting," Bello said. "The ceasefire proposal from the CPP-NDF is already a major step forward."

Bello said he will retain current government peace panel member Efren Moncupa for the negotiations with the communists. **Next page**

Formal peace talks between the Aquino administration and the CPP-NDF-NPA bogged down in February 2011.

Talks could not resume because the communist group has been demanding the reactivation of the Joint Agreement on Safety and Immunity Guarantees (Jasig), which will give safe conduct passes to communist negotiators and political consultants

The government earlier rejected the NDF's proposal to draft a new Jasig list after the original one, stored in a very old floppy disk, got corrupted and could no longer be retrieved.

Bello said things will change under a Duterte administration, starting with the reconstitution of the Jasig.

"We will recommend to him [President-elect Rodrigo Duterte] that we honor the Jasig and other previously signed agreements," Bello said.

Duterte has expressed his desire to end the nearly five-decade-long insurgency through a comprehensive peace agreement with the CPP-NDF-New People's Army.

Known to be close to the left, Duterte even announced his choice of progressives to join his Cabinet, including Judy Taguiwalo to head the Department of Social Welfare and Development and Rafael Mariano to head the Department of Agrarian Reform.

Earlier, Sison said he will return to the Philippines as soon as a final peace pact is signed even as he acknowledged rumors that he will be assassinated once he arrives in the country.

"Assassination? I will not return to the Philippines without any guarantee on my personal security. And in case I am killed, Duterte will be responsible for that," he added.

# Libingan ng mga Bayani is for heroes only

Many of us are surprised that President-elect Rodrigo Duterte plans to bury the late dictator Ferdinand E. Marcos in the Libingan ng mga Bayani, the place where the heroes of the country are laid to rest. This news was met with much resistance because to bury Marcos alongside other national



heroes would be an insult to the thousands who suffered under martial law and are still awaiting justice.

In fact. Duterte's close ties with the Marcos family are one of the most controversial topics that continue to crop up when the President-elect is asked questions or faces the media. When I see news of people dying because of drugs or rapists roaming free and hurting others, I admit I get mad and want "an eve for an eye" justice. However, where does one draw the line? If I have the freedom to buy a gun and kill someone as a vigilante, what's to stop someone from doing the same to me or to others?

I wrote in previous columns that I supported the death penalty and that has not changed. After all, crime is so rampant in the country and it seems as if those who would break the law really have nothing to fear. I still think reinstating the death penalty will go a long way in addressing crime in the Philippines, but I do think this must be coupled with fair justice and due process. I can't say I am onboard with the buying of guns and the gunning down of "drug dealers" without due process. To be honest, I don't envy the task ahead for our President-elect. There is just so much to be done and he is most definitely going to face adversity along the way. As early as now, he is already facing problems with the way his statements and his actions are construed. # CenterLaw voices alarm over Duterte's acceptance of NPA kangaroo court

ENTERLAW, a nongovernment organization dedicated to the promotion of the Rule of Law in the Philippines and Asia, reminded President-Elect Rodrigo Duterte that as president of the Philippines, which he will be in 23 days, he is legally bound to ensure that every one within Philippine sovereignty is accorded due process of law.

CenterLaw expressed grave concern over the statement of Duterte that he is leaving the fate of police Chief Inspector Arnold Ognachen of the General Generoso, Davao Oriental to his captors, the New People's Army.

Duterte, which has included the Communist Party of the Philippines in his government, had worked for the release of policemen captured by the CPP's armed group before the May elections. He had also called for the release of Ognachen, who was captured when the NPA recently raided the Davao Oriental police station.

But in his press conference last Thursday, he said an NPA commander told him that they seized drugs from Ognachen adding the rebel leaders would not lie to him.

Duterte is waging war against illegal drugs, "I said I'd be harsh. I'm sorry for that guy," he said.

He said he told the NPA commander, "You have a kangaroo court.... Sentence him to 20 years

of hard labor."

Romel R. Bagares, Centerlaw executive director, noted the double irony of Duterte referring to the NPA's justice system as "kangaroo courts."

"Because that is exactly what they are – tribunals that make a mockery of even just a modicum of justice," he said.

Bagares said, Duterte, who is a lawyer and a former prosecutor, "should know that we now have Republic Act 9184, the International Humanitarian Law Act, which penalizes as a war crime all executions without a judgment of a regularly constituted court that afforded all judicial guarantees generally recognized as indispensable."

The International Humanitarian Law Act, passed in 2010, embodies the country's commitment to the Geneva Conventions and the Rome Statute establishing the International Criminal Court.

Bagares recalled that in a series of official reports on summary executions and extrajudicial killings in the Philippines from 2007 to 2010, then UN special rapporteur Philip Alston called on the Communist Party of the Philippines (CPP) and the National Democratic Front to put an end to the NPA's so-called 'people's "courts", because these violate fair trial standards set by international human rights law and international human rights law and international humanitarian law.

Bagares said "Common article 3 of the 1949 Geneva Conventions, which applies to all combatants in the Philippines, prohibits the passing sentences without a judgment by a regularly constituted court, 'affording all the judicial

guarantees which are recognized as indispensable by civilized peoples."

"Moreover, the 1977 Additional Protocol provides that the court must be independent and impartial, and the accused shall have the right to be at the trial and present a defense, among other guarantees."

Bagares further said:" In fact, the Bill of Rights of our 1987 Charter – under which he will swear his oath of office as President – likewise prohibits the deprivation of life without due process of law.

The NDF, of which the CPP and the NPA are members, is a coalition of 16 groups waging a so-called protracted people's war for national democracy in the Philippines for more than four decades now.

News reports said when the NPA got Ongachen, they also captured two other persons and seized seven shotguns, 12 rifles, two 9mm pistols and three undetermined types of firearms.

Outgoing PNP chief Ricardo Marquez said they respect the president-elect's pronouncements but they will have to rescue Ongachen.

"It is our responsibility to rescue our people if they are kidnapped," Marquez said.

AST Friday Dr. Aileen Baviera of the University of the Philippines Asian Center delivered a public lecture on the impact of the West Philippine Sea (South China Sea) maritime dispute on domestic stakeholders.

Hers was the first presentation from this year's batch of UP President Edgardo J. Angara fellows-UP scholars and researchers awarded individual grants to study some key policy issues. Her lecture primarily centered on how the ongoing maritime disputes have affected defense and law-enforcement agencies, including the Philippine Navy, Philippine Air Force, Philippine Coast Guard (PCG), PNP Maritime Group and the Bureau of Fisheries and Aquatic Resources (BFAR)

Through interviews and focus

group discussions, Baviera found that many of the frontline agencies' concerns relate to their capability to deal with issues, given the mismatch between their respective mandates and resources placed at their disposal.

These frontline agencies also are faced with a lack of clarity on the nature and geographic scope of their missions, as well as unclear rules of engagement and "gray zones" created by the activities of foreign forces. fishermen are the ones encroaching on the Philippines's exclusive economic zone. The confusion is confounded by what Baviera described as the "immaturity" of our maritime governance bureaucracy, demonstrated by lack of central guidance on policy and strategy.

Alarmingly, a deeper ambiguity is felt by local government units (LGUs)—particularly in Palawan, Zambales and Pangasinan. Some LGUs, Baviera said, appear to be disinterested and disengaged from

the country's broader foreign-policy goals, preferring to toss the maritime disputes to the national government—even though they are in the best position to address the negative effects of the disputes on the ground.

The most seriously affected appears to be fisherfolk. For instance, one National Coast Watch Center study estimated that up to 50 percent of the local fishermen in Masinloc, Zambales—which is very close to Bajo de Masinloc—lost their livelihood, with many having to rely on food rations provided by the municipal government, some even placing the blame on the Philippine government.

This stakeholder analysis points up to the need for a clearer commandand-control setup. As Beijing has openly expressed it will disregard whatever ruling of the Permanent Court of Abritration, the next administration must urgently prepare the domestic constituency to tackle the eventuality.

# Army division chief honors 'best and brightest' officers, personnel

Petinglay explained that the PRB is awarded to Army personnel who complied and passed the five performance measures as specified in the directive of the Philippine Army, to wit: Physical Fitness Test (PFT), Marksmanship, Net Take Home Pay, Latest Career Course, and Officer's Appraisal Report/Enlisted Personnel Evaluation Mark.

The personnel awarded with gold category have the highest average score for the five categories and obtained a score between 93 percent to 100 percent.

She added PRB intends to recognize the readiness status and capabilities of the Army Personnel, which is one of the transformations in the Philippine Army to further empower the officers and enlisted personnel.

# Troops clash with bandits, camp seized in Zamboanga town

Government troops captured an encampment of suspected bandits following a fire fight in the town of Sibuco in Zamboanga del Norte province in southern Philippines, police said Tuesday.

Superintendent Rogelio Alabata, a regional police spokesman, said they have alerted their forces in the town after troops clashed with bandits who attacked soldiers guarding a government bridge project in Puliran village.

Alabata said there were no reports of casualties in the Monday's fighting, but soldiers from the army had seized the bandit's encampment about 500 meters from the construction site.

He said soldiers from the 42<sup>nd</sup> Infantry Battalion recovered bullet shells from the camp, which was quickly abandoned by bandits led by Jamaruddin Alih.

Police said armed groups have been extorting money from construction companies in the province. It was not immediately known if the armed men were affiliated with other rebel groups actively operating in the Zamboanga Peninsula.

# Army commander assures presence in Leyte despite troops' deployment to Mindanao

A top military official in Eastern Visayas assured the continuing Army presence in Leyte province despite the recent transfer of the 19th Infantry Battalion (IB) to North Cotabato.

Maj. Gen Velarmino, commander of the Army's 8th Infantry Division based inCatbalogan City in Samar, said that the pull out of troops was in response to the order from higher officials to augment troops in conflict-stricken Mindanao provinces.

"Although we transferred them to Mindanao, that doesn't mean that we will leave the northern part of Leyte. I assigned two units of reconnaissance team from Samar and Division Headquarters to occupy the vacated area of 19th IB," Velarmino told reporters.

Velarmino assured insurgency situation in Leyte is manageable considering that most of the towns covered have been declared as rebel-free.

The absence of 19th IB will not also affect the on-going activity of the government to declare areas in Leyte as insurgency-free, according to the commander.

"It was only stopped due to election, but we will continue it again with the assessment of Leyte province." he added.

Prior to the transfer, the Army has declared 17 towns under the jurisdiction of the unit as insurgency-free. These are the towns of Matag-ob, Merida, Palompon, Tabango, Barugo, Babatngon, San Miguel, Leyte, Pastrana, Tolosa, Dagami, Calubian, Sta. Fe, Alangalang, Tunga, Carigara and Palo.

The 19th IB based in Kananga town with 400 soldiers, including their officials left the province on May 29, 2016.

Sending the unit to Mindanao shows that Leyte insurgency situation is more manageable than in Samar provinces, according to Velarmino.

The battalion covers the northern part of Leyte and Biliran province. The southern part of Leyte is under the 78th Infantry Battalion stationed in Burauen, Leyte.

Velarmino added that sending troops to Mindanao is also part of their battalion retraining.

"If they were not pulled out they would be non-operational by August 1. They are currently undergoing battalion re-training in Carmen, North Cotabato before their assignment to the 6th Infantry Division," Velarmino added.

The official is still unsure when the 19th IB will be re-assigned to Leyte again.

The battalion is the second unit of the 8th Infantry Division moved to Mindanao to help in the peacekeeping effort.

In 2009, top Army officials deployed the 46th Infantry Battalion from Samar province to Mindanao after the Maguindanao massacre. The battalion is now in Pantukan, Compostela Valley after its assignment in Shariff Aguak, Maguindanao.

This is not the first time that the 19th IB was deployed in Mindanao. From 1974 to 1979, the unit was sent to Maguindanao and Lanao del Sur. In 2001 to 2002, the battalion was assigned in Sulu and Zamboanga City.

On May 30, members of the Cadet Corps who went on road run were already heading back to their bivouac area when Margin collapsed at around 4:45 p.m., the military statement said.

"He was immediately attended to by the medical team following the road run and was brought to the medical dispensary of the Marine base," it added.
