

# after r Court decision seen to help start talks

THE UNITED States on Wednesday called on China and other rival claimants to exercise restraint when an international tribunal issues a landmark ruling on the South China Sea disputes that Beijing has chosen to ignore.

A senior US state department Asian and Western governofficial, who spoke on condition of anonymity to Asian journalists through a teleconference, said the upcoming 'decision by the arbitration panel in The Hague may offer "a great deal of clarity" on the disputes and help the claimants forge an arrangement to avoid potential confrontations.

She said the decision, expected within weeks, could also serve as a jumping-off point to diplomatic talks.

"We would certainly call on all governments to exercise restraint and to use this post-arbitration period as an opportunity to restart those diplomatic discussions," she said.

China has said it would not recognize any arbitration deci-Army Col sion despite calls by several

ments for it to respect international law.

Some tear Beijing may take a harder stance and take provocative actions if it comes under pressure from outside, including by the United States, to comply with an adversarial rul-

In a harsh attack on US policies in Asia, the flagship newspaper of China's ruling Communist Party on Wednesday accused Washington of seeking to turn the South China Sea "into a powder keg" and warned it not to underestimate China's determination to defend its territorial claims.

cent combined exercises by two US Navy aircraft carrier strike groups off the eastern coast of the Philippines as a sign of US hegemony and said Washington had made a mistake in seeking to intimidate China.

In making displays of military power aimed at China, the United States has "picked the wrong counterpart." said the editorial, the contents of which are usually vetted by high ranking party officials.

#### **Competing claims**

US military activity, including freedom of navigation cruises near China's man-made islands and exercises with allies, is contributing to the militarization of the region, the editorial said.

China claims almost all of the 3.5-million-square-kilometer South China Sea, in-

cluding waters close to the shores of its smaller neighbors in the region.

The Philippines, Brunei, Malaysia and Taiwan have overlapping claims in the South China Sea, a crucial waterway where \$5 trillion in global shipborne trade passes every year and where islets, reefs and atolls are believed to be sitting atop vast energy reserves.

Beijing prefers one-on-one negotiations with each of the rival claimants, an arrangement that gives it advantage because of its sheer size and clout and prevents Washington from playing any role to resolve the conflicts.

In the case filed in the United Nations Permanent Court of Arbitration, the Philippines challenged the validity of China's "nine-dash line" claiming virtually the entire stretch of the South China Sea and demanded respect for its right to explore resources in waters within its 370-km exclusive economic zone (EEZ)

The Philippines also asked the tribunal to rule whether several disputed areas are outcrops, reefs or islands and how much stretch of territorial waters they project.

#### Natuna incidents

The US official also expressed concern over China's Coast Guard ships escorting Chinese fishing vessels in areas including Indonesia's Natuna Islands, where Indonesian vessels fired warning shots on Friday.

Indonesia has rejected China's stance that the two nations have overlapping claims on "maritime rights and interests" in the South China Sea. Indonesian Foreign Minister Retno Marsudi on Wednesday said his country had "no overlapping claims in any form in Indonesian waters with China."

But Jakarta has objected to Beijing's inclusion of waters around Natuna Islands within its "nine-dash line" claim to almost all of the South China Sea.

A Chinese fishing boat entered those waters on Friday, prompting an Indonesian naval vessel to fire a warning shot, injuring one person.

It was the third reported confrontation between Indonesian naval vessels and Chinese fishing boats near the Natuna Islands this year.

#### Confrontation at Ayungin

The Philippines also has stood up to China's bullying in the South China Sea, with a small, rickety Bureau of Fisheries and Aquatic Resources vessel outsmarting a large Chinese Coast Guard ship to restock a small Marine garrison on the BRP Sierra Madre on Ayungin Shoal (Second Thomas Shoal) in the Spratly Islands on March 29, 2014.

The next day, the Philippines submitted evidence to the arbitration court in The Hague, which proceeded to hear the case despite China's refusal to take part in the proceedings.

In his last week in office, President Aquino is waiting for the ruling, which he hopes will be in favor of the Philippines.

"We have done what we can [to obtain] a resolution that is fair to all parties concerned," Mr. Aquino told reporters in a recent news conference.

# 'Thou shall not kill' is absolute - Pope

## Rody: Death is retribution, not deterrent

VATICAN CITY – Pope Francis is amplifying his opposition to capital punishment, saying it's an offense to life, contradicts God's plan and serves no purpose for punishment.

In a video message to an anti-death penalty congress in Norway, Francis declared the commandment "Thou shalt not kill" has absolute value and applies both to the innocent and to the guilty.

Francis has gone beyond his predecessors and traditional Catholic teaching in saying there is simply no justification for the death penalty today. He said Tuesday that rather than rendering justice, it forters vengeance.

Church teaching allows for recourse to capital punishment when it is the only way to defend lives "effectively" against an aggressor.

"It must not be forgotten that the inviolable and Godgiven right to life also belongs to the criminal," he said.

Francis sent the video message to the delegates of the sixth World Congress against capital punishment, currently being held in Oslo, Norway

The pontiff did not mention any particular country in his message.

He stressed the practice of capital punishment

brings no justice to victims.

"Indeed, nowadays, the death penalty is unacceptable, however grave the crime of the convicted person," Francis said in the message.

The World Congress in Oslo discussed the need to sustain the move in abolishing the death penalty

in some countries.

As of today, 140 nations have abolished the death penalty, as compared to only 16 countries in 1977.

The Republic of the Congo, Fiji, Madagascar, Mongolia and Suriname become the latest countries

to formally abolish capital punishment.

The death penalty is prevalent in Asia and the Middle East, with Pakistan, Saudi Arabia and Iran responsible for 89 percent of recorded executions in 2015. This does not include China, where official statistics on its use are considered a state secret.

China, Iran, Iraq, Saudi Arabia and the US are the

five biggest executioners in the world.

Other countries have passed counterterrorism laws that expanded the list of crimes punishable by death

In the Philippines, president-elect Rodrigo Duterte has announced his intent to bring back the death penalty, 29 years after its abolition was formally adopted.

Duterte stressed the need to revive the death pen-

alty which, he said, would serve as "retribution" for those who committed crimes

He said those who insist that the death penalty is not a deterrent to crime do not understand his posi-

tion on the issue.

"The death penalty might be a deterrence to commit a crime but that is one school of thought," Duterte said. "Death penalty to me is the retribution. It makes you pay for what you did."

Even without capital punishment, Philippine police have killed more than 60 drug suspects all over the country in the six weeks since Duterte was

elected on May 9

The death penalty was abolished in 1987 during the time of President Corazon Aquino but was revived in 1993 under President Fidel Ramos. Around a handful of convicts were executed during the abbreviated term of then president Joseph Estrada

Crimes punishable by death include murder, rape,

kidnapping and drug trafficking

Former president Gloria Macapagal-Arroyo, a devout Catholic, signed a law abolishing capital punishment in 2006.

Duterte reiterated that he would not hesitate to kill those who seek to destroy the youth, which he

said is the future of the country

"Do not destroy my country because I will kill you. Do not destroy my children because I will kill you," he said.

Duterte, who has pummeled critics of his strong

anti-crime drive, said he would just ignore Commission on Human Rights Chairman Chito Gascon, who has been critical of his plans

"If you know Gascon or if he is your friend, tell him I won't follow him," he said.

Duterte also made an unusual threat against incoming senator Leila de Lima,

who vowed to scrutinize the law enforcement operations of the next administration.

"If De Lima does not shut her mouth, I will kill her – with love. If she agrees, I don't know," he remarked. - AP, Alexis Romero

## 29 troops, ASG terrorists killed or wounded

Twenty-nine soldiers and Abu Sayyaf terrorists were either killed or wounded after intense clash erupted between government troops and the bandit group in the outskirts of Sulu Tuesday afternoon.

Maj. Filemon Tan Jr., spokesman of the Western Mindanao Command (Wesmincom), said that three Abu Sayyaf terrorists were killed while 10 others were wounded during the clash in Sitio Bud Duwa Bayho. Barangay Pansul, Patikul town at around 2:20 p.m.

On the other hand. Tan said that 16 soldiers were wounded.

The government casualties were immediately brought to Camp General Teodulic Bautista in Busbus, Jole for medical treatment.

According to Tan, elements of the Army's 32nd Infantry Battalion (IB) encountered more or less 200 Abu Sayyaf terrorists.

"The encounter lasted for about 1 hour and 30 minutes, after which the ASG members scampered toward separate directions," said

"Hot pursuit operations are still ongoing," he added.

The encounter was the first

contact between pursuing government troops and the Abu Sayyaf group following the beheading of Canadian Robert Hall last June 18.

Hall was beheaded after the deadline for the payment of P600 million ransom expired. His head was found near the Mt. Carmel Cathedral in Jolo while his body is yet to be recovered.

Last April 25, another Ganadian - John Ridsdel, was also beheaded by the Abn Sayyaf. His head was found in front of the Jole town hall while his body was recovered in the jungles of Suln days later.

The two Canadians were among the four hostages snatched from the posh Oceanview Resort on Samai Island last September. The other two -Norwegian Fjartar. Sekkingstad and Filiping Marites Flor, remained under Abi Saryaf captivity.

The terrorists threatened to harm Sekkingstad next of their P600 million ransom demand is not met.

Aside from Flor and Sekkingstad, the military said that the Abu Sayyaf also holds five other captives.

Tan did not mention if there was sighting of the remaining hostages during the clask in Parikul.

## 3 Abu Sayyaf killed; troops take 2 Sulu camps

ZAMBOANGA CITY – Three Abu Sayyaf gunmen were killed and 26 other combatants – 10 Abu Sayyaf and 16 soldiers – were wounded in a 90minutes firefight at a remote sitio in Patikul town in Sulu province Tuesday afternoon

Major Filemon Tan Jr., spokesman of the Armed Forces of the Philippines-Western Mindanae Command (AFP-

WestivinCom), reported that troops of the 32nd Infantry Battalion led by Lt. Col Ramon Fiores encountered about 200 Abu Sayyaf men at about 2:20 p.m. at Sitio Bud Duwa Bayho, Barangay Pansul, in Patikul, Sulu. The firefight between the military and the Abu Sayyaf lasted about 90 minutes leaving three ASG gunmen dead and 10 wounded. The 16 wounded soldiers were immediately brought to the Kuta Heneral Teodolfo Bau-

tista Trauma Hospital in Busbus, Jolo, Sulu, for treatment

As the military continued its operations in Sulu, the 45th Infantry Battalion overrun two major Abu Sayyaf camps in Barangay Sinumaan, Talipao, Sulu.

According to Tan, the two camps can accommodate approximately 150 persons. They had running trenches

and potable water within the perimeter of the two camps.

During a search in the camps, the military found hammocks, water containers, and other personal belongings of the Abu Sayyaf.

The AFP continues its operations in Sulu to rescue the remaining hostages that are still in the hands of the Abu Sayyaf.

## PA Mobile C3 Center deployed during nationwide quake drill

The Philippine Army's (PA) mobile command, control and communication center was tested during the second Metro Manila Shake Drill and National Simultaneous Earthquake Drill (NSED) Wednesday.

It is also known as the PA Mobile C3 Center, said Army spokesperson Col. Benjamin Hao.

It is the latest land based mobile communication platform developed by the Army.

Col. Vener Odilon D. Mariano, PA Assistant Chief-of-Staff for Command and Control Communication and Cyber System, said the PA Mobile C3 Center is the latest land based mobile communication platform developed by the Army.

"This Mobile C3 Center will serve as the alternate Army Operations Center for continuous command, control and communications for humanitarian assistance and disaster response (HADR) operations of the Army," he added.

The PA Mobile C3 Center is equipped with major means of communications ranging from high frequency (HF), very high frequency (VHF), ultra high frequency (UHF), air and marine bands including satellite voice capability.

It can communicate in different Armed Forces of the Philippines and Army major units through voice and data using the telephone extenders and its radio communications.

Hao said the PA's participation in the earthquake drill aims to prepare the military personnel and its dependents before, during and after the earthquake to save lives and properties.

The Army's HADR units were also alerted to respond during the occurrence of disasters and calamities.

The PA is one of the government agencies that is immediately deployed as first responders during disasters.

ZAMBOANGA CITY, Philippines – Remember that longtime campaign of donating school supplies in shoeboxes to children? The Philippine Army has adopted that with its "Project Shoebox: Shoebox ko, Para sa Pag-aaral Mo."

The Sigma Alpha Sorority of the University of the Philippines Los Baños had a better idea, though: It launched the shoebox project to bring gifts to soldiers in Basilan.

"Project Shoebox: Bayanihan para sa mga Bayani ng Bayan" seeks to give military personnel personal items as a way of thanking them for their sacrifices for the country.

On Friday, June 17, the Sigma Alpha Sorority turned over 1,500 giftboxes to the military personnel of the 104th Brigade, 18th Infantry Battalion, 64th Infantry Battalion, 3rd Scout Ranger Battalion, 4th Special Forces Battalion, and 8th Field Artillery Battalion of the Philippine Army.

The turnover ceremony was held at the headquarters of the 104th Brigade.

The boxes contained hygienic kits, clothes, reading materials, and other tokens from donors.

The Army started its Project Shoebox for school children through its Southern Luzon Command in 2012. The initiative, which was led by then Lieutenant Colonel Thomas Sedano Jr, then Commander of the 4th Light Armor Battalion, has since been replicated by other Army units.



#### P4.5M marijuana seized in Agusan del Sur

Cagayan de Oro City - Barely a week after the Caraga Police Regional Office 13 (PRO13) pounced on some PhP6.6 million worth of marijuana in Loreto, Agusan del Sur, a composite police and army raid confiscated around P4.5 million pesos worth of marijuana at a mountain barangay in the town of La Paz, Agusan del Sur, Monday afternoon.

"Our team, comprised of men from La Paz Municipal Police Station, the Regional Intelligence Division and soldiers from the Army's 26th Infantry Battalion, went to Km 32, Barangay Valentina, and seized marijuana stalks weighing around 36.5 kilograms and an estimated Dangerous Drug Board valuation of PhP4,562,500," said Police Superintendent Michael Lozada, spokesperson of PRO13. Lozada pointed out that the operation was conducted "based on information from the barangay chairman

Lozada pointed out that the operation was conducted "based on information from the barangay chairman of Barangay Valentina in the town of La Paz in Agusan del Sur by our provincial intelligence personnel. Aside from the already harvested marijuana stalks, our raiding team also discovered 30 more marijuana plants that the Dangerous Drug Board estimated to be worth Php6,000.00 planted in the area."

Lozada added that PRO13 is looking at the possibility there are more plantations in the area.

"We are intensifying our information collection activity in Agusan del Sur to pinpoint where the plantations are and who might be involved. We are also coordinating with the Bukidnon provincial police since the area is more accessible through Bukidnon, and most of the marijuana is shipped through their side rather than Agusan del Sur," he said.

Police Senior Inspector Ignacio Serano Jr, station commander of the La Paz Municipal Police station, revealed how the operation was conducted:

"After we received the information, the members of the provincial police intelligence unit, together with 16 soldiers and eight of my personnel, drove toward Barangay Valentina. We walked another six hours just to reach the location of the plantation, which is hidden by the forest. By my estimate, the area is about 60 kilometers away from the town proper of La Paz and it is almost at the border of Bukidnon," said Serano. Serano told InterAksyon that it was not easy to gain access to the area because of its remote geographical location and the possible risk of encountering insurgents.

## NDFP peace consultant on alert for missing tribesmen allegedly abducted by Army troops

BAGUIO CITY - Randy Malayao, a National Democratic Front of the Philippines (NDFP) consultant on the peace process, on Wednesday expressed concerns regarding the possible abduction of Aggay tribesmen of San Mariano, Isabela by elements of the Philippine Army 5th Infantry Division.

According to Malayao, the human rights group Karapatan-Cagayan Valley (Karapatan CV) has reported that some indigenous people in San Mariano have been taken away by Army troops operating under the 86th Infantry Battalion of the 5th Infantry Division.

"If there is some truth to this, or that some Aggays are being forced to serve as guide by patrolling troops, we condemn this as violation of protocols of war or of rules of engagement," Malayao said.

Karapatan, in an alert message, stated that 16 Aggays, including women and children, were seized by the government soldiers on June 17, 2016. The human rights group also reported that the soldiers illegally searched the huts of the Agtas.

Malayao said that KARAPATAN CV, with the Social Action Center of the Archdiocese of Ilagan City, Isabela and representatives of the Provincial Government of Isabela conducted a search for the missing Aggays.

According to the group, the 5TH Infantry Division denied that the Aggay tribesmen were in their custody.

Malayao added that Aggays interviewed by Karapatan-CV said some of their village mates were forced into a helicopter.

He said, while this still has to be verified, "ang malinaw, may ongoing military operations sa Tappa-Cadsalan-Buyasan area ng San Mariano (What's clear is that there is an ongoing military operation)."

### 3 Sayyaf killed, 2 camps captured in Sulu

ZAMBOANGA CITY -Three suspected Abu Sayyaf bandits were killed and 26 others wounded in a running gun battle in Patikul, Sulu, the military reported yesterday.

Maj. Filemon Tan Jr., spokesman for Western Mindanao Command (Westmincom), said government troops encountered a large group of Abu Sayyaf gunmen, triggering a firefight in a remote area in Barangav Pansul, Patikul town on Tuesday.

Among those wounded during the encounter were 16 soldiers, Tan said.

Tan said troops of the Army's 32nd Infantry Battalion figured in clashes with some 200 Abu Sayyaf in the area.

He said the gun battle lasted

for over an hour as troops tried to go after the bandits carrying their wounded.

Initial reports said 10 bandits were wounded.

The fighting erupted as government forces were on the offensive to rescue the remaining hostages of the Abu Sayyaf.

On Monday, troops overran two camps of the Abu Sayyaf in a remote village in Talipao.

Tan said the troops took the camps without any resistance from the escaping bandits. "There was no engagement when the troops captured the camp. But the indication was clear that the Abu Sayyaf hastily abandoned the camp and escaped," Tan said.

Tan said the troops continued to scour the area to prevent the Abu Sayyaf from moving away with their hostages.

The bandits have beheaded two other hostages, Canadians John Ridsdel and Robert Hall.

Aquino had admitted planning to impose martial law in Sulu in the effort to contain the Abu Sayyaf.

The Abu Sayyaf network is deeply entrenched and efforts to flush out its fighters have proved to be a big challenge for thousands of troops tracking them down.

The military had said some residents and relatives living in the islands of Sulu and Basilan are helping the bandits.

Duterte on Tuesday warned the Abu Sayyaf to surrender and release all hostages or face the consequences.

But the Abu Sayyaf laughed off Duterte's threat.

"Wage a war with no mercy

In the video, they said the ISIS has designated Abu Sayyaf leader Isnilon Hapiron as their "emir."

Armed Forces spokesman Brig. Gen. Restituto Padilla said the video was another propaganda by the Abu Sayyaf.

They have nothing to say except to spread evil and to propagate the values of radicalism and extremism. They are not very human in nature. These are animalistic and evil in their entirety," Padilla said.

## 3 Abu Sayyaf killed, 16 troops injured in clash, says AFP

MANILA – At least three fighters of the bandit group Abu Sayyaf were killed in a clash that also wounded 10 others in Patikul, Sulu on Tuesday.

Western Mindanao Command spokesperson Major Filemon Tan said at least 16 soldiers were also wounded in the firefight that lasted for more than an hour in Sitio Bud Duwa Bayho in the village of Pansul. Some of the soldiers were taken to the trauma hospital in Busbus, Jolo, Sulu for medical treatment while the others were airlifted to Camp Navarro General Hospital in Zamboanga City.

Tan said operating troops from the 32nd Infantry Battalion were scouring the village of Pansul as part of its rescue mission for the remaining hostages of the Samal Island resort kidnapping when they chanced upon more than 200 bandits.

On Monday, the government troops overran two temporary camps of the Abu Sayyaf Group in the village of Sinumaan, Talipao, Sulu.

The temporary encampment could accommodate more than 150 persons with workable trenches and water supply.

There were also hammocks recovered and some personal belongings of the bandits.

Meanwhile, Defense Secretary Voltaire Gazmin flew to Basilan on Wednesday morning to personally oversee the ongoing military operation against the bandits.

Tan said high-ranking military officers gave Gazmin a security briefing and development of the ongoing offensives that the military has been undertaking to neutralize some of the high-value targets in Basilan, including top commanders of the Abu Sayyaf and some foreign terrorists helping the bandits in the province

Tan added that there has been no let-up in their operation to rescue the remaining hostages being held by the Abu Sayyaf Group in Sulu. These include Norwegian Kjartan Sekkingstad and Filipina Marites Flor. They were among the four kidnap victims snatched in a resort in Samal Island in Davao del Norte September of last year.

The Abu Sayyaf group beheaded the two Canadian nationals, John Ridsdel and Robert Hall, on separate dates, after ransom was not paid.

## Sayyaf propaganda taunts Rody

#### BY VICTOR REYES

A DAY after President-elect Rodrigo "Rody" Duterte vowed to crush the Abu Sayyaf, a video purportedly coming from the international terrorist group Islamic State surfaced, calling on Filipinos to support the Abu Sayyaf which is notorious for its kidnapping for ransom activities.

A man in the video said Muslims should wage jihad by attacking government leaders, politicians, and Muslims who have rejected Islam in exchange for money. He said their houses and localities should be bombed.

"Do not pity them. Stab them with the use of bolo, pour gasoline on their residences. Be careful and

be strong and don't be misled by the tactics of the newly-elected President of the Philippines in the person of (Rodrigo) Duterte," he said.

The Armed Forces, through spokesman Brig. Gen. Restituto Padilla, dismissed the video as "propaganda."

He also said there is nothing new in the video which spread through social media.

In the video, a man brandishing a rifle urged Muslims to unite under Abu Sayyaf leader Isnilon Hapilon, who he said is the "amir" or prince of mujahiden in the Philippines. Hapilon, in a video released in 2014, was shown showing allegiance to the IS, a radical Islamic group.

Several other groups in Mindanao, including the Bangsamoro Islamic Liberation Front, a breakaway group of the Moro Islamic Liberation Front, have been linking themselves to the IS which has been suffering defeats in Iraq and Syria from US-backed military troops.

Padilla said, "People should not be bothered by this because its part of their propaganda they are propagating"

Padilla said asked members of the social media community not to spread the video.

"If you are a member of the social media community, let us not dignify this. Let us not give impor-

tance to this (video). Let's do what is right which is to delete it and don't pass it to others," Padilla said.

Duterte has vowed to crush Abu Sayyaf during his term. The Abu Sayyaf has about 300 to 400 members, mostly operating in the provinces of Sulu and Basilan.

Duterte has the image of being tough against crimes. He is also waging war against illegal drugs.

Meanwhile, three Abu Sayyaf men were killed while 10 others were wounded in a firefight with troops in Patikul town in Sulu on Tuesday afternoon.

Sixteen soldiers were also wounded.

Maj. Filemon Tan, spokesman of the military's Western Mindanao Command, said troops from the 32nd Infantry Battalion were on a security operation when they encountered

about 200 Abu Sayyaf men in Sitio Bud Duwa in barangay Pansul around 2:20 p.m. Tuesday.

Tan said the Army troopers clashed with the Abu Sayyaf men for one-and-ahalf hours, until the bandits "scampered towards several directions."

The fighting occurred eight days after the group beheaded Canadian Robert Hall in the nearby town of Talipao town for failure of authorities to pay ransom for him and his fellow Samal kidnap victims.

Hall was among the four people abducted from a resort on Samal island in Davao del Norte last September. He was beheaded on June 13.

The three others are Norwegian Kjartan Sekkingstad and Filipina Marites Flor, who are still in the hands of the Abu Sayyaf, and Canadian John Ridsdel who was beheaded last April 25 also in Talipao.

## Marcelino elated over DoJ decision junking

Villanueva, however, stressed they were not surprised by the DoJ decision, citing Marcelino was always on the side of truth.

"He is happy but we were expecting that decision because from the start Colonel Marcelino's conscience was clear," Villanueva said.

He added Marcelino is currently working on a position paper or a proposal which he plans to submit to the incoming administration of President-elect Rodrigo Duterte on how to better fight illegal drug menace

"His passion for anti-drugs and anti-criminality is really burning. He

really wants to contribute to the government's campaign in combatting filegal drugs," Villanueva said.

"He is looking forward to having responsibility in the government's anti-illegal drug campaign," he added.

Marcelino was charged with possession of illegal drugs and violation of the Comelec gun ban by PDEA and AIDG.

In a 15-page resolution, the DoJ, through Senior Deputy State

Prosecutor Theodore Villanueva, junked the charges.

"After an assiduous evaluation of the evidence presented by both parties, the DoJ finds the evidence so far presented by the PNP and PDEA insufficient of the required evidence to sustain a conviction during the trial on the merits of the case," the DoJ decision stated.

Marcelino, former intelligence officer of the PDEA, and Chinese interpreter Yan Yi Shou were arrested in a drug raid last January 21 at a house in Sampaloc, Manila. The operation yielded over P380

million worth of drugs.

The DoJ noted the search warrant for the house in Sampailoc was for a certain Lo Chi are "Tanda," Atong Lee aka "Atong and a certain Chu. Marcelino and "Yan were not seen during the casing and surveillance of the premises.

Known as a no-nonsense affitidrug operative, Marcelino denied any involvement in the illegal ffings trade and claimed he was on a surveillance mission at the clandestine shabu laboratory when the PDEA and PNP-AIDG conducted the raid. 

## Arming the Army

HE economy grew at 6.2 percent but not everyone was blessed, or impressed. Now take a look at how the Armed Forces have modernized, to the tune of 760 14 billion, to make the soldiers who guard our air, land, and sea stand straighter, taller.

A sampling of where that money went: 8 attack helicopters. 114 armored personnel carriers (they look like tanks). 120 ambulances. 2 FA-50 airplanes. 5 naval helicopters. 2 navy ships. 3 medium life aircraft. Radios and trucks. Close to 100,000 assault rifles.

Those weapons and machines my eyes can see, even when what they see are mere photographic likenesses. Unlike the GDP, which may be a big deal to economists but means little more than three letters of the alphabet to ordinary folks. the modernization of the Armed Forces is a dream come true for the men and women in uniform, their families, and fellow citizens who have been embarrassed for too long by an army without arms, an air force without airplanes, a navy without boats - a fighting force rich in fighting spirit and little else, such as bullets in short supply and shoes in the wrong sizes.

Well into his second can of Coke (regular) for the night - "no ice, ice dilutes the taste" - during a farewell dinner with us girls, the President did not dismiss my question, "How much is 60 B?" Ever ready with notes and numbers, the obsessivecompulsive President who reads military and history books produced a slip of paper showing how previous Presidents regarded the AFP: Arroyo (2001-2010, 9 years) spent P26.2 B; Estrada (1998-2000), P5.5 B; Ramos (1992-98), zero.

And as good weather is preferred to fly a plane, sail a boat, win a battle anywhere, it is not mere happenstance that military people as well as civilians can relate to PAGASA leveling up from "hoping only" to a 974 km forecast track error, better than the 120 km error threshold of the World Meteorological Organization! Project NOAH and its scientists save lives in fair and foul weather, and the sun shines on PAGASA's budget growing from ₱766 million to ₱3.4 billion.

Say what you will about the branding success or failure of "daang matuwid," but by arming the Armed Forces and providing sunny weather for PAGASA, this President has made his mark.

## We have to build credible force to deter foreign aggression – Incoming AFP chief

Incoming Armed Forces of the Philippines (AFP) chief-of-staff Lt. Gen. Ricardo Visaya vowed to prioritize the acquisition of modern equipment and weapons to make the Filipino military a more credible defense force.

"We have to build a credible force. We have to have a defense capability that can deter foreign aggression," he said in reply to question on whether he will continue to push for the AFP's modernization.

As of this posting, fruits of the AFP's ongoing modernization program include the two Hamilton-class cutters, six multi-purpose assault craft, 113 armored personnel carriers, three brand-new C-295 medium lift aircraft, two C-130 heavy transports, two FA-50PH light-interim fighter aircraft and eight attack versions of the AgustaWestland AW-109 "Power" helicopters, five landing craft heavies and two strategic sealift vessels to name a few.

Visaya said modernizing the AFP will allow the Philippines to stand up on its own against aggressors without dependence from other countries.

"Just like any Armed Forces, the AFP is bound to defend our country and secure our sovereignty," he added.

Visaya is slated to take command of the 125,000-strong AFP by July 1.

He is a member of the Philippine Military Academy Class of 1983 and outgoing commander of the Lucena, Quezon-based Southern Luzon Command.

#### Ample military assets deployed during nat'l quake drill

Adequate military assets were deployed during the 2nd Metro Manila Shake Drill and National Simultaneous Earthquake Drill.

This was disclosed by Armed Forces of the Philippines (AFP) spokesperson Brig. Gen. Restituto Padilla during a press briefing.

This includes three AgustaWestland AW-109 "Power" helicopters which has the capability to detect and transmit on real time videos of devastated areas in Metro Manila and six UH-IH air ambulances which could transport critical injured individuals to treatment centers in the aftermath of 7.2 magnitude earthquake.

These UH-IHs will be coming from the Northern and Southern Luzon Command and Joint Task Group-National Capital Region, Padilla said.

Also deployed are the Army's Libis, Quezon City-525th Engineering Combat Battalion which is the military's premier humanitarian assistance and disaster response unit.

An engineering battalion consists of around 500 - 1,000 officers and enlisted personnel.

It is equipped with a variety of bulldozers, backhoes and other heavy construction equipment.

Padilla said the 525th Engineering Combat Battalion is specialized in urban search-and-rescue and collapsed structure retrieval operations.

The 525th Engineering Combat Battalion was one of the first military units deployed to Leyte during the aftermath of Supertyphoon "Yolanda" in Nov. 8, 2013.

Together with units of the Catbalogan-based 8th Infantry Division, the 525th Engineering Combat Battalion helped clear debris from roads leading to Tacloban City and other parts of Leyte.

## AFP warns public not to dignify hate video calling for attacks

The Armed Forces of the Philippines (AFP) refused to comment on a viral video reportedly released by an "radicalist, extremism group" calling for massive attacks against people standing against their beliefs as it urged the public not to be swayed by such gesture.

"Do not glorify and dignify (statements and videos made by) these groups," AFP spokesperson Brig. Gen. Restituto Padilla said.

In the same vein, Padilla urged the public to refrain from spreading the video and delete it, so as not to spread the group's message of hate, radicalism and extremism.

"The message of the video is animalistic and evil in all its entirety," he added.

In the video, an unidentified terrorist group is calling for violent attacks against Christians and Muslim backsliders who are standing against them.

## SC orders PNP to probe abduction of CPA founding member

The Supreme Court (SC) has ordered the Philippine National Police (PNP) to investigate the abduction of James Balao, the founding member of the Cordillera People's Alliance (CPA).

The CPA is a coalition of non-government organizations (NGOs) which is advocating the interest of the indigenous people in the Cordillera Region.

Balao was abducted by five armed men on Sept. 17, 2008.

In the latest resolution of the SC on the case of Balao issued on Tuesday, the Armed Forces of the Philippines (AFP) and the Commission on Human Rights (CHR) were relieved of the duty to investigate the case.

Instead, the SC ordered the PNP to investigate the angle presented by the witness Bryan Gonzales. In the PNP Formal Report, it said that according to Gonzales, Balao may have been abducted by the members of the CPA themselves.

It was learned that Balao was living in a house together with the alleged members of the CPA who were only identified as "Uncle John" and Rene.

However, when the PNP attempted to investigate the two individuals, it was surprising that the leadership of the CPA did not cooperate.

The SC gave the PNP a period of six months to complete the investigation.

The case stemmed from the petition for the issuance of writ of amparo filed by the siblings of Balao and the leadership of the CPA before the La Trinidad, Benguet Regional Trial Court (RTC) against former President and now Pampanga (2nd District) Rep. Gloria Macapagal-Arroyo.

The RTC granted the petition for the writ of amparo.

However, on Dec. 13, 2011, the SC reversed the privilege of the writ since the petitioner did not present sufficient evidence.

The writ of amparo is granted to any individual whose right to life, freedom and security is being violated or threatened.

## Abu Sayyaf in Basilan recruiting new members using IS tag - source

MANILA, Philippines -- A Basilan-based faction of the Abu Sayyaf has reportedly begun recruiting new members using the name of the Islamic State, a police intelligence source said.

"The recruitment of new members under the name of (IS) is centered in the hinterland villages in the towns of Tipo-Tipo and Al-Barka, both in Basilan," and is undertaken by the group of Abu Sayyaf subleader Isnilon Hapilon, said the source, an officer based in Camp Crame who insists on being identified only as Pokemon and has provided accurate information on the extremists in the past.

In 2014, a video was posted on the internet of Isnilon leading his men in swearing allegiance to IS.

Pokemon said Isnilon's band appears to be awash in cash, indicating they may have their own source of funds aside from the ransoms for victims of the Abu Sayyaf's frequent kidnappings.

"They have already recruited at least 20 new members, mostly belonging to the Yakan" tribe, Pokemon said.

"They are promising their new recruits the amount of P5,000 and an M-16 rifle per meeting ... and so far they have (held) three meetings," he added, citing information he said was relayed by inside informants.

The Abu Sayyaf used to be linked to Al-Qaeda, the terror network founded by Osama bin Laden, but lately has been said to identify more with IS.

Other armed groups reported to have pledged allegiance to IS are the Bangsamoro Islamic Freedom Fighters, which broke away from the Moro Islamic Liberation Front, and the Rajah Solaiman Movement, which also used to be associated with Al-Qaeda.

#### ASG member nabbed in Zambo City

ZAMBOANGA CITY, June 22 (PNA) – Combined police and military operatives have arrested a suspected notorious Abu Sayyaf Group (ASG) member disguised as fruit vendor in this city, a top official disclosed Wednesday.

Chief Supt. Billy Beltran, Police Regional Office-9 (PRO-9) director, identified the arrested notorious ASG member as Usman Atalad, 46, who carries the aliases of Atalad, Suhud Limaya and Hud.

Beltran said Atalad was arrested during a law enforcement operation around 12:45 p.m. Tuesday along J.S. Alano Street, Barangay Zone, this city.

He said the lawmen sighted the suspect selling fruits in the vicinity of the Zamboanga City Police Office (ZCPO) and the old public market.

He said Atalad has standing warrant of arrest for seven counts kidnapping and serious illegal detention issued by a court in Basilan province.

Atalad was the second suspected ASG member who was arrested in the vicinity of ZCPO and old public market. The market is located at the back of ZCPO headquarters.

The first was Adam Mahamdom alias Junior Hali, who arrested on June 15 by joint police and military operatives.

Mahamdon, a member of the ASG's Urban Terror Group (UTG), is facing eight counts kidnapping and serious illegal detention cases. (PNA)

#### Joma wants Marcos burial in Ilocos Norte

DAVAO CITY - Communist Party of the Philippines (CPP) founder Jose Maria Sison is urging the Marcos family to keep its earlier promise to just bury the remains of the late President Ferdinand Marcos in Ilocos Norte.

Sison said the Marcoses should not insist on burying the remains of the late dictator at the Libingan ng mga Bayani.

He said the family should just honor its earlier agreement with former President Fidel V. Ramos, who allowed the repatriation of Marcos's remains from Hawaii on the condition that the latter will be buried in his home province.

"Ang mga Marcos dapat tuparin nila ang pangako nila na ang labi ni Marcos ay ililibing nila sa Ilocos Norte. Sa palagay ko nakalibing na iyon, wax na lang ang nakalitaw," Sison said at a video call session here.

Sison, nonetheless, said he is not fully opposed to a Libingan ng mga Bayani burial for Marcos, as he does not consider the cemetery as something meant for heroes.

"At their own risk, pwede na nilang ilagay sa libingan ng maraming traydor. Hindi naman mga bayani ang lahat ng nandoon eh," he said.

President-elect Rodrigo Duterte has agreed to have Marcos' remains buried at the Libingan ng mga Bayani, saying the late dictator should be buried there for serving the country as a soldier.

Duterte: Marcos burial in Libingan to 'erase hatred'

He recently met with the late dictator's only son and namesake, who said the burial can happen as early as September.



## Duterte says purchase of FA-50 jets just a waste of money

DAVAO CITY, Philippines - The Aquino administration's purchase of 12 FA-50 lead in fighter trainer jets is just a waste of money as the air assets are only being used now for ceremonies, President-elect Rodrigo Duterte said.

Duterte said the jets – the biggest items in the military's modernization shopping list – cannot be used to fight insurgency.

He added that the two FA-50s that were delivered to the Air Force are not enough to challenge China, which has occupied Panatag (Scarborough) Shoal, a fishing area off Zambales that is within the Philippines' exclusive economic zone.

"We only have what two FA-50s? Why did you buy that?" Duterte said in a business forum in Davao City last Tuesday.

"To the Air Force, do not misconstrue me. I'm a Filipino. I'm a citizen of this country and I have every right to say what I want to say. Sayang ang pera dun (Money was wasted there). You cannot use them for anti-insurgency, which is the problem at the moment. You can only use these for ceremonial fly-by," he added.

The Aquino administration has bought 12 FA-50 jets from South Korea's Korea Aerospace Industries for P18.9 billion to enhance the country's territorial defense capabilities. Two of the jets were delivered in November while the ten others will be arrive in the country next year.

The jets conducted fly-bys during the 80th anniversary of the Armed Forces of the Philippines in Pampanga and national hero Jose Rizal's 119th death anniversary in Manila last December.

Duterte said the money spent for the jets could have been used to buy helicopters or boats that would have prevented the kidnapping of three foreigners and a Filipina in Davao del Norte last year.

"If we had night vision goggles, we could have caught up with these guys and if we had fast boat, we could have pursued them," he added, noting that the assets would have allowed security forces to reach Davao del Norte in two to three minutes.

Duterte said the internal security problems should be solved first so the country can promote tourism and lure more investments. Military officials previously claimed that they are achieving gains in their anti-insurgency campaign and are ready to shift their focus from internal security to territorial defense.

Abu Sayyaf bandits kidnapped Canadians John Ridsdel and Robert Hall, Norwegian Kjartan Sekkingstad and Filipina Maritess Flor at the Ocean View Resort in Samal Island off Davao Oriental last September.

The local terrorists beheaded Ridsdel last April and executed Hall last week because their ransom demands were not met. They have threatened to behead Sekkingstad next if his family fails to pay ransom.

The designated security officials of the incoming Duterte administration has asked the help of local executives to secure the release of the remaining captives.

#### ISIS releases first propaganda video for Philippines

MANILA, Philippines — The so-called Islamic State, or ISIS, released a video early on Wednesday in an attempt to recruit radical fighters in the Philippines and neighboring countries.

Rita Katz, director of SITE Intelligence Group tracking the activities of ISIS, said the video targeting the Philippines was in five languages: Arabic, English, Filipino, Indonesian and Malay.

Screenshots of the video taken by the agency show Filipino, Indonesian and Malaysian fighters urging their countrymen to join their ranks in Syria. But for those who could not reach the Middle East, the group also gave them an alternative.

"If you can't get to Syria, 'join the muhajideen in the Philippines'," the terror network said, as quoted by Katz on her Twitter account.

Describing the content of the video, deep web monitor Vocativ said the ISIS has appointed a leader in the Philippines by the name of Abdallah al-Filipini, a representative of the self-dubbed caliphate.

The release of the video did not surprise Katz, who noted that the Islamic State has also released an infographic claiming the presence of its network in the Philippines.

In the graphic released earlier this month, ISIS claimed to have 10 fighting battalions in five different locations in the country. It also claimed that ISIS followers mostly in Basilan have killed 289 people since April 2015.

Security officials in the Philippines denied the presence of ISIS fighters in the Philippines, but noted that several radical groups such as the Abu Sayyaf have pledged allegiance to Abu Bakr al-Baghdadi, the Islamic State's self-appointed caliph.

Last week, the Abu Sayyaf beheaded its second Canadian hostage, Robert Hall, after its demands for ransom were not met by the Philippines and Canadian governments. Canadian Prime Minister Justin Trudeau, American President Barack Obama and President Benigno Aquino III condemned the execution of Hall, but insisted that ransom will not be settled with extremist groups.

Security forces have intensified operations against the Abu Sayyaf following the beheading. On Tuesday afternoon, three Abu Sayyaf fighters were killed while 16 soldiers were hurt in a clash in Sulu.

US Attorney General Loretta Lynch said Tuesday that countering jihadist propaganda continues to be a challenge for the government.

"How do we break that chain? How do we counter this extremist ideology that's online, knowing that the internet has to remain free and open? What can we get out there that's a counter-message to that?" she said in an interview with the Associated Press. Her statement came amid investigations of a recent massacre on a nightclub in Orlando by a gunman allegedly inspired by the ISIS.

Meanwhile, air strikes in Syria targeted the Islamic State's de facto capital of Raqqa on Wednesday, killing at least 18 civilians, including two children, according to activists. The barrage, blamed on the Russian and Syrian air force, came as government forces sought to recover from losses suffered in a stalled offensive on the extremist-held city. — with reports from Associated Press
