

Comelec proclaims 12 winning senators

AFTER a grueling count of the votes, the Commission on Elections (Comelec) yesterday proclaimed the 12 winners in the senatorial race, including five newcomers who expressed openness to presumptive President-elect Rodrigo Duterte's plan for a shift to the federal form of government, but were divided on his proposal for the return of the death penalty.

The newcomers were Senators-elect Joel Villanueva, Manny Pacquiao, Risa Hontiveros, Sherwin Gatchalian and Leila de Lima.

After a nine-day count of the votes by the Comelec serving as the national board of canvassers, the five newbies were proclaimed winners together with old-timers Franklin Drilon, Vicente Sotto III, Panfilo Lacson, Richard Gordon, Ralph Recto, Francis Pangilinan and Miguel Zubiri.

All but Sotto and Lacson were present at the proclamation. Election lawyer Romulo Macalintal and former Comelec Chair Sixto Brillantes Jr. accepted the certificates of proclamation on COMELEC / A8

behalf of Sotto and Lacson.

Macalintal said he had given the wrong date for the proclamation to Sotto, who was out of the country.

All the winners arrived at the Philippine International Convention Center (PICC) with members of their families and friends for their proclamation.

Some people were seemingly disappointed when Pangilinan and Recto showed up without their celebrity wives.

Pangilinan explained to inquiring reporters that his wife, singer-actress Sharon Cuneta, was on a taping. "Somebody has to earn while I am here," he said in jest.

There was no word from Recto as to the whereabouts of his wife, movie actress Vilma Santos, who won her run for the seat of the 6th district of Batangas province in the House of Representatives.

Senator Pacquiao

But the crowd at the PICC was buoyed when Pacquiao, the world boxing champion turned politician, arrived with his wife, Jinkee, and their two sons, Michael and Jimwell.

Before the proclamation ceremony, people asked for selfies with the new senator, while Comelec employees were content to get a few snapshots of him from afar.

De Lima was a celebrity on her own, drawing the loudest cheers from the crowd, next to Pacquiao, when she was officially named senator-elect.

proclaiming the last three winning senators, claiming irregularities in the vote count.

De Lima beat Tolentino by 1.33 million votes. Tolentino polled 12,811,098 votes.

In proclaiming De Lima, the Comelec said the remaining 1,211 uncanvassed votes would no longer materially affect the ranking of those in the Top 12 slots, including De Lima.

In the final official tally of the Comelec, Drilon garnered the highest votes, 18,607,391, followed closely by Villanueva, with 18,459,222 votes, and Sotto, with 17,200,371 votes.

Lacson captured the 4th spot with 16,926,152 votes; Gordon took the 5th place with 16,719,322 votes and Zubiri the 6th place with 16,119,165

'Vindication'

Zubiri, who came with his wife, Audrey, and their three children, said his victory was a vindib penalty. cation of sorts for his "rough and tumble" political career.

"It's a vindication of sorts for the work I've done and not really because of anything to do with the past-with 2007 and 2013. It's a vindication that people have seen the work I've done when I was there for four years in the Senate," Zubiri said in an interview with the INOURER.

Zubiri was proclaimed winner in the senatorial election in in 2007 but he resigned in 2011 when it became clear that he benefited from fraud. He ran again for the Senate in 2013,

but lost.

Zubiri said he was open to discussion on Duterte's federalism proposal, which he believed would promote competency and efficiency in the country, but might change his mind about his original stand for the reinstatement of capital punishment.

"I am open to the possibility of not allowing it if, and only if, we can come up with a national penitentiary where there is full isolation of prisoners," he said.

Hontiveros, who vowed to push for better healthcare for higher compensation for barangay health workers, said the eventual shift to a federal government was welcome, but she would fight against the reimposition of the death penalty.

"What the people can expect from me as I work in the Senate is to help make it stronger and independent, especially when there is a need for a check and balance in any overreach

utive or any branch of the government," she said.

Death penalty

Pacquiao was reluctant to make known his position on federalism, but he minced no words in voicing his assent to the reinstatement of the death

"I support death penalty as long as our laws are in order because death penalty is biblical. Read Romans 13," he said, referring to Paul's epistle on submission to the authorities.

Villanueva, the son of evangelist Eddie Villanueva, also said he supported the reimposition of the death penalty.

"I am for the death penalty, believe it or not as long as our justice system works, which is

very crucial," he said.

Villanueva, who turned in a strong showing in the senatorial race, described his victory as a vindication after being hounded for years by allegations linking him to the pork barrel scam.

De Lima said her stand against the return of capital punishment would not change.

"His proposed shoot-to-kill orders, I will definitely oppose that," De Lima said, referring to Duterte's plan for a law-and-order crackdown. "That's illegal. That's unconstitutional."

But like Recto and Gordon. De Lima said that she was open to Duterte's proposal for federalism.

"I'm open to it, but I cannot really give my commitment until I see the whole proposal," she said.

Recto and Gordon said they might support the restoration of capital punishment, but only for heinous crimes.

"I think it's important that we help the new administration, the new President. Let's be cooperative as much as possible, as much as we can," Recto said.

Economy expands 6.9% in first quarter

THE PHILIPPINES is a star in a weak global economy: Its economy grew 6.9 percent in the first quarter, making it one of Asia's best performers, even outpacing China for the first time in 27 years.

In the same period last year, the economy expanded 5.2 percent.

The growth, however, did not help the Aquino administration in the May 9 elections, as its presidential candidate lost by a wide margin, an indication that growth was not trickling down to the poor, among other reasons.

The Philippines outpaced the growth posted by major Asian economies, such as China's 6.7 percent, Vietnam's 5.5 percent, Indonesia's 4.9 percent and Malaysia's 4.2 percent, according to the National Economic and Development Authority

Sustained robust domestic demand coupled with ramped up government spending for public goods and services ahead

of the elections pushed economic growth to its fastest pace in over a year.

Services grew 7.9 percent and industry recorded its highest growth in five consecutive quarters at 8.7 percent. Investments also boosted the economy, with fixed capital posting 25.5 percent growth.

Agriculture contracts

The growth came despite a relatively weak exports and a farm sector ravaged by the worst El Niño in 28 years. Agriculture contracted 4.4 percent, the fourth consecutive quarter of decline.

With election spending expected to boost second-quarter growth to over 7 percent, Socioeconomic Planning Secretary Emmanuel E Esguerra on Thursday said the economy was "on track" to reach at least the lower end of this year's gross domestic product (GDP) growth target of 6.8 to 7.8 percent.

It puts the economic expansion during outgoing President Aquino's six-year term at 6.2 percent, the highest since 1978.


"We are pleased to be turning over a strong and stable economy to the next administration," he said at a news conference, referring to presumptive President-elect Rodrigo Duterte, who takes office on June 30.

Philippine Statistics Authority data showed that the first-

quarter growth figure matched the 6.9 percent posted in the fourth quarter of 2014.

Impact of poll spending

Neda has yet to determine the actual impact of poll-related spending on the first-quarter economic output, but Esguerra said previous elections showed a 0.3 to 0.4-percentage point contribution to the GDP during the election season.

Other economic managers welcomed the news of the strong economic expansion.

Bangko Sentral ng Pilipinas Gov. Amando M. Tetangco Jr. said the first-quarter GDP growth confirmed that policy settings were appropriate right now.

"We will, however, continue

to be mindful, among others, of weather-related developments. While El Niño seems to be winding down, it could still have residual effects on the crop cycle. In addition, we may see the onset of La Niña by midyear," Tetangco said in a text message to reporters:

Budget Secretary Florencio B. Abad said he remained optimistic that the economy will continue to expand this year.

"The country has made unprecedented growth in the past five years and we primarily owe this to the principles of good governance—upholding transparency, accountability and openness, especially in the management of public funds," he said.

Finance Secretary Cesar V.

Purisima, for his part, said the next administration would inherit a rapidly growing, vibrant Philippines cushioned by robust foundations built over six years.

Much better place

Purisima said the Aquino administration was leaving the Philippines in a much better place than when it first found it.

"No longer the sick man of Asia, the Philippines emerges more confident and more optimistic than ever, demanding to be governed by even higher standards of governance than before," he said.

Esguerra said that while strong economic growth and investment inflows could be sustained despite a change in administration by midyear, re-

forms should be sustained and plans fleshed out.

"What will happen in the second half will depend on how investors will react to the policies that the incoming administration will be putting in place," said Esguerra, who is also director general of Neda.

Eight-point agenda

The Neda chief welcomed the Duterte administration's eightpoint economic agenda, under which the incoming leadership plans to accelerate infrastructure spending, address land adattract more foreign direct investment flows, expand and improve the conditional cash transfer program, shore up government revenue collection, make tax administration more progressive, modernize the agriculture sector, as well as strengthen the basic education system.

"It's comforting that based on what have been said so far, the business sector largely accepted the agenda. But it's still in very general terms," Esguerra said.

Neda, as part of the transition committee to ensure smooth transfer of power from the Aguino to the Duterte administrations, will turn over to the incoming leadership policy recommendations, including pending "important" legislation that should be passed to ensure that the gains made thus far in terms of economic reform could not be reversed.

Part of the legislative agenda are reforms to further reduce the cost of doing business, bills aimed at closing the infrastructure gap, enforcement of the recently enacted competition law, rationalization of investors' fiscal perks alongside comprehensive tax reform, and removal of the quantitative restoration or quota on rice imports.

Risks

Moving forward, Esguerra noted risks to economic growth for the rest of the year.

"In particular, the agriculture ministration and management, and fishery sectors will continue to reel from the lingering impact of El Niño though the transition to a normal weather condition is already happening. We should also start preparing for the La Niña, which now has a 75-percent probability of occurrence," said the Neda chief.

Agriculture employs 27 percent of the Philippine labor force. Farmers also comprise a large chunk of the 26 percent of Filipinos who live on \$1.30 a day or less.

Esquerra called for added state spending to diversify crops, boost community defenses against disasters that also include typhoons and floods, and social protection, including crop insurance.

He said strong domestic demand would push growth in the near term, offsetting the weak global environment. With reports from AP and AFP

FP-NPA clash in Davao kills 4

THREE rebels and a soldier were the latest casualties in the government's anti-insurgency campaign against the government even as peace talks preparations have already underway between the camp of President-elect Rodrigo Duterte and the Communist Party of the Philippines-New People's Army-National Democratic Front in Davao City.

According to Captain Rhyan Batchar, public affairs chief of the 10th Infantry Division, the casualties were from a series of encounters Wednesday between soldiers of the 60th Infantry Battalion NPA rebels in Sitio Booy, Barangay Pinamuno, San Isidro, Davao del Norte and in Sitio Tugpahan, Barangay Imelda, Laak, Compostela Valley.

The first encounter in Booy at around 11:45 a.m. lasted for two hours. Two rebels and a soldier were killed while two improvised explosive devices (IEDs), 200-meter detonating cord, blasting caps, subversive documents, a cellphone, and some personal belongings were recovered.

The second clash in Tugpahan at around 2:50 p.m. led to the recovery of three M16 rifles and another IED.

The third encounter at around 5:50 p.m. happened during clearing operations in Booy. It led to the death of another rebel and recovery of an AK-47 rifle.

3 Reds, soldier killed in clashes

THREE suspected New People's Army (NPA) rebels and a soldier were killed during a series of encounters in Davao del Norte and Compostela Valley province on Wednesday.

Captain Rhyan Batchar, Philippine Army's 10th Infantry Division (ID) Public Affairs Office chief, said the first encounter occurred in Sitio Booy, Barangay Pinamuno in San Isidro, Davao del Norte.

He said elements of the Army's 60th Infantry Battalion (601B) were conducting security patrol in the area when they engaged the guerrillas in a firefight that lasted for about two hours where the rebels retreated leaving two of their fallen comrades.

Security forces recovered two

unexploded Improvised Explosive Devices (IEDs), detonating cord, blasting caps, subversive documents, and a cellular phone.

A soldier, whose identity was withheld pending notification of next of kin, died during the encounter.

Later, another encounter occurred in Sitio Tugpahan, Barangay Imelda, in Laak town, Compostela Valley where the rebels left three M-16 rifles and another IED.

NPA owns up cult head's slay

GINGOOG CITY—Communist New People's Army (NPA) guerrillas on Wednesday owned up the killing of a retired policeman-turned-religious group founder in Gingoog City.

Allan Juanito, spokesperson of the NPA's north central Mindanao command, said Francisco Baguiz was executed for "crimes against the people."

The rebels said Baguiz had been involved in land grabbing and the killings of several people, including Marc Anthony Bagaipo, former councilor

Baguiz, the NPA said, was also found to have posed as a communist guerrilla in robbery and extortion campaigns. The victim is also behind attacks on the NPA through the cult "Gintong Araw," the NPA statement said.

The statement was referring to Baguiz's religious group Apocalypse International Ministry Inc., also known as Gintong Araw, based in Sitio Sioan in Barangay Malinao in Gingoog City.

The statement said rebels tried to execute Baguiz on Dec. 18, 2005 but he survived the attack.

The rebels said they would return to Baguiz's family his personal belongings and cash.

SPO4 Teddy Macarayo, of the Gingoog police, said Baguiz was handcuffed and brought by the armed men to a secluded area, where he was stabbed four times. He did not reach the hospital alive.





Luisita farmers hit AFP pick

A FEDERATION of farm workers on Wednesday asked presumptive President-elect Rodrigo Duterte to drop his plan to appoint Lt. Gen. Ricardo Visaya as chief of staff of the Armed Forces of the Philippines due to his alleged role in the so-called Hacienda Luisita massacre in 2004.

The Unyon ng mga Manggagawa sa Agrikultura (UMA) said Visaya

should instead be prosecuted for the death of seven striking workers who were shot dead during a confrontation with policemen and soldiers at the gates of Hacienda Luisita on Nov. 16, 2004. President Aquino, a member of the Cojuangco family that owns Hacienda Luisita, was a congressman of Tarlac at the time.

The Office of the Ombudsman had dismissed two murder cases filed against Mr. Aquino and Gen. Gregorio Catapang for the violence that attended the riot at Luisita. Catapang was appointed AFP chief of staff by Mr. Aquino 10 years after the bloodshed.

Reacting to the UMA claim, Visaya said he was not investigated or ordered to submit a

counteraffidavit in connection with the deaths in Luisita.

At the time, Visaya was commanding the 69th Infantry Battalion, which was not at the riot site because it was providing area security away from Luisita. Visaya is the current Southern Luzon Command chief.

Danilo Ramos, UMA secretary general, described Visaya as a "right hand man and protégé" of detained retired Maj. Gen. Jovito Palparan.

Palparan is standing trial for the kidnapping of two University of the Philippines students in Bulacan province.

Visaya said "leftists always try to discredit me."

Sulu bet says video shows brazen cheating

ZAMBOANGA CITY—A candidate for Sulu governor has filed an electoral sabotage case against the winner of the gubernatorial race claiming that video footage

and other pieces of evidence show the brazenness with which fraud was committed during the May 9 elections in the province.

Temojen "Cocoy" Tulawie, who lost to Abdusakur "Totoh" Tan II, son of Sulu patriarch Abdusakur Tan, said massive cheating and vote-buying were documented in Timpook and Taong in Talipao; Taglibi in Patikul and Alat in Jolo town.

But the elder Tan said Tulawie's accusation was just a form of "sour graping."

"I guess it is the same for other losers," said the elder Tan.
"They readily say they were cheated."

"The problem with Cocoy is he talks too much because he wants public attention," the elder Tan said.

"Let him bring his case to court and we will face him there," he said.

Tulawie said his camp filed the electoral sabotage case at the Commission on Elections on May 12.

He said his supporters were able to obtain video footage that showed Tan's daughter, Shiela Tan Hayudini, and her husband, Ging Hayudini, storming several precincts and ordering voters to leave the room.

"They then started shading the ballots," said Tulawie, describing the content of the video.

The Hayudini couple, Tulawie said, gained access to polling precincts with police and military escorts.

Another footage, Tulawie said, showed a suspected Tan supporter walking to and from a voter's chair to the vote-counting ma-

chine without the board of election inspectors (BEI) doing anything.

Tulawie said volunteers who helped in his campaign got

money from Tan's camp. They kept the money and handed it over to the police as evidence. He said the volunteers collected about P100,000 in cash from the Tan camp.

Tulawie also alleged majority of teachers, who served as members of the BEI, were in collusion with the Tans.

These BEI members, he said, demanded P20,000 from every candidate "and I was informed that Tan paid."

Tulawie said Udtog Tago, Sulu election supervisor, should also be made to explain why the younger Tan was proclaimed governor when the number of votes canvassed had not yet reached 90 percent.

He said failure of elections in some areas in the province also helped the younger Tan win.

Giocelito Jayma, a lawyer for Tulawie, said he contested the proclamation of the younger Tan by filing a petition on May 13. A case seeking to disqualify the younger Tan for electoral sabotage has also been filed.

Tago said he was ready to answer the accusations in court.

"We will answer his allegations. His accusations against political candidates will be answered by those involved," said Tago. Julie Alipala and Dennis Santos, Inquirer Mindanao

The 24 US air crew members were held for 11 days until Washington apologized for the incident.

That encounter soured US-Chinese relations in the early days of President George W. Bush's first administration.

Both countries have traded accusations and warnings over such surveillance flights in subsequent years.

Duterte can't just scrap BBL, says MILI

THE MORO Islamic Liberation Front (MILF) yesterday said the proposed Bangsamoro Basic Law (BBL) cannot be unilaterally set aside by the government as the incoming Duterte administration pushes for a federal system of government.

"It will not happen," MILF chief negotiator Mohagher Iqbal told the Inquirer by phone, referring to the statement of newly elected Davao del Norte Rep. Pantaleon Alvarez that the peace process with the Moro rebels would go back to square one.

"We will continue to insist on the implementation of the peace process," Iqbal said.

Iqbal said it was important to clarify if Alvarez made a "personal point of view" when he claimed that the peace talks with the Moro rebels would be back to square one under presumptive President-elect Rodrigo Duterte or if this was really the incoming administration's policy.

Alvarez is poised to be the next Speaker of the House of Representatives.

"My first question is, is this an official

policy of the Duterte administration or his personal point of view because if it's his personal opinion, it won't hold any significance," Iqbal said.

He said the Philippine government and the MILF signed in 2010 the Declaration of Continuity for Peace Negotiation, which

cannot be abrogated.

Ironically, a day before Alvarez made the announcement, the MILF published on its website an appeal to the incoming administration to honor the declaration.

In a statement on their official website, luwaran.com, the MILF said the essence of the declaration is that "where the parties stopped, as consequence of major obstacles like all-out war or shortness of time of the administration in power like that of President Fidel V. Ramos, they will continue and start from they stopped or forced to discontinue."

"Government cannot just set this aside. It is an obligation by both parties because it was an agreement we both signed," Iqbal said.

Iqbal reminded the incoming administration that negotiations between the MILF and the government have been completed and both parties have already signed the Framework Agreement on the Bangsamoro (FAB) and the Comprehensive Agreement on the Bangsamoro (CAB).

The CAB is the essentially the peace agreement between the government and the MILE

The Moro National Liberation Front (MNLF) has also completed its tripartite review of its peace accord with the government.

"There are no more negotiations to speak of but the peace process is ongoing," Iqbal said.

The 15th Congress was unable to pass the proposed BBL, which would have created a new Bangsamoro autonomous region as a compromise to the full independence the MILF has fought for decades.

The Mamasapano debacle in January last year threw a monkey wrench on the otherwise smooth sailing peace process between the MILF and the Aquino administration, with members of both houses of Congress casting doubt on the sincerity of the Moro

One of the leading dissenting voices to the proposed BBL is Sen. Alan Peter Cayetano, running mate of Duterte. Cayetano has been promised a Cabinet position in the Duterte administration following a yearlong ban for losing candidates to be appointed in government posts.

ZAMBOANGA CITY – A Filipino-Chinese businessman kadnapped by Abu Sayyaf gunmen in March has been freed.

Ryan Nuñeza Tan, 21, was released a few meters away from Camp Cawa-Cawa around 6 p.m. on Tuesday. He was reunited with his family in Lapuyan, Zamboanga del Sur on Wednesday night.

Word about Tan's release came out only yesterday as his family requested for privacy, citing the safety of his 70-year-old grandfather. Antonio Tan was separated from his grandson while in captivity.

The Tans were seized in Purok San Francisco, Barangay Maruing in Lapuyan, Zamboanga del Sur.

They were among six
Filipinos held by Abu Sayyaf
bandits in the jungles of Sulu
along with Canadian Robert
Hall and Norwegian Kjartan Sekkingstad, who were
taken from a resort on Samal
Island, a Dutch birdwatcher
and four Malaysians.

Canadian John Ridsdel—who was seized along with Hall, Sekkingstad and Filipina Marites Flor — was beheaded on April 27 after the deadline set for the payment of a P300-million ransom lapsed.

The kidnappers threatened to behead another Samal hostage if their ransom demand is not met.

Enrile to Rody: Think twice before dealing with CPP

Outgoing Sen. Juan Ponce Enrile advised yesterday incoming president Rodrigo Duterte to think twice before striking a deal with the Communist Party of the Philippines (CPP).

"They have to act with caution," the 92-year-old Enrile said when asked to comment on Duterte's dealing with exiled CPP founder Jose Maria Sison after the party was offered four Cabinet

posts under the incoming administration.

The defense minister during martial law cited grave security implications in case Duterte pursues his plans to allow communist leaders to occupy key government posts without going through the legal process.

"Well, they better study it very well," he said.

"There are security implications there. I am sure the incoming president is aware of the problem of a coalition with the Left. There are many examples of this like what happened in Russia, the coalition between the Mensheviks and the Bolsheviks."

Enrile said it is up to the Duterte administration to draft a peace agreement or to give amnesty to members and officers of the CPP and the New People's Army.

"It depends upon the policy," he said. "That is part of his political decision. I am not in a position to advise him. He has good advisers at this point. All I can say is, the government must act with caution.

Enrile reserved his comment on the composition of the upcoming administration, expressing belief that Duterte knows

what he is doing.

He took note of the impending appointment of lawyer Vitaliano Aguirre to the justice portfolio. He said that Aguirre is

a good lawyer.

As for incoming House speaker Pantaleon Alvarez, Enrile said he also knows him, but then, they were on opposite sides in the past administrations.

Enrile said Duterte should be given the chance to prove himself to the Filipino people on his plan to have curfews for minors and a liquor ban nationwide.

"I am not familiar with the law," he said. "But they should do something to legalize that power."

Zhang Baohui, a security expert at Hong Kong's Lingnan University, said he believed the encounter highlighted the limitation of CUES, and showed that Chinese pilots would still fly close to US surveillance planes if needed.

"Frankly, we're always going to see these kinds of incidents as China will always

put the priority on national security over something like CUES whenever it feels its interests are directly threatened," he said.

While the precise location of the encounter is not yet known, regional military attachés and experts say the southern Chinese coast is a military area of increasing sensitivity for Beijing.

Its submarine bases on Hainan are home to an expanding fleet of nuclear-armed submarines and a big target for ongoing Western surveillance operations.

The Guangdong coast is also believed to be home to some of China's most advanced missiles, including the DF-21D anti-ship weapon.

The Pentagon last month called on China to reaffirm it has no plans to deploy military aircraft in the Spratly Islands after China used a military plane to evacuate sick workers from Kagitingan (Fiery Cross) Reef, where it has built a 3,000-meter runway.

In April 2001, an intercept of a US spy plane by a Chinese fighter jet resulted in a collision that killed the Chinese pilot and forced the American plane to make an emergency landing at a base on China's Hainan island.

The 24 US air crew members were held for 11 days until Washington apologized for the incident. That encounter soured US-Chinese relations in the early days of US President. George W. Bush's first administration.

Last month, the Pentagon said that Russia had intercepted a US Air Force aircraft over the Baltic Sea in an "unsafe and unprofessional" way.

PNP, AFP step up drive vs NPAs, other lawless groups

BUTUAN CITY – The Philippine National Police (PNP) and Armed Forces of the Philippines (AFP) yesterday directed all field unit commanders to step up operations against armed lawless group (ALG) in their respective areas of responsibility.

The command group of the Northeastern Mindanao Police Regional Office 13 (PRO 13) and its military counterpart, the Northeastern and Northern Mindanao Army's Fourth Infantry (Diamond) Division (4th ID) also directed its field unit commanders to sustain patrols and avert any terroristic activities carried out by the New People's Army (NPA), armed wing of the Communist Party of the Philippines (CPP).

"Our main task in protecting the people did not stop even after election and we are duty - bound to thwart any terror group plans," said a police officer who requested anonymity as he is not authorized to issue any statement to media.

Davao Norte, ComVal clashes

The directive came in the wake of a series of skirmishes between government forces and New People's Army (NPA) rebels last Wednesday which resulted in the killing of four persons,

the 10th Infantry (Agila) Division of the Philippine Army reported.

Captain Rhyan Batchar, chief information officer of 10th ID said three rebels and an Army trooper belonging to 60th Infantry Battalion were killed during a series of armed encounters in Sitio Booy, Barangay Pinamuno, San Isidro town in Davao del Norte and in Sitio Tugpahan, Barangay Imelda, Laak, Compostela Valley province.

Peace talks backed

Meanwhile, majority of the field unit commanders of the AFP, when reached by phone by the Manila Bulletin yesterday said they are in favor of the resumption of stalled peace talks between the government and CPP-NPA, but insisted that the NPAs must first lay down their firearms.

In a related development, a certain 'Ka Alan Juanito', who claimed to be the spokesperson of the NPA's Julito Tiro Command claimed responsibility for the execution of a former police officer in Gingoog City last Monday.

The supposed NPA spokesperson said former Senior Police Officer 4 Francisco R. Baguiz was executed for his alleged involvement in the killings of some tribal leaders and other alleged criminal a and 'anti-revolutionary' activities in the highland communities in Gingoog City.

Duterte meets top communist leader

PRESIDENT-ELECT Rodrigo Duterte has met with a senior communist guerrilla leader, the two sides said Thursday, raising hopes of ending one of Asia's longest armed insurgencies.

Rebel negotiator Fidel Agcaoili said he talked to Duterte about how to immediately resume peace talks, three years after the incum; bent president ended them.

"I am optimistic that the talks will be resumed. Our meeting was positive," Agcaoili said, but did not specify if a timetable for the resumption of the talks had been set.

Running for almost half a century, the communist insurgency has claimed 30,000 lives, according to military estimates.

President Benigno Aquino 3rd revived talks soon after taking office in 2010 but shelved them in 2013, accusing the rebels of insincerity in efforts to achieve a political settlement.

A spokesman for Duterte confirmed the meeting had taken place on Tuesday.

Duterte has vowed to seek a political settlement to the conflict.

He has offered four cabinet posts to the insurgents and ex-

pressed willingness to free ailing guerrillas from prison.

Netherlands-based Agcaoili said he was hopeful about Duterte's commitment.

"He has political will," he said of the president-elect. "Duterte is not like (President Aquino) who was fond of delays."

He said Duterte told him that government emissaries will travel to the Netherlands to meet with the group and prepare documents needed for the formal negotiations and that he pledged to grant amnesty to political prisoners.

But Duterte's designated negotiator, Silvestre Bello, said such a move would require congressional approval.

"He said he is considering, studying the possibility of recommending to Congress the passage of the general amnesty law," Bello said.

"I am very confident peace negotiations will resume."

The communists' armed wing, the New People's Army, is believed to have fewer than 4,000 soldiers, down from a peak of 26,000 in the 1980s, according to the military, however it retains support among the deeply poor in the rural Philippines. AFP

Joma warns Duterte of coup, slay plots

LUCENA CITY—Presumptive Presidentelect Rodrigo Duterte should watch out for coup d'etat and assassination plots by disgruntled military officers supposedly supported by Sen. Antonio Trillanes IV, according to Communist Party of the Philippines founder Jose Maria Sison.

"The Trillanes gang has declared war on Duterte. Upon assumption of office as President and Commander in Chief, [Duterte] has to deliver decisive blows on this tiny gang," Sison said in an online interview on Thursday.

On the eve of the national elections, a 13-minute video was uploaded on YouTube by a group called the Network of Officers to Defend the Republic. Trillanes, a former Navy officer, earlier confirmed it was produced by military officers and soldiers who did not approve of Duterte's alliance with communist rebels.

"Only stupid political prostitutes and

pathological anticommunists like Trillanes cannot understand Duterte as a smart representative of his government," Sison said.

Duterte has said he would consider a general amnesty for political prisoners, which Sison described as a "high-minded, generous and excellent initiative."

Sison said Duterte's statement meant the incoming Philippine leader was willing to inspire the achievement of a just and lasting peace.

Duterte's proposed general amnesty was based on "sound precedents" of the amnesty proclamations by former Presidents Corazon Aquino in 1986 and Fidel Ramos in 1992, Sison said.

He said the Filipino people and the majority of government officials, businessmen and military and police officers were interested in the resumption of peace talks between the Duterte administration and the National Democratic Front of the Philippines (NDFP).

Sison said the NDFP would consult with

the special envoy of the Norwegian government for advice and assistance on ceasefire monitoring and the formation of reciprocal ceasefire committees and liaison officers.

The Norwegian government is brokering the peace negotiations between the Philippine government and the NDFP.

ENA CITY—A rarely heard of underund group of farmers sought to add its to a proposal, in the words of pre-

sumptive President-elect Rodrigo Duterte, to "concede" the agrarian reform program to the Left.

This early, however, the group Pambansang Katipunan ng mga Magbubukid (PKM), one of the organizations under the

umbrella of the National Democratic Front of the Philippines (NDF), said the Left's demand for genuine agrarian reform could be met only through the success of peace negotiations between the incoming administration of Duterte and the leftist rebel movement.

In a statement, Andres Agtalon, spokesperson of PKM, said while the group supported the resumption of peace talks under a Duterte administration, the Left already had a model for agrarian reform—its own.

The NDF, said Agtalon, was already carrying out a "revolutionary agrarian program" in guerrilla bases and territory.

The program, he said, went on while the government's "failed agrarian reform program" led to "widespread land grabbing and displacement of farmers."

A genuine agrarian reform program, said Agtalon, had two key characteristics—breaking up "land monopolies" and "free distribution of land."

The NDE the PKM spokesperson said, had already outlined an agrarian reform program that would lead to rural development and was supported by "adequate and affordable irrigation systems, farm-to-market roads, more farm technicians, post-harvest facilities, marketing agencies and research and development."

The NDF idea of agrarian reform, he said, would lead to rural industries spurred by agricultural modernization and food processing.

The objective, said Agtalon, was for rural development to be a key ingredient of "national industrialization and progress."

For a start, according to a left-wing militant group of farmers, Duterte should certify as urgent the pending Genuine Agrarian Reform Bill in Congress.

Antonio Flores, secretary general of Kilusang Magbubukid ng Pilipinas, said the Department of Agrarian Reform, which Duterte offered to concede to the Left, would no longer have a mandate to carry out agrarian reform because the law that allowed it to do so, the Comprehensive Agrarian Reform Program with Reforms, had expired on June 30, 2014, except for its provision on land distribution.

'NDF peace talks should resume without pre-conditions'

DAVAO CITY – Incoming government negotiator with communist rebels Silvestre Bello believes that peace talks with the National Democratic Front should resume without pre-conditions.

In an interview yesterday, Bello said peace talks should resume and then the issue of ceasefire or the release of some rebel consultants could be the product of negotiations.

Setting pre-conditions would violate The Hague Joint Declaration, an existing agreement between the government and the NDF, Bello said.

NDF negotiator Fidel Agcaoili said rebels—serving as peace consultants should be freed because it is a government obligation under the Joint Agreement on Safety and Immunity Guarantees signed in 1995.

"It seems that president Duterte does not have any problem with the release of political prisoners, a majority of whom were detained under (President) Aquino," he said.

Bello said he has relayed to Agcaoili his position that the release of prisoners should be an offshoot of negotiations. "I am very confident that the peace negotiation will resume," he said. "I made it very clear to him that if we resume, it should be without precondition."

Negotiations between the government and the NDF hit a snag after the two sides failed to reach a consensus on jailed rebel leaders.

The NDF had demanded the release of rebels charged with criminal cases. They are working as peace consultants and should therefore be immune from arrest, they claimed.

However, the government panel rejected the demand as their identities could not be validated, especially those using aliases.

Communist rebels have been waging an armed struggle against the government since the late 1960s.

The insurgency, the longestrunning in the region, has claimed more than 40,000 lives.

Meanwhile, Kilusang Magbubukid ng Pilipinas secretary general Antonio Flores expects more than 300 "peasant political prisoners" to be released under the incoming Duterte administration.

"The resumption of peace talks will pave the way for the release of all political prisoners, now reaching more than 500, detained at various jails in the country," he said.

Flores is optimistic of the intention of incoming president Rodrigo Duterte to seriously continue the peace process by taking significant steps that include the release of all political prisoners.

"Many political prisoners who are detained since the Arroyo administration are peace consultants, activ-

ists, farmers and leaders and members of mass organizations," he said.

"Peace talks between the National Democratic Front and the government of the Republic of the Philippines were stalled in 2011 when the Aquino government deliberately refused to free political prisoners and implement previous agreements, including The Hague Declaration and the Comprehensive Agreement on Respect for Human Rights and International Humanitarian Law." – Alexis Romero, Ding Cervantes


Populism

THE COMING presidency of Rodrigo Duterte is taking more twists and turns than many expected, setting off roller-coaster emotions among both supporters and critics.

Human rights defenders protested when Duterte said he would restore the death penalty, with a graphic description of how hanging would be used. But the double-dead threats have come with promises to release all political prisoners, which

elates many human rights groups.

the Conversely promise to release detainees political and offers of Cabinet positions to the Com-Philippines (CPP),



have dismayed more conservative Duterte supporters who expected a tough law-and-order stance, with activists, the National Democratic Front (NDF), and the CPP included as targets.

Amid all this, a book review in the British newspaper The Guardian caught my eye and sent me into Amazon, only to find that the book won't be available until June 1 (at a hefty \$61). Nevertheless, the review provided enough information for me to think harder about Duterte, and populism in the Philippines.

The book is Benjamin Moffitt's "The Global Rise of Populism," which is the result of his doctoral research at the University of Sydney. Moffitt's interest in populism came out of his native Australia, where he grew up during the era of populist politician Pauline Hanson, whose racist views he found "abhorrent." But, precisely because such "abhorrent" ideas seemed to have a wide following, he was intrigued enough

to go into a global review of populism.

The book will probably be a best-seller considering how, in recent years, populist politicians have gained power worldwide. Moffitt is probably following the news now about Duterte and, halfway across the world, Donald Trump, the presumptive (why does it sound like "presumptuous" to me?) Republican nominee in the current US electoral circus.

Flexibility Moffitt's book is anchored on an important characteristic of populist politicians: They are not bound by a consistent ideology. It is flexibility that becomes a populist's greatest asset. We're certainly seeing that in Duterte who, while declaring himself a socialist, is not with any political party. Certainly not with the CPP, despite some of the almost funny speculation in social media. (In one online fire fight, someone said Duterte was "UP Diliman KM," drawing reactions from others who clarified, correctly, that he is from Lyceum, where he once had CPP founder Jose Ma. Sison as a teacher.)

Populist leaders, Moffitt suggests, are performers. One could argue that all politics is grand theater, and that politic cians are actors (and in the Philippines, actors are politicians). But for Moffitt, populist leaders are far more intentionally performative, and, from excerpts of his book, I'd suggest populist leaders even set up their own stage, scenes and props.

Instead of abstract ideological issues, populists latch on to and amplify people's main anxieties, making people feel, Moffitt says, that "we're on the precipice of failure at all times." In Duterte's case, this was zeroing in on street and neighborhood crime. Everyone could relate to that: the upper class feeling besieged by "squatters" all around and putting up walls that would shame Jericho, complete with barbed wire charged with electricity; the middle class in mortal fear of being robbed in broad daylight while in a jeep, taxi or bus; the urban poor who know that their neighbor sells shabu or, worse, operates a drug den for users.

Enter the populist politician with promises of, and here I'm quoting a passage that resonates for all of us: "strong, swift simplistic action that sweeps aside the cautious deliberations and negotiations that normally characterize liberal democracy."

Political incorrectness

Moffitt says that "bad manners," including political incorrectness, are also important for populists. In both the United States and the Philippines, these "bad manners" were predicted, over and over again, as possibly leading to the downfall of the populist politician. But Moffitt says that on the contrary, bad manners are essential to the populist style, especially when coming from a less privileged class (Duterte's parents were middle-class) and up against politicians from the elite (in our case, Mar Roxas especially, and the ruling Liberal Party).

Moffitt observes that the bad manners will include sexual bragging, and cites Ecuadorian President Abdala Bucaram boasting of his "big balls" and Trump of the size of his hands. Duterte is mild compared to those two when it comes to bragging about personal assets, but he exceeded them with his joke about the Australian missionary raped and killed in prison.

Because politics and media are now so intertwined, Moffitt writes, populism becomes more tempting for even mainstream politicians. Again we see that in the Philippines, with social media in particular becoming so important in shaping a politician's image. Gone are the days of rhetorical promises; now politicians have to brand themselves, and where they used to fear controversies, they now know scandals can add to their popularity.

Staying in power

After I put down the book review, I thought: Winning an election is always the easy part with populist politicians, but staying in power and being able to effectively govern are far more difficult.

Staying in power will require even more of that populism, but now in the face of realpolitik. Duterte will have to play according to the rules of the game, including a coalition government to win over the elite, and restrain to some extent the restlessness of the masses. He will need the cooperation of the military and the police, as well as of the CPP/NDF which does have a large organized following among workers, peasants and students.

I see parallels with the Cory Aquino presidency, which started out as a rainbow coalition that included the Left. The response came swiftly: military coup attempts and assassinations of Left (and I mean here CPP/NDF-affiliated) lead-

ers. The Left is wiser now, and warier.

I do think that populist leaders have more than political power in mind. They tend to be people who believe they can bring about radical change, with popular support.

The bottom line, too, beyond the theatrical performances, is that the Duterte victory came largely because of the people's disillusionment with elite politics. This time around, it was being fed up with not just empty promises but with outright incompetence that has led to daily trials and tribulations for Filipinos across classes. Besides the feeling of a state of siege from criminality, there are the drought-stricken farmers met with bullets when they rallied for help; indigenous peoples' homes and schools burned down so that they have to leave their ancestral lands; and urbanites packed like cattle in deteriorating LRT and MRT trains. Even members of the upper class had their complaint, such as not getting their car plates or driver's licenses on time. Also, most of the time government inefficiency was wrongly interpreted as corruption, eroding the claims of daang matuwid (straight path).

I want to believe that Duterte and his advisers do care about these issues. They have to, for the sake of the nation,

and for their own.



DUTERTE, THE AMERICANS, THE CHINESE, AND THE COMMUNISTS



PRESIDENT Duterte has three main priorities: one, kill drug lords and those guilty of heinous crimes like rape and murder; two, extricate something practical and profitable from the Philippine territorial claim in the West Philippine Sea; and three, share power with the communist rebels to bring to an end the longest communist insurgency in the world. Relatedly, for the Muslim separatist rebels, President Rody offers nothing short of federalism-a concept grand as a vision but mind-boggling in its execution.

Priority No. 1—drugs, is a no brainer. The facts are stark and disturbing: Consider the following:

- 1.7-million Filipinos are drug addicts.
- 20 percent of the country's 43,000 barangays are hit by drug-related crimes
- Drug lords live like kings at the National Penitentiary.
- Low-level drug cases clog court dockets and delay justice.
- Higher purity methamphetamine from Mexico supplanting less pure Chinese-sourced methamphetamine.
- Bulk shipments still come from China, largely controlled by Chinese organized criminal groups.
- Drug couriers use flights to the Philippines both to smuggle drugs into the country and to trans-ship

drugs to other countries.

- More West African drug syndicates use airports to smuggle methamphetamine into the Philippines for onward distribution throughout Southeast Asia.
- Latin American drug trafficking groups now operate locally.
- Casinos should be included in money-laundering controls.

"Philippine authorities are faced with multiple challenges, including the expansion of Mexican-based trafficking organizations, ongoing domestic methamphetamine production, and confronting drug trafficking in rural areas where little state presence exists," says a recent US State Department report on narcotics in the Philippines.

The West Philippine Sea claim brings into sharp relief two of the biggest and most strategic partnerships of the Philippines—the United States and China. The Philippines is often perceived as a lackey of America. But America has little money to give away. China, on the other hand, has plenty of money. However, of late, it has been on a territory-grabbing spree.

US-Philippine relations are based on strong historical and cultural links and a shared commitment to democracy and human rights. The Philippines is a major non-Nato ally of the US which means that if the former's

territory is invaded, America will come to its defense.

The Manila Declaration signed in 2011 reaffirmed the 1951 US-Philippines Mutual Defense Treaty as the foundation for a robust, balanced, and responsive security partnership. Some four million US citizens—including Grace Poe—are of Philippine ancestry.

More than 220,000 Americans live in the Philippines. Nearly all Philippine presidents, with the possible exception of Ferdinand Marcos and the incoming Rodrigo Duterte, were pro-Americans. Marcos was ousted by the Americans in 1986. The US still has to warm up to Duterte and is concerned with his previous human rights record.

The US is the Philippines' second largest investor, after Japan. Bilateral trade is more than \$25 billion. US is the Philippines' third largest trading partner.

Meanwhile, using its so-called nine-dash line map, China has occupied seven reefs claimed by the Philippines as part of its 200-mile Exclusive Economic Zone. EEZ does not grant sovereignty but ownership and exclusive economic use of the fishes, minerals and other resources under the waters covered by the EEZ. The seven reefs are: Subi, Gaven, Fiery Cross, Cuarteron, Johnson, Huges and MisChief.

China's nine-dash line map grabs 80 percent of the Philippine EEZ. Manila has sued Beijing for these territorial grabs. The International Arbitral Tribunal on the Law of the Sea is expected to issue a ruling anytime now. The ruling could be favorable to the Philippines but China has said it won't honor the decision.

Duterte is particularly pissed with China's occupation of Scarborough Shoal. Scarborough is clearly Philippines territory, having been ceded to Manila by the US in the 1990 Treaty of Washington. According to Justice Antonio Carpio, Scarborough Shoal, being a regular island, is entitled to a 12-mile territorial sea around it. This amounts to 155,165 hectares of maritime space-more than twice the land area of Metro Manila which is 63,600 hectares.

Duterte wants an explanation, particularly from Senator Antonio Trillanes whom he blames for the loss of Scarborough, after the latter made 16 visits to China. Duterte says he can take all kinds of garbage and insult but not the loss of territorial land or waters.

President Obama, on the evening of May 17, called Duterte to congratulate him and stressed the two countries' shared commitments to democracy, human rights, rule of law and inclusive

and provide the reserve of the state of the

economic growth.

For his part, Duterte told Obama in effect he will initially joint the western alliance in opposing China's South China Sea territorial claims. But if nothing moves, he might be forced to talk turkey with China, on a bilateral basis, "if there is no wind to move the sail" in still waters.

As for the power-sharing with the Reds, well in Economics 101, there are three factors of production-land, labor, and capital.

With the CPP taking over four departments-Agrarian Reform, Natural Resources and the Environment, Labor, and Social Welfare and Development, the communists have, in effect, taken over land and labor, or 60 percent of what makes the economy moving and productive.

Included in the takeover are the bureaus, agencies and financial institutions, like the Land Bank, Cocobank, and even the Development Bank of the Philippines. Also, the four departments have more positions than the total NPA regulars and communist cadres. DENR alone has 19,500 people; DAR 12,600, and DoLE and DSWD 2,500 each.

So overnight, our communist friends have become employers. bankers and capitalists. Change, indeed, is coming.
