

The Philippine Coast Guard (PCG) has resumed sending patrol vessels to Panatag (Scarborough) Shoal, but only to "test the waters" and not to confront the Chinese who have stopped harassing Filipino fishermen but remained in control of the area, Transportation Secretary Arthur Tugade said yesterday.

The PCG suspended deployment in the area at the height of Typhoon Karen and later Super Typhoon Lawin and in deference to President Duterte's state visit to Beijing last month.

Days after Duterte's return last Oct. 21 from Beijing, the Chinese stopped harassing Filipino fishermen at the shoal. but have maintained a presence in the area.

To be deployed to Panatag, Balvlo said, were the ships BRP Tuhbataha, BRP Davao del Norte and three monitoring, control and surveillance (MCS) vessels. The BRP Pampanga is on standby for deployment.

Panatag is only 124 nautical miles from Zambales and is well within the country's 200-nautical-mile exclusive economic zone (EEZ)

"There is instruction to deploy vessels to Bajo de Masinloc any time today (Thursday). They will be coming from Manila and Subic," Balilo said, referring to Panatag by its local name.

Malacañang earlier stressed the Filipino
fishermen were able to return to Panatag after
four years of Chinese blockade due to "friendly

Agreement" with China.

Presidential spokesman Ernesto Abella said China's relaxing its hold on Panatag was mainly a result of Duterte's visit to Beijing, specifically his bilateral talks with President Xi Jinping. "While fishermen are no longer harassed by the Chinese Coast Guard ships staying at the shoal, there was no formal agreement signed yet by the two governments," Abella said.

No formal deal

Foreign Affairs Secretary Perfecto Yasay Jr. also made it clear there was no formal agreement with China on the latter's lifting of its blockade of Panatag Shoal.

"There is no agreement that has been arrived at with China insofar as these ships leaving or our fishermen having access to Scarborough," Yasay said

"But I would imagine as part of our quiet diplomacy trying to build mutual trust and confidence with two countries, these have been made possible," he pointed out.

The Armed Forces of the Philippines would continue to monitor developments, said its spokesman Brig. Gen. Restituto Padilla.

"The AFP welcomes the recent developments that have been monitored to have been happening in the area and we hope this continues in the interest of all those who are getting their livelihood out of the area." Padilla said.

"We in the AFP will just continue to monitor and hopefully, the current status out there is for the good of local fishermen," Padilla said.

Chinese Foreign Affairs ministry spokesperson Hua Chunying also said the successful visit of Duterte to China has put the relations between the Philippines and China back on track.

"We have seen all-round improvement of China-Philippines relations following President Duterte's visit to China," she said.

But she stressed that China has been merely exercising normal jurisdiction over the shoal and "the situation there is and will remain unchanged."

The Chinese seized the shoal in 2012 after a standoff with the Philippine Navy, which had tried to arrest Chinese poachers.

GMA News cited a near encounter in September when a PCG patrol confronted a Chinese vessel that had strayed into the Philippines' EEZ.

But the Chinese replied they were "currently conducting a patrol in our exclusive economic area under the jurisdiction of People's Republic of China."

The July 9 ruling by the UN-backed Permanent Court of Arbitration declaring Panatag as a common fishing ground did not stop China from asserting control over the shoal.

In the same ruling, the international tribunal also invalidated China's massive "historical" claim in the South China Sea and West Philippine Sea.

Meanwhile, in the fishing community of Masinloc in Zambales, people are confident of a merrier Christmas this year with the lifting of the Chinese blockade of Panatag.

Antonio Calixtro, a fish dealer based in Barangay Matalbis, said the development has rekindled hope among fishermen and that their enthusiasm is palpable.

siasm is palpable
Calixtro supplies fishermen's needs
like fuel for motorized banca, ice for
preserving fish and food for a week
for fishing expeditions.

"We have problems for daily needs since the Chinese occupied Scarborough in 2012 and denied our fishermen access to the shoal, but now that has changed and we hope to see it continue to happen so we will have a merry Christmas," Calixtro told The STAR.

Roberto Aldea, a storeowner in Barangay Luanan in Palauig, said the residents suffered terribly when the Chinese barred their fishermen from Panatag.

"But now that has changed again and hope our Christmas will be merry and happy again," Aldea said. He lends grocery items to fishermen's families.

Malacañang has also confirmed fishermen from Zambales, Bataan and even Pangasinan are now allowed inside the lagoon. Aerial image released recently by the Asia Maritime Transparency Initiative indicated the inner lagoon was still closed to Filipino fishermen, with a Chinese coast guard vessel guarding the lagoon's mouth.

Doubts raised

Meanwhile, Pangasinan Rep. Jesus Celeste yesterday expressed doubts Filipino fishermen were able to go to Panatag without hassle, saying no fishing boat could have reached the place due to inclement weather.

In an interview over dwlZ, Celeste said fishermen usually avoid the shoal in the months of November and December due to big waves. "Fo my mind. I cannot believe there are fishermen who went to that area," Celeste, himself a fisherman, said. "November, December, there is no fishing because of big waves," he added. Celeste's turnincludes coastal towns like Infanta, Dasol and Bolinao. He said fishermen go to Panatag between February and July.

"Once amihan starts, they do not go there anymore. They will just lose because of their fuel expenses but few fish catch," he added.

But Charlito Maniago, barangay captain of Cato, Infanta, Pangasinan said some of his constituents returned from Panatag late October with bountiful catch.

"We would see this time because they are set to leave anew and fish in that area again, if indeed they are already free again to fish in Scarborough Shoal," Maniago said. Travel from Cato to Panatag takes about 18 hours.

Maniago also said they had expected President Duterte to discuss developments at Panatag during his brief visit to Sual last Nov. 2. The President, however, only presided over the ceremonial sendoff for 17 Vietnamese fishermen arrested in September for fishing illegally in the waters of llocos Sur.

wing to his trust and respect for President Duterte, Moro National Liberation Front (MNLF) founding chairman Nur Misuari has pledged his steadfast support to the government's efforts in advancing peace in Mindanao.

Misuari made the pledge to the President in Malacañang after being delighted to regain his partial reedem following the suspension of a arrest warrant against him.

"Allow me to reiterate my sense of gratitude to the President and my promise that should be need our cooperation in his campaign for peace, you can count on us, Mr. President," Misuari said in his remarks at the Palace.

Misuari had earlier came out of hiding after a court suspended a warrant arrest in connection with his alleged involvement in the deadly Zamboanga siege in 2013. Some government officials, led by Presidential Adviser on the Peace Process Secretary Jesus Dureza, fetched Misuari in Jolo, >4

Sulu and brought him to Manila for a historic meeting with the President in the Palace.

Misuari admitted that he was "happy to be free again," thanking the President for his role in "restoring my freedom if only partially."

"Lam so happy to be free again, owing to the initiative of our President,"

He also described the President as the "man who I respect and trust," adding he could never reject an invitation from Duterte to talk peace "because I respect him too much."

"I came here to meet the President, the man who I respect and trust," Mi-

"I believe, as I said during the campaign, there is one single man who can provide solutions to the problem of peace and order in our homeland of Mindanao," he said.

The President, meantime, welcomed "with great happiness" Misuari's decision to talk peace with the government. He assured Misuari that there was no intention to deprive him. of his liberty

Duterte had earlier invited Misuari to hold a dialogue about the peace process in Mindanao, assuring the fugitive leader that he would be given safe passage by the government. He recognized Misuari's key role in bringing peace to the troubled south.

"There is the pending warrant which is suspended now upon my orders so that we can talk and I would like to assure Nur, brother Nur, that there was never any intention to deprive you of your liberty," Duterte said.

He also asked Misuari to work with him and other Moro brothers in creating a "country that is really, that is just and that is good and that would be for the next generations to come."

"I assure you, I said, as you have narrated, we will come up with the modality and then of course, how to place us in our proper homeland, our Mindanao, and that we will talk about the Bangsamoro Authority," he added.

Justice Secretary Vitaliano Aguirre

said criminal proceedings against Misuari have been suspended to allow the resumption of peace talks with the rebel group. He stressed that the warrant of arrest against him was not lifted, but only suspended.

Misuari is facing non-bailable charges of rebellion and violation of Republic Act 9851, the Philippine Act on Crimes Against International Humanitarian Law, Genocide, and Other Crimes Against Humanity, before the Pasig Regional Trial Court (RTC) in connection with the 2013 Zamboanga

Proceedings were only suspended. Thus, implementation of warrant of arrest against Misuari was suspended," stated Aguirre.

In a resolution dated October 27,

Jadge Ma. Rowena Modesto-San Pedro of Pasig Regional Trial Court (RTC) Branch 158 granted the request of the Office of the Presidential Adviser on the Peace Process (OPAPP) to suspend the proceedings and the enforcement of the arrest warrants.

"The Philippine National Police, Armed Forces of the Philippines, the National Bureau of Investigation, and other law enforcement agencies are hereby directed to suspend, as well, the enforcement of the Warrants of Arrest issued against accused Nur Misuari," read the resolution.

The judge indicated that the suspension of proceedings is only for a period of six months starting from the issuance of the resolution. (With a report from Jeffrey G. Damicog)

No budget for allowance hike of cops, soldiers

The proposed 2017 national budget does not include the increased combat allowance for soldiers and policemen promised by President

Camarines Sur Rep. Rolando Andaya Jr., Deputy Speaker and former House appropriations committee chairman, disclosed this to media yesterday.

Andaya was quick to add, though, that it is still not too late for the House to include the required P12-billion budget for the increased combat incentive next year.

He said the chamber could propose the inclusion of the fund during the bicameral con-

ference on budget, after the Senate approves its version of the government's spending bill.

The House passed its proposed 2017 national budget on third and final reading before the congressional recess two weeks ago. The chamber is set to transmit it to the By JESS DIAZ

Senate when sessions resume next week.

Andaya said the Department of Budget and Management was not able to include funding for the increased combat allowance because the budget proposal was already with the House when President Duterte authorized the adjustment.

He assured soldiers and policemen, though, that there is still time to adjust the 2017 budget to provide funds for their incentive.

Duterte increased the combat pay of uniformed military and police

personnel from about P500 a month to P3,000 starting September.

The President has also promised to double

their pay next month. Earlier, Budget Secretary Benjamin Diokno said there were no funds in this year's or in next year's budget to fulfill the President's promise

But he pointed out that the country's soldiers and cops would get salary hikes, as these are included in the government-wide pay adjustment program laid out in the 2017 budget.

Andaya has estimated that doubling the salaries of uniformed military and police personnel would cost taxpayers about P230 billion a year.

AFP treads softly on Scarborough

FOR the sake of the fishermen's livelihood, the Armed Forces will not be sending ships to assert the country's claim over Scarborough or Panatag shoal, Armed Forces spokesman Brig. Gen. Restituto Padilla said yesterday.

"As of now, we're not," Padilla said when asked to react to the suggestion of some groups to send ships to the shoal which was taken over by China in April 2012.

Padilla said the military's action will remain confined to monitoring. He did not elaborate.

"We'll be monitoring only and let the current condition to prevail...It's better that we not comment (on how the military will do the monitoring)," he said.

He said the Armed Forces welcomes the recent developments in the shoal "and we hope this continues in the interest of all those who are getting their livelihood out of the area."

"It's better that we allow the

prevailing condition to continue for the interest of our fishermen," said Padilla, appealing to the public not to "muddle" the situation, pending dialogue between the two sides.

"We all know that (past) events there were sensitive so any move should be properly calculated. What we want to prevail is a situation where our fishermen can resume livelihood and we achieved that already," added Padilla.

China had been driving away Filipino fishermen from the shoal until after President Duterte went on a state visit to China to strengthen ties.

Despite the development, Foreign Affairs

Secretary Perfecto Yasay Jr. reiterated that no agreement has been reached between Manila and Beijing regarding Panatag Shoal.

Yasay said what happened could be part of a "quiet diplomacy" between the two countries to inspire and build mutual trust.

"There is no agreement that has been arrived at with China insofar as these ships leaving or our fishermen having access to Scarborough or Panatag Shoal but I would imagine as part of our quiet diplomacy trying to build mutual trust and confidence with two countries, these have been made possible," Yasay said in a television interview Thursday.

The DFA chief also denied that the country sought permission from Chinese authorities to allow Filipino fishermen to

return to Scarborough. He said doing so would mean conceding authority to China.

Yasay did not answer why Chinese Coast Guard ships and a Navy vessel are still in the area, though Filipino fishermen who have ventured there said they were not harassed.

In a statement Wednesday, the Chinese Foreign Ministry said the condition "is and will remain unchanged," as "the Chinese side has always been exercising normal jurisdiction over Huangyan Dao (Scarborough Shoal).

For his part, National Security Adviser Hermogenes Esperon Jr. said both countries reached a "friendly understanding" to let Filipino fishermen go back to Scarborough, without Manila and Beijing dropping their claims.

Phl, Malaysia, Indonesia to join forces vs Abus

DAVAO CITY -- The Philippines, Malaysia and Indonesia will jointly pursue the Abu Sayyaf as an international terrorist group, President Duterte

Duterte stressed the need for the three countries to join forces and strengthen border patrol to prevent the Abu Sayyaf from kidnapping for-

"We are looking into who are with the Abu Sayyaf other than the Filipinos. There could be foreigners with the group. Duterte said on Tuesday

Duterte said he would discuss the issue with Malaysian Prime Minister Najib Razak when he visits Kuala Lumpur next week.

"I have already discussed it with Indonesian President Joko Widodo and we have agreed on strengthening our border cooperation," he said.

Up to 18 Indonesians and Malaysians were kidnapped in three attacks on tugboats earlier this year in Philippine waters by groups suspected to have ties to the Abu Sayyat. All 14 Indonesian citizens were

later released.

The rise of sea bijackings involving the Abu Sayyat has prompted Indonesia, the Philippines and Malaysia to agree on measures to coordinate patrols to secure the region's busy waterways. However, coordinated patrols are yet to get underway.

"We are going to jointly address this problem of piracy in the seas together with indonesia and Malaysia by conducting joint border patrols in going after the Abu Sayvaf," Duterte said.

Abu Sayyaf, known for amassing tens of millions of dollars from kidnappings, reportedly earned more than P380 million in ransom for the first half of the year.

"The point is, they are bringing their victims and keeping them in Sulu," Duterte said.

Duterte said the government would also look into the 126,000 cross-border trips between Malaysia and the Philippines as well as between Indonesia and the Philippines. that have gone unchecked by proper authorities.

Visuari ready to talk peace with

gov't

Fugitive Moro National Liberation Front (MNLF) founding chairman. Nur Misuari surfaced in Sulu yesterday and then met with President Duterte at Malacañang to discuss peace between the government and the Muslim rebels in Mindanao.

Duterte recalled how he had accepted Misuari with open arms when he was still vice mayor of Davao City and "I said that maybe someday we can finally talk about peace."

"And little did I know, brother Nur, by the grace of Allah, I became the president of the republic and in the twilight of our years, we would be able to talk about the problem of our country, the revolution that you have led all these years and finally, understanding on a common ground with government," Duterte said.

"And that I assure you, I said, as you have narrated, we will come up with the modality and then of course, how to place us in our proper homeland, our Mindanao, and that we will talk about the Bangsamoro Authority," the President added

Duterte said he and Misuari were now ready for the peace negotiations and even the federal system of government, "give everybody his due, do justice to the Moro people" who had been victimized by atrocties for years.

Duterte and Misuari embraced each other before Misuari on the President's instance approached the podium and

Misuari vowed to cooperate with Duterte's peace efforts as he assailed the media for supposedly distorting his statements. He expressed confidence that the President would fulfill his promise to bring lasting peace to the country.

The impact of the Zamboanga City siege, for which Misuari is wanted, was not mentioned during the speeches of Duterte and Misuari. The aging MNLF leader, however, mentioned the event to stress that his group was not yet a spent force as portrayed by media.

Misuari said even the Bangsamoro Islamic Freedom Fighters (BIFF), the breakaway group of the Moro Islamic Liberation Front (MILF), was sympathetic with him and told him "if you go to war, count on us."

"I want people to be truthful about things. If you want us to be fair with you, you want us to deal with you, please be fair with us, just tell the truth, simple truth," Misuari said.

Sipadan hostage-taking

Misuari also revealed that some Malaysian leaders were

behind the Sipadan kidnapping incident in April 2000. A total of 21 people, mostly European tourists, were kidnapped in a dive resort in Sipadan, Malaysia and were held by the Abu Sayyaf for more than a year in Mindanao.

The MNLF founder lamented that his group was blamed for the kidnapping incident Misuari was governor of the Autonomous Region in Muslim Mindanao at the time.

Duterte said the warrants of arrest were "lifted." but Justice Secretary Vitaliano Aguirre II clarified they were only suspended.

Presidential Peace Adviser Jesus Dureza, who fetched Misuari from Sulu to meet Duterte in Malacañang, was described by Duterte as a key player in his road map to peace in Mindanao.

Habib Mujahab Hashim, chair of the MNLF's Islamic Command Council (ICC), said Dureza presented the suspended warrants to Misuari, who emerged in Jolo with several of his armed MNLF followers.

Hashim said Dureza escorted Misuari out of Jolo at 11.25 a.m. to meet with Duterte originally in Davao City.

The suspension of proceedings and the enforcement of the warrants of arrest against Misuarı will be effective for six months, unless sooner lifted by the court, read the order directed at the Philippine National Police, Armed Forces of the Philippines and the National Bureau of Investigation.

The local government of Zamboanga City initiated the filing of the cases against Misuari and wanted him held accountable for the 21-day siege that killed more than 200 civilians, soldiers and

rebels.

Duterte earlier called on the military and police not to arrest Misuari so as not to jeopardize government efforts to forge peace with the MNLE

In its decision, the court cited the vital role of Misuari in the peace talks and that pursuing negotiations with the MNLF was a political assessment of the executive department.

Hashim said the meeting of Misuari and Duterte would boost the chances of lasting

peace in Mindanao The government has been talking peace with the MILF but the Duterte government wants the MNLF and other sectors included, as well as the full implementation of all Bangsamoro peace agree-

ments.

The government of Zamboanga City and the AFP also declared their full support for Duterte's "bold and fresh"

initiatives to bring out Misuari to achieve sustainable peace in Mindanao.

But Mayor Maria Isabelle Climaco-Salazar said the city would pursue its cases against Misuari for his alleged masterminding the bloody September 2013 siege.

"Secretary Jess (Dureza exerted) effort to explain that Misuari's release is temporary and subject to several conditions imposed by the court. Salazar said


Salazar sard sire had mentioned to Duterte on several conversations that Misuari must be made accountable for his alleged crimes against the people of the city. "We trust (that) justice will eventually be served," Salazar said.

AFP spokesman Brig. Gen. Restituto Padilla said the military could only hope that Misuari's surfacing would lead to a big leap in attaining peace. "We, as members of the AFP, are abiding by the orders of our commander-inchief, because we know that his only desire is to have a lasting peace in our country," Padilla said.

"There will be some opposition to this move but let us wait. The process is yet to be finished and let us allow our negotiators to work (on) this. The more important thing is to serve justice but at the same it is also equally paramount to bring peace to the land,"

Nur links Malaysia leaders to Mindanao kidnappings

oro National Liberation
Front (MNLF) founding
chair Nur Misuari has accused "leaders" of Malaysia
for alleged involvement in the kidnappings in Mindanao, threatening to take
them before the international court.

Misuari dropped the bombshell shortly after holding talks with President Duterte in Malacañang on how to pursue lasting peace in the troubled south.

"Our source is saying that since Malaysia is the one who is involved in this kidnapping-for-ransom, probably, one day, I will drag their leaders into that International Criminal Court," Misuari said in his fiery remarks at the Palace.

"I have all the (pieces of) evidence in my hands," he added.

Misuari claimed that these Malaysian conspirators have hired his own people to do their dirty work, citing the 2000 Sipadan hostage taking.

"My people are everywhere and besides, they cannot escape because they are hiring my own people. Even Sipadan, they hired my cadre officers; because they opt for the millions," he said.

In 2000, 21 foreign hostages were abducted from a dive resort in Sipadan, Malaysia, by Islamic militants and were later taken to an Abu Sayyaf stronghold in Jolo. The captives were eventually released after the alleged exchange of hefty ransom payments.

In recalling the incident, Misuari voiced his disgust toward the Malaysian leaders who had the gall to seek a dialogue with him in Jeddah or Saudi Arabia. He said he rejected such overtures because "I don't have the heart to see these people."

Misuari criticized these Malaysians for the "conspiracy to destroy the honor and integrity of my people."

While he linked the Malaysians to the abductions in the south, Misuari highlighted his role in the safe recovery of hostages, including Norwegian

Kjartan Sekkingstad, taken by the Abu Sayyaf Group

He said when Duterte asked him to move against the Abu Sayyaf, he sent his forces to force the bandits to release the hostages. "I want people to be truthful about things. If you want us to be fair with you, you want us to deal with you, please be fair with us, just tell the truth, simple truth," he said.

In the same event, Misuari rallied behind President Duterte's war on illegal drugs, saying the menace was the biggest threat to humanity.

"Everytime I finish my prayers in the morning, morning prayers, I go to the balcony of my humble house, overlooking the highway, in Jolo. Everytime I see people, young people, in the prime of their life, walking like insane people. I say what's the cause? Drugs," he said.

"They are destroying our children, our youths. Who will succeed us after this, when our citizens are already destroyed by these drugs? To us, Eve always been saying that drug is a restless creeping 'threat to humanity," he added.

tarian crisis looms in Sulu, Basilan

Residents displaced by fighting between gov't, Abus need help, says International Committee of the Red Cross official

ZAMBOANGA CITY—The International Committee of the Red Cross (ICRC) said it has been receiving reports of humanitanan concerns in Sulu and Basilan provinces as a result of clashes between government troops and bandits, but it must carefully assess the situation before it sends teams there due to a violent experience in the past.

Wolde-Gabriel Saugeron, deputy head of delegation for prevention and communication of ICRC, cited the January 2009 kidnapping of ICRC workers Andreas Notter, Eugenio Vagni and Mary Jane Lacaba in Sulu

"The kidnapping of 2009 was quite a trauma for the organization;" Saugeron said in a recent visit here.

He said the humanitarian concerns, due to conflicts in the two provinces, were being assessed by ICRC because "there are needs of the civilian population."

The military has laimched massive operations in Basilan and Sulu to stamp out Abu

Sayyaf bandits.

Journalists based in these provinces reported there had been families displaced by the fighting and they hardly received aid. They said residents in Barangay Danag in Patikul town, for example, were ordered to vacate their homes to give way to, military operations there.

Displaced families

Haroun Al-Rashid Lucman Jr., regional vice governor of the Autonomous Region in Muslim Mindanao and who acts as regional social welfare secretary, said five towns in Sulu were affected by the operation. He said their monitoring showed that 19,763 people or 3,985 families had been displaced in the province.

In Basilan, where operations covered four towns, he said 1,729 families were affected by the fighting.

"Definitely, we are now assessing the situation and also reaching out to all stakeholders so we can have a dialogue with. everyone and be granted enough security guarantee to work in Sulu and Basilan,"

Saugeron said.

He said working in the two provinces "is definitely one of our priorities now."

Maj. Filemon Tan Jr., spokesperson of the military's Western Mindanao Command, said the operations in Sulu and Basilan were continuing and that casualties from both sides

were being reported.

The ongoing offensives against the Abu Sayyaf make humanitarian intervention a bit difficult, Saugeron said.


But he said ICRC was trying its best to deliver aid to displaced residents of Sulu and Basilan through its local partners.

"We are not directly going

there [at this time] but it doesn't mean that we are inactive. We can work through other partners," Saugeron said.

Lucman said the regional government had provided an mitial assistance of about 12,000 food packs, worth P5.3 million, to families displaced by clashes in these provinces. INQ

China wants military alliance with PH to 'move forward'

The Chinese Ministry of National Defense (MND) wishes to "move forward" on its military ties with the Philippines.

Colonel Wu Qian, spokesperson for the Ministry of National Defense (MND) of the People's Republic of China (PRC), expressed hope that the military-to-military relationship between China and Philippines would be further developed and strengthened. He made the statements during a press briefing at the Ministry on October 27, 2016.

Responding to the Chinese Ministry of Defense's pronouncement, Foreign Affairs Secretary Perfecto Yasay Jr. clarified that "we do not have military alliance with China," adding that "forging military alliance with China is not in the Philippine government's radar."

Colonel Wu Qian said.
"If you want me to make comments on the recent China Philippines military-to-military relationship, I'd like to say that the relationship seemed to be going nowhere, but we expect to find a way

forward," he said during the press briefing

Wu noted that "the healthy and stable development of the military-to-military relationship between China and the Philippines is in accord with the fundamental interests of the people of the two countries, and are conducive to regional peace and stability."

He said that the Chinese military took note of the "consensus" reached between President Xi Jinping and President Duterte when the latter visited Beijing last month.

"The armed forces of the two countries will earnestly implement the important consensuses reached between President Xi Jinping and President Duterte, remove obstacles, manage disputes, accumulate mutual trust and strengthen exchanges and cooperation, so as to make positive contributions to the development of bilateral relations," Wu said.

Reaffirming his earlier statement, Secretary Yasay said: "Military alliance is something that is not being thought of. We have not discussed it with China at this point."

Second chance for Misuari

Nur Misuari once famously sighed that waging a rebellion was easier than governance. This was when he was governor of the Autonomous Region in Muslim Mindanao - his prize for forging peace between his Moro National Liberation Front and the Ramos administration in 1996.

The landmark peace agreement brought many MNLF members into the social mainstream, raising hopes for peace in the Muslim region. But the ARMM suffered from weak governance. MNLF members also found themselves confronting their breakaway faction, the Moro Islamic Liberation Front.

By most indications, the founding MNLF chieftain proved to be an ineffective ARMM governor, Allegations of corruption hounded Misuari's government, and the ARMM struggled to be lifted from poverty and underdevelopment. Lines between public and private funds were blurred, with the ARMM arsenal serving as Misuari's own but built up using people's money. In 2000, MNLF members ousted him as their chairman and fielded Parouk Hussin to replace him as ARMM governor. The national government also sought an accounting from Misuari for P43 billion in ARMM funds.

With his hold on power crum-

bling, Misuari loyalists attacked Army outposts in Sulu on Nov. 19, 2001. His nephew Julhambri Misuari also led some 300 MNLF loyalists in taking over the Cabatangan government complex in Zamboanga city, holding local residents hostage. By the time the "mini rebellion" was quelled, some 100 people were dead and many others wounded.

In 2013, as the Misuari faction of the MNLF felt left out in the peace process with the MILF, Misuari loyalists again attacked Zamboanga, laying siege to the city for nearly three weeks. About 25 people were killed and the house-to-house combat displaced an estimated 100,000 people.

Now President Duterte has plucked Misuari from his legal woes and given the MNLF founder yet another chance to work for peace. For understandable reasons, there are groups particularly in Zamboanga that harbor misgivings about this peace initiative with a man who has a record of using power for personal purposes. At the start of a new administration, however, the President can still ask the nation to support his peace efforts. Misuari is being given a golden chance to reinvent himself. The least that he can do is to make sure he will not disappoint a trusting President.

A local court has ordered the lifting of the arrest warrant against Moro National Liberation Front founding chairman Nur Misuari in connection with the bloody Zamboanga City siege in 2013.

AFP: Study needed before PHL can decide on new suppliers of weapons, equipment

From the Philippine News Agency (Nov 3): AFP: Study needed before PHL can decide on new suppliers of weapons, equipment

An official of the Armed Forces of the Philippines (AFP) said purchase of military weapons and equipment from other suppliers aside from the US needs careful study and research.

Before looking for a new supplier, AFP public affairs office chief Col. Edgard Arevalo said the weapons and equipment for purchase must meet the requirements set.

"I think the Commander or Chief (President Fodrigo Duterte) has already intentioned that there are other suppliers who are willing to provide for our needs but this needs in detailed study or research to determine whether they are readily adoptable to local conditions, availability of supply reliable, efficient and dependable." Arevalo said in Filipino.

He cited the case of radio equipment which he said must be able to communicate from ship-toship, planes or in ground units.

Earlier, Arevalo said US supplies of weapons and other defense equipment will continue pending the abrogation of the 1951 Mutual Defense Treaty (MDT).

He made this comment after being asked on whether the alleged US order halting the sale of 26,000 assault rifles to the Philippine National Police (PNP) will have repercussions on the Filipino military.

"The alleged US decision to halt sales of 26,000 assault rifles to the PNP will not have an effect on the AFP as our weapons and equipment are sourced through Foreign Military Sales (FMS) which is guarantee under the MDT," Arevalo said in Filipino.

Through FMS, weapons or equipment for acquisition will not need to pass US Congress approval, unlike contracts completed using American suppliers or manufacturers.

Sole approval on FMS lies on the US government, the AFP official said.

Until the 1951 MDT is abrogated, the AFP can source its equipment needs through FMS, he added.

The Filipino boxer joined the Army's reserve force on April 27, 2006 as a sergeant and rose through the ranks through meritorious promotion.

He was conferred his current rank in 2011 after satisfying the requirements for commissionship in the military.
