



non prohibits foreign troops from engaging in direct com-bat operations, the US soldiers' role is limited to assisting the local mulitary through training and information sharing

The US Joint Special Operations Task. Force-Philippines, set up in 2002 upon the request of then president Gloria Macapagal-Arroyo amid a kidnapping spree in Basilan by the Abu Sayyaf ended its mission in Zamboanga in 2015. The ISOTF-P consisted mainly of Special Forces and SEALs

A ranking Philippine military official who declined to be named said fewer than 200 US soldiers have remained in Zamboanga City, and they were mainly involved in pro-viding "technical assistance" to Filir ino troops

"The situation there (in Mindanao) will worsen If they (Americans) are seen there, they will be killed," Duterle said.

The President said it was a message he could not deliver during the Association of Southeast Asian Nations summit in Laos last week, mainly out of respect for US President Barack Obama who was at the summit

"I could not speak then out of respect and I do not want a rift with America. But they

terrorists. Since the Constituth have to go," the President said Under Duterte, the Philippines has had an uncomfortable relationship with the US, its treaty partner and longtime ally. The Philippine president has scored the American government for lecturing him about human rights despite its own record of atrocities committed by its soldiers during the Philippine-American War in 1898

The US has expressed deep concerns over rising deaths of suspected drug offenders in Duferte's war on illegal drugs Human rights advocates said Duterte's tough approach to fighting drugs has encouraged summary executions and targeted only the poor. Nearly 3,000 suspected drug offenders have been killed since Duterte assumed office in June, almost half of them by suspected vigilante groups

Duterte has lashed back at the US by citing its supposed failure to stop the killing of African Americans by policemen and by accusing it of "exporting terrorism" in the Middle East.

The President continued with his tirades against the US yesterday as he blamed Washington for the violence in Iraq and Libya. He also showed photos of the Bud Dajo massaare, where US forces massacred. more than a thousand Muslim fighters and civilians holed up in a mountain fortress during the Filippro-American war

The photo showed American soldiers posing among piles of dead Muslims including naked women The reassacre happened in Jolo in 1906 "The US is a hypocrite," Duterte said

He had also shown photos of the Bud Dajo massacre at the East Asian Summit in Lacs

"Look at the bodies there For as long as we stay with America, we will never have peace in that land We might as well give it up," Duterte said
"See the soldiers stepping

on a woman's bare breast They even made a postcard out of it he added

Piesidential spokesman Ernesto Abella said Duterte's statement reflects the President's "new direction towards coursing an independent for-

eign policy"
"He (Duterte) has made reference to the unrecognized, unrepented and unatoned for massacre at Bud Dajo in Sulu by the Americans, hence our continued connection with West is the real reason for the 'Islamic' threat in Mindanao," Abella said in a statement

"The American silence on the matter lacks congruence with its 'moral' position, in the light of actions taken in the past by the Germans who

confessed and made aronement for the Holocaust, and Japan which made reparations for the atrocities it perpetrated among the peoples they conquered," he added

Abella said Duterte is on "morally firm ground" by "breaking up walls that cover dark corners" in the bilateral ties between the Philippines and the US

Duterte has vowed to pursue an independent foreign policy and has repeatedly stressed that he is not beholden to anyone but the Filiping people

Rock solid

Despite Duterte's latest innuendo against the US the Philippines' relationship with the mightiest nation remains "rock solid" according to Defense Secretary Delfin Lorenzana

"It's strong," Lorenzana said. "The US is truly a military ally because of our mutual defense weaty which was signed in the 1950s and is still there," he said, referring to the Mutual Defense Treaty

"It's not abrogated. What the President said was we're going to talk with others who could give us good equipment to stiengthen our defense and we will do that, but we are going to still have our treaty alliance with the United States," he added.

In fact, Lorenzana said he

had a scheduled meeting with the US officials led by Detense Secretary Ashton Carter by the end of September in Honolulu to discuss security issues

He said ASEAN defense ministers would also discuss security issues in the South China Sea as well as terrorism among other issues

President Obama called off a planned meeting last week with President Duterte on the sidelines of the ASEAN summit, after the latter spewed out expletives at US officials whom he accused of intertering in Philippine affairs.

"Clearly, he's a colorful guy," Obama said on being told of Duterte's unsavory statements "What I've instructed my team to do is talk to their Philippine counterparts to find out is this in fact a time where we can have some constructive, productive conversations."

Meanwhile, military officials – especially those in the Western Mindanao Command – declined to comment on the President's position against the presence of US troops in the region.

"It is beyond our level and any statement relative to that pronouncement of our Commander-in-Chief will be from the higher headquarters," a military official who declined to be named said.

The military official said there are still US military per-

sonnel operating in Zamboanga City under the status of foreign liaison elements at the Westmincom

US military forces used to operate under the US Special Operation Task Force-Philippines (JSOTF-P) with troops deployed on iotation basis since 2002. If terminated its operations after 10 years and left its camp inside Westmincom only with haison personnel.

The deployment then of US military torces was upon the multation of the Philippine government to assist and advise their Filipine counterpart in the campaign against terrorism particularly by the Abu Sayvaf group

Meanwhile, local officials in Basilan and Sulu said they were saddened by Duterte's pronouncement against the US military. They said US soldiers have been active in humanitarian projects in the region.

"We have reservations on the pronouncement of the Fresident as we all know the assistance provided by the US troops in ensuring the security and peace and order in the city" acting Mayor Cesar Ituralde said. He said they hope the President would reconsider his pronouncement.

"But we will highly respect the President as we are very much supportive of his plans and programs in this matter," he added. — With Cecille Suerte Felipe, Roel Pareño 3 September 2016

Says Abu terrorists consider

'high-value targets'

PRESIDENT Duterte yesterday called for the withdrawal of US military personnel from Mindanao, fearing an American troop presence could complicate offensives against Islamist militants notorious for beheading Westerners.

Mr. Duterte, who was in the spotlight last week over his televised tirade against the United States and US President Barack Obama, said Special Forces now training Filipino troops were high-value targets for the Islamic State-linked Abu Sayyaf as counterinsurgency operations intensified.

"These Special Forces, they have to go," Mr. Duterte said in a speech during an oath-taking ceremony for new officials. "I do not want a rift with America. But they have to go."

American troops are staying in the Western Mindanao Command headquarters in Zamboanga City. Both US and Philippine military officials refused to give the exact number of American soldiers.

Early this year US troops trained elite policemen on marksmanship. The 45-day marksman-

ship training focuses on enhancing the skills and capabilities of Special Action Force (SAF) men.

Gas station owner in Lanao Sur abducted

A 60-YEAR-OID female owner of a gas station was abducted by still unidentified armed men in Linamon town in Lanao del Norte early morning pesterday.

Le Col. Benedicto Manquiquis public affairs officer of the Army's 1st Infantry Division in Zamboanga del Sur, said military efforts are underway to rescue the victim, who was identified as Clarita Belisario.

Citing initial reports, Manquiquis said Belismio was abducted at the Caltex gas station she owns at Purok 4 in Poblacion Linamon at around 5 a.m. He said the gas station is located in front of the Belisario's residence.

Manquiquis said Belisario was seized by eight "fully-armed" men who used a gray van and a white Mitsubishi Montero sports utility vehicle, with plate number ABC 5430, in the kidnapping.

Maj. Highway robbery

ZAMBOANGA (TTY – Five armed men siaged a hold-up in a provincial bus at dayin yesterday and carted away the passengers' cash and personal belongings amounting to some P85,000

Jude Amantiad driver of Rural Transit Bus Kinglong and conductor Virgil reported to the Siay Muricipal Police Station that five armedmen held up their bus about 12:30 a.m. yesterday along the national highway of Barangay Mirangan in Siay town, Sibugay province

The provincial bus, with plate number JVH-940, was carrying 15 passengers at the time of the incident

The passengers said the robbers were armed with 45 caliber pistols. They hoarded the bus pretending to be passengers.

Amantiad told police probers that two single Honda motorcycles waited at Mirangan, where the holdup incident took place

Amantiad said the two suspects on board declared the hold-up, one of them pointing a gun to him. The men ordered the bus to stop where the two motorcycles were parked

He said the three men standing along the motorcycles immediately boarded the bus and took the cash and belongings of the passengers.

One of the passengers. Phil. Army Corporal Rogelio A. Baman, was able to shoot the last suspect who stepped out of the bus, hitting him in the neck area. But the other men took the wounded man with them to escape.

Ex-ceasefire chief to head Army division in Central Mindanao

DATU ODIN SINSUAT, Maguindanao—A military officer who served as ceasefire mechanism chairman during the Mamasapano massacre in 2015 will be installed as commanding officer of the Army's 6th Infantry Division (6ID) based here.

Maj. Gen. Carlito Galvez, deputy chief of staff for operations, will assume his new post on Monday in turnover rites to be presided by Army chief Lt. Gen. Eduardo Año.

Galvez, a member of the Philippine Military Academy Class of 1985, will replace Maj. Gen. Edmundo Pangilinan, who assumed his new position as Army's vice commander last week.

The incoming commander of the 6ID served as chairman of the Coordinating Committee on the Cessation of Hostilities, the ceasefire mechanism panel formed in the peace talks with the Moro National Liberation Front for about a year. He was the chairman during the Mamasapano bloodbath in January 2015 that killed 44 elite policemen.

The police forces engaged with the MILF and the Bangsamoro Islamic Freedom Fighters when they took down top Malaysian terrorist Zulkifli bin Hir alias Marwan.

Galvez served as deputy chief for operations of the Armed Forces of the Philippines from October last year. He was previously the deputy commander of the Western Mindanao Command and the commander of the 104th Brigade in Basilan.

Army spokesperson Col. Benjamin Hao described Galvez as a "peace builder" and his role was also crucial in helping to prevent the Mamasapano incident from further escalating. *IDL/rga*

Combat planes from Korea, not US, clarifies Lorenzana

DEFENSE Secretary Delfin Lorenzana yesterday said the two FA-50 combat aircraft that arrived in the country in November last year had come from South Korea and not from the United States as President Duterte

Lorenzana issued the clarification following the President's speech before the Filipino community in Indonesia last week, that the two FA-50s, which he claimed were just for show, had come from the United States.

Mukhang nagkomali lung siya (It looks like he made a mistake), said Lorenzana. "Iyong FA-50 is from Korea, Sabi niya dalawa lang binigay, hindi eh labindalawa iyon (The FA-50 is from Korea. He said only two aircraft were given, but there were 12)

Ceremonial only

In his speech before the Filipino community in Indonesia on Sept 9, the President belittled the US defense assistance to the Philippines as for "ceremonial" purposes only.

He said: "We have received so many things from America. Thank you for your generosity. What they sold us two, only two FA-50 (fighter jets). It's FA-50 but they never gave us the missiles and the bullets and the can-

nons to fight. For ceremonial long (only) "...

Manufactured by the Korean Aerospace Industries (KAI), the FA-50s are expected to serve as the PAF's lead-in trainer Lorenzana said 10 more FA-50s will arrive in batches next year as part of the 12 planes purchased for the Armed Forces of the Philippines P18 9-billion modernization program

According to IHS Jane's All the World's Aircraft the FA-50 type, although billed as a "light" fighter, has a potent air-to-air and

air-to-surface capability

"The type has been flown by South Korea and the Philippines, with Iraq set to receive its first aircraft shortly and Feru considering an offer of the aircraft, said IHS Jane, considered the most trusted and respected public source of defense, risk and security information in the world.

Lorenzana said the FA-50 would serve as lead-in fighter, which means it could serve both as a trainer and fighter plane for Filipino pilots who have not experienced flying fighter planes for a long time.

The defense chief said it will take many years to train fighter pilots from the Philippine Air Force to fly real fighter planes.

"So FA-50 first, and then later on, if we have capabilities to purchase real fighter planes, we will do that," he said

DND chief to meet Carter, Asean peers

Lorenzana is due to fly to Honolulu, Hawaii at the end of the month to meet US Secretary Ashton Carter and his Association of Southeast Asian Nation counterparts.

Lorenzana made the announcement after attending the assumption of new 6th Infantry Division commander Maj. Gen. Carlito Galvez at the 6th ID headquarters in Maguindanao yesterday morning.

"We are going to discuss the security in the South China Sea, security against terrorism and other problems, general

problems concerning our security, he said the Asean defense ministers meeting.

Lorenzana did not elaborate on the specific issue that will be discussed about the South China Sea, or West Philippine Sea where the oil and minerals rich Spratly Islands are situated.

The Spratly Islands chain is being claimed in part or in whole by the Philippines, China, Malaysia, Vietnam, Brunei and Taiwan.

A United Nations arbitral court invalidated China's excessive nine-dash line claim in the South China Sea last July. Also,

it said China's occupation and reclamation of Mischief Reef was in violation of the UN Convention on the Law of the Sea.

Lorenzana said the Philippines' defense relations with the US remains strong, amid a rift between President Duterte and US President Barack Obama over human rights issues.

"It's strong. It's rock solid as the Americans described our defense relation or relationship," said Lorenzana. "US is our ally military ally because of the Mutual Defense Treaty which was signed in 1950s. -- Victor Reves

AFP verifying reports on abduction of 3 Malaysians

pines said yesterday that it is still verifying reports on the alleged abduction of three Ma laysians by the Abu Sayyaf Group near the tourist resort of Pulau Pom Pom off Semporna, Sahan, Malaysia

Marine Col Edgard A. Arevalo, the chief of AFP's Public Affairs Office said the military will make the announcement when information becomes available

'We're validating the report as well. We will make necessary reports as information become available," Arevalo said

AFP Spokesman Brig Gen Restituto Padilla said they have received an initial report on the incident but they have yet to validate it especially the information that the Abu Sayyaf Group was involved.

He quoted a report from Star Malaysia Online which said three fishermen were abducted by gunmen in Sabah waters near the tourist resort of Pulau Pom Pom off Semporna

The suspected Filipino armed group composed of seven men is believed to have taken the victims across the border towards the southern Philippines island chain of Tawi Tawi province.

Eastern Sabah Security Command (Esscom) commander Datuk Wan Abdul Bari Abdul Khalid confirmed that they received a report from the owners of the fishing trawler at 1:59 a.m. Sunday.

"Tcan only confirm Sabah police commissioner (Datuk Abdul Rashid Harun) will release the details later," he said when contacted

The owner of the fishing boat confirmed that the gumnen kidnapped the skipper and two crew members at about 10 20 p.m on Saturday

It is believed that the three fishermen, one of them identified as Flipino Bajaus were among a crew of 11 on the trawler when seven kidnappers confronted them at guipoint

The kidnappers only took three crewmen and fled in a green-colored fast boat lowards southern Philippines. The rest of the crew steered the trawler back to the Semoorna letty.

Meanwhile, AFP-Western Mindanao Command (AFP-WesMinCom) Spokesman Maj Filemon Tan said yesterday that the Malaysian Eastern Sabah Security Command (ESSCOM) has formally informed the military here of the recent kidnapping incident involving three Malaysian citizens.

The report of the ESSCOM said that the seven suspected members of the ASG were on board two 75 horsepower engine speed boat, took the victims at gun point and immediately sped to the high seas bordering Malaysia and Philippine waters.

Tan said operating troops of the Joint Task Force Tawi-Tawi and Naval forces Western Mindanao (NFWM) immediately mobilized their water assets to prevent the entry of the armed men with their hostages to Tawi-Tawi and Sulu

Tan said the military in this part of the country and ESSCOM will be sharing and exchanging information to track down the where about of the suspects and their hostages.

The incident came hardly two days after Esscom conducted an intensive operations against cross border sniugglers in the five districts in the east coast

Esscom has said that security forces were on high alert along the border as the Philippine military had launched a massive all-out war against the Abu Səyvəfin Jolo

AFP Chief of Staff Gen Ricardo Visaya visited and railied troops involved in the offensive against the terrorist Abu Sayyaf Group (ASG)

This is the fifth time that the AFP. Chief visited troops taking the brunt of the fighing in the effort to destroy the ASG and rescue the remaining hostages. Three of those visits were done after the beheading of Patrick James Almodvar a local Muslim Jolo resident, said Co. Rodrige Gregorio of the Information Support Team, Joint Task Force Sulu (JTFS).

The top brass of the AFP who accompanied the Chief of Staff were the Commanding General of the Phil Army, Lt Gen Erluardo Ano: Western Mindanao Command Chief Lt Gen Mayoralgo deta Cruz, Chief Surgeon, Brig. Gen Mariano Mejia, and other generals from the General Headquarters.

He said the troops were headed by Joint Task Force Sulu Commander, Brig Gen Arnel Dela Vega, with 101st Brigade and 501st Bridage Commanders Col Jesus Manangqui and Col Jose Faustine including Battation Commanders and other key officers and troops.

The visit aims to boost the morale of troops, be abreast of the conduct of operation and hear for himself the needs of the operating units as well as provide guidance and convey the message of President Duterte to ground troops on the war against terror, Gregorio said.

The AFP chief also inspected the newly constructed camp hospital and status of its facilities

"Those in the Abu Sayyaf who want to surrender, the AFP will accept them, provided that they release their hostages; if not, our soldiers will hunt them down and pursue them until all of them are neutralized" Gen. Gov't forces locating kidnapped Malaysians

GOVERNMENT forces have been deployed in Sulu and Tawi-Tawi to locate three Malaysian fishermen abducted from Malaysian waters last Saturday, a military official said yesterday.

The Abu Sayyaf is suspected to be behind the kidnapping, said Maj. Filemon Tan, spokesman of the Armed Forces' Western Mindanao Command based in Zamboanga City.

Malaysian officials on Sunday said the three crew members of a trawler were abducted last Saturday near a resort in Semporna by a group of seven "Filipino armed men" who headed to Tawi-Tawi after the incident with their victims.

They did not specifically point to the Abu Sayyaf which is blamed for the kidnapping of dozens of Indonesians and Malaysians in Indonesian, Malaysian and Philippine waters over the past several months

Tan, citing reports received from Malaysia's Eastern Sabah Security Command, Tan said the fishermen were seized at around 11 pm. Saturday in the general area of PomPom island near Mataking Island Resort off Semporna.

Tan said the suspects used a boat, powered by two 75-horse-power engines.

"The boat was described to be a color green and white with red line which sped off towards northeast in the direction of Alice reef and Bulubulu island of Tawi-Tawi," he said.

Tan said ground and naval forces immediately conducted intelligence operations established security points at the kidnappers' probable routes.

Tan said the military is continuously coordinating and sharing intelligence information with Malaysian authorities.

Tan said the kidnappers may have difficulty bringing their captives to Mindanao.

"The sea is rough. The Navy said they will have difficulty crossing because of the sea condition," he said.

If the kidnapping was indeed perpetrated by the Abu Sayyaf, the group did it possibly to distract the military from its operations against the group in Sulu and in Basilan.

Defense Secretary Delfin Lorenzana said he "suspects" the kidnap victims will be brought to Tawi-Tawi, Jolo in Sulu, or Basilan, where it would be easier for the Abu Sayyaf to hide.

He also said the campaign against the Abu Sayyaf is continuing.

President Duterte has said he wants the Abu Sayyaf destroyed during his term.

Mayon lava wall may collapse - Phivolcs

pine Institute of Volcanology and Seismology (Phivoics) has reiterated its warning against entering the 6-kilometer radius permanent danger zone (PDZ) as lava wall collapse may occur that could lead to pyroclastic flow in the southeast quadrant of the restive Mount Mayon here

"Possible collapse of lava wall might occur due to brittleness of the wall instigated by molten materials. Wall collapse is very dangerous because that could trigger pyroclastic flow," Phivoics regional director Ed Laguerta said on Monday.

He explained that if the lava dome currently blocking the volcano's rim explodes side by side with the wall collapse then pyroclastic flow may fall anytime.

Pyroclastic is the hottest molten volcanic material and can travel as fast as 60 kilometer per hour.

The southeast quadrant of the volcano is facing the towns of Santo Domingo Daraga and Camalig and the city of Legazpi

"So we are reiterating to the public not to enter the six-kilometer danger zone even though Mayon Volcano appears very calm. We don't know when the volcano may eropt but fresh magma beneath the volcano is activating," Lagueria said

Over the weekend, Phivolcs led by Laguerra with Raffy Alejandro of the Office of Civil Defense in Bicol, Ceduc Daep, chief of Albay Public Safety Emergency Management Office, and Air Force Major Aivin Buars of Tactical Operations Group 5-Philippine Air Force conducted an aerial survey to check possible development of new lava dome in the northern part of the volcano aside from the existing dome in the southeast quadrant

Daep told *The Manila Times* that they are not discounting the possibility of lava wall collapse in the coming days specifically when the volcano is expected to become more restive.

Mayon is an active stratovolcano and the most active in the country, having erupted more than 50 times in the past 400 years

Duterte to grace anniversary of 250th Presidential Airlift Wing

PRESIDENT Dutette will grace the 48th foundation anniversary today of the 250th Presidential Airlift Wing of the Philippine Air Force in Villamor Air Base in Pasar City

The mission of the 250th PAW is to "provide safe, secure and effective air transportation" for the President and the immediate members of his or her family, and for visiting heads of state, state guests and other VIPs.

After the anniversary celebration, the President will preside over his first command conference with the Air Force leadership. The command conference will be attended by other military and defense officials.

"He will be engaging with Air Force personnel and their dependents through the 'talk to the airmen' and boodle fight that will follow," said Air Force spokesman Col. Araus Robert Musico.

This will be the second major

Air Force event that the President will attend since assuming office on June 30.

The first was last July 5 during the celebration of the PAF's 59th foundation anniversary in Clark Air Base in Pumpanga.

Before assuming as President, Duterte criticized the acquisition by the Air Force of FA-50s as a "waste of money." What should have been bought, he said, were helicopters with night-flying capability.

The previous administration acquired 12 FA-50s for P18.9 billion from the Korean Aerospace Industries. Two of the aircraft were delivered last year while the sest are due for delivery this year and next year.

The acquisition of the fighter jets signaled the return of the Air Force to the supersonic age since the decommissioning of a fleet of F-5s in 2005 due to oldage and costly maintenance.

Last Friday, Puterte said the US sold the Philippine military the fighter jets.

He said: "We have received so many things from America. Thank you for your generosity. What they sold us, two, only two FA-50 (fighter iers). It's FA-50 but they never gave us the missiles and the bullets and the cannons to fight. For ceremonial lang (only)."

In an interview yesterday, Defense Secretary Delfin Lorenzana acknowledged the President made a mistake by saying the FA-50s came from US.

"Nagkamali lang siya, yung FA-50 is from Korea Sabi niya dalawa' lang binigay, hindi e, labindalawa yan, yung sampu ide-deliver pa' lang," Lorenzana said in an ambush interview in Maguindanao.

Lorenzana defended the acquisition of the fighter jets by the previous government.

"Ang nakita kong justification nung pagkuha nung past administration is that lead-in fighter kasi 'to. Ibig sabihin pwedeng gawing trainer, pwede ring gawing fighter," he said.

Arguments for Marcos burial at Libingan



(Part 2)

DURING the 2016 campaign, lameduck President Benigno Aguino III urged voters not to elect then-Senator Ferdinand "Bongbong" Marcos Jr., who was running for vice president Againo warned that electing the son will resurrect the authoritaiian government of the father

Despite Aquino's nationwide hate campaign, Bongbong got millions of votes, enough to land him in first place during the first three days of the election tally. and onward until the Commission on Elections and its controversial foreign contractor tampered with the counting machines

The millions of voters who supported Bongbong at the polls not only gave him their blessings for his quest for higher office; they also repudiated the Martial Law bogeyman-the scarecrow repeatedly used by the Aquinos to instigate continuing public scorn and hatred for the Marcoses.

President Ferdinand Marcos may have stepped down from office in February 1986 unceremoniously, but soon thereafter, the Filipino people reinstated his family to power Former first lady Imelda Romualdez Marcos has repeatedly won congressional seats. Eldesi daughter Imee leads her dad's Ilocos Norte. Bong-bong was elected senator. From this perspective alone, whatever anti-Marcos sentiment there was in the Philippines in 1986 has been extremely diluted today.

The anti-Marcos petitioners

contesting President Marcos' burial at the Libingan ng mga Bayani insist that Marcos was a criminal who plundered the nation's wealth—enough reason, they say, to stop the burial. They cite several decisions of the Supreme Court which contain passages that label the former president and his Martial Law regime as corrunt and abusive

Their argument has a flawthere is no Philippine court decision on record which convicted President Marcos for the crimes the ann-Marcos petitioners now attribute to him The Constitution mandates that every person is, in the absence of a final criminal conviction, presumed innocent Therefore, to insist otherwise, as the anti-Marcos petitioners want to, is to violate the Constitution. That makes the Marcus accusers violators of the fundamental law.

Indeed, there are statements in past decisions of the Supreme Court which do not put President Marcos and his strongman administration in a very good light. Those statements, however, were made in civil (not criminal) cases decided while Marcos was stranded in Hawaii. or had already passed away there. Where is the fairness in those statements?

For the record, President Marcos wanted to leave Hawaii and go home to the Philippines to face the music, but President Corazon Aquino refused to give him a passport, a refusal sustained by the Supreme Court. This deprived Marcos of his right to defend himself. Thus, it is unfair for the anti-Marcos petitioners to invoke those cases against Marcos.

Anti-Marcos remarks in past decisions of the Supreme Court, at the Libingan repeals all prior

made while President Marcos was stuck in Hawaii, or had already died there cannot take the place of the requisite final judgment by a Philippine court. rendered after due trial, finding Marcos guilty of the crimes attributed to him. There being no conviction by final judgment that may be cited against Marcos, the criminal label against him is in violation of due process.

The anti-Marcos petitroners may argue that it is not their fault that Marcos died in Hawan before he could be accused of and convicted for crimes he allegedly committed against his country and his people. It's not Marcos fault, either. Remember, Marcos wanted to return to the Philippines but Mrs. Aquino did not permit his repatriation.

Republic Act No 10368, enacted in 2013 (long after President Marcos passed away) calls for the payment of reparations to persons who allegedly suffered during the Martial Law years It does not prohibit Marcos' ourial at the Libingan.

Even if Republic Act No. 10368 were to contain a provision categorically Jeclaring Marcos a criminal and prohibiting his burial at the Libingan for that reason, that provision is unconstitutional because it amounts to class legislation, and convicts an individual without a prior trial.

Whether or not regulations of the Armed Forces of the Philippines regarding burials at the Libingan are binding on the Supreme Court is immaterial. President Duterte is the commander-inchief of the AFP, and he has the discretion to amend AFP regulations any time. His recent decision to allow the Marcos burial

AFP regulations As such, and as stated in last week's column, the only issue to be resolved in the anti-Marcos petitions in the Supreme Court is whether or not President Duterte committed a grave abuse of his discretion when he allowed the Marcos burial at the Libingan From all indications discussed in this column, President Duterte did not commit a grave abuse of discretion

Finally it is speculative to say that President Marcos was dishonorably discharged from office by the Filipino people in the so-called 1986 Edsa Revolution

First, stories about the events which led to the 1986 Edsa Revolution were written by Aquino allies Those stories praised the event as a bloodless revolt, but failed to mention that the event was bloodless precisely because President Marcos refused to use military force on the people assembled at Edsa. The television coverage of the event reveals that Marcos rejected the idea of hurting his own people, despite his trusted generals' repeated insistence that violence is the only feasible way to disperse the people.

Second, the less than one million people who went to Edsa in February 1986 are a mere fraction of the millions more who voted for the Marcoses in elections held after 1986. Evidently, the present has disavowed the past.

Hopefully, when the time comes for the Supreme Court to rule on the Marcos burial issue. the high tribunal will confine the issue to whether or not President Duterie acted arbitrarily in allowing President Marcos to be buried at the Libingan dismiss the anti-Marcos petitions, and let justice be done though the heav-

MANILA, Philippines — Government forces will be added near the Sulu West Sea to heighten maritime security against the Abu Sayyaf, Presidential Communications Secretary Martin Andanar said.

During President Rodrigo Duterte's state visit in Indonesia last Sept. 9, he and President Joko Widodo talked about the issue of piracy and maritime security in Sulu and at the Sulu West Sea.

Andanar said that the two presidents were able to talk about security in the said area, particularly the kidnappings and activities of the Abu Sayyaf. He added that the two countries will be helping each other regarding the issue.

Defense ministers of Malaysia, Indonesia and Philippines also held a trilateral meeting to talk about the authorized sea lanes between the three countries.

"Anybody who sails outside of the authorized sea lanes will be deemed hostile," according to Andanar.

Andanar also said that the main focus of the Armed Forces of the Philippines is to guard the Sulu West Sea.

In recent reports, however, Malaysia's Eastern Sabah Security Command reported that three Malaysians were taken from their trawler off Sabah late Saturday evening.

The Western Mindanao Command said they were alerted of the kidnapping, but could not immediately say if it was another case of cross-border kidnapping involving groups associated with the Abu Sayyaf.

They gave assurance, however, that troops were placed on alert for the Malaysians.



ZAMBOANGA CITY — The military launched intelligence operations to trace the possible presence of three Malaysian fishermen abducted by gunmen off the waters in Sabah, a military official said Monday.

Maj. Filemon Tan Jr., spokesman of Western Mindanao Command (Westmincom), said troops from the Joint Task Force Tawi-Tawi and Naval Forces Western Mindanao also established security points at all possible routes and passages of the kidnap-for-ransom groups operating in the borders of Philippines and Malaysia.

"Coordination and intelligence sharing and exchange with the Eastern Sabah Security Command (ESSCOM) is now being done," Tan said.

According to Tan, reports they received from ESSCOM disclosed that the three Malaysian fishermen were abducted about 11 p.m. Saturday in the general area off Pom Pom Island near Mataking Island Resort off Semporna, Sabah.

The gunmen, about seven of them, were on board a speedboat, powered by twin-engine at 75 horsepower each, seized the victims and headed northeast in the direction of Alice Reef and Bulubulu Island of Tawi-Tawi.

However, Tan said there was no immediate report on the identity of the suspects or whether they are linked with the Abu Sayyaf group that operates the cross-border kidnapping.

The Abu Sayyaf, which has been on the run due to intense military offensives in Sulu, has not claimed responsibility for the latest kidnapping.



Brig. Gen. Arnel dela Vega, Joint Task Force Sulu Commander met troops of the 101st Infantry Brigade in Patikul led by Col Jesus Manangquil and the 501st Infantry Brigade headed by Col Jose Faustino.

Gen. Dela Vega's visit intends to boost the morale of troops in the field and was at the same time appraised on the progress of the focused military operations. Several media were also among the contingent and able to see first-hand the situation and the untiring efforts of troops to pursue the ASG.

Asked by media on the complexity of the operation, Brig. Gen. Dela Vega said "it will just be a matter of time before our troops will engage the ASG and punch a decisive blow into their ranks and leadership".

When asked by media on particular advantage of the ASG on terrain familiarity, Col Jesus Mananguil of 101Bde said, "the familiarity of terrain is a noted advantage to them as of now but as our troops conduct more operations and patrols and become more familiar with the terrain, we will negate that advantage and we will deliver a decisive blow against the ASG.

Media and NGOs accompanying the visit marvelled at the scenic beauty of the place from Patikul to Talipao. Coi Jose Faustino of 501Bde said "We have to cleanse Sulu of the scourge of the Abu Sayyaf and make this place peaceful so that economic activity and tourism will prosper".

The latest tally of ASG killed is 59 (32 in Sulu, 27 in Basilan) while govt troops suffered 18 killed in action (15 in Sulu, three in Basilan); 28 wounded in action (27 in Sulu, one in Basilan). JTFS / MCAG

MANILA, Philippines — After blasting the United States (US) for supposedly interfering with his anti-drug war, President Rodrigo Duterte said American troops in Mindanao should leave as they are in danger of being abducted by terrorist group Abu Sayyaf.

Duterte said the Abu Sayyaf bandits hate the US so much that they are ready to kill any American they would see.

"The special forces, they have to go. They have to go in Mindanao. There are many whites there," the president said during the oath taking of new appointees Monday in Malacañan.

"if they see an American, they would kill him. They would demand ransom then kill him. Even if you're a black or white American as long as you are an American," he added.

Some US troops have been deployed in Zamboanga City to assist Philippine security forces in its campaign against terrorists.

Since the Constitution prohibits foreign troops from engaging in direct combat operations, the US soldiers assist the military through training and information sharing.

Duterte said he could not express the sentiment during the Association of Southeast Asian Nations meet in Laos last week, which was also attended by US President Barack Obama.

"I could not speak then out of respect and I do not want a rift with America. But they have to go," the president said.

Lorenzana to meet with US defense chief to tackle security issues

DATU ODIN SINSUAT — Defense Secretary Delfin Lorenzana will fly to Honolulu in Hawaii at the end of the month to meet with US Defense Secretary Ashton Carter and his counterparts in the ASEAN to discuss security issues including the South China Sea dispute and terrorism.

"Ang pag-uusapan namin ay seguridad ng South China Sea, seguridad natin against terrorism at saka yung iba pang pwedeng problema sa kaligtasan natin," he told reporters on the sidelines of turnover rites at Army's 6th Infantry Division here.

A ruling in July by an international tribunal court favored the Philippines in its case against China's massive claims in the South China Sea.

'Rock solid' ties with US

Despite the tirades of President Rodrigo Duterte that led to the calling off a bilateral meeting with the United States at the ASEAN Summit in Laos, Lorenzana said the relationship between the two countries has not changed

"It's strong. Malakas yan ... Rock solid nga sabi ng mga Americans dyan ang defense relationship because US ang ating military ally. The Mutual Defense Treaty which was signed in the 1950s and it's still there. Hindi naman namin inabrogate yun," he said.

"Ang sabi lang ni Presidente we are also going to talk with others kung sino ang makakapagbigay ng magandang equipment to strengthen our defense alliance and we will do that but we will still have an alliance with the United States, "he also said.

FA-50s for training

The defense secretary also defended Duterte's wrong reference of the FA-50 lead-in fighter trainer jets supposedly purchased from the United States instead of South Korea.

In his speech to the Filipino community in Indonesia last week, the President criticized the jets given by the United States. The brand new jets were bought from South Korea.

"Mukhang nagkamali lang siya. Yung FA-50 is from South Korea, sabi niya dalawa lang eh hindi 12 yan. Yung 10 i-deliver pa lang," he said.

He said the purchase of the FA-50s was necessary because it will train Air Force pilots until the government can afford real fighter planes like the F15 fighter jets.

"Ang nakita kong justification nung pagkuha ng past administration is the lead-in fighter kasi to eh, ibig sabihin pwede gawing trainer, pwede ring gawing fighter. Ang mga piloto dyan matagal ng hindi nakkahawak ng fighter planes so hindi natin pwede isabak agad sa real fighter planes... It takes years to train fighter pilots. Itong FA-50 ito yung una muna and then later on if we have the capabilities to purchase the real fighter planes we will still do that," Lorenzana said.
