

President Duterte yesterday denied any involvement in the so-called Davao death squad (DDS), saying it was a political tool used by the opposition during the elections.

"It started in Davao as a political issue. As a matter of fact, you go to Davao, the DDS is not really a DDS. It was during the time 'Sparrow versus the DDS of government,"" Duterte said.

"I'm now a subject of persecution and I am no longer safe, I don't feel safe. The truth is, I'm not safe," De Lima said in a press conference at the Senate.

"They're (administration) violating my rights – my right to security and privacy,"

she said. She doubted if she could trust the Philippine National Police, the National Bureau of Investigation and the Armed Forces of the Philippines to protect her

She said she was considering the suggestion of some of her colleagues to seek protection from the Senate security.

The senator confirmed that she has found a temporary residence after she found herself unable to go home on Tuesday after the House inquiry publicly disclosed her address in Parañaque City and her mobile phone number.

She lamented that her neighbors are now being inconvenienced.

She also had cut off the phone line

after receiving calls and 2,000 obscene and angry text messages from "trolls and fanatics" of President Duterte

Marcelino said he never had any doubt about De Lima's integrity and expressed plans to personally visit her in her office "when everything's settled down."

Another text message sent on Sept. 5 was ominous as Marcelino said "pressure is mounting" to reopen his case and plans to be incognito. "Rest assured, I'll never give in to them," he said.

Marcelino asked their common friend to tell De Lima to "keep the faith and be strong.

However, Marcelino last night denied De Lima's claims that he is being pressured to testify against her

Marcelino told an impromptu news conference with Public Attorney's Office (PAO) chief Persida Acosta that he will issue a written

statement over the reversal of the DOJ resolution dismissing his drug case.

"The struggle is sweeter if you're on the side of truth," he said

"That's clear, no one pressured him to testify against anyone. That's because he is ready to tell the truth and only the truth, whatever he knows, anywhere," Acosta added, to emphasize Marcelino's statements.

Acosta said they will fight

the drug case in court as she expressed dismay over how. intelligence officers like Marcelino are being subjected to questionable charges when he is just performing his duty.

Marcelino, who was arrested along with his Chinese companion Yan Yi Shou, had maintained they were framed as they were working undercover when PDEA agents found them in a condominium in Manila with 60 kilos of shabu last Jan. 21

De Lima added her reliable sources revealed that shortly after the May elections, people were going around the NBP asking convicts to sign affidavits to implicate her.

She said some of those who testified were subjected to psychological torture, blackmailed or given money to testify against her

ZAMBOANGA CITY—Twenty members of the Abu Sayyaf Group surrendered and turned over eight high-powered firearms to the government on Thursday in Basilan province, a military official announced.

Maj. Filemon Tan Jr., Western Mindanao Command (Westmincom) spokesperson, said the surrenderers are led by ASG sub-leader Katatong Balaman alias Tatong

Tan said the group of Balaman surrendered to Col. Thomas Donato Jr., Army's 104th Infantry Brigade commander, and Mayor Gulam Hataman of Sumisip, Basilan.

The Sumisip-based Army's 64th Infantry Battalion facilitated the surrender of Balaman's group in a ceremony held at the town hall of Sumisip.

Tan said the group of Balaman also turned over two locally-made shotguns aside from the eight high-powered firearms.

Donato said the group of Tatong is responsible for several ambuscades and skirmishes against the government troops, particularly in Barangays Sukaten and Baiwas in the municipality of Sumisip.

"This is the result of the relentless operation we are conducting where they suffered lots of casualties. These Abu Sayyaf now fear for their lives, leading to the surrender," Donato said. PNA

ARMM gov't takes over Sayyaf camp in Basilan

THE former Abu Sayyaf Group (ASG) stronghold in Barangay Baguindan, Tipo-Tipo in Basilan was turned over by the military to officials of the Autonomous Region in Muslim Mindanao (ARMM), restoring full civilian control over the area.

The turnover came after the Armed Forces of the Philippines (AFP) overran the ASG camp in August as part of a government crackdown against the terronst group.

Regional Gov. Mujiv Hataman called for unity in achieving lasting peace to hundreds of residents in the village.

"It's about time for this place [Barangay Baguindan] to receive various projects from the government," Hataman said, as he vowed to pour projects into conflictaffected ARMM areas.

Lt. Col. Ernest John Jadloc, 74th Infantry Battalion commander, said the camp was seized after a month of operations involving members of the 18th IB, 64th IB, Scout Rangers and Special Forces.

The operations paved the way for restoring local government authority and social services in areas where the terror group lorded over for years.

Baguindang was among the liber-

ated areas from the ASG jihadists, including Bohe Piang of al-Barka town after months of fighting, according to military officials.

Bisahari Hantian, village chairman, said they were grateful that the residents will finally experience peace and their lives brought back to normal.

Also, village resident Saida Abubakar said 40 years of constant evacuation because of fighting was too much for them to bear, especially the children.

After the ceremony, a People's Day was conducted to provide medical consultation and check-ups and hygiene kits were distributed.

The region's humanitarian emergency action response team (ARMM-HEART) also distributed relief packs to 1,574 families in Barangay Baguindan and Barangay Silangkum and in al-Barka town, both ASG strongholds

Meanwhile, 20 ASG members on Thursday surrendered and turned over eight high-powered firearms in Sumisip town also in Basilan

Maj Filemon Tan Jr., Western Mindanao Command (Westmincom) spokesman, said the group, led by ASG sub-leader Katatong Balaman alias Tatong, surrendered to Col. Thomas Donato Jr., the Army's 104th Infantry Brigade commander, and Mayor Gulam Hataman of Sumisip.

Sayyaf frees another Indonesian hostage

ZAMBOANGA CITY: The Philippine military on Thursday said Abu Sayyaf bandits have freed a kidnapped Indonesian skipper of a fishing boat in Sulu in the Muslim autonomous region in Mindanao.

It said the 38-year-old Herman Bin Manggak, who was snatched along with two others on August 3 in Sabah, was handed over by the Abu Sayyaf to the rebel Moro National Liberation Front (MNLF) of Nur Misuari.

The military's Western Mindanao Command (Westmincom) did not release details surrounding the release of the Indonesian or whether ransom had been paid to the bandits, who have pledged allegiance to the Islamic State.

Security officials said Herman

was turned over by the MNLF to the military's Joint Task Force Sulu on September 22. The foreigner was interviewed by Army interrogators at Camp Teodulfo Bautista before being handed over to the Westmincom.

Malaysian authorities said Herman was the captain of a Malaysian fishing vessel and that two of his crew, an Indonesian and a Malaysian national, was released earlier by the kidnappers who originally demanded a 10,000-ringgit ransom.

The MNLF did not release a statement. Misuari's group has assisted in the release of over a dozen hostages, including a Norwegian man kidnapped last year at Samal Island in Davao del Norte province.

Freed Abu hostage leaves for Norway

Kjartan Sekkingstad, the Norwegian hostage released by Abu Sayyaf bandits, left yesterday to finally return to Norway after almost a year of captivity in the jungles of Sulu.

Sekkingstad was reportedly accompanied by a relative on board a Thai Airways jet that took off at around 1 p.m.

The Abu Sayyaf released the Norwegian last Sept. 17, nearly a year after he and three others were abducted by the suspects from a resort on Samal Island in Davao on Sept. 21, 2015

The President expressed hope that the Glock 30 pistols would be distributed to the soldiers as soon as possible

The President told the soldiers that in fighting terrorism they should learn how a terrorist operates

Duterte said that the soldiers should also study terrorist profiling and detection.

'I have told all your command-

ers, the chief of staff, that you will get everything you need to fight the enemies of the state," Duterte said.

He also told the soldiers to train themselves and reinvent themselves

Duterte has ordered the officers and men of the Army's 9th Division during his visit on Wednesday at Camp Eliasin Barangay Tinangisin Pili, Camarines Sur to shift the fight against terrorism now that they are not engaging with the NPA due to the unilateral ceasefire.

₱300-K bounty up for arrest of Sultan Kudarat bombers, murder suspects

GENERAL SANTOS CITY (PNA)
— The provincial government of Sultan Kudarat has offered an initial bounty of \$\mathbb{P}_{300,000} for information that will lead to the arrest of the suspects behind the series of killings and other crimes in the province since last year.

Sultan Kudarat Gov Sultan Pax Mangudadatu said Thursday the reward money was offered to speed up the resolution of the cases, among them the previous grenade attacks in Esperanza and Isulan towns

"It will be given to anyone who would be able provide information leading to the arrest of the suspects," he said

The governor said the putting up of the bounty was supported by members of the Provincial Peace and Order Council in a recent meeting.

He specifically cited Vice Gov. Raden Sakaluran, officials of the Sultan Kudarat Provincial Police Office and the Army's 601st Infantry Brigade as those who backed the measure.

Mangudadatu said the provincial government's top priority is the resolution of the two grenade attacks, and the killing of a former municipal councilor of Isulan as well as two other barangay officials.

A six-year-old boy was killed while more than 40 others were injured when a grenade exploded at a carnival in Esperanza town last February 21.

A grenade explosion also rocked the celebration of the province's foundation anniversary on Nov 21, 2015, leaving 11 persons injured

On March 15, 2015, former Isulan councilor Elmo Segura was gunned down by unidentified suspects.

Two barangay chairs were also killed in separate shooting incidents in the province earlier this year.

Mangudadatu directed authorities to dig deeper into these incidents and give justice to the victims.

"All these suspects should be arrested and put behind bars," he said.

No joint patrol with US counterparts, Rody tells soldiers

A day after saying the Philippines still needs the US in the South China Sea, President Duterte yesterday reiterated he would not allow local troops to go on a joint patrol with their American counterparts

He also said Filipinos would be seeing him more often in China within his six-year term in office.

Duterte pointed to his "new

foreign policy" that aims to seek independence from traditional Philippine partners like the US

"I will not allow it (joint patrols in the South China Sea), and if there is war, where is the battlefield? Palawan?" Duterte said in a speech during the inauguration of Filinvest Development Corp.'s power plant in Villanueva, Misamis Oriental

The US and Philippine forc-

es have been training under the Balikatan program, which includes counterterrorism operations

"So, what we do now is we go to China and rightly so. China is in good faith... there is the Arbitral judgment and after we won, we have two options. we go to war to claim it or we talk in peace." Duterte said.

Since the country does not have the capability to go to war, Duterte said the better option would be to talk

"And there will be a time, there is always a time in this world the time to talk, a time to war, a time for blood, a time to be purified," he said.

Duterte stressed the Philippines will not have anyone to depend on except itself.

Duterte reiterated his willingness to talk with China on the country's entitlements in the South China Sea using the decision of the Permanent Court of Arbitration in The Hague.

"This piece of paper that we have our award, we do not go out of the four corners of this paper. We talk. That should be the way. We do not approach it

arrogantly. It's just business," he said

Among the things that Duterte said he would "demand" when he visits China is to allow Filipino fishermen their fishing rights

Although there is no date set yet, Duterte said Filipinos would be seeing him more often going to China to negotiate with its leaders.

Senators grill 'executioner' over By MARVIN SY

committee on justice and human rights grilled self-confessed Davao death squad (DDS) hit man Edgar Matobato yesterday, putting his credibility as witness on the line in the inquiry on al-

leged extrajudicial killings. Seeing many inconsistencies in the witness' statements, the committee agreed in the end to invite alleged DDS members, as identified by Matobato, to also testify in the next hearing.

At the start of yesterday's hearing, newly installed com-mittee chairman Sen. Richard Gordon and Sen. Alan Peter Cayetano took turns in cross checking the details of Matobato's testimony in the previous

hearing With a copy of the affidavit that Matobato executed before the National Bureau of Investigation when he was still under the Witness Protection Program of the Department of Justice, Cayetano confronted the witness with the alleged killing of a terrorist identified as Sali Makdum.

Cayetano pointed out that Matobato and Makdum knew each other before he was killed and that they were business partners based on a report of CNN Philippines. It was also reported that Matobato's wife and the wife of Makdum were

Matobato said he had real estate dealings with Makdum and that he only found out about his being a terrorist from the heinous crimes division of the Davao City police.

Asked if the killing of Makdum was ordered by President

The newly organized Senate Duterte when he was still mayor of Davao City, Matobato said the order did not come directly from Duterte, but from SPO4 Arthur Lascañas, whom he described as the head of the DDS.

Cayetano noted the inconsistencies in Matobato's statements on how Makdum was killed based on his affidavit and his testimony before the Senate.

In the affidavit, Cayetano noted, Matobato saw a group of policemen slitting the throat stabbing him.

But in his Senate testimony yesterday, Matobato said he and Lascañas hanged Makdum, then Lascañas chopped up Makdum's body

According to Matobato, he was aware that the orders handed down by Lascañas were coming from the President.

In the case of a certain NBf agent known only as Amisola, whom Matobato claimed engaged 30 armed men in a firefight and was eventually shot dead by Duterte himself, Cayetano maintained that the narration was incredible.

Cayetano said it was hard to believe that 30 armed men were unable to put down a single person. Matobato said there was difficulty in hitting Amisola because he was hiding behind his vehicle and shooting back at them.

On Matobato's claim that he was also involved in the killing of the bodyguards of former House speaker Prospero Nograles, Cayetano noted that in his affidavit, he claimed that several policemen gave the order to kill them, but in his

testimony yesterday, he said the instruction came from Lascañas

Gordon also noted that Matobato gave conflicting testimonies about whose men exactly they killed. Matobato explained that the bodyguards were men of generals Mattllano and Jovito Palparan but were detailed to Nograles, who was running for mayor against Duterte.

Gordon also tried to verify of Makdum before taking turns) Matobato's claim that he was a member of the CAFGU (Civilian Armed Force Geographical Units) before Duterte recruited him into his so-called Lambada Boys, which eventually became the DDS

Gordon pointed out Matobato's name was not in the Armed Forces of the Philippines' list of CAFGUs

Matobato clarified that he was actually part of the Civilian Home Defence Forces (CHDF), CAFGU's predecessor, starting from 1982

Matobato said in his testimony yesterday he decided to quit the DDS in September 2013 because he was already old and no longer wanted to take part in

But Sen. Panfilo Lacson said Senate President Aquilino Pimentel III had relayed to him the claim of a regional adjudicator of the Department of Agrarian Reform in Davao that Matobato made an attempt to kill him in October 2014 in Davao

Lacson said DAR's Abeto Salcedo Jr. saw Matobato on television during the previous Senate hearing and recognized him right away as the person

who tried to kill him.

Matobato denied the claim, insisting he was in Manila in 2014

Asked by Cayetano if the affidavit he executed at the NBI was about the DDS, Matobato said it was about how he was tortured and not about the DDS

Cayetano pointed out that the affidavit was full of details about the DDS, contrary to Matobato's claim.

According to Ferdinand Laviña, officer-in-charge of the Office of the Deputy Director for Forensic Investigation Service of the NBI, the DOJ, then headed by Sen. Leila de Lima, had sent Matobato to the NBI

NBI's Anti-Illegal Drug Division chief Joel Tuvera admitted no lawyer assisted Matobato when he executed his affidavit.

Tuvera said Matobato opted against getting a lawyer and refused when he was ordered to go to Davao with them to present proof of the killings, allegedly for fear for his life.

As such, Tuvera explained, the NBI was not able to build a case regarding the DDS claims of Matobato.

Sen, Juan Edgardo Angara said it was important for the Senate committee to test the credibility of Matobato and the veracity of his allegations during the hearings.

'Matobato's allegations are so grave," Angara said. "But in my opinion, these seem to be full of inconsistencies and conflicted with his statements in the past two hearings. But then, we must let the committee decide on

what recommendation or action to take. What's important is this issue is in the public eye."

In the end, the committee agreed to summon the alleged DDS members named by Matobato, although invitation was already sent to 23 of them, when De Lima was still heading the committee.

To be summoned are: Lascañas, SPO4 Sanson Buenaventura; Chief Insps. Jacy Francia; Fulgencio Pavo and Ronald Lao; SPÖ3 Jim Tan; Jun Laresma and Donito Ubales; SPO2 Enrique de los Reyes Ayao; SPO1 Reynante Medina, Bienverudo Furog, Vivencio Jumawan, Jun Bisnar and Gaston Aquino, Senior Supts. Isidero Florivel/Florobel, Rey National Police (PNP) is not in-Capote, Tony Rivera and Dionisio Abude, and certain Bienvenido Laud, Alvin Laud, Roly Engalia and Arnold Ochavez

No CHR representatives

For yesterday's hearing, the committee invited officials of the Commission on Human Rights (CHR) to attend, but they did not make it due to short notice.

'It is not the case of being more comfortable with one or the other senator," CHR chairman Chito Gascon said yesterday

"Due to lack of time, we failed to make appropriate arrangements for security and transport concerns for the witnesses," Gascon said.

CHR had sent representatives to the previous committee hearings, then headed by De Lima.

But Gascon stressed the commission is always ready to cooperate with the Senate and ready to assist in shedding light

on the matter.

"But we also need to ensure that our witnesses are secure,"

The CHR chief said the absence of their officials was because of miscommunication between the committee secretariat and the agency, partly due to the dhange in leadership

Following the ouster of De Lima as committee chair, Gascon said the CHR is ready to work with Gordon and other officials to ensure that human rights and the rule of law are upheld.

No corroboration, no investigation

Meanwhile, the Philippine clined to investigate policemen linked to the DDS by Matobato without a sworn statement that validates his allegations.

PNP spokesman Senior Supt. Dionardo Carlos said the PNP sees no basis for such investigation yet, as Matobato's testimony in the Senate remains unconfirmed.

But Carlos said the PNP would go ahead with it once there is a sworn affidavit validating Matobato's allegations.

"What we are looking for is an affidavit, sworn statement or evidence that would corroborate the statement of one person," Carlos said.

In his testimony at the Senate last week, Matobato said some members of the Davao City Police took part in the killing of criminals in Davao during the term of then mayor now Presi-dent Duterte. - With Cecille Suerte Felipe, Janvic Mateo, Paolo Romero

NE of six bidders in the government's acquisition of two Navy frigates has raised questions on re alleged modification of the bid strucire by the bids and awards committee BAC) of the Department of National refense (DND), in which the project was upposedly split into two components.

STX Offshore and Shipbuilding o. Ltd. (STX Korea) claimed that viding the bidding for the two tips and their weapons systems, nd the bidding for ammunition, as grossly disadvantageous to the overnment and in serious violaon of procurement laws.

"Splitting the Authorized Budet of Contract (ABC) and the tems to be bid out after the first ' tage of the bidding, and before he second stage, is tantamount o changing the terms and conlitions of the bid in the middle of the game," STX Korea said in

It said that initially, the bidders were made to believe that the ABC was P18 billion and the items for bidding were the vessels, weapons system and ammunition, "and we

joined the bidding on the basis of those parameters."

"It is thus unfair for everyone, especially for those who failed to pass the initial stage, to have the terms substantially changed when the bid has already been submitted," STX Korea pointed out.

It said the BAC later released the technical specification for the project but removed all references to ammunition. The BAC also attached a memorandum to the bid document, specifying the need to split the bidding for the vessels and the ammo which could be in the form of missiles, bullets, torpedoes and others.

The firm claimed the BAC purposely split the project to make it appear that the winning bidder, Hyundai Heavy Industries, offered

the two vessels alone

Splitting the bid will limit the number of bidders to those who will be able to match the specifications of the winner of the first bidding, it claimed.

"In other words, there will be no competition for the bid of ammunition as the manufacturer of the launchers in the first bid is the only manufacturer of the ammunition that will fit such launchers," STX Korea added

Arsenio Andolong, DND Public Affairs Service director, said the action of the BAC should not be considered as splitting the contract

He explained that the separation of the procurement of the platforms with launchers and procurement of missiles and munitions was the result of technical discussions with eligible bidders that included STX Korea, STX France. HHI, Garden Reach Shipbuilders and Engineers, Navanta S.A. and Daewoo Shipbuilding and Marine Engineering Co.

Andolong added that the eligible bidders suggested to the Philippine Navy's technical working group to acquire missiles or munitions through a governmentto-government transaction, to facilitate the export-import license

The DND official maintained that the department did not violate any provisions of Republic Act (RA) 9184 or the Procurement Reform Act in modifying the bidding documents.

"It must be emphasized that the frigate project or Lot 1 was undertaken through a two-stage bidding as provided for under Section 30.3 of RA 9184 and its IRR (Implementing Rules and Regulations). he pointed out.

"In this modality, due to the nature of the requirements of the project, the required technical specifications . of the contracts cannot be precisely defined in advance bidding, therefore, the procuring entity shall prepare the bidding documents including the technical specification in the form of performance criteria only," Andolong said

"Thus prospective bidders shall be requested at the first stage to submit their respective eligibility requirements and initial technical proposals only. Subsequently, meetings or discussions will be held by the BAC with those eligible bidders who passed the first bidding in order to come up with the final revised technical specifications," Andolong explained.

Chief spook speaks up

National Security Adviser (NSA) Hermogenes Esperon Jr. spoke for the first time since President Rodrigo Duterte declared a state of lawless violence in Mindanao last Sept. 3.

Breaking his self-imposed silence - as required most of the time by his job as the government's chief spook - Esperon confirmed intelli-



gence authorities are following leads the Davao blast may be part of a much bigger plot than a mere act of terrorism.

Without getting into details, Esperon assuaged the public that government agencies tasked to protect the country from the enemies of the state are doing their best to head off terror attempts. He disclosed that the Davao blast that killed 15 people and injured 100 others have some shades of destabilization plot against the Duterte administration.

As national security adviser, Esperon has under his command the resources and personnel of the National Intelligence Coordinating Agency. The NICA has interagency support from the Armed Forces of the Philippines (ĂFP), Philippine National Police (PNP), National Bureau of Investigation (NBI), Philippine Coast Guard and Bureau of Immigration among other law enforcement arms.

Himself a retired AFP chief of staff, Esperon speaks from his experience since he entered as a cadet at the Philippine Military Academy. He graduated from PMA in 1974, or two years after the late president Ferdinand Marcos declared martial law. Citing lawless violence across the country, Marcos imposed martial law through Proclamation 1081 on Sept. 21, 1972.

This sad chapter in our country's history marked its 44th anniversary on Wednesday and coincided with our weekly Kapihan sa Manila Bay at Café Adriatico in Malate, Manila where we had Esperon as featured guest.

Esperon doused cold waters to concerns on the possible return of martial rule in our country.

Martial law fears arouse from pronouncements of Esperon's fellow Cabinet official who espoused "constitutional authoritarianism" for President Duterte. Aside

from the declaration of a state of emergency that empowers President Duterte to call the AFP to help the PNP quell lawless violence, Chief Presidential Legal Counsel Salvador Panelo floated the idea of giving the commander-in-chief expanded powers under a "constitutional dictator-

ship" to give him powers over the executive and legislative branches to speed up reforms.

"He (President Duterte) will not go for it," Esperon

Smarting from the decision of President Duterte to allow the burial of Marcos at the Libingan ng mga Bayani, foes and critics now accuse him of laying the groundwork for martial law in the country. The Supreme Court, however, has issued a temporary injunction against the burial of Marcos pending resolution of the petitions filed before it.

Esperon could not be pinned down to reveal if they suspect the destabilization plots come from rival political camps. President Duterte earlier pointed to the Liberal Party (LP), the erstwhile party in power, to be plotting to impeach him.

President Duterte admitted having sensed obvious slanted reports here and abroad linking him to alleged extrajudicial killings in the ongoing police operations against illegal drugs.

A few days earlier, no less than Presidential Communications Office Secretary Martin Andanar bared to Malacañang reporters about supposed ouster plots against President Duterte. The anti-Duterte group allegedly wants him out of Malacañang by January 2017.

Andanar said a Cabinet member learned of the supposed plot while on official trip in the United States. The Cabinet official said unnamed Filipino-Americans based there were purportedly hatching the ouster plot. Andanar refused to name the Cabinet official. Currently on official trip in New York are presidential spokesman Ernesto Abella and Department of Foreign Affairs Secretary Perfecto Yasay Jr.

Esperon declined to elaborate on this alleged ouster plot. He is willing to bet big-time though that narco syndicates are funding the campaign to oust President Duterte in retaliation to his administration's all out war against illegal drugs

In fact, Esperon disclosed, they have detected "funds moving" Esperon stopped to say "who" and "where" the funds are going, except that they know the "why."

Esperon gave assurance that President Duterte is not a power-hungry leader contrary to fears foisted by his bitter critics and arch political enemies. He said President Duterte has been in the forefront of the campaign for a shift to a federal form of government that would subdivide the country into federal states since he was Davao City mayor. So how can someone who would lose so much jurisdiction over federal states be a power-hungry dictator, Esperon argued.

As a lawyer and prosecutor for so many years, Esperon said President Duterte knows the limits of the laws. Esperon further averred to President Duterte's strict adherence to the 1987 Constitution to carry out what needs to be done for the country during his watch.

"So do we call him a constitutional dictator, or do we call him a forceful law enforcer, enforcer of the laws of the land, enforcer against criminality, enforcer against illegal drugs, enforcer against corruption, enforcer for good governance?" Esperon asked, adding: "Be the judge."

The former Davao City mayor is better known as "the punisher." Nonetheless, Esperon said President Duterte won 16 million votes on a campaign promise to suppress illegal drugs and corruption.

This is why Esperon said he is very confident no destabilization plot will prosper while President Duterte enjoys the trust and support of 91 percent of Filipinos based on the latest surveys on his first 50 days in office.

Esperon admitted the country's narco problem is so pervasive and is one of the immediate threats to national security. With an estimated 3.7 million Filipinos as drug addicts, he too, is worried.

Speaking as chief spook, Esperon vows to help President Duterte stamp out the narco menace in our country before it's too late.

CAMP BAUTISTA, Sulu (DWDD) - Another Indonesian kidnap victim was released in Sulu Thursday morning as troops continue intensified rescue efforts.

The released hostage was identified thru his passport as Herman Bin Manggak, 30 years old. He is the sixth Indonesian freed from Abu Sayyaf captivity since Pres Rodrigo Duterte assumed office and ordered an intensified rescue effort.



Herman was officially turned over to military custody at 12nn by the local government of Sulu and was immediately taken to Camp Bautista hospital in Jolo for check-up and processing.

Talking to an interpreters, he asked for food and relayed how government troops nearly rescued him three times as they engaged the ASG in fierce gunbattles."The release of the victim is the result of relentless focused military operations combined with efforts of different sectors particularly LGU of Sulu and other stakeholders"



Brig.Gen. Arnel Dela Vega, commander of Joint Taskforce Sulu said Several kidnap victims were successively rescued or released after the intensified rescue efforts and arrival of more troops in Sulu.

It may be recalled that Martina Yee who was kidnapped by armed men in Sirawai was rescued yesterday in Indanan Sulu by elements of the 35th Infantry Battalion, only two days after her captivity; the fastest and successful rescue operation conducted on a kidnap victim by armed men before she can be further turned over to the ASG.



The swift rescue of Yee was attributed by authorities to a well- coordinated effort by AFP and PNP with the help of civilian populace from Sirawai to Sibuco and Zamboanga City to Sulu who informed and alerted troops on the presence of armed men.

Gen.Ricardo Visaya, the AFP Chief of Staff, commended the troops for the success. Sayyafs free another Indonesian hostage in Philippines

ZAMBOANGA CITY - The Philippine military on Thursday said Abu Sayyaf militants have freed a kidnapped Indonesian skipper of a fishing boat in the southern province of Sulu in the Muslim autonomous region in Mindanao.

It said the 38-year old Herman Bin Manggak, who was kidnapped along two others on August 3 in Sabah, Malaysia was handed over by the Abu Sayyaf to the former rebel group Moro National Liberation Front under Nur Misuari.

The Western Mindanao Command did not release details surrounding the release of the Indonesian or whether ransom had been paid to the militants whose group is tied to the Islamic State.

But security officials said Herman was turned over by the MNLF to the military's Joint Task Force Sulu on September 22 where the foreigner was interviewed by army interrogators at Camp Teodulfo Bautista before being handed over to the Western Mindanao Command.

"Western Mindanao Command emphasizes the efforts of Joint Task Force Sulu troops in conducting continuous focused military operations to track down and destroy the Abu Sayyaf group responsible for the series of kidnappings and atrocities in the area," the military said.

Malaysian authorities said Herman is the captain of a Malaysian-flagged fishing vessel and that two of his crew members - an Indonesian and a Malaysian national - had been released earlier by the kidnappers, who originally demanded 10,000 ringgit ransom.

The MNLF did not release any statement, but Misuari's group helped seek the release of over a dozen Indonesian hostages, including a Norwegian man kidnapped last year in Samal Island in Davao del Norte province in Mindanao. (Mindanao Examiner)

PERSONAL INTERACTION | Duterte visits 9ID in CamSur

here Wednesday afternoon and proceeded to Camp Elias Angeles, headquarters of the 9th Infantry Division (ID) of the Armed Forces of the Philippines (AFP) in Barangay San Jose, Pili, Camarines Sur, to visit the troops.

Maj. Gen. Manolito P. Orense, commander of the 9th ID, also known as the Spear Division, gave a situation briefing to the President when he arrived at the Officers' Club at around 3:30 p.m. or four and a half hours later than his scheduled arrival of 11 a.m.

At around 4:30 p.m. when the President started his speech before the soldiers in Bicol, he initially dwelt on the "encompassing" illegal drug problem, which he said, has come to destroy the nation.

He said the drug menace will "destroy your children and the next generation."

But the President said "the technicality of the law makes it hard for me to deal with the problem on illegal drugs."

He added: "What is very disturbing about this country now, ang droga kasi within the government na ang away." (the fight against illegal drugs has reached the ranks of the government)

The President made passing remarks on how the United States became interested in Mindanao.

"Naging interesado ang mga Amerikano sa Mindanao kasi walang typhoon (The Americans became interested in Mindanao because there is no typhoon). But they could not get workers to work for them," he said.

President Duterte gave assurance to the soldiers that "there will be an inclusive government with the left but there will not be a coalition government."

With regards to the problem with the Abu Sayyaf Group or ASG, the President said, "I do not want to talk with the Abu Sayyaf Group."

He told the Bicol soldiers to "make the most of this time to come up with doctrines on how to deal with terrorism."

Before the end of his speech at around 5 p.m., the President gave three Glock 30 and four magazines to the soldiers which he said were for use in encounters with the terrorists.



"Para sa engkuwentro sa mga terorista," he said.

The President has been going around military camps in the country in previous weeks with a promise to the soldiers that they will be given what is due them while soliciting support for his programs.

Presidential Communications Office Secretary Martin Andanar earlier said President Duterte has to visit the military camps just like the previous Presidents to boost the soldiers' morale and to personally interact with them on the government's programs lined up for the AFP.

In past weeks, government troops from Bicol under the 9th ID have been sent to help fight the ASG in Mindanao.

On September 3, the 49th Infantry Battalion of the 9th ID was sent to augment the troops of the Western Mindanao Command. Soldiers from the 65th IB, also from the 9th ID, were earlier deployed to the same area.

The President's visit here in Camp Elias Angeles was his third visit to military camps across the country in a span of four days. On Tuesday, September 20, the President took the time to visit and talk to the Agila troops of the Philippine Army at Camp General Manuel T. Yan Sr. in Mawab, Compostela province.

Earlier, on Sunday, Sept. 18, the President visited the 5th Infantry Division (ID), at Camp Melchor F. Dela Cruz in Isabela. (PNA)

Medal of valor winners to get house and lot: Duterte

PRESIDENT Rodrigo R. Duterte said that the soldiers have the full backing of the national government, and their bravery would be rewarded promptly.

"Give me Valor, and I will give you something very, very good."

Mr. Duterte was a guest at the 10th Infantry Division Camp Manuel T. Yan, Sr., in Mawab, Compostela Valley Tuesday afternoon.

"It's true, I have no money but I will raise it. I have so many friends who are millionaires. You will immediately own a house and lot here in Davao (for those who will win the medal of valor)," he promised.

The medal of valor is the highest military honor the government can bestow on a soldier in the line of duty. Republic Act 9049, or the Act granting monthly gratuity and privileges to an awardee of the medal of honor, guarantees benefits and rewards for the recipients of the medal.

Recipients of the honor receive P20,000 in monthly gratuity for the lifetime, aside from salaries and pensions.

Mr. Duterte also promised to provide body vests and the acquisition of Barrett sniper rifles for the troops.



"I have told all your commanders, the Chief of Staff, that you will get everything you need to fight the enemy of the state," Mr. Duterte said.

President Duterte said that he was already impressed with the capabilities of the Philippine army's snipers. "The Philippine military is doing good on snipers, so you better train," he said.

According to the president, the Philippine Army should start training to be involved in counter-terrorism operations. He said that the military should invest more in training in the profiling of bombing or terror suspects.

President Duterte said that the soldiers should expand their training capabilities, especially since the Philippine war on terror includes only a handful of suspects, who were likely not interested in bombing the hinterlands.

"You'll have to study crime and detection, bomba, tapos iyong profiling. How to deal with them, kasi ang kalaban natin diyan hindi naman paramihan – 1, 2, 3, 4, 5," he said.

Pampanga to ink deal with DND, VMCC on veterans' healthcare

CITY OF SAN FERNANDO, Pampanga, Sept. 22 (PNA) -- The provincial government of Pampanga headed by Governor Lilia Pineda, Department of National Defense (DND) and the Veterans Memorial Medical Center (VMMC) will partner to bring medical services closer to veterans.

VMCC medical professional staff Dr. Dominador Chiong Jr. and Dr. Martha Nucum met on Thursday with Governor Pineda, Provincial Administrator Andres S. Pangilinan Jr. and officer-in-charge of the Provincial Health Office Dr. Jose Antonio Rivera to discuss the veterans hospitalization and medical care program that can be implemented in 11 provincial and district hospitals.

Chiong said the program aims to address the health care needs of the veterans and their qualified dependents who do not have convenient access to VMMC and provide partial subsidy for the hospitalization expenses and reimbursement of certain select procedures and additional benefits.

Living World War II veterans, Armed Forces of the Philippines retirees and former members of the Philippine Constabulary (PC) and their dependents are covered in the program, Chiong said.



Rivera said the provincial government will put up a veterans ward in the 11 provincial and district hospitals and train nurses that will coordinate with the beneficiaries.

Rivera also said that a veterans summit will also be conducted to inform the veterans and retirees in Pampanga and other provinces in Central Luzon of the benefits that they can get under the said program.

A medical mission will also be conducted during the event that will render medical consultation, dental checkup, eye examination and ECG, among others.

A help desk will also be established where concerns of veterans regarding pensions, IDs and re-validation will be processed.

According to Chiong, "there are about 17,000 living World War II veterans and 424,000 retirees and their dependents in the whole country who are entitled to healthcare benefits at present. Every year, about 5,000 retirees are being added on the list." (PNA)

PHL Air Force flies 34,423 kg. of relief goods to Batanes Island

MANILA, Sept. 22 (PNA) – The Philippine Air Force (PAF) has flown 34,423 kg. of emergency supplies and equipment to Typhoon 'Ferdie'-ravaged Batanes Island.

The supplies were carried by one Lockheed C-130 Hercules cargo aircraft and one Airbus Military 295 medium transport, Air Force spokesperson Col. Araus Robert Musico said in an interview with the Philippines News Agency (PNA) Thursday.

Relief flights took place over the weekend, he added.

Musico said the C-130 transported 32,200 kg. and the C-295, 2,223 kg. of relief goods and equipment. More goods will be flown if needed, he said.

The Air Force currently has four C-130 and three C-295 aircraft in its fleet.

The National Disaster Risk Reduction and Management Council (NDRRMC) earlier announced that it is focusing on early recovery operations in Batanes Island.

"There is now an ongoing coordination with the Regional DRRMC (Disaster Risk Reduction Management Council) for the formation of a Post-Disaster Needs Analysis Team to be deployed to Batanes," NDRRMC executive director Ricardo Jalad said.

A psychosocial stress debriefing team had left for Batanes Tuesday to help typhoon victims traumatized by Typhoon Ferdie.

Jalad also said that power and communication lines knocked down during the storm are being restored. (PNA) CVL/PFN
