Peso plunges to

US rates, Duterte policies cause fall

By Doris Dumlao-Abadilla and Ben O. de Vera

INVESTOR concerns on the Duterte administration's war on drugs coupled with external developments causing uncertainty globally pulled the peso to a seven-year low on Monday.

The peso closed at 48.25 to a dollar, the weakest level since the close of 48.335 on Sept. 15, 2009.

At the Philippine Dealing System, the domestic currency reached an intraday low of 48.26 after opening at 48.07, weaker than Friday's close of

The total volume traded rose to \$758.5 million from \$590.5 million on Sept. 23.

"The peso movement reflected the continuing uncertainty about the US Fed's next policy action, just like other regional currencies," Governor Amando

M. Tetangco Jr. of the Bangko Sentral ng Pilipinas (BSP) said in a text message to reporters

The US Federal Reserve kept policy rate steady during its meeting last week, such that markets are betting it could eventually push through with a rate hike in December, soon after the presidential election in November.

Tetangco also attributed the weaker peso to "strong foreign exchange demand for fixing and corporate requirements."

Drug war jitters

Some analysts have turned critical over how Mr. Duterte has been waging a war on drugs, alongside some of his foreign policy pronouncements.

Global debt watcher S&P Global Ratings last week said Mr. Duterte's law and order thrust "could undermine respect for the rule of law and human rights, through the direct challenges it presents to the legrimacy of the judiciary, media and other democratic institutions."

S&P had taken note of numerous instances of extrajudicial killings under Duterte.

"When combined with the President's policy pronouncements elsewhere on foreign policy and national security, we believe that the stability and predictability of policymaking has diminished somewhat," said the ratings agency

While most Asian markets have not been spared from market reversals resulting from earlier US Fed jitters, Philippine markets—including bonds, stocks and currency—have underperformed regional peers,

said Bank of the Philippine Islands economist Emilio Neri Jr.

"Most of the investors who have raised their concerns with us find the uncertainty about Philippine foreign policy and diplomacy to be most unsettling," Neri said.

Not lone loser

Even so, Finance Secretary Carlos G. Dominguez III told reporters that the peso was not the lone loser among currencies globally.

"You know that when Yellen says we might raise the rate, that will affect us," he said, referring to US Federal Reserve Chair Janet Yellen.

"It's not only our situation," Dominguez pointed out.

Joey Cuyegkeng, senior economist at ING Bank Manila, noted that the Philippine peso "continued to underperform other Asian currencies."

External factors, including economic developments in China, the European Union and Japan, as well as expectations of a lower current account surplus are exacerbating the peso's weakness, Cuyegkeng said.

"Some analysts think the current account would post a deficit this year or in the coming years—if this materializes, then we would be back to a twin deficit environment that plagued the economy early last decade," he noted

But Cuyegkeng said other domestic factors weakening the peso "have to do with market perception about Philippine valuations (and its outlook relative to other Asian markets) and other concerns, including noneconomic concerns."

"In sum, economic fundamentals remain favorable but

there are emerging stresses on the economy and could be exacerbated by noneconomic factors. Investors have priced in a lot of positives about the economy and are now on the lookout for risks that could disappoint expectations," he said.

Debate on causes

In a research note, Papa Securities said that foreign funds may be almost done selling.

"The pace of the net outflows in the past two months has been faster than other periods historically, averaging above a billion pesos a day. There is still some debate if the cause of which is profittaking, uncertainty over the Fed hike, or concerns on domestic stability. It's likely an unknowable mix of all three—though one thing is for certain, this sell-off is certainly not regional," the local stock brokerage said.

The brokerage said it suspected that Mr. Duterte's oftenquoted statements were merely aggravating foreign selling in a relatively "fragile" market.

Since peaking in August, investors have been net sellers to the tune of around 0.75 percent of the total market cap of the PSEi, according to Papa Securities.

"The only other country to experience anywhere near this level of outflows is Vietnam, and theirs is only at -0.35 percent of their peak at the start of the year," the local stock brokerage said.

Papa Securities said it remained bullish for 2017, sharing the BSP's assessment that the country's economic fundamentals were solid and the list of catalysts expected to emerge starting in the fourth quarter were numerous.

President Duterte is ready to face investigation by the United Nations, the United States and the European Union over alleged summary executions of drug suspects, but only if they promise to follow "the process in my jurisdiction."

"I am willing – any and all questions, I will answer, ipadala mo na iyong mga EU na bright, mga bobo, iyong mga p**g i**g ito, maniwala kayo diyan (send the bright ones from EU. They're stupid, those sons of b**s, believe me)," he said.

"But if they think they are really brighter than us, oh, come here," Duterte said.

"What I want is everybody should be placed under oath. So in the end, if it is proven that you are lying, I can proceed (with) a case against you. If you just listen and the down notes, then get the garbage of De Lima, that's b**t," he said, referring to Sen. Leila de Lima, with whom he has locked horns over human rights issues.

He recalled being probed by UN rapporteur Philip Alston for killings in Davao City when he was still mayor.

"I do not have to remind him again . they know it al-ready," he said. "What I don't like is that

they threaten me. So I was quiet about it. When I was mayor, that's already fine. But now I am President, we are getting embarrassed. I am used to it, but not our people," he said,

"I will ask them. It's provided in the Constitution. And if they come here, I have the laws, the penal laws and the Constitution And I would just tell them, find something here that is wrong, where you can be charged Because if it is not a criminal offense, then any other country cannot turn it or cannot categorize it as a crime," he said

"I am a citizen of this Republic, the crimes and felonies are in our books," he added.

"Before international law, there is the Constitution which is the bedrock (of Philippine democracy)."

While Filipinos speak many dialects, he said the Philippines is bound by its laws.

"You disregard the flag, the Constitution, there will be trouble," he pointed out.

"Find me a fault there, if there is because you have to begin with the criminal laws of my land." he said. "Why stayed i time, let

He also made clear he is unfazed by a warning from Standard and Poor's that the country's credit rating might be affected by the current campaign against drugs.

Spewing out expletives, he said he is not afraid of S&P's and other credit raters. "You want me to answer, you answer also We're on the same boat. Who are you to threaten me?"

Duterte said he has tasked

his legal team to prepare a draft invitation for any international body that would want to come and probe summary executions in the country.

"It is up to them. But I have asked my lawyer here, legal (team) to prepare the letter to invite them to come and investigate. But I said it should be something live and not a one-way affair," he said in remarks at the oath taking of officers of media covering Malacañang.

Duterte again repeated his attacks against US President Barack Obama, reminding him of police abuses targeting African-Americans

"Even Obama, we'll ask him so he must be prepared. Now, why should I prepare? Who are you? In the context of things, who are you? Why are you asking me? What about you, killing the black people? Do not be such a hypocrite," he said.

"Why me? Those who have stayed in America for a long time, let's not fool each other. What is their treatment there of foreigners, or if you are not white? Now, you who have studied in America, have lived in America, tell me straight, walang bolahan. How are you treated there in America if you are not white?" he added.

Duterte also vented his anger at columnists whom he thought were more concerned about the impact of his attacks against the US, than about him and his constituents.

Hypocrisy

He berated the US anew for what he called its hypocrisy and for invading Iraq supposedly in search of weapons of mass destruction.

After wasting Iraq, the US, Britain and their allies never recovered even fireworks, he

"That's their hypocrisy,"
Duterte pointed out.

"Kung hindi lang bawal magpatay ng Amerikano, patayin kita dito (If it's not unlawful to kill an American, I'll kill you here)," he said.

Duterte reiterated that he wanted Americans in the probe. "Ano sa palagay nila sa akin, gago (What do they think of me, stupid)?" he said.

The President reiterated that he does not care if he goes down in history as a killer or a disgraced politician.

"If I go down in history as a killer or disgraced, as I am the one impeached, it's okay. Assassination, fine. I do not lose

my honor in both It's fine with me," he said

Duterte reiterated that he has long put his integrity and his presidency and even his life on the line in his intensified war against illegal drugs.

At the same time, Duterte reiterated he cannot allow his accusers to draw "garbage" of information from De Lima and make a report out of it.

"That's about stupid," he said.

He said any investigation should be a two-way street where all parties concerned would also be allowed to ask questions.

"Magtanong muna sila sa lahat then magtanong ako sa kanila (They may ask questions, and then I'll ask them too). Rapporteur of EU, rapporteur of UN, whoever is interested, rapporteur of the state department or Obama," he said

Duterte said Obama may come to the country to personally ask questions, but the President said he should also be allowed to ask Obama pertinent questions regarding the abuses and the killing of African-Americans in the US

"Tutal wala naman siya ginawa na kasi (He has done
nothing anyway because) he's
out, maybe he can come here
and find time to ask me questions and I'll answer him. I
have some interesting questions to ask. I would just term
it very interesting questions.
You know what's sauce for the
gander is sauce for the goose,"
he said

"It cannot be just a oneway traffic here. Even if I am a President of a small republic, I will see to it that in matters of principle, we are in parity, tabla (equal). Even if we're not as popular as America," he added.

The President said he would never allow UN rapporteurs to work on a wrong premise fed by his political enemies.

Duterte recalled that he talked with Alston when he was mayor of Davao but nothing came out of the investigation

vestigated by the human rights and the rapporteur, nothing came out of it," the President said.

The President again fired a broadside at De Lima, whom he accused of having immoral relations with her driver and for benefiting from drug money from convicts.

"Then a secretary of justice here, and if you have noticed, she kept on hammering at me. And I said, if you have a good case, if the goods are there with you, file a case," he said.

Duterte said De Lima has been banking on the testimony of her key Senate witness, self-confessed killer Edgar Matobato, but still she dillydallied in the filing of charges against him.

He 'vowed yesterday to have De Lima put behind bars on non-bailable charges.

"Kasi nandiyan na daw 'yung witness niya si Matobato, so go ahead. Wala siyang ginawa. Now, nandito na sila, naipit na siya (She has Matobato as witness, go ahead. She did nothing. Now, she's in trouble)," he said.

"But this De Lima, she screwed her driver and screwed the nation," the President said

"Our problem is not my mouth It's drug addicts numbering about three million, and we have new surrenderees. My slurs and my curses –they are but manifestation of the anger inside me," he said. "Wag nila akong takutin (Don't threaten me)."

Duterte said it's the US, the EU and the UN that should be investigated "because they have committed far more injustice.

"Even then there were already killings. Look at the statistics. That would make

you a good journalist because you are fair, factual," he said.

He added he is ready to "resign tonight" once it is established that he is behind the summary killings.

He reiterated that the local police are not in the business of "mummifying" slain drug suspects, as such practice is an expertise of drug syndi-

Meanwhile, the UN said its review of the human rights situation in the Philippines on Sept. 28 will be done from Geneva and not in Manila.

Tess Debuque, UN Information Center Manila, has clarified an 18-man team from the UN Committee on Economic, Social and Cultural Rights will conduct its review at the Palais des Nations at 3 p.m. to 6 p.m. (9 p.m. to midnight in Manila), and not in Manila as reported earlier.

A UN advisory said the Philippines will undergo a review because it is one of 164 states that have ratified the International Covenant on Economic, Social and Cultural Rights Signatories to ICESCR undergo regular review.

The committee will discuss with a Philippine delegation a range of issues relating to the implementation of the ICESCR.

The advisory said the committee's meetings with the Philippine delegation at the Palais des Nations will be public and will be webcast at http://webtv.un.org/.

The Philippines has submitted a report to the ICESCR.

The committee will release its findings on Oct. 10.

Other countries being reviewed are Costa Rica, Cyprus, Poland, Tunisia, Lebanon and the Dominican Republic

NPA rebel yields to army troopers in Ilocos Sur From the Philippine Information Agency (Sep 26): NPA rebel yields to army troopers in Ilocos

Sur

A self-proclaimed member of the New People's Army (NPA) group operating in the northern part of flocos Sur abandoned his unit and surrendered to the Army.

According to Colonel Eugenio Julio Osias IV, the commander of the 81st Infantry Battalion of the Philippine Army, the rebel surrenderee was identified as alias Ka Monsor, 38 years old, and a resident of Barangay Maratudo, Magsingal town.

Osias spent 17 years as member of the NPA's Kilusang Laranang Sinag based in the mountainous areas within the boundary of the provinces of llocos Sur and Abra.

He confirmed that Ka Monsor, who voluntarily submitted himself to the authorities through the intervention of his family members, is one of the remnants of the NPA rebel operating in Northern Luzon. He is also one of the five NPA rebels who surrendered to their unit this year.

In a tactical interrogation. Ka Monsor claimed that he decided to return to the fold of law due to the hardships he experienced while hiding in the mountains.

Last week, the rebel returnee received P65,000 worth of livelihood assistance from Ilocos Sur Governor Ryan Luis V. Singson in a simple rite at the provincial capitol.

Meanwhile. Singson called the remaining members of the NPA group operating in the province to voluntarily surrender to authorities for the sake of peace and development.

No amnesty, no peace talks with Abu Say, af

PRESIDENT Duterte yesterday said there would be no amnesty for members of the Abu Sayyaf, a group notorious for beheading kidnap victims who could not pay ransom, as he reiterated there would be no peace negotiations with the "despicable" bandit group.

Duterte said he agrees with the military that there could never be amnesty for the bandits.

"The Abu Sayyaf were decapitating people like just they were just fowls and pigs and goats. And there will be no talks. Tama iyung Armed Forces, iyung rejecting an amnesty. I will not. I will never. There will never be an amnesty," he said.

Duterte said former Moro National Liberation Front chairman Nur Misuari has been hinting of the possible inclusion of the Abu-Sayyaf in peace efforts in Mindanao.

He said he is pursuing peace but does not include the Abu Sayyaf.

The military stepped up operations against the Abu Sayyaf last month, which authorities said may force the group to conduct retaliatory or diversionary attacks.

The Abu Sayyaf is holding 16 foreign and Filipino hostages in Sulu. Government troops foiled a potential roadside bombing in Indanan town, Sulu with the recovery of an improvised explosive device (IED) believed to have been manufactured and planted by the Abu Sayyaf.

The bomb was found by residents in Sitio Kajatian, Barangay Tagbak at around 1:40 p.m. on Sunday.

Military and police bomb experts diffused the IED about an hour later.

The bomb is composed of 30 liters of ammunition nitrate as main charge, blasting cap, and a 150-meter wire, said Col. Rodrigo Gregorio, spokesman of the military's Joint Task Force Sulu, – With Victor Reyes

PH interest in Russian military arms explained

THE Philippine Embassy in Moscow yesterday clarified that the donation to or borrowing of Russian military equipment and technology are not part of any discussions on military and technical cooperation between the Philippines and Russia.

"As stated in our previous press releases, there have been briefings and preliminary discussions with Russia on military technical cooperation," Philippine Ambassadorto Russia Carlos D. Sorreta said

He stressed "We have also been briefed on the different modes of financing, but there have been no discussions on donating or lending military equipment or technology.

Sorreta said that the Philippine defense establishment knows what it needs, particularly in terms of internal defense and counterterrorism.

"What we are doing now is to see if the systems we need are available from Russia, if the prices are competitive, if the terms are beneficial to the Philippines, if there. will be transfer of technology and if there will be itarian law." local investments," Sorreta explained.

"There are military items that the Philippines needs to deal decisively with our internal threats that are not readily available from other sources, either because some countries don't believe we can use these hi-tech systems properly or because of certain country-specific conditionalities," Sorreta

As of now, according to the Ambassador, it appears that the military systems and technologies the Philippines needs are available from Russia and "they trust that we will use these in accordance withinternational human-

Sorreta added it seems that there are no conditionalities, other than those that generally apply to all nations.

"For example, not to use these to commit acts of aggression in violation of the UN Charter or to develop weapons of mass destruction," the Ambassador explained

Russia sells military equipment and militaryrelated equipment to a host of nations.

_The Pentagon has bought a large number of Russian helicopters for use in Afghanistan. The Republic of Korea has also purchased Russian helicopters for use in differentroles.

Citing an article in the Wall Street Journal (July 06, 2016), Sorreta noted that in the five-year period through 2015, Russian arms sales to Southeast Asia more than doubled to nearly \$5 billion from the preceding five-year period

Duterte invites Tiamzons for dinner at Palace

PRESIDENT Duterte yesterday admitted "rumblings" in the Armed Forces of the Philippines as he cozied up to leaders of the Communist Party of the Philippines-National Democratic Front of the Philippines (CPP-NDFP) who remained "enemies of the state" in the eyes of the military.

In a speech in Malacañang, Mr. Duterte said: "I've heard that there are rumblings because they are natural enemies

... there are many who died from the military. But I told them, you know guys, I am your President, I am your Commander in Chief. That is a title for war Unfortunately, I am not a war-time President."

Mr Duterte said his "main task" was to seek peace in the country, which was why even before he set foot in Malacannang, he had touched base with leaders of the CPP-NDFP

on the possibility of restarting talks that were stalled during the Aquino administration.

The President was scheduled to meet with the "entire communist hierarchy" led by the Tiamzon couple, who were released recently as part of the peace negotiations, for dinner at the Palace after a meeting with Manila Mayor Joseph Estrada.

"This would really be the first time that the enemies of the state are here for—it's part

of what you would call civility. Just because we are in a war doesn't mean to say that we have to be war at all times. We can always talk and maybe, just maybe, it will bring peace to the land," said Mr. Duterte.

The decades-long rebellion mounted by CPP founder Jose Ma Sison in the late 1960s has created deep enmity between its armed unit, the New People's Army, and the AFP due to the high body count on both sides.

Duterte to boost economic ties with China,

Russia

President Duterte is set to strengthen economic ties with China and Russia, saying yesterday he is about "to cross the Rubicon" with the United States over killings linked to his all-out war against illegal drugs in the Philippines.

Duterte's bloody fight against illegal drugs in the country has reaped criticism from western governments and human rights

Economic analysts pointed to his ensuing outbursts against the US and the United Nations as possible reasons for the local stock market's extended decline vesterday.

"Global funds sold Philip-

pine stocks for the 23rd straight day amid nervousness about the fallout from Duterte's anti-drug war and his outbursts against the US and the United Nations," Bloomberg reported

In a speech during the oathtaking rites of the Malacañang Press Corps, Presidential Photojournalist Association and the Malacañang Cameramen Association, the President said he had suggested closer economic ties with Russia to Russian Prime Minister Dmitry Medvedev on the sidelines of the Association of Southeast Asian Nations (ASEAN) Summit in Vientiane, Laos earlier this month

"I told him (Medvedev). I am about to cross the Rubicon with the United States," Duterte related, adding he had plans to begin talks on trade and commerce with countries reputed to be less than friendly with the US.

The Chief Executive said he also intends to talk with Chinese President Xi Jinping about inviting Chinese businessmen to invest in the Philippines

Specifically, Duterte said he would invite Chinese and Russian airlines to come over and do business in the Philippines to force local carriers, especially on domestic routes, to shape up

"I told him (Medvedev) .. I and give more efficient service about to cross the Rubicon to the public – or go bankrupt.

Addressing local airlines, he said: "You go bankrupt? I do not care. I'm going to invite China and Russia to put up their airlines here. All of you, big businesses in public service: observe humanity."

Duterte, however, stressed in a press briefing following the media induction rites that he is not totally breaking ties with the US even as he strengthens ties with China and Russia

"Actually, I said I'm not really breaking ties, but we will open up alliances with China, and I had a good talk with Prime

Minister Medvedev. He's there waiting for my visit," Duterte told Palace reporters.

"After China, I think I'll go to Japan and I'll go to Russia," he continued "Never mind about the ratings. I will open up the Philippines for them to do business alliance of trade and commerce."

Not about military alliances

Though he is opening up to China and Russia, Duterte said he is not inclined to talk about military alliances, especially in the wake of the UN arbitration ruling that granted rights to the Philippines over disputed areas

at the South China Sea.

There will never be time to talk about military alliances, Duterte said. "If America wants to go to war about the China Sea, it can have its day."

Duterte reiterated that he is not ready to wage war against China, admitting anew that the Philippines' defense is not at par with China. "I will not join a war that would only destroy my country because we are not really up to the arms of the opposite side. Walang mangyari sa atin (Nothing will happen to us)," he said.

The President also reiterated his disapproval of the conduct of joint patrols with the US. – AFP

PH-US ties nearing a 'point of no return?'

PRESIDENT Rodrigo Duterte said Monday he was about to cross a "point of no return" in terms of the Philippines' relationship with it's long-term ally the United States, and also insisted he was not afraid of any credit downgrades as a result of his war on illegal drugs.

"I'm about to cross the Rubicon between me and the United States at least for six years. I would need your help and everything; trade, commerce and I will open up," he said referring to his meeting with Russian Prime Minister Dmitry Mevdevev at the sidelines of the Association of Southeast Asian Nations Summit

Duterte made his statement even as Foreign Affairs on Monday said the Philippines was looking at the possibility of buying military equipment and technology from Russia, contrary to a previous report that Moscow planned to donate defense equipment to Manila or to provide them on loan. Next page

Manila court suspends Marcelino's arraignment

A Manila court on Monday suspended the arraignment of Lt. Colonel Ferdinand Marcelino, who was charged with possession of illegal drugs by the Department of Justice.

Judge Felicitas Laron-Cacanindin of the Regional Trial Court Branch 17 gave the Justice department and the Public Attorney's Office (PAO) 10 and five days, respectively, to submit their replies.

The judge granted the motion of PAO chief Persida Rueda-Acosta to suspend the arraignment since there was no warrant of arrest.

The DoJ indicted Marcelino and Chinese Yan Yi Shou in connection with the raid of drug laboratory on Jan. 21 in a condominium in Binondo, Manila.

"A Quezon City court already ruled that there was not enough evidence

against the two, especially Marcelino on charges of illegal possession of drugs. So, why harass them further?" Acosta told reporters after the hearing yesterday.

Marcelino refused to give any statement to the media, saying Acosta had explained everything

Last week, the DOJ filed a criminal case for violation of the Dangerous Drugs Act against Marcelino and Yan, reversing its June resolution that cleared the two

The filing of the case prompted Acosta to ask the Manila court to suspend the issuance of a warrant of arrest and defer the arraignment of the duo.

Marcelino was a former operative of the Philippine Drug Enforcement Agency.

PCG conducts night patrols vs Abu Sayyaf

ZAMBOANGA CFTY – The Philippine Coast Guard (PCG) revealed the conduct of night patrols following reports the Abu Sayyaf bandits were fleeing Sulu amid intense military operations, according to an official.

Troops, police foil roadside bombing in Sulu province

From the Philippine News Agency (Sep 26): Troops, police foil roadside bombing in Sulu province

Government troops and policemen, with the help of civilians, on Sunday foiled a roadside bombing in Indanan, Sulu by defusing an improvised explosive device (IED).

Col. Rodrigo Gregorio of the Joint Task Force Sulu's information office, said the IED was discovered by local residents at about 1:40 p.m. at Km. 3 between Kajatian and Tagbak barangays in Indanan.

Gregorio said that when they learned of the IED from the residents, troops from the Army's 501st Infantry Brigade and police immediately cordoned off the area, while the joint task force's Quick Reaction Force scoured the vicinity for possible secondary devices or the presence of armed men.

He said an Explosive and Ordnance Disposal (EOD) team assessed and successfully defused the IED at 2:45 p.m.

Troops have recovered a 30-liter container filled with ammonium nitrate as the IED's main charge, a blasting cap and a 150-meter wire. The IED components were turned over to the Jolo Internal Defense Force.

He said that EOD personnel believed the IED was for passing troops but could have been more deadly to passing civilians.

Brig. Gen. Arnel dela Vega. Joint Task Force Sulu commander, attributed the successful recovery of the IED to the "vigilance and cooperation of the local residents and the timely action of soldiers and policemen".

"Terrorism has no place in our society. The collective efforts of our people in collaboration with authorities have been proven to be a formidable weapon against terrorism. Let us unite in the fight against terrorists and make our communities safe and secure for our families, for our children," dela Vega added.
