iUS to remain Phix only military ally?

The United States will remain the only military ally of the Philippines, Foreign Affairs Secretary Teodoro Locsin Jr. said yesterday.

"Why the US, the only world power that is a bastion of deniocracy and human rights, is and will remain our only military ally. We don't need any other," Locsin tweeted.

During a joint press conference with US Secretary of State Michael Pompeo in Manila last month, Locsin had said, "in vagueness lies the best deterrence," to describe the almost seven-decade-old Mutual Defense Treaty (MDT).

Defense Treaty (MDT).

The MDT provides that the Philippines and the US will come to each other's aid in case of armed attack

other's aid in case of armed attack.
Locsin's remarks were issued amid the apparent growing influence of China in the Philippines under President Duterte.

Pompeo assured the Philippines that US obligations under the MDT are "real."

"As the South China Sea is part of the Pacific, any armed attack on Philippine forces, aircraft, republic vessels in the South China Sea would frigger mutual defense obligations under Article 4 of our Mutual Defense Treaty," he said.

Since Duterte assumed office in 2016, he has set aside a landmark arbitral court ruling in exchange

The Philippines, Washing ton's oldest ally in Asia, wants to have a bigger relationship with China that has a major presence in the Indo-Pacific region and looks at great economic opportunities.

Resolution vs 5 US senators

Meanwhlle, Sen. Panfilo Lacson yesterday pushed for a resolution to rebuke the five US senators, who earlier condemned what they sald was the "ongoing human rights abuses" in the country,

Lacson, who chairs the committee on public order and dangerous drugs, said a Senate

resolution "is appropriate to call out these five US senators."

"We are not their colony. We have a Constitution that provides for three co-equal branches and a judicial system where due process is followed, regardless of its flaws and weaknesses," he said through Twitter.

US Senators Edward Markey, Marco Rubio, Richard Durbin, Marsha Blackburn and Chris Coons earlier filed a six-page resolution expressing alarm over the human rights situation in the country.

The resolution also called on the Duterte administration to release detained Sen. Lella de Lima and end the harassment of veteran journalist and Rappler chief executive officer Maria Ressa.

"Extrajudicial killings in the Philippines have been a stain on the country's human rights record," Markey said.

"But rather than working with lawmakers, journalists and civil society in the Philippines to hold perpetrators for these crimes accountable, the

Duterte government is turn-

ing the law against the very voices promoting the rights of the Philippine people," he

The Philippines is a close ally of the US, according to Markey, but the resolution seeks to convey the sentiment of the US Congress in seeking "an immediate improvement in the government's behavior and the end of efforts to weaponize the rule of law against brave individuals like Senator Leila de Lima and Maria Ressa."

DUTERTE SLAMS PCIJ FOR WEALTH SERIES

The President says what his family earns outside of politics should be of no concern to the public. He is reacting to a report about the unregistered law firm of his daughter and undisclosed business interests.

Whatever his family earns outside of politics is nobody's business, President Duterte said on Saturday night in Iloilo City.

The President rose to the defense of his children following a media report on the allegedly unregistered law firm of his family and other undisclosed business interests.

While not naming the report and the news organization, he was apparently referring to a series of the Philippine Center for Investigative Journalism (PCII),

The series delved on the significant increases in the incomes of the President and his children, Davao City Mayor Sara Duterte-Carpio and former Vice Mayor Paolo Duterte, while they were in office.

"My children and I are being criticized, all about lawyering. What do they care about what happened to my law office?" he asked.

Mr. Duterte said he was not required to report what he earned through his own sweat.

'None of your business'

"What we earned outside is none of your business, actually. That we have businesses and law firms, what a goddamn shit." he said.

He made the remarks in a speech in Iloilo City before some 2,000 delegates to the 25th National Convention of the National Federation of Motorcycle Clubs of the Philippines at the Iloilo Convention Center.

Citing the statements of assets, liabilities and net worth (SALNs) of Mr. Duterte, Sara and Paolo, the report claimed that the Dutertes had an unregistered law firm and shares in other companies that they did

not include in their SALNs.

PCIJ reported that Carpio & Duterte Lawyers, with Sara and husband Manases Carpio as partners, was not registered with the Securities and Exchange Commission.

Cebu branch

The law firm, put up by Sara and her husband in 2008, opened an office at City Times Square II in Mandaue City on Feb. 13, 2019. Its clients included cigarette maker Mighty Corp., Panay Electric Co. and those that deal with the Bureau of Customs.

The President himself was a partner at Fabiosa Duterte Cimafranca Carcedo law office but he did not declare his interest in the firm in his SALNs, according to PCIJ.

PCIJ cited the prohibition on mayors and governors from exercising their profession. But the President said the law firm was a necessary option for their family.

He, however, said other people had no business poking their noses into their affairs, as long as it did not involve public funds.

Fallback position

"Our law firms and what happened to our business partnership, it's not your goddamn business. It's my worry. For as long as it's not the people's money," he said.

He added: "You have to have a law office because there is an election every three years. And it's so short. What if you lose this election, where would you go?"

Mr. Duterte argued that it was fine for a politician to own a law firm, as long as he did not practice law while in public office or give advice contrary to the government's position.

Well, there's nothing wrong if we advertise our names. As long as you do not practice and you do not help people get something from government, that is illegal," he said.

He added: "I am a lawyer, I

worked hard for it, naturally I will have my name displaced. They say I shouldn't be practicing so my name and Sara's shouldn't be there. You fools. We are just saying we are lawyers!"

Mr. Duterte said his wealth was inherited from his late mother, Soledad Duterte, and that he had lived with her even when he was Davao City mayor.

He added: "SALN? You didn't work for that money. Were you the one who earned it? Why should I put it in my SALN?"

Impeachment, ouster

A government employee who does not declare certain assets in his SALN risks losing his job.

That happened to Chief Justice Renato Corona, who was found guilty by the Senate impeachment court of not declaring his dollar deposits in his SALN. Corona was ousted in 2012.

In his speech, Mr. Duterte accused PCIJ of being a paid hack used by his enemies to smear his family's name and reputation.

PCIJ is an independent, nonprofit media agency that specializes in investigative reporting. It was founded in 1989 by nine Pilipino journalists who realized, from their years on the beat and on the news desk, the need for newspapers and broadcast outlets to go beyond day-to-day reporting.

In 2000, it reported that then President Joseph Estrada, his family members and cronies allegedly acquired multibillionpeso lands and houses in Metro Manila, Baguio and Tagaytay on Estrada's behalf.

Estrada was impeached but was toppled by the Edsa uprising in January 2001. The Sandiganbayan found him guilty of plunder on Sept. 12, 2007, and was pardoned a month later by then President Gloria Macapagal-Arroyo. — WITH A REPORT FROMINQUIRER RESEARCH INQ

Chinese arbitration body's standards questioned amid Phi loans

The government must find out whether the arbitration body in Beijing that will resolve possible disagreements between the Philippines and China over the loans extended will follow international standards in handling such disputes, Sen. Sherwin Gatchalian said yesterday.

Gatchalian, chairman of the Senate economic affairs committee, made the pronouncement amid fears of a lopsided ruling from a Beijing-based arbitration body in the event the two countries get into a dispute over the huge loans from China.

"We must find out if the arbitration entity in Beijing follow international standards in resolving disputes, how they are different from internationally recognized arbitration bodies," Gatchalian told dzBB.

Supreme Court Associate Justice Antonio Carpio has warned that the country could lose its natural resources, particularly its huge natural gas deposits in Recto Bank, if it defaults in its loan payments to China.

Experts said the loan agreements are governed by Chinese laws, and any dispute arising from contracts will have to be resolved by arbitration bodies in Beijing.

Carpio warned the Philippines is not assured of fair proceedings under the China International Economic and Trade Arbitration

Commission that will use its own rules to resolve disputes.

Gatchalian said it was the first time that the country agreed to submit to an arbitration body based in Beljing.

He said the loan contracts, official development assistance, and other financing agreements entered into by the Philippines with other countries and multilateral institutions have designated the respected and independent arbitration bodies such as the Singapore International Arbitration Centre; International Centre for Settlement of Investment Disputes in Washington; Hong Kong International

Arbitration Centre, or the New York International Arbitration Center. \ 23

President Duterte earlier ordered a review of all foreign loan agreements entered into by the country even as senators asked that this should be done carefully so as not to discourage investors.

Former Foreign Secretary Albert del Rosario and former Ombudsman Conchita Carpio Morales last month filed a complaint against Xi and other senior Chinese officials on behalf of Filipinos "persecuted and in-Jured" by China's aggressive moves in insisting it owned almost the entire South China Sea.

'Testing the waters'

Fishermen from this town had expressed fear of a backlash from the filing of the complaint, but those from Barangay Cato who had sailed to Panatag to "test the waters" returned on Thursday with good news.

skipper of the fishing boat Ruvina 1 that sailed to Panatag on March 23, reported that the Chinese coast guards allowed his group free access to the shoal,

He said the coast guards even allowed them to fish inside the shoal's lagoon, something they were not allowed to do before.

Sumagunday said he did not notice any unusual moves ments by the five Chinese Coast Guard ships stationed near the shoal during his group's stay there.

China selzed Panatag from the Philippines after a twomonth maritime standoff between the two countries in 2012.

Arbitral ruling

The court ruled in favor of the Philippines in 2016, invalidating China's sweeping claim and declaring it violated the Philippines' sovereign rights in the West Philippine Sea.

Although China reportedly agreed to allow Pilipinos to fish at Panatag, fishermen often reported being shooed away by the Chinese Coast Guard,

Last week, fisherman Usaffe Fontanilla reported that the Chinese Coast Guard seemed to be testing its water cannon when his group was about to leave the shoal on March 19.

But Sumagunday said on Thursday that the Chinese coast guards were driving away Vietnamese, not Filipino, fishermen.

The Vietnamese fishermen would move about 10 km from the shoal then return to resume fishing there, he said,

They would leave before the Chinese coast guards could see them, he said.

Panatag overfished?

Sumagunday, however, had a sad story to tell: Pishing at Panatag was no longer the lucrative business it used to be.

He said his group's trip to the shoal last month was almost a losing one, with each bitration in The Hague, A stream on the boat making only P2,000 after selling their catch of small red snapper, parrot and rabbit fish.

> That could mean only one thing: Panatag could be over-fished.

> "Maybe there are now too many fishermen in the area," Sumagunday said, adding that there were more than 20 fishing boats in the area during his group's trip there last month.

He said fishermen from the Visayas and Palawan were now going to Panatag, unlike before when only fishermen from Pangasinan and Zambales fished at the shoal, INQ

He made the remark on Twitter in response to a news article on the prospects of floating cities amid rising sea levels in Antarctica due to climate change.

"Rising sea levels will wipe out the issue of disputed reeds in the South China/West Philippine Sea. And good riddance," Locsin said.

"At the UN (United Nations) Security Council I said the Philippines would not regret climate change and rising sea level if it covers the disputed reefs in the South China Sea and exposes the foolishness of taking and weaponizing them," he said.

President Rodrigo Duterte on Thursday warned China not to touch Pag-asa (Thitu) Island in the South China Sea (West Philippine Sea), where hundreds of Chinese vessels have massed.

The President issued the warning following reports from the Armed Forces of the Philippines that hundreds of Chinese coast guard and fishing vessels had "swarmed" the Manila-held Pagasa Island.

The military's Western Command said the vessels were part of China's maritime militia.

Chinese Ambassador to the Philippines Zhao Jinhua, however, said the Chinese vessels seen near the island were not armed.

The Philippines had filed a diplomatic protest with Beijing over the matter.

Roxas to Duterte: Focus on real problems

FORMER interior secretary Manuel A. "Mar" Roxas II is calling on President Duterte to focus on addressing pressing national issues, like high prices of food and basic commodities, instead of wasting time thinking of ways to silence his critics.

He said President Duterte is veering away from the real problems that Filipinos are facing with his threat to suspend the writ of habeas corpus and to declare a revolutionary government.

"The ordinary Filipino people have so many problems. We've walked around and heard from the market vendors that business is slow. People don't have money. The buyers think that everything is expensive," he told reporters on Saturday while campaigning at a public market in Blumentritt, Manila.

"So this is the (economic) squeeze people are going through. This is the real problem which needs to be addressed," he added.

The President on Thursday last week warned critics he would suspend the privilege of the writ of habeas corpus so that he can order their arrest and declare what he called a "revolutionary war" until his term ends in 2022.

Duterte first threatened to declare a revolutionary government in 2017 amid alleged destabilization efforts against him which he said was being hatched by including communist rebels, "oligarchs," and the Central Intelligence Agency.

The President's latest threat was prompted by a statement from Sen. Franklin Drilon who urged him to be extremely cautious in reviewing government deals, including those with China. Duterte last week said

he wants a review of all contracts entered into by government with companies and other countries to determine if there are "onerous provisions" in any of the deals.

Rep. Gary Alejano (PL, Magdalo) said the threat to declare a revolutionary government is just another "diversionary tactic" amid the controversy linking the President's son, Paolo, to illegal drugs trade and the allegedly onerous deals with China.

Alejano also belongs to the Otso Diretso slate whose candidates have been pressing Duterte to face issues "squarely" and not resort to means outside the Constitution.

Detained opposition Sen. Leila de Lima likened President Duterte to a "mad dog" for his latest threat. "This President does not really

"This President does not really care about the Constitution and the rule of law. All he cares about is his psychotic self. The kind of revolution that we need, and urgently, is a revolution of conscience among the enablers and all others who still cannot see or refuse to see through the moral bankruptcy of this regime," De Lima said.

Sen. Panfilo Lacson said he does not believe Duterte meant what he said, saying "he will not do it because he is too smart and intelligence to know he cannot do it."

Opposition Sen. Francis Pangilinan, Otso campaign manager, said the President should instead run after big-time drug lords and not declare war against his own people.

Vice President Leni Robredo yesterday denounced what she said were efforts to mislead the public on her supposed "eagerness" to replace Duterte should he declare a revolutionary government.

Robredo, a lawyer, said she was only responding to questions about her "readiness" to succeed Duterte after his threat to declare a revolutionary war, suspend the writ of habeas corpus, and arrest his critics.

The President's remarks had sparked discussions of revolutionary government among legal experts, who said Robredo would be his rightful successor.

Last Friday, Robredo was asked if she was ready in case Duterte make good his threat.

She answered in the affirmative, but her detractors accused her of being too eager to replace the President.

"Hindi naman tayo iyong nagsimula ng usapin, Actually, si Pangulo ang naggawa ng isang deklarasyon at tayo ay pinapa-komento lang doon (I didn't start the issue. Actually, it was the President who made the declaration and I was just asked to comment about it)," Robredo said during her weekly radio show.

Robredo also responded to comments comparing Duterte's remarks with the late President Corazon Aquino's declaration of a revolutionary government.

The Vice President pointed out that Aquino made the move in line with re-establishing a democratic government.

She added that the situation during the time of Aquino was different because of the "confusion" that arose from 1986 EDSA "People Power Revolution."

The Vice President reiterated that declaring a revolutionary government runs against Duterte's duties as President, in particular his oath to protect and uphold the Constitution.

She also stressed that there are no circumstances that would warrant the suspension of the privilege of the writ of habeas corpus.

Robredo called on the government officials to remain cautious in words and actions, even in the face of criticisms.

Election lawyer Romulo Macalintal, another Otso candidate, has said Duterte will cease to be President once he declares a revolutionary government and such act will pave the way for Robredo to take over the vacant position.

He said declaring a revolutionary government would mean that Duterte "becomes the leader of a revolutionary government while Robredo becomes the leader as president of a duly constituted government." – With Raymond Africa and Angela Lopez de Leon

SHANGHAI -- China, the rising world superpower, said it was not a competitor with other economies in the global market, but rather a "good friend" that could help spur development in its neighboring countries.

Yujun Yang, former Ministry of National Defense Information Bureau director and spokesperson said China wants to be friends with all nations of the world.

"China is a friendly nation. We want to make friends with everybody. We won't go into war with any country,'

said Yang when pressed if China would to war over the maritime disputes in the South China Sea,

Despite a ruling by the Permanent Court of Arbitration that the Philippines has exclusive sovereign rights over the West Philippine Sea, China has maintained its claim over most of the South China Sea.

But Yujun, now dean and senior research fellow at the Academy of Media and Public Affairs of the Communication University of China noted that while China maintains its claim over the disputed waters, it does not intend to use force to gain control of what it believes belong to the country.

A military official before his retirement from the Chinese government service, he said China will always opt for peaceful negotiations to settle disputes. He said it is better to sit down and talk than resort to destruction.

"China will not destroy nations, but instead, will help build nations, help build infrastructure, help give jobs. China will always be a partner in nationbuilding and development," he said.

He also noted that China's continuing technological innovations should not be taken as a move of China to be competi-

"We are doing this not to compete, but to make life easier and more comfortable for all the people of the world and improve livelihood," said Yang in an interview during a dinner here with Shanghai municipal officials.

In particular, he said, the Chinese people are taking initiatives to make Shanghai and Beijing investment-friendly.

"We want investors to come to us in Shanghai, Beijing and other cities of China and make investments," said Yujun, one of the speakers during the 10day China-ASEAN Center Advanced Studies Seminar Workshop on New Media sponsored by CUC.

With \$18,450 per capita GDP in 2017, Shanghai, located in eastern China, is the country's largest economic center. It's GDP is equivalent to a medium-developed country or region.

In a radio interview on dzBB, GMA resident analyst Richard Heydarian said the continued presence of Chinese vessels in the West Philippine Sea shows that the country's effort to build "friendly" ties with China does not work.

"Here's the problem. After everything President Duterte did for them, our fishermen still cannot fish inside the Scarborough Shoal lagoon," he said in Filipino. "The Chinese lied because they promised easier access for our fishermen, and that did not happen."

He said there was no evidence to suggest that President Rodrigo Duterte's policy toward China was working.

"If anything, China could be encouraged to push the envelop and become aggressive in the West Philippine Sea," he said.



'History Walls' retell stories of heroism of PH veterans

GLARK FREEPORT—What happened in various parts of the Philippines during World War II?

The Philippine Veterans Bank (PVB) tells local war stories through its "History Walls."

At least 30 of the bank's 60 branches feature local World War II history to pay tribute to the courage and sacrifices of Filipino veterans for national freedom.

They actually own PVB because half of the bank's seed fund in 1963 came from the \$20-million reparation payment of Japan to them.

Educating the youth

"We want to educate the youth on this history of the Philippines in World War II," former PVB president and chief operating officer, Nonllo Cruz, said of the History Walls project.

These walls consist of permanent panels of photographs, video documentaries and display cases of memorabilia.

The PVB branch in Building 2435 on E. Quirino Street here opened its history wall for

public viewing in 2017 to remember the 72nd anniversary of the retaking of Clark Field by two US Army Infantry Divisions from the Japanese Imperial Army's Kembu Group in less than a month of air and

land combat in 1945.

Built in 1919 next to Fort Stotsenberg and regarded as the most important military air field in the country, the erstwhile Clark Field was taken by the 30,000-men Kembu Group immediately after Japan attacked Pearl Harbor in Hawaii on Dec. 8, 1941.

After months of defense by Filipino and American soldiers, Bataan and Corregidor fell to enemy's hands on April 9, 1942.

Clark Field attack

An account in the History Walls says. "The US Army's 37th and 40th Divisions attacked Clark Field on Jan. 24, 1945 and within a week, the Kembu Group lost all its heavy weapons and tanks."

"The survivors took up harassing positions in the Zambales mountains, where they infiltrated Clark Field and destroyed aircraft and equipment in night raids."

It recalls that "Exhausted, the 40th Division garrisoned Clark Field while the unit refitted. The XIV Corps secured the Clark Field air center for the Allied Air Forces—construction work began and the Fifth Air

Porce planes fly in from repaired strips.

Filipino veterans share their accounts in documentaries that are played during banking hours.

The display cases feature a copy of the "instrument of surrender" that Gen. Tomoyuki Yamashita and Vice Adm. Denhici Okochi of the Japanese army and navy, respectively, signed at Camp John Hay in Baguio City on Sept. 3, 1945.

The documentary "Unsurrendered 2: The Hunters ROTC Guerrillas" shares the story of college cadets who resisted the Japanese invasion, mounted operations and ambushes and launched the raid on Los Baños in February 1945.

The glass cases also show Japanese occupation stamps, an Asiatic-Pacific campaign medal, old: cover of mimeographed newspaper "Liberator" illustrated by Esmeraldo Izon, sketch of guerrilla intelligence work on Japanese positions, Gen. AFP told: Learn assassin's ways

WHATEVER the New People's Army rebels will do, the Philippine government will also deliver, President Rodrigo Duterte said Saturday as he ordered the armed forces to "learn the art of assassination" against the communist rebels.

In his speech during the National Federation of the Motorcycle Clubs of the Philippines' annual national convention in Iloilo City, Duterte said he had not given up his dream to create his own military squad to counter the NPA Sparrow unit.

He said he had been telling the police and military forces to be wary of the NPA's liquidation unit.

"I'm addressing myself to the police and the military. I've been telling you sparrow, sparrow," Duterte said.

"They would really take the arms, that ammunition. If they [NPA] saw you with arms, they will not stop until... So, I told them to learn the art of assassination."

The President first floated the idea of matching the NPA's "talent" in assassinating people in November 2018.

While his recommendation was previously studied by his Cabinet officials to come to "fruition," human rights defenders were quick to slam him for his proposal. Still, the Palace viewed the President's idea against the NPA rebels as a "serious" one.

"Now, I said, this one's real. If the NPA has' a Sparrow [unit], then why don't we have one? So, I told them, 'Well, you form a unit to target the NPA'," the President, said."

"Whatever you [NPA] do, I will do also. Why? Do you think you're the only one who wants to have an advantage in this life?"

In the same speech, the President advised the military not to allow themselves to be captured by communist rebels, telling them to kill themselves instead.

"I do not want to see planes carrying decapitated soldiers. Put the gun in your mouth and shoot yourself, Duterte said.

"If you surrender, you will be brought to their camp and treat you like a dog.

Learn 'art of assassination,' Duterte tells soldiers, cops

ALMOST half a year since he broached the idea of forming a special unit that will go after communist rebels, President Duterte on Saturday night advised the military and the police to learn the "art of assassination."

He also reiterated that they should form their own hit squads

to go after the Communist Party of the Philippines and its armed wing, the New People's Army which has a liquidation squad called "Sparrow" unit

The President, at the 25th annual convention of the National Federation of the Motorcycle Clubs of the Philippines on Saturday night in Iloilo City, said he has repeatedly told the military and

He said he had tried to talk peace with the communists but they refused. Duterte formally ended the peace talks with the CPP-NPA-National Democratic Front of the Philippines last month. He said the communists would have to wait for the next administration if

they want to hold peace talks again.

Duterte on Saturday night also reiterated he has been distributing guns to soldiers and policement to help them defend themselves against rebel attacks, especially when they are not on duty.

'DIE LIKE A WARRIOR'

The President also said policemen and soldiers should learn to "die like a warrior" as he advised them anew not to allow themselves to be captured, especially by terrorists groups and Islamic State-inspired groups like the Abu Sayyaf.

The President said he does not want to see soldiers and policemen decapitated.

He also said captives are treated like animals:

"Kasi kung mag-surrender ka, dalin ka sa kampo, bababuyin ka lang parang aso. Kung anong gagawain sa iyo, magpamasahe, tapos 'yung... And there are homosexuals there. They will use you day and night. Philippine Navy Captain Jonathan V. Zata, Director of the Naval Public Affairs Office, said the large antisubmarine ships Admiral Tributs and Vinogradov, and large sea tanker Irkut, will dock at Pier 15, South Harbor.

Zata said the Philippine Navy will render the customary welcome ceremony for the vessels to be followed by a press briefing with both navies' key officials led by the Commander of Detachment of the Russian Pacific Fleet, Capt. Sergey G, Alantiev.

He said the docking of the Russian vessels is a tradition that signifies Russian and Philippine Navy cooperation.

During the five-day port call, the Russian Navy will hold a wreath-laying ceremony, courtesy calls on top military officials, friendly sporting events, and maneuvering exercises with its Philippine counterparts.

On Tuesday, the Russian ships will also hold an Open Door Day from 1 p.m. to 5 p.m.

The Pacific Fleet ships will wrap up their visit on Friday, April, 12.

Zata said this will be the second visit of the Russian Navy this year and the eighth since 2012.

Last January, three Russian Navy vessels — the large anti-submarine ship Admiral Panteleev, the guided missile cruiser Varyag, and the large sea tanker Boris Botuma — were in Manila for five days.

It will be the second time for the Admiral Varyag and the Boris Botuma to visit the country. It will be the first visit for the Admiral Panteleey.

3 Russian vessels due for 5-day visit

THREE Russian Navy vessels, including two anti-submatine ships, are due to arrive today for a five-day goodwill visit, the second one to be made by the Russians this year.

Navy spokesman Capt. Jonathan Zata said there are initial plans for President Duterte to visit the ships after their arrival at the South Harbor in Manila but no final decision has been made yet.

Zata said the three ships—the anti-submarine Admiral Tributs and Admiral Vinogradov and sea tanker Irkut—are due to arrive at around 9 a.m. and will be welcomed by a Philippine Navy delegation.

The Russian delegation will be involved in several activities while in the country, including a courtesy call on Navy chief Vice Adm. Robert Empedrad and friendly games with their Filipino counterpart.

Last January, the Russian sent anti-submarine Admiral Panteleev, guided missile cruiser Varyag, and sea tanker Boris Botuma to Manila for a similar port visit.

Relations between the two navies have improved under President Duterte's independent foreign policy. The Russians have donated 20 trucks, 5,000 assault rifles, a million rounds of ammunition and 5,000 helmets to the Philippine military during the Duterte administration. – Victor Reyes

Philippine Navy sealift vessel to join Chinese Navy fleet review

The Philippine Navy (PN) will send a strategic sealift vessel to China to participate for the first time in the Chinese Navy's fleet review later this month.

The Flag-Officer-in-Command (FOIC) of the Philippine Navy, Vice Admiral Robert Empedrad, said the BRP Tarlac (LD-601) will join the fleet review to mark the 70th anniversary of the People's Liberation Army Navy.

Empedrad said the Tarlac will depart for Qingdao, China, on April 16 and arrive on April 21. The ship will have 118 crewmembers and 493 passengers from the Naval Task Group, students from the Naval Education Training and Doctrine Center, and Philippine Military Academy (PMA) cadets.

The Tarlac is the lead ship of her class of Philippine Navy Janding platform docks. She is the second ship to be named after the Philippine province of Tarlac, one of the provinces considered to have significant involvement in the Philippine revolution against Spain.

The ship can accommodate 500 troops and support vehicles and equipment;

Capt. Jonathan V. Zata, director of the Naval Public Affairs Office, said the fleet review will be held on April 23 in the city of Qingdao.

He added that the Philippine Navy's participation in the Chinese navy's fleet review is in keeping with President Duterte's policy of engaging not only with the country's traditional ally and strategic partners but other countries as well.

"The Navy, through its naval diplomacy role, maintains good relations with other countries' navies while safeguarding our country's maritime interests," Zata said.

Gordon wants ROTC a 'patriotic duty' for students

enator Richard Gordon has renewed his appeal to make the Reserve Officers Training Corps (ROTC) program mandatory for students,

Noting how China is already getting a foothold in Philippine territories in the disputed islands in the West Philippine Sea, Gordon urged the government to support proposals to revive the ROTC in prepara-

tion for any possible armed attacks.

"We are challenged right now, and we should be prepared. I have been proposing the revival of the ROTC so that male citizens who are 18 years old will have military training," Gordon said during the Commemoration of the 77th Arawng Kagitingan and Philippine Veterans Week held at Fort Bonifacio last Friday.

"They can be asked to give six months military service. In other countries, citizens are even asked to give as long as two years," Gordon said.

Gordon also stressed that having an army of reserved officers that can be mobilized to assist in matters of external and territorial defense, internal security and peace and order is important given that the country "faces a buffet of disasters, both natural and man-made."

He said reserved officers can be tapped for disaster risk reduction and

management.

Gordon was the guest of honor and speaker at the said event. The senator's father, former Olongapo City Mayor James Leonard Tagle Gordon, was given a posthumous award as one of the heroes of World War II.

According to Gordon, his father was assigned as a junior officer under the Intelligence Staff engaged in intelligence gathering and monitoring the province of Zambales. The senator said his father had the rank of a first lieutenant and joined the resistance on November 1, 1943.

"Ang mga bata dapat marunong magsundalo. Dapat kaya nilang lumaban para sa bayan kung kallangan (the youth should know how to be a soldier. They ought to know how to fight for the nation in any eventuality)," he added.

With the aim to foster patriotism and nationalism among the youth, Gordon filed last year, Senate Bill No. 1417, or the Citizen Service Act of 2017 which proposes to require all college students and those of technical vocational courses to undergo basic citizen service training.

The Senate sub-committee on education, arts and culture chaired by Sen. Sherwin Gatchalian, will hold its second hearing on the issue today. April 8, together with the committees on national defense and security, youth and fluance.

De los Santos is a known supporter of Bansud Mayor Angel Saulong, who is seeking reelection in the May 13 elections.

Saulong told police he received a text message on April 4, purportedly from the rebels, demanding permit to campaign fees.

He said the "rebels" threatened to snatch his supporters if he would refuse to pay.

NPAabducts 4 in Mindoro Oriental

AMP EFIGENIO Navarro, Calapan City: The New People's Army (NPA) on Friday evening abducted a barangay (village) chairman, two civilians and a member of the Civilian Active Auxiliary (CAA) in Barangay Malo, Bansud, Oriental Mindoro.

Col. Marceliano Teofilo, commander of the 203rd Brigade, said kidnapped were Malo village chief Peter de los Santos, Loule Medinilla, Ricky Capillo and CAA Reymond Malupa.

They were forcibly taken from

their houses by about 10 NPAs under Kilusang Larangan Gerilyalgnacio Clafero Magadia (KLG-ICM) clad in military uniform, who brought them to Sitio Paypay, which is two hours' walk from their barangay," Teofilo said.

"Westrongly condemn the desperate actions of the CPP-NPA. The abduction only shows how weak these NPA terrorists are, they do not spare even innocent civilians. They threaten, extort money and if they are refused, they will kidnap," he added.

The CPP is the Communist Party of the Philippines and the NPA is its armed wing.

The barangay chairman's refusal to support the NPA is one of the motives police are trying to look into.

He is a well-known supporter of Bansud reelectionist Mayor Angel Saulong, who refused to give in to the extortion demand (permit-to-campaign) of the NPA.

Malo residents said the victims were respected in their community and they were wondering why the NPAs abducted them.

In Bongabong, Mindoro Oriental, more than a week ago, the NPA abducted one civilian, who was forced to join the communist rebels, but he managed to escape and reported the incident.

His identity is being withheld for fear for his life and for his family.

Troops of the 203rd Brigade and the Mindoro Oriental police already sent out troops to hunt down the kidnappers.

This forced the NPA terrorists to release other victims. I already

aletted all camps and patrol bases as these terrorists may attack soft targets to divert and disrupt the joint Army-PNP (Philippine National Police) operations," Teofilo said.

Maj. Gen. Rhoderick Parayno, commander of the Philippine Army's 2nd Infantry Division, said: "The NPA terrorists are no different from being kidnappers. They have violated Republic Act 9851 (An Act on Crimes Against International Humanitarian Law, Genocide and Other Crimes Against Humanity), such as taking of hostages under Section 4 (b) (3). In this case, they have deprived the civilians of their rights to liberty. The full force of

law will run after them."

Meanwhile, Police Regional Office Mimaropa (Mindoro Occiental and Mindoro Oriental, Marinduque, Romblon and Palawan) spokesman Lt. Col. Socrates Faltado said the NPAs already released three of the kidnap victims, while the CAA is still being held hostage.

Those released Jare now with their families after debriefing with local police and social workers.

The wife and the four children of the remaining kidnap victim now fear for their father's life and they are appealing to the NPA to release their father and not to hurt him.

Hungary and member states of the Association of Southeast Asian Nations (ASEAN) are convinced of the terror threats and are in agreement with the AFP that the CPP networks pose threats, not only to the Philippines but to other countries as well, if left unchecked,

Initially, Parlade said Australian, Hungarian and the ASEAN delegates at the Millpol Asia-Pacific 2019 Conference in Singapore have expressed surprise over the AFP presentation which centered on the CPP schemes to gain power, influence and money.

But Parlade disclosed that the delegates later appreciated the AFP presentation and vowed to exert pro-active efforts to help the Philippines address its concerns over insurgency and terror.

As "It's (CPP) totally under their radar. Now they know where to

look," Parlade said.

"They are convinced this scheme or scam can easily morph into a transmational syndicated oriminal activity in the region, especially as the Philippine government tightens the moose against the communist terrorist group," Parlade added.

In his presentation. Parlade detailed how the CPP, 50 years since its founding, managed to establish an international network, named the International Department, comprised of some 252 member-organizations based in 39 countries.

The group established 16 chapters overseas through the International League of Peoples' Struggle (ILPS) headed by CPP founding chairman Joso Maria

Through the ILPS, Parlade said that the CPP connects organizations, from various countries with similar orientations and solicits funding to support armed revolution being waged by the New People's Army.

"This formula of the CPP can easily be copied by other terrorist organizations around the world," Parlade said.

Parlade also revealed that he had one on one dialogues with the representatives of Hungary and Australia, two countries whose support to the Philippines is crucial.

Parlade said that Hungary vowed to back AFP efforts to engage other stakeholders from Europe from where huge donations to GPP legal fronts are coming from.

Australia, meanwhile, wants to have a more comprehensive briefing about the CPP practice, Parlade said.

'ROTC to prevent Reds from recruiting students'

THE military yesterday it wants the mandatory Reserve Officers Training Course (ROTC) to be revived to prevent students from getting recruited by the New People's Army, the armed wing of the Communist Party of the Philippines, and other threat groups.

Army spokesman Lt. Col. Ramon Zagala said some of the student-recruits ended up getting killed in clashes with soldiers.

"One of the reasons we want to bring back (mandatory) ROTC is to make our students, our youth more productive members of the society, instead of getting recruited by the rebel movement and becoming destructive," Zagala said in a radio interview.

Lawmakers are discussing proposals to revive the mandatory ROTC, this time for Grade 11 and 12 students.

President Duterte is in favor of reviving the mandatory ROTC. In November last year, he said the program will help prepare the youth to defend the country in times of war.

The ROTC program was made

optional by virtue of a law passed in 2001 after the killing of Mark Welson Chua, an engineering student of the University of Sto. Tomas. Chua was killed by an ROTC soldier-instructor for exposing anomalies in the ROTC.

"There are a lot, documented instances wherein students were killed in encounters," said Zagala referring to students who got killed in encounters with soldiers after being recruited by the NPA.

"The youth is very malleable. They can be shaped by anyone. That's why we want ROTC (to be mandatory) because the main objective of ROTC is selfless service, patriotism," said Zagala.

Zagala also said there are groups,

Zagala also said there are groups, including the NPA and even cyber hackers, who can recruit the youth through various means including cyberspace.

"Everybody uses social media which is a platform for agitation. It's a platform for recruitment, not only by ISIS-inspired groups but also by the communist rebels who want to bring down this government through violent means," said Zagala.

Maj Gen. Amador Corpus, chief of the Philippine National Police-Criminal Investigation and Detection Group, said Tamano Esmail Sabpa was arrested at the parking area of the Cotabato Regional and Medical Center in Barangay Rosario Heights at around 2 p.m.

The suspect was arrested based on a warrant issued direct assault with murder.

A card identifying Sabpa as a member of the MILF was found in his person, authorities said.

Sabpa was reportedly one of the gunmen who engaged the SAF commandos in an encounter in Barangay Tukanalipao on Jan. 25, 2015.

Aside from the 44 commandos, Malaysian terrorist Zulkifli bin Hir, alias Marwan, was killed in the fire-fight. — Emmanuel Tupas __ April 2019



MILF member arrested in Cotabato City

A MEMBER of the Moro Islamic Liberation Front was arrested on Saturday in Cotabato City for involvement in the January 2015 "Mamasapano massacre" in which 44 policemen from Special Action Force died in Mamasapano town in

Maguindanao.

Tamano Esmail Sabpa, who is also known as Tamano Sabpa Esmael, was arrested by operatives of the PNP's Criminal Investigation and Detection Group-Autonomous Region in Muslim Mindanao at the parking lot of the Cotabato Regional and Medical Center in Cotabato City at around 2 p.m. on Saturday, said police Lt. Col. Mary Grace Madayag, CIDG spokeswoman.

Madayag said the policemen were armed with a warrant issued by Cotabato City judge Alandrex Betoya for direct assault and murder in connection with the massacre,

Sabpa's arrest was in line with the PNP's "Oplan Pagtugis," a campaign plan meant to account for persons with arrest warrants, Sabpa is described as a wanted person at the national level.

On Jan. 25, 2015, hundreds of fighters from the MILF and the Bangsamoro Islamic Freedom Fighters waylaid SAF commandos who had just killed Indonesian bomber Zulkifli bin Hir alias Marwan in Mamasapano.

The attack left 44 SAF members dead.

MILF officials said the policemen entered their territory without any coordination, in violation of a ceasefire agreement. They claimed the policemen fired the first shots and that MILF rebels merely acted in self-defense.

According to the report, the police were armed with a war-

rant of arrest for direct assault with murder issued by Judge Alandrex Betoya of the Cotabato City Regional Trial Court, 12th Judicial Region, Branch 15 dated Jan. 25, 2017.

The report said Sabpa was among the MILF and Bangsamoro Islamic Freedom Fighters (BIFF) who engaged the SAF troopers deployed for Oplan Exodus, a special mission to neutralize or capture Malaysian bomb-maker Zulkifli Abdhir alias Marwan at Barangay Tukanalipao in Mamasapano on Jan. 25, 2015.

Marwan was killed by the government forces but 44 SAF troopers, now known as the SAF 44, were killed by the MILF and BIFF in a surprise attack.

According to the police report, an identification card detailing the membership of Sabpa to the MILF was recovered from the suspect.

Sabpa was brought to the CIDG-ARMM station in Cotabato City for documentation.

The court has recommended no bail for Sabpa.

Mamasapano suspect snared

Authorities in Cotabato City have arrested a suspect in the killing of 44 commandos of the Philippine National Police Special Action Force (PNP-SAF) during the infamous encounter in Mamasapano, Maguindanao in 2015.

According to the PNP Criminal Investigation and Detection Group (PNP-CIDG), Tamano Esmail Sabpa was arrested in a parking area of a hospital in Cotabato City late Saturday afternoon.

The arrest was conducted by members of the CIDG in the Autonomous Region in Muslim Mindanno and operatives of the Cotabato City Police.

On 25 January 2017, Judge Alandrex Betoya

issued a warrant from Branch 15 of the Regional Trial Court in Kabacan, Cotabato against the suspect for a direct assault case, An ID recovered from the suspect indicated is a member of the Moro Islamic Liberation Front (MILF).

In 2016, PNP-SAF commandos conducted a successful mission to neutralize Malaysian terrorist Marwan in Mamasapano. But as they withdrew, they ran into MILF troops and members of the Bangsamoro Freedom Fighters (BIFF), triggering an encounter where 44 SAF men were killed.

Meanwhile, the military reported on Sunday that four suspected members of the BIFF were killed in an encounter between government troops and members of the Islamist militant group in Maguindanao last 4 April. Elements of the 1st Mechanized Infantry Battalion, 37th Infantry Battalion and 64th Division Reconnaissance Company encountered the suspected BIFF members while conducting combat clearing operation in Barangay Tina in Shariff Aguak.

Tamano Esmail Sabpa was arrested in a parking area of a hospital.

After the 15-minute encounter, government troops recovered one M203 grenade launcher, one Barrett .50 callber rifle, assorted anti-personnel mine components, as well as assorted parts of firearms and equipment.

According to military estimates, at least 11 other BIFF fighters were wounded during the clash. With Kathleen Mae Bulquerin

2 Abu hostages freed, 1 drowns

An Indonesian fisherman held hostage for four months by the Abu Sayyaf Group (ASG) has drowned while two other captives were rescued by government troops, a military spokesman said.

The three men were seized by the Islamic militant group from their fishing boat early December last year. They were held on a remote island for nearly six weeks as a standoff ensued when government troops blockaded the island in a bid to corner the kidnappers.

According to military spokesman Lt. Col. Gerry Besana, the ASG fled the southern island of Simusa Friday, bringing their hostages with them.

He is currently being treated at a military hospital.

One Indonesian fisherman, Heri Ardiansyah, was rescued as the militants tried to flee, but another captive, identified only as Hariadin, drowned in the escape bid.

Besana said another hostage, Malaysian Jari Abdullah, was rescued by soldiers a day earlier. He is currently being treated at a military hospital for gunshot wounds but is in a "stable" condition.

Three of at least seven kidnappers were killed in the operations, Besana said

After getting wind of the location of the ASG in late February, Besana said the military ordered the small civilian population of the island to leave to ensure their safety.

The ASG has gained notoriety for bombing attacks and kidnapping of tourists and missionaries for ransom.

'y father, the late Max Soliven once wrote about China. He LV Lsaid: The People's Republic of China, once a pariah and "doomed" to failure in the world's eyes after the lune 1989 Tlenannien Square "niassacre," is now the Travel Destination of the Year. In ancient times, the saying went that "all roads lead to Rome." Not anymore. Even Wal-Mart and Starbucks - and



yes, Versace – are making a beeline for China. Now, China has become a world power. It is so strong that it could in fact widen its influence wherever they want and

get what they want with such ease and candor.

My father first met Chairman Deng Xiaoping when he, as a member of the Philippines' Foreign Policy Council accompanied the late Vice-President and Foreign Affairs Secretary Salvador Laurel to Beijing in 1988. It was at that session in the Fujian Room of the Great Hall of the People that Chairman Deng first announced that the Spratly's "Belonged" to China.

Chairman Deng called the Spratly's by another name - Nansha Islands. He also made clear to the Philippine group that whatever name is given to the islands they still belong to China. For years now, China and the Philippines have contesting territorial claims in the South China Sea, an international waterway that Beijing claims as its own. Remember how former President Benigno Aquino III

launched a formal case against China over the matter in 2016 and the Hague tribunal ruled in favor of Manila, invalidating Beijing's claims? Well, nothing happened because Chinese officials dismissed that ruling.

Then came Duterte. For some reason, he gave up on us and softened his approach to China. His stand is that China is so big and so strong she can wipe us out in a few seconds. Then, he made a dramatic turn around on our foreign policy when he declared a separation from the United States and chose to align with China. The president's action

of course angered many Filipinos.

Records show that in a span of 18 months, the government normalized its ties with China, thought of conducting a joint exploration in the disputed islands, re-enabled the Filipino fishermen to operate within the Scarborough. Shoal and strengthened cooperation on tourism. A Six-Year Development Program was signed by the two countries to follow on the progress of their economic partnership in the areas of trade, investments, agriculture and fisheries,

infrastructure, and tourism among others.
In October 2016 Duterte visited China, Chinese President XI Jinping agreed to normalize diplomatic relations as well as resume bilateral dialogues on the issue of the West Philippine Sea dispute. This resulted in the signing of 13 cooperation agreements with the Chinese government and secured financial assistance and investment pledges worth USD24 billion, with business-to-business contracts amounting to USD 15 billion and official development as-

sistance (ODA) comprising the remaining USD 9 billion.
With the closer ties between Manila and Beijing, 19 projects and programs worth a total of P731.7 billion are said to be rolled out during President Duterte's term through loans and grants from China.

Two projects worth at least P500 million are the Department of Agriculture's P500-million Philippine-Sino Center for Agricultural Technology-Technical Cooperation Program Phase 3, and the Seawater Desalination Complete Equipment Project in Dauis, Bohol will be financed by Chinese grants.

So far, the Duterte administration has signed two Chinese loan agreements, the P4:37 billion Chico River Pump Irrigation Project and the Kaliwa Dam worth P12:2 billion.

Projects that are still under negotiation for loans from

China are the Department of Transportation's P175.3-billion North-South Railway Project-South Line (Long Haul); and the Bases Conversion and Development Authority's P57:2-billion Subic-Clark Railway Project; the P39.2-billion Ambal-Simuay River and Rio Grandé de Mindanao River Flood Control Projects; P25.6-billion Davao City Express-way Project; P97.3-billion Panay-Guimaras-Negros Island Bridges; P56,6-billion Cebu-Bohol Link Bridge; P44.6-billion North Luzon Expressway East Project; P47,4-billion Dinagat (Leyte)-Surigao Link Bridge; P57.6-billion Luzon-Samar Link Bridge; P72.1-billion Bohol-Leyte Link Bridge; P14.4-billion Negros-Cebu Link Bridge, and P2.3-billion

All these planned projects tapping China's ODA sparked concerns on a "Chinese debt trap. How much price do we have to pay for the realization of the country's 'golden age of infrastructure'? It has been reported that among the loan contracts signed by the Philippines with other countries such as Korea and Japan, the deals with China had specific waivers on sovereign immunity and mentioned patrimonial assets. Socioeconomic Planning Secretary and NEDA chief Ernesto M. Pernia said that the Secretary and NEDA chief Ernesto M. Pernia said that the Philippines was "more cautious" and "extra careful in having projects funded by China.

What about the dozens of Chinese citizens working on

at least two construction projects under Duterte's "Build, Build, Build" program and funded by Chinese grants? Foreign Minister Wang Yi said that Chinese investments in the country increased more than five-fold in the first six

in the country increased more than five-fold in the first six months of the year after a 67 percent expansion last year. An exclusive report on "24 Oras" mentioned that project managers and many of the engineers and surveyors of the construction of the Binondo-Intramuros Bridge and the Estrella-Pantaleon Bridge are Chinese citizens. Based on DPWH data, there are 93 Filipinos and 55 Chinese hationals working on this project. These two projects cost P3.38 billion and P1.47 billion respectively and are funded by China through grants. By the way, the contractor is also Chinese. The DPWH also said that it has urged China to abide by the Republic Act 6685 which requires private contractors

the Republic Act 6685 which requires private contractors to hire not less than 50 percent of unskilled laborers and 30 percent of skilled laborers from the residents of the area

where the project is being undertaken. A. Malacanang said that the Chinese workers are legally entering the country with permits. Those without proper documents shall face violations of immigration laws. Chinese Ambassador Zhao Jianhua told Presidential Spokesperson Salvador Panelo that, "If this government will just deport Chinese not in accordance with law, then we will

also do the same." That's lit for tat.

The point is we are anxious about all these. The Spratly's have clearly been taken over by China with the huge developments taking place over there. The Chinese financial assistance is enormous. Reports say that out of the 75 major projects the Duterte administration aims to complete on or before 2022, about one-fourth or 19 will be funded by China. The conditions and situation we are in with China is scary especially with the predicament we have with a country who we all know is positioning itself to be a global superpower. If these loans are not managed well, it can work to our disadvantage. Where do we go from here? Where will all these lead us to? Why is Duterte in a fix?

The President issued the statement after being informed by security officials about the presence of some 200 ships believed to be part of China's maritime militia near Pag-asa Island, part of the Palawan municipality of Kalayaan where many residents are soldiers and the main source of livelihood is fishing in the West Philippine Sea, Records of the Armed Forces of the Philippines show that the Chinese vessels have been monitored in the area since the start of the year.

Whether his Chinese friends will heed his advice remains

to be seen. In the meantime, the Department of Foreign

Affairs has lodged a formal protest over the presence of the Chinese vessels. Similar vessels continue to patrol Panatag or Scarborough Shoal off Zambales, which in 2016 was declared by a UN-backed arbitral court as a common fishing area over which ho country is supposed to have control.

The Permanent Court of Arbitration in The Hague also awarded the Philippines sovereign rights over Panganiban or Mischief Reef off Palawan, which the Chinese have turned into an artificial island on which they have built a multistory garrison. So far, there has been no indication that Beijing intends to leave Panganiban Reef.

President Duterie has gone out of his way to extend a hand of friendship toward China amid the continuing dispute in the South China Sea. Bilateral ties continue to strengthen on various fronts. How Beijing will react to his "advice" on Pag-asa, however, will test whether his rapprochement is worth it.

Duterte's suicide mission to Pag-asa Island

resident Duterte addressed China on Priday: "Let us be friends, but do not touch Pag-asa Island and the rest. If you make moves there, that's a different story. I will tell my soldiers, 'Prepare for suicide mission.""

Strong words, indeed! A defiant statement reported all over the world.

Apparently, the statement is not off the cuff. The Philippine government previously issued a statement that the Chinese Navy sent as many as 275 navy, coast guard and maritime militia vessels to the vicinity of Pag-asa. "It has been observed that Chinese vessels have been present in large numbers and for sustained and recurring periods—what is commonly referred to as 'swarming' tactics—raising questions about their intent as well as concerns over their role in support of coercive objectives."

But one does not exactly know now whether the President says what he means, and means what he says. Is the suicide mission just another "jetski" story?

Mr. Duterte can help us understand him if he will translate his words into deeds.

The first presidential thing to do is for Mr. Duterte to visit Pag-asa and make a strategic declaration of Philippine resolve to defend Philippine territory and sovereignty in the West Philippine Sea. Sen. Panfilo Lacson already gave a strong hint when he said he is willing to accompany Mr. Duterte on such a visit.

Mr. Duterte actually owes it to the nation to visit Pag-asa. A visit to Pag-asa is the operational equivalent of the first stage of his jetski promise to plant the Philippine flag on the Spratlys in the South China Sea. If he is up to it, he can take the Philippine flag to the now

Chinese-occupied Subi Reef, 26 kilometers away from Pag-asa—a jetski-able distance on a tankful of gas, even for an old macho man.

Mr. Duterte would add a nice personal touch if he would also stay the night, and have a boodle fight and a round of beer with the soldiers who are stationed there for boring months on end.

The second presidential thing to do is to now call for volunteers in the military services to make up the suicide mission. Even the Japanese kamikaze had to prepare and go through training and motivation sessions before they went on their one-way mission. They were allowed to write letters to their loved ones, akin to Islamic State suicide bombers making suicide videos.

But it looks unlikely that President Duterte will openly make a personal visit to Pag-asa Island. This will be a defiant, symbolic and potentially strategic move that reverses all the fawning toward China he has maintained over three years. Xi Jinping will not allow him to do that. Unless, perhaps, he is accompanied by

Ambassador Zhao Jianhua of China. But wait!

We forget that this Pag-asa crisis is happening just before the May elections. Mr. Duterte will do anything to prevent a dramatic shift in public opinion that will endanger the chances of his administration candidates. If he does not win a Senate supermajority (17 automatic votes out of 24), he will not have quasi-dictatorial powers within the framework of the 1987 Constitution.

The candidates of the Duterte administration are way ahead of the opposition candidates according to the surveys. But Mr. Duterte is beleaguered, suffering simultaneous setbacks—the loss of his "air force" of worshipful Facebook accounts due to "coordinated inauthentic behavior." He had to explain to Xi Jinping he had nothing to do with the complaint against the latter before the International Criminal Court. Viral videos allege that the Dutertes are behind drug operations in the country. He is exasperated with the worsening drug and corruption problems. The psychological moment for a shift in political fortunes is in the air!

Will Xi Jinping allow Rodrigo Duterte to play hero, visit Pag-asa Island, boodle with the troops and make hyperbolic announcements in aid of the election of the Hugpong ng Pagbabago candidates? His visit to Pag-asa, of course, would only be a moro-moro to calm the natives; the China-Duterte friendship will remain. He closes with a sly wink.

Ah, I am sure Xi Jinping is a reasonable man, with a long-term vision, in dealing even with his subalterns.

Cold-blooded murder in Bataan

ast week, I asked a young lady from Balanga, Bataan, what she knew about the events that took place in her home province 77 years ago. Understandably, she only had sketchy ideas about what happened during those fateful days in April 1942, and why tomorrow is a national holiday.

Let me provide some background.

In December 1941, Japanese forces attacked US military installations in the Philippines destroying much of what represented Ameri-

can air power in the region.
After three months of heavy
fighting in the Bataan Peninsula, Maj. Gen. Edward King,
commander of Luzon Force
defending the Peninsula, surrendered to Japan's 14th Army
led by Gen. Masaharu Homma
on April 9, 1942. David McGullough in his prize-winning biography of President Harry
Truman described the capitulation as "the largest surrender of an American force since

Appomattox." (Appomattox, a small village in Virginia, was the scene of Gen. Robert E. Lee's surrender of the Army of Northern Virginia to Gen. Ulysses Grant in 1865, signaling the end of the US Civil War. The surrender also took place on April 9. Lee surrendered an army of 28,000, while King gave up a Fil-American force of 75,000.)

Not many people are aware that King surrendered without informing his immediate superior, Lt. Gen. Jonathan Wainwright, the commander of US Forces in the Philippines who had replaced Gen. Douglas MacArthur. Upon learning of the surrender "MacArthur was shocked and demanded of Wainwright a full explanation of King's conduct. Wainwright replied that he had expressly forbidden such action and that King did not broach the subject of capitulation to him." Nevertheless Wainwright refused to criticize King because "the decision which he was forced to make required unusual courage and strength of character."

Tomorrow, we shall mark Araw ng Kagifingan with the traditional visit by the President or his representative accompanied by Japanese

and American embassy officials to the Dambana ng Kagitingan on Mount Samat. We shall once again recall the heroism of men who fought fierce battles in Bataan. We shall relive the Death March and remember the concentration camp atrocities at O'Donnell in Tarlac.

In our thoughts and prayers, let us not forget what happened to some 350 to 400 Filipino officers and men of the 91st Philippine

Army Division.

On April 11, 1942, just two days after the surrender, this group was separated from their American colleagues and moved to the Pantingan River that crosses the Pilat-Bagac road. In his book "Bataan: The March of Death," American military historian Stanley Palk describes what took place after the separation: "The captives were formed into three groups and their wrists tied securely with double-strand telephone wire... At a given signal, the execution began. Japanese officers moved down the line from one end, mercilessly beheading the luckless Filipinos with their gleaming sabers. From the other end, Japanese enlisted men worked toward them, methodically plunging their bayonets into the backs of the prisoners. For two hours the grisly slaughter continued, the Japanese sweating at their work in the hot sun, pausing to wipe away the perspiration and then returning to their grim task..." When the slaughter was over, only a few prisoners remained alive buried beneath their slain comrades.

The massacre of Filipino officers and non-coms of the 91st Philippine Army Division remains a mystery of the Bataan saga that has never been fully explained. It was apparently aimed only at Filipinos. And yet, in our commemoration of Araw ng Kagitingan, there is hardly any mention of the event, Much of the national attention centers on the Death March. Painful as it may be, we must confront the fact that what took place was not the usual loss of life in battle—it was a case of

the cold-blooded mass murder of prisoners of war.

Have we ever identified who were these officers and men? There should be a roster somewhere of the men belonging to the division. Why were they singled out for execution? Have we dedicated a special portion of our commemorations to remember their memory? How often in world conflicts covered by the Geneva Convention have prisoners of war been treated in such an outrageous manner and then are forgotten by the nation they served? After the war, Homma was fried by an American tribunal for atrocitles committed by his troops during the Bataan Death March. Apparently, the mass murder at the Pantingan River was not among the charges made against him.

Each year our national leaders celebrate Araw ng Kagitingan with speeches about the heroism and valor of those who fought in Bataan. Let us also remember those who lost their lives, victims of inhuman

conduct by a savage enemy flushed with victory.



Yes, the award sided with much of the Philippines' arguments, among them its ruling that China's claim over much of the seas in the South China Sea (demarcated by the ambiguous nine-dash line) had no basis under the UN Convention on the Law of the Sea (UNCLOS).

What del Rosario and his pro-American boys posing as objective academics do not mention is the following ruling of the Permanent Court of Arbitration on the case:

"None of the high-tide features in the Spratly Islands, in their natural condition, are capable of sustaining human habitation or economic life of their own within the meaning of Article 121(3) of the Convention."

And Article 121(3) of the Convention categorizes such features as "rocks," as opposed to "islands."

Our Pag-Asa Island in the Kalayaan Island Group (KIG), as well as three other features that Marcos had called islands when he annexed the area in 1978 through his Presidential Decree1596, are all in the Spratly Islands, which therefore under the arbitral award are not islands but rocks.

Islands under UNCLOS are entitled to a 200-nautical mile exclusive economic zone (EEZ). Rocks do not have such a zone, and have only a 12-nautical mile territorial sea.

If there had been no such arbitration ruling, we could have argued that Pag-Asa is an island and therefore entitled to an EEZ. This would have extended our existing EEZ, which as of now is measured from baselines in Palawan, and ends near the KIG.

Talk of the law of unintended consequences. Or perhaps it was the consequence the LIS strategists wanted.


Aquino and del Rosario wanted to get the arbitral tribunal to rule that the seven features in the Spratly islands occupied by China were just rocks, and therefore could not have an exclusive economic zone, and could only have a 12- nautical mile territorial sea.

The tribunal agreed with them, which would therefore classify much of the vast area around the Spratlys as international waters. But contrary to their misinformation, the tribunal did not rule what country is the sovereign of any of the Spratly "rocks". That is beyond its authority of the UNCLOS.

China does not recognize the tribunal and its decision on the ground that it actually ruled on sovereign claims over land, which is beyond the law of the sea.

Still though, the award now gives the US much legal justification—which translates to favorable international public opinion—that its Seventh Fleet's increased patrols in the South China Sea, which often sail close to Chinese claims, are all within international waters. These are euphemistically called freedom of navigation operations (FONOPs), but are clearly messages that the US is still the military superpower in the region.

The recent swarm of Chinese fishing vessels near Pag-Asa, which President Duterte has protested over, could be the unintended result of the arbitration award.



tall Talping and Pag-Asa's EEZ (inside the circle) if they were islands.

It is not clear how far from Pag-Asa island the fishing vessels are, if they are within the 12 nautical miles that is the entitlement of a rock according to the arbitral award and within the Philippines' EEZ as measured from the Palawan baselines, in which case they are indeed violating Philippine territory.

However, if it was the Chinese government that was behind the fishermen, it might have positioned the vessels just outside Pag-Asa's 12-nautical mile entitlement and the Philippine EEZ, just to taunt the Philippines for filing the suit against China.

My suspicion that the arbitration was a brilliant US machination is bolstered by the fact that it devoted much discussion to its ruling that Taiping Island (Itu Aba), occupied by Taiwan is not an island but just a rock.

The award totally disregarded the reality that faiping is the biggest island in the Spratlys, and has been so developed over the decades that it is a garrison with an airport that can accommodate even C-130 planes, and a meteorological station.

"If Taiping were an island, it would have generated a 200-nautical mile EEZ, which would – if Pag-Asa also had an EEZ – cover a vast area that are not within the EEZs of the littoral states.

The US doesn't have a problem with Pag-Asa's EEZ given its influence over the Philippines. But what if Taiwan became part of the People's Republic of China, which would seem inevitable in the next 50 or even just 25 years?

In the most probable scenario, Taiwan's integration would be similar to Hong Kong's. This would mean that it would become an autonomous region with its independence intact except for one aspect: its foreign policy and external defense.

That would mean a huge part of the South China Sea within the PRC's control as its EFZ, and the US would have to get its permission for its Seventh Fleet to sail through.

The arbitration was a boon not to the Philippines but to the US, which after all planned and executed it. More on that in future columns.

Public agendas and private interests in ICC/South China Sea

In the contested ICC and South China Sea issue's, there are increasing concerns about public agendas fueled by private interests. The structures of Albert del Rosario's think-tank and its many bedfellows are a case in point.

IN February, the US-based Asia Maritime Transparency Initiative (AMTI) released a heavily promoted report alleging that China sought to intimidate Filipinos into ceasing construction work on the Pag-Asa Island (Thitu) in the South China Sea.

In March, former Foreign Affairs Secretary Albert del Rosario and former Ombudsman Conchita Carpio Morales filed a complaint before the International Criminal Court (ICC) against Chinese President Xi Jinping's South China Sea "plan" portrayed as a "crime against humanity." Perhaps, emboldened by the filing, the ICC, reportedly, also tries to pursue a case against the Philippine drug war.

Filed in the name of "Filipino fishermen," the complaint has been followed by rounds of alarmist media headlines, coupled with heavily touted AMTI reports about "Chinese militarization" of the South China Sea. Yet local fishermen are apprehensive about the filing and its timing since they do not feel harassed by the Chinese coast guards anymore, according to Philippine-based GMA News.

Nevertheless, media carousels have intensified after the visit of US Secretary State Mike Pompeo



and US "freedom of navigation" exercises, the debate about the review of the Philippine-US Mutual Defense Treaty, and the impending Philippine midterm elections.

Worse, the ICC filing is also linked with potential private gains behind the public agendas. Every think-tank is entitled to its voice, but neither AMTI nor del Rosario's think-tank are as "independent" as claimed – and the latter is haunted by allegations of perceived conflicts of interest, according to its Filipino critics.

Interest conflicts and energy reserves

Educated in the United States, del Rosario served as Philippine ambassador to the US in the 2000s and Secretary of Foreign Affairs in the Benigno Aquino 3rd government (2010-2016). His ties with the Aquino political dynasty go back to the presidency of Corazon Aquino (1986-1992), when he accompanied her on state visits to the US.

While del Rosatio is portrayed

as a diplomat, he is also a business executive. In the Aquino government, he was reportedly the wealthiest, with net worth almost \$14 million in 2013. Prior to government, his business career covered many industries, corporate chairmanships and directorships. These ties were officially suspended during his government activities + but not effectively.

In February 2010, Philippine government granted Forum Energy, the partner of Philex Mining, the right to explore oil and gas in Reed Bank. At the time, del Rosario served as director of Philex, which is led by Manuel V. Pangilingan, a wealthy businessman and the CEO of First Pacific Co., a Hong Kong-based investment firm which in the Philippines has major interests in telecom (PLDT), banking (Metro Pacific Investments) and

mining (Philex).

In February 2011, President Aquino appointed del Rosario as Acting Foreign Affairs Secretary Reportedly, he left the Philex board in March 2011, when he also stepped down from his post as non-executive director of First Pacific. In January 2013, the Philippine Department of Energy deferred to the Department of Foreign Affairs the decision to grant permits concerning the exploration and mining

activities at the Reed Bank "because the area was part of the disputed waters being claimed by China."

That gave del Rosario, as Secretary of Foreign Affairs, effective authority to influence concessions on Reed Bank.

Indeed, the friction in the South China Sea involves more than sovereign interests of several countries in the region. According to a 2013 report by the LIS Energy Information Administration, Reed Bank could hold up to 5.4 billion barrels of oil and 55.1 trillion cubic feet of natural gas.

So, Philex Mining and its associates, including del Rosario, could gain hugely from concession rights.

Bold dreams, cold realities

At the same time, the Philippines also filed the arbitration case against China in the Permanent Court of Arbitration (PCA) at The Hague. And in 2014, a year later, del Rosario and Aquino achieved the Enhanced Defense Cooperation Agreement (EDCA), which again opened the country to US military, ships and planes for the first time since 1991.

That's when efforts began to deepen US ties with del Rosario's think-tank, Stratbase (Albert del Rosario) Institute for Strategic

and International Studies (ADRI), which evolved in parallel with the Asian Maritime Transparency Initiative (AMTI), at the Center for Strategic and International Studies (CSIS), a major US thinktank close to State Department, Pentagon and Wall Street.

In May 2015, the CSIS/AMTI launched a three-year US-Philippines Strategic Initiative in Washington, with speeches by del Rosario, and William Cohen, former US defense secretary. It was supported by del Rosario's ADRi and the Philippine Trade Foundation (PTF), which is linked with the free-market Foundation for Economic Freedom (FEF) and partners with US Asia Foundation, Australia's Foreign Affairs Department, USAID, World Bank, and Grover Norquist's ultraconservative tax lobby.

The assumption was that Sen. Hillary Clinton would become the next US president and that the US-Philippine Strategic Initiative would promote "a greater sense of urgency" to deepen the bilateral trade and military partnership.

On Feb. 8, 2016, del Rosario, citing health reasons, announced he would resign as Secretary of Foreign Affairs. Then the 2016 Philippine election caused a meltdown in Aquino's Liberal Party, del Rosario's core constituency. While sustaining US ties, President Duterte began to recalibrate foreign policy for a better economic relationship with China, Clinton lost the presidency to Trump who buried Obama's TPP trade deal, while questioning US alliances - the twin cornerstones of del Rosario's bilateral initiative.

Think-tanks, governments and moneymakers

The fight was lost, but not the battle, del Rosario concluded. His health issues did not stop Pangilinan from re-appointing him as an independent non-executive

director of First Pacific in July 2016, just weeks before the release of the PCA arbitration decision. As his think-tank and its foreign associates intensified their activities, the boundaries between public agendas and private interests dissolved further, Indeed, these organizational links are so diffuse that they require a chart (see figure).

Del Rosario has long, historical business ties with Manuel Pangilingan, who is also the co-chair of del Rosario's think-tank. Due to public controversies about its water (Maynilad) and electric-power (Meralco) arms recently, Pangilingan's Metro Pacific has not avoided negative publicity. In turn, Philex and Pirst Pacific are linked with the Salim Group, which was created by Indonesia's richest businessman Sudono Salim, who made his fortune in the Sukarno and Suharto years.

Today, the Salim Group is led by his son Anthoni Salim whose net worth is \$5.3 billion. The Salims own 44 percent of First Pacific, which has assets of \$17.2 billion in six countries. In Philippines, these assets also include major stakes through PLDT in media, such as Philippine Star, Business World, TV5, Bloomberg Philippines and radio stations.

Through its board members and executives, del Rosario's ADRi is joined with its parent, Stratbase, an "advisory and research con-

sultancy" founded in 2004, and Bower Group Asia led by Ernest Z. Bower 4th. With equity and intelligence arms, Stratbase is the Philippine partner of Bower Group Asia. Between the mid-1980s and mid-2000s, Ernest Z. Bower led the US-Asean Business Council, which had been housed in the US Chamber of Commerce. He remains senior non-resident Southeast Asia advisor at CSIS, embedded with AMTI, and board member of del Rosario's think-tank.

Due to interlocking leaderships, Stratbase's head Victor Andres Manhit serves as ADRi's president, heads Bower Asia Group's Philippine branch and is a fellow at the FEF. Along with Pangilinan's mining interests, ADRi's trustees also include former president of Philippine Mines and the incumbent ICC judge Raul C. Pangalangan, a former publisher of Philippine Daily Inquirer. The latter paper has been critical of the Duterte government, and Pangalangan remains in the ICC, despite the Philippines' exit.

Public agendas and private interests

Here's how the process plays out in the media: In a typical sequence, the CSIS/AMTI releases a commentary and satellite photos of contested spots in the South China Sea, which leads to commentaries by ADRi's members,

which are then promoted in the Philippines, especially in the country's foreign-owned media, such as Rappler (linked with US-based North Base Media and billionaire Pierre Omidyar's network) and by media properties close to Pangilinan/del Rosario and their allies. Next, these articles are heavily headlined in international media, which republish the pieces or interview their authors as "independent". Filipino voices, even if they are ADRI's non-resident fellows and CSIS/AMTI authors in the US (e.g., Richard J. Heydarian).

Internationally, truly independent think-tanks shun interlocking directors and dual structures with private, particularly foreign interests, to ensure their integrity, Del Rosario's ADRi is very different, and that's its prerogative.

Unfortunately, the net effect is that it is not clear whether ADRi seeks to influence Philippine decision-makers, who promote Filipino interests, or their American counterparts, who push US interests – as evidenced by its tight cooperation with the AMTI that has been criticized for bias and alarmist hyping in the region.

The perceived private interests and potentially huge private gains of ADRi's co-chairs confound issues further, which is perhaps why del Rosario's toughest Filipino critics have compared his alleged conflicts of interest with those of former US Vice President Dick Cheney and Halliburton.

The comparison may be uncomfortable, but the substance of the argument is the same.

Oplan Sauron Part 2

N March 30, the police and military implemented Operation Sauron Part 2 in Negros Oriental, It became even bloodier than Part I last December, where six persons were killed by the police. This time around, 14 persons were killed in the antiinsurgency operation, with eight of the victims in Canlaon City, four in Manjuyod and two in Sta. Catalina. Two of the people killed in Manjuyod were incumbent barangay captains while majority of the rest were reported to be farmers and active members of local affiliates of the Kilusang Magbubukid ng Pilipinas.

The police and military defend Sauron 2's 36 search warrants as having been issued by Judge Soliver Peras of Cebu City's Regional Trial Court Branch 10 (Peras was also responsible for the more than 100 search warrants issued in connection with Sauron Part 1). Aside from the 14 persons shot dead by the police for allegedly resisting arrest, 16 were arrested, among them leaders of Gabriela, Anakpawis and Karapatan. Fifty-three assorted firearms and explosives were recovered, according to authorities.

Murder and massacre, claims Karapatan. The victims were farmers who were simply shot dead in their homes by the policemen. The police and military say that the targets of the search warrants were members or key supporters of the communist New People's Army (NPA) and that they were linked to liquidations and ambushes.

There are two issues here: first, the manner in which the search warrants were implemented; and second, the personalities of the targets of the operation.

Personally, I am convinced that the targets were indeed members of the NPA or supporters providing assistance vital for the NPA to operate and survive. The police and military were reportedly more careful this time compared to last. December (Sauron Part 1) where some targets were identified by questionable informants with dubious motives, and thus, mistakes were made.

The NPA has long had a presence in Canlaon City, NPA fighters withdraw to the city during military operations in the adjacent Guihulngan City—especially Brgy. Trinidad—and Moises Padilla. Trinidad, where more than 100 youths "celebrated" the Communist Party of the Philippines' 50th founding anniversary last December 18, shares boundaries with three barangays in Canlaon City.

On Oct. 13, 2018, the Leonardo Panaligan Command (LPC)-NPA Central Negros liquidated retired Army Master Sergeant Celso Pedochino in Canlaon City. Last month, the LPC murdered three persons in the abovementioned Brgy. Trinidad; and it claimed responsibility for the March 31 murder of Moises Padilla councilor Jolomar Hilario.



His "crime" was to allocate funds for military operations.

A day after, the Army's 62nd Infantry Battalion engaged a group of NPA fighters at Brgy. Quintin Remo. The encounter lasted more than an hour resulting in 1,740 local residents fleeling the town. The police, serving as a blocking force, arrested 11 suspected rebels—including two minors—at adjacent Brgy. Sebucawan, Isabela. Four of the 11 were subsequently identified as being allegedly involved in the murder of Hilario.

The Leonardo Panaligan Command is without doubt the most active and lethal of the five NPA commands operating on Negros Island. For an observer of the insurgency in Negros in general, and in Central Negros in particular, the March 30 operation in Canlaon City, the encounter in Moises Padilla and the arrest of the 11 in Isabela tögether put pressure on the NPA in Central Negros. This is a welcome development. The police and the army must continue this offensive until the enemy has been at least significantly crippled.

Of course, committing injustice in the name of ending insurgency is wrong and unwise, Did the police execute the 14 or were proper procedures observed? Did they plant the firearms? Unfortunately, the police have only themselves to thank if the public doesn't believe that the victims shot it out with the team that served the warrants. The police in Central Visayas routinely violate rules of engagement and the rule of law, and then spin strange stories to cover up. The accidental killing of four-year-old Skyler Abatayo, the failed attempt to kill Tejeto (Cebu City) Kagawad Jessielou Cadungog, the mysterious death of police officer Roderick Balili, the murder of Guihulngan City Deputy Chief of Police Porferio Gabuya, and the killing of Jesus Isugan, an innocent man, are examples of how the police deliberately misinform the public.

Unfortunately for the 14 killed and 16 arrested in Negros Oriental last March 30, Karapatan is as untrustworthy, if not more, than the police. For years the organization has been covering up for the NPA. The mere presence of Karapatan is proof that the targets of the March 30 operations belonged to the CPP-NPA united front, even if they may not have been communists or armed combatants. It would actually have helped the cause of the killed and arrested persons if Karapatan had stayed away and a credible party with a true concern for human rights had taken the lead.

Warning China



IN A rare show of exasperation, President Rodrigo Duterte warned China not to push its boundaries past Pagasa. It was the first time the Philippine president used strong language in asserting the country's territorial sovereignty against an aggressive China.

The stakes are too high.

The presidential outburst was triggered by reports of a fleet of Chinese warships near Pagasa known also as Scarborough Shoal. Filipino fishermen earlier reported the Chinese gunboat and complained that they were being prevented to fish in waters well within the 200-mile Philippine exclusive economic zone mandated under the United Nations Convention on the Law of the Sea.

But China—which considers itself outside the UNCLOS accord including The Hague arbitration tribunal that ruled against its sweeping claim of nearly the entire South China Sea—continues to militarize the region.

The stakes in the South China Sea are the enormous oil, gas and mineral resources under the seabed which China needs to achieve its agenda to rise as a superpower and surpass the United States.

President Duterte meanwhile has alarmed the populace with his recent statement he would "suspend the privi-

lege of the writ of habeas corpus and declare a revolutionary war until the end of my term in 2022."

The president's threat drew a reaction from lawyer Bgon Cayosa of the Integrated Bar of the Philippines. The IBP official said Mr. Dutere as president can suspend the writ of habeas corpus, but only for 60 days and if there is rebellion or foreign invasion. This was according to the Constitution, Cayosa said. He also pointed out that President Duterte said "revolutionary war," not revolutionary government, adding that if it's the latter, then he would have to resign with Vice President Leni Robredo taking over in the order of succession when the head of state resigns due to health incapacity, death or inability to govern.

Cory Aquino declared a revolutionary government because she was not elected president but was swept to the presidency as an aftermath of the EDSA People Power uprising on Feb. 22, 1986.

President Duterte's outburst was brought about by his own words that he has enough problems with critics adding to his woes. These problems include the proliferation of illegal despite his bloody campaign against it, the P5 billion in damaged agricultural crops because of El Niño which also resulted in water shortage in Metro Manila, the monstrous traffic and now the adverse public opinion against his close ties with China despite its agressive action in the West Philippine Sea.

But he sought the presidency and won it so he must deal with the problems that come with it and not show his breaking point.



Army says it favored revival of ROTC to instill discipline among the youth

Army spokesman Lt. Col. Ramon Zagala Sunday reiterated that the military was calling for the revival of the Reserve Officers' Training Corps (ROTC) to help instill discipline among the youth and not just to prepare for threats both inside and outside the country.

In an interview over radio station DZBB, Zagala said one good reason that they want the ROTC revived was to make the youth to be more productive members of society.

"Instead na ma-recruit sila dito sa rebel movement at be destructive, let's just be productive," Zagala said.

(Instead of being recruited by the rebel movemeng and be destructive, lets just be productive).



Zagala cited the case University of the Philippines Los Baños (UPLB) student John Carlo Capistrano Alberto, who was killed in an encounter against government troops in Sitio Pinamintian, Barangay San Buenaventura, Luisiana, Laguna.

A number of students, who joined the NPA have also been killed in previous encounters with the Armed Forces of the Philippines (AFP) after being lured to join the Communist movement, including UP Manila student Josephine Lapira of Gabriela who died in an encounter in Batangas in November 2017.

"There a lot of documented instances wherein students were killed in an encounter. So madami pa tayong mga isntances na ganito [So there are more instances similar to these]," Zagala said.

Zagala said unlike countries such as South Korea, Singapore and Israel, which have mandatory military service because they have active threats all the time, what the AFP wants is to revive the ROTC to also instill leadership and nationalism among the youth of today.

"Magaling talaga ang mga kabataan natin ngayon so very reliable sila, pwede mo silang ma shape to whatever they want to be, whoever wants to help. Kaya ROTC ang gusto namin kasi ang main role ng ROTC talaga is selfless service, patroitism, etc," Zagala said.

(Our youth of today is good, so very reliable, they can be shape to whatever they want to be, whoever wants to help. The reason we want ROTC because its main role is selfless service, patriotism, etc.)

"Kung mabalik natin ang ROTC first of all is to instill discipline, kasi madami sa atin hindi na disiplano eh, simple following of traffic rules, wala nang sumunod, kanya kanya na tayong ginawa. So we want the ROTC program to help in doing all these things. Gusto rin nating magkaroon ng leadership..Hindi naman ibig sabihin na matuto ka ng leadership sa ROTC hindi mo na magagamit sa labas iyan," he added.

"If ROTC is revive first of all is to instill discipline because a lot are no longer disciplined. even traffic rules are not followed, doing our own things. So we want the ROTC program to help in doing all these things. So we want to have leadership, Is doesn't mean you learn leadership from ROTC you cannot use it outside).

The Department of National Defense (DND) and the Armed Forces of the Philippines (AFP) earlier expressed optimism that the proposed revival of the Reserve Officers' Training Corps (ROTC) would be passed and enacted into law in the current 17th Congress.

DND Undersecretary Cesar B. Yano said the purpose of the reimposition of the ROTC in Grades 11 and 12 (senior high school) levels, no longer in college, will be values and character formation, not much on military affairs.

Yano said that the idea of reimposing the mandatory ROTC training came from the President himself in his first State of the Nation Address (SONA) in July 2016.

The President, Yano said, wanted to strengthen the ROTC that would instill love of country and good citizenship among the youth.

Time's up for your fake advocacy, AFP exec tells Karapatan

MANILA -- Foreign non-government organizations (NGOs) will no longer believe in the fake advocacy being promoted by Karapatan once military proves to the world that the group is a front organization of the communist movement, an army official said Sunday.

Armed Forces of the Philippines (AFP) Deputy Chief-of-Staff for Civil-Military Operations, Major Gen. Antonio Parlade Jr., made this comment after opposition lawmakers in the Makabayan bloc urged him to stop red-tagging the group for lack of proof on these allegations.

Bayan Muna Rep. Carlos Zarate earlier claimed Parlade was "doing a disservice to Filipinos" by believing that "progressive people's organizations" such as Karapatan launched a fake human rights advocacy to collect donations from European countries.

Parlade shot back at the Makabayan bloc, insisting the latter was the one which made a disservice to Filipinos by exaggerating figures on people killed during the drug from war from police data which showed only 5,000 deaths to 27,000 deaths only to get more funding from foreign organizations.

"You know you have to paint any sitting government as oppressive, a tyrant, and that there exist in the Philippines a consistent pattern of gross, flagrant, or mass violations of human rights' so that you can continue to ask for donations from Europe, America, Australia, elsewhere for your fake advocacies, through well-meaning govts and foreign NGOs," Parlade said.

"Philippines is safe, its only you who are hyping that scary picture which in turn sends investors and tourists away. Now that's disservice to your fellowmen. That's what progressive" people do - send progress and development away?" he added.

Public debate

Parlade shrugged off Zarate's comment and challenged the Makabayan bloc to a televised public debate to prove that the group is a front organization of the Communist Party of the Philippines (CPP).

"Makabayan, take the challenge. See who are propagandizing. Lets see who is on the side of truth? Monday, choose your TV station," Parlade said in a statement.

"Bakit kami mapapahiya (Why would we be put to shame)? For what? For telling the people the truth?" he added.



Parlade said he has long challenged groups like Karaptan to a public debate but they never accepted his dare.

"Yan nga hamon, matagal na. I challenged Karapatan tumahimik. I challenged Ibon wala din (That has long been my challenge. I challenged Karpatan, they were quiet. I challenged Ibon, no response from them)," he said.

"We will show the world proof, as we have shown EU and Belgium. Lets see who has red tagged who. Its not me. Not us," he added.

'Red-tagging never a crime'

Meanwhile, a former CPP leader who requested anonymity, said he found nothing wrong with AFP's efforts to determine which groups were CPP front organizations.

"Persistently exposing the duplicity and profound hypocrisy of these open and above ground CPP-led organizations and alliance network like BAYAN, BAYAN MUNA, KMU, ACT, NUPL, IBON, LFS, GABRIELA, etc., is not an act of red tagging nor a disservice to the Filipino people," the former CPP leader said.

In fact, he said, it is the obligation of the AFP to expose tactics of the CPP to deceive and manipulate foreign NGOs to the broader public.

"Besides, red tagging is never a crime; it is just a lame excuse and desperate refuge of CPP-NPA-NDF cadres and operators who are utilizing the available democratic space and legal maneuvers for them to continue with their cowardly subversion of legitimate government authority and state instruments," he said.

The former CPP member tagged the Makabayan bloc as "pathological liars" who are deeply wounded by Parlade's head-on approach to expose them.

"They are deeply wounded by the head-on approach of Maj. Gen Antonio Parlade, the reason that these pathological liars styling themselves as communists parrots are now whining like cry babies," he said.

"They deserve such straightforward head-on counter narratives which is long overdue for the government to have been executed as a matter of its moral obligation to the people," he added.

Last month, a Philippine delegation, in a series of engagements with officials of Belgium and EU in Brussels last month, presented to them findings that their governments have been funding front organizations masquerading as NGOs and human rights defenders.

Parlade has repeatedly insisted that Karapatan has always been a supporter of the CPP and urged them to prove him wrong.

The CPP-NPA is listed as a terrorist organization by the Unites States and EU. (PNA)
