

More senatorial aspirants have received warning from the Commission on Elections (Comelec) supposedly for using unlawful campaign materials.

In her Twitter account @commrguanzon, Comelec Commissioner Rowena Guanzon said six more names were added to the original list of 34 senatorial candidates with illegal posters and campaign materi-

als. There are 62 running for senator in the May elections.

"Thirty-four plus six senatorial candidates have illegal posters, as of yesterday," she said.
Ordered to remove their unlawful

campaign materials were Freddie Aguilar, Ibrahim Albani, Gary Alejano, Richard Alfajora, Raffy Alunan, Sonny Angara, Bam Aquino, Ernesto Arellano, Marcelino Arias, Bernard Austria, Nancy Binay, Edmundo Casiño, Pia Cayetano, Glenn Chong, Neri Colmenares, Chel Diokno, JV Ejercito, Jinggoy Estrada, Larry Gadon and Conrado Generoso.

The others were Florin Hilbay,

"where Comelec got information of any violation committed in relation to posting of propaganda campaign mate-

rials."
"As early as Feb. 11, I have already advised all my supporters thru my radio interviews that if they have posted any propaganda materials for me in any area not allowed by law to please remove the same immediately on or before Feb. 11," he maintained.

At a forum, Comelec spokesman James Jimenez said candidates found violating the campaign rules would be given the chance to comply.
"We are just informing them

of our guidelines and are giving them warnings to comply.

He also called on all government agencies and public schools not to invite candidates in the May 13 polls to be their

guest speakers.

"If it's private, that's OK. But for those in government, my advice is to avoid it. While there is no prohibition on that act specifically, we need to avoid appearance of impropriety," he said.

Itmenez noted that having cardidates as guest speakers could be percented as partisan political activity.

After their receipt of the notices, they need to take actions immediately," he said.

"We've been complying on campaign posters but 'unscrupulous people' also put them up," Angara said.

Sen. Aquilino Pimentel III said he was surprised by the inclusion of his name in the list of alleged violators.

"I have very few posters. Hence, (that's) most unlikely," Pimentel told reporters.

"We have many supporters, hence, we have not memorized all locations of posters they have put up... Comelec should tell us where," Pimentel said.

'Offensive'

Sen. Nancy Binay said she was surprised and offended by the report of the Comelec.

"I find it very offensive that I'm being tagged as a violator (of) campaign materials. Why's that? When candidates whose

faces are plastered all over the country are not in the list,

Binay said.

"I find the Comelec's list highly questionable. In fact, I have no tarpaulins, I only have one billboard-and I've not ordered one-but I've requested the one who put upers were so they can be verified the billboard to remove it," she said.

She explained she was among the first to appeal in social media to her fellow candidates "for them to take down posters that don't conform with the allowed sizes.

She said she plans to request Guanzon to conduct a full information drive with regard to campaign "do's and don'ts." The Comelec, she said, should come up with a list/directory of designated common poster areas in every barangay, mu-

nicipality, and city as reference and guide for political parties,

candidates and their supporters, Legal Network for Truthful Elections executive director Rona Caritos, meanwhile, lauded the Comelec for its "aggressive" action against illegal posters and campaign materials.

"We are happy over the pro-active accountability mechanism of the Comelec... We are happy with this move - due process is observed and they get the side of candidates," she said:

But Comelec, she stressed, should be impattfal in enforc-

ing rules.

They should not be biased. Don't look at partylines or color of the candidates. Otherwise, the credibility of the Comelec will be affected," she added. - With Paolo Romero

President Duterte says he did not endorse the candidacies of former Senators Estrada and Revilla because he had already finalized his list when they sought his support.

President Duterte said he did not endorse the candidacy of former Sen. Jinggoy Estrada and two other proadministration senatorial aspirants because it was already "too late" when they sought his backing.

Estrada, former Sen. Bong Revilla and former TV journalist Jiggy Manicad were absent at the proclamation rally of the administration, party Partido Demokratiko Pilipino-Lakas ng Bayan (PDP-Laban) on Thursday in the City of San Jose del Monté, Bulaçan province, where the names of only 11 administration senatorial candidates were announced.

"They gave me the signal too late," Mr. Duterte told reporters after the rally. "Actually, almost a year ago I was already forming the ticket. But I just played dumb. I really didn't tell."

'Good track record'

In a statement, Estrada said he respected the decision of the administration party "regarding their preferred senatorial bets."

"With or without the en-

dorsement of the President," he said, "I will continue to be an ally of this administration. My support to this administration is not diminished in any way,"

He said the endorsement of "our popular President" would liave been helpful, but he trusted Pilipinos to reelect him "based on my good track record as a public servant, long list of legislative accomplishments and genuine desire to uplift the lives of the masses."

Estrada and Revilla were charged with graft and plunder in connection with the Pio-billion pork barrel scam masterminded by businesswoman Janet Lim-Napoles.

Revilla was acquitted last year but Estrada is still facing trial and is out on bail.

The President's act of raising Estrada's hand, the standard display of endorsing a candidate, at an event in Albay last week was intended to show "courtesy"

and to avoid putting the former senator in an awkward situation, according to presidential spokesperson Salvador Panelo.

"From what I know [of] the President's character, he does not embarrass people, especially women. As he explained, it was just, courtesy to him," Panelo sald at a press briefing on Friday.

Estrada, Revilla and Manicad, however, are included in the bloated Senate slate supported by Hugpong ng Pagbabago (HNP), the regional party established by the President's daughter, Davao City Mayor Sara Duterte.

Mr. Duterte, national chair of PDP-Laban, said he respected HNP's choice of 13 candidates.

Own preferences

"For my part, I had my own preferences," the President said. "The problem is that Inday, she's a politician and I am also. So we camot agree on all, especially on all of the personalities there."

PDP-Laban's senatorial candidates are its party president, reelectionist. Sen. Koko Pimentel, former presidential political adviser Francis Tolentino, former Bureau of Corrections Director General Ronald dela Rosa, Maguindanao Rep. Zajid Mangudadatu and former Special Assistant to the President Bong Go.

Decision 'understandable'

The ruling party's guest candidates are reelectionist Senators Cynthia Villar, Sonny Angara and JV Bjercito, Taguig Rep. Pia Cayetano, Ilocos Norte Gov. Imee Marcos and singer Freddie Aguilar.

Agullar was included in the lineup because of Mr. Duterte's utang na loob (debt of gratitude), according to Go.

Speaking to reporters at an HNP rally in Bagulo City on Friday, Duterte said her father's decision on Estrada was "understandable."

"My father is close to many people and he has other candidates in mind," she said.

Island villägers fear getting caught up in mining dispute

GUIVAN. Eastern Samar - The festdents of Homonton are alarmed by the growing presence of policomen, army and armed civilians on the Island as a dispute between two mining companies began to escalate.

Tension began to build up on the island after a liquidation order was issued by Judge Phz Cortes of Regional Trial Court Branch 271 in Taguig City against Technon Resources Inc. (TRI) a corporation engaged in mining chromite and other minerals on Homonhon

The iquidation order was issued after the court upheld the polition of former mining operator and mineral production sharing agreement holder, Cambayas Mining Corporation (CMC), alleging that Techiron was not complying with the profit snaring agreement. Techron argued that it has gained no profits despite the multi-million investments and short span of operation.

Techiron started operations in Decentber 2015 on a 1,500-licciare site.

CMC insisted on implementing the order without a sheriff. A contingent from CMC went to the mining site accompanied by over 50 policemen from the Regional Mobile Force Battallon, ath Regional Public Safety Battallon and Guluan Police.

"We are here to protect our property, we will take over the place," CMC

The President said he could easily recruit new policemen to replace dismissed cops who defy his order against drinking in public places.

"No drinking for police in public. That's an order. You violate it, I will dismiss you. Hindi lang suspend. I'll dismiss you," he said during the proclamation rally of the administration

party's senatorial ticket in Bulacan.

In prohibiting cops from drinking liquor in public, Duterte explained that he wanted to avoid incidents where unformed personnel get into a drunken fight and put lives in danger.

If the cops wanted to enjoy a drinking session, they better go home instead, according to the President.

"Minsan Army, pulis, mag-abot diyan sa sing-along, karaokehan. Kapag maabutan nila ang Army nagkakanta ayaw nang bitawan, 'My way..." Tapos ito namang mga buang na pulis suplado. 'Hoy, t*** i** mo kayabang mo diyan.' Maya-maya barilan na (When

soldiers and cops meet at a sing-along or karaoke bar, if the Army keeps on singing 'My Way' and the snooty cops heckle them for being arrogant, a shootout ensues)," he added.

"Kaya kayo mag-inuman doon, uwi kayo sa bahay ninyo (So if you want to drink, go home)," he said.

Duterte insisted that he would not tolerate erring cops and instead offer their jobs to other Filipinos looking for employment.

"Sobra-sobra ang Pilipino. Marami diyan naghihintay lang ng opportunity. Huwag mo akong patiisin sa iyo. L**** Bakit ako magliis? Eh'di maghahanap

ako (There are many Filipinos waiting for the opportunity. I won't bear with you. Why would I suffer? I'd look for someone else)," he said.

Last January, the President announced that policemen and soldiers were no longer allowed to drink in public to curb drunken and violent behavior.

Interior and Local Government Secretary Eduardo Anolater cautioned that cops seen drinking in bars and other public places could face administrative raps such as dereliction of duty, insubordination and gross neglect of duty. 16 February 2019

Hugpong bets stump in Pampanga

They then proceeded to Floridablanca and where they were joined by Senator Cynthia Villar and former Presidential special assistant Christopher Go and welcomed by some 10,000 supporters.

They also attended jam-packed sorties in Arroyo's hometown in Lubao.

HNP candidates were scheduled to go next to Sasmuan, Guagua and Sta. Rita.

Arroyo has vowed to give the HNP senatorial candidates her all-out support.

HNP led by its founder and chairman Davao City Mayor Sara Duterte, kicked off its senatorial campaign on Tuesday in Pampanga because it is where President Duterte received the most number of votes outside of his own bailiwick, Davao.

Meanwhile, six of the candidates wooed voters in the north, making a stop in Baguio

City.

Duterte led the caravan along with the party's senatorial bets-re-electionist Senators Edgardo Angara and JV Pjercito, former senator Jinggoy Estrada, former Philippine National Police chief Ronald dela Rosa, Maguindanao Rep. Zajid Mangudadatu and former reporter Jiggy Manicad.

The mayor said they do not intend to join the alumni homecoming of the Philippine Military Academy as they had

a rally Saturday in La Union.

The Armed Forces of the Philippines has barred PMA alumni, including honorary class members, from "engaging in political campaigning" during their annual homecoming this weekend at Fort del Pllar.

Dela Rosa belongs to PMA Class 1986.
On the other hand, re-electionists
Senators Grace Poe (Independent) and Paolo Benigno Aquino IV (Liberal Party) will be at the Lipa Love Fest Free Valentine Concert to be held today at the nBIR compound (Olan's Place), Barangay Marawoy, Lipa City, Balangas

The event was organized by Senate President Pro Tempore Ralph Recto together with Team Bangon Poe remained the top senatorial candidate in the 2019 midterm elections, the latest Pulse Asia

revealed on Friday.

Last month, Pulse Asia interviewed 1,800 respondents nationwide on their

preferences for senator.

Poe remains at the top with an overall voter preference of 74.9 percent for a statistical ranking of solo first place.

President Rodrigo Duterte-backed re-

electionist Villar came in second with 60.5 percent voter preference.

Taguig City Rep. Pia Cayetano and former senator Lito Lapid shared the third to sixth spot in the overall ranking places with 53.3 percent and 53.0 percent voter preferences. respectively.

Both re-electionist senators Ma. Lourdes Nancy Binay, with 50.1 percent voter preference, and Angara, 48.8 percent, were ranked third to seventh and third to ninth places, respectively.

The ruling party PDP-Laban senatorial bet Senator Aquilino Pimentel III ranked 5th to 11th places with 45.5 voter preference while Duterte's former top nide Christopher Go entered the 6th to 12th spot with 44.7 voter preferences.

Estrada, who faces plunder and graft cases, ranked 6th to 12th spot with 44.3 percent.

The Liberal Party's former senator Manuel Roxas II, with 41.8 percent,

ranked 7th to 14th places.

Ilocos Norte Gov. Imee Marcos, at 41.2 percent, ranked 7th to 15th places, former senator Bong Revilla, Jr., 40.2 percent, ranked 8th to 15th places, and re-electionist Senator Paolo Benigno Aquino IV, at 38.5 percent, ranked 10th to 15th places.

Completing the top 15 list were former senator Sergio Osmeña III, 37.7 percent, at 10th to 15th places, and former Bureau of Corrections chief Ronald Dela Rosa, 36,9 percent, at 11th to 16th places.

Only 3.4 percent of the respondents were undecided about who they would vote for as senator, while 1.1 percent fefused to identify their preferred candidates, Another 1.1 percent said they were not included to vote for any candidate for the post.

The survey, conducted from Jan. 26 to 31, used face-to-face interviews of 1,800 Filipino adults nationwide. It has a + 2.3% error margin at the 95% confidence level.

Subnational estimates for the geographic areas covered in the survey have the following error margins at 95% confidence level: +6,5% for Metro Manila, +3.5% for the rest of Luzon, +5.3% for the Visayas and +4.7% for Mindanao.

Seven out of the U Duterte-endorsed senatorial candidates were able to make

it in the Top 15.

Administration-backed senatorial bets who didn't make it in the list were Maguindanao Rep. Zajid Mangudadatu, former political adviser Francis Tolentino, re-electionist Senator JV Ejercito, and folk singer Freddie Aquilar.

'Lend a wife' a hyperbole, Palace defends Rody vs Tatad

PRESIDENT Rodrigo Duterte's challenge of virility to former Senator Francisco Tatad was just hyperbole, the Palace said Friday, adding Duterte was "only making fun" of the columnist for proliferating "false news."

As usual, Presidential Spokesman Salvador Panelo again defended Dutorte's remark, saying he was only "dramatizing" things when he asked Tatad to "lend" his

In his speech in San Jose Del Monte, Bulacan, on Thursday night, Duterte slammed Tatad for allegedly spreading rumors about his "deteriorating" health.

'The former Senator recently wrote in a newspaper column that Duterte underwent a "successful" kidney transplant at the Cardinal Santos Medical Center in San Juan. The transplant, he said, was conducted on len 29.

But Duterte allegedly had attended the premiere of the biopic of former Bureau of Corrections chief Ronald "Bato" Dela Rosa that day.

"Hey. Tatud, you know there's a border between press freedom and disrespecting a person. If I see you, avoid me. F*** you, I will slap you. Believe if, I will slap you in front of many people." Duterte said as he led the initial campaign rally of the ruling PDP-Laban party.

He said Tated had violated press freedom by publishing a "disrespectful" column about his health. The 73-year-old President then dared the 79-year-old columnist to prove his manhood.

"You really want to try if we still have it or not? Do you have a wife? Lend it to me... Maybe let's do it here. It'll be fine: it's just 10 minutes." he said.

Panelo then added Duterte's remark to his long examples of "figurative speech."

"Well, that's just hyperbole. That's just to dramatize that he's still virile at his age. He's pissed off with false news," Panelo told reporters.

"People have been used to this Presignent. Hyperbole, He uses certain situations and makes fun of it, makes fun of the and makes fun of others; it's just for fun."

It was not the first time that Tatad targeted the President's state of health in his column.

In 2017 he said Duterte traveled to China to assess his health condition with the doctors of the Fuda Cancer Hospital in Guangzhon.

The President then said he went to China to be circumcised.

Since then, Duterte has called Tatad an "idiot" for using his column to redeem himself from the negative views about his role during Martial Law.

In 1969, the late strongman Ferdinand Marcos appointed Tatad as Minister of Public Information. He gained prominence when he went on air on Sept. 23, 1972, when he announced Proclamation 1081 in which Marcos declared martial law.

a United Nations body of a stronger legal framework and institutional mechanisms to address the matter.

The mission also included officials from the Departments of Foreign Affairs (DFA), National Defense (DND), Justice (DoJ) and Armed Forces of the Philippines (AFP).

"The delegation, at the same time, expressed concern over false information submitted to the working group, including some cases which were not supported by facts and were reported without obtaining the required consent from the families of victims," the DFA said.

Reds purge to blame

Brig. Gen. Antonio Parlade, AFP assistant deputy chief of staff for operations, presented information indicating that many of the cases took place at the height of the internal purging by the Communist Party of the Philippines and its armed wing, the New People's Army.

During the initial meeting, Catura formally moved for the delisting of the 625 cases.

He also gave assurances that the government, under President Duterte, has put in place a strong legal framework and institutional mechanism to address the issue.

NPA frees 6 militias, kills 2 soldiers in raid

2AMBOANGA CITY: Communist insurgents freed six out of over a dozen soldiers and militias they captured in southern Philippines, and, at the same time, raided a military post and killing two soldiers and wounding another in the restive region.

Army Lt. Col. Ezra Balagtey, spokesman for the Eastern Mindanao Command, said that in a ceremony held on Thursday in the hinterlands of Barangay San Juan Bayugan City, Agusan del Sur, New People's Army (NPA) rebels released militias Jurian Gaviola, Marson and Hermito Iligan, Bienvinido Lamion, Eddie Tindoy and Sanny Malobay, but seven other militias and two soldiers remain captive in the province.

The six militiamen were captured after their detachment was attacked and overtaken by the NPA last December 9 in Barangay New Tubigon, Sibagat town.

Balagtey said the rebels released the militias to a third party facilitator, including the International Committee of the Red Cross, and handed them over to the 401st Infantry Brigade, also in the town. "The release was brought about by the pressure of the relentless military operations to rescue the kidnapped troops," he said.

Balagtey said despite the release of the hostages, rescue operation would still continue in the province. He said Maj. Gen. Felimon Santos Ir., the regional military commander, ordered the operation. "As of this time, our units in

the area are continuously conducting military operations to rescue the remaining troops who are still being held and used as human shield and propaganda subject by the NPA," Balagtey said.

This was confirmed by Santos, who also branded the release as rebel propaganda, "We assure our communities that this will not affect our effort and commitment in protecting our people," he said.

A rebel spokesman, Ka Malem Mabini, said NPA fighters also raided late Thursday a patrol base of the 1st Special Forces-Civilian Active Auxiliary in Dalwangan Village in Bukidnon's Malaybalay City, and killed two soldiers and wounded another.

Mabini said rebel forces also seized seven assorted automatic rifles from soldiers, "in this military action, it was confirmed that two officers of the Special Forces were killed, while one soldier was also wounded. The Red armies also seized seven different high-powered rifles from the soldiers," he said.

Balagtey confirmed the fighting and said four rebels were reportedly slain in the clash. He said about 30 rebels attacked the patrol base, sparking a firefight.

He said an 11-man army team was constructing a patrol base in the village when rebels assaulted the soldiers, who fought the attackers and eventually fled, leaving behind two automatic rifles and two landmines. ALJACINTO AND

6 gov't auxiliary hostage released

SIX government auxiliary men who were taken hostage by terrorist NPA's who raided a military patrol base were freed after 75 days of captivity even as four NPA rebels and two army soldiers were killed in a renewed fighting preceding a raid by local insurgents at a construction site of a military detachment in Bukidnon.

The six Civilian Active Auxillary were part of the 15 government troops (two soldiers and 13 CAAs) manning the Tubigon Patrol Base in Sibagat, Agusan del Sur who were kidnapped by the NPA rebels during a raid on December 1 last year.

Maj. Gen. Felimon Santos Jr., commander of the Eastern Mindanao Command, said the NPA captors of the six CAAs were forced to released their captives in the midst of exhaustion and on the run from pursuing security forces in Caraga region,

Santos identified the freed CAAs as Jurian Gaviola, Marson Iligan, Bienvenido Lamion. Eddie Tindoy, Sanny Malobay and Hermito Iligan.

The civilians volunteers were reportedly released at the vicinity of Barrage San Juan, Bayugan City, Agusan del Sur at about 6:07 p.m. on Valentine's Day.

Santos said the release was facilitated by a third party—the erstwhile hostages subsequently turned over to the the 401st Brigade at Purok 12-A, Poblacion, Sibagat, Agusan del Sur.

Santos said military units were continuously conducting operations to rescue the remaining troops who were still being held hostage and used as human shield and propaganda by the NPAs.

Meanwhile, four New People's Army rebels and two army soldiers were killed during a clash preceding a raid by the terrorist group at a construction site of a patrol base at the outskirts of Malaybalay City, Bukidnon Thursday night.

Capt. Rhyan Delgado Layug of the 403rd Brigade sald a platoon of soldlers was constructing a patrol base in in Sitlo Green Valley, Dalwagan, Malaybalay City when some 30 armed NPAs struck at them.

Layug reported that the team of army troopers was surprised and overwhelmed by the attacking NPA rebels resulting to the death of two soldiers.

However, the soldiers managed to retaliate against the rebels forcing them to scamper and flee, dragging with them their four dead comrades.

Layug said the NPA rebel band had admitted in a radio communication intercepted by the military that they indeed lost four men.

He said what Tatad published was a violation of press freedom. The opinion piece was published in *The Manila Times* this week.

"This Tatad, you Tatad. You know, there is a border between press freedom and disrespecting people. If I see you, get out of my way. You son of a b***h, I will slap you. Believe me, I will slap you in front of a lot of people," Duterte said.

"You son of a b***h, if I see you, guard yourself. That is really a violation of press freedom. But

this is not... your joke, it was disrespectful," he added.

Duterte did not stop there, even going to the extent of asking Tatad to let him "borrow" he former senator's wife as he questioned Tatad's virility.

He said that this was so because he kept disrespecting people.

"You really want to test if we really have [it]? You have a wife. You lend her to me, you son of a b***h," Duterte added.

In a news briefing on Friday, Palace spokesman Salvador Panelo sald Duterie's lewd statement was merely a "hyperbole" and was meant to just dramatize.

The spokesman then asked Tatad to verify his stories first before publishing them in his column.

In the piece published in *The Manila Times* last February 11, Tatad quoted two sources who said a team led by Dr. Rose Marie Rosete Liquete, the nation's first woman

kidney transplant doctor and executive director of the National Kidney and Transplant Institute, performed the procedure.

The two sources, however, differed in details, with one saying the operation was held at Cardinal Santos Medical Center in San Juan, while the other said the same doctor performed the same procedure in Davao.

DEMOLITION OF BUILDINGS AT MARAWI'S GROUND ZERO STARTS

MARAWI CITY—Demolition and clearing of structures heavily damaged by the five-month war in 2017 between government forces and the Islamic State-inspired Maute group here began on Thursday, signalling the start of the rebuilding of Marawi, an official of the National Housing Authority (NHA) said,

Ikmat Bantuas, NHA field engineer, assured property owners that CJI General Services, a Batangas provincebased contractor which won the contract to clear Sectors 2 to 9 of the city's ground zero, or the area where heavy fighting was centered, would only demolish structures that were allowed by their owners to be dismantled.

Mayor's property

Among the first to be demolished was a building owned by Marawi City Mayor Majul Gandamra on Osmeña Street at Barangay Sangkay. Gandamra's property, located inside Sector 5, was one of 409 structures whose owners consented to the demolition, Bantuas sald.

"We want to show residents that we are doing it in a proper manner," he said. "We follow the guidelines. Pirst, the property owner had to be there. Second, all concerned agencies should have signed the demolition permit."

But Bantuas warned that the crew would no longer return to clear structures whose owners had refused to give their consent.

"If they refused to demolish their structures now but decided to change their minds later, then we would no longer come back," he said.

The demolition and debris

clearing within Sector 1 of the city's ground zero was stopped in December last year after its contractor falled to secure a demolition permit from the local government, and an environmental compliance certificate from the Department of Bnvironment, and Natural Resources,

Negotiations

A total of 6,800 structures, classified as nonhabitable, hazardous and heavily damaged, still stand inside the 250-hectare ground zero, according to the NHA.

The Inter-Agency Committee on Debris Clearing, composed of the Department of Public Works and Highways, Bureau of Fire Protection and the Department of Health, will determine which of these remaining structures are still habitable, hazardous and need to be demolished.

Bantuas, however, said the NHA would negotiate with landowners if their structures needed to be cleared to give way to government projects, like road widening or the construction of public facilities.

"We'll find ways to get their

consent," he said.

Bantuas said some property owners were reluctant to give their consent because they thought they might lose portions of their properties once their structures were demolished.

The Task Force Bangon Marawi, however, assured this would not happen. "We will document everything. We want to show them their properties will be restored, nothing more, nothing less," he said.

Edsel Alan Manigbas, deputy project manager of CJI, said the firm was given eight months to finish the demolition. INQ

Pincy among & arrested in Malaysia for terror links

KUALA LUMPUR - Malaysian authorities said yesterday they have arrested six people, including four foreigners, suspected of planning attacks or being members of militant groups.

Malaysia has been on high alert since gummen allied with the Islamic State (IS) carried out a series of attacks in Jakarta, the capital of neighboring Indonesia, in January 2016.

Police said the six were arrested in five separate raids between December and January, on suspicion of planning attacks or having links to militant groups.

"They include two Malaysians and four foreigners from Singapore, Bangiadesh,

the Philippines and a South Asian country," Fuzi Harun, police inspector general, said in a statement posted on social media.

The group included a 48-year-old Singaporean accused of planning to attack a building used by Freemasons in the state of Johor. He is believed to have links with Akel

Zainal, a Malaysian identified as an 1S fighter in Syria, police said.

Police also detained a suspected member of the Abu Sayyaf group in a separate raid in the eastern state of Sabah, where he worked as a labore. The 21-year-old suspect is believed have ties with Abu Sayyaf leader Furuji Indama,

Fuzi said.


A 28-year-old man from an unidentified South Asian country was arrested during a raid in Selangor state. Interpol had issued a warrant, known as a red notice, for his suspected involvement in criminal and militant activities, Fuzi said.

Malaysia has arrested hun-

dreds of people over the past few years for suspected links to militant groups.

A grenade attack on a bar on the outskirts of the Malaysian capital, Kuala Lumpur, in June 2016 wounded eight people. Islamic State claimed responsibility for the attack, the first such strike on Malaysian soil.

4 Abus slain, 5 hurt in Sulu clash

ZAMBOANGA CITY—Four Abu Sayyaf bandits were killed and five others were wounded as government troopers launched pursuit operations yesterday for the group they encountered in Patikul, Sulu, on Thursday.

Brig. Gen. Divino Rey Pabayo, 11th Army Division and Joint Task Force Sulu commander, said personnel of the 6th Special Forces Battalion clashed with the group of Monde Sawadjaan, a nephew of Abu Sayyaf sub-leader Hatib Hajan Sawadjaan.

Hatib is the alleged mastermind in the twin bombings in Jolo last Jan. 27 that left 23 people dead and more than a hundred wounded.

Meanwhile, the remains of Cpl. Nemesis Salviejo, who was killed in the clash in Barangay Igasan on Thursday, were flown to Villamor Air Base yesterday after a sendoff ceremony held at the Edwin Andrews Air Base here.

Three other soldiers were wounded in the clash.

Pabayo vowed relentless military operations to neutralize the Abu Sayyaf.

Sayyaf terrorist captured in Sabah

ZAMBOANGA CITY: An Abu Sayyaf tertorist, who fled the Philippines in March last year, was arrested in Sabah where he was working in a construction site, Malaysian media reported on Friday.

The Malay Mail quoted Inspector-General of Police Tan Sri Mohamad fuzi Harun saying: "The suspectaged 21, had illegally entered Malaysia in March 2018 and has been working at a construction site. He is highly skilled in handling firearms and has direct connections with Puruji Indama, the current leader of ASG (Abu Sayyaf Group)."

According to Harun, five other suspected terrorists were also captured separately in anti-terror taids in Malaysia. One of them is a 48-year-old Singaporean man, who had planned to attack the Freemason building in Johor.


He said they were also holding a 31-year-old Bangladeshi supporter of the Islamic State Group (IS), who was arrested in Selangor, and was involved in recruiting local militants for the extremist group, as well as two Malaysian suspects, both aged 38, who were deported to Malaysia after they were found to have channelled funds to an IS terrorist while working at a farm abroad.

Harun said police also arrested another terror suspect from a south Asian country in Selangor after police received information that the 26-year-old terrorist had been giving protection to another terror suspect whose name was listed under Interpol's red notice for his involvement in serious terror activities.

Police gave no other details on the Pilipino, except that all of those arrested have been detained under the Security Offences Act of 2012. The Department of Foreign Affairs and the Armed Forces of the Philippines, including the Philippine National Police, have not release any report about the Filipino terrorist arrest.

Misuari seeks travel permit

Moro National Liberation Front (MNLF) founding chairman Nur Misuari on Friday sought the approval of the Sandiganbayan to attend pan-Islamic council summits where he said the MNLF enjoys an observer status on behalf of the Bangsamoro people.

Misuari, in his urgent motion to travel filed at the Sandiganbayan Third Division, said he intends to travel to Abu Dhabi, United Arab Emirates from 1 to 2 March and to Rabat, Morocco on 13 to 14 March.

Misuari stressed that the MNLF is the sole representative of the Bangsamoro people in both summits, noting his trip would benefit the peace process in Mindanao.

The MNLF chairman explained the trip to Abu Dhabi is for the Organization of Islamic Cooperation (OIC) composed of 52 Islamic states while his travel to Rabat is for the Parliamentary Union of the OIC-Member States (PUIC) and attached the respective invitation letters in his travel motion.

Misuari stressed that the MNLF is the sole representative of the Bangsamoro people in both summits, noting his trip would benefit the peace process in Mindanao.

"The participation of the MNLF in the forthcoming meetings of the OIC and PUIC as above stated will greatly benefit the Philippines in terms of ending the armed conflict in Mindanao and to improve the Philippine economy as a whole," Misuari said.

The prosecution opposed the intended trip of Misuari, saying he should file separate motions for each of the summits and has likewise failed to prove the necessity of his attendance and questioned the duration of Misuari's trip since the summits only last two days but his itinerary states he will be abroad

for almost one month.

Based on his itinerary, Misuari will depart Manila for Abu Dhabl on 27 February and will proceed to Morocco on 11 March. His return to the Philippines is expected

between 17 and 20 March.

The motion of Misuari has been submitted for resolution of the Sandiganbayan on Friday, according to the division clerk of court.

Misuari faces two counts each of graft and malversation for giving undue advantage to CPR Publishing House, MBJ Learning Tools and White Orchids for the procurement of "ghost textbooks" from 2000 to 2001 during his term as ARMM governor.

He and his co-accused also allegedly falsified procurement documents to justify the legality of the P77.26-million contract.

Gov't forces raid BIFF gun factory in Maguindanao

Government forces selzed illegal firearms in a dawn raid at a gun factory of the outlawed Bangsamoro Islamic Freedom Fighters (BIFF) in Brgy Poblacion, Buluan, Maguindanao.

Another US sail-by, another China protest

WO United States guided-missile destroyers - the USS Spruance and the USS Proble - salled into the South China Sea last Monday, close to the Spratly island group near Palawan. The sail-bys were, as expected, immediately protested by China as a "provocative action."

Earlier, last January 7, another US warship, the USS McCampbell, sailed near the Paracels, another group of islands also in the South China Sea but farther north, between Vietnam and Luzon. These are only the latest incidents involving US ships and planes in the South China Sea. And they are not likely to be the last.

At the root of the dispute is China's claim to nearly all of the South China Seal defined by a nine-dash loop, as its territorial waters and the many islands within the loop as its territory. The US, whose warships sail all over the globe, rejects this claim, saying the South China Sea – like other international waters – is open to all shipping under the principle of "freedom of navigation."

China's claim is similarly disputed by several nations in Southeast Asia, notably the Philippines, Vietnam, and Malaysia. The Philippines is specially concerned as Scarborough Shoal, which is known to us as Panatag or Bajo de Masinloc, is well within our 200-mile Exclusive Economic Zone under the UN Convention on the Law of the Sea.

But it is also within China's nine-dash loop.

China and the Association of Southeast Asian Nations (ASEAN) have an understanding on their respective claims. We will stand by our claims, especially since we are backed by the UN Arbitral Court in The Hague. But we all agreed to have a Code of Conduct to guide our moves and decisions without giving up our legal claims.

This has helped keep the peace between China and the Southeast Asian nations, but the US, the world's remaining superpower, is not yielding on the principle of "freedom of navigation." It has vowed to keep sending its warships and its planes into the South China Sea, close to the shoals China has built up with runways and garrisons.

The danger is that one of these days, a close encounter may lead to a shooting incident, and escalate into a wider war which we all fear. This is why the Philippines and its fellow ASEAN members hope that some kind of agreement, perhaps under the United Nations, can be reached to settle this matter.

We will continue to have those repeated sailbys by American warships, followed automatically by protests by China. Surely in this modern age, nations should be able to sit down and come to some agreement, knowing that a war like those in the earlier days of our world is no longer possible in today's nuclear age.



Peace still elusive

The new Muslim government. has been painted by the government. as the solution to end the cycle of poverty and violent extremism.

The Moro Islamic Liberation Front (MILF), whose leaders are expected to become the kingpins in the newly formed but highly questionable Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) and to FROM operate yet under a parliamentary system, Ninez Cacho-Olivares despite the existence

of the constitutional presidential system, may not succeed in bringing peace in Mindanao as promised - just to get President Duterte to push for an MILE government with a lot of powers granted and taxpayers' money that may all come to waste.

The bigger problem really is the MILF's refusal to submit to decommissioning its arms and, unlike the peace pact forged between

the government and Nur Misuari with his Moro National Liberation, where the armed MNLF troops were integrated in the Philippine Army, the MILF leaders refuse to budge and give up their arms. This may mean that the MILF leaders, despite having won what it wanted by way of legal status - albeit constitutionally questionable

since the Constitution cannot be amended by a mere law from Congress — will use its firearms independent of the Philippine police and the military which hardly bodes well for peace in Mindanao, especially as the MILF leaders aren't wont to accept responsibility for trouble descending on Muslim Mindanao.

demanding the return of Sison to the Philippines to face justice.

Although the embassy received the letter, the Dutch government has not acted on it.

Peace-loving nations like The Netherlands should not coddle terrorists like Sison. If the Dutch decide to keep Sison in their country, then it's time for President Rodrigo Duterte to restudy the diplomatic ties between Manila and Amsterdam.

NPA arsonist killed, rebels injured in Laguna encounter

CAMP GEN. MATEO CAPINPIN, Tanay, Rizal -- A member of the New People's Army (NPA) communist terrorist group responsible for burning heavy equipment for a dam project was killed in a military encounter Thursday in Sitio Pinamintian, Barangay San Buenaventura, Luisiana, Laguna.

Brig. Gen. Arnulfo Marcelo Burgos Jr., Commander of the 202nd Brigade, who directly supervises ongoing Focused Military Operation (FMO) to run after rebel arsonists, said government troops engaged the NPAs to a gun battle, killing one of them and injuring several others as evidenced by heavy traces of bloodstains at the encounter site.

No one was hurt on the government side, as military offensives forced terrorist insurgents who dragged along wounded and suspected dead comrades, as they fled towards different directions.

Military and police officials said their series of encounters are considered punitive actions against the NPA arsonists whose attacks to civilians and their properties are expected to cause delay in the ongoing construction of Kaliwa Dam and component road projects.

The Kaliwa Dam, one of the government's "Build, Build, Build" infrastructure flagship projects is expected to bring development and provide livelihood for the people in the far-flung areas of Quezon and Laguna.

"Thursday's encounter was the result of the 80th Infantry Battalion and the 2nd Jungle Fighter Company's (2JFC) pursuit operations in Infanta, Quezon," Burgos said.

As of press time, government troops are continuing their ongoing pursuit operations against the terrorists, while checkpoints are heightened to collar the rebels lurking in the area. (PNA)
