

## PNP CONFIRMS SPYING ONACTTEACHERS

Director General Albayalde bewails the 'scary' method of profiling members of the teachers' group. Amid a public outcry, the education department has recalled a letter to school heads endorsing the police operation. A2

The Philippine National Police has confirmed reports that it is profiling members of the Alliance of Concerned Teachers (ACT), a group critical of the Duterte administration, drawing an outcry from rights and lawyers organizations.

PNP Director General Oscar Albayalde on Monday sacked three police intelligence officers. not for the profiling of ACT members but for their "scary" method of intelligence gathering.

"Maybe they don't know what the job of an intelligence officer is. No. 1, if you're an inofficer. there telligence shouldn't be a leak lof your operations] ... especially so if you would be creating unnecessary panic," Albayalde said.

"You have to do a good job discreetly," he added.

The relief of intelligence officials from the Santa Cruz, Manila. police station; Batasan, Quezon City, police station; and another in Zambales province came following complaints by ACT over the weekend that the PNP was openly profiling its members.

#### Policemen's visits

In Manila, at least six public elementary and high schools had been visited by police officers, some reportedly in civilian clothes.

The police officers reportedly carried a memorandum signed by Chief Insp. Rexson Layug, intelligence chief of the Santa Cruz police station in Manila.

Information gathering has been reported, too, in other provinces, including Bulacan, Sorsogon, Camarines Sur and Agusan del Sur.

"They want to justify and normalize surveillance," ACT secretary general Raymond Basilio told the Inquirer. "We have the right to live freely and what they are doing does not fall under 'normal."

Human rights and lawyers' groups denounced the PNP's insistence on the legality of its collection of information on members of ACT, which they said was sowing more fear given the political climate under the Duterte administration.

The Commission on Human Rights (CHR) said the PNP had violated the ACT members' constitutional rights to privacy and association.

CHR spokesperson Jacqueline Ann de Guia said in a statement on Sunday that reports that the PNP was profiling public and private school teachers were "alarming."

#### Harassment

The National Union of Peoples' Lawyers (NUPL) said coming up with the "inventory"—though deemed harmless by police officials—should be seen in the larger context of the crackdown on

activists and opposition leaders.

"It's invasive, discriminatory and amounts to harassment and persecution," said NUPL national president Edre Olalia.

Karapatan secretary general Cristina Palabay expressed fear that the profiling would lead to prosecution, arrests and even killings, given the trend of "Red-tagging" under the Duterte administration.

"The recent Red-tagging [of] ACT Rep France Castro and this recent incident come to more than mere coincidence," Palabay said in a statement.

In November last year, Castro was arrested, along with former Bayan Muna Rep. Satur Ocampo and 16 others, at a checkpoint in Talaingod. Davao del Norte province, for alleged "lumad" (indigenous) child trafficking.

#### Teachers' union

ACT Davao City president Elenito R. Escalante said his group was a legitimate union of teachers recognized by the Department of Education (DepEd) and other government agencies.

"Our championing of the rights and welfare of teachers is no crime." Escalante said.

In a rally at the Camp Grame gates on Monday, ACT national chair Benjie Valbuena said the group first learned about the operations after police officers went to Cecilio Apostol Elementary School in Manila on Thursday.

The police officers asked school officials to fill out a "survey form" seeking an "inventory" of ACT members on the faculty and informing the school about the police operation.

A teacher took a photo of the "form" and reproduced it for ACT.

The form was a memorandum from the intelligence chief of the Santa Cruz police station ordering the policemen to "conduct an inventory of all public and private school teachers who are members aligned with the ACT."

The memo showed an example of the database format to be used and cited other memorandums purportedly coming from the Metro Manila regional intelligence division and the "midterm elections of 2019"

A new party-list group called ACT-CIS is accredited for the May elections. Its top nominee is Erwin Tulfo, a supporter of President Duterte.

Amid the uproar, the DepEd has ordered the recall of a letter addressed to school heads by the Schools Division Office in Manila that endorsed the PNP memo.

#### Other groups, too

At the press conference, Albayalde said the gathering of information was not limited to ACT members.

The PNP chief said the intelligence officers focused on ACT to determine whether it was doing something wrong like supporting armed rebellion.

Escalante likened the PNP move to the government's antiillegal drug campaign "tokhang," a combination of two Visayan words—"toktok" (knock) and "hangyo" (ask)—in which drug suspects are subject to profiling.

The PNP has been criticized since the beginning of the administration's crackdown on illegal drugs after it came up with "drug watch lists" considered a target list for extrajudicial killings. —with a REPORT FROM VINCE F. NONATO INQ

Aside from allegedly ordering the murder of Ako Bicol party-list representative Rodel Batocabe last month in Daraga, Albay, Carlwyn Baldo when he was vice mayor also wanted to kill mayor Gerry Jaucian in May last year so he could assume the top post in the town, an intelligence officer claimed vesterday.

Chief Supt. Amador Corpus, Criminal Investigation and Detection Group (CIDG) director, said the plot to kill Jaucian did not materialize because the mayor died of lung cancer on May 4 as Baldo was planning the hit

Corpus said Baldo employed at the time the very same persons he contracted for Batocabe's murder, promising to pay them P350,000.

"If you remember, (Baldo) was the vice mayor prior to June 2018... the information came from our primary witness," Corpus said

He said Emmanuel Judayar the former henchman of Baldo who backed out due to their falling out in October last year, detailed the information about Baldo's plots.

Director General Oscar Albayalde, Philippine National Police (PNP) chief, said that because the revelations. opened a can of worms, they would recommend that the P50-million reward for the solution to Batocabe's murder be given to Judavar.

He pointed out that the resolution of the Batocabe murder started from Judavar's revelations, although the PNP is "not closing its doors to other angles" that include an alleged internal rift within the Ako Bicol party.

Albayaide also declared at yesterday's press briefing that the recovered spent shells at the place where Batocabe and his bodyguard, Senior Police Officer I Orlando Diaz, were

gunned down matched that of the licensed firearm of self-conlessed gunman Henry Yuson.

Quoting a report from the police crime laboratory, he said the 11 shells and five slugs recovered from the crime scene matched Yuson's .40 caliber pistol.

The result of the examination in the Integrated Ballistics Identification System, he added, would further boost the case against those accused of involvement in Batocabe's murder.

"Even without the presence of the real firearm, our evidence is strong because it cross-matched... We are now confident that what he (Yuson) was saying is true," Albayalde said in the briefing.

Yuson earlier confessed to killing the lawmaker on Baldo's order Batocabe and Diaz were killed as they were boarding a vehicle after a gift-giving activity for semor citizens in Barangay Burgos

last Dec 22

Meanwhile, a source from the intelligence community said the murder is also rooted in the never-ending feud resulting from the operation of Small Town Lottery (STL) in Albay.

"Batocabe earned the ire of very powerful people in the province because of his incessant criticism and investigation of the STL, particularly the loss of billions of pesos in revenues on the part of the national government," the source told The STAR

It appeared that a day before Batocabe was killed, the congressman visited an official of the Philippine Charity Sweepstakes Office (PCSO) and discussed "very sensitive matters."

"Eliminating Batocabe is like killing two birds with one stone — you get rid of somebody who doesn't stop prying into the shenanigans in the STL operations and kill a potential mayor who doesn't dance to your music." the source added.

He claimed that a provincial government official might have something to do with the murder and that Baldo was a willing accomplice in the crime.

Batocabe started his inquiry into the alleged failure of the STL operations in 2017 after receiving reports that it was being used as fronts for nucleing and other illegal games in the country.

In May that year, Lucky V Prime Enterprises Corpstarted operations in Albay after securing a license to operate STL. The firm was then headed by its president, Alex Herman Alemania, and corporate secretary Alexander Javier, both of Quezon province.

But in November 2017, barely six months after they started operating, Alemania was shot by motorcycle-riding gunmen in front of a shopping mall. He survived the murder attempt. Police killed one of his attackers and wounded another in an alleged shootout.

Last August, the PCSO issued Board Resolution 248 canceling Lucky V's franchise to operate in Albay for failing to remit a total of P259.4 million in monthly sales. It was also discovered that the firm failed to use official tickets or receipts.

The PCSO board subsequently forfeited Lucky V's cash bond as penalty and payment for its obligations.

"I'm sure the authorities are also looking into these things but won't come out with an official statement unless they have concrete evidence to pin down the bigger fish," the source said.

The National Bureau of Investigation expressed willingness to look into all possible angles in the Batocabe slay, including the alleged STL anomalies, when ordered.

#### Right to question

Daraga Mayor Baldo could still contest the decision of Lakas-Christian Muslim Democrats (Lakas-CMD) party to withdraw its nomination for his re-election bid in the coming May 13 midterm polls, the Commission on Elections (Comelec) said yesterday.

Spokesman James Jimenez noted the poll body's rules allow Baldo to question the cancellation of his Lakas-CMD Certificate of Nomination and Acceptance (CONA).

"Withdrawal of CONA must be with the consent of the individual. So, we have to get his take on this. If (he agrees), he will become an independent if he decides to continue to run," he explained.

Jimenez maintained that Lakas-CMD could no longer appoint a substitute for Baldo because the period for this is already over. Baldo is being accused of masterminding the slaying of Batocabe, his rival for the mayoralty post in Daraga.

Yesterday, Comelec law department director Maria Norina Tangaro-Casingal received the letter of Lakas-CMD executive director Bautista Ongpin Jr revoking the CONA issued to Baldo as the party's official candidate for mayor of Daraga

#### DFA urged to coordinate with Vietman over disputed South China Sea

AN opposition solon urged the Department of Foreign Affairs (DFA) to work with Vietnam in negotiating a Code of Conduct (COC) in the

South China Sea. Magdalo Rep. Gary Alejano agreed with the proposal of former Foreign Affairs Secretary Albert Del Rosario for the Philippines to discuss the issue with the Vietnam-

ese government "Vietnam has taken a strong stance against pro-China provisions in the proposed COC. The Philippines must support

Vietnam on this to block the attempts of China to gain complete control of entire South China Sea," Alejano said

Del Rosario has recenily called on the DFA to block the pro-China provisions in the proposed COC in the South China Sea.

Specifically, Del Rosario urged the DFA to take the same position of Vietnam on banning any new air defense identification zone, clarifying maritime entitlements in accordance with international law, blocking of a proposal by China to ban

military drills in the South China Sea with countries outside the region unless all signatories agree, and blocking China's propos-al to exclude foreign oil firms by limiting joint development deals to China and Southeast Asia.

Alejano has previously expressed admiration on the position and ac-tions of Vietnam regarding China's expansionist policy

"Vietnam has been vocal in condemning China's militarization of the South China Sea. And while it has maintained

good economic relations with China, it has not foregone its territorial claims in the South China Sea and compromised its sovcreignty - a few things the Duterte administration should take note off." Alejano stressed

The former Marine officer enjoined the Philippines and the rest of the Association of Southeast Asian Nations (ASEAN) to ensure that the COC serve its main purpose of ensuring peace and sta-bility in the region according to international law.

#### Election gun ban to start Jan. 13

The gun ban to be imposed for the midterm elections will start on Jan. 13 and end on June 12, Philippine National Police (PNP) chief Director General Oscar Albayalde said vesterday.

While the ban is in place, licensed gun owners are not allowed to carry or transport their firearms outside their residence, but they may seek exemption from the Commission on Elections (Comelec), which will review the applications.

Albayalde said law enforcers on duty and in uniform are exempted from the gun ban. Also excluded are personnel of the Armed Forces of the Philippines, Philippine Coast Guard, National Bureau of Investigation and other law enforcement agencies.

Private security agencies may also be exempted from the gun ban.

threats, Albayalde said they may apply for security escorts from the PNP Police Security and Protection Group.

Albayalde said there are more than one million loose firearms nationwide.

#### Permit to carry suspended

Albayalde has also suspended the permit to carry firearms outside of residence (PTCFOR) in Manila as part of security measures for the annual Black Nazarene procession.

The suspension will start from 8 a.m. today until Jan. 10.

During the period, only members of the PNP, AFP and other law enforcement agencies are allowed to bear firearms provided they are performing official duties and wearing proper uniforms

Albayalde said the 27,000-strong National Capital Region Police Office (NCRPO) is on full alert and will field a contingent of 7,200 officers during the traslacion for the annual feast

Authorities are taking all possible threats seriously, according to Albayalde, including the revelation of Mayor Joseph Estrada about an intelligence report that members of an Islamic terrorist group might create trouble during the religious event.

"We are taking all these reports seriously. The members of the intelligence community are constantly monitoring any possible threat," Albayalde said.

He advised people to avoid the 6.1-kilometer procession route from Rizal Park to Quiapo Church that will be inaccessible to traffic.

"We strongly advise those with no urgent business in these areas to postpone their trips for another day for their own convenience," Albayalde said.

To achieve the goal of zero casualty. Albayalde urged everyone, including the devotees, to cooperate with authorities.

#### Siopics

Meanwhile, opposition senatorial candidate Romulo Macalintal sees nothing illegal about the showing of movies about the lives of fellow senatorial bets as long as these are done before the campaign period, which starts on Feb. 12.

"If the movie will be shown during or within the campaign period, that will be an election offense," Macalintal, a veteran election lawyer, said, apparently referring to the upcoming movie about the life of former PNP chief Ronald dela Rosa, who is a pro-administration senatorial candidate.

The Comelec also warned against the showing of the film during the campaign period.

PHILIPPPINE National Police chief Director General Oscar D. Albayalde yesterday said they will strictly enjoyce the Commission on Elec-tions' ban on the carrying of unauthorized weapons and employment of bodyguards starting Sunday until June 12 to ensure the holding of a safe, orderly and fair May 13 national and local elections.

The PNP chief said only members of the uniformed service who are in their official prescribed uniforms and in the actual performance of duty will be allowed to carry their firearms in public

Police will arrest anybody incivilian clothes who will befound carrying firearms during the period.

Starting this Sunday, all Permits-to-Carry-Firearms-Outside-of-Residence issued by the Office of the Chief PNP will automatically deemed as invalid until midnight of June 12.

A motor vehicle, water or air craft is also not considered a residence or place of business or extension hereof. Licensing of firearms will also cease during the period.
The PNP will also be

enforcing the ban on the employment, availment or engagement of the services of security personnel or bodyguards during the election period,

although Albayalde said politicians with validated threats on their lives can still be provided security details in uniform.

The Omnibus Election Code says that during the election period, "no candidate for public office, including incumbent public officers seeking election to any public of-fices, shall employ, avail himself of or engage the services of security personnel or bodyguards, whether or not such bodyguards are regular mem-bers of the Philippine National Police, the Armed Forces of the Philappines or other law enforcement agency."

However, the following officials are allowed to retain their security

personnelor bodyguards: the President Vice President, Senate President, Speaker of the House of Representatives, Chief Justice of the Supreme Court, Secretary of National Defense Secretary of the Interior and Local Government, Chairman and Commissioners of the Commission on Elections Chief of Staff of the AFP and AFP Major Service Commanders, and Director Generals and Senior Officers of the PNP

Senators, members of the House of Representatives and Provincial Governors, and Justices, Judges and Cabinet Secretaries, whose regular secunty complement have been

ernment Law Enforcement Agencies for at least one (1) year at the time of the promulgation of this Resolution, may be allowed to retain the service es of a maximum of two (2) of the currently detailed officers or members of said law enforcement government agencies

When circumstances warrant, including but not limited to threats to their life and security, incumbent public officials whether elected or appointed, candidates for the May 13, 2019 national and local elections or his/ her immediate family within the second degree of consanguinity and private individuals may also provided by the PNP, papply for police security AFP, NBI or other Gov during the period.

More than 7,200 policemen would be stationed along the 6.1-kilometer route of the procession. On top of this, the Armed Forces of the Philippines said it would also field some 2,000 soldiers to help ensure the safety of devotees.

#### Temporary gun ban

Eleazar said the Philippine National Police had temporarily suspended permits to carry firearms outside of residence in Manila from Jan. 8 to 10.

During this period, only members of the PNP, AFP and other law enforcement agencies on official duty and in uniform would be allowed to carry firearms.

The NCRPO would also be implementing no-fly and no-sail zones in Manila. Telecommunication signals along and around the traslacion route would be jammed as well.

#### No confirmed threat duri Nazarene feast - PNP, AF

Police and military officials clarified yesterday that there is no confirmed threat to the traslacion of the Black Nazarene in Quiapo, Manula tomorrow.

Philippine National Police (PNP) National Capital Region Foirce Office (NCRPO) chief Director Guillermo Eleazar yesterday said the police have not confirmed any threat on the traslacion.

Rumors of threats have circulated. These either have no basis or are unreliable," Eleazar said.

He issued the clarification following the revelation of Manila city officials that they received intelligence reports of an Islamic

group planning to create trouble during the traslacion.

Manila officials admitted that the reports are not validated but they are not taking these for grant-

At least five million devotees are expected to participate in the treslection of the image of the Black.

According to Eleazar, they are continuously coordinating with various government agencies and the intelligence community regarding any threat to the procession of the centuries-old image.

Eleazar cancelled all leaves and rest and recreation of all police personnel as they focused their attention on security of the traslacion tomorrow.

The NCRPO will deploy some 7,200 personnel during the trustacion, to be augmented


"Our uniformed personnel would be securing the Quirino and Quiapo areas and the 6.1-kilometer route, which is divided into 10 segments," Eleazar said, noting that each segment would be manned by a police commander accompanied by a medical team and several agencies equipped for emergency assistance.

THe NCRPO deployed augmentation forces of 1,500 policemen starting 8 p.m. yesterday, with an additional 3,500 at 8 p.m. today.

The NCRPO will employ the containment ring system of security, with first layer being the venue security at the Quirino Grandstand in Rizal Park, Quiapo Church and the procession route of the image of the Black Nazarene.

The PNP has suspended the permit to carry firearms outside residence (PTCFOR) in Manila during the traslacion, from 8 a.m. of Jan. 8 up to 8 a.m. of Jan. 10.

"Only members of the PNP,

Armed Forces of the Philippines and other law enforcement agencies who are performing official duties and wearing agency related uniforms will be allowed to carry firearms," said Eleazar.

According to Eleazar, PNP chief Director General Oscar Albayalde approved his recommendation to suspend PTCFOR in Manila for the peaceful and orderly traslacion.

A rosary vendor in front of the Quiapo Church was nabbed for possession of a homemade shotgun two days before the celebration of Black Nazarene's feast.

Manila Police District (MPD) director Senior Supt. Vicente Danao Jr. said charges of illegal possession of firearm and ammunitions were filed against Peter Coderias, of Old Balara, Quezon City.

# No security threat in Traslacion'

PNP chief Director General Oscar Albayalde yesterday said the police have not monitored any security threat in connection with tomorrow's Translacion of the Black Nazarene in Manila.

"We have not monitored any significant security issue that may possibly affect the otherwise peaceful and orderly celebration of the Feast of the Black Nazarene in Manila this year," Albayalde said.

On Manila Mayor Joseph Estrada's claim that terrorists may sow violence during the event, Albayalde said: "We are taking all these reports seriously. These are all unconfirmed reports but we are not taking these reports for granted, all these we are taking them seriously.

"As of now, we have not received any information that confirms that report but as I've said, we are taking all these reports seriously. We cannot take these reports for granted... Members of the intelligence community are constantly monitoring any possible threats," said Albayalde.

Albayalde said the National Capital Region Police Office, which is now on full alert, is deploying 7,200 policemen to secure the event. This is on top of an undetermined number of Armed Forces personnel who will be supporting the security measure.

"The mission is to assist devotees in ushering the holy image of the Black Nazarene from the Quirino Grandstand back to the Minor Basilica in Quiapo. The ultimate goal is to prevent if not minimize deaths or injuries that has been

perentially associated with this annual event," said Albayalde.

Albayalde urged the cooperation of everyone, particularly the devotees joining the Traslacion, "to observe proper decorum and behavior befitting the sanctity of this religious rite" to achieve zero casualty.

NCRPO chief Director Guillermo Eleazar said the PNP chief has ordered the suspension of all permit to carry firearms outside residence in Manilastrom 8 a.m. today up to 8 a.m. of Thursday.

"Only members of the PNP, AFP and other LEAs (law enforcement agencies) who are performing official duties and wearing agency related uniforms will be allowed to carry firearms," said Eleazar.

The NCRPO will also implement a Manila-wide liquor ban

until the culmination of the Translacion.

Albayalde said the PNP is finetuning all preparations and final coordination with government agencies and the Archdiocese of Manila.

"As expected, the movement of a mammoth crowd of this magnitude will render all roads and peripheries along the 6.1-kilometer procession route around the Luneta and Quiapo areas virtually inaccessible," said Albayalde.

"Therefore, we strongly advise those with no urgent business in these areas to postpone their trips for another day for their own convenience," he added.

#### DEFINING FAITH

Quiapo Church Parochial Vicar Fr. Douglas Badong advised devetees, especially new ones, must keep in mind that being able to rouch and get near the image on fanuary 9 will not define their faith.

"It's difficult when come January 9, everybody is racing to touch the image even to the point of bumping and stepping into one another," said Badong.

"We are discouraging them from doing that," he added.

The priest said if touching the image is their only purpose, they can do so anytime of the year, sans any need to hurry in doing so.

"The Black Nazarene is here all year long. They can touch, kiss, hug Him all they want," he said.

"Once it seaches the church, anytime, any hour, He is just there at the altar. There is no limit in kissing His feet, hands, clothing," added Badong.

During the Traslacion, the priest said it is already enough for a devotes to join the procession and pray.

"We should put a deeper meaning in our faith," stressed Badong. During the Traslacion, it is a common sight to see some individuals get on top of the ses of harefoot, yellow, and maroon clad devotees in a bid to touch the image of the black Christ.

Such scenes during the popular procession often draw criticisms that it already manifests Filipino idolatry and fanaticism, instead of faith.

Today, the traditional "Pahalik" is set to begin at the Quirino Grandstand at 8 a.m., which is expected to be attended by long queues of devotees.

Also to be held starting 5 p.m. today at the Quirino Grandstand is the overnight vigil, which shall feature spiritual talks, youth dance/drama presentations, and catechesis.

The overnight vigil will then be temporary suspended to give way to the Fiesta High Mass at midnight to be led by Manila Archbishop Cardinal Luis Antonio Tagle as the main celebrant,

## Army sarge killed in CamSur shooting

# Court upholds order to arrest Trillanes

HE Makati Regional Trial
Court Branch
150 has upheld its decision to have Sen.
Antonio Trillanes 4th arrested as it junked the lawmaker's plea to reverse the ruling.

Branch 150 Judge Elmo Alameda, who ordered Trillanes arrested in September last year said the senator failed to prove the existence of an "original" application for amnesty and to explain his failure to produce it.

"Since the existence of the duly accomplished application form for amnesty has never been established nor the fact of his admission of guilt of the crime he committed... the substitutionary evidence he presented is considered hearsay evidence and cannot be admitted," Alameda said

in his order which was released on Monday

"In view of all the foregoing, the Omnibus Motion is denied," he added.

Trillanes previously filed a 19-page oranibus motion for reconsideration by way of special appearance through his counsel Reynaldo Robles last October 1, where he asked the court to void its September 25 order for his arrest as it lacked "legal and factual basis."

It said that Branch 150 made a

"grave" mistake in issuing an arrest order on the basis of President Rodrigo Duterte's Proclamation 572 which voided Trillanes' amnesty ab initio (from the beginning).

Alameda ordered Trillanes arrested in September as it found that the senator did not apply for amnesty.

The rebellion charges filed against Trillanes in connection with the 2007 Manila Peninsula siege were dismissed in 2011 after he was granted amnesty by President Benigno Aquino 3rd.

#### 'Hearsay' evidence

Trillanes lost his appeal a week after leaving for Europe for a series of engagements

In his six-page order, Alameda said the senator was not able to prove through testimonies and documents that he indeed filed for amnesty and that he admitted or recanted previous statements that compromised his admission of guilt.

Alameda said Trillanes failed to produce an original copy of his amnesty application form which bears a receiving stamp from the Department of National Defense's (DND) Amnesty Ad Hoc Committee, which he argued in the rules of court was the "highest available degree of proof."

Without it, Trillanes could not prove his compliance with the amnesty procedures, the court said.

"Sen. Trillanes cannot claim exception to this rule since no evidence has been presented that such accomplished application form exists in the files of the DND Ad Hoc Amnesty Committee." he said.

"[Trillanes] failed to satisfactorily prove the [following] predicates: the existence of the original, the loss or destruction of the original or its non-production in court, the unavailability of the original is not due to bad faith on his part," he added.

The judge said the senator's evidence and testimonies from Armed Forces and DND officials saying he filed for amnesty and admitted guilt were "hearsay."

The rule requires that the highest available degree of proof must be produced by him to prove the contents thereof especially his claim that he made a narration of his admission of guilt of the crime subject of the application for amnesty," he added.

#### Makati court denies Trillanes appeal

THE Makati Regional Trial Court Branch 150 has upheld its decision to issue an arrest warrant against Sen. Antonio Trillanes IV in connection with President Duterre's issuance of Proclamation 572 which nullifies the amnesty granted to him in 2011.

In a three-page decision, Judge Elmo Alameda of the Makati RTC Branch 150 denied the senator's motion for reconsideration to a decision issued in September last year. Alameda's latest decision was dated December 18 but was released to media only yesterday.

"By way of reiteration, Sen. Trillanes was not able to prove through testimonial and documentary evidence that he filed his application for amnesty nor expressly admitted his guilt in the application form for the crime he committed during the Manila Peninsula incident, which are the minimum requirements set forth under Proclamation No. 75," said Alameda.

Trillanes is our of the country. He left last December 11 for speaking engagements in Europe and the US until next month.

His lawyer, Reynaldo B. Robles, said: "We have yet to see the ruling of the Court so we cannot comment on the supposed basis

of the denial of our motion. Needless to state, we will consider the possibility of appealing or questioning the ruling before the higher courts."

Alameda said Trillanes failed to show an official copy of the amnesty application form, which is the primary evidence required as proof of filing, and the official copy of the application form which he filed.

He noted Trillanes presented only documents and affidavits of several military officers and a former defense secretary

to prove he complied with the minimum requirements.

Lass September 25, Alameda granted the motion of the Department of Justice to issue an arrest warrant and a hold departure order against Trillanes after finding factual and legal basis for Proclama-

tion No. 572.

Trillanes posted bail of P200,000 on the same day.

In Proclamation 5-2 signed on Aug. 31, 2018, President Deterte voided the grant of amnesty to Trillanes, a former Navy lie atenant who was among leaders of a mutiny at least 15 years ago, for allegedly failing to comply with requirements for the clemency, including admitting guilt. Duterre also ordered Trillanes' arrest, Justice Secretary Menatdo Guevarra then said that based on the Proclamation 572, Trillanes failed to comply with the requirements for amnesty grant, which are to apply for amnesty and admit one's guilt.

Proclamation No. 572 also instructed the Department of Justice and the Armed Forces "to pursue all criminal and administrative cases" filed against Trillanes in connection with the July 2003 Oakwood Mutiny, the February 2006 Matines stand-off, and the Manila Feninsula "siege" in November 2007.

# NO GOV'T POLICY TO PLACE TEACHERS UNDER SURVEILLANCE, SAYS PALACE

The government has no policy of putting teachers under surveillance but the Philippine National Police will "monitor" those suspected of illegal activities such as having links with communist rebels, presidential spokesperson Salvador Panelo said on Monday

Panelo made the statement in reaction to reports that the PNP was profiling members of the Alliance of Concerned Teachers (ACT).

"Definitely, there is no policy to surveille teachers. The President loves teachers," he said, pointing out that Mr. Duterte's late mother was a teacher.

At a news conference, Panelo reminded the public that the PNP had already denied it was profiling ACT members.

#### Identified with Left

But he said those being "monitored" by the PNP were

doing illegal things.

"You must remember, ACT is a legal organization identified with the Left, and the PNP and the President have said there were legal fronts but actually they are together with the Left." Panelo said.

"If you're not doing anything, why should you be afraid," he added. "If you're not doing anything, nothing will happen."

Panelo also said that if the police were putting anyone under surveillance, it was for a reason.

Asked to explain, he cited a possible reason that police would surely monitor if they got word that one or two teachers were involved with identified New People's Army (NPA) rebels or were suspected to be NPA members.

Asked why the police were focusing on these groups, Panelo said the PNP had a lot of jobs and it had already denied profiling ACT members.

He said that if ever the PNP was monitoring the group, it might just be focusing on one or two of its members, probably "hard-core leaders."

Panelo noted that Mr. Duterte was taking care of teachers, reminding the public that the President had promised to double their salaries.

Told there was a leak of a PNP memorandum on an inventory of all public and private teachers who are members of ACT, he said there was no proof that the document was authentic. INQ

# 3 PNP officers sacked over leaked memo on ACT

Philippine National Police (PNP) chief Director General Oscar Albayalde yesterday ordered the relief of three intelligence officers over the leak of a supposed memorandum ordering profiling and surveillance of the members of a left-leaning teachers' group

Sacked were the intelligence chiefs of the Manila Police District Station 3. Quezon City City Police District Station 6 and provincial intelligence branch of the Zambales police.

Albayalde said the leakage of the memo has caused fear

among members of the Alliance of Concerned Teachers (ACT), who feel they are being intimidated by the police.

He said the intelligence officers, by the nature of their job, should have done their work discreetly.

"Anyone, when they realize they're being profiled by the police, there is that feeling always," the PNP chief said in a mix of English and Filipino.

Albayalde said he did not sign any document ordering intelligence officers to conduct an inventory of ACT members.

But he did not deny that the order came from a PNP unit

"The different directorates of the PNP can always issue memorandum, especially if it falls under their jurisdiction," he said.

Albayalde assured ACT members there is no cause for alarm if they have not committed any wrongdoing.

He said the surveillance order may have stemmed from the declaration of communist leader Jose Ma. Sison that ACT is one of their front organizations.

ACT members should not be afraid of police surveil-

lance if they are not doing anything unlawful, Malacanang said yesterday.

Presidential spokesman Salvador Panelo said it is not the policy of the government to conduct surveillance on teachers

"It's the job of the PNP to monitor all groups. If you're not doing anything wrong, why should you be afraid?" Panelo said.

"The President loves the teachers. But if you're doing something illegal or irregular it's natural for the police to monitor what you are doing," he added.

Panelo said President Duterte has vowed to promote the welfare of teachers and to increase their salaries.

The teachers' union accused the PNP of deploying police personnel to schools to gather information about its members.

The group claimed that the PNP had issued two memoranda ordering an inventory of teachers affiliated with ACT

#### Albayalde relieves 3 intel chiefs over ACT project

Philippine National Police chief Director General Oscar Albayalde yesterday relieved three local police intelligence chiefs over an alleged confidential directive purportedly ordering the profiling of all members of the Alliance Concerned Teachers (ACT).

But Albayalde denied issuing such order to the intelligence community

"As far as I am concerned, I have not signed anything like that at nume mag-leak yan, I have already ordered for all intelligence officers involved to be relieved," Albayalde told reporters in a press briefing at Camp Crame.

Those relieved from their posts were the intel chiefs of Manila Police Station 3, Quezon City Police Station 6, and the Zambales Provincial Police Office.

Albayaide surmised the

instruction might have come from the Directorate for Intelligence (DI) since it could issue such order to local intelligence units.

"I will look into that but they are relieved pending investigation," said Albayalde

Pressed on why he had ordered the relief if no such order came from his office. Albayalde explained that it was due to sloppy work of intelligence chiefs that led to the memo's purported leak.

"If you are an intelligence officer bindi mo dapat ganun nagle-leak yung mga ginagawa mo. Kaya nga intel officer, if really merong utos na ganun hindi ba and especially so that we are creating an unnecessary panic ng mga tao na ito kung naintimidate sila," said Albayalde.

"You have to do your job discreetly." he added

#### Memo leaked

The source of irritation is a January 4 memorandum on the "Inventory of All Public and Private School Teachers who are members of, or aligned with, Alliance Of Concerned Teachers (ACT)" that purportedly came from MPD Station 3, quoting an earlier memo from the Regional Intelligence Chief of Metro Manila police as the basis.

The January 24 memo has been circulating in social media

Albayalde, however, stressed that it was not a profiling but part of the intelligence monitoring activities of the police.

"This is not profiling. It has been part of our intelligence monitoring. It does not mean that if you are subjected to profiling, you are already a member," said Albayalde. Leaders of ACT raised safety concerns on the supposed PNP memo. Yesterday, some of its members conducted a protest action in front of Camp Crame.

But Albayalde said that ACT members have nothing to be afraid of if they are not doing anything illegal. Instead, ACT members, he said should be proud they are members of the group.

"The question is, why are you afraid if you are a member of ACT? If you are not violating any law, why be afraid," said Albavaide.

The official later said that they are currently monitoring groups affiliated with communist rebels.

"Remember, there are pronouncements coming from the CPP-NDF (Communist Party of the Philippines-National Democratic Front) that they have front organizations. This did not come from us or me or even from the military," said Albayalde.

The PNP chief cited a video uploaded on You Tube, where CPP founder Joma Sison reportedly identified ACT as one of their front organizations.

"So this is for departmental use, to ensure that this organization is legitimate, that his group is not doing something illegal like supporting armed rebellion," said Albayalde

#### Endorsements recalled

Meanwhile, the Department of Education (DepEd) yesterday ordered the recall of two endorsements by DepEd Schools Division Offices (SDO) in relation to an unnumbered memorandum from the PNP directing the inventory of teachers who are members of ACT

In an official statement, DepEd said that it received communication from a representative of the ACT raising concern over the SDO endorsements

"Based on available information, it is noted that the DepEd Central Office has not received any such request from the PNP," DepEd said. "It is confirmed though that a letter addressed to school heads was issued by one SDO through an Acting Division Superintendent, forwarding a purported Memorandum from a PNP unit," DepEd added.

In consultation with the concerned Regional Office, DepEd said the "recall of this forwarding letter has been directed."

"Initial feedback from the field shows that there is no other similar forwarding letter which has been issued by any other DepEd local unit," DepEd added.

The agency stressed that should any inter-agency request for personal information of individuals, "such request shall be evaluated based on existing laws and regulations, including the Data Privacy Act."

In an advisory dated January 4, 2019 issued by DepEd National Capital Region (NCR) Assistant Schools Division Superintendent and Officer-in-Charge (OIC) Sheryll Gavola, all public and private elementary and secondary school in Division of City Schools – Manila were given a copy of an unnumbered memorandum dated December 26, 2018 signed by Rexson Layug, Police Chief Inspector, Chief of Intelligence Branch regarding the "inventory of all public and private teachers who are members" of ACT.

Undersecretary and Spokesperson Annalyn Sevilla said the DepEd Central Office is "looking into the matter" at the Secretary level. The CO, she added, is also waiting for "verification from regional offices and legal team."

#### Intimidating

Meanwhile, the ACT strongly condemned the move calling it a "scheme to intimidate and harass" its members

In a statement, ACT decried the recent move of the PNP to "profile" all public and private school teachers who are members of the ACT. The group alleged that the PNP are also currently making the rounds in schools and offices of the DepEd "to press" education officials for an inventory of all ACT members under their jurisdiction.

"The operations appear to be of a

nationwide scale and points to the top PNP leadership as the foremost source of the order as we received similar reports from our members in Manila, Malabon, Las Pinas, Zambales, Bulacan, Rizal, Mindoro, Sorsogon, Agusan Del Sur, among others," the group added

For ACT, the move is "grossly illegal and unconstitutional attack on our collective right to free expression and right to self-organization."

The PNP's "concerted national scheme to single out" ACT and extract a list of all its members from principals and other school officials is a "clear violation of the constitutional right to self-organization, freedom of expression and assembly, and right to privacy."

#### 3 police intel officers sacked for profiling leak

PNP CHIEF Oscar Albayalde yesterday ordered the relief of three intelligence officers of police stations in Manila, Quezon City, and Zambales, who leaked information on the reported profiling of reachers who associated with the militant party-list group Alliance of Concerned Teachers.

"If you are an intelligence of-

ficer, you should have not allowed that information to leak," said Albayalde in a press conference in Camp Crame, adding intelligence officers should do their job discreeds.

"They may not know how an intelligence officer is supposed to work. They do not know how to be an intelligence officer," he also said.

Albayalde did not name the

sacked intelligence officers but said they are assigned with Station 3 of the Manila Police District, Station 6 of the Quezon City Police District, and the Zambales provincial police.

ACT on Sunday denounced the reported PNP profiling of its members, after reports said a PNP memoranda ordered schools to

submit a list of all ACT members in every school. It said members in Manila, Malabon, Las Piñas, Zambales, Bulacan, Rizal, Mindoro, Sorsogon, Agusan del Sur, and other areas reported similar orders.

Reports also said policemenhave been going to schools, asking principals for the names of teachers who are ACT members. ACT chairperson Joselyn Martinezasked the PNP for its motive in conducting such profiling.

Albayalde said he is not aware of the supposed memorandum for policemen to profile members of ACT.

Albayaide also said past pro-

nouncements of communist leader Jose Maria Sison, identifying ACT as a front organization of the communist movement, may have prompted the profiling.

"That may have been what they are looking into (ACT members). But as I said, we will check on this. I will personally check on it,"

Albayalde assured the public any profiling done by the PNP "is part of our security preparations, these are all part of our security protocols, this is all part of the maintenance of peace and order in this country."

The Department of Education DepEd directed school division offices in Manila and Zambales to recall the memoranda.

Photos of the memoranda allegedly issued by the Manila and Zambales police last month went vital on social media last week. The two memoranda, which bear the signature of Manila police chief Insp. Rexson Layug and Zambales police chief Insp. Pancho Doble, ordered public and private school heads to identify teachers affiliated with ACT.

"Based on available information it is noted that the DepEd Central Office has not received any such request from the PNP. It is confirmed though that a letter addressed to school heads was issued by one school division office through an acting division superintendent, forwarding a purported memorandum from a PNP unit," DepEd said.

Chief Presidential Legal Counsel Salvador Panelo said government has no policy of placing teachers under surveillance or profiling them.

Asked what could have prompted the police to monitor the ACT members, Panelo said ACT is a known legal front of the Communist Party of the Philippines which is waging a rebellion against the government.

He said maybe a leader or two of ACT was seen engaging with CPP leaders and police are just monitoring and ensuring that they would not commit any criminal activity or engage in anything illegal: — With Evan Orias and Jocelyn Montemayor

#### Reds profiling: 3 cops probed for info leak

AT least three police intelligence officers were sacked for allegedly leaking the results of their discreet profiling on members of the Alliance of Concerned Teachers, Philippine National Police chief Oscar Albayalde said Monday.

Albayalde declined to identify the

three spy cops, but said they were from Manila's Station 3, Quezon City's Station 6 and a station in Zambales, with ranks of senior inspector to chief inspector.

Albayalde also ordered an investigation on the leak of confidential information.

The PNP chief said he signed no order to investigate ACT, but said if such

an order were issued, the intelligence officers should have done their job more discreetly

ACT, in a statement, said police officers have been approaching officials of local schools and asking for a list of ACT members in their schools.

The Commission on Human Rights. for its part, expressed concern over the profiling, saying it violated ACT members' rights to privacy and to free association.

In a statement, Albavalde said there was no crackdown on ACT members in any school.

"What the PNP is undertaking is simply intelligence or information gathering, which is one of its major functions," he said

"It is the responsibility of the PNP to monitor any and all groups and organizations critical of the government, especially those linked to militant organizations whose objective is to overthrow the duly-elected government."

He said Communist Party of the Philippines founder Jose Maria Sison himself had identified organizations with links to the rebels.

"This did not come from us or even from the military...this was the pronouncement of Joma Sison, an He identified these organizations, not us," he added.

The Palace said Monday members of ACT should have nothing to fear if they are not doing anything illegal.

Presidential Spokesman Salvador Panelo maintained that the PNP has already dismissed the claims that the agency has called for an inventory of all public and private school teachers who are affiliated with the ACT.

#### PNP defends profiling of ACT members

#### **By Alfred Dalizon**

PHILIPPINE National Police chief Director General Oscar D. Albayalde yesterday said there's nothing wrong with profilingmembers of the supposed left-leaning teachers' union Alliance of Concerned Teachers but at the same time ordered the administrative relief of three of his intelligence officers who supposedly leaked the report to the media and the tutors themselves.

Ordered relieved from their posts were the intelligence chiefs of the Manila Police District Station 3 and Quezon City Police District Station 6 as well as the intelligence chief of the Zambates Police Provincial Of-

The PNP chief said that he ordered the investigation of the three since internal communicationshould remain confidential and must not be leaked to the public to avoid alarming the people concerned.

Albayaide said he did not sign any such memorandum and added that most probably, there is "carelessness" on the part of some of his men.

He explained that if the memorandum really came from the PNP Directorate for Intelligence, it should remain for internal consumption only. He added that different PNP directorial staffs release their own routine reports and memorandum which do not go to the Office of the Chief, PNP.

Gen. Albayalde however said that as far as he is concerned, any such memorandum cannot be used to harass ACT members, not unless they are guilty of a crime.

"As I've said, I did not specifically order gathering of information on ACI members. But I will be extremely surprised if our intelligence community has not done so on ACI and other front organisations of the Communist Party of the Philippines identified by Jose Ma. Sison," the PNP chief said.

"It is the duty of the state to protect its ditzens and its interests against the enemies of the state (Communist Terrorist Groups or CPP/NPA) and its allies or front organisations enumerated by Jose Ma. Sison

such as BAYAN, KMU, KMP, LFS, GABRIELLA, ACT, KADENA, etc.

Gathering intelligence will allow the state to distinguish genuine progressives from unrepentant communist terrorists out to overthrow a duly elected government through violent means; routinely extort, burn and loot assets of businesses that gave livelihood to peace-loving citizens of this country, he added

"Now that Sison himself has identified ACT as a frontorganization of the CPP/NPA/NDF, the burden is now upon members of ACT to dissociate themselves from this terrorist organization and denounce its infiltration, manipulation, and use of the ranks of Eilipino educators," Gen. Albayalde said

National Capital Region Police Office chief Director Guillermo Lorenzo T. Eleazar said that even assuming that there are indeed such moves, he believes there is nothing wrong with it since its part of their mandate to find out what is happening in the country.

Eleazar said it's good for intelligence officers to have "many open sources" instead of just getting information on ACT from the Civil Service Commission and skipping its rounds in schools. However, he gave the assurance that police will not abuse the informationit gathered. "Alam namin ang tama at mali at hindi kami magwang mali at hindi kami magwang mali at hindi kami magmali "he said."

#### NORMAL POLICE WORK

Malacanang also said there is nothing wrong with the PNP's reported surveillance of ACT.

Presidential Spokesperson Salvador Panele said authorities will only monitor members of the Alliance of Concerned Teachers who have ties with communist rebels." If they have shown any acts that will be mimical to the state."

These efforts are part of the job of the police he said.

The Alliance of Concerned Teachers claimed over the weekend that police officers recently visited schools in Malabon, Cebu, Isabela and some Mindanao provinces, asking for the names of their members

The supposed profiling is meant to stille "all forms of opposition," claimed ACT, which last year earned the ire of President Rodrigo Duterte's daughter, Davao Mayor Sara Duterte, for claiming that her city does not give allowances to teachers.

#### NO INVENTORY REQUEST

The Department of Education (DepEd) has not received any request from the PNP regarding an inventory of teachers who are members of the Alliance of Concerned Teachers (ACT).

In a statement issued by DepEd on Monday it said the DepEd Central Office has not received any such request from the PNP.

The representative of the ACT earlier raised concern over alleged two endorsements by DepEd Schools Division Offices (SDO) of a supposed Memorandum from the PNP directing the inventory of teachers who are members of ACT.

# NUJP hits Red link, Joma 'supervision'

FORMER member and organizer of the National Union of Journalists of the Philippines on Monday asserted his knowledge of the "direct communication and supervision" of Communist Party of the Philippines founder Jose Maria Sison on the newsmen's group.

The statement came about a week after the same source, who called himself "Ka Ernesto" but did not divulge his real identity, made headlines in local tabloids and regional newspapers for calling out the "deceit and lies" of the CPP and its armed wing, the New People's Army, ahead of the communist group's 50th anniversary last Dec. 26.

In a statement also issued Monday, the NUIP disowned their supposed member and denounced the continued efforts in linking them to the communist revolutionary movement, saying the tagging "is part of an orchestrated effort to intimidate them into silence."

NUIP officers found themselves answering requests for interviews from community news outfits around the country, soliciting reactions to charges by the so-called Ka Ernesto.

When the union asked where the story originated from, the community outfits invariably pointed to banner stories carried by a number of Manila-based tabloids-Police Files Tonite, Bagong Bomba and Saksi Mata ng Katotohanan-which carried the exact same headline "NUJP pinamumunuan ng CPP-NPA-NDF\*\* (NUJP headed by CPP-NPA-NDF), the latter initials referring to the National Democratic Front, which Sison heads.

"It is hilarious that they keep repeating these charges since the NUIP's menibership represents a broad spectrum of creeds and political beliefs bound by a common dedication to defending and expanding the bounds of freedom of the press and of expression," the newsmen's group statement read. "But, as they say, stupid is as stupid does

Ka Ernesto, who requested that his full name not be made public for the sake of his personal safety as well as his family's, said the link between NUIP and CPP "is part of a collective effort of people from the communist organization supervised by a certain RSV, the group's political officer."

He said the NUJP has a direct link with the Utrecht-based Sison and the communisi leadership because of a "special operation' the journalists are supposedly spearheading-that is, to shield members of the NPA who are getting arrested.

Being a "longtime member" of the CPP, Ka Ernesto said he is a witness of the communications and dialogues of "RSV" and a certain "JMS" on Facebook Messenger and other social media chat apps. and claimed to have deciphered messages

of those communications.

He said he has been with the movement for a long time and he can attest to the fact that the operations and leanings of NUIP are being manipulated by the communist

Ka Ernesto claimed to be a pioneer of the NLUP and had been active in recruiting and influencing laborers to form union groups in different newspaper companies.

He said he started out as a youth organizer for the College Editors Guild of the Philippines and became editor-in-chief of a college paper of a known university in Metro Manila.

He added that he did finish his college degree after he was convinced by the CPP to go full time in the group's "legal point."

This is the second time in a few weeks the NUIP has been linked to the rebels since a certain Mario Ludades, claiming to be one of the founders of the CPP, accused the group of being a "legal front" of the underground movement in stories run by several outfits on Dec. 26, incidentally the 50th anniversary of the CPP.

Ka Erneste, however, said the CPP "will get back at him" since he had been speaking of the "wrongdoings" of the communist group.

He said he spent 12 years as the movement's organizer of youth for the CPP and as a fact-finding journalist in areas where the NPA is being defeated by government troops during encounters.

There is no way the communists can oust President Rodrigo Duterié who enjoys a very high trust and approval ratings from the people, Ka Ernesto added

#### MILF OFFERS TO SECURE COTABATO

DAVAC CITY—The Moro Islandic Liberation Front (MILF) on Monday offered to secure Cotabato in the wake of reports that armed men were planning to attack the city that was rocked by an explosion on New Year's Eve that killed two people and wounded 30 others.

Von Al Haq, spokesperson for the Bangsamoro Islamic Armed Forces (BIAF), the MILF's armed wing made the offer as he appealed for calm amid social media reports that gunnen would sow chaos in Cotabate City.

He called the reports "fake news," saying these were spread by people hired by a group opposing the inclusion of Cotabato City in the new Bangsamoro region that would be created after the ratification of the Bangsamoro Organic Law (BOL).

"The MILF's BIAF is ready to provide even a battalion of fighters to help secure the peripheries of Cotabato City should the proper government agencies request for augmentation," he told the Inquirer by telephone.

#### Request

Al Haq was referring to either the military or the police, which, he said, could make the request through the coordinating committee on the cessation of hostilities, one of the mechanisms in the peace process between the MILP and the government.

During the Marawi siege in 2017, the MILF ordered its troops to stand guard in the peripheries against terrorists escaping from the city, he said

For the plebiscite to ratify the BOL, the MILF wants peace and order to reign during the exercise, particularly in Cotabato City that has been serving as seat of the Autonomous Region in Muslim Mindanao (ARMM) for the last 28 years, Al Haq said.

The BOL. which is anchored on the final peace agreement between the government and the MILF that was signed in 2014, seeks to establish the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) to replace the ARMM.

replace the ARMM.

The Commission on Elections has scheduled the plebiscite on Jan. 21 and Feb. 6.

Cotabato twice rejected its inclusion in the ARMM, and its mayor, Cynthia Gulani-Sayadi, had said the city "would do the same in the upcoming plebiscite."—BONG SARMIENTO INQ

the 1996 peace accord with the Moro National Liberation Front (MNLF), an MNLF official said yesterday.

A total of 38 people consisting of 20 soldiers, five policemen and 13 civilians were killed during the siege.

The battle between state forces and MNLF rebels also displaced 100,000 city residents.

Emmanuel Fontanilla, MNLF spokesman, in an interview with Daily Tribune, said in March 2013 the government and MNLF peace panels were in the final stage of resolving the remaining contentious issues in the agreement when the government panel issued a notice terminating the peace talks.

"After the government panel walked out from the negotiating table, the MNLF had no option but to pursue its original political objective, which is declaring the independence of the Bangsa More Republik (BMR)." he said.

The MNLF has declared Davao the capital of BMR in its petition with the United Nations (UN), which recognizes the granting of independence to all colonized countries, Fontanilla added.

During the proclamation of independence in July 2013, MNLF founding chairman Nur Misuari declared Mindanao, Palawan Tawi-Tawi and Basilan including the Malaysian island of Sabah and Sarawak, as part of the BMR territory.

#### Noynoy plays general

After hoisting its flag in Davao City the next stop would have been Zamboanga City but government forces thwarted the MNLF mission after it intercepted a pump boat loaded with 30 MNLF guerilias. The battle ensued afterwards.

"After terminating the peace talks, Aquino then ordered an all-out war against the MNLF in Zamboanga city using military air, land and sea assets," he said.

At the height of the fighting, Aquine was sighted in full combatgear as if leading the troops in the operation.

According to an MNLF source, Aquino also set up a "war room" where he personally directed troop movements using a computer.

The MNLF declaration of independence gained the attention of the international community, particularly the 57-member Organization of Islamic Cooperation (OIC), which closely watches political developments in Mindanao.

The OIC has granted the MNLF a permanent observer status during plenary sessions and also recognized Misuari as the sole representative of Muslim Mindanao.

Misuari, however, ordered the shelving of MNLF's independence petition to pave the move by President Duterte for the shift of the form of government from a unitary to a federal set up, which the secessionist group fully supports

After the government panel walked out from the negotiating table, the MNLF has no option but to declare the independence of the Bangsa Moro Republik.

"No more political activities related to the independence and the petition to the UN happened." Fontanilla said.

He added the MNLF peace panel is again ready for the resumption of the stalled peace talk for the full implementation of the 1996 peace agreement abandoned by Aquino.

Fontanilla said they are waiting to be notified by the Office of the Presidential Peace Adviser for the resumption of the discussions

Earlier, President Duterte announced his willingness for a new round of talks with Misuari to prevent the "dismemberment" of the country.

#### Hopes high

With the appointment of retired general Carlito Galvez as the new peace adviser, we are optimistic that the MNLF and government panels will soon return to the negotiating table," he said.

#### Plebiscite preparations ongoing despite SC petitions vs BOL

Unperturbed by the two petitions filed in the Supreme Court (SC) against the Bangsamoro Organic Law (BOL), the Commission on Elections (Comelec) is not about to slow down in its preparations for the plebiscite on Jan. 21 and Feb. 6.

in an interview, Comelec spokesman James Jimenez said they cannot allow

themselves to be sidetracked.

"We are not bothered by these petitions. If the SC issues a temporary restraining order (TRO), only then will we stop what we are doing," Jimenez added.

The Comelec official said they do not want to be "caught flat-footed" if they stopped the preparations and no IRO is issued by the SC

"Remember, the challenges are not directed versus Comelec but the law itself. If ever the Comelec is going to be a party, it's just incidental because we are the one that enforces it," he maintained,

#### Muslim accountants back BOL

Meanwhile, a national organization of Muslim accountants vesterday asked the SC to uphold the legality of the BOL

In a 51-page answer-in-intervention, the Philippine Association of Islamic Accountants (PAIA) supported the solicitor general in defending the constitutionality of the BOL and asked the SC to dismiss the petitions filed by the Sulu provincial government led by Gov. Abdusakur Tan II and the Philippine Constitutional Association

Joined by Commissioner Manuelito Luna of the Presidential Anti-Corruption Commission, PAIA led by its president Amanoding Esmail argued that the BOL or Republic Act 11054 does not violate Article 10, Section 18 of the 1987 Constitution, which authorized only one organic law to establish the Autonomous Region in Muslim Mindanao (ARMM)

The group stressed that the Constitution allows Congress to repeal and amend

the ARMM

"It is our submission that autonomy in the Constitution is a juridical entity and it may undergo metamorphosis into its better form by congressional legislation in

the name of general welfare or the welfare of the Bangsamoro," read the pleading.

"No doubt, the autonomy provisions in the Constitution constitute the legal formulation of the resolution of the Bangsamoro struggle for self-determination, which is an issue of social justice that is rooted in their marginalization by the majority population of the country for centuries. Against this social backdrop, there cannot be any one masterstroke to span the social gap and mend the relationship," it pointed out.

#### Fight vs insurgency. terrorism

For its part, the military will work with Filipino Muslim communities in the effort to end the country's insurgency problem and the threat posed by terror groups.

Armed Porces of the Philippines (AFP) chief Lt. Gen. Benjamin Madrigal Jr., speaking at his first flag-raising ceremony in Camp Aguinaldo vesterday, called on his fellow officials and soldiers to strive for excellence

Madrigal added that the AFP will "fully support the conduct of the plebiscite" for the BOL and gave assurance the Bangsamoro people's exercise of their right to vote would be safeguarded.

"We also need to eradicate the existence of terrorist cells through our initiative on preventing and countering violent extremism with the support of concerned agencies and the Muslim community." Madrigal said.

The new AFP chief, who assumed the post last month, laid out his intentions for the year, stressing the need to enhance professionalism and character development alongside achieving operational goals.

"To reach higher levels of success, it is imperative that we possess a deeper sense of dedication, teamwork, professional competence and commitment to excellence," he said. Madrigal reminded his fellow officials,

officers and soldiers of the AFP's goal of putting an end to the armed conflict and the terror threat in the country

"We will carry on and push our strong will to score a complete victory and finally put an end to local communist armed conflict. We will focus on capacitating

# Dureza confident BOL will become a reality

AVAO CITY – Former Presidential Adviser for the Peace Process (PAPP) secretary Jesus Dureza expressed confidence that the Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao (OLBARMM) will become a reality, saying that the fruits of the 50-year Moro struggle, that was marked by loss of lives, human sufferings, and agony, will soon "ripen for everyone to harvest."

"I am not a Moro but I am a Bangsamoro. I grew up from childhood and lived in the Moro homeland of Mindanao. I know the BOL (Bangsamoro Organic Law) will be a reality. No doubt about it," he said in a statement on Monday.

Dureza, who resigned as PAPP secretary in November 2018 following the corruption controversies involving some of his executives, said the ratification of the BOL would not deliver "magical instant results" but nevertheless called on the people to help nurture, tend and nourish it one step at a time until it becomes sustainable.

The Commission on Elections (Comelee) has scheduled two separate dates for the plebiscite of OLBARMM. The January 21 will be for the voters in the six provinces and two cities in the ARMM as well as Cotabato City and Isabela City in Basilan while and February 6 for the province of Lanao del Norte, except Iligan City; the municipalities of Aleosan, Carmen, Kabacan, Midsayap, Pikit, and Pigkawayan in the province of North Cotabato; and all other areas that asked for inclusion in the future BARMM.

Dureza said he was also optimistic that Cotabato City and Isabela City of Basilan, situated at the heart of the ARMM but which are still not part of core territory, will decide to join the future Bangsamoro government that will replace the present ARMM when it gets ratified.

He urged the people to give the OLBARMM the last chance to work as the best step to take despite the trauma suffered and the lingering doubts of the people.

He also said that the social healing and acceptance are starting points for cohesion.

"It may take time but now is the best time to start. There are still untold benefits to the area that need to be shown. A rejection may worsen the situation with a disabling environment. No one can survive as an island apart from the rest," he said. Despite the perceived objection of the province of Sulu to OLBARMM for the moment, Dureza said it should not be a cause for concern, as he believed the people of the province will see the light and give the law a chance to prevent engendering animosity, enmity and inevitably distance and dissatisfaction stemming from a "no vote."

"We understand why there are discordant voices and they are not without reason. But since there is no way to 'opt out' of the original ARMM inspite of the 'No' in Sulu province, the result will be of no moment. Sulu will be part of the new BARMM, notwithstanding," he said.

"If things do not happen as expected, it's not the end of the world. We still have President Duterte whose remaining years in office will enable him to surely align matters, in his own bold—at times, unconventional ways. Truth to tell, were it not for him, this rare chance would not have come to pass," he added.

He said the people should trust Duterte as the OLBARMM is "his baby" and that he will not allow this to be a wasted legacy.

If all else fails, Durèza said the OLBARMM can still be amended or changed to suit the prevailing situations and climes.

## Muslim accountants ask SC to dismiss case against BOL

A group of Muslim accountants and several individuals have joined the government in asking the Supreme Court (SC) to dismiss the petition against the constitutionality of the Bangsamoro Organic Law (BOL) or Republic Act No. 11054.

In their pleading, the Philippine Association of Islamic Accountants (PAIA) told the SC that the Constitution allows Congress to amend, revise, or strengthen the law that created the Autonomous Region in Muslim Mindanao (ARMM)

The group, in effect, joined the Office of the Solicitor General (OSG), the government's law firm, which sought the dismissal of the petition filed by the Sulu provincial government through Gov. Abdusakur Tan II.

RA 11054 was signed into law by President Duterte in July last year. It expanded the ARMM with the new Bangsamoro Autonomous Region (BAR) with greater fiscal autonomy, regional government, parliament, and justice system.

BAR will be composed of the current ARMM members - Tawi Tawi, Sulu, Basilan, Maguindanso, and Lanao del Sur. To be added to the region are six municipalities in Lanao del Norte, 39 villages in Cotabato, and the cities of Isabela and Cotabato subject to the approval of voters in the areas.

The Commission on Elections (Comelec) has set the plebiscite for the BOL on January 21.

The PAIA said the BOL did not violate the constitutional principle of separation of powers in the government.

"In the traditional structure of power in political democracy separation of power is apportioned between the Executive, the Legislative and the Judiciary, with the Executive executing the law and seeing to it that the law is faithfully enforced or complied with, the Legislature making the law and defining state policies, and the Judiciary interpreting the law This political rule underwrites the principle of check and balance. And the BOL, provides for this political arrangement." It said.

Earlier the OSG—in its comment to Tan's petition—told the SC that HA 11054 does not violate Sections 18 and 19. Article X of the Constitution that mandates only one organic act to establish the ARMM.

It said that RA 11054 which created the BAR was not exactly a creation of a new autonomous region as described in the Constitution, but rather an amendment of the organic act and an expansion of the territorial jurisdiction of ARMM.

### Dismiss petition vs. BOL—'Minda' group

THE Supreme Court has been asked to dismiss the petition filed by Sulu Gov. Abdusakur Tan II seeking to declare as unconstitutional Republic Act No. 11054, also known as the Bangsamoro Organic Law.

In a 51-page answer-in-intervention, the Philippine Association of Islamic Accountants, Inc. led by Amanoding Esmail argued that the BOL is far better that the present Autonomous Region in Muslim Mindanao.

Refuting the arguments of the petitioner, the PAIA said that Section 18 and 19, Article X of the Constitution do not prevent Congress from passing legislations establishing or strengthening or even abolishing the ARMM and creating a new one.

The petitioner earlier claimed that the BOL violates the 1987 Constitution, particularly Sections 18 and 19, which created the ARMM.

PAIA insisted that there was no legal basis to abolish the ARMM and that if the government wants to do it, it can only be done through amending the Constitution.

The group emphasized that Section 19 can be construed as a mere directive for the first Congress elected under the 1987 Constitution to pass the organic acts for the autonomous regions in Mindanao and the Cordilleras within 18 months from the time of its organization while Section 18 relates to the process of such organic acts.

"Petitioner overreached in opining that the constitutional provisions delimit the legislative power of Congress; it is reading something into the provisions," the group said.

The PAIA also accused Tan of "over-reading" the law in saying that the BOL violates the constitutional principle of separation of power and check and balance.

"In the traditional structure of power in political democracy, separation of power is apportioned between the Executive, the Legislative and the Judiciary, with the Executive executing the law and seeing to it that the law is faithfully enforced or complied with, the Legislature making the law and defining state policies, and the Judiciary interpreting the law. # Peaceful BOL plebiscite

Presidential spokesperson Salvador Panelo said the Executive Branch will respect the sovereign voice

The New Year's Eve bombing in Cotobato City was a "peace spoiler" but the Moro Islamic Liberation Front (MILF) yesterday committed to a peaceful ratification of the Bangsamore Organic Law (BOL) and rowed to honor whatever is the result of the polls.

Defense Secretary Defin Lorenzana relayed the MILF commitment as the Armed Forces of the Philippines (AFP) reaches its height of preparations to ensure the orderly and smooth holding of the 21 January plebiscize in areas under the Autonomous Region in Muslim Mindanao (ARMM) and the cities of Isabela and Cotabato City, where a recent blast had killed two and injured.

a score of others.

"The MILF leadership pledged to have a peaceful plebiscite and will honor the result," Lorenzana said.

The MILF is pushing for the ratification of BOL – a result of its decades long peace negotiations with government which was signed into law by President Duterte last year. Once ratified, it will allow Bangsamoro more autonomy.

Lorenzana stressed that only members of the AFP and the Philippine National Police (PNP) will carry firearms upon approval of the Commission on Elections (Comelec).

#### The MILF leadership pledged to have a peaceful plebiscite and will honor the result.

Government security forces are an alert against the so-called "peace spoilers" who want to disrupt peace in Mindanao.

Cotabate City Mayor Cynthia Guiam-Sayadi claimed that an MILF commander had issued a threat prior to the explosion in a Cotobate City shopping mall. Cotabate City is said to be against the BOL.

"The AFP and the PNP commanders are closely coordinating. It will be determined by them if there is need for additional troops. We are all upbeat that the plebiscite will be conducted peacefully and that the people will be able to vote according their choice," Lorenzana said:

Meanwhile, AFP Chief of Staff Lt. Gen. Benjamin Madrigal assured the people that the military and police will do their best in ensuring a peaceful and orderly plebiscite.

"We just want to check on the apprehension of the constituents. The Armed Forces and the PNP want to assure our people that we are doing everything to ensure that we are able to conduct the plebische peacefully and orderly." Madrigal said.

Malacanang, meanwhile, maintained it is leaving the BOL's fate at the hands of the people.

Presidential spokesman Salvador Panelo said the Executive Branch will "respect the sovereign voice."

"Of course, the Palace is pushing for the ratification. However, as always, the people will have to decide on that. In those areas affected, the decision is up to them. We will have to respect the sovereign voice," he said.

Lorenzana stressed that only members of the APP and the PNP will carry firearms upon approval of the Comelec.

Panelo also stated they would let the Supreme Court (SC) decide on the constitutionality BOL following a petition by Philippine Constitution Association (Phileonsa) slamming the creation of two autonomous regions in Mindanao.

"We'd rather not say anything about it because it's sub judice. We'll let the Supreme Court decide," the spokesman reiterated. In its petition before the SC, Phileonsa

In its petition before the SC, Phileonsa argued that the BOL violates Sections 18 and 19 of Article 10 of the 1987 Constitution which allows the enactment of only one organic act for Muslim Mindanao.

Under the BOL, the same ARMM provinces will still comprise the new region while Cotabato City, Isabela City, six Lanao del Norte towns and 39 North Cotabato provinces may opt to be included.

Solicitor General Jose Calida has already filed a counter move asking the SC to junk Philiconsa's petition.

# Batocabe murder closure demands political culture reform

VEN though there is more to do and resolve in the investigation of the murder of AKO BICOL Party-list Rep. Rodel Batocabe, there is already plenty to commend in the police investigative work done on the case. Also commendable is the firm leadership of the Philippine National Police (PNP) by Gen. Oscar Albayalde and his team of officers.

It is thrilling for us to say this, given the roller-coaster story and the sometimes tragic, sometimes heroic, and always dangerous image projected by the force during the past two-anda-half years.

With respect to the Batocabe murder, the following must certainly be said:

First, the PNP was able to quickly find, neutralize and arrest the six suspects in the killing.

Second, responsibility for the murder has been established because the arrested suspects have all implicated Daraga Mayor Carlwyn Baldo as the mastermind or the brains behind the killing.

Third, the PNP has filed double murder charges against Baldo and the six suspects. The PNP chief and other police officials believe they have an airtight case against Baldo and the other suspects. They are fully convinced that they can convict the accused, if the case goes to trial.

The major blemish of the case at this stage is that Mayor Baldo remains at large, and has so far successfully eluded arrest. All efforts should turn now toward arresting him.

The PNP should be ever aware that the country has a sorry history in catching accused individuals who run from the law, become fugitives and who even subsequently get elected to office. Lapses in law enforcement in the past, for whatever reason, should never be used as an excuse for failure. On the contrary, they should impel resolve to not let Baldo get away

We believe extra effort must likewise be taken to reconstruct the full story behind this appalling case. The nation needs credible answers to a host of questions.

1) Why was Congressman Batocabe really murdered? It's too simple and superficial to say that the killing was politically motivated. "Politically motivated" is not an acceptable explanation, it sounds more like a cover for something.

2) Far more useful is to find the back story behind this killing. Were Batocabe and Baldo political allies or rivals? Did they support each other in past elections? Was there a break of an alliance of friendship? Was there enmity between these two politicians?

3) Since Batocabe is a native son of Daraga and a congressman, it is not possible that the two had no official or personal dealings or relationship with each other.

The extreme recourse to murder for hire by a sitting public official suggests a serious psychological reason behind the killing.

4) It has been reported that Baldo had some NPA fighters in his employ. How were these people employed, and for what purposes? Is the NPA involved in the Batocabe killing or in any of Baldo's activities?

5) Is Baldo the ally of other Albay politicians and public officials? Who are these officials? Did Baldo and the Daraga local government partake of the pork barrel or pork projects of Albay congressmen and Bicol senators, Batocabe included?

We raise these questions because they are all material for comprehending and resolving this case.

We raise them to help the PNP and its investigators resolve the case to public satisfaction, and certainly not to instruct our one and only national police.

There are also lessons here for our political leaders and political parties.  $\hbar u$ 

political parties.

Reform of our politics is clearly just as important as police work in bringing closure to the Batocabe murder.

#### PH-US 1951 MUTUAL DEFENSE TREATY


Defense Secretary Delfin Lorenzana recently said it is time to review the 1951 Mutual Defense Treary (MIDT) between the Philippines and the US.

He stressed that the ultimate goal of the review is to either "maintain, strengthen or scrap it."

That's great news.

I assume Lorenzana had the go signal of President Digong to have the treaty reviewed. I have long been voicing in this space support for Digong's promise to get rid of. foreign troops on our soil. Such a review could conceivably result in the fulfillment of his promise.

If I may be so bold as to suggest, however, a review of the Visiting



Forces Agreement (VFA) and the Enhanced Defense Cooperation Agreement (EDCA) should also be undertaken simultaneously because they are inextricably linked

In this regard, I also wish to reiterate my previous proposal for the creation of a committee to review and reassess the whole gamus of PH-US relations in the context of present day realities with a view to making recommendations that would be consistent with Digong's vision of what those relations. ought to be.

Interestingly, an opposition stalwart, Cong. Gary Alejano, supported the call for a review of the MDT.

Curiously, however, Foreign Secretary Teodoro "Tweever" Locsin, Jr., has not tweeted or issued a statement on the review. Is he for or against such a review? I suspect it is the latter.

Just before Christmas, he was

reported to have met with US Secretary of State Michael Pompeo in Washington.

A press statement issued by the US Department of State said "the two Secretaries discussed ongoing efforts to address regional issues such as the South China Sea, North Korea, and counterterrorism."

Did they now? Certainly, it couldn't possibly have been an indepth discussion of the issues mentioned. Just like all his producessors, I think Locsin merely paid obsisance to his counterpart, period.

#### LOCSIN AND THE CANADIAN WASTE

The South Korean government has agreed to take back 6,500 tons of garbage and hazardous waste imported into the Philippines in keeping with its contractual obligation under the Basel Convention that govern the movement of hazardous wastes between nations.

In contrast, the Canadian wastes that were brought into the country some five years ago continue to rot at the Bureau of Customs.

What is our government doing to return the wastes to Canada? And the freaking Canadian government? Two years ago, its Prime Minister, Justin "Trashy" Trudeau, promised to implement what he pompously called the "Trudeau Solution." (This Trudeau appears to be prone to reneging on his commitments. Remember how he also reneged on selling 16 helicopters to us?).

Sources say that a working group has been established to consider a number of legal and technical issues before a decision could be raken on the matter.

Say what?! What's the difference berween the South Korean and Canadian wastes?

I think this is one instance where the DFA head, "Tweeter" Locsin, could start making appropriate noises by tweeting the Canadians to take back their wastes instead of dipping his middle finger in issues that do not concern his department.

"Barman, a second round for everyone but him, and this time take it all from the top shelf."


The Nazi looks again at the Jew and notices that he is STILL smiling back, and even warmer than before

THE big news last week was the local stock market roaring into the new year with an unprecedented upsurge that beat out almost all other markets globally.

The PSEI gained by about four points over three straight days of upticks to Friday, making it the world's second-best performing index according to Bloomberg. BDO's chief market strategist Jonathan Ravelas expects the market to test the 8,000 level sometime the first half of the year, and "sooner rather than later"

Various reasons prompted this market optimism better-than-expected GDP growth last quarter, double-digit improvement in corporate earnings last year, even spillover effects from the start of campaign-related spending.

The boys at the Department of Finance had been saying all along that the inflation spike last year would only be temporary—the product of one-off effects from excise tax hikes that would eventually be offset by higher disposable incomes after income tax rate outs start to kick in

What also happened—also as predicted-was the successful management of rice prices and supply—with the implementation of further rice import liberalization and tarifficatio-as well as the moderation of global oil prices, which will now allow government to again raise oil excise taxes as scheduled this year.

All of this prompts me to ask. Where are all those inflation hawks now? What happened to all those doomsnyers who were roundly blaming last year's inflation spike on the Duterte administration and its aggressive pursuit of tax reform and infrastructure spending?

And so it's evident that this statement from ACT is simply intended to allow them to continue to provide such cover, hiding under the glossy garb of "academic freecom.

So shouldn't we open the field to anyone and everyone who can bring in the money and technology to fill that gap? The more the merrier, right? But this straightforward logic totally escapes Mr. RJ, who can only mumble that the two dominant telcos can still build a needed tower if the tower company fails to respond positively within 30 days.

What in God's name does that have to

do with anything?

Luckily for us, the acting DICT Secretary Eliseo Rio—a former general whom I was lucky to recruit into the board of Bayantel during my stint there—is standing his ground on plain common sense. And I have no reason to doubt that his reported successor, outgoing Senator Greg Honasan, will behave any less reasonably.
