

Tongues have been wagging about a notorious Ilocos Norte official nicknamed "Engineer Forty," who, as the story goes, routinely pockets a 40-percent cut of the cost of infrastructure projects in the district.

It's local lore that seems steeped in reality if one considers what happened in a Promillion flood control project on the Laoag river basin tributary that runs through the villages of Bacsil, Lataag and San Mateo in Laoag City.

Barely a week after the project was completed in July 2018, the concrete structure crumbled, leaving officials redfaced and residents angry.

Pork in the budget

The incident, according to Sen. Panfilo Lacson, is one of the new manifestations of pork in the budget—where contractors shortchange taxpayers by using low-grade materials for infrastructure projects, while gifting agency officials and law-makers with huge commissions in exchange for the contracts.

Pork, public money used to finance projects proposed by lawmakers, is a source of kickbacks.

But over the years, legislators in cahoots with agencies and contractors have become

creative in larding the government's budget, according to Lacson, who earlier exposed the insertion of multibillion-peso allocations in the districts of favored legislators, wastage of P583.5 billion in discontinued or shelved projects, and P74.6 billion in road projects marred by right of way issues.

At present, Lacson said, the going rate for kickbacks is "10 percent [of the project cost] to the legislator, and 5 percent to the agency."

It's the contractor who would shell out the money, often in the millions of pesos, to satisfy the politicians, he told Inquirer editors and reporters during a briefing in December last year.

So how do contractors make money?

"Substandard materials," Lacson replied.

Public money wasted

This was precisely the case with the Laoag flood control project, which began construction on Feb. 12, 2018, and was

completed on July 11, 2018, Lacson said.

"One week after construction, it caved in," he said.

Former Ilocos Norte Board Member Melvin de la Cuesta, who inspected and photographed the site, said the dike "collapsed like a fallen curtain."

"Clearly, the project is substandard and it needs investigation by appropriate agency. Public money is wasted through anomalous projects," De la Guesta said in a Facebook post on Aug. 30, 2018.

Contacted by the Inquirer on Monday, De la Cuesta said he found that no steel bars were used to build the dike, making the foundation weak.

"The cement was thin," he added.

'Soil was loose'

De la Cuesta recalled the controversy the debacle stirred among officials of the Ilocos Norte provincial government and the investigation that followed.

"The excuse of engineers was that the soil was loose," he said.

The contractor, Katha Builders and Supplies, eventually bowed to public pressure and reconstructed the dike, according to De la Cuesta. It is now back in operation.

According to the records, the Laoag project was given P9.503,768.23 in the General Appropriations Act of 2018, with the Department of Public Works and Highways (DPWH) district engineering office as implementing agency.

Katha Builders is one of the top contractors of the DPWH under the Duterte administration

According to data compiled by the Philippine Center for Investigative Journalism, the company based in Santa Maria, Bulacan province, cornered DP-WH contracts valued at P235.5 million from July 2016 to December 2017.

The Inquirer tried but could not reach Katha on its listed contact numbers.

65-35 sharing

Lacson said pork, by definition, was a "postenactment" practice, meaning lawmakers would insert funds into the budget law after it had been passed.

But the practice stopped in the aftermath of Supreme Court decisions striking down the pork barrel system and its iterations, including the Priority Development Assistance Fund, as well as graft and plunder cases sparked by the Pto-billion pork scam involving businesswoman Janet Lim-Napoles.

In the case of the Napoles scam, Lacson said it involved mostly soft projects, referring to social welfare programs.

"So with Napoles, 65 percent went to the legislator, while Napoles got 35 percent. The costs were also shouldered by Napoles, while 65 percent went cleanly to the legislator. Napoles would get some from the remaining 35 percent to cover the operation," he said.

These days, Lacson said pork insertions would happen even before the President submitted the proposed budget, or the National Expenditure Program (NEP), to Congress.

"Sometimes the congressman or the agency could get an advance from the contractor before the budget law was passed," he said.

The official reason is "exigency," he said. "If you wait for the passage of the GAA (General Appropriations Act) before bidding, then it would take too long, because our bidding process can be quite lengthy," he said.

Laguna bridge

On Jan. 10, Lacson called attention to an Inquirer story about a portion of a bridge under construction that collapsed in Pakil, Laguna province.

The DPWH district engineer blamed the contractor, St. Gerrard Construction General Contractor and Development Gorp., of Pasig City, saying the lack of scaffolding and other support systems caused the structure to collapse when the workers poured concrete.

Lacson lamented on Twitter: "If this happened in other jurisdictions, government agents would be knocking on some people's doors." INQ



US Navy exec axed for paid sex in Phi

The commander of a United States Navy submarine was relieved from his post in August following his admission of hiring female prostitutes while the vessel was docked in the Philippines early last year, according to a report published in a Washington state newspaper on Friday.

Capt. Travis Zettel, commander of the USS Bremerton, was fired in August "following a loss of confidence in his ability to command the Los Angeles-class fast attack submarine, which is now tied up in Bremerton for decommissioning," the Kitsap Sun reported.

The Bremerton, Washington-based daily said it based its report on documents received through a Freedom of Information Act request.

The report said the incident occurred during the submarine's port call in Subic Bay on March 1. Zettel was reportedly seen with 10 "provocatively dressed females outside the front door of (his) hotel" at dinnertime of that day, according to a tipster interviewed by the Naval Criminal Investigative Service (NCIS)

agents over the Department of Defense Inspector General's hotline.

The report added that Zettel told the tipster and another sailor that he had "requested/ ordered 10 girls to arrive at the hotel." Another sailor, according to the newspaper, told investigators he saw "Zettel walking around and talking to other sailors in his command with three local females holding onto his arm."

In May, almost a month after the vessel arrived in Bremerton for decommissioning, the NCIS launched a criminal probe and confronted Zettel with the allegations, the Kitsap Sun report said.

Zettel, a Puyallup, Washington native commissioned in 1998 and first served on board the USS Salt Lake City

Six of 10 Filipinos distrust China; US enjoys 84% Support-survey

Six of 10 Filipinos are distrustful of China, which is embroiled in a territorial dispute with the Philippines in the South Chna Sea, while eight of 10 trust the United States, according to the latest Pulse Asia survey.

The survey, which polled 1,800 adult respondents from Dec. 14 to 21, showed that 60 percent distrust China, down from 63 percent in March 2017.

Fifty-four percent of the respondents also distrusted Russia, the Philippines' new ally, down from 56 percent in March 2017.

The percentage of the respondents who trust the United States rose to 84 percent, from 79 percent in March 2017, while trust in Japan remained at 75 percent.

"I believe [the low trust in China] is largely due to the [South China] Sea disputes, un-

St. desperation

fortunately propped up by simmering historical and cultural biases against the foreign Chinese," said Jay Batongbacal, director of the University of the Philippines Institute for Maritime Affairs and Law of the Sea.

South China Sea conflict

The conflict in the South China Sea has "not been helped" by China's conduct in the strategic waterway, which Filipinos "perceive as unworthy of their trust." Batongbacalsaid.

Over the years, China has turned a string of reefs in the South China Sea into military garrisons.

By contrast, the United States, the country's traditional ally, has stepped up "freedom of navigation operations" in the 3.5-million-square-kilometer

sea to counter China's claim.

Former Solicitor General Florin Hilbay was more blunt, saying "Filipinos understand that a bully cannot be trusted."

"[It's] because [Filipinos] understand that China continues to disrespect our rights over the [South China] Sea, that its aggression is selfish and at the expense of the rights of Filipino fishermen," he said in a text message to the Inquirer.

Presidential spokesperson Salvador Panelo acknowledged that it may take time for Filipinos to begin trusting China.

Culturally closer

"Maybe as we go along and see China showing its sincerity with respect to agreements between the two countries, that perception might change," he said at a press briefing.

Batongbacal said Filipinos were historically and culturally closer to the United States.

Unlike the mainland Chinese, Filipinos share core values such as freedom and democracy with the Americans, and language is not a barrier

between them, he said.

"We tend to see them (Americans) in a better light," he pointed out, citing the close ties between the two longtime allies.

The Ulat ng Bayan survey, which had a margin of error of plus-or-minus 2.3 percentage points, showed that distrust was the prevailing sentiment toward China in every region and class (68 percent and 62 percent, respectively).

The Filipinos' high trust in the United States also did not come as a surprise to Panelo.

DND 'ready to respond' to threats in disputed sea

Malacañang on Monday said the government was prepared to "respond accordingly" should any threat arise from the increased presence of Chinese fishing vessels in disputed waters in the South China Sea. But the Palace refused to speculate on the report of Asia Maritime Transparency Initiative, which noted a substantial increase in the number of Chinese fishing boats at Philippine-claimed Subi (Zamora) and Mischief (Panganiban) reefs. "I am sure whoever is authorized to oversee that area will know what to do if they feel there's a security threat," presidential spokesperson Salvador Panelo said at a press briefing. He said he expected the Department of National Defense (DND) to look into the reported increase in the presence of Chinese fishing vessels in the disputed areas. —JULIEM. AURELIO

Panelo confident that DND looking into presence of Chinese vessels in PH sea

The Department of National Defense (DND) is expected to look into the reported increased presence of Chinese fishing vessels within the West Philippine Sea, Malacañang said Monday.

"I'm sure the Department of National Defense is doing that already," Presidential Spokesman Salvador Panelo said during Palace press briefing when asked if the government would conduct a probe on the alleged Chinese presence in the area.

"I'm sure that whoever is authorized to oversee that area ay alam nila ang gagawin nila if they feel na may security threat [they know what to do if they feel there is a security threat]," he added.

But for now, the Palace found nothing worrisome about Chinese vessels in Subi and Mischief reefs as long as they are only engaged in fishing.

"Kung fisherman lang naman, pareho rin tayo nagpupunta tayo doon sa what they claim to be theirs, pinababayaan tayong mag-fish. Walang problem kung fishing fishing lang (If they're just fishermen, it's the same situation as ours. We go there which they claim to be theirs. We're left alone to fish. There's no problem if it only involves fishing)," Panelo said.

He said allegations that fishing vessels loltering in Philippine waters were manned by Chinese soldiers were still "speculation."

"We don't know that yet. That's speculation," he said.

"Kung sino ang nagbabantay doon, alam nila kung may threat [Whoever is guarding the area, they know if there's a threat] and they will do and respond accordingly," he insisted.

An official from the Asia Maritime Transparency Initiative recently reported that satellite imagery showed the huge number of Chinese fishing boats operating in Subi and Mischief reefs located within Philippine territory. Only a few Chinese vessels allegedly showed signs of actual fishing in the area last year, according to the report.

Most Pinoys say US can be trusted, are wary of China

THE majority of the Filipinos polled believe the United States is the most trustworthy country following the return of the Balangiga bells last month, while China is the most distrusted nation, a Pulse Asia survey said Monday.

This emerged even if Chinese President Xi Jinping visited the Philippines two months ago.

In its survey on the trustworthiness of selected countries and regional organizations, eight out of every 10 Filipinos it

surveyed, Pulse Asia said 84 percent considered the US as the most trusted country while 29 percent had a great deal of trust and 54 percent had a fair amount of trust.

On the other hand, only 16 percent of the Filipinos surveyed expressed distrust in the US.

The second most trustworthy country among Filipinos was Japan with 75 percent, followed by Australia with 72 percent and the United Kingdom with 57 percent.

The same survey showed that Filipinos continued to distrust over China despite the country's "enduring relationship" with the Asian giant,

The pollster recorded that a majority of the Filipinos it suveyed, or 60 percent, did not trust China amid Beijing's continuous reclamation activities, weather system installation and strong presence over the disputed South China Sea or the West Philippine Sea.

However, with the several agreements signed because of Xi's state visit to the country two months ago, 39 percent of the Filipinos surveyed believe the country should at least extend a fair amount of trust to China.

Russia also emerged as the second least trustworthy

country for those surveyed with 54 percent saying they did not trust Moscow as against 45 percent who did.

Presidential Spokesman Salvador Panelo said the figures showing the Filipinos' trust and distrust on US and China were "understandable."

"It's understandable [for them] to feel that way because we have been used to the States being our allies. We have been accustomed to America," Panelo told reporters on Friday.

"Maybe as we go along, the public will see the sincerity of China. With respect to the agreements between the two countries, maybe it will change their point of view."

Panelo said the survey results did not mean President Rodrigo Duterte had failed to persuade the Filipinos to like China.

"It takes some time for people to accept certain changes that they are not used to it," he said.

The Pulse Asia survey was conducted after the US Department of Defense returned the historic Balangiga bells to the country as a sign of "healing and closure" between the two countries on Dec. 11, 2018.

Xi's visit last Nov. 20, on the other hand, paved the way for Manila and Beijing to forge 29 agreements.

The said survey, conducted from Dec. 14 to 21, 2018, used face-to-face interviews of 1,800 adults.

Some Western observers may hope China and the Philippines return to confrontation after the two countries' ties show signs of warming up in recent years, giving the US an excuse to get more involved in the South China Sea. However, we won't make their wish come true.

No matter how tough the South China Sea issue is, it doesn't represent

the entirety of the China-Philippines relationship. While expressing territorial claims in the South China Sea, the Philippines also enjoys the economic driving force that comes from China.

Bilateral relations are complicated.
Since Rodrigo Duterte was sworn in as the Philippines' president in 2016. bilateral relations have warmed up. Economic and trade exchanges are on the upswing, as the two countries expand cooperation in fields such as agriculture, tourism. real estate, infrastructure.

Thousands join interfaith rally for clean elections:

An estimated 6,000 people yesterday joined an interfaith rally and covenant signing in Quezon City for clean, peaceful, orderly and credible midterm elections in May.

Administration and opposition candidates attended the event together with officials from the Commission on Elections (Comelec), Department of the Interior and Local Government, Philippine National Police (PNP), Armed Forces of the Philippines (AFP) and other government agencies.

The activity started as early as 5 a.m. and ended at around 9 a.m., according to the Quezon City Police District (QCPD).

The event was preceded by a unity walk from various parts of the city and ended at the Quezon Memorial Circle.

On Monday, a US Navy ship sailed within 12 nautical miles of the Xisha Islands in the South China Sea, Some Western observers may hope China and the Philippines return to confrontation after the two countries' ties show signs of warming up in recent years, giving the US an excuse to get more involved in the South China Sea. However, we won't make their wish come true.

No matter how tough the South China Sea issue is, it doesn't represent

the entirety of the China-Philippines relationship. While expressing territorial claims in the South China Sea, the Philippines also enjoys the economic driving force that comes from China.

Bilateral relations are complicated.

Since Rodrigo Duterte was sworn in as the Philippines' president in 2016, bilateral relations have warmed up. Economic and trade exchanges are on the upswing, as the two countries expand cooperation in fields such as agriculture. tourism, real estate, infrastructure, manufacturing and energy.

Like China, the Philippines' primary strategy is to promote economic and social development. The South China Sea dispute sometimes puts pressure on economic ties, but economic cooperation can also be the key to the South China Sea dispute, f

Security preparations for May polls go into full swing

DAVAO CITY - Security preparations for the 2019 mid-term elections have started to go into full-swing as Police Regional Office 11 (PRO 11) placed its forces in the whole Davao region under heightened alert and the Regional Joint Security Control Center (RJSCC) in Northeastern Mindanao, or Caraga region, announced that it is already looking into reports of Communist rebels extorting money in exchange for permits to campaign.

PRO-11 director Chief Supt. Marcelo C. Morales said all police personnel in the region have been directed to closely watch their respective assigned areas, especially, with the start of the election period on January 19.

"I want you to look back on how we perform in the previous elections, fill the gaps and develop our performance, and make the voting day an ordinary one and let people choose leaders freely without retribution," Morales said, referring to police personnel in the region.

Morales also cited the Philippine National Police (PNP) Ethical Doctrine that states that PNP members shall provide services to everyone without prejudice regardless of party affiliation, following the existing laws and regulations.

To prevent their personnel from be-

ing influenced by politicians, Morales said, the region will have to reshuffle some of them, particularly those police officers who have a relative involved with a running politician.

"May I remind the city and provincial commanders to be non-partisan and that all police personnel must observe utmost discipline and professionalism at all times," Morales added.

The police regional director assured the public that the PRO-Davao personnel and its counterparts will continue working together to intensify the implementation of security plans all over the region.

Based on the intelligence community sources, the RJSCC considers the New People's Army (NPA) as the number one threat during the elec-

tion, considering that they are already reportedly collecting campaign election fees to candidates running in the May 2019 polls.

"We are still collecting reports pertaining to this alleged campaign election fees imposed by the communist terrorists," also said PRO 13 Regional Director Chief Supt. Gilberto DC Cruz.

No need for birth certificates

Palace: Old or current passport is all you need during renewal

certificates just because their data was lost, said Presidential spokesman Salvador Panelo.

He issued the statement after Department of Foreign Affairs (DFA) Secretary Teodoro Locsin Jr. said a "pissed" passport production contractor the government had terminated "made off" with the data.

Defense Secretary Delfin Lorenzana on Monday confirmed Locsin's revelation that the personal database of the public was taken by the company.

"It is a security concern. I believe this happened several years ago. The DFA (Department of Foreign Affairs) is looking into it and I am sure they will come up with an appropriate solution so that nothing of this sort happens again," Lorenzana said.

"It is a very grave security concern and quiet alarming. These are personal information such as full name, date and place of birth and other information that could be used illegally," he added

The situation prompted the DFA to "rebuild" its database for passports issued before 2010 because a previous outsourced passport maker took all the data when contract terminated. Locsin said passports issued after 2009 do not need to submit their birth certificates as the digital copy of the document is already stored in their database.

But Panelo, in a statement, rejected the idea of requiring applicants to bring their birth certificate for passport renewal.

"Applicants should not be burdened by submitting original copies of their certificates of live birth, obtaining which requires another application process before the Philippine Statistics Authority, to renew their passports just because the producer lost their relevant data," Panelo said.

"The submission of the old or current passport which the applicant seeks to renew should suffice for the purpose. The ongoing practice is not only cumbersome to everyone affected but is a form of red tape which this administration frowns upon and will not tolerate," he added.

Serious matter

Despite this, Panelo said the passport breach is a "serious and grave matter."

According to the Palace official, the National Privacy Commission (NPC) has been directed to investigate the incident and ascertain whether certain provisions of the Data Privacy Act of 2012, have been violated, particularly with respect to the personal information of the data subjects.

"The investigation should not, however, end here since the current arrangement for the printing of passports should also be examined to determine if there are violations of pertinent laws which may be detrimental to the public," Panelo said.

"We are one with the Filipino people in their quest for truth and so we will not treat this issue lightly," he added.

In a tweet, Locsin said he was wondering why the previous contractor was terminated in the first place.

"Why was the previous contractor terminated? New technology? Then demand it to acquire the new technology but leave the job to it. Di ba (Right)? But that means no kickback. In short, people made money by changing contractor," he said.

Locsin also said the DFA did nothing about it or could not do anything about it because they were in the wrong... However, he assured that such incident will not happen again.

"We did nothing about it or couldn't because we were in the wrong. It won't happen again. Passports pose national security issues and cannot be kept back by private entities. Data belongs to the

state," he said.

In a response to a netizen, Locsin said he was not sure how affected passport holders could be assured that their personal information would be protected.

"How can we be sure? I don't know. Why you guys who understand data acquisition and protection should keep up the attacks," he said.

Lorenzana said the Department of National Defense (DND) is ready to assist the DFA should they need their help to retrieve the personal information if still retrievable.

"We will get in touch with the DFA to find out the details of this issue and how to mitigate its ill effect," Lorenzana said.

Earlier, Secretary Locsin vowed to "autopsy" those behind the alleged data breach in the passport system, as well as the "yellows" who orchestrated the existing service contract to manufacture the E-passport.



In a series of tweets over the weekend, Locsin suggested that a Senate probe should be held in order to unmask those who perpetrated the crime and for the Department of Justice (DOJ) to file the appropriate charges.

"I will autopsy the 'yellows' who did the passports deal alive. This is called evisceration," Locsin said, apparently referring to people closely identified with the Aquino administration.

Locsin's reactions came following reports that former private contractor, Oberthur, reportedly took all the passport data when its contract was abruptly terminated to give way to the entry of APO Printing Unit, a tiny and little-known division under the Presidential Communications Office (formerly the Office of the Press Secretary).

Oberthur is a French company that was hired by the Bangko Sentral ng Pilipinas (BSP) through bidding, to supply all the materials necessary to produce the machine-readable electronic passports (MREPs).

The BSP was the official printer of Philippine passport from 2006 to 2015. Its agreement with the DFA was terminated three years ago to give way to APO's entry.

Locsin said the current problem that the DFA is facing started under the administration of former President Gloria Macapagal Arroyo and "got worse" under the term of President Benigno Aquino III.

"It will be solved by PRRD (President Duterte) and DFA under Locsin. The yellow crowd who perpetrated the passport fraud are in panic because we are gonna autopsy their crooked deal. Period," he said.

He further assured that "no power on earth" could stop him from unravelling the truth behind the passport mess.

"I just want it fixed and not repeated," the foreign affairs chief said.

Since Locsin assumed office last October, his Twitter account has been swamped with complaints from netizens about the new DFA regulation requiring those who are renewing their passports to present their birth certificates.

Meanwhile, Catholic Bishops Conference of the Philippines Episcopal Commission on Migrants and Itinerant People chairman and Balanga Bishop Ruperto Santos said the alleged data breach in the passport system should be probed.

Santos said the matter should be thoroughly investigated and those guilty punished for the sake of overseas Filipino workers who will also be affected by this incident.

"We appeal for thorough investigation, no sacred cows, those guilty be prosecuted," he said. (With a report from Leslie G. Aquino)

Yasay: No passport data stolen

FORMER Foreign Affairs Secretary Perfecto Yasay Jr. yesterday said current Foreign Affairs chief Teodoro "Teddy Boy" Locsin Jr. could have been "misinformed" about the supposed breach of data of passport holders as he belied Locsin's claim that data was stolen by a private passport printer after its services were terminated by government.

Yasay also said Locsin may have been given the wrong information by certain DFA officials to "deflect the real issue of the passport mess," which he said is the violation of provisions of the contract awarded to APO Production Unit. Inc. (APUI) for the production of machine-readable electronic passports, which states the agency could not subcontract the project to a private firm.

"So it was, to my mind, on that score that Secretary Locsin was misinformed," he said.

Locsin said he was not misin-

formed.

"I love Perfecto Yasay but I am not 'misinformed' although I lack more information on what (Chief Presidential Legal Counsel Salvador) Panelo rightly says demands deep investigation: the anomalous DFA-BSP-Oberthur/APO passport contracts. My predecessors seem to be panicking. I don't know why," Locsin said.

Yasay, who served as DFA chief from June 2016 to March 2017, said it is impossible for French firm Francois-Charles Oberthur Fiduciare (FCOF or Oberthur) to run away with the data as claimed

by Locsin last week.

He said when the DFA awarded the production of a new electronic passport system to APUI in October 2015, which subcontracted it to United Graphic Expression Corp. (UGEC), Oberthur simply "withdrew" as it already completed its contract.

"When APO and UGEC came in, Oberthur withdrew. After all it was just assisting the government in the management of the operating system for free. Oberthur already completed its contract. To say now that Oberthur ran away, with the data is completely false," Yasay said in an interview with ANC News.

"There is no data breach by Oberthur. Computerized passport data has

always been with the DFA which it turned over to APUI-UGEC," he added.

Earlier, Yasay said in a Face-book post that sometime in October 2015, the DFA awarded the contract for the printing of the e-passports to APUI which then "subcontracted" it to UGEC. He added that when the APO and UGEC took over the passport production, the data, which was initially in the facility of Bangko Sentral ng Pilipinas, was moved to a facility in Lipa, Batangas.

With this, Yasay said the DFA may not have been able to access the data because of the new system

by APUI and UGEC.

"It is preposterous and malicious and completely false for the DFA or anyone else to say that Oberthur ran away with the data because they could not run away with it," he said.

Yasay, in the same interview, also said he tried to resolve the is-

sue on the passport printing mess but "some powerful members of Congress intervened, powerful members who are also members of the Commission on Appointments (CA), and said there was nothing wrong with the contract."

Yasay failed to get the CA nod for his appointment as foreign affairs secretary, leading to the appointment of Alan Peter Cayetano

to the post in 2017.

He declined to identify the Congress members who allegedly

intervened.

Locsin reiterated the current administration has nothing to do with the mess. He said the problem started during the time of then President, now Speaker Gloria Macapagal Arroyo.

He also said there is "no leak so

far" of the passport data.

"But the data is possibly hopelessly corrupted and at any rate inaccessible now or we are being lied to as usual," he said, adding that Oberthur, out of irritation, deposited the data in a warehouse in Lipa and refused to give the access code so it could now be "corrupted."

The National Privacy Commission appealed for the public to stay calm and to wait for official

findings of any inquiry.

In an interview over radio dzBB, NPC Commissioner Raymund Liboro said the agency will conduct an investigation and inform the public about the status of their personal data.

Defense Secretary Delfin Lorenzana and PNP chief Oscar Albayalde said the DND and the PNP are ready to assist the Department of Foreign Affairs in investigations.

Lorenzana described the incident as a "security concern."

Albayalde said he considers the data breach "not only a threat to national security but also a threat to our identities because many Filipino who acquired passports, all their information are there."

Panelo said his office is looking into the incident which he said Malacañang considers as a "serious

and grave matter."

Panelo, concurrent presidential spokesman, said he is asking the DFA, the Presidential Communications Operations Office and its attached agency APUI, and UGEC for documents. — With Jocelyn Montemayor and Victor Reyes

Central Luzon PNP conducts simultaneous

Chief Supt. Joel Napoleon M. Coronel. Central Luzon police regional director, said that 151 checkpoints were established on Sunday for police interdiction operations and gun ban violators as the nationwide Commission on Elections (Comelec)-imposed gun ban marked its first day.

As a result, two gun ban violators were apprehended during checkpoint operations while two died in a shootout with authorities and five firearms were confiscated

"Aside from apprehending gun violators. Comelec checkpoints have also proven effective in the anti-criminality and gun control campaign of the PNP particularly against syndicated crime groups, local insurgents, and holders of loose firearms in the previous elections," Coronel further stated. By advocating "secure and fair elections 2019," Police Regional Office 3. in collaboration with the Commission on Elections, Armed Forces of the Philippines (AFP), the Department of the Interior and Local Government (DILG) and the Parish Pastoral Council for Responsible Voting (PPCRV) held a Unity Walk and Peace Covenant Signing early last Sunday in the City of Malolos, marking the official start of the 2019 election period.

The unity walk was attended by prominent election stakeholders composed of leaders, personnel and

members of concerned government agencies, religious groups, academe, students, civic and Non-Government Organizations (NGOs) started at the Barasoain Church where the participants also converged and held an interfaith prayer rally.

The event was highlighted by the signing of a pledge for clean and honest elections and the releasing of doves.

Chief Supt. Coronel said that similar events were held in the national head-quarters and different regional offices to drumbeat the significance of the midterm elections this May.

2 killed, 10 nabbed at checkpoints

TWO unidentified persons were killed while 10 others were arrested on the first day of the setting up of the Philippine National Police and Commission on Elections checkpoints in Bulacan on Sunday.

Meanwhile, the candidates running for national and local posts should coordinate with military units during the campaign period for their security from possible rebel attacks, Armed Forces of the Philippines public affairs office chief Noel Detoyato said on Monday.

Detoyato said candidates could request security but it was up to the Commission on Elections to approve it.

Supt. Orlando Castil Jr., City of San Jose Del Monte City chief of police, said the two slain men were riding on a motorcycle without plate numbers and ignored the police and Compelec personnel manning the checkpoint around 1:15 a.m. at Graceville Village.

"The personnel tried to flag down the motorcycle but instead of yielding it accelerated, which prompted the police to chase the suspects," Castil said.

He said all Police Community Precincts were ordered to establish dragnet operations while possible exit routes were blocked by mobile patrols.

"The suspects, sensing they would be overtaken, immediately got off from the motorcycle and fired shots toward the responding personnel, prompting them to retaliate," Castil said.

The police collected a .45-cal. pistol, a 38-cal revolver and the motorcycle used by the suspects.

Meanwhile, Senior Supt. Chito Bersaluna, chief of the Bulacan Provincial Police Office, said the 10 people were arrested in the PNP-Comelec checkpoint in Angat town.

"The suspects shouted towards the police manning the checkpoint and accelerated their tricycle and tried to evade arrest. They were immediately chased and arrested. The suspects were under the influence of liquor," Bersaluna said.

DILG to local execs: Don't pay campaign fees to rebels

The Department of the Interior and Local Government (DILG) yesterday warned local officials against paying "permit to campaign fees" to communist rebels.

Interior Secretary Eduardo Año has issued a memorandum circular reminding all governors, mayors and electoral candidates that they could be held liable under Republic Act 10168 or the Terrorist Prevention and Suppression Act.

"Many reelectionists are in the heat of campaign mood,

whether discreetly or openly, as the May 2019 midterm elections near. "Under this scheme, they demand money from candidates in exchange for allowing them to enter and campaign freely in the hinterlands that are within their area of operations," Malaya said.

He described the act as a form of extortion of the rebel to raise funds to fuel their

campaign to overthrow the government.

"The DILG is calling all (local government units) and law enforcement agencies to ensure that all candidates and political parties are allowed unhampered entrance in every LGU and to ensure the peace and order in all areas, including those considered as hotbeds of insurgency, so that all candidates and political parties are given access to the electorate during the campaign period without intimidation or manipulation by any group," he said.



JP execs hit fold Red Scare

PNP presents NPA members who say students visit rebel camps as

part of immersion activities

Officials of two state universities on Monday expressed alarm over the Philippine National Police's claim that their students were visiting New People's Army (NPA) camps as part of immersion activities, then being intimidated by rebels into joining the insur-

The fresh allegations levied against University of the Philippines (UP) and Polytechnic University of the Philippines (PUP) students left officials with a sense of déjà vu months after both schools, along with 16 others, were linked by the military to a supposed plot to oust the President.

"We're very, very disturbed," UP Diliman Chancellor Michael Tan told the Inquirer. "It's the old 'Red scare' at work."

Both Tan and Jose Dalisay, UP vice president for public affairs, said it was their first time to hear of these immersions at hinterland communities in Laguna province, information the police allegedly gleaned from NPA surrenderers.

Wrong basis

Tan said he would not be surprised if the PNP were to use the former rebels' statements as a basis for monitoring UP students, similar to its recent and widely criticized profiling of members of the militant Alliance of Concerned Teachers.

For his part, PUP's student regent, Ron Cervantes, called the allegations "nothing but lies," saying these placed "students, teachers, officials and all members of the PUP community in danger."

Cervantes, a student of the extension school in Maragondon, Cavite province, said the police had recently administered a survey inside the campus that sought to elicit information about members of progressive organizations.

The PNP Calabarzon office that conducted the survey was also the one which revealed the alleged immersions in Laguna province.

"They are using these as an excuse because UP and PUP are known for being at the forefront of the fight against the administration's policies. That is how desperate they are," Cervantes said.

According to Tan, the PNP's use of immersion activities as a means to stoke fear was an attack on the philosophy behind a UP education, which places a

primacy on learning outside the classroom.

"We continue to uphold our right to educate students in a holistic way which includes exposure to realities. We are not about to stop our field activities," he said. "We cannot be an ivory tower—that is to betray our mission as educators."

PNP's claim confirmed

At a press conference in Camp Crame on Monday, the Calabarzon police director, Chief Supt. Edward Carranza, said that 20 NPA members from Kalayaan, Laguna province, who surrendered over the weekend confirmed the PNP's claim that students from the two universities were being recruited by insurgents.

The surrenderers said the students periodically visited Sitios Pulot, Magololon and

Balay Kahoy at Barangay San Antonio in Kalayaan.

"It's part of their immersion to see what life is like in the mountains, [but] we also have reports that while [the students] are there, [the NPA] will tell them that they can never come down because they will be targeted by the military and police," Carranza said.

"That's why we have a project to monitor schools because there are groups that are just front organizations for [the recruitment of students]," he added.

One of the NPA members presented to reporters said that the students—two to eight at a time—were supposed to stay for just one night with the group only to be scared by the NPA into joining the movement. —WITH A REPORT FROM JAYMEET. GAMIL INQ

Ex-rebel leader confirms NPA recruitment of college students

Communist rebels formerly operating in Laguna and nearby provinces confirmed yesterday the recruitment

of college students by the New People's Army (NPA) who are reportedly first lured to visit poor communities in the Calabarzon (Cavite, Laguna, Batangas, Rizal, and Quezon) region for immer-

sion that end in frequent visits to rebel camps.

The 20 rebel returnees said students from the University of the Philippines (UP) and the Polytechnic

University of the Philippines (PUP) regularly visit them.

"They would go to some far-flung communities for research but some of them would no longer go back and would choose to stay," said alias Ka Ruben, one of the communist leaders based in Laguna revealed in an interview at Camp Crame.

The revelation reinforced the allegations of the Philippine National Police (PNP) that the New People's Army (NPA) has been recruiting in colleges and universities through the rebels' legal fronts.

Chief Supt. Edward Carranza, director of the Calabarzon PNP, said their focus now is on persons who served as point men in recruiting the students.

"We really have to find these people because they are not only putting the lives of these students at risk but also destroying the future and hope of their families," Carranza told reporters.

The official said they have long been receiving intelligence reports of the supposed visits of college students in known areas where communist rebels operate in Calabarzon.

While some may have voluntarily joined the local communist rebels, Carranza said some have been tricked into joining rebel groups.

The students, Carranza revealed were first lured into visiting indigenous people and poor communities living in the mountains of Calabarzon. After the visit, the communist rebels would reportedly tell the students they have to stay a little longer due to the presence of police and military forces who detected their arrival.

The students are reportedly led to join the regular communist rebels in finding safe routes out of the rebel lair.

The problem, according to Carranza, is that the students are sometimes pinned down once the operating military units chance upon the rebel group.

He cited a case in Batangas a few years ago where some of those killed in military engagements were college students.

Carranza said some of the rebel surrenderers were members of the Dumagat tribe living in the mountainous areas of Laguna.

"These Dumagats were recruited from 1997 to 2016 under Bagong Hukbong Bayan. They were issued handguns and long firearms such as AK-47 and M16 rifles," said Carranza.

The firearms were turned over to the government when they surrendered.

The rebel returnees will be given livelihood and cash assistance by the government.

Huge mistake

Meanwhile, the Liga Independencia Filipinas, a group of former NPA rebels picketed The Netherlands Embassy and asked the Dutch government to terminate the asylum status of Communist Party of the Philippines (CPP) founder Joma Sison and repatriate him to the Philippines to face punishment.

Nolan Tiongco, leader of the anticommunist group said Sison has conveniently made The Netherlands his safe haven while the communist group he founded lost touch of its purpose to bring injustices to light in the country.

"Ang nangyayari pa, mas marami pang injustices na idinulot ang mga giyera ng New People's Army (NPA). Maraming nasaktan at namatay, wala naming naligtas katulad ng dapat sanang mithiin ng grupo (What happened here is more injustices were brought by the NPA. Many were wounded; nothing has been resolved)," Tiongco said.

The 50-year struggle of the communist group showed no proof that the group's fight is legitimate.

Tiongco said most of the rebels who joined during his time dropped the fight because they realized it made no sense.

"Malaking pagsisi namin na dating kabahagi ng movement ang pagsali. Mali yung pakikipaglaban, mismo yung mga kasama na nakikibaka, sila mismo yung nag-aaway away at karamihan ay terroristic act (Joining the movement was a huge mistake. Fighting was wrong, our comrades in the group were fighting against each other, mostly terroristic acts)," he added.

Early this year, Senator Panfilo Lacson reminded the Department of Justice to follow-up in its petition seeking to tag the CPP-NPA as a terrorist group.

"I urge the executive branch, particularly the DOJ to follow up with the judiciary the case that they filed calling for the prescription of the NPA as a terrorist group which is provided under Section 2 of the Human Security Act of 2007," Lacson said on Twitter.

"They have not succeeded for the past five decades so I don't see how they can. Right now, they are reduced to a band of extortionists, arsonists and robbers, even a terrorist group," added Lacson, former PNP chief. (With a report from PNA)

Students forced to join NPA - police

Philippines (UP) and Polytechnic University of the Philippines (PUP) were being forced by the New People's Army (NPA) to be part of the rebellion, according to the police and recent rebel group members who surrendered to authorities on Monday.

Chief Supt. Edward Carranza, Calabarzon regional director, said UP and PUP students would usually visit the mountains in their region for immersion in communities living there, but would later be told by NPA members that they could not return to mainstream society as they were already targeted by the government army and the Philippine National Police (PNP).

Carranza said the information came from the 20 NPA members who surrendered on January 11 in Kalayaan, Laguna to Sub Regional

Military Area 4A.

The 20 former NPA members, including a minor, were presented in a news briefing in Camp Crame.

The group yielded one rifle, two shotguns, three homemade shotguns, four revolvers, one submachine gun, one rifle, one fragmentation grenade, one rifle grenade, and 442 ammunition.

One member, who identified himself as Ka Ruben, said students were threatened by NPA members to join the communist rebel group.

"You will be scared if a gun is

facing [you], so they just say 'yes,''
he said.

He added that their group surrendered to the government because they could not see the goal of the communist group anymore.

PNP Chief Director General Oscar Albayalde said, they were still conducting dialogues with the Commission on Higher Education and Department of Education on how to prevent college students from joining rebel groups.

"I think they were already informed and now are aware about what's happening with their students. These students sometimes get their minds poisoned, so they will go to the mountains, have their immersion, and then be forced to stay there," he said.

The Armed Forces of the Philippines on October 2018 released a list of 17 universities in Metro Manila, including UP and PUP, where the Reds are allegedly recruiting students to join their group.

New life for returnees

Ex-rebels get aid, reveal Reds' illegal recruitment

Each returnee received P65,000, including P50,000 for livelihood and P15,000 for immediate assistance

Some 76 former rebels received livelihood assistance and firearms remuneration from Davao City Mayor Sara Duterte during the Enhanced Comprehensive Local Integration Program (E-CLIP) benefits awarding ceremony at the Grand Men Seng hotel.

Each returnee received P65,000, including P50,000 for livelihood and P15,000 for immediate assistance. Twenty-seven of them will soon receive their firearms remuneration depending

on the value of the firearms surrendered.

"This monetrary assistance is really for you. I just hope that you will use it properly," Duterte told the returnees.

The awarding rites coincided with a revelation by a rebel surrenderer in Camp Crame that the New People's Army (NPA) is illegally recruiting students from the University of the Philippines and Polytechnic University of the Philippines to join the movement.

Ka Ruben, together with 19 other surrenderers, was presented by the police to the media wearing masks to conceal their faces.

Calabarzon Police Regional Office Chief Supt. Edward Caranza said these students were originally part of immersion activities in the mountainous parts of Laguna.

"(The students) who conducted immersion activities in the area were being threatened (by NPA) that if they

go back to urban area, they will also be the target of police and military operations," Carranza said.

Brig. Gen. Ernesto Torres Jr., commander of the 103rd Infantry Battalion, said the cash assistance of the returnees comes along with livelihood training, rehabilitation and monitoring before they return to the community.

"I hope you will be able to make the money grow," Torres told the former rebels (FR).

Each FR will have his/her own integration plan depending on his skills. The city government of Davao will help facilitate for their certificate that they can use for employment.

Torres said the assistance aims to help and assist former rebels who are expected to help bring peace to the region.

Duterte assured the FR of safety

and security guarantee from the Local Government of Davao and the Philippine National Police (PNP) in coordination with the Armed Forces of the Philippines (AFP).

Duterte likewise promised relocation support from the LGU. She said a housing program in Los Amigos in Tugbok District has already been prepared for the FR. She also encouraged them to urge other rebels to avail of the E-CLIP.

Representatives from Landbank were present during the distribution.

E-CLIP is a locally-driven, managed and implemented program aiming to respond to the circumstances, needs and concerns of the FRs through provision of assistance.

Under the E-CLIP, the province or highly urbanized city serves as the focal point of authority and management of integration program to provide more sustainability and consistency.

PNP tags 19 towns, cities as election hotspots

he Philippine National Police
(PNP) has placed 19 towns and
cities in Luzon and Mindanao in
its election watchlist areas for
the midterm polls in May.

PNP chief Director General Oscar Albayalde cited history of violent elections in the past, as well as presence of armed groups and other threat groups such as communist rebels, as the reason for including the 19 areas in the election hotspot list

He identified these as Sudipen, Balaon, and Jones towns in Isabela; Lemery in Batangas; Roxas town in Oriental Mindoro; Balud and Dimasalang towns in Masbate; Daraga in Albay; Pagadian City in Zamboanga del Sur; Cagayan de Oro City; Hadjih Mohammad Ajul, Lantawan, Tipi-Tipo in Basilan; Marawi City; Sultan Dumalondong, Mamasapano, Shariff Aguak, Shariff Saydona Mustapha, and

Datu Unsay in Maguindanao.

The PNP initially listed 18 cities and towns but Daraga town in Albay was included after its sitting mayor, Carlwyn Baldo, was accused of ordering the killing of AKO Bicol Party-list Rep. Rodel Batocabe who was supposed to run for mayor of the town.

"We also included intense rivalry and presence of big threat groups as the reasons for the inclusion in the list," said Albayalde.

Special case for security preparations, according to Albayalde, is Cotabato City and nearby areas following the December 31 bombing that left three people dead.

Albayalde said they deployed a battalion of police commandos in Cotabato City for the conduct of plebiscite for the Bangsamoro Organic Law next week — which is said to be the reason behind the bomb attack.

"In some areas, we will see. We just

have to consolidate our troops or redeploy our personnel particularly coming from the police regional mobile groups," said Albayalde.

The PNP has already started positioning its troops around the country, especially starting Sunday when the 150-day election period began.

Albayalde said the police deployment will be reinforced by the military, especially in areas where big threat groups such as the communist rebels operate.

9 soldiers hurt in clash with NPA in Samar

NINE soldiers were injured Saturday in Samar during a clash with New People's Army rebels who are supposedly plotting attacks in San Jorge town, the military said yesterday.

The soldiers were hit by shrapnel wounds from explosives detonated by the communist rebels during the firefight, said Capt. Ryan Velez, civil military operations officer of the Army's 803rd Brigade.

The recall is part of the routine election ban as prescribed by Commission on Elections (Comelec) Resolution 10466. The resolution was passed to limit violence during the heated election period.

Exemptions allowed

The PSPG added that politicians who face serious threats on their lives can file a case before the Comelec to obtain a Certificate of Authority for Security Detail (CASD) to be provided with security escorts despite the ban.

Politicians can then submit their CASD to the police Regional Joint Security Control Center, which can issue them a 30-day Temporary Authority for Security Detail and it will also be the PNP's reference before assigning police escorts.

Also, government officials are exempted from the security recall, including those for the president, vice president, Senate president, Speaker, chief justice, secretary of the Interior and Local Government, secretary of National Defense, Comelec chairman and commissioners, Armed Forces chief, Army, Air Force and Navy chiefs, PNP chief and policemen with rank of superintendent or higher.

Skills improvement

The PSPG also assured the public that the police escorts will not be left idle during the entire election period. Assigned security detail willibe undergoing "competency and skills enhancement" training to refresh them of their past training and schooling regarding protecting VIP (very important persons).

The cops will stay in police camps, depending on orders issued by the PSPG based on the guidelines.


Sobejana attributed the success of the operation to the cooperation shown by residents and local officials.

MILF, AFP were never enemies – Murad

OTABATO CITY – Buoyed by a series of accolades from state authorities, Moro Islamic Liberation Front (MILF). Chairman Murad Ebrahim on Sunday claimed that the Armed Forces of the Philippines (AFP) as an institution has never been the enemy of his revolutionary group.

"We were never enemies," Ebrahim, popularly called Hadji Murad, told the rank and file personnel of the Army's 6th Infantry Division (6ID), referring to the MILF and AFP as organizations.

"Our enemies are oppression, injustice and exploitation, not the military as an organization. The armed conflicts we had were only circumstantial because the military is part of the government's defense structure," Murad stressed.

Murad unveiled his perspective of the AFP during his unprecedented visit at the 6ID headquarters in Camp Siongco, Datu Odin Sinsuat, Maguindanao.

Combatants of the 6ID and the MILF have figured in countless bloody encounters that waned only when the country's largest Moro revolutionary group saw feats in its 2013 and 2014 ma-

jor peace deals with the government.

Murad thanked Major Gen. Cirilito Sobejana, 6ID commander, for arranging his "first ever" and "historic" visit to the camp.

The 6ID covers operationally the provinces of Maguindanao, Sultan Kudarat, North Cotabato and parts of Lanao del Sur where the MILF maintains more than 30 major enclaves.

Murad's visit to the 6ID was his second in an AFP camp. The first was in Camp Aguilando where then AFP Chief of Staff Carlito Galvez Jr. hosted the MILF chieftain on Nov. 19, 2018. It was a reciprocation of Galvez's first visit too at the MILF's Camp Darapanan in Sultan Kudarat, Maguindanao on Oct. 6 of same year.

Murad and Galvez have since maintained their partnership bolstered by their common push for the ratification of RA 11054, also known as Bangsamoro Organic Law (BOL), in two upcoming plebiscites. The latter, who once served as 6ID commander, is now the Presidential Adviser on the Peace Process.

The two MILF-GPH accords, especially the 2014 Comprehensive Agreement on Bangsamoro (CAB), were the main bases for RA 11075, which the 17th Congress and President Rodrigo Duterte enacted in July last year as a major instrument in ending

the decades of secessionist rebellion in the country.

Gen. Sobejana's hosting of Murad visit jived with the conduct of caravan by several thousands of pro-BOL supporters aboard motorbikes and four or more-wheeled vehicle around the highway of Maguindanao, Sultan Kudarat and North Cotabato that started early morning and winded up here in late afternoon.

Sobejana and his staff officers presented to Murad some memorable presents citing the latter's continued assurance for MILF forces' shift from combat orientation to peace advocacy.

He and Murad have agreed on mutual cooperation in ensuring the safe and orderly conduct of two plebiscites set on Jan. 21 and Feb. 6 for the ratification of the BOL, which seeks to create the Bangsamoro Autonomous Region (BAR) in replacement of the 29-year-old Autonomous Region in Muslim Mindanao (ARMM).

The BOL prescribes for BAR's absorption of all ARMM component areas – Maguindanao, Lanao del Sur, Basilan, Sulu and Tawi-Tawi provinces and the cities of Marawi and Lamitan – as well as the cities of Cotabato and Isabela in Basilan, six towns in Lanao del Norte and 39 barangays in six North Cotabato towns.

Rising from Marawi's ruloble

FIRST OF TWO PARTS

OLLOWING the battle between government troops and extremist groups in 2017, Marawi City could only dream of getting its former status back. It was once distinguished as the economic hub of Lanao del Sur and the center of Islam in the country. Today, the business district and the surrounding barangays have been reduced to rubble.

Homes of well-to-do families, including Marawi Mayor Majul Gandamra's, were demolished by blasts or damaged by artillery. It's the equivalent of the Makati Central Business District and its surrounding elite villages being bombed out.

In spite of the spoils of war, some cultural icons have remained, such as the scenic Mindanao State University and the "torogans," the traditional Maranao homes with intricate carvings.

On a personal initiative, Gandamra, his family and friends donated 46 hec-

tares of land for settlements, consisting of temporary shalters built by the National Housing Authority and the municipality Many poor families who were displaced during the war have returned to Marawi and have moved into these homes.

In Barangay Sagonsongan, families have occupied 1,050 temporary shelters. An additional 300 houses are being put up.

Of the 1,500 temporary shelters in Barangay Boganga, 600 have been turned over to other residents.

Meanwhile, a thousand homes in Barangay Dulay are on the rise.

The temporary shelters are just the start of Marawi's urban renewal, which officials said could probably take more than a decade.

The five-month Marawi siege was said to be the country's longest urban war. Fighters of ISIL (Islamic State of Iraq and the Levant) and the local radical Islamic groups of the Maute and Abu Sayaff tried to conquer the city, including the capitol building.

When the siege began in May 2017, Gandamra, his immediate family, and his staffers were holed up at the city hall.

"It was the target of the ISIL and the Maute so that they could conquer [the city] and install their flag. They were well equipped and tried to kill us, but we stood our ground," the mayor said.

"The City Hall is the symbol of our sovereignty. Our retaliation was calibrated. After four days, the military strengthened our forces. We were then able to extricate ourselves from the city hall," said Gandamra.

The mayor and his family have since been staying in their other residence in

Iligan City, Lanao del Norte, which is 38 kilometers or an hour's drive from Marawi.

Unable to sack city hall, the extremist groups took over Marawi's central business district instead.

"There was least resistance there," said Gandamra.

While government forces bombed several areas, 95 percent of Marawi's residents fled to their relatives away from the city or lived in evacuation centers. The battle ended in October 2017.

Gandamra said out of Marawi's 96 barangays, 72 have tried to return to normalcy. Over 800 households are still staying in evacuation centers outside of Marawi.

Task Force Bangon Marawi, comprised of various government agencies, is slowly working on the rehabilitation of Ground Zero or Marawi's devastated city center.

As part of the cleanup, it has to get permission from homeowners to demolish the ruins of their homes that are deemed unsafe. There are plans to build roads and install underground cables. (to be continued)

"Exhausted" Maute gang men yield

Tired of being on the run and dissatisfied with the way their group was being managed by their leaders particularly Abu Dar, three members of the Islamic State-inspired Maute group over the weekend decided to yield to government troopers in Piagapo, Lanao del Sur.

Lt. Col. Jason Jumawan, Philippine Army's 82nd Infantry Battalion commander, said the bandits whose names were withheld, also handed over one rocket propelled grenade (RPG), one grenade launcher and one caliber .30 M1 Garand rifle with ammunition.

Last Friday, two members of Maute group who confessed to being part of the Marawi City siege last May 2017, also voluntarily surrendered to authorities.

During interrogation, the suspects confessed that they were followers of Owayda Benito Morohomsar alias Abu Dar who is now one of the top leaders of the Maute Gang.

"While we are supporting the recovery, reconstruction and rehabilitation of Marawi, our efforts against Maute group remnants will continue, in order to achieve a peaceful and progressive community in our area of operation," Col. Romeo Brawner Jr., commander of the Army's 103rd Infantry Brigade said.


Last Friday, two members of the Maute group who confessed to being part of the Marawi City siege last May 2017, also voluntarily surrendered to authorities.

The two surrenderers were also followers of Abu Dar and decided to escape the group and surrender to the authorities for the same reason that "they are already tired of running and evading the troops."

The Maute group gained notoriety when it seized Marawi City last 28 May 2017 and openly challenged government authorities, resulting to more than five months of occupation that virtually reduced the once prosperous city into rubbles.

The war left more than 150 government forces dead, thousands of Islamic fighters killed ,87 civilian casualties and displaced nearly one million residents.

ANDAYA: WHERE ARE FUNDS FOR BANGSAMORO PLEBISCITE?

President Duterte's efforts to bring lasting peace to Mindanao may come to naught after Budget Secretary Benjamin Diokno failed to allocate funds for the plebiscite on the proposed new Bangsamoro juridical entity, House Majority Leader Rolando Andaya Jr. said on Monday.

In a privilege speech, Andaya wondered how the Commission on Elections (Comelec) would be able to conduct the plebiscite on Jan. 21 and Feb. 6 as mandated by the Bangsamoro Organic Law (BOL) without any appropriation approved by Congress.

He said he had told Diokno about the matter, but the budget secretary failed to act on it.

"(Diokno) completely forgot about it. Had we listened to him and passed the budget without even looking at it, then we would have been part of that negligence," Andaya said.

"Maybe he has other things in mind other than the President's peace and order agenda," he added.

In a statement, Andaya said the "prospect of lasting peace in Mindanao is in peril."

P857M for plebiscite

He said the Comelec needed P857 million in holding the plebiscite, but the Department of Budget and Management (DBM) did not include this in the proposed P10-billion budget of the Comelec for this year.

"The budget for BOL plebiscite is not the only item which Diokno forgot to include in the 2019 budget. Even the budget for the BOL implementation is missing from budget documents submitted by the DBM to Congress," he noted.

At least 2.8 million people are expected to cast their votes in the plebiscite for the ratification of the BOL, based on records of the Comelec.

Enacted last year, the BOL provides for the creation of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).

The BARMM will cover the existing Autonomous Region in Muslim Mindanao (ARMM), including Cotabato City and Isabela City, six towns in Lanao del Norte, and 39 barangays in

six North Cotabato towns.

Some barangays in Iligan City and Zamboanga City, five towns in Lanao del Norte, and some barangays in Zamboanga Sibugay also petitioned to be included in the BARMM.

The Comelec said the Jan. 21 plebiscite would be conducted in areas comprising the ARMM as well as Isabela City in Basilan and Cotabato City.

The plebiscite for province of Lanao del Norte, except Iligan City; the towns of Aleosan, Carmen, Kabacan, Midsayap, Pikit and Pigkawayan in the province of North Cotabato; and the 28 areas contiguous to any of the Bangsamoro core areas, where either the local government or at least 10 percent of registered voters asked for inclusion in the plebiscite, shall hold theirs on Feb. 6.

The Comelec expects to finish this week the printing of the official ballot, said Ma. Victoria Dulcero, vice chair of the Comelec's printing committee.

North Cotabato leaders

North Cotabaro province, unlike their Moro counterparts in Sulu and Lanao del Norte, non-Moro leaders are throwing their allout support for the BOL despite the prospect of losing some of their barangays that would opt to join the Bangsamoro territory.

North Cotabato Gov. Emmylou Taliño-Mendoza expressed her support for the BOL on Saturday at a forum at tended by national and local officials, and leaders of the Moro Islamic Liberation Front and the Moro National Liberation Front at the gymnasium of the provincial capitol in Kidapawan City.

Printing of ballots for BOL plebiscite

The Commission on Elections (Comelec) expects to finish the printing of the ballots to be used for the February 6 plebiscite for the ratification of the Bangsamoro Organic Law (BOL) this week

Vicky Dulcero, vice chairman of the Comelec Printing Committee, said they are targeting to finish the printing of the 600,000 ballots either Tuesday or Wednesday.

According to Dulcero, they started

printing the ballots for the February 6 Plebiscite at the National Printing Office (NPO) in Quezon City over the weekend.

These are the ballots for Lanao del Norte and North Cotabato.

"We are almost done. So I think in a

day or two we will be able to deliver to our packing and shipping committee for deployment of the ballots," said Dulcero.

To note, the Comelec already finished printing the more than two million ballots for the January 21 Bangsamoro Plebiscite December last year.

"We have to wait for the passage of the 2019 General Appropriations Act. Otherwise, we do not have legal basis for the implementation of the fourth tranche," he said.

Diokno earlier said government workers will get their salary increase next month, retroactive to January 1, upon the approval of the P3.7-trillion 2019 national budget.

Government is currently running under a reenacted 2018 budget.

Budget Undersecretary Janet Abuel said DBM is preparing its response to the petition for mandamus and would state provisions of the law including EO 201 that guided their actions.

Budget Assistant Secretary Myrna Chua said DBM needs about P45 billion to P50 billion to cover the fourth tranche of salary hike for some 1.3 million government workers.

Chua said the MBFP under the reenacted 2018 budget cannot be used for the new wage hike because it was specific only to the third tranche of salary increase.

Presidential spokesman and concurrent Chief Presidential Legal Counsel Salvador Panelo dismissed the claim of Andaya that the executive branch is holding the salary hike hostage, saying "the one holding (the salary hike) hostage would be Congress, not the executive department.'

Senate majority leader Juan Miguel Zubiri said senators in a caucus set January 23 as the target approval date of the 2019 budget.

Zubiri said senators will try to

finish the plenary debates on Jan. 16, approve the proposed budget on third and final reading on Jan. 21, and conduct a bicameral conference the following day which they will try to finish on the same day.

If everything goes smoothly, Zubiri said the proposed budget can be ratified by both chambers on Jan. 23.

Senate President pro tempore Ralph Recto said they can tackle the budget in two or three weeks, while other bills can be discussed on the remaining time before their break on February.

SUBPOENA

Andaya had a change of heart, saying the House of Representatives will subpoena Diokno if he will continue to snub the committee on rules' hearing on the alleged flood control scam under his leadership.

"We will subpoena him (Diokno) if he does not show up," he told a press conference. "We will play hide and seek in Luneta if he doesn't show up."

Andaya earlier said he would no longer force Diokno to attend his committee's hearings because it would be too confrontational.

Diokno snubbed the panel's initial hearing in Naga City early this month, saying he was advised by the Executive not to attend it.

The Andaya panel has formally invited Diokno, his daughter Charlotte Justine, and her in-laws who are incorporators of Aremar Construction to appear as resource persons in the hearing.

Andaya's panel has been investigating Diokno for allegedly manipulating the annual budget to favor some individuals, especially the in-laws of Charlotte, who are involved in the construction business.

Andaya said the House remains optimistic that Diokno will cooperate and attend the hearing, especially since his integrity is at stake.

"He needs to clarify himself. His son-in-law has already hired a lawyer to help him face us tomorrow (today). He (Diokno) should also get his own lawyer," he said.

Andaya said officials of Aremar Construction, which is partly owned by the in-laws of Diokno's daughter, might be liable for plunder for using dummy corporations after cornering billions worth of public works projects in exchange for hefty commissions.

He said some Triple A contractors gave him copies of deposit slips worth around P70 million to prove the allegation.

NO BUDGET FOR BOL

Andaya also blamed Diokno for allegedly imperiling the prospect of lasting peace in Mindanao when he allegedly forgot to include the budget for the Bangsamoro Organic Law (BOL) plebiscite in the P3.757-trillion proposed national budget for 2019.

"Everybody is praying for the success of the BOL plebiscite on January 21 and February 6. Yet nobody is asking if we have the funds necessary to conduct the plebiscite. I hate to be the one to burst the bubble. The DBM has not allocated a budget, not even a centavo, for the

BOL plebiscite," he said.

Andaya said while the Comelec

needs P857 million for the plebiscite, Diokno forgot to include the amount in Comelec's P10 billion 2019 budget.

He said even the budget for the BOL implementation is missing from budget documents submitted by the DBM to Congress.

He said Senate debate records show that the implementation of the BOL will cost P109 billion in the first year, P369 billion in the first three years, and will reach P1.981 trillion for a period of 10 years.

The amount does not include funds for social services like the Pantawid Pamilyang Pilipino Program or 4Ps, and pension for senior citizens.

ABUSE OF POWER?

Rep. Luis Raymond Villafuerte (NP, Camarines Sur), Andaya's political nemesis, accused Andaya of abusing his position to get back at Diokno.

"This is a bizarre situation in which the House majority leader has for the first time ever orchestrated a demolition job on the DBM and on Secretary Benjamin Diokno, who is an alter ego of the President, in tandem with the House minority bloc," Villafuerte said,

Villafuerte, who earlier called for Andaya's ouster as majority leader, said pursuing the hearing would be 'against the wishes of a majority of our peers in the ruling coalition who wants a speedy congressional approval of the 2019 GAA in support of President Duterte's vision for high and inclusive growth." - With Jocelyn Montemayor, Wendell Vigilia and Raymond Africa

Should we end our alliance with US?

s it still relevant to our security? Maybe not," said Defense Secretary Delfin Lorenzana in a press conference last month, revealing his plans to review the 1951 Philippine-US Mutual Defense Treaty (MDT).

The surprising announcement came shortly after the return of the Balangiga bells, which was warmly welcomed by no less than President Duterte, who had demanded their repatriation.

After all, many expected a thaw in frayed bilateral relations, which have been undermined by disagreements over human rights and democracy concerns as well as divergent approaches to dealing with the China challenge in the West Philippine Sea.

Lorenzana raised the stakes by making it clear that scrapping the treaty altogether is an option on the table. "Let's see... We are going to approach this MDT, look at it in the backdrop of what's happening in the area, in the interest of the nation, not the interest of other nations," he said.

It's not really clear what the exact intent is behind calling for the MDT review, but it clearly reflects lingering anxieties in the Philippines vis-à-vis the precise coordinates of American security commitments.

There are two fundamental concerns with the MDT, namely lack of temporal automaticity as well as clarity of spatial scope. According to the treaty, each party "would act to meet the common dangers [in their area of jurisdiction] in accordance with its constitutional processes." This means that in an event of conflict between the Philippines and a third party, the US government will still have to rely on the deliberation and approval of the US Congress, which has a say on the war powers of the country's presidency. If the conflict is a major one, and American public opinion is divided on

the issue, it's unlikely that any American president would try to completely bypass the Congress even if he/she deems the need for expedient intervention.

As for the geographical scope of the treaty, it makes mention of "an armed attack on the metropolitan territory of either of the Parties, or on the island territories under its jurisdiction in the Pacific or on its armed forces, public vessels or aircraft in the Pacific..."

Yet, it's far from clear whether "island territories" include Scarborough Shoal and other claimed and controlled Philippine land features in the West Philippine Sea. Since the 1970s, Washington has equivocated on this issue.

As former US secretary of state Henry Kissinger argued, "[Philippine] occupation could hardly be termed uncontested in the face of claims and protests of Chinese and Vietnamese."

Crucially, the Richard Nixon administration made it clear that the "MDT may apply in event of attack on [Philippine] forces deployed to third countries," which "is fundamentally different from a case where deployment is for purpose of

enlarging Philippine territory."

Thus, this could mean that Washington is only willing to intervene if Philippine troops and vessels operating in the contested area come under attack.

This, however, raises questions on the coercive occupation of Philippine-claimed land features, where Filipino troops are either absent or were driven away without a firefight.

In more concrete terms, does the treaty cover the Scarborough Shoal? What if China managed to completely cut off the supply lines of our troops in Second Thomas Shoal (Ayungin) and the Kalayaan Group of Islands, driving them away without any actual armed conflict?

This is particularly relevant in light of China's rapid militarization of reclaimed islands, laying down the foundation for an effective imposition of an Air Defense Identification Zone and other forms of exclusionary measures in the area, with potentially dire consequences for the supply lines of other claimant states.

Doubts over American commitment to the Philippines were only reinforced during the Chinese occupation of Mischief Reef (1994) and Scarborough Shoal (2012), where Washington stood largely idly by.

Washington has consistently argued that it is "neutral" vis-à-vis the sovereignty disputes in the area, thus its reluctance to intervene on behalf of the Philippines against other claimant states. But what about helping its ally to protect its sovereign rights per international law?

The proposed review of the MDT, thus, could serve as a much-needed springboard to push for greater American clarity on these fundamental questions.

AFP willing to provide security to poll bets

MANILA -- Poll bets running for national and local posts are advised to coordinate with military units during the campaign period for their security from possible rebel attacks, especially in New People's Army (NPA)-infested areas, Armed Forces of the Philippines (AFP) public affairs office chief Col. Noel Detoyato said on Monday.

Detoyato said candidates can request for security but it is up to the Commission on Elections (Comelec) to approve it.

"They can update their campaign trail with the AFP unit in their area to give them area security as long as they coordinate in advance so that troops can be pre-deployed," he said in a message to the Philippine News Agency.

The election period began on Sunday (Jan. 13).

Earlier, Detoyato said the AFP would ensure the peaceful conduct of the May polls and all election-related activities this year, including the Bangsamoro Organic Law plebiscite on January 21 and February 6. (PNA)
