Supply and Delivery of Materials for the Repair and Enhancement of TOQ1, HHSG, PA at Fort Bonifacio, Metro Manila

- 1. The Philippine Army, through the Certificate of Funding Chargeability from MFO, 51st EBde, PA signed by MAJ ANABELLE R PARAAN (CE) PA, Chief, MFO, 51st EBde, PA concurred by BGEN LYNDON J SOLLESTA PA, Commander, 51st EBde, PA under Advice of Sub-Allotment (ASA) dated 08 February 2021 with ASA Nr 5100-2021-0038 intends to apply the sum of Twelve Million Seven Hundred Eighty-Nine Thousand Six Hundred Forty Pesos (PhP12,789,640.00) being the ABC to payments under the contract for Supply and Delivery of Materials for the Repair and Enhancement of TOQ1, HHSG, PA at Fort Bonifacio, Metro Manila, PA with Bid Reference No. ENG'G PABAC3 028-21 (1ST REBID). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Philippine Army**, now invites bids for the above Procurement Project.

Required delivery period and delivery place shall be as follows:

Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).



3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Interested bidders may obtain further information from Philippine Army and inspect the Bidding Documents at the Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila from 8:00 am to 5:00 pm during office hours.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on 16 July 2021 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Eleven Thousand Forty-Six and 12/100 Pesos (PhP11,046.12).** only. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person during submission of bids.
- 6. The Philippine Army, will hold a Pre-Bid Conference on <u>23 July 2021, 9:30 A.M.</u> at the Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila and/or through video conferencing or webcasting *via* **ZOOM**, which shall be open to prospective bidders.
- 7. Bids must be duly received by the PABAC3 Secretariat through manual submission at the Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila, on or before <u>05 August 2021, 9:30 A.M</u>. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on <u>05 August 2021, 9:30 A.M.</u> at the **Office of the PA Bids and Awards Committee 3 (PABAC3) Fort Bonifacio, Metro Manila.** Bids will be opened in the presence of the bidders' representatives physically or virtually (via ZOOM).
