The Philippine Army, through the Notice of Fund Allocation Number IATF-59-2019 dated 20 May 2019 signed by COL DENIE MAR A CLEMENCIA Chief, OAFM intends to apply the sum of Two Hundred Ninety-Nine Million Seven Hundred Twenty-Five Thousand Five Hundred Five and 50/100 (PhP299,725,505.50) being the ABC to payments under the contract for Supply and Delivery of Asphalt (Item 302) 148MT, Asphalt (Item 310) 20,543 MT, Thermoplastic Paint 10,095 sqm, Diesel 147,600.31 liters, Item 104, Item 201 and Materials for Laoag Airport Development Project at Laoag City, Ilocos Norte with Bid Reference No. ENG'G PABAC3 005-21.
