**INVITATION TO BID**

**Procurement of Various MED Items**

1. The Philippine Army, through the General Appropriations Act (GAA) intends to apply the sum of Sixteen Million Pesos Only (PhP 16,000,000.00) corresponding to the total cost of each item to bid for the Procurement of AI-Mg (OH) 60 ml suspension and 162 other Drugs and Medicines under MED PABAC 001-2021 and Procurement of Absorbable Hemostat (2.5cm x 5cm), 2's and 358 other Medical Supplies under MED PABAC 002-2021 being the ABC to payments under the contract for each Line item. Bids received in excess of the ABC shall be automatically rejected at bid opening:

Delivery of the Goods is required within 5 days upon Call-Off. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

The prospective bidders are advised to first log and wait for further advice to join the BAC meeting room, the link of which shall be provided to the prospective bidders before the start of the Pre-bid Conference.

8. Bids must be duly received by the PABAC1 Secretariat through manual submission at the office address indicated below on or before the date of submission of bids as specified below. Late bids shall not be accepted.

9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

10. Bid opening shall be on the date as specified below and at the given address below through Virtual Tele Conference (VTC) via zoom at the PABAC1 Conference Room, Fort

Andres Bonifacio, Taguig City, M.M. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
