The Philippine Army, through **OAFM Certification dated 30 September 2020** with an amount of **EIGHT BILLION ONE HUNDRED THREE MILLION EIGHT HUNDRED THIRTY-SIX THOUSAND EIGHT HUNDRED NINETY PESOS AND 18/100 (Ph8,103,836,890.18)** included in the program of the Philippine Army based on FY 2021 per Budget Level National Expenditure Program (NEP) intends to apply the following sums of Pesos: **Twenty Seven Million Pesos (Php27,000,000.00)** being the Approved Budget for the Contract (ABCs) to payments under the contract for the Procurement of various Grenades for the Philippine Army under Bid Ref. 
