The **Philippine Army**, through the **Noticed of Fund Allocation Number IATF-59-2019 dated 20 May 2019** signed by COL DENIE MAR A CLEMENCIA Chief, OAFM intends to apply the sum of **Three Hundred Million Seven Hundred Fifty-Six Thousand Three Hundred Fifty-Five and 50/100 (PhP300,756,355.50)** being the ABC to payments under the contract for **Supply and Delivery of Asphalt (Item 302) 148MT, Asphalt (Item 310) 20,543 MT, Thermoplastic Paint 10,095 sqm, Diesel 147,600.31 liters, Item 104, Item 201, Personnel Protective Equipment/First Aid Kit and Materials for Laoag Airport Development Project at Laoag City, Ilocos Norte with Bid Reference No. ENG'G PASBAC 005-21**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Army**, now invites bids for the above Procurement Project. Delivery of the Goods is required by **Two Hundred (200) calendar days from Receipt of NTP**. Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

7. Bids must be duly received by the PASBAC Secretariat through manual submission at the office address indicated below, on or before 17 February 2021. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on 17 February 2021 at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
