The **Philippine Army**, through the **Certificate of Funding Chargeability** from **MFO, 51<sup>st</sup> EBde, PA** signed by **MAJ ANABELLE R PARAAN (CE) PA**, Chief, MFO concurred by **BGEN LYNDON J SOLLESTA PA**, Commander, 51EBde, PA charged against **Check Nr.: 0000640090** dated **14 February 2019** intends to apply the sum of **One Million Two Hundred Fifty-Two Thousand Four Hundred Fifty-Four Pesos and 02/100 (PhP1,252,454.02)** being the ABC to payments under the contract for **Supply and Delivery of Doors and Windows for the Specialty Works in Connection with Repair and Renovation of Veterans Center (1-Lot)** with Bid Reference No. **ENG'G PABAC3 011-21**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Army**, now invites bids for the above Procurement Project.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Office of the Philippine Army Bids and Awards Committee 3 (PABAC3)** and inspect the Bidding Documents at the address given below during **Office Hours from 8:00am to 5:00pm**.

5. A complete set of Bidding Documents may be acquired by interested Bidders on April 12, 2021 from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PhP5,000.00)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person during the ROBE.

6. The **Philippine Army**, will hold a Pre-Bid Conference on **April 16, 2021, 9:30 A.M.** at Army Support Command (ASCOM) Multi-Purpose Hall and/or through video conferencing or webcasting *via* ZOOM, which shall be open to prospective bidders.

7. Bids must be duly received by the PABAC3 Secretariat through manual submission at the office address indicated below, on or before **April 29, 2021, 9:30 A.M.** Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

9. Bid opening shall be on **April 29, 2021, 9:30 A.M.** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
