The Philippine Army, through the ASA Nr 2600-2022-0028 duly signed by COL RAMON ANTONIO E BELLO GSC (CAV) PA, AC of S for FM, G10, PA intends to apply the sum of Sixty-Seven Million Four Hundred Ninety-Five Thousand Nine Hundred Thirty-Five Pesos and 84/100 Centavos (PhP67,495,935.84) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of One (1) lot Night Fighting System (NFS) under SIG PABAC3 007-22. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Army now invite Bids for the above Procurement Project. Delivery of the Goods is required within One Hundred Fifty (150) calendar days from receipt of Notice to Proceed (NTP) by the Supplier, which date shall not be later than **seven** (7) days from the issuance of NTP.
