Request be informed that the discrepancy mentioned above on the said Invitation to Bid and Bidding Documents was only noticed when the approved NOA was about to be posted in the PhilGEPS. It must be emphasized that all the documents supporting the said project show the intention was to procure various tires in different quantities in one (1) lot. Thus, the said publication in the ITB and bidding documents of 412 vis-à-vis 421

was inadvertently done, and there was no intention to mislead the proponents of this project.

To align the posting of NOA with the correct approved quantity (Quantity for Tire, 9.00-20 DIR—421), we have to post the erratum on the Procuring Entity's website and in any conspicuous place following the guidelines under Section 3, APPENDIX 33 of the Revised IRR of RA 9184.
