## DILG CHIEF DISMISSED OVER FIRETRUCKS DEAL

Interior Secretary Ismael Sueno lost his job because of a row with his three undersecretaries in the Department of the Interior and Local Government (DILG) over the right to sign contracts and promotions, according to a spokesperson for the agency.

But according to one of those officials, Sueno was fired because of irregularity in the purchase of firetrucks from Austria.

Interior Undersecretary for Public Safety Jesus Hinlo said Sueno was sacked because of his involvement in the purchase of the firetrucks without a competitive public bidding.

"There is a [case pending in] the Supreme Court involving the finetrucks but Sueno still proceeded with the transaction," Hinlo said in a phone interview on Tuesday.

"There should be due diligence, that's the issue that I think weighed heavily in the decision of the President," he said. Legal opinion

Hinlo could be right, as Mr. Duterte, in a speech at the Metropolitan Manila Development Authority (MMDA) on Tuesday night, referred to a legal opinion that Sueno had told him he knew nothing about.

"If you answer me with that kind of statement, that you never read the legal opinion of the legal officer of your own office, it's either you're taking me for stupid, an idiot, or you are lying through your teeth," Mr. Duterte said.

"That's why I said son of a bitch. So I said, 'You're fired. I simply said, 'You're fired.'" he said.

Malacañang said earlier on Tuesday that Mr. Duterte sacked Sueno for "loss of trust and confidence."

Sueno had a reported rift with his three undersecretaries, who accused him of corruption, shielding a politician OFFICE OF THE ARMY CHIEF

linked to illegal drugs and other wrongdoings.

Mr. Duterte questioned Sueno about his activities before sacking him on Monday, presidential spokesperson Ernesto Abella said on Tuesday.

### Warning to others

He said Sueno's dismissal should serve as a warning to other government officials that Mr. Duterte would not tolerate any wrongdoing even in his Cabinet.

Sueno's dismissal took effect right after Mr. Duterte's pronouncement on Monday, according to Executive Secretary Salvador Medialdea.

An officer in charge for the DILG will be announced soonest, he added.

At the Philippine Army headquarters, Mr. Duterte told reporters that he was looking for a replacement for Sueno but he would not name former Sen. Ferdinand "Bongbong" Marcos Jr. to the top DILG post because Marcos had a pending electoral protest concerning his loss in last year's vice presidential election to Leni Robredo.

"No. 1 don't think so. He would abandon his appeal. He would have to let go of it. When you are appointed to a position, it would be lost for all intents and purposes," Mr. Duterte said.

Sueno was fired at the end of the Cabinet meeting in Malacañang late on Monday, the same day he parried calls from his underlings in the DILG for his investigation for the purchase of firetrucks from Austria worth P20 million even though there were alternatives available for just P7 million.

Abella declined to provide details of what Mr. Duterte had found about Sueno.

He said, however, that Mr. Duterte had checked the activities of Sueno. Among the questions that Mr. Duterte asked Sueno, Abella said, was whether he had traveled to a certain country and whether he knew the background of a certain situation.

"The President was quite open and frank in questioning the secretary, initially, in fact, at the beginning of the meeting," Abella said.

After questioning Sueno, Mr. Duterte moved on to other topics and the Cabinet meeting went on for several hours.

'When Mr. Duterte made a closing statement, he announced that he was letting Sueno go.

A "short exchange" followed, Abella said, but gave no details.

He said the reason for Sueno's dismissal went beyond the complaints of DILG officials.

It wasn't clear whether Sueno would be formally investigated and possibly prosecuted

### 'I'm not corrupt'

In a statement, Sueno insisted on his innocence, but said he respected Mr. Duterte's decision.

"I wholeheartedly accept the decision of the President. It is his call if he wants me in his Cabinet or not. But for the record, Mr. President, and I can say this with all honesty and sincerity, I am.not corrupt," Sueno said.

He said Mr. Duterte was given "wrong information by those salivating" for his post from the start.

"I just wished the information was validated. If only the President asked DILG personnel from the central down to the regional and field offices, he would have known who among us are more credible and trustworthy," he said.

Sueno said he was ready to face any investigation to clear his name

Assistant Secretary Ricojudge Janvier Echiverri early on Tuesday said the row between Sueno and his three undersecretaries—Hinlo, John Castriciones and Emily Padilla—erupted after Sueno decided to retain the executive right to approve promotions and contracts.

Echiverri said that some people in the DILG felt that if Sueno had to go, then his critics should also go. INQ

## 2 junior officers cited for bravery in combat

PRESIDENT Duterte yesterday conferred the Distinguished Conduct Star, the second highest military medal in combat, on two junior Army officers for feats against the Abu Sayyaf in Basilan and Sulu.

Captains Ariel Robles and Dennis Prado received the medals during the celebration of the Army's 120th foundation anniversary at the Army headquarters in Fort Bonifacio.

Army chief Lt. Gen. Glorioso Miranda profusely thanked the Duterte for caring and attending to the needs of the soldiers and reiterated the Army's commitment to make the country free from illegal drugs and crimes.

Miranda also thanked the President for his "frequent" visits to Army camps and wounded soldiers.

Earlier yesterday, 17 couples tied the knot in a mass wedding in Fort Bonifacio. Duterte stood as one of the principal sponsors although he was not present in the ceremony.

The other sponsors were Miranda, Defense Secretary Delfin Lorenzana, and Armed Forces chief Gen. Eduardo Año.

Of the 17, 16 were male soldiers who married civilians while the 17th couple are both soldiers – Sergeants Ralph Tabug and Jonah May Otlang.

Robles, a company commander under the 3rd Scout Ranger Bat-

talion, led the assault of an Abu Sayyaf bomb-making camp in Barangay Tuburan proper in Hadji Mohammad Ajul town in Basilan in May 14, 2015.

The operation led to the killing of three Abu Sayyaf men and one soldier, and wounding of three Abu Sayyaf members and six soldiers. Troops recovered 20 improvised explosive devices from the overrun camp.

Prado, a company commander under the 32nd Infantry Battalion, led soldiers in a 30-minute encounter with the Abu Sayyaf in Barangay Tagbili in Patikul town in Sulu on Feb. 5, 2015.

The firefight resulted in the death of two Abu Sayyaf men and recovery of seven high-powered firearms. Four soldiers were also wounded in the skirmish.

The DCS is the second highest military decoration for bravery in combat. The highest military award is the Medal of Valor, which comes with perks, including P75,000 in monthly gratuity.

Two other soldiers received the third highest military decoration in combat, the Gold Cross Medal. They are Pfc. Eddie Boy Vilar of the 26th Infantry Battalion and Pfc. Glyn Senangote of the 32nd Infantry Battalion.

Vilar, a squad leader, played a key role in foiling a plan of the New People's Army to burn heavy equipment owned by civilians, in Veruela town, Agusan del Sur, on June 27, 2015. The fighting also led to the recovery of an M653 rifle, a K47 rifle and two M16 rifles.


Senangote, a rifle man, participated in a firefight with about 200 Abu Sayyaf men in Barangay Gata, Talipao town in Sulu. The clash left nine Abu Sayyaf men and two soldiers dead and 14 Abu Sayyaf and 15 soldiers wounded.

Twenty-two other soldiers, civilians, government and nongovernment organizations received awards from Duterte, including Major Generals Rafael Valencia and Rhoderick Parayno, commander of the 9th and 2nd infantry Divisions, respectively.

Valencia got an Outstanding Achievement Medal while Parayno received the Distinguished Service Star. The awards are non-combat in nature.

The other awardees were Capt. Armando Gabia and 1Lt. Joe Mark Bitbit (Silver Cross Medal); Lt. Col. Leonardo Pagaduan (Gawad sa Kaunlaran); Lt. Col. Joel Mamon, Cpl. Lolibel Guloy, and Cpl. Adonis Sombrero (Bronze Cross Medal); Sgt. Joseph Hulibayan (Enlisted Personnel of the Year); and Roy Manlampoong (Cafgu Active Auxiliary of the year).

The others are Armi Agatea (model supervisor of the year), Dr. Blanca Bien (model employee of the year), Lt. Col. Allan Rellon (best reservist officer of the year), Sgt. Ronald Locion (best reservist enlisted personnel of the year), Cdt Col. Edmon Limbaga (best male Advanced ROTC Cadet of the year), and Cdt Col. Gea Brellia Jayson (best female Advanced ROTC of the year).



## Top NPA commander in Caraga yields

CAMP MAKAPANDONG, Prosperidad, Agusan del Sur – An alleged top commander of the New People's Army (NPA) who is facing a string of warrants of arrest for murder and other crimes voluntarily surrendered to the 401st Infantry (Unity) Brigade at Camp Makapandong here, a ground Army commander yesterday said.

Col. Cristobal N. Zaragoza, commanding officer of the 401st Brigade based here, identified the alleged top NPA commander as Estelito Camino Jr., alias "Commander Puma", the alleged commanding officer of the Sub-Region Sentro de Grabidad of the CPP-NPA North Eastern Mindanao Regional Committee operating in the tri-boundaries of Surigao del Sur and Agusan provinces.

The 401st Brigade commander cited hardship and disillusionment with the underground movement as reasons for his surrender.

"He surrendered to the 401st Brigade headquarters here on Sunday (April 2) and pledged to support the Army's peace and development program," Col. Zaragoza said.

Camino said he wants to be an example to his sub-commanders to pursue their surrender plan after he has proven that no maltreatment is committed by government forces to those who surrendered contrary to the stories told to them by their older cadres, the

ground Army commander said.

Col. Zaragoza said the guerilla commander was with the NPA for 14 years where he earned several warrants of arrest for the atrocities he allegedly committed.

He revealed that his being with the NPA left him no chance of being with his wife and three children who are also hard-up after the NPAs failed to give their promised monthly support to his family, the 401st Brigade commander said.

He also bared that "most of his comrades are already thinking of laying down their arms at an opportune time as they accordingly believe that the Duterte administration is their best chance to have a peaceful life, he said.

Col. Zaragoza also credited the surrender of Commander Puma to the relentless pressure exerted by the 402nd Infantry (Stingers) Brigade and PNP in Surigao and Agusan.

Maj Gen. Benjamin R. Madrigal, Jr. congratulated yesterday the two Army Brigades, the Police Regional Office 13 and the Intelligence Units of the Army for the surrender of the alleged top NPA commander in Caraga region.

He instructed them to prepare for the influx of surrenderers as Puma has a following in the NPAs in Caraga region.

The surrender happens in the midst of the ongoing peace talks between the Philippine government and CPP-NPA-NDF in The Netherlands.

# Du30 allows settlers to occupy gov't houses

Thousands of homeless families who faced eviction for occupying idle units in six government housing projects in Bulacan province last month are going to keep the houses after all.

President Duterte on Tuesday said he would give members of the urban poor group Kalipunan ng Damayang Maralita (Kadamay) the government houses in Bulacan, and asked military and police personnel, supposed to be the original beneficiaries, to let go of the units.

In turn, Mr. Dutere promised to build better houses for members of the police and the military by December, as he sought understanding for the poor.

As of March 20, 5,262 houses had been occupied by Kadamay members in housing projects in Pandi town and San Jose del Monte City, said the National Housing Authority (NHA), which administers the housing projects.

"Let's not trouble the people there because they're fighting back. Their only sin is really, they are poor like us," Mr. Duterte said at the 120th anniversary celebration of the Philippine Army in Fort Bonifa-

cio on Tuesday.

"I will give you better houses, more expensive, more comfortable and more spacious," he added

The President said he would supervise the new housing project for the police and soldiers himself and make sure these had running water and electricity.

#### Change of tune, 'big triumph'

The tone of the President's statements on Tuesday was a departure from that of his statements last month, when he said the homeless families that occupied the Bulacan houses must follow the law or he would be forced to remove them from the area.

Kadamay members welcomed the President's decision

"That's good. But it should be written down. They have to issue that document because that statement could be taken back anytime," Kadamay chair Gloria Arellano said.

"We will not celebrate yet. We will not yet offer our gratitude [until we are given the rights to the houses]," she said.

Arellano said Mr. Duterte's openness was a "big triumph" for the urban poor. But she also expressed hope that the President would look at the overall problem of homelessness in the country.

"So many houses that are built by the government remain unoccupied," she said. "We hope that they just distribute it to the homeless poor."

### Huge housing backlog

The Kadamay occupation of the government housing project in Bulacan highlights the country's severe housing backlog, estimated at 5.56 million.

The NHA is the sole government agency tasked with building shelters for 1.5 million homeless families, which grow at a rate of 3.4 percent annually.

Addressing Kadamay members, Mr. Duterte said they should not trouble the police or soldiers who were already living in the government housing units.

"Eventually, they will be removed and transferred to a new unit that is better than the one you took from them," he added.

### 'Understand the poor'

Mr. Duterte sought understanding from the soldiers as he defended his decision to give the houses to Kadamay members.

"Well, anyway, I said I'm asking you, if possible, do not be offended. Take it with an open mind, I myself, your President, am pleading with you: 'Let us not wage a fight against our own people. Since they are

poor, try to understand them," he said.

Mr. Duterte said he did not want to use force because it would just result in violence.

"Do not pick a fight. It would be useless. And then the police have guns, and you know,, something could go awfully wrong. Let us let it be," he said.

Mr. Duterte said he had asked the NHA, which had the money to build the new houses, to look for a suitable land for these.

He said he could even give the houses furnished with a bed.

Last week, the NHA lifted the eviction orders it issued against the families after Kadamay members agreed to submit to a validation as housing applicants.

Arellano hoped that the President's pronouncement would cover other abandoned housing units that they occupied in Bulacan, not only those intended for policemen and military personnel.

"The houses should be directly awarded to those who occupy them," said Kadamay spokesperson Michael Beltran.

Beltran said the question remained whether the urban poor beneficiaries would be made to pay for the houses, as with other relocation programs.

Many of the occupied houses have no doors, windows and toilets. INQ

He assured the soldiers that they would have their own houses; that their compensation and other benefits are provided; and their equipment will be modernized.

Kadamay members last month started occupying low-cost housing units of the National Housing Authority in Pandi, San Jose del Monte, and Bustos, all in Bulacan, which were meant for the personnel of Philippine National Police and Armed Forces.

Kadamay members claimed that the police and soldiers do not want the houses which are small, without power and water, and far from Metro Manila. The houses measures about 22 square meters but has a provision for an expansion for a second level.

The NHA said more than 5,000 low-cost housing units in Bulacan located in Pandi Heights 1, Pandi

Village 2 and Pandi Residence 3 have been occupied by Kadamay.

Attempts to evict them had been futile after Kadamay blocked and tried fighting the authorities.

Duterte said he would give the houses to Kadamay provided they not occupy or create problem for the policemen, soldiers and their families who are already living in some of the houses.

He said he intends to transfer the soldiers, policemen and their families who are already occupying units to another location once the new housing units are already completed.

Reports said more than 500 policemen and soldiers have been awarded the housing units.

The Army said it supports President Duterte's appeal to soldiers to leave alone Kadamay members who occupied their housing units.

"We will adhere to the President's appeal. We will talk to our troops and explain to them the position of our President," said Army spokesman Col. Benjamin Hao.

Told that President's stance may encourage similar incidents in the future, Hao just said: "We are going to wait for the right authorities to issue the rules and regulations on this."

The previous administration

built around 20,000 housing units for soldiers and policemen, through the National Housing Authority, in various parts of the country, including Bulacan.

Hao could not immediately say how many soldiers availed of the housing units in Bulacan.

Last year, Magdalo party list Rep. Gary Alejano disclosed that the housing units were substandard and small for a soldier with children. The military confirmed that the units were indeed "too small and substandard."

Military sources saidmany soldiers have signified their intention to avail of the units when the Aquino administration announced their construction. However, they backed out when they saw the actual units.

The PNP said it will not object to Duterte's plan to give the housing units to Kadamay members as it will not be a loss for them since policemen will still be awarded decent homes.

"The President said he will replace the housing units occupied by Kadamay with bigger, better and more comfortable houses for the soldiers and police," said PNP spokesman Dionardo Carlos. – With Victor Reyes and Raymond Africa

## Better housing program for soldiers, police vowed

President Duterte has promised soldiers and policemen that he will move them to a better housing project by December, urging them to just let go of the houses that was originally intended for them,

He made the vow in the wake of the failure of authorities to evict members of the Kalipunan ng Damayang Mahirap (Kadamay) who occupied six housing units in Pandi, Bulacan, supposedly for personnel of the Armed

Forces of the Philippines (AFP), Philippine National Police (PNP), and for informal settlers in Metro Manila.

"I will look into the matter seriously and I will ask 'yung (the) soldiers and the policeman, bitawan na lang ninyo 'yan. Ibigay na lang natin sa kanila tutal mahirap lang sila (to just let go of it and give the houses to the Kadamay because they're just poor)," he said in his almost nine-minute speech at the 120th founding anniversary of the Philippine Army in Taguig.

"But I promise you, I will look for another land nearby and gagawa ako ng mas maganda – may tubig na at may electricity na pagpasok niyo (I will have a housing project for you complete with water and electricity)," he added, comparing it to the current disputed project which has none of the two basic necessities

Duterte, however, hopes that the soldiers and the police will take his plans with an open mind as he said the only sin of the members of the Kadamay is they are poor.

"I'm asking you, kung maaari lang (if possible), do not be offended. Take it with an open mind. Ako na mismo nakikiusap sa inyo (I ask you), let us not wage a fight against our own people," he said, asking the soldiers and police to just understand the situation of the Kadamay

Duterte said he has asked the National Housing Authority (NHA) to look for a suitable land nearby and he will try to finish the housing project there by December.

"I will build another housing project for you [At the] soonest, I intend to build it by December. In the fullness of God's time, maybe by December," he said

"I am making you the commitment, and I guarantee, you will have your [houses] – mas maganda, walang problema (better and problem-free)," he added.

Duterte also assured the soldiers and the police that he will personally go to location of the new housing project to

supervise and ensure the transfer be done by December.

"Magdasal lang tayong lahat (Let us just pray) that everything goes well," he said.

"Wag na lang natin guluhin yung mga tao diyan kasi lumalaban (Let's not touch them because they fight back). Their only sin is just really mahirap din sila kagaya natin (they are poor just like us)," he said.

Kadamay warned

About 24,000 Kadamay members have occupied around 5,740 vacant units in six project sites in Pandi since March 8. They have put up barricades in front of the units to hold off the authorities who would reclaim the units.

However, Duterte warned the Kadamay members to not try to ward off the police and the soldiers who are already settled in the housing units.

"Yung mga Kadamay nandiyan:
'Wag ninyong galawin ang mga sundalo
at pulis kasi paalisin ko kayong lahat
diyan (To the Kadamay members there.
Do not touch the soldiers and the police
or I will drive you out)," he added.

He added that he will transfer the police and the soldiers who have already settled there to avoid conflict and any untoward incident.

"But eventually they will be removed and transferred into – na mas maganda pa sa inyong inagaw (a place that is better than the ones you have taken over)," he said.

The housing units in Bulacan occupied by Kadamay were meant for the personnel of the Philippine National Police and Armed Forces of the Philippines.

## Duterte counts on AFP's help vs drugs

President Duterte yesterday said he is hoping that the military will continue their support in his administration's war against illegal drugs.

In his speech during the 120th founding anniversary of the Philippine Army, Duterte said the Army is vital in solving the country's problems – chaos, terrorism, and drugs.

"It is not only the acts of chaos and terror that you must end. I trust that the Philippine Army and all branches of the military will continue to help us in our drive against illegal drugs," he said.

"This is a serious call not only to you, but to all Filipinos, including your loved ones, whose lives may be affected or lost, if you will not help resolve it," he added.

According to Duterte, without the Army, the government will not be able to eradicate the "ills of society that have been crippling" its development for a long time.

"The Philippines will truly be a harmonious and a progressive nation with you - our soldiers - as our country's vanguards of peace, freedom and justice," he said.

Duterte then assured the army that his administration will sure that they will be at comfort while doing their duties to protect the country.

"As we continue to face both perennial and fresh security challenges, this administration guarantees that our soldiers are well provided with the necessary training, equipment and benefits before they go into war," he said.

The President added that in line with the modernization program on the Armed Forces of the Philippines, the government has been providing telecommunication apparatus and fire power and infantry fighting vehicles to the army.

"This was among the priority initiatives we im-

mediately undertook when I assumed the presidency in July last year," he said.

Duterte then said they have allocated P6.5 billion for Philippine Army projects under the Revised AFP Modernization Plan. This will be used to procure individual equipment such as rifles, pistols, grenade launchers and force protection armors.

He also said he signed an Executive Order last September, 2016 which increases the combat pay for all members of the AFP from ₱500 to ₱3,000 per month and their combat incentive pay from P150 to P300 per day. (Argyll Geducos)

## BI, NAIA manpower woes worsen

The crisis over unpaid overtime work rendered by Bureau of Immigration officers is getting worse, as more BI personnel assigned at the Ninoy Aquino International Airport (NAIA) have resigned or filed leaves ranging from six months to a year.

Red Mariñas, BI Port Operations Division chief at NAIA, said that since January this year, 35 immigration officers (IOs) have resigned and more are planning to quit "They have applied for certificates of employment from our personnel section

to be used for job applications," he

He said at least 17 to 18 IOs are absent almost daily at the four NAIA terminals.

The IOs are those assigned at the immigration counters to process the travel documents of departing and arriving passengers.

Mariñas said that he asked members of the Travel Control and Enforcement Unit (TCEU) and the supervisors to man the vacant counters.

Mariñas is also planning to recruit immigration officers from the Clark and Subic international airports in time for the Holy Week rush next week when thousands of passengers are expected to arrive or leave the country Passengers of Philippine Airlines (PAL) taking international flights were advised to check in at NAIA Terminal 2 at least four to five hours before their flight's estimated time of departure due to insufficient staffing at the immigration counters.

The queues become longer during peak hours from 10 a.m. to noon and from 2 p.m. to 10 p.m.

Before the issue on overtime pay, at least two to three IOs were absent in the four terminals due to illness or emergency matters, but about 17 to 18 officers are absent daily.

Mariñas added that some of the regular employees who quit are lawyers fed up with the overtime pay issue.

Mariñas said that an Immigration Officer 1 has salary grade 11 with basic pay of P16,000 a month

but take-home is only P13,000 after deductions if the employee has no loans

There are 900 contractual workers who have ceased receiving salanes and overtime pay since January this year while overtime pay for some 1,600 organic personnel was also stopped.

Mariñas said Budget and Management Secretary Benjamin Diokno assured the BI that P224.835 million has been appropriated in the 2017 budget specifically for overtime pay of its employees.

Diokno said since there is a specific funding for the overtime pay of BI employees in the 2017 budget, there is no need to tap into the express lane funds.

The BI charges express lane fees from foreigners to expedite the processing of their permits.

Collections from the express lane

fees were previously placed in a trust fund, which was used to pay additional benefits for BI personnel who rendered overtime until President Duterte vetoed it because "there is already funding in the General Appropriations Act (GAA) for this purpose."

"We hope Duterte would hear the wishes of the employees and take action," Mariñas added in Filipino

Mariñas added that the manpower shortage due to the resignation of IOs might adversely affect their operations, especially during peak months, amid the plan that the bureau will add 700 IOs who will undergo months of training

BI spokesperson Ma Antonette Mangrobang said the bureau would deploy starting April 9 some 150 newly hired IOs at the NAIA terminals to augment the shortage of personnel during the

Holy Week

Mangrobang said that Immigration Commissioner Jaime Morente called for a management committee meeting last Monday where they crafted a contingency plan.

She said that 21 other new immigration personnel would be assigned at the international airports in Cebu, Clark, Davao and Iloilo.

Mangrobang explained that even without the reports of BI airport personnel going on leave, the bureau has long been experiencing manpower shortage. There are currently about 1,700 BI regular personnel plus around 300 contractual employees and they hope to raise the number of workers to 4,000.

Malacañang expressed hope that the DBM and BI would reach a compromise to resolve the problem at the NAIA.

Presidential spokesman Ernesto Abella said the budget department has agreed to create additional posts to address the concerns of the BI regarding the salaries of confidential agents related to job orders and overtime pay.

Abella said the Bl has not responded to the budget department's proposals.

"According to the explanation of Secretary Diokno, they have made a proposal and they're waiting for the BI to make the proper response. It's as simple as that. In a sense, it's almost a household accounting job," Abella said.

Abella said Malacañang is hoping that a compromise would be reached to spare the public from inconvenience.

"Somebody should be able to accommodate. There should be some form of compromise and find a way to resolve the situation," Abella said.

"They cannot hijack the government into giving them all their demands through threats of work stoppage and thereby endanger public safety. We recognize their right to overtime allowances, but this must be compliant with pertinent laws and rules that apply equally to all government agencies," he added.

Diokno said the funds for the overtime pay would be released as soon as the BI submits a special request with the budget department.

Diokno said the government would deploy soldiers to temporarily replace Army Vision & immigration officers at the NAIA.



# AFP verifying info on Hapilon's death

#### BY VICTOR REYES

ARMED Forces chief Gen. Eduardo Año yesterday said the military received raw information that senior Abu Sayyaf leader Isnilon Hapilon died in an air strike in Butig town, Lanao del Sur last January.

Año's statement came after President Duterte said Monday that Hapilon, who was said to be organizing a caliphate of the Islamic State of Iraq and Syria (ISIS) in Mindanao, may have been killed in the operation.

"The President said he believes Hapilon might be dead because the latter was seriously wounded and no word from him was heard since then," Año said.

"There are raw reports but we still have no confirmation that Hapilon is really dead. Operations against his group will continue in the Lanao provinces (Lanao del Sur and Lanao del Norte) and Basilan," the military chief added.

The US government is offering \$5 million for information that will bring Hapilon to justice. This is on top of the P10-million bounty from the Philippine government for information leading to his arrest or death.

The air strike was conducted on January 25. It involved the Air Force's FA-50 fighter jets which targeted Hapilon's lair and members of the Maute Group which is also linking itself to the ISIS.

Hapilon was said to have left his bailiwick in Basilan last December to organize the ISIS caliphate in Lanao del Sur.

The military said 15 terrorists died in the air strike, including an Indonesian identified only as Mohisen. Many others were reportedly injured, including Hapilon.

Año said the military's last infor-

mation on Hapilon was last February when Hapilon "was being carried: by four ASG members, transferring' from one temporary base to another in the hinterlands of Butig."

Hapilon had been indicted in the District of Columbia for his alleged role in terrorist acts against Americans and other foreigners in the Philippines, according to the US Rewards for Justice.

Hapilon is involved in the kidnapping of 20 tourists from the posh Dos Palmas resort in Palawan in May 2001. The victims included American missionary couple Martin and Gracia Burnham and American-Peruvian Guillermo Sobero.

Sobero was beheaded by the Abu Sayyaf a month later in Basilan. Martin Burnham died in a rescue operation in Zamboanga del Norte launched by soldiers while his wife was rescued, though injured, in the same operation.

## Military yet to confirm if ASG's Hapilon is dead

THE Armed Forces of the Philippines (AFP) is verifying if Isnilon Hapilon, the leader of the terrorist Abu Sayyaf Group (ASG), is already dead, as President Rodrigo Duterte wanted when he ordered the bombing of the jihadist's lair three months ago.

On Monday, Duterte said he hopes that Hapilon was killed when the AFP conducted air strikes on his hideout.

"The President said he believes Hapilon might be dead because the latter was seriously wounded and no word from him was heard since then. There are raw reports but we still have no confirmation that Hapilon is really dead. Operations against his group will continue in Lanao provinces and Basilan," in southern Mindanao,

said AFP Chief of Staff Gen. Eduardo Año when asked on the pronouncement of the President.

According to the AFP chief, the last report that he heard about the ASG leader was in February when he was reportedly seen being carried by four jihadists as they transfer from one temporary base to another in the hinterlands of Butig in Lanao del Sur.

In late January, Defense Secretary Delfin Lorenzana disclosed that Hapilon had moved to Central Mindanao on orders from the Islamic State in Iraq and Syria or ISIS to find out if the region is conducive to the establishment of an ISIS group.

Citing intelligence reports, the Defense chief bared that the ASG had communication with ISIS, which instructed

the local terrorist group to look for a bigger place to establish an ISIS group because their current strongholds—ulu and Basilan—are too small and they could be easily crushed by security forces.

Hapilon was monitored to have brought a small group of his men.

The bulk of ASG members are still in Basilan, according to Lorenzana.

Brig Gen. Restituto Padilla Jr., AFP spokesman, said as of Tuesday, the military had no information on the fate of Hapilon after the January air strikes.

"We will continue ongoing efforts to ascertain this," he added. FERNAN MARASIGAN

# Sayyaf divides 19 captives into 5 groups

ZAMBOANGA CITY – The Abu Sayyaf has separated its Indonesian and Vietnamese hostages to better elude government troops conducting rescue operations, an official said yesterday.

Maj. Gen. Carlito Galvez Jr., Western Mindanao Command chief, said the bandits divided their seven Indonesian captives into three groups and 12 Vietnamese into two.

Galvez said information provided by civilians helped them locate an area in Barangay Laos in Talipao, Sulu, where the bandits are believed to be hiding their Indonesian hostages. An encounter in the area on Sunday left 10 bandits dead and 32 soldiers wounded.

"We are happy that civilians and local government units provided us with good information. We're happy they heeded the advice of the President," Galvez said However, he said they do

not know where the bandits are hiding the Vietnamese captives.

"We are trying to determine their location either in Tawi-Tawi or Basilan," he said.

A Dutch man and eight Filipinos are among the 28 remaining hostages of the Abu Sayvaf April 2017





## Gov't, Reds agree on joint interim ceasefire

The government and the National Democratic Front (NDF) yesterday agreed on a joint interim ceasefire.

In the fourth round of talks held in the Netherlands, the government peace panel led

"(The NDF) asked for some time to go over (the GRP proposal) and study it, and hopefully, tomorrow will have open discussions already," said GPH peace panel chairman Labor Secretary Silvestre Bello III, who also stressed that the conditions set by the President were "not for the peace talks, but only for the BCA."

And while the four conditions set by Duterte may appear too onerous for the communist side to agree to, Bello said these have actually been discussed before and that the NDF panel was "open to the idea."

"Because under the proposal, there will be signing, but it will be dependent on the convergence of the four annexes that will be the parameters of the BCA," Bello averred

NDF peace panel chairman Fidel Agcaoili said their proposal would consist of declarations of unilateral ceasefire by each party, with these orders being merged together to form a BCA.

Agcaoili contended that the NDF proposal had proven its viability since the unilateral ceasefires imposed by both sides in August, 2016, had held with nary a report of any armed hostilities.

"The rules of engagement were clear, there were no armed hostilities," he maintained.

He was referring to the unilateral ceasefire orders implemented by the GPH and NDF last August when the formal talks started in Oslo, Norway.

Only an encounter in Makilala, North Cotabato, in January broke that truce and eventually led to the withdrawal of the unilateral ceasefires in early February.

## AFP pushes for joint ceasefire

Air Force Brig. Gen. Restituto Padilla, spokesman of the Armed Forces of the Philippines (AFP), called on leaders of the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF) to agree to signing a joint ceasefire with the government if it is really sincere in achieving lasting peace in the country.

Speaking at a press briefing at Camp Aguinaldo, Quezon City, General Padilla said, "We can see that a unilateral ceasefire arrangement will not be effective, as what we have experienced in recent months. There are a lot of complaints but there is no one that has the power to investigate, to implement and render who is accountable on either side," Padilla said.

"So the ceasefire agreement

"So the ceasefire agreement remains fragile that's why we are pushing to have a joint ceasefire agreement which is more durable," Padilla said. "For as long as there is no joint ceasefire agreement signed, with mechanisms laid out in order to maintain and ensure that the ceasefire period will reign, we will not suspend our military and police operations."

Padilla said the refusal of the communist side to sign a joint ceasefire agreement shows that they are only concerned with their own interests.

On the Communist Party statement stating that stopping the "revolutionary tax" in NPA- controlled areas, is not acceptable, Padilla said the NPA cannot claim control of any part of the country.

"Nobody has control of any part of the Republic of the Philippines. Anytime, soldiers and policemen can go to any place because we only have one country, the Republic of the Philippines, and there is no group here that can control any part of the country. That is why we will not recognize that," Padilla said. (Francis Wakefield)

# CPP supports peace talks, warns against peace-spoilers'

The Communist Party of the Philippines (CPP) on Tuesday called on its political wing, the National Democratic Front of the Philippines (NDFP), and the government to speed up negotiations to end nearly 50 years of rebellion but warned that "peace-spoilers" and preconditions set by President Duterte could derail the talks

In The Netherlands, where the fourth round of formal talks opened on Monday, CPP founder Jose Maria Sison, chief political consultant of the NDFP in the talks, said the rebels would reject preconditions that could undermine their position.

"NDFP will resist any attempt of the [government] at making it submit to capitulation, mere pacification or self-destruction," Sison said in an online interview late on Monday.

The President on Sunday set four preconditions for the fourth round of talks, including the forging of bilateral truce and the release of soldiers and policemen held by the New People's Army. He also demanded an end to the rebels' revolutionary tax collection and territorial claims.

#### Military establishment

In a separate statement on Tuesday, the CPP congratulated the NDFP and the government negotiating panels for pushing through with the fourth round of talks "despite the peace-spoiling by stooges of US imperialism in the military establishment," referring to Defense Secretary Delfin Lorenzana, National Security Adviser Hermogenes Esperon and Armed Forces of the Philippines Chief of Staff Gen. Eduardo Año.


Lorenzana tagged the rebels as "terrorists" and he and senior officers of the AFP also insisted on a bilateral ceasefire agreement before resuming the talks, the CPP said.

The President set other conditions that had pushed the talks "to the brink," but to the credit of the flexibility of the two peace panels the negotiations moved ahead despite the preconditions, it said.

"For peace talks to continue moving forward ... President Duterte must reject the insistence of the militarists to prematurely push a bilateral cease-fire agreement even before agreements on substantive issues are forged," the CPP said. "Discussions on the more crucial socioeconomic issues, which the GRP panel also considers the meat of the negotiations, should not be preempted."

"The CPP and all revolutionary forces call for acceleration of negotiations to forge am agreement on comprehensive socioeconomic reforms, which are at the root of the armed conflict," it added.

Discussions on a bilateral ceasefire could come "as a consequence" of the Comprehensive Agreement on Social

and Economic Reforms (Caser) and the Comprehensive Agreement on Political and Constitutional Reforms (CAPCR), it said.

Sison said both parties "should (move) ahead of the issue of ceasefire, the social, economic, political and constitutional reforms demanded by the people and needed to address the roots of the civil war."

By setting the preconditions for the talks, Mr. Duterte and the government were "just maximizing their demands in the press," he said.

Sison said the specific policy issues that were important to both sides would determine the "concrete content" of the range of their respective minimum and a maximum negoti-

ating stance.

"For instance, ceasefire is a policy issue," Sison said.
"There must be flexibility in determining what kind of ceasefire can be accepted by the negotiating parties. What are circumstances and requirements for that ceasefire?"

#### Release of political prisoners

In his opening remarks at the opening of the talks in The Netherlands on Monday, Sison said the immediate forging of a bilateral truce would depend "if President Duterte can put forward the amnesty and release of all political prisoners listed by the NDFP."

Despite all the challenges and hurdles to the talks, Sison expressed hope that the government and NDFP would agree and sign two major agreements in the latest round of negotiations—the Caser and the bilateral ceasefire.

He indicated that after reading and studying the draft proposals, both sides could reach an agreement. "I observe that there are enough concurrences and similar positions as common ground for forging the agreements," he said in his speech.

He said, however, that "as a matter of principle" Caser should come ahead of the ceasefire agreement "unless these agreements can be signed at the same time by the panels and then by the principals." INQ

#### Military peace spoiler – analyst

THE commitment of the Philippine government and the National Democratic Front of the Philippines (NDFP) to forge a fair deal and their determination not to be affected by acrimonious issues are crucial in keeping the momentum of the peace negotiations, a political analyst said on Tuesday.

Professor Bobby Tuazon, director for Policy Studies

of the Center for People Empowerment in Governance (CenPEG) said President Rodrigo Duterte's commitment to finish the peace talks within his term is a positive step on the part of the government.

However, Tuazon stressed that if the President wants to have accurate information on the ground, he should stop listening to the military which he described as a "peace spoiler."

"Mr. Duterte should listen to his , own panel as well as to independent reports from the tri-media and human rights groups," he said.

According to Tuazon, at least 30 activ-

ists and farmers have been killed by the Armed Forces of the Philippines (AFP) and paramilitary units since July last year. This is aside from the bombing of communities in Mindanao, Abra, and other provinces following the president's directive to the military to launch an "all-out war" against the New People's Army.

"The AFP has not been candid in admitting that military operations also continue in the provinces. Unfortunately, many accounts reveal that government forces have been suffering some setbacks," he added.

The government and NDFP resumed peace negotiations on Tuesday in the Netherlands, a process seen by both sides as "difficult."

Asked if the negotiations will prosper despite obstinate refusal of the President

to release political prisoners, one of the demands of the communist group. Tuazon said the government panel and NDFP on March 11 issued a joint communique in Utrecht clearly stating that the Duterte government will release a number of political prisoners on humanitarian grounds before the resumption of talks in April.

"President Duterte has not acted on this commitment," he added.

Tuazon believes that the forging of a bilateral ceasefire is possible since both panels have agreed to discuss a truce which is necessary so that both parties can tackle with less hindrance the substantive agenda, especially the Comprehensive Agreement on Social and Economic Reforms (CASER).

#### Peace train


he once seemingly unstoppable train to peace with the longest running communist insurgency in the world is limping out of its fourth station on the new route—delayed by a day, dragged down by issues of bad faith and unkept promises, disturbed by new questions about ultimate direction.

But the important thing—to borrow a metaphor close to President Duterte's railway-obsessed heart—is that it is back on track It is still not picking up pace as it should, the rail line ahead needs to be tested for signs of strain, the list of stations to stop at remains dauntingly long. But at least the fourth round of negotiations in Europe, hosted by the Dutch government, is finally underway.

Several weeks ago President Duterte threw a spanner into the works, causing the train to sputter to a halt. The scale and surprising swiftness of the change almost caused a derailing of the peace talks; the negotiators of the National Democratic Front were disoriented and—the candid truth—the government's own negotiators were also caught by

surprise. Can the peace negotiations survive what appears to be President Duterte's change of heart?

The answer depends in part on whether what has happened since was merely a change of tactics on the part of the government, but not of strategy. In this view, the President has had to reconsider and recalibrate his public approach to the negotiations because of increasing resistance from within the defense department and the military. Still smarting



from the decision to release Benito and Wilma Tiamzon to allow them to serve in their role as NDF peace consultants, the security establishment had grown wary of the many concessions the Duterte administration has granted the communist movement.

Candid as always, the President admitted that he could no longer follow through on his promise to release hundreds of political prisoners because it would mean he would have fewer cards left to play with, in the protracted negotiation, Last Sunday, he outlined a set of four conditions—what he called his "barest conditionalities"—which he said needed to be met before the peace talks can resume, These include a signed bilateral declaration of a permanent ceasefire ("a signed official document"), the end of the NPA practice of collecting so-called revolutionary taxes ("no extortion or revolutionary tax"), the recognition by the communist movement that it cannot in fact claim any territory in the country as its own ("That's crazy"), and the release by the NPA of all its prisoners. "This fight has been going on for the last 50 years. I hate it.'

Are these barest conditionalities meant, not to deny the communist movement the space in which to move, but rather to enable the Duterte administration to find the elbow room for negotiation? It is negotiating with the views of the security establishment in mind. Instead of concessions, it would come back to the peace table with these conditions, confident that the aging leaders of the communist movement will also return to the table. That is one view.

But the answer also depends in part on whether President Duterte has come to a different realization about the true nature of the communist insurgency. In this view, the increasingly audacious excursions by the New People's Army into non-conflict zones led to the decisive moment when Mr. Duterte, who describes himself as a socialist and a longtime friend of the NPA rebels in his area, finally saw the insurgency for what it is—as antithetical to the government he now heads. As city mayor, he could afford to allow a massive funeral march for an NPA leader. As president and commander in chief, he would be courting possible impeachment.

But whether the new realities that have transformed the most optimistic cycle of the on-again, off-again peace negotiations into what chief government peace negotiator Silvestre Bello now calls "very difficult and exacting" talks were triggered by a change in the President's tactics, or a change in his overall strategy, the fact remains that negotiations are the most certain road to a lasting peace. We should support the ongoing round of talks, and hope for a successful outcome.

## Philippine soldiers kill 'more than 10' militants in bid to free captives

MANILA - Philippine soldiers killed "more than 10" Islamic State-linked Abu Sayyaf militants in an attempt to free Vietnamese captives held on a remote southern island as troops fired howitzer shells on rebel positions, an army general said on Monday.

The small but violent militant group, known for extortion, beheading and kidnap-for-ransom activities, is holding more than two dozen captives on Jolo island. It beheaded a German captive two months ago when no ransom was paid for his release.

Major-General Carlito Galvez, military commander of western Mindanao, said 32 soldiers were also wounded in Sunday's assault on an Abu Sayyaf hideout in Talipao town, where the militants were believed to be holding six Vietnamese captives.

"The 105mm howitzer directly hit enemy positions," Galvez told reporters, saying four rounds were fired when advancing troops were pinned down.

"More than 10 were killed. Our troops had discovered mangled bodies in the area, but we continue to pursue them."

There was no word on the fate of the captives. Four of the wounded soldiers were airlifted to a hospital while 28, among them a battalion commander, had minor shrapnel wounds from grenade blasts.

Galvez said troops had clashed for more than an hour with about 100 Abu Sayyaf rebels led by Radullan Sahiron, a one-armed militant leader who figures on the US State Department's wanted list, with a \$1-million bounty.

Last month, five Malaysians were freed on Jolo and two Filipino sailors were rescued on nearby Basilan island by soldiers chasing the Abu Sayyaf militant group.

# 'Let it go': Duterte to build new housing for soldiers, cops affected by Kadamay occupation

MANILA - President Rodrigo Duterte has promised police and soldiers affected by the occupation of a housing project in Pandi, Bulacan by followers of Kalipunan ng Damayang Mahihirap (Kadamay) that he will build another housing project for them by December.

He asked that the soldiers and policemen "let go" ("Bitawan na lang ninyo 'yan.") of the Pandi housing project originally meant for them, because the people who would now benefit from it were poor, anyway.

"This ruckus in Bulacan, eh parang inagaw ng mga kapwa nating Pilipino na mahirap rin (it's like our fellow poor Filipinos stole from us). I will look into the matter seriously, and I will ask you soldiers and the policemen, bitawan na lang ninyo 'yan (let it go). Ibigay na lang natin sa kanila, tutal mahirap sila (Let's just give it to them, since they're poor). But I promise you, I will look for another land nearby or adjacent or maybe contiguous to that area there. And gagawa ako ng mas maganda, may tubig na at may electric na pagpasok ninyo (And I will make a better one, with water and electricity once you get there)," Duterte said Tuesday. He was speaking at the 120th founding anniversary of the Philippine Army at its headquarters in Fort Bonifacio, Taguig City.

"Ako na mismo, inyong presidente, nakikiusap sa inyo (Your president himself beseeches you). Let us not wage a fight against our own people. Tutal mahirap lang 'yan sila (After all, they're poor). Intindihin na lang ninyo (just understand them), and I will build another housing project for you soonest, and I intend to complete it by December," Duterte added.

He promised a better, bigger, more comfortable housing project for the police and the soldiers, and stressed that he would go to the area personally to supervise the new housing project.

He also addressed Kadamay in his speech, asking them not to disturb the soldiers and the police, as well as not to create trouble.

"Ngayon 'yung Kadamay, ibigay ko na lang 'yan sa inyo (Now as for Kadamay, I will just give it to you)... Huwag niyong paalisin 'yung mga sundalo pati pulis na nandiyan na (Just don't force the soldiers and police who are already there out). But eventually they will be removed and transferred to a new, na mas maganda pa sa inyong inagaw (nicer than what you occupied). Para hindi na kayo mag-ano (So that you will no longer)... Ayoko kasing pilitin ang isyu because it would somehow result in bugbugan, mga paluan (I don't want to force the issue because it would somehow result in fistfights, beatings)," Duterte said.

As of last week, about 5,000 urban poor informal settlers had been occupying the vacant units of a housing project originally meant for soldiers and police personnel in Pandi, Bulacan.

After that, another KADAMAY group tried to take over supposedly vacant units in Bocaue Hills, also in Bulacan, but Army Core Purpose: Serving the people. Securing the land.

According to the PCUP chairman, the country's housing fund was worth less than one percent of the national budget, an amount that "pales in comparison" to the budget for education, health, and social welfare.
