

NoKořmissi explodes on launch

SEOUL-A North Korean missile exploded during launch on Sunday, US and South Korean officials said, a high-profile failure that comes as a powerful US aircraft supercarrier approaches the Korean Peninsula in a show of force.

It was not immediately clear what kind of missile was testfired from the east coast city of Sinpo.

But the failure will sting in Pyongyang because it comes a day after one of the biggest Korean propaganda events of the year—celebrations of the 105th birthday of late North Korea founder Kim Ilsung, the current leader's grandfather.

The North's test firing can be seen as a message of defiance to the Trump administration in Washington, coming as it did on the day US Vice President Mike Pence arrived in Seoul for talks on North Korea as part of his 10day trip to Asia.

Pence said North Korea's "provocation" was another reminder of the risks that US and South Korean service members faced every day "in the defense of the freedom of the people of South Korea and the defense of America in this part of the world."

At a fellowship dinner at US Army Garrison Yongsan in Seoul, Pence said that the willingness of military members "to stand firm without fear [inspired] the nation and [inspired] the world."

US President Donald Trump was uncharacteristically quiet about the failed launch.

In a statement, Defense Secretary Jim Mattis said Trump and his military team were "aware of North Korea's most recent unsuccessful missile launch. The president has no further comment."

The failure, which is likely to be-seen as a public embarrassment for the regime, came amid soaring tensions in the region over the North's nuclear weapons ambitions.

"The missile blew up almost immediately," the US Defense Department said of the early morning launch, which was also

detected by the South Korean clear-tipped shorter range mismilitary. 🙏 🚐

Missiles

Washington and Seoul will try hard to figure out what exactly North Korea fired.

This matters because while North Korea regularly launches short-range missiles, it is also developing mid-range and longrange missiles meant to target US troops in Asia and, eventual-Iv, the US mainland.

It came after North Korea displayed nearly 60 missiles-including what is suspected to be a new intercontinental ballistic missile—at the Saturday parade.

The ultimate goal is to have a full array of nuclear-tipped missiles in response to what Pyongyang said was hostility by Washington and Seoul meant to topple its government.

North Korea is thought to have a small arsenal of atomic bombs and an impressive array of short- and medium-range missiles.

Many outside analysts believed that North Korea had not vet mastered the technology to build warheads small enough to place on long-range missiles, though some civilian experts said it could already build nusiles that have South Korea and Japan within its striking range.

South Korea's defense ministry said it was analyzing exactly how the North Korean launch failed.

High animosity

In Seoul, South Korea's presidential office convened a national security council meeting to examine security postures.

High animosity has risen on the Korean Peninsula in recent months, as the United States and South Korea conduct its annual war games which North Korea claimed were preparations for an invasion.

A US aircraft carrier, the USS Carl Vinson, is headed to waters off Korea in a show of force.

Analysts warned that even failed missile launches could provide valuable knowledge to North Korea as it tried to build its weapons program.

The country launched a long-range rocket and conducted two nuclear tests last year, including its most powerful to date.

Aside from improving the technology, North Korean missile and nuclear tests are seen by outside analysts partly as efforts to bolster the domestic image of leader Kim Jong-un and apply political pressure on Seoul and Washington.

Kim Jong-un has overseen three nuclear tests and a string of missile and rocket launches since taking over after the death of his father, dictator Kim Jong il, in late 2011.

Another missile test from Sinpo failed earlier this month, when the rocket spun out of control and plunged into the ocean:

That launch came shortly before Trump's first meeting with Chinese leader Xi Jinping.

China is North Korea's only major ally.

The extended-range Scud missile in that earlier launch suffered an inflight failure and fell into the sea off North Korea's east coast, according to US imagery and assessments.

Despite Sunday's failure, the North's previous claim to have used "standardized" warheads has led to worries that it was making headway in its push to develop small and sophisticated warheads to be topped on long-range missiles.

Washington sees North Korea's pursuit of nuclear weapons and ballistic missiles as a threat to world security and to its Asian allies, Japan and

South Korea.

The United States, South Korea and other countries have vowed to apply more pressure on the North, but so far nothing has worked to stop Pyongyang's nuclear program.

Six-nation negotiations on dismantling North Korea's nuclear program in exchange for aid fell apart in early 2009.

Provocation .

"It is likely that this launch is a test for a new type of missile or an upgrade so the possibility is high for further provocation in the near future." Kim Dongyub, a military expert at Kyungnam University's Institute of Far Eastern Studies in Seoul, said.

In August last year, a submarine-launched ballistic missile tested from Sinpo Flew 500 kilometers (300 miles) towards Japan.

North Korean leader Kim Jong-un hailed that test as its "greatest success" and said it brought the US mainland within range of a mobile delivery system.

Pyongyang's rogue atomic ambitions have come into sharp focus in recent weeks, with Trump vowing a tough stance against the North and threaten-

ing unilateral action if China failed to help curb its neighbor's nuclear program.

With speculation mounting that the North is preparing to conduct a sixth nuclear test, he sent an aircraft carrier-led strike group to the Korean peninsula—a pointed gesture in the wake of the recent US missile strike on Syria.

But the defiant regime has reiterated it was ready for war with the United States, and its army vowed a "merciless" response to any US provocation.

Recent satellite images suggested that the North's main nuclear site was "primed and ready," according to specialist US website 38North, and White House officials said military options are "already being assessed."

China, the North's sole major ally, and Russia have both urged restraint, with Beijing's foreign minister Wang Yi warning that "conflict could break out at any moment."

The UN Security Council has imposed six sets of sanctions against the North since its first nuclear test in 2006 — all of which have failed to halt its drive for what it insists are defensive weapons. —REPORTS FROM APAND AFP

Abu Sayyaf beheads Filipino hostage

The Abu Sayyaf has beheaded one of ts Filipino captives in Patikul, Sulu, the Armed Forces of the Philippines (AFP) onfirmed yesterday.

Noel Besconde, one of the crewmem-

bers of F/B Remona seized in the Celebes Sea in December, was executed at around 2:30 p.m. on April 13, according to Brig. Gen. Cirilito Sobejana, chief of Joint Task Force Sulu (JTFS):

Sobejana said they received the intermation on the same day, but did not confirm it until the AFP secured a copy of a video of the killing allegedly perpetrated by the group of Abu Sayyaf leader Hatib Sawadjaan.

The search and retrieval operation for the victim's body is ongoing in the western

part of Patikul.

"We have confirmed it because we have seen the video and we have reports on the ground. We are now doing our best to locate the cadaver and bring the body to the family," Sobejana said.

The military said the beheading was more of a necessity on the part of the bandit group, as the victim was reportedly getting sickly.

Sobejana said dragging a sick captive hampers the movement of the bandits, who have constantly been on the run to evade pursuing soldiers.

He said the group had probably contacted the victim's family to ask for P3 million as ransom, which they failed to obtain as the Bescondes are not rich and the military is firm on the no-ransom policy.

Initially, the AFP did not believe the information, thinking it was just proparated

Sobejana said the video showed scenes not similar with previous beheadings wherein the terrorists appeared first to be doing some rituals.

"This one showed the killing was done

in haste," he said.

In February, the Abu Sayyaf beheaded the 70-year-old German, Jurgen Kantner, for failure to pay P30-million ransom. Pursuit operation

Pursuit operation against the Abu' Sayyaf bandits who stormed Bohol last week is ongoing, even as AFP chief Gen. Eduardo Año declared that the terror threat in the province is over.

"Our assault team continues scouringthe area," he said, noting Army soldiers are hunting down the remaining bandits including Joselito Melloria, alias Alih, whose photographs are being distributed in the island.

Melloria allegedly served as a guide for Abu Sayyaf in Inabanga, where an encounter broke out last Tuesday and resulted in the death of four bandits, three soldiers and a police officer.

Año said the swift military and police action resulted in the killing of Maumar Askali, alias Abu Rami, leader and spokesman for the bandit group.

Año earlier expressed confidence that the military could eliminate the Abu-Sayyaf by June 30.

'Show must go on'

The Bohol clash between the military and the bandits will not deter a scheduled conference of the Association of Southeast Asian Nations (ASEAN) in the province on April 19-20.

The Department of the Interior and Local Government (DILG) gave assurance that security measures are in place to protect the participants and delegates and secure the event.

"The military and the police are on top of the situation. We assure delegates, tourists and residents we are exerting our best efforts for Bohol," DILG officer-in-charge Catalino Cuy said.

RESIDENT Rodrigo Duterte told security forces Sunday to finish off the Abu Sayyaf as another of the terrorist group's sub-leaders was sighted in Negros Oriental province, and as the bandits beheaded another kidnap victim.

off ASAP," said Defense Secretary Delfin Lazaro after Duterte received a briefing from security officials.

Last week, Abu Sayyaf bandits planning a terrorist attack clashed with police and troops in Inaban-

Intelligence officers, ever, said another sub-leader of the group, Alhabisi Misaya, was spotted in Negros Oriental, constituting a threat to nearby Apo Island, Sumilon Island and Siquijor.

A spokesman for the Armed Forces, Brig. Gen. Resty Padilla Jr., said the all-out war on the Abu Sayyaf would continue.

In an interview, Padilla said the AFP's Joint Task Force Sulu commanded by newly promoted Army Brig. Gen. Cirilito E. Sobejana, is the main unit tasked to track down some 300 Abu Sayyaf terrorists in Mindanao, mostly on the island of Sulu and nearby islets.

on the unrelenting war against the Abu Sayyaf, which is still holding about 30 hostages.

Ground forces are supported by artillery of the Army, and planes and helicopter gunships of the Air Force.

The Navy has also intensified its sea patrol around Sulu and nearby Tawi-Tawi islands to prevent the terrorists from escaping.

Aside from kidnapping, the Abu Sayyaf is also engaged in drug trafficking to raise funds for their terroristic activities which must be stopped, Sobejana said.

He also said that Muammar Askali, alias Abu Rahmi, who was killed in Bohol last week following a gun battle with government forces, was the most notorious Abu Sayyaf member and is believed to have led the recent beheading of foreign hostages.

Rahmi slipped out of Sulu because of the intensified military offensive on the island and went to Bohol together with some of his henchmen but five of them, including Rahmi was killed.

Amid the Abu Sayyaf incursions into provinces with popular tourist destinations, National Security Adviser Hermogenes Esperon said the government is ready to thwart possible attacks by the bandits, who typically abduct tourists and behead them if no ransom is paid.

During the President's meetings Arab leaders, Duterte discussed counter-terrorism efforts against threats such as the Islamic State, Esperon said.

In recent speeches, Duterte warned that ISIS could spread to Southeast Asia, particularly to the Philippines, if the jihadist movement falls in the Middle East.

On Sunday, military officials confirmed the beheading of another Abu Sayyaf kidnap victim.

Reports said Noel Besconde, a crew member of the FB Ramona, was beheaded by Abu Sayyaf subleader Hatib Hajan Sawadjaan near Patikul, Sulu.

Besconde was abducted with three other crew members along the waters of the Celebes Sea late last year. Military sources said Besconde was "very sick" before he was beheaded.

On Saturday, the Interior Department assured participants in the scheduled Association of Southeast Asian Nations activity on April 19-20 in Bohol would proceed as planned, despite the recent clash between the Abu Sayyaf and security forces in the province that left three soldiers, a policeman and six bandits dead.

Among those killed in the firefight was Abu Sayyaf leader Moammar Askali, an emerging hard-line leader who had pledged allegiance to the Islamic State group.

In a statement, Interior Secretary and officer-in-charge Catalino Cuy said Bohol "might as well be considered a well-fortified and most secure place in the country right now."

Cuy, a retired police general, added that the "military and the police are on top of the situation."

"We would like to assure the delegates, tourists and residents

alike that we are exerting our best efforts for Bohol," he said.

Officials said that about 4,000 personnel from the Philippine National Police, AFP, emergency response units and various agencies will be deployed during the Asean Summit meetings, which are expected to draw around 200 delegates.

The Bohol meetings, which will include trade-related sessions, will be held at the Hennan Resort in Panglao town.

The province will be hosting many ministerial, senior official and fechnical working group meetings throughout the year.

Cuy echoed the sentiments of Bohol Gov. Edgar Chatto that the situation in Inabanga would not affect the rest of Bohol or the rest of the country.

Inabanga is about 80 kilometers away from the venue, Panglao Island, which is close to the capital Tagbilaran City.

Earlier, the Bohol governor assured the public that law enforcers have the province's security under control and that the situation in Inabanga, where the intense firefight took place, had gone back to normal.

On April 26 to 29, Metro Manila will play host to the 30th Asean Summit, with the major summit on the last day to be held at the Philippine International Convention Center.

The Philippines currently chairs the Asean Summit 2017 and will also host the 31st Asean Summit on Nov. 10 to 14 in Clark, Pampanga. The country's chairmanship coincides with 50th Anniversary of the 10-nation bloc. With PNA

Army seeks release of two soldiers as promised by Reds

AVAO CITY (PNA)—The Philippine Army's 10th Infantry (Agila) Division (ID) urged Sunday the Communist Party of the Philippines and its armed wing, the New People's Army (NPA); to make good their promise to release two soldiers they abducted in Sultan Kudarat province last February.

"We denounce the CPP-NPA for its 'double-faced lie' in not releasing the two soldiers of the 39th Infantry Battalion they abducted at the height of the unilateral ceasefire last February 2," said Capt. Rhyan Batchar, chief information officer of 10th ID.

The soldiers who are still being held by the communist rebels are Sgt. Solaiman Calucop and PFC Samuel Garay. Batchar said there was "no more hindrance to the release of the soldiers."

As part of a joint statement issued last April 6 after the fourth round of its talks with the Philippine Government (GRP) in Noordwijk, The Netherlands, the National Democratic Front (NDF), political arm of the Communist group, agreed to release government security personnel under NPA custody—two on Easter Sunday, and another two after.

But a day after, the NDF accused the Armed Forces of the Philippines (AFP) of refusing to, suspend military operations to pave the way for the release of abducted soldiers in Mindanao, including Calucop and Garay.

But Bachar said the 10th ID and the

39th IB have already suspended their military operations against the NPA rebels responsible for the abduction of Calucop and Garay.

"We demand that the NPA immediately release our soldiers without any condition, as this is the only way to rectify the "treacherous and insincere act" of abducting our soldiers while the unilateral ceasefires are still in effect," Batchar said.

In an interview last week, AFP Chief of Staff Gen. Eduardo Año said there was no need for a SOMO (suspension of military operations), noting that the NPA already released two abducted government troops in Davao Oriental last March even if there was no SOMO in the area.

Army not sure of Sayyaf sightings

ACOLOD CITY, Negros Occidental: The military here said it cannot confirm that armed men reportedly sighted in Cauayan town, Negros Occidental, on Friday night are members of the terrorist Abu Sayyaf Group (ASG).

According to 1st Lt. John Tumamao, commander of the Philippine Army 79th Infantry Battalion's Bravo company, some residents claimed to have seen armed men passing by a river in Sitio Capaclan, while others said they were not sure whether the men they saw were carrying firearms or just backpacks.

Tumamao said his menhave been hearing different stories from the locals. Some residents reportedly heard gunshots in Barangay Inayawan that "may have come from New People's Army rebels," he added, referring to the communist guerrillas.

What concerned many residents most was the white pump boat found near the shore in Inayawan.

On board the boat were an American, Frank Blaskis, 74, and his 12-year-old daughter.

Blaskis allowed the Coast Guard

to check his boat and cargo.

But suspicion that armed men boarded his boat or that they were on two other boats believed to have arrived at the same time as he did angered the American.

He explained that he and his daughter were from Bacong in Negros Oriental and that they were traveling to Iloilo but were forced to seek shelter in Cauayan because of huge waves.

Blaskis denied hearing gunshots and seeing armed men upon arriving in the area.

Barangay (village) chief Sanderson Sumugot Jr. said village officials could not establish a link between Blaskis and the two other boats reportedly used by the armed men.

Blaskis said they only carried one bag with them and that their boat cannot carry 10 persons.

"I want to know who spread the

rumors," he told a local radio station.

Coast Guard personnel who inspected the pump boat did not see anything suspicious.

Blaskis and his daughter later returned to Negros Oriental.

Chief Insp. Ruben Pajarito, Cauayan municipal police chief, assured residents that "what happened in Bohol last week will not happen" in his watch.

On Friday, many residents in the area were not able to sleep after reports that members of the Abu Sayyaf who clashed with government forces in Bohol may have reached their place.

Government forces continued to patrol Cauayan and the neighboring areas while intelligence reports are being validated.

Authorities advised residents to remain calm and to cooperate and coordinate with local police and the military.

3 NPA rebels killed in Masbate clash

Three New People's Army rebels were killed while an undetermined number of rebels were wounded in an encounter with government troopers in Milagros, Masbate on Holy Saturday, an Army official said in a belated report yesterday.

Col. Greg Almerol, commanding officer of the 2nd Infantry Batallion, added that four high-powered firearms were recovered during the hour-long "intense firefight" that occurred in Barangay San Antonio, Milagros town between elements of the 2ndIB and some 50 communist rebels.

He said the three communist rebels, who have yet to be identified, were killed during the firefight while three M-16 rifles, an M-14 rifle and a shotgun were recovered from the rebels.

"In addition, there were 28 improvised explosives taken from the rebels." he added.

Almerol said a generator set, ammunition for M-16 and M-14 rifles, communist propaganda materials and personal belongings of the rebels were left behind in the clash site.

He said villagers in Barangay San Antonio had tipped off authorities about the presence of the NPA guerrillas because they "resented the extortion (of the rebels) through the so-called revolutionary taxation."

Almerol said he immediately organized a team from the Scout platoon of the Alpha and Bravo companies of the 2nd IB under Capt. Jessie Cabangcala to check the; information but the government troops were immediately fired upon around 7:30 a.m. on Saturday when they reached the area.

He said the NPA rebels were under the command of Ruel Ibañez alias "Gemo."

"Our troops in the area are still conducting hot pursuit operation against the fleeing rebels," he said.

It was the second encounter between 2nd IB troops and NPA rebels this year. On February 13, four top NPA rebels were killed in a clash in Barangay Pangle in Aroroy town.

Army denies accusations of having abusive members

THE Army's 10th Infantry Division belied allegations by a militant organization attributing the deaths of several people in Davao Region to their soldiers.

Captain Alexandre Cabales, acting chief of the 10th Infantry Division Public Affairs Office, said the Armed Forces of the Philippines (AFP), particularly the 10th Infantry Division, do not condone any misbehavior and abuses of its members.

He said the division urged the organizations, like Karapatan, to file complaints against suspects of those killings—soldiers or not—before the appropriate government investigating or judicial bodies so justice will be served.

"If the suspects are members of the division, we will welcome, cooperate and support the investigations and judicial process. We will be grateful to those who will help us purge our ranks of misfits and abusive members," Cabales said.

Cabales also urged the organizations to go beyond their usual communist propaganda lines and seek justice for those victims through the rule of law and not through press releases and statements.

"The police likewise called upon the community or anyone who has information to help them in their investigations. The allegations against our soldiers are therefore unfounded without any basis," he added.


Cabales said based on their initial investigations and research of police reports, the deaths of the couple Ramon and Leonila Pesadilla in Compostela, the couple Arlene and Arman Alcominar, Cora Lina in Laak, Pedro Pandagay in Mabini, Danilo Nadal and Edwin Catog in Pantukan, and Elias Pureza in San Isidro in Davao del Norte are still under investigation and that there is still no suspect.

LORENZANA SAYS CPP DELUSIONAL ON BOHOL ATTACK

Defense Secretary Delfin Lorenzana on Sunday lashed out at the Communist Party of the Philippines (CPP) for claiming that the United States was behind the Abu Sayyaf attack in Bohol last week.

Lorenzana said the CPP had become "delusional" and had become "the victim of its own 'propaganda" when it claimed that the US Central Intelligence Agency (CIA) was behind the bandits' incursion in Central Visayas.

"The CPP, as before, has become delusional and can no longer distinguish between what is fact and what is fantasy," Lorenzana said.

"It has clearly become a victim of its own propagandizing and has rendered itself inutile and an unreliable source of the truth. It is not and has never been credible," he said.

Last week, Abu Sayyaf members arrived in Bohol but were cornered by the military and the police.

The ensuing firefight killed six rebel gunmen as well as three soldiers and one policeman.

However, the CPP on Friday accused the United States of being behind the Abu Sayyaf attack, which Lorenzana denied.

"Definitely, transparency is not a value they have. Just like the Plaza Miranda bombing which they hatched, executed, denied, and eventually admitted, the CPP is likely to create scenarios and will pass off these lies as the truth in order to push its selfish, antipeople and antigovernment motives, such as extortion, kidnapping and intimidation," Lorenzana said.

"If there is a fake organization composed of individuals pretending to be patriots and nationalists, it is these communist terrorists," he said.

In its statement, the CPP questioned statements from the Philippine government and called the military operations "overkill."

"The news stories regarding the supposed arrival and presence of members of the Abu Sayyaf criminal bandit group in Bohol island smacks of US yarn," the CPP said.

Department of National Defense (DND) Secretary Delfin Lorenzana on Sunday said that the Communist Party of the Philippines (CPP) has become delusional and can no longer distinguish between what is fact and what is fantasy,

ABU SAYYAF BANDITS BEHEAD BOAT CAPTAIN ABDUCTED IN CELEBES SEA

Abu Sayyaf bandits beheaded a Filipino fishing boat captain abducted last December in the Celebes Sea, a ranking military efficial said vesterday.

Brig, Gen. Cirilito Sobejana, head of Joint Task Force Sulu, confirmed that Noel Besconde, captain of FB Ramona 2, had been beheaded by the bandits.

Sobejana said the military

was able to confirm Besconde's death after getting hold of the video showing his beheading and after getting more details from military sources on the ground.

. He said the group of Abu Sayyaf sub-leader Hatib Hajan

Sawadjaan beheaded Besconde at around 2:30 p.m. on April 13.

"Now, we are looking hard for his cadaver so that we could return him to his family and he could be given a decent burial," Sobejana said. The FB Ramona 2 was found empty on Dec. 19, 2016, in the Celebes Sea near Sulu province.

Besconde and his three crewmen, all residents of Tukuran, Zamboanga del Surprovince, were also missing Sobejana said the bandits might have beheaded the captain because he was already "sickly." He added that the bandits had called the victim's family but the latter could not raise the ransom money of P3 million. INQ

DND chief slams 'terrorist, delusional' CPP

"The news stories regarding the supposed arrival and presence of members of the Abu Sayaff bandit group on Bohol island smack of a US yarn," the CPP said.

"The Philippine Air Force dropped nine bombs in barangays Napo, Calenti and Banahao in Inabanga, forcing at least 1,200 local residents to evacuate," it added.

The communist group contradicted a report of the Armed Forces that six bandits, three soldiers and a police officer were killed in the encounter.

It said two of the casualties were actually civilians.

Before the bandits were spotted in Bohol, the US embassy warned its citizens against visiting central Philippines due to threats of kidnappings.

With the help of residents, the military repelled the bandits.

One of the slain terrorists was identified as Maumar Askali, alias Abu Rami, commander and spokesman for the bandit group.

Askali had taken part in the kidnap-

Group hits killing of MILF vice chairman's brother

HARIFF AGUAK, Maguindanao: A civil society organization on Sunday condemned the killing of the brother of Moro Islamic Liberation Front (MILF) vice chairperson Gadzali Jaafar, labelling it as a move aimed at sabotaging talks between the government and the rebel group.

Philippine National Police (PNP) operatives on Tuesday last week shot dead Jaafar's brother, Mohaimen Abo, in what the former claimed to be a legitimate police operation.

However, Alan Balangi-Amer, president of 1-Bangsamoro Movement (1-Bangsa), said the operation against Abo violated a security agreement between the MILF and the government where the latter conceded to the former the author-

Philippine National Police * ity to arrest MILF members facing PNP) operatives on Tuesday last criminal charges.

Abo was also known in MILF circles as Commander Falcon or Ustadz Mohaimen.

Senior Superintendent Agustín Tello, director of the Maguindanao provincial police, claimed that Abo was facing arrest for criminal charges including kidnapping with homicide, kidnapping for ransom, murder, and frustrated murder.

"He was facing criminal cases

in courts in Midsayap, North Cotabato and in Surallah, South Cotabato," Tello said.

Citing a report from the municipal police office of Sultan Kudarat, Tello related that when PNP operatives sought to arrest Abo, the latter pulled out a pistol, triggering a shootout that resulted in his death.

Jaafar, for his part, clarified that under the 1997 Agreement on General Cessation of Hostilities (AGCH) between the MILF and the government, the arrest of MILF members may only be carried out in coordination with the ceasefire committee and Ad-Hoc Joint Action Group formed by both panels.

Balangi-Amer said the PNP operatives should have respected the provisions of the 1997 AGCH.

He likened the PNP operation against Abo to the Mamasapano

incident during the administration of former president Benigno Aquino 3rd that resulted in the killing of 44 police commandos.

He said that like the Mamasapano incident, no proper coordination with the government-MlLF ceasefire committee and Ad-Hoc Joint Action Group was made by the PNP when it sought to arrest Abo.

"We in the 1-Bangsa are calling on all stakeholders of peace not to allow the spoilers of peace to succeed in their grand design to drive away the elusive peace, since the Bangsamore people in general whether Muslims, Christians, and Lumads are now feeling tired of war in Mindanao," the 1-Bangsa president told The Manila Times.

"What we need is a genuine peace for everyone to enjoy and not the peace and tranquinty of a graveyard," he said.

DOHA, Qatar - The Philippines is "fundamentally peaceful" despite the lingering threat from the Abu Sayyaf Group (ASG) linked with the Islamic State, President Duterte affirmed last Saturday,

MILF hits out at govt for ceasefire violation

COTABATO CITY—The Moro Islamic Liberation Front was set to file a protest for violation of its standing ceasefire agreement with the government, following the killing of one of its members in a police operation on Tuesday.

Ghadzali Jaafar. MILF first vice chairman, said the police operation against his brother Mohaimen Abo, was yet another instance of a failure of coordination, as provided under a 19-year-old peace agreement with the government.

The Philippine National Po-

But Jaafar said the proper channel should have been the bilateral Ad Hoc Joint Action Group, since his brother was a member of the MILF's Bangsamoro Islamic Armed Forces. Next page

Police arrested two other members during the operation.

"You know if the government should conduct a law enforcement operation, there is a ceasefire mechanism [in place as a channel] for it, as bilaterally agreed by the government and the MILF," Jaafar said, referring to AHJAG.

Jaafar said a failure in bilateral

coordination for law enforcement operations was an obstacle to peace. Manzano, however, said the arresting officers were compelled to fire back when Abo shot at them.

Police said he had a .45 pistol.

The Regional Trial Court of Sultan Kudarat Branch 12 has ordered the arrest of Abo, and a certain Kumander Falcon, for a string of criminal cases, including murder, robbery, frustrated murder, kidnapping-for-ransom and kidnapping with homicide.

ISIS bomber deported to Kuwait

Philippine state security forces have deported suspected terrorist Hussein Aldhafiri, who is fe ared to be a bomb expert working, for the Islamic State of Iraq and Syria (IBIS), back to Kuwait where he will be facing charges for plotting terror operations.

Aldhafiri and his wife Rahaf Zina were suspected to be active members of the notorious Middle Eastern terrorist group based on information from American investigating authorities and the Armed Forces of the Philippines

Department of Justice (DoJ) Undersecretary Erickson Balmes,

citing a spot report from the Bureau of Immigration (BI) Fugitive Search Unit (FSU), said that Aldhafiri was transported to the Ninoy Aquino International Airport (NAIA) last Friday noon for his deportation.

According to the spot report, BI FSU agents transported the suspected ISIS bomb expert from the AFP Intelligence Service Group (ISG) headquarters in Fort Bonifacio in Taguig City.

Hussein was then escorted by FSU agents, together with personnel from the BI Warden Facility and the Manila International Airport Authority-Airport Police Department to NAIA Terminal 1 for his deportation.

Aldhafiri was deported following the request of the Kuwaiti Embassy for the Philippine government to

assist its security services personnel in processing the suspected bomber's deportation.

In a letter to the Department of Foreign Affairs (DFA), the Kuwaiti Embassy said that evidences obtained by Kuwaiti's state security agencies showed that Aldhafiri is planning to carry out terroristic attacks against Kuwait.

The Kuwaiti Embassy added that Aldhafiri has a standing warrant of arrest issued against him by the Kuwaiti Prosecutor General in relation to crimes against the state.

Meanwhile, Aldhafiri's wife, Zina, is believed to be the widow of Abu Jandal Al-Kuwaiti, ISIS' former number two military commander operating in Syria.

Immigration authorities are also set to deport Zina back to Syria.

"Wherefore, finding the charge to be sufficient and well substantiated, we hereby order the deportation of Rahaf Zina to Syria, subject to the submission of her National Bureau of Investigation (NBI) clearance," read the BI department order.

The BI has also blacklisted Zina under the remarks "undocumented" and "undesirable." The deportation order also stated that Zina's presence in the country "poses risk to public interest."

Aldhafiri and Zina were arrested in Taguig City after the United States Federal Bureau of proper immigration documents.

Investigation (FBI) tipped Philippine authorities that the couple are ISIS members.

The FBI also informed state security forces that Aldhafiri and Zina are believed to be involved in explosives manufacturing.

DoJ Secretary Vitaliano Aguirre also bared that the nabbed terrorists had entered and exited the country several times. He added that Aldhafiri and Zina had visited Cebu and Davao last January.

But Aguirre said that they are still investigating why the suspected terrorists visited the country. The Justice chief said Aldhafiri and Zinz were only charged for violation of immigration laws for failing to produce proper immigration documents.

AFP to create all-Muslim fighting units

The military has announced plans to create all-Muslim fighting units, with quotas from the Catholic country's largest religious minority, as it looks to bolster efforts to tackle Islamic insurgents.

Five percent of all new applications will be allocated for Muslims under the new order, military spokesman Col. Edgard Arevalo said in a statement on Saturday, adding the eventual aim was to have a dedicated brigade or division to be deployed in the country's troubled south.

The country is battling Muslim extremist militants in lawless southern regions, some of whom have pledged allegiance to the Islamic State group.

Arevalo said the Muslim quota, which roughly reflects the proportion of the religious minority in the population, would help the army operate in areas where it has been previously viewed with suspicion by local people.

"Most of our Muslim brothers and sisters perceive the deployment of almost 100 percent Christian soldiers in their communities as invading or occupational forces," he said, adding that fellow Muslims would be more aware of religious or cultural "sensitivities."

The statement did not give details of the existing numbers of Muslims in the military.

The southern region of Mindanao, the ancestral homeland of the country's Muslim minority, has been locked in a separatist insurgency since the 1970s, with the conflict claiming more than 120,000 lives.

While the major rebel organizations have for years observed a ceasefire with the government as part of peace efforts, there are breakaway factions opposed to compromise and other gangs that have declared allegiance to the IS.

Earlier this week, security forces clashed with suspected Islamic militants from the Abu Sayyaf kidnap group on a popular resort island, the first attack on a key tourist destination in recent years.

Palace counters Karapatan's claims of political executions

From the Sun Star-Manila (Apr 12): Palace counters Karapatan's claims of political executions

MALACAÑANG on Wednesday denied that there have been political executions under the watch of President Rodrigo Duterte.

Presidential Spokesperson Ernesto Abella belled the accusation of rights advocacy group Karapatan Alliance for the Advancement of People's Right that there are 47 alleged killings of peasants, Indigenous peoples and workers considered as human rights defenders under the Duterte administration.

Abelia said the latest allegation negates the President's "long-standing principle" to address problems through a peaceful approach.

"It is not the policy of the Duterte administration to violate citizens' human rights," Abella said in a statement.

Abella's statement came on the heels of Karapatan's plea to United Nations special rapporteur on extrajudicial, summary of arbitrary executions Agnes Callamard to "consider, investigate, make recommendations and take any appropriate actions" on the supposed political executions in the Philippines.

In a letter by Karapatan secretary general Cristina Palabay addressed to Callamard, a total of 47 cases of political killings have reportedly been documented by the rights advocacy group from July 2016 to March 31, 2017, in line with the government's continuing counter-insurgency program.

"These killings are all in the context of the counter-insurgency programs implemented from one regime to another that supposedly seek to end the armed rebellion of revolutionary movements in the Philippines," Palabay said in a letter sent to Callamard on Tuesday.

"These counter-insurgency programs have victimized thousands of Filipinos, including struggling communities, tagged as 'enemies of the state,'" she added.

Kadamay pinned hope that Callamard could convince Duterte to "completely junk counterinsurgency programs; issue strong warnings to and prosecute EJK (extrajudicial killing) perpetrators; and continue to pursue efforts at attaining just and lasting peace with the NDFP (National Democratic Front) and the Moro liberation movements."

Abella questioned the latest move by Karapatan, citing that the country's justice system and domestic institutions "are more than adequate to judge the matter."

He said Duterte welcomes International probers to "sovereign and democratic" Philippines but certain conditions must be met before they could be able to "come in and interfere with is domestic affairs."

"Despite the initial setbacks, the [government] and the National Democratic Front of the Philippines continue to pursue peace and seek solutions to the root problems of the age-old armed conflict," the presidential spokesperson said.

Operation against NPA's stepped up in Agusan del Sur

A wide pursuit operation against the fleeing New People's Army (NPA) rebels, the armed wing of the Communist Party of the Philippines (CPP), was stepped up on Sunday in the hinterland area of Mahagsay, 40 kilometers from San Luis town in Agusan del Sur province.

The operation of the 26th Infantry Battalion (26th IB), which is being closely monitored and supervised by the command group of 401st Infantry (Unity) Brigade (401st IB) based in New Leyte, Prosperidad town of that same province, is currently being supported by the Tactical Operations Group (TOG) of the Philippine Air Force (PAF) Strike Wing.

The 26th IB has been pursuing the main body of Guerrilla-Front Committee 88 of the North-Central Mindanao Regional Committee, which abandoned their camp during gun battle on Maundy Thursday in Mahagsay area, said 401st Brigade Civil Military Operations Officer Capt. Jasper T. Gacayan.

The 401st CMO Officer said that the fleeing rebels had dragged along with them their wounded comrades-in-arms as they fled towards the border of Agusan and Bukidnon.

"We want to bring their wounded to the hospital for medical treatment," he said.

The command is also open for the other rebels who wanted to return to the folds of the law and avail of the government's peace and development program, Capt. Gacayan said.

"The Maundy Thursday gun battle with communist insurgents led to the capture of the estimated two hectares NPA encampment in Mahagsay area," he said.

No one on the government side was hurt during that gun battle, he said.

The CMO officer said that Coi. Cristobal N. Zaragoza, commanding officer of the 401st Brigade deployed more combat maneuvering troops in San Luis town to beef up the forces of 26th iB Commander Lt. Col. Rommel Pagayon who continuously pursued without let up the fleeing rebels.
