

SOLONS RAISE OUESTIONS ONOZAMIZ DRUGSLAYS

Two senators on Monday raised this question as they expressed willingness to conduct an investigation into the police raids in Ozamiz City on Sunday that killed Mayor Reynaldo Parojinog Sr. and 14 others, drawing parallels with the death of Albuera Mayor Rolando Espinosa Sr. in November last year.

Senate Minority Leader Franklin Drilon wondered why the search warrants against the Parojinogs, as in the case of Espinosa, were "served in darkness."

"Both are tagged as drug lords. Too much of a coincidence?" he said.

The senator said the police had a lot of explaining to do. "The police cannot just say that 'we were met by a volley of fire and everyone is killed and nobody is killed on our side," he said.

"I won't be surprised if one of my colleagues will file a reso-

"The Senate has been doing a lot of investigations because a lot of things are happening. I don't like it but it is made necessary by what is happening," Drilon told reporters.

"Generally, a search warrant should be served in the daytime. While it may also be served anytime of the night, the issuing judge must so expressly specify in the search warrant," Drilon said, referring to Section 9, Rule 126 of the Rules of Court.

This is also the general rule under the Philippine National Police manual, Sen. Francis Escudero said.

"In fact, there is a separate provision on searches and seizures alone in the Constitution to put a premium on how important this issue or this thing is," Escudero said in a

lution to investigate what happened and given that both cases in the Albuera mayor and the Ozamiz mayor, they were both suspected of having drug links," Escudero said.

"But that often by itself doesn't merit a death warrant. Search warrant, maybe yes. Arrest warrant, maybe yes but not a death warrant," the senator added

Sen Panfilo Lacson said: "I don't see the need to investigate unless there is a development later and there are signs that [Mayor Parojinog and the others] were summarily executed, which as of now we don't see."

The PNP chief, Director General Ronald dela Rosa, scoffed at remarks that search warrants should indicate a time.

"Every time is a legal time to serve a search warrant. There is nothing in the search warrant that says you serve it at a particular time, like during office hours," Dela Rosa said, defending the raid that he said was carried out "to gain maximum advantage."

"We have to be able to dictate the tempo of the opera-

tion." he said.


Although he called the Parojinogs "big fishes" in the war on drugs, Magdalo Rep. Gary Alejano said Sunday's raid could have "long-term implications on our democracy way beyond the term of President Duterte."

"While it may look like a success on the surface like the thousands killed [in] the war on drugs, its impact [on] due process of law, human rights and professionalism of the PNP cannot be underestimated." Alejano said.

"I strongly support the elimination of illicit drugs in the country as much as I strongly advocate for the strengthening of our democratic institutions and democratic processes in the country," he said. —WITH REPORTS FROM NIKKO DIZON AND VINCE F. NONATO INO

Reds launch attacks in Negros

BACOLOD CITY - Suspected New People's Army (NPA) guerrillas launched fresh attacks on Sunday, burning construction equipment in Siaton, Negros Oriental

The rebels, on three motorcycles, torched equipment owned by the Medalla Construction parked near the Siaton River in Barangay Katikugan, according to Maj. Gen. Jon Aying, chief of the Army's 3rd Infantry Division.

Aying said the rebels, armed with rifles, shouted "Mabuhay ang NPA (Long live the NPA)" and fired shots in the air as they were fleeing the area.

Troopers of the Regional Public Safety Battalion assisted the Army in pursuing the guerrillas.

Authorities recovered bullet shells for different firearms and a container with gasoline.

The attack occurred more than a week after another group of insurgents ambushed and killed six police officers and a civilian in Guihulngan City, also in Negros Oriental.

Among those killed was the city police chief, who was responding along with his men to a call for help from a city councilor.

Aying denounced the continued atrocities committed by the NPA in Negros Island Region.

In a visit to the province recently, President Duterte ordered security forces to be more aggressive in running after the communist rebels, who continued with their offensives against government forces despite the ongoing peace talks.

7 loggers beheaded by Sayyaf captors

ZAMBOANGA CITY - Government security forces have recovered the decapitated bodies and severed heads of the seven loggers kidnapped by the Abu Sayyaf in Basilan last week.

The decomposing bodies of Nestor Divinagracia, 50, and his son Ily, 25, were recovered at Campo Barn, Barangay Switch Yakal in Lantawan at around 3:30 p.m. on Saturday. Chief Inspector John Cundo, Maluso police chief, and 2nd Lt. Tactay Panlaque of the 14th Special Forces Company led police and military personnel in search and rescue operations for the victims

Senior Superintendent Nixon Muksan, Basilan police director, said soldiers belonging to the 15th Special Forces Battalion found the five other captives at about 4 p. m on Sunday

Divinagracia and his son were initially taken by the

bandits from their house in Barangay Lower Mahayahay, Maluso on July 20.

While fleeing, the kidnappers seized along the way Berto Lacastesantos, 48; Hernando Sally, 53; Renato Casiple Jr., 36; Rene Sanson, 28, and Mamerto Falcasantos, 55.

14th Special Forces Company led police and military personnel in search and rescue operations for the victims.

Muksan said the victims were identified by their family members through their clothes.

"It's an unfortunate incident The military did its best to rescue the victims," said Col Juvymax Uy, Joint Task Force Basilan.


Uy said the beheadings were a desperate move of the Abu Sayyaf, noting that many

of their followers had surrendered or had been neutralized.

Several hostages, mostly foreigners, have been beheaded for failing to pay ransom.

The bandits are still holding five construction workers whom they seized at a public school in Patikul, Sulu last month. Sixteen other foreigners and eight Filipinos remain in the hands of the Abu Savyaf

Autonomous Region in Muslim Mindanao Gov. Mujiv Hataman appealed to residents of Basilan to help authorities end the Abu Sayyaf problem in the province. "This should not divide us. Let us stand united to end this problem," he said.

Army builds model houses for Marawi relocation

LANAO DEL SUR – Army engineers started vesterday the construction of model houses of temporary shelters for displaced residents of Marawi City.

Lt. Gen. Carlito Galvez Ir. of the Western Mindanao Command told The STAR that personnel of the 54th Engineer Brigade are building two model houses in Barangay Sagongsongan in Marawi.

Engineers from the Department of Public Works and Highways Region 10 led by Abdulracman Paunte are assisting the military in building model houses for the soon to be returning evacuees

The model house is a steel structure with a 26-square-meter floor area that could accommodate at least two to three small families

The other model is a 4x6-meter building made of lumber with an elevated floor and galvanized roofing.

"We are expecting these model houses to be fully constructed a week from now," Galvez said Saturday

The shelter project for evacuees, whose houses were either burned or destroyed as a consequence of the hostilities between Maute terrorists and the military, is part of Malacañang's post-conflict rehabilitation program for Marawi City

Marawi is the capital of Lanao del Sur, a component province of the Autonomous Region in Muslim Mindanao

The 11-hectare relocation area for the evacuees in Barangay Sagongsongan will be divided into five housing sites, according to Galvez.

Task Force Bangon Marawi spokesman Kristoffer James Purisima said the government would soon construct the "transitional shelters" for thousands of evacuees.

"Again, what will be provided to the IDPs (internally displaced persons) are not tents, but transitional shelters," he said at the regular Mindanao Hour in Malacañang yesterday

Purisima, also a deputy secretary at the Office of Civil Defense, said there are 104,000 displaced families or 467,000

The task force is conducting Rapid Damage Assessment and Needs Analysis (RDANA) and Post Conflict Needs Assessment to determine the exact needs for the rebuilding of Marawi City. The assessment and analysis report will be ready within the week.

The rehabilitation of war-torn Marawi will start as soon as the fighting ends.

Defense Secretary Delfin Lorenzana said Bangon Marawi is now on its postdisaster assessment stage with Undersecretary Cesar Yano as the person in

He said local government units, departments and local officials like governors, mayors and sultanates are being organized as "they will also have a say on the rehabilitation "

"Our priority is to bring back the infrastructure, the roads, the bridges. And then clearing the area and bringing back evacuees whose homes were not destroyed," Lorenzana said yesterday.

As for those whose houses were destroyed, particularly in the central business district of Marawi City, he said temporary housing will be built until evacuees can return to their homes after repair or rebuilding for those beyond

Health Secretary Paulyn Ubial vowed to improve the healthcare system of Marawi City once the fighting ends.

"There are many health impacts of

this armed conflict and we hope it will be over soon so that we can start rebuilding Marawi build back better. We are laying down the rehabilitation plan for Marawi," she noted during a forum.

Ubial said over 30,000 residents are staying in evacuation centers while some 400,000 others are staying in the houses of relatives.

She assured the people that there is no outbreak of disease in the 87 evacuation centers set up for the evacuees

The conflict had resulted in various health impacts that include the displacement of people, deaths, diseases, injuries, disabilities, damage to health facilities, interruption of health services and depletion of health resources

Rebel killed in Bukidnon clash with SAF men

CAMP BANCASI, Butuan City-An alleged New People's Army (NPA) rebel was killed, while some war materials were seized by government forces in a fierce gun battle in Sitio Gape, Barangay Bukang Liwayway, Kibawe, Bukidnon province, a sketchy report reaching here on Monday said.

An initial report received here said elements of the First Special Action Forces (1st SAF) were conducting security patrol in Gape area when they were engaged at 7:30 a.m. on Sunday by an undetermined number of Communist guerillas.

The encounter lasted for more than 20 minutes, regional Army spokesperson Capt. Joe Patrick A. Martinez told The Manila Bulletin on Monday

He said the rebels disengaged from the gun battle and fled to the nearby forested border of Bukidnen with Agusan and Davao region, after sensing they were outgunned and outnumbered.

The body of an unidentified insurgent was left behind by his retreating comrades.

Troops recovered four rifle grenades, landmines, a bolt assembly of an M16 Armalite rifle, other bomb-making materials, food, assorted medicines and several anti-government documents, he said.

"Our operating troops also found traces of blood along the bandits' withdrawal route, which indicated that several other rebels were wounded during the gunbattle," Martinez.

As of press time, combat troops of the 1st SAF and other combat maneuvering troops from the 403rd Infantry Brigade were still pursuing to the fleeing rebels in Gape area, he said.

The rebels were believed members of OFFICE OF THE ARMY CHIEF PUBLIC AFF the Communist Party of the Philippines (CPP)-NPA North-Central Mindanao Army Core P Regional Committee, he added. Juliang the land.

Army probes attack on quarry site

ILOILO CITY—The Army is investigating if the New People's Army (NPA) is behind the burning of heavy equipment at a quarry site in Siaton, Negros Oriental, last Sunday.

"We are still verifying if it was perpetrated by the NPA," said Capt. Eduardo A. Precioso Jr., spokesman of the army's 3rd Infantry Division.

Police said a backhoe and a payloader were doused with gasoline and set on fire by armed men on motorcycles. The armed men also fired several shots.

"That was based on the police report. But we don't have confirmation from the army's side," Precioso told The Manila Bulletin in a phone interview Monday.

He said the armed men shouted "Mabuhay ang NPA! (Long live the NPA)" before leaving the quarry site.

"That statement is usually associated with the NPA. But we can't be sure for now," he said.

The incident came more than a week after six policemen, including a police chief, were killed in an ambush in Guihulngan City.



NPA arms cache raided



Abu Sayyaf kills 5, beheads 2 in Basilan


LANTAWAN, BASILAN-Families of farmers and militiamen beheaded by suspected members of Abu Sayyaf are demanding justice just as the number of bodies recovered separately in the province of Basilan, believed to be Sayyaf victims, had risen to seven.

"They treated my brothers like animals," said Lucia Constancia of her brother Renato Casiple, 36, and half-brother Rene Sanson, 29.

"They cut their heads, they chopped their bodies," Constancia said. The headless remains of Casiple and Sanson were found in the town of Maluso in Basilan on Saturday.

They were among five bodies recovered in Maluso believed to have been killed by the Abu Sayyaf.

Col. Andrew Bacala, commander of 4th Special Forces Battalion, said the victims were

who had been actively supporting the government's antiterrorism campaign in Basilan.

The five bodies found in Maluso on Saturday were re-

The Divinagracias were kid-

napped by Abu Sayyaf members in Maluso on July 20.

Military retakes key bridge in Marawi

Government forces have captured a key bridge leading to the main position of Islamic State-inspired terrorists in Marawi City but will not use it to launch a major assault and instead press efforts to rescue civilian hostages, the military said on Monday.

Troops gained control last week of Mapandi bridge, which leads to Marawi's commercial center, where just 40 to 60 remaining terrorists from the Maute and Abu Sayyaf groups are believed to be holding 80 to 100 civilian hostages, mostly in a large mosque, according to Brig. Gen. Restituto Padilla Jr., spokesperson for the Armed Forces of the Philippines.

"We now have access to ground zero," Padilla said at a news conference in Malacanang, referring to the bridge over Marawi's Agus River.

Main objective

The bridge can now be used to rapidly transport troops and combat supplies to the war zone, but Padilla said the military's main objective was "to rescue the hostages."

President Duterte has ordered troops to ensure the safety of the hostages and not launch a massive assault that can endanger the captives even if that prolongs the terrorist siege of Marawi, which has already dragged for more than two months.

A total of 650 people have died in the fighting—491 terrorists, 114 soldiers and police, and 45 civilians—since the terrorists stormed Marawi on May 23 to establish an enclave OFFICE (of the Middle East-based Islamic State (IS) jihadist group in Southeast Asia.

Defense Secretary Delfin Lorenzana expressed fears on

Monday that the terrorists, who have been using their hostages as human shields, may force some of the captives to serve as suicide bombers.

"That's one of the fears of our soldiers—[the terrorists] may let loose the civilians but force them to carry bombs," Lorenzana said.

Padilla said the terrorists were holed up in buildings in two villages within a square-kilometer pocket of the city center.

500 buildings

There are around 500 buildings in the area that troops have to clear of booby traps and unexploded ordnance, further slowing down the campaign to retake the city from the terrorists, Padilla said.

The terrorists have left so many improvised explosive devices and unexploded ordnance, slowing down the clearing operation, he added.

Padilla said troops were risking their lives in clearing the buildings but the job had to be done to prevent loss of life and limb from explosions when residents returned to the city after the crisis.

More than 104,000 families, or 467,000 people, have fled their homes to avoid getting trapped in the fighting. They are staying in government-run shelters in Iligan City and surrounding areas.

Padilla said Marawi residents remained barred from returning to the city.

Only residents of villages outside the city have been allowed to return to their homes, he said.

Stray bullets

"Some Marawi residents tried to return to the city, but we had an incident where a returning resident was hit by a stray bullet. Good thing the resident did not die," Padilla said.

The return of faculty and students to Mindanao State University has also been delayed, as the school remains vulnerable to stray bullets, he said. —REPORTS FROM AP AND PHILIP C. TUBEZA INQ

DAVAO CITY—A military-led multiagency team formed to help Marawi City rise after the attempt by terrorists to set up an Islamic State (IS) province there is dropping plans to put up a tent city and instead build sturdier structures for residents who lost homes.

An initial batch of 5,000 families have been tagged as beneficiaries.

The decision by Task Force Bangon Marawi came after local officials expressed hesitation to support the tent city proposal.

Marawi Mayor Majul Gandamra earlier said providing the displaced with semipermanent structures would give them not only a more decent shelter but also give them privacy

"It will also make them comfortable because it will be a house," Gandamra said.

Tents, he said, "would always remind them that they are evacuees."

Capt Jo-ann Petinglay, Joint Task Force Marawi spokesperson, said the Army's 54th Engineering Brigade, the Department of Public Works and Highways (DPWH) in Northern Mindanao and Marawi City Engineers' Office had started building two model temporary shelters.

Templates

Petinglay said the model houses would serve as templates for the structures that would be built in Sagonsongan, a village in Marawi tagged as a relocation site.

"The models are expected to be done after a week of work," she said.

Abdulracman Paunte, resident engineer of the DPWH in Northern Mindanao, said the

first model being built would be made of steel and wood and have 26 square meters of floor area. The temporary shelters, he said, could accommodate three families each.

Each unit would take at least eight days, Paunte said.

The relocation site in Sagonsongan could accommodate at least 1,000 units

The shelter site would have communal kitchens, toilets and laundry areas. Power and water supply are being installed, Paunte said.

A unit would require four workers who could earn up to P15,000.

Lt. Gen. Carlito Galvez, Western Mindanao Command chief, said bringing normalcy to the lives of Marawi residents was a top priority of the military.

The military, he said, would deploy mostly female soldiers for the rehabilitation phase in Marawi.

"Your soldiers will risk their lives not only to make sure that Marawi City would be free from OFFICE OF THE ARMY CHIEF PUBLIC terrorists, but also to speed up

Lt. Col. Jonjie Juguilon of the 547th Engineering Battalion said that while the model houses were being built, Army engineers were conducting ground works in the area.

Paid work

Mike Gulem, field engineer of the Marawi City government, said the completion of the entire site was expected by September or October.

Evacuees were tapped for the work to give them a source of income.

rehabilitation, so that shelters would be ready at the soonest possible time," Galvez added.

The military said it was in the final stages of finishing off members of Maute Group, a homegrown terror organization that had sworn allegiance to IS and tried to establish an IS province in Marawi, a predominantly Muslim city.

Authorities said only two villages and parts of a third village were still being occupied

MNLF: No recruitment in Basilan, Sulu

The Moro National Liberation Front has denied claims that it is recruiting new members in Basilan and Sulu to undergo training at an MNLF camp in Lanao del Sur.

Emmanuel Fontanilla, MNLF spokesman, said MNLF guerrillas are confined to their camps, adding that their movement is coordinated with the military to avoid misencounters.

At least 60 alleged MNLF recruits were recently intercepted at a military checkpoint near Marawi, 33 in Ipil, Zamboanga del Sur and 27 in Guiwan, Zamboanga City The MNLF has

said it has no links with the groups.


Upon interrogation, the men claimed they would undergo basic military training at Camp Jabal Nur prior to their integration into the Armed Forces of the Philippines.

"These arrests should

allay the fears of our people of the likelihood that rebellion in Marawi will spill over to their places, because the military and police are doing their level best to contain it," said Lt. Gen. Carlito Galvez Jr., Western Mindanao Command chief.

Maute fighters in Marawi down to 40

The military is fighting some 30 to 40 remaining members of the Maute terror group in Marawi City, Defense Secretary Delfin Lorenzana said vesterday

"I think there are 30 to 40 left but these are the good fighters. In fact, we are still sustaining

"We now have direct access to ground zero," Padilla said at a news conference in Manila, referring to the bridge over Marawi's Agus River that can now be used to transport troops and combat supplies. "Our main objective is to rescue the hostages."

President Duterte has ordered troops to ensure the safety of the hostages and not launch a massive assault that could endanger the captives even if that prolongs the militant siege, which has already dragged on for more than two months.

The Philippine Coast Guard (PCG) also banned the loading and unloading of passengers in private seaports in Zamboaga, Basilan, Sulu and Tawi-Tawi (Zambasulta) that might be in control of Ma- used by supporters of the

Maute group.

PCG spokesman Commander Armand Balilo yesterday said that Coast Guard Southeastern Mindanao District commander Captain Ronie Gil Gavan issued the directive that took effect last Sunday.

Ships and boats have to use the public seaports operated by the Philippine Ports Authority (PPA) to load or unload their passengers.

"Passenger ships are no longer allowed by the District Commander Captain Gavan to load and unload passengers at the private ports in the entire area of Zamboanga, Basilan, Sulu and Tawi-Tawi. We have already notified the ships that they are not allowed to dock in these private ports," said Balilo.

"Sometimes you cannot be too certain with the private ports, if you have their full operation in enforcing security or if they are profit-oriented. We can never be entirely certain," he added.

7 Basilan loggers beheaded; ARMM police point to Abu Sayyaf

Seven local loggers were killed and beheaded by men believed to be Abu Sayyafin Basilan, Chief Superintendent Reuben Theodore Sindac, director of the Autonomous Region in Muslim Mindanao (ARMM) regional police,

said on Monday

The decomposing bodies of the seven victims were found by personnel of the Maluso Police Station on Sunday in Barangay Switch Yakal in Lantawan town.

They were identified as Nestor Venegracia, 50, his son Ily, 25, residents of Barangay Lower Mahayahay in Maluso town, Berto Lacastesantos, 48, Hernando Sally, 53, Renato Casiple, Jr. 36, Rene Samson, 28; and Mamerto Falcasantos, 55.

Sindac said the two Venegracias were kidnapped on July 20 by unidentified gunmen who burned down their houses and motorcycles.

As the gunmen were dragging the two towards the mountainous area of Lanatawan, they took five other log-

The headless bodies of the Venegracias were found at around 4 p.m. Sunday The bodies of the five other victims were found nearby. The seven bodies were identified by their relative by the clothes they were, Sindac said.

Two of the suspects, according to Sindac, were identified as Pasil Bayali and Otho Dobol.

Chief Inspector Tara Leah Cuyco, ARMM regional police information officer, said investigation disclosed that the kidnapping of the seven loggers and their beheading was carried out by the Abu Sayyaf

The two suspects were said to be connected with Furuji Indama whose rubber planatation had been destroyed by chainsaw operators. Indama is believed to be a commander of the Abu Sayyaf in Basilan and is tagged as responsible in several other beheadings in the past.

Cuyco said Indama believed that the seven loggers were responsible for the destruction of his plantation. (Aaron B. Recuenco)

Maute use of hostages as 'suicide bombers' feared

Security forces continue to tighten the noose on Maute fighters who, according to Defense Secretary Delfin Lorenzana have been reduced to about 30 or 40 fighters holed in two barangays in Marawi City. But though only a handful, Lorenzana cautioned against underestimating the group say-

ing those holding their ground against government troops in the battle zone are "good fighters." In fact, Lorenzana said the government is still taking in casualties.

Reports from the field also place the number of civilian hostages being used as human shield at 30

During the Flag Raising ceremony at the GHQ Canopy, Camp Aguinaldo in Quezon City Monday morning, the Defense chief aired the concern of soldiers in Marawi about the possibility that the militants might use their civilian hostages as "suicide bombers" out of desperation.

Lorenzana said, "what our troops fear (is) that they might order the civilians with bombs ... to get near the troops and detonate themselves."

Lorenzana stressed that ongoing mopping operations – house-to-house and room-to-room clearing is very difficult and dangerous.

Troops are doing these tasks very carefully morder to avoid the militants' practice of using hostages as shields to avoid causing needless casualties to civilians.

As of Sunday night, about 491 Maute fighters have been killed in 68 days of fighting while the government lost 114 soldiers. At least 45 civilians were killed.

Security forces have recovered about 584 high-powered firearms while 1,723 civilians were rescued

Sick

Meanwhile, at least 25 soldiers got sick of dengue, typhoid and diarrhea in the month of July alone while fighting the Maute terrorists because of the poor environmental condition in the battle-zone.

Captain Jo-Ann Petinglay, spokeperson of the Armed Forces of the Philippines-Western Mindanao Command (AFP-WestMinCom) and Joint Task Force Marawi said the troops "got sick of dengue due to the presence of mosquitoes as the entire city has not been cleaned, as there are no people. Some with diarrhea due to dirty water, the water source. In every firefight, sometimes our troops drink dirty water.

So before residents can return, we need to furnigate the place."

The presence of dead bodies of humans and animals in their midst also contributed to the problem, she added.

Petinglay said most of those who got sick have already been treated and have gone back to the battlefield.

"What we are trying to emphasize is may ganun na nangyayari and we want to prevent the spread of epidemics," Petinglay said

Unsafe

Task Force Bangon Marawi has started post-disaster assessment towards the rehabilitation of Marawi.

"Undersecretary (retired Gen. Cesar) Yano is already there. He is the one in charge to organize the government agencies, the departments, the local officials, the governor, mayor and LGUs)," Lorenzana said.

"They will also have a say in the rehabilitation Their priority is to bring back infrastructure, the roads, and clear the area of debris. Once cleared, we will allow the evacuees to return to their homes if these were not destroyed. Then we will also start with stores, that's why the DTI will have rolling stores so that the evacuees will be able to buy supplies." he added.

Lorenzana said those whose houses were located in the Central Business District (CBD) will temporarily stay in the temporary housing units.

"After the firefight, we will start the rehabilitation immediately. The engineering equipment is already there, they are ready. Even the DPWH is ready for the rehabilitation," Lorenzana assured.

However, as the troops continue to clear the area of explosives and other traps by the rebels, Armed Forces spokesperson Brig. Gen. Restituto Padilla Jr. strongly advised displaced residents against returning to their houses.

Please do not return to your houses yet due to the huge risk or danger you will facel," Padilla said in a Palace news conference.

-"The current operation inside

Marawi is ongoing and the focus is particularly in areas where quite a number of unexploded ordnance and IEDs (improvised explosive devices) are still present," he added.

Outside residents only

Apart from explosives, Padilla raised the danger of sniper fire and stray bullets may hit innocent civilians who insist on returning to their homes.

He noted that they received initial reports that a resident who tried to go home was hit by a stray bullet and fortunately survived. He said the incident highlights the persistent security risks in the battle zone.

Padilla said the government troops want to ensure Marawi City is safe and secure to avoid the loss of more lives and limbs

While the military used to clear 50 to 100 buildings a day, the operations have slowed down since the area is littered with unexploded ordnance.

"Unfortunately as we get into the main battle area, the complexity of clearing operations becomes all the more compounded primarily because of many more unexploded ordnance," he said

"We appeal for more patience because we are also hastening the cleaning efforts," he added

For now, Padilla explained only residents outside Marawi city are allowed to go back their respective residences.

"We would like to set the record straight that current plans to allow the return of residents to their places of residence applies to IDPs who are residents outside the city of Marawi. In particular, these municipalities within Lake Lanao and not IDPs from Marawi City itself," he said.

He said the residents of municipalities within Lake Lanao and outside of Marawi City can return to their homes by passing through alternate routes—the Saguiaran-Piagapo road and Malabang to Lanao del Sur road.

Displaced families from Marawi City who want to stay with their relatives living near Lake Lanao may do so, according to Padilla. He assured that they would continue to receive relief assistance from government upon registration with local authorities. (With a report from PNA)

NPA'abductions'send schools in panic

AN NICOLAS, Pangasinan: Local government and public school officials here appealed to the public to stop circulating unverified news about the alleged abduction of some students in various schools by heavily armed men believed to be members of the communist New People's Army (NPA).

"The fake news reports are yery alarming to us and some of the parents refused to send their children to school for fear that they will be kidnapped by the NPA rebels," some teachers told *The Manila Times* in an exclusive interview on Monday.

The principal of Talongapor Elementary School in Santa Maria town where government troops and NPA rebels clashed on Friday belied reports about the abduction of their students, contrary to the reports circulated on social media and aired by Metro Manila-based radio stations.

Maxima Bandiola, San Nicolas school district supervisor said the fake news reports were still cartied by social media as of Monday but this did not lead to suspension of classes in elementary schools here.

In an emergency meeting on Monday, Bandiola urged school principals to inform parents not to be afraid of sending their children to school because there are no NPA abductions in San Nicolas.

Bandiola said classes are proceeding normally in various schools in mountainous areas – Kulangew Elementary School, Bangar Elementary School, Pastoran Elementary School and Puyao Elementary School.

"I hope it will be published in the national newspapers that there is no truth to the news circulating on social media so that [Education] Secretary Leonor Briones will not be worried about us," Donato Balderas, Pangasinan 2 schools Division superintendent said.

Santa Maria barangay (village) chairman Rodolfo Mengua said this was the first time since his childhood that a gunfight happened between soldiers and rebels in their locality.

He, however, NPA rebels who are apparently based in Santa Fe, Nueva Vizcaya, have been sighted by residents since 2015

"People from our village who live in the mountains have confirmed seeing armed rebels in their area but they [rebels] have not disturbed the peace," Mengua said.

Mengua also belied reports that Santa Maria is now infested with NPA rebels, calling them a fabrication, considering that no NPA campsite has been found in their village.

A checkpoint along the provincial road going to San Nicolas has been removed upon orders of the police provincial director, Senior Supt. Ronald Oliver-Lee.

ABU Sayyaf bandits beheaded their seven victims whose bodies were found on the outskirts of Maluso town in Basilan on Sunday afternoon, an official said Monday.

In a statement, Chief Supt. Reuben Theodore Sindac, regional director of the Autonomous Region in Muslim Mindanao, said the decomposing bodies of the seven victims were recovered separately in Basilan's forested areas.

Sindac identified the victims as Nestor de Venagracia and his son Ely, both residents of Lower Mahayahay village in Malusotown, Berto Lacastesantos, 48, Hernando Sally, 53, Renato Casiple Jr., 36 and Rene Sanson, 28, all residents of Campo Barn in Switch Yakal, Lantawan; and Mamerto Falcasantos, 55, of Next page

Santo Niño in Matarling village in Lantawan town.

All seven were said to be loggers who were kidnapped in separate occasions on July 20.

Sindac said the bodies of the victims were turned over to their respective families while their case was still being investigated

In February this year and in November last year, the Abu Sayyaf beheaded German national Jurgen Kantner and Canadians Robert Hall and John Ridsdel after their families failed to pay ransom.

The bandits are still holding dozens of kidnapped Asians and Europeans while the military continues to look for them.

What revolution?

odrigo Duterte used to say he's the Philippines' first leftist president and that he's a socialist.

Duterte endeared himself to voters and later to many citizens for speaking about "bold reforms." He spoke about forming a government of national unity, adopting an independent foreign policy, fighting the oligarchy, implementing free land distribution stopping Endo and contractualization reforming the tax system, having one single national minimum wage, and addressing the historic grievances of the Bangsamoro.

At other times, he broached the idea of the New People's Army, the Moro Islamic Liberation Front and the Moro National Liberation Front joining the Armed Forces of the Philippines in concerted actions.

Taken together, these are revolutionary ideas that could bring radical reforms beneficial to the majority. No wonder, his supporters proclaimed a coming Duterte revolution.

But the revolution has not come. Between 30 June 2016 and now, nothing revolutionary has happened under Duterte Even the most loyal and most devoted Duterte supporter can only give us a list of "consuelo de bobo" or token reforms, or would only manage to recite the standard refrains of apologists: "It's been only one year," "give him a chance," "look at the bright side," and so on

In the past few days, President Duterte has completely shed his previous claims of being a leftist and socialist. He has ordered the Philippine National Police, the chief implementor of the brutal anti-drug war, to "wipe out the NPA." He said he wants to bomb schools of Lumad. He also shut the door to the peace negotiations.

From claiming to be a leftist and socialist, Duterte is now at war with leftists and socialists.

Duterte has embraced a triad of warmongers and anti-communist defense officials who preach martial law and counterinsurgency war. This triad represents the past that we seek to change — the idea that a military solution, even a most brutal war, would end the so-called communist insurgency — the mindset since the time of Marcos.

Duterte has been obedient to this trio, and we have lots of proof that he obeys. He reneged on his promise to release all political prisoners. He has insisted on a ceasefire, while showing a disinterest in forging agreements on socio-economic and political reforms. He has imposed and extended martial law in Mindanao. Like a marionette, he now spews the standard military lines against the communists.

If there's a part of the state bureaucracy that needs to be reformed, it is the military and police. Incompetence is their least offense. People have a long list of their offenses and crimes. But under Duterte, they just instantly became new. No reforms needed.

For all his bravade, Duterte has not fought the oligarchy Instead, Duterte has clinged to the oligarchy and gave the oligarchs starring roles in his economic team

Consider this: Duterte's labor department not only has refused to stop contractualization. It could only offer workers a beggarly \$16 minimumwage increase. (Labor has rejected the "limos")

Consider this too: The oligarchs are "fine" with Duterte's tax reform package. They are fine with it because it is the poor and the middle class who would bear the burden of expanded excise taxes and other new impositions. What's so radical or bold in a tax reform that pampers the rich and crucifies the majority?

Our parents and grandparents should be having an endless déjà vu since 2016, starting with Bongbong Marcos' candidacy and Duterte's decision to honor the dictator with a hero's burial.

Like Marcos, Duterte promised a revolution Like Marcos, he could only deliver a new martial law against revolutionaries. There's no revolution against the oligarchs and the corrupt—who remain in power and who sustain him in power.

Duterte thinks he can terrorize the NPAs with martial law, Marcosian terror and "street thug" talk. He forgets that Marcos became the NPA's biggest recruiter and arms supplier. The Reds outlasted Marcos and subsequent regimes.

Today, Duterte's fall from grace as a self-styled revolutionary is nearly complete: In his post-SONA press conference, he had no second thoughts saying Lumad schools should be bombed

Bombing schools is cowardly. And history teaches us that cowards have been known to abandon and betray the revolution.

DoJ sets hearing on suspected Maute members

From Business World (Jul 31): DoJ sets hearing on suspected Maute members

THE DEPARTMENT of Justice (DoJ) in Manila has taken the lead in the case filed against 58 suspected members of the Maute terrorist group and an alleged lone recruiter.

State prosecutors, led by Senior Assistant State Prosecutor Peter L. Ong, headed the inquest proceedings of the 59, who were flown in from Zamboanga del Sur, at the main office of the DoJ last Friday.

Among the 59 facing rebellion complaints is Moro National Liberation Front (MNLF) member Nur Supian, who was identified by the 58 as their recruiter.

The DoJ said the preliminary investigation hearing will continue on Aug. 14, 2:00 p.m. The suspects are expected to file their counter-affidavit or their defense on the next hearing.

Justice Undersecretary Erickson H. Balmes, in a message, said the arrested "claimed that they were MNLF/MILF (Moro Islamic Liberation Front) but MNLF/MILF denied them."

The MNLF and the MILF have committed to the peace process and both were represented in the Bangasamoro Transition Commission that drafted the latest proposal for a new Bangsamoro political and geographic entity.

All the 59 suspects are currently detained at Camp Bagong Diwa in Taguig City.

Once the case reaches court trial, it will be handled by the Taguig Regional Trial Court as ordered by the Supreme Court.

FIREFIGHT | PH Marines engages NPAs in Southern Palawan anew



PALAWAN (DWDD) - Philippine Marine forces engaged the terrorist New People's Army near the border of Rizal and Bataraza Town in southern Palawan.

According to Lt. Col. Danilo Facundo, commanding officer of the Marine Battalion Landing Team – 4, the latest encounter occurred at the boundary of Barangay Malihud in Bataraza and Barangay Culasian in Rizal, which was the third of similar skirmishes between the two forces since the government launched "focused military operations" to run after the insurgents.

Based on reports, the marines, led by 1Lt. Geovanni Bangoy, engaged the terrorist group which fied the area carrying with them their wounded companions. Recovered from the encounter site were a homemade shotguns and a mobile phone.

The first encounter between military forces and the NPA occurred on July 21 at Sitio Kambingan, Malihud. The second followed on July 23, also in the same barangay but in the area of Sitio Ilyan. **WESCOM / MCAG**

ARTICLE 179 | Philippine Army statement on unauthorized wearing of military uniform

FORT ANDRES BONIFACIO, Taguig City (DWDD) – The military uniform is a symbol of authority that must be used properly and with dignity. The unauthorized wearing by civilians impacts negatively on the image of the Philippine Army and the Armed Forces of the Philippines, apart from security implications. Lawless elements have often worn military uniforms to carry out atrocious activities or impersonating as soldiers for other criminal purposes. We call on all civilian citizens to desist from unauthorized wearing of any military uniform. Under the law, offenders can be prosecuted for violation of Article 179 of the Revised Penal Code (Illegal Use of Uniforms or Insignia), which penalizes any person who shall publicly and improperly make use of insignias, uniforms or any dress pertaining to an office not held by that person or to a class of persons of which he or she is not a member. Offenders can also be prosecuted for violation of Republic Act 493, for the crime of wearing, using, manufacturing and selling of insignias, decorations, medals, badges, patches and identification cards prescribed for the Armed Forces of the Philippines by persons not in the service. We highly encourage the public to report cases of violations of RA 493 and Article 179 of the RPC to proper authorities. 

AW ENFORCEMENT | 4ID MLSAG Confiscated 16 Assorted Firearms in CDO Operation

CAMP EVANGELISTA, Patag, Cagayan de Oro City (DWDD) – By virtue of the two search warrants that were issued by the RTC 10 Branch 43, the 4th Infantry Division Martial Law Special Action Group or 4ID MLSAG composed of personnel from the 4ID, PDEA 10, CIDG 10, PRO 10, and RIC 10 simultaneously launched law enforcement operations in Barangays Pagatpat and Bonbon, both of Cagayan de Oro City which resulted to the successful confiscation of sixteen assorted firearms (3 long and 13 short) and the arrest of one suspect early today, 27 July 2017.

In Barangay Pagatpat, the operation was launched to search the house of a certain Jalaludin Bacaraman Lao. Lao is allegedly linked to gun smuggling in Northern Mindanao. Unfortunately, only Lao's wife was present during the operation. The team recovered one (1) M4 5.56mm rifle, two (2) cal.45 pistols, one (1) cal.38 pistol, and assorted ammunitions.

It can be recalled that last month, June 29, more or less 8000 ammunitions were intercepted by 4ID MLSAG in a garage of a cargo forwarding office in Brgy Camaman-an, CDOC. According to the witnesses, the items were supposed to be delivered to Marawi City and Lao has a direct involvement on the said transaction.

"Aside from addressing the threat situation, one of the major concerns of the 4ID MLSAG is to stop the proliferation of illegal firearms, ammunitions, and other contrabands in the area. That is why together with the PNP, PDEA, and other Government forces, we are relentless and very deliberate in our action to intercept and to stop any kind of illegal transactions that are aiding the enemy of the state." Said by Col Adonis Ariel G Orio, 4ID Martial Law Command Center Spokesperson

In Brgy Bonbon, another operation was also launched to implement the search warrant to the residence of a certain Jabar Tago Y Dura and Jamelodeng Tago Y Dura for allegedly possessing illegal firearms. The team recovered the following items: one (1) M4 5.56mm rifle, one (1) AK47 rifle, two (2) cal 40 pistol, five (5) cal 45 pistol, three (3) 9mm pistol, and assorted ammunitions. Said information was tipped-off by a concerned civilian in the area. During the operation, only Jamelodeng and his relatives were present in the compound. He (Jamelodeng) provided documents to justify the legality of the confiscated firearms but all of these will be subject for further verification by the CIDG 10.

MGen Benjamin R Madrigal Jr., 4ID Commander said, "I would like to congratulate our government forces for the very swift execution of these two separate law enforcement operations. We have once again proven our competence in ensuring the safety and security of our people in Cagayan de Oro City."

"To all people who engage themselves in smuggling and any kind of criminality and illegal activities, stop or else you shall face the full force of the law. People are now more aware of your illegal transactions and it is just a matter of time that the long arm of the law will finally catch up with you." **4DPAO / MCAG**
