

FAELDON LINKS LACSON, SON TO SMUGGLING

Outgoing BOC chief says Sen. Panfile Lacson is accusing him of corruption because the customs bureau is closing in on the senator's son for cement smuggling.

TAYTAY, RIZAL—A day after Sen. Panfilo Lacson named him as among the corrupt officials in the Bureau of Customs (BOC), outgoing Customs Commissioner Nicanor Faeldon fired back at Lacson, accusing the senator and his son of cement smuggling.

Faeldon, in a press conference near his home in Barangay Dolores in Taytay, Rizal province, said the senator's son and namesake, Panfilo Lacson Jr., was the managing director of Bonjourno Trading, a company that the customs commissioner said was cited as the "No. 1 smuggler of cement in the country" by the Cement Manufacturers Association of the Philippines (CeMAP) Inc.

Lacson, however, said Faeldon should have filed charges against his son if he had a case against the latter.

"If my son is guilty or he is into smuggling, I will be the one and not (Faeldon) to file a case against him," Lacson said in a news conference, which he called after the resigned BOC chief made the public accusations.

He said his son had denied any wrongdoing.

67 shipments

Faeldon said that during his one-year stint at the BOC. Bon-journo brought in 67 shipments of cement, 63 of which were valued at P4.6 billion.

He said one of his staff members, a brokerage exam topnotcher, discovered that Lacson Jr.'s company attempted to undervalue by 50 percent the freight cost of at least four shipments.

Faeldon said Lacson's son declared a freight cost of \$8 per metric ton when the prevailing market price was between \$16 and \$20.

"We discovered the smuggled shipment during our first 12 days in office at [the Bureau of] Customs," he said.

'Fake documents'

"In a span of a week, the company managed to bring in three shipments worth a total of P106 million. How is that possible for a company whose starting capital is only P20,000? These are only initial three ships," Faeldon said.

"Can he afford this? Did he

pay the right tariff? The right tax?" he asked, adding that Bonjourno also submitted fake documents to try to justify the amount that it was insisting to pay.

"Of course, this is smuggling," he added.

But Faeldon said the four shipments were eventually released after the company paid the correct freight charges.

Lacson said there was no smuggling because cement was not subject to customs tariff and duties but was only covered by the value-added tax, which is collected by the Bureau of Internal Revenue.

63 other shipments

"What Faeldon is saying that (the tax for freight cost should be) \$16 per ton. That's too high. One friend who is exporting nickel to China, which is supposed to be more costly, the freight (cost) is \$8-\$9 per ton," the senator said.

Faeldon said he was still looking into Bonjourno's 63 other shipments to determine if the company had paid the correct freight charges.

The younger Lacson, he said, also went to his office several times and allegedly tried to bribe his staff.

"Ping Lacson mentioned players at the BOC. My question to him: 'Are you a player (in smuggling)? Is your son a player? Is he your dummy?" Faeldon said.

The senator said he was not a dummy for his son, noting that if his son had indeed made so much money, he would have finished the construction of his house, which began two years ago.

Lacson said he asked his son about Faeldon's claim that he was delivering money to the commissioner's office

"He said he had not done so at anytime, he had not met Faeldon. He had absolutely no reason to bribe Faeldon or the customs bureau. That's a big big lie,' he said," Lacson said.

Faeldon said the senator seemed to know everything at the BOC. "Does he know this? Or are you the one behind this?" he said, referring to Lacson Jr.'s alleged smuggling activities.

Closing in

"How much tax are you paying? You brought in tons of cement. If those do not match, then you are a smuggler, Senator Lacson, unless you tell me you do not know Panfilo Lacson Jr.'s activities," he said.

"If you deny knowing these,

you know nothing about Customs. You are a liar," Faeldon

Faeldon said Lacson's accusations against him was meant to remove him and his appointed men from the BOC as they were closing in on Bonjourno's illegal activities.

"They do not want the truth to come out. They want us all out, the six of us," he said, referring to the former military officers that he had recommended to key posts in the BOC who were also named on Lacson's list of alleged corrupt Customs officials.

Faeldon also accused Lacson of using the issue to launch another bid for the presidency.

The outgoing customs chief called on the Senate blue ribbon committee, which is investigating the entry to the country of a P6.4-billion "shabu" (crystal meth) shipment from China that passed through the BOG, to also investigate Lacson and his son.

Faeldon cited pieces of evidence, including bank certificates and a letter from CeMAP, which listed Bonjourno as among the four importers "still undervaluing their freight rates."

"Let us investigate this because this is smuggling of cement by a high-ranking government official," he said. INQ

Expert: Kian kneeling when shot by cops

Teenage student Kian Loyd delos Santos was slumped or kneeling on the ground when three bullets were fired into his body—two to the head and one in the back, forensic experts testified before the Senate yesterday.

In separate testimonies before the Senate committee on public order and dangerous drugs, Dr. Erwin Erfe, head of the forensics department of the Public Attorney's Office (PAO), and Dr. Jocelyn Cruz of the Northern Police District (NPD) said two bullets entered the 17-year-old victim's head, one behind the left ear and one through the ear itself.

Both experts said the bullets that

entered the head had an "upward trajectory," indicating Delos Santos was prone when shot by an assailant standing on the left side of the Grade 11 student.

Cruz and Erfe conducted separate autopsies on Delos Santos, whom police said engaged the lawmen in a firefight during an anti-drug operation in Caloocan City on Aug. 16.

The three police officers – PO3 Arnel Oares, PO1 Jerwin Cruz and PO1 Jeremiah Pereda – accused of killing Delos Santos claimed the victim fired at them, triggering a shootout.

However, a security video showed two of the three officers dragging an individual to an alley where Delos Santos was later found.

"The position of the victim, he was kneeling face down when he was shot," Cruz told the panel chaired by Sen. Panfilo Lacson.

Erfe, whose services were sought by the victim's parents, however, said there was a third shooter who shot the victim in the back.

"He (assailant) was at the near contact distance, malapit na malapit (very close). The shooters were standing," Erfe said.

Erfe said he conducted the autopsy after Delos Santos'

body was already embalmed by a funeral parlor in Malabon City.

It was not clear why the NPD autopsy missed the third bullet wound found by Erfe on the victim's back.

Lacson noted that both the PAO and NPD autopsies found two exit wounds in the head but there was no exit cavity for the third entry at the back.

He said the Philippine National Police (PNP) Scene of the Crime Operatives (SOCO) found only two slugs, apparently from the head shots.

"So where's the third slug? Have you found it?" Lacson asked the two forensic experts. There were no clear answers as other senators cut in to ask their questions.

Cruz's autopsy determined the head shots were done at a distance of 60 centimeters, or two feet or more. She noted that there was no "tattoo-

ng," or the marks left by inburned gunpowder, on the entry wounds when the gun is ired at close range.

Senators asked Cruz to provide photographs of the sutopsy, but she said police did not have them

Erfe said it was possible not o have tattooing even if shots ire fired at close range,

The reasons for the differing iutopsies were not resolved luring the hearing.

Sen. Paolo Benigno Aquino V also asked the whereabouts of Delos Santos' clothes on the right he was killed but no one resent in the hearing could inswer.

Chief Insp. Amor Cerillo,

who was relieved as head of the Caloocan Police Community Precinct 7 where the three policemen are assigned, said initial ballistics report indicated that the 9 mm slugs recovered from the crime scene came from Oares' pistol.

Shoot first. ask later

When asked by Aquino to comment on the autopsies, particularly that Delos Santos was shot while prone, PNP chief Director General Ronald dela Rosa said in Filipino: "If you shoot someone in the back, who is kneeling, you're not a law enforcer, you're a criminal, a murderer."

In yesterday's hearing, the police officials seemed to justify the killing of Delos Santos, learning that the victim was into illegal drugs only after he was killed

Chief Supt. Roberto Fajardo, the NPD director who was relieved of his duty, told the hearing there was no specific target of the Aug. 16 operation in Caloocan City, but police could confirm Delos Santos was involved in drugs.

Asked if those drug links were known after the killing, Fajardo said: "Yes. We have to check the background. We checked after."

He said a drug suspect arrested the following day confirmed Delos Santos was dealing drugs.

Senior Supt. Chito Bersaluna, the former Caloocan police chief, said Delos Santos could be tied to the drugs trade by a recovered cellphone and "based" on what came out on social media" after his killing.

Those admissions will add to the growing scrutiny on police behind a crackdown that President Duterte on Wednesday said would not stop. He said there was no justification for the killing of Delos Santos, and police responsible would face

The three police accused of involvement in the killing said little during the inquiry. One refused to speak, while the other two maintained the individual on the security video was their "asset," not Delos Santos.

Witnesses said otherwise.

They claimed seeing Delos Santos being dragged into a corner before he was found dead in a ditch near his home. A. 45 caliber pistol was reportedly found in his left hand.

The same witnesses had been taken into custody by Sen. Risa Hontiveros, who said it was only "temporary."

She said the families of the witnesses sought her for their

protection.

PAO chief Persida Acosta echoed Justice Secretary Vitaliano Aguirre II's call to Hontiveros to surrender the witnesses for custody under the government's witness protection pro-

The Senate, however, has provided protective custody to the three witnesses.

Hontiveros said the executive session to hear the testimony of the three witnesses did not push through because Lacson wanted to secure a written authorization letter from the mother of one of the witnesses first before speaking with them.

Two witnesses are minors and are related, so the authorization from the mother of one of them would cover for both.

The sister of the two minors initially signed the consent form to allow Hontiveros, the Integrated Bar of the Philippines and Caloocan Bishop Pablo David to have them in custody.

She also went to the Senate yesterday to give her consent to the chamber to provide them with protective custody. - With Marvin Sy, Edu Punay, Reuters

Army battalion to be deployed in Basilan

MAGUINDANAO – The Western Mindanao Command (Westmincom) will deploy another Army battalion in Maluso, Basilan to prevent a repeat of the attack by Abu Sayyaf bandits on Monday.

The contingent will not only secure the area but also engage in civic-military activities, said Lt. Gen. Carlito. Galvez Jr., Westmincom chief.

Nine villagers, including a militiaman, were killed while 16 others were wounded when the bandits led by Furudji Indama attacked Barangay Tubigan. The bandits strafed and burned houses and a barangay day care center.

Four bandits were killed and six others wounded when the villagers returned

fire

The Abu Sayyaf beheaded a retired soldier in another barangay while fleeing toward a forested area.

Autonomous Region in Muslim Mindanao Gov. Mujiv Hataman distributed relief goods to affected residents on Wednesday. Local officials provided cash assistance to the families of the slain villagers.

Village officials expressed concern that the bandits would avenge the death of their comrades.

Residents said more soldiers should be deployed in their barangay, noting that only a small group of militiamen and soldiers are deployed in their village.

Oust-Duterte move 'imaginary' – 4th ID chief

CAGAYAN DE ORO CITY—The newlyinstalled 4th Infantry Division commander of the Philippine Army has branded as "imaginary" the clamor of an alleged group composed of military and police personnel to oust President Duterte.

"It's imaginary. We have worked for so long about professionalizing our Armed Forces, and these people are just, maybe, imagining what they can," Maj. Gen. Ronald Villanueva said.

Villanueva was chief of the Intelligence Service of the Armed Forces of the Philippines (ISAFP) He replaced Maj Gen. Benjamin Madrigal Jr., who was assigned as chief of the Southern Luzon Command

A group that called itself the Patriotic and Democratic Movement (PADEM), in a statement, has called for the ouster of President Duterte.

"We, officers and members of the Armed Forces of the Philippines and the Philippine National Police, hereby make a compact to constitute ourselves as the Patriotic and Democratic Movement (PADEM) and to condemn and hold Rodrigo R. Duterte accountable for gross crimes in betrayal of public trust and in violation of national sovereignty and democratic rights of the Filipino people," PADEM said in a statement.

NPAs free abducted CAFGU in Agusan

BUTUAN CITY - In less than three days in captivity, the New People's Army (NPA), armed wing of the Communist Party of the Philippines (CPP) on Wednesday afternoon freed a former member of the Citizen Armed Force Geographical Unit (CAFGU) in the outskirts of Barangay Mahaba, Cabadbaran City, Agusan del Norte province. Panisan was formally turned over by the NPA custodial force to local officials of Mahaba and third party facilitators before he was turned over to his immediate kin. Troops regain Marawi police station, mosque

FTER three months of intense fighting, government troops finally regained the Marawi City police station and the Grand Mosque in Marawi City.

Brig. Gen. Restituto Padilla Ir., military spokesman, said troops took-control of the police station on Tuesday. Prior to that, soldiers cleared nine structures inside the main battle zone, where at least 29 buildings were regained.

Padilla said the mosque was

used by the Maute Group as a storage area.

The fighting entered its 95th day on Thursday.

"Our use of artillery fire in several places occupied by the enemy are still ongoing and air strikes or air support, close air support from our Air Forces is also continuous," Padilla said in a news conference.

The military has yet to get the latest report on the number of casualties from the ground. Military officials earlier said clearing operations had been slow because many of the buildings in Marawi were littered with explosives. Padilla said Maute terrorists planted explosives while retreating.

Padilla said Maute leaders Isnilon Hapilon, Abdullah and Omarkhayam Maute are still inside the battle area.

"We want to believe that they are

still in Marawi," he said.

At least 300 buildings in Marawi City have yet to be cleared of explosives and booby traps.

"We need to clear every place, buildings and we also have to be careful in clearing these because we are all aware that these buildings were previously used as strongholds by our enemies," Padilla said.

So far, 129 soldiers have been killed in the clashes while 45 civilians were slain by terrorists. At least 595 Maute members have been neutralized by the government forces.

Gov't troops close to retaking Marawi

Government security forces moved closer to ending the battle for Marawi City by retaking the police headquarters previously occupied by the Maute group.

Armed Forces of the Philippines (AFP) spokesman Brig. Gen. Restituto Padilla said the troops are also close to retaking the grand mosque that the terrorists have been using as main base since they occupied the city last May 23.

"The retaking of the Marawi City police station, which is highly strategic, is very significant in our ongoing operations to liberate the city," Padilla said

Padilla said the Maute terrorists are now left with little space to maneuver. He added that out of the 600 buildings that the terrorists have occupied in the main battle area, half have been cleared by government troops.

"Operations are still ongo-

ing, including the clearing of the Grand Mosque," Padilla said.

The extremists had used the Grand Mosque as well as other mosques in the city as machine gun and sniper nests.

The military said up to 50 militants are still inside the mosque, holding 46 civilians hostage

Mosques and other places of worship were excluded from the airstrike target list by the military.

Padilla added the troops are still hunting down Abu Sayyaf leader Isnilon Hapilon.

Hapilon, the designated Islamic State emir in Southeast Asia, is still in the area along with some of his top lieutenants, Padilla said.

Padilla explained it would not be possible for Hapilon to slip past the tight military and police security cordon thrown around the city to include the passageway in Lanao Lake to prevent any escape or reinforcement. — With Roel Pareño 25 August 2017

Duterte visits anew main battle area in Marawi

PRESIDENT Duterte yesterday visited troops battling terrorists in Marawi City, hours after the troops gained control of a mosque that had been occupied by the Maute Group.

Col, Romeo Brawner, deputy commander of the military's Joint Task Force Ranao, said the President arrived at around 4 p.m. in the main battle area and talked with the soldiers.


The main battle area is where the fighting is confined. It is now less than a square kilometer and is in portions of two barangays in the city. Military estimates say there are about 50 Maute members confined in the main battle area.

"He stayed for about two hours. He went to the main battle area. He congratulated the troops for the progress (of the operations), because we gained control of the Islamic center," said Brawner.

It was the third time Duterte visited Marawi City since the conflict started on May 23, and the second in the main battle area. The first was on August 4.

Duterte extended some financial aid, food

packs, and watches.

Zia Alonto Adiong, head of the Marawi Crisis Management Committee, said in a tweet Duterte "went inside the main battle" ground.

"Thrice he visited Marawi & (and) twice inside the MBA (main battle oride ground)," Adiong said.

The conflict has already resulted in the death of 595 Maute members, 129 soldiers and policemen, and 45 civilians.

Brawner said the President also spoke to the troops about the need for the military to focus on its duties and responsibilities.

"He also talked against corruption. He told the soldiers not think

of that and just focus on their job," he said. Brawner said the President was accompanied AFP chief Gen. Eduardo Año, Army chief Lt. Gen. Glorioso Miranda, and national security adviser Hermogenes Esperon, among other officials.

Lt. Col. Emmanuel Garcia, chief of the 4th Civil Relations Service, said: "He (Duterte) congratulated the troops for a job well done in defending Marawi from terrorist elements and for retaking the Islamic center this morning."

"Message to troops, in a nutshell, is he will not abandon troops whether in the fight versus LTG (local terrorist group), drug lords

or common criminals as long as the troops are doing their sworn duty to enforce the law and protect the Republic, and doing it in accordance with law," Garcia also said.

Brawner said soldiers gained control of the mosque yesterday after some enemy resistance. He said three soldiers were reported injured in the fighting.

"The attack was not frontal because we want to preserve the mosque. What we did was envelopment to preserve the mosque. We didn't bomb it, no frontal attack," said Brawner.

A military official, speaking on condition of anonymity, said the Grand Mosque was abandoned by the Maute men who repositioned themselves in structures.

The source said soldiers gained control of mosque past noon yesterday and is has been cleared of improvised explosive devices.

He said the structures at the back of the mosque are "stronger."

Duterte sets foot in Marawi's main battle zone anew

President Duterte visited the war torn city of Marawi, Lanáo del Sur's main battle area for the second time on Thursday

In photos shared to members of the media by Special Assistant to the Presi-

dent Christopher Go Thursday evening, Duterte, clad in full military attire, was seen riding a vehicle.

Marawi Crisis Management Committee head Zia Alonto Adiong, in his Twitter account, said Duterte visited inside the main battle area.

This was the third time Du-

terte visited the besieged city and his second time inside the main battle area.

According to a Palace official, Duterte was accompanied by National Security Adviser Hermogenes Esperon Jr. and Armed Forces of the Philippines (AFP) Chief of Staff General Eduardo Año.

The Palace official also added that Duterte once again distributed financial aid, food packs, and watches to the soldiers. He also delivered a speech before the government troops.

Duterte last visited Marawi City on August 5 where he expressed his support and appreciation to the soldiers.

"I have to be here because I want all of you to know that – mahal ko kayo (I love you)," Duterte had told the soldiers during his August 5 visit.

The President also said that he is hopeful that the government will not lose more troops because of the ongoing battle.

"I hope you will be able to clean up Marawi City and get rid of the terrorists," Duterte said.

He also visited to wounded soldiers in Camp Ranao and gave a

short message before the members of Joint Task Force Marawi.

Duterte was able to visit Marawi for the first time since the war broke out last July 20 after two failed attempts due to the bad weather.

The war in Marawi City erupted on May 23, 2017 while Duterte was in Moscow, Russia, for an official visit. The insurgency prompted Duterte to declare martial law in the entire island of Mindanao.

Duterte's declaration expired last July 22 but Congress granted its extension until December 31,

According to the August 23, 2017 report of the AFP, a total of 45 civilians were killed by the terrorists while 1,728 civilians have been rescued by the government troops.

The government troops were able to kill a total of 595 members of the pro-Islamic State (ISIS) Maute Group, while the number of government casualties is at 129.

In his speech last Wednesday, Duterte recalled how he knew about the brewing threat of terrorism in Marawi City but said he was appalled how the terrorists were able stockpile on ordnance, ammunition, explosives, and firearms.

Duterte visits Marawi anew

DAVAO CITY – President Duterte visited Marawi City again yesterday, as the crisis created by the Islamic State-linked Maute terrorist group entered its third month.

Clad in a camouflage military uniform, bulletproof vest and helmet, the President was armed with a rifle while traveling around the besieged Islamic town. Duterte has repeatedly said he would keep coming back to boost the morale of soldiers deployed in the area.

His visit yesterday was kept under wraps so that even some ranking military and security officers were not aware where he exactly went.

At least 40 Maute terrorists are

believed to still be in the city and are keeping close to 300 residents, including a Catholic priest, as hostages.

As military operations in the city wind down, some residents have returned to their homes and the Mindanao State University has resumed classes. – Edith Regalado

AFP forms anti-terror task force

Rights group raps new AFP intel chief

THE human rights group Karapatan yesterday criticized the designation of Brig. Gen. Macairog Alberto as chief of the Intelligence Service of the AFP (ISAFP), saying he is behind killings in Compostela Valley.

In a statement, Karapatan secretary general Cristina Palabay said the promotion of Alberto as chief of all the military intelligence unit "is another step towards this worsening climate of impunity in the country."

"Alberto's one-year stint in Compostela Valley has resulted in at least 15 peasants and Lumad killed in one province alone, in pursuit of counter-insurgency objectives of the Duterte administration," said Palabay.

Alberto, the outgoing commander of the Army's 1001st Brigade based in Compostela Valley, is due to assume the new post today. He is a member of the Philippine Military Academy class of 1986.

Alberto is succeeding Maj. Gen. Ronald Villanueva, of the PMA Class 1985, who is the new commander of the Army's 4th Infantry Division based in Cagayan de Oro City.

Palabay expressed disappointment that "murderers in uniform" are given higher assignments, instead of getting punished. – Victor Reyes

Aid groups see humanitarian crisis⁷ in PH

PARIS—Fighting in the troubled southern Philippine region of Mindanao has combined with extreme weather events to create a "humanitarian catastrophe," according to French aid groups.

Around 1 million people have fled their homes in the region, said Thibault Henry, head of the Philippine chapter of the charity Acted.

"Basic needs are not covered," Henry told Agence France-Presse (AFP) on Wednesday.

400.000 displaced

"Clearly it's a huge humanitarian crisis, a catastrophe, that will affect the region for many years," he said, noting that more than half of the population lives in poverty.

In early July, the government estimated that fighting between government forces and Islamic State-inspired local terrorists in Marawi City had displaced more than 400,000 people.

The Moro Islamic Liberation Front (MILF), the Philippines' largest Muslim rebel group, and government forces, with US and Australian military backing, are battling terrorists from the Maute group and the Abu Sayyaf bandit group who had pledged loyalty to the Middle East-based Islamic State (IS) jihadist group.

Hundreds of the terrorists occupied parts of Marawi on May 23 and the battle to retake the city from them had claimed more than 700 lives.

Mindanao was struck by ty-

phoons in 2012 and 2013 and a drought in 2016, Henry noted, adding that other rebel movements affected other parts of the region.

Vanessa Cardamone of Handicap International said conflict combined with extreme weather events had created a "complex crisis."

Cardamone said only 6 percent of those displaced were in evacuation centers, while most were lodging with relatives or friends.

Aid short of needs

For his part, Javad Amoozegar of the French charity Action Contre la Faim said humanitarian aid was falling far short of needs.

"The Philippines is at the bottom of the list ... forgotten by

the news," Amoozegar said.

"Most donors look at the number of victims before mobilizing. Here the people aren't dead yet, but we want to help them so they don't die," he said

The 10,000-strong MILF has been leading a rebellion for more than 40 years to establish an independent or autonomous homeland in Mindanao for the mainly Catholic Philippines' Muslim minority.

Hardline militants, including former MILF members, oppose any form of peace with the government, and some have in recent years pledged allegiance to IS.

The MILF has repeatedly warned that if the peace process collapses it will lose many of its younger members to IS-aligned groups.—AFP

Joma to AFP: Don't speculate on Rody ouster plot

Communist Party of the Philippines (CPP) founding chairman Jose Ma. Sison slammed the Armed Forces of the Philippines (AFP) for engaging in speculation in singling out an overseas Filipino worker as the lone source of a group seeking the ouster of President Duterte.

Sison said AFP spokesman Brig. Gen. Restituto Padilla made the mistake of accusing a certain Jon Bustamante of Pinoy Abrod as the originator of the Patriotic and Democratic Movement (PADEM), a group that calls for the ouster of Duterte.

Pinoy Abrod is an Amsterdam-based publication of overseas Filipino workers with whom Bustamante is closely associated.

Sison said Bustamante initially received the PADEM call from military and police officers from the Philippines and the US on his Facebook account

Military cyber security experts traced the origin of PA-DEM to Bustamante, whom they claimed to be closely identified with Sison.

Shortly after Bustamante uploaded the PADEM state-

ment, Sison and his fellow communist leader Fidel Agcaoili shared on their respective social media accounts Bustamante's post.

"It is understandable why the PADEM leaders and members are not yet revealing their real identities. If they do so prematurely, they would be subjected to punitive measures and even physical elimination. The high sense of security of PADEM should not give General Padilla the license to call PADEM a one-man organization," Sison said.

Padilla stood by the military findings, saying the CPP leadership is only waging a campaign against the government aimed at deceiving the public into believing that there is now a brewing rift within the military and police.

"They failed to get what they want from the government," Padilla said.

Padilla added that when the unilateral ceasefire and later the peace talks were ordered terminated by the President, Sison and his colleagues were stunned as these moves cut short their anti-government plans. — Jaime Laude

Yesterday, Harris traveled to Zamboanga City to meet Lt. Gen. Carlito Galvez Jr., chief of the Western Mindanao Command.

Capt. Jo-Ann Petinglay, Westmincom spokesperson, said Harris vowed to extend US assistance, including technical assistance and training on urban type operation, to the Philippine military, which continues to battle groups atfiliated with the Islamic State in the country.

She added that Galvez presented Harris reports about the technical assistance provided by the US in counterterror operations. — With Roel Pareño, Jaime Laude

US Admiral meets Du30, AFP officials

COMMANDER of the United States Pacific, Command Adm. Harry Harris Jr. met with President Rodrigo Duterte to discuss US support to the Philippines on its ongoing efforts to end the conflict in Marawi, interoperability between the two militaries, and regional threats, the US Embassy in Manila said Thursday.

Harris also met with secretary of National Defense Delfin Lorenzana, Chief of Staff of the Armed Forces of the Philippines Gen. Eduardo Año, Secretary of Foreign Affairs Alan Peter Cayetano, and later travelled to Zamboanga to meet Commander of Western Mindanao Command Lt. Gen. Carlito Galvez Jr.

"Adm. Harris participated in a wreath laying ceremony on Aug. 23 at the Heroes' Cemetery, or Libingan ng mga Bayani, in Taguig to honor the sacrifice of the brave Filipino military heroes buried there," the embassy said.

The US's Admiral's meetings focused on upcoming bilateral engagements, recent aid and military assistance that the US government has provided to the Philippines, as well as opportunities for additional support to Marawi.

Col. Ernest C. Lee, chief of the Joint US Military Assistance Group in the Philippines, formally transferred a new 28M Class Tethered Aerostat Radar System to Flag Officer in Command of the Philippine Navy Vice Adm. Joseph Ronald Mercado in a turn-over ceremony at the Naval Education and Training Command in Zambales on Aug. 22, 2017.

Mercado was the guest of honor and keynote speaker, and US Embassy Deputy Chief of Mission Michael Klecheski also delivered remarks during the turnover.

The 28M Class TARS is a self-sustained, rapidly deployable, unmanned lighter-than-air platform which can rise to an altitude of 5,000 feet while tethered to a single cable.

Meanwhile, 16 Philippine Naval Information and Communication Technology Center personnel are engaged in a rigorous six-week training program at the NETC in Zambales to learn assembly, handling, operation, maintenance, and troubleshooting for the TARS.

"These 16 students will become instructors for the next class of operators," the US embassy said.

Through the donation, the PN is expected to enhance its capability in Maritime Intelligence Surveillance and Reconnaissance by effectively detecting maritime and air traffic within the country's coastal waters using sensors.

Moreover, it will also be utilized in Humanitarian Assistance and Disaster Response operations.

The TARS includes a weather station that provides telemetry data for the monitoring of ambient temperature, OFFICE OF THE ARMY CHIEF PUE pressure, wind speed and other pertinent parameters to successfully operate the system.

SOLDIER SHOT DEAD BY POLICEMEN IN ZAMBO SUR

ZAMBOANGA CITY—Private First Class Rodilo Bartolome survived the battle against terrorists in Marawi City, but failed to dodge bullets fired by policemen in Zamboanga del Sur province on Wednesday.

Bartolome, a member of the 53rd Infantry Battalion, was on a break from his assignment in Marawi City and was on his way home to Midsalip town when he was shot and killed in Aurora town, some 50 kilometers from Midsalip.

A police report said Oscar Asuelo, a van dispatcher, reported Bartolome's presence, describing him as an "unidentified man with a gun" standing near a store in Barangay Monte Alegre.

PO2 Ronald Zeros and PO1 Michael Bullanday responded to Asuelo's report. Police claimed that when Zeros and Bullanday reached the area, Bartolome allegedly drew a .45 cal. pistol, prompting them to shoot the soldier.

But resident Lydia Saycon had a different version of the incident. She said she saw Bartolome waiting for a van near an abandoned police checkpoint when two policemen in civilian clothes arrived.

"He was getting his wallet to show his ID to the Aurora policemen who were not in uniform. Suddenly they started shooting the man. We all got scared. That man was unarmed," Saycon told the Inquirer.

Chief Supt Billy Beltran, Western Mindanao regional police director, has ordered an investigation.

"I was told that the policemen responded to a call from residents about a suspicious person... The responding policemen alleged that as they were approaching the suspect, he immediately pulled a gun and aimed it at them," Beltran said.

The military did not respond to phone calls and text messages. Beltran, however, said he had spoken with Lt. Gen. Carlito Galvez, commander of the Western Mindanao Command, and with Brig. Gen. Rolando Bautista, commander of the 1st Infantry Division, about the ongoing investigation.

"We are saddened by the incident, and I will make sure that we uncover all facts as soon as possible," Beltran said, noting that the police would offer the soldier's family any assistance.
