

President Duterte's shoot-tokill order, even if aimed at suspected armed rebels, is not in accordance with the Constitution, Vice President Leni Robredo said on Thursday.

"If we say we can kill just because we are accusing someone of a crime, what will hapsaid when asked by reporters in Caloocan City about Mr. Duterte's order.

The President on Wednesday said soldiers should shoot armed members of the New People's Army (NPA) right away and disregard human rights.

"Shoot them! They will kill you anyway. If there is an armed NPA there or terrorist holding any firearms, shoot ... I'll answer for you," he said in a speech at Sual town in Pangasinan province.

The NPA is the armed wing of the Communist Party of the Philippines (CPP), which has been waging a rebellion for nearly 50 years.

Mr. Duterte, a lawyer, said he would answer for the soldiers accused of human rights violations.

He also said he would take up the cudgels for soldiers and police officers if they killed someone mistaken for an NPA member.

#### Mistaken identity

The President noted that a "mistaken identity" was "an exempting circumstance.'

His shoot-to-kill order came a day after government forces killed 15 suspected NPA members, including five women, in separate encounters in Nasugbu, Batangas. The fatalities were in a jeepney and a van.

Mr. Duterte terminated pen to all of us, right?" Robredo - peace negotiations with the National Democratic Front of the Philippines (NDFP), the political arm of the CPP, last week through Proclamation No. 360. He cited the rebels' "insincerity" in the talks, saying that they continued to attack and kill soldiers and civilians.

A day after signing the proclamation, the President told soldiers to be prepared for "virulent confrontations" with the rebels.

#### **Eroding rule of law**

Robredo, who is also a lawyer, said the Président's shoot-to-kill order did not seem to be stated in the Constitution and the laws.

ties for the charges," the Vice-President told reporters in an interview, a transcript of which was e-mailed by her office.

She said the rule of law would be eroded if people were allowed to take the law into their own hands. "[T]hat would lead us to a lot of mess."

Robredo was attending the Bonifacio Day celebration in Caloocan City, where Defense Secretary Delfin Lorenzana represented the President who skipped the event to tend to the Mindanao conflict.

Malacañang defended the President's order for soldiers to shoot and kill armed members of the NPA.

Presidential spokesperson Harry Roque said on Thursday that communists who took up arms against the government were legitimate military targets since they were committing a crime.

#### Crime of rebellion

"The crime of rebellion is a crime of taking arms against the government," Roque told reporters. "When you are bearing arms against the government, you are engaged in crime."

A legal consultant to the NDFP said Mr. Duterte's shoot-to-kill order was a violation of the Comprehensive Agreement on Respect for Human Rights and International Humanitarian Law (Carhrihl), which was signed by both the government and the NDFP in 1998.

"There are rules of war aka international humanitarian law. One who is not in a position to fight or doing an overt hostile act should not be killed summarily," said lawyer Edre Olalia an NDFP consultant.

Carhrihl is a 2-decade-old agreement between the Philippine government and the NDFP, signed in The Hague, that ensures that despite the armed conflict, human rights are upheld by both sides and abuses would not go unpunished.

The military spokesperson, Maj. Gen. Restituto Padilla Jr., assured the public that the Armed Forces of the Philippines would continue its "strict implementation" of its rules of engagement, pointing out that the communist rebels have committed more human rights violations.

#### **Focused operations**

Padilla said the military was implementing focused operations "against the NPAs and their economic sabotage activities."

CPP founding chair Jose Maria Sison said human rights groups should investigate the gun battle in Batangas to determine if there was an actual firefight.

Also on Tuesday, two members of a human rights group were killed and another was wounded while on a fact-finding mission in Negros Oriental. (See story in Regions, Page A20.) INQ

# Rody to troops: Shoo armed NPA terrorists

After scuttling peace talks with the communists, President Duterte has ordered security forces to shoot armed rebels even as an executive order is being prepared to declare them as terrorists.

Duterte also ordered the military and police to re-arrest the top leaders of the Communist Party of the Philippines-New People's Army (CPP-NPA) earlier released as consultants of the moribund peace talks.

"So if there is an armed NPA there or terrorist, if he's holding a firearm - shoot," Duterte said during a ceremony at the Sual wharf in Pangasinan on Wednesday.

Duterte said he is prepared to defend his men against allegations of human rights violations in killing NPA rebels.

"Do not answer that issue of human rights. You say, 'Go to Duterte. It is and was his order'," he said.

Duterte said his team is now preparing the executive order declaring the CPP-NPA and the National Democratic Front (NDF) as terrorists. He said the executive order will effectively treat the communist rebels as criminals.

"I am preparing now. They are preparing the executive order declaring them to be terrorists and they will be afforded the treatment of being criminals," Duterte

"There will be no filing of cases under public security like rebellion because rebellion is considered sometimes a noble undertaking, it's only because you want your country to do better," he added.

In the same speech, Duterte talked about his decision to cancel the peace talks with the communists.

"Because I think that they are not really serious... (they are) just biding their time, they do not have the second echelons to carry the fight and they just want to be comfortable," he said.

Duterte criticized the CPP-NPA over deadly attacks against soldiers and police in the countryside while the NDF is holding peace talks with the government.

Duterte had already shelved a round of negotiations in May and informal talks last July, citing treacherous attacks on security forces.

"I have given too much, too soon and I know that the military were complaining. But I said, 'You know my job is to seek peace with everybody, to attain peace for my country.' You have to understand that," Duterte narrated.

"There will be no talks with the NPAs now, and I told them, 'We have been fighting this war 50 years ago,' and they want another 50 years," he added.

"I said, I have pleaded even to go down on bended knees to ask everybody at the start of my presidency. We should talk peace not war... that is not my job as President to promote wars, it's not my job to encourage violence."

On his orders to re-arrest the freed NPA consultants, Duterte said there are "conditionalities," explaining that some rebel leaders cannot be arrested because of old age and humanitarian considerations.

'Also out of humane reasons. For one, those who were above 70 like me, I'm getting tired of going out to find them. Anyway, they cannot go far... they cannot climb those mountains there. You will find them in a hospital or in a room just resting their tired old bodies," he said.

While he has ordered an all-out war against the NPA, Duterte said he still hopes that the conflict will not get out hand.

"I do not want to start a real violent war. But if the NPAs, just like the terrorists would do it, then we will give them the favor," he said.

Presidential spokesman Harry Roque said Duterte acted within legal bounds when he directed security forces to kill any armed NPA rebel.

Roque pointed out it is prohibited under the law to take up arms against the government.

"So naturally, when you are bearing arms against the government ... you are supposed to implement the law and then again the President had the power to implement the law," he said.

Under international law on armed conflict, any armed rebel is a legitimate target.

> There is no timetable for the declaration, "but the President said he will do that," the spokesman said.

### Still open

Chief government peace negotiator Silvestre Bello III said the President's plan to declare the CPP-NPA-NDF as terrorist groups would dash all hopes of getting the stalled peace negotiations back on track.

"That would end everything. That is because we cannot negotiate with terrorists," Bello said.

He said the door is still open despited Duterte's order to terminate the peace talks with the communists.

"The negotiations are terminated right now on orders of the President, but he is open to resuming them once the environment for their resumption becomes conducive," Bello told reporters yesterday.

"That means no more ambush, like the one they conducted in Bukidnon in which civilians, including a child, were killed. No more hostilities. That is the environment that could lead to the resumption," he said.

Bello said he or presidential peace adviser Jesus Dureza would soon formally communicate to the NDF the President's decision to end the peace talks.

The NDF has said it needed a formal notice of such decision.

The military, for its part, said the President has already ordered a full offensive against the NPA even without formal notice to end the peace talks.

"We are hoping that with our heightened operations we will have more accomplishments in the days ahead because we will not rest on what we have already started, fighting these NPA terrorists as ordered by our commander-in-chief," Armed Forces of the Philippines (AFP) Public Affairs Office chief Col. Edgard Arevalo said.

Arevalo said the AFP is currently monitoring the movements of the freed NDF consultants upon orders of the President to re-arrest them.

"We are still awaiting any specific guidance. While doing so, the military is now conducting intelligence monitoring," Arevalo said.

A total of 21 NDF consultants were freed to allow them to participate in the peace talks with the government. Among them are top NPA leaders Benito Tiamzon and his wife Wilma. – With Jaime Laude, Jess Diaz

signed Proclamation 360, which officially terminated peace negotiations with the NDF, the pollulcal arm of the Communist Party of the Philippines (CPP),

Presidential Peace Advised Jesus Dureza had confirmed that 21 consultants were released for the peace talks last year, including Benito and Wilma Tianzon, the couple leading the communist rebellion.

Arevalo clarified that the cancellation of the peace negotiations with the communist movement did not mean the immediate arrest of the 21 consultants.

"The Presidential Proclamation 360 is enough as a signal for them to take heed or take the cue that the peace talks have officially been canceled," Arevalo told reporters.

He ad the Joint Agreement on Safety and Immunity Guarantees between the government and the NDF, which provides protection to NDF consultants given safe conduct passes.

When Duterte reopened peace talks with the communists, safe conduct passes were issued to the consultants who were freed from detention, including the Tiamzons, Adelberto Silva, Alfredo Mapano, Tirso Alcantara, Pedro Codaste, Porferio Tuna, Concha Araneta Bocala, Ernesto Lorenza, Eduardo Ganelsa, Ariel Arbitrario, Runel Saluta, Jaime Soledad, Kennedy Bangibang and Alan Jazmines.

Arevalo said the military did not have information on the exact whereabouts of the Tiamzon couple.

"The ones that we are monitoring and the ones we will arrest are different. We have to conduct the monitoring [to prepare for the] time [when] there will be instruction, specific order to arrest [the consultants]," he said. "We have to be proactive in our actions."

In February, the government filed a motion before the Quezon City Regional Trial Court Branch 216 seeking the re-arrest of the Tiamzon couple, but failed.

### Intensified ops

The military also vowed to heighten operations against the NPA, following the encounter between government security forces and NPA rebels in separate incidents in Nasugbu, Batangas that resulted in the deaths of 15 NPA members and the wounding of two rebels and five soldiers.

"We will not stop especially now that we have started our heightened campaign against this terrorist group of the New People's Army," Arevalo said.

The Philippine Army disputed the claims made by CPP founding chairman Jose Maria Sison that the clashes between government troops and the NPA in Batangas were like the police's anti-illegal drug operations dubbed "Oplan Tokhang."

Brig. Gen. Arnulfo Marcelo Burgos, commander of the Army's 202nd Infantry Brigade, said Sison's statements were "mere propaganda" against the military.

The same day when the encounter transpired, Sison called on independent human rights organizations and the Commission on Human Rights to investigate the deaths of the supposed NPA members in Batangas, which he described as "Tokhang-like."

"Joma Sison's statement is a mere NPA propaganda against the government forces which are pure and simple lies with the sole intention of salvaging their eroding mass base support and projecting relevance in the region," Burgos said in a statement.

#### Order to shoot NPAs defended

Malacañang on Thursday defended President Duterte's order to the police and military to shoot armed communist rebels.

Palace spokesman Harry Roque maintained that the President's directive against armed rebels was within the bounds of the law.

"Of course, because anyone who bears arms is guilty of rebellion. The crime of rebellion is the crime of taking up arms against the government," Roque told Palace reporters.

"So it's natural, so when you are bearing arms against the government you are engaged in crime, you are supposed to implement the law and yes, the President has that power to implement the law. Labor Secretary Silvestre Bello 3rd, chief government negotiator with the CPP-NPA-NDF, said that the issuance of President Duterte of a proclamation declaring the NPA as "terrorists" would be the final nail in the coffin in terms of peace negotiations.

"If the issuance [of the proclamation] happens then it will be the end of everything [in terms of the peace talks] because we cannot negotiate with terrorists," Bello said in Filipino in an interview at the House of Representatives.

# ANGAS CLASHES WERE DN SLANSTIDEN 'IMMERSION' PROGRAM, SAYS AFP

A University of the Philippines (UP) student and other youngsters who were among the 15 suspected New People's Army (NPA) members killed at Nasugbu town in Batangas province on Tuesday were on an "immersion" program, according to a top military official.

Rhoderick Mai. Gen. Parayno, commander of the Army's 2nd Infantry Division, said the program, or "tour of duty" (TOD), was meant to prepare fresh recruits for the rigors of living dangerous lives.

aims to strengthen the belief of the would-be recruit that he or she is joining a just group and

that they have noble purposes," Parayno said in a phone interview.

"Our theory is they were Isupposed to conduct an offensive. They were 'dressed to kill." he said.

The NPA is the armed wing of the Communist Party of the Philippines (CPP).

He said a TOD member from UP "means she or he is being groomed to be a leader or cadre of the group."

#### **UP and PUP**

Among those killed in what the military said were gun battles between government forces and the NPA was Josephine Anne Lapira, 22, a "TOD, normally in groups, . former biochemistry student at UP Manila.

> Also killed was Kamil Manangan, a former Polytechnic

University of the Philippines (PUP) student and spokesperson for Gabriela Youth, the women's group Gabriela said.

. Authorities had yet to release the official list of those slain as of Thursday afternoon.

The military said Glen Mark Aytona, 22, of Balayan, Batangas, and Carl Espinosa Labajata, 32, of Lemery, also in Batangas, were among those killed.

Sources identified two other fatalities—Julieto Pellazar Jr. and a certain Dondon from Antipolo City, Rizal.

#### Lone survivor

The lone survivor is Victoriano Almario, 47, whose home is just about 20 meters from the encounter site in the village of

Almario was taken to Medical Center Western Batangas in

Balayan but was later moved to Batangas Regional Hospital in Batangas City. He is being guarded by policemen who denied the Inquirer's request to talk to his relatives on the phone.

"He is an NPA," Parayno said of Almario, who was under hospital arrest.

He said Almario drove the jeepney that ferried the rebels up to a police-military checkpoint in Aga.

Five people in the jeep died while nine others in a van were killed in the second clash in Barangay Kaylaway, about 2 kilometers away.

Chief Insp. Rogelio Pineda, Nasugbu police chief, said Almario would be charged with illegal possession of explosives and attempted murder.

Batangas Integrated Human Rights Advocates said Almario, quoting relatives and neighbors, was "just a jeepney driver" hired by the group.

#### Just a driver?

Nasugbu Mayor Antonio Barcelon confirmed that Almario was a jeepney driver and that the vehicle was owned by a family from Barangay Banilad.

"[But] he would always be seen driving the jeep hired by protesters during rallies If anything, he could be a 'supporter," Barcelon said.

Families of those killed were still awaiting the release of the remains of their loved ones. As of Thursday afternoon, only Lapira's remains had been released, according to Evangelista. -with a report

VICE President Maria Leonor "Leni" Robredo led other government officials in a simple ceremony commemorating the 154th birth anniversary of revolutionary hero Andres Bonifacio at the Bonifacio Monument in Caloocan City on Thursday.

However, many were surprised why the vice president was not given a chance to speak before the thick crowd.

Caloocan Public Information Officer Nolan Sison was quick to explain that the city government had nothing to do with the preparation and invitation of the guest of honor and speaker.

Sison said the National Historical Commission supervised and organized the Bonifacio Day programs and activities.

He spoke out after students, city residents and members of the media asked him why Robredo, the highest official of the land during the event, was not given time to speak.

Caloocan Mayor Oscar Malapitan delivered the opening remarks where he boasted of the 20-percent decrease in the crime rate in the city and various programs and projects, including the Tutuban-Clark railway and the opening of the new "Big Dome" on December 8.

It was Defense Secretary Delfin Lorenzana who served as the guest of honor and speaker, and talked about the "untold and true story" of Andres Bonifacio.

Aside from the three officials, also present in the rites were Armed Forces of the Philippines (AFP) Chief of Staff Gen. Rey Leonardo Guerrero, National Historical Commission Director Ludovico Badoy and Gregorio Bonifacio, a relative of Andres Bonifacio.

Lorenzana called on Filipinos to draw inspiration from Bonifacio's legacy of freedom.

# ARMY FORMS UNIT IN MINDANAO TO FIGHT URBAN TERROR

DATU ODIN SINSUAT, MAGUINDANAO—The military's 6th Infantry Division (ID) based here has activated a new Army battalion to combat urban terrorism and prevent a siege, similar to what happened in Marawi City, in areas under its watch, an Army official said.

The 6th ID has jurisdiction over Maguindanao province, portions of North Cotabato and Sultan Kudarat provinces, and some towns in the second congressional district of Lanao del Sur province, including communities near Butig town, where the Maute terror group started building its forces.

Lt. Col. Gerry Besana, chief of the 6th ID's civil military operations, said the new 90th Infantry Battalion (IB) was undergoing a monthlong organizational process and would be based in Cotabato City.

Besana said the new unit, which would "act as deterrent to a Marawi City-like siege," was among 10 antiterror battalions that the Army had started to organize across the country.

Besana said veteran soldiers who would make up the new unit, which he would head, would undergo refresher courses.

He said some unit members were attending a special skills and capability refresher course at the Division Training School here.

"All personnel who compose the unit are actually battle-tested and experienced in countering violent extremism in Central Mindanao," Besana said.

"Equipment is not a big problem because the Army has enough but ... there is still a need to procure or acquire new and essential equipment," he added.

He said the military would ensure that the new battalion was ready to take on terror threats before deployment.

"Hence, our people should also expect that the 90th IB, in particular, is ready to serve them and protect them based on our constitutional mandate," he said.

Besana asked residents of Central Mindanao for support.

"As I have said before, peace is everybody's concern. Therefore, we should all work together for the [sake] of Central Mindanao. We have to have unity amid diversity," he said.—EDWINO.FERNANDEZ INQ

# NOLCOM WATCHES NPA ATTACK SITES

CITY OF SAN FERNANDO— The chief of the military's Northern Luzon Command (Nolcom) said government forces and resources had been concentrated in areas where communist rebels had intensified attacks before President Duterte canceled the peace talks last week.

In a statement on Tuesday, Nolcom commander, Lt. Gen. Emmanuel Salamat, said "focused military operations" were being undertaken against the New People's Army (NPA).

"Our intent is to concentrate our attention in areas where we have identified these criminal groups have been operating," Salamat said.

On Monday night, Army soldiers clashed with suspect-

ed communist rebels in Sallapadan town in Abra province. Pfc. Jeffrey Siron of the Army's 24th Infantry Battalion was hit in the leg and was treated at a local hospital.

The NPA has yet to react to a report from the overseas security and intelligence firm, Pacific Strategies and Assessment, about a rise since January of rebel attacks in Batangas province and Cordillera, Cagayan Valley and Ilocos regions.

Salamat said Nolcom would carry out a "more proactive campaign" against the NPA to counter rebel activities such as coercion and extortion on business owners. —TONETTE OREJAS WITH A REPORT FROM KIMBERLIE QUITASOL INQ

Speaking at the send-off for Vietnamese fishermen in Sual town in Pangasinan province on Wednesday, the President said Southeast Asian countries had committed that they would treat poor fishermen, who had wandered into their waters, with understanding and love.

# NDF calls for more frequent attacks

Communistrebels warned vesterday of "more frequent and more intensified attacks" against the government once President Duterte formally tags the Communist Party of the Philippines (CPP) and its armed wing the New People's Army (NPA) as terrorist groups.

The National Democratic Front (NDF), the umbrella organization: representing the CPP-NPA in peace negotiations with the government, threatened to wage war if Duterte continues to ignore the peace efforts and officially classifies the rebels as terrorists.

NDF-Mindanao spokesman Joaquin Jacinto said yesterday that 50 years of struggle against the government have shown the CPP-NPA-NDF

as an advocate and defender of the interests of exploited and oppressed Filipinos.

He said the CPP-NPA-NDF is essentially a revolutionary organization seeking to establish a society unshackled from imperialist domination.

"Thus, under whatever circumstance, the CPP-NPA-NDF can never ever be terrorists. Thus, the NDF-Mindanao calls on the New People's Army to launch more frequent and more intensified tactical offensives to frustrate military operations that only bring more death, destruction and misery to the people of Mindanao," Joaquin said.

Duterte on Wednesday said he has ordered security forces to shoot communist rebels bearing firearms.

He revealed an executive order is being prepared to declare the NPA as a terrorist group.

Jacinto said Duterte is "greatly mistaken" in thinking the communist rebels and their supporters "will cower in fear in the face of his boasts and threats."

He said Duterte is daydreaming in his objective to wipe out the CPP-NPA-NDF by the end of 2018.

Jacinto mentioned Presidential Decree 360, the supposed executive order to be signed declaring the CPP-NPA-NDF as a terrorist group.

He said PD 360 only reveals the Duterte administration's "utter contempt for attaining just and lasting peace and its propensity towards a reign of death, destruction and tyranny."

"Thus, it is only just and correct that the revolutionary movement in Mindanao and the entire nation, under the leadership of the Communist Party of the Philippines, respond through the New People's Army by way of launching widespread and more frequent tactical offensives against the AFP, PNP (Armed Forces of the Philippines, Philippine National Police) and paramilitary troops that seek to ravage numerous hinterland communities in the entire island," Jacinto said.

In Negros Island, the NPA has warned quarry operators of destruction of their equipment, as they owned up to the bombing of heavy equipment on Sunday in Kabankalan City, Negros Occidental.

Police said they are looking into extortion as the possible motive for the raid of a quarry site and the bombing in Ka-

The police also dismissed the spate of attacks staged by the NPA in the Visayas as diversionary tactics by the rebel

PNP chief Director General Ronald dela Rosa said the series of NPA attacks in the region form part of a bigger plan

in Mindanao. Dela Rosa did not go into details on the NPA's purported plans for Mindanao but stressed security forces are not pulling out from the Visayas.

We will add forces here to prevent NPAs from doing more atrocities," he said.

The military in Mindanao revealed the NPA is becoming more aggressive in attacking government troops. - Ben Serrano, Jennifer Rendon, Gilbert Bayoran, Ed Amoroso

# AFP locating communist consultants

THE Armed Forces yesterday said it is locating the 21 consultants of the National Democratic Front of the Philippines, who were freed by the Duterte administration so they can participate in peace negotiations between government and the communist group.

President Duterte formally terminated the peace negotiations last week because of what he said was the communists' lack of sincerity and commitment to the peace process. Following the termination, he asked the consultants to surrender or "face punitive actions." Duterte said the consultants should "go back to where you belong," referring to jail.

AFP public affairs chief Col. Edgard Arevalo said the military has yet to get specific orders from higher authorities to arrest the consultants but is now determining their whereabouts in preparation for the arrest. Among the consultants are

Benito Tiamzon, chairman of the Communist Party of the Philippines, and his wife, CPP secretary general Wilma Austria.

Tiamzon and Austria were arrested by military intelligence operatives in 2014 in Cebu for various crimes. The two and 19 other NDF consultants were freed last year so they can participate in the peace talks.

"As of now, we have no information on their location but we are awaiting specific guidance if we should arrest them, based on order from our courts," Arevalo told a press briefing in Camp Aguinaldo.

Arevalo said Proclamation 360 on the termination of the talks should be "enough signal for them (communists) to take heed or take cue that the formal talks are already over."

"We are going to await further instruction about this (arrest of the consultants) but we are already monitoring them," said Arevalo.

"Monitoring is different from arrest. We have to monitor them

so that we're already aware of their whereabouts when there is already an instruction, specific order to arrest them. We have to be proactive in our actions," said Arevalo.

Asked if the Tiamzons and the other NDF consultants are in the country, Arevalo said: "I cannot answer that question right now but what I am sure about is we have efforts to locate them."

Four rounds of formal talks were held in Norway and Rome. A fifth round was supposed to be held also in Norway before Duterte suspended the talks in July because of, among others, continued attacks by the New People's Army, the CPP's armed wing, on government forces.

The military has stepped up its campaign against the NPA which Duterte is planning to declare a terrorist organization.

Arevalo said the military would take more actions against the NPA,

similar to that in Nasugbu, Batangas last Tuesday, where 14 NPA members were killed in clashes with government forces.

The Nasugbu incident is the biggest feat so far since President Duterte issued Proclamation 360 on Thursday last week.

"We are going to be relentless in our intensified campaign against the terrorist New People's Army, especially so that our combat operations in Marawi are now over," Arevalo said.

He was referring to the attack by the Maute Group in Marawi City. The conflict that started on May 23 lasted five months.

#### SISON'S PROPAGANDA

Brig. Gen. Marcelo Burgos, commander of the Army's 202nd Brigade, accused communist party founder Jose Maria Sison of resorting to propaganda and misinformation to undermine the military success in Nasugbu.

The Netherlands-based Sison

earlier insinuated that those killed in the fighting were civilians and not NPA members.

Burgos said Sison's statement is aimed at "salvaging their eroding mass base support and projecting relevance in the region."

Burgos maintained that the fatalities, including UP student Josephine Anne Lapira, are all NPA members. Four other female rebels died in the fighting.

"They are all armed. They are all NPAs. And they are there to conduct tactical offensive. They're wearing bandoliers and they have arms. How can you explain the number of firearms they were carrying?" said Burgos.

Burgos said the rebels were planning to attack a police detachment in Nasugbu.

Maj. Gen. Rhoderick Parayno acknowledged that Lapira is a UP student but stressed she is an NPA member. "Her status in the NPA is full-timer, meaning that she is really an NPA (rebel)," said Parayno.

# Rody's shoot-to-kill order vs Reds'normal' — Palace

Malacañang sees nothing wrong with President Duterte's shoot-tokill order against any armed communist rebel.

Presidential spokesman Harry Roque said yesterday that it is a natural mandate for state security forces to hunt down any armed member of the New People's Army (NPA).

Duterte on Wednesday urged soldiers to shoot any spotted NPA, claiming full responsibility of such

punitive actions.

"Anyone who bears arms is fusing rebellion. The crime of rebellion is a crime of taking up arms against the government," Roque told reporters in a phone-patched interview.

"So it's natural. When you are bearing arms against the government you are engaged in crime you are supposed to implement the law and yes, the President has that power to implement the law," he added.

In a speech in Sual, Pangasinan, the Commander in Chief said he wants the military to boost its communist crackdown.

"If there is an armed NPA there or terrorist who is holding firearms, shoot and tell them I will answer for it," Duterte said.

The President's pronouncement came over the military's recent maneuver that killed 16 NPA rebels in Batangas.

Among those killed were formerly known Manila-based student activists belonging to legal left-leaning groups.

lamented Duterte's kill-order on NPAs, saying such pronouncements undermine the rule of law.

Talking to reporters at the sidelines of the Bonifacio Day celebration in Caloocan City, the Vice President said that killing any suspected criminals without legal due procedures is against the law.

"It appears that is not what our Constitution states," Robredo said of Duterte's threat on communist insurgents.

"The laws say that if one commits crime, there should be due process to investigate if the allegations are true, and there are corresponding penalties to those crimes committed," she added.

The Vice President opined that Duterte's proposed bloody crackdown on communists somewhat undermine the state's legal institutions.

"If we would put the law into our hands, it's like we're undermining democracy, invalidating the rule of

law. It would be the start of our disarray." Robredo said.

"That's why we have institutions because these institutions ensure that we live our lives decently everyday. If we kill because we are merely accusing people of crimes, what would happen to us?" she added.

#### Joma's propaganda

The claim of Communist Party of the Philippines (CPP) founder Jose Maria "Joma" Sison that no real encounter took place in Nasugbu, Batangas that left 14 NPA rebels dead and another wounded and captured is just a propaganda.

This, according to Army's 202nd Infantry Brigade commander, Brig. Gen. Arnulfo Burgos, in an interview yesterday.

"Joma Sison's statement is a mere NPA propaganda against the government forces which are pure and simple lies with the sole intention of salvaging their eroding mass base support and projecting relevance in the region," he added.

Burgos said what the CPP founder cannot contradict is that troops applied first-aid and evacuated the wounded rebels to the nearest hospital for appropriate medical treatment which is more than enough proof that the military highly values the rights and lives of the people.

"This blatant attempt to weaken our resolve through misinformation and harassment only shows that we are hitting, hurting and disrupting their terroristic plans which inspire us to remain steadfast in pursuing our mandate of protecting the people of Region IV and securing this part of our land," the military official added.

In a series of encounters in Barangays Aga and Kaylaway that started 8:20 p.m. Tuesday, an initial 13 rebels were killed and three security troops were wounded in the gun battles that lasted for 20 to 40 minutes.

Also wounded were two NPA rebels whom troops provided with first aid and brought to the nearest

One of the wounded rebels later died, bringing the death toll of the NPAs to 14.

The encounter was "intelligence driven" and stemmed from the November 20 operation in Barangay Utod that earlier resulted in the capture of a NPA base and undetermined rebel casualties.

The seized NPA encampment is capable of housing and training a significant number of rebels.

Nine of the slain rebels were male With PNA while five were female.



# Abu Sayyaf member nabbed in Basilan

AN Abu Sayyaf member with a P1.3-million reward for his neutralization was arrested by joint military and police operatives in Isabela City in Basilan on Tuesday.

Capt. Jo-an Petinglay, spokeswoman of the AFP's Western Mindanao Command based in Zamboanga City, identified the suspect as Rahim Abdul alias Aman Kabalu.

Petinglay said Abdul was nabbed

by troops of the military's Joint Task Force Basilan, aided by local policemen, in Zone 1 in Barangay Kampurhan at around 3:40 p.m. Tuesday. Abdul yielded a fragmentation grenade.

JTF Basilan commander Brig. Gen. Juvymax Uy said a civilian provided information to the military, leading to the arrest of Abdul. He said the suspect did not resist arrest when cornered by the troops.

Petinglay said Abdul is listed in the DND-DILG's Joint Order of Rewards, a list of wanted personalities.

She could not provide details on Abdul's activities or cases he has participated in.

The Abu Sayyaf is notorious for kidnapping-for-ransom activities and for beheading hostages. It operates mainly in Sulu and Basilan, and is holding several hostages. – Victor Reyes

# Soon to be released EO declares NPA as a 'terror' group

PRESIDENT Duterte is nearing to issue an executive order (EO) branding the communist-led New People's Army (NPA) as "terrorists," his spokesman revealed on Thursday.

According to Presidential Spokesman Harry L. Roque Jr., Malacañang is now crafting an EO placing the NPA under the terror watch. "[There is] no date, but the President will do that," Roque said in a phone interview.

This came a day after the President announced he will be preparing an EO, declaring the NPA as terrorists. Peace talks with the National Democratic Front, the negotiating arm of the communists, has been terminated by the government, saying it had enough of attacks from communist rebels.

"I am preparing now. They are preparing the executive order declaring them to be terrorists, and they will be afforded the treatment of being criminals," Duterte said on Wednesday.

The President added he already cut ties with the NPA, which he formerly considered bringing into the government. He said the communist rebels "are not really serious" in talking peace with the government, and are "just biding their time" to destabilize the Duterte administration. "They do not have the second echelons to carry the fight, and they just want to be comfortable," Duterte added.

The government also intends to arrest activists alleged of conniving with the communists rebels, such as members of left-leaning groups. This, however, has drawn flak from human-rights groups, saying it might lead to a brutal crackdown, like the war on drugs.



**MANILA** -- Like Gat Andres Bonifacio, who is celebrating his 154th birthday Thursday, the Philippine Army (PA) is always ready to serve the people and protect the land.

"Gat Andres Bonifacio is a hero to all of us not only because he fought for our freedom, but because he also taught us to use that hard-won freedom in the best interest of the country and people," he added in a message to the Philippine News Agency.

Tiongson said the PA is more than willing to emulate the example of the 'Great Plebeian'.

Around 8 a.m. Thursday, as part of the commemoration rites to honor Kataas-taasang "Kagalang-galang na Kapitunan na Anak ng Bayan" (KKK) founder, a simple wreath-laying ceremony was held at the Bonifacio Monument in front of the Tutuban Center.

Activities were led by officials and representatives of the Tutuban Properties, Inc. and National Historical Commission of the Philippines.

Bonifacio, born on Nov. 30, 1863 in Tondo, Manila, was the founder and later supreme leader of the KKK movement which sought to free the Philippines from Spanish colonial rule.

Bonifacio and his brother Procopio were executed in Maragondon, Cavite, after being found guilty of treason by the Katipunan Magdalo faction supporting Gen. Emilio Aguinaldo in May 10, 1897. (PNA)





## New Army battalion eyed to fight NPA in Panay

From the Philippine News Agency (Nov 29): New Army battalion eyed to fight NPA in Panay

Interior and Local Government Undersecretary Eduardo Año on Tuesday talked of a plan to activate a new battalion in Panay to continuously go after the New People's Army in the island.

"We need the unity of different sectors. Once and for all, let us end this," he stressed in a media interview after his visit to the wake of slain Police Officer I Joeffel Odon who died in a recent NPA ambush in Maasin, Iloilo.

Currently, they are working to fast track the pull out of the Philippine Army's 82nd Infantry Battalions (IB) deployed to Marawi City during the conflict. The battalion is based in Miagao, Iloilo.

Colonel Pio Diñoso, commanding officer of the Philippine Army's 301st Infantry Brigade (3rd Infantry Division) based in Dingle, Iloilo, said that they are currently expediting the activation of the new battalion.

"We have a lot of candidate soldiers who will undergo training so we could create the additional battalion," he said in a media interview.

Diñoso expressed hope that the new battalion will be organized early next year.

Año said that they would also provide additional training and equipment to the troops of the Regional Mobile Force Battalion (RMFB) of the Police Regional Office (PRO-6) to improve their skills and perform better.

He added that they would also review the Standard Operating Procedures (SOPs), tactics, procedures and techniques of the Philippine National Police personnel in Western Visayas to improve their skills in dealing with incidents like NPA ambush and clash.
