

Communist rebels stepped up their offensive against the government, killing a local official and a policeman in separate attacks in Cagayan and Camarines Police said Baggao town Councilor An-ros, Romar Umandap and Johnson Espana. Norte yesterday.

gelo Luis died on the spot from multiple gunshot wounds.

Luis was taking a stroll in his garden when New People's Army (NPA) rebels, armed with M16 rifles and clad in camouflage uniforms, opened fire at close range.

Cagayan provincial police director Senior Supt. Warren Tolito said at least 20 rebels stormed the house and killed Luis before fleeing.

NPA rebels also attacked and killed a policeman and wounded six others in an ambush in Labo, Camarines Norte.

PO2 Richard Abad of the Provincial Mobile Force Company (PMFC) died on the spot while six of his colleagues were wounded during the attack in Sitio Binuang, Barangay Daguit.

Initial reports identified the wounded policemen as PO2s Ronald Gutierrez, Erickson de Vera, PO1s Jeffrey Tarrobago, Pedro Vale-

Cerilo Trilles Jr. said nine policemen were on two patrol vehicles on their way back to the provincial headquarters in Daet when the rebels waylaid them.

The policemen engaged the rebels in a firefight until reinforcements from the provincial police and military arrived.

The rebels fled the scene with no immediate reports if they also suffered casualties.

The police and military have launched pursuit operations against the rebels.

The NPA's Henry Abraham East Cagayan Command owned up to the killing of Luis, accusing the victim of working undercover for the military.

Luis has been critical of the NPA's extortion against local businessmen, traders and contractors in the province, police said.

Tolito said the rebels are attacking the Turn to Page 6

construction sites in the province and burning heavy equipment used for the construction of the road going to Baggao and other government projects.

"This is the very advocacy Luis is espousing - a clean and good government for the people, that cost his life. Let us not waste it,"

Philippine National Police (PNP) chief Director General Ronald dela Rosa slammed the NPA for the treacherous attacks.

Dela Rosa said they expected the NPA to resort to dirty warfare.

"They (NPA) waited for the policemen. That's deceit," he said.

Dela Rosa they would have wanted to avoid casualties in armed conflicts with the communist rebels.

"Sometimes you win, sometimes you lose. That's part of the game," he said:

The communists threatened to wage "more frequent and more intensified attacks" against the government once President Duterte formally tags the Communist Party of the Philippines (CPP) and its armed wing the NPA as

terrorist groups.

Duterte has ordered security forces to shoot communist rebels bearing firearms as he revealed an executive order is being prepared to declare the NPA as a terrorist group.

Duterte also threatened to tag all "legal fronts" of the CPP-NPA as criminals and have

them arrested for conspiracy.

Duterte has caricelled all future peace talks with the communist rebels, blaming the insurgents for deadly attacks against soldiers and police while the National Democratic Front (NDF), the umbrella organization representing the CPP-NPA, is holding peace negotiations

with the government.

The CPP, through the NPA, has been waging an insurgency since 1968.

Peace talks to end the conflict, which the military said has claimed 30,000 lives, have been conducted on and off for three decades.

They were revived last year after Duterte was elected president, with Norway and the Netherlands hosting the negotiations.

Duterte had shelved a round of negotiations in May and informal talks in July this year, citing treacherous NPA attacks on government forces - With Celso Amo, Victor Martin, Raymund Catindig, Cet Dematera

## Rody may decide on Mindanao martial law extension next week

ZAMBOANGA CITY - Whether martial law in Mindanao will be extended or not, the nation will know from President Duterte by next week or before Congress goes on Christmas recess, his spokesman said yesterday.

In a press briefing, presidential

spokesman Harry Roque said the Armed Forces of the Philippines (AFP) has submitted its recommendation to President Duterte after a consultation

He declined to give details, but said he has set a media briefing for tomorrow.

He stressed the President cannot extend martial law without Congress'

"Consultation is over. They now have a decision, and they will submit their recommendation to the President this week," Roque said in Filipino.

The presidential spokesman was here on invitation of Mayor Ma. Isabelle Climaco-Salazar.

President Duterte declared a 60-day martial law in Mindanao on May 23 while on a trip in Russia when Maute and Abu Sayyaf militants – both claiming links to the Middle East-based Islamic State (IS) laid siege to Marawi City. The President later extended his proclamation until Dec. 31, with the concurrence of Congress.

Roque said while the government has liberated Marawi City, threats of terrorism and violence remain.

He said world leaders in fact acknowledged the prevalence of terror threats not only in Asia but in the whole world during the recent Asia Pacific Economic Cooperation (APEC) and Association of Southeast Asian Nations (ASEAN) summits in Da Nang and Manila.

The leadership of Task Force Bangon Marawi said IS-linked militants have resumed recruiting members in Mindanao.

"Yes, I think martial law will help in the process of rebuilding Marawi. Everyone involved in the Bangon Marawi would feel safer if the President will exercise his power as commander-in-chief," Roque added.

Presidential Communications Secretary Martin Andanar said any decision on whether to extend martial law or not

would likely be based on the assessment of the security situation by the military and the police.

"I trust the wisdom of the congressmen and the senators," he said.

"At the same time, we also wait for the recommendation of the Armed Forces of the Philippines and the Philippine National Police because based on what the President said last week, he will have to wait for the recommendation of AFP and PNP," Andanar added.

Members of the Senate minority bloc, however, rejected calls for an extension of martial law in Mindanao.

In a statement, the Senate minority bloc said that martial law in Mindanao should be lifted as soon as possible "so that we can all focus on the rehabilitation of the devastated lives and livelihoods of the people of Marawi City and nearby areas.'

Comprising the Senate opposition bloc were Minority Leader Franklin Drilon and Sens. Francis Pangilinan, Paolo Benigno Aquino IV, Risa Hontiveros, Antonio Trillanes IV and Leila de Lima.

"The military itself has declared that Marawi City is already free from the clutches of the terrorist Maute Group so there is no more reason to extend military rule in the region. The reported threat on peace and order could already be addressed by the police," they said.

"Instead of focusing on extending

martial law, the government should train its sights on the quick rehabilitation of Marawi City so our Maranao brothers and sisters can resume their normal lives at the soonest possible time," they added.

They stressed they would support whatever rehabilitation plans the government would unveil for Marawi.

Sen. Sonny Angara said he would like to be briefed by the AFP and Department of National Defense on the actual situation in Marawi and in Mindanao as a whole.

"We know that the threat to replicate this (Marawi siege) is serious so we should be very cautious about 5, 5295 - With Marvin Sy this," he said.

## Commanders back martial law extension in Mindanao

ZAMBOANGA CITY—Because the threat posed by Islamic State-inspired terror groups still hangs like the sword of Damocles over Mindanao, President Duterte is relying on the word of the military to help him decide whether to extend or lift martial law on the island.

Presidential spokesperson Harry Roque on Saturday said Mr. Duterte was only waiting for the recommendation of the Armed Forces of the Philippines so he could make a decision as early as next week.

"I have had prior consultations with the AFP and the recommendation will be submitted (to Malacañang) next week," Roque told reporters in Zamboanga City.

He said the President would base his decision on the military's take on the situation, particularly in Marawi City, which was liberated from Maute and Abu Sayaff terrorists in October, and nearby towns and provinces.

"The President will make a decision next week or the week after because Congress will go on recess on the 15th (of December)," Roque said. "And as you know we cannot have an extension of martial law without the consent of Congress."

A military commander, who spoke to the Inquirer on condition of anonymity, said he and fellow ranking officers in Mindanao backed the extension as it would help them quell rising terror threats in the region.

"It is really up to our [superiors] if they will push for an extension," said the officer. "Many military commanders on the ground are in favor of it."

He said extending martial law would help hasten the rebuilding of Marawi "as the military has full control of the area."

Another officer, Col. Romeo Brawner Jr., deputy commander of Joint Task Group Ranao, said a "higher office" would make the recommendation to the President.

"As far as TF Ranao is concerned, we do not make one," he told the Inquirer by phone.

Brawner, however, said he would support the extension of martial law.

"I support it because it's already working in Marawi. It will be to the advantage of residents because they already feel safe. We have talked to them and they told us that they would feel less safe without martial law.'

Task Force Bangon Marawi chair Eduardo del Rosario also backed continued military rule in Mindanao.

"I would like martial law to continue," said Del Rosario, former commander of the Western OFFICE OF THE ARMY CHIEF heads the Housing and Urban pa.army2012@gmail.com - Tel no. (02 -with A REPORT FROM TITO FIEL IN 1982) Development Council.

"As [task force] chairperson, my main concern is the security of the whole rehabilitation effort, he added during a press briefing in Malacañang last Wednesday.

Roque said the military's recommendation was crucial despite the fact that Marawi had been cleared of terrorists.

"To me, let the AFP decide" because they are on ground," he said.

Presidential 'Communica' tions Secretary Martin Anda B nar said "most, if not the marjority" of ordinary people in Mindanao preferred martial law's second extension.

Andanar said many rest dents were still worried about peace and order in Mindanao, where martial law remains in effect until Dec. 31.

"If you will, as the ordinary people in Mindanao, I can bet that for most, if not the majority, martial law is OK for the improvement of trade," Andanar said over state-run Radyo Pilipinas.

Andanar, who said he is from Cagayan de Oro City and Surigato de Sur province, also preferrel the extension of martial law.

"It's because you really can say what will happen," he said.

Certain groups, however, in sist that the threat has passed and are calling on the President to lift martial law.

In Cagayan de Oro City, Drieza Lininding of the More Consensus Group said the liftings of martial law, specifically ifi Marawi, will hasten the return of affected residents to their homes.

"Martial law was the reasoff" why many civilians fled MaraWi<sup>1</sup> in the early days aside from airstrikes, and it is still the reason why many (people), even in cleared areas, are afraid to rell turn. There will be no trues homecoming unless martial law is lifted," Lininding said.

He said martial rule has "ਰੳਸ prived many of us [of the?] chance] to visit our homes of what remains of it in the MBA [main battle area], while we see VIP and powerful persons being toured around the area. Our [homes have become] a tourist spot for VIP of influential pedA ple, including celebrities."

Lininding also blamed then many cases of abuse allegedly suld) fered by civilians on martial law." (1)

In its postinvestigation report, the nongovernment organi nization Kalinaw Mindanao sard it documented more than 300 cases of human rights violations allegedly perpetrated by soldiers in Marawi at the height of the conflict and even after Mr. Duterte declared the city liberated from the extremists.

Marawi Bishop Edwin dela Peña said he was against the imposition of martial law on the island from the start.

"I also did not favor the extension of martial law and was vocal about it," Dela Peña said.

## No public bidding for Marawi projects

The government will not hold a public bidding for the reconstruction of war-torn Marawi City and will instead accept proposals from developers that would be subjected to a Swiss challenge, according to Task Force Bangon Marawi chair Eduardo del Rosario.

Del Rosario said accepting proposals that would undergo a

Swiss challenge was a faster process than conducting a public bidding.

"This seems to be a much better and faster process instead of bidding. But instead we will go to the mode of Swiss

challenge. It will be like bidding but faster and better," Del Rosario said in a briefing.

Del Rosario said the total comprehensive. rehabilitation and reconstruction plan would be crafted by the National Economic and Development Authority.

The plan would be ready by the last week of March, he said.

Earlier estimates put the cost of reconstruction as high as P90 billion.

According to Del Rosario, what the government has done regarding Marawi was to call on big-time developers, both foreign and national, to submit unsolicited proposals for rebuilding the city. INQ

# Solon: NPA attacks part of plot for RevGov

The supposed antagonism beween President Duterte and gommunist leaders could be part of a "grand scheme" to use insurgent attacks as an excuse to declare a revolutionary government (RevGov), a lawmaker said on Saturday.

"Wittingly or unwittingly the communists could be part of this scheme," said Magdalo Rep. gary Alejano, a former rebel Marine captain, in a statement.

Alejano suggested there might be a connection between Mr. Duterte's increasingly hostility to communist leaders he previously called friends and moves to declare a revolutionary government.

Alejano said Mr. Duterte's seeming antagonism with the communists could result in more

and intensified militant attacks, which would justify a revolutionary government.

"Communist groups have long been waging acts to bring down the democratic government regardless of who the sitting president is, yet President Duterte immediately and comfortably appointed communist allies in the Cabinet and other government high-ranking posts," he said.

Though former Social Wel-

fare Secretary Judy Taguiwalo and Agrarian Reform Secretary Rafael Mariano have been rejected by the Commission on Appointments, some leftists remain in government.

Among them are Labor Undersecretary Joel Maglunsod, National Anti-Poverty Commission Secretary Liza Maza and Presidential Commission for the Urban Poor Chair Terry Ridon.

#### Peace talks

Moreover, Alejano said Mr. Duterte's public pronouncements against the leaders of the Communist Party of the Philippines (CPP), New People's Army (NPA) and National Democratic Front of the Philippines (NDFP) did not jibe with his actions.

"The repeated threats of declaring a revolutionary government by the President, his

continuing relationship with the CPP-NPA-NDFP, and the disjointed and disparate policy against communist rebels are something to be wary about," Alejano said.

Based on the information I received, backdoor negotiations between the peace panels have continued even after President Duterte discredited the importance of pursing peace talks with the communist groups," he said.

"In fact, as a result of these backdoor negotiations, a proposed simultaneous signing of agreements this December between the peace-negotiating panels is being prepared, Alejano said.

He said these agreements include the contentious Comprehensive Agreement on Social and Economic Reforms, a general amnesty to political prisoners, and an Agreement on Coor-

dinated Unilateral Ceasefire.

"Specifically contained in the ceasefire agreement would be a stand-down order to (the Armed Forces of the Philippines) while NPA units remain in their designated zones," Alejano said.

#### 'Puzzling'

"Further, Duterte has not yet transmitted a formal notice of termination of peace talks to the negotiating panels," he added.

Alejano said: "It is puzzling that while President Duterte is lambasting the CPP-NPA in public, backdoor negotiations with the NDFP continue."

"The people and other government institutions, particularly the military, should remain vigilant and critical [of] such machinations meant to violate the Constitution and destroy our democratic government," he said. INQ

## NPA REBELS KILL COP, WOUND 7 IN BICOL AMBUSH

CITY—Suspected LEGAZPI rebels killed a police officer and wounded seven others in an ambush in Labo town in Camarines Norte before dawn on Saturday after the Communist Party of the Philippines (CPP) ordered the New People's Army (NPA) to intensify attacks against state forces.

The attack came days after the rebels suffered at least 15 dead in a clash with Air Force troops and police in Batangas province in the biggest singleday casualty for the NPA since President Duterte ordered the termination of peace talks with the insurgents last month.


The rebels waylaid two police patrol cars traveling through Barangay Daguit on their way from Labo town to Camarines Norte provincial police headquarters in Camp Wenceslao Vinzons in Daet town, said Bicol pólice spokesperson Senior Insp. Maria Luisa Calubaquib.

PO2 Richard Abad, a member of Camarines Norte Police Mobile Force, was killed in the attack at around 1 a.m.

Ronald Wounded were Gutierrez and Ericson De Vera, both with rank of PO2, and Jeffrey Tarrobago, Pedro Valeros, Romar Umandap, Johnson España, and a certain Aguilar all with the rank of PO1.

Communist party founder Jose Maria Sison said in an online interview on Saturday that the intensified attacks against government forces were in retaliation to Mr. Duterte's recent moves against the rebels.

"He [Duterte] has arrogantly announced that he continues on the path of all-out war. The NPA has no choice but to take the initiative and do its best to defeat its enemy in as many

places as possible," Sison said.

In a statement last week, the CPP ordered the NPA to "continue to wage and intensify guerrilla warfare nationwide in order to inflict powerful blows against Duterte's fascist machinery."

Calubaquib said that Chief Supt. Antonio Gardiola Jr., Bicol police chief, ordered all police stations across the region to be on round-the-clock "high alert" after the President declared the cancellation of peace negotiations.

Senior Supt. Cerilo Trilles, acting police provincial director in Camarines Norte, said the police, backed by soldiers, were pursuing the rebels that attacked the police convoy.

Masagca, commander of the pof tagging them as terrorists,

Army's 901st Infantry Brigade, said the military would also conduct more counteroffensives against the NPAs.

In Saturday's interview from Utrecht, the Netherlands. where he has lived in exile since 1987, Sison said, "It is impossible for Duterte to wipe out the CPP, NPA and NDFP (National Democratic Front of the Philippines) by using methods of mass murder."

He said more than 90 percent of CPP members were "secret," adding that to kill one "he [Duterte] will have to kill 100 or even 1,000 suspects."

Sison also claimed that many legal activists were preparing to join the underground revolutionary move-In Albay, Col. Alden Juan ment following Duterte's threat opening them to attacks.

Presidential spokesperson Harry Roque on Saturday said the President's earlier shootto-kill order were for armed rebels, not for noncombatants like members of civil society and religious groups.

Roque also belittled the threat by the NPA to intensify attacks, citing the government's victory over the pro-Islamic State militants in Marawi

"If we have defeated the Isis, how much more [the NPA]? I am not bragging but if the government managed to defeat a [global] terrorist group as Isis, wouldn't they (get defeated too)?" he said. --with REPORTS FROM DELFIN T. MALLARI JR., MICHAEL B. JAUCIAN AND ALLAN NAWAL INQ

# Seagal exhorts, lauds PH troops, backs Rody's battles

ollywood actor Steven Seagal reiterated his support for President Duterte as he expressed that the Chief Executive's battles are winnable, even if the victories may take a long time.

Seagal joined Duterte who visited soldiers stationed at Camp General Teodulfo Bautista in Jolo, Sulu Friday.

When asked by Duterte to speak to the troops, Seagal commended the soldiers for being able to overcome the five-month war against the Daesh-inspired terrorists in Marawi

City, Lanao del Sur.

"I think the main thing we all have to keep in our hearts is we don't win this battle today. We don't win this battle tomorrow. It's gonna be a long fight, but the idea is to annihilate the enemy through attrition," Seagal told the soldiers.

"It's gonna be a long battle, but slowly, day by day, week by week, month by month, year by year, the enemy will get smaller and finally they will be gone to the point where it is absolutely and positively controllable," he added.

He also commended the troops for their commitment to the country, the President, and for their commitment "to do the things you have to do to make the Philippines safe."

"I believe there is a formula that can help the armed forces, the police, the intelligence network to combat this very, very well. I am looking forward to discussing these things with President Duterte at a later time," he added.

"I hope I can be involved with all of you in this war against all of these evil things," he continued.

Seagal has always expressed his admiration for the President, saying

Duterte is a good president and is instrumental in making the Philippines a safer place to live in.

Last October, Duterte met with Seagal in Malacanang as the actor scouted for a location in the country for his upcoming movie.

Upon learning that Seagal's movie is about illegal drugs and other crimes, Duterte reportedly told the 65-year-old celebrity that movies are a reflection of life.

He also reiterated to Seagal his strong stance against illegal drugs as it enslaves people to a form of synthetic chemical.

Seagal, who is in the country for the third time, said he is interested in casting Filipino talents for the show.

The filming will reportedly take place in various parts of the country, including in Vigan City.

# NPA owns up to killing of Cagayan town councilor

A MUNICIPAL councilor of Baggao town in Cagayan province was killed by alleged members of the New People's Army (NPA) who barged into his house on Saturday morning at Barangay Awallan.

Based on a statement released to Bombo Radyo in Tuguegarao City, the NPA's Henry Abraham East Cagayan Command claimed responsibility for the killing of Baggao town councilor Angelo Luis for "being unfriendly to the movement."

In the statement, the NPA said

Luis has been an "undercover agent" who feeds information to the Military Intelligence Group in Gagayan Valley.

Cagayan police said at least 20 NPA rebels wearing Philippine Army uniform entered the house of the victim and shot him dead.

Initial investigation showed that Luis was fatally shot three times in the head, resulting in his immediate death.

The victim's family was still in shock and refused to comment on the allegation made by the

NPA rebels in their statement.

In 2012, Luis filed a case against Vice Mayor Joan Cabildo Dunuan, then an administrative assistant of Baggao local government, for falsifying her daily time record (DTR). Dunuan was removed from the service when the Civil Service Commission (CSC) ordered her dismissed after finding her guilty of serious dishonesty.

Dunuan relinquished her post only on October 30, 2017 when the Department of the Interior and Local Gov-

ernment (DILG) enforced the CSC order.

She said the complaint against her was politically motivated.

Meanwhile, the Philippine Councilors League (PCL) Cagayan Chapter has condemned the murder of Luis.

"We call on the concerned authorities to conduct a thorough investigation on the circumstances surrounding the death of the honorable councilor," PCL head Maila Ting Que said in her Facebook post.

Also an ex-officio member

of Cagayan provincial board and Tuguegarao City councilor, Que said there is a need for the investigation "to eliminate all possible angles amid speculations and pronouncements made by certain groups claiming responsibility."

The provincial government also expressed in the strongest terms its condemnation and called for authorities to conduct a thorough and speedy investigation and bring to the bar of justice those responsible.

Governor Manuel Mamba said

the killing is "disguised as an act of patriotism pursuant to communist ideologies is nothing but plain and simple terrorism.

"Our leaders should not cower in fear or be coerced to submit to the whimsical and capricious demands of these insurgent groups," Mamba added.

"This is also an earnest call on the members of the Cagayano community to support the government's efforts to fight insurgency, especially in our province," he said.

According to them, lifting martial law, as scheduled, would allow authorities to "focus on rehabilitation" in Marawi City and neighboring areas.

"There is no reason to extend military rule in the region. The alleged threats to order and crime can be addressed by police," they added.

Last month, the President declared Marawi City "liberated from terrorists' influence" but the military said the five-month battle against militants loyal to the Islamic State group was not yet over. Pro-IS gunmen occupied parts of Marawi on May 23 following a foiled attempt by security forces to arrest the head of the Islamic State group in Southeast Asia, Isnilon Hapilon.

Mr. Duterte had said Hapilon, who was killed in an offensive alongside Omar Maute, one of two brothers who allied with Hapilon to plot the takeover of the city.

The senators stressed the government should instead focus its efforts on implementing rehabilitation and reconstruction programs.

# AFP LOOKING By Alfred Dalizon FOR FREED REDS

SECURITY forces are now tracking down 21 consultants of the Communist Party of the Philippines-National Democratic Front and other identified supporters of the underground New People's Army following President Duterte's decision to scrap peace talks with the rebels amid their continuing atrocities in the country-side.

Armed Forces of the Philippines (AFF) Public Affairs Office chief Colonel Edgard Arevalo said military intelligence agents are now locating the 21 NDF consultants who were ordered released by the court last year so that they can participate in the peace talks with the Duterte administration.

Arevalo confirmed "ongoing efforts to locate the 21 NDF consultants" although he said that they still have no information on their whereabouts as

of last Friday.

Among the NDF consultants are captured CPP leaders Benito and Wilma Tiamzon who are both facing multiple murder and kidnapping charges before the Manila and Quezon City Regional Trial Courts at the time of their release last year.

Agents want to keep an eye on the NDF consultants since there is still no official court order to place them under arrest.

"Mino-monitor natin, kailangan natin gawin, so that at that time na mayroon nang instruction, may specific order to arrest them, hindinatin saka sila hahanapin, we have to be proactive in our actions," Arevalo explained

Solicitor General Jose Calida last August had said that they have asked concerned courts to cancel the bail bonds posted by the accused and issue warrants for their arrest.

Calida maintained that

the conditional release granted to the jailed NDF consultants by the courts are for the sole purpose of the peace negotiations including backchannel talks.

However, the conditional release is expected to be rendered moot and academic with the presidential decision to end the peace talks with the leftist movement as the government cited "recent tragic and violent incidents all over the country" committed by the NPA.

# President has power up revolutionary

PRESIDENT Rodrigo Duterte is empowered under the Constitution to declare a revolutionary government, Chief Presidential Legal Counsel Salvador Panelo said amid persistent calls for a revolutionary government and growing opposition to it.

Panelo explained that the Constitution states that it is the duty of a sitting President to serve and protect the people "He further explained

that if there is any move that will bring down the government, then the Constitution directs him, instructs him...to do something about it. Declaring a revolutionary government would be one of them," Panelo said.

Panelo also believes that such possible move by the President will be widely supported because he had raised the idea during the May 2016 election period. "Moreover, when he

campaigned during the last stretch, he said that he would declare a revolutionary government, in other words, we voters factored that into (electing him president)," he said.

Panelo also said Duterte is receiving information from intelligence agencies that terrorists and communistrebels are conspiring against the administration.

He however clarified that there is no need for a revolutionary government owing to the relatively peaceful situation prevail-

ing in the country.

Earlier, Duterte said that putting up a revolu-tionary government (RevGov) was a "very ex-treme measure" that he would resort to only if the government was in imminent danger of being toppled.

"If you overstay...I become a dictator? The military will do me in same with what happened in the past," the President said in a speech before an anticorruption summit in

Pasay City. "You overstay and you abuse ...there will always be (coup) attempts that will be done. Or mutiny for

that matter," he added. The President said that establishing a revolutionary government at this time was like "looking for a headache."

"I'd go to RevGov only if the ship of state is about to sink...maybe I'd be forced. That is a very ex-treme measure," Duterte

The President has on multiple occasions said he would declare a revolutionary government, beginning from the campaign trail to the presidential seat in 2016. Last week, Duterte said he will declare a revolutionary government if his critics, particularly the left, continue their acts of "destabilization."

# Palace checking reports Australia aid fund went to Maute

#### By Efren Montano

MALACAÑANG is set to probe reports that aid money from the now-defunct Australian Aid (AusAID) agency was channeled to the Maute terror group.

"We'll look into this allegation that AusAID fund was sent to Maute. This shows that we really need to implement antimoney laundering act because ang nangyari dito, this is a form of laundering na aid money (was) used for terrorism," Presidential spokesperson

Harry Roque said in a press briefing in Zamboanga City yesterday.

In a November 11 report The Weekend Australian said the Australian government may have had unwittingly channeled money to the Maute terror group.

Roque said the government would coordinate with the Anti-Money Laundering Council (AMLC) to investigate the matter.

"I find it hard to believe because Australians are very tough on terrorism too. So I do not know how this can happen to AusAID," Roque said. Terror leader Mohammadkhayam Maute was reportedly contracted to build classrooms, science laboratories and school libraries across the Autonomous Region in Muslim Mindanao (ARMM) in a AU\$12.7-million (P485 million) project funded by the AusAID that ran from 2012 to 2017.

The report said Australian Foreign Minister Julie Bishop had confirmed that the Australian government discovered the Maute link in a project audit in 2015.

It stated that a subcontractor, Habitat for Humanity, had contracted a local firm associated with the Maute family.

The aid agency has folded up and is now under Australia's Department of Foreign Affairs and Trade.

Before the Marawi siege, the wealthy Maute family was known to be engaged in construction and property development in Mindanao, it was learned.

Magdalo Representative Gary Alejano, who belongs to the opposition bloc at the House of Representatives; said soldiers, policemen and those rendering services for the peace and order deserve adjustment in their pay.

However, Alejano is proposing that the indexation of the retirees' pension should also be adjusted.
"I very much welcome and support this develop-

mert. However, I hope that the provision which suspends the indexation of retirees' pension be amended," Alejano said.

"I strongly believe that our retirees and veterans deserve no less but to be included in the said measure,

he added.

The solon said failure to consider the retirees' pension would undermine existing laws which provide that retired military and uniformed personnel receive the same increase in benefits whenever the salaries of those in active duty are upgraded.

The House Committee on Appropriations has ap-

proved a joint resolution which seeks to increase the base pay of military and uniformed personnel (MUP) in the government.

The House panel approved House Joint Resolution No. 18; authorizing the increase in the base pay of military and police personnel, as well as other uniformed government personnel.

The resolution underscored the need to adjust the salary package of the MUP to provide better compensation for the soliders and policemen in performing their role in maintaining national security and peace and order.

The modified Base Pay Schedule will apply to all military personnel under the Department of National Defense and uniformed personnel under the Department of Interior and Local Government, the Philippine Coast Guard, and the National Mapping and Resource Information Authority.

Military and uniformed personnel will also be en-

titled to a fixed hazard pay of P540 per month.

If approved, the modified Base Pay Schedule will be implemented starting January 1, 2018.

### Mindanao martial law extension looms

PRESIDENT Rodrigo Duterte is set to decide next week on the extension of martial law in Mindanao.

Presidential spokesperson Harry Roque said Duterte would submit his decision to Congress before the chamber goes on Christmas break starting December 15

"Inaantay pa rin po natinang rekomendasyon ng Hukbong Sandatahan (We are still awaiting the recommendation of the Armed Forces) and because the national media is here, I have had prior consultations with the Armed Forces (and) the recommendations (will be out) next week," Roque said in a press briefing in Zamboanga City.

"So the President will make a decision if not next week then the week after because Congress will go on recess on the 15th and as you know, we cannot have extension (of) martial law without (the) consent of Congress," Roque said.

The spokesperson said the Armed Forces of the Philippines (AFP) has finished its consultation with stakeholders and would just need to submit its recommendation to the President.

"I didn't want to say it now because mape-preempt 'yung aking (it would preempt my) press briefing sa Lunes (on Monday). And I'm going to read verbatim already what was given to me by

the AFP.

"Mayroon na pong binigay sa aking statement, Monday ko na po babasahin yan (I have received the statement and I will read it on Monday)," he said.

While no final decision has yet been made, Roque said that the martial law extension would ensure the safety of the citizens in Marawi City and nearby areas.

Earlier, Task Force Bangon Marawi chief Eduardo del Rosario backed the extension of martial law up to the rehabilitation phase of the war-torn Marawi City to ensure the continuous reconstruction of the city.

Del Rosario aired his stand following reports of massive recruitment of Islamic State-inspired terror groups.

# Reds assassinate Cagayan councilor

BAGGAO, Cagayan — Twenty suspected members of the New People's Army (NPA) barged into the 'compound of a municipal councilor in Barangay Awallan and peppered him with bullets yesterday morning.

Angelo Luis, who sustained several bullet wounds in the head, died on the spot, according to Chief Inspector Emil Pajarillo, Baggao police chief.

Police said Luis had just arrived

from his farm at around 7 a.m. and was resting alone at his nipa hut inside the compound when the alleged NPA hitmen showed up and opened fire.

The police report did not state whether there were people inside the victim's residence at the time of the attack.

In a letter sent to a local radio station, the NPA in East Cagayan claimed responsibility, saying Luis was an "enemy of the people."

Luis was accused of being an active informer of the Military Intelligence Group (MIG) in Region

# BBL gets determined push

strong argument in favor of the Federalism move would be the removal of the vicious cycle that had tied down both the economy and the political destinies of the nation which is the election every three years.

The economic managers of Rody is now trying to solve the boom and bust cycle that is tied to the election period in which economic growth shoots up right after the polls before hitting a skid the next two years.

The more urgent political goals of Rody such as securing peace in Mindanao, unfortunately, are tied up to that routine.

While elections spending always provides stimuli to the economy, as candidates and the government opens up the financial tap during the campaign period, politicians lose their focus on legislation in every two years of three in favor of the election circus.

Rody, aware of the cycle, had sought from Congress to immediately approve a refined version of the Bangsamoro Basic Law (BBL) that is being relied on to provide lasting solutions to the rebellion problem in Mindanao.

Rody should be credited for building from the work of the previous administration of Noynoy on the BBL instead of coming up with a new proposed law.

The draft BBL of Rody removed the questionable provisions which held down the approval of the bill in the previous administration.

Despite the infirmities, the BBL of Noynoy was the product of long negotiations and consultations with mainly the Moro Islamic Liberation Front.

Rody's negotiating panel supplied the views of other Mindanao groups to give the BBL more representation.

The BBL version under Rody is now more comprehensive considering that it was crafted during the administration of a President who knows Mindanao well.

The five-month Marawi City siege that ended October 23 underlined the urgency of the BBL and later cementing the gains of regional autonomy through the Federalism push of Redy.

Rody said that he may call a special session during the holiday season to speed up the BBL deliberations which have to excruciatingly pass through again the scrutiny of the House and the Senate before a final fine-tuning at the bicameral conference committee.

Recent experiences on the Tax Reform for Acceleration and Inclusion and the budget bills indicate that it would be not be impossible to achieve Rody's aim to get the BBL enacted before the end of the year.

The Train and the budget measures hurdled the second and third readings within a day at the Senate as a result of Rody's endorsements.

Members of the Senate said the most pragmatic expectation is that the BBL will pass before the March recess about which Rody appears not too happy.

Rody knows that the closer the Senate and the House discussions on the crucial but highly contentious bill becomes to the election period, the chance for its enactment becomes more uncertain.

There is another practical consideration for the immediate forming of a Bangsamoro region which is the speeding up of the Marawi City rehabilitation.

A five-year timeframe has been given on the reconstruction of the center of Muslim culture in Mindanao which would put its conclusion beyond the administration of Rody who wanted to see a new Marawi City before he hands over the rein of power.

"What is at stake here is the preservation of the Filipino republic and to correct historical injustice," Rody had said about the BBL.

Duterte said that during the decades when the Philippines was under Spanish and then American colonial rule, the Christian majority had taken control of vast parts of Mindanao, leaving native Muslims and other tribes marginalized.

Rody's determination to provide genuine autonomy to the predominantly Muslim provinces in Mindanao may turn out to be his enduring legacy to the nation.

### Karapatan reports 25 new alleged EJK cases to UN special rapporteurs

From GMA News (Dec 2): Karapatan reports 25 new alleged EJK cases to UN special rapporteurs

Militant human rights group Karapatan submitted on Saturday a letter of allegation concerning 25 cases extrajudicial killings (EJK) to United Nations special rapporteurs Agnes Callamard and Michael Forst.

Karapatan said it had initially informed Callamard, Special Rapporteur on extrajudicial, summary or arbitrary execution and Forst, Special Rapporteur on Human Rights Defenders, of <u>47 alleged EJKs last</u> April.

The group alleged that the EJKs were perpetrated by security forces "in line with [President Rodrigo] Duterte's counter-insurgency program."

"From one counter-insurgency program to another, cases of extrjaudicial killings against peasants, indigenous peoples, Moro, workers, women and youth continue to be committed with impunity under the murderous Duterte regime. Also, most, if not all, of the perpetrators of human rights violations under the administrations of former Presidents Gloria Macapagal-Arroyo and Benigno Simeon "Noynoy" Aquino III have not been brought to justice," said Karapatan secretary general Cristina Palabay said in the group's letter to Callamard and Forst.

Karapatan said that among the victims of the new alleged EJKs was 18-year-old Obello Bay-ao, a member of the Manobo tribe and a students' organization.

It said Bay-ao was walking home one afternoon last September from a day of harvesting corn in Davao del Norte when two gunmen fired at him.

Karapatan said the gunmen were allegedly members of an auxiliary group of the Armed Forces of the Philippines.

The group said all alleged EJK victims were peasants, indigenous peoples, Moro, workers, women and youth.

The group said they asked Callamard and Forst to "consider, investigate, make recommendation/s or take any appropriate action/s" on the allegations.

A part of the letter reads: "We allege that state security forces are primarily responsible for these killings that are all in the context of a government program that makes no distinction between armed and unarmed civilians, thus providing a pretext for the arbitrary tagging of individuals, groups and movements as 'enemies of the state."

<u>Duterte</u>terminated the government's peace talks <u>with the Communist Party of the Philippines-New People's Army-National Democratic Front of the Philippines (CPP-NPA-NDFP).</u>

Duterte also announced that the government will launch a <u>crackdown on supposed legal fronts of the</u> communist group.

The government decried supposed "hostilities" and a "lack of sincerity" from the communists, who in turn <u>blamed Duterte for allegedly botching</u> the two parties' latest attempt at a <u>decades-long quest for</u> reconciliation.

The NPA's countryside revolution is said to be the world's longest-running communist insurgency.

Duterte has also said he would declare the NPA as a terror group.

The President's termination of peace talks earned a nod from the military, which has long accused communist rebels of <u>economic sabotage</u> through alleged destruction of agricultural and mining equipment.

The left, on the other hand, has slammed the military for alleged attacks against farmers, human rights workers, and community and Lumad leaders, among others.
