

LENI: PROBE BUNGLING EVACCINEPROGRA

The Vice President says those responsible for the error in the dengue immunization program should be held accountable as Malacañang vows to go after the people behind the 'public health scam.'

Vice President Leni Robredo on Sunday called on the government to look into the effects of wrongly administered dengue vaccine on the health of hundreds of thousands of schoolchildren in the country and ensure that those who bungled the immunization program would be held liable.

Malacañang vowed to "leave no stone unturned" in the investigation of the fiasco that placed more than 733,000 schoolchildren at risk of severe dengue infection.

Justice Secretary Vitaliano Aguirre II said he would order the National Bureau of Investigation to look into the liability of government officials who had approved the purchase of Dengvaxia vaccine from the French pharmaceutical company Sanofi Pasteur.

The Department of Health (DOH) suspended the P3.5-billion immunization program on Friday, two days after Sanofi Pasteur announced that Dengvaxia could worsen the effects of dengue on people who had not been previously afflicted by the disease.

"This should be seriously studied and those who should be held accountable must be held accountable," Robredo said on her weekly radio program.

What happens to the kids?

The "most important thing," she said, was to "get the answers" to questions about the effects of Dengvaxia on the health of the schoolchildren who had received the vaccine.

"The parents of the children , they need to know what to do. If there really is a bad effect, what can be done to save their children?" Robredo said.

According to the DOH, more than 733,000 public school children aged 9 and above from Metro Manila, Central Luzon

and Calabarzon (Cavite, Laguna, Batangas, Rizal, Quezon) have received at least one dose of the vaccine.

Presidential spokesperson Harry Roque said in a statement that those responsible for the use of Dengvaxia in the government's antidengue drive would be held accountable.

"We will leave no stone unturned in making those responsible for this shameless public health scam, which puts hundreds of thousands of young lives at risk, accountable," Roque said.

He called on the public to stay calm.

"We understand the concern of our people, especially the parents and the relatives of public elementary [school] children residing in [Central Luzon, Calabarzon and Metropolitan Manila], where the dengue vaccination ... initiative launched by the previous administration," he said.

"However, we call on all cit-

that may cause undue alarm," he added

DOH-DepEd monitoring

Roque noted that the DOH had not monitored any case of severe dengue infection among the children who received the vaccine last year.

He said the DOH was working with the Department of Education (DepEd) to monitor the health of the thousands of schoolchildren who had received Dengvaxia.

Aguirre said he had received a complaint from a parent whose son became ill after receiving the vaccine.

"One [parent] complained to me that his son, who was inoculated [with] that antidengue vaccine in April 2016, is now sick [with] baby TB (tuberculosis) and his immune system is now very weak," Aguirre said in a text message to reporters.

He said he would order

the NBI to investigate.

WHO guidelines followed

In a text message to the Inquirer, former Health Secretary Janette Garin said the immunization program was implemented in line with World Health Organization (WHO) guidelines.

The dengue vaccination program was launched during Garin's term.

"Implementation was based recommendations from both local and global experts," Garin said.

She said dengue, which was affecting 90 to 93 percent of the population in the recommended and targeted areas "was [dealt with] as our government's obligation to respond."

On Friday, Health Secretary Francisco Duque announced the suspension of the immunization program after Sanofi Pasteur said Dengvaxia was safe and effective in the long run only for people who had been infected before they were vaccinated.

"For those not previously izens not to spread information infected by dengue virus, however, the analysis found that in the longer term, more cases of severe disease could occur following vaccination upon a subsequent dengue infection," the pharmaceutical company said in a statement.

Duque, however, was quick to ease fears of parents who were worried about their children who had been vaccinated, particularly those who had no prior infection.

He assured them that the DOH was on top of the situation.

"The vaccine has a 30month protection period against dengue, regardless [of whether the child had prior infection or not," he said.

Duque added that the DOH would monitor the health of all the recipients of the vaccine

Review going on

He said a review of the program was going on, including consultation with experts

and the WHO.

The WHO's Strategic Advisory Group of Experts on Immunization will soon meet to discuss the latest development on the dengue vaccine, he said.

Concerns about the effects of Dengvaxia on people without prior infection were raised by resource persons in an inquiry called by the good government committee of the House of Representatives last year.

At a hearing on Nov. 29, 2016, Antonio Dans of the Philippine College of Physicians expressed worry that antibodies introduced by the vaccine might "enhance" the dengue virus if a person is bitten by the mosquito after immunization.

Dans told lawmakers that the immunization program should be suspended until the theory of antibody dependent enhancement was thoroughly studied.

But Sanofi Pasteur's regional dengue expert, Anh Wartel, played down the possibility, saying "the concerns expressed in the background are based upon 'what-if' conjectures."

She said the chance of the scenario unfolding would not be great because the high "seroprevalence"—the number of infected people in a given population—was rather high in the regions where the vaccine was administered.

Undue haste

Besides the vaccine's effects, the House inquiry also tackled the alleged undue haste in the DOH's procurement of Dengvaxia shortly after the May elections in 2016.

The Food and Drug Administration approved the certificate of product registration on Dec. 22, 2015; a month later, on Jan. 21, 2016, the Philippine Children's Medical Center made a purchase request.

The Formulary Executive Council issued a certification for Dengvaxia on Feb. 3, 2016. The certification is a requirement for medical items not included in the Philippine National Drug Formulary.

The immunization program started on April 4, 2016, two months before the Aquino administration ended. INQ

No Christmas truce-AFP

With communist rebels intensifying their attacks on government forces, the military yesterday called anew on the New People's Army (NPA) to "surrender or suffer the same fate as their cohorts killed in the latest military operations."

"While we are hopeful that more NPAs will surrender in the coming days, our troops on the ground will continue with our relentless operations against them who remain active in their violent and destructive criminal activities against our people in the communities," Armed Forces of the Philippines (AFP) Public Affairs Office chief Col. Edgard Arevalo said in a statement.

Arevalo said the military is gaining the upper hand with a total of 264 rebels either killed or apprehended by government forces from February to Novem-

A total of 573 rebels surrendered after President Duterte terminated the peace talks with the communists under Proclamation 360.

Arevalo said the AFP will continue to open its doors for the rebels to surrender amid the intensified military offensive

He said the AFP will likely not observe a holiday truce with the rebels.

Arevalo said Proclamation 360 effectively ruled out a ceasefire with the communist rebels since the peace talks had been cancelled.

Instead of a truce, Arevalo aid the military will continue "relentless conduct of operaion" against the communist ebels, who are expected to ilso intensify their offensive.

The NPA has stepped up ts offensive over the weekand with attacks in Misamis Driental, Camarines Norte and lagayan.

The rebels attacked the police station of Binuangan in Aisamis Oriental yesterday

vounding four police officers. Baggao, Cagayan town Councilor Angelo Luis was hot dead by NPA rebels on aturday while PO2 Richard Abad was killed and six of his olleagues were wounded in in ambush in Labo, Camarines

Norte.

Elsewhere, gun battles between government troops and communist rebels broke out in Sallapadan town in Abra since early Saturday.

There were no immediate reports of casualties or injuries.

The NPA suffered a setback after 14 rebels were killed in a firefight with government forces in Batangas.

The AFP said the military's latest operational success came days after Duterte signed Proclamation 360 terminating the peace talks with the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

"Prior to the President's

actively conducting counterinsurgency operations against the NPA since the peace negotiations broke down in Feb. 4." Arevalo said.

Duterte has cancelled all future peace talks with the communist rebels, blaming the insurgents for deadly attacks against soldiers and police while the NDF, the umbrella organization representing the CPP-NPA, is holding peace negotiations with the government

Duterte has also ordered security forces to shoot communist rebels bearing firearms as he revealed an executive order is being prepared to declare the CPP-NPA-NDF as a terrorist group.

Duterte also threatened to tag all "legal fronts" of the CPP-NPA-NDF as criminals

Presidential spokesman Harry Roque justified Duterte's order to shoot down any armed rebel

NPA: 15 dead in Batangas were ours

The communist-led National Democratic Front of the Philippines (NDFP) and the New People's Army (NPA) in Southern Tagalog hailed the heroism of their 15 comrades who were killed on Tuesday in clashes with government forces in Nasugbu, Batangas province.

"The revolutionary movement in Southern Tagalog salutes the 15 Red fighters and the commander of the New People's Army who were slain by the fascist Armed Forces of the Philippines," Patnubay de Guia, NDFP-Southern Tagalog spokesperson, said in a statement.

The NDFP is the political arm of the Communist Party of the Philippines (CPP), while the NPA is the armed wing of the CPP.

On Nov. 28, military and police forces engaged NPA members in two vehicles in a fire-fight in the adjacent villages of Aga and Kaylaway, along the dimly lit part of the Tagaytay Nasugbu highway.

The military tagged the slain rebels, including student activists, as "full-time" guerrillas.

Call for probe

The Gabriela Women's Party, meanwhile, has called on the Commission on Human Rights to conduct a "thorough and immediate" probe of the firefight that killed 15 people, including two female university students.

Killed in the ambush in Nasugbu, Batangas, were University of the Philippines-Manila biochemistry student

Josephine Anne Lapira, also an officer of the Gabriela Youth-Manila; and former Polytechnic University of the Philippines student Kamil Manangan.

UP student buried

Lapira was buried at Loyola Memorial Park in Marikina on Sunday afternoon. The burial was private and off limits to journalists.

Gabriela denounced the AFP and the Philippine National Police for disclosing the names of those killed without their families' consent, and for releasing Lapira's photo

through the Legal Army Wives Facebook page.

Gabriela also condemned the brutal manner of their deaths and the ill treatment of their bodies. "All their belongings, even the clothes on their bodies, were taken away by the military," it said.

The photos, which showed Lapira's body wrapped in blankets, were contrary to the Army's claim that Lapira had been rushed to the hospital, Gabriela said.

Overkill

"The haphazard handling of the crime scene investigation points to a whitewash, amid initial reports that also point to excessive use of force and overkill on the part of AFP and PNP operatives," the women's group added

De Guia considered the killing of the NPA members, claimed by state forces as their "latest big score" against communist insurgents, a temporary setback

Losing support

"Soon, the revolutionaries of Batangas will gain strength again to take up arms and take the places of our martyred comrades in Nasugbu," De Guia said. But Maj. Gen. Rhoderick Parayno, commander of the Army's 2nd Infantry Division, said the NPA was losing support

"Those valuable reports on the NPA location and activities were often provided by unknown ordinary civilians through phone calls or text messages," Parayno said.

He said civilian communities even in remote areas, the traditional mass base of communist rebels, had been providing vital information to the police and the military.

"This trend indicates that the NPA is now losing the support [of] their so-called mass base," Parayno said.

'Grand scheme'

On Saturday, Magdalo Rep. Gary Alejano expressed suspicion that the supposed antagonism between President Duterte and communist leaders could be part of a "grand scheme" to use insurgent at tacks as an excuse to declare a revolutionary government.

The former rebel Marine captain and ardent Duterte critic said the communist rebels could be a witting or unwitting partner in the President's scheme.

CPP founder Jose Maria, "Joma" Sison in an interview from Utrecht, The Netherlands, belied the observation that the conflict between the communist movement and the Duterte regime was part of the President's plan to proclaim a revolutionary government.

Sison vowed that those who doubt "will witness more fighting to come from the people's army, the mass movement and the broad united front." INQ

GUERRILLAS **ATTACK POLICE** STATION: 4 **OFFICERS HURT**

DAVAO CITY—Communist rebels attacked a police station in Binuangan, Misamis Oriental province, on Sunday, wounding four police officers.

A report from the regional police office in Cagayan de Oro City said around 60 armed men belonging to the New People's Army (NPA) assaulted the police station, wounding SPO1 Ramonito Zambas, PO3 Alberto Bernadas, PO1 Joshua Satur and Senior Insp. Dante Hallazgo The place is 72 kilometers from Cagayan de Oro.

The officers were hit by shrapnel from a 40-millimeter grenade launched from an M203 by the rebels.

The NPA, armed wing of the Communist Party of the Philippines (CPP), has been waging an insurgency for five decades.

The policemen were able to fight back, repelling the rebels and preventing them from getting the firearms in the police

Chief Supt. Timoteo Pacleb, police director for Northern Mindanao, lauded the policemen for successfully defending their station.

NPA warning

In a text message to journalists, the NPA said the attack should serve as a reminder to the police, military and the Duterte administration that the communist movement did not fear President Duterte's threat of an allout war and martial law.

The NPA said the unit responsible for the attack was the East Misamis Oriental Northeastern Bukidnon Subregional Command. It added that the NPA did not suffer any casualties

Maj. Gen. Ronald Villahueva, commander of the 4th Infantry Division, in a statement said the policemen were able to stand their ground because of the timely report from the civilians in the area.

Villanueva said government forces expected more attacks from the NPA after the Duterte administration canceled peace talks with the National Democratic Front of the Philippines, political arm of the CPP

"That is why we have further fortified and alerted all our units," he said. —REPORTS FROM JIGGER J. JERUSALEM AND DIVINA M. SUSON INQ

Abus free 6 Pinoy hostages

ZAMBOANGA CITY – Six Filipino captives including two minors have been released by the Abu Sayyaf bandit group in Patikul, Sulu, the military said yesterday.

The hostages were freed an hour after President Duterte visited Jolo along with American actor and martial arts expert Steven Seagal on Friday Released were Jessie, 53, Marissa, 54, and Jimmy, 21, all surnamed Trinidad; and Lucy, 21, Marciano, 14, and Nelson, 7, all surnamed Hapole.

The six, who were seized from their homes in Barangay Latth, Patikul on Nov. 14, were set free at around 2 p.m. in Sitio Buhawan.

The victims were brought to a hospital for a medical checkup. They will undergo

debriefing before they are allowed to go home, according to Brig. Gen. Cirilito Sobejana, chief of the Joint Task Force Sulu (JTFS).

The military condemned the kidnapping, noting the victims were poor and cannot afford to pay ransom.

Their release brought

down the number of remaining Abu Sayyaf hostages to four Filipinos and seven foreigners.

Meanwhile, a suspected Abu Sayyaf bandit surrendered to the military in Banguingui, Sulu on Friday

Hussin Aranain, alias Friend, yielded to the Army's 54th Engineering Brigade in Barangay Bacaan, Sobejana said.

Aranain, said to be a follower of Abu Sayyaf sub-leader Asbi Misuari, alias Imbo, also surrendered his rifle, magazines and ammunition.

Imbo earlier surrendered to the JTFS.

Abu Sayyaf releases 6 hostages

AMBOANGA CITY - Relentless military operations reportedly forced members of the Abu Sayyaf Group (ASG) in Sulu to release six people they abducted 16 days ago in the village of Anuling, Patikul, Sulu,

Brig. Gen. Cirilito Sobejana, Commander of Joint Task Force Sulu, said yesterday intense military patrol in the forested areas of Sulu led to the release of the victims "unconditionally," or that no ransom payment was made. The hostages were set free 2.p.m. Wednesday.

Sobejana identified the victims as Jessie M. Trinidad, 53; Marissa V. Trinidad, 54; Jimmy V. D. Trinidad, 21; Lucy Hapole, 21; Marciano D. Hapole, 14; and Nelson T. Hapole, 7.

According to Sobejana the victims were released in sitio Buhawan-Buhawan, Barangay Latih, Patikul, Sulu.

Last November 14, the six were forc-

ibly taken by seven armed men wearing bonnet and equipped with high-powered firearms at about 8 p.m. from their respective residences located in Barangay Anuling,

Sobejana said that members of the ASG-Ajang-Ajang group under Roger Samlahon were responsible for their abduction.

The military immediately brought the six released kidnapped victims to JTF-Sulu Hospital in Jolo, Sulu for medical and custodial debriefing. As this developed, another ASG fighter surrendered to JTF-Sulu Friday night in the village of Bacaan in Banguingui, Sulu.

Sobejana identified the surrenderer as Hussin Arain. He also turned over an Armalite rifle with magazines and ammunitions.

Arain surrendered to the JTF-Sulu through the joint efforts of the 54th Engineering Brigade, Philippine Coast Guard district southwestern Mindanao.

6 Abu Sayyaf captives freed after paying ransom

SIX civilians, including two children, were released by the Abu Sayyaf in Patikul town in Sulu on Friday, two weeks after they were abducted.

Brig. Gen. Cirilito Sobejana, commander of the military's Joint-Task-Force Sulu, said the victims gave the Abu Sayyaf P100,000 "for board and lodging," which means ransom.

Released were Nelson Hapole, 7; Marcieno Hapole, 14; Lucy Hapole, 21; Jimmy Trinidad, 21; Jessie Trinidad, 53; and Marissa Trinidad, 54.

Sobejana said the six were released at around 2 p.m. Friday in Sitio Buhawan-Buhawan, Barangay Latih in Patikul town.

Sobejana said the victims are "the poorest of the poor in Jolo. He said they sold their properties "at a very low cost" and their neighbors contributed to raise the money demanded by the Abu Sayyaf.

The six were seized by the Abu

Sayyaf, led by one Roger Samlahon, in Barangay Anuling, Patikul town on November 14.

Sobejana said government forces conducted operations to rescue the victims "but we cannot control everything."

The Abu Sayyaf is holding 13 foreign and Filipino kidnap victims in Sulu, including Dutch wildlife photographer Elwood Horn who was abducted from Tawi-Tawi in February 2012.

ASG releases six kidnap victims

THE Abu Sayyaf Group has released six of its hostages over the weekend in Patikul, Sulu.

Joint Task Force Sulu chief Brig. Gen. Cirilito Sobejana identified the released victims as Jessie Trinidad, 53; Marissa Trinidad, 54; Jimmy Trinidad, 21; Lucy Hapole, 21; Marciano Hapole, 14; and Nelson Hapole, 7—all residents of Kalimayahan Village, Barangay Latih in Patikul.

Sobejana said the victims were abducted by ASG bandits led by a certain Roger Samlahon on Nov. 14.

Last week, Abu Sayyaf member wanted for bombing a public terminal in Kidapawan City in 2007 was arrested in a joint military and police operation in Basilan.

Rahim Abdul alias Aman Kabalu was nabbed in Kampurnah village in Isabela City. He is listed under the Department of National Defense/Department of the Interior and Local Government joint order of rewards with a bounty of P1.3 million.

Joint Task Force Basilan commander Brig. Gen. Juvymax Uy said Abdul was identified by a civilian and that led to his arrest.

NOLCOM officials said the killing of Luis in his very own home only reflects the real intention of the NPA which is to sow terror and instill fear in the civilian community, which they said is a trademark of terrorists.

The 56-year-old councilor, known among townfolk as "Buridik," was resting inside his nipa hut at 7:10 a.m. when about 20 armed guerrillas arrived and shot him with M16 and M14 rifles.

According to the victim's neighbor, about 17 NPA guerrillas were seen to have entered the victim's house. Four other armed guerrillas were standing guard in front of his house while six others were on the lookout in Zone 5 of the same barangay.

After the killing, the band of gunmen headed to Sitio Kagurongan of Barangay Awallan and scattered propaganda leaflets on their path.

The NPA's Henry Abraham Command (HAC) later sent a letter to a local radio station to own up to the murder. The letter read on air, stated that the HAC "punished Luis as an enemy of the people," citing his alleged spying for the Military Intelligence Group (MIG) in Region 2.

Last month, President Rodrigo Duterte officially terminated the peace negotiations with the communists by signing Proclamation 360.

The military immediately vowed to go "all out" against NPA members attacking civilians and government forces in the countryside.

In September, Duterte threatened to crush the communist movement but CPP founding chairman Jose Maria Sison downplayed the warning.

"[Duterte] cannot ground the Left to dust. The CPP is

not the PKI (Indonesian Communist Party) of [leader Dipa Nusantra Aidit], compeletely exposed to enemy intelligence agencies in the course of electoral politics," Sison said in an interview, the transcript of which was posted on his Facebook account.

"The advantage of the CPP is that more than 90 percent of its cadres and members are not known to the enemy. Just to kill one real communist, the enemy has to kill 100 to 1,000 non-communists," he added.

Attacks expected

Arevalo said the recent series of attacks perpetrated by the NPA in the provinces was expected because of the cancellation of the peace talks.

"Those (attacks) were meant to make up for the tactical defeats they have experienced in view of the intensified focused military operations," he said in a statement.

He cited last week's encounter in Nasugbu, Batangas between government security forces and communist fighters that

resulted in the killing of 15 NPA rebels, including a former biochemistry student from the University of the Philippines, and the wounding of one rebel and five soldiers.

Sison called on independent human rights organizations and the Commission on Human Rights to investigate the incident, claiming those killed were civilians.

Arevalo said as of November this year, at least 119 NPA members have been neutralized -while a total of 62 firearms were seized from the rebels.

On Sunday, suspected NPA rebels attacked a municipal police station in Binuangan, Misamis Oriental, leaving four policemen injured

Maj. Gen. Ronald Villanueva, commander of the 4th Infantry Division, said the military is bracing for more attacks.

"Again, the CPP-NPA-NDF will attract local and foreign organizations to shield their leadership from being captured by security forces," Villanueva said

"With this prevailing situation, government forces are also monitoring all the actions of the possible conspirators who will provide aide or support to this terrorist organization," he added. DEMPSEY REYES

AFP to NPA rebels: Surrender or die

The Armed Forces of the Philippines (AFP) challenged New People's Army (NPA) rebels yesterday saying that their only option is to surrender or suffer the same fate of their cohorts who were recently killed in military operations.

"While we are hopeful that more NPAs will surrender in the coming days, our troops on the ground will continue with our relentless operations against them who remain active in their violent and destructive criminal activities against our people in the communities," AFP public affairs chief Col. Edgard Arevalo said in a statement.

Arevalo issued the statement in the aftermath of the death of 14 NPA members in a clash with police and troops from the Philippine Air Force's 730th Combat Group in Nasugbu, Batangas last Tuesday.

Among those killed were the secretary of NPA Guerilla Unit ਤੇ and one plateon leader while two other fighters were wounded.

Government troops also

seized 12 high-powered firearms from the encounter site.

Five soldiers, meanwhile. suffered minor injuries but are now in stable condition.

Last November 23, President Duterte signed Proclamation 360 which ended peace negotiations between the government and the Communist Party of the Philippines-New Army-National People's Democratic Front (CPP-NPA-NDF).

"Prior to the President's proclamation, we have been actively conducting counterinsurgency operations against the NPA since the peace negotiations broke down in February 4," Arevalo said.

In November alone, the military was able to neutralize 119 NPAs. Of this, 21 were killed in operations, 29 were apprehended, and 69 voluntarily surrendered, he said.

Government troops also retrieved 62 high-powered and low-powered firearms from the rebels in the past month.

With this, the AFP said it is bracing for more NPA atrocities,

primarily in the nature of economic sabotage.

"These violent activities by the NPA seek to falsely project that they are still a force to reckon. There is an ostensible leadership vacuum caused by the death of ranking NPA members in the past months resulting to the decreasing capability of the rebel group," Arevalo said.

As of November, the AFP recorded 47 NPA-initiated atrocities that include harassment and ambush of military troops, and kidnapping of civilians.

Reds launch offensives

The NPA is believed to be on a desperate rampage after it attacked a police station in Misamis. Oriental that wounded four policemen, including an officer, and liquidated a town councilor in Cagayan last Saturday.

Reports reaching Camp Crame showed that about 100 NPA rebels attacked the Binuangan Municipal Police Station (MPS) at around 3:15 a.m. by firing rifle grenades.

The attack resulted in the wounding of Senior Ins. Dante Hallazgo, SP01 Ramonito Zambas, P03 Alberto Bernadas and P01 Joshua Satur. They sustained shrapnel wounds.

Reports showed that only 10 policemen were at the station during the attack but held their ground and prevented the NPAs from overrunning the police post.

Chief Supt. Timoteo Pacleb, director of Police Regional Office 10 (PRO-10), commended the Binuangan MPS personnel for defending their station despite being outnumbered.

Pacleb directed all police units under PRO-10 to continue intensifying security measures and target hardening efforts to thwart any attempt by the communists to launch atrocities.

In Cagayan, a councilor in Baggao town was killed by NPA rebels on Saturday.

Lt. Col. Isagani Nato, public information officer of the Northern Luzon Command (Nolcom), said that Angelo Luis, 56, was murdered by the communists right inside his residence in Barangay Awallan.

The NPAs also carted away four firearms from the councilor's home.

Nato said that the victim's neighbors reported that around 17 NPA rebels swooped down at Luis' residence while the others acted as look out from the outside and some even established checkpoint leading to the house.

The witnesses claimed that the rebels even waited for Luis to arrive at his residence from his farm in nearby Barangay Lasilat.

"Upon the victim's arrival, four armed NPAs forcibly entered his house, fired at him several times causing his instantaneous death," Nato said, citing witnesses' accounts.

"After the killing, the NPA criminal group immediately headed towards Sitio Kagurongan of Barangay Awallan. The terrorists also scattered leaflets along their route of withdrawal," he added.

The latest NPA atrocities came a week after President Duterte

ordered the cancellation of the peace negotiations between the government and the Communist Party of the Philippines-National Democratic Front (CPP-NDF), the political wing of the NPA.

Duterte also announced he intends to declare NPA as a terrorist group.

Bomb expert cedes

An NPA bomb expert also surrendered to the Army in Compostela Valley province.

Lt. Col. Esteveyn Ducusin, commander of the Army's 71st Infantry Battalion (IB), identified the surrenderee as Jomar Madalo Antolin, alias Raffy, an active member of the NPA's Guerrilla Front 2, Southern Mindanao Regional Party Committee.

Ducusin said that Antolin operated in Compostela Valley province, particularly in Maco town.

"He is an organizer in Maco for seven years and a known bomb expert," said Ducusin.

Antolin was tagged in several encounters between NPA rebels and government forces in Compostela Valley.

The military is urging other NPA rebels to just lay down their arms and surrender after President Duterte cancelled the peace talks.

In the month of November alone, the AFP was able to neutralize 119 NPAs.

Of this, 21 were killed in operations, 29 were apprehended, and 69 voluntarily surrendered.

Military urges NPA to yield

The Armed Forces of the Philippines has called on members of the New People's Army to surrender or be killed in military operations nationwide.

AFP Public Affairs Office chief Marine Col. Edgard Arevalo said they are hopeful that more NPAs will surrender in the coming days.

However, he said, troops on the ground will continue their relentless operations against them to curtail their violent and destructive criminal activities.

Late last month, the Philippine Air Force 730th Combat Group and the police killed 14 NPA members, including the secretary of the NPA Guerilla Unit 3 and a platoon leader, in an encounter in Nasugbu, Batangas.

Two communists were wounded in the encounter and government troops recovered 12 high-powered firearms from the NPA. Five soldiers on the other hand suffered minor injuries but are now in stable condition.

The encounter occurred days after President Duterte signed Presidential Proclamation No. 360 terminating the peace negotiations between the government and the

Communist Party of the Philippines-NPA-National Democratic Front.

AFP studying lease of Camp Aguinaldo

ARMED Forces chief Gen. Rey Leonardo Guerrero has ordered a study on the possible lease out of Camp Aguinaldo, the military's general headquarters in Quezon City, and other military camps to raise funds for soldiers.

AFP public affairs chief Col. Edgard Arevalo said the study would consider the strategic value of these camps.

The lease was broached by President Duterte last month.

The deed of donation for Camp Aguinaldo and the adjacent Camp Crame, the headquarters of the Philippine National Police, states that the property should be returned to original owners if the government will sell or use it for other purposes. The land of the two camps was donated by the Ortigas family during the Commonwealth, solely for military use.

Duterte, during a visit to the Army's Special Operations Command in Fort Magsaysay, Nueva Ecija on November 22, said leasing out Camp Aguinaldo would raise billions of pesos for the soldiers. He also earlier raised the idea of leasing out the Army headquarters in Fort Bonifacio in Taguig City, and idle lands inside military camps throughout the country.

"We understand what the President said and his intention why he mentioned that recommendation. That's why the chief of staff has ordered to study this particular proposal or idea of the President," said Arevalo.

Arevalo said the AFP chief ordered the study so that the military can "strike a good balance between commercial value and strategic value" of these camps.

A security official, speaking on condition of anonymity, said leasing Camp Aguinaldo is a "thorny issue," noting that a large part of the camp was donated by the Ortigas family solely for the use of the Armed Forces.

"It's a complicated issue. That's a thorny issue because there is a clause in the (donation) contract that it shall be for the use of the Armed Forces of the Philippines," the source said.

"So it might not be possible to sell or lease. It is of my opinion that if it is not going to be used by the Armed Forces, we have to return the donated land to them. Leasing the camp will have some legal implications," he also said.

The previous administration also considered leasing part of the 178-hectare Camp Aguinaldo to raise funds for the modernization of the Armed Forces. The plan was, however, overtaken by events.

In 2011, then Defense Secretary Voltaire Gazmin said technical working groups were looking into legal issues that may arise from leasing out the military installations.

The Ramos administration has sold military lands, also supposedly for the benefit of soldiers and policemen. Republic Act 7227, or the Bases Conversion and Development Act of 1992, paved the way for the privatization of Fort Bonifacio and Villamor Air Base and military installations in Subic and Clark. Questions have been raised as to whether government has followed the allotment scheme for proceeds of the sale.

The relevance of the Communist Party of the Philippines

HE government's renewed offensive against the New People's Army is a welcome development and an appropriate response to the latter's numerous attacks across the country, but 15 killed on the enemy side in a single operation is still shocking. The clash was obviously unusually fierce and desperate.

In my own experience – limited as it may be – with the Philippine Army, capturing the enemy alive, including making sure that medical assistance is extended to the wounded, seems to be preferable to killing the enemy. Not only isn't there much glory in killing some poor farmer or lumad, however armed and dangerous he may be, death leaves scars that may never heal. A killed enemy might also become a martyr, in whom the family takes pride.

President Rodrigo Duterte re-



cently canceled the peace talks with the communists, thus, officially completing his turnaround from having given them a seat at the high table after the elections. A few are still holding out, with former Gabriela Representative Liza Masa, head of the National Anti-Poverty Commission, the most prominent. However, she is reportedly marginalized in the Cabinet and not being invited to meetings. This is such a different situation from last year when the communists headed the Departments of Agrarian Reform and Social Welfare and Development, and with other comrades

appointed as undersecretaries and commissioners.

It was the accidental killing of an infant by the NPA during an ambush in Talalak, Bukidnon that triggered Mr. Duterte's tagging of the NPA as terrorists and calling off the peace talks officially. The NPA took responsibility for the death of the infant and apologized. On October 3, an NPA ambush on a police patrol car in Cauayan, Negros Occidental, resulted in the wounding of three civilians, whose vehicle just happened to be traversing the same road as the police vehicle.

Is this sufficient reason why the NPAs should be labeled as terrorists? Personally, I see nothing new in what the NPA is doing. Yes, they have stepped up their attacks across the country. But the attacks themselves – ambushing police, liquidating soldiers, military assets and

former NPA members, extorting and raiding companies, destroying property – are old news. That is what the NPAs have been doing for decades. The modus operandi of the NPA has not changed fundamentally over the years – neither has the overall goal of the Communist Party of the Philippines: The communist revolution, the seizing of political power and the advent of a socialist Philippines remain the goals of the CPP. If the NPA is a terrorist organization today, so it was yesterday and last year.

The CPP and its armed wing and all their members and supporters have been consistent throughout the years. They grabbed the opportunity offered by Mr. Duterte when he invited them to be part of the government, no conditions asked. Unlike our mainstream politicians, the communists remain loyal to their

political party and its ideology. They might enjoy the perks that come with the positions, but they don't lose sight of their ultimate goal, the great communist revolution. This keeps them going.

While most of us might have focused on the end of armed conflict as the main objective and positive outcome of a peace agreement, for the communists it is the Comprehensive Agreement on Social and Economic Reforms (CASER). It is – or was – only upon the signing by both parties of the CASER that a joint ceasefire agreement would materialize. The communists' demands under the CASER included the national – as opposed to private sector-led industrialization, and distribution of land for free to farmers, to mention some of the points

The peace talks also involved political and constitutional reforms. What these contained in detail I do not know, but isn't it the will of the sovereign people as exercised during general elections, that would determine the nature of any political and constitutional reforms, if any? What makes the Communist Party so special that it, in exchange for stopping its armed attacks, would be granted major political concessions? In the 2016 election, while winning seats under the party-list system, the communists could not garner enough popular support to have their lone senatorial candidate elected. Obviously, a majority of the voters are not in favor of communism. Waging an armed struggle might have earned the CPP the government's attention, but not the public's approval.

Yes, there is too much poverty, injustice, corruption and violence in the Philippines, much of which is the result of structural defects of the country's socio-economic and political systems. Simply bringing in foreign investors to create more jobs and business opportunities is likely insufficient to alleviate poverty. But national industrialization? We are in the 3rd millennium, with the fates of nation states being shaped by climate change and information technology rather than steel production and national patrimony.

Surrender or suffer the consequences, AFP urges Reds

MANILA – The Armed Forces of the Philippines (AFP) on Sunday urged New People's Army (NPA) rebels to surrender or suffer the same fate of their cohorts who were killed in military operations.

"While we are hopeful that more NPAs will surrender in the coming days, our troops on the ground will continue with our relentless operations against them who remain active in their violent and destructive criminal activities against our people in the communities," AFP public affairs chief Col. Edgard Arevalo said in a statement.

This comes after the death of 14 NPA members in a clash with police and troops from the Philippine Air Force's 730th Combat Group in Nasugbu, Batangas on Tuesday.

Among those killed were the secretary of NPA Guerilla Unit 3 and one platoon leader while two other fighters were wounded.

Government troops also seized 12 high-powered firearms from the encounter site.

Five soldiers, meanwhile, suffered minor injuries but are now in stable condition.

Last November 23, President Rodrigo Duterte signed Proclamation No. 360 which scrapped peace negotiations between the government and the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

"Prior to the President's proclamation, we have been actively conducting counterinsurgency operations against the NPA since the peace negotiations broke down in February 4," Arevalo said.

In November alone, the military was able to neutralize 119 NPAs. Of this, 21 were killed in operations, 29 were apprehended, and 69 voluntarily surrendered.

Government troops also gained 62 high-powered and low-powered firearms from the rebels in the past month.

With this, the AFP said it is bracing for more NPA atrocities, primarily in the nature of economic sabotage.

"These violent activities by the NPA seek to falsely project that they are still a force to reckon. There is an ostensible leadership vacuum caused by the death of ranking NPA members in the past months resulting to the decreasing capability of the rebel group," Arevalo said.

As of November, the AFP recorded 47 NPA-initiated atrocities that include harassment and ambush of military troops, and kidnapping of civilians. (PNA)

Cagayan guv condemns killing of Baggao councilor

TUGUEGARAO CITY -- Cagayan Governor Manuel N. Mamba on Sunday condemned the killing of Sangguniang Bayan (SB) member Angelo "Buridek" Luis of the municipality of Baggao by New People's Army (NPA) rebels.

Mamba said the killing was disguised as an act of patriotism pursuant to communist ideologies and is nothing but plain and simple terrorism.

"Our leaders should not cower in fear or be coerced to submit to the whimsical and capricious demands of these insurgent groups," Mamba said in a statement.

"We share the grief of the family of SB Buridik, offering them our condolences and prayers for the eternal repose of his soul and for comfort in their bereavement," he added.

The governor called on authorities to conduct a thorough and speedy investigation to bring the perpetrators to justiice.

He also urged Cagayanos to support the government's efforts to fight insurgency in the province.

Luis was killed by the NPA's Henry Abraham Command in East Cagayan in his home at Barangay Awallan, Baggao at 7 a.m. Saturday.

Investigation is still ongoing to determine the motive of the killing.

Lt. Col. Isagani Nato, Northern Luzon Command spokesperson, said the suspects, whom witnesses said are 30 in number, reportedly belong to the NPA's Abraham Command operating in Eastern Cagayan.

Reports said four of the rebels forcibly made their way inside Luis' house and shot him dead while the others positioned themselves strategically to avoid being surprised by security troops.

The NPA members also carted away four firearms belonging to the Luis family before fleeing towards the direction of Sitio Kagurongan where they scattered propaganda leaflets. (PNA)

CAMP GEN SERVILLANO AQUINO, Tarlac City (DWDD) — A municipal councilor in Baggao, Cagayan was brutally murdered by the terrorist group New People's Army at 7:00 in the morning of December 2, 2017.
