

## Palace cites Human Security Act, fierce clashes mark proclamation

THE government has officially declared the Communist Party of the Philippines-New People's Army a terrorist organization following the collapse of peace talks between the government and the rebels.

Presidential Proclamation, tion following the collapse coincided with reports on intensified anti-insurgency operations by the military against the NPA which sparked renewed fierce clashes leaving at least eight rebels, including a pastor and two soldiers dead in Luzon and Mindanao Sunday and Monday, security authorities said.

A Malacañang statement said President Rodrigo Duterte had declared the Communist Party of the Philippines-New People's

The declaration, via a Army a terrorist organizaof peace talks between the government and the communist rebels.

> According to Secretary Jesus Dureza of the Office of the Presidential Adviser on the Peace Process, the next step is for Secretary of Justice Vitaliano Aguirre II to file a petition for "proscription" in court under the provisions of the Human Security Act for a judicial affirmation.

An existing law-Sec 17 of RA 9372, or "Proscription of Terrorist Organizations,

Association, or Group of Persons"-says "any organization, association, or group of persons organized for the purpose of engaging in terrorism, or which, although not organized for that purpose, actually uses the acts to terrorize mentioned in this Act or to sow and create a condition of widespread and extraordinary fear and panic among the populace in order to coerce the government to give in to an unlawful demand shall, upon application of the Department of Justice before a competent Regional Trial Court, with due notice and opportunity to be heard given to the organization, association, or group of persons concerned, be declared as a terrorist and outlawed organization, association, or group of persons by the said Regional Trial Court."

Duterte's signing of the proclamation declaring the rebels a terrorist group in accordance with the Human Security Act and international laws...

In a statement, Lorenzana said: "We have long since maintained that the CPP-NPA is a blight to the Filipino people, with its members engaging in constant criminal activities and wanton acts of terror.

"The government has walked the extra mile to accommodate them by resuming the talks. But they have imposed unreasonable conditions and continued their criminal acts such as kidnappings, attacks on the military and the police, destruction of property, and extortion.

"Clearly their aim is not the welfare of the Filipino but the pursuit of their selfish agenda. Henceforth, they will be called Communist Terrorists."

Lorenzana added: "We enjoin the Filipino people to work closely with the military, police and local officials to safeguard our communities from the violence, treachery, and opportunism that the CPP-NPA are known for."

AEP spokesman Maj. Gen Restituto. Padilla also issued a statement: "The

Commander-in-Chief's proclamation declaring the CPP-NPA as a ferrorist organization is a consequence of the end of formal peace talks.

"The government has done all it could to attain a much sought after just and sustainable peace throughout our country. Despite the numerous show of smeerity and compromises of the Government, it is apparent that the CPP-NPA-NDF never aspired for peace but merely used it as an opportunity to fulfill it's selfish ends.

"This proclamation clearly classifies and labels the group for what they really are and will simplify military and law enforcement operations as efforts against lawless elements and enemies of the state. "This will certainly ensure that the AFP can now fully execute and perform its mandate without reservation and restrictions.

Thaving said that, the AFP's Focused Military Operations will now become even more precise, simple and effective. We can now address without any hesitation and with all the means and resources available to us the increasing criminal and economic sabotage activities of these terrorists.

The heavy death toll incurred by the NPA occurred at the tri-boundary of

Sultan Kudarat and South Cotabato after army troops seized a large guerrilla base, killing seven rebels and wounding two others.

Lt. Col. Harold Cabunoc, commander of the Army's 33rd Infantry Battalion, said among the rebels kided who were confirmed by Datu Dandee Denian, a tribal leader from fulale village, were Datu Victor Denian and two of the latter's sons while the wounded were Jeffrey Denian, 18.

At the height of the intense fighting, 10 rebels of Platoon Arado of Guerrillas Front 73, who were a kilometer away from the seized NPA camp and scene of fighting, forced to surrender to the military.

Cabunoc said the fighting crupted after NPA terrorists engaged the troops of the 27th Infantry Battalion near a rebel enclave in Sitio Datal Bonglangon, Ned village, Lake Sebu in South Cotabato, resulting in two soldiers dead and seven rebels dead.

Recovered at the scene of fighting were two firearms and subversive documents, while the military arranged a tribal burial rite for the dead rebels who were from the Dulangan Monobo tribe.

In Oriental Mindoro, a member of the Kings Glory Ministry in Brgy. Don

Pedro, Mansalay, whom the military claimed was a member of the NPA, was killed in an encounter with army troops at Sitio Bait, Panaytayan town.

Brig. Gen. Antonio Parlade, Commander of the 203rd Infantry Brigade, identified the slain pastor as Jovelito Quinones, 57.

Quinones was in the company of seven motorcycle-riding comrades traversing the national highway of Panaytayan town when chanced upon by troops conducting combat patrol at about 1:55 p.m.

An exchange of guntire ensued between the group of Quinones and the troops, killing the pastor on the spot while his companions escaped

"It's a legitimate encounter—based on our intelligence operations. He is an active NPA member," Parlade said.

Clashes also erupted in Ilocos Sur and Abra between NPA rebels and army troops wounding undetermined insurgents.

So far, the series of an intensified military operations against the NPAs in two weeks of fighting across the country bring to 25 rebels dead and dozens of wounded after Duterte ter-vinitated peace talks with the communist party.

## Duterte declares NPAterrorist organization

Mindanao clashes leave 7 rebels, 2 soldiers dead

President Duterte yester-day signed a proclamation classifying the Communist Party of the Philippines (CPP) and its armed wing the New People's Army (NPA) as terrorist groups following the cancellation of peace talks.

Presidential spokesman Harry Roque said the declaration was made "in view of the violent acts of the CPP-NPA, which sow and create a condition of widespread and extraordinary fear and panic among the populace."

"As the President has stated before, he has finally classified the CPP-NPA as a terrorist organization within the purview of the Human Security Act," Roque said

The President's order also allows the state to go after groups or individuals who are wittingly or unwittingly supporting the CPP-NPA.

Roque explained that under the Human Security Act, any

person or entity is designated as terrorist if they finance terrorism or a terrorist group under an applicable resolution of the United Nations Security Council or jurisdiction or supranational jurisdiction.

"Take note that the domestic statute and the UN Security Council prohibit the giving of funds to terrorist organizations," Roque said. "This will enable law enforcement agencies to run after individuals who will, in any way, provide financial support to the NPA now that it has been described as a terrorist organization."

#### **Duterte blames CPP**

Duterte blamed the communists anew for the collapse of the peace talks, saying they want him to "share" the Philippines' sovereignty.

"They want to have a coalition government. I told them, 'I cannot give you that which I do not own.' That is sovereignty, exercise of sovereignty," Duterte told overseas Filipino workers yesterday in Malacañang.

Duterte said under the Constitution, only people who are elected by the people can handle sovereignty.

"So I cannot share with you any of the powers of the presidency because it is not mine to give," he said.

Duterte also ordered Justice Secretary Vitalliano Aguirre II to file the necessary application for the proscription or declaration of the CPP-NPA as a terrorist group with the appropriate regional trial court (RTC).

"They have been proclaimed by the President and that has effect already because, of course, we don't talk peace with terrorists now. But for the purposes of Human Security Act, the RTC must rule

that pursuant to the government petition that the CPP-NPA is in fact a terrorist

organization," Roque said.

Duterte also directed the Department of Foreign Affairs to publish the designation of CPP-NPA in accordance with the Human Security Act.

The US designated the CPP-NPA as a foreign terrorist organization on Aug.

9, 2002.

#### Military to be 'relentless'

The Armed Forces of the Philippines (AFP) supports the proclamation classify-

ing the CPP-NPA as terrorists.
"This will certainly ensure that the AFP can now fully execute and perform its mandate without reservation and restrictions," said Maj. Gen. Restituto Paidlla, AFP spokesman.

"The chief of staff, Gen. Rey Leonardo Guerrero, has reiterated his guidance to the troops to never let their guard down and be relentless in pursuing the enemy that has been the source of so much suffering of our marginal citizens in the countryside.

"This proclamation clearly clarifies and labels the group for what they really are and will simplify military and law enforcement operations in our efforts against lawless elements and enemies of

the state," he added.

Defense Secretary Delfin Lorenzana also expressed support for the proclama-

#### 9 killed in new clash

Before Duterte signed the proclamation declaring the NPA as terrorists, seven

communist rebels and two soldiers were killed in gunfights at the border of South Cotabato and Sultan Kudarat provinces

The series of encounters involved NPA guerrillas and combined personnel of the Army's 33rd and 27th Infantry Battalion under the 6th and 10th Infantry Divisions, respectively.

Two soldiers of the 27th IB were killed

in the hostilities.

The running gunfights at the boundary of Lake Sebu in South Cotabato and Bagumbayan, Sultan Kudarat also resulted in the capture of wounded rebel Jeffrey Denian.

Three other NPAs carrying the injured Denian from the scene - Armando Barot, Jack Tatao and Bert Lawud – were cornered by soldiers and detained by the Bagumbayan municipal police.

Sources from the Bagumbayan and Lake Sebu municipal peace and order councils said seven NPA rebels perished in the skirmishes, two of them adolescents.

Villagers also reported seeing three wounded NPA members, identified only as Lito, Roman and Eddie, being carried away by their fleeing comrades.

Lt. Col. Harold Cabunoc of the 33rd IB said they treated the gunshot wounds of Denian before he was turned over to the

Bagumbayan municipal police.

The rebels scampered away when they ran out of ammunition, leaving behind a .30 caliber Carbine, a 9-millimeter Ingram machine pistol and four 12 gauge shotguns.

Local officials in Bagumbayan said 10 NPA rebels yielded peacefully to the 33rd IB about three hours after the skir-

The 10 rebels, who belong to the NPA's Guerilla Front 73, surrendered to Cabunoc in the presence of a Manobo tribal elder,

datu Tony Paan, and barangay officials.

Senior Supt. Raul Supiter, director of the Sultan Kudarat provincial police, said 87 families residing around the scene of the NPA-Army encounter evacuated to safer barangays in Bagumbayan.

Supiter said government relief workers from South Cotabato province are now attending to the displaced villagers.

Meanwhile, the Commission on Human Rights (CHR) said it is investigating the deadly clash between the military and members of the NPA in Nasugbu, Batangas on Nov. 28.

Fifteen people, including University of the Philippines student Josephine Lapira,

were killed in the encounter.

CHR spokesperson Jacqueline de Guia said their regional office in Southern Tagalog has started an investigation on the encounter even before groups called for the human rights body to look into the incident.

"Even prior to calls for investigation the CHR Region 4A has taken cognizance of the case motu proprio or through its owr

initiative," De Guia said.

"We shall determine if the rules of en gagement have been strictly followed, she added:

Women's group Gabriela called for an independent investigation of the incident noting the supposed haphazard handling of the crime scene investigation and the possible use of excessive force by govern ment forces.

"Results of the investigation can b instrumental in filing cases of violation of human rights and international hu manitarian law against culpable Philip pine National Police and Armed Force of the Philippines units," the group saic

## Military exhume 2 dead NPAs from shallow graves

CAMP BANCASI, Butuan City

- Two bodies, believed to have
been hastily buried just three feet
below ground by their New People's Army (NPA) comrades, have
been exhumed by the military
with the help of local residents in
Nasipit, Agusan del Norte, it was
reported on Tuesday.

Capt. Al Anthony B. Pueblas, Civil-Military Operations (CMO) officer of the Army's 402nd Infantry (Stingers) Brigade told The Manila Bulletin that the remains of Reynel Jhon Agoncillo of Barangay Lower Olave, Buenavista, Agusan del Norte, and a Jemar A. Martinez of Barangay Marbon, Talacogon, Agusan del Sur were dug up in Kilometer 9, Sitio Hinandayan, Barangay Camagong, Nasipit, Agusan del Norte.

"The NPAs hurriedly left their dead comrades and buried them like animals along a creek in Barangay Camagong, Nasipit town," Pueblas said.

According to him, one of the

local residents said NPA rebels informed them that they had already buried their comrades along the creek.

Last November 19, 2017, a 15-minute gun battle broke out between forces of the 23rd Infantry Battallion (23rd IB) and the insurgents that resulted in the death of the two rebels, he said.

Agoncillo and Martinez, both 22, were said to be regular members of the guerilla-Front Committee 4-A of the CPP-NPA North Central Mindanao Regional Committee.

The remains were positively identified by their parents and relatives who immediately sought the assistance of the local government for the exhumation last Nov. 30, 2017, Pueblas added.

Brig. Gen. Franco Nemesio M. Gacal, commanding general of the 402nd Brigade was sad about what happened. "It is very unfortunate that the NPAs left their comrades hurriedly and buried them unceremoniously," he said.

## PASTOR SLAIN AS NPA REBELS, SOLDIERS GLASH IN MINDORO

The lone fatality in the clash between government forces and suspected communist rebels at Mansalay town in Oriental Mindoro province on Sunday was a religious leader who was also an active facilitator of the government's antipoverty program.

Leovelito Quiñones, 57, a pastor of the Guardian of Truth Ministry, was killed, according to Willy Yasay of the Southern Mindoro Ministerial Association, a group of Christian leaders in Oriental Mindoro.

#### 13-year-old wounded

Chief Insp. Romeo Plaida Jr., Mansalay police chief, also confirmed in a text message on Tuesday that Quinones was a feligious leader.

Quiñones (identified as Pablito Quinunez in a military report) was killed when armed men believed to be members of the New People's Army (NPA) fought Army soldiers belonging to the 4th Infantry Battalion at Sitio Bait in Barangay Panaytayan at 8:30 p.m. on Sunday.

A 13-year-old boy was wounded by a stray bullet that hit his house near the battle site.

#### Mistaken identity?

In a telephone interview on Juesday, Yasay said Quiñones'

death could have been a case of "mistaken identity."

"He was an active pastor. That day, he was on his way home from Bansud (town) after getting an amplifier for their church when he was killed," he said.

In a separate interview, Catherine Fos, a facilitator of the government's Pantawid Pamilyang Pilipino Program (4Ps), confirmed that Quinones was also an active 4Ps volunteer assigned to the villages of Don Pedro and Teresita in Mansalay.

The cash aid program aims to alleviate the life of the country's poorest families with conditions that they must attend family planning sessions regularly or make sure that their children go to school.

#### Military report

The military, however, stood by its report that Quiñones was an NPA rebel who left a wife and five children.

He was among eight rebels traveling on four motorcycles from Bulalacao town to deliver "logistics" to guerrillas. said Brig. Gen. Antonio Parlade Jr., commander of the Army's 203rd Infantry Brigade.

The other rebels reportedly escaped after the encounter.

The military said the soldiers recovered from Quiñones a .45-caliber pistol and two containers of bullets. INQ

Supported by artillery fire from the Charlie company of the 7th Field Artillery Battalion, the soldiers broke through the bunkers, forcing the NPA to escape.

The troops recovered two firearms and rebel documents from the seized encampment.

On Monday, Cabunoc and his men, accompanied by tribal elders, entered Datal Bonglangon to treat a wounded identified as Jeffrey Denian, 18.

Cabunoc said that Datu Dandee Denian, a tribal leader from Barangay Tulale, confirmed that among those killed were Datu Victor Denian and two of his sons who reinforced the NPA rebels.

Cabunoc and his men arranged a tribal burial rite for the dead rebels who all belonged to the Dulangan Manobo.

At around 3 p.m., also on Monday, 10 NPA members from Platoon Arabo of Guerilla Front 73 surrendered to Cabunoc in the presence of Datu Tony Paan and Barangay Sto. Nino village Chairman Julieto Ynion.

In Ilocos Sur, a firefight also occurred at around 8:30 a.m. on Monday between rebels and elements of the 71st Division Reconnaissance Company (7th DRC) and 81st Infantry Battalion at Barangay Balidbid, Salcedo town.

Military Northern Luzon Command spokesman Lt. Col. Isagani Nato said members of the 71st DRC and personnel of Mortar Platoon under the 81st IB were conducting combat operations when they chanced upon a group of fifteen rebels operating in the area.

A firefight occurred and lasted for 30 before the rebels withdrew.

Last week, 15 NPA rebels were killed in a clash with elements of the Army's 202nd Brigade in Nasugbu, Batangas - one of them a female student of the University of the Philippines Manila.

Lorenzana said the killing of the student should serve as a lesson to parents who "should be knowledgeable where their children are at all times or find out where they are and also to advise them not to be associating with armed people."

In view of the continuing attacks by communist rebels on government troops even when a ceasefire was in effect, Defense Secretary Delfin Lorenzana will not recommend a suspension of military operations (SOMO) against the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF) this Holiday Season.

"Not at all. His order is to shoot armed NPAs so we have been doing that all along even before. If they are armed and they fight we will also fight back (and) we shoot them," he said.

Asmed Forces of the Philippines (AFP) Chief of Staff General Rey Leonardo Guerrero yesterday denied that it

is cracking down on New People's Army (NPA) guerrillas around the country

In an interview Guerrero said that military operations against communist rebels should not be considered as a

crackdown on them because they are just responding to the atrocities being committed by NPAs.

"We cannot say it's already a crackdown. It's just part of our intensified, focused military operations in response to their atrocities," Guerrero said.

"We saw that they (NPA) have stepped up their atrocities nationwide. So this is just, it's part of our response to make sure we are able to address these concerns," Guerrero said.

The Chief of Staff said that the NPA's stepped-up attacks are already expected following the AFP's shifting some of their forces to Marawi City during the

five-month war there.

"Since we have shifted our forces to Marawi to address the problem there. We created gaps in some of our deployments elsewhere. And this is the result of the gaps, they were able to move around, recruit additional members, and be able to perpetuate atrocities," he said.

Guerrero said the specific order of President Duterte to them is to address all NPA atrocities and make sure that they are able to cover all areas being bothered by the NPAs.

"We are also tasked to reduce their capability, negate the capabilities of the NPA," he said.

## Hunt on for Maute leader Abu Dar

COTABATO CITY—While seven Maute siblings involved in the siege of Marawi City were killed in the five-month battle, the military is still seeking a senior ring leader, identified only as "Abu Dar."

Western Mindanao Command chief Lt. Gen. Carlito Galvez Jr. said during a Regional Peace and Order Council (RPOC) meeting that Abu Dar is a Maranao who was among those

recorded on video plotting the Marawi siege.

The video, recovered by government forces during the siege, showed Abu Dar with siblings Omar and Abdullah Maute and Abu Sayyaf leader Isnilon Hapilon.

#### Rebellion charges

"He can likely assume leadership of Maute terror group," Galvez said, adding that there were three other Mautes in government custody who have been charged with rebellion.

They are the Maute matri-

arch Farhana, Maute, who allegedly funded her sons' illegal activities, and two other sons.

The government also had custody of patriarch, engineer Cayamora, but he died of medical complications while in government custody on Aug. 27, more than two months after he was arrested in Davao City on June 6.

The authorities arrested Farhana on June 9, while she was transporting wounded Maute fighters through a Lanao del Sur town.

Mayor Dimnatang Pansar of

Butig, Lanao del Sur, the hometown of the Maute clan, confirmed that all the Maute brothers were either dead or under government custody.

#### **Good Mautes**

But several Maranaos who are also surnamed "Maute" have been held for questioning or have gone into hiding for fear of arrest.

Autonomous Region in Muslim Mindanao (ARMM) Gov. Mujiv Hataman, who presided over the RPOC meeting, lamented that there were also "good

Mautes" who had been ostracized by their own townmates

"We will help them return to their communities but subject to coordination with the police and the military," Hataman said.

ARMM Vice Gov. Alrashid Alonto-Lucman told also related that one of his daughter's medical school classmates surnamed Maute was forced to drop out after the siege.

Speaking to the Lanao town mayors, Hataman said local government executives should take steps, to prevent Islamic

radicalization in their towns.

Galvez agreed and said failure "would give these violent religious extremists an issue they could use to generate hatred and entice prospective recruits to join their fold."

Hataman also ordered the local executives to help locate Abu Dar who, according to military intelligence, is leading the regrouping of terrorists in Lanao del Sur.

"War is destructive. We have to prevent conflicts at our level first before we let the military come in," Hataman said. INQ

# PRESIDENT DEGLARES GPP, NPA TERRORIST ORGANIZATIONS

President Duterte further widened his break with communist insurgents by formally declaring as terrorist organizations the Communist Party of the Philippines (CPP) and its armed wing, the New People's Army (NPA).

The declaration followed the President's decision to cut all peace negotiations with the rebels, saying he was fed up with their attacks on government forces and civilians.

The National Democratic Front of the Philippines (NDFP), the political arm of the CPP, was not included in the proclamation that the President signed on Tuesday, said presidential spokesperson Harry Roque. He did not explain why the group was spared.

The Department of Justice has been directed to file the petition in the Regional Trial Court to legally declare the CPP and NPA terrorist organizations under the Human Security Act.

Roque said this was "[i]n view of the contin-

ued violent acts of the CPP-NPA, which sow and create a condition of widespread and extraordinary fear and panic among the populace."

"It is not automatic that just because the executive has classified the group as a terrorist organization, it will be considered a terrorist organization under the domestic law and under relevant security council resolutions," he said.

The President also directed the Department of Foreign Affairs to publish the designation of CPP-NPA as terrorist organizations.

While a court order is needed to legally recognize the groups as terrorists, the President's proclamation has an effect because the government does not negotiate with terrorists, Roque said.

He also said that state forces would be able to go after CPP or NPA members for terrorism if they were committing the predicate crimes listed under the Human Security Act, with the additional element that their act was intended to sow fear and panic in the minds

of the public.

The government would also go after those providing financial support to terrorist organizations, he said. These include mining firms and other businesses

"Take note that the domestic statute and the UN Security Council prohibit the giving of funds to terrorist organizations. This will enable law enforcement agencies to run after individuals who will, in any way, provide financial support to the NPA now that it has been described as a terrorist organization," he said.

In his proclamation, Mr. Duterte declared the CPP-NPA a designated or identified terrorist organization pursuant to the Terrorism Financing Prevention and Suppression Act of 2012.

It defines a terrorist financier as "any person or entity designated and/or identified as a terrorist, one who finances terrorism, or a terrorist organization or group under the applicable United Nations Security Council resolution or by another jurisdiction or supranational jurisdiction."

Roque said the petition to declare the CPP and the NPA terrorist organizations would be subject to a hearing, with the rebel groups to be afforded the chance to argue why they should not be deemed terrorist groups.

For purposes of the Human Security Act, the CPP and the NPA would be considered terrorist organizations after the court issued a ruling saying so.

ACT Teachers Rep. Antonio Tinio said declaring the CPP and the NPA terrorist organizations would usher in more human rights abuses against critics of the Duterte administration. —WITH A REPORT FROM VINCE F. NONATO INQ

## Duterte attaches 'terrorist'

## tag to CPP-NPA

RESIDENT Duterte has placed the Communist Party of the Philippines (CPP) and its armed wing, the New People's Army (NPA), under the terrorist list of the country.

In an interview with reporters on Tuesday, Presidential Spokesman Harry L. Roque Jr. said the President has signed a proclamation labeling the CPP-NPA as terrorists.

The proclamation came after Duterte terminated the peace talks with the communists in November.

Although the proclamation is yet to be officially released by Malacañang as of this writing, Roque said the President has instructed the publication of the CPP-NPA, as well as persons and organizations affiliated to them, as terrorists.

"In this regard, I hereby direct

to publish the foregoing destination of the CPP-NPA and all other designated persons and organizations in accordance with Sections 3 and 15 of RA [Republic Act] 10135 and its implementing rules and regulations," Roque said, quoting the draft proclamation.

Under RA 10168, or the Terrorism Financing Prevention and Suppression Act, the financing of terror groups is prohibited and penalized. Section 15 of RA 10168 mandates the Department of Foreign Affairs to publish a list of the designated persons to which the law or the Human Security Act applies.

Executive Secretary Salvador C. Medialdea has also issued a memorandum to Justice Secretary Vitaliano N. Aguirre II to immediately file for the proscription of the CPP-NPA as a terrorist organization in a regional trial court (RTC). "Because of the proclamation, the [justice] secretary was directed by [Medialdea] to file a petition in the RTC because it is not automatic that just because the Executive has classified the group as a terrorist organization, it will be considered as a terrorist organization under

the domestic law and under relevant security council resolutions," Roque said.

However, the proclamation has not named the negotiating arm of the CPP-NPA, the National Democratic Front (NDF), as a terror group. Nonetheless, all those who are proven financing the CPP-NPA will face criminal charges in court.

Peace talks between the government and the NDF has collapsed due to tensions on the ground resulting from encounters between soldiers and communist rebels.

## Rody officially declares commies terrorists

It's official. Malacañang has declared that the communists are terrorists.

President Duterte yesterday signed a memorandum classifying the Communist Party of the Philippines (CPP) and its armed wing, the New People's Army (NPA), as a terrorist group.

Presidential spokesman Harry Roque made the announcement right after the Commander in Chief's joint command conference with the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) at the Palace.

The National Democratic Front (NDF), the CPP-NPA's negotiating wing and propaganda arm, is not covered by the Presidential proclamation.

Roque said the proclamation is "declaring the Communist Party of the Philippines, New People's Army as a designated, identified terrorist organization under (Republic Act) 10168 (or) the Human Security Act."

"This will enable law-enforcement agencies to run after individuals who will in any way, provide financial support to the CPP-NPA," he added.

However, the President's declaration does not necessarily brand the CPP-NPA as terrorists at once.

The Chief Executive has "directed" Justice Secretary Vitaliano Aguirre "to file a petition at the Regional Trial Court because it is not automatic that the CPP-NPA would be considered a terrorist organization under the domestic law."

"The reason the declaration of the CPP-NPA as a terrorist organization has to be brought to court is that of the need for due process," Roque said.

"The CPP-NPA has to be heard on why they shouldn't be tagged as terrorist groups," he added. Roque stressed that CPP-NPA card-bearing members will not be arrested solely because of their membership.

According to the presidential spokesman, CPP-NPA members that have to be arrested should be charged with the conditions spelled in the Human Security Act.

"The Human Security Act can be a basis for criminal persecution of terrorism if you are found to be a member of a terrorist group, but you have to commit predicate crimes in the Act," Roque said.

Republic Act no. 10168 defines a terrorist as "any person or entity designated and/or identified as a terrorist, one who finances terrorism, or a terrorist organization or group under the applicable United Nations Security Council Resolution or by another jurisdiction or supranational jurisdiction."

The Chief Executive also eyes to punish the CPP's legal fronts.

The new Proclamation, which has not been marked with official numbers as of press time, does not cover who or what the legal fronts are but based on Mr. Duterte's previous pronouncements, he said that the CPP's legal fronts are progressive groups like Bagong Alyansang Makabayan (Bayan), Kilusang Mayo Uno (KMU) and transport group Piston. although the arrest of the Piston's leader, it was stressed by the Palace, that the arrest has nothing to do with the terrorist branding.

The Department of National Defense (DND) also will not recommend suspension of offensive military operations (Somo) against the NPA during the Yuletide Season -citing orders from communist leaders to intensify attacks against government forces.

Defense Secretary Delfin Lorenzana said the government can break the tradition by not

declaring Yuletide truce with the communist group.

"No, I will not," replied Lorenzana when asked if he will recommend the Somo to President Duterte in observance of the holiday season.

"Because there was an order by their commanders to intensify operations against us. So if we declare Somo and we will stand down then they will attack us again," he added.

Traditionally, the government declares Somo and suspension of offensive police operations (Sopo) during the Christmas Season with the NPA.

"We can always break tradition," said Lorenzana.

In recent weeks, there have been a series of encounters that happened as both the government and the NPA have stepped up their

attacks against each other following Duterte's decision to permanently scuttle the talks with the NDF, the umbrella organization of democratic forces and groups in the country.

Yesterday, the military reported that elements of the Army's 33rd Infantry Battalion and 27th IB seized the largest NPA guerilla base in the boundary between Sultan Kudarat and South Cotabato on Sunday following a series of firefights.

Lt. Col. Harold Cabunoc, commander of the 33rd IB, said a firefight erupted at past noon when rebels engaged elements of the 27th IB near an NPA cave hideout at Sitio Datal Bonglangon, Barangay Ned, Lake Sebu, South Cotabato.

Seven rebels and two soldiers were killed in the running gunbattle that ensued.

Cabunoc said that as his troops from the 33rd IB maneuvered to support the 27th IB, they were met with heavy volume of fire by more or less 30 rebels, who have occupied fortified 95 bunkers

Paez succumbed to multiple gunshot wounds in the body while being treated at the Gonzales General hospital in San

Leonardo town. Provincial police director Senior Supt, Eliseo Tanding said a task force was formed to look into the murder of Paez.

Tanding said investigators are looking at the victim's profile and background which could provide clues on the people who wanted the retired priest dead.

"We have yet to establish the motive," Tanding said.

Human rights group Kaparatan condemned Paez's killing, which they claimed occurred after the victim assisted in the release of suspected communist rebel Rommel Tucay from the provincial jail in Cabanatuan City.

Tucay was arrested in Čarranglan, Nueva Ecija several months ago for ilfirearms and was suspected to be a New People's Army (NPA) guerrilla. He was reportedly an organizer of the militant group Alyansa rangay Lambakin late Monday. ng Magbubukid sa Gitnang Luson.

Paez reportedly facilitated the release

of Tucay on bail. Paez worked as a coordinator of the Rural Missionaries of the Philippines and had been active in campaigns for upholding human rights in Central Luzon, Karapatan said.

Paez belonged to the Diocese of San Jose City and served as parish priest of the towns of Što. Domingo, Guimba, Nampicuan, Rizal and General Natividad in Nueva Ecija before retiring in 2015.

The Catholic Bishops' Conference of the Philippines (CBCP) said Paez served the diocese for more than 30 years.

Even after retiring from the priesthood, Paez was involved in the Church's human rights and social justice advocacy, the CBCP said.

## Activist priest slain in N. Ecija

AEN, Nueva Ecija — Catholic priest and known activist Fr. Marcelito "Tito" Paez, 72, was gunned down by motorcycle-riding assallants while driving his vehicle along a road in this town the other night.

Police said Fr. Paez was attacked while driving his vehicle around 8 p.m. He was taken to a hospital in the neighboring town of San Leonardo, but expired later due to two severe bullet wounds in the body.

It will be recalled that Paez was the priest who facilitated the release of political detainee Rommel Tucay, an organizer of the Alyansa ng Magbubukid sa Gitnang Luson-Nueva Ecija (AMGL-NE), who was captured last March by soldiers from the Philippine Army's 56th Infantry Battalion.

Paez served the diocese for more than 30 years since its erection in 1984 then retired from the priestly ministry in 2015.

Fr. Tito, as Novo Ecijanos call him, is known for his active stand against hu-

man rights violations and militarization in the province.

Nueva Ecija Bishop Roberto Mallari condemned his killing and called on the authorities to conduct investigation and bring forth justice.

Militant group Karapatan dispatched a fact-finding mission to investigate the killing of the priest.

## Retired priest gunned down in Nueva Ecija

A RETIRED Catholic priest was gunned down by motorcycle-riding men in Jaen, Nueva Ecija on Monday night.

Supt. Fe Grenas, Central Luzon police regional spokesperson, identified the priest as Fr. Marcelito "Tito" Paez, 72, former parish priest of Guimba, Nueva Ecija and the coordinator of the Rural Missionaries of the Philippines in Central Luzon.

Police said Paez was driving his grey Toyota Innova (AAB-2391) along Jaen-Zaragoza road in Barangay Lambakin, Jaen town when he was attacked at around 7:30 p.m.

The Roman Catholic Diocese of San Jose (Nueva Ecija) yesterday condemned the killing Paez and demanded justice. It also called on the faithful to offer prayers for justice.

Responding policemen took Paez to the Gonzales General Hospital in San Leonardo, Nueva Ecija where he later died. Police have yet to establish motive for the killing.

Human rights group Karapatan said Paez assisted in facilitating the release of political prisoner Rommel Tucay who was detained at the Cabanatuan City Jail in Cabanatuan City.

The Promotion of Church Peoples' Response, Karapatan and other rights groups held an indignation rally at the Boy Scouts Circle in Timog Ave., Quezon City to decry the killing of Paez and Pastor Lovelito Quiñones in Oriental Mindoro last December 3.

Karapatan said Quiñones, of the Kings Glory Ministry, a resident of Sitio Anapla, Barangay Don Pedro, Mansalay, Oriental Mindoro, was shot at around 8:30 p.m. allegedly by soldiers.

Quinones was riding his motorcycle, on his way home, when he passed by an area near an alleged encounter site of the AFP and NPA. He was near his residence when he was shot in the chest, killing him on the spot. – With Gerard Naval

## SC upholds decision validating ML edict

The Supreme Court (SC) voted 10-3-1 to uphold the validity of President Duterte's Proclamation 216 issued last May 23 declaring martial law and suspending the writ of habeas corpus in Mindanao in response to the Islamic State (IS) inspired armed siege of Marawi City.

SC spokesman Theodore Te said the 15-man High Tribunal voted 10 to 3 to turn down motions for reconsideration filed by petitioners with the court citing mootness and lack of merit.

Malacanang has said it may adopt a recommendation by the Armed Forces of the Philippines (AFP) this week on whether or not to lift martial law.

"In the matter of the consolidated petitions...the Court, voting 10-3-1, denied with finality for mootness and lack of merit all three motions for reconsideration filed by petitioners from the Court's decision dated July 4, 2017," the resolution stated.

Last May 23, hours after the ISinspired Maute Group laid siege in Turn to page 2

Marawi City, Mr. Duterte placed the whole of Mindanao, including Basilan, : Sulu, and Tawi Tawi, under martial law vannounced during a press briefing held in Moscow, where Duterte was on an official visit.

Congress supported the measure in a resolution issued last May 31. Through a special joint session of the llouse of Representatives and the Senate, lawmakers in a 261-18 vote backed Mr. Duterte's request to extend Proclamation Order 216 until the end of this year.

Two days after the declaration, last May 25, the Communist Party of the Philippines called on its armed wing, the New People's Army, to "plan and carry out more tactical offensives across Mindakao and the entire archipelago" in response to the government's declaration of martial law.

In its original 82-page July 2017 ruling by Associate Justice Mariano del Castillo, the Court held that there was sufficient factual basis for the declaration of martial law in Mindanao and suspension of the privilege of the writ of habeas corpus in the region after the attacks of local terror group Maute last May in Marawi City.

The 11 justices who originally voted in favor of declaring as constitutional the martial law in Mindanao-were Justices del Castillo, Presbitero Velasco, Teresita Leonardo-de Castro, Diosdado Peralta, Jose Mendoza, Bienvenido Reyes, Noel Tijam, Lucas Bersamin, Estela Perlas-Bernabe, Francis Jardaleza and Samuel Martires.

Chief Justice Ma. Lourdes Sereno, Alfredo Benjamin Cagnica, Antonic Carpic voted for the partial granting of the petitions against martial law.

Both Sereno and Caguioa want to limit martial law in the provinces of Lanao del Sur, Magnindanao and Sulu while Carpio wanted it within Marawi only. Associate Justice Marvie Louis opposed the proclamation...

The SC-added that Congress did not gravely abuse its discretion in not convening jointly upon President Duterte's issuance of Proclamation 216, placing the entire Mindanao region under martial law and suspending the privilege of the writ of habeas corpus.

The Court held that Article VII, Section 18 of the 1987 Constitution, which allows the President to declare martial law and suspend the writ of habeas corpus only "in case of invasion or rebellion, when public safety requires it," imposes no duty on Congress to convene.

## Supreme Court declares final its ruling upholding martial law in Mindanao

The Supreme Court (SC) on Tuesday declared final its July 4 ruling on the constitutionality of President Duterte's imposition of martial law and suspension of the privilege of the writ of habeas corpus in Mindanao.

During its full-court session, 10 justices voted to dismiss the motions for reconsideration filed by the petitioners who had challenged the President's Proclamation No. 216 that was issued in response to the attacks by the Maute Group in Marawi City last May 23.

Dismissed were the motions filed by Rep Edcel Lagman, local Mindanao leaders led by Lumad leader Eufemia Campos Cullamat, and a group of women from Marawi led by Norkaya Mohamad

Those who voted to dismiss the motions were Justices Presbitero J. Velasco Jr. Teresita J. Leonardo de Castro, Diosdado M. Peralta, Lucas P. Bersamin, Mariano C. del Castillo, Estela M. Perlas Bernabe, Samuel Martires, Noel J. Tijam, Andres Reyes Jr., and Alexander Gesmundo.

Justice Francis H. Jardeleza who had earlier voted on the legality of the martial declaration was on leave and did not indicate his vote.

Chief Justice Maria Lourdes P. A. Sereno, Senior Justice Antonio T. Carpio, and Alfredo Benjamin Caguioa voted to partially grant the motions as they maintained their position that martial law should be limited only to certain areas in Mindanao.

Justice Marvic Mario Victor Leonen was the only magistrate who voted to grant the motions.

With the dismissal of the petitions, the SC reiterated its ruling that the President has the power to determine the scope of territorial application of martial law.

Earlier, the SC had unanimously voted to dismiss two petitions that wanted to compel Congress to convene in a joint session to tackle the validity of the declaration of martial law in Mindanao.

The SC dismissed the petitions "on the ground that Congress did not gravely abuse its discretion in not convening jointly upon the President's issuance of Proclamation No. 216."

It ruled that Section 18, Article VII, of the Constitution "imposes no such duty on Congress to convene, such duty (to convene and vote) being limited to instances where Congress intends to revoke or extend any proclamation of martial law or suspension of the privilege of the writ of habeas corpus."

Congress had voted unanimously to extend the imposition of martial law and the suspension of the privilege of the writ of habeas corpus in Mindanao until the end of this year.

The Constitution empowers the President to declare martial law and suspend the writ of habeas corpus "in cases of invasion, rebellion or when public safety requires it."

It mandates the SC "to review, in an appropriate proceeding filed by any citizen, the sufficiency of the factual basis of the proclamation of martial law or the suspension of the privilege of the writ or the extension thereof, and must promulgate its decision thereon within thirty days from its filing."

It also provides that "Congress, voting jointly, by a vote of at least a majority of all its members in regular or special session, may revoke such proclamation or suspension, which revocation shall not be set aside by the President. Upon the initiative of the President, the Congress may, in the same manner, extend such proclamation or suspension for a period to be determined by the Congress, if the invasion or rebellion shall persist and public safety requires it."

## It's final: SC upholds legality of ML in Mindanao

The Supreme Court (SC) yesterday upheld with finality the legality of President Duterte's martial law declaration in Mindanao.

The justices voted 10-3-1 to affirm the high court's decision last July dismissing three consolidated petitions seeking to strike down Proclamation No. 216 for lack of necessary factual basis.

The SC dismissed the appeals filed by petitioners led by Albay Rep. Edcel Lagman for mootness and lack of merit.

The high court stood firm in its ruling that there was sufficient factual basis for the declaration of martial law in Mindanao and suspension of the privilege of the writ of habeas corpus in the region after the attacks of local terror group Maute last May in Marawi City.

Those who voted in the majority to dismiss the appeals of petitioners were Associate Justices Presbitero Velasco Jr., Teresita Leonardo-de Castro, Diosdado Peralta, Lucas Bersamin, Mariano del Castillo, Estela Perlas-Bernabe, Samuel Martires, Noel Tijam, Andres Reyes Jr. and Alexander Gesmundo.

Associate Justice Francis Jardeleza, who earlier also voted for the legality of the martial law declaration, was on leave and did not leave his vote.

Chief Justice Maria Lourdes Sereno, Senior Associate Justice Antonio Carpio and Associate Justice Alfredo Benjamin Caguioa voted to partially grant the appeals and maintained their position that martial rule should be limited to some areas only.

Associate Justice Marvic Leonen again sided with petitioners and was the only magistrate who voted to grant their appeals.

The SC issued its final ruling as President Duterte was set to decide whether to extend the martial law declaration, which lapses by the end

of the year.

The Court reiterated its finding that the power to determine the scope of territorial application of martial law belongs to the President and that there is no constitutional provision that such emergency power should be implemented only in the place where actual rebellion exists.

The government had repeatedly said martial law was necessary to quell rebellion since Islamic State (IS)-inspired local rebel groups had taken up arms against the Philippine government to secede Mindanao from the republic and to deprive Duterte of his powers and prerogatives.

Petitioners filed motions for reconsideration, insisting that there was no sufficient factual basis to justify martial law implementation as several information cited in the proclamation were "false inaccurate and contrived."

## Couple killed, burned in feud with 'Mautes'

ILIGAN CITY – A barangay councilor and his wife were shot dead, and their house later set on fire last December 1 by suspects later identified by the couple's children as members of the Maute clan in Barangay Matampay, in Marantao, Lanao del Sur.

Lanao del Sur Provincial Police Director Sr. Supt. John G. Guyguyon identified the victims as Ustadz Khalid Ditingki and his wife Santalia Ditingki.

Guyguyon said the Ditingkis were with their children inside their home when the suspects barged in and opened fire at the couple. The suspects then set the house on fire.

According to Guyguyon, the children were later able to identify their parents' assailants as Nabel S. Tomara, a security guard at the Mindanac State University (MSU) Marawi City campus; Morad Dayaan Maute, a 67-year-old retired security guard; and Roalden and Maunara Maute, residents of Baran-

gay Rapasun, Marawi City.

The suspects had other companions who remained unidentified but were said to be from Pantao Ragat in Lanao del Sur.

On December 2, Marantao police and the Lanao del Sur provincial police were able to arrest Tomara and Morad Maute in Barangay Rapasun, while the other suspects remained at-large.

Nabel and Morad were armed with .45-caliber pistols when they were arrested.

Guyguyon said the Mautes were actually relatives of the victims because the children were readily able to identify the suspects.

"May lumalabas na awayan tungkol sa lote (There seems to be an angle about feud over a piece of land), but we are still digging deeper and are not discounting investigation on other issues, and we'll see what's the involvement of the Maute, as they are also trying to see kung ano ang relationship sa gumawa dito sa Marawi (on what is the link to those who perpetrated the Marawi siege)," said Guyguyon.

## 7 Maute brothers confirmed dead

SHARIFF AGUAK, Maguindanao: The chief of the Western Mindanao Command (WestMin-Com) has confirmed that all seven Maute brothers were killed by government troops who battled members of the Maute Group from May to October this year in Marawi City

The Islamic State-linked Maute group seized several areas in the Islamic city on May 23, prompting President Rodrigo Duterte to declare martial law in Mindanao.

Lt. Gen. Carlito Galvez, Jr., WestMin-Com chief, announced the killing of the Maute-brothers during a meeting of the regional peace and order council (RPOC)

in Cotabato City.

Omar Maute and Isnilon Hapilon, top leaders of the Maute group, were killed in a military assault on October 16. Abdullah Maute was believed killed in September.

Galvez said although all the Maute brothers are dead, the military continues its manhunt for Abu Dar, a senior Maute leader who remains at large.

Dar belongs to a Maranao tribe just like the Maute brothers. He was a member of the central leadership of the Maute terror group.

The Maute patriarch, Cayamora, who was arrested in Davao City in

June, died of an illness while in a police detention facility in Camp Bagong Diwa in Taguig City. Cayamora's first wife, Farhana, mother of the seven slain Maute brothers, was arrested by the police in Masiu town in Lanao del Sur in August. She is being detained on rebellion charges.

"Abu Dar can likely assume the leadership of the Maute terror group," Galvez told members of the RPOC, headed by Autonomous Region in Muslim Mindanao Gov Mujiv Hataman.

Mayor Dimnatang Pansar of Butighometown of the Maute clan, corrobotated the announcement of Galvez,

saying he also received reports confirming that all seven Maute siblings, who started the trouble in Marawi City are dead.

"Many of their leaders were killed during the conflict in Marawi City," Pansar said.

Pansar, president of the League of Mayors in Lanao del Sur, said the bigger challenge now for the government is the rébuilding of Butig and Marawi City.

RPOC members have agreed to help the "good Mautes" who were forced to go underground rejoin society.

"We will not treat them as special people. We can only help them return

to their communities but subject to coordination with the police and the military," Hataman said.

ARMM Vice Governor Haroun Al-Rashid Lucman said many of the Mautes not connected to the terror group have been ostracized.

Hataman has called on all 39 municipal peace and order councils in Lanao del Sur to help the police and military prevent recruitment of Maranaos by local IS-inspired blocs.

"There must be strong semblance of government in the municipalities, War is destructive. We have to prevent conflicts within our level first before we let the military come in. Our presence in the municipalities will help a lot," he said.



## 500 Marawi families to get new homes before Christmas: DPWH

MANILA — Some 500 families displaced by the Marawi City siege would be moving in the transition shelters before Christmas, the Department of Public Works and Highways (DPWH) said on Tuesday.

According to DPWH Secretary Mark Villar, the construction of resettlement area in Barangay Sagonsongan is on schedule, thus, they expect the initial number of beneficiaries to be in their new transition homes before December 25.

"The construction of the houses is on going. They have already completed the construction of (some of) the houses," he said in an interview.

Villar recently visited the areas that were damaged by the war between government forces and the Maute group, which lasted for five months.

The Duterte administration is eyeing 4,000 "bakwit" families to benefit from building the transition area.

"But an initial batch of houses by December, before Christmas, would be available. The target is 500 houses before Christmas," the DPWH chief added.

He said that the local government and the Department of Social Welfare and Development (DSWD) would be the ones that would identify the first 500 families that would occupy the newly-built houses.

Earlier, Villar reported that post conflict needs assessment (PCNA) team has entered the area to conduct assessment on the extent of the damage on the infrastructure in the war-torn city.

"Continuous data is coming in, we would be able to assess," he said. (PNA)

## Duterte formally declares CPP-NPA as terror group

**MANILA** — President Rodrigo Duterte has signed a proclamation formally designating the Communist Party of the Philippines-New People's Army (CPP-NPA) as a terrorist organization.

Presidential Spokesman Harry Roque made the announcement during a press conference in Malacañang.

The Palace spokesperson said the President signed the proclamation pursuant to the provisions of Republic Act No. 10168 or the Human Security Act.

Roque said that under the law, affiliate revolutionary groups of the CPP-NPA would now also be considered terrorists groups, and anyone proven to be financing these groups would be held liable.

Citing the pertinent provisions of RA 10168, Roque said that a designated person is "any person or entity designated or identified as a terrorist, as one who finances terrorism or a terrorist organization or group under the applicable United Nations Security Council resolution or by another jurisdiction or supranational jurisdiction and pursuant to the proclamation which implements the Human Security Act."

"Take note that the domestic statute and the UN Security Council prohibits the giving of funds to terrorist organizations, this will enable law enforcement agencies to run after individuals who will, in any way, provide financial support to the NPA now that it has been described as a terrorist organization," Roque said.

In his proclamation, Duterte directed the Department of Foreign Affairs "to publish the foregoing designation of CPP-NPA and other designated persons, organizations, in accordance with Sections 3 and 15 of RA 10168 and its implementing rules and regulations."

The proclamation was issued two weeks after the Philippine government terminated peace talks with the CPP-NPA after a series of violent attacks that the President said is against humanitarian law.

Meanwhile, Roque said that due to the proclamation, Executive Secretary Salvador Medialdea has already issued a memorandum to Justice Secretary Vitaliano Aguirre II to immediately file the necessary application for the declaration of the CPP-NPA as a terrorist organization with the appropriate regional trial court (RTC).

He said this is because a proper petition must be filed by the DOJ in court to classify the CPP-NPA as a terrorist group under the Human Security Act for the group to be considered as such under domestic laws and under relevant UN Security Council resolutions.

"This is not just in relation to Philippine domestic law but also in relation to a UN Security Council resolution intended to curtail financing of terrorist organizations," Roque said. (PNA)

## Lorenzana mum on martial law, Guerrero extension

**MANILA** — Department of National Defense (DND) Secretary Delfin Lorenzana refused to comment on the possible extension of martial law in Mindanao and Gen. Rey Leonard Guerrero's term as Armed Forces of the Philippines (AFP) chief-of-staff.

"I cannot talk about that, we already submitted our recommendation (on the extension of martial law in Mindanao) yesterday (Monday)," Lorenzana said on the sidelines of the National Disaster Risk Reduction and Management Council Yearend Meeting, held at the AFP Commissioned Officers' Club in Camp Aguinaldo, Quezon City Tuesday.

When asked on the contents of their recommendations, the DND chief replied, "Hindi ko sasabihin sa inyo kasi bahala na ang Malacanang na mag-announce kung ano yun. (I will not share that with you anymore. It is up to Malacanang to announce what that recommendation is.)"

Martial law was declared in Mindanao on May 23 following the series of attacks conducted by Maute Group terrorists in Marawi City.

The Congress, voting jointly -- 261 against 18 -- affirmed the need to extend Proclamation No. 216 extending martial law and the suspension of the writ of habeas corpus until Dec. 31 as initiated by President Rodrigo Duterte.

When queried on whether he recommended the extension of Guerrero as AFP chief, Lorenzana also declined to comment on the matter.

"I cannot talk about that," he added.

Guerrero succeeded Gen. Eduardo Año last Oct. 26. He is a member of the Philippine Military Academy

He is expected to retire on December 17. (PNA)
