

Palace asks Congress to extend military rule amid terror threat

PRESIDENT Rodrigo Duterte wants martial law in Mindanao, imposed in May. extended for one more year and, senior officials said, will again seek Congress' approval following the recommendations by the military and the police.

Executive Secretary Salmessage to reporters, confirmed the President would be transmitting his latest appeal to both chambers of Congress today.

In related developments:

· Communications Secretary Martin Andanar said the terrorist group Daulah Islamiyah, connected to the Maute and Abu Sayyaf groups, had been planning to attack another city in the country.

Andanar revealed this as. vador Medialdea, in a text he stressed the need to extend martial law in Mindanao, based on the proposal

of the AFP.

In an interview over Super Radyo dzBB, Andanar said the Daulah Islamiyah group had continued its recruitment activities.

The Department of National Defense and the Department of the Interior and Local Government, in separate recommendations to the President, said that military rule would help in rebuilding the Islamic city as "the threat of terrorism remains." Next page

• The Commission on Human Rights said Sunday the extension of martial law in Mindanao beyond the Dec...31 deadline might be a prelude to a "strongman rule."

CHR Commissioner Roberto Cadiz said in an interview with Super Radyo dzBB that the military and the police's recommendation to extend the Mindanao martial law was "alarming" because it had no justification.

DND public affairs chief Arsenio Andolong said in an interview: "It will help us to continue our momentum in our campaign against the Daesh [Arabic word for ISIS] and their sympathizers and not to do so will allow them to regroup again.

"[And] as you know there have been reports that they are recruiting already in the Lanao area so I think this will help curb their activities on the ground.

"If we dont have martial law, it will be very difficult for the rehabilitation of Marawi and the other wartorn areas in the area."

House Majority Leader and Ilocos Norte Rep. Rodolfo Fariñas said the Lower House was expected to receive Monday the letter

signed by Duterte seeking Congress' approval for the extension of martial law in Mindanao beyond Dec. 31.

Fariñas said Medialdea informed him about the matter through a text message.

As to how long the martial law in Mindanao shall be extended, Pariñas saidhe would not know until the matter was discussed by the House leadership.

Congress, which upheld Duterte's first request to extend martial law in Mindanao last July 22, will be going on a Christmas break on Dec. 15, and will resume sessions on January 15 next year.

Recently, the Supreme Court, in a 10-3-1 vote, affirmed the constitutionality of Duterte's order to place Mindanao under martial law.

Former Armed Forces of the Philippines spokesman Maj. Gen. Restituto Padilla in a news briefing last Friday said while terrorist groups in Mindanao were largely "scattered," "disorganized," and "leaderless," recruitment still continued in most parts of Mindanao, promising fabulous pay just to join the jihadist movement.

"Those who survived that siege still remain at large and are attempting to recover by recruiting other

members of the society, particularly the vulnerable sector of our population, and they are students, children, women and the like, as well as relatives of those who lost their lives in the fight," he added.

The military also cited continuing significant violent activities of other terrorist groups affiliated with the Islamic State, such as the Bangsamoro Islamic Freedom Fighters controlling Maguindanao, Lanao and Cotabato, along with the Abu Sayyaf in the islands of Basilan, Sulu and Tawi-Tawi.

Padilla also cited threats by the communist New Peoples' Army as a growing threat in Mindanao, which grew in number during the full in the peace negotiations.

Amid the perceived criticism on the possibility of a second extension of martial law, presidential spokesman Harry Roque, in an earlier news briefing, insisted that what mattered most was the opinion of those on the ground, and not those far from the battle zone.

"What matters most is the view of the stakeholders, the view of the Mindanaoans on martial law...why should people from Luzon complain?" he earlier said.

Duterte, in less than 24 hours during his trip to

Moscow, Russia on May 23 placed the entire island of Mindanao under martial law after the ISIS-inspired Maute group laid siege in Marawi City.

The initial declaration was supposed to end after 60 days, but Congress, in joint session, approved Duterte's request to extend it until the end of the year.

Last October 17, Duterte declared Marawi City free from terrorists after security forces were able to neutralize terrorist leaders Isnilon Hapilon and Omar Maute.

According to Article VII, Section 18 of the 1987 Constitution, the President as Commander in Chief can place the Philippines or any part of it under martial law or suspend the privilege of the writ of habeas corpus "in case of invasion or rebellion, when the public safety requires it."

The President must submit a report to Congress in person or in writing within 48 hours of the proclamation of martial law.

Congress, in turn, voting jointly, by at least a majority, of all its members in regular, or special session, may revoke the proclamation, and the President may not set aside the revocation.

Durterte Wants 1 more year of VILIA Mindanao

President Duterte has approved the recommendations of security officials and will seek a one-year extension of martial law in Mindanao to contain terrorism and other threats to public safety.

Executive Secretary Salvador Medialdea said a letter requesting the extension of military rule in the south would be transmitted today to Congress.

"Recommendation is one year," Medialdea said in a text message yesterday.

Earlier, Malacañang officials said Duterte had received the recommendations of the Department of National Defense, Armed Forces of the Philippines and Philippine National Police to extend martial law in Mindanao. The officials assured the public that the safety of Filipinos would be the main consideration in making his decision.

"(The President's) paramount concern is the security of our people especially the Mindanaoans in the face of

threats and the use of available means under the law to fight them," presidential spokesman Harry Roque said in a statement.

Duterte declared martial law in Mindanao on May 23 to run after Islamist militants who occupied Marawi and held hostage dozens of civilians. Congress voted in July to extend military rule until the end of the year.

Last week, the military expressed support for a proposal to extend martial law by one more year, saying this could quell the threats posed by terrorists who survived the Marawi siege and communist rebels.

But some sectors are worried that the extension of martial law in Mindanao would Turn to Page 11

lead to human rights abuses. Opposition lawmakers are also against an extension, saying lifting military rule would allow residents affected by the Marawi crisis to return to their homes.

The extension of martial law in Mindanao requires the approval of Congress, which will go on a month-long break before the weekend.

Speaker Pantaleon Alvarez and Majority Leader Rodolfo Fariñas said they have been notified of the request.

But Alvarez said he asked that the request be made formal in a letter "so that we (Congress) can act on it immediately."

Alvarez told The STAR that he expects to receive the letter of the President this morning.

Alvarez has said it would be best to ask the people from Mindanao regarding the matter because they would know better.

Justified?

Bangon Marawi Task Force

chair Eduardo del Rosario, who oversees the rebuilding of war-torn Marawi, wants martial law in Mindanao extended to secure rehabilitation efforts and foil attempts to recruit people into terrorist groups.

The DND also said there is still a credible terrorist threat in Mindanao that justifies the extension of martial law being enforced in the area.

DND public affairs chief Arsenio Andolong said the proposed extension of martial law will help us to continue our momentum in our campaign against the Daesh (Islamic State) and their sympathizers."

He noted that doing other-

wise will allow terrorist cells and sympathizers to regroup considering reports that they are already recruiting in the Lanao area.

"So I think this will help curb their activities on the ground and if we don't have martial law, it will be very difficult (to implement) the rehabilitation of Marawi and the other war-torn areas," Andolong explained.

He said rehabilitation work will entail movement of logistics and equipment and allowing terrorist groups to roam free can hamper the operations due to security concerns.

Andolong said "there is a

threat" and that in terms of seriousness, such depends on the area but "it is there, it is credible."

Albay Rep. Edcel Lagman and Akbayan party-list Rep. Tom Villarin said there is no basis for Duterte to ask Congress to extend martial law in Mindanao because the Constitution states clearly this can only be done in "case of invasion or rebellion, when the public safety requires it."

Lagman said there is no more "actual invasion or rebellion" in Mindanao as the President himself had declared that Marawi had been liberated from local and foreign

terrorists two months ago.

Zamboanga City Rep. Celso Lobregat of the first district said the proposed martial law extension must be tackled before Congress goes on a Christmas break on Dec. 12 "because if it is not then we have to go for a special session."

Lobregat said Congress will also have to tackle the duration of the martial law extension.

"Let us wait for the President's request. I'm sure it will be upon the recommendation of the PNP and the AFP," Lobregat added.

Remains of Vietnamese held hostage by ASG recovered

OTABATO CITY — The remains of a Vietnamese boat captain kidnapped along with five compatriots by the Abu Sayyaf Group (ASG) last year were recovered on Friday by the police in Sulu, the police regional office of the Autonomous Region in Muslim Mindanao (PRO-ARMM) announced over the weekend.

The bones of Pham Minh Tuan, captain of the MV Royal 16 from Vietnam, were exhumed at Sitio Kasulutan in coastal Barangay Bus-Bus, Jolo, Sulu, Maguindanao-based ARMM police director Chief Supt. Graciano Mijares said.

Barangay Bus-Bus is located a few nautical miles from Jolo, the capital of Sulu province, a component of ARMM.

Tuan and his five crewmen were abducted on November 11, 2016 while

sailing near Sibagu Island, about six nautical miles off Lamitan City in Basilan, Mijares said.

"The operation that resulted in the recovery of his remains was an initiative of the Sulu provincial police, the Joint Task Force Sulu and the Mindanao field unit of the Anti-Kidnapping Group," Mijares said.

Tuan was reportedly executed by his captors, led by Idang Susukan, amid an encounter with the Army's 41st Infantry Battalion in Barangay Upper Binuang in Talipao town in Sulu on September 7, 2017.

"Possibly, his cadaver was buried somewhere in Jolo... to mislead authorities," Mijares said.

Basilan officials on Saturday said the Abu Sayyaf first held Tuan captive in their province, but transferred him to Sulu due to pressures from armed Yakan villagers, who were helping the

police and military fight the Islamic— State-inspired group.

"They must have thought they can

get a big ransom in exchange for the release of the boat captain," Mijares said, quoting a town mayor.

Tuan's remains will be airlifted to Manila and turned over to the Vietnamese embassy, he said.

Duterte to extend martial law

President Duterte will ask Congress to extend martial law in Mindanao for a year before both houses adjourn for their Christmas recess on Friday.

House Majority Leader and Ilocos Norte Rep. Rodolfo Fariñas said Executive Secretary Salvador Medialdea informed him that Mr. Duterte had already signed the request and the letter is expected to be delivered on Monday.

Medialdea confirmed to reporters the signing of the request which seeks an extension of martial law in Mindanao for an entire year after the original extension expires on Dec. 31.

Both the House of Representatives and the Senate, which originally scheduled their last

day of session for Dec. 13, will only have until Dec 15. to jointly vote on the extension.

"I, of course, relayed it first to the Speaker who said we will discuss it tomorrow. We will have to discuss it with our Senate counterparts," Fariñas said.

The House leader said the process for the reextension will be the same as when Congress approved the first extension last July 22.

Senate President Aquilino Pimentel III said on Friday that he expected the Palace to seek an extension and would immediately take up the matter with other senators when he receives the request.

Mr. Duterte sought the martial law extension after the military said it needed to sustain the military's "momentum" against terror groups that have started regrouping after their

defeat in Marawi City.

"Not [extending martial law] will allow them to regroup again and, as you know, there have been reports that they are recruiting already in the Lanao area," said Department of National Defense (DND) spokesperson Arsenio Andolong.

'Credible threat'

"So I think this will help curb their activities on the ground," Andolong said, noting there is a "credible threat" that the military needs to address in Mindanao.

Andolong did not elaborate on the "credible threat," but Armed Forces of the Philippines spokesperson Brig. Gen. Restituto Padilla said the military is monitoring the Daulah Islamiyah fi Ranao (Islamic State in Lanao) group and their foreign allies.

Presidential Communica-

tions Secretary Martin Andanar also said the Daulah Islamiyah fi Ranao group, which is connected to the Maute and Abu Sayyaf groups, had been planning to attack another city in the country.

Speaking in a radio interview on Sunday morning, Andanar also cited unclarified intelligence reports about terror groups that are supposedly stepping up their recruitment activities. In justifying the extension of martial law, Andolong said it would also help in the rebuilding and rehabilitation of Marawi City and other war-torn areas.

"How do we continue the rebuilding if we cannot secure the area? Our engineers might be ambushed," Andolong said, citing the usual security threats in conflict areas.

Aside from the Daulah Islamiyah fi Ranao, Padilla said

there could also be attacks by the Bangsamoro Islamic Freedom Fighters in Maguindanao, Lanao and Cotabato, and the Abu Sayyaf in Basilan, Sulu and Tawi-Tawi.

In addition to the jihadists, Padilla said the military also needed to guard against attacks by communist rebels who have, in the past, attacked construction activities in Mindanao.

65% increase in attacks

Padilla said there had been a 65-percent increase in attacks perpetrated by communist rebels in Eastern and Western Mindanao from January to November this year.

The martial law proclamation over Mindanao is set to expire on Dec. 31, unless extended by Congress. —with reports from Nikko dizon INQ

Martial law extension now in Duterte's hands

President Duterte is now studying the recommendations made by the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) to extend martial law in Mindanao which is set to expire by the end of the year.

The recommendations have been submitted to the President through

the Departments of National Defense (DND) and of the Interior and Local Government (DILG).

"The President is studying the recommendations and he is assessing the need for further

extending martial law in Mindanao,"

Roque said in a statement.

Roque said in a statement.

"PRRD's paramount concern is the security of our people especially the Mindanaoans in the face of threats and the use of available means under the law to fight them." he added.

Earlier, Duterte said that he cannot decide on the fate of martial law alone and that he would follow the recommendation of government forces as they are the ones who have first-hand knowledge of the situation on the island.

The PNP had said it recommended the extension of martial law in Mindanao for another year. However, the AFP has not indicated for how long it wants martial law to be extended.

The terrorists

The AFP earlier explained that it is seeking for an extension due to reports of terrorist recruitment, increase in violent incidents involving the New People's Army (NPA), and the existence of armed groups including the Abu Sayyaf Group (ASG) and the Bangsamoro Islamic Freedom Fighters (BIFF).

"The increasing violence initiated by the Left is part of the reason why martial law may be needed in order to cover areas where potential terrorists may be hiding," former AFP spokesperson Maj. Gen. Restituto Padilla earlier explained.

He also said that terrorists who survived the Marawi siege still remain at large and are attempting to recover by recruiting

other members, particularly children, students, women, and even family members of terrorists killed during the five-month war, through huge amounts of cash.

"We still face significant violent activities that are possible from the groups of the BIFF over in Maguindanao, Lanao and Cotabato as well as the threats brought about by the continued existence of ASG forces in the islands of Basilan, Sulu and Tawi-Tawi," Padilla also said.

The AFP, however, assured the public that there will be no human rights abuses under their watch in case Congress grants the second extension of martial law in Mindanao.

DND's view

For his part, DND-Public Affairs Service (DND-PAS) Chief Arsenio Andoong said that extending martial law in Mindanao will help them continue with their

momentum against local and foreign terrorists lurking in the region.

Andolong told The Manila Bulletin that extending martial law will ensure that Daesh-inspired militants and their sympathizers will be arrested and prevented from regrouping.

"As you know there have been reports that they are recruiting already in the Lanao area so I think this will help curb their activities on the ground," Andolong said.

"And if we don't have martial law it will be very difficult (for) the rehabilitation of Marawi and the other war torn areas in the area," he added.

Andolong explained that if militants and supporters are allowed to freely move, they may even hamper the rehabilitation efforts in the city destroyed by five months of war.

Congress support

"Because we're going to move logistics; like equipment. If they (terrorists/supporters) move freely there they can hamper the rebuilding process. We cannot continue with it if we cannot secure the place. Our engineers will also be going there, they might get ambush." Andolong said.

As the clock continues ticking, Malacañang is keeping its fingers crossed that Congress will still be able to approve a martial law extension within this year.

The Palace is requiring the Congress' approval before the Legislative Branch goes on its Christmas break on December 15.

Presidential Communications Operations Office (PCOO) Secretary Martin Andanar expressed optimism that there is time for the Congress to act on two initiatives – martial law extension and the Bangsamoro Basic Law (BBL).

MARTIAL-LAW EXTENSION A MUST TO CURB TERROR SYMPATHIZERS: DND

HE extension of martial law in Mindanao is essential to completely curb threats from sympathizers of the Maute-Islamic State of Syria and Iraq (ISIS), the Department of National Defense (DND) said on Sunday.

"It will help us to continue our momentum in our campaign against the Daesh [Arabic word for ISIS] and their sympathizers and not to do so will allow them to regroup again. [And] as you know, there have been reports that they are recruiting already in the Lanao area, so I think this will help curb their activities on the ground," DND Public Affairs chief Arsenio Andolong said in an interview.

"If we dont have martial law, it will be very difficult for the rehabilitation of Marawi and the other war torn areas in the area," he added.

"We're going to move logistics ano 'yung mga equipment, pagka sila'y nakakaikot ng malaya d'un, they can hamper 'yung pagre-rebuild natin di ba, kasi paano natin matutuloy 'yun eh kung hindi natin ma-secure yung area, papuntapa 'yung mga engineers natine baka ma-ambush na "yung mga gan'un ba," Andolong said.

When asked whether terror threats remain in Mindanao, Andolong said "there is a threat. In terms of seriousness kasi relative 'yun saiba-ibang areas eh, pero meron, it is there, it is credible."

On July 23, Congress, voting 261-18, extended martial law in Mindanao until year-end.

In October Lorenzana announced the end of the five-month long conflict between government forces and Maute terrorists in Marawi City following the death of top terrorist leaders Omar Maute and Isnilon Hapilon.

Andolong, meanwhile, echoed Defense Secretary Delfin Lorenzana's stand saying there would be no holiday ceasefire with Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

Andanar also said that aside from Daulah Islamiyah, groups such as the Bangsamoro Islamic Freedom Fighters and the Abu Sayyaf have likewise posed threats to several areas in Mindanao.

"So therefore, kailangan ma-extend ang martial law sa Mindanao."

Also, Andanar said violence may further persist in Mindanao after the formal termination of peace talks between the government and the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF)

Andanar clarified that the communist rebels cannot be immediately considered a terrorist group under the Human Security unless declared by the court.

No holiday truce with NPA, DND insists

Even if it breaks tradition, the Department of National Defense (DND) is not bent on suspending military operations against the New People's Army (NPA) during the Christmas and New Year break.

DND public affairs chief Arsenio Andolong said yesterday a ceasefire with the NPA, the armed wing of the Turn to Page 11

Communist Party of the Philippines (CPP), will only give the rebel group a chance to continue their attacks on military and police outposts.

"Defense Secretary (Delfin) Lorenzana has already spoken that he is not inclined to declare a suspension of military operations this Christmas," he added.

During the past years, ceasefire was always declared during the Christmas and New Year break. But Andolong said Lorenzana is ready to break tradition if necessary.

President Duterte declared the CPP-NPA as terrorist group after he cancelled the peace talks following the reported attacks of the NPA against the military and police.

The Philippine National Police (PNP), meanwhile, is intensifying intelligence operations to thwart attempts by the NPA to expand its activities in the countryside.

Chief Supt. Dionardo Carlos, PNP spokesperson, said the police force is prepared to address threats posed by the NPA against communities, industries and

government installations.

Carlos said the readiness of the PNP was evident when police units repulsed two separate attacks staged by the NPA in Labo, Camarines Norte and Binuangan, Misamis Oriental recently.

Government forces and the NPA have been clashing in various provinces, with encounters resulting in casualties and injuries mostly from the rebel side.

Last week, 14 NPA members were killed in an encounter with soldiers in Nasugbu, Batangas. Among the dead was a student of the University of the Philippines.

On Dec. 2, suspected communist rebels attacked members of the provincial mobile force company assigned at the Camarines Norte Police Provincial Command, during an early morning combat patrol operation.

Police Officer 2 Richard Abad was killed in the attack while six were wounded.

Last Dec. 3, four policemen of the Binuangan Municipal Police in Misamis Oriental were wounded after the municipal police station was attacked by suspected members of the NPA.

recruitment of our brother Muslims for them to join Daulah Islamiyah," he said.

According to global antiterrorism think tank Terrorism Research and Analysis Consortium (TRAC), the pro-IS group is active in the Malaysian states of Perak and Selangor,

Its objective is establishment of an Islamic Caliphate in an area that covers Malaysia, Indonesia, Singapore, southern Thailand as well as southern Philippines" which it plans to name Daulah Islamiah Nusantara.

It subscribes to the "Salafi jihadist ideology" similar to that of al Qaeda and the IS, it added.

"The (intelligence report) stated that its recruitment efforts in Mindanao are being intensified. There are intelligence reports that it plans to attack another city," Andanar said but he did not name the target city.

Andanar said that the threat supports proposals for the extension of martial law in Mindanao which also is being threatened by other groups such as the Bangsamoro Islamic Freedom Fighters (BIFF) and the Abu Sayyaf,

"So therefore, there is a need to extend martial law in Mindanao," he said.

Andanar added the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF) also poses a serious security threat after the termination of peace talks between the government and the communist rebels.

Andanar said communist rebels cannot be branded a terrorist group and be covered by the Human Security Act unless a court

declares that they have a terrorist nature.

"Once the court hands down a decision naming the CPP-NPA-NDF as a terror organization, only then the government can start arresting their members," he said.

Extended ML drew mixed reactions

The proposal to extend martial law in Mindanao made separately by the Philippine National Police (PNP) and the Armed Forces of the Philippines (AFP) to Mr. Duterte drew mixed reactions from the retired and active members of the uniformed services.

While many expressed support to the extension of martial law in Mindanao, there are also those who are apprehensive and concerned over the possible effects of prolonging military rule in southern Philippines.

"ML (martial law) extension might be the best option," a retired AFP general told The Tribune.

The AFP cited continuing recruitment by Islamic Stateinspired terrorists and the threat posed by the communist NPA in recommending for the extension of martial law in Mindanao.

On the other hand, the PNP also noted threats from the terrorists in justifying its recommendation to extend martial law for another year.

The source, however, stressed that the military and police alone cannot address terrorism in Mindanao region.

"It (martial law extension can) be matched by a sweeping clean up of LGUs (local government units). Jail public officials who are corrupt, supporting terrorist groups linked to drug trade; include the entire local bureaucracy per LGU (then it is desirable)," the general said.

"The public should feel the government is helping not exploiting them," he added.

Meanwhile, some 270 apprehensive over the AFP and PNP recommendations.

A retired police official doubts the basis of the recommendations raising belief that such were made by AFP and PNP officials to please Duterte.

"The fly in the ointment? PRRD (Duterte's initials) publicly impressed that he wants the extension! So, was the recommendation based on sincere appreciation of the situation or PRRD's wish?" he asked.

On the other hand, most active PNP and AFP officers are fully supportive of the move to extend martial law.

"We need to sustain the gains he achieved in Marawi City against the Daesh-inspired terrorists. We nipped the terrorists aim of establishing a caliphate in Mindanao because of ML," a senior ranking Camp Aguinaldo official said.

Last May 23, Duterte placed Mindanao under martial law after IS-inspired terrorists, led by Isnilon Hapilon and the Maute brothers, laid siege on Marawi City.

With the declaration, more than 120 individuals, including politicians, were captured by virtue of Arrest Order Nos. 1 and 2 issued by martial law administrator Defense Secretary Delfin Lorenzana.

Congress approved it extension last July up until the end of the year.

On Oct. 23 or exactly five months after the siege erupted, Lorenzana declared the liberation of Marawi City from the terrorists.

More than 1,200 terrorists, government troops and civilians were killed during the five month conflict. Around 400,000 civilians were displaced.

authorities are focused on the massive repair and rehabilitation of the Islamic City.

DND says extension essential

The Department of National Defense (DND) added the extension of martial law in Mindanao is essential to completely curb threats from sympathizers of the Maute-IS.

"It will help us to continue our momentum in our campaign against the Daesh (Arabic word for ISIS) and their sympathizers and not to do so will allow them to regroup again. (And) as you know there have been reports that they are recruiting already in the Lanao area so I think this will help curb their activities on the ground," DND public affairs chief Arsenio Andolong said in an interview.

"If we dont have martial law, it will be very difficult for the rehabilitation of Marawi and the other war torn areas in the area," he added.

When asked whether terror threats remain in Mindanao, Andolong said "there is a threat. In terms of seriousness that is relative in different areas eh, but it exists, it is there, it is credible."

Andolong, meanwhile, echoed Defense Secretary Delfin Lorenzana's stand saying there would be no holiday ceasefire with Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

"Secretary Lorenzana has spoken that he is not inclined to declare a suspension of military operations this Christmas because it will give them (NPA) a chance also to continue their attacks on our outpost, they are taking potshots at our troops and policemen and he does not relish that and we will be giving them a chance do all of that during the Christmas season," he added.

7 Marines, cop wounded in North Upi roadside blasts

COTABATO CITY-Seven Marines and a policemen were injured in two roadside explosions that rocked the Maguindanao before dawn Saturday, authorities reported yesterday.

The wounded Marines were identified as Major Romulo Ducay, Corporals Ryan Cabual, Arnel Jiun, Oliver Albo and Alvin Sangadan, and Privates First Class Johnny Panday and Gerwin Perez, all of the Fifth Marine Battalion based in Barangay Mirab in North Upi town.

The Marines were returning to their base after responding to an earlier blast at a nearby police detachment when a bomb planted along the road went off, initial police reports said.

The initial blast, which reportedly originated from a projectile grenade fired at the police detachment, wounded

PO2 Esmael Alabat, initial police reports said.

The wounded Marines were rushed to the military hilly town of North Upi in hospital of the Army's 6th Infantry Division headquarters at Camp Siongco in Datu Odin Sinsuat town, also in Maguindanao, the initial police investigation said.

Alabat, who sustained shrapnel wounds in various parts of his body, is now recuperating at the regional medical center here, it was learned.

Sr. Supt. Agustin Tello, director of the Maguindanao provincial police, said his field investigators were still looking into the two separate explosions.

The peace and order council of North Upi, a peaceful home to Muslim, Christian and lumad people, has no clue on who were responsible in the incidents, Tello said. (Ali G. Mcabalang)

CLASHES WITH BIFF

DISPLACED IN OTHER BATTLES VS TERROR: 11,000 FAMILIES

ZAMBOANGA CITY—At least 11,000 families were displaced and many were still grappling with daily survival in battles between government soldiers and rogue Moro guerrillas in Maguindanao province that largely went on unnoticed because all eyes were focused on the war on terror in Marawi City.

A report by the International Committee of the Red Cross (ICRC) Philippines said while barely noticed, clashes between soldiers and Bangsamoro Islamic Freedom Fighters (BIFF) guerrillas in August in Maguindanao and skirmishes that followed sent thousands of families fleeing their homes.

Allison Lopez, head of ICRC public communications division, said the report documented the plight of the displaced families.

"Thousands of displaced families in Maguindanao have been deprived of basic everyday necessities as intense fighting persisted in the area," Lopez said.

ICRC and Philippine Red Cross had provided food ration good for 15 days and other supplies to at least 11,600 people in the town of Shariff Saydona Mustapha on Dec. 2.

"While the attention over the recent months has been mostly focused on the Marawi conflict, several communities in Maguindanao have been seriously affected by armed clashes," said Tomako Matsuzawa, head of the ICRC office in Cotabato City.

"We remain concerned about their plight as they have been displaced for more than three months," Matsuzawa said.

Maj. Gen. Arnel Dela Vega, head of the 6th Infantry Division, told the Inquirer, however, that fighting had stopped in these villages in the towns of Mamasapano and Shariff Aguak—Salbu, Datu Saudi Ampatuan, Pagatin and Datu Salibo.

The ICRC report listed these areas as sites of clashes between soldiers and members of BIFF, an armed group that broke off from Moro Islamic Liberation Front (MILF) over disagreements in MILF's peace negotiations with the government.—JULIEALIPALA INQ

Cutting the funds flow to the CPP-NPA

PRESIDENT Rodrigo Duterte could not hide his frustration when he recently declared the CPPNPA as a terrorist organization.

This came in the heels of an earlier presidential decision to terminate all talks with the CPP-NPA-NDF leadership based in the Netherlands.

To the layman, the termination of the on again-off again talks with Jose Maria Sison and company is fairly understandable. Sison et al have not shown any good faith in dealing with the government. While the talks are going on, the CPP-NPA on the ground have not stopped attacking government troops and extorting from business establishments in their areasof influence.

In fact many have been wondering why it took so long for the President to pull out of the talks.

But the declaration of the CPP-NPA (but not the NDF) as a terrorist group is something else and it needs further explanation.

By way of background, the United States has long declared the CPP-NPA as terrorists. The US has been badgering the Philippines to do the same. Sison et al, for their part, deny to the death that they are a terrorist group.

So why is so much importance attached to the label?

The short answer is:

Post 9/11, a terrorist organization will find it more difficult, although not impossible, to raise funds and to move it around in order to finance its activities.

It all started when the the UN Security Council adopted a wideranging resolution demanding member countries to take action to suppress terrorist financing.

150 governments responded positively and have since passed legislation criminalizing terrorist financing, and also requiring financial institutions to report suspicious tranctions.

In these jurisdictions, banks are now required to check their clients and third parties involved in transactions against a list of suspected terrorists.

The same governments have also ratified the UN Convention on Financing Terrorism. The convention has created a greater degree

of international cooperation in tracking down terrorist financiers.

To a certain extent, the legal measures have disrupted the flow of funds used for terrorist activities, constraining overall capabilities of terrorists and helping frustrate their ability to timely execute attacks.

With such measures applying to the CPP-NPA, the group needs to work doubly hard to source their requirements outside of their usual "charitable" sources.

Extend martial law after rebels all dead?

even months into martial law, it is clear Filipinos do not know or do not care how our Constitution is supposed to protect us.

Sen. Franklin Drilon protested that it is unconstitutional to extend martial law after the shooting in Marawi City has long stopped.

But we ignored him. His crucial, obvious point was but an afterthought at the bottom of news reports.

Daenerys Targaryen does not order "dracarys" after the battle is won. Lebron James does not shoot after the buzzer sounds. So why would we extend martial law after the rebellion was crushed?

Our collective ignorance peaked after the Lagman decision allowing martial law in all of Mindanao.

Our 1987 Constitution only allows martial law if there is actual rebellion, meaning actual shots fired to overthrow our government

This rule emphasizes "actual." Martial law merely for the threat of rebellion was prohibited after Marcos, or it would be too easy to declare martial law like Marcos.

Thus, the Lagman case revolved around whether there was actual rebellion in all of Mindanao, even though the actual shooting was only in Marawi.

Except for Justice Marvic Leonen, all justices accepted there could be actual rebellion in Marawi itself. This was the decision's starting point.

The majority deferred to the President's judgment that the rebellion covered all of Mindanao, given armed groups' mobility and that groups in other provinces might join the fighting.

Chief Justice Maria Lourdes Sereno, Senior Associate Justice Antonio Carpio and Justice Alfredo Benjamin Caguioa found this speculative. They would limit

martial law to only Lanao del Sur. Frustratingly, the most ignorant in media dismissed them as "partial" dissenters.

The same ignorant mediamen hyped Leonen's as the only "true" dissent. He rejected martial law even in Marawi, discarding the actual rebellion framework for a hodgepodge of unrelated, doctrinally strained theories.

The hype and ignorance sidelined the key actual rebellion debate. Now, faced with a second martial law extension, we remain collectively ignorant as to why the context is totally different if the actual shooting is now over.

We must resolve two crucial problems. First, how would there be actual rebellion now?

The need to rebuild Marawi is not it, or we could declare martial law after Supertyphoon "Yolanda."

Renewed extremist recruitment and threats of future attacks are not actual rebellion, either. The New People's Army obviously cannot be a ground for extension because it was not a ground for the initial declaration.

But second and far more important, even if the factual basis existed, what new

powers would martial law give now that the shooting has stopped?

Our 1987 Constitution now limits martial law to the military administering a combat zone where civilian government has collapsed. Solicitor General Jose Calida himself argued in the Lagran hearings that it is now a symbolic exclamation point. It grants no actual powers outside combat zones.

Think about it. Even without martial law, we can rebuild Marawi and even deploy troops to help, as we have done for every calamity.

Even without martial law, we can arrest suspected rebels. The arrest order against suspected Maute group members was based on the "continuing crime" in criminal law doctrine and not martial law, which is why it applied outside Mindanao.

The military may launch offensives. They did so against the NPA, even outside Mindanao.

We may deploy troops to guard Marawi, although they need to coordinate with the mayor.

Military intelligence may monitor suspected terrorist recruitment, as they were before fighting broke out in Marawi.

Visualizing every possible scenario, one can only conclude that if the actual fighting has stopped, martial law would have a mere symbolic effect. It cannot authorize anything our government does not already have the power to do.

Then what are we debating? What would be the point of extending martial law other than for show?

As is par for the course, it seems only Drilon has thought this through.

Cutting the funds flow to the CPP-NPA

RESIDENT Rodrigo Duterte could not hide his frustration when he recently declared the CPP-NPA a terrorist organization.

This came in the heels of an earlier presidential decision to terminate all talks with the CPP-NPA-NDF leadership based in the Netherlands.

To the layman, the termination of the on again-off again talks with Jose Maria Sison and company is fairly understandable. Sison et al have not shown any good faith in dealing with the government. While the talks were going on, the CPP-NPA on the ground did not stop attacking government troops and extorting from business establishments in their areas of influence.

In fact, many have been wondering why it took so long for the President to pull out of the talks

But the declaration of the CPP-NPA (but not the NDF) as a terrorist group is something else and it needs further explanation.

By way of background, the United States has long declared the CPP-NPA as terrorists. The US has been badgering the Philippines to do the same. Sison et al, for their

part, deny to death that they are a terrorist group.

So why is so much importance attached to the label?

The short answer is:

Post 9/11, a terrorist organization will find it more difficult, although not impossible, to raise funds and to move it around in order to finance its activities.

It all started when the the UN Security Council adopted a wideranging resolution demanding that member countries take action to suppress terrorist financing.

One hundred fifty governments responded positively and have since passed legislation criminalizing terrorist financing, and also requiring financial institutions to report suspicious transactions.

In these jurisdictions, banks are now required to check their clients and third parties involved in transactions against a list of suspected terrorists

The same governments have also ratified the UN Convention on Financing Terrorism. The convention has created a greater degree of international cooperation in tracking down terrorist financiers.

To a certain extent, the legal measures have disrupted the flow of funds used for terrorist activities, constraining overall capabilities of terrorists and helping frustrate their ability to timely execute attacks.

With such measures applying to the CPP-NPA, the group needs to work doubly hard to source their requirements outside of their usual "charitable" sources.

Martial law extension a must to curb terror sympathizers: DND

MANILA -- The extension of martial law in Mindanao is essential to completely curb threats from sympathizers of the Maute-ISIS, the Department of National Defense (DND) said Sunday.

"It will help us to continue our momentum in our campaign against the Daesh (Arabic word for ISIS) and their sympathizers and not to do so will allow them to regroup again. (And) as you know there have been reports that they are recruiting already in the Lanao area so I think this will help curb their activities on the ground." DND public affairs chief Arsenio Andolong said in an interview.

"If we don't have martial law, it will be very difficult for the rehabilitation of Marawi and the other war torn areas in the area," he added.

"We're going to move logistics ano yung mga equipment, pagka sila'y nakakaikot ng malaya dun, they can hamper yung pagre-rebuild natin di ba, kasi paano natin matutuloy yun eh kung hindi natin masecure yung area, papunta pa yung mga engineers natin e baka masambushna yung mga ganun ba," Andolong said.

When asked whether terror threats remain in Mindanao. Andolong said "there is a threat. In terms of seriousness kasi relative yun sa iba-ibang areas eh. pero meron. It is there, it is credible."

On July 23, the Congress, voting 261-18, extended martial law in Mindanao until yearend.

In October, Lorenzana announced the end of the five-month long conflict between government forces and Maute terrorists in Marawi City following the death of top terrorist leaders Omar Maute and Isnilon Hapilon.

Andolong, meanwhile, echoed Defense Secretary Delfin Lorenzana's stand saying there would be no holiday ceasefire with Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

"Nagsalita na si Secretary Lorenzana dyan that he is not inclined to declare a suspension of military operations this Christmas because it will give them (NPA) a chance also to continue their attacks on our outpost, they are taking potshots at our troops and policemen and he does not relish that and we will be giving them a chance do all of that during the Christmas season." he added. PNA)
