

Congress sets joint session on Rody proposal

The threat posed by comnunist rebels was one of he reasons cited by Presitent Duterte to justify his equest for Congress to exend martial law in Mindmao by one more year.

In a letter to the House of

Representatives and the Senate dated Dec. 8. Duterte said the New People's Army intensified its rebellion and "terrorist attacks" against civilians while the government was busy addressing the problems caused by jihadists

"The New Leonie's Army tool, advantage of the situation and intensified their decades-long rebellion against the government and stepped up terrorist acts against innocent civilians and private entities as well as guerrilla warfare against the security sector and public and government infrastructure, purposely to seize political power through violent means and supplant the country's democratic form of government with communist rule," the President said.

"These recent developments involving the NDF-CPF-NPA (National Democratic Front-Communist Party of the Philippines-New People's Army Forebode another vear of intensified armed hostilities was the together

with other security concerns described above, continue to make Mindanao the hotbed of

rebellion," he added. The NPA is the armed component of the communist movement while the CPP serves as its political arm. The NDF used to represent the rebels in the peace talks with the government before negotiations collapsed this year.

Duterte is asking Congress to extend martial law in Mindanao by one year to curb the threats posed by the Islamic State (IS)-linked terrorists who survived the Marawi siege and other armed groups.

The President imposed military rule in Mindanao on May 23 after terrorists laid siege to Marawi City, kidnapped dozens of civilians and burned several buildings.

Congress voted to extend martial law until the end of the year last July. The President did not mention the communist threat when he sought an extension of martial law in Mindanao five months ago.

Duterte declared Marawi liberated from terrorists last October but did not lift martial law because of supposed for judicial remedy." ... threats in other parts of Mindanao like Basilan and Sulu.

Last week, the military recommended a one-year extension of martial law in Mindanao, saying the government needs to run after other armed groups in the south.

Civil society groups and the political opposition are concerned that the extension of martial law in Mindanao would lead to abusive practices and human rights violations.

tension two weeks after he terminated peace talks with communist rebels, whom he accused of pushing for a coalition government.

The request also came a week after he declared the NPA and the CPP as terrorist groups.

The extension of military rule in Mindanao has to secure the nod of Congress, which will go on a month-long break from Dec. 15.

Presidential spokesman Harry Roque said the administration expects intensified clashes between government forces and communist rebels.

Roque said the President would use the "full force" of martial law against the NPA "as long as there are acts of rebellion being committed in the island province of Mindanao."

Asked if an arrest order would also be issued against NPA members, Roque said: "Of course, That goes without saying that the martial law administrator is empowered to order the arrest of individuals and because the privilege of the writ of habeas corpus is also suspended, then they would have to await the lifting of martial law

In his letter, Duterte said the NPA has perpetrated a total of 385 atrocities in Mindanao, which resulted in the death of 41 government troopers and the wounding of 62 others.

The violent incidents involving communists also left 23 civilians dead and six others wounded, he added.

Duterte said the communist insurgents also staged 59 arson incidents in Mindanao and has destroyed P2.2 billion worth of properties. Among the com-

panies attacked by the rebels were the Lapanday Food Corp. in Davao City, the Mil-Oro Mining and Frasec Ventures Corp. in Davao Oriental.

He said the atrocities prompted him to issue Proclamation 360 declaring the termination of peace negotiations with the communists and Proclamation 374 labeling the CPP and NPA as terrorist organizations.

Other threats

The President also cited the threats posed by remnants of the Maute group, the Abu Sayyaf and the Bangsamoro Islamic Freedom Fighters (BIFF) in his letter to Congress

He said the remnants of the group of terrorist leader Isnilon Hapilon and brothers Abdullah and Omar Maute have continued to recruit and train new members and fighters. Hapilon and Omar died in a clash last October while Abdullah was killed last September.

Duterte claimed that at least 185 persons listed in the martial law arrest orders remain at

large. He said members of the ISinspired Da'awatul Islamiyah Waliyatul Masriq and their supporters have been building up finances and logistics and reorganizing in Central Mindanao, particularly in Maguindanao, North Cotabato, Sulu and Basilan.

"These activities are geared toward the conduct of intensified atrocities and armed public uprisings in support of their objective of establishing the foundation of a global Islamic caliphate and of a wilayat (state or province) not only in the Philippines but also in the whole of Southeast Asia," Duterte said.

The President also men-

tioned the presence of a certain Turaife group, which was reportedly planning to stage bombings in Cotabato.

He said Abu Turaife, described by some reports as a commander of a BIFF breakaway group, is a "potential successor" of Hapilon as an emir of the IS in the Philippines and Southeast Asia.

Duterte said the BIFF, breakaway group of the Moro Islamic Liberation Front, continued to defy the government by perpetrating at least 15 violent incidents during the martial law period in Maguindanao and North Cotabato. The group has initiated at least 89 violent incidents this year, he added.

The remnants of the Abu Sayyaf, Duterte claimed, remain a "serious security concern." The terrorist group is believed to have presence in Basilan, Sulu, Tawi-Tawi and Zamboanga peninsula.

Duterte said the Abu Sayyaf, which has been involved in several kidnapping incidents and bombings, has conducted at least 43 acts, of terrorism which claimed the lives of eight civilians, three of whom were beheaded.

Joint session

The Senate and the House of Representatives would convene and hold this week a joint. session to deliberate on the proposal of President Duterte to extend martial law in Mindanao for another year.

"Our session officially ends on Friday, Dec. 15; hence, we may have a joint session on Thursday or Friday as part of the 2nd Regular Session, without need of a special session," House Majority Leader Rodolfo Fariñas told reporters in a Viber group message.

Fariñas said there is no

need to hold a special session as espoused by Malacañang earlier to discuss the martial law request, since Congress has until Dec. 15 to deliberate on it before it adjourns for the Christmas break.

Security officials are expected to brief senators today on the situation in Marawi City and other parts of Mindanao, which Duterte said remains under serious threat not only from Islamic extremists but also communist rebels.

Senate President Aquilino Pimentel III said economic managers and human rights officials will also give their respective briefings and answer questions from senators.

"Then, Wednesday morning is the joint session. We start in the morning, I don't know what time we'll finish," Pimentel told reporters

The Senate last night approved the concurrent resolution calling for a joint session of Congress on Wednesday.

Under the Constitution, the president needs congressional permission to extend any existing declaration of martial law.

The Senate and the House are to vote jointly, so senators are expected to be outvoted by the congressmen.

Meanwhile, opposition Rep. Edcel Lagman of Albay yesterday said Duterte's request for a one-year extension "amounts to a patent violation of the safeguards which the 1987 Constitution imposes for the limited grounds and duration of martial law and its extension.

It is also a "malevolent perpetuation of the subjugation of the supermajority in the Congress by the President even against the unequivocal provisions of the Constitution protecting civil liberties and the rule of law."

The Philippine Councilors League (PCL) of the Philippines expressed support for Duterte's request for an extension of martial law in Mindanao for another year.

The PCL endorsed to the President its support to the recommendation of the Department of National Defense (DND) and the Department of the Interior and Local Government (DILG) on the extension of martial law.

Davao City Councilor Danilo Dayanghirang, chair of the PCL, said Mindanaoans have noted a surge in investors who felt that their investments are more secure under martial law.

Activists of the human rights group Karapatan, however, claimed that the extension of martial law in Mindanao could bring the country closer to nationwide military rule.

This is a dangerous precedent that inches the entire country closer to a nationwide declaration of martial rule. Martial law in Mindanao has paved the way for the intensification of rights violations - both within and outside of Marawi," Cristina Palabay, secretary-general of Karapatan said.

Since the declaration of martial law last May 23, Karapatan said it recorded at least 29 victims of extrajudicial killings, including 15 cases in Southern Mindanao.

Many of the supposed victims were members of local peasant organizations and affiliates of the Kilusang Magbubukid ng Pilipinas (KMP), who were targeted for their local campaigns for genuine agrarian reform and against militarization. - With Delon Porcalla, Paolo Romero, Michael Punongbayan, Edith Regalado, Artemio Dumlao, Roel Pareño

PRRD justifies extension of martial law

Malacañang on Monday released a copy of President Rodrigo R. Duterte's letter to Congress requesting to extend the validity of martial law in Mindanao for another year, citing threats from ISIS-inspired groups and the communist rebels. In a letter addressed to Senate President Aquilino Pimentel

III and House Speaker Pantaleon Alvarez, the President

justified that further extension of the implementation of martial law and the suspension of the writ of habeas corpus in Mindanao will help military and the police and all other law enforcement agencies to "quell completely and put an end to the ongoing rebellion on Mindanao and prevent the same from escalating from other parts of the country."

"Public safety indubitably requires such further extension, not only for the sake of security and public order, but more importantly to enable the government and the people of Mindanao to pursue the bigger task of rehabilitation and the promotion of a stable socioeconomic growth and development, Duterte said in his letter dated December 8, 2017.

Regrouping forces

Duterte said martial law administrator Defense Secretary Delfin-Lorenzana recommended a one-year extension of martial law to "ensure total eradication of the DAESH-inspired Da'awatul Islamiyah Waliyatul Masriq, other like-minded local and foreign terror groups and armed lawless groups, the communist terrorists and their coddlers, supporters, and financiers."

In his letter, the President said the recommendation was based on the security assessment made by the AFP, and a separate evaluation from the PNP.

Duterte said he is seeking an extension of the validity of martial law and the suspension of the writ of habeas corpus from December 31, 2017 to December 31, 2018, "or for such other period of time as the Congress may determine, in accordance with Section 18, Article VII of the 1987 Philippine Constitution."

Despite the death of the Maute brothers and Isnilon Hapilon, Duterte said there are remnants of the terror group who have continued to rebuild their organization through the recruitment and training of new members and fighters to carry on the rebellion, noting that 185 of those who were listed in the martial law arrest warrants have remained at-large, "in all probability, are presently regrouping and consolidating their forces."

NPA, Turaifie group

Another concern is the Turaffie group, which he said, has been "monitored to be planning to conduct bombings, notably targeting the Cotabato area. The group's leader is said to be Hapilon's potential successor as emir of DAESH Wilayat in the Philippines and Southeast Asia.

Furthermore, Duterte said the Bangsamoro Islamic Freedom Fighter (BIFF) continues to defy the government by perpetrating at least 15 violent incidents during the martial law period in Maguindanao and North Cotabato. This year alone, the President said the BIFF has initiated at least 89 violent incidents, mostly harassments and roadside bombings against government troops.

Duterte also cited the remnants of the Abu Sayyaf Group remain a security concern in Mindanao, especially in Basilan, Sulu, Tawi-Tawi, and Zamboanga Peninsula. The ASG, on the other hand has conducted at least 43 acts of terrorism, including attacks using improvised explosive devices (IEDs), harassments and kidnappings this year which resulted in the killing of eight.civilians, three of whom were mercilessly beheaded.

The President also included in the list of security threats in Mindanao the Communist Party of the Philippines and the New People's Army (CPP-NPA).

The NPA has perpetuated a total of at least 385 atrocities in Mindanao this year resulting in 41 deaths and 62 wounded on the part of government forces.

Apart from other killings and atrocities involving the NPA, the Chief Executive said 59 arson incidents were carried out this year by communist rebels in Mindanao, targeting businesses and private establishments, and destroying an estimated P2.2 billion of properties.

Go after looters

The Metro Marawi Chamber of Commerce and Industry (MMCCI) vice president Solaiman L. Matonding is supporting the extension of martial law in Mindanao for "security reasons" but says government must ensure victims of looting and human rights abuses are "given justice."

Matonding, president of the Marawi Association of Internally Displaced Business Persons Association urged government to look into the looting allegedly perpetrated by members of the Armed Forces (AFP) in Marawi.

He said they likewise seek justice for victims of looting and human rights abuses and that culprits must be prosecuted, otherwise "it won't be wise to extend" martial law in Mindanao.

Stolen items included, among others, money, pieces of jewelry, sala sets, appliances, jars, decorations and even wooden doors made of "narra."


"Terrorists don't have cargo trucks to transport these things, only the military is capable of that," Matondingsaid.

He recommended to Task Force BangonMarawi the creation of a special body that will investigate possible abuses of the police and military and avoid "extortion by men in uniform" and establish a Marawi Inventory on Properties Damaged Board (MIPRODAB) to conduct an official assessment of actual damage to private properties and business establishments.

Matending added they seek indemnification to all victims in the business sector.

The Marawi Chamber estimated losses in the business sector could reach \$\mathbb{P}8.8\$ billion.

2 dead, 8 hurt in Cotabato military truck accident

WO soldiers died and eight others were injured after a military truck traversing while turtle turned the Bulwang Spring/So Lukeke crossing in Antipas, Cotabato on Monday.

Lieutenant Silver Belvis, civil-39th Infantry Battalion (IB), said at about 9:30 a.m. in Barangay

Malatab a KM450 military truck military operations officer of the carrying a squad under the 39th IB tried to avoid hitting a child who suddenly crossed the Antipas-

Arakan road but its driver lost control of the wheel.

The driver swerved to the opposite lane to avoid the child but the vehicle flipped and fell 10 feet down the left side of the road killing the two soldiers and injuring eight others.

A separate police report identified the driver as Private First Class Manuel Lumanod, 32; he only sustained minor injuries.

The others injured were iden-

tified only by their last names as Lumanod; Corporal Anta; Private First Class Lacunsay, PFC Amarillo, PVT Guimay, PVT Gepitulan, PVT Alao and PFC Silva.

The dead soldiers were PFC Pregillana and PVT Marsaga. They were dead on arrival at Antipas Medical Specialist Hospital.

Belvis said the troops came from security operations in Arakan, North Cotabato.

4 soldiers dead in road accidents

FOUR soldiers died and 17 others were injured after when their trucks fell into ravines in accidents in North Cotabato and Zamboanga del Sur.

The latest incident occurred around 9:30 a.m. yesterday in Sitio Lukeke, Barangay Malatab, Antipas town in North Cotabato.

Soldiers from the 39th Infantry Battalion, coming from a security operation in the province, were on the way back to their detachment in Arakan town, when their truck avoided a child who suddenly crossed the road, said 1Lt. Silver Belvis, civil military operations officer of the Army's 39th IB.

The truck driver lost control of the military vehicle which overturned and fell into a 10-feet ravine at the left side of the road, Belvis said.

The incident left two soldiers

dead and eight injured. The names of the casualties were not immediately available.

In Pagadian City in Zamboanga del Sur, two soldiers died and nine others were injured in another vehicular accident in Barangay Lourdes at around 10:15 a.m. last Friday.

Maj. Richard Enciso, spokesman of the 1st Infantry Division, said the soldiers were evacuating three soldiers, wounded in a firefight earlier with New People's Army rebels in Laewood town, when their truck's brake malfunctioned and it subsequently fell into a ravine.

Enciso named the fatalities as Staff Sergeants Celerino Objero and Isgerie Papolonias. The wounded were Sergeants Bejakar Kasim and Roberto Rojas; Corporals Darryl Banares, Rodrigo Castillo, Melvin Calobong and Crisaldo Tan; Pfc. Jayson de Guzman; Pvt. George Bajo; and militiaman Romelson Tasa.

TWO enlisted personnel were killed while eight

TWO enlisted personnel were killed while eight others were wounded when the military truck they were riding overturned while avoiding a child who was crossing the highway in Cotabato.

Lt. Silver Belvis, Civil Military Operation (CMO) officer of the Army's 39th Infantry Battalion (IB), said the identities of the victims were not yet identified as of presstime while the wounded soldiers were taken to the nearest hospital.

Reports said the accident occurred at 9:30 a.m. in Crossing Bulwang Spring, Sitio Lukeke, Bgy. Malatab,

Cotabato.

Accordingly, the victims were enboard a military truck on their way back to Dilion TPB in Bgy. Doroluman, Arakan, Cotabato, when the accident happened.

The report said the truck was traversing along the highway when a child suddenly crossed, prompting the driver to apply the brakes, causing the vehicle to overturn and fell into a 10-foot canal on the left side of the road.

Because of the strong impact, two enlisted personnel were killed while eight others were wounded.





With ML, Duterte vows 'total eradication' of terrorists

PRESIDENT Rodrigo Duterte vowed the "total eradication" of Islamic State-insipired terrorists and communist rebels, including their coddlers, supporters and financiers should Congress heed his request to extend beyond Dec. 31 martial law in Mindanao for one more year.

Citing the continued threat of terrorism and rebellion in the region, which makes Min-

danao "the hotbed of rebellion, Duterte stressed Monday the need for a one-year extension of martial law to "ensure total eradication of DAESHinspired Da'awatul Islamiyah Waliyatul Masriq, other Local/Foreign like minded

Terrorist Groups and Armed 'Lawless' Groups, and the communist terrorists as well as their coddlers, supporters, and financiers."

"Public safety indubitably requires such further extension,

not only for the sake of security and public order, but more importantly to enable the government and the people of Mindanao to pursue the bigger task of rehabilitation and the promotion of a stable socioeconomic growth and development," Duterte said in his letter dated Dec. 8 to Senate President Aquilino Pimentel III and House Speaker Pantaleon Alvarez.

Remnants of Da'awatul Islamiyah and their allies have

been monitored towards continuing with their plan to build a "wilayat" or province for the Islamic State in Southeast Asiaactivities including recruitment and reorganization in Central Mindanao, particularly in Maguindanao and North Cotabato as well as Suin and Basilan, Duterte said.

The President referred to continuing threats posed by the Bangsamoro Islamic Freedom Fighters and Abu Sayyaf group carrying out acts of terrorism in various parts of the island.

In related developments:

· Congress will convene into

a joint session tomorrow to approve Duterte's request to extend martial law in Mindanao for another year, House Majority Leader and Hocos Norte Rep. Rodolfo Fariñas said on Monday.

Farifias said Congress would not hold a special session during the Christmas holiday break.

Speaker Pantaleon Alvarez said the House leadership would support the President all the way.

We support the President's desire to extend martial law in Mindanao to bring peace in Mindanao-'the hotbed of terrorism' as described by the President," Alvarez said.

· Two opposition lawmakers, meanwhile, opposed the Palace's declaration for martial law extension, saying this violated the Constitution.

"Where is the actual invasion or actual rebellion in Mindanao? The Constitution provides that martial law can only be declared and its extension authorized in case of invasion or rebellion when public safety requires it," Albay Rep. Edcel Lagman said, echoing the sentiments of partylist Rep. Carlos Zarate.

"Since the original or initiatory declaration of martial law is limited to not more than 60 days,

In seeking a yearlong extension of martial law in Mindanao, President Duterte told Congress on Monday of persistent security threats in the region, including remnants of Islamic State-inspired extremist groups, the rise of a "potential successor" to slain terrorist leader Isnilon Hapilon, and increasing hostilities with communist insurgents.

In a letter to Senate President Aquilino Pimentel III and Speaker Pantaleon Alvarez, Mr. Duterte said extending martial law and the suspension of the privilege of the writ of habeas corpus for one year would help the military, police and other law enforcement agencies to "quell completely and put an end to the ongoing rebellion in Mindanao" and prevent it from spreading to other parts of the country.

Mr. Duterte cited Defense Secretary Delfin Lorenzana's Dec. 4 letter recommending the extension of martial law based on the security assessment of the military.

In response to the President's letter, House Majority Leader Rodolfo Farinas said the Senate and the House of Representatives would have a joint session on Wednesday, the last session day of Congress this year, to discuss whether to grant the extension.

Siege of Marawi

Mr. Duterte initially imposed military rule across Mindanao on May 23 to quell an uprising by local terrorists loyal to the Islamic State (IS) jihadist group in Marawi City.

Hundreds of gunmen rampaged through Marawi in what Philippines and Southeast Asia.

authorities said was part of a campaign to establish a Southeast Asian enclave for IS.

A military campaign backed by the United States, Australia and China took five months to defeat the terrorists, with the conflict claiming more than 1,100 lives and leaving large parts of Marawi in ruins.

'Despite the death of Hapilon and the Maute brothers, the remnants of their groups have continued to rebuild their organization through the recruitment and training of new members and fighters to carry on the rebellion," Mr. Duterte said in his letter to Congress.

He said at least 185 people listed in the martial law arrest orders remained at large and "in all probability, are presently regrouping and consolidating


their forces."

Mr. Duterte said the Islamic militants had apparently found a "potential successor" to Hapilon as emir, or leader, of their planned IS province in the Turaifie group

The President said a band of extremists known as the "Turaifie group" had been monitored to be planning to conduct bombings, notably targeting the Cotabato area.

The band is led by Esmail Sheikh Abdulmalik, alias Abu Turaifie, a former Moro Islamic Front Liberation Bangsamoro Islamic Freedom Fighters (BIFF) leader who formed his own group, the Jamaatul Muhaajireen Wal Ansar, in April. His group is allegedly recognized by IS.

"Turaifie is said to be Hapilon's potential successor as [leader of the IS province] in the Philippines and Southeast

Asia," Mr. Duterte said.

Hapilon was a leader of the notorious Abu Sayyaf bandit group and seen as the IS leader in Southeast Asia. He was killed in a targeted military operation in Marawi in October.

Mr. Duterte said the BIFF

"continues to defy the government by perpetrating at least 15 violent incidents during the martial law period in Maguindanao and North Cotabato."

He added that remnants of the Abu Sayyaf in Basilan, Sulu, Tawi-Tawi and Zamboanga

Peninsula remain as a serious ' security concern.

The group has committed at least 43 acts of terrorism this year, including bombings and kidnappings, which resulted in the death of eight people, three of whom were beheaded, Mr. Duterte said.

Communist rebels

"Last but certainly not the least," the President cited the threat posed by the communist New People's Army, whose members, he said, took advantage of the situation "while the government was preoccupied" with the IS-inspired terrorists.

He said the NPA rebels "intensified their decadeslong rebellion against the government and stepped up terrorist acts against innocent civilians, and private entities, as well as guerrilla warfare against the security sector and public and government infrastructure, purposely to seize political power through violent means and supplant the country's democratic form of government with communist rule."

Mr. Duterte said the NPA committed 385 "atrodities" in cluding "terrorism and guerrilla warfare in Mindanao."

Congress approved Mr. Duterte's initial imposition of martial law on the whole of Mindanao and in July extended its enforcement to the end of December. Now Mr. Duterte wants Congress to extend military rule and the suspension of the privilege of the writ of habeas corpus in Mindanao up to Dec. 31, 2018.

An opposition lawmaker said the President's request was tantamount to a "patent violation of the safeguards which the 1987 Constitution imposes for the limited grounds and dura-

tion of martial law and its extension."

Albay Rep. Edcel Lagman described the move as a "malevolent perpetuation of the subjugation of the supermajority in Congress by the President even against the unequivocal provisions of the Constitution protecting civil liberties and the rule of law."

"Where is the actual invasion or actual rebellion in Mindanao? The Constitution provides that martial law can only be declared and its extension authorized in case of invasion or rebellion when public safety requires it," Lagman said.

"Since the original or initiatory declaration of martial law is limited to not more than 60 days, it stands to reason that any extension is subject to the same constraints with respect to duration and grounds," he added.

Cagayan de Oro Archbishop Antonio Ledesma urged the government to enforce martial law in Mindanao only up the end of the year.

"In general, I am not in favor of it;" Ledesma told reporters on Monday.

He warned that the extension of military rule in Mindanao may adversely affect the island's economy.

Presidential spokesperson Harry Roque challenged the opponents of the extension to question it in the Supreme Court.

"They're free to challenge martial law anew in the Supreme Court, but please note that there [have] been two challenges and in both instances the Palace has been upheld," Roque told reporters. —WITH REPORTS FROM JULIE M. AURELIO AND AFP INQ

Congress to discuss martial law extension

EMBERS of the Senate and House of Representatives will discuss President Rodrigo Duterte's request to extend martial law in Mindanao for another year on Dec. 13, Wednesday.

Senate President Aquilino Pimentel 3rd said the two chambers will hold a joint session to tackle the President's letter asking congress to extend martial law.

Before the joint session, security officials will explain to senators why martial law should not be lifted.

Sen. Panfilo Lacson, chairman of the Senate Committee on Public Order and Dangerous Drugs, said Armed Forces.chief Rey Leonardo Guerrero and Defense Secretary Delfin Lorenzana will conduct the briefing.

"We'll find out what is the reason why there is need to extend," Lacson told reporters.

Lacson said he is not opposed to martial law extension because it would help security forces address other threats

particularly the Bangsamoro Islamic Freedom Fighters.

But Senate minority leader Franklin Drilon said same standards should be observed if martial law is extended. He explained the extension must be in accordance with the Constitution.

The President wants to extend martial law because of the continuing threat by armed groups in the area, but Drilon noted that it is not among the requirements stated in the constitution, such as there should be an actual [rebellion].

In his letter request sent to congress, Duterte cited the threats posed by "communist terrorists" whom he said took advantage of the situation to intensify their attacks against the government.

Palace spokesman Harry Roque

said martial law will be used to quell the possible intensified attacks of the New People's Army . (NPA) in Mindanao.

"For as long as there are acts of rebellion being committed in the island province of Mindanao, yes, he (Duterte) will use a full force of martial law against the NPA as well," Roque said in a news conference.

"We expect an intensified fighting on the part of the NPA. In fact, they have been exhibiting more intense targeting of ours soldiers and civilians after the President has already classified them as terrorist group," he added.

Duterte through Proclamation 374 declared the Communist Party of the Philippines and its armed wing, the NPA, as terrorist groups.

Roque said the act of rebellion perpetrated by NPA insurgents is a "continuing crime" that needs to be addressed by the government.

"We engaged them in peace talks and we hoped that in fact, there would be eventual peace between the government and the NPA. We were frustrated because as you know, they never stopped attacking soldiers and civilians," Roque

said. "Act of rebellion is a continuing crime. So for as long as they don't lay down their grounds, they are committing a criminal act."

Albay Rep. Edcel Lagman however strongly opposing the military's proposal to extend martial law, saying it is unconstitutional.

In a statement on Monday, Lagman said the extension of martial law is a "patent violation of the safeguards which the 1987 Constitution imposes for the limited grounds and duration of martial law and its extension."

[It is a] malevolent perpetuation of the subjugation of the supermajority in the Congress by the President even against the unequivocal provisions of the Constitution protecting civil liberties and the rule of law and blatant mockery of the liberality of the majority of the Supreme Court in upholding the President's past questionable actions," he added.

Lagman said that the extension cannot be backed by the Constitution because there is no actual invasion or rebellion in the Mindanao region.

SURIGAO CITY - Skirmishes between government forces and the New People's Army (NPA) erupted in this city after the Communist fighters launched two attacks in different parts of this city Sunday.

A.Philippine National Police (PNP) patrol car, bearing six policemen and a civilian, was ambushed in Kilometer 13, Barangay Anomar before a team from the PNP Surigao del Norte Provincial Mobile Force Company (PMFC) was attacked in Kilometer 12 in Barangay Trinidad that sparked fierce encounters between the two sides.

The police reported no casualty and on their side, and surmised that the Communist terrorists sustained heavy casualties based on the bloodstains they left behind in the areas of the encounters.

According to Surigao City Chief of Police Supt. Jay Baybayan, six policemen and a civilian were onboard a patrol car of the Claver Municipal Police Station, on their way to this city to have the vehicle repaired, when they were pounced upon by heavily armed men in Kilometer 13 in Barangay Anomar.

After this attack, the armed group struck anew in Kilometer 12 in Barangay Trinidad when it ambushed a PMFC team, led by Insp. Rodulfo Haradji.

Hot pursuit operations ensued with the PMFC being reinforced by elements of the Army's 402nd Infantry (Stingers) Brigade.

The Communist terrorists were believed to belong to the Sangay sa Partido Pamproganda (SPP) = 16-B and guerilla-Front Committee 16-C of the CPP-NPA Northeastern Mindanao regional Committee (NEMRC) under a certain "Commander Blu;" said Police Reginal Office 13 Regional Spokesperson Chief Insp. Renel E. Serrano.

"The gunfire took place but the NPA bandits retreated to a nearby hilly forested area after sensing they were outgunned, out-positioned and afraid of the reinforcement from nearby areas," PRO 13 Regional Director Chief Supt. Noli A. Romana said.

127 Sayyaf men slain, 90 held in W. Mindanao

ZAMBOANGA CITY -A total of 127 Abu Sayyaf bandits were killed while 90 others were arrested this year, a military official said yesterday.

In his annual report, Lt. Gen. Carlito Galvez Jr. of the Western Mindanao Command said 136 Abu Sayyaf bandits – 72 in Basilan, 43 in Sulu and 21 in Tawi-Tawi also surrendered.

Galvez said 230 firearms were recovered from the bandits.

He said the number of Abu Sayyaf members who were neutralized is almost five times higher compared to last year, which was only 75.

With intensified military operations, Galvez said kidnappings were down to only 12 compared to 23 in 2016.

The bandits are still hold-

ing a Dutch man, five Indonesians and three Filipinos.

Galvez said persónnel of the Joint Task Force Sulu led by Brig. Gen. Cirilito Sobejana, Joint Task Force Basilan under Brig. Gen. Juvymax Uy and Joint Task Force Tawi-Tawi led by Brig. Gen. Custodio Parcon are leading the operations to finish off the Abu Sayyaf and recover its remaining hostages.

Sobejana said they are running after 400 bandits led by Radulan Sahiron in Sulu.

In Basilan, Uy said they are pursuing 102 bandits led by Furuji Indama.

The military had set a deadline of until June this year to defeat the Abu Sayyaf.

The campaign was disrupted after Maute militants and their Abu Sayyaf cohorts attacked and occupied Marawi on May 23.

Duterte lists reasons for seeking ML extension

PRESIDENT Duterte yesterday formally asked Congress for another extension of his martial law (ML) declaration in Mindanao, this time lasting for a year, citing recruitment activities of the Maute terror group which attacked Marawi City in May, and its efforts to reorganize.

He also said other Islamic Stateinspired groups and armed groups are planning bombings in the southern part of the country.

"These activities are geared towards the conduct of intensified atrocities and armed public uprisings," Duterte said, adding the activities are aimed at establishing a global Islamic caliphate and a 'wilayat' not only in the Philippines but the whole of Southeast Asia.

He also cited attacks by the communist New People's Army which he recently declared a terrorist group together with the Communist Party of the Philippines.

The President made the request in a letter dated December 8 sent to Congress yesterday.

House majority leader Rodolfo Fariñas said the House and the Senate will hold a joint session on the President's request tomorrow, the last session day before Congress goes on a Christmas break.

Senate President Aquilino Pimentel III said senators will receive a briefing today from security officials on the martial law declaration.

Duterte declared martial law on May 23, the day the Maute Group attacked Marawi. In July, he asked for an extension and Congress extended martial law to December 31.

The battle between government

forces and the Maute lasted for five months.

Duterte said a one-year extension is needed "primarily to ensure total eradication of Daesh-inspired Da'awatul Islamiyah Waliyatul Masriq, other like-minded local/ foreign terrorist groups and armed lawless groups, and the communist terrorists and their coddlers, supporters and financiers."

He said security forces have monitored continued recruitment activities by in Central Mindanao by the Maute Group despite the deaths of the Maute leaders and of Isnilon Hapilon, an Abu Sayyaf leader said to have been anointed by the Islamic State as its southeast Asia leader.

Duterte also said at least 185 people, whose names are in arrest orders issued during the martial law period, have yet to be arrested.

The President said other reasons for seeking an extension are reports that a group headed by a "Turifie," who is reportedly being groomed to replace Hapilon, is planning bomb attacks in the Cotabato area; continuing harassments activities and attacks by the Bangsamoro Islamic Freedom Fighters; threats from the Abu Sayyaf particularly in Basilan, Sulu, Tawi-Tawi, and the Zamboanga Peninsula; threats and

He said the extension aims to give security forces time to put an end to the ongoing rebellion in Mindanao and prevent it from escalating and spilling to other parts of the country.

"Public safety indubitably requires further extension, not only for the sake of security and public order, but more importantly to enable the government and the people of Mindanao to pursue the bigger task of rehabilitation and the promotion of a stable socioeconomic growth and develop-

ment," he added.

Martial law allows for tougher surveillance and arrests without warrant, giving security forces greater rein to go after suspected extremist financiers and facilitators.

Duterte has long warned that Mindanao faced contamination by Islamic State, and experts say Muslim parts of the predominantly Catholic southern Philippines are fertile ground for expansion, due to their history of marginalization and neglect.

WHAT REBELLION?

Critics of Duterte, who has held open the possibility of extending military rule to the whole country, have slammed the imposition of martial law in Mindanao as a misuse of power and evidence of the president's authoritarian tendencies.

Rep. Edcel Lagman (LP, Albay), a member of the opposition bloc, said Duterte's request is "patent violation of the safeguards which the 1987 Constitution imposes for the limited grounds and duration of martial law and its extension."

Where is the actual invasion or actual rebellion in Mindanao? The Constitution provides that martial law can only be declared and its extension authorized in case of invasion or rebellion when public safety requires it," Lagman said.
He said there is no more fac-

tual basis for the extension of martial law in Mindanao after the President declared the liberation of Marawi City in October.

Senate minority leader Franklin Drilon said there should be an "actual" armed uprising constituting rebellion or invasion, and when public safety requires the declaration of martial law. - With Wendell Vigilia, JP Lopez, Victor Reyes, Ashzel Hachero and Reuters

The AFP said it was the third time the beverage company sent a donation for soldiers killed in Marawi.

Terror threat, NPA attacks cited in Duterte's plea for ML extension

President Rodrigo Duterte has officially asked Congress to extend martial law in Mindanao until the end of next year to combat Islamist militants and communist rebels.

In a five-page letter addressed to Senate Aquilino President Pimentel III and Speaker Pantaleon Alvarez dated December 8, the Chief Executive said the extension was necessary to contain an ongoing rebellion by supporters of

the Islamic State group as well as a rising threat from the New People's Army (NPA) communist guerrillas.

"I ask the Congress of the Philippines to further extend the proclamation of Martial Law and the suspension of the privilege of the writ of habeas corpus in the whole of Mindanao for a period of one year," from January 1, 2018, the letter stressed.

Speaking to reporters, presidential spokesman Harry Roque said the government was expecting that members of the NPA would carry out "intensified" attacks against troops, that the especially

MEMBERS of the Senate and the House of Representatives will hold a joint session tomorrow to deliberate on the request of President Rodrigo Duterte for the extension of martial law in Mindanao.

Speaker Pantaleon Alvarez yesterday received the formal request from President Rodrigo Duterte on the further extension of the proclamation of martial law and suspension of the privilege of the writ of habeas corpus in Mindanao.

Majority Leader Rodolfo Fariñas provided the media

a copy of the letter. With the recommendation from the Armed Forces of the Philippines (AFP) and Philippine National Police (PNP), President Duterte requested Congress to extend the proclamation of martial law in Mindanao from

January 2018 to December 2018.
The last session day of Congress for this year is on December 13, but with this letter, the lawmakers may

delay their Christmas break.

Fariñas said there is no need for a special session as

they can hold session until Friday. "Our session officially ends on Friday, December 15; hence, we may have a joint session on Thursday or Friday as part of the Second Regular Session, without need of a special session," Fariñas said in a text message to

Farinas added that Speaker Pantaleon Alvarez told him they will discuss the letter with their Senate coun-

terparts.

It can be recalled that the proclamation of martial law was already extended until December 31 of this year

when it was declared last May 23.

President Duterte was prompted to declare martial law in Mindanao when the Maute Group attacked and terrorized Marawi City last May 23. The war between government troops and Maute Group lasted until October.

Mauteleader Omar Maute and Isnilon Hapilon of the Abu Sayyaf Grouop were killed by the soldiers.

Senators on ML extension

Extending martial law in Mindanao for another year will be beneficial for the people and the region, according to some senators.

Sen. Manny Pacquiao said he is in favor of the request of extension martial law in Mindanao by another year. Pacquiao, a party mate of Duterte under PDP-

Laban, said residents of Mindanao feel safer with martial law in place.

Former Solicitor General Florin Hilbay yesterday said there is no legal basis for an extension of martial law in Mindanao, adding that there is no such thing as "preventive martial law" in the 1987 Constitution.

Hilbay said the Constitution was very clear on the reason for allowing the President to declare martial law, which is either an actual invasion or rebellion and when the public safety requires it.

He stressed that though in all likelihood, President Duterte will get congressional support for his request for a one-year extension of martial law in the region, political support is different from complying with the provisions of the Constitution.

"There is no such thing as preventive martial law. Political support for martial law is different from constitutional compliance," Hilbay said.

House okays pay hike for cops, soldiers

VOTING 167 against four, the House of Representatives yesterday approved on third and final reading House Joint Resolution No. 18 authorizing the compensation adjustment for military and uniformed personnel (MUP) in the government, including doubling the base pay of rookie cops, soldiers, firefighters and jail guards which will require P63.4 billion starting next year.

Davao City Rep. Karlo Nograles, the committee

Davao City Rep. Karlo Nograles, the committee chairman, said it means that a rookie cop will enjoy a 100 percent increase in the thought base pay from the current P14,834 to P29,668.

"This is in recognition of the critical role of the military and police in maintaining national security and peace and order, as they exercise their duty to ensure the safety of our citizens being exposed to various high peril environments and life-threatening risks, in the discharge of their functions," Nograles explained. Nograles, Speaker Pantaleon "Bebot" Alvarez, and House Majority Leader and Ilocos Norte Rep. Rodolfo "Rudy" Farinas underscored the importance to increase the compensation package of MUP because of their crucial role in ensuring the safety and peace and order of the country.

Under the joint resolution, the Department of Budget and Managements aid the resolution will double the base pay of a police officer (PO) I in the Philippine National Police (PNP), a private in the Department of National Defense (DND), and equivalent ranks in the Bureau of Jail Management and Penology (BJMP), Bureau of Fire Protection (BFP), Philippine Public Safety College (PPSC), Philippine Coast Guard (PCG) and the National Mapping and Resource Information Authority (NAMRIA).

But the measure said that the modified base pay schedule for MUP shall be implemented in two tranches charting 2018 and 2019.

starting 2018 and 2019.

"Pending review of the current MUP pension system by the legislative and executive branches of government, which is aimed towards ensuring a sustainable and equitable pension system, the indexation of the pension of retired MUP with base pay of those in the active service shall be suspended with respect to the base pay increase authorized in the joint resolution," it said.

It was learned from the proposal that the overall adjustments will result in a 58.7 percent average increase in base pay for all MUP ranks.

It also said that the provisional and officers' allowances will no longer be part of the compensation of MUP as these are granted as an interim measure pending the modification of the base pay schedule.

The measure also provides that the increase in the compensation of the MUP will be funded from the Miscellaneous Personnel Benefits Fund (MPBF), and from any available allotment in the respective budgets of the agencies concerned.

Duterte asks Congress for ML extension

THE threats from ISIS-inspired groups and the Reds has prompted President Rodrigo Duterte to formally request Congress to extend martial law in Mindanao for a war.

wrote

Duterte said remnants of the groups of the Maute brothers and Abu Sayyaf leader Isnilon Hapilon have started recruiting and training new fighters. Members and allies of the DIWM, for instance, were monitored continuing their efforts in regrouping in Maguindanao and North Cotabato as well as Sulu and Basilan, geared to establish a wilayat in the Philippines and Southeast Asia

The President also cited the Turaifie Group, which was allegedly monitored planning bombings in the Cotabato area.

He said that Turaifie is believed to be Hapilon's potential successor as ISIS emir in Southeast Asia.

In his letter, Duterte also mentioned the Bangsamoro Islamic Freedom Fighters and the Abu Sayyaf group attacks.

Duterte also pointed out the threat of the New People's Army, which he said took advantage of the situation in Mindanao and intensified its "terrorist acts." In his letter, the President listed down the NPA's activities against the government.

"These recent developments involving the NDF-CPP-NPA for ebode another year of intensified armed hostilities which, together with other security concerns described above, continue to make Mindanao the hotbed of rebellion," he said.

Palace releases letter seeking ML extension

Malacañang yesterday released a copy of President Duterte's letter to Congress requesting the extension of martial law in Mindanao for another year, citing threats from Islamic State-inspired groups and communist rebels.

In the letter addressed to Senate President Koko Pimentel and House Speaker Pantaleon D. Alvarez, Duterte justified that a further extension of martial law and the suspension of the Writ of Habeas Corpus in Mindanao will help the military and the police and all other law enforcement agencies to "quell completely and put an end to the ongoing rebellion on Mindanao and prevent the same from escalating from other parts of the country."

"Public safety indubitably requires such further extension, not only for the sake of security and public order, but more importantly to enable the government and

the people of Mindanao to pursue the bigger task of rehabilitation and the promotion of a stable socio-economic growth anddevelopment," Duterte said in the letter dated Dec. 8, 2017.

Duterte said martial law administrator Defense Secretary Delfin Lorenzana recommended a one-year extension of martial law to "ensure total eradication of the Daesh-inpsired Da'awatul Islamiyah Waliyatul Masriq, other like-minded local and foreign terror groups and armed lawless groups, the communist terrorists and their coddlers, supporters, and financiers."

The Chief Executive said the recommendation was based on the security assessment made by the Armed Forces and a separate evaluation from the Philippine National Police. (Roy C. Mabasa)

Gov't asks for vigilance

Malacañang yesterday urged Filipinos to be always on guard and coordinate with authorities following reports that another terror group is reportedly plotting to attack a certain city or area in Mindanao.

In a radio interview, Presidential Communications Office Secretary Martin Andanar confirmed that Daulah Islamiyah, an umbrellatype of armed militant group, is currently on a recruitment binge and is said to be planning to attack a still unverified city orarea in Mindanao.

"There are reports that they are planning to invade a place in Mindanao, but we don't know the place yet. That why the AFP and the PNP have issued stern warnings to our people in Mindanao to be very cautious and always be on guard," Andanar said. (Roy C. Mabasa)

AFP wary of terror reprisal

The Armed Forces of the Philippines has instituted stringent measures to prevent foreign and local terrorists from launching any attacks in Mindanao similar to what happened to Marawi City.

AFP-Public Affairs Office (AFP-PAO) chief Marine Colonel Edgard Arevalo gave this assurance after the remark made by Presidential Communications Secretary Martin Andanar regarding alleged plans of the terrorist group Daulah Islamiyah attack another city in Mindanao.

"We have instituted stringent measures to keep foreign and local terrorists in check. These include constant coordination with other intelligence agencies of government through established platforms. We have protocols that we observe and continuously undergo updating," said Arevalo.

Arevalo added that the active participation of the public and community will also help in ensuring that terrorists will not succeed in launching any kind or form of attacks.

"But at the end of the day, the active involvement of our people and institutions of government that shall render our security posture strong and effective," said Arevalo.

Meantime, Metro Marawi Chamber of Commerce and Industry (MMCCI) vice president Solaiman L. Matonding agreed to extend martial law in Mindanao to one year for "security reasons."

But at the same time, Matonding wants government to ensure victims of looting as allegedly perpetrated by members of the Armed Forces of the Philippines (AFP) be "given justice."

Matonding, who is also President of the Marawi Association of Internally Displaced Business Persons Association, appealed to government to look into the issue hoping for culprits to be prosecuted, otherwise, he said, "it won't be wise to extend" martial law in Mindanao. Military won't give in to holiday truce pleas

The military is not inclined to give in to a Christmas truce with the Communist Party of the Philippines New People's Army-National Democratic Front (CPP-NPA-NDF) despite calls by some groups, including the Church.

This, according to Armed Forces of the Philippines (AFP) public affairs office chief, Col. Edgard Arevalo late Sunday.

"The AFP supports the wisdom and wise discretion of the CinC (Commander-in-Chief, President Rodrigo Duterte). He has already declared that there will be no unilateral ceasefire this December. The SND

(Secretary of National Defense Delfin Lorenzana) has made a similar announcement of his position on the matter," he added.

In the wake of continued NPA attacks, Arevalo said they see no difference this Christmas season.

The DND chief earlier had said he cannot recommend a "suspension of military operation" against as the CPP-NPA-NDF vowed to intensify attacks against military targets in wake of Proclamation 360 that terminated peace talks and negotiations with the latter.

Duterte signed the proclamation last November 23.

SUSPECTED New People's Army guerrillas harassed a group of po-licemen who were on their way back to their headquarters in Surigao City late Sunday morn-ing but immediately retreated af-ter the officers returned fire, the Caraga police director said yesterday

Police Regional Office 13 director Chief Supt. Noli A. Romana said the rebels fired shots at a convoy of vehicles bearing members of the Surigao del Norte Provincial Public Safety Company while passing along Bgy. Trinidad, Surigaq City at 10 a.m. "It was a mere NPA harassment

"It was a mere NPA harassment since no one was hurt on our side and not a single bullet struck any of our vehicles," Romana said.

The Caraga police director said that the officers under Supt. Diomedes Chadra Jr. immediately returned fire at the rebel position and forced them to retreat. Security troops are still tracking down at least 45 guerrillas led by alias Ka Jun' who were tagged led by alias 'Ka Jun' who were tagged as behind the harassment.

The harassment came as Philippine National Police troops nationwide were ordered to intensify intelligence operations to thwart attempts by the NPA to mount more terror attacks in the

to mount more terror attacks in the countryside in the wake of President Duterte's order declaring the CPP/NPA/NDF as a terrorist organization—"The Philippine National Police is prepared to address threats posed by the communist New People's Army against communities, industries, private businesses and government installations," said PNP spokesman Chief Supt. Dionardo B. Carlos amid warnings aired about resurgent NPA atrorings aired about resurgent NPA atrocities in the countryside in the aftermath of Presidential Proclamation No. 374 declaring them as terrorists.

According to the official, the PNP

According to the official, the PNP continues to maintain tactical capability thru its national, regional and provincial maneuver forces to respond to contingencies arising from CPP/NPA terrorist activities.

This was the case when PNP units successfully repulsed two separate hostilities staged by the CPP/NPA in Labo, Caracticas Norte and Binuangan Mis-

Camarines Norte and Binuangan, Misamis Oriental recently," he said.

But at the same time, Carlos warned that persons or entities providing financial and material support to the CPP/ NPA can be held liable for serious violation of law either as conspirators, accomplices or accessories to terrorism.

communist group that has been declared as "terrorists."

"For as long as there are acts of rebellion being committed in the island province of Mindanao, yes, he (Mr. Duterte) will use a full force of martial law against the NPA as well," he stressed.

"We expect an intensified fighting on the part of the NPAs. As in fact, they have been exhibiting more intense targeting of ours soldiers and civilians after the President has already classified them as terrorist group," the Palace official added.

Mr. Duterte last month called off peace talks with the communists, blaming continuing deadly attacks by the rebels

The President initially imposed military rule across Mindanao in May to quell an uprising by Islamic Stateinspired Maute groups in Marawi City.

Hundreds of gunmen rampaged through the Marawi in what authorities said was part of an attempt to establish a Southeast Asian base for IS.

Mr. Duterte declared in October that the city was "liberated" and military chiefs said most militant leaders, including the IS leader Isnilon Hapilon and Maute brothers Omarkhayam and Abdullah, had been killed.

But authorities have continued to warn that those who escaped are regrouping and recruiting in Mindanao.

In his letter, the Commander-in-Chief said martial law had been key to containing the IS supporters in Marawi.

"The remnants of their group have continued to rebuild their organization through the recruitment and training of new members and fighters to it stated.

Christmas break on December 15, and will resume sessions on lanuary 15, 2018.

Senators are set to hold a briefing with so-called martial law administrators today before they deliberate on the proposed extension of Mr. Duterte's proclamation that placed the entire Mindanao region under military rule.

The said proceedings prompted the committee on public information and mass media postpone its hearing which coincided with the said briefing and deferred to a later date.

The convening of the joint session was announced by Majority Leader Vicente Sotto III following his submission on the floor of Senate concurrent Resolution 9 for the said proceedings which will start at 9 a.m. on Wednesday.

The resolution was immediately adopted, subject to style, as there had been no objection on the floor from among the senators.

Pimentel said there may no longer be any need to hold special spssion by Congress to deliberate the proposed extension of martial law in Mindanao.

"We're expecting half day more or less (joint session). That's the idea," he stressed.

So far, Pimentel said he has yet to hear any negative report regarding the implementation of military rule in the past seven months in Mindanao.

"That's why tomorrow we need a briefing (to find out) what is now the factual basis. How come the military recommended the extension," he added.

The Senate chief said, security officials and those from the Executive will have to justify before them why a one-year implementation is being recommended.

Roque, however, said there are chances that the Commander in Chief might opt to shorten military rule in Mindanao if he deems so.

"I think they want a final period to deal with acts of rebellion. So let's just give them the leeway because, after all, as soon as it is extended. it can be cut short if there is no need for it," he stressed.

Congress likely to approve ML extension

The Senate and the House are set to hold a joint session this week to decide en Mr. Duterte's request to extend martial law for another vear.

Alvarez said the lower chamber is supportive of the proposal.

"Of course we are supportive of the President and we will approve the martial law extension," he added.

Alvarez expressed the view that military rule should be imposed for the duration of Duterte's term.

House Majority Leader Rodolfo Farinas said the joint session was arrived at after the 5-page letterrequest of the President was transmitted to the House of Representatives at noon on Monday.

Fariñas also reiterated that Congress has until Friday to discuss the martial law request because they still have ample time to deliberate on the request of Mr. Duterte.

According to Fariñas, extending martial law would have to be discussed with the Senate.

"We will have to discuss it with our Senate counterparts," he said. Congress is set to go on a

No legal basis

But rights groups and other critics warned that the President is destroying the country's democracy following his request to extend martial law in Mindanao. 🤄

Former Solicitor General Florin Hilbay said moves to extend military rule has shaky legal basis under the Constitution.

"Constitutional compliance is an entirely separate matter. So we need to clarify what martial law is all about. There is no such thing as preventive martial law," Hilbay opined. in a television interview where he was asked to comment on his. thoughts when the martial law. extension expires December 31.

He said if the President wants to extend the force of martial law in the entirety of Mindanao a fresh request for another extension is needed.

"And so we need to look at it at a constitutional stand point, there's no doubt in all likelihood the President would get the support of the House and the Senate? he added.

The former Solgen also said the Supreme Court has ruled that a declaration of martial law requires that there be an actual invasion or rebellion.

"Now if the President already declared, the military has already declared victory in Marawi against the rebels there then you now move. into a rehabilitation phase for which there is no need or justification for another martial law," Hilbay said.

"You may have continuing lawless violence but you don't need martial AFP law for that," he added.

Extend martial law? What for?

any residents of Marawi City are lackadaisical toward, if not wary of, the issue of extending martial law in Mindanao, maybe out of despair and hopelessness. Such an extraordinary presidential power reserved by the Constitution for extreme crisis did not save their city from being flattened into rubble. In fact, it might even have emboldened military planners into carpet-bombing Marawi and unleashing military might. Martial law neither protected their houses from ruin nor accelerated the city's liberation from the jihadists. So why the fuss over the issue?

The opinion advanced by Sen. Franklin Drilon, who knows his law, having twice served as secretary of justice (forget that he is a "dilawan"), should not be casually dismissed by Malacañang. The alleged "significant violent activities" and continuing threat by extremists to security, upon which the military and police base their recommendation to extend martial law, are way off the constitutional requirement of persisting rebellion or invasion or when "public safety requires it." The fact that there is no ACTUAL rebellion and invasion in Mindanao stares us in the face. No amount of sugarcoating and gobbledygook can shroud that. But then, cases are often decided, not on legal grounds, but on other factors, not the least of them politics.

Martial law is needed in the rehabilitation of Marawi? I don't see the nexus, except perhaps in that it can suspend bidding on and speed up reconstruction projects—which can

be done anyway by other executive flats.

As an upside to today's martial law, I don't see any fingerprint or vestige close enough to what we experienced during Ferdinand Marcos' dictatorship. Every time I go to Iligan City I keep forgetting that we are under martial law. (Until now we are barred from visiting our house in Marawi and seeing the extent of its destruction even if it is distant from "ground zero" and despite the message of the secretary of national defense to allow me and my son, Maamor, to at least put locks on the doors of what remains of our house as well as the compound after the bombing and subsequent ransacking. Our hope is that perchance some memorabilia can still be retrieved.)

Let me give you a glimpse of a facet of Marcos' martial law that is absent in today's situation. One time after playing golf in nearby Iligan, my friends, including then Vice Gov. Abdul Marohombsar (now deceased), and I were stopped at a military checkpoint. I was driving my car and was ordered by a soldier to disembark and take off my golf cap and shades, just to irritate us. In good nature and hoping a semblance of respect would be accorded our group, the vice governor introduced me as the president of the local branch of the Integrated

Bar of the Philippines, which I was. This got the goat of the soldier, who angrily swore and retorted that it was lawyers like us who were making life hard for them: "P*ta, kayong mga abogado ang nagpapahirap sa buhay namin!" He held us for about 30 minutes, or until the queue of cars behind us was about two kilometers long.

In another instance, soldiers rounded up professionals, religious leaders and sultans, and government officials, including myself, and detained us for days on end on the trumped-up charge of rebellion. Now contrast this with the raid on the houses of the Parojinogs and similar raids and arrests that were done only on the strength of warrants issued by a court.

Kudos to the framers of the 1987 Constitution who, taking a leaf from the experience during the Marcos regime, made it difficult, through rigid protocols, for a president to declare martial law and instituted safeguards for the citizenry's civil and political rights.

As for the issue at hand: Extending martial law or not will not bring back our former life as residents of Marawi, or the smiles on our faces, or our precious possessions. What the heck,

The insurgency situation, then and now

N the 16 months that President Corazon C. Aquino ran the government as a dictator after abolishing the 1973 Constitution and wreaked the entire Marcos bureaucracy, she arbitrarily freed the communists from prison and their social-democrat allies.

Worse, the Aquino administration, after issuing Proclamation 2, which granted general amnesty to communist rebels and their socialist democrat allies (left of center), compromised national security, employed many of them in her government and triggered a spate of rebellion among the young officers in the police and military organizations.

Hundreds of these leftists and their allies later went back to the hills and elsewhere and resumed fighting

the government.

Some infiltrated the trade unions, schools and universities, businesses, church, media, judiciary and departments of Agrarian Reform, Agriculture, Human Rights Commission, defense department, Congress and other sectors of society. When Marcos lost power, the NPA, the guerrilla arm of the CPP, had 16,500 regulars, but none of them could operate effectively in Metro Manila.

After that, she declared a unilateral cease-fire and held peace talks with them without precondition, hoping that she would win the coveted Nobel Peace Prize.

Among those released were Jose Maria Sison, Communist Party of the Philippines (CPP) chairman, and Dante Buscayno, New People's Army (NPA) commander, who were placed, respectively, in the custody of the late Joker Arroyo, President Aquino's first Executive Secretary, and Doña Aurora Aquino, the President's mother-in-law.

Sison subsequently escaped to Eastern Europe on a passport issued by the Aquino government and then settled in Utrecht, Netherlands, where he relentlessly directed the armed and political struggle against the Philippine government with other members of the CPP Central Committee, who later joined him there.

Sison and the key CPP members were convicted by the courts for waging an insurgency war for more than two decades before Mrs. Aquino freedthem from prison. Their socialist democratic allies were, likewise, imprisoned for exploding bombs and burning shopping malls and hotels that killed innocent people, including American nationals.

By 1988, the NPA had an armed strength of 25,200, including 2,500 operating in Metro Manila. Worse, 20 percent of the country's 42,000 barangays or villages were under the CPP-NPA's influence. Ironically, this was the same year that President Aquino announced in her second State of the Nation address that "the insurgency was broken."

Between 1988 and early-1992, 78 policemen and military men were systematically assassinated by the NPAs in Metro Manila alone.

Only then-Defense Secretary Juan Ponce Enrile and the reformist officers questioned President Aquino's immediate release from prison of the communists and their allies at the height of the Edsa euphoria.

"Cory's point was that everybody whofought Marcos deserved a second chance for freedom. It did not seem to matter that Sison and company were not just fighting Marcos—they were out to overthrow the state and democracy. Cory would be proven wrong and naïve," Enrile said.

Enrile, who initiated the militarylead Edsauprising that swept Aquino to power and whom she had tried to banish from her administration that early, told the President and her Executive Secretary that releasing the leftists from prison without first requiring them to renounce their

own constitutions, abjure armed struggle and pledge allegiance to the Philippine flag would be a dangerous move. The CPP and NPA operate under their own separate constitutions and bylaws that they approved on December 26, 1968, and March 29, 1969, respectively.

Recalling that incident, then-Army Col. Gregorio B. Honasan, head of the Reform the Armed Forces Movement, known by now as Revolutionary Alliance of the Masses, said that President Aquino merely ignored Enrile's advice.

Honasan said: "Mrs. Aquino was supposed to provide the leadership and a clear direction to the armed services in fighting the communists, but she chose, instead, to stay in the middle [centrist] and treated the insurgency problem as if it was the sole concern of the individual soldiers."

First elected to the Senate in 1995 as an independent candidate, Honasan said when President Aquino ordered the military to deliver a string of victories against the communists, "Ididn't know whether I should laugh or curse her, for how can we deliver a string of victories when she was sleeping with the communists and, at the same time, treating the military as her enemies?"

Mrs. Aquino's successor, President Fidel V. Ramos, who also aspired the Nobel Prize, did not even object to the wholesale release of the leftists, according to Enrile in his book. Worse, Ramos repealed Republic Act 1700, the country's only anti-subversion law, with his allies in Congress on January 22, 1992.

The repeal, in effect, created a serious security vacuum, enabled the communists to expand and rearm, resurrected the already moribund Moro National Liberation Front (MNLF) and revitalized the Moro Islamic Liberation Front, a group that had been granted belligerent status by the previous regimes and now incessantly demanding for the creation of its own laws, separate territory, parliamentary system of government, separate taxation, armed forceandits own human-rights commission, among others, all in violation of the Philippine Constitution.

It can be recalled that it was also Mrs. Aquino who resurrected MNLF Chairman Nur Misuari, then on self-exile in Libya, on the initiative of her brother, Jose "Peping" Cojuangco, Local Government Secretary Nene Pimentel and Butch Aquino, her brother-in-law. With them then was socialist-democrat Norberto Gonzales, who played a keyrole as a national security adviser of both Presidents Ramosand Gloria Macapagal-Arroyo.

Looking back, can the Moros really outsmart President Duterte and Congress in the name of a "peace negotiation," which many observers believed is just, to them, an extension of their battlefield as multifarious security events showed?

Lagman: Where is actual invasion, rebellion in Mindanao?

But opposition lawmaker, Albay Rep. Edcel Lagman rejected Duterte's request.

"Where is the actual invasion or actual rebellion in Mindanao? The Constitution provides that martial law can only be declared and its extension authorized in case of invasion or rebellion when public safety requires it," Lagman said in a statement issued Monday.

He said another year of martial law in Mindanao would amount to the following:

- 1) Patent violation of the safeguards which the 1987 Constitution imposes for the limited grounds and duration of martial law and its extension;
- 2) Malevolent perpetuation of the subjugation of the supermajority in the Congress by the President even against the unequivocal provisions of the Constitution protecting civil-liberties and the rule of law; and
- 3) Blatant mockery of the liberality of the majority of the Supreme Court in upholding the President's past questionable actions

"Since the original or initiatory declaration of martial law is limited to not more than 60 days, it stands to reason that any extension is subject to the same constraints with respect to duration and grounds," the lawmaker said.

"There is no more factual basis for the extension of martial law in Mindanao after President Duterte declared the liberation of Marawi City from rebels and terrorists almost two months ago, and government combat forces had been withdrawn," added Lagman.

The Philippine National Police and the Armed Forces of the Philippines recommended the extension of martial law in Mindanao for another year purportedly to contain continuing threats by terrorists.

But Lagman said "this is not a constitutional ground because threat or imminent danger of an invasion or rebellion has been removed as a ground for martial law in the 1987 Constitution for being self-serving, contingent and even nebulous."

"It is even arguable that not more than one extension is allowed because a series of extensions would violate the constitutional intent for a limited martial law duration, and the phraseology of the Constitution only authorizes the extension of "such proclamation" (original declaration), but not any extension thereof," he explained.

Instead of extending martial law, Duterte should "call the armed forces to subdue lawless violence or declare martial law anew but limited by constitutional restraints and subject to the oversight powers of the Congress and the Supreme Court," according to Lagman.

Westmincom: 354 Abu Sayyaf 'neutralized' since January

Anti-terror task forces under the Western Mindanao have neutralized — by death, arrest or surrender — 354 members of the Abu Sayyaf this year, five times more than in 2016.

Lt. Gen. Carlito Galvez Jr., Westmincom chief, said that from that number, at least 127 Abu Sayyaf militants were killed and 90 were apprehended. Att least 136 have surrendered to government forces — 72 in Basilan, 43 in Sulu and 21 in Tawi-Tawi.

"This is almost five times higher than the number of neutralized Abu Sayyaf members in 2016, when only 75 members were neutralized," Galvez said in a press briefing.

Westmincom's figures account for 40 percent of bandits neutralized this year, he said.

The campaign against the Abu Sayyaf slowed down in May after the Islamic State-inspired Maute Group and Abu Sayyaf attacked and held parts of Marawi City until October 23.

Galvez said intensified operations in the Westmincom's area of responsibility decreased kidnappings by the Abu Sayvaf to 12 incidents against 23 in 2016. Government forces have yet to recover at least 11 kidnap victims — seven foreigners and four Filipinos — still held in the mountains of Sulu.

The number of violent incidents — kidnapping, harassment, bombings and killings — in 2017 was also lower at 77 against 123 in 2016.

Westmincom also recovered 230 firearms from the Abu Sayyaf group.

Galvez said credit for the achievements should go to Joint Task Force Sulu under Brig. Gen. Cirilito Sobejana. Joint Task Force Basilan led by Brig. Gen. Juvymax Uy and Joint Task Force Tawi-Tawi led by Brig. Gen. Custodio Parcon.

ML extension to thwart ISIS, NPA threats in Mindanao: Duterte

MANILA -- President Rodrigo Duterte has asked Congress to further extend the declaration of martial law in the whole of Mindanao for another year, or for the entirety of 2018, in order to totally eradicate terror threats posed by remnants of Islamic State (IS)-linked terrorists and by communist rebels in the region.

In his letter to Congress dated December 8, Duterte said extending the martial law for another year will help state security forces to crush the rebellion in Mindanao and ensure public safety.

"A further extension of the implementation of Martial Law and suspension of the writ of habeas corpus in Mindanao will help the AFP (Armed Forces of the Philippines), the Philippine National Police (PNP), and all other law enforcement agencies to quell completely and put an end to the ongoing rebellion in Mindanao and prevent the same from escalating to other parts of the country." Duterte said in his letter.

"Public safety indubitably requires such further extension, not only for the sake of security and public order, but more importantly to enable the government and the people of Mindanao to pursue the bigger task of rehabilitation and the promotion of a stable socio-economic growth and development." he added.

In his letter, Duterte highlighted the different terror threats facing Mindanao, which were part of the security assessment submitted to Malacañang by the AFP and the PNP.

The President noted that despite the deaths of almost a thousand IS-inspired extremists, including their leaders, in the battle of Marawi, remnants of the group and their supporters have continued their recruitment and training of new members "to carry on the rebellion."

"You will please note that at least 185 persons listed in the martial law arrest orders have remained at large and, in all probability, are presently regrouping and consolidating their forces," he said.

He specifically pointed to the remnants of the IS-inspired Da'awatul Islamiyah Waliyatul Masriq (DIWM) as being active in recruiting and consolidating their forces in Central Mindanao.

"These activities are geared towards the conduct of intensified atrocities and armed public uprisings in support of their objective of establishing the foundation of a global Islamic caliphate and of a Wilayat not only in the Philippines but also in the whole of Southeast Asia," Duterte said.

The President also cited the terror threat from the Turaifie Group, which has been monitored to be planning to conduct bombings in the Cotabato area.

In the meantime, the Bangsamoro Islamic Freedom Fighters (BIFF), a breakaway faction of the Moro Islamic Liberation Front (MILF), has been continuously perpetrating violence in Maguindanao and North Cotabato, having initiated a total of 89 violent incidents since the start of this year.

He also cited threats posed by remnants of the Abu Sayyaf Group (ASG) in Basilan, Sulu, Tawi-Tawi and Zamboanga Peninsula.

According to reports, the ASG was behind 43 acts of terrorism this year, which included bombings, kidnappings and beheadings.

Lastly, Duterte accused the NPA of taking advantage of the Marawi siege to intensify their decades-long-rebellion against the government and "stepped up terrorist acts against innocent civilians and private entities, as well as guerilla warfare against the security sector and public and government infrastructure."

He said the NPA's objective was to "purposely seize political power through violent means and supplant the country's democratic form of government with Communist rule."

The President said the NPA has perpetrated at least 385 atrocities in Mindanao since the year started that resulted in the deaths of 41 state forces and the wounding of 62 others.

He said these atrocities also resulted in the deaths of 23 civilians, including a four-month old infant, and the wounding of six others.

In the meantime, at least 59 arson incidents against private business and establishment have been carried out by the NPA in Mindanao this year that resulted in the destruction of an estimated PHP2.2 billion worth of properties.

The President said that he was constrained to terminate peace talks with the National Democratic front-Communist Party of the Philippines-New People's Army (NDF-CPP-NPA), and later on to tag the CPP-NPA as a terrorist organization, as a direct result of the atrocities on the part of the NPA.

"These recent developments involving the NDF-CPP-NPA forebode another year of intensified armed hostilities which, together with other security concerns and described above, continue to make Mindanao the hotbed of rebellion," he said.

"For all these reasons, I ask the Congress of the Philippines to further extend the proclamation of Martial Law and the suspension of the writ of habeas corpus in the whole of Mindanao for a period of one year, from 01 January 2018 to 31 December 2018, or for such period of time as the Congress may determine, in accordance with Section 18, Article VII of the 1987 Philippine Constitution," Duterte said in his letter.

President Duterte first declared martial law in Mindanao on May 23, 2017 when fighting broke out between government forces and IS-linked terrorists erupted in Marawi City.

In July, Congress extended the declaration until December 31, upon Duterte's request. (PNA)

In a text message to reporters on Monday. December 11. House Majority Leader Rodolfo Fariñas saíd that the congressional session "officially end on on Friday. Dec 15; hence, we may have a joint session on Thursday (Dec. 14) or Friday (Dec. 15) as part of the 2nd Regular Session, without need of a special session."

He added that Congress members would have a briefing with military officials on Wednesday, December 13.

ML in Mindanao needed for 'total eradication' of ISIS-inspired and communist-led terrorist groups

In his five-page December 8 letter to Senate president Aquilino "Koko" Pimentel III and Speaker Pantaleon Alvarez. Duterte asked the chambers to extend martial law in Mindanao until 2018. "primarily to ensure total eradication" of terrorist groups in the region "inspired by of DAESH" or ISIS such as the Da'awatul Islamiyah Waliyatul Masriq (DIWM) and other local and foreign extremist groups and armed lawless groups "and the communist terrorists and their coddlers, supporters, and financiers."

Army Core Purpose: Serving the people. Securing the land.

The President said his request for Congress to extend martial law in the South was based on the "security assessment made by" the Armed Forces of the Philippines (AFP) chief as stated in the December 4, 2017 letter that Duterte received from Department of National Defense chief Delfin Lorenzana.

"The security assessment submitted by the AFP, supported by a similar assessment by the Philippine National Police, highlights certain essential facts that I, as Commander-in-Chief of all armed forces of the Philippines, have personal knowledge of." added Duterte.

Duterte: Terrorist acts by ISIS-inspired groups, NPAs continue

According to the chief executive, remnants of the DIWM and their allies, protectors, supporters and sympathizers "have been monitored in their continued efforts towards radicalization/recruitment, financial and logistical buildup, as well as in their consolidation/reorganization in Central Mindanao, particularly in the provinces of Maguindanao and North Cotabato and and also in Sulu and Basilan."

"These activities are geared towards the conduct of intensified atrocities and armed public uprisings in support of their objective of establishing the foundation of a global Islamic caliphate and of a *Wilayat* not only in the Philippines but in the whole Southeast Asia." the President noted.

Regarding the alleged threat by communists. Duterte informed Congress that while the government was preoccupied with fighting ISIS-inspired groups in the South, the New People's Army allegedly "took advantage of the situation and intensified their decades-long rebellion."

The NPA allegedly did this by stepping up "terrorist acts against innocent civilians and private entities as well as guerilla warfare against the security sector and public and government infrastructure." according to Duterte.

The President claimed that the NPA did all these "purposely to seize political power through violent means and supplant the country's democratic form of government with Communist rule."
