

Survivors warned of aftershocks

SURIGAO CITY—Officials on Sunday warned survivors of a powerful earthquake that left at least seven people dead in northeastern Mindanao to ensure their homes and buildings were sturdy enough before venturing back amid continuing aftershocks.

A strong aftershock alarmed residents, some of whom screamed in fear, while waiting for President Duterte to arrive to console earthquake survivors gathered in a gymnasium in the hard-hit capital of Surigao del Norte province.

The 6.7-magnitude quake struck late Friday, killing at least seven people, injuring more than 200 and damaging the main airport and about 1,000 houses in Surigao.

Some residents said the shaking was so strong they could not stand up to rush out of their houses,

Officials appealed for volun-

teer engineers to help check the stability of damaged schools, hospitals, malls, hotels and other buildings, especially in the provincial capital of Surigao City, which has been placed under a state of calamity to ensure a rapid release of emergency funds and prevent food hoarding.

Power was restored on Sunday in some parts of the city.

Homes must be safe

"Our call is do not return hastily after the strong quake," said Romina Marasigan, spokesperson of the National Disaster Risk Reduction and Management Council (NDR-RMC). "We have to ensure that our residences are safe."

"The critical infrastructure—the schools, the hospitals and offices that provide services—should also be checked if they are still safe for use," Marasigan said.

"We are again reiterating our appeal for help from civil and structural engineers to ensure the safety of the people," she added.

Renato Solidum, who heads

the Philippine Institute of Volcanology and Seismology, said at least 137 aftershocks had hit following the quake.

"Aftershocks are normal after a strong earthquake Typically, these may last for days, up to weeks," Solidum said.

Among the structures damaged by the quake were 12 schools, six bridges and some

shopping malls, many of which had visible cracks, shattered glass windows and damaged canopies.

The quake may have busted tap water pipes, limiting supply in Surigao City, which lies about 700 kilometers southeast of Manila, and three outlying towns, officials said.

Mr. Duterte, accompanied

by Social Welfare Secretary Judy Taguiwalo, arrived more than three hours late in Surigao City because his entourage had to make a detour following the closure of its airport due to deep cracks in its runway.

He later pledged P2 billion in financial help to quake survivors needing medical treatment.

Relief goods arrive

A government plane loaded with relief supplies and emergency aid landed on Sunday morning in Butuan City for overland transport to Surigao City and nearby towns as authorities moved to restore power and water supply in the quake-stricken areas

Even so, life appeared to be returning to normal, according to Surigao del Norte Vice Gov. Carlos Egay

NDRRMC Executive Director Ricardo Jalad said the Philippine Air Force Lockheed C-130 "Hercules" cargo aircraft transported 10 generator sets, 150 solar lamps, 30,000 pieces of disaster relief packs, 4,090 bars of brown rice, 100 rolls of laminat-

ed sacks, 2,000 pieces of mosquito nets, 2,000 plastic mats and 2,000 blankets.

The plane left Villamor Air Base in Pasay City at around 6 a.m. and landed about an hour later in Butuan City's Bancasi Airport loaded with goods for overland transport to Surigao City.

Buildings closed

"We're still being hit by aftershocks, and as of now we do not have tap water supply. The people are suffering," provincial information officer Mary Escalante said in a television interview.

"Buildings that suffered structural damage have been closed," Escalante said, adding some schools and gyms that were meant to serve as evacuation centers were among those damaged by the quake.

Health Secretary Paulyn Ubial advised residents to refrain from drinking water from faucets. —REPORTS FROM CHRIS V.

Aftershocks terrify Surigao

SURIGAO - Thousands of residents of this city sought refuge in the streets as aftershocks hit the region yesterday, two days after a powerful earthquake killed six.

The 6.7-magnitude quake struck Surigao and nearby areas of Mindanao late Friday, injuring hundreds, with over a thousand homes destroyed or damaged, officials said.

People who had fled their damaged homes wrapped themselves in blankets and sacks for a second night as they slept side-by-side on the pavement since Saturday.

The Philippine Institute of Seismology and Volcanology (Phivolcs) recorded 135 weaker quakes in Surigao, a city of 152,000 people, and in the region around it since the quake struck, though there were no additional reports of

casualties or damage.

"The people are terrified of the aftershocks," said Romina Marasigan, spokesperson for the National Disaster Risk Reduction and Management Council (NDRRMC)

The NDRRMC reported the number of dead remained at six though the injured increased to 202. Many of those killed or injured were pinned down or hit by debris during the quake.

Marasigan said classes in Surigao City are suspended today to give way to damage assessment in schools for the safety of teachers and

"We remain on red alert status together with our response cluster, including the regional council in Caraga region which will monitor the situation and gather more information on the extent of damage," Marasigan said

Because aftershocks are still expected, Marasigan called on residents of Surigao City to remain calm and alert with the safety of their families considered as their primary concern.

"This was the first time Surigao had suffered a quake this strong. The previous one occurred in the 1800s," said Martin Andanar, presidential communications chief and a native of the city.

"This is the strongest (earthquake) for this century," he said. His house in the city was also damaged by the quake.

Andanar thanked private groups that extended assistance to the earthquake survivors. He said among the groups providing help is the MVP Foundation, which has sent cellphone chargers and generators to affected areas.

He said agencies are continuously offloading relief items at the Butuan Airport, some 100 kilometers away from the city.

Andanar stressed the need for the public to donate potable water and other relief items to quake survivors.

"Water is important in Surigao. Potable water is what is important here," Andanar said.
"We ask the NGOs (non-

Duterte comforted the residents, who were already getting jittery with the aftershocks.

"In everything that happens in the world, there is always a time for them," Duterte told the residents gathered at the Surigao City gymnasium.

"Thank God. Buotan man gud ang mga Surigaonon (Surigaonons are good people)," he said.

Duterte quoted a passage in the Bible in sympathy for those who lost their loved ones.

"Naa ang Ecclesiastes (3.1) in the Bible, naay panahon sa kasadya ug kaguol (there is time for happiness and sadness, for joy and sorrow)," the President said in Cebuano.


Phivolcs said last Friday's magnitude-6.7 quake was generated by the movement of the Surigao segment of the Philippine fault.

The strongest ground shaking was felt in Surigao City at Intensity 7, which is described by Phivolcs as "destructive."

On July 1, 1879, the Surigao segment of the Philippine fault also generated a magnitude-7.4 quake. This was considered to be the largest quake to hit the area on record, Phivolcs said

An average of five earthquakes, most of them undetectable except through instruments, hit daily across the Philippines, which lies on the so-called Ring of Fire, a vast Pacific Ocean region where many earthquakes and volcanic eruptions occur.

The last lethal quake that hit the country measured 7.1-magnitude. Soldier hurt in ComVal

RE GLASHES IN 3 PROVINCES BETWEEN SOLD **COMMUNIST REBELS**

DAVAO CITY—Clashes between government soldiers and communist guerrillas continued in parts of Mindanao following President Duterte's declaration of an end to peace talks ing for the Army's 10th Infantry with leaders of the National Division, said a soldier was Democratic Front of the Philippines (NDFP), the underground umbrella organization of leftist militant groups.

The clashes took place in

the provinces of Sarangani, Compostela Valley and Davao Oriental on Saturday, according to an Army spokesperson.

Capt. Rhyan Batchar, speakwounded in a clash with New People's Army (NPA) rebels in the village of Little Datal Anggas in Alabel town, Sarangani, that lasted for at least two hours.

Batchar said the wounded soldier, who has not been identified, was airlifted to the military hospital in Panacan here.

He said three separate gunfights also took place between soldiers under the 60th Infantry Battalion and communist rebels in the village of Bollucan in Laak town, Compostela Valley.

Batchar said the first gun-

fight in Laak lasted for about an hour, Soldiers backed by armored personnel carriers pursued the rebels and engaged them in a second clash. The third clash came when soldiers caught up with some of the rebels.

In Davao Oriental, Batchar said a brief clash took place when NPA rebels ambushed three military trucks in the vil-

lage of San Jose in Caraga town on Saturday No casualty has been reported.

Batchar said the military had sent MG520 attack helicopters and fired cannons at the rebels' direction.

He said soldiers are conducting clearing operations to check if the artillery round has been accurate. - ALLAN NAWAL INQ

Military touches base with folk in Northern Samar

CAMP LUKBAN, Catbalogan City – The Army's 8th Infantry Division (8ID) discussed with local chief executives last week ways to further improve the peace and order situation in Northern Samar.

The discussion took place during the February 8 Provincial Peace and Order Council Meeting and Stakeholders Fellowship at the Governor's Residence in Catarman.

Major General Raul M. Farnacio, 8ID commander, told reporters after the meeting the activity also aimed to unite the local chief executives and stakeholders in addressing poverty alleviation; peace and order and to gather support for the government's drive against illegal drugs and lawless violence.

Farnacio said the meeting was attended by military, police and local government officials, Rep. Raul A. Daza, Northern Samar Governor Jose L. Ong Jr., Vice Governor Gary M. Lavin, Vice Governor of Northern Samar, the 24 mayors of Northern Samar; church leaders and media personalities.

He said that during the open forum, the local chief executives were urged to deliver the basic social services needed especially in remote communities.

Farnacio also assured the people of Eastern Visayas of military protection following the lifting of the ceasefire by communist groups.

Members of the New People's Army (NPA) who will surrender will be given financial aid to help them start anew, he said.

Farnacio also highlighted the Armed Forces of the Philippines' new Development Support and Security Plan (DSSP), "Kapayapaan.

"This is the continuance of Internal Peace and Security Plan "Bayanihan" that was terminated last year. This campaign will focus on sustained military operations to defeat foreign and local terrorist organizations, contribute to the promotion of peace, active support to law enforcement in war against drugs; and contribute to nation-building," he said.

Military, civilian casualties in brazen NPA attack

URIGAO CITY - An Army soldier and two civilians were killed, while two other civilians were wounded in a gun battle that erupted Saturday morning between government security forces and communist insurgents in the hinterland area of Sarog, Barangay San Isidro, Santiago, Agusan del Norte.

The identity of the slain Army soldier was temporarily withheld, pending notification of his next of kin, while the names of the two wounded civilians were not immediately available.

The local residents who were killed in the crossfire were Jerson Saladaga Beto, 19 of Purok 5 and Pepito Qiambong, 33 of Purok 7, both of Barangay San Isidro

Capt Angelo Gomez, spokesperson of the 29th Infantry battalion (29th IB) said the wounded civilians were immediately brought to the Cabadbaran City District Hospital for medical treatment. Lt. Col. Glenn Joy Aynera, 29th IB commander said the NPAs violated the Comprehensive Agreement on Respect of Human Rights and International Humanitarian Law (CARHRIHL), when they swooped down on the community of Sarog area.

The attackers were believed to belong to the guerilla-Front Committee 16-C of the CPP-NPA Northeastern Mindanao Regional Committee (NEMRC), according to Gomez.

"There is a situation in that community that needs to be addressed that is why I have sent my soldiers to secure the people against these NPAs," Aynera said, in his statement,

Upon reaching the community at around 4:30 a.m. last Saturday, troops were able to talk with some villagers to confirm the report about harassment from communist insurgents.

However, as the dialogue was being held, about 10 fully-armed NPA rebels reportedly opened fire indiscriminately on the troops and civilians. The attack lasted for about 10 minutes before the NPAs withdrew towards the nearby communities, he said.

"This is a clear violation of the CAR-HRIHL which was duly signed by the GPH and NDFP in 1998 at The Hague, The Netherlands that says that civilian population and civilians shall be distinguished from combatants and, together with their property, shall not be the object of attack. They shall likewise be protected against indiscriminate strafing," the 29th IB commander said.

"We condemn their atrocious act which claimed the lives of two innocent civilians, and seriously wounded three others. We are also deeply saddened for the lost of one of our comrades. Rest assured we will always continue to conduct peace and security operations to ensure the safety and security of the people in Agusan del Norte," Aynera said

As of press time, hot pursuit operation was still ongoing towards Mount Ilong-Ilong area of that same town.

Rash of rebel kidnappings in Agusan, ComVal

CAMP BANCASI, Butuan City – A barangay chairman and his wife, and a father and his son were abducted in separate incidents allegedly by members of New people's Army (NPA) in Agusan del Sur and Compostela Valley (ComVal), Capt. Rhyan B. Batchar, spokesperson of the Army's 10th Infantry (Agila) Division (10th ID) yesterday said.

In a statement, the 10th ID spokesperson said late reports showed that Barangay Pangyan Chairman Rene Carlos and his wife Maribeth were abducted by armed men believed to be communist insurgents along a barangay road in Pangyan, Trento, Agusan del Sur last February 5.

It appeared that the rebels only targeted the Carlos couple as a relative, a barangay councilor and tanod, who were with them at the time of the incident, were later released, according to Batchar

Elements of the 25th IB, along with the Trento Municipal Police Station (MPS), were still conducting search and rescue operations for the abducted barangay chairman and his wife in the mountain border of Trento town and Monkayo, ComVal province, Batchar

Meanwhile, a separate report from the 71st Infantry Battalion said that a certain Jun-jun Custodio and his son Marjun were also kidnapped by the group of a certain "Ka Mokloy," allegedly the team leader of the NPA's Milisya ng Bayan in Barangay Malamudao in Maco town, ComVal province last February 8, Batchar disclosed.

The fate of the abducted father and son was still not known as of press time.

Brig. Gen. Macairog Alberto, commanding general of the 1001st Infantry Brigade condemned the abduction of the civilians, saying "the NPA abducts innocent civilians who they intend to use as human shields." (Mike U. Crismundo)

Soldier, 2 civilians dead in NPA attack in Agusan

A SOLDIER and two civilians were killed Saturday in an attack staged by New People's Army rebels in Santiago town, Agusan del Norte.

Three other civilians were injured.

The soldiers from the Army's 29th Infantry Battalion were sent to Barangay San Isidro in Santiago town after the military received reports that a group of rebels were conducting extortion activities in the area.

Upon arrival at the barangay at around 5 a.m., the soldiers approached a group of civilians to verify the information. During the conversation, around 10 NPA fully-armed rebels "indiscriminately opened fire against the troops," unmindful of the presence of the civilians, said Capt. Joe Patrick Martinez, public affairs officer of the Army's 4th Infantry Division.

The rebels withdrew after a 10-minute firefight with the sol-

Army man dead, scores of rebels killed as firefight continues

SURIGAO CITY - An Army soldier and two civilians were killed while two others were wounded when a gunbattle erupted between government security forces and communist ansurgents. Saturday morning in the hinterland area of Sarog, Barangay San Isidro, Santiago, Agusan del Norte.

29th Infantry battalion (29th IB) spokesperson Capt. Angelo Gomez identified the fatalities as Jerson Saladaga Beto, 19 of Purok 5 and Pepito Qiambong, 33 of Purok 7, both of Barangay San Isidro, in Santiago town, Agusan del Norte.

The name of the Army soldier is yet to be released until the relatives of the army man is notified.

29th IB commander Lt. Col. Glenn Joy Aynera said they responded to a report about a supposed peaceful community being badgered by rebels which is a violation of the Comprehensive Agreement on Respect to Human Rights and International Humanitarian Law (CARHRIHL).

The soldiers reached the community around 4:30 a.m. where they were immediately attacked by the rebels which lasted for about ten minutes.

"This is a clear violation of the CARHRIHL which is duly signed by the GPH and NDFP in 1998 at The Hague, The Netherlands that civilian population and civilians shall be distinguished from combatants and, together with their property, shall not be the object of attack. They shall likewise be protected against indiscriminate strafing," said Aynera.

Gomez meantime said the fleeing rebels are believed members of guerilla-Front Committee 16-C of the CPP-NPA Northeastern Mindanao Regional Committee (NEMRC).

In Tugegarao, Cagayan, government forces called on the NPA to prove their sincerity after 15 rebels were killed when it encountered an Army platoon patrolling the vicinity of Sto Niño in Cagayan Wednesday

This was the response of the military after NPA spokesman Crispin Apolinario of the Danilo Ben command of the NPA West Cagayan announced on radio proposing for a ceasefire in the Sto. Niño, Cagayan province. (Mike Crismundo and Liezle Basa Iñigo)

Concerned military officers are now up in arms against the conferment of the highest combatawar I on the 42 Special Action during the launching of the botched Oplan "Exodus" In Maguindanao in 2015.

National Police (PNP) announced* President Duterte approved the conferment of the Medalyic hg Kagitingan - equivalent to the military's Medal for Valor, on the 42 SAF commandos-making all the fallen SAF 44 awardees of the highest combat award

While the officers, who requested and nymity, said they were not particularly familiar with the criteria in bestowing the PNP's Medalya ng Kagitingan, but based on the pronouncements of the PNP and National Police Commission (Napolcom), they may not be different from those in the Armed. Forces of the Philippines (AFP)

They maintained the highest

combat award is an individual award - not to be given to entire unit, recognizing a trooper's extra ordinary conduct during operation and acts of gallantry in action over and beyond the call of duty. They, Force (SAP) commands in died however, stressed they had nothing against the SAF 44 commandos.

With the conferment of medal of valor on all the fallen SAF 44, Last Thursday, the Philippine - the PNP now has more awardees than the AFP which only has 40 in its 81 years of existence, some are still living and in the active service.

"Is this a bad joke? Are they aiming for a Guinness record for giving out Medal of Valor to so many troops in a single encounter? Very bad precedent," a senior Army official told the *Tribune*.

"The President must be misinformed in approving this move that only desecrates the coveted MFV (Medal for Valor)," he added.

In the military, there was even an instance when an awardee questioned the conferment of the award on another official due to questionable circumstances that surrounded the incident that prompted an AFP board to consider and ultimately awarded the Medal

"I am not aware of the criteria used by the PNP to recommend the awards to the President but I would believe it would not be far from the criteria of the AFP. To my understanding it is an individual award," a Camp Aguinaldo official

"I just hope it was not given just to push a political agenda if any or just to appease the family of the SAF 44. If so they just 'bastardized the meaning of the award Bad precedence now anybody can demand for the PNP MFV," he added.

During the second anniversary of the Mamasapano incident, Duterte expressed his intent to award Medal of Valor to the 42 SAF commandos.

The Napolcom en banc subsequently recommended to Duterte the conferment of Medal of Valor on the 42 SAF commandos who were previously awarded with Medalya ng Kabayanihan or Distinguished Conduct Medal.

Two other SAF commandos. Chief Insp. Gednat Tabdi and PO2 Romeo Cempron were conferred with Medal of Valor on January 25, 2016 - exactly the first anniversary of the day-long clashes in barangays Tukanalipao and Pidsandawan in Mamasapano.

More than 300 SAF troopers were sent to Maguindanao to execute Oplan "Exodus" targeting Malaysian terrorists Zulkifli bin Hir. alias Marwan, and Amon Baco and Filipino bomb maker Basit Usman.

Marwan, a subject of \$5-million reward offered by the United States government, was killed during the operation while Baco and Usman escaped

However, the two companies of SAF troopers, 84th and 55th Special Action Companies, were pinned down by combined Moro Islamic Liberation Front and Bangsamoro Islamic Freedom Fighters - resulting in the killing of 44 SAF commandos, including nine junior officers.

The execution of Oplan "Exodus" was criticized and many described the operation as a failure.

N official of the Armed Forces of the Philippines (AFP) on Sunday said the province of Basilan should not be labelled as a "trash bin for scalawags" following the reassignment of rogue personnel of the Philippine National Police (PNP) to the province.

Arevalo stressed that young officers and enlisted personnel have volunteered to be assigned

in the cited island provinces for their "baptisms of fire."

"It's a choice assignment."
Because such deployments offer them a wealth of experience, innumerable lessons, opportunities to excel, and yes, earn trophy points," he explained.

Meanwhile, a military official, who requested anonymity, recounted that when he was still a young second lieutenant, he volunteered to be assigned to the Marine Battalion Landing Team-6 then deployed in Basilan.

The official, now a full colonel, is holding a sensitive post in the AFP.

Over 200 policemen, mostly accused of minor offenses, were presented to President Rodrigo Duterte in Malacanang last week by PNP chief Director General Ronald de la Rosa.

"Prepare to move out. I'll give you two weeks from now, 15 days. Start to move out. If you do not want to go there, go to your superior officer and tell them that you're going to resign," Duterte told the policemen lined up before him.

The President said those who will be sent to Basilan will stay there for two years.

AFP: Basilan, Sulu for heroes, not for misfits, rogues, scalawags

THE Armed Forces yesterday said it does not treat Basilan and Sulu, bailiwick of the Abu Sayyaf, as a dumping ground for misfit and scalawags, but as "a breeding ground for heroes and military leaders who thrive in adversities."

AFP public affairs office chief Col.

Edgard Arevalo said that "for soldiers and Marines, sailors and airmen, being deployed in Basilan – or in Sulu for that matter – is a source of pride. Because only the warriors, professionals, and those who excel in their fields are sent to Basilan."

Arevalo issued the statement "so that our soldiers assigned there and would be assigned there will not feel they are misfits or errant.

"Some people resent that Basilan would be the destination for some erring members of the security forces, especially the ones who have gone astray or failed to measure up to standards,"

said Arevalo.

"It's a choice assignment. Because such deployments offer them a wealth of experience, innumerable lessons, opportunities to excel, and yes, earn 'trophy points.' For the military, it is a big deal to be deployed in Basilan or Sulu for that translates to a distinction," said Arevalo.

Arevalo cited a Marine junior officer, now

Last Thursday, AFP chief Gen. Eduardo Año said cops should welcome an assignment to Basilan, Sulu and Tawi-tawi. He said soldiers take the assignment to these areas as an opportunity to earn a Medal of Valor, the highest military decoration in combat.

A soldier conferred with the medal receives a monthly gratuity of P75,000, free education, hospitalization for his families. The lifetime gratuity is on top of the salary or pension they receive.

"What's wrong (with) being assigned in Basilan and Sulu. If you want to serve the country and the people, that's the best way. Now, if they are complaining, then you can see the quality of these people that you do not need in the organization," said Año.

16-year jail term vs AFP engineer affirmed

THE Sandiganbayan Third Division has affirmed the 16-year jail sentence meted out against engineer Dante Senen, supply accountable officer of the Armed Forces of the Philippines (AFP) Military Supply Unit in Cebu City on his conviction for graft and malversation of public property concerning the anomalous sale of four power generators to a private individual in 2002.

Senen failed to convince the

anti-graft court to reverse its decision dated November 29, 2016 that found him guilty of conspiracy with former Philippine Air Force (PAF) Brig. Gen. Vladimir delos Trino, Major Antonio Jason Garcia, and private defendant Antonio Ularte of Eduard Enterprises for the unlawful transaction

Delos Trino and Garcia were convicted of both charges in May 2011 but their co-accused, Senen and Ularte, remained at large. Senen was arrested only on November 21, 2011 inside Camp Aguinaldo, Quezon City.

All three were collectively ordered to pay the government the sum of P1.2 million as indemnity for the loss sustained on the sale on top of a P1.2 million fine.

The court found the three AFP officials liable for selling the power generators to Ularte

for only P800,000.00 without holding the required public bidding that tended to favor Ularte's firm.

In his appeal, Senen argued that there was no evidence that he colluded with Delos Trino and Garcia.

The court, however, declared otherwise, noting that it was Senen who had official custody of the power generators but the accused failed to inform his commanding officer about. their transfer and did not in-clude them in his inventory and inspection report that he. submitted to the headquarters.

Gov't, MNLF to resume talks

The government and the Moro National Liberation Front (MNLF) are set to resume their talks on the final implementation of the 1996 peace agreement

Emmanuel Fontanilla, MNLF spokesman and member of the peace panel, said yesterday they were just waiting for the composition of the government panel for the resumption of talks.

He said the MNLF would not be part of the newly formed Bangsamoro Transition Commission that would discuss peace with the Moro Islamic Liberation Front because the MILF would have separate talks with the government

"The MNLF (members) in the transition commission belong to a breakaway group; they do not represent MNLF," Fontanilla said.

He said the resumption of talks with the government would be confined to three remaining unresolved issues for the final implementation of the 1996 peace accord, which was brokered by the Organization of Islamic Cooperation (OIC).

These issues are governance, wealth sharing and territory

Fontanilla said it would be up to Congress to consolidate a law that would synchronize the 1996 peace agreement with the MNLF and peace accord to be forged with the MILF.

The OIC, in a resolution, has urged the government to link up the two peace accords to attain lasting peace in Mindanao.

The 1996 final peace agreement between the government and the MNLF, represented by its founding chairman, Nur Misuari, was signed on Sept. 2, 1996 under the administration of then president Fidel Ramos.

That same year, the MILF,

which had broken away from the MNLF in 1977, began informal talks with the Ramos-led government.

But a final peace accord has yet to be reached with the MILF. The current administration is continuing the peace negotiations with the MILF with the creation of the BTC.

President Duterte has also met with Misuari, who surfaced recently after going into hiding as he was ordered arrested by the court for the 2013 Zamboanga City siege.

The MNLF has been originally demanding the inclusion of 13 provinces in an autonomous region in Mindanao since

it started peace negotiations with the government since the Marcos administration. Then president Ferdinand Marcos did not agree to it despite the signing of the 1976 Tripoli Agreement.

În 1989, the Autonomous Region in Muslim Mindanao was created under then president Corazon Aquino, who also refused to give in to the MNLF's demand.

Misuari eventually became governor of ARMM from 1996

to 2001

Former president Benigno Aquino III pushed for the creation of a more inclusive autonomous region as he described the ARMM as a failed experiment.

the girl as they distributed food packs to the displaced families.

Duterte also went to Butuan City yesterday to posthumously award Sgt. Marlon Balais a bronze anahaw leaf medal for his meritorious services to the nation. Balais, a scout leader of the 29th Infantry Battalion, was killed in a firefight with NPA rebels in Agusan del Norte.

Also killed in the clash was Jerson Beto, a grade 11 student, and small-scale miner Pepito

Tiambong.

The encounter happened at week after Duterte terminated the peace talks with the communist rebels and labeled them a terrorist group. The President decided to scrap the peace negotiations after the communists insisted on their demand to free more than 400 rebel leaders whom they claim to be political prisoners

Duterte rejected the demand, which he described as tantamount to granting amnesty. Communist rebels then called off the unilateral ceasefire and stepped up attacks against government forces in various parts of the country.

Former president and now Manila Mayor Joseph Estrada is backing Duterte's declaration of war against the NPA although he continues to hope that peace negotiations would resume.

He said the communists have all the reasons to fear Duterte's wrath because the President never backs down

from a fight.

"They should fear President Duterte. Let us see if the President will still give them a chance," Estrada said when asked about the NPA going head-to-head against Duterte.

The CPP, in a statement, said an all-out war would fail and that defeating the NPA is only a Duterte pipedream.

"Other regimes before him

have tried and failed," the CPP said.

The NPA was tagged as a foreign terrorist organization by the US State Department and as a terrorist group by the European Union Common Foreign and Security Policy. Its estimated strength has since dwindled to less than 3,000.

Estrada said Duterte was right when he suspended the unilateral ceasefire in reaction to the atrocities and ceasefire violations committed by the NPA in the past weeks, but stressed that he supports another round of peace talks.

He recalled his days when, as president, he ordered the Moro Islamic Liberation Front camps and territories wiped out during his war against terrorism, noting that he gave the group enough opportunities to talk with the government.

"I talked to them for about three months then in the fourth month, they burned down Kauswagan (Lanao del Norte) Many innocent civilians, mostly children were killed, and they even beheaded six soldiers," Estrada said

Estrada said the MILF raid on Kauswagan was the last straw.

Ghadzali Jaafar, MILF vice chair for political affairs, said they are not affected with the collapse of the government's talks with the NPA, adding that the administration's negotiation with the Moro people is distinct.

He welcomed the recent announcement of new members of the expanded Bangsamoro Transition Commission - a body that will draft the new Bangsamoro enabling law as part of the implementation process of the southern peace pact or the Comprehensive Agreement on the Bangsamoro signed between the Philippine government and the MILF in March 2014 - Edith Regalado, Michael Punongbayan, Jose Rodel Clapano, Cecille Suerte Felipe, Alexis Romero

Reds heed AFP call for truce in Surigao

THE communist New People's Army operating in Surigao and portions of Agusan del Norte has declared a unilateral interim ceasefire with government troops effective Feb. 11 following a magnitude 6.7 earthquake that struck the region, leaving six people dead and several structures damaged.

In a report in Mindanews, Ka Oto, the NPA's spokesman in the region, said the communists had ceased tactical offensives against government forces effective 6 p.m. on Saturday "until the province will recover from the disaster."

He said the rebels will focus on humanitarian efforts to help the quake victims.

"Rest assured we will not do any harm to the military as long as they will not come to our areas," Oto said.

The military had earlier urged the communist rebels not to attack its soldiers conducting rescue and rehabilitation operations in the areas affected by the earthquake.

"Allow the soldiers every opportunity to help the victims of Next page

the earthquake," Marine Colonel Edgard Arevalo, head of the military's Public Affairs Office, said Saturday.

"We urge you not to attack our soldiers or in any other ways [that will] disrupt the AFP's rescue and rehabilitation activities for our people," he said.

The military's appeal came as the NPA announced a "heightened armed resistance" against the government's all-out war declaration on Saturday.

On Friday, Communist Party of the Philippines founding chairman Jose Maria Sison urged his former student, President Rodrigo Duterte, to continue with the peace negotiations with the communists to clarify "misunderstandings" that he said were instigated by the peace "spoilers."

But Malacañang told the communist rebels to show their sincerity before any peace talks could continue.



Medal of Valor

ore than 25 years ago, a young captain assigned with the Anmy's Special Forces carried out a stunning nighttime operation against a numerically superior group of some 200 rebels located at Sitio Manipulon, Murcia, in Negros Occidental Province The results of the raid set a new standard in the Armed Forces of the Philippines' counterinsurgency efforts that, to this date, has not been duplicated in terms

of enemy killed and firearms recovered.

On April 6, 1990, Capt Arturo B. Ortiz led five teams of the 606th Special Forces Company, Philippine Army along with a Cafgu number of troops in a raid against a large NPA training camp in Negros Occidental. Under cover of darkness, Ortiz led his troops on a grueling 11hour cross-country march, scaling a 1,000-

foot high cliff, enabling his units to infiltrate the enemy position while avoiding booby traps and claymore mines. Aware that air support and artillery fire would be futile due to the dense forest cover, Ortiz instructed his men to move as close as 10 meters from the enemy periphery before launching the surprise attack. Moving from one team to the other, he directed their line of fire that spared the women and children in the encampment.

For this outstanding performance of duty, Captain Ortiz was awarded the nation's highest military honor, the Medal of Valor (MOV). His citation reads: "The two-hour gun battle resulted in 84 terrorists killed with 22 dead bodies counted, including 17 recovered on site, 8 captured, and several others wounded and missing as reported by the Negros Regional Party Committee. Recovered from the enemy were 33 assorted firearms, 21 rifle grenades, several hand grenades, five ICOM radios, and other enemy equipment. By this display of exceptional courage and high degree of leadership, Capt. Ortiz distinguished himself in the field of combat in keeping with the highest tradition of Filipino soldiery."

The Medal of Valor is the highest military honor that can be bestowed on members of the AFP for conspicuous gallantry and intrepidity at the risk of life above and beyond the call of duty. It is not an award that is easily granted. To date, there have been only 40 MOV awardees: 27 from the Philippine Army, 8 from the Philippine Marines, 3 from the defunct Philippine Constabulary, and 2 from the Philippine Air Force.

Each award is thoroughly screened and is vetted through several layers of command before it reaches the major service commander. From here, the papers go to the AFP chief of staff, the secretary of national defense, and finally, the Office of the President, for approval. Only the president can authorize the award and the whole process usually takes anywhere from nine months to a year, even longer. In the case of Captain Ortiz, his MOV was awarded nine months after his successful mission. The award is so prestigious that even the president as commander in chief may choose to salute the MOV holder, the only individual given this rare honor.

Lt. Gen. Arturo Ortiz, who retired from military service as the 53rd commanding general of the Philippine Army, graduated with PMA Class 1979. He is presently the president of the Association of AFP MOV awardees.

Incidentally, one of the most attractive sites at the Philippine Military Academy is the view of a pine-covered mountainside stretching all the way to distant Mount Santo Tomas from the back of Lim Hall. The hall, named in honor of Brig. Gen. Vicente Lim, the first Filipino to graduate from West Point, houses the offices of the PMA superintendent, the dean, corps of professors, and the commandant of cadets.

The centerpiece of the building is the Hall of Valor, featuring the framed photos of PMA MOV awardees, with their respective citations. It is a sanctuary for those in search of heroism and inspiration, and each time I visit the Academy, I make it a point to stop even for a few brief moments at the Hall of Valor. I always leave the place with a feeling of deep pride and respect for the achievements of this select group of PMAyers, some of whom paid the supreme sacrifice in the performance of duty. Let me add that there are other military personnel, some officers with different sources of commission, as well as enlisted men, who have been honored with the MOV in recognition of their bravery and heroism under enemy fire.

Last week, Malacanang approved the award of the MOV to 42 members of the PNP's Special Action Force (SAF) who were killed in the Mamasapano action two years ago. Two from the same group were earlier awarded the medal posthumously. The grant to the other 42 SAF troopers was one of the requests of family members during a meeting with the President last month.

The sudden mass conferment, in response to family pleas, has drawn widespread criticism from both AFP and PNP elements. General Ortiz has forwarded to me a few of the comments that he received:

• The MOV must not be given wholesale. It is a singular act of exceptional and uncommon heroism by a soldier that sets him apart from the rest. It must not be trivialized, abused, demeaned, or devalued. Otherwise, the medal loses its honor and prestige.

• This action sets a bad precedent and would open a floodgate for indiscriminate awarding of the MOV. This cheapens the award and might weaken the institution and system of AFP awards.

• In the entire AFP history, there have only been 40 awardees. Then in one fell swoop, 42 SAF members get the same medal. It would surely land us in the Guinness Book of World Records.

 The MOV should not be trivialized and all soldiers and men in uniform should stand against this.

 The AFP leadership and concerned authorities should do something to restore, protect, and preserve the honor and prestige and integrity of the MOV, revered and considered sacred by the AFP. Wholesale award of the MOV to the SAF 44 is too much.

Defense Secretary Delfin Lorenzana and AFP Chief of Staff Eduardo Año have expressed similar concerns about the grant of the award. We can honor the memory and sacrifices of the SAF troopers in ways that do not diminish the value and prestige of the Medal of Valor.

NPA undertook military operations at height of peace talks

Including raid on Henry Sy's Pico de Loro resort in Nasugbu

THE communist New People's Army (NPA) undertook 18 armed attacks against government forces in February alone, or at the height of the peace talks, according to information in the Communist Party of the Philippines (CPP) publication Ang Bayan.

I don't know if President Duterte was even aware of this, as he had not pointed to these attacks as the reason why he terminated the peace talks. Rather, it was the coldblooded killing of three Army soldiers February 28 in Malaybalay, Bukidnon, and the communists' demand to free 400 of their comrades, captured and presently in jail, which he said convinced him to end the peace talks

Top communist negotiator Luis Jalandoni, scion of a Negros landlord clan who has been living in the Netherlands for the past 30 years, said the soldiers were killed by government assassins in order to derail the peace talks.

The CPP, however did boast f the 18 attacks against governnent forces, euphemistically callng these " active defense" in its ebruary 7 edition of Ang Bayan.

"Various units of the NPA aunched more than 18 armed ictions all over the country in ompliance with the directive of ts National Operations Command to undertake active defense to defend the welfare of the citizens and of the revolutionary forces," the party publication said in Filipino (my translation).

Only a fool, though, would call the following attacks as made only in "active defense" which I quote verbatim, translated from the Pilipino:

• "The NPA Eduardo Dagli Command in Batangas harassed a detachment of the Philippine Air Force February 1 at Sitio Buntog, Barangay Bulihan, Nasugbu."

 "The NPA Celso Minguez Command in Quezon ambushed a patrol of the 31st Infantry Batallion in Trece Martires, Casiguran, February 6, Two soldiers were wounded.

 "The NPA's Napoleon Tumagtang Command in Southern Panay attacked troops of the 82nd Infantry battalion and the 3rd Infantry Battalion that were conducting operations in Baragnay Boloc, Tubungan, Ilioilo and Barangay Osorio III in San Remigio, Antique."

 "Red fighters harassed troops of the 8th Infantry Battalion camped at Barangay Concepcion, Valencia City, Bukidnon."

 "Red fighters February 2 captured and declared prisonersof-war two soldiers of the 39th Infantry Battalion at Telefas, Columbio, Sultan Kudarat.

Quite obviously, the NPA acted as if there were no peace talks at all. There could be only two



explanations for this

First, the "peace talks," are merely a tactic for the communists to keep the Republic's military cooped up in their camps, unable to undertake operations against the NPA, while the latter expands its recruitment and areas of operations. In past peace talks, the NPA recovered areas they had lost when there were no peace talks, and executed, barangay officials who had cooperated with the government.

Second, the peace negotiators, mainly Jose Sison, Fidel Agcaoili, and Jalandoni who have lived in the Netherlands for over 30 years have no influence or control at all over the NPA, or the party leadership in the Philippines, which continue their programs for expanding their territory while their comrades abroad make fools of government negotiators. Without any role in the revolution, Sison et al's existence and lives in that social-welfare advanced country, are justified only if they pretend to be undertaking the noble pursuit of peace.

Pico de Loro attack

The biggest incident that not only exposes the peace talks as a huge deception by the Communist Party, but the NPA as a threat to the country's image as a safe place for tourists and investors was the NPA's attack January 29 at the tycoon Henry Sy's Pico de Loro resort, which is just two

hours from Makati and a favorite weekend escape for the rich from the polluted metropolis. Strangely, the broadsheets did not report it.

Following is the communist newspaper Ang Bayan's account (translated form Filipino) of this attack in its February 7 edition, which it described as intended to 'punish Henry Sy":

"The NPA confiscated fortyone arms, including 14 M-16s and 20 shotguns, thousands of bullets, magazines, and communications equipment in two raids to punish the Selective Security Agency and 3-1 Security Agency on January 29, 6:30 to 7.45 in the evening at Barangay Papaya, Nasugbu (location of Pico de Loro, with these agencies those guarding the resort--RDT)

"The Red fighters of the NPA's Eduardo Dagli Command of Batangas disarmed the guards and armed goons of Henry Sy at Hacienda Looc The NPA, however, made sure that guards and employees of the security agen-

cies were not harmed.

"The attack was part of the NPA's step to punish Henry Sy and his guards for the violent grabbing of lands at Hacienda Looc. These guards have several times aimed their guns at farmers living in this land. The guards have also prevented fishermen from fishing in the waters of Hamilo Cove and driving farmers away from Henry Sy's lands at Barangay Calayo and Barangay Papaya.

The number of NPA attacks appears to be more than the 18 claimed in the Ang Bayan article. NPA spokesman "Ka Oris" says it is 30, in the following statement issued February 11 with which he announced—in a tone of intrepidity, I would say—the CPP's decla-


ration of all-out war on President; Duterte's administration:

"Starting today, the Unilateral Declaration of Interim Ceasefire is now completely terminated. All NPA commands and territory rial units, as well as people's militia and self-defense units, can now take the full initiative to. defend the people and advance: their interests, especially in the face of the declaration of all-out; war of the Duterte regime.

"Since February 1, we eagerly waited for the GRP's positive, response to widespread clamor. for it to implement its CAR-i HRIHL obligations (primar-) ily the release of all political, prisoners) which could have preempted the termination of the CPP and NPA's unilateral ceasefire. Contrary to the hopes of the people, however, GRP, Pres: Duterte displayed intran-> sigence and arbitrarily cancelled; all peace negotiations, playing to the AFP line of an 'all-out war' against the CPP and NPA.

"Over the past ten days, responding to orders to carry out active defense, NPA units carried out almost 30 military; actions to defend the rights and, welfare of the people, primarily, against AFP troops occupying barangays and conducting strike operations. In its active defense; posture, NPA operations were, launched exclusively against, paramilitary groups and uniformed personnel conducting, combat, intelligence and psywar_s operations within the territories, of the revolutionary government. A case in point is the February 1 encounter between the NPA and troops of the 8th IB, which had been occupying Ba-, rangays Kibalabag and Manalog, 36 kilometers from the center, of Malaybalay City, Bukidnon.
