Phivoles warns Valley Fault residents

Residents of Metro Manila and nearby provinces should prepare for the "Big One," a magnitude 7.2 earthquake to be generated by the West Valley Fault, which is ripe for movement.

Amid the devastation caused by the magnitude 6.7 earthquake in Surigao, the Philippine Institute of Volcanology, and Seismology (Phivolcs) yesterday appealed to residents of Metro Marula and nearby provinces to prepare for a powerful earthquake that could kill thousands

"Everyone must learn from the recent effects of the magnitude 6.7 earthquake in Surigao del Norte. If

a similar event happens in a highly urbanized area, the effects can be more devastating," Phivolcs director Renato Solidum warned

State seismologists have repeatedly warned the public that the West Valley Fault is ripe for movement.

The West Valley Fault, Solidum said, moves roughly every 400 years. The last major earthquake generated by this fault was in 1658 or 357 years ago.

The 100-kilometer fault traverses parts of Bulacan through Quezon City, Marikina, Makati, Pasig, Taguig

A 2004 study funded by the tion Agency for Phivolcs and the Metropolitan Manila Development Authority showed that the magnitude 7.2 quake could kill up to 34,000 people and mure 100,000 others due to collapsed buildings.

Solidum explained that the movement of the Philippine Fault (Surigao segment) would not trigger the movement of faults farther like the West Valley Fault The Asian . By

Phivolcs continued to record aftershocks from the magnitude 6.7 quake that hit Surigao last Friday night, killing at least eight people and injuring hundreds.

More than 150 aftershocks

have been recorded as of yesterday morning, Phivolcs said.

At 351 am yesterday, an aftershock of magnitude 41 struck Surigao It was reportedly telt at Intensity 3 in the city.

Phivolcs earlier warned the public to brace for more after-

shocks from the magnitude 6.7 quake that could collapse already damaged structures.

■ Church and government should look for middle ground for the good of Filipinos, he says

"Walk for Life' on Saturday will send message that prayers, not blood, should fill the streets

The Catholic Bishops' Conference of the Philippines (CBCP) is hoping to engage an increas. ingly antagomstic Duterte administration in "greater critical; collaboration," its president, Archbishop Socrates Villegas, said on Monday

At the Meet Inquirer Multimedia forum, the Lingayen-Dagupan archbishop disclosed that the 120-strong CBCP had designated a group of bishops, whom he declined to name, to keep the communication channel open

Villegas said this group was doing "pretty well." having been able to establish a connection with one of President Duterte's Cabinet secretaries, an ex-seminarian. There are three former seminarians in the Cabinet Leoncio Evasco, Ernesto Pernia and Ismael Sueno.

"There is a level of openness with the government because [it] is still composed of Filipinos and most of them Catholics and three of them exseminarians and they are also in need of our pastoral care," said the 56-year-old prelate.

"We look at it from the bigger point of view and looking at the pro and anti as both our parishioners. We want to keep the communication lines open to all sectors of society because we are bishops." Villegas said.

Villegas was asked why the Church was seemingly hesitant to lead its flock into a moral outrage amid the wave of ethical and moral issues houndingthe country under Mr.

Duterte's unorthodox style of leadership just as it did during the dark days of martial law.

The CBCP head noted that "critical collaboration" was also the Church's response during the Ferdinand Marcos dictatorship, listening not just to human rights victims but also keeping the line open to dialogue with the government.

Striking a balance

Villegas said the Church was very vocal and active during the Marcos regime, but there were also occasions during those years when then Manila Archbishop Jaime Cardinal Sin found himself attending socials in Malacañang or celebrating Mass for Marcos.

"It was walking a tightrope,

striking a balance between being a prophet of denunciation and yet a minister of healing and reconciliation. And until now, that is clearly our mission," said Villegas, Sin's protégé.

"We will denounce what is evil but we will also offer the ministry of healing to those who are willing and ready to receive it," he said.

The Church and the Duterte administration have been at loggerheads over a wide range of issues, particularly the rising number of deaths in the President's bloody war on drugs and the moves in Congress to reinstate the death penalty.

On Jan. 30, the CBCP issued a pastoral statement, its strongest message so far, opposing the revival of the death penalty as

Congress began plenary debates on House Bill No 4727, a consolidated version of seven bills on capital punishment

Villegas has also endorsed a grand procession dubbed."Walk for Life, on Feb. 18 initiated by the lay group Laiko following the CBCP pastoral letter to protest the spate of drug-related killings in the country and proposals to revive the death penalty

During the forum. Villegas Said five procession, from 4:30 am to 7 am; was aimed at "sending the message that the country's streets should be kept safe and should be filled with prayers, not with blood.

'We are not afraid'

"And after that we hope that there will be more people who would be disturbed every time one human person is killed because one brother or sister killed is already too much and we should not allow this to keep on increasing," Villegas said.

He said the CBCP was not afraid of Mr Duterte, who had repeatedly blasted the Church as "the most hypocritical institution."

When I say we are not afraid of President Duterte, don't get me wrong. I'm not picking a fight, I am not saying we are equals. What I am saying is, there is only one thing that makes us afraid and that is sin." he said

When asked how the CBCP would collaborate with the Duterte administration, he said the Church would start with a study of what good things the other party had done so far in combating corruption, helping the poor and reaching out to the margins, among other things INQ

4 NPAs killed in Masbate

I.EGAZPI CITY - Four New People's Army (NPA) rebels were killed yesterday morning in an encounter with soldiers in Barangay Pangle in Arorcy, Masbate, the military reported

Capt Joas Pramis, public affairs officer of the Army's 9th Infantry Division, said a platoonled by 1/Lt April John del Rosario was conducting combat operation at about 6.30 a.m. when they clashed with communist guerrillas

Pramis said four rebels were killed during the 20-minute firefight and the soldiers recovered two M-16 rifles, two M-14 rifles, an M-203 rifle grenade launcher, an improvised explosive device, two handheld radios, a hand grenade, assorted ammunition and magazines

and communist propaganda materials

Col. Fernando Irmidad, commander of the 903rd Infantry Brigade, said the bodies of the slain rebels were brought to a morgue in Aronov town proper

Arorey, Masbate, the miliry reported farmers in the barangay of Capt Joas Pramis, public extortion by NPA rebels," said airs officer of the Army's Trinidad

In Ifugao, a soldier and several NPA guerrillas were reportedly wounded during clashes in Asipulo town on Sunday evening

The Army's 54th Intantry Battalion said the encounter lasted for more than an hour in Barangay Namal

Army Captain Jefferson Somera, civil military operations officer of the 54th IB, said government troops seized one rifle left by the retreating rebels who carried their wounded companions.

Col Edgard Arevalo, chief of the Armed Forces of the Philippines Public Affairs Office, said six NPA members were captured by members of the Army's 73rd Infantry Baltalion following an encounter in Sarangani

He identified the rebels as Simeon Salda, Jun Moda, Claude Palbe, Garzon Palbe, Rene Ompao and Sabelo Colano

Arevalo said the NPA is suffering tactical defeat since the AFP launched an all-out war against them nine days ago.

Arevalo claimed that while the National Democratic Front continues to push for the resumption of peace negotiations, it is clear that they are losing hold on their men on the ground

4 rebels slain in Masbate

killed in a 20-minute firefight between government troops and the New People's Army in Barangay Pangle, Atoroy town in the island province of Masbate on Monday morning

This was the first bloody encounter between the military and the rebels in the Bicol region after President Rodrigo Duteite suspended the peace talks with the Communist Party of the Philippines over a week ago

Soldiers of the 2nd Infantry Battalion (2IB) led by Army 1st Lt April John del Rosario were conducting regular combat operations when they encountered the communist insurgents. The gun battle resulted in four casualties on the rebels' side

Major Gil Perez, spokesman of the Southern Luzon Command (Solcom), said soldiers from the Army's 21B encountered at least 20 members of the NPA at about 6:20 a.m. in Barangay Pangle, Aroroy while on regular patrol

"Our troops from 2IB under the 903 Infantry Brigade recovered two M14 rifles, two M16 rifles, one M203 grenade launcher and subversive documents from the NPAs," Perez added.

The Bicol region specifically the provinces of Sorsogon, Masbate and Camarines provinces were identified as rebels' lair

Army Colonel Fernando Trinidad, commanding officer of the Army's 903rd Infantry Brigade, urged the communist guerrillas to return to the fold of the law as the military is willing to assist them and help provide livelihood to start a new life with their families.

The Solcom said they are open for localized peace talks at the grassroots level and encourage the NPA to stop resorting to violent means, attacking government projects and civilians in the countryside.

CAMP O'DONNELL, Capas, Tarlac – LTGEN GLORIOSO V MIRANDA AFP, Commanding General of the Philippine Army visited Headquarters of the Mechanized Infantry Division led by MGEN EDGAR F GONZALES AFP based at Camp O'Donnell Brgy Sta Lucia, Capas, Tarlac on 11 February 2017.

An information briefing, tour of facilities and Capability Demonstration of the newest armored vehicle of the Mechanized Infantry Division, the M113A2, Caliber .50 with Red Dot Sight, Remote Controlled Weapon Station (RCWS) and Unmanned Turret System (UTS) was demonstrated to LTGEN MIRANDA and his party.

All these vehicles have the M113 APC platform. These vehicles have a top land speed of 64 kph and top water speed of 5.6 kph. It has long been used in combat in various areas of our country and is proven to be tough and effective. These vehicles were acquired through the Armor Acquisition Project under the AFP's Capability Upgrade Program.



During this visit LTGEN MIRANDA was able to give his personal message to the troops. He emphasized the importance of combined arms and encouraged everyone to have a good teamwork in order to achieve our mission and to realize how potent and how powerful really our capability.

Army division chief reaches out to Maguindanao's orphans of war

CAMP SIONGCO, Maguindanao — With peace prevailing in its area of jurisdiction, the Army's 6th Infantry (Kampilan) Division, led by Brigadier General Arnel B. Dela Vega, 6th ID Multi-Sectoral Advisory Board, Goldin Institute Philippines (GIP) and the Autonomous Region in Muslim Mindanao (ARMM), launched over the weekend its Peace and Development Program in a remote village in Maguindanao.

The program, dubbed as Project "Kagkapia" (Hope), was launched with the support of Regional Governor Mujiv Hataman through the Humanitarian Emergency Action Response Team (HEART) and Dr. Susana Anayatin of GIP, aims to extend help and psychological intervention to orphans of Markaz-ul Aytam Orphanage Center in Barangay Gang, Sultan Kudarat, Maguindanao.

Capt. Arvin Encinas, 6th ID Public Affairs Office chief, said "Project "KAGKAPIA" or Hope," benefited 280 children who are orphans of war due to the conflict in the region.

Most of these children, with ages ranging from 8 to 22 years old, came from conflict-affected areas in the five provinces of ARMM: Maguindanao; Lanao Sur, Basilan, Sulu and Tawi-tawi.

The peace and development project includes activities such as the distribution of sports equipment, slippers, hygiene and sanitary kits, food supplies and the feeding program, Capt. Encinas said.

Physical enhancement of the orphanage's facilities through repair and renovation to be facilitated by the 6th Civil-Military Operations Battalion with construction materials provided by the regional governor, Hon. Mojiv S. Hataman, shall also be undertaken to uplift the living conditions of the orphans.

"The objectives of Project "KAGKAPIA" aims to make the orphans feel that the government and other sectors of the society care for them and guide them to have high hopes for their future," Encinas added.

Convergence of efforts among various stakeholders for the project is also sought by the Armed Forces of the Philippines to realize the whole of nation approach in achieving lasting peace and development.

"Orphans of war, if not properly taken cared of, can be potential source of recruits by bad elements or even terrorists/extremists hence, project "KAGKAPIA" is 6ID's tool to insulate the children from their influence," said Brig. Gen. Dela Vega.

The Markaz-ul Aytam Orphanage Center is administered by Ustadz Hasan Maloon relying only from voluntary contributions from benevolent sources.

Army, PNP defenses up vs. rebels attacks

Increasing New People's Army attacks in various areas of the country, have been noted in the past several days and both the Philippine Army and National Police in Negros Island Region are not taking chances by revisiting their offensive and defensive strategies.

Senior Supt. William Senoron, provincial police director of Negros Occidental, also said yesterday that he reconvened the Joint Peace Security Coordinating Council to review their security contingencies, after the unilateral ceasefire was lifted.

The JPSCC meeting Friday attended by commanders of the 6th Special Action Battalion, Regional Public Safety Battalion 18, 62nd Infantry Battalion, Public Safety companies, and other law enforcement agencies, also focused on the realignment of security forces, in anticipation of possible NPA tactical offensives.

Senoron said the PNP will be actively supporting the internal security operations of the Philippine Army, especially in intelligence gathering.

The Negros Occidental Police Provincial Office is also consolidating its public safety units that are deployed in others areas of the province.

Maj. Gen. Jon Aying, 3rd Infantry Division commander, maintained that liivelihood in the countryside is the "key" in the fight against insurgency.

"With the support of the government, the non-government organizations, the military and the people themselves, we will work hard to make such efforts bear fruit," Aying said.

Brig.Gen. Francisco Delfin, 303rd Infantry Brigade commander, meanwhile, encourages localized peace talks.

"There have been precedents of localized peace talks, although these were hidden, since the focus was on the peace talks at the national level," Delfin said.

He said that in the past six months, "NIR experienced a peaceful environment, in the absence of insurgencyrelated incidents, because of the unilateral ceasefire observed by both the CPP-NPA and the Philippine Army."

Priest-turned-rebel Frank Fernandez, spokesman of the National Democratic Front in Negros, has repeatedly turned down offers for a localized ceasefire.

After the unilateral ceasefire was lifted, Army soldiers stationed in Negros island went on combat mode in anticipation of NPA attacks following clashes in Iloilo and other areas of the country.

This group is composed of IP leaders from different CADT areas in Caraga and was organized last November 14, 2015 to provide a venue for ICC/IP leaders to meet, discuss and agree amongst themselves the different issues and concerns currently being confronted by the ICCs.

Meanwhile, in his assumption speech, Lt. Col. Valdez recounted his significant experiences in the military service. He said that he has learned the value of constant learning as a means for personal and professional growth.

"I am more inclined in doing my best and to continue what my predecessor have started and accomplished especially that he has able to make a difference during his term in this battalion," Valdez said.

Sarangani, ComVal clashes leave one soldier wounded

A SOLDIER of the 73rd Infantry Battalion was wounded after a series of armed clashes with the NPAs in Sarangani and Compostela Valley on Saturday, Feb. 11.

Capt. Rhyan Batchar, spokesperson of 10th Infantry Division, said the first incident occurred around 10:30 a.m. on Saturday when troops engaged communist guerrillas belonging to the Front Guerilla 71 in a two-hour firefight in Sitio Tangis, Barangay Little Datal Anggas, Sarangani.

The wounded soldier, whose name is withheld pending notification of his family, was immediately airlifted to Camp Panacan hospital in Davao City for medical attention.

Meanwhile, three consecutive firefights occurred in Barangay Bollucan, Laak, Compostela Valley between troops of 60th IB and the NPA belonging to Guerilla Front 34 and Pulang Bagani Company 4 starting at 10:40 a.m.

The exchange of gunfire lasted for about an hour.

Simba fighting vehicles were immediately dispatched resulting to another 40-minute gunbattle against the withdrawing NPA 700 meters away from the first encounter at around 11:50 a.m. of the same day. The troops involved in the first encounter pursued the NPA in the same area which resulted into half-an-hour clash.

The troops of 73rd IB were in pursuit of the fleeing NPAs following a series of clashes in Sitio Kisoy, Barangay Little Baguio, Malita, Davao Occidental and Sitio Dulid, Barangay Datal Anggas, Alabel, Sarangani on Feb. 6 and 8, respectively.

On the other hand, troops of the 60th IB pursuing the NPA in Laak, Compostela Valley earlier stumbled upon several NPA encampments in barangays Macopa, Langtud and Bollukan.

Batchar said the latest incidents involved the employment of MG 520 attack helicopter and 105mm howitzer which delivered fire support to the engaged troops.

Ground forces are now conducting clearing operations.

In a separate report from the 67th Infantry Battalion, troops on board three KM450 military trucks were attacked with an improvised explosive device at the vicinity of Daw-an, Barangay San Jose, Caraga, Davao Oriental around 2:45 a.m. of Feb. 11. No soldier was hurt in this incident.

The 10th Infantry Division earlier accounted 10 NPA rebels who surrendered since Feb. 1.

Maj.Gen Rafael Valencia, the division commander, said relentless combat operations will continue until they cripple the NPA.

"We are urging NPA members to return to the folds of the law and abandon the group that continuously extorts, attacks and harass our fellow Filipinos," he added.

Four abducted by NPA, including brgy. captain

A BARANGAY official and his wife, along with two others, were allegedly kidnapped by the New People's Army in two separate incidents on Feb. 5 and 8.

Based on the report of 25th Infantry Battalion, Barangay Pangyan chief Rene Carlos and wife Maribeth Carlos were abducted along the road in Trento, Agusan del Sur on Feb. 5. Their companions were released while the couple was hogtied.

There's no news yet of the demand from the armed men on the couple's abduction.

Meanwhile, in a separate report from 71st Infantry Battalion, Jun-jun Custodio and his son, Marjun, were allegedly abducted by armed men, led by alias Mokloy who is reportedly a team leader of NPA's Milisya ng Bayan, in Barangay Malamudao, Maco, Compostela Valley on Feb. 8.

Brig. Gen Macairog Alberto, 1001st Infantry Brigade commander, said they believe the NPA kidnaps innocent civilians to use them as human shields.

Meanwhile, Maj.Gen Rafael Valencia, the division commander, urged the NPA to spare civilians in their activities.

"The NPA is being used by their communist leaders as instruments of their propaganda to the extent of using them to sow fear among the innocent civilians," he said.

Soldier, 2 civilians killed in NPA attack

THE ARMY has condemned the rebels' attack in Agusan del Sur that killed two civilians and wounded three other non-combatants on Saturday.

The attack that also killed a soldier is a clear violation of the Comprehensive Agreement on Respect to Human Rights and International Humanitarian Law (CARHRIHL), which the communist group agreed with the Philippine government in 1998 in The Hague, Netherlands, said Lt. Col. Glenn Joy Aynera, the commanding officer of the Philippine Army's 29th Infantry Battalion (IB).

Guerillas attacked Sitio Sarog, Barangay San Isidro of Santiago, Agusan del Norte on Saturday at 5 a.m., seven hours after an earthquake hit the area.

Aynera said he sent his soldiers to the barangay after receiving reports that there were armed men conducting extortion activity in the area.

"There was a situation in that community that needed to be addressed," Ayner said. "That's why I have sent my soldiers to secure the people against these NPAs."

Upon reaching the community at around 4:30 a.m., the troopers were able to talk with some locals to confirm the report.

But around 10 fully-armed NPAs, unmindful of the civilians in the area, indiscriminately opened fire. Two civilians and one soldier were instantly killed and three other civilians were wounded in a 10-minute attack.

"We condemn their atrocious act that claimed the lives of two innocent civilians, and seriously wounding three others. We are also deeply saddened for the loss of one of our comrades," he further said.

The communist groups under the National Democratic Front of the Philippines (NDFP), including the Communist Party of the Philippines and the NPA, signed the CARHRIHL, in which they agreed "to affirm and apply the principles of international humanitarian law in order to protect the civilian population and individual civilians."

Aynera said the agreement calls that "civillan population and civillans shall be distinguished from combatants and, together with their property, shall not be the object of attack."

"They shall likewise be protected against indiscriminate strafing," he said.

Aynera assured the public that they will "always continue to conduct peace and security operations to ensure the safety and security of the people in Agusan del Norte."

Pursuit operation is ongoing to capture the perpetrators of the attack.

The NPA declared a ceasefire in the earthquake-hit Surigao del Sur and three towns of Agusan del Norte. Santiago is not among the three towns but is in the boundary of Tubay and Jabonga, two of the three municipalities.

Another attack

in Laak, Compostela Valley on the same day, 60th IB troopers engaged undetermined number of NPAs guerillas in a 30-minute gunfight.

No soldier was hurt.

The attackers belong to the NPA's Guerilla Front 34 and Pulang Bagani Company (PBC) 4.

Meanwhile, two NPA amazons returned to the folds of the law after a community dialogue conducted by the troopers of 67th IB in Caraga, Davao Oriental on Friday.

Capt. Rhyan Batchar, spokesperson of 10th Infantry Division, identified the two amazons as Ka Joy, 20, and Ka Rose, 17, and both members of Guerilla Front 15.

Soldiers of 67th IB were consulting with 150 displaced families temporarily housed in Caraga Municipal Gymnasium when the two NPA amazons surrendered

The displaced families from Barangays Don Leon Balante and PM Sobrecarey of Caraga reportedly left their homes due to NPA presence in their communities.

Earlier, six NPA members returned to the folds of the law in Davao Oriental through the 67lB while two others submitted to the 73lB in Davao Occidental.

The latest surrender count is now 10.

Maj. Gen Rafael Valencia, 10th ID commander, encouraged the NPA members to leave their group before the full brunt of military capabilities will catch up with them.

"The NPA members are just victims of the manipulation of their communist leaders," he said.

Rebelleader falls in Metro

ECURITY forces captured an alleged ranking leader of the New People's Army (NPA) in Metro Manila, reports eaching Camp Crame, Quezon City said n Monday.

Ferdinand Castillo, tagged by ie police as secretary of the NPA's letro Manila Regional Party Committee, was arrested by intelligence agents of the Philippine National Police (PNP) Criminal Investigation and Detection Group (CIDG) and the Intelligence Service Group of the Philippine Army in Barangay Sia Quiteria Caloocan City Sunday.

Castillo is facing a warrant of arrest for wanted for double murder and multiple attempted murder issued by Branch 63 of the Calauag, Quezon Regional Trial Court

Seized from Castillo were a 45 cal. pistol with five bullets and assorted identification cards.

Meanwhile, Col. Edgard Arevalo, chief of the Armed Forces of the Philippines (AFF) Fublic Affairs Office, said that since the government launched an all-out war against the NPA, six rebels have been killed, 12 arrested, 14 surrendered and 19 firearms were recovered

"It has been nine days since the AFP launched an all-out-war against the New People's Army (NPA). And since then, the com-

munist rebels had suffered several tactical defeats and the support of some frightened citizens continues to erode," Arevalo said.

"While the National Democratic Front (NDF) continues to push for the resumption of the peace negotiations, it is clear that they are losing hold of their men on the ground. They are either attacking innocent civilians and business establishments; or surrendering to the government fold," he added.

On Monday, four rehels were killed during an encounter with government forces in Masbate.

Atevalo said members of the Philippine Army's 2nd infantry Battalion and the 96th Military Intelligence Company were conducting security operations in Barangay Pangle in Masbate when they encountered around 20 NPA guerrillas.

No casualty was reported on government side.

Valor awardee heads fight vs Abu Sayyaf in Sulu

A RECIPIENT of the Medal of Valor, the highest military decoration in combat, is the new commander of the Joint Task Force Sulu which is going after the Abu Sayyaf in the island-province.

Col. Cirilito Sobejana of the Philippine Military Academy Class of 1987 assumed the post Saturday in rites presided by Maj. Gen. Carlito Galvez, chief of the AFP Western Mindanao Command, in Camp Teodulfo Bautista, the task force's headquarters, in Jolo town.

Sobejana, who was commander of the 601st Brigade based in Maguindanao before his new designation, replaced Brig Gen. Jesus Mananquil who is now commander of the Joint Task Force National Capital Region.

Sobejana was awarded the Medal of Valor "for conspicuous gallantry and intrepidity at the risk of life above and beyond the call of duty" in connection with a fierce gun battle with at least 150 Abu Sayyaf criminals in Isabela City in Basilan in January 1995. Then a captain, he led the 1st Scout Ranger Company in a two-hour firefight that led to the death of 30 Abu Sayyaf men. Sobejana sustained a bullet wound that almost severed his right arm.

Early last month, Armed Forces chief Gen. Eduardo Año set a new timetable for the military to defeat the Abu Sayyaf and other terrorist groups in Mindanao - within the first six months of the year

Sobejana said he is confident he can finish off the Abu Sayyaf within the timeframe,

He said he would introduce some adjustments in the strategy to defeat the Abu Sayyaf. "It's not going to be an abrupt adjustment It's just a matter of strategizing the deployment of our forces and the concept of operations that we will be undertaking."

Muksan said they will be tasked to conduct foot patrols in the community where they will be assigned to and conduct checkpoints in the villages where ASG bandits are found.

Muksan, who is known as a disciplinarian in the police organization also said "ayoko ang police na

The police provincial director also said that the police scalawags who will be assigned to Basilan will not stay in office. They will always conduct patrols in the vicinity of their assigned towns

Lamitan City Mayor Rose Furigay

opposed the assignment of policemen in her city saying that she would prefer the presence of smart policemen in the city over police scalawags.

Lamitan City Councilors Ajid Dalawis, a retired police chief of Lamitan City and Malik Uyag were one in saying that the scalawags should be assigned to critical areas and join military operations against the ASG.

Councilors also said PNP Chief Director General Ronald dela Rosa should instead terminate the police scalawags from the service and recruit new ones who can protect and serve the people better.

ROTC is good for the Filipino youth

ALACANANG'S recent approval of the plan to make the Reserved Officers Training Corps (ROTC) program mandatory for all senior high school students certainly comes as good news to those yearning for a more disciplined and patriotic citizenry.

And beyond the sense of discipline and patriotism that one gets, from active involvement in ROTC is the readiness to fulfill the ultimate responsibility of defending the Philippines from foreign aggression considering that defense of the state is the duty of everyone

It was Singapore's founding father Lee Kuan Yew who prominently pushed the idea that an army comprised of the nation's citizenry can serve as a deterrent to foreign invaders because of the "knowledge that even if they could subdue our armed forces, they would have to keep down a whole people well-trained in the use of arms and explosives"

The move to revive mandatory ROTC comes at a time when controversies — hazing, abuses by trainers and cadet officers, corruption, among others — that hounded the program in the past are still in the minds of those who decried the 2001 killing of cadet Mark Chua who exposed corruption that plagued the ROTC at the University of Santo Tomas. After his death, ROTC became optional starting in 2002 through RA 9163 or the National Service Training Program Act.

Critics of ROTC cannot be blamed if abuses and violence in the past have created the impression that the program is no good and students are not learning anything other than marching on the field un-

der the sweltering heaf of the sun. A militant youth group even claimed ROTC promotes "blind obedience" and that it is "nothing more than a fascist tool of repression used by the state to instill a militaristic mindset" among students.

But many are in favor of ROTC. Listeners of the DZMM teleradyo program. Magpayo nga Kayo (Saturdays, 9 30 to 10 30 am), which I now co-hest with veteran broadcaster May Valle Ceniza, have called in or sent text messages to express support, saying military training fosters not only discipline but also chivalry which now seems to be waning among the youth in these modern times

All the marching and the various formations that ROTC cadets execute under the hot sun indeed have their purpose. Leadership skills, teamwork and unity are developed and the grueling exercises instill the value of discipline and sacrifice to achieve common objectives. I should know I became corps commander in Preparatory Military Training during my high school days

In those days, we viewed the training as a sort of rite of passage from adolescence towards adulthood Sporting long hair was the fad then, and like others in the bloom of youth, I didn't want to go against the trend by having the short haircut required for the training. But it didn't take long for us to learn and appreciate the value of humility and obedience to authority

Discipline and obedience to authority developed through the ROTC program can go a long way in addressing the problems our country is faced with — from the hellish traffic jams worsened by undisciplined motorists and pedestrians, to the nightmarish drug menace.



with all the values that help shape a young person's character—aside from toughening of the phy sique through puships and jumping jacks—derived from ROTC, it is essential to bring back the old glory of citizens' military training, minus all the bad things that have tarmshed its image As the idiomatic expression goes, "Don't throw the baby out with the bathwater"

To gain widespread acceptance and make the public realize the necessity of ROTC in our country's development and security there is need to enhance the program and put in place the necessary safeguards to avoid controversies anew

Our leaders could be guided by what Lee said when he started building Singapore's defense system to the exemplar that it is today. "We had to re-orientate people's minds to accept the need for a people's army and overcome their traditional dislike for soldiering. Only if we changed people's thinking and attitudes could we raise a large citizen army like Switzerland or Israel."

With public acceptance of an improved ROTC program, it would then be easier to implement, if the need should arise, the provision (Article 2, Section 4) in the 1987 Constitution which states that "Government may call upon the people to defend the State and, in fulfillment thereof, all citizens may be required, under conditions provided by law, to render personal military or civil service."

And the knowledge that millions of Filipinos with ROTC training would be capable of defending the motherland can indeed help deter enemies of the state

Hopes remain for revival of peace talks

HE call of over a hundred congressmen for the revival of the peace talks between the government and the National Democratic Front (NDF) representing the Communist Party of the Philippines (CPP) and the New People's Army (NPA) reflects a widespread feeling that, with so much already accomplished in the talks, it would be unfortunate if they are now abandoned.

The call to revive the talks was made last Thursday by some 100 lawmakers represented by the Makabayan bloc in the House of Representatives, after the collapse of the peace talks in Rome. Italy Frustrated by President Duterte's refusal to release immediately some 400 political detainees, the NDF-CPP-NPA panel had announced that the NPA commanders in the field were now free to determine if they would still follow their unilateral ceasefire. President Duterte answered with his own announcement cancelling the government's own ceasefire.

The Makabayan bloc in the House includes lawmakers of party-list organizations Bayan Muna, Gabriela, Alliance of Concerned Teachers, Anakpawis, and Kabataan. The bloc lamented the breakdown of the talks when so much progress, it said, has already been accomplished.

The negotiating panels had held three sessions

- the first two in Oslo, Norway, with the support
of the Norwegian government, and the latest in

Rome, Italy. The two sides had reached agreement on several issues under Socio-Economic Reforms and Political-Constitutional Reforms. They were to take up proposals for a binding bilateral ceasefire—to replace their separate unilateral ceasefires—at their next meeting on February 22-25 in Utrecht, Switzerland.

In its resolution urging a revival of the talks, Makabayan stressed that the talks under the Duterte administration had gone so much farther than in previous administrations. In response to the President's statement that the peace talks would resume if there is a compelling reason that will benefit the nation, Makabayan said a "just and lasting peace" is a compelling reason to continue the talks.

The two sides will have to step back from their positions on the release of detained political prisoners and reach some middle ground. They also need to talk it out on the NPA complaint that government soldiers are helping in civic community programs in areas they claim to be under their authority

These are minor issues compared to the solid and basic socio-economic and political-constitutional matters that they have already discussed Even without declared ceasefires, the two sides should exert all possible efforts to avoid any encounter. In due time, the proper atmosphere for talks should come about and the peace efforts can resume.

AFP: NPA suffering tactical defeat

MANILA, Philippines — The Armed Forces of the Philippines claimed on Monday that communist rebels are suffering a tactical defeat following a spate of kidnappings, encounters and arrests over the past few days. In a press statement, the Armed Forces declared that the New People's Army (NPA) has suffered defeats in several fronts in different provinces more than a week after President Rodrigo Duterte launched an all-out war against communist guerillas.

"And since then, the communist rebels had suffered several tactical defeats and the support of some frightened citizens continues to erode," the military said.

The AFP attributed these advances to "deliberate, surgical, focused and well-planned combat, intelligence and

civil-military operations" launched by the military in various areas.

The military also asserted that the communist rebels were losing hold of their men on the ground as demonstrated by the mismatch between National Democratic Front's (NDF) call for continued peace talks and the rebels' attacks on civilians and businesses.

In Barangay Pangle in Masbate, four NPA members were killed after a 20-minute gunfight at 6:30 am on Sunday. Elements of the 2IB and 96 military intelligence encountered the rebels while conducting security operations in the area.

The troops recovered two M14 rifles, two M16, one m203 and subversive documents following the retreat of the rebels toward the southeast direction.

The military also said that two civilians and one soldier was killed in an ambushed staged by NPA rebels in Agusan del Norte on February 11 while the soldiers were acting on reports on NPA presence in Santiago town. Three civilians were also seriously wounded when the 10 rebels "indiscriminately fired" government troops. Other incidents of NPA attacks were also reported on February 11 in Caraga, Davao Oriental and on February 12 in San Fernando, Bukidnon. No casualties were recorded in these two incidents.

The AFP also reported that NPA elements abducted four civilans in two separate incidents in Trento, Agusan Del Sur on February 5 and in Moco, Compostella Valley on February 8.

On Febuary 12, the Philippine National Police and an intelligence unit of the military arrested an NPA leader in Caloocan City.

The leader was identified as Ferdinand Castillo, secretary of the Metro Manila Regional Party Committee. The arrest was done by virtue of a warrant of arrest for double murder and multiple attempted murder charges issued by the Regional Trial Court Branch 63 in Calauag, Quezon Province.

In Sarangani, six NPA members were arrested, five of whom were carrying high-powered firearms.

AFP open to localized peace talks with NPA groups

NPA Violates CARHRIHL, indiscriminately killed 2 Civilians and 1 Soldier, Wounding 3 More

BUTUAN CITY — The NPA Terrorists Violated the only agreement that the CPP-NPA-NDF had so far signed with the government, the Comprehensive Agreement on Respect to Human Rights and International Humanitarian Law (CARHRIHL), when they swooped down a peaceful community of Sitio Sarog, Barangay San Isidro, Santiago town of Agusan del Norte and killed two civilians, wounding three others and killed one soldier at around 5 A.M, 11 February 2017.

A report was earlier received by the 29th Infantry Battalion about the presence of the said extortionist-terrorists in the area.

"There is a situation in that community that needs to be addressed that is why I have sent my soldiers to secure the people against these NPAs." Ltc Glenn Joy Aynera, 29IB Commanding Officer on his statement.

Upon reaching the said community at around 4:30 A.M., troops were able to talk with some locales to confirm the said report. However, unmindful of the civilians in the area, more or less ten (10) fully-armed NPA terrorists indiscriminately opened fire against the troops. Two (2) civilians and one (1) soldier were badly hit that caused their instantaneous death while three (3) other civilians were wounded.

The harassment lasted for about ten (10) minutes before the NPAs withdrew towards the nearby communities.

The government troops immediately applied first aid to the wounded civilians and facilitated their delivery to the nearest hospital, and conducted combat clearing operations.

Ltc Aynera said "This is a clear violation of the CARHRIHL which is duly signed by the GPH and NDFP in 1998 at The Hague, The Netherlands that Civilian population and civilians shall be distinguished from combatants and, together with their property, shall not be the object of attack. They shall likewise be protected against indiscriminate strafing."

"We condemn their atrocious act which claimed the lives of two innocent civilians, and seriously wounding three others. We are also deeply saddened for the lost of one of our comrades. Rest assured we will always continue to conduct peace and security operations to ensure the safety and security of the people in Agusan del Norte." Ltc Aynera Concluded.

Pursuit operation is ongoing to capture the perpetrators of the said crime.

Ceasefire by NPA in quake-hit areas a 'good move'—AFP

The declaration of a unilateral ceasefire by the New People's Army (NPA) in quake-hit areas in Surigao del Norte and parts of Agusan del Norte was a "good move," the military said on Monday.

"We welcome this expression within the portion of the ranks of the NPA. Ipinapakita lang nito na may bahagi ng NPA na nararamdaman na mas higit nilang gusto na yumakap sa kapayapaan (This shows that a part of NPA wanted to embrace peace)," Armed Forces of the Philippines public affairs office chief Col. Edgard Arevalo told reporters at Camp Aguinaldo.

The NPA in North Eastern Mindanao Region on Monday declared a temporary unilateral ceasefire in Surigao del Norte and quake-hit areas in Agusan del Norte from Feb. 11 to 11:55 p.m. of Feb. 20 to give way to relief operations.

A strong 6.7-magnitude earthquake struck Surigao del Norte last Friday which has left eight people killed so far. Arevalo said the temporary ceasefire by the NPA was "a good move" and they were happy that the communist rebels responded to their calls of sparing soldiers doing relief operations.

"There remains people who have good intentions, who have good desire at nagpapakita ng pagmamalasakit sa kapwa (show compassion for fellow countrymen)," Arevalo said.

He also urged the NPA to help out in relief operations and hoped they would do similar acts in the future. "We hope this will not happen only during calamities. Malay natin (Who knows) a repetition of similar actions may lead to the resumption of the peace talks," Arevalo said.

President Rodrigo Duterte terminated the peace talks early this month following the collapse of the unilateral ceasefires of the government and communist rebels. *RAM/rga*

Israel to provide equipment to Philippine special forces

1,190 Sets of force protection equipment (FPE) worth PhP53.5 million from Israeli company MAROM Dolphin Ltd. is set to be delivered in the second quarter of 2017. These equipment will be for the use of Joint Special Operations Group of the Armed Forces of the Philippines (AFP).

The winning company, MAROM Dolphin, supplies force protection equipment to the Israel Defense Force. The mode of procurement is government-to-government pursuant to a Memorandum of Understanding on Logistics and Defense Industry Cooperation and the Implementing Arrangement for Procurement of Defense Materials between the Department of National Defense (DND) and the Israel Ministry of Defense (ISRAEL-MOD).

JSOG is at the forefront of the current intensified anti-terrorism campaign. It is composed of specialized units from the various major services of the AFP, including the Philippine Army's Light Reaction Regiment, the Philippine Navy's Naval Special Operations Group, and a Special Operations Wing from the Philippine Air Force.

The Department of National Defense said this procurement is part of various equipment acquisitions that the Department is pursuing in order to upgrade the capability of the AFP in combating terrorist groups and terrorist cells.

"We have prioritized the procurement of these specialized vests for our defenders to enhance their survivability in encounters and battles against terrorists and lawless elements. Kahit saang lupalop sila magtago, hahanapin sila ng ating mga tropa!" Defense Secretary Delfin N. Lorenzana said.

16-year jail term vs AFP engineer affirmed

THE Sandiganbayan Third Division has affirmed the 16-year jail sentence meted out against engineer Dante Senen, supply accountable officer of the Armed Forces of the Philippines (AFP) Military Supply Unit in Cebu City on his conviction for graft and malversation of public property concerning the anomalous sale of four power generators to a private individual in 2002.

Senen failed to convince the anti-graft court to reverse its decision dated November 29, 2016 that found him guilty of conspiracy with former Philippine Air Force (PAF) Brig. Gen. Vladimir delos Trino, Major Antonio Jason Garcia, and private defendant Antonio Ularte of Eduard Enterprises for the unlawful transaction.

Delos Trino and Garcia were convicted of both charges in May 2011 but their co-accused, Senen and Ularte, remained at large. Senen was arrested only on November 21, 2011 inside Camp Aguinaldo, Quezon City. All three were collectively ordered to pay the government the sum of P1.2 million as indemnity for the loss sustained on the sale on top of a P1.2 million fine.

The court found the three AFP officials liable for selling the power generators to Ularte for only P800,000.00 without holding the required public bidding that tended to favor Ularte's firm.

In his appeal, Senen argued that there was no evidence that he colluded with Delos Trino and Garcia.

The court, however, declared otherwise, noting that it was Senen who had official custody of the power generators but the accused failed to inform his commanding officer about their transfer and did not include them in his inventory and inspection report that he submitted to the headquarters.
