Lopez on Tuesday ordered the cancellation of 75 mining contracts, stepping up her campaign to stop extraction of resources in sensitive areas after earlier shutting more than half of the Philippines' operat-

ing mines. The contracts—known as mineral production sharing agreements, or MPSAs are all in watershed zones, with many in the exploration stage.

They cover projects not yet in production and the latest action by Lopez suggests she will not allow them to be developed further.

Sanctity of contracts

The Chamber of Mines of the Philippines (COMP) said in a statement that with Lopez's unilateral action, the controversy was "no longer a question of whether a handful of companies really violated environmental laws" but "whether we still uphold the sanctity of contracts."

Suggesting, the, affected miners were preparing to take legal action, COMP said the matter had "now become a question of due process" and "fairness and justice that applies to all."

COMP lawyer Ronald Recidoro said Lopez's latest action was "absurd" and ignored due process given MPSAs were contracts between the government and the mining companies.

"You cannot just unilaterally cancel contracts, especially if there are no specific grounds," Recidoro said.

Mining law allowed operations in watersheds, except those declared protected by the government, he added.

The American Chamber of Commerce of the Philippines called the cancellation of the mining contracts "irresponsible."

"We do not understand why these permits—which are only to explore but not to produce-are harming watersheds. Responsible government agencies reviewed the permits, and there are dispute resolution provisions that should be followed," John D. Forbes, senior adviser to the chamber, said in a text message to the Inquirer.

The Philippine Chamber of Commerce and Industry agreed. "There should be due process for the mining firms," its president, George T. Barcelon, said in a phone interview.

#### Control at the Maria Control of Duterte ally

The canceled contracts include the \$2-billion Kingking gold and copper project in Davao del Norte province, the holder of which is the group of former Sen. Manuel Villar, an ally of President Duterte.

Five of the scrapped contracts involve the Philex group led by Manny V. Pangilinan, who figured in a verbal tussle with Lopez when she spoke against mining during an industry forum in 2012.

A longtime environmentalist, Lopez ordered the closure of 23 of the Philippines' 41 mines on Feb. 2 for allegedly damaging watersheds and for siltation of coastal waters and farmlands.

from the industry. Protesting Lopez's action, COMP on Monday filed its opposition to her nomination in the Commission on Appointments.

COMP said Lopez's orders would affect 1.2 million people.

#### Legal action

The industry plans to appeal Lopez's orders to President Duterte, although some miners facing a shutdown of their operations have threatened legal action, with some miners saying on Tuesday they had received a formal closure order from the DENR

Top Philippine nickel ore producer Nickel Asia Corp. said it would "pursue all legal remedies to overturn [the] order because of due process violations and the absence of any basis" that would warrant a suspension or closure of operations of CAFFAIRS - | its unit Hinatuan Mining Corp.

Hinatuan was told that its operation had "impaired the ource of na functions of the watershed in the area," according to a copy of the closure order.

Lopez said on Tuesday that courts could not halt her orders.

"There is no TRO (temporary restraining order) that holds function in the case of environment enforcement," she said.

"You can't have a TRO. We are protecting the environment and you can't stop us from protecting the environment," she added.

The contracts she ordered canceled on Tuesday include the \$5.9-billion Tampakan copper-gold project in South Cotabato province, the biggest stalled mining venture in the

#### in the know

A mineral production sharing agreement (MPSA) is one of three types of mineral agreements that the government grants to a contractor for the right to mine within, but not title over, a contract area.

Under the MPSA, the govern ment shares in the production of the contractor, whether in kind or in value, as owner of the minerals.

In return, the contractor provides the financing, technology, management and personnel for the mining project.

The other types of contracts are the coproduction agreement, under which the government provides inputs to the mining operations other than the mineral resources, and the joint venture agreement, under which the government and the contractor organize a joint venture company, with both parties having equity shares.

A Filipino citizen of legal age and with capacity to contract is. qualified to apply for a contract as an individual.

Corporations, partnerships, associations or cooperatives, organized or authorized for the purpose of engaging in mining, are also qualified provided they are duly registered and 60 percent Filipino-owned -INQUIRER RE-SEARCH Sources: mgb.gov.ph

"The contract here covers four provinces-South Cotabato, Sarangani, Sultan Kudarat and Davao del Sur-and six rivers and the food basket of Mindanao," Lopez said.

#### 7 days to comment

The mining companies that would receive cancellation orders would have seven days to comment and "show why we shouldn't cancel their MPSAs," she said.

Four of the five Philex contracts canceled on Tuesday were assigned to Philex Gold Philippines Inc. and involved projects in Surigao del Norte, Surigao del Sur, Zamboanga del Norte and Negros Occidental provinces.

The fifth MPSA was assigned to Silangan Mindanao Mining Co. Inc. in Surigao del Norte, where Philex hopes to develop a \$2-billion coppergold project that would replace the group's biggest revenue source—Philex Mining Corp.'s Padcal mine in Benguet province, whose production life is expected to expire in 2022.



# Military open to localized peace negotiations with NPA groups

# HE Armed Forces is open to pursuing localized peace talks with communist rebels.

This was stressed by the Armed Forces Public Affairs Office chief, Col. Edgard Arevalo, in a press briefing at Camp General Emilio Aguinaldo in Quezon City

Request for such negotiations came from New People's Army (NPA) groups operating in the Visayas and Masbate, Arevalo added

These groups were reportedly surprised at the decision of the Communist Party of the Philippines (CPP)-NPA, National Democratic Front (NDF) national leadership to terminate the unilateral cease-fire with the government effective 11.59 p.m. of February 10.

But, while the military is open to such negotiations, Arevalo said a mechanism must be first crafted so that common ground rules between the two parties can be set up.

The military has long believed that the CPP leaders on self-exile in the Netherlands have only "tenuous control" over the NPA units in the field

A senior military officer said the NPA units in the field may feel abandoned by their leaders who are abroad.

"Besides, it is the NPA units, through extortion, or so called revolutionary taxes, that are supporting the CPP leaders abroad," the officer said.

Thus, he said the communist guerrillas feel that, aside from being abandoned by their leaders, they are also made to support them.

#### Troops capture 8 NPA rebs

GOVERNMENT forces captured eight NPA guerrillas, while another has surrendered in a series of operations in the hinterlands of Alabel town in Sarangani province.

Col. Tyne Bañas, commander of the Army's 1002nd Infantry Brigade, said the rebels were separately arrested following clashes between troops under the 73rd Infantry Battalion (IB) and the NPA's Front 71 on February 6, 8 and 11 in sitios Tangis and Silutan, Barangay Datal Anggas in Alabel.

Six of the captured rebels were formally presented to the media late Monday afternoon in a news conference at the Kasfala Hall in Alabel.

They were identified as Simeon Salda, Jun Moda, Claude Palbe, Garzon Palbe, Rene Ompao and Sabelo Colano. The two others were identified as Nonoy and Moreno Salaman.

Seized from the rebels were five M-1 Garand rifles, two M-16 rifles and a caliber 30 carbine.

Also presented was a surrenderer, identified only as an alias Kaloy, who reportedly served as spokesman in the NPA's recruitment activities among the Tagakaolo tribe in parts of Sarangani.

Bañas said the 73 IB launched the combat operations based on a directive from the Armed Forces following the termination of the unilateral cease-fire with the NPA by President Duterte.

He said the operations were also in response to an attack staged

by NPA rebels on troops securing a government road project in the coutskirts of Alabel on January 29, when the cease-fire was still.

Lt. Col. Marion Angcao, 73.IB commander, said they don't consider the captured rebels as enemies, but "victims of the NPA"

He said most of them were new recruits of the NPA, and were only duped into joining the group on promise of monetary benefits.

Following the declaration of the government's unilateral cease-fire in July last year and the opening of the peace negotiations with the CPP-NDF, he said they monitored "heavy recruitment activities" of the NPA in the area.

"Kung tutuusin, sila [those captured], wala talagang kasalanan [In truth, they did not commit any wrongdoing]. They were victims of the deception by the enemy. That's why they are being treated well," Angcao said.

In the three encounters with the NPA, he confirmed one soldier was wounded but is now in stable condition at a hospital in Davao City.

Angcao said they are currently verifying reports of casualties on the side of the rebels.

## Army presents plan to curb Visayas insurgency

ILOILO CITY – Despite the cancellation of the unilateral ceasefire, the Philippine Army's 3rd Infantry Division (3ID) has formulated a framework to curb communist insurgency in key areas of the Visayas.

Major General Jon Aying, 3ID commander, outlined the approach that will reduce the strength of the Communist Party of the Philippines-New People's Army (NPA) in the Visayan islands of Panay, Negros, Cebu, Bohol, and Siquijor,

Aying reiterated that the "Seven Angels of Change" approach is a multifaceted and multi-sectoral framework that can be easily implemented in Western Visayas, Central Visayas and Negros Island regions beginning this year until the end of 2019.

According to Aying, the framework combines security reform initiatives, peace building, legitimate use of force; community public safety system, grassroots community development; disaster risk reduction, and following the rule of law.

This will be implemented by the 5,000 soldiers, 4,000 members of the Citizens Armed Forces Geographical Unit (CAFGU) and its various partners both from the public and private sectors.

Last week, a soldier of the 61st Infantry Battalion was killed in a skirmish with suspected NPA rebels in the mountains of Tapaz town, Capiz province.

Army troopers dropped some 4,000 leaflets on Monday over Sarangani Province urging the surrender of NPA rebels operating in the area.

Lt. Col. Marion Angcao, commanding officer of the Army's 73rd IB, said they dropped the leaflets aboard a Philippine Air Force UH-1 or Huey chopper while delivering relief goods to evacuees in a remote village in Alabel town in Sarangani

"This is aimed to promote peace and encourage the surrender of NPA rebels based in Sarangani," he said in a press conference.

Each leaflet carried the phrase "Manag-uban Kita sa Tul-id nga Dalan (Let's join together in the straight path)" on one side. The other side details pictures of firearms and monetary benefits that may be availed of by the surrenderees (Mike U. Crismundo and Philippine News Agency)

## Reds 'use' civilians as shield in clashes

ZAMBOANGA CITY: New People's Army (NPA) rebels clashed with government troops on Tuesday in Davao Oriental as security forces continued their offensive against the communist group in the restive region.

The military's Eastern Mindanao Command said fighting erupted in Barangay New Visayas in Lupon town

It accused the rebel group of retreating to a chapel and used civilians, including women and children, as shield against pursuing soldiers.

Rebel forces also blocked a highway, preventing motorists from passing through the village.

"We lament the NPA's conduct of road block disturbing the economic activity of the area and the use of children and women and a chapel as part of their diversionary act against pursuing troops," Army Maj. Ezra Balagtey, spokesman for the Eastern Mindanao Command, said.

"These condemnable acts are manifestation of the gross disregard of the NPAs of human rights, especially those of children and the elderly," he added.

Balagtey did not say whether the civilians had been safely freed but the clashes broke out after patrolling group from the 28th Infantry Battalion (IB) ran Into a huge group of rebels and a firefight ensued.

There were no immediate reports of casualties on both sides but soldiers recovered at least 14 backpacks left behind by the insurgents.

Rebel spokesman Rigoberto Sanchez said NPA forces have successfully defended base 'areas and guerrilla zones around the region. Meanwhile, in Sarangani province,

about 150 families fled their homes in Barangay Datal Angas in Alabel town after soldiers of the 73rd Infantry Battalion (IB) swooped down on an NPA hideout and seized high-powered firearms and ammunition

Troops from the 73rd IB led by Lt.
Col. Daryl Causancio raided the NPA
lair in the mountain ranges, triggering
a heavy firefight where a soldier and
several rebels were wounded.

• The insurgents withdrew.

Major General Rafael Valencia, Army's 10th Infantry Division commanding 'general, disclosed that they had almost 18 encounters against the NPA rebels since last year, killing several of them.

The 150 families have been temporarily housed at a school compound in Alabel town.

# Troops capture 8 Reds in Sarangani operations

ENERAL SANTOS CITY— Government troops captured eight alleged members of the New People's Army while another surrendered in a series of operations in the hinterlands of Alabel town in Sarangani province.

Col. Tyne Bañas, commanding officer of the Army's 1002nd Brigade, said the rebels were separately arrested following clashes between troops under the 73rd Infantry Battalion and the NPA's Front 71 on Feb. 6, 8 and 11 in Sitios Tangis and Silutan, Barangay Datal Anggas in Alabel.

Six of the captured rebels were formally presented to media late Monday afternoon in a press conference at the Kasfala Hall in Alabel.

They were identified as Simeon Salda, Jun Moda, Claude Palbe, Garzon Palbe, Rene Ompao and Sabelo Colano. The two others were identified as Noney and Moreno Salaman

Seized from the rebels were five Garand rifles, two M-16 Armalite rifles and a Carbine rifle.

Also presented was a surrenderer identified only as an alias Kaloy, who reportedly served as spokesperson in the NPA's

the Tagakaolo tribe in parts of Sarangani.

Bañas said the 73IB launched the combat operations based on a directive from the Armed Forces of the Philippines following the termination of the unilateral ceasefire with the NPA by President Rodrigo R. Duterte

He said they were also in response to an attack staged by NPA rebels last Jan. 29 on troops securing a government road project in the outskirts of Alabel

Lt. Col. Marion Angeae. commanding officer, said they don't consider the captured rebels as enemies but "victims of the NPA."

"Actually, they did not commit any wrongdoing. They were only victims of the deception of the enemy. That's why they are being treated well," Angeao said.

In the three encounters with the NPA, he confirmed that one trooper was wounded but is now in stable condition at a hospital in Davao City, He said they are currently verifying reports of casualties on the side of the rebels. PNA

Last year, the bandits executed two Canadian hostages, Robert Hall and John Ridsdel, after the victims' families

failed to pay the huge ransom.

The Abu Sayyaf kidnapped Ridsdel and Hall, along with Norwegian Kjartan Sekkingstad and Filipina Marites Flor, at a resort in the Island Garden City of Samal in September 2015. Sekkingstad and Flor were released separately after payment of ransom.

"The government, we do not negotiate with terrorists, we

do not pay ransom to terrorists," Arevalo said.

Arevalo added that the military will exert all effort to rescue Kantner, and that rescue operations are continuing against the bandits and yielding positive results

He also said that as matter of national policy, the military discourages any group from paying ransom for the hostages.

"Our position has been consistent. We discourage payment of ransom because we believe that payment of ransom will only embolden them, will continue to capacitate them and they can even buy the loyalty of the community," Arevalo said

The military said Abu Sayvaf bandits are currently holding 27 local and foreign hostages in Sulu and Basilan.

# US sub in RP to underscore 'strong' military relations

The Los Angeles-class submarine USS Louisville (SSN 724) yesterday has docked in Subic Bay to underscore the "strong" military connections between the Philippines and America, said the United States Embassy to Manila

In a statement, the embassy mentioned that the Louisville crew will participate in a series of community service projects and sporting events during this short visit.

The ship will also use the stop to conduct some minor maintenance with the assistance of Filipino companies.

Louisville is forward-deployed to the US 7th Fleet area of operations in support of security and stability in the Indo-Asia-Pacific region.

The embassy stressed that this brief port call does not only highlight military connections between the two nations but also its strong people-to-people linkages.

In January, US and Philippine service members have trained side by side in a series of Subject Matter Expert Exchanges as part of the most recent US Air Contingent. The purpose is to further promote increased interoperability between American and Filipino forces.

The training provided the Philippine and US service members an opportunity to practice and refine planning Humanitarian Assistance and Disaster Relief operations.

In this recent Air Contingent rotation, US military from the Hawaii Air National Guard's 154th Wing, US Army's 5th Engineer Detachment Geospatial Planning Cell and 500th Military have trained alongside Filipino pilots

Military planners use the Eagle Vision system to acquire satellite imagery to aid the planning of military operations to include disaster response.

According to the embassy, the first rotation of the Air Contingent was held in Clark, Pampanga April 2016, following a joint announcement by then-Philippine Secretary of National Defense Voltaire Gazmin and former US Secretary of Defense Ash Carter.

The Philippines is a longstanding treaty ally of the United States with a history of partnership of more than 70 years.

## NDF counsel slams Andanar over peace talk comments

10 Theftists yesterday 'said that communications Secretary Martin Andanar should better shut his mouth when it comes to President Duterte's prospects in the peace process with communist rebels.

National Democratic Front (NDF) legal counsel Edre Olalia, reacting to Andanar's opinion column in another newspaper, said that the Palace mouthpiece made erroneous claims regarding the Communist Party of the Philippines-New People's Army's (CPP-NPA) declaration to cease their ceasefire with government troops and as well as wrong reasons as to why the geace talks were suspended.

Dalia pointed out that the NDF did not essentially "withdrew their uniateral ceasefire just because the political prisoners were not released" and that not all CPP

leaders — that are portrayed to be "peace consultants" — have been convicted by courts as claimed by Andanar.

"Simple fact check would disclose that roughly only 50 detainees have been convicted, with all the rest facing trial at different stages. These wrongly convicted prisoners are all candidates for presidential pardon but only three have been released so far under this mode," the NDF lawyer said.

The NDF also denied that it was their party who asked the President to delist Communist Party founding chairman Jose Maria Sison from the US government's terror list.

"It was the Government's Panel chairman (Labor Secretary Silvestre Bello) that surprisingly but pleasantly unilaterally announced to the international media in Rome that the government will work for

the removal of the NDP's chief political consultant Prof. Jose Ma. Sison from the US so-called terrorist list so that he could purportedly go home," Olalia said.

"(Bello) also announced in advance to the media that such fact will be placed in the Rome Joint Statement. The government never proposed it to be included in the statement though and nothing of that sort appears therein," he added.

Andanar, the other day, also said in a radio interview that there is no compelling reason yet for the government to continue talking with the communists.

"The act of talking on the negotiating table, we simply follow the direction of the President to stop peace negotiations," the Palace official said.

Former NDF chairman and former Bayan Muna partylist Rep. Satur Ocampo, in an interview, for his part, said that the rebels won't buy Andanar's claims regarding the issue.

Ocampo articulated that the only guys whom the NDF will be listening to, when it comes to the peace process, would be Bello, Presidential Peace Adviser Jesus Dureza and Duterte himself.

Meanwhile, Chief Presidential Legal Counsel Salvador Panelo said that they are still hopeful that another round of peace negotiations between the government and the Reds is still possible.

"I am also confident that eventually they'll go back to the negotiating table," Panelo told reporters in an ambush interview in Malacañang.

"After all, the Left, they're saying what they're doing is for the people then there's no reason for them back out or not to continue with the peace talks," he added.

Communist rebels earlier ended a unilateral ceasefire declared in August last year, saying the government failed to release hundreds of detained rebels.

This prompted President Duterte to cancel the peace talks

The government also revoked the Joint Agreement on Safety

and Immunity Guarantees (JA-SIG) between the government and the communists.

With the termination of JASIG, communist leaders can now be arrested, Panelo said

The communists had rejected the termination of peace talks and said they are willing to explore ways to reopen the negotiations.

CPP founding chairman Jose Maria Sison has asked Duterte to address the discord between the communist rebels and the government and eventually resume peace talks.

"I propose [that Duterte] consult thoroughly with his negotiating panel and the peace advocates in his own Cabinet and others outside of his government, and encourage and allow back-channeling efforts to clarify misunderstandings and solve immediately the current problems," Sison said

"[The CPP wishes] to pursue with the government the bright prospects that started with the first round of formal talks in August 2016 and overcome the peace spoilers that run counter to the progress that has been achieved in the third round of formal talks," he added

## **EXECUTE GERMAN HOSTAGE**

## ABU SAYYAF GROUP THREATENS TO

ZAMBOANGA CITY: Abu Sayyaf rebels have threatened to behead a German yachter kidnapped in November last year off Sabah near southern Philippines if their ransom demand is not paid.

\*The rebels who are holding Jurgen Kantner set their deadline on February 26. The 70-year old Kantner was kidnapped with his wife Sabine Merz. 56, when Abu Sayyaf gunmen intercepted them just several nautical miles from the southern province of Tawi-Tawi.

The woman was killed. Her naked body was found by soldiers in the boat. A shotgun was also recovered near her body, according to the military's Western Mindanao Command. It said an Abu Sayyaf sub-leader Muamar Askali phoned a media organization in Zamboanga City to say that they are holding Kantner and demanding P500 million for his safe release.

The Abu Sayyaf demand was contained in a video released on February 14 on Telegram Messenger where it showed Kantner pleading to his government to save his life. The rebels were demanding a P30 million ransom.

In April 2014, Askali's group also kidnapped two German yachters - Stefan Viktor Okonek, 71, and Henrike Diesen, 55 -- and demanded a P250 million in ransom

The duo was freed six months later after the German government paid the ransom delivered by Filipino security officials.

The Abu Sayyaf is still holding

about two dozen Malaysian, Indonesian and Vietnamese sailors kidnapped last year in Sabah and Basilan province.

The Philippines is hunting down at least 23 people who were identified and wanted by Malaysian authorities for the string of ransom kidnappings and attacks at sea off Sabah.

Six of the 23 individuals, mostly Abu Sayyaf members, are facing arrest warrants

They are Apo Mike, alias Majan Sahidjuan, Hatib Hayan, alias Saw-

adjaan, Alden Bagde, alias Sayning. Muamar Askali, alias Abu Rami, Idang Susukan and Alhabsi Misaya

The Eastern Sabah Security Command recently released the names of 23 people sought for involvement in kidnapping incidents in the coastlines and waters of eastern Sabah.

The Abu Sayyaf group, formed by Ustadz Abdurajak Abubakar Janjalani in 1992, continues to recruit members to fight the government in their attempt to set up a strict Islamic caliphate in Mindanao. It now has hundreds of members in the Muslim autonomous region and the military had failed to stop the growing influence and violent campaigns of the rebel group because it did not sustain the combat operations needed to wipe out the Abu Sayyaf in the restive region. Much of the military's huge budget goes to combat operations and its modernization program

## Peace negotiation and the NPA rebellion

President Duterte, fresh from his election mandate, announced he would seek peace with communist rebels. With peace established, more economic development would be enabled.

Thus, direct meetings of the constituted peace panels from the government and the leaders opened auspiciously in August 2016 in Oslo, Norway Two other meetings were held, one in Oslo and the other in in Rome. No hard concessions from the rebels were being consummated

The rebel panel included its exiled leaders and those who were held in captivity who were given safe passage for the purpose of the meetings.

Through the three meetings, the demands prior to real negotiations hardened. The communists had insisted on the release of 400 prisoners be made first before the

conduct of substantial negotiations.

Moreover, certain events that happened in the field that led to the killing of government troops even during a ceasefire was in effect made the President terminate the peace negotiations. It seemed the communists had no control over their men in the field

Why the government terminated the negotiations. President Duterte explained his action to the nation and to people in Surigao, Mindanao (the site of a deadly

earthquake devastation) thus:
"I tried everything," the President explained. "I walked the extra mile, released prisoners, released their leaders so they can go to Oslo (Norway) to talk, and now they want 400 prisoners who fought the government under a rebellion released. This will (be) only given after a successful talk. What is there to talk about if I would release them?"

A more detailed explanation was provided by the government communications director, Martin Andanar, who writes a column in the Philippine Daily Inquirer ("The path to peace," Feb. 13). I quote from him.

"No previous president yielded so much so quickly just so the peace process could be restarted with an abundance of trust.... Having won an arm, the communists wanted to take a leg. They wanted 400 convicts they prefer to define as 'political prisoners' to be unconditionally released.

Each time the negotiating panels met, it seems the list of demands presented by the communists effectively as preconditions to the continuation of the talks lengthened. This is why President Duterte called them 'spoiled brats'"

Five peace parleys with other Philippine presidents have failed. Five Philippine presidents - Corazon Aquino, Fidel Ramos, Joseph Estrada, Gloria Macapagal Arroyo, and Benigno Aquino III - have tried to win over the communists to end their rebellion. All these efforts have failed.

Paulyn Sicam, a former member of the Philippine government panel under the Macapagal administration, who now writes an opinion column for The Philippine STAR (her column, July 2, 2016), reviewed her personal experience thus: "Although the talks (would begin) with a lot of goodwill among friends who had tought against the (Marcos) dictatorship together, it quickly deteriorated into another impasse, on the same issue that the communists have always insisted on – the release of their jailed leaders. As they did with every panel, (they) declared that they would just wait for a more open, friendlier government to resume talks with.

She concluded thus: "I am convinced that to the communists, the peace process is a one-way street that they are on only to get as many concessions as they can from the government without conceding anything in return....

Yet, in this particular negotiation, the communists appeared to expect that President Duterte would be more pliant. This time, it was Duterte who called the negotiations off. In addition, he referred to the communists as a terror organization.

Soon after the President made this announcement, the communication sought reconsideration his decision. They obviously see in Duterte their best chance of concluding a peace treaty, with some of their objectives achieved

There are no more Maoists except in the NPA. In the almost half century of fighting against the government, a lot has changed in this world. But the NPA has remained remarkably the same, with its leaders still immersed in their old ideologies. The rhetoric that they espouse on economic policy is out of tune with the times

The Philippine communist party is essentially behind the times. There are hardly any more Maoists in the world of development policy. Or rather, the Mao doctrines of development have been superseded by those who led China to the great boom years in its economy, following

the reforms of Deng Hsiao-peng.

These policies have much relevance to the changing conditions that we in the Philippines face today. This is most clearly set from the examples of high economic growth of China and Vietnam today, two countries that have been growing at high speed which are still considered communist countries in organization.

But since the late 1970s, the model moved away from the Mao vision of a highly centralized and directed economy. The key elements of successful transformation of today's China is based on embracing the principles of the market, of competition, and of seeking high employment in industry and commerce. These are also the same patterns of reforms that Vietnam has been following.

Where the Philippines requires to move forward are often the policies that many of NPA's ideologues want to thwart: strengthen access to foreign capital, liberalize further the investment areas, and strengthen market foreign

ther the investment areas, and strengthen market forces.
