





## AFP BATTALION JOINS WAR ON ILLEGAL DRUGS

The military plans to field between 300 and 800 soldiers to help the Philippine Drug Enforcement Agency in intelligence work against drug syndicates

# AFP battalion Joins drug war

The Armed Forces of the Philippines is planning to deploy a battalion-size task force to go after drug syndicates—not to engage in street operations—in President Duterte's war against illegal drugs, Gen. Eduardo Año said on Saturday.

The AFP chief of staff told reporters that between 300 and 800 soldiers would be fielded in response to the President's call on the military to take an active role in helping the Philippine Drug Enforcement Agency (PDEA) fight the drug menace.

"We have no figures yet, but we are talking about a battalionsize formation," Ano said at the Philippine Military Academy Alumni Homecoming in Baguio City

The task force can be reinforced by additional troops, if the need arises, so that it could help PDEA with intelligence support SHIEF and going after target, he said.

### Human rights groups

Mr. Duterte last month suspended the participation of the Philippine National Police in his campaign following allegations that its senior officials were involved in an extortion racket under cover of his antinarcotics drive in which a South Korean businessman was kidnapped. murdered inside the PNP headquarters, cremated and the ashes flushed down the toilet.

The President has also said

he wants to grant troops powers to arrest "scalawag" police.

Mr. Duterte has brushed aside protests by human rights activists against his drug war, which has claimed more than 6,000 lives, including over 2,000 in police operations, but has reacted sharply to the brutal killing of the Korean businessman.

Año, however, ruled out a bloody operation by the task force, unlike some of the raids conducted by the national police.

"The AFP will not do that, we will not be involved in the street, we'll not be involved in running after street pushers," he said

"The AFP will help PDEA in e people. Securing the land. running after high-level drug syndicates," he added.

#### DDB resolution

PDEA Director General Isidro S. Lapeña announced on Saturday that the Dangerous Drugs Board (DDB) had approved a resolution, tapping 1,280 more personnel and modifying the agency's structure to improve its intelligence and investigation divisions.

"The approyed modifications in the organizational structure and staffing pattern of PDEA will be endorsed to the Department of Budget and Management for appropriate and immediate action," Lapeña said in a statement.

"Cognizant of the challenges posed by the enormity of the country's drug problem and the suspension of the conduct of antidrug operations by other law enforcement agencies, PDEA has to carry the brunt of all antidrug operations all over the country.

The situation prompted us to strengthen our organizational structure," he added

#### PDEA workforce

PDEA currently has a "limited workforce" of 2,271 regular personnel deployed in its national services and regional offices.

Of this number, 1,274 are drug enforcement officers, who serve as frontliners of the antidrug campaign, 761 are administrative personnel, and 236 are technical personnel

"The approval of the DDB resolution means that an additional 1,280 warm and able bodies will be joining our roster as PDEA braces for a tough grind ahead," Lapeña said.

The resolution also calls for the creation of a new PDEA counterintelligence service, which will include a financial investigation division (FID).

"The newly formed FID will strengthen our efforts against suspected money launderers, particularly drug syndicates, who 'wash' their illegal drug transactions and proceeds being routed through banks and other regulated entities," Lapeña said

#### More with less

Under the resolution, the Maritime Drug Enforcement Coordinating Center will be renamed technical operations support division.

"It is all about doing more with less. These changes will make PDEA sufficiently equipped and numerically upgraded to wage an all-out war against illegal drugs," Lapeña said. —with a REPORT FROM REUTERS

# NPA KEEPS 6 GOV'T TROOPERS CAPTIVE

DAVAO CITY—The New People's Army (NPA) in Mindanao is now keeping captive six government troopers following President Duterte's declaration of an end to peace talks between his administration and rebel leaders.

The number of NPA captives rose to six following the capture of two government militiamen at a rebel checkpoint in Davao Oriental on Feb. 14.

In a statement, NPA Southern Mindanao spokesperson Rigoberto Sanchez said the rebels had set up the checkpoint in the village of Don Mariano in Lupon town, Davao Oriental, where militiamen Rene Doller, 34, and Carl Mark Nucos, 24, had been captured.

The two belonged to the Army's 72nd Infantry Battalion

Rebels seized handguns from the two who, Sanchez said, are "being treated leniently." The militiamen, Sanchez added, are also being investigated for "possible crimes against the people and the revolutionary movement."

Rebels, said Sanchez, are also investigating the militiamen's role in counterinsurgency operations.

NPA rebels operating in Central Mindanao have also sought to assure the families of their other captives that the soldiers are being treated well.

Also in captivity are Pfc. Samuel Garay and Sgt. Solaiman Calocop who were captured in the town of Colombio, Sultan Kudarat province, on Feb. 1.—REPORTS FROM ALLAN NAWAL, EDWIN FERNANDEZ AND ELDIE AGUIRRE INQ.

Solo died at the scene from gunshots to the cheek, head





# Año: Military gaining momentum in offensives against terror groups

The Armed Forces of the Philippines (AFP) is claiming momentum in the ongoing offensives against terror groups in Southern Philippines, particularly the Abu Sayyaf Group and Maute Group.

2.5 This, despite the killing of two military intelligence operatives, the of them Maj. Jerico Mangalus, in a clash with members of the Maute group in Marawi City last Thursday.

midAFP chief of staff Gen. Eduardo ARio tagged the group of Otto Maute, one of the leaders of Mautre group of Lanao del Sur, as the band encountered by elements of the Military Intelligence Group-qui (MIG-10), led by Mangalus.

neil Año described Mangalus, a finember of the Philippine Military Academy (PMA) Class of 2002, as saigood intelligence officer.

He is a very good officer... when I was chief of the Intelligence Service he was working under me and I can say that he is really a very good intelligence officer," Año said.

Mangalus and his team were on an intelligence operation in Marawi City when they encountered the group of Maute — resulting in his death and another soldier.

In spite of Mangalus' killing in a firefight with Maute group, Año said that the military has the momentum in the ongoing campaign against terror groups in Sulu, Basilan and Tawi Tawi—citing recent combat scores against enemies of the state that resulted in the neutralization of 10 terrorists.

Año is optimistic that the military is on track with the sixmonth self-imposed deadline set to significantly defeat all terrorist groups in Southern Philippines, particularly the Abu Sayyaf and Maute Group.

He said operations are being conducted by various military units in Sulu against the group of Radullan Sahiron, in Basilan against the band of Furuji Indama, in Tawi Tawi area against those involved in kidnapping, and in Lanao del Sur against Isnilon Hapilon and the Malite group.

"We are doing these simultaneously not only to put pressure to these groups but to reduce their capacity to fight and their will to fight...there are good developments in the campaign, and

the attitude of our soldiers to fight is also good, they are motivated," Año said.

"The momentum is on our side," he added

The AFP chief said there is no need to kill all the terrorists as he stressed that strategic victory would come when they lose their will to fight, stop with their terror activities or surrender.

Ano also cited the all-out support being provided by the general headquarters and the major service commands to the operating troops, and the additional fund approved by President Duterte.

Duterte ordered the AFP to destroy the terror groups operating in Southern Philippines, particularly the Abu Sayyaf which still holds 27 hostages, mostly foreigners. In response, Año set the six-month deadline for the AFP to defeat the terrorists.

# AFP foils deadly landmine attack In Davao City By Zaida delos Reyes

GOVERNMENT troops has foiled what could have been another deadly explosion when they recovered on Saturday an improvised explosive device (IED) planted by the New People's Army at a populated area in Calinan District, Davao City

loint Task Force Haribon Civil Military Operation officer Major Ezra Balagtey said pursuing troops of the 3rd Infantry Battalion and Army Explosive and Ordnance Division (EOD) discovered the IED in Inayangan, Calinan District.

Balagtey was told by residents in the area that the rebels planted a landmine on the mad

Balagtey said the IED they recovered was composed of anti-vehicle land-

mine, explosive blasting machine, improvised blasting cap and electric wire.

Joint Task Force Harbon commander Brigadier General Gilbert I. Gapay condemned the move since the area is being frequented by many civilians

"Laying of landmines

in busy roads and populated areas by the NPA is a wanton disregard of the safety of the people which is a violation of their human rights," Gapay said.

Gapay lauded the residents for their vigilance.

Last Thursday, two soldiers were killed while

15 others were injured after their convoy hit a landmine of the NPA around 4 p.m. along the boundary of Barangay Lacson and Barangay Lamanan in Davao City.

The slain soldiers were identified as Cp! Michael D. Yadao and Pvt. Virnel M. Damondon.

# Gov't eyes new pension plan for military, police

The government will pitch a new pension system for uniformed men to arrest the ballooning costs of benefits for retired military and police personnel

Budget Secretary Benjamin E. Diokno said in a forum last week that paying for the pension of military personnel from the annual budget was "not sustainable."

"The day will come that 70 percent of their budget will go to pension and not to those in active service," Diokno said

The Legislative-Executive Development Advisory Council during last month's meeting "agreed that there should be a review of [uniformed personnel's] pension," the budget chief said

"We will legislate a new plan for them," he added.

According to Diokno, only the new entrants to the service will be covered by the new pension scheme.

"Those paid in the past will continue to be paid [the same way]. That's basic—you don't take that away from them," he said.

The budget chief said that

among the ideas he had to address was transferring police pension to the state-run Government Service Insurance System since the Constitution states that the Philippine National Police is civilian in nature.

Diokno said another proposal was to hire nonmilitary and police for services provided within camps.

The Cabinet-level interagency Development Budget Coordination Committee (DBCC) had flagged the ballooning military pension as a fiscal risk

"The pension costs of all uniformed services are rapidly

increasing every year. The problem is mainly attributable to the features present in all existing retirement laws of the uniformed services—pension entitlement of a retiree is automatically adjusted based on the prevailing scale of base pay for similarly ranked active personnel; pension is noncontributory in nature, hence budget comes from the annual general appropriations of the government; and early entitlement to pension benefits even before attaining the compulsory retirement age of 56," the DBCC said in its Fiscal Risks Statement report for 2015-2016. # Reds open to bilateral ceasefire

DAVAO CITY—The future of a more stable ceasefire looks bright.

Jesus Dureza, presidential adviser on the peace process, expressed appreciation over the public pronouncement of the Communist Party of the Philippines (CPP) to negotiate and craft a bilateral ceasefire agreement.

"We welcome and respect the positive position coming from the leadership of the CPP, NPA (New People's Army), NDFP (National Democratic Front of the Philippines)," Dureza said in a statement.

The CPP, in a statement, said the originally scheduled meeting to discuss the details of a bilateral ceasefire agreement in The Netherlands on Feb. 22 to 27 could proceed if President Duterte decides to send the government negotiating panel.

"The Party and the New People's Army reiterate their support for efforts to forge a bilateral ceasefire agreement. The revolutionary forces are encouraged by the previous statements of President Duterte that all political prisoners will be released within 48 hours once the bilateral ceasefire agreement is signed," the CPP said.

But the CPP admitted that negotiating the details of the ceasefire agreement would be challenging.

"We anticipate that negotiations concerning the terms of reference of a bilateral ceasefire agreement will be most difficult. The revolutionary forces

are bound by principle to assert the withdrawal of the AFP's operating troops from areas under the sway of the revolutionary government," the CPP said.

As a positive gesture, the CPP directed the New People's Army to immediately release all captured soldiers and police officers.

President Duterte earlier canceled the negotiations following the NPA's announcement to end its own ceasefire effective Feb. 10.

The NPA cited the alleged nonrelease of political prisoners and the continuing presence of government forces in the communities as reasons for terminating its ceasefire.

Over 30 armed hostilities have already been reported since then

The NDFP and President Duterte recently hinted at the possibility of resuming the peace negotiations, with both working on backchannel talks.

Labor Secretary and chief government peace negotiator Silvestre Bello III on Sunday welcomed the offer of the CPP to negotiate a bilateral ceasefire agreement with the government Bello said he would relay the offer to President Duterte and the matter could be taken up during Monday night's dinner meeting with the three members of the Left in the Cabinet: National Anti-Poverty Commission chair Liza Maza, Social Welfare Secretary Judy Taguiwalo and Agrarian Secretary Rafael Mariano

"It (the peace offer) is a very good development. If they continue to show goodwill, then the President might reconsider his decision about the peace talks," Bello said in a phone interview. INQ

# Reds ready for truce, want to restart talks

The Communist Party of the Philippines (CPP) yesterday ordered its armed wing the New People's Army (NPA) to release the six soldiers and policemen they are holding captive and called for a bilateral ceasefire agreement with the government.

In a statement yesterday, the CPP said the release of the six "prisoners of war" is their "positive gesture" to continue peace negotiations with the government.

This came days after the peace talks folded as the NPA lifted its unilateral ceasefire. President Duterte responded by terminating the ceasefire and peace talks.

The CPP ordered the release of Pfc Edwin Salan who was captured in Alegria, Surigao del Norte on Jan 29; Sgt Solaiman Calucop and Pfc Samuel Garay who were captured in Columbio, Sultan Kudarat on Feb 2, PO2 Jerome Natividad captured in Talakag, Bukidnon on Feb 9, and paramilitary Rene Doller and Carl Mark who were captured in Lupon, Davao Oriental on Feb 14

The CPP said "the Armed Forces of the Philippines (AFP) can cooperate by withdrawing all troops in and around the areas where the prisoners of war will be released to pave the way for their safe and orderly release"

If the AFP will cooperate, all six captives can return to their families before or during the scheduled peace negotiations in the Netherlands next week, the CPP added.

The CPP also ordered the NPA commands in charge of the custodial units "to work closely with third party facilitators." The CPP said that if Duterte is really "obsessed with peace" as the government peace panel said, "he can heed the people's clamor and reverse his earlier pronouncements terminating peace negotiations."

"The CPP earnestly encourages him to do so. He would surely not want to set aside the achievements attained during the first three rounds of the peace talks and waste the opportunity to leave a legacy of peace," the group added.

The bilateral ceasefire agreement has been an issue in the peace negotiations as Duterte has refused to give in to the call of the CPP-NPA to release 400 political detainees unless the communist group signs a document signifying ceasefire.

The peace negotiations folded just a week after the third round of formal talks

was concluded in Rome, Italy. The third round ended without any agreement on a bilateral ceasefire.

The CPP-NPA said yester-day that should Duterte decide to send the government negotiating panel and emissaries to the scheduled peace talks, negotiations for a bilateral ceasefire agreement can proceed as scheduled on Feb. 22 to 27 in the Netherlands

And to ensure success of the negotiations, the National Democratic Front (NDF)-CPP said, the government panel can help facilitate the travel of the NDF's ceasefire committee members and consultants

# CPF wants truce, peace talks

AVAO CITY - The Communist Party of the Philippines (CPP) reiterated yesterday its call on President Duterte to reverse his previous order calling

off peace talks with the communist insurgents, and expressed willingness to return to the negotiation table on February 22 to discuss a bilateral ceasefire between the two parties.

The Philippine Government (GRP) and the National Democratic Front (NDF), the CPP-NPA's political arm, were supposed to meet on February 22 to 27 in Utrecht, Netherlands to discuss the proposal for a bilateral ceasefire that was formally submitted by the government to the communist side in the last round of talks in Rome, Italy last January 25.

The two parties were also supposed to oversee the deposit of the list of NDF-CPP-NPA consultants, who are participating in the talks and are protected by the Joint Agreement on Security and Immunity Guarantees (JASIG), in a safety deposit box.

The fourth round of formal talks was also set on April 2 in Oslo, Norway.

The communists added that the GRP can help facilitate the travel of the NDF's ceasefire committee members and consultants to ensure success of the negotiations in Utrecht, which is only two days away

NPA may release 6 'prisoners of war'

As a gesture of goodwill, the CPP called on the NPA to expedite the release of the six prisoners of war (POWs) who were captured in different parts of Mindanao ever since the communist group abruptly cancelled its unilateral ceasefire.

Those in NPA custody are PFC Edwin Salan, who was captured in Alegria, Surigao del Norte on January 29; Sgt. Solaiman Calucop and Pfc Samuel Garay, captured in Columbio, Sultan Kudarat on February 2; PO2 Jerome Natividad, captured in Talakag, Bukidnon on February 9; and alleged "paramilitary" members Rene Doller and Carl Mark, both captured in Lupon, Davao Oriental on February 14.

"The NPA commands in charge of

the custodial units can work closely with third party facilitators. The AFP (Armed Forces of the Philippines) can cooperate by withdrawing all troops in and around the area where the POWs will be released to pave the way for their safe and orderly release," it added.

The POWs can be allowed to return to their families before or during the scheduled GRP-NDFP peace talks in The Netherlands, the CPP added

### Terms of reference

The leftist group also said it was anticipating that the talks on the "terms of reference" of a bilateral ceasefire document will be difficult, but pledged to work with GRP negotiators to forge a bilateral document "that will be mutually acceptable and enforceable."

"The revolutionary forces are bound by principle to assert the withdrawal of the AFP's operating troops from areas under the sway of the revolutionary government," it said.

### Top officials favor talks

President Adviser on the Peace Process Jesus Dureza and GRP Peace Panel Chairman Silvestre Bello III welcomed the CPP position as both hoped that this would be the "compelling reason" that President Duterte had cited as the only reason why he will turn back on his order to call off the talks.

"We share the same commitment to work for just and lasting peace in the land," said Dureza.

"It is now up to the President, whatever he orders, we will follow," said Bello, who added that setting the February 22 meeting in Utrecht was "still very feasible."

Armed Forces of the Philippines (AFP) Chief of Staff General Eduardo Año said the military was not totally closing its door on peace negotiations with communist rebels.

In an interview during the media fellowship night at the Pine Breeze Hotel in Baguio City Saturday night, Año said the 125,000-strong military force was very supportive of the peace process, but nevertheless maintained that they will not allow communist NPA guerrillas from conducting atrocities and

hamper the lives of people in various communities around the country.

"The Armed Forces, more than anyone else, it is the soldiers who want the peace talks to succeed," Ano told reporters "But we will not allow the CPPNPA to conduct atrocities and similar activities and imperil the lives of the ordinary people in the community."

Meanwhile, National Security Adviser Hermogenes Esperon said that he is one in favor of peace negotiations getting back on track.

"Well, I, myself, am in favor of resuming the peace talks. You know who, where I came from I was in OPAPP (Office of the Presidential Adviser on the Peace Process) before I was a combatant and the first people who would want this are the combatants," Esperson said.

"I was also a frontline officer from the time I was a lieutenant until I was a battalion commander in Agusan and Brigade commander in Jolo, Zamboanga, Cotabato, and Basilan. So who doesn't want peace especially if you see your own men part of the casualties? My life was also put in danger many times." he said.

However, Esperson said that peace will not be attained "if the other group is doing war."

"While we are doing war, we cannot attain (or) have a modicum of progress in the area," Esperson said.

### NDF consultant's motion

As this developed, Rafael Baylosis, one of the NDF consultants who were ordered freed by the government but is now being sought for recommitment to jail, filed a motion with the Manila Regional Trial Court (RTC) to defer the resolution on the government's motion seeking their rearrest.

In a manifestation filed on February 14, Baylosis, through his legal counsel, asked the Manila RTC Branch 32 to defer ruling on the motion of the Office of the Solicitor General (OSG) to revoke the bail granted to him.

Baylosis asked the court to defer the resolution on the motion "so as not to render moot and academic the efforts toward the resumption of the peace negotiations" (With reports from Yas D. Ocampo and Cris Odronia)

# Clashes with NPA increasing, says AFP

BAGUIO CITY. - Armed Forces chief Gen. Eduardo Año said government forces have been engaging New People's Army rebels twice a day since February 4 when President Duterte terminated the peace talks with the communists.

"Since February 4 to February 18, there were about 30 encounters already. So if you compute, it's like having two encounters a day," Ano told reporters on Saturday night.

Año said the armed engagements with the insurgents have resulted in the death of 12 rebels while 22 rebels have been arrested or surrendered during the same period.

"We have neutralized around 40 NPAs (since February 4) – 12 body count, 15 captured and about 17 surrendered. It's 40 plus, that is so far the statistics (in the fight against the communists)," said Año.

Duterte lifted the government's unilateral truce and terminated the peace talks in the wake of a series of NPA attacks in various parts of the country that had claimed that lives of several soldiers, including a junior officer, and abduction of three others.

"We are intensifying our operations more on the CPP-NPA. We need both military pressure on our side and social pressure from the non-military side so that they will be forced not only to go back to the negotiation table but probably choose the path of peace," said Año Año said the military is open to the resumption of peace negotiations with the communists. Latest military estimates indicate that the NPA has more than 3,000 men, mostly in the northeastern Mindanao area.

Año said one of the "compelling reasons" for the Duterte administration to revive the peace talks is for the communists to stop their extortion activities or revolutionary tax, a major source of funds for the rebels.

National Security adviser Hermogenes Esperon, for his part, said he has supported the peace process with the communists but the recent excesses of the NPA justify the termination of the talks.

"You know where I came from," said Esperon, referring to his military background. He said combatants, like him, are for peace because they are the ones sent to the frontlines to address insurgency.

Esperon served as the Army chief and later Armed Forces chief during the Arroyo administration. After his retirement from military service, he was appointed as presidential adviser on the peace process.

"I'm a combatant and the first people who would want this (peace) are the combatants. I was a frontline officer, starting from my lieutenant days," said Esperon, who commanded a battalion in the Agusan provinces and headed two Army brigades, one in North Cotabato and the other in Basilan.

he 300 errant cops who will be sent to Basilan tomorrow can now heave a sigh of relief after no less than the military chief of staff assured that they would not be tapped to hunt down the Abu Sayyaf Group (ASG).

Gen. Eduardo Año, chief of staff of the Armed Forces of the Philippines (AFP), also disclosed that the deployment of the 311 cops from Metro Manila will not be concentrated in Basilan alone.

"Our discussion with the PNP (Philippine National Police) is not only Basilan but they will beef up forces in priority areas," said Año.

"Their main job is to take care of the town centers, urban centers so that the AFP will concentrate on the hinterlands," he added.

Año admitted that the arrival of 311 policemen in conflict-torn areas in Mindanao is a big boost in terms of augmentation of the existing police and military forces.

He said the police deployment means more than 300 pairs of eyes watching out for threats against civilians in urban centers.

The 311 policemen from five police districts in Metro Manila, headed by an official with a rank of superintendent (lieutenant colonel in the military), who are facing various offenses from habitual tardiness to involvement in illegal drugs, will be flown to Zamboanga City on Tuesday on board a C-130 cargo plane.

They will then be immediately shipped to Basilan as instructed by President Duterte.

"They are of big help in urban centers especially in manning checkpoints and in the conduct of civil military operations," said Año.

Año earlier disclosed that they have conducted another wave of operation against the Abu Sayyaf after the latest seriously wounded Basilan-based commander Isnilon Hapilon.

"They are important additional manpower in some areas. And it means some of the soldiers will be freed of their duties (in urban centers) and then we will have more warm bodies to run after Abu Sayyaf," said Año. (Aaron Recuenco)

### ASG-backed alien jihadists regrouping

DOZENS of foreign jihadists were among the Basilan-based Abu Sayyaf members under Isnilon Hapilon who left their home base in a bid to establish an Islamic State (ISIS) stronghold in southwestern Mindanao, a military source said Sunday.

The terrorists composed of Indonesians, Malaysians, and Middle-Eastern nationals were sighted in the rugged terrain of Lanao del Sur last month, the source added.

The area where Hapilon and his men have sought sanctuary lies within Camp Busra, the main camp of the Moro Islamic

Liberation Front. The area is being used by jihadists for training, the source said.

Meanwhile, Armed Forces chief Gen. Eduardo Año said security forces are applying "intense pressure" on the group of Hapilon to carry out President Rodrigo Duterte's order to decimate the ASG.

Hapilon was critically wounded in an artillery attack while four of his companions, including an Indonesian identified only as Mohisen, were killed during the skirmishes with Army troopers on the outskirts of Butig, Lanao del Sur two weeks ago.

Mohisen brings to three the number of Indonesian jihadists killed in Mindanao in separate clashes with security forces in Lanao del Sur and Sultan Kudarat last year.

Several military operations are also taking place in Basilan, Tawi-Tawi and Sulu to neutralize the ASG, the Maute group and other terrorists groups, Año said.

"The ongoing operations in Lanao del Sur, targeting Isnilon Hapilon and the Maute brothers are being done simultaneously not only to put pressure on this group, but to reduce their capacity to fight and their will to fight," Ano said.

So far, the ASG has suffered 10 members killed in fierce fighting with Marines troops on Capual Island, Omar town in Sulu last week.

An estimated 14 battalions of composite troops are currently deployed in Basilan, Tawi-Tawi and Sulu in a search and destroy operations against the group of Hapilon and its sub-leaders.

The Armed Forces expects to defeat the ASG in six months, Año said.

### 500 soldiers to join war on drugs

About 500 soldiers will soon join the Philippine Drug Enforcement Agency (PDEA) in the war against illegal drugs waged by President Duterte

Armed Forces of the Philippines (AFP) chief Gen Eduardo Año, speaking to reporters in Baguio City Saturday night, said the 500 would initially form the anti-illegal drugs task force

He said the soldiers would have to undergo further training to carry out the job and they would have their own strike force.

"I already met with PDEA director Isidro Lapena. We already have a MOA (memorandum of agreement) with PDEA even before the President stopped the PNP (Philippine National Police) from conducting anti-drug operations," Año explained.

"We will just renew this MOA because based on the President's pronouncement, we will implement adjustments We are just waiting for the EO (executive order) and we are ready to operate with

PDEA," he said.

He noted that PDEA would still be the main operating agency with the AFP just providing support in anti-illegal drug operations

Año said the military would not carry out the war on drugs in the same way Oplan Tokhang was implemented by the PNP, as he gave assurance that "we will not be involved in the street, we'll not be involved in running after street pushers"

"The Armed Forces will help PDEA in running after high-level drug syndicates," he said

The AFP chief said the number of soldiers in the task force would also be adjusted depending on the necessity or level of threat

Año said he will deploy soldiers that will comprise the task force depending on the threat. "A task force is very flexible and will depend on the available threat. The task force could reach up to 5,000 or as low as 500 men," he added

"Depending on the requirement we can increase or we can decrease depending on the situation," he added.

When asked if the joint PDEA and AFP anti-illegal drugs operations will be

similar to the Philippine National Police (PNP) "Oplan Tokhang" campaign, Año said that will not be the case.

He also said that their anti-illegal drugs operations will not be bloody and will not target small time drug pushers.

"No, the AFP will not do that. We will not be involved in the streets. We'll not be involved in running after street pushers. The Armed Forces will help PDEA in running after high-level drug syndicates," Año said

The AFP said initially they are looking for a battalion size unit that will compose the task force

Año, at the same time, said that he has already met with PDEA chief Director General Isidro Lapeña to renew their existing Memorandum of Agreement (MOA) to better help in fighting illegal Dicker Sortic States in Franc

"I already met with PDEA director Isidro Lapeña even before the President announced that he is putting a stop to the PNP's anti-drug operation because PDEA and the Armed Forces already have a MOA even before. We will just renew it because based on the pronouncement of the President, we need to make certain adjustments," Año said.

"Even with the absence of an EO (Executive Order) we are ready to operate with PDEA - PDEA as the main and we are just support. We also discussed that we can start actually do operations if there is a target package," he said.

Año reiterated that the Armed Forces will always be on the support role and once the EO is approved part of that will be a training package for personnel which will be attached or will be placed under the operational control of PDEA," Año said.

# Battalion eyed to aid PDEA

BAGUIO CITY - The Armed Forces is organizing a battalion-sized task force to help the Philippine Drug Enforcement Agency in going after high-profile drug traffickers.

"It has yet to be created but we are talking about a battalion-sized (force)," AFP chief Gen. Eduardo Año said on Saturday night.

A battalion is composed of around 500 officers and men

Año said the task force, which will have its own "strike force," will be placed under the operational control of PDEA.

Año said he has made initial coordination with PDEA director general Isidro Lapena even before President Duterte told the PNP to stop its operations against drugs last month.

Año said the AFP is waiting for Malacañang to issue an executive order formally tasking the military to aid the PDEA in the war on drugs. He said soldiers are ready to assist the anti-drug body in anti-narcotics operations.

He said that while the military task force

will be composed of 500 personnel, its number can be increased to as high as 5,000 "depending on the situation."

Año also said soldiers will not be involved in Tokhang operations, or house-to-house operations targeting ordinary drug users.

"The AFP will not do that. We will not be involved in the street; we'll not be involved in running after street pushers. The Armed Forces will help PDEA in running after highlevel drug syndicates," he said.

#### SUSPECTED PUSHER KILLED

A suspected drug pusher was shot dead by two unidentified motorcycle-riding men in Pasig City on Saturday night.

Senior Supt. Orlando Yebra, local police chief, said Chrispolo Cruz, 43, of Barangay Kalawaan died on the spot.

Yebra said Cruz was in the barangay drug personality watch list as a pusher and user.

### DRUG TESTS FOR HS STUDES

The Department of Education has issued a memorandum directing high school stu-

dents, elementary and secondary teachers, and school division personnel to undergodrug testing this year.

Education Secretary Leonor Briones said a three-day orientation will be conducted nationwide from March to April before the actual drug testing.


The program also aims to train school personnel on specimen collection and validity testing, train participants on documentation and recording of drug testing process, discuss the intervention for students found to be positive for drugs, and formulate an action plan for the conduct of the random drug testing.

More than 650,000 people in 316 conflict-affected communities situated in 75 municipalities have benefited from the trust fund through the construction of new roads, classrooms, health clinics and community centers and improved access to electricity and water supply, said the World Bank. —With John Unson

## Dureza lauds MILF, UNICEF in ending use of minors in conflict

"We are moving from a climate of conflict, to a climate of peace."

This was how Presidential Adviser on the Peace Process Jesus Dureza described the stage of the ongoing peace negotiations with the Moro Islamic Liberation Front (MILF), which entered a "big transition" with the release of the first batch of 1,858 children who are formally or informally associated with the Moro group's military arm Bangsamoro Islamic Armed Forces (BIAF).

coming to a fulfillment.

Lotta Sylwander, UNICEF Country Representative for the Philippines said that the MILF was the first rebel group in the world to commit and work with the United Nations, through UNICEF, to stop the recruitment and use of children in conflict.

MILF and the UN signed the Action Plan in August 2009 to ensure that civilians affected by conflicts are well protected. The MILF committed itself to a concrete and time bound activities to unimpeded access by the monitoring teams, prevention of recruitment and awareness and capacity-building of its men on the child protection protocol mechanism.

"Children affected by armed conflict are some of the most vulnerable children in the world. They can be recruited as soldiers engaged in direct combat or as aides with seriously harmful consequences to their

lives and well-being. Let children be children-let them play, go to school and live healthy and happy," Sylwander said.

Dureza also noted that children, who grew up with their parents engaged in armed conflict, will most probably also volunteer to fight.

"It is by nature that the children of a combatant will sympathize and help protect their family. We must provide the enabling environment to make this process easier for everyone."

## Trillanes presses AMLC on Du30 bank accounts

Sen, Antonio Trillanes IV will call President Duterte's bluff by asking this week the Anti-Money Laundering Council (AMLC) to disclose amounts of money it flagged in the bank accounts of the President from 2006 to 2015

Trillanes made this statement in a radio interview on Sunday. Contacted by the Inquirer, he said he would write the AMLC to make the request using the President's directive for the council to reveal how much he was worth.

### Rehashed charges

The President gave the directive in front of the members of the Philippine Military Academy Class of 1967, which adopted him as member, in Baguio City on Friday, as he denied he and his family had hidden wealth as alleged by Trillanes.

Describing Trillanes' latest allegations as mere rehash of his previous accusations, Mr. Duteffe called the opposition senator a "bandit" and yowed to quit as President if Trillanes would be able to prove his claim.

Last week, the senator urged anew Mr. Duterte to open his bank accounts and show he did not have P2.2 billion in transactions between 2006 and 2015 in three bank branches. Trillanes made the same call to the then presidential candidate in last year's election campaign.

Trillanes said he would resign as senator if proven wrong.

The senator last week also showed documents indicating that the President's commonlaw wife, Honeylet Avanceña, had almost P200 million in bank transactions from 2004 to 2009 and that she and his children received P120 million from Sammy Uy, Mr. Duterte's close friend and a campaign financier, from 2011 to 2013.

### Verbal waiver

Trillanes yesterday described the President's directive to the AMLC as "verbal waiver."

Asked if Mr. Duterte would release the transaction history of his three bank accounts between 2006 and 2015, presidential spokesperson Ernesto Abella said, "That's his call But I suppose he will."

"Everything depends on the AMLC, I suppose, to do what they need to do," Abella added.

Trillanes said he would ask information from the AMLC about the President's every transaction of at least P500,000 that it had reported or "flagged."

### Flagged bank transactions

"The President gave the directive on national TV and if he backs down, then you see he is date to determine a depositor' fooling again the people," Tril-

lanes told the Inquirer



# US carrier strike force patrols South China Sea

BANGKOK—A US aircraft carrier strike group has begun patrols in the South China Sea amid growing tension with China over control of the disputed waterway and concerns it could become a flash point under the new US administration.

China's foreign ministry on Wednesday warned the United States against challenging its sovereignty in the South China Sea.

The US Navy said the strike force, including Nimitz-class aircraft carrier USS Carl Vinson, began routine operations in the South China Sea on Saturday. The announcement was posted on the Vinson's Facebook page.

The strike group's commander, Rear Admiral James Kilby, said that weeks of training in the Pacific had improved the group's effectiveness and readiness.

### China exercises

"We are looking forward to demonstrating those capabilities while building upon existing strong relationships with our allies, partners and friends in the Indo-Asia-Pacific region," Kilby was quoted as saying by the Navy News Service.

Friction between the United States and China over trade and territory under US President Donald Trump have increased concerns that the South China Sea could become a flash point.

Three Chinese warships on Friday wrapped up a week of scheduled training exercises in the South China Sea shortly after China's sole aircraft carrier tested its weapons in the disputed region.

The flotilla of warships, including a destroyer that can launch guided missiles, had been conducting drills since Friday last week and were now sailing to the eastern India Ocean and the Western Pacific, according to the official Xinhua News Agency

Exercises by the Chinese ships, in particular the aircraft carrier Liaoning, have unnerved its neighbors in recent months, especially given long-running territorial disputes in the South China Sea.

#### 'Unchangeable trend'

The training, which included sudden attack drills, had been carried out successfully in poor sea conditions, Xinhua said.

The drills were "without an arranged script" and "as close as possible to real combat," military affairs expert Yin Zhuo told the state broadcaster

China Central Television.

Regular exercises by the Chinese Navy in the high seas were an "unchangeable trend," Yin said, though he added that China's long-range naval capabilities were not sufficient to secure its interests in open waters.

Beijing's warning to Washington against challenging its sovereignty in the South China Sea came amid reports that the US Navy was planning fresh patrols in the region.

The United States has criticized China's construction of man-made islands and its buildup of military facilities in the area, expressing concern they could be used to restrict free movement.

The US Navy has conducted several "freedom of navigation" patrols through the waters.

China claims most of the South China Sea, while Taiwan, Malaysia, Vietnam, the Philippines and Brunei claim a portion of the waters that command strategic sea lanes and contain rich fishing grounds as well as with oil and gas deposits.

Even so, China says it is committed to freedom of navigation in the strategic waterway through which about \$5 trillion worth of trade passes each year.—REUTERS

### **US carrier group patrols** South China Sea

WASHINGTON – A United States patrols in the South China Sea amid control of the disputed waterway and aircraft carrier strike group has begun growing tension with China over concerns it could become a flashpoint

under the new US administration.

China's foreign ministry on Wednesday warned Washington against challenging its sovereignty in the South China Sea

Foreign ministers of the Associaton of Southeast Asian Nations (ASEAN) meeting in Boracay began yesterday top-level discussions on a code of conduct framework that regional leaders hope to finish this year to help deescalate tensions in the disputed sea.

The framework has been in the works for years since China and ASEAN agreed in a 2002 declaration to "undertake self-restraint" and "refrain" from occupying islands and other features in the disputed areas.

There's still a long way to go but ASEAN is really working hard to have this code of conduct concluded very soon," foreign affairs spokesman Charles Jose told reporters.

The US Navy said the force, including Nimitz-class aircraft carrier USS Carl Vinson, began routine operations in the South China Séa on Saturday. The announcement was posted on the Vinson's Facebook page.

The strike group's commander, Rear Admiral James Kilby, said that weeks of training in the Pacific had improved the group's effectiveness and readiness.

We are looking forward to demonstrating those capabilities while building upon existing strong relationships with our allies, partners and friends in the Indo-Asia-Pacific region," he was quoted as saying by the Navy Navo Service

Friction between the US and China over trade and territory under President Donald Trump have increased concerns that the South China Sea could become a flashpoint.

China wrapped up its own naval exercises in the South China Sea on Friday War games involving its own aircraft carrier have unnerved neighbors with which it has long-running territorial disputes.

China lays claim to almost all of the resource-rich South China Sea, through which about \$5 trillion worth of trade passes each year.

Brunei, Malaysia, the Philippines, Taiwan and Vietnam also claim parts of the waters that command strategic sea lanes and have rich fishing grounds, along with oil and gas deposits

### PhI 'lost its victory'

Murray Hiebert, senior adviser of

the American think tank Center for Strategic and International Studies (CSIS), said the Philippines lost its victory in the arbitral tribunal that found China's "nine-dash line" historical claim "illegal" when the government put the issue on the back burner

Hiebert, also the deputy director of the Southeast Asia Program at the CSIS. said raising the South China Sea ruling and mentioning the favorable decision more often could give the Philippines "stronger cards in the hands to play"

"You pretty much lost what you won in the tribunal. The Chinese just put that in their pocket," Hiebert told . Filipino journalists during a discussion on Philippines-US relations at the CSIS headquarters here recently

He said the Obama administration had all kinds of plans on how they would respond to China not honoring the ruling but in the end did not do very much.

In a landmark ruling on July 12, the Hague-based Permanent Court of Arbitration (PCA) found no legal basis for China to claim historic rights to a "nine-dash line" in the South China Sea and said Beijing had breached the sovereign rights of the Philippines, which brought the case

The court also ruled that many purported islands controlled by China are not, in fact, islands, but instead reefs or rocks, which do not

generate territorial rights.

China has refused to honor the ruling and accused the judges of the wikunal of taking bribes from the Philippines in our lange for invalidating Beijing's expansive and excessive claims in the South China Sea.

The ruling, according to Hiebert, was a "hallmark" that also defines what the situation is in the

South China Sea.

When there are other disputes involving China, he stressed that the ruling can be brought out "but it's going to be tough for the Philippines to walk us back.

Former foreign affairs secretary Albert del Rosario, the top diplomat of the Aquino administration and the brains behind the arbitration case, criticized the Duterte administration for not protesting China's deployment of missile systems in the South China Sea and for declaring that it would set aside the arbitral ruling

"If a new Aquino and Del Rosario come to power in the future, how do they suddenly raise this again? I think the Philippines could have used this without rubbing the Chinese noses in it too much," Hiebert said, referring to former president Benigno Aquino III.

"In some ways by starting to engage immediately was a good idea but may be not totally forgetting about the ruling I think the Philippines would have had few stronger cards in their hands if they play, mention a little bit

more," he added.
Not engaging immediately after the arbitral tribunal ruled on the Philippines' case against China, Hiebert said Manila missed the time and "China has already assumed that the Philippines has moved on

With its rebuilding of the islands in the South China Sea, he said China has made it clear that it is determined to keep its position as a dominant player in the South China Sea and there is not much to negotiate even if there is a talk, in light of the ruling. of possible joint exploration - Reuters, Pia Lee-Brago

# Aquino girded for war over sea dispute

BAGUIO CITY. — National security adviser Hermogenes Esperon Jr said the Aquino administration wanted to go to war with China over the South China Sea or West Philippine Sea dispute.

At the sidelines of the Philippine Military Academy homecoming on Saturday, Esperon said the government cannot afford a war with China with only three capable ships in the inventory of the Philippine Navy.

Esperon's predecessor, Cesar Garcia, once told a congressional hearing that the South China Sea dispute has "overtaken all security issues in our hierarchy of national security issues."

Garcia cited the then massive

land reclamations by China in several reefs in the South China Sea. Last month, China was reported to have installed weapon systems in the seven reclaimed reefs, prompting Foreign Affairs Secretary Perfecto Yasay to send a note verbale to China.

"Biggest threat? Kasi gusto nilang lumaban sa China noon. Anoing ilalaban mo, tatlong Coast Guard cutter na 1965 model? Biggest threat kung ang idea is to fight it out," said Es-

Esperon was referring to the three former US Coast Guard cutters that were given to the Philippine Navy over the past several years. One of them, the now BRP Andres Bonifacio, was actually transferred to the Navy during the Duterte administration.

Esperon said Philippines and China can be friends, adding that the relations of the two countries should not be based on the territorial dispute alone. The Duterte administration is seeking improved relations with China and with

He said there is "so much trade" between US and China despite their being military rivals Also, he said Russia and Japan are also trade partners while they are also involved in a territorial dispute.

"So what really would you want to prefer, go to war or improve the lives of our citizens, citizenry, improve our economies, make it a better world? War is not our instrument of policy," said Esperon.

He said improving Philippine relations with China and Russia


is "sort of a win-win situation."

"If you are going to always see is the South China Sea, that's not the sum total of our relations with China. As you can see now, much of our relations are on economic, in economic field, trade, said Esperon.

China has pledged P240million in assistance to the Philippines during the Duterte administration to fight terrorism and address illegal drugs. The defense department has already submitted a list of equipment to be acquired from China using the fund offered by the Chinese

Last week, President Duterte met with Russian Security Council Secretary Nikolai Patrushev in Davao City to discuss various issues, including possible defense cooperation between the two countries

# Geraldine Roman supports ROTC

n a commencement address delivered before the ROTC graduates of the University of the Philippines on March 20, 1941, Brig Gen Vicente P. Lim, the first Filipino West Pointer, declared. "Our country has such an extensive shoreline in proportion to our revenues that we cannot sustain a standing army big enough to defend it. We must therefore educate every citizen to be prepared to fight at a moment's notice. You will be the

officers of this citizen army I urge you, therefore, to enhance the military training that you have acquired It is not only for your benefit but for the protection of your country."

After World War II, the mandatory ROTC program remained part of college education. In 2002, however, the National Service Training Program Act was passed, giving college students three options in place of





mandatory military training: Civil Welfare Training Services, Literacy Training Services; or ROTC In effect, the latter became optional and voluntary, leading to a decline in participants in the program, and the resulting loss of potential leaders for our military force.

Last week, President Duterte approved the return of mandatory ROTC for students enrolled in Grades 11 and 12, making it part of the basic curriculum for a senior high school education in all public and private educational institutions. The President certified as "urgent" Defense Secretary Delfin Lorenzana's proposal to amend Republic Act No. 7077, to revive mandatory ROTC in our schools.

The rationale for bringing back ROTC as a mandatory course is to inculcate among the youth of the land love of country, leadership qualities, and character development. It aims at "enhancing consciousness in the ethics of service, patriotism and nationalism, respect for human rights, the importance of discipline, and an appreciation of the role of national heroes in the historical development of the country."

There are a few examples of the practical use of ROTCtrained elements, in the 1953 presidential contest that saw Ra-



mon Magsaysay elected by a land-slide, ROTC personnel were fielded to guard against poll irregularities. Natural disasters like severe flooding, and earthquakes, which take place in different parts of the country from time to time, highlight the need for an organized and trained citizenry particularly when there are no AFP units available to lend assistance in remote communities.

Of course, there is no universal love for mandatory ROTC. The mere fact that the program is mandatory automatically attracts resistance from those concerned with personal liberties. And there is substantial opposition for various reasons. Some folks do not see how marching under the hot sun-

for hours can develop love of country. This is understandable. Marching under the hot sun does entail sacrifice involving personal comfort and convenience.

But marching in step with others helps instill a sense of discipline, a sense of teamwork—for the common good. It is this mindset that will contribute in the long term to national security and development. Wars have never been fought under the shade of trees with cool winds blowing around. Attending to natural, disasters that cause so much damage and loss of lives is never an easy task. It requires a disciplined and dedicated citizenry, particularly among the youth. The idea of "white side walls" (crewcut) for a hairstyle has never been attractive for many young people. More significant for its negative impact have been the past cases of abuse and corruption in the implementation of the ROTG program, owing to improper supervision and lack of attention to detail by irresponsible officials.

In building a large citizen army for his nation, Singapore's, founding father, Prime Minister Lee Kuan Yew, once said: "We had to reorient people's minds to accept the need for a people's army and overcome their traditional dislike for soldiering: We set up a national cadet corps and a national police cadet corps in all secondary schools so that parents would identify the army and the police with their sons and daughters. Only if we changed people's thinking and attitudes could we raise an effective citizen army." He went on to say that even if an enemy could subdue our armed forces, they would have a difficult time dealing with a population well-trained in the use of arms, fighting for their country.

Last week, support for the ROTC program came from a sector of society not often identified with the military. Rep. Geraldine Roman (first district, Bataan), the first transgender woman elected to Congress, expressed her strong support for the return of the ROTC. She said this would prepare them for the country's defense and for typhoon and earthquake rescue operations. Roman, who won 62 percent of the vote in her recent election campaign, also commended President Duterte, Defense Secretary Lorenzana, and the AFP chief of staff, Gen. Eduardo Año, for allowing the entry of members of the LGBT (lesbian, gay, bisexual, and transgender) community into the military organization. Roman is the daughter of former Batasan assemblyman and deputy finance minister Antonino Roman Jr., a respected colleague in the defunct ministry of finance during the martial law years.

Also speaking up in support of a revived ROTC is Commission on Election Chair Andres Bautista, who said that the program "could help inculcate the importance of exercising the constitutional duties and rights of suffrage, emphasizing that democracy is not a spectator sport."
