

Du30 paid us to kill, says ex-cop

A retired police officer on Monday disclosed that President Duterte, when he was the mayor of Davao City, ordered and paid him and other members of a death squad to kill criminals and opponents.

Human rights lawyers who presented retired SPO3 Arthur Lascañas to reporters during a news conference in the Senate said his disclosures could be grounds for impeaching Mr. Duterte.

Saying he was ending his "blind obedience and loyalty" to Mr. Duterte, Lascañas said it was the then mayor of Davao City who ordered the murder of radio host Juan Pala Jr. on Sept. 6, 2003

PaM to kill Pala

He said then Mayor Duterte paid him and his group P3 million to kill Pala.

"This is the whole truth about the Pala murder case. Now this is considered solved. I am one of those who killed Jun Pala," he said

Lascañas' comments differed from those he made last October at a Senate hearing into extrajudicial killings. At the time, he denied the existence of the so-called Davao Death Squad (DDS).

His account on Monday was similar to that of confessed hit man Edgar Matobato, who testified in the same Senate inquiry to personally watching Mr. Duterte shoot a man dead with an Uzi machine pistol and give orders for police to kill suspected criminals.

Matobato testified that Lascañas was the leader of the DDS, which was composed of policemen, militiamen and former communist rebels.

War on drugs

Human rights groups have documented some 1,400 suspicious killings in Davao City since the early 1990s and critics say the bloody war on drugs that Mr Duterte has unleashed since taking office seven months ago bears the hallmarks of DDS attacks.

More than 7,700 people have been killed in the nationwide

crackdown on illegal drugs, some 2,500 in what police say are shootouts during raids and sting operations.

Many of the killings are under investigation and attributed by the authorities to vigilantes and drug gangs covering their tracks.

Activists, however, say many have been extrajudicial killings.

"Of all the killings we did in Davao City, either we bury them or throw them into the sea, it is paid [for] by Mayor Rody

Duterte," Lascañas, 56, told the news conference in the Senate on Monday.

"Most of the time P20,000, sometimes P50,000 and depending on the status of the target, sometimes P100,000," he said.

Breaking into tears at one point, Lascañas said he was speaking up because he was bothered by his conscience, including his role in the deaths of his two brothers, whom he ordered killed because they were drug users.

"I had my own two brothers killed. Even if I end up dead, I'm content because I've fulfilled my promise to the Lord to make a public confession," he said.

Senate inquiry

Senators Leila de Lima and Antonio Trillanes IV called for a Senate inquiry into the public confession of Lascañas, whose lawyers from the Free Legal Assistance Group (FLAG) gave assurance that the former policeman was ready to face a Senate inquiry and the proper government body.

It was Trillanes who presented Lascañas at Monday's news conference.

Lascañas narrated several killings that he said Mr. Duterte had ordered, permitted or financed as mayor of Davao City, including the 1993 bombing of mosques as retaliation after Moro rebels were blamed for the bombing of a Roman Catholic cathedral

Lascanas said he and his group shot dead a kidnapping suspect along with the man's pregnant wife, young son, father-in-law and two others with the consent of Mr. Duterte.

After his group informed Mr Duterte about the capture of the suspected mastermind of a kidnapping in Davao, Lascanas quoted the mayor as saying. "All right, make it clean."

Another target was radio commentator Pala, who was critical of Mr Duterte. He was killed in an ambush on Sept. 6, 2003, by the liquidation squad's members, who then got financial rewards from the mayor, Lascañas said.

Lascañas said the mayor wanted Pala killed because the broadcaster attacked him on his radio program every day.

He said Mr. Duterte hired

him through the mayor's driver, SPO4 Sonny Buenaventura, for P3 million to kill Pala.

Bodyguard's tip

Lascañas said Pala survived two attacks, but the third one succeeded with the help of the radio host's part-time bodyguard, rebel returnee Jerry Trosio.

He said it was Trosio who tipped off the squad to Pala's whereabouts one night and the hit men were able to kill the broadcaster.

Two days after the murder, Lascañas said Mr. Duterte paid the group P₃ million through Buenaventura.

He said he and Buenaventura split P1 million and gave P2 million to hit man Jim Tan, who got P1 million and gave the rest to the other gunmen. —with RE-PORTS FROM AP AND REUTERS INQ

Ex-cop: I killed broadcaster on Rody's order

Tired of incessant criticism when he was mayor of Davao City, Rodrigo Duterte took out a P3-million contract to kill broadcaster Jun Pala, and then gave a P1-million bonus when the deed was done.

This was the claim made yesterday by one of three policemen who allegedly carried out the still unsolved assassination in 2003, as he came out in public to insist that President Duterte set up death squads in his home city that were responsible for the summary execution of about 1,000 crime suspects.

"Consider the Jun Pala murder case solved. I was one of those who killed Jun Pala," Arthur Lascañas said yesterday, four months after he faced a Senate inquiry and denied the existence of Davao death squads.

Flanked by members of the Free Legal Assistance Group (FLAG), Lascañas narrated: "The first time mayor Duterte sat as mayor of Davao City, we started what we call salvaging of people, criminal and drug suspects in Davao."

"We implement the personal orders of Duterte... in all the killings we do in Davao City – whether burying them or throwing them at sea – we're being paid by mayor Rodrigo Duterte," Lascañas said.

In changing his version of events, Lascañas explained that he was bothered by his conscience.

Duterte in previous interviews had denied having Pala killed, but said the broadcaster deserved his fate and that some journalists invited assassination. The statement drew condemnation from media groups at the start of Duterte's presidency.

Brothers, pregnant woman

In tears, Lascañas claimed he even had his two brothers killed for involvement in drugs

Allegedly on Duterte's order, Lascañas' death squad also executed the suspected mastermind in the kidnapping of a certain Mrs. Abaca, who was freed after ransom was paid.

The kidnapping suspect, a certain Mr. Patasaja, was intercepted in his Ford Fiera in General Santos City. But he was with his wife, who was seven months pregnant; their son who was about five years

prchestrated by staunch old, the target's 70-year-old father-in-law and two helpers, a man and a woman

> Lascañas said the five were brought to the Laud quarry in Davao City where Patasaja was taken to a separate structure for interrogation.

> A certain Major Macasaet reportedly briefed Duterte about the case and returned later to the quarry with instructions to "erase all" Lascañas şaid Duterte wanted the killing to be,"clean."

> Lascañas claimed that he pleaded with his cohorts to spare the boy and take him to a bus station so he could get out of Davao. But Lascañas claimed his cohorts warned that the boy would remember their faces and would get back at them when he grew up and could no longer be recognized by the death squad members.

"Here, evil prevailed," Lascañas said. A silenced .22-caliber pistol was used on the family and their helpers.

Blind obedience

Facing the media at the Senate in what he described as a "public confession," Lascañas said he carried out the "salvagings" out of "blind obedience and loyalty" to Duterte.

Death squad members were also paid from P20,000 to P100,000 "depending on the status of the target," he said.

He claimed he also received an allowance from Duterte's office amounting to P100,000. It was not clear if this was a regular monthly payment.

Lascañas has just retired from the Philippine National Police with the rank of seniorpolice officer 4. He declined to take questions from reporters.

During the hearing conducted by the Senate committee on justice last year, he was described by self-confessed hitman Edgar Matobato as part of Duterte's inner circle. Matobato claimed he received assassination instructions from

FLAG lawyers Arno Sani-Lascañas would tell all under oath in a proper government investigation. In the meantime, Lascañas will be given protection as his life may be in danger.

Take your time

Lascañas alleged that an "angry" Duterte put out the P3-million contract to kill Pala Lascañas said he took the contract together with a certain SPO4 Sonny Buenaventura and SPO1 Jim Tan, who had many "players" or hitmen who are former communist rebels in his stable

Pala survived two assassination attempts by the group Lascañas said he apologized for the failed hits when he ran into Duterte at a shopping mall. But the mayor allegedly told him in the Visayan dialect, "Take your time. Don't hurry."

They were able to assassinate Pala outside his house with the help of the victim's bodyguard, who they were able to turn into an informant for P350,000

Lascañas sought forgiveness from the children of his two brothers whom he had ordered killed, saying it was the first time he had divulged his deeply held secret.

"I call on the PNP... killing is not the solution. This is against the law and against the law of God. We will be haunted by our conscience," Lascañas said. "I may be killed but I'm now contented in fulfilling my

promise to God in making this public confession."

New EJK probe sought

During the afternoon session at the Senate, Trillanes sought a reinvestigation into extrajudicial killings.

Sens. Paolo Benigno Aquino dad and Jose Ma Diokno said IV. Leila de Lima and Risa Hontiveros in separate statements backed the reopening of the inquiry.

Hontiveros described the revelations as a direct stab at the credibility of Duterte, undermining his "moral capacity to lead."

"They strengthen suspicions that the death squads responsible for thousands of unsolved extrajudicial killings are state sanctioned," she said.

De Lima described Lascañas' allegations as "hairraising.'

Senate President Aquilino Pimentel III said while any senator may file a resolution for an investigation based on Lascañas' claims, there is no assurance that it will push through.

Senate Majority Leader Vicente Sotto III said Trillanes' manifestation would be referred to the Senate committee on public order and dangerous drugs, chaired by Sen. Panfilo Lacson.

Sotto said the Senate justice committee, chaired by Sen. Richard Gordon, would also have to be informed of Trillanes' manifestation.

Sanidad and Diokno said it would be up to members of the House of Representatives to decide whether or not to push for Duterte's impeachment.

They said Lascañas' statements and the affidavits he would issue in the coming weeks could be used by concerned government bodies to investigate Duterte.

Army facilitates Feeding Program in Bukidnon

Malaybalay City – Soldiers under 403rd Infantry (Peacemaker) Brigade, in collaboration with Malaybalay City LGU, CSWDO of Malaybalay City, DepEd, and the teachers, faculty, and staff of the beneficiary school, conducted a Feeding Program at BCT Elementary School in Brgy. Gov't on ceasefire: NPA must first stop attacks

The government will resume peace talks with communist rebels if they stop their attacks on soldiers, extortion activities and the burning of properties, Malacañang said yesterday.

Presidential spokesman Ernesto Abella said there should be "compelling reasons" to continue the negotiations, which were terminated by President Duterte this month after the rebels staged a series of attacks against government forces.

"While it is understandable that suspicions linger about the motives of the parties on opposite sides of the ideological spectrum, some 'compelling reasons' need to be provided for talks to resume," Abella said in a statement.

"Considering the unprecedented good-will the President has shown, these actions from NDF (National Democratic Front) may provide compelling reason and could put at ease, to some extent, the apprehension of the military and the administration. After all, when guns are silent we can better listen to each other," he added.

The NDF represents the communist rebels in the peace negotiations with the government.

Abella said the communists should agree to a bilateral ceasefire and stop the collection of the so-called revolutionary tax, the ambushes on military personnel, the burning of properties and other provocative and hostile actions.

"We need to take in good faith the President's vision for a peaceful, just and inclusively prosperous Philippines. He has already taken the first steps forward. We wait for the NDF to respond," he said.

The peace negotiations between the government and the NDF were scrapped after the communists insisted on their demand to free 400 rebels whom they claim to be political prisoners. Duterte rejected the demand, saying it is similar to the grant of amnesty.

The disagreement prompted the communists and subsequently the government to call off their respective unilateral ceasefire orders

On Feb. 4, Duterte announced that he is terminating the peace talks and ordered the security forces to arrest the NDF consultants who joined the negotiations.

He has also described the NDF, the Communist Party of the Philippines (CPP) and their armed wing the New People's Army (NPA) as "terrorists."

On Sunday, the CPP ordered the NPA to free the six soldiers and policemen they are holding captive as a "positive gesture" for the resumption of the peace talks. The group also reiterated its support for a bilateral ceasefire agreement

"The revolutionary forces are encouraged by the previous statements of President Duterte that all political prisoners will be released within 48 hours once the bilateral ceasefire agreement is signed," the CPP said in a statement.

"We anticipate that negotiations concerning the terms of reference of a bilateral ceasefire agreement will be most difficult. The revolutionary forces are bound by principle to assert the withdrawal of the AFP's operating troops from areas under the sway of the revolutionary government," it added.

The disagreement over jailed communist rebels was also the contentious issue that led to the collapse of the peace talks during the previous administration.

Release troops

The military called on the NPA yesterday to release the soldiers and policemen without conditions to show the sincerity of the CPP to resume the peace talks.

"The NPA should prove and substantiate their announcements with clear and sincere actions, not propaganda," said Armed Forces of the Philippines spokesman Brig. Gen. Restituto Padilla.

Among those to be freed are Pfc. Edwin Salan who was captured in Alegria; Surigao del Norte on Jan. 29, Sgt. Solaiman Calucop and Pfc. Samuel Garay who were captured in Columbio, Sultan Kudarat on Feb. 2; Police Officer 2 Jerome Natividad captured in Talakag, Bukidnon on Feb. 9; and militiamen Rene Doller and Carl Mark who were captured in Lupon, Davao Oriental on Feb. 14

In its statement issued Sunday, the CPP said the release of the six "prisoners of war" is their positive gesture to continue peace negotiations with the government.

Padilla welcomed the move by the communist rebels, whom the military earlier said had been suffering tactical defeat

since the government lifted its unilateral ceasefire declaration on Feb. 4

"Doing so (freeing the soldiers without condition) would lessen the seriousness of their continuing crimes and add to any goodwill they wish to convey," he said.

Presidential adviser on the peace process Jesus Dureza said the government would take the necessary steps for the resumption of peace talks if the CPP/NPA/NDF rebels are willing to proceed with the negotiation for a bilateral cease-fire agreement.

"We welcome and respect the positive position coming from the leadership of the CPP/NPA/NDF," Dureza said in a statement yesterday.

"On the part of the Philippine government, we share the same commitment to work for just and lasting peace in the land. When compelling reasons, as President Duterte earlier announced, are present, then we in government shall take the next necessary steps," Dureza added.

The NDF also directed the NPA to work closely with third party facilitators for the release of the six captives before the scheduled peace negotiations in the Netherlands next week.

Hand of peace

Presidential daughter Davao City Mayor Sara Duterte-Carpio yesterday offered a hand of peace to the NPA to stop the spate of encounters, particularly in Davao City.

"In light of the recent events in the third district of Davao City that resulted in the deaths of our fellow

Filipinos, I am offering my hand in peace to the NPA," Duterte-Carpio said in a statement yesterday.

"In the event that you will decline my offer, I can only pray that there will be no more deaths and leave everything to the AFP and to God," she added.

The mayor

NDF consultant Satur Ocampo said rebel consultants should not be arrested during the one-month grace period after the government notified them about the cancellation of the Joint Agreement on Safety and Immunity Guarantees (JASIG).

Ocampo stressed that the NDF asked that its consultants be freed because they are covered by JASIG "that tells that their participation in the peace talks would guarantee them against harassment, arrest and filing of cases."

Meanwhile, the military said NPA rebels allegedly forced hundreds of villagers out of Barangays Cabua-an and St. Niño in Madella, Quirino province last Saturday.

1/Lt. Rhea May Reyes, spokesperson of the Army's 5th Infantry Division, said residents of the two barangays were terrorized by the presence of the armed men.

More than 100 rebels had occupied a school in nearby Barangay San Martin.

Stop extortion, then we talk peace - Palace

ALACAÑANG on Monday called on the Communist Party of the Philippines (CPP), the New People's Army (NPA) and the National Democratic Front of the Philippines (NDFP) to stop extortion and other hostile activities if it wants to resume peace talks.

Presidential spokesman Emesto Abella announced four conditions on the communists calling for a stop to the following: collection of "revolutionary taxes" or extortion activities, ambushes on military personnel, burning of property and provocative and hostile actions.

"While it is understandable that suspicions linger about the motives of the parties on opposite sides of the ideological spectrum, some compelling reasons

need to be provided for talks to resume. Considering the unprecedented goodwill the President has shown, these [conditions] may provide compelling reason and could put at case, to some extent, the apprehension of the military and the administration," Abella said in a statement.

"When guns are silent, we can better listen to each other. We need the President's vision for a peaceful, just and inclusively

prosperous Philippines He has already taken the first steps forward in good faith. We wait for the NDFPI to respond," he added.

Abella however called out the communists for demanding the immediate release of their 400 detained comrades, which the rebels claimed were already old and sickly.

"It may be pertinent to take note that the [NDFP] probably pushed the envelope too fast and too soon in demanding the full release of political prisoners prior to any signed agreement and for lifting the ceasefire ahead of their deadline," Abella added.

In a separate statement, Presidential Adviser on the Peace Process Jesus Dureza said President Rodrigo Duterte was willing to negotiate a bilateral ceasefire pact with the Reds.

Dureza issued the statement after the communists expressed willingness to negotiate a bilateral ceasefire agreement and announced on Sunday the release of six government men held as "prisoners of war."

Talks were initially scheduled on February 22 to 25 in the Netherlands, but Duterte cancelled all negotiations and a

unilateral ceasefire on February 4 after a series of NPA attacks on military men

The cancellation of the talks came after the communists junked their own unilateral ceasefire declaration because of the President's refusal to free the 400 detained tebels.

"We welcome and respect the positive position coming from the leadership of the CPP/NPA/NDF. On the part of the Philippine government, we share the same commitment to work for just and lasting peace in the land," Dureza said.

"When compelling reasons,

as President Duterte earlier and nounced, are present, then we in government will take the next necessary steps," Dureza added.

As this developed, child rights, watchdog Children's Rehabilitation Genter accused state forces of escalating human rights violations, in the government's all-out war campaign versus the NPA.

AFP: NPA should release captives without con

HE Armed Forces yesterday said the New People's Army should release three oldiers, two militiamen and a policeman without precondition amid demands by the communists for the withdrawal of soldiers n certain areas in exchange for the release of their captives.

"The NPA should prove and substantiate their announcements with clear and sincere actions, not propaganda," AFP spokesman Brig. Gen. Restituto Padilla said.

"Hence, they should release the soldiers they have abducted immediately without any condition. Doing so would lessen the seriousness of their continuing crimes and add to any goodwill they wish to convey," Padilla added.

Padilla's statement was in contrast with the statement issued by AFP public affairs office chief Col. Edgard Arevalo who said the AFP is open to relocating its forces in certain areas in Mindanao to pave the way for the release of the six who were

abducted by the NPA rebels over the past three weeks

"We will afford every opportunity to ensure the safe release of these abducted soldiers and other members of security forces," Arevalo said.

Arevalo said the military welcomes the decision of the communists to release the six - PFCs Edwin Salan and Samuel Garay, Sgt. Solaiman Calucop, militiamen Rene Doller and Carl Mark Nucos, and PO2 Jerome Natividad

The six were abducted between January 29 to February 14 in Agusan del Norte, Suitan Kudarat, Bukidnon, and Davao Oriental.

In a statement last Saturday, the Communist Party of the Philippines (CCP) said negotiations for bilateral or joint ceasefire may resume if President Duterte sends government negotiators to Netherlands for the earlier scheduled meeting on February

Duterte terminated the peace negotiations and lifted the government truce last February 4 after a series of NPA attacks

on civilian and military targets

The CPP said it has called NPA units to "expedite the release" of the six, so-called "Prisoners of War," as a "positive gesture." He said the NPA can work closely with third party facilitators to free the six.

The CPP said the AFP can *cooperate by withdrawing all troops in and around the areas where the POWs will be released to pave the way for their safe and orderly release." It said the six can return to their families before or during the scheduled negotiations in Netherlands if the military cooperates.

Arevalo said the release of the six captives "as an act of goodwill and not as leverage to constrain the government to go back to the negotiating table."

He said the government terminated the peace negotiations not because of the abduction of the six security forces but due to the NPA's "atrocious criminal activities," including the killing of three soldiers in Bukidnon earlier this month, burning of public conveyances and farm implements and extortion. - With Joselyn Montemayor

NGO claims violations of children's rights escalated after 'all-out war' vs NPA declared

HE Children's Rehabilitation Center (CRC) said an upsurge in violations of children's rights has followed the declaration by the military of an all-out war campaign against the New People's Army (NPA)

CRC, which had been counseling children traumatized by military operations for years, challenged President Duterte to order his troops to leave the children alone and stop making their schools and day-care centers as their bivouac areas.

Cristina Palabay, secretary-general of the human-rights watchdog Karapatan, also urged the Duterte government to respect the provisions of the International Covenant of

Children's Rights (ICCR), which bans the recruitment of child soldiers and the use of educational institutions as staging areas for military operations

NPA Spokesman Jorge Ka Oris Madlos said "the NPA stands by its prohibition on the use of children as combatants, and this has been spelled out in the documents released by the National Democratic Front of the Philippines [NDF]."

"Even while the peace negotiation between the Government of the Republic of the Philippines and the NDF is ongoing, we have been witness to the continuing humanights violations by the Armed Forces of the Philippines [AFP]. Especially after Duterte's declaration of an all-out war, the military has continued, and even gained more confidence, in violating human

rights of progressives, activists and even civilians," CRC executive director Sr. Jacqueline Ruiz said

On February 11 about 100 families of the Tagakaolo minority group in Barangay Datal Anggas, Alabel, Saranggani, forcibly evacuated their homes and fled to Sitio Kindag when six bombs were dropped on Sitio Tangis, following an encounter between NPA guerrillas and soldiers.

Three Lumad community schools, operated by the Center for Lumad Advocacy and Services Inc., were also affected by ongoing combat operations

Ruiz lamented the Duterte government's all-out war "is leaving hundreds of children as orphans, with many of them separated them from their parents, who were either arrested and detained and slapped with trumped-up charges or disappeared altogether."

Vietnamese killed, 6 seized in Tawi-Tawi pirate attack

ZAMBOANGA CITY – Gunmen attacked a Vietnamese cargo vessel in the waters off Tawi-Tawi, killing a crewmember and seizing six others on Sunday night.

(PCG) and the military said the M/V Giang Hai was sailing near Pearl Bank and Taganak Island when gunmen on a speedboat blocked its way.

The vessel reportedly came from Indonesia and was headed for lloilo.

Petinglay said members of the Marine Battalion Landing Team 8 responded to the scene and rescued 10 Vietnamese

The body of the fatality was recovered from the vessel.

Fishing vessels towed the Giang Hai to Taganak.

Petinglay said government security forces in Tawi-Tawi and Sulu were ordered to be on the lookout for the kidnappers.

modore Joel Garcia said a notice to mariners would be issued to ships passing in the

The PCG launched a pursuit operation against the pirates.

Petinglay said they could not yet ascertain whether the Abu Sayyaf was behind the

The incident brings to 12 the number of Vietnamese kidnapped in Philippine waters.

In November, the bandit group seized six Vietnamese sailors near Basilan.

Vietnamese sailor killed, labducted in pirate atta

A VIETNAMESE crew member of a foreign cargo vessel was killed while six others were abducted by still unidentified armed men off Tawi-tawi on Sunday night, according to military and coast guard officials.

The Coast Guard also said that 10 Vietnamese, members of the 25-man crew of MV Giang Hai that was attacked near Baguan Island in Tawi-Tawi, an area close to the stronghold of the notorious Abu Sayyaf militant group, were rescued.

Armed Forces public affairs office chief Col. Edgard Arevalo said there was still no indication if the Abu Sayyaf, linked to similar attacks in Tawi-tawi and nearby areas in the past, was involved.

Arevalo said the Vietnamese vessel was attacked by pirates at around 8:25 p.m., about 17 nautical miles off Pearl Bank

and killed one of the crewmen, Vu Duchan, who sustained 12 bullet wounds.

Arevalo said Marine soldiers, policemen and Coast Guard personnel responded to the scene after learning of the incident early yesterday, "They conducted board and search on the same vessel," he said.

"They learned that 17 crew members were on board (prior to the attack) and they were able to account only 10 (survivors) and one dead. The six others were abducted by the armed men," Arevalo said.

Arevalo identified the abducted crewmembers as ship captain Buy Xuan Vien; chiefmate Do Huu Nghia; 3rd mate Bui Trung Duc; 2nd engineer Nguyin Huu Trong; sailor Tran Viet Van; and oiler Nguyen Quang Huy.

spokesman Guard Coast Cmdr. Armand Balilo said the Philippine Coast Guard was informed by the Vietnamese

Coast Guard on Sunday night.

Balilo said the PCG deployed two speedboats, carrying Coast Guard and Marine personnel, to the area. The ill-fated vessel was later towed by fishing vessels to Taganak anchorage

Balilo said the MV Giang Hai was coming from Indonesia bound for Iloilo when it was attacked. The official said investigations are underway to determine the other details of the incident

As to the possible involvement of the Abu Sayyaf, Arevalo said: "We don't have information if this (group of suspects) the group of the Abu Sayyaf. That is part of the thorough investigation that we are conducting.'

The Abu Sayyaf have conducted similar attacks in the Tawitawi, Sulu and Basilan areas and in the waters of Indonesia and Malaysia over the past months, and abducted a number of crew members of vessels.

The Abu Sayyaf is still hold-

ing 27, mostly foreign, kidnap victims in Sulu. The 27 victims include six Vietnamese crew members of bulk carrier MV Royal 16 which was intercepted last November off Basilan.

An Abu Sayyaf spotter was killed in a firefight in Turtle island in Tawi-tawi at around 2 p.m. last Sunday.

Arevalo said soldiers initially invited for questioning Al Abdullah after he was seen in the presence of armed men. Abdullah admitted that he was earlier in the company of three armed men - one Absar, Musub Baudin and Man Baudi - who came to his house.

Arevalo said Abdullah later asked permission and was allowed to go to his house. Abdullah later returned with an M16 rifle and fired towards the troops.

Arevalo said they have information that Abdullah has been serving as Abu Sayyaf spotter for potential kidnap victims.

AFP DUI'SUGS kidnappers of ietham

The Armed Forces of the Philippines (AFP) Monday said that pursuit operations are currently being conducted to track down a group of still unidentified armed men who reportedly abducted seven crew members of a Vietnamese vessel near Baguan Island, Taganak, Tawi-Tawi, Sunday night.

Captain Jo-Ann D. Petinglay, Armed Forces of the Philippines-Western Mindanao Command (AFP-WestMinCom) spokesperson said a team from the Philippine Marines is currently assisting the Philippine Coast Guard (PCG) in finding seven crew members of the Vietnanese flag vessel MV Giang Hai.

Reports disclosed that the piracy attack happened at about 7:10 p.m. Sunday at vicinity 17 nautical miles North of Pearl Bank which then drifted near Baguan Island, Taganak.

Petinglay said the Philippine Coast Guard (PCG) assigned in Turtle Island received informa-

tion from local fishermen that the cargo vessel MV Giang Hai was seajacked by unidentified armed men and was sighted within the vicinity of Baguan, Turtle Island, Tawi-Tawi.

The vessel reportedly has a total of 25 crew members, seven of which were abducted by the armed group and one was reported killed.

Petinglay said Philippine Marines stationed in the area together with the PCG and Philippine National Police (PNP) Taganak immediately organized and conducted Joint Law Enforcement Operations to rescue/recover said vessel.

"We confirmed receiving a report about the reported seajacking incident and efforts are being made to locate the whereabouts of the victims," Petinglay said during an inter-

Petinglay said they are still gathering more information if suspected Abu Sayyaf bandits or other local terrorist groups were behind the incident.

She said at least 14 battalions of soldiers backed by the Philippine Air Force, Philippine Navy and police were running after the Abu Sayyaf militants

Kantner was kidnapped by Abu Sayyaf gunmen near Tawi-Tawi in Tanjong Luuk Pisuk, Sabah in November last year.

The body of Kantner's partner, Sabine Merz, 50, was found on his yacht, Rockall, adrift off Mindanao

The Abu Sayyaf has been holding hostage a Dutch man, a Korean, seven Indonesians, five Malaysians, six Vietnamese and six Filipinos.

FVR: Battalion of soldiers not needed in drug war

Helping the government in its war against illegal drugs does not necessarily need a battalion of soldiers, former president Fidel Ramos said yesterday

"It does not have to be a battalion. they can instead form small units in several places," Ramos, who also served as Armed Forces of the Philippines (AFP) vice chief-of-staff, told reporters in a news forum. While he agrees with the need to help the Philippine Drug Enforcement Agency (PDEA) in the war against illegal drugs, a large number of military men is not needed for this, he said in reaction to the plan of AFP chief General Eduardo Año to form a task force with 500 to 5,000 soldiers.

Ramos also said the military should not run after drug users and pushers, like what the police did in Oplan Tokhang, and focus instead on drug lords and other high-value targets

Drug stings, he added, should not be as bloody More than 7,000 people have been killed in the government's war against drugs, with more than half committed by unidentified men often referred to as vigilantes

Authorities claimed that the drug syndicates might have been purging their own ranks, resulting in the high number

of people killed by unknown assailants.

To win this war, Ramos said the military, police and local government units should work as a team in running after criminals and potential insurgents

He suggested a method to make this set-up work well the military would clear communities of insurgents, dissidents and criminals and the police could come later to prevent them from re-entering.

It was for this feat that Costales

got his Gold Cross medal that recognizes gallantry in action

Salamat, a member of the Philippine Military Academy (PMA) Class of 1985, was the former commander of the 1st Marine Brigade in Sultan Kudarat from February 2014 to June 16 Prior to this, he served as chief of the Unified Command. Staff of the Armed Forces of the Philippines (AFP) Western Command from May 2013 to December 2013.



Trillanes, the soldier who cried wolf

Senator Trillanes was a Navy officer who only became relevant for his part in the Oakwood mutiny and the Manila Peninsula siege. He, together with his group, claimed to be fighting against corruption and for the rights of soldiers. These events provided the opportunity for him to become part of the Senate.



However, as a senator, what has he really accomplished for the Filipino people? What tangible achievements has he done to stop corruption in the government? What has he achieved to support his fellow soldiers?

His heart may have been on the right track when he was just starting but when he became a politician, it seems that he adopted the characteristics of traditional politicians as well: out of touch with the true needs of the people, full of empty promises during elections, ambitious, and prioritizes personal political needs or political allies' needs instead of serving the Filipino people.

Last April 2016, nearly two weeks before the elections, Senator Trillanes raised the issue of President Duterte's BPI account and alleged that it contains millions of pesos. One can only surmise the Senator's purpose for "exposing" the accounts: Is it to prove that then presidential candidate Rodrigo Duterte was just fooling the people with his "simple" image? Just because a man lives a simple life – as people who have seen the President's lifestyle can vouch for – doesn't mean that he should also be poor.

People admire him for his simple lifestyle. The way he interacts with the ordinary folk makes them really feel that he is one of them compared to other politicians who only claim to represent them. The timing of the "exposé" also made it suspect. It was clearly a politically motivated attack to prevent Duterte from winning the presidency especially with insinuations that the money in the bank accounts may have come from illegal activities or from corruption.

It is worth noting that after the election when Duterte had clearly won by a wide margin, Senator-Trillanes acknowledged the will of the people and left the issue for the media to pursue, saying that he had already done his part. If you ask me, if the senator is confident about the evidence that he holds or if he is sure about the allegations, why stop pursuing it? Could it be because the "part" he says he has accomplished is to try to prevent Duterte from winning the election by throwing unfounded accusations?

Now, the senator is reviving the issue of the bank accounts, and just as he did the first time, dares the President to prove him wrong. He disregards the simple fact that the burden of proof is on him, he being the one throwing accusations. With the renewed attack, is there more confidence on the truth behind the allegations, or is this just another politically motivated noise just like the first time? The senator seems to have forgoften that he was the one who abandoned the issue before. He is now reviving it without anything new. With his brave talk, his allegations remain just that; baseless accusations coated by strong words and appearance. The question we should be asking is this: If he used this issue before in an attempt to influence the result of the election, what reason could he have to revive the issue that he once abandoned? Is it to boost support for rallies against the President?

Aside from the issue of the bank accounts, Senator Trillanes has also involved the President in the Bureau of Immigration bribery scandal. But just like all his accusations against the President, there is no tangible proof to back up his claims. He also said that based on "information," President Duterte wants him dead, but Mr. Senator, why would he want you dead when they can just simply watch you destroy your credibility and make a fool out of yourself in front of the cameras with all your unfounded allegations? At least present some credible proof to support your case so that it won't look like you are simply being bitter that you were not chosen to be the President's running mate.

Right now, you have already destroyed your reputation, if there was any to begin with. If you are contemplating another mutiny, Filipinos will see that you are not doing it for the sake of the people but just for your own agenda and those of your political allies. Do your job as a senator who should be serving the Filipino people and stop wasting public funds.

AFP still open to peace talks with rebels

From the Philippine News Agency (Feb 20): AFP still open to peace talks with rebels

Despite the all-out war campaign against the rebels, the Armed Forces of the Philippines (AFP) is still open for the government to renew peace negotiations with the New People's Army (NPA).

However, this does not mean that the military will tolerate NPA attacks and atrocities on civilian and other targets, AFP chief-of-staff Gen. Eduardo Año said in an interview over the weekend.

"We are not against the path to peace but we will not allow the NPAs to conduct atrocities and similar activities that will imperial the lives of ordinary people in the communities," he added in Filipino.

With this, Año said they are exerting pressure on the NPA to force the latter to go back to the negotiating table.

This is in line with the no-military pressure being exerted by other agencies and bodies.

"You need military and non-military pressure so that they will forced to go back to the negotiating table," he added.

On Feb. 4, President Rodrigo Duterte terminated the peace talks after a series of unprovoked rebel attacks against military targets, killing six soldiers and abducting another three people.

In the ongoing campaign against the NPAs, the AFP chief said that they already have 30 encounters with the rebels resulting in the neutralization of 44 insurgents.

This can be broken down into 15 captured, 12 killed and 17 surrendered, Año said.

The AFP chief added that the bandits will further disintegrate once the military gets further support from the community.

Año earlier set a six-month deadline to eliminate terrorists and bandit groups in Mindanao upon his assumption of the AFP's top post last December.

The campaign is now on its second month.
