

# De Lima to turn self in today

"The fight goes on," an emotional Sen. Leila de Lima declared on Thursday night, hours after a warrant for her arrest was issued by the Muntinlupa City Regional Trial Court (RTC), on drug charges.

In a brief appearance before reporters in the Senate after a meeting with her legal team, De Lima, her voice breaking, said. "I will come home tonight. I will be back tomorrow morning and here, in the Senate, I will wait for the arresting team."

"I will wait for them. I will voluntarily surrender to them." she said. "But for now, I want to be with my family at home," said De Lima, a mother of two

critic of President Duterte's war on drugs was a "major step forward" in the campaign to eliminate the narcotics scourge.

"The war on illegal drugs targets all who are involved and the arrest of an incumbent senator demonstrates the President's strong resolve to fight pushers, peddlers and their protectors, and that his government will not yield until the last pusher and trader are out of the streets victimizing the Filipino youth," said Mr. Duterte's spokesperson, Ernesto Abella

#### No intention to hide

Executive Judge Juanita Guerrero of RTC Branch 204 issued the warrant for the arrest of De Lima six days after the Department of Justice (DOJ) elevated criminal complaints against the senator and several others.

The charges, which include the sale and trading of drugs, were based on testimonies of high-profile convicts that De Lima allegedly profited from the drug trade at New Bilibid Prison during her time as justice secretary.

She has repeatedly denied the charges, and called the cases a retaliation from the "vengeful" President, with whom she has had a history of conflict.

As chair of the Commission on Human Rights, De Lima investigated Mr. Duterte's involvement in extrajudicial killings carried out by the Davao Death Squad during his time as Davao City mayor. She believes the administration is using the same tack to get rid of drug suspects even OFFICE OF THE ARM without proof of crime now that he is President.

While questioning the le-

gality of the arrest order, De Lima said she would not evade it.

"I have no intention to Malacanang said the court hide because I will face those move against the harshest cases," she said. "The fight goes on."

De Lima expressed surprise at the swiftness of the court move, pointing out that hearings on her motion to quash had been scheduled for Friday and that the DOI had even requested a postponement

#### Detention at NBP

Salvador Panelo, the President's chief legal counsel, did not offer an objection to De Lima's request to spend a night with her family before vielding to arresting officers.

"Let her rest tonight and meditate on her sins of omission and commission that brought her to the rot she is in," he said

'Hopefully, in her meditation she will come to the realization on the validity of the cardinal principle that what you sow is what you reap. She is now reaping the whirlwind of what she has sown," he added.

Justice Secretary Vitaliano Aguirre II said De Lima would probably be detained at the Muntinlupa city jail, noting that she did not want to be detained in a Philippine National Police jail.

Curiously, the DOJ panel that recommended the filing of charges against De Lima was headed by Senior Assistant State Prosecutor Peter Ong, a fraternity brother of Mr. Duterte and Aguirre in the Lex Talionis

Besides the senator, also named in the arrest warrant were former Bureau of Corrections chief Rafael Ragos and De Lima's former driver, Ronnie Dayan

"After a careful evaluation of the herein information and all the evidence presented during the prelimi-

investigation.., the narv court finds sufficient probable cause for the issuance of warrants of arrest against all the accused," Guerrero said in her order.

#### Caught flat-footed

News about the issuance of the arrest warrant came two hours after De Lima attended a hearing on the murder of Korean businessman Jee Ick-joo She immediately met her legal team in her office.

"We were surprised because what we know is that the judge had just returned from Macau today and there's supposed to be a hearing tomorrow," Ferdie Maglalang, De Lima's media officer, told reporters.

Aguirre said the issuance of the arrest warrant had been expected, as De Lima refused to present evidence in her defense during the preliminary investigation.

"She only relied on her legal points that the Ombudsman and not the DOI has jurisdiction over her case. That's a major blunder of De Lima and her lawyers," Aguirre said over the phone.

"Justice is working in our beloved nation," Speaker Pantaleon Alvarez said in a text message.

But colleagues in the Liberal Party rallied behind De Lima. "The Sandiganbayan, not the RTC, has jurisdiction over the case," said a statement issued by Senators Franklin Drilon, Pangilinan and Bam Aquino. -WITH REPORTS FROM DJ YAP AND CHRISTINEO, AVENDAÑO INO

# Lela ordered arrested

### No bail allowed

By EDU PUNAY and EMMANUEL TUPAS

A day before the courts were to hear her motions contesting the drug charges against her, Sen. Leila de Lima was ordered arrested by a judge who cited "sufficient probable cause" to issue an arrest warrant.

In a one-page order, Muntiplupa Regional Trial Court Branch 204 Judge Juanita Guerrero also ordered the arrest of De Lima's co-accused, former driver and lover Romnie Dayan and National Bureau of Investigation (NBI) deputy director Rafael Ragos

De Lima was in her fifth floor office at the Senate when news of the court's order broke yesterday. She emerged from the office at past 7 p.m. to face the press, then went home to prepare for detention.

Police went to her home to arrest her, but missed her as she returned to the Senate, where she spent the night.

Dayan was arrested at 7 p.m. at his home in Aplaya, Barangay Galarin in Urbiztondo, Pangasinan. He did not resist arrest.

In Davao City, President Duterte did not comment on De Lima's impending arrest when he addressed the Knights of Rizal

under Republic Act 9165, the Reynaldo Esmeralda and Ruel Comprehensive Dangerous Lasala, and Sebastian Drugs Act, are non-bailable.

The RTC judge said there was probable cause to proceed with the charges filed by the Department of Justice (DOJ) last Feb. 17 against the senator.

"After a careful evaluation of the herein information and all the evidence presented during the preliminary investigation conducted in this case by the Department of Justice, Manila, the Court finds sufficient probable cause for the issuance of warrants of arrest against the accused Leila de Lima, Rafael Marcos Ragos and Ronnie Palisoc Dayan," read the order.

The court issued the arrest warrant despite De Lima's pending motion for the dismissal of the charges and deferment of issuance of arrest order while judicial determination of probable cause is ongoing

De Lima is facing two other counts of drug cases before RTC branch 205 under Judge Amelia Fabros-Corpuz and branch 206 under Judge Patria Manalastas-De Leon

Her nephew Jose Adrian Dera is included in the second count in branch 205

The third count in branch 206 included former Bureau of Corrections chief Franklin Bucayu, his alleged bagman Wilfredo Elli, convict Jaybee Sebastian, De Lima's former bodyguard Jonel Sanchez, Dayan and Dera

Guerrero issued the arrest warrant at 4 p.m., a staff told The STAR over the phone.

As of 4:30 p.m., the sheriff who was to serve the warrant was out implementing another order not related to De Lima's case, Guerrero's staff said.

#### Day in court

Reacting to the arrest order on De Lima, presidential spokesman Ernesto Abella said she "will now have her day in court where she will have full opportunity to prove her claim of innocence '

Senior Insp. Lea Galvan of the CIDG-National Capital Region (NCR) earlier instructed the 16 police officers to wear the official CIDG shirt and six-pocket khaki pants. But an hour later, they were directed to change to general office attire as part of procedure in

serving warrants of arrest. Galvan said the deployment was based on verbal instructions from CIDG-NCR Senior Supt. Belli Tamayo.

#### Political persecution

Senators from the Liberal Party (LP) condemned what they called political persecution of a "brave administration critic" and expressed fears for her safety in detention

LP president and Sen. Francis Pangilinan and Senators Franklin Drilon and Paolo Benigno Aquino IV in a statement maintained that it was the Sandiganbayan, not the Muntinlupa RTC, that has jurisdiction over De Lima's three drug cases.

We heard that this judge (Guerrero) just came from Macau, and the motion to quash (the charges) was voluminous. She should read the motion first. The haste is deplorable,"

"We fear for Sen. Leila's life and security given what happened to Albuera mayor Espinosa and Korean businessman Jee Ick-joo, who were both killed inside police-controlled facilities," they said.

They described the arrest order as "purely political vendetta and has no place in a justice system that upholds

the rule of law." Moreover, the order was "condemnable" as they stressed that an arrest based on trumped-up charges is illegal.

They reiterated the Office of the Ombudsman has primary jurisdiction over cases against public officers "cognizable by the Sandiganbayan."

Violation of the Dangerous Drugs Act, which is the DOJ's case against De Lima, falls under "other offenses committed by public officials" listed in the Sandiganbayan Law, they maintained.

"We maintain that if this warrant of arrest is served, it would be a clear violation of legal proceedings and is therefore a violation of her Constitutional right to due process," they said.

Drilon said he was "saddened by what happened." He said his advice to De Lima is "we will avail of all the remedies under the law, including bringing these issues to the appellate courts."

Pangilinan, Aquino and LP ally Sen. Risa Hontiveros paid a visit to De Lima in her office at the Senate to show their

solidarity.

"This is an ugly episode. I hope she is afforded respect and given an opportunity to be with family members. I pray for her safety," Akbayan Rep. Tom Villarin said.

"She is a victim of political persecution as charges against her are trumped up. It demeans our sense of justice and fairness," he said.

Before news of her arrest came out, De Lima said she hoped to meet UN special rapporteur on extrajudicial, summary or arbitrary executions Agnes Callamard in Switzerland next month.

De Lima has an invitation to attend the 15th International Film Festival and Forum on Human Rights in Geneva, Switzerland on March 18.

"Your tireless advocacy of the respect of fundamental rights in your country has earned you the unanimous re-

spect and admiration of the human rights community'around the world," Isabelle Gattiker, director of the festival, said in a letter of invitation to De Lima.

The international film festival and forum on human rights is organized in collaboration with the UN Office of the High Commissioner for Human Rights and the Swiss Federal Department of Foreign Affairs

De Lima, if allowed to leave the country, will also have a chance to meet with Ruth Dreifuss, former president of the Swiss Confederation and chair of the Global Commission on Drug Policy.

De Lima filed Senate Resolution No. 153 urging the Department of Foreign Affairs to invite Callamard to look into the spate of extrajudicial killings and summary executions in the country

### **REDS VOW TO FREE 6** GOV'T TROOPERS SOON

DAVAO CITY—Communist in Davao Oriental province rebels in Mindanao on Thursday said they were finalizing the release of six soldiers, militiamen and a policeman in their custody even amid fighting on the ground

Joaquin Jacinto, spokesperson of the National Demotratic Frant of the Philippines (NDFP) in Mindanao, identified four of those set to be freed as Police Officer 2 Jerome Anthony Natividad, who was taken captive in Talakag town in Bukidnon province on Feb 9; Private First Class Edwin Salan, who was held in Alegria town in Surigao del Norte province on Jan. 29; and Sgt. Solaiman Calucop and Pfc Samuel Garay, who were nabbed in Columbio town in Sultan Kudarat province on Feb. 2.

Jacinto said two other captives would be released by the New People's Army (NPA) unit holding them. He did not name the captives but the NPA, on Feb. 14, abducted government militiamen Rene Doller and Carl Mark Nucos in Lupon town

"The respective regions will soon announce the details of the release of these aforementioned prisoners of war," Jacinto said.

He said the decision to release their captives was a "gesture of support for the resumption of formal talks between the [government] and NDFP."

In an earlier statement, Maj. Gen. Rafael Valencia, commander of the military's 10th Infantry Division, said President Duterte ordered the military to continue the offensive against NPA rebels even as efforts to rescue their captives were continuing.

Valencia said if NPA rebels were serious about talking peace, they should lay down their arms and stop their attacks on government troops and other targets.

Jacinto said the NPA's termination of its unilateral ceasefire was "necessary" because the military had not stopped its operations against the rebels. - ALLAN NAWAL INQ

## POWs to be released even as fighting continues — NDFP

AVAO CITY – The National Democratic Front of the Philippines (NDFP)-Mindanao has vowed it will release the prisoners of war (POWs) as a gesture of support for the resumption of peace negotiations with the government.

In an NDFP statement released yesterday, NDFP-Mindanao spokesperson Joaquin Jacinto said they will release the POWs "even as fighting continues in the field."

To be released are: PFC Edwin Salan, captured in Alegria, Surigao del Norte on January 29; Sgt. Solaiman Calucop and Pfc Samuel Garay, captured in Columbio, Sultan Kudarat on February 2; PO2 Jerome Natividad, captured in Talakag, Bukidnon on February 9; and two alleged "paramilitary" members Rene Doller and Carl Mark, both captured in Lupon, Davao Oriental on February 14

"The respective regions will soon announce the details of the release of these aforementioned prisoners of war," he said

He said that they encouraged the GRP to heed the call of the Filipino people "for the resumption of formal talks with the NDFP despite the absence of any ceasefire agreement."

He added that President Rodrigo R. Duterte, should not ignore the clamor for genuine agrarian reform and national industrialization.

"If genuine agrarian reform and national industrialization are carried out to the satisfaction of Filipino peasants, workers and national minorities, millions will surely benefit and significantly improve their lives," he said.

"Both the GRP and the NDFP owe it to the Filipino masses, at the very least, to continue to buckle down in significant dialogue and thresh out, and possibly agree on means to eradicate the very roots of

armed conflict in the country, which are feudal exploitation, US imperialist domination and bureaucrat-capitalism," he added.

He explained that the Communist Party of the Philippines, New People's Army, and National Democratic Front (CPP-NPA-NDFP) lifted its bilateral ceasefire due to the non-release of the more than 400 political detainees and the continuous violations of the Armed Forces of the Philippines and Philippine National Police (AFP-PNP) who they claimed "occupied hundreds of communities in both cities and the countryside in Mindanao and the rest of the country" in the guise of military and police operations

"In this context, the NPA, in active-defense mode, was only duty-bound to launch offensives against operating AFP/PNP troops in order to defend these communities from state-sponsored atrocities," he

### Top NPA leader captured in Batangas

A top leader of the communist New People's Army (NPA), tagged in large scale extortion activities and atrocities in Southern Tagalog region including the raid at the posh Hamilo Coast-Pibo de Loro, was captured by military troops in Batangas.

Maj. Gen. Rhoderick Parayno, commander of the 2nd Infantry Division (ID), identified the arrested NPA leader as Ernesto Samarita, alias Mel, secretary of the NPA's Guerilla Unit-3, Southern Tagalog Regional Party Committee, and head of the finance committee STRPC.

Samarita is believed to be an alternate member of the Communist Party of the Philippines

(CPP) Central Committee operating in Cavite, Batangas, Laguna and Central Quezon province.

He is the third highest in the NPA's Southern Tagalog Regional Committee and headed the Tactical Center of the 2nd Congress of the CPP's Central Committee held in Mindanao only last January

The military tagged Samarita in large scale extortion activities by the NPA in Southern Tagalog region, including the raid at the posh Hamilo Coast-Pico de Loro resort in Barangay Papaya, Nasugbu.

Parayno said that Samarita was arrested by elements of the 730th Combat Group of the Air Force while on combat operation along Barangay Munting Indang in Nasugbu at around 3 a.m. on Tuesday.

"The troops noticed a relitor detonating cord, which is an explosive part or component, protruding from the unzipped part of the belt bag that the subject was wearing," said Capt. Xy-zon Meneses, information officer of 2nd ID

"When asked why he is in a possession of an explosive detorming cord, instead of answering, he this back and tried to escape. However, he was ably prevented by the troops." he added.

A high-ranking leader of the communist New People's Army (NPA) who led numerous atrocities and large scale extortion in Southern Tagalog Region has been captured by government troops Tuesday in Batangas City.

Ernesto Samarita alias "Mel" Secretary of the Sub-Regional Military Area-Guerrila Unit 3 (SRMA-GU3), Southern Tagalog Regional Party Committee) was nabbed during a combat operation by a section of the 730th Combat Group of the Philippine Air Force (PAF) Barangay Munting Indang, Nasugbu, Batangas.

Samarita, who is also the head of the Regional Finance Staff of the STRPC, and Alt Central Committee member operating in the areas of Cavite, Batangas, Laguna, and Central Quezon, was initially stopped for acting suspiciously in the wee hours Tuesday.

The troops noticed a roll of detonating cord, which is an explosive part or component, protruding from the unzipped part of the belt bag that the subject was wearing.

When asked why he is in a possession of an explosive detonating cord, instead of answering, Samarita turned his back and tried to escape but was subsequently prevented by authorities from fleeing.

Samarita was turned over to authorities in Barangay Munting Indang, which has jurisdiction over the place where the subject was arrested.

Samarita is third highest in the Komiteng Rehiyon Timog Katagalugan and headed the Tactical Center of the 2nd Congress of the Komiteng Sentral held in Mindanao in January 2017.

He is also believed to be an Alternate Member of the Central Committee of the Communist Party of the Philippines.

### Govt forces in Bulacan on alert following NPA sightings

From the Philippine News Agency (Feb 23): Govt forces in Bulacan on alert following NPA sightings

Government forces in this province, particularly those assigned in the north eastern part of Bulacan, are on alert following confirmed sightings of band of New People's Army (NPA) guerrillas in Dona Remedios Trinidad town and in the mountains of Umiray, Aurora which is close to the mountain town of Norzagaray, Bulacan.

Bulacan acting police director Senior Supt. Romeo Caramat Jr., made this disclosure during the Peace and Order Council (PPOC) meeting held at the Hiyas Convention Center here on Thursday morning.

Caramat told PPOC chairman and Gov. Wilhelmino M. Sy-Alvarado and Vice Gov. Daniel Fernando that <u>a</u> <u>band of NPA rebels were first sighted in the mountain village of Kabayunan, Dona Remedios Trinidad on Feb. 7.</u>

He said that based on intelligence reports and sources that was verified by the <u>48th Infantry Battalion of the Philippine Army under the command of Lt. Col. Ramil Anoyo, the communists guerrillas were on procurement missions.</u>

He said the rebel band bought dresses, combat boots, 100 bullet rounds of M203 grenade rifle and 10,000 rounds of M16 rifles.

Alvarado said both the police and military should be vigilant since Bulacan has already been declared insurgent -free by the Philippine Army in 2013, during the time of AFP chief Gregorio Pio Catapang.

He also said that while no violent incidents have been reported for so many years now, the government troops assigned in Bulacan must always remain on alert and vigilant because the anniversary of the NPA will take place next month and they might do some surprises in the province.

### Leyte, Samar remain peaceful amid halt in peace talks with Reds

From the Philippine News Agency (Feb 23): Leyte, Samar remain peaceful amid halt in peace talks with Reds

The Philippine Army reported that Eastern Visayas region remained peaceful despite the termination of peace talks between the government and communist rebels.

Army's 8th Infantry Division commander Brig. Gen. Raul Farnacio said Leyte and Samar provinces have been spared by recent atrocities of the New People's Army (NPA).

Farnacio attributed the situation to the fact that one of the key rebel leaders in the region is a priest, who is also searching for genuine peace. The official is referring to Fr. Santiago Salas, the National Democratic Front (NDF) Eastern Visayas spokesperson.

"Fr. Salas adheres to the peace agreement of the negotiating panel and there is a big chance that they are really pursuing peace, once and for all," he said.

"I believe that he is aware of the consequence that warring parties had brought to the region, especially to worsening poverty incidence in Samar provinces."

Farnacio noted that even in Western Visayas where rebels are led by a priest, there are no atrocities as well.

Although there were reported tactical moves by rebels, the official said no violence had been perpetrated by communist rebels recently unlike in other parts of the country where there are attacks, abduction of soldiers, and burning of equipment.

Recently, three NDF leaders in the region have conveyed their intention to continue with the peace talks.

Samar provinces have been a stronghold of armed rebels due to its terrain consisting of densely forested mountainous areas, high poverty incidence, and issue of widespread landlessness, according to a 2013 study of William Norman Holden of the University of Calgary in Canada.

Since the early stages of the rebellion, Samar Island has been considered to be a rebel stronghold with 11 percent of all NPA-related incidents having taken place in the three provinces, the same study revealed.

The NPA launched its first tactical operation in the country in Calbiga, Samar in 1974, when it ambushed an army scout patrol and seized a number of their weapons.

### Military receives 2 leased JP planes

TWO Japanese reconnaisance aircraft transferred to the Philippine government are expected to upgrade the Southeast Asian country's surveillance capability over its long coastline, particularly in the hotly-contested reefs and shoal in the West Philippine Sea.

Navy Flag-Officer-in-Command Vice Admiral Ronaldo Joseph Mercado revealed the impending arrival of two TC-90 reconnaissance aerial aircraft during fellowship night with the Defense Press Corps aboard BRP Andres Bonifacio birthed at Pier 13 South Harbor Wednesday.

Mercado said the 2 TC-90 aircraft from the Japan Maritime Defense Force were scheduled to arrive on March 27 this year, the first batch of the five to be delivered to the Philippine government as part of the countries' bilateral defense booperation:

"Yes, it will boost our capability on aerial reconnaissance, particularly on maritime surveillance," Mercado said.

Mercado said the 2 TC-90 in the Air Force inventory would eventually be utilized not only for surveillance purposes, but would also hasten humanitarian assistance and could ferry limited cargoes and personnel for maritime use as well

The Philippines has 36,289 kms coastline, longer than Australia's 25,760 kms and Japan's 29,751 kms but shorter than Russia's 37,653 kms.

Navy spokesman Capt. Lued Lincuna also said the three TC-90s would be transferred to the Philippine Navy hopefully at the end of the year.

Lincuna said the Japanese surveillance plane would supplement the existing Norman-Britten BN-2 Islander fleet in its maritime missions.

# AFP in all-out drive vs Abu Sayyaf, IS cohorts

O many issues demand the new administration's attention but it must not lose sight of one problem that lies at the center of peace and development in Mindanao – the jihadist groups trying to establish an Islamic State (IS) base in the southwestern part of the island.

Military sources said the core group is the Abu Sayyaf, which has been joined by dozens of Indonesians, Malaysians, and Arabs from the Middle East. Two weeks ago, the Armed Forces, in an artillery attack followed by gunbattles on the ground, engaged the group in an area near Butig, Lanao del Sur, and one Indonesian was reported killed.

Military operations are now underway in Basilan, Tawi-Tawi, and Sulu, Gen. Eduardo Ano, chief of staff of the Armed Forces of the Philippines (AFP), said. Fourteen battalions of government troops are engaged in a search-and-destroy campaign. The AFP, he said expects to defeat the Abu Sayyaf in six months.

For years the Abu Sayyaf has carried out its operations in Mindanao, kidnapping many foreigners, holding them for ransom, and beheading them if their families fail to deliver Only a few days ago, the Abu Sayyaf came out with a video

showing a German hostage, vowing to kill him if P30-million ransom is not paid by February 26.

The video showed the German, Jurgen Kantner, pleading for his life, in the same way previous foreign hostages had pleaded for their lives. Two Canadians – John Ridsdel and Robert Hall – were killed in April and June, 2016, seven months after they were kidnapped from a resort island in the Davao Gulf. Their companions – a Filipina and a Norwegian – were freed soon afterwards and police sources said the Abu Sayyaf got \$\mathbb{P}30\$ million for the Norwegian.

The February 26 deadline is just two days away. We will soon know if the military campaign against the Abu Sayyaf and its jihadist allies from Indonesia, Malaysia, and the Middle East has them on the run after two months of operations. Or shall we have another foreign victim of the Abu Sayyaf, who continue to defy all efforts to eliminate them and are even gaining adherents from various parts of the world?

We continue to hope that the Armed Forces with its 14 battalions will be able to force the Abu Sayyaf and their jihadist cohorts out of their bases in Mindanao. We cannot allow the Philippines to be the next site of Islamic State operations after Syria and Iraq.

THE situation has changed in the on-again. off-again peace negotiations between the Philippine government and the Communist Party of the Philippines (CPP). New People's Army, and the National Democratic Front of the Philippines (NDF).
