



# RAQ DECLARES VICTORY DVER IS GROUP IN MOSUL

lragi prime minister congratulates 'heroic fighters' as defeated Islamic State jihadis fiee across Tigris River.

MOSUL, IRAQ—Iraqi Prime Minister Haider al-Abadi declared victory in the "liberated" city of Mosul on Sunday, his office said, after a grueling nearly nine-month battle against the Islamic State (IS) group.

Abadi arrived "in the liberated city of Mosul" and congratulated "the heroic fighters and the Iraqi people on the achievement of the major victory," his

office said in a statement.

A photo on Abadi's official Twitter account showed him dressed in a black military uniform and cap as he arrived in Mosul to announce the recapture of

The fighting did not seem to be completely over yet, with gunfire still audible in Mosul and airstrikes hitting the city around the time the premier's office released the statement.

Iraqi forces launched the Mosul operation in October last year, first fighting their way to the city, retaking its east and then assaulting its western side, where some of the heaviest fighting occurred.

The battle has taken a heavy toll on civilians, pushing more than 900,000 people to flee their homes, only a frac-

tion of whom have returned, according to the United Nations.

And security forces have also suffered heavy losses, with thousands killed and wounded, though official casualty figures have not been released by Iraqi authorities.

IS overran large areas north and west of Baghdad in 2014, but Iraqi forces backed by US-led airstrikes have force in the Old City of Mosul

since regained much of the territory they lost.

Earlier on Sunday, IS militants threw themselves into the Tigris River, trying to flee the battlefield in Mosul as they faced imminent defeat by Iraqi forces fighting to dislodge them from their last pocket in the city.

A US-trained elite Iraqi

reached the Tigris riverside, state TV said, indicating that the insurgents' last redoubt was on the verge of falling.

After eight months of combat that had ruined parts of the city, killed thousands of civilians and displaced nearly 1 million people, Iraqi officials said victory was close.

The militants had been driven from all but a patch of territory on the western bank of the Tigris bisecting Mosul, where they had staged a last stand in the narrow alleys of the Old City.

#### Decaying corpses

Plumes of smoke rose over the Old City on Sunday and the decaying corpses of IS fighters lay in the streets.

Scattered bursts of gunfire could be heard and several airstrikes were carried out.

Brig. Gen. Yahya Rasool, spokesperson for the Iraqi military, told state TV earlier on Sunday that 30 militants had been killed attempting to get away by swimming across the Tigris.

Later, Iraqiya News ran an on-screen headline saying: "Forces from the Counter Terrorism Service raised the

Iraqi Special Forces were still fighting a few hundred meters away.

Nizal's soldiers danced to

patriotric music atop tanks even as airstrikes sent plumes of smoke into the air nearby.

IS vowed on Saturday to fight to the death" in Mosul.

State television quoted a military spokesperson on Saturday as saying the insurgents' defense lines were collapsing.

"We are seeing now the last meters and then final victory will be announced," a presenter said, citing correspondents embedded with security forces fighting in IS redoubt in the Old City by the Tigris.

#### Female suicide bombers

Cornered in a shrinking area of the city, the IS fighters had resorted to sending female suicide bombers among the thousands of civilians who are emerging from the battlefield wounded, malnourished and fearful.

The battle has also exacted a heavy toll on Iraq's security forces.

The Iraqi government does not reveal casualty figures, but a funding request from the US Department of Defense said the Counter Terrorism Service, which has spearheaded the fight in Mosul, had suffered 40-percent losses.

The United States leads an international coalition that is back-

ing the campaign against IS in Mosul by conducting airstrikes against the militants and assisting troops on the ground.

The US Department of Defense has requested \$1.269 billion in US budget funds for 2018 to continue supporting Iraqi forces:

Without Mosul—by far the largest city to fall under miliatant control—the IS dominion in Iraq will'be reduced to mainly rural, desert areas west and south of the city where tens of thousands of people live.

It is almost exactly three years since the ultrahardline group's leader Abu Bakr al-Baghdadi proclaimed a "caliphate" spanning Syria and Iraq from the pulpit of the medieval Grand al-Nuri mosque.

#### **End of IS**

Abadi declared the end of the IS group's "state of falses hood" a week ago, after security forces retook the mosque—although only after retreating militants blew it up.

The recapture of Mosul does not, however, mark the end of the threat posed by IS, which holds territory elsewhere in Iraq and is able to carry out frequent bombings in government-held areas.

The militants are expected to revert to insurgent tactics as they lose territory.—REPORTS FROM AFP, AP AND REUTERS

# Congress seen to back martial law extension

Members of the two chambers of Congress are expected to support an extension of martial law in Mindanao in case Malacañang asks for it.

Senators and congressmen said they would ask for security briefings on the situation in Marawi, but would likely support the Duterte administration in its decision.

Malacañang also does not see any hindrance should President Duterte decide to extend martial law in Mindanao beyond the 60-day period after the Supreme Court (SC) ruled there was factual basis for the proclamation.

Senators expect that a request from the President to extend the imposition of martial law in Mindanao will easily hurdle Congress, which is dominated by his allies.

Based on the constitutional limit of 60 days, martial law Turn to Page 14 will lapse on July 23, a day before Duterte's second State of the Nation Address (SONA)

Presidential Communications Operations Office (PCOO) Secretary Martin Andanar yesterday expressed belief there would be no difficulties in the event that the President sees the need for an extension of martial law.

"It depends on when the conflict in Marawi will end. I think it will see its end. But if it is not yet finished. The declaration of martial law was supported by Congress and the judiciary." Andanar told radio station dzBB

"All co-equal branches of government were one in saying that the martial law in Mindanao was justified. I think if there is a need to extend it, there will be no problems," he added:

On Saturday, Duterte hinted that he might seek an extension of martial law as government forces continue to battle Maute militants in Marawi.

Duterte declared martial law in Mindanao on May 23 after the Islamic State-aligned Maute terrorists launched attacks in Marawi City, burning several structures and holding hostage more than a dozen people. Under the 1987 Constitution, the President can declare martial law if warranted for 60 days and inform Congress within 48 hours the justifications for it.

Any extension of the declaration should be done with the consent of the Senate and the House convening jointly.

Officials could not give a categorical answer when asked whether the President would ask Congress to extend martial law, saying it would depend on the assessment of the military.

Andanar claimed that martial law in Mindanao, which has sparked fears of human rights violations, has the support of a majority of Filipinos.

"Almost all Filipinos support the declaration of martial law because people want peace in the land," he said

"It showed that the President does not hesitate to act if it is for the benefit of our countrymen," Andanar added.

### ML extension backed

Duterte's allies in Congress have approved resolutions expressing support for martial law and rejecting calls from the opposition to hold a joint session to review the basis of

the proclamation.

Senate President Aquili-Leader Vicente Sotto III earlier sought another closed-door on the situation in Marawi City before Duterte's Proclamation 216 expires

"We want to be briefed so that we'll have a better grasp and understanding of the situation on the ground in Marawi," Sen Joseph Victor

Ejercito said

But since there have been no atrocities or any human rights violations committed since the imposition of martial law, it will be easier to justify an extension if needed," he said

Sotto said "if the situation so warrants" the two chambers would agree to extend martial law.

Sen. Francis Escudero said as much: "If they show that the problem is still subsisting, and martial law is still needed to address it."

Sen. Panfilo Lacson, who chairs the Senate committee on public order and safety, said while the lawmakers' decision would largely depend on how the security officials will present their case to Congress, Duterte has "an overwhelming number of allies" in both Houses

Pimentel earlier said the 23-member Senate and the House with 296 members would vote once they convene injoint session to deliberate on the extension

Sen, Gregorio Honasan, chairman of the Senate committee on national defense and security, said any "rational informed policy decision (of Congress) must be based on complete, accurate and timely information."

Sotto, Ejercito and Sen. Richard Gordon said last week they were inclined to support an extension, especially after the high court upheld the

proclamation. Sotto and Ejercito, however, said it might be better if the scope of the extension was limited, for example, to Lanao del Sur where Marawi City is located.

Pimentel and Gordon earlier informs Congress of his intention to extend martial law.

Gordon suggested that Duterte make a formal justification of his extension when he delivers his SONA before the joint session of Congress at the opening of the second regular legislative session on July 24.

Senate Minority Leader Franklin Drilon earlier suggested that Duterte inform Congress of his intention to extend martial law.

Since Congress will be in joint session on July 24, Drilon suggested that instead of adjourning after the SONA, lawmakers continue the session to deliberate on the request for possible extension.

Drilon said even if there could a gap of a day or a few days from the expiry to the time Congress makes its decision, another martial law proclamation is still considered an extension.

"To me, to avoid any constitutional issues—this is a case of first impression, as it has never happened before. I think the President will lose nothing if before July 22 he sends a notice to Congress that he wants to extend martial law for whatever reason," he said. Escudero earlier said the

possible gap is not an issue as government troops will still be in Marawi City rooting out the Maute terrorists.

"I have always been against setting deadlines that may endanger the lives of our soldiers just for the sake of meeting the deadline set," Escudero said.

Allies of the President in the House of Representatives also expressed support for an extension of martial law

"The Marawi conflict left more than 400 people dead and damaged buildings and infrastructure. So I support the extension of martial law," Surigao del Sur Rep. Johnny Pimentel, chairman of the House committee on good government and public accountability, said.

House Minority Leader Danilo Suarez of Quezon province echoed Pimentel's statement

"I think the situation in Marawi is far from being normal. An extension of the martial rule may be in order," Suarez said.

Andanar said the government is praying that the Marawi crisis would end soon, noting that the rehabilitation can only start once the security threats are addressed.

# 2 Filipinos kidnapped by ASG recovered alive

SHARIFF AGUAK, Maguindanao: The Anti-Kidnapping Group, the Sulu Provincial Police Office and the 501st Brigade under the Joint Task Force (JTF) Sulu recovered alive two kidnap victims at Daang Puti, Patikul, Sulu on Thursday afternoon, a military official said on Sunday.

Capt Jo-ann Petinglay, spokesman for the Western Mindanao Command (West-MinCom) said Reyjim Rocabo, 41, a mechanic, and Roel Leones, 37, a crew—both from Tukuran, Zamboanga del Sur—were on board a motorcycle when intercepted and recovered by government forces.

Upon verification, the two said they were kept under the custody of a certain Ben Tatoo and Almujer Yaddah during their captivity along with some other kidnap victims, Petinglay added.

Rocabo and Leones are crew of FB Ramona 2 who were forcibly taken by the Abu Sayyaf Group (ASG) along with two other boat crew last December 20, 2016 on the high seas of the Celebes.

Abducted with Rocabo and a Leones were Noel Besconde, boat captain, and Roy Borja Ramos, also a crew

On April 13, after more than three months in captivity, Besconde was beheaded by the group of Abu Sayyaf Group sub-leader Almujer Yadah at Sitio Pantay Minol, Barangay Tanum, Patikul, Sulu.

On June 8, Roy Borja Ramos, was rescued by government forces at Barangay Lagtoh, Talipao, Sulu after he was able to escape his captors in Patikul area two days before

"Rocabo and Leones are now under the custody of the Anti-Kidnapping Group and will eventually be turned over to their families after actionable information is taken from them," Brig Gen Cirilito Sobejana, JTF Sulu commander, said.

"As we speak, follow-up operations, in coordination with the Sulu police, are ongoing for the possible rescue of the other kidnap victims," Sobejana added.

"We call on the people of Suluto continue helping us in this endeavor. A peaceful and progressive community will never be achieved if we will not take a strong stand against these local terrorists," the ITF Sulu commander said.

"Every one of us is part of the solution, we must join the fight and help save our communities," Sobejana added.

Twenty kidnap victims remain in the hands of the Abu Sayyaf Group, a terrorist band affiliated with the Islamic State or IS

Of the 20, 16 are foreigners and four are Filipinos, according to Sobelana.

## 2 BOAT CREW MEMBERS FREED FROM SAYYAF

ZAMBOANGA CITY—Two kidnapped crew members of a fishing boat were rescued, in Patikul, Sulu province, on Friday, the military said.

Capt. Jo-Ann Petinglay, spokesperson of the Western Mindanao Command, said members of the Anti-Kidnapping Group, the Sulu provincial police office and the Army's 501st Brigade rescued Reylim Rocabo, 41, and Roel Leones, 37, both from Tukuran, Zamboanga del Sur province.

The rescuing team was under Joint Task Force Sulu, a multiagency group that is focused on preventing and solving kidnapping cases.

Rocabo and Leones were crew members of FB Ramona 2. They and two others had been taken captive by Abu Sayyaf bandits on Dec. 20 off Gelebes Sea.

The captain of the boat was beheaded on April 13, or after more than three months in captivity.

Another crew member, Roy Ramos, escaped from his captors on June 8.—JULIES. ALI-PALA INQ

# NPA REBELS RETURN VALUABLES SEIZED FROM COPS, DRIVER

ILOILO CITY—Communist rebels turned over to employees of an Iloilo radio station personal items that the rebels seized in last month's raid on the police station of Maasin town in Iloilo.

A group of rebels, who introduced themselves as members of the New People's Army (NPA) Napoleon Tumagtang Command, on Friday handed over two laptops to two Bombo Radyo Iloilo employees.

John Talento, assistant station manager, said the rebels had arranged a meeting at a hinterland village in Iloilo where the laptops were turned over.

The rebels told Talento that they returned the items because these were personal belongings of Maasin policemen.

They asked the radio station employees to facilitate the return of the laptops to their owners

Talento said the radio station employees had proceeded to the headquarters of the Iloilo provincial police office in Santa Barbara town and turned over the laptops.

The laptops were among items taken by at least 60 rebels who raided the Maasin police station on June 18.

Policemen on duty were un-

harmed but the rebels took 15 firearms, including 11 M-16 rifles and four hand guns, ammunition and radio sets among others.

The Philippine National Police will use the two laptops as evidence in the criminal complaints filed against suspected rebels who took part in the raid, according to a statement of the Western Visayas Police Office.

Those charged included leaders of the NPA's Southern and Central Fronts in Panay.

In a separate turnover on Saturday, a group of NPA rebels, who introduced themselves also as members of the Napoleon Turnagtang Command, handed over to two reporters of RMN Iloilo personal belongings and cash of Charles Paconsis.

Paconsis was the driver of the van that the rebels commandeered and abandoned in San Miguel town on June 15 or three days a before the raid.

Unidentified persons who later turned out to be rebels had arranged to hire the van driven by Paconsis.

Paconsis escaped from the rebels and reported the attack to police.

Wilfredo Talaron, one of the RMN Iloilo reporters who met with the 40 rebels on Saturday, said the rebels admitted that they had intended to use the van during the raid on the Maasin police station.

They told Talaron and fellow reporter Ralph Mosqueda that they took Paconsis' bag for "safekeeping."

The rebels handed over bottles of perfume and cologne, two mobile phones, an asthma inhaler, a power bank and bills and coins.

They also gave P7,000 which they said was the "rental fee" for the van

The reporters turned over the cash and items to the San Miguel police station.

Talaron said the rebels asked for permission to blind-fold the radio employees before they were taken to the site of the turnover. INQ

**OUSE** Speaker Pantaleon Alvarez wants martial law in Mindanao to stay until 2022 or until President Rodrigo Duterte steps down.

The period of martial law is limited to 60 days by the Constitution, and can only be extended by Congress.

In the Senate, the majority bloc said they see an easy approval of an extension of martial law in Mindanao should the President request it.

"The main issue here is [whether] he President had enough informaion to declare martial law in the vhole of Mindanao, particularly on the [existence of] rebellion. That s the focal point here because the upreme Court, in its ruling, said hat it is not important whether the resident's information is true or nough," Baguilat said

"The Supreme Court should xplain why it found enough rounds to say that there is rebelion in Mindanao and, thus, the reed to declare martial law. As far is we are concerned, the declaraion based on rebellion [is] based on scant, if not false information,"

Baguilat added.

Duterte declared martial law pposition lawmakers, petitioners and the suspension of the privilege of the writ of habeas corpus in Mindanao on May 23 through Proclamation 216, in response to the siege of Marawi City by memhers of the Maute Group.

> The lawmaker said he was taken aback when the ruling upheld the declaration of martial law over the entire island of Mindanao and not just in Lanao del Sur province, where government troops are locked in an armed conflict with the Islamic State-linked Maute group

> "Had the martial law been limited to Lanao del Sur, we can live with that. And so we were surprised that the entire declaration was deemed legal. If the martial law declaration in Mindanao is baseless, then the Supreme Court could void the martial law declaration in Mindanao and limit

it to Lanao del Sur instead," he maintained

Baguilat added, "We can't give up on this because there are a lot of points in the ruling that can be contested under the [motion]. A lot of people are emotional because we want to defeat Maute, and so there is this supposed need to declare martial law. But we have. to explain to our people that declaring martial law is not simple as that and eradicating terrorism or quelling military uprising can be addressed with regular presidential authority."

He stressed that the President should not be authorized to declare martial law based on false information.

"Let's go back to the start. This Marawi incident happened because there was an unsuccessful military operation aimed at atresting Isnilon Hapilon who is the Maute leader. There was no statement on Maute's part that they want to take Marawi or Lanao off Philippine territory. Given such, there's no rebellion there," the lawmaker said.

The martial law proclamation in Mindanao will end on July 22.

#### Senators open to extending martial law

Some senators expressed belief on Sunday that President Duterte

would not have difficulty in getting Congress' approval to extend martial law in Mindanao.

Senate Majority Leader Vicente Sotto 3rd said he would not object to a martial law extension as long as the situation warranted such move

Sen. Francis Escudero said the Executive branch must show that the problem was still subsisting and that martial law was still needed to address it.

For Sen Joseph Victor "JV" Ejercito, it would be better if senators would again be briefed by security officials on the situation in Marawi, to get a better grasp and understanding of the situation on the ground

# Congress open to ML extension

Congress appears receptive to President Duterte seeking an extension of martial law in Mindanao if prior to the lapse of the 60-day limit on the extreme Executive measure under the Constitution.

Senators said they do not see any impediment in granting Mr. Duterte's request extending the implementation of martial law even after the 60-day period expires two weeks from now or on July 23 when Mr. Duterte delivers his second State of the Nation Address (Sona).

"It will largely depend on how

the security officials of the government will present their case to the Congress, notwithstanding the overwhelming number of allies the President has in both Houses," Sen. Panfilo Lacson said which was a view echoed by Majority Leader Vicente Sotto III.

Amid talks of possible xtension of the martial law roclamation, a number of senators are pressed for another round of prieting with security and defense fficials to assess the situation and secretain the need for its continued mposition in Mindanao or limit its icope only in Marawi City.

House Majority Leader Rodolfo Fariñas said he will also support Mr. Duterte if he decides to extend martial law in Mindanao.

"If the President requests Congress to extend his proclamation or suspension on the ground that the rebellion is still persisting and public safety requires it, I shall support him," Farinas said in a statement.

"Pres. Duterte has shown that he is true to his oath to support and defend the Constitution, and our people continue to express their trust and confidence in him." he added.

Under the 1987 Constitution, "upon the initiative of the President, Congress may, in the same manner, extend such proclamation or suspension for a period to be determined by the Congress, if the invasion or rebellion shall persist and public safety requires it."

#### Plea for extension anticipated

This early, however, some senators admitted that they're anticipating the possible extension of martial law after the 60-day

period of implementation expires on July 22.

"We want to be briefed so that we'll have a better grasp and understanding of the situation on the ground in Marawi," Sen. JV Ejercite said in a text message to reporters.

Ejercito shared the call for the conduct of another round of briefing first broached by Minority Leader Franklin Drilon and Sen Win Gatchalian last week.

The need for it was also called by Sen. Sonny Angara especially if Duterte will request for an extension.

We will ask for a briefing from the military which is what we also requested for after the initial proclamation and then we take it from there," Angara said.

Sen. Gregorio Honasan, chairman of the Senate committee on national defense and security, echoed the need for such a briefing saying that any rational and informed policy decision must be based on complete, accurate and timely information.

"It all depends on the most current comprehensive, consolidated report from the martial law administrators, local governments and coordinated agencies on the ground," he added

Ejercito and Sen. Francis "Chiz" Escudero said any such request will likely breeze through if security and defense officials can prove that the armed conflict is still subsisting and martial law is still needed to address it.

"But since there have been no

atrocities or any human rights violations committed since the imposition of martial law, it will be easier to justify the extension if needed," Ejercito said.

#### Strong public support

A latest Social Weather Stations survey showed that Duterte got a record-high public satisfaction rating after his declaration of martial law in Mindanao, which had been upheld by the Supreme Court (SC).

Congress and the SC have also both ruled that Proclamation 216 which imposed martial law in Mindanao was in accordance with the Constitution.

"The imposition of Martial Law is an act of the Commander-in-Chief, subject to its revocation by the Congress and review by the SC of the sufficiency of its factual basis," Fariñas said.

The SC last July 4 upheld Mr. Duterte's proclamation, dismissing the consolidated oppositions filed by a group of opposition congressmen led by Albay Rep. Edcel Lagman, activists and militant lawmakers, and four women residents of Marawi City.

"We should all support him, as well as the Armed Forces of the Philippines, the Philippine National Police and all government authorities in alleviating the sufferings of our people in Mindanao," Fariñas said.

Sotto expressed the view that if martial law is extended, it should be limited to Lanao del Sur and not the entire Mindanao while Ejercito the extension should be "not too long" and that

they can "crush the Maute group in the period they are asking for" suggesting an extension of not more than two months.

Speaker Pantaleon Alvarez expressed a personal view the other day to extend martial law until the end of the term of Mr. Duterte in 2022 but which was a proposal that did not sit well with other legislators.

"If they can guarantee that they can finish operations in a month or two we can grant it. I'm inclined to vote for it," Ejercito said.

The senator also noted that there were no reports of abuses or atrocities committed by members of the Armed Forces of the Philippines (AFP) for the duration martial law was declared.

Defense Secretary Delfin Lorenzana said the Duterte administration needed a couple more weeks to determine whether they would recommend an extension of the implementation of Martial Law in Mindanao.

"We will know in a couple of weeks time, after that we will make our recommendations (as) we are still studying the situation in Marawi, Lanao Del Sur and therest of Mindanao," Lorenzana said in Filipino.

Lorenzana also refused to comment on whether fighting in Marawi City before Duterte's first State-of-the-Nation-Address (SONA).

"We would like that to happen but we are leaving it to the ground commanders to do their pace, we are not micromanaging the events there, " the DND chief stressed."

# MARTIAL LAW EXTENSION NEXT LOOKOUT FOR MINORITY

A lawmaker from the opposition "Magnificent Seven" bloc has raised the possibility that the House of Representatives might extend martial law in Mindanao in time for President Duterte's delivery of his State of the Nation Address (Sona) on July 24.

Since the Sona coincides with the first day of the second regular session of the 17th Congress, it was possible the chamber, dominated by Duterte allies, would present such a resolution, according to Ifugao Rep. Teddy Baguilat Jr

The 60-day martial law proclamation is effective until July 22.

"On July 24, we will have the joint session. Right before Sona, they might present the resolution extending martial law. We should be prepared for that," Baguilat said in a radio interview on Sunday.

Baguilat's statement came as the Armed Forces of the Philippines continued to assess if martial law needed to be extended amid continuing clashes with the Maute group in Marawi City.

#### Speaker's preference

Speaker Pantaleon Alvarez told the Inquirer on Saturday that "if I can convince my colleagues, I will push for an extension until 2022, because two months is too short."

Baguilat said the opposition bloc would likely file again another petition in the Supreme Court if martial law was extended.

On July 4, the Supreme Court issued a landmark decision upholding the factual basis of Mr. Duterte's proclamation of martial law, and his presidential prerogative in deciding the scope of its coverage.

Baguilat said it would be a "suntok sa buwan" (a long shot) to seek a reversal of the July 4 ruling.

Even as the 60-day limit looms, the Magnificent Seven will still file a motion for reconsideration to appeal the ruling this week

Baguilat, however, said he would rather focus on fighting the possibility of an extended martial law.

"I was the one who said, let's not pursue a motion for reconsideration. Let's just concentrate on the possible extension of martial law," Baguilat said. INQ

President Duterte will meet with senators from the majority bloc a week before Congress opens its second regular session on July 24.

Asked about the agenda of the meeting with the President, Senate Majority Leader Vicente Sotto III said apart from the legislative agenda and Mr. Duterte's second State of the Nation Address (Sona) on July 24, it would likely touch on the assessment of the ongoing government operations to retake Marawi City from the Maute group and the Abu Sayyaf

# AFP: Hostages killed for not taking up arms

MARAWI CITY—Islamic State S)-inspired terrorists have illed at least six hostages for, efusing to take up arms against overnment forces, the military aid on Sunday.

Lt Col Christopher Tampus, ommander of the military's 1st ifantry Battalion, told reorters the military learned bout the executions from three ostages who escaped from neir captors on June 29.

"That's what the gunmen inde are doing. They are forcing ieir hostages to take up arms gainst our troops," Tampus said.

"We talked to three hostages, and that's what they relayed to s," he added.

The hostages were firing at oops patrolling Lake Lanao, e said

• "They were forced to do that. Six of the hostages were shot and killed in front of them, that's why they can't do anything but follow the orders given to them," Tampus said.

#### **Atrocities**

The escapees' account of the killings, which could not be independently verified, is the latest report of atrocities to come out of the conflict zone in Marawi, where the military is battling terrorists from the Maute group and their allies from an Abu Sayyaf faction that has pledged allegiance to the IS jihadist network in Iraq and Syria.

Eight or 10 hostages who either escaped or were rescued by the military earlier reported that the terrorists forced their civilian captives to loot homes, take up arms against government troops and serve as sex

slaves for the terrorists.

Some of the escapees said bodies of residents had been left in the streets, some for weeks, and civilians were distressed by government airstrikes and artillery bombardment that had reduced Marawi to rubble.

The terrorists stormed Marawi on May 23 to establish an IS enclave in Southeast Asia, drawing a military response that included airstrikes aided by US and Australian surveillance aid

Most of Marawi's more than 200,000 residents have fled the city and the fighting has cost the lives of more than 470 people—366 terrorists, 85 soldiers and police, and 39 civilians.

#### 'Just a matter of time'

The military said the terrorists were down to just 80 fighters and a statement it released on Sunday quoted Gen. Eduardo Año, chief of staff of the Armed Forces of the Philippines, as saying the end of the conflict was "just a matter of time."

Año's assessment came after receiving a briefing on the conflict on Friday at Camp Ranao, the base of the Army's 103 Brigade in Marawi City.

Explaining why only 80 terrorists remained when the original enemy force had been estimated at 700, Lt. Col. Jo-Ar Her-

rera, spokesperson for the 1st Infantry Division, said some terrorists managed to slip out of Marawi "probably in the first two weeks" of the fighting when the military was not yet in full control of Lake Lanao and other parts of city.

There were unverified reports that among those who had escaped was Isnilon Hapilon, the leader of the Abu Sayyaf fighters holed up in the city.

In the final stages of the conflict. Tampus' troops were tasked to secure the City Hall, 250 meters from the battle zone.

"The enemy's resistance continues, but they have no more automatic fire ... The resistance usually comes from snipers with grenade launchers," he said.

Herrera said around 300 civilians and hostages were in the battle zone. —WITH REPORTS FROM NIKKO DIZON IN MANILA AND REUTERS INQ

# Marawi war - source

A grim picture of Marawi City, which has been turned into a battleground between symphatizers of the Islamic State (IS) and state forces for more than a month, is emerging as the Armed Forces of the Philippines (AFP) indicated the impending end of the conflict in "a matter of time."

A lawyer, former government official and a long-time member of

the PDP-Laban claimed in a text message from the city that the civilian death toll in Marawi since May 23 could have breached 2,000.

Government vowed to end mopping-up operations soon but the fighting has continued for 47 days, belying the capacity of the military to use conventional warfare against a small guerrilla force in an urban setting.

The death toll of 2,000 civilians belies the claim of the military by the weekend that only 39 civilians

were killed in the fighting.

The lawyer, who spoke on condition of anonymity since he is staying on the arena of battle, said the AFP has claimed killing 351 members of the Maute Group while sustaining 85 fatalities from May 23.

President Duterte has ordered not only carpet-bombing of Marawi despite the danger of killing more civilians even as he apologized for the destruction of property in the course of the prolonged conflict.

The lawyer added the military has

barred civilians from the battle zone even as its bomber planes and 105 mm howitzers continue to flatten the city center, which he said is still under the control of the Maute Group.

It. Col. Jo Ar Herrera of the AFP Western Mindanao Command (Westmincom) said aerial bombardment was needed to "neutralize the enemy sniper positions in high-rise buildings and neutralize their defensive positions."

The youth leader said martial law in Mindanao has led to a spate of human rights abuses, with over 2,050 Lumad fleeing 13 communities after AFP soldiers invaded their ancestral lands and at least 14 peasant leaders and activists arrested in Mindanao ince

May 23.

"Duterte himself said that martial law shall remain until all enemies of state are wiped out. This is short of saying that martial law will remain forever and only gives license on the AFP and the police to unleash state violence and fascism on the people," said Crisostomo.

Anakbayan said that the use of martial law powers to go after revolutionaries, like the regime's order to "flatten the hills" and allout war declaration is in line with US counterinsurgency doctrine and

further exposes the US hand behind martial law in Mindanao.

# Survivor's tale: 'Tasty water lilies'

MARAWI CITY—Jun Abapo, his nephew Onkoy Anggay, and fellow construction worker Barok Cueco decided on Wednesday evening to get out of the war zone in Padian (marketplace) here after more than a month of hiding.

The trio were constructing a building owned by an official of Molundo, Lanao del Surwhen the fighting erupted on May 23

"We hid in many structures while the fighting was going around us. Bombs would also drop near our location that our hiding places would shake violently," he said.

Abapo said they grew tired of the gunfire and of the exploding bombs that on Wednesday evening they decided to try their luck and escape.

They tried hard to avoid detection by Islamic State-inspired militants, who regularly patrolled the area, by moving from one house to another until they reached a portion of the Agus River.

Using improvised floaters such as water jugs, Abapo said they followed the flow of the water—occasionally hiding in the vegetation by the riverbank.

#### **Eating water lilies**

He said on Thursday morning they were fired upon by the gunmen but they managed to dodge every bullet by constantly diving underwater.

By Thursday evening, although exhausted and hungry, they continued with their goal—to get out of the war zone alive by all means.

"We didn't have anything to eat anymore and we were very hungry. We gathered some water lilies and ate the young stems. It did not taste bad so we just chomped on it." Abapo, a resident of Sultan Naga Dimaporo in Lanao del Norte, said as he held back his tears.

For the succeeding days, they would swim by the riverbank while dodging more sniper fire and eat more water lilies whenever they can.

"For us, it was important

that we get out as soon as possible." he added.

But on Saturday evening, while swimming toward the bridge in Barangay Bubong, Abapo said a sniper's bullet hit Cueco.

"I put his body on a ramp by the riverbank," he said

#### Separation

During successive snipers' fire, Abapo said he lost sight of Anggay, a son of his younger sister.

"I don't know where he went and I have no knowledge of what has become of his fate," he said, his face growing dim.

"I prayed hard that God give me more protection as I spent more hours on the river," he

"By then, water lilies had become tasty already," he added

On Sunday morning, Abapo said he finally reached the bridge, where he was spotted by a group of soldiers on the other side of the river, near the city hall.

He reckoned it was about 8 a.m. when he started swimming toward them.

1Lt. Yvonne Altamera, company commander of the Alpha Co. of the 1st Infantry Battalion, said they noticed Abapo swimming toward them amid gunfire.

"We did not return fire so as not to compromise our location but we were yelling to him to just swim toward us," Altamera said

#### Surviving terror

It was around 9 a.m. when Abapo was finally plucked out of the water, weak and gasping for air.

"We gave him dry clothes to wear and slippers then brought him to our (battalion) headquarters," Altamera said

Lt Col. Christopher Tampus, the 1st IB commander, said they immediately informed higher officials about Abapo's rescue.

"He had survived the Mautes' terror," Tampus added. —ALLAN NAWAL AND JEOFFREY MAITEM INQ

# Operations vs Maute fine-tuned, says AFP

#### BY VICTOR REYES

THE military is fine-tuning operations against members of the Maute Group still holed up in parts of Marawi City, a military official said yesterday.

The adjustments were crafted during a visit of top security officials in Marawi City last Friday, who checked on efforts to end the conflict which is on its 49th day today.

The conflict has so far resulted in the death of 367 Maute members, 85 soldiers and policemen, and 39 civilians.

Col. Edgard Arevalo, chief of the AFP public affairs office, declined to give details on the adjustments being made on the ground, saying these are operational details that may compromise the efforts to rid the city of Maute remnants.

The visiting officials were led Defense Secretary Delfin Lorenzana, Armed Forces chief Gen. Eduardo Año, National Secretary Adviser Hermogenes Esperon, and the major service commanders.

Arevalo said the top officials were given a 25-minute briefing by Brig. Gen. Rolando Bautista, commander of the 1st Infantry Division commander and concurrent head of the Joint Task Force Ranao.

"A thorough deliberation and assessment followed unhampered" after the briefing, he said.

Arevalo said Lorenzana, Año and Esperon gave inputs but this does not mean the officials were "imposing" their thoughts on the ground commanders.

Arevalo said the current approach to defeat the Maute may be "perfect" for ground commanders but inputs from "experienced" and "knowledgeable" persons like Lorenzana, Esperon, and Año should be welcomed.

Lorenzana is a former Army major general who commanded the elite Special Operations Command of the Army. Esperon was Armed Forces chief, Army chief, and Army Special Operations Command chief.

"They are merely airing their (views) how it (operations) will be improved," said Arevalo. He said these inputs were "married" to the concepts of the ground commanders, thus the adjustments.

"It's going to be implemented because that is what was discussed," said Arevalo of the adjustments, which he said will hasten the accomplishment of their mission to neutralize the Maute Group, rescue civilian hostages, and pave the way for the reconstruction and rehabilitation of the city.

"The overall objective is towards the attainment of the mission. The objective is for us to accomplish our mission better," said Arevalo.

Arevalo reiterated that the military is not setting a timeline as to when to end the conflict. "It might be detrimental to our interest if we are going to set a deadline."

Asked if they can finish the job before President Duterte's state of the nation address on July 24, Arevalo said: "We can't say that, it's difficult. It's like setting a deadline already because SONA is on the 24."

"We are going to finish it the soonest time possible without sacrificing the safety of our civilians and course our personnel... Our objective is to finish this the soonest time possible given the observations and adjustments. We are hopeful that we are going to accomplish it the soonest time possible but we cannot set a deadline," said Arevalo.

Arevalo said Lorenzana and Año

were satisfied at how the operations are being conducted.

Año reiterated that the fighting will be soon over.

# Military air strikes target high-rise Marawi snipers

Snipers in high-rise buildings are the main problem facing government forces battling to crush pro-Islamic State fighters who have occupied Marawi City for more than a month, a military spokesman said Saturday.

Lt. Col. Jo-ar Herrera said this was the reason the government was using air strikes against the militants despite the massive damage it may cause in the city.

"If we do not use air strikes, we will incur more casualties of our troops," he told reporters in Marawi, which was overrun by hundreds of militants on May 23.

Despite more than a month of fighting with hundreds of government troops, militants flying the black flag of the Islamic State are still entrenched in parts of the city.

The military has used jet fighters, attack planes and helicopter gunships, armed with bombs and rockets, to

attack areas where the gummen are hiding.

"We have identified key defensive positions. These are being subjected to surgical air strikes now. They are still occupying high-rise buildings. We need to take them down so we

can facilitate a swift offensive of our troops," Herrera said.

"One reason we are using air battle are assets... is this is the advantage we need to neutralize the snipers' "These positions," the regional military spokesman added. "They occupy high-rise buildings so we have to be higher. So we use air strikes."

While hundreds of fighters rampaged through much of Marawi in the early days of the siege, Herrera said there were now around 80 gunmen still active in the "main battle area" comprising around 800 buildings

"These are the tall buildings. This was the center of commerce of Marawi City," he explained.

However, the buildings also needed to be cleared of improvised

bombs and other booby-traps as the troops advance, he said

There are also about 300 civilians trapped in the area, Herrera said, adding that some were being used as hostages, bearers of supplies and even being forced to help in looting the city.

President Duterte last month vowed to "crush" the militants, but several deadlines have already been missed to end a conflict that has forced almost 400,000 people from their homes.

The fighting has reduced Marawi, considered the Muslim capital of the largely Catholic Philippines, to a ruined ghost town. It also prompted Duterte to declare martial law over the entire southern Philippines.

Herrera said 366 enemy fighters, 39 civilians and 87 government troops had been killed in the fighting so far.

# AFP carries Bicolanos' aid for Marawi refugees

TABACO CITY, Albay: Capt. Ronnie Madrinan of the Philippine Army's 9th Infantry Division's Public Affairs Office on Friday led a humanitarian team from the Armed Forces of the Philippines (AFP) in transporting relief goods and nearly P1 million given by Bicolanos to Marawi City refugees.

Madrinan led at least five military and government trucks loaded with 200 sacks of rice, canned goods, noodles and used clothing generated after almost three weeks of knocking at the doors of the people of the Bicol Region seeking aid for evacuees affected by more than one month of fighting between the AFP and the Islamic Stateaffiliated Maute Group

Besides the military and government trucks packed with goods, the AFP collected P800,000 in cash from the Bicolanos to be handed over by Madrinan to the city social welfare office of Marawi City currently stationed in neighboring Lanao del Norte, Iligan City

Madrinan left Tabaco City international seaport via commercial ferry boat *Regina Calixta* owned by Catanduanes Gov. Joseph Cuabound for Virac, Catanduanes to get the goods gathered by the people of the province.

The AFP Bicol was given 50 percent discount in shipping fees by *Regina Calixta* management.

From Virac, Madrinan will be transporting the goods to Iligan using a cargo ship also owned by Cua for free.

The AFP Bicol has been receiving donations from people from all walks of life, with Carlo Lincaso, owner of a thrift store in Legazpi City and former cameraman of GMA7 donating five big sacks of used clothes for the Marawi refugees

The donation was picked up by Tactical Operations Group 5-Philippine Air Force in Bicol and transported to Tabaco City international seaport for the trip to Virac-

"We're grateful to the Bicolanos because in just less than three weeks, we were able to produce P800,000 and assorted relief goods for war-torn. Marawi. The Bicolanos share whatever they can. These goods and money came solely from the Bicolanos, our stakeholders," Madrinan said.

He added that the relief goods will be handed over to the Marawi social welfare office

The AFP launched the "Pagmakulog sa Sadiring Lahi (Compassion for our Fellowmen)" project, an initiative to lend a hand to the evacuees, on June 19 in Bicol's six provinces.

The kick-off was led by Army Gen. Manuelito Orense, commanding officer of the 9th Infantry Division.

After the launch, the AFP in Bicol also tapped social media

to appeal for help from netizens and local radio stations across the region

The project aims to encourage Bicolanos to give any form of assistance to boost the morale of the displaced families

According to Madrinan, they will sail for three days to reach lligan City.

"We hope that the war in Marawi will be over, so that the displaced

families can return home;" he said.

The AFP in Bicol earlief sent at least three battalions to Mindanao before the Marawi City clashes erupted to go after Maute Group terrorists

Since the Marawi siege started on May 23, at least three Marayes from the Bicol Region and an Agray soldier have been killed in action.

The fallen herdes were given military honors here and here

# MILF PERPLEXED AT THE WAY MAUTE GROUP IS FIGHTING MILITARY

ILIGAN CITY—The Moro Islamic Liberation Front (MILF), a 40year veteran of separatist insurgency in Mindanao, is perplexed at the Islamic State (IS)-inspired Maute terrorist group fighting the government head-on.

In a statement posted on its official website, the MILF said on Sunday the Maute group was "defying the logic of war."

#### Guerrilla warfare

"A weak party can only fight a strong party through a highly mobile warfare ... If the MILF has managed to stay alive and kicking to this day, it is because of the early realization that a weak party can never fight a [strong] party effectively, except by using various guerrilla warfare, including psychological war operation," the MILF said.

Styling itself as a local branch of the IS jihadist group in Iraq and Syria, the Maute

group, backed by the Abu Sayyaf faction led by Isnilon Hapilon, rampaged through Marawi on May 23 and seized parts of a city in a bid to establish an IS enclave in Southeast Asia.

The MILF dismissed that

goal as "more in the mind rather than an immediate possibility."

#### Martyrdom

It said the Maute terrorists' "apparent wish or love [of] martyrdom" prevented them from pursuing guerrilla warfare as a means to advance their cause.

"It is their belief or obsession that martyrdom brings them direct to heaven ... This perhaps explained their almost stationary style of fighting, especially during the early part of the siege of Marawi City," the MILF said.

Prior to signing a peace deal with the government, the MILF fought four major wars with the military, the longest of which was in 2000, lasting some five months and concluding with the capture of its main camp in Maguindanao

At the time the peace agreement was signed in 2014, the MILF had an estimated 12,000 fully armed fighters. INQ

## 'Martial law pa more'


#### PEAKER Pantaleon Alvarez said he will be pushing for the extension of martial law in Mindanao declared by President Duterte last May 23 and is supposed to end on July 22, two days before he delivers his second State-of-the Nation address.

Alvarez, who has shepherded a docile House of Representatives to Duterte's bidding, said Saturday, "If I can convince my colleagues, I will push for an extension until 2022, because two months is too short. Five months or one year or two years is too short.'

Alvarez did not say what is needed that cannot be done without the sword of martial law hanging over Mindanao.

Duterte himself does not seem so eager to lift martial law in Mindanao. News reports said when he was asked last week if he would lift it before delivers his second SONA on July 24, he replied, "No".

"I consulted the [military and the police] and [they] said it was criti-



cal. It will be the Armed Forces and the police who will say if it's no longer critical," Duterte said.

Brig. Gen. Restituto Padilla, AFP spokesperson said they are still assessing the situation in Marawi which is entering its seventh week as a battlefield between government forces and terrorist groups of Maute and Abu Sayyaf which get support from the dreaded Middle Eastbased ISIS (Islamic State in Iraq

and Syria).

There is no pressure for Duterte to end his martial law declaration in Mindanao. In fact, he is getting all the support. The Supreme Court upheld the validity of his martial law declaration in the whole of Mindanao overwhelmingly 11 = 4.

Actually, only Associate Justice Marvic Leonen opposed his declaration all the way. Senior Associate Justice Antonio T. Car-

pio supported his declaration of martial law but said it should be confined only to Marawi. Chief Justice Lourdes Sereno and Associate Justice Benjamin Caguioa saw the need for martial law in Lanao del Sur, Maguindanao, and Sulu.

The Filipino people do not seem to worry about martial law in Mindanao as reflected in the Social Weather Station Survey conducted last June 23 through 26 with 66 percent of the respondents satisfied with the way Duterte is running the country.

Never mind that in Mindanao, his net satisfaction rating dipped 12 points from 87 in March to 75 in June. His satisfaction rating increased in Luzon and Visavas for an overall assessment of "very good."

If he is getting high scores with martial law, why should he stop? He should give the Filipino people more of the same.

The Filipino people's embrace of Duterte reminds us of boiling

bviously, President Duterte will have to get his martial law imposition extended by Congress, and he probably will easily get it from Congress shortly after he delivers his State of the Nation Address on the 24th.

He said as much the other day when he stated martial law in Mindanao will be maximized, giving no indication that he will be lifting this before he delivers his Sona.

While the Armed Forces of the Philippines will be making an assessment and recommendation to determine whether martial law in Mindanao will be extended, it is the political leadership that will make a final decision on the matter, the AFP spokesman said

These will be coming from the ground commanders engaged in the ongoing operations to clear Marawi City and those tasked to secure Mindanao, said AFP spokesman Brig. Gen. Restituto Padilla Thursday.

He added that when Mr. Duterte placed Mindanao under martial law following the May 23 attack of the Maute Group terrorists, the AFP has set up certain conditions it has to meet before the 60-day declaration expires.

It was his defense chief, Delfin Lorenzana who kept on pushing the end of the Marawi war before the Sona, but even this may not occur, since Duterte says the time to lift martial law would be dependent on the assessment of the military, and the police, which to this day, the assessment remains "critical" or so he says.

# Martial law head nixes scalawags in Mindanao



The martial law administrator is against reassigning scalawag cops to Mindanao for disciplining. "Personally, for me, don't bring them here," Defense Sec. Delfin Lorenzana opined to the press last week. "We need good people to come here to fight this war."

He was reacting to Philippine National Police director general Ronald dela Rosa's sending two Metro Manila patrolmen to Marawi City for brutality. One was caught on video caning two detained drunks while the other did nothing to stop it. Dela Rosa ordered the hardship posting upon watching the video. Government troops are into their eighth week of house-to-house fighting to regain downtown Marawi from Maute Islamist terrorists.

"But what would they do here?" Lorenzana reacted to the cops' transfer. "Others don't want to come here." Born and raised in Mindanao, Lorenzana as an Army officer participated in the capture of three Moro separatist camps in the late 1990s. Recalling his military stint, he said the assignment of scalawags from Luzon to Mindanao only gave the commanders problems. Lorenzana was designated administrator of martial law in Mindanao that President Rodrigo Duterte imposed on May 23. The defense chief is in charge of planning the military and police drive against violent extremists.

Muslim Autonomous Region Assemblyman Zia Alonto Adiong also opposed dela Rosa's action. "It's quite offensive to treat us as a trash bin for abusive cops," he said as spokesman for the Marawi crisis committee overseeing 300,000 war evacuees. "To use the Marawi siege as punishment shows insensitivity."

Adiong and Lorenzana worried that Mindanao as disciplinary posting would trivialize the Marawi situation. Eighty-seven soldiers and three policemen have been killed in the fierce fighting. Government forces have displayed extraordinary deeds. Wounded soldiers keep volunteering to the battlefront, along with officers taking leaves of absence from

long-planned schooling in Manila. Five Muslim policemen withstood five weeks of starvation to protect five Christian civilians trapped in a terrorist-held area.

Still dela Rosa sent the two erring cops to Mindanao. He challenged newsmen to lay bets that the duo would become "the best" after their disciplinary stint. Dela Rosa too was born and raised in Mindanao, where he rose up the police ranks.

This is the third time under the Duterte administration that high officials howled against Mindanao postings of rogues in uniform. The first was in July 2016, when dela Rosa, newly designated as PNP chief, sent there 32 Quezon City anti-narcotics cops suspected of reselling confiscated meth. The second time was in February 2017, when 385 Metro Manila cops, with cases ranging from extortion to absenteeism, were sent to Basilan, where the Abu Sayyaf Islamists

kidnappers for ransom were rampaging.

Senate President Aquilino Pimentel III, who hails from Mindanao, and Muslim Autonomous Region Gov Mujiv Hataman back then said Mindanao deserved better policemen than scalawags from Luzon.

At that time dela Rosa did not mean Mindanao posting to produce the "best." His three reasons then were that there are no Korean retirees in Basilan for the crooked cops to kidnap for ransom, that the Moros would kill offending cops, and that the Mindanao posting would rid the PNP general headquarters of administrative headaches.

If dela Rosa now says Mindanao is good for discipline, it would be worthwhile to report what happened to the first batch of 32 and second batch of 385 transferees. Duterte said then that bad cops can become the worst criminals because they know the ins and outs of the law. Dela Rosa estimated that only two percent of the 160,000-strong PNP are crooked, but in the wake of the kidnapmurder of Korean businessman Jee Ickjoo, Duterte remarked that 60 percent of the force is "rotten to the core."

Two senators stood by de la Rosa's

disciplinary option. Francis Escudero and Gregorio Honasan said personnel reassignment is dela Rosa's prerogative. So long as the offenders criminally and administratively are charged, there's nothing wrong, Escudero explained. Honasan advised the executive officials to focus instead on the terrorist problem, like how the Maute jihadists were able to stockpile arms and food for the Marawi siege.

Two senators criticised dela Rosa. Bam Aquino said the posting of rogue cops will only further deteriorate the trust of Mindanaoans in policemen. Sherwin Gatchalian likened the rotten cops to cancer that must be excised and not merely transferred.

## PMA Class 1965 vs Cebu Pacific

n March 1965 the Philippine Military Academy graduated 57 brand-new second lieutenants for the Armed Forces of the Philippines. The commander in chief then was President Diosdado Macapagal, while the AFP chief of staff was Gen. Alfredo M. Santos, an engineer-turned-soldier who was corps commander of the Mapua Institute of Technology ROTC contingent in his college years.

The valedictorian of the class was Cadet Antonio Daza,

younger brother of Rep. Raul Daza of Samar Aside from the Presidential Sabre that was reserved for the class topnotcher, Daza would win many of the awards that were handed out during graduation rites at Fort Del Pilar. The Captain, "Baron," was Cadet Felix from the Turingan, Province Mountain Turingan, along with Cadet Rex Robles of Iloilo, would later on be-

come stalwart members of the Reform the Armed Forces Move-

ment during the crisis years of the Marcos regime.

At the height of their careers, Romeo Padiernos would serve as commander, Southern Command, while Jose Lapuz would head Central Command in the Visayas. Romeo Malig was one of my key officials at the Bureau of Customs. He would later become the first Filipino to head American President Lines in Manila.

At the turn of the century, members of the class started to drop out of the service as they reached the compulsory retirement age of 56 years. Many would join the private sector while one, Ernesto Sacro, would be installed as a bishop of a Protestant community in the country. Jose Solquillo is an executive with the Lucio Tan group of companies, while Tirso Rosal served as a security consultant with Hanjin Shipyard in Subic after a stint as director of the PNP Computer Service.

Today all the living members of the class, together with the widows, are basically senior citizens of our society. They proud-

ly carry senior citizen identification cards.

And this is where my story begins.

On May 26, 2017, four members of the class, including one widow, booked online round-trip tickets to Tagbilaran, Bohol, via Cebu Pacific. They were to attend the burial of a deceased classmate, Rear Admiral Manuel De Leon, Incidentally, De Leon was the first Philippine Coast Guard Commandant after the Coast Guard was transferred from the Department of National Defense to the Department of Transportation and Communications, now the Department of Transportation.

While making their bookings online, they realized there was neither a place to enter the information that they were all senior citizens, nor was there a clear notice or advice that senior citizen discounts were not allowed for online bookings, The following day they proceeded to SM Fairview to pay for their tickets, thinking that the senior citizen discount would then be implemented at the payment center. Not finding any Cebu Pacific office at SM Fairview, they went to a BDO payment center, presented their senior citizen IDs and asked for the senior discount. To their surprise, the receiving clerk informed them that she could only accept payment in the amount indicated in the online booking entry which was P50,265.44. They paid the whole amount, thinking that the discounts would be implemented at the Cebu Pacific counter at the airport. However, upon checking in they were told by the counter clerk that senior citizen discounts were not granted for online booked tickets.

Upon their return to Manila, they proceeded to the Cebu Pacific office at the airport to seek clarification as to why they were not granted the senior citizen discount. They were referred to a supervisor, Francis Dalagot, who in turn informed them that an Ivan Gaw would attend to their complaint based on the Passenger Feedback form which they were asked to fill out. In the form, they pointed out that the airline was in violation of the Senior Citizen Law, and asked for a reimbursement of the discount to which they were entitled to under the law. They included their names and contact numbers. Until now, there has been no response from Cebu Pacific.

My comments:

DOTC-DTI Administrative Order No. 01, Series of 2012, provides for a "Bill of Rights for Air Passengers and Carrier Obligations." Under this Bill of Rights is Section 4.2 that in part reads: "In case of online booking, the air carrier must establish a system wherein the purchaser is fully apprised of the required disclosures under this Section twice prior to final submission of his/her online offer to purchase."

But even in the absence of this administrative order, the fundamental law is quite clear. Republic Act No. 9904, known as the Expanded Senior Citizen Act of 2010, grants senior citizens a 20-percent discount for "actual transportation fare for domestic air transport services." The Implementing Rules and Regulations of this law specifically reads as follows: "Fare for domestic air and sea travel including advanced booking, shall be subject to the 20% discount and VAT exemption, if applicable."

In this particular case, Cebu Pacific did not comply with the Bill of Rights for Air Passengers, and violated RA 9904, by not granting the senior citizen discount. Neither did Cebu Pacific get in touch with the passengers to explain its position.

Lengthy legal proceedings will not benefit either the community of senior citizens or the business organization concerned. Let us get together to ensure that the law is observed in a manner convenient for our elderly citizens. In the end, we all benefit from beloing each other.

## Leonen's baseless anti-martial law dissent

akarta-Many were "shookt" by Justice Marvic Leonen's dissent-before the Lagman decision was outl—because only he argued martial law is invalid even in Marawi City. Some headlines dubbed Leonen the "lone dissenter," fake news that undermined Chief Justice Maria Lourdes Sereno, Senior Associate Justice Antonio Carpio and Justice Benjamin Caguioa's dissents.

The script styles Leonen as a new Claudio Teehankee, the Marcos Court's great lone dissenter Leonen fueled it by tweeting his dissent at 6 p.m., on July 5, hours

before Lagman's release.

People quote the dissent's lines with great emotional appeal, but the actual legal portions have no basis. It is structured like an Antonio Contreras post bashing law using political science.

First, Leonen argues martial law is invalid as President Duterte declared it but

did not define what it allows.

But that is Leonen's job. Past presidents declared a "state of rebellion" or "state of national emergency." The Supreme Court ruled these grant no new powers

Second, Leonen argues Mr. Duterte should use normal "calling out" power to deploy the army, not martial law. But this

is a political, not legal, point.

Third, Leonen argues the wrong case. The issue is Mr. Duterte's sufficient—not perfect—factual basis. Passing is 50 percent, not 90 percent. Justices thus gauge the big picture, not single factual errors.

Leonen goes far beyond facts to show Mr. Duterte interprets intelligence reports and the cultural context of Salafi-jihadis. He insists hundreds of armed men are terrorists and cannot possibly be rebels.

Even if he is right, we elected

allows Congress—not the Supreme Court-to review Mr. Duterte's interpretation of facts. Because passing is only 50 percent, note nonfanatic scholars from Carpio to former solicitor general Florin Hilbay stop short of questioning factual basis in Marawi itself, a sure "gg.

Fourth, Leonen imprecisely conflates martial law and calling out. He rightly asks why armed forces orders on martial law mix dismantling the New People's Army, private armies and drug syndicates.

But the president may "call out" troops any time. Invalidating abuse of calling out is separate from invalidating martial law.

Fifth, Leonen breaks from centuries of martial law doctrine to search for new bases. He applied "void for vagueness"-a freedom of speech doctrine—to the martial law declaration's text, an odd mix and match

Nothing destroys an advocacy more than forcing far-reaching but weak arguments over measured but solid ones. Previously, Leonen argued the "National Pantheon" law prohibits the Marcos burial. All Mr. Duterte, not him. The Constitution other justices, even dissenters, ruled this is a different cemetery from the Libingan ng mga Bayani

If Leonen is right, we must impeach the entire Supreme Court for gross incompetence—they could not even find the right cemetery!

The Lagman decision's shocking surprise was—and not all justices agree—that Supreme Court review of martial law must be all or nothing. If the Supreme Court upholds, geographic scope is left solely to Mr. Duterte. It claims to have no power to effect Carpio's dissent, echoed by Sereno and Caguioa, that martial law is valid in Marawi but not all of Mindanao because of the decades-old doctrine that there must be "actual," not just "imminent," rebellion.

Does factual basis in Marawi thus allow Mr. Duterte to declare martial law nationwide and replace Batanes' governor?

Martial law means replacing civilian government that broke down with the military. Carpio asserted—and Solicitor General Jose Calida agreed—that Mr. Duterte has no new powers under martial law where there is no actual fighting. This fits within Lagman and was echoed by concurring justices such as Presbitero Velasco.

If the Supreme Court explicitly adopts this on reconsideration, it would both preserve the commander in chief's traditional latitude but deter abuse of martial law. Sadly, we are too fixated with Leonen's tweets to pursue the real debate.

# AFP to create unit to defend PH military cyberspace

With the Internet now being used as a platform for attacks by various threat groups natiownide, the Armed Forces of the Philippines (AFP) on Sunday announced that it will build up a capable "cyber workforce" that will secure and defend the military's information networks and systems.

This was announced by AFP public affairs office chief Col. Edgard Arevalo as the military concludes its Cybersecurity Summit which is aimed at educating and informing its members about the latest trends in cybersecurity.

It tapped partners from the information and communications technology sector to impart knowledge and strategies on how to address the latest cybersecurity threats.

"It is high time that the AFP raise awareness for a secure and resilient AFP cyberspace as we adapt to the rapid technological advancements brought by the digital age," Arevalo stated.

The two-day summit was spearheaded by the Office of the Deputy Chief-of-Staff for Communication Electronics and Information System (CEIS).

It took place last June 28 to 29 at AFP headquarters in Camp Aguinaldo, Quezon City.

It gathered some of the military's information technology experts as well as representatives from the CEIS offices of the AFP Major Services and Unified Commands, Philippine National Police, and Philippine Coast Guard.

Resource persons from the Department of Information and Communications Technology, PNP Anti-Cybercrime Group, National Privacy Commission, and other partners from the private sector attended the event.

Among the topics discussed in the summit were the National Cybersecurity Plan 2022, Data Privacy Act of 2012, Cyber Crime and Prevention, and Cyber Threat Awareness and Updates.

During the summit, AFP deputy chief-of-staff for CEIS Major Gen. Jose Tanjuan, Jr., announced that his office has been developing a strategic plan specifically to enhance the military's cyberspace capabilities.

"The development of the AFP Cyberspace Strategic Plan is one of the thrusts of the AFP in attaining information security. It will provide the Armed Forces with a roadmap that will lead us to the realization of a fully cyberspace-capable organization by 2022," he added.

# (News Feature) Majority of MID assets now seeing action in Marawi City

A large portion of the country's armored assets are now seeing action in the ongoing operations to clear Marawi City of the remaining Maute Group terrorists.

This was bared by Mechanized Infantry Division (MID) public affairs office chief Capt. Emman Adriano in an interview with the PNA over the weekend.

"(Armored assets deployed) are four mechanized battalions, one cavalry squadron and one light armored troop. All of our newly acquired armored vehicles are now deployed in Marawi City," he added in Filipino.

These units consists of more than 120 armored vehicles of various types.

The EDA Program grants excess US military equipment, without cost, to qualified allied countries.

The new armored vehicles, Adriano is referring to the 114 M-113A2 armored personnel carriers acquired from the US through the Excess Defense Articles Program (EDA) in 2016.

The latter program gives excess American military equipment, without cost, to qualified allied countries.

The Armed Forces of the Philippines virtually got these additional armored assets for free saved for the shipping costs which amounted to PHP67.5 million and refitting of .50 caliber machine guns to the APCs.

The M-113A2 was developed to provide a survivable and reliable light tracked vehicle that allows for troops to be brought forward under armor for dismounted operations.

Also seeing action are the 28 armored vehicles fitted with remote-control weapons systems with .50 caliber, 25mm and 90mm guns.

The above-mentioned armored units were upgraded by Israeli defense manufacturer Elbit Systems Ltd for PHP882 million last 2014 and delivered in 2016. (Priam F. Nepomuceno/PNA)

## 3 Abu Sayyaf members killed in clash with soldiers in Sulu

MANILA – Three members of the Abu Sayyaf local terrorist group were killed in an encounter Saturday in Sulu Province, as troops of the Joint Task Force Sulu continue to besiege the lairs of ASG remnants, the Western Mindanao Command said in a report.

Soldiers of the 21st Infantry Battalion headed by Major Christopher Genzola engaged in an hour-long fierce firefight with heavily armed ASG under Almujer Yaddah at Sitio Darayan at the boundary of Barangay Danag and Barangay Buhanginan, both of Patikul, Sulu at 8:45 a.m. Saturday.

One soldier was killed in the clash.

During clearing operations, troops recovered one unidentified body of the enemy from the encounter site.

"Our operating troops were also able to see the bandits dragging two bodies of their companions who appeared to be already lifeless," said Brigadier General Cirilito Sobejana, Commander of the Joint Task Force Sulu.

Troops were acting upon information initially taken from the two recovered kidnap victims Friday afternoon in Daang Puti, Patikul, Sulu.

Rocabo and Leones specifically pinpointed the locations of the targetted Abu Sayyaf group who were keeping captive other kidnap victims, including some Vietnamese crewmen. The ASG last week beheaded two of their Vietnamese captives.

"As we speak, skirmishes are still ongoing as our troops are going after the tracks of the withdrawing bandits," said BGen Sobejana.

"The soldiers are very careful in their movements since it is believed that the Abu Syayaf group is still carrying with them around 6 to 7 kidnap victims.

"During the course of encounter, one soldier died and 15 others were slightly wounded. All WIA [wounded in action] were safely evacuated and are already being treated at the Kamp Teofilo Busbos Hospital in Jolo, Sulu, while the body of the dead soldier was brought to the military mortuary in the JTF Sulu headquarters," Sobejana said.

"The family of the fallen soldier will immediately be notified and will receive all compensations due to the family of a hero.

"Forces of the JTF Sulu are in still in the area pursuing the bandits who left several blood stains on their tracks. We will continue pressing them on until these terrorists are all neutralized and the KVs rescued," said Sobejana.
