IS SNIPERS REMAIN MAJOR HURDLE ore airstr

The military has stepped up efforts to retake Marawi City yesterday with morning airstrikes as the Armed Forces of the Philippines (AFP) vowed to do its best to meet President Duterte's latest deadline to finish the Marawi City siege

Military via strikes continued against positions will being held by the Islamin State (18) inspired terrorists in Marawi City after a tall Tuesday night due to had weather.

A report said that Philippine Air Force air craft banched morning serties—targeting areas at downtown Marawi City where terrorist snipers are still putting up pockets of resistance 51 days after laying siege on the Islamic City

Cot. Edgard Arevalo, AFT-Public Affairs Office chief, stressed that the military will try to meet the F-day period as announced by Mr. Interior last Tuesday in a speech at the Philippine Stock Exchange.

"The 15 days is a period within which the President hopes the crisis in Marawi to end. The APP will do its best, as it has been siving its level bost, to crush the schollion of the Mante-IS Group," said Argyalo.

"The Commander in Chief is were of the complexities of the complexities of the complime operations because he is being briefed regulach. Your government security forces resolute desire to accomplish the mission remain and truitminished," he added.

The military has failed to meet its June 12 self-imposed deadline to address the siege that starred last May 23 when government forces attempted to arrest Isulion liapilon, the designated emir or leader of the Islamic State of Iraq and Syvia (ISIS) in Southeast Asia.

Defense Secretary Deffin Lemmans also set three deadlines but relied. Landy, he said be hopes that the contlict is over before the President delivers his second state of the nation address (Sona) on July 24.

Id. Col. Joint Herrera, spokesman of Joint Tesk Force Murawi, said 54 more buildings were cleared of IS inspired terrorists at the main battle area. Earlier, the military said that the terrorists were still huled up in some portions of four barangays in downtown Marawi City.

"Vesterday, we cleared 54 buildings," said Herrera, who earlier said that the area being occupied by the terrorists is composed of around 800 buildings.

The military has stressed that the ongoing clearing operations in Marawi City is done house to house, building by building and floor by floor to ensure that all is cleared.

As of yesterday, Herrera said Abdullah Maute is still commanding the 18-inspired terrorists still putting up a fight against advancing government troops.

"Your government security forces' resolute desire to accomplish the mission remain and is undiminished," Arevalo said. Day 51 in Marawi City operations

As fighting between Monte Group terrorists and military reached its 51st day, an estimated 389 lawless elements were reported killed in the ongoing clearing operations along with 90 government troops, Arevalo said.

He added that this information is as of 6 p.m. of July 11.

Also, the number of civilians executed by the Mauto Group terrorists remained at 39 while number of rescued individuals are placed at 1.723.

Arevale said the number of weapons recovered has been placed at 494.

Fighting broke out in Marawi City after government troops tried to arrest Abu Sayyaf leader Isnilon Hapilon and ISIS "emir" in Southeast Asia last May 23.

An estimated 200 civilians are still trapped in areas held by Mante Group, AFP spokesman Brig. Gen. Restituto Padilla said citing reports of the Marawi City local government.

"There are estimates (of) about 300 or more who are still unaccounted for "he said.

The unaccounted civilians

include residents who are still hiding in their homes or missing persons who may be hostages of the terrorists, he added.

Padilla said the military is inoking at the possibility of recovering or seeing additional remains of civilians killed by the Mante Group terrorists once they overrun the last remaining positions of the lawless elements.

"As of now, we have not gone into the interiors of previously held enemy areas and once we do that we may get the surprise of our lives and find numbers of cadavers left who have been killed by the enemy," he said.

Schooling disrupted

About 22,000 students and 1.411 teachers in Marawi City have been displaced due to the ongoing armed conflict between the Maute group and government forces, a top official of the Department of Education (DepEd), meanwhile, said,

In an interview, ImpEd Assistant Secretary and spokesman Tomsito Umali said as of July 10, 21,457 out of the 22,000 have been tracked down in various areas in the country.

Some of the displaced students enrolled in Region 1 with 84 students.

The highest number of Marawi displaced learners are in Region 10 with an estimated 12.663 students

DepEd found some of the learners in Lanao del Norte with 4,889 wherein 4.027 are in Higan City.

In Lanao del Sur, there are about 4,049 students and in banao del Sur, 3,506.

For those absorbed in various divisions, he saidDepEd has provided interventions such as psychological first aid.

Tents and temporary learning spaces have been set up in areas that can be longer accommodate students in tempo tooms.

"We provided learning kits.

Same thing with our teachers we provided them teaching kits, hygiene kits... all the necessary things for them. As much as possible normally, all regions but particularly in region 10," he said.

Out of the 1.411 displaced feachers, DepEd said about 1.284 teaching personnel are from Marawi City.

"We are still trying to track all of them, in the same way we track some as far as Batac. Maybe if they are back to work or they were called where they are or if they are teaching now in other divisions. Kasi wala naman silang habalikan na sa Marawi. Ganun din nag enroll lahat yan yung sinabi kong numero. Yung iba nasa evacuation centers nais munang manatili doon." he said.

Part of the efforts of the department to assist the displaced DepEd workers and students include trying to locate them, especially the teaching and non-teaching personnel.

"Once we locate them we would like to make sure that they are all okay. We try to provide what we can provide them," he said.

"And we give them provisions or whatever help we can possible provide. Again, trying to make their lives again be the same persons to take care of our children who are also affected, by giving them a sense of normalcy, the way they do," he said.

"We do not want a situation where our teachers and nonteaching personnel tasked to take care of our children are themselves worried about what will happen." he added.

"The policy right now is that we don't want our Marawi displaced learners to wait for the day for Marawi to resume classes before they return to classes," he said.

As of July 11, DepEd records show the displaced learners increased to 23,370 from 21,457, logion to has the highest displaced learners with 14,412 from 12,668,

The military is doing its best to end the siege of Marawi by Maute militants as soon as possible or within 10 to 15 days as projected by President Duterte.

Col. Edgard Arevalo, chief of the Armed Forces of the Philippines (AFP) Public Affairs Office, gave the assurance in response to Duterte's assess ment that more time is needed to defeat the militants linked to the Middle East-based Islamic State (IS),

The President made the forecast in remarks at the Philippine Stock Exchange on Tuesday.

"The AFP will do its best, as it has been giving its level best, to crush the rebellion of the Maute-ISIS group," Arevalo said.

He said Duterte has basis for the 15-day forecast as the President has been receiving daily updates and is aware of the complexities of the operations against the terrorists!

security forces have been conducting ground and air operations against the terrorists. The militarits began their siege of the country's only Islamic city on May 23.

Despite heavy rain, air offensive continued vesterday. Bad weather slowed down ground operations, however.

The military said the terrorists were down to only 80 fighters holed up mostly in four locations in the city's commercial district.

A total of 381 terrorists, 90 soldier and 39 civilians have been killed since fighting began in May. Government troops have also recovered 461 terrorist firearms and rescued 1,723 civilians trapped in the war zone.

Philippine National Police (PNP) chief Director General Ronald dela Rosa echoed Duterle's assessment that the conflict in Marawi would be over in 15 days, noting that the President is very much aware of the situation on the ground. "That's a very good assessment coming from the President."

He also said that despite battlefield setbacks, the Maute terror group still

poses a threat in other parts of Mindanao

The National Capital Region Police Office (NCRPO) for its part, is also verifying reports on the presence of Maute militants in Luzon, possibly even in Metro Manila

"We take these information seriously because if they were able to do it in Marawi they can do it in other places," Dela Rosa told reporters, citing teports the terror group was planning attacks in other parts of Mindanao

It is for this reason, Dela Rosa said Tuesday, that martial law should be extended in Mindanao.

But he stressed any extension should be within what is allowed under the law "As I have said, we better not take chances," he said.

even civilians were always on guard against possible terror attacks:

"They are very much aware that since they are in Mindanao, there is chance of a spillover of the problem in their area," Dela Rosa said.

Dela Rosa also revealed that three members of the Maute clan held on Tuesday at the Ninoy Aquino International Airport on suspicion of being terrorists were released yesterday.

"There is no reason to hold them further," said Dela Rosa, referring to Ashary Palawan Maute, Yasser Dumaraya Maute and Abdulraham Maute. The three were about to depart for Malaysia when accosted."

Reports said the Criminal Investigation and Detection Group (CIDG) did not find any evidence linking them to the Marawi siege.

"If we later find out these people are involved in the war in Marawi, then we have a reasonable ground to hold them," Dela Rosa said.

NCRPO Director Oscar Albayalde said he has asked Metro Manila mayors as well as Muslim leaders to cooperate with authorities in efforts to secure the metropolis.

"We do not take anything for granted. We are close-

ly monitoring with our AFP counterparts to verify the information, especially on our intelligence operatives," he said.

Hopeful

Senators are hopeful that President Duterte would be able to end the crisis in Marawi City in 15 days, as this could mean there would be no need to extend the 60-day martial law in Mindanao that expires on July 22.

Sen. Joseph Victor Ejercito said while he is generally receptive to extending martial law if Duterte asks Congress for it, it would be better if it would no longer be needed.

Sen. Franklin Drilon from the minority said he is deferring to Duterte on his latest timetable.

"The President is presumed to have access to information which none of us would have; when he says he will finish it in 10 to 15 days, that we will defer to the judgment," Drilon said.

He said he is looking forward to the briefing of security officials to senators to guide them in the event they have to deliberate on a possible request for extension of martial law.

"So if that is where it is, then

the decision of Congress will certainly be influenced by this assessment of the President... when he feels he can finish the problem in Marawi," Drilon said.

Meanwhile, a civilian hostage in Marawi who was reportedly able to secretly call his family said Fr. Teresito 'Chito' Suganob was being forced to make explosives by his captors.

"The Maute tasked the priest to collect the explosives and make improvised bomb," a relative of the civilian quoted the latter as saying during a clandestine phone call. The identity of the hostage was not revealed for security reasons. It was not clear how he was able to make a phone call to his family.

The hostage told his wife he could not pinpoint their exact location in Marawi but believed the soldiers were on track because of their constant skirmishes with soldiers.

Meanwhile, two soldiers were killed while 11 others were wounded when another wayward bomb intended for Maute militants was dropped by a Plulippine Air Force (PAF) plane in Marawi yesterday

Reports reaching Camp Aguinaldo said the incident, the second to happen in more than a month of fighting, occurred around noon.

"Initial report from Marawi indicates that the bomb was 250 meters off target. The impact of the explosion caused the collapse of nearby structures," Col. Edgard Arevalo, Armed Forces of the Philippines (AFP) spokesman said.

He said large pieces of flying debris from heavily reinforced buildings hit the two soldiers, killing them

Fragments and shrapnel of the exploding bomb also caused injuries to 11 soldiers, whose wounds are all ambulatory in nature, he said. The wounded troopers are now recuperating in a nearby hospital.

"We are saddened by this unfortunate incident. We are attending to the needs of the families of our troops who died or were hurt," Arevalo said

On May 31, 10 soldiers were killed in a friendly fire involving the PAF's SF260 fixed wing aircraft, one of the PAF planes being used by the AFP in its airstrike operations against the Maute.

Another 'friendly fire' incident leaves 2 soldiers dead, 11 injured

TWO soldiers were killed and 11 others were injured when an airstrike against members of the terrorist Maute Group missed its target and hit government troops instead, a military official said vesterday.

"Initial report from Marawi indicates that the bomb was 250 meters off target. The impact of the explosion caused the collapse of nearby structures," said Armed Porces public affairs chief Col. Edgard Arevalo.

"Large debris from heavily reinforced buildings accidentally hit two of our personnel who succumbed to death in the process," Arevalo said.

He said the incident injured 11 other

soldiers who sustained minor wounds from shrapnel. "All are ambulatory and are recuperating in the nearby hospital," he said

Arevalo said the military is "saddened by this unfortunate incident," the second accident involving a military aircraft during the ongoing Marawi City armed conflict, which dragged on its 51st day yesterday.

On May 31, a bomb released by an SF-260 aircraft landed at the position of government troops, instead of the Maute members. The incident resulted in the death of 10 soldiers and wounding of seven others.

"We are attending to the needs of the families of our troops who died or were hurt," said Arevalo, referring to the soldiers who died and who got injured in the latest incident.

"Cognizant units from the AFP have formed a group that is now conducting initial investigations to determine the cause of the mishap and prevent the chances of it recurring," he also said.

Arevalo also said government forces are doing their best to end the continuing rebellion of the Maute Group in the next 15 days, in keeping with an earlier pronouncement of President Duterte.

He said attaining the 15-day period set by the President to end the armed conflict, which broke out last May 23, was "possible."

Duterte on Tuesday said he needs 10-15 more days to end the crisis which dragged on its 51st day yesterday, noting

that the Maute members were not running out of firearms and grenades.

"The President is aware of the complexities of the ongoing operations; that we are continuously gaining ground in the main battle area. We will work along the guidance of the President. We will do our level best to clear the portions of the four remaining barangays within the period," said Arevalo.

Arevalo said the fighting has already left 389 Maute members, 90 soldiers and policemen, and 39 civilians dead. It has also resulted in the recovery of 494 Maute firearms and rescue of 1,723 civilians.

The Philippine National Police re-

leased three of the four individuals who were arrested at the Ninoy Aquino International Airport in Pasay City last Monday afternoon on suspicion of involvement in the continuing rebellion in Marawi City.

The suspects were freed on Tuesday afternoon by the PNP Criminal Investigation and Detection Group due to lack of evidence to link them to the rebellion, PNP chief Director General Ronald Dela Rosa said.

CIDG National Capital Region chief Senior Supt. Wilson Asueta named the three as Ashary Maute, Yasser Maute and Al Nazir Maute, who were intercepted last Monday afternoon by immigration authorities while about to board a flight bound for Malaysia.

Another suspect, Abdulrahman Maute, was also arrested and taken into custody of the NBI because he was among those listed in the Arrest Order No. 2 issued by DND

secretary and Martial Law Administrator Delfin Lorenzana.

PNP Aviation Security Group head Chief Supt. Sheldon Jacaban earlier said Abdulrahman was among those taken into the custody of the CIDG for further investigation and that Al Nazir was the one brought to NBI.

Bureau of Immigration spokesperson Ma. Antonette Mangrobang said it was Abdulrahman who was taken by the NBI for custody. She could not however say if Abdulrahman is still with the NBI as of yesterday.

Dela Rosa said the three suspects released by the CIDG can be re-arrested if investigators are able to gather evidence, in the future, to link them to the rebellion.

On the possibility that the three may leave the country, Dela Rosa said: "Since we have no evidence against them, they can go (out of the country). It's actually up to the Bureau of Immigration, that's their turf already," he said.

Two soldiers killed, 11 others wounded by friendly fire

t least 300 civilians remain unaccounted for and may still be trapped in war-torn Marawi City, the Armed Forces of the

Philippines (AFP) said Wednesday. AFP spokesman Brig Gen Restituto Padilla said the number is based on the information provided by local government units (LGUs) in the area. He said those unaccounted for are

either trapped inside war-torn Marawi or being held hostage by the ISISinspired Maute Group.

"Unaccounted civilians may include trapped residents who have not yet left their places of abode; they may include missing persons who may be hostages of the enemy, or may just be around," Padilla said.

Based on records, Padilla said at least 39 civilians have been killed by the Maute Group since the rebellion started

on May 23, 2017. He expects the civilian death toll to increase once government troops enter other parts of the city which the terrorists still control.

"We hope to clear the city of the terrorists in the soonest possible (time)," he said.

Padilla said that as of 6 p.m., Tuesday a total of 389 Maute fighters have been killed while 494 firearms had been either seized or recovered.

He also said that 90 government forces have been killed in the battle against the Islamist terrorists, while 1,723 civilians have been rescued by government forces from the war zone.

Meanwhile, AFP-Public Affairs Office (AFP-PAO) chief Colonel Edgard Arevalo Wednesday said that President Duterte's pronouncement that the rebellion in Marawi City could be "over in 15 days" is just "a period within which the Chief Executive hopes the crisis in the city will end."

In a statement, Arevalo assured that the AFP will do its best to crush the rebellion of the Maute-ISIS group the soonest possible time.

"The Commander-in-Chief is aware of the complexities of the ongoing operations because he is being briefed regularly." Arevalo said.

"We will work along the guidance of the President. We will do our level best to clear the portions of the four remaining barangays within the period," Arevalo said.

The US earlier revealed that ait was providing "technical assistance" to government troops fighting Maute terrorists.

He is being briefed every now and then about the situation and he came up with [the 15-day] assessment," de la Rosa told reporters in a chance interview in Camp Crame.

Long rehab

As government turns its focus to the rehabilitation of Marawi, Health officials said helping residents there get back on their feet will be a long process.

"Rehabilitation will take years. This will not happen in the next few months. This will take years," Assistant Secretary Eric Tayag said

in a TV interview.

Tayag said health officials are monitofing Marawi evacuees for signs of post-traumatic stress disorder, which may lead to depression and anxiety.



Asked on the possibility that Islamic terrorists can thrive in the province, Torres replied, "There is a possibility in Davao del Norte, although it is remote."

He said military forces in the province have been constantly keeping an eye on the migration of internally displaced persons, or the so-called bakwits, from the conflict area of Marawi City and keeping the level of good security of the province right now.

He differentiated the current martial law in Mindanao to Marcos's martial law, which he reckoned to have a "political purpose", while the current is addressing a "specific security problem".

Soldiers foil NPA attack, kill eight in C. Valley

SECURITY forces yesterday foiled a plot by the New People's Army to conduct a massive offensive during President Rodrigo Duterte's second State of the Nation Address with the killing of eight insurgents in a fierce fight in Compostela Valley Wednesday morning.

The latest firefight with the local communist also claimed the life of a soldier.

Army Capt. Alexandre Cabales, acting chief of the Army's 10th Infantry Division, said the clash occurred after ground troops encountered a 40-man rebel band at Barangay L.S. Sarmiento, Laak, Compostela Valley at around 8:30 a.m.

Cabales said the NPA group were the same rebel band that troops from the 25th Infantry Battalion had engaged in a clash in Barangay Casoon in Monkayo town which led to the seizure of an NPA camp last July 10.

He said the rebel group was planning to avenge the seizure of the communist camp in Boy Casison through an ambush against military personnel but failed as security forces anticipated the plot.

Prior to the series of encounters, Lt. Col. Ismael Mandanas, commander of 25IB said that they have been receiving reports that the same NPA rebel group will consolidate at Barangay Casoon to conduct tactical offensives prior to President Duterte's State of the Nation Address in compliance to their communist leaders instructions,"

Anticipating the NPA attack, combined troops from the 25th Infantry Battalion and 60th Infantry Battalion conducted combat patrol in Barangay Casoon and eventually chanced upon the same rebel group.

An hour-long fighting ensued with the rebel band, after which the insurgents withdrew leaving 8 of their comrades dead.

The troops recovered six high-powered firearms consisting of five armalite rifles and an M60 machine gun left by the fleeing rebels.

Major Gen. Noel Clement, commander of the 10th Infantry Division, lauded the bravery of the troops even as he expressed sadness following the death of one of the soldiers, who was not named pending notification of his loved ones.

"We will not lower our guards against any arm threat that can harm the peaceful leaving of our people," Clement said,



ment and families failed to pay ransom. Their decapitated bodies were recovered in the village of Tumahubong in Sumisip town in Basilan province.

The sailors were kidnapped on November 11 off Basilan along with four others seamen Phang Minh Tuan and Do Trung Hieu and Huang Vo, who was released last month by the Abu Sayyaf in Sumisip town. They are all crew members of the cargo ship MV Royal 16

Duterte: I'm ready to die for Marawi

President Duterte is ready to die for the liberation of Marawi City from the Islamic State (IS)-inspired Maute terror group as he plans to enter the battle zone anew after two failed attempts in recent weeks.

Duteric said he wanted to personally boost the morale of soldiers in Marawi about one and a half months after he declared martial law and suspended the privilege of the writ of habeas corpus when Maute terrorists attacked the citylast May 23.

"Since they said we came here to die, when I get there and they ask me, 'Mayor, why are you here? I will tell them I came here also to die," he said in English and Filipino during the 26th anniversary celebration of the Bureau of Jail Management and Penology (BJMP) at Camp Aguinaldo in Quezon City vesterday.

The President has been vocal about his intent to penetrate the conflict area, but his security advisers twice prevented him ostensibly due to bad weather.

Duterte also reiterated his call to the military vesterday not to take prisoners,

in Marawi, saying this would be an additional burden on government. Since the conflict has caused massive destruction in Marawi looking for a place to lock up the prisoners would be problematic, he said.

Instead, Duterte told the soldiers, "patawin me (kill them)."

"If you apprehend them, take them into custody. They will have to be detained where they committed the crime of rebellion – that's in Marawi – and they will be tried within the jurisdiction of Marawi, the place of the commission of the offense. Saan naman ako maglagay ng presohan dun (where will I put a prison there)?" he said.

He said if the terrorists are detained, the other militants would free them when the soldiers leave, "so we don't need prisoners."

Duterte assured the residents of Marawi that the government would not abandon them.

"We will help you, we will help rebuild (Marawi)," he said.

He added that his administration is focused on fighting corruption and helping the poor.

Sona sends House stirring

THE House of Representatives will implement stricter security measures in this year's State of the Nation Address to prevent any possible violence by drug lords and terrorists.

House Sergeant-at-Arms Ronald Detabali, at a news conference, said drug lords who have been affected by President Rodrigo Duterte's war on drugs could use the occasion to retaliate and sow terror.

"Definitely we will impose heightened security measures not only because of the current problem on ISIS, but because of the huge achievements of the President especially in the war on drugs and criminality," Detabali said.

Without giving details, Detabali said there would be more security personnel from the Presidential Security Group, Philippine National Police, Armed Forces of the Philippines and House security personnel compared to President Rodrigo Duterte's first Sona last year.

As they did last year, House leaders urged lawmakers and guests to do away with the ostentatious and to instead dress simply.

"The Speaker says the Sona is going to be a working day and so officials and employees are advised to wear inexpensive modest clothes. It could be Filipinia dress, but not long gown, it could also be business attire," said House Secretary-General Cesar Pareja.

Metro Manila police director Oscar Albayalde said 6,000 men from the National Capital Region Police Office and 2,000 men from the Metro Manila Development Authority will be deployed to ensure peace and order and manage the flow of traffic during the Sona on July 24.

Albayalde said he and other NCRPO officials would discuss security deployment for the Sona with Quezon City Police District chief Supt. Guillermo Eleazar, who is the overall commander of the police forces to be deployed to the Batasan Pambansa complex.

Albayalde said security measures during the Sona would be stricter this year because of some issues such as the martial law in Mindanao and the ongoing armed conflict in Marawi City.

He added the NCRPO will implement security adjustments for this year's Sona upon orders from Malacañang.

The NCRPO chief said they had added 2,000 policemen due to the presence of Islamic State-leaning sympathizers in Metro Manila.

Metro Manila is under heightened alert in light of the threat posed by members of the extremist Maute group.

The Maute group on May 23 attacked Marawi City resulting in the declaration of martial law in Mindanao.

Albayalde's office recently received information that a document was being circulated through social media that a series of bombings would be launched anytime in the National Capital Region.

That memo, dated June 16, spoke of a series of terror attacks planned by the extremist Maute group in Manila, Makati and Quezon City.

Last year, protesters were allowed to conduct rallies during Duterte's first Sona.

Albayalde also said officials of the Commission on Human Rights would meet with anti-riot policemen days before the Sona.

During the Metro Manila Council meeting, MMDA chairman Danilo Lim said the traffic enforcers will manage the crowd and vehicular flow during the event.

Lim also advised motorists to take alternate routes since traffic flow is expected to be heavy due to protesters.

Authorities earlier said three lanes on the northbound of Commonwealth Avenue will be allotted for protesters this year

In 2016 Sona, two lanes were allotted to protesters but they also occupied another lane and snarled the traffic flow on the major thoroughfare. Plastic barriers will also be installed near the Batasan Complex.

The MMDA's Unified Vehicular Volume Reduction Program, commonly known as the "number-coding," will remain in effect.

Emergency personnel will also on standby, including fire trucks and ambulances.

Dela Rosa said on Tuesday he had recommended an extension of martial law to senators.

He did not specify the extension period, saying only that it should be "within the legal framework."

6 in 10 Pinoys oppose martial law beyond Mindanao

AT LEAST six out of 10 tesidents from Luzon and the Visayas opposed the idea of extending martial law outside Mindanao, even if majority of Filipinos supported its imposition in Mindanao last month, the June 23 to 26 survey of the Social Weather Stations (SWS) showed.

The survey, involving 1,200 respondents nationwide, showed that 63 percent of respondents disagreed with the statement that the President "should also declare martial law in the Visayas," while 23 percent agreed. This means a net agreement rating of -40.

Opposition to the proposed extension of martial law in the Visayas was highest among respondents from Visayas (79 percent disagree, 15 percent agree) and Metro Manila (71 percent disagree, 20 percent agree) while close to a majority of respondents from Mindanao agreed to its expansion (43 percent agree, 38 percent disagree).

The SWS results also showed that 67 percent of respondents disagreed with the statement that Duterte "should also declare martial law in Luzon" while 20 percent agreed. This resulted in a net agreement score of -47.

Opposition to the proposed extension of martial law in Luzon was highest among respondents from Metto Manila (79 percent disagree, 13 percent agree) and in Luzon (76 percent disagree, 13 percent agree). Many respondents from Mindanao agreed to its expansion (40 percent agree, 38 percent disagree).

Presidential spokesman Ernesto Abella said Malacañang acknowledges the sentiments of the public but reassured that the decision on whether to expand the coverage of martial law outside of Mindanao or extend its imposition "would depend on the situation on the ground as assessed and recommended by military and police authorities."

The SWS survey also showed that 57 percent favored the imposition of martial law in Mindanao. Around 29 percent said "it should have been declared only for Marawi City and the province of Lanao del Sur" and 11 percent said "it should have been declared only for Marawi City, the province of Lanao de Sur and nearby provinces." Two percent said they were undecided.

Abella said the support of the majority for martial law validates the Filipinos' approval of the performance of the President during the last quarter where he garnered a "very good" +66 satisfaction rating.

He said the positive public response is also indicative indicates that the public believed that there was "factual and legal basis" for the imposition of martial law in Mindanao last May 23.

Abella said public interest along with the recommendations of the military and the police would be the main considerations of President Duterte in deciding whether to extend the imple-

Palace welcomes positive response to martial law

Malacañang yesterday welcomed the result of the latest Social Weather Stations (SWS) survey showing a majority of Filipinos support the declaration of martial law in Mindanao to prevent the Marawi rebellion from spreading.

In a nationwide survey conducted from June 23-26 with 1,200 respondents, 57 percent of the respondents agreed that President Duterte was right in declaring martial law in Mindanao.

Twenty-nine percent said martial law should have been declared only in Lanao del Sur where Marawi is 🄰

located while 11 percent said martial law should also be declared in nearby provinces aside from Lanao del Sur

Of the respondents, 64 percent of those polled from Mindanao said the declaration was a "right decision." Fifty-eight percent of Metro Manilans likewise agreed it was the right move and so did respondents from the Visayas (57 percent) and the rest of Luzon (53 percent).

The same sentiment was found among Filipinos in urban (58 percent) and rural (56 percent) areas

Despite the figures, ACT Teachers Rep. Antonio Tinio said the "support for martial law in Mindanao is not solid and unanimous."

Factual, legal basis

Presidential Spokesman Ernesto Abella, in a statement, said the Filipi nos understand that the situation in Marawi Cily was critical enough for the declaration of martial law and the suspension of the privilege of the writ of habeas corpus in entire Mindanao

"The positive public response indicates that they believe the factual and legal basis of the proclamation of martial law for Mindanao," Abella said yesterday

Based on the survey, 63 percent disagreed that Duterte should expand martial law (ML) to Visayas, while 67 percent disagreed the President expand his declaration to Luzon.

"As to the same survey showing that majority except in Mindanao, opposes expanding martial law in Luzon and in the Visayas, it is noteworthy to mention that all these would depend on the situation on the ground as assessed

and recomi lended by military and police authorities," Abella said.

Voting 11-3-1, the Supreme Court (SC) last week upheld Duterte's Proclamation No. 216 placing Mindanao under martial law.

'LUMAD' FLEE AS SOLDIERS RETURN TO SURIGAO VILLAGES

LIANGA, SURIGAO DEL SUR— Less than a year after their return to their villages, more than 2,000 Manobo lumad (indigenous peoples) from nine hinterland villages in three towns had to flee their homes again as soldiers occupied their communities last week, the human rights group Karapatan said.

United Church of Christ in the Philippines Bishop Modesto Villasanta, chair of Karapatan in Surigao del Sur province, said 2,043 lumad villagers fled after noting a helicopter hovering around their villages last week

The lumad residents now staying at Simowao Tribal Community School in Sitio Emerald in the village of Diatagon here are the same people who left the community in Sitio Hanaya and stayed for a year in Tar ag City after the killing of educator Emerito Samarca and lumad leader Dionel Campos on


Sept. 1, 2015.

Residents blamed the paramilitary group Magahat-Bagani for the murder of Samarca and Campos. The group, they said, was targeting suspected communist leaders and sympathizers.

The lumad returned to their villages in September 2016 after the military left their community.

"Now, amid martial law and continuing militarization, these indigenous communities are again threatened by military operation," Karapatan said in a statement.

Karapatan said after President Duterte declared martial law in Mindanao on May 23, a

2 dead in Marawi airstrike

Two soldiers were killed while 11 others were injured when a bomb during an airstrike missed its target and exploded near their position in Marawi City at noon yesterday.

The Armed Forces of the Philippines said that it is now investigating the incident.



2 SOLDIERS KILLED IN FRIENDLY FIRE

MARAWI CITY—Two soldiers were killed and 11 others injured when a bomb dropped by a military plane missed its target and exploded near the position of government troops here around noon on Wednesday.

Lt. Col. Jo-Ar Herrera, spokesperson for Task Force Marawi, said an investigation was "being conducted" to determine the circumstances surrounding the incident.

250 meters off-target

"Initial report from Marawi indicates that the bomb was 250 meters off-target," Herrera said.

"The impact of the explosion caused the collapse of nearby structures. Large debris from heavily reinforced buildings accidentally hit two of our personnel, who [died] in the process," he said.

Eleven other soldiers suffered minor shrapnel injuries, he added.

"We are saddened by this unfortunate incident. We are attending to the needs of the families of our troops who died or were hurt," Herrera said.

He said the military had formed a group to investigate the accident, determine its cause and make recommendations to prevent similar incidents from happening.

It was the second time that soldiers were the ones hit by government bombs during fighting with terrorists in Marawi City.

On May 31, 11 soldiers perished when a bomb intended for the Maute group landed on an area occupied by soldiers. INQ

Guidelines on expensive military, police pensions likely out by end of year

HE proposal bringing the country's military, police, coast and jail guards, as well as firemen pension, under the ambit of the Government Service Insurance System (GSIS) should be completed by year-end.

Finance Secretary Carlos G. Dominguez III said on Wednesday he has asked the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) to provide the Department of Finance (DOF) with an updated list of personnel, since the latest record the government has was still dated 2010.

"We will complete the study maybe by the end of the year. Then, we will present that, obviously, to the Cabinet and then if required, which I think it is, has to be legislated," Dominguez told financial reporters.

National Treasurer Rosalia V. de Leon also confirmed the review on military pensions is under thorough evaluation

"We are looking into the guidelines, in terms of how much [increase in pension rates can be implemented]," de Leon said.

This developed even as the military continues to liquidate the assets of the pension fund known as the Armed Forc-

es of the Philippines—Retirement and Separation Benefit System (AFP-RSBS) and refund the contribution of military personnel

The AFP-RSBS was deattivated in 2007 by then-President Gloria Macapagal-Arroyo, the fund having failed long before to deliver its mandate to take care of the retirement benefits of its members

Based on data from the Department of Budget and Management (DBM), the government needs to fund the pension needs of 210,816 retirees coming from the military, police, coast guard and fire bureau, totaling an estimated P73.9 billion.

This represents a 4.08-percent expansion from estimated pension of some P71 billion as of 2016.

In April this year, the DOF and the DBM bared a plan to create a retirement fund for soldiers, through the GSIS, finally to address the increasing pension cost of soldiers serving the military.

Dominguez said this was a priority measure that needs to go through legislation quickly.

That is a political decision, one that will have to be legislated. But we have to fix it." he said.

In February Budget Secretary Benjamin E. Diokno said addressing the cost of military pension through the annual budget was unsustainable and that the Legislative-Executive Development Advisory Council also agreed there should be a review of the pension system for military personnel and for policemen.

The Cabinet-level Development Budget Goordination Committee earlier said the pension requirement of military personnel as of end-2016 amounted to P71 billion and that this could more than double in eight years to P187.9 billion.

In the 2017 General Appropriations Act, the government sought a budget of P3.35 trillion of which P110 billion was allotted the PNP and another P137.2 billion for the Department of National Defense with P137.2 billion.

Last September, President Duterte signed an executive order (EO) increasing the combat duty and incentive pay of the AFP and the PNP.

Under the EO, the combat-duty pay of the enlisted personnel of the AFP and the PNP was raised to a fixed rate of P3,000 per month, from only P500 in the case of the AFP and only P340 a month for the PNP. Rea Cu



AFP: HOW DO YOU RECOVER P105M FROM DEAD PENSIONERS?

The Commission on Audit (COA) has called out the Armed Forces of the Philippines for having yet to recover the excess payment of P105.33 million in benefits to pensioners who have already died.

In its annual audit report for the year 2016, COA said the AFP Finance Center reported having recovered only P127.11 million of the P232.44 million paid to deceased pensioners with no qualified beneficiaries.

This meant only 54.69 percent of the amount was collected, with GOA adding that the P105.33-million balance is "yet to be recovered or may no longer be recovered."

COA cited the military's "defective pension information system" and "ineffective monitoring system" in keeping track of the real status of pensioners as the cause for the overpayments.

"It appears therefore that these deceased pensioners were not regularly monitored as to their real status and that they were continuously paid although no longer qualified to receive benefits until their deletion from the payroll," read the COA report.

Auditors said this resulted in the wastage of government funds that should have been used for other valid and urgent claims.

urged AFP COA strengthen the control and monitoring of pensions funds to minimize undetected payments to deceased and unqualified pensioners.

It also pushed AFP to immediately remit the recovered overpayments to the Bureau of Treasury. INQ

"I admire them (Lady Maroons), they played good defense and often when we thought we killed the ball, they kept the ball alive," said Yongco



Price of a 'surgical' bomb for Mautes

IT IS amazing how partisan politics has polluted the air in Manila. The other day I asked on Twitter if anybody had information, which I needed, on the unit price of those "surgical" bombs being dropped on rebel lairs in Marawi.



Instead of a simple price tag, I got this impertinent tweet of a reply

"Cheap whatever the price considering the alternative. Maute wins and gays flung from rooftops." Huh?

Et was a good thing a retired AFP officer, sober at 69, emailed me a longer but more factual answer, with the caveat that the correct figures may have changed since he left the service. He said:

"The Armed Forces does not announce the types of bombs being used in Marawi. But many times, what are being referred to as 'bombs' in the media are not bombs but rockets and other small missiles. If the ones used are rockets, then they will not be too expensive.

"An ordinary dumb 250-pound bomb will cost something like \$2,000 to \$3,000 depending on the type and manufacture. Those US-made are more expensive, but practically all arms-manufacturing countries, including the Philippines, produce them. Floro used to make them.

"A 2.75-inch 'Hydra' ground-attack rocket costs a minimum of \$2,500. The cost will depend on its warhead. Air Force trainers pressed into service in Marawi are armed with these rockets. Also the SF 260 light attack planes as well as the MD500 choppers."

planes as well as the MD500 choppers."

I took the opportunity to ask also about armored, personnel carriers, such as the V-150, that our resourceful soldiers have converted into gaudy fighting machines clad in layers of cardboard and wooden planks scrawled with graffiti in the jeepney folk tradition.

He explained the seeming incongruity of wood and cardboard being used to protect steel armor.

"The soldiers in the field have discovered that RPG (rifle-propelled grenades) rounds just get embedded in wooden planks instead of exploding. These ammo have contact fuses na puputok lang pag tumama sa matigas na object like an armor plate."

With that input from the testing ground, the designers of the V-150 and other armored vehicles may want to go back to the drawing board.

WOMEN SAY YES TO PEAGE TALKS, NO TO MARTIAL LAW

ilipino women have been suffering for decades under a succession of governments who have promised change. Genuine social change, however, never came. Governments came and went, but the same social problems remained—kleptocracy, the plunder of our country's resources, widespread poverty, joblessness, landlessness, low wages.

Women became modern slaves, laboring without end in a futile attempt to ward off hunger and homelessness; suffering the lack of support services for their own basic needs; experiencing grave abuses of their human rights in the hands of men in uniform as they defend their land, their homes and their communities from local and foreign big business; experiencing sexual and other forms of violence against their person.

Women had high hopes when President Duterte came into power, even taking an active role when peace negotiations between the National Democratic Front of the Philippines and the government began.

We anticipated the realization of the Comprehensive Agreement on Socio-Economic Reforms (Caser) as a possible way to peace, a possible avenue for reforms in the fundamental issues of the nation.

which are also the fundamental issues of women land reform, expanded basic social services, national industrialization, an end to low wages and contractualization.

A sudden turn of events, however, threatens to put these initiatives into the dustbin. The government panel canceled the fifth round of the peace talks. The declaration of martial law in Mindanao worsened the climate of impunity with which the Armed Forces commit human rights abuses against peasant and indigenous communities.

Government response to the Marawi siege has turned severely out of proportion, with ground assaults and indiscriminate aerial bombings causing massive destruction and innumerable loss of lives. It is now a war against terror that has itself sown terror among the people of Marawi. A war gone awry, whose consequences are bound to fall heavily on women's shoulders as they struggle to rebuild what is left of their previous homes and communities.

The entry of US military forces into what should be a purely Philippine military and police operation in Marawi runs counter to the Duterte administration's pronouncement of adopting an independent foreign policy. US intervention threatens to turn our country into another labo-

ratory for a US-defined war, a war with no clear parameters and no clear boundaries.

As if these weren't enough, President Duterte's own callousness, as shown by his seemingly habitual jokes about rape and disrespectful treatment of women, abets his allies' misogynist attitude and the Armed Forces' impunity in violating women's human rights.

Women have had enough!

We demand genuine change We demand respect and guarantees for women's hitman rights. We urge the Duterte government to carry out its pronouncements for a truly independent foreign policy.

There can be no real peace without social justice. We call for the resumption of the peace talks and demand a successful conclusion to Caser. End Martial Law Now!

Moving forward after Marawi

y now it is obvious that our military authorities have not read "The Art of War" by Sun Tzu, the great Chinese general who said "if you know yourself but not the enemy, for every victory gained, you will also suffer defeat. If you know neither, the enemy nor yourself, you will succumb in every battle."

The worst debacle that the Armed Forces of the Philippines has suffered in decades could not have happened in Marawi if the authorities knew the enemy or if our intelligence networks have done their job of monitoring the movement of the jihadists, particularly in their massing of weapons and armed men in the city.

It was this intelligence failure, "of not knowing the enemy," that resulted in a few hundred bandits and terrorists, later identified as fanatics who have sworn allegiance to Daesh or the Islamic State (IS), holding hostage the whole country, rampaging through Marawi and leaving in its wake some 90 soldiers and scores of civilians killed, with hundreds more injured, and the displacement of thousands of families not to mention the massive destruction of the once idyllic and peaceful lakeside city.

Indeed, it was unthinkable for the AFP and the Philippine National Police, with P2.5 billion in intelligence funds, to have failed to detect the entry of the jihadists in a small city like Marawi.

In other words, the Marawi tragedy could have been prevented. There is no doubt about it.

Hence, as soon as the guns are silenced permanently, the Duterte administration must embark on a two-pronged campaign to learn from the lessons of Marawi and to right a wrong so as not to repeat this kind of "preventable" disaster in the future.

But first, our authorities must admit their failure. Only then can we move forward and give justice to those who died and suffered in the city.

The immediate need is, of course, to start a massive rehabilitation and reconstruction effort to restore Marawi to its former self as the bastion of Islamic culture in the country. That the government has earmarked P20 billion as initial funding is a step in the right direction.

But parallel to this, a nonpartisan and independent commission should be formed to look into the circumstances and series of events or developments that culminated in the well planned and highly focused attack on Marawi on May 23 that has upended all that the AFP as protector of the Filipino people has stood for.

The proposed commission is not without precedent. There was the Agrava Commission that looked into the assassination of Benigno "Ninoy" Aquino Jr. in 1983. There was the Davide Commission and later the Feliciano Com-

mission that probed the Oakwood mutiny in 2003, and the Melo Commission that examined political killings in 2006.

Unlike similar commissions in the past, the proposed fact-finding body would be just that: a fact-finding body. It is not aimed at building a case for criminal negligence against anybody or blaming any units of the military and police for what happened; it will deal only with the flaws and inadequacies in our intelligence agencies in their gathering and monitoring operations.

The objective is to plug loopholes in operations and institute needed reforms, such as more coordination, joint undertakings and intense training to fight new challenges to intelligence services, notably the emergence of IS in the country.

It is proposed that among those to be summoned are the top officials of the military, police, Intelligence Service of the AFP, National Intelligence Coordinating Agency, National Counter-Terrorism Action Group, and the different intelligence branches of the major commands, such as the Navy, Air Force, and Coast Guard. The officials in terror-plagued areas in Mindanao and experts in counterintelligence, both foreign and local, should also be summoned.

Terrorists dead in 51st day of fighting now at 389

MANILA. July 12 — As fighting between Maute Group terrorists and military reached its 51st day, an estimated 389 lawless elements were reported killed in the ongoing clearing operations along with 90 government troops.

This was bared by Armed Forces of the Philippines (AFP) public affairs office chief Col. Edgard Arevalo in a statement Wednesday.

He added that this information is as of 6 p.m. of July 11.

Also, number of civilians executed by the Maute Group terrorists remained at 39 while number of rescued individuals are placed at 1,723.

Arevalo said number of weapons recovered has been placed at 494.

Only Pres. Duterte can request extension of martial law — Pimentel

MANILA. July 12 -- Only Pres. Rodrigo Duterte can request for an extension of martial law in Mindanao, Senate Pres. Aquilino Pimentel III said in response to House Speaker Pantaleon Alvarez's proposed extension.

Alvarez earlier proposed a five-year martial law to rid Mindanao of not just the Maute Group but other terror groups as well.

"...Ang aking position is extension of martial law must be requested by the president. So, dapat sa kanya manggaling yung idea na kailangan ng extension hindi po galing sa kahit kanino (My position is that the extension of martial law must be requested by the president. The idea to extend it must come from him and not anyone else)," Pimentel told reporters in an interview.

"Siguro ang ginawa lang ni Speaker is pag merong request, he is open up to that period of time. Tinelegraph niya lang yung kanyang personal position (Perhaps what speaker proposed was if there would be a request, he would be open to that period of time. He merely telegraphed his personal position)." he added.

Duterte's declaration of martial law will lapse on July 22.

Pimentel said that a Senate security briefing with the martial law administrator and implementor, Defense Secretary Delfin Lorenzana and Armed Forces of the Philippines Chief-of-Staff Eduardo Año, respectively, has yet to be scheduled.

He said that it is only after the security briefing that they can decide on the timeframe.

He also clarified that the meeting with some senators, Department of Interior and Local Government officer-in-charge Catalino Cuy and Philippine National Police chief Director General Ronald Dela Rosa on Tuesday was merely a request from Cuy.

"The DILG OIC requested for a briefing. Requested for an opportunity to brief me about Marawi law and order situation," Pimentel said.

"The martial law briefing must be given by the martial law administrator who is the Secretary of National Defense and the martial law implementor who is the AFP Chief of Staff plus the National Security adviser," he added.

Two other senators were also open to the possible extension of martial law but noted that it is best to wait the security briefing before deciding on the timeframe of any extension.

Sen. Nancy Binay, like Pimentel, said that she would rather wait for the security briefing before giving a timeframe.

Binay said that she wanted to "restrict" the implementation of martial law to Lano del Sur noting its possible negative effects to tourism.

"Siguro nga tingnan muna natin kung ano yung mangyayari sa security briefing bago siguro natin bigyan ng timeframe yung pagkakaroon ng martial law kasi alam ninyo sa akin ang concern ko talaga bilang chairwoman ng Commitee on Tourism, talagang naaapektuhan ngayon yung industriya ng turismo pagdating dito sa usapin ng martial law (I think let's see what will happen during the security briefing before we give martial law a timeframe because my concern here as chairwoman of the Committee on Tourism, is that the tourism industry is really being affected)," Binay said.

"Maganda ngang pag-aralan din baka pwedeng i-ano [restrict] hanggang Lanao na lang yung coverage ng martial law (It would be worth reviewing if we can restrict the coverage of martial law to Lanao)?" she added.

Neophyte Sen. Sherwin Gatchalian said that Alvarez's proposed five-year martial law has "no basis".

"Sa akin, walang basis ang five years, dahil we want to get this over as fast as we can at gusto natin na magkaroon ng sense of normality na sa Mindanao at sa buong bansa (To me, five years has no basis because we want to get this over as fast as we can and we want there to be a sense of normality in Mindanao and the whole country)," Gatchalian said.

Gatchalian, chair of the Senate Committee on Economic Affairs, said that a five-year martial law extension could also send a "wrong signal" to potential investors in Mindanao.

He further said that prior to the martial law, there were several investors eyeing Mindanao. A five-year martial law, he said could make investors "hesitate".

The neophyte senator, however, said that he was open to a martial law extension but also stressed that he would wait for updates from the security briefing. (Azer N. Parrocha/PNA)

At least 300 civilians still trapped in Marawi: AFP

MANILA, July 12 — An estimated 300 civilians are still trapped in areas held by Maute Group in Marawi City where fighting is now on its 51st day.

This was disclosed by Armed Forces of the Philippines (AFP) spokesperson Brig. Gen. Restituto Padilla, citing reports of the Marawi City local government.

"There are estimates (of) about 300 or more who are still unaccounted for," he said.

The unaccounted civilians include residents who are still hiding in their homes or missing persons who may be hostages of the terrorists, he added.

Padilla said they are looking at the possibility of recovering or seeing additional remains of civilians killed by the Maute Group terrorists once they overrun the last remaining positions of the lawless elements.

"As of now, we have not gone into the interiors of previously held enemy areas and once we do that we may get the surprise of our lives and find numbers of cadavers left who have been killed by the enemy," he said.

Latest figures of casualties from the Maute Group are placed at 381, civilians at 39 and government troops, 90.

GOVERNMENT TROOPS RECLAIM 54 BUILDINGS IN MARAWI

A military spokesperson reports that the government's forces have recouped control over at least 54 establishments in Marawi City that has been occupied by the Islamic State-linked Maute group as the clashes in the city entered its 51st day.

Joint Task Force Marawi spokesperson Lt. Col. Jo-ar Herrera statedthat they are continuously conducting combat clearing operations and that there are still portions of the main area that are being turned into defensive positions.

He said in earlier statements that 800 buildings were yet to be cleared in Marawi, those of which are believed to be where the Maute members and snipers are based. Herrera added that more or less 80 Maute members were in Marawi.

Air strikes have been conducted by the military in the area to flush out the militants occupying the buildings in the city's business district.

Herrera then stated in the interview that Abdullah Maute prevails to in command of the remaing Maute members. However, they are yet to confirm Isnilon Hapilon's location, Hapilon is the appointed 'emir' of ISIS in Asia.

8 REBELS DEAD, 6 FIREARMS RECOVERED, A SOLDIER KILLED IN COMVAL CLASH

MAWAB, COMPOSTELA VALLEY PROVINCE – Combined troops of 25th and 60th Infantry Battalions encountered a group of 40 NPA rebels belonging to Secom 3 and PBC 4 at Brgy L.S. Sarmiento, Laak, Compostela Valley Province (CVP) on Wednesday morning, July 12. The same troops recovered eight dead bodies of the NPA and six high-powered firearms comprising five M16 armalite rifles and an M60 machine gun left by the fleeing rebels. A soldier whose name is being withheld prior notification of his family was earlier wounded but later expired while en route to the hospital.

Two days before, July 10, the troops of 25IB engaged in firefight the same rebel group in Brgy Casoon, Monkayo, CVP. On this said encounter, said troops siezed an NPA encampment.

Prior to this series of encounters. Ltc Ismael Mandanas, commander of 25IB said that they have been receiving reports that the same NPA rebel group will consolidate at Brgy Casoon to conduct tactical offensives prior to President Duterte's State of the Nation Address (SONA) in compliance with their communist leader's instructions.

Major General Noel S Clement, 10ID commander, lauded the bravery of the troops. Clement expressed sorrow while rendering his salute to the fallen soldier for offering the ultimate sacrifice in pursuit of peace for the people.

"We will not lower our guards against any armed threat that can harm the peaceful living of our people," Clement said.

Troops are still in pursuit of the fleeing NPA rebels. While Army-Police checkpoints were immediately established in the different areas of 10ID.
