



## CASINO ATTACK: 38 DIE

A lone gunman terrorized a hotel-casino complex near Ninoy Aquino International Airport early Friday, opening fire with an assault rifle and torching gambling tables. At the end of a long night, 37 guests and employees were dead from smoke inhalation. The gunman killed himself and police ruled out terrorism

When Gil Yongco heard that gunshots were being reported at Resorts World Manila's hotel-casino where his daughter, Hazel, worked, he immediately rushed to the scene—only to find chaos and the hotel in flames.

There was no one to approach for assistance, and Yongco had to fight off first responders with a desperate father's determination to see his daughter alive. "What should I do? No one could tell me anything But my daughter is still there," he said, pointing to the hotel, where black smoke continued to billow out from its broken front windows.

"Where is Hazel?" he desperately called out to policemen who, while sympathetic, also did not know how to respond. Yongco stayed with the press pack with his wife Cathy.

A hotel employee later said she had grabbed Hazel's phone as they ran out because she dropped it. When she turned back, Hazel was gone.

Hazel, 29, was a table supervisor at Resorts World. She was among those missing since early Friday, when a gunman the police said appeared to be crazy walked into the hotel with an assault rifle and started shooting and setting the place ablaze.

Full combat regalia

Hundreds of policemen and soldiers in full combat regaliatrooped to the hotel, one of the premier destinations in Manila fronting its main airport and just a stone's throw away from the military's Villamor Air Base. At least two armored personnel carriers were dispatched to scour the place for any sign of other fighters, but no one has yet been arrested

Around 5.30 a.m., four people walked out of the hotel, one of them fainting to the ground and rushed to an ambulance. They were shell shocked, caught by surprise by the attack, which came on the 11th day that the

military has been battling to retake Marawi City in Mindanao from the Islamic State-linked Abu Sayyaf and Maute gunmen believed backed by a contingent of foreign fighters

Yongco later conceded that his daughter may be among the 38 casualties in the attack. "Just give me the body please," he called on the authorities.

"We are deeply saddened by the loss of my sister, Hazel," her brother Mark told the Inquirer. "There is complete chaos in lawlessness," in what transpired, he added.

Like Yongco, casino high roller Arianne Johnson, 39, was also searching for some of the eight people she used to hang out with at the casino. She said she only knew her friends by their first names, but that she had grown fond of them on the slot machine floor.

### Lone shooter

When the alarm sounded, she said people started running from the second floor, as bursts.

of gunfire rang out. "We were running, people were shouting. It was chaos everywhere," she

"We rushed out when we heard at least four gunshots fired," Johnson said, adding that she was with a friend who worked at the security department of the casino. They watched the scene unfold on the closed circuit television camera.

The Philippine National Police chief, Director General Ronald dela Rosa, earlier said casino patrons ran screaming after a lone shooter fired an M4 carbine, a shorter version of the M-16 assault rifle, inside the Resorts World Manila complex across the road from Ninoy Aquino International Airport.

He said the crisis was over, hours before the smoke had cleared and the rest of the bodies were found

"Up to this time, we can't say this is an act of terror. Why? Because [the gunman] had done no other violent act inside, aside

from stealing chips and shooting at a TV. He did not hurt anyone. If you were a terrorist, you want to sow terror. You would have gunned down people," Dela Rosa insisted.

#### Manhunt

The man was wearing a backpack and carrying a liter of gasoline which he poured on a gambling table before setting it alight.

"We reviewed [the video] recording, we did not see that he took any hostages. In fact, he passed by some people. He ignored some people," Dela Rosa said.

The incident sparked a manhunt and hours later, police announced that the gunman had killed himself after firing at security forces.

"He killed himself. At room 510. It looks like he was alone. chief Oscar Albayalde. "Our assessment is he burnt himself. He committed suicide," he said. urpose: Serving the people. Securing the land.

Dozens of soldiers and police officers in body armor and carrying rifles deployed around the hotel after reports of a shooting spread quickly through social media.

Two armored personnel carriers could be seen outside the hotel hours after the shooting, which took place as government security forces were locked in a 10-day firefight with militants from the Maute group who were waving the black flag of the Islamic State (IS) in Marawi.

"Right now, we cannot say that he is a member of the Maute," Dela Rosa said of the casino gunman.

### 'Terror attack'

In Washington, US President Donald Trump opened a news conference at the White House by commenting on what he described as "the terror attack in Manila."

"We are closely monitoring the situation," Trump said. "It is really very sad as to what's going on throughout the world, with terror. Our thoughts and our prayers are with all of those affected."

The US-based SITE Intelligence Group, which monitors the online communications of extremist groups, reported that "an Islamic State Filipino operative who provides daily updates on the ongoing clashes in Marawi stated that the group (was) responsible for the attack at Resorts World Manila."

But the police said the claim could be propaganda.


"As far as the Philippine National Police is concerned, we can't attribute (the attack) to terrorism without concrete evidence. IS can claim anything as part of its propaganda, but until we know the man's motives, we can't tell at this early stage, Dela Rosa said, using another acronym for IS. INQ

# Deadly Dight in the casino

Security guards shot and wounded the gunman who attacked Resorts World Manila early on Friday before he forced his way into a room of an adjoining hotel and killed himself, the top official of the hotel-casino complex said.

Stephen Reilly, chief operating officer of Resorts World Manila, also said 13 employees and 24 guests, one of them the wife of Pampanga Rep. Aurelio Gonzales, died from suffocation and smoke inhalation after the gunman torched gambling tables in the casino.

Police said 38 people, including the gunman, died in the attack on Resorts World Manila, a complex of hotels, restaurants, stores and a sprawling multifloor gambling area near Ninoy Aquino International Airport.

Two of the dead employees and six of the dead guests remained unidentified on Friday night.

### Not terrorism

The attack sent hundreds of people fleeing into the night outside the Resorts World Manila complex in Pasay City and produced a claim of terrorism that Malacañang and the Philippine National Police stressed had no evidence to support it.

US President Donald Trump referred to the attack as an act of terror, but Malacañang and police officials said the attack was the work of an "apparently emotionally disturbed individual" who acted alone.

They also cautioned people fe against spreading false claims that the Islamic State (IS) group was behind the attack.

"All indications point to a criminal act by an apparently emotionally disturbed individual Although the perpetrator gave warning shots, there apparently was no indication that he wanted to harm or shoot anyone," presidential spokesperson Emesto Abella told reporters

Abella also said authorities found no link between the attack and the terrorist siege of Marawi City that entered its 11th day on Friday.

Robbery?

IS claimed responsibility for the attack, according to the group's Amaq news agency, but Philippine authorities suspected that robbery was the gunman's motive.

Authorities suspect the man, who stuffed his backpack with P113 million in stolen casino chips, was trying to rob the casino at Resorts World and fired an M4 assault rifle at TV screens and set fire to gambling tables to cover his escape.

"Either he lost in the casino and wanted to recoup his losses or he went totally nuts," said Director Oscar Albayalde, chief of the National Capital Region Police Office

While there was a claim on social media that a "lone wolf soldier" of IS was behind the attack, police noted that the gunman did not shoot anyone he encountered.

"He would have shot all the people gambling," if his goal was terrorism, said the PNP chief, Director General Ronald dela Rosa.

The attack happened just after midnight, police said.

Dela Rosa said security footage showed the gunman ignoring a guard who tried to question him at the complex's entrance, then going straight to the casino.

The man stuffed his backpack with gambling chips, fired

his assault rifle at TV screens and set gambling tables on fire by pouring gasoline onto them from a 2-liter bottle he carried, Dela Rosa said

It was not clear how the man smuggled the gasoline and rifle into the crowded casino.

Albayalde said the gunman may have an extra container of gasoline as well

#### Caucasian

The gunman, who Dela Rosa described as "white, with a mustache," about 1.8 meters tall and English speaking, fled the gambling area and barged into a room on the fifth floor of Maxims Hotel, which is part of the Resorts World complex.

He laid down on the bed, covered himself with a blanket, doused himself with gasoline and then set himself on fire, Dela Rosa said.

The gunman carried no identity documents, police said

The bag of high-value gambling chips—with an estimated worth of P113 million to P130 million, or more than \$2 million—was found in a toilet.

Reilly said hotel security guards shot and hit the gunman in the leg.

"Testimonies of responding members of Resorts World Manila security team confirm that we were able to shoot and wound the gunman," Reilly said.

"Severe loss of blood from a gunshot wound significantly slowed down the assailant and resulted [in] his holing up in a room where he took his own life," he added.

Reilly said reports that the gunman had lost heavily in the casino were "sheer speculation."

He also denied reports that a security guard accidentally shot himself.

Reilly said the report of an attempted robbery was being investigated, but insisted that "all of the resort's gambling chips" were in the management's possession.

Reilly said the man was already armed when he approached from the parking lot the "security point" on the second floor of Newport mall, which leads to the casino.

"With his firearm forward, world-cla he unloaded a number of shots He was in military attire. A security guard who was at the door all add: oa of X-ray screening tried to slow the assault down but unfortunately could not do so," he said.

Only one gunman

Reilly also denied online reports that there were two gunmen.

"On behalf of the victims" families and loved ones, we request everyone to refrain from spreading hurtful speculation and false information," he said.

More than 70 people suffered mostly minor injuries in the stampede to escape, police said.

A South Korean died of a possible heart attack suffered during the evacuation, the Department of Foreign Affairs said.

Albayalde said the gambling room was carpeted and the tables were combustible, and all the bodies were found in the smoky room.

Investigators were going check if the water sprinklers in the hotel worked.

Chief Supt. Tomas Apolinario, chief of the Southern Police District, said investigators were checking out a person of interest whose identity they based on the registration papers of a vehicle the gunman allegedly used in going to Resorts World Manila

Apolinario said security footage images showed the person of interest resembled the gunman. — with reports from DEX-TER CABALZA, AS AND REUTERS INQ

## PNP: No IS hand in Resorts World attack

Thirty-eight bodies were found inside a casino in Pasay City after a masked man burst in with an automatic rifle and set fire to a gaming room early yesterday.

Dozens of others were injured in a stampede as they rushed to leave Resorts World Manila after the man fired what police said was an M4 assault rifle and started the fire around midnight.

The burnt body of the gunman was found in a hotel room inside the complex about five hours later, Philippine National Police (PNP) chief Director General Ronald dela Rosa said.

Dela Rosa said the gunman only fired at a television screen and did not take aim at anyone.

Responding lawmen initially found 36 bodies in the casino, who they said died from inhaling smoke that had Turn to Page 6

become toxic because of the carpet on the gaming room floors.

"The victims who suffered from suffocation went up to 36," National Capital Region Police Office director Chief Supt. Oscar Albayalde told

reporters.

"Practically, (the bodies were found) in the gaming area of casino. They were all recovered from the gaming area. None were found in the rooms," he said.

Two more victims were later found in the second floor of the building yesterday afternoon. One of the victims was buried by debris from a portion of the ceiling that fell, while the other was found in one of the rooms covered with a blanket.

The gunman initially disappeared into the chaos of smoke and running people, leading to a manhunt through the complex that ended just after dawn when he was found dead in Room 510, according to Dela Rosa.

"He lay down on the bed, covered himself with a thick blanket, apparently poured petrol on the blanket and burned himself," Dela Rosa said.

Police said it appeared the suspect had killed himself after firing at officers searching the still-smoking building.

"Our assessment is he burned himself. He committed suicide," Albayalde added.

Police said earlier the man's

Police described the gunman as tall with pale complexion and a mustache and spoke English.

### No lapses

The attack sent hundreds of people fleeing through the complex and out into the night. More than 70 people suffered mostly minor injuries in the stampede to escape.

Resorts World Manila chief operating officer Stephen Reilly said 22 guests and 13 employees initially died in the incident

"It is with deep regrets that we confirm there were 35 casualties in this tragic incident, of which 13 are employees and 22 are guests," Reilly read from a prepared statement.

Reilly said they are doing to the families of the victims.

"This is also a very difficult time for all of us here in Resorts tried to grab millions worth. World Manila. We consider our guests, patrons and our employees as family," he said.

According to Reilly, the gunman initially figured in a firefight with casino security men. He said the gunman managed to escape though severely wounded, and was later found in a room where he had set himself ablaze.

Reilly stood firm that there were no security lapses on their part.

He said the security guards inside the complex were not provided firearms as a rule.

"We had an armed intruder who entered into the property. He fired his firearm. He was in combat attire. Security inside the premises do not carry firearms only on the outside of the premises," Reilly said.

"They (security guards) did not engage because you've seen that it would escalate the situation. Unfortunately, the situation did escalate a bit further, moving towards gaming areas," he added.

Reilly also maintained their fire safety measures "had worked as it should do."

He pointed out the issue was not about the fire, but the thick smoke that engulfed the gaming section of the establishment and eventually killed their patrons.

"There is proper ventilation in the property. Unfortunately, I think a lot there was a degree of panic, which I understand when people hear gunshots they are going to hide for cover, evacuating the property quickly. They seek shelter and that is why they were overwhelmed by smoke," Reilly said.

"Unfortunately, those victims suffer from smoke inhalation," he added.

Resorts World officials led by Reilly read the names of the victims.

Among the fatalities were P Ling Hung Lee, Lai Wai Chung and Lai Yu Cheeh while the other 15 identified guests are Filipinos. They are Caccam Katherine Cervantes, Pacita Comquilla, Pomenciano Vargas Jr., Susan Abulencia, Jaime Gaboy Jr., Ariel Abrogar, Cliff Reyneira, Rolando Sison, Eluterio Reyes, Antonina Alanigue, Sheila Malicse, Carmelita de la Cruz, Mielle Oliveros, Pamela Silvestre and Elizabeth Gonzales.

Four of the victims remain unidentified, Reilly said.

Reilly branded as speculation reports that the suspect was a previous guest at the casino who lost in gambling. He noted the police claim that the motive could have been simple robbery since the gunman tried to grab casino chips.


Reilly also hailed the police and security forces for immediately responding to the scene.

# Soldier killed in Marawi on final journey home

DUMAGUETE CITY-The remains of the Army officer slain in Marawi City who was from Bais City, Negros Oriental, arrived here Thursday on a Philippine Air Force plane.

2 Lt. MacGlen Abuyabor, 28, was killed by sniper fire Wednesday morning during a clash with members of the

Maute group in Marawi

Abuyabor received full military honors from the Army's 79th Infantry Battalion and the 2nd Negros Island Geographical Battalion at the Dumaguete-Sibulan airport.

In an interview, Police Officer 1 Jaykel Abuyabor, the younger brother of the slain soldier, said MacGlen visited them just last week in Bais from Lapu-lapu City in Cebu after complying with some requirements for his promotion.

MacGlen had already come from Marawi before working on his promotion but was asked to return, the

brother said.

The soldier's last message to him when they accompanied him to the bus stop was to take care of their parents and not to leave them alone, said PO1 Abuyabor.

His last text message, according to the brother, was to send roses this Saturday to a girl in Dumaguete that 2Lt. Abuyabor appeared to have interest in, he added

The police officer said he would send the flowers to the girl this Saturday

According to him, the family first knew on Wednesday through social media that Abuyabor was wounded but later the classmates called him and somebody from G-1 of the Philippine Army also called to confirm that he had died

Abuyabor was assigned to the Light Ranger Regiment of the SOCOM (Special Operations Command), his brother said.

Initial reports reaching the family said the soldier was shot twice on the right side of his body around 6 a.m. Wednesday, but his body was recovered several hours later because of the presence of terrorist snipers.

Evangeline and Alex, Abuyabor's parents, said he was too young to die Evangeline appealed to President Duterte to do all that it takes to end the crisis in Marawi or more soldiers could be killed.

Addressing the Maute group, she said they were ruthless in killing his

Abuyabor was in the Army for three years and had graduated cum laude with a degree in business administration from the Negros Oriental State University in Bais.

The soldier will be buried in about three days, his brother said. (PNA)

# Maute using human shields, prevents troops from clearing Marawi of extremists

### By GENALYN D. KABILING

Martial Law administrator Defense Secretary Delfin Lorenzana gave ground troops until yesterday to resolve the Marawi crisis.

But the self-imposed deadline was not met.

Armed Forces spokesperson Restituto Padilla said efforts to flush out Maute extremists were hampered by their use of civilians as human shields.

Padilla admitted the troops have calibrated their movements to avoid endangering the lives of civilians trapped in the conflict.

"Based on the report that we're getting, I don't think we can meet that deadline today (June 2) to completely — I'd like to qualify that — to completely free Marawi of every single armed element on every street," he said in a Palace press conference.

"Compounding the situation on the ground is the use

of these forces, these armed elements, of children and civilians as human shields," he added.

Padilla said the troops would abide by the rules of engagement when faced with such "complexity of war," citing their commitment to ensure the safety and protection of women and children.

Sniper nest

"There are international protocols related to this kaya nag-iingat tayo. We have to protect children, we have to protect women, we have to protect innocent lives," he said.

Apart from the use of human shields, Padilla said the militants have also turned the madrasahs into staging areas and the mosque as sniper nest. Such tactics were employed by the rebels in their hope "to limit the movement of our forces and their capability to neutralize them." he added.

Padilla made clear that deadlines are "relative to the amount of resistance that still exists and the threat in the area."

"It was a deadline that was set forth and provided by the Secretary of National Defense so we can aim for it. But the final decision actually rests on the ground commander," he said.

For now, Padilla said the military is doing its best to accomplish their mission, mainly to clear Marawi of armed elements and rescue trapped residents immediately. And they will never run out of ammunition.

"And even if they want to keep this fight up to the end of this month, or this week, or whatever, we are determined to take care of all these forces that have brought and disturb the peace, brought violence, and disturb the peace to the peace-loving community of Marawi," he said.

He said the military will continue to apply commensurate power on these threats as pockets of resistance, including the use of air strikes despite the recent botched bomb run that left 11

soldiers dead.

The enemies have presently occupied commercial buildings as their "defensible enemy lairs" which are now the subject of military action, Padilla explained.

He said the botched air strike in Marawi City is currently under investigation by the Board of Inquiry, "The aircraft and the crew involved have all been pulled out and are administratively back in their headquarters for debriefing as well as counseling," he said.

### Relieved

Meanwhile, Reuters reported that the Army general leading the offensive against pro-Islamic State militants holed up in Marawi has been relieved of his command, an army spokesman said on Friday, the 11th day of the country's biggest security crisis in years.

The removal of Brigadier General Nixon Fortes as commander of the Army brigade in Marawi City was not related to the battle that has raged in the city, the spokesman said. He was replaced by his deputy, Colonel Generoso Ponio,


On Wednesday, an air strike aimed at flushing out rebels killed 10 troops, a major blow that the army said was an accident of the sort that sometimes happens in the "fog of war."

Asked if the course of the conflict was the reason for Fortes' replacement, spokesman Lieutenant-Colonel Ray Tiongson said: "That's not the reason."

A military source, speaking on condition of anonymity, said Fortes was dismissed because not all his forces were in the city when the rebels began their rampage, even though military intelligence had indicated that Islamist militants, including foreign fighters, were amassing there.

The source said some of Fortes' forces were busy fighting a small band of communist insurgents in a nearby town when some 400 militants took over some barangays last Tuesday after a botched military raid to capture their leader, Isnilon Hapilon.

Thirty-nine members of the security forces have been killed in the Marawi battles, as well as 19 civilians and 120 Maute fighters. (With a report from Reuters)



Maute group have launched widescale atrocities in Marawi City last May 23 after government troops attempted to arrest him.

Padilla said civilian death toll remains at 19, pending the continuing clearing operations despite reports that more were likely killed.

"The reports remain for validation and until such time that these are validated accordingly, we cannot include them," he added.

Civilians rescued in the ongoing operations have also increased to 1.024

### Mante to blame for 'friendly fire'

Allies of President Rodrigo Duterte in the House of Representatives, meanwhile, blamed the Maute group for the "friendly fire" that killed 10 soldiers in Marawi City.

House Deputy Minority Leader Alfredo Garbin cited the legal principle of "proximate cause" in pinning the blame on the Maute for the soldiers' death.

"He who is the cause of the cause is the cause of the evil cause." he stressed.

A Philippine Air Force plane was doing bombing rounds to flush the terrorists out of the city when the incident happened.

According to Garbin, under the proximate cause tenet, the person who caused something bad to happen is the person who should

be charged in court.

"But then again AFP should be extra cautious and improve its capability and intelligence on the ground to avoid similar incidence and the continued loss of precious lives, including our soldiers," he said

Davao City Rep. Karlo Nograles also believes the guilty party is the Maute

"Casualties resulting to unexpected mishaps are certainly something that we should frown on but in war, things like these can happen. Miscommunication can happen amid the chaos of war and our soldiers in the field, no matter how hard they train, may commit mistakes," he said.

Nograles, who is a lawyer like Garbin, added: "We have no one else to blame for his incident but the terrorists who are spreading this wickedness."

The lawmakers came out with the statement even as the AFP started its own investigation on the incident.

Sources of terrorist weapoury

The military, for its part, said it will trace the source of the Maute group's high-powered firearms and ammunition once Marawi City has been cleared of terrorists.

"On the firearms they are using against government security troops, it looks like they have stockpiled them for some time, and we have captured a lot of them in the past few days. We will know where they acquired them once our investigation starts. Padilla said in Filipino

While he did not identify any possible supplier, the military official said they are not discounting the possibility that the group's weapons and ammunition are sourced from the black market or from undisciplined government security force personnel.

## Marawi airstrikes to continue

Despite an accident that killed 10 soldiers (not 11 as the military earlier reported) during a bombing run on Wednesday, the military will continue airstrikes in Marawi City, where government troops are alocked in battle with pro-Islamic State terror groups.

Brig. Gen. Restituto Padilla, Armed Forces of the Philippines spokesperson, said the incident was being investigated while the crew involved had been pulled out of the battle zone so they could undergo debriefing and counseling.

The debacle, Padilla said, would not suspend airstrikes.

"We continue to apply commensurate military power on these existing threats and pockets of resistance, and will continue to do so, including the use of airstrike," Padilla said in a press briefing in Malacañang on Friday.

He said the military was not likely to meet the deadline imposed by Defense Secretary Delfin Lorenzana to end clashes in Marawi by Friday, the 11th day

of fighting between government troops and the terrorists.

The final decision on what happens on the ground rests with the commander in the area, Padilla said.

"And based on the report that we're getting I don't think we can meet that deadline today (Friday) to completely—I'd like to qualify that—to completely free Marawi of every single armed element on every street," he said.

"So until such time that every member of this armed group, this rebellious group that still wants to make a stand inside Marawi exists, we cannot totally say we have cleared Marawi," he added.

A Reuters report said 39 soldiers had been killed in the Marawi clashes, as well as 19 civilians and 120 terrorists.

### Army commander sacked

On Friday, a military spokesperson announced the relief of Brig. Gen. Nixon Fortes as commander of the Army brigade in Marawi City.

Lt. Col. Ray Tiongson, who was speaking for the military, said Fortes' removal was not related to the fighting in the city.

Fortes' deputy, Col. Generoso Ponio, took over command of the brigade.

A military source, speaking on condition of anonymity, said Fortes was dismissed because not all his forces were in the city when terrorists from the Maute group began their rampage last week, even though military intelligence had indicated that Islamist gunmen, including foreign fighters, were massing up there.

### Victory

The source told Reuters that some of Fortes' forces were busy fighting a small band of communist insurgents in a nearby town when some 400 gunmen overran Marawi City on May 23 after a botched military raid to capture one of their leaders, Isnilon Hapilon

President Duterte on Friday assured soldiers of victory in the fight against extremism, saying they would prevail in the end even if they suffered losses.

"When it comes to extremism, we will win. We will have losses, that's how life is governed in this universe, you would never

know when. But to say we will lose, that's impossible," the President told soldiers in Ipil town in Zamboanga Sibugay province.

He said he was willing to step up government efforts against the extremists and promised them that the government would acquire more jets and new military equipment.

"It has to be brand new. I would no longer accept secondhand military equipment. The ones being given by the Americans, I don't want them, even if I have to spend double the money," he said.

Mr. Duterte told the soldiers that the fight the government was waging would be longer because unlike its enemies, the government cared about protecting civilians.

"We are a government and we are bound by rules and even treaties," he said.

If the government waged war like the terrorists, the conflict would have long been over because it could have just bombed everything, he said.

"This is a rebellion where we fight [in a] civilized way of dealing with the problems of the

country," Mr. Duterte said.

"We should carry on for as long as we can accept this. If not, then we raise the fighting to a higher degree—raise it one bar," he said.

This does not mean, though, that the government would be like its enemies.

"We cannot say that we will follow them. We are a civilized nation and we have a well-disciplined military and we also value human life even if we have to destroy sometime," he said.

Padilla said the military was doing its best to complete its mission quickly.

Among the things hindering the swifter completion of military operations in Marawi was the caution troops had to take to ensure that civilians would not be harmed, he said.

Padilla said the armed groups in Marawi were using children and civilians as human shields The terror groups have also been using madrasahs (learning centers) and mosques as staging areas and sniper nests, he said.

As the fighting raged, the government and the Moro Islamic Liberation Front (MILF) set

up the peace corridor in Marawi to provide a safe zone for those displaced by the conflict, said Irene Santiago, chair for the Bangsamoro peace process.

Santiago said they would also put up joint coordinating, monitoring and assistance centers in Marawi and in Malabang town, Lanao del Sur province, as well as a mobile center that would go around evacuation centers in the peace corridor,

She said 300 members of the joint peace and security teams would be deployed throughout the length of the corridor. More forces would be added as the need arises.

"The peace corridor is a manifestation of the shared vision of [the] government and the MILF of what our society should look like, one that is open, inclusive, compassionate, just and cooperative," she said.

The corridor seeks to offer a safe space for civilians, including the wounded and evacuees, as well as for relief goods. It was created to facilitate the delivery of humanitarian aid to those affected by the fighting, -WITH RE-PORTS FROM ALLAN NAWAL, FRIN-STONLIM AND REUTERS INQ

## Military resumes irstrikes in Maray

ZAMBOANGA CITY -The military resumed Thursday its airstrikes against pockets of defensive posi-

tions of the Islamic State (IS)-inspired Maute group, barely hours after a bomb run accidentally hit and killed 10 soldiers in Marawi City, Lanao del Sur.

This time, after 10 days of intense clearing operations, the Philippine Air Force (PAF) unleashed its FA-50 sonic jets to assist ground forces battling the well positioned Maute and Abu Sayyaf groups backed by foreignbased terrorists

It grounded Thursday the Italian-made SF260 Marchetti trainers' plane following the bomb run that accidentally hit the troops' position, killing 10 soldiers and wounding seven others who were manning the blocking posts

Yesterday afternoon, President Duterte went to Ipil town in Zamboanga Sibugay to boost the morale of the 102nd Infantry Brigade, saying the government will win over terrorism.

"We choose to be in government so we are always in jeopardy. But that's beside the point. The point is we are fighting for a principle and that is what it is... but to say that we would lose (this), that's impossible. It will just

take a longer period (to win), Duterte said, pointing out that unlike terrorists, government forces need to adhere to the Geneva Convention and lessen collateral damage.

as human shields; (b) that the enemy is using madrasahs (Islamic schools) as staging areas and mosques as sniper nest," Padilla said in a report released to the media.

Padilla said 36 government troops have been killed in action during the ongoing clearing operations in Marawi, a Muslim majority city in Lanao del Sur province that is part of the Autonomous Region in Muslim Mindanao.

The number Maute members killed remained at 120, but gunmen continue to occupy some commercial establishments "defensible enemy lairs," he said.

Padilla said the military's focus is on clearing operations, the rescue of trapped residents, recovery of civilian casualties, and assistance to local government units, civil society organizations and nongovernment organizations conducting relief operations...

"[We] continue [to] call on the remaining terrorists to surrender while there is an opportunity or face the dire consequence of military action." Padilla added.

## 'Human shields' stall cearal

THE use of human shields have made the military helpless to free Marawi City of ISIS-linked Maute group bandits yesterday.

"Compounding the situation on the ground is the use of these forces, these armed elements of children and civilians as human shields,' AFP spokesman Brig Gen Restituto Padilla said at a news briefing yesterday.

Padilla said terrorists continued to occupy commercial buildings. He added they had also turned madrasahs as staging areas and the mosque as sniper nest.

We continue to apply commensurate military power on these existing

threats and pockets of resistance and will continue to do so including the use of airstrike," Padilla said.

Padilla stressed that the goal of the military offensives remain to clear Marawi from armed elements, rescue trapped residents, recover civilian victims and other potential casualties, and assist local government units as well as civil and non-government organizations conducting relief operations.

Padilla earlier this week told reporters after a fourhour closed-door executive session with senators that the military committed to accomplish the mission in Marawi City in the "fast-

est" way possible. Padilla said the death toll in the Marawi City siege has reached 175 after 11 more

soldiers died Wednesday. The AFP Spokesperson said the civilian and enemy death toll still stood at 19 and 120, respectively, while the number of those killed from the government

side rose to 36.
Among the latest deaths, 10 were killed after a fighter plane mistakenly hit troops on the ground with a conventional bomb, Padilla said. An ensuing gunbattle then killed another soldier.

Padilla clarified that the earlier report of 11 deaths from the "friendly fire" was wrong, as one of these men apparently died in the gunbattle that erupted after the bungled air strike.

He said the AFP Board of Inquiry has been tasked to investigate the incident, even as the military continued to extend support to the families of the slain soldiers and help personnel involved in the bungled air strike deal with the unfortunate incident through debriefing and counseling.

Padilla said troops continued clearing operations in Marawi City, as terrorists including members of the Maute and the Abu Sayyaf groups remained holed up in concrete structures, shielding them from military bomb runs. "Apart from that, they

have also been turning to the madrasahs as staging areas and the mosque as sniper nests, thereby hoping to limit the movement of our forces and their capability to neutralize them," he said.

## Gov't misses deadline to end siege

The government has been unable to meet its self-imposed June 2 deadline to flush out extremists in Marawi City after the troops faced some difficulties, including the rebels' use of civillans as human shields.

Armed Forces spokesman Brig. Gen. Restituto Padilla admitted the troops have calibrated their movement to avoid endangering the lives of civilians trapped in the conflict.

"Based on the report that we're getting, I don't think we can meet that deadline today to completely—I'd like to qualify that—to completely free Marawi of every single armed element in every street," Padilla said in a Palace press conference.

"Compounding the situation on the ground is the use of these forces, these armed elements of children and civilians as human shields," he said.

Padilla said the troops would abide by the rules of engagement when faced with such "complexity of war," citing their commitment to er sure the safety and protection of women and children.

# AEPfails to meet June 2 deadline

HE Armed Forces of the Philippines (AFP) admitted on Friday that it could not meet the June 2 deadline set by Defense Secretary Delfin Lorenzana to clear Marawi City of militants.

In a news conference in Malacañang, AFP spokesman Brig. Gen. Restituto Padilla said that no deadline has been set on defeating the Maute Group forces.

"We are doing our best to accomplish this mission immediately," he said.

"No deadlines are relative to the amount of resistance that still exists and the threat in the area. It was a deadline that was set forth and provided by the Secretary of National Defense so we can aim for it. But the final decision actually rests on the ground commander. And based on the report that we're getting, I don't think we can meet that deadline today to completely free Marawi of every single armed element in every street," Padilla told reporters.

"So until such time that every member of this armed group, this rebellious group that still wants to make a stand inside Marawi exists, we cannot totally say we have cleared Marawi," he added

Lorenzana, the administrator of martial law, earlier set the June 2 deadline for security forces to finish the Marawi crisis

As of the latest reports from ground commanders, Padilla said members of the Maute group still occupy some commercial establishments in the city.

Padilla said the military will continue their air strikes despite the bungled bombing that accidentally killed 10 soldiers.

"We continue to apply commensurate military power on these existing threats and pockets of resistance and will continue to do so including the use of air strike," he said.

He added that the aircraft and crew involved in the air strike that killed government troops have been pulled out of Marawi.

"The worst scenario that can be likened to the worst nightmare for every pilot who tries to assist his fellow uniformed services on the ground is to have a case or an incident like this," he said

Padilla clarified that only 10 soldiers were killed by "friendly fire."


"Continued efforts also is being exerted in our collaboration and coordination with other concerned agencies to ascertain the status of victims whose families continue to ask for assistance on their whereabouts, as well as those of the hostages that are known to us," Padilla said.

# Arrest orders out for narco pols behind IS-Maute

The Armed Forces of the Philippines (AFP) is now ready to conduct arrest operations against suspected drug personalities linked with the Maute group following President Duterte's statements that the Maute brothers have been using drug money to bankroll their goal to make Marawi City and the rest of Mindanao part of an Islamic State (IS) caliphate

"There has been a list that has been approved, that in effect indicates identified personalities that need to be arrested," AFP spokesman Gen. Restituto Padilla said yesterday in a Palace briefing

Padilla said he is not privy to the details "but this will be the subject of implementation in the coming days."

"I cannot divulge the names for security reasons. And whatever else that we can find in the next few days as potential supporters of this armed rebellion will be dealt with accordingly," he said.

Padilla also said once the Marawi conflict is finally over, the military will shift its focus to hunting down individuals or groups who may have supported the Maute gunmen and their foreign cohorts in attacking the city Tuesday last week.

Padilla said an investigation will be conducted to determine the sources of high-powered firearms used by the Maute-IS terrorists.

"On the firearms they have been using against government security forces, it looks that they have stockpiled for some time, and we have (seized) allot of them in the past few days," Padilla said.

Initially, the military said the high-powered firearms were acquired by the terrorists from the black market.

But Padilla said the defense and military leadership are also not discounting the possibility that some of these weapons came from rogue members of the uniformed services.

On top of this, the terrorists were also able to seize government-issued ammunition and firearms when they raided and ransacked the provincial jail in the city.

The terrorists also seized a number of high-powered firearms from policemen after their armored personnel carriers were disabled by rocket propelled grenades.

There were talks that, aside from their IS backers in the Middle East, key personalities in Mindanao supportive of the Mautes have provided the terronsts with logistical support.

Duterte declared martial law in Mindanao last May 23 following the breakout of hostilities in Marawi. He also suspended the privilege of the writ of habeas corpus

The other day, Department of Justice (DOJ) Secretary Vitaliano Aguirre II said the government has ordered the arrest of members of the Maute and

Abu Sayyaf groups and their Padilla noted. suspected supporters.

issued the arrest order in its capacity as administrator of martial law.

Asked if the military leadership will recommend that the drug issue be included in the coverage of martial law now being implemented in Mindanao, Padilla explained rebellion and invasion are the only two conditions under the Constitution that would warrant martial law declaration.

"There are no conditions other than those. The conditions prevailing right now in Marawi and elsewhere in Mindanao constitute rebellion and partly invasion and that is where martial law was based,"

The DOJ also said it is in The defense department—the process of selecting the members of the four panels of prosecutors that would handle the cases to be filed against members of the Maute group

Each panel will be composed of three members.

Aguirre likewise said they were thankful that prosecutors from Marawi City are safe.

"We need to provide them with all that we can to help them start serving the people again. Justice is a 24/7 commitment of the DOJ. The airlift of equipment and supplies to our prosecutors is our way of ensuring that we honor that commitment," Aguirre said. -With Jaime Laude, Evelyn Macairan

# Reds offer to join fight vs Maute

NOORDWIJK—Communist negotiators have offered a cease-fire and the deployment of New People's Army (NPA) guerrillas against local terrorists in a bid to revive the suspended peace talks.

"The GRP and [National Democratic Front] must act in consonance with the Filipino people's clamor for peace [and] reforms," the NDF said in a statement

The NDF issued the statement on Thursday after communist leaders Jose Maria Sison, Fidel Agcaoili and Benito Tiamzon met with government negotiator and Labor Secretary Silvestre Bello and government negotiator Angela Librado.

"Upon the success of the counterterrorist measure, these must cease to allow normalcy and full respect for human rights as soon as possible," Agcaoili added. INQ

## Duterte rejects Reds' offer to fight with AFP

President Duterte rejected last night the offer of the Communist Party of the Philippines-New People's Army (CPP-NPA) to deploy rebel fighters in Marawi ostensibly to show a united front against the Maute group, now the subject of military operations in the city after the declaration of martial law in Mindanao.

Addressing members of the Army's 102nd Infantry Brigade in Ipil, Zamboanga Sibugay, Duterte said he could not allow the NPA to "fight alongside government" until the rebels have signed a commitment for a peace agreement.

National Democratic Front (NDF) peace panel chairman Fidel Agcaoilí sent

a letter, offering to help the government fight the Maute, the President said.

"I don't know but I am not so keen about it. Anyway, it's a show of goodwill," he said

Duterte said he would not authorize presidential peace adviser Jesus Dureza and government chief negotiator Labor Turn to Page 2

Secretary Silvestre Bello III to go back to the negotiating table yet.

Duterte has been keen on having communist leader Jose Maria Sison and other leaders sign a document declaring a unilateral ceasefire.

"I will just be frank with them right now, either we continue to talk about peace but we have to stop fighting. I will not allow any talks on my behalf, or myself, since Dureza and Bello are there (in the Netherlands)," Duterte said, adding he had done his part by releasing old communist prisoners upon his assumption in office

"I will not allow or authorize them to go back to the negotiating table without them signing a document of unilateral (ceasefire), they would say that they will stop fighting," he added.

He recognized that there have been "pockets of rebellion everywhere," but these are not "large-scale."

During the opening of the fifth round of talks between the government and the CPP leaders last week, Dureza and Bello notified their counterparts that the government would not participate in the talks until it got an assurance that the rebels will not engage in atrocities in the countryside.

Duterte said the Islamic State will never allow the NPA or any group to join their ranks – in case the Islamic

groups emerge victorious against the government.

The President also expressed confidence that the government will win over extremism in spite of the headway the militant groups have made recently in the southern part of the country, particularly in Marawi City and Jolo.

"We will win over extremism. There is no way that extremists will win over us, over government," he told the soldiers

The President explained that what is happening now in the fight against the extremism of IS-affiliated Maute group and Abu Sayyaf is that the collateral damage is rather huge, given the loss of lives from the military as well as civilians caught in the crossfire during skirmishes or attacks

Duterte said the problem is extremists kill civilians without any care at all, which he said government cannot do.

The President said the Philippines is a civilized nation and could not do what the terrorists are doing

"We are a civilized nation and we have a military that is well-disciplined, that is why. Sometimes we are in a quandary," he added.

But the President vowed that when he steps down from office, the country will have a strong Armed Forces

#### Reds offer help, Du30 sets terms

COMMUNIST rebels on Friday offered to "cooperate and coordinate" with the Duterte administration in its fight against terrorism should the government return to the negotiating table, but President Rodrigo Duterte demanded they first rescindits orders to the New People's Army to intensify attacks on government troops.

After last-minute backchannel talks between negotiators of the government and the National Democratic Front in The Netherlands, the NDF said the Armed Forces of the Philippines and the NPA may be bound by a cease-fire agreement in specific areas to "counteract the Maute group and the Abu Sayyaf."

"In this connection, all panelists, legal and political consultants and other personnel in the peace negotiations must be Next page

allowed to return to the Philippines and subsequently attend the fifth round of formal talks," Fidel Agcaoili, chairman of the rebel panel, said in a statement.

Ageaoili also suggested a ceasefire agreement "in specific areas of cooperation and coordination ... pending the issuance of ceasefire declarations that are

unilateral but simultaneous and reciprocal."

He said both sides "must stand together to oppose and fight terrorism, terrorist groups and acts of terrorism."

"We must condemn and must be resolved and determined to counteract the Maute group and Abu Sayaff which are wreaking havoc in Marawi City," he said.

"By terrorism we mean actions that intimidate, terrorize and harm civilians solely or

mainly in violation of human rights and international humanitarian law," he added.

The fifth round of formal talks originally scheduled to end June 2, Friday was aborted May 28 as a result of a rebel call to increase attacks on government troops as a way of opposing martial law, which Duterte declared in Mindanao to combat the Maute group terrorists.

Duterte, however, said that he would not allow Peace Process Secretary Jesus Dureza and government chief negotiator and Labor Secretary Silvestre Bello to proceed with the fifth round of talks unless the Communist Party of the Philippines signs a unilateral ceasefire document.

"On our fight with the NPA, I don't know what will be the developments because Agcaoili wrote to me and I've shown it to the officers. They have offered to fight alongside us against terrorism," Duterte said.

"I will not allow any talks on

my behalf, [by either] Dureza or Bello. I will not allow them or authorize to go back to the negotiating table without them [the communists] signing a document [saying they] would stop fighting," he added.

Duterte also said he was not keen about the latest communist proposal.

Duterte earlier threatened to arrest and jail NDF consultants who might return to the Philippines after the aborted talks.

## Rody to MNLF: Integrate before helping AFP

ZAMBOANGA CITY— Integrate into the Armed Forces of the Philippines (AFP) first

President Duterte made this call to fighters of the Moro National Liberation Front as he clarified his statement regarding the offer of MNLF chief Nur Misuari to deploy 5,000 MNLF fighters in military operations against Maute militants and other terrorists in Mindanao.

"The President said MNLF members who would be accepted have to be integrated and placed under military control before they will help the government fight against terrorists," Said Mayor Ma. Isabelle Climaco-Salazar, citing her conversation with the President when she welcomed him at the Andrews Air Base yesterday on his way to Ipil, Zamboanga Sibugay.

Salazar had expressed concern over the President's statement that he had accepted Misuari's offer. Misuari and his men are

facing criminal charges in connection with the MNLF siege in this city in 2013.

Misuari and around 300 of his men were charged with rebellion and violation of the Humanitarian Law, genocide and other crimes against humanity over the siege that left more than 200 people dead and displaced over 120,000 residents.

"As far as Zamboanga City is concerned, we only recognize police and military forces to carry firearms. All others not belonging to the Philippine National Police and AFP will be apprehended if they are caught carrying firearms in the city," Salazar said.

She also urged Presidential Adviser on the Peace Process Jesus Dureza to set the guidelines on the possible deployment of MNLF fighters.

## MARAWI SIEGE SEEN AS ISIS'S FIRST ATTEMPT TO FOMENT WAR IN PHL

President Duterte's decision to put Mindanao under martial rule—even as some still see other motives—as reports and developments tend to lend credence to the belief that the raging conflict in Marawi City may just be the Islamic State of Iraq and Syria's (ISIS) initial battle in a war that it wants to stir in the country.

No less than Defense Secretary Delfin N. Lorenzana admitted on Wednesday that the imposition of martial law was not only meant to end the raging operations in Lanao del Sur's capital, but also to address the rebellion and the Islamic militancy-borne terrorism in the southern part of the country.

"The situation currently being dealt with by state security forces goes beyond Marawi City President Duterte's imposition of martial law aims to put an end to the long-running rebellion in various provinces in the South," a statement released by his office quoted Lorenzana as saying.

The statement also mentioned Lorenzana's recollection of the

Commander in Chief's repeated statements that if and when he declares martial law, he would use it to end all security-related problems in the region, including the terrorism posed by "local and foreign terrorist groups".

Same group

DURING the first day of the government operations, the defense chief admitted that the conflict in Marawi City was a "Maute Group/ISIS" campaign "because they are the same group", suggesting even that the pictures that have been exhibited by the militants in Mindanao's city were no different from the photographs of ISIS in Iraq.

### ISIS... CONTINUED FROM AX

While the Armed Forces continue to maintain its stance that the war in Mindanao's key Islamic city—an offshoot of the joint police and military operations to arrest Isnilon Hapilon—was waged by the homegrown Maute terrorist group for domestic atrocities, bigger reasons painted it rather differently.

For one, Maute's call is for an Islamic caliphate in the South after it has affiliated itself, or has been recognized by the ISIS, and its recognized leader is Hapilon, the acknowledged leader of the ISIS, not only in the country, but in the whole of Southeast Asia.

Hapilon, the commander of the Basilan-based Abu Sayyaf Group, has bonded together factions from all the three homegrown terrorist groups, which included the Bangsamoro Islamic Freedom Fighters (BIFF), for a single flag and for a single purpose, both under the ISIS.

Foreign jihadists

WHILE the war in Marawi City is being waged and resisted by the predominantly Maute with its local Islamic fighters, the military, however, noted the involvement of foreign jihadists in the fighting, most of them from neighboring Malaysia, Indonesia and Singapore, and even other "Arablooking" militants.

The presence of an unusually big number of foreign fighters in the clashes was something that the government has never seen or experienced in its years of dealing with the local terrorist groups in Mindanao, wherein, in some of its previous operations, it has killed one or even maybe two foreign fighters.

At the start of the operations in Marawi City, military Spokesman Brig. Gen. Restituto Padilla said security forces have killed at least six Indonesians and Malaysians, with the possibility that the number could grow, as government forces move to completely clear the city.

"There are certain foreign elements here who have been in the country for a long time aiding these terrorists in skills related to terrorism, primarily bomb making," Padilla said.

"There are also Malaysians, Singaporeans, and in the fight that has been ongoing in Marawi, we are continuously verifying that there have been a number of them who have been killed...so that confirms the presence of these foreign terrorists," the military spokesman also said in an earlier statement.

Before the weekend, various

reports in Malaysia claimed that at least 28 Malaysians have joined the Maute Group in the battle against government forces, confirming the statements of Padilla and other government officials about the involvement of foreign militants in the war.

Other than Malaysians, at least 10 Indonesians and Singaporeans, reports said, have joined the Lanao del Sur-based terrorist group.

The Malaysians reportedly arrived in Marawi City days before the fighting broke out, suggesting that the Maute and Southeast Asian jihadists were gearing up for a showdown with the Philippine government, with Marawi City as the scene and their object of conquest.

#### Heightened regional security

REPORTS also quoted an alarmed Malaysian Defense Minister Datuk Seri Hishammuddin as saying he was in communication with Lorenzana, and even with his other counterparts in the region, as the battle in Marawi City unfolds.

All the officials have also agreed to further heighten security within their borders with the Philippines, as they moved to quell the exodus of foreign fighters to Mindanao.

#### ISIS province?

AS the presence of foreign fighters in Marawi City alarms the country's neighbors, Padilla said they were still confirming the number of Malaysians, Indonesians and Singaporeans who were involved in the war, although their presence cannot be denied, as shown by battle casualty reports.

"We cannot confirm it still because they all looked the same. All the recovered bodies showed the same features and they do not have identification. So we still have to identify them, [a] process [to be undertaken] by the intelligence," Padilla said.

He emphasized that, while they could not deny the presence and involvement of foreign jihadists in Marawi as shown by the recovered bodies, they, however, need to have proofs to ascertain their so-called presence in big number and the extent of their involvement.

"For Marawi, there could be, but we have to ascertain first because we could not show proof," Padilla said, adding when the military says the foreign fighters were in the city, it must be backed by facts. "We cannot show proof, except from the information coming from no less than the network of foreign terrorists that they are there."

However, a clearer statement on the involvement of foreign fighters in Mindanao had been put up by Solicitor General Jose C. Calida, where he defined the rebellion in Marawi City as an "ISIS call".

He said, "What is happening in Mindanao is no longer a rebellion of Filipino citizens. It has transmogrified into an invasion by foreign fighters," whose players are Malaysian, Indonesians, Singaporeans and other foreign jihadists.

Calida said foreign Islamic fighters are responding to the call of the ISIS to travel to Mindanao and put up a wilayat, or an ISIS province.

#### Base

NOTWITHSTANDING the country's varied positions, security and counterterrorism experts in the region believe the Marawi City operations were part of the grand plan of Southeast Asian jihadists, who have fought with the ISIS in Syria and Iraq, to establish a base in the Philippines.

This idea cropped up during the security conference held in April in Singapore by the Milipol, wherein experts advanced the notion that Mindanao was an ideal base for jihadists returning from the Middle East because of its unstable condition and porous border, which could facilitate the easy transport of firearms and war materials.

Rohan Gunaratna, a Singaporean counterterrorism analyst, told the conference that the ISIS was already moving to "creating a territory in southern Philippines."

"The most recent communication issued by Islamic State [IS] has announced that they have formally declared an East Asia division of IS in the southern Philippines," he said.

On the other hand, Singapore's Home Affairs Minister K. Shanmugam declared that with the Philippine government's difficulty in controlling Mindanao despite its efforts, the country's southern region can become a sanctuary for returning ISIS fighters.

## Hoax messages about Maute presence decried

ILOILO CITY — The Philippine National Police (PNP) is urging the public to stop spreading hoax messages that claim that members of the Maute terrorist group were in Western Visayas.

"There is no truth to that," said Supt. Gilbert Gorero, spokesman of Police Regional Office for Western Visayas

Since terrorists attacked Marawi City last month, false text messages and posts on social networking sites have spread.

According to the false message, a Maute member has been spotted at a shopping mall, but did not specify the location. This particular shopping chain has branches in all four provinces of Panay Island—Aklan, Antique, Capiz, and Iloilo.

Gorero also clarified that many Muslims in the region were law-abiding citizens who run legitimate businesses and are unlikely to be involved in terrorist activities.

Gorero added that Chief Supt. Cesar Hawthorne Binag, the regional police director, said local Muslim communities in the region help collect intelligence for the authorities.

There is also a proposal to create a database of various local Muslim groups that easily identifies law-abiding Muslims and those that may pose a threat.

## 'Be wary of Visayas martial law plan'

BACOLOD CITY — A priest is urging the public to be vigilant following the pronouncement of President Duferte that he is considering placing Visayas under martial law.

Sumagaysay and Coscolluela also said the plan to suspend the writ of habeas corpus was unnecessary.

## Health chief Ubial denies IS link

processing company Winston Q8

based in Manila.

Speaking to reporters at a hotel here, Ubial said she is willing to shed light on the issue and expressed her willingness to cooperate with any investigation to look into allegations that the Department of Health sanctioned the continuing operations of Win-

ston O8

The Maute group, now fighting government troops in Marawi City since May 23, has pledged allegiance to IS.

Reports said Winston Q8 was allegedly managed by people who have connections to IS, but the accusation by some lawmakers in

the House of Representatives that Ubial has "ties" to the company is not only false but highly malicious and libelous, said a DOH statement released yesterday.

Ubial was accused of colluding with Winston Q8 for failing to stop the firm's accredited clinics from collecting exorbitant fees.

The DOH, through the Office of Health Regulations and Health Facilities, said it has revoked the accreditation of medical clinics contracted by Winston Q8 due to violations of existing laws, among them the collection of additional medical certification and visa accreditation fees to Kuwait-bound overseas Filipino workers (OFWs) on behalf of Winston Q8.

The agency noted eight of these medical clinics have since ceased operation. DOH also clarified it has no authority over Winston Q8.

The collection of extra fees reached the attention of the DOH last year and on Sept. 23, 2016, the agency issued Memorandum Circular 2016-0267 prohibiting all OFW clinics from doing the same.

The DOH said the OFWs "must get full protection on their rights to choose relevant medical clinics for screening

The collusion between these clinics and Winston Q8 has to stop."

Last March 9, the health department issued a preventive suspension order to the eight medical clinics involved in processing of medical certificates after receiving complaints of their continued activities despite the early directives.

On May 9, Úbial finally ordered these clinics closed

"It is clear and of common knowledge to anyone involved in the industry that the DOH under my watch definitely shut down Winston Q8 and never at any time facilitated their continued operation in the Philippines," she said.

Ubial said: "It should be understood by all that we at the DOH cannot have people or companies that we like and those that we don't like when we deal with sectors that we serve."

She said her office has to deal with everyone justly and fairly as public servants and that they are trying to eliminate the culture of favoritism and patronage politics

"We welcome any investigation; it will clear our name. My conscience is clear, I have not done anything wrong," she added.

The Department of Social Welfare and Development (DSWD) Field Office VII has sent 20,000 family food packs to Mindanao for families affected by the fighting in Marawi.

Last May 25 and 26, DSWD 7 sent

10,000 food packs to Iligan City and on May 28 and 29, another 10,000 packs were delivered to Cagayan de Oro City.

The agency provided support to DSWD ARMM and Northern Mindanao as part of government efforts to provide assistance to those affected, said DSWD Regional Director Evelyn Macapobre

Each family food pack contains six kilos rice, four cans of sardines, for cans of corned beef or beef loaf and six sachets of instant coffee

"Through the Visayas Disaster Response Center (VDRC), we were able to improve the production of food packs using the mechanized production system, storage of food packs and warehousing of food and non-food commodities," Macapobre said.

DSWD put up the center to improve emergency response through assistance from the United Nations World Food Programme (UNWFP) and the governments of Australia and the United Kingdom.

Since the center opened in April 2016, DSWD has sent relief assistance to Region 2 for Typhoon Lawin, Regions 5 and 8 for Typhoon Nina, and Region 13 for the 6.7 magnitude earthquake in Surigao del Norte

# The young distinguish between martial law in Mindanao-and in entire PH

n May 23; 2017, a band of rebels called the Maute group, invaded the city of Marawi, Lanao del Sur. Since then, disturbing images of destruction and violence in the city known as the Summer Capital of the South have flooded television, print and social media.

Insurgents took over a school and city hall, set a church on fire and held a Catholic priest and some parishioners hostage. Hundreds have been killed in the senseless battles that appear to have no end in sight just yet.

The spate of violence has led President Duterte to declare martial law in the whole of Mindanao—and he may just impose it "throughout the country to protect the people," he said.

Fearing a repeat of the abuses during 14 years of martial rule under then President Ferdinand Marcos, various groups staged street protests, while netizens expressed their views and frustrations about the situation. One notable online reaction came from some residents of Mindanao, who were annoyed by the protests of people who "aren't even from Mindanao."

We asked students their opinions about the Marawi conflict and President Duterte's decision to declare martial law.

#### Bomb threats Are you for or against martial law?

"Yes With what's happening in Mindanao now, especially in the Lanao areas, we need marzital law. So far, since President Digong declared martial law, we've been 100 percent okay with it. So far, the effects of martial law here have been posi

tive." —JJ Blasco, Mindanao State University-Iligan Institute of Technology


"Yes, I agree with the declaration of martial law, given that the Marawi clash happened so suddenly. If the President did not put the whole of Mindanao under martial rule, the chances of terrorists invading Marawi's closest cities are great. In fact, before the clash, neighboring cities were already getting bomb threats in their churches and malls. One thing I hope and pray for is that this martial law would not be as damaging as the martial law under Ferdinand Marcos"

## S pullout from Paris climate deal troubles Ph

#### By JANVIC MATEO

The decision of US President Donald Trump to pull the United States out of the Paris climate agreement could have an adverse effect on efforts to address climate change, the Climate Change Commission (CCC) said yesterday.

In a statement, the climate body said the Philippines is "deeply troubled" by Trump's move and urged him to reconsider his decision.

An official of the Department of Environment and Natural Resources said developing countries must unite and pressure the US not to withdraw from the landmark 2015 global agreement to fight climate change

Two senators and the In-

stitute for Climate and Sustainable Cities (ICSC) also assailed Trump's decision, calling it a step backwards.

Trump's decision drew anger and condemnation from world leaders and heads of

industry

The US president, tapping into the "America First" message he used when he was elected president last year, said the Paris accord would undermine the US economy, cost jobs, weaken American national sovereignty and put the country at a permanent disadvantage to other countries of the world

But the CCC said "the US, as the second largest emitter of greenhouse gases and, more importantly, one of the world leaders, would have played a key role in creating the much

needed global paradigm shift towards a more climate-resilient and climate-smart future."

The DENR official, who requested anonymity, said the US is a major contributor in terms of financial and technological support to agreements such as the Paris accord.

"Imagine if the US will withdraw its commitment, we will also lose the support it is providing," the official said.
"The Philippines, though it

gave its full commitment to the agreement, doesn't have the capability to execute the terms of the agreement even if combined with the efforts of other countries... given the lack of resources," the official said.

"Global protection should be everybody's concern. Let us convince the US not to turn its back on the agreement."

The CCC said the Philippines, as one of the most vulnerable countries to the adverse effects of climate change, "affirms its commitment to the Paris Agreement.

"We recognize the need for all countries to work together to address the increases in global temperature, which have resulted and will continue to result in more intense and frequent typhoons and droughts for the Philippines, threatening the security of our people, the food and water needed to sustain them and their livelihoods," the climate body said

"We call on all other countries that are parties to the Paris Agreement to become even more vigilant in ensuring that the Paris Agreement achieves its goal, as the future OFFICE OF THE of our children and this world depends on it," it added

The US was one of 195 nations that agreed to the accord in Paris in December 2015, a deal that former US president Barack Obama was instrumental in brokering. The US has committed to reduce its emissions by 26 percent to 28 percent from 2005 levels by 2025. The US, exceeded only by China in greenhouse gas emissions, accounts for more than 15 percent of the worldwide total

Sens. Loren Legarda and Juan Miguel Zubiri also lamented Trump's decision, saying the rest of world would have to work harder to reduce greenhouse gases:

It is unfortunate that Mr. Trump decided to pull out from the Paris Agreement. The decision reeks of ignorance and condemns US foreign policy into infamy. It is truly a sad day, but we are not hopeless,' Legarda said in a statement.

Legarda, who chairs the Senate committee on climate change, said one way to mitigate the effects of Trump's move is for US cities and states to enforce the Paris Agreement.

She noted the Americans are even eager to do their share to reduce greenhouse gases and they can continue to demand from their leaders and lead themselves along with the private sector.

Zubiri, a member of the committee, said other parties to the agreement must make sure they comply with the pact within the agreed timetable to help compensate for the US withdrawal - With Paolo Romero, Helen Flores, Rhodina Villanueva, Reuters

## Friendly fire

s of Thursday, 171 people have died in the fighting in Marawi City-19 of them civilians and 32 government forces. Of those soldiers who perished in battle, 11 carry an additional tinge of tragedy due to the unfortunate circumstances of their death. They were not hit in a fire fight with the enemy; it was a wayward bomb intended for the bandits and terrorists holed up nearby that killed them, and wounded seven others. A military investigation is now underway to look into the mishap.


"It's very sad to be hitting our own troops," Defense Secretary Delfin Lorenzana said. "There must be a mistake somewhere, either someone directing

from the ground, or the pilot."

The incident complicates the already thorny nature of the relentless air strikes that the government has ordered against the bandits and terrorists. Some 218,665 people have been displaced by the strife as of May 31, according to the Humanitarian and Emergency Response Team of the Autonomous Region in Muslim Mindanao. The Red

Cross adds that about 3,700 residents are still trapped in Marawi, unable to leave their hiding places as sporadic gun battles continue in the streets between government forces and the terrorists. The latter's position is located in a dense area of the city, said Lorenzana, making it hard for the military to hit targets with artillery.

In the "friendly fire" incident that involved 11 soldiers, the Maute and Army groups were reportedly hunkered down near each other in close-range combat in a cluster of buildings and houses. The aircraft that dropped the wayward bomb had earlier made three successful air strikes in the area, only for the fourth one to miss and hit the troops. The jets were using conventional bombs, not the precision bombs that the military had earlier said would make for

"surgical" air strikes that would not result in largescale damage to Marawi and its trapped residents.

The military has announced that the aircraft and its pilots are now grounded pending formal investigation of the incident. "It was very unfortunate and no one wanted it to happen," said Armed Forces chief of staff Gen. Eduardo Año.

Indeed, it must be heart-wrenching for the families of the soldiers to learn that their loved ones died, not in a heroic battle with the enemies of the nation—the singular task for which they had trained and dedicated their lives—but from a random mistake by someone on the same side. "Friendly fire" is an innocuously phrased but cruel-sounding euphemism for such incidents; friends and comrades on the battlefield are not supposed to end up killing each other, and the accidental nature of such circumstances, in the frantic heat of the moment when a soldier's split-second decisions may mean life or death, makes for a particularly harrowing kind of tragedy. The bombers and air controllers who made the apparent mistake that felled their comrades on the ground must also be in enormous pain over this accident—a deeply saddening event all around.

The violence in Marawi is in its second week. Clouds of dark smoke periodically rise to indicate the intensity of the conflict. Public support for the fight against the bandits and terrorists is palpable, though also tempered by fears that the fierce air strikes being done will eventually hit noncombatants and friendly forces, or flatten Marawi and leave its residents returning to rubble once the dust clears.

There should be no question that the military must accomplish its mission of freeing the city and the rest of Mindanao from the bandits and terrorists; that's what the island wide martial law declaration is for, according to Malacañang, despite the fighting being currently limited to Marawi. But as the swells of displaced Filipinos streaming into Iligan, Cagayan de Oro and other places grow by the hour, and the fighting goes on without letup, more trying days are ahead. We need to steel our souls, and reach out to help.

## MARTIAL LAW ENDANGERS WOMEN

he Women's Legal and Human Rights Bureau (WLB) adds to the voices of many groups condemning the proclamation of martial law and the suspension of the writ of habeas corpus in the wake of the Marawi crisis.

We are appalled by yet another rape joke made by President Duterte that, in effect, exonerates soldiers raping women as part of military actions. The President's obstinate and consistent sexist remarks are an affront to women and exacerbate the already grave condition that women and girls are in, in times of armed conflict.

Martial law emboldens and allows abuse of power by the military. Let us not forget the atrocities under the Marcos dictatorship Martial law is an assault to democracy and human

rights, including women's rights. We recall how women who opposed the dictatorial rule were sexually violated by the military.

We detest the proliferation of inaccurate and false accounts of the situation in Marawi made by government officials to create the illusion of security as justification for martial law.

We reiterate the obligations of the government as provided in international human rights law and domestic legislation. The Magna Carta of Women Act of 2010 (Republic Act No. 9710) obliges the government to protect women from all forms of gender-based violence, such as rape and other forms of sexual abuse, and all forms of violence in situations of armed conflict.

There must be an end to the

culture of impunity that normalizes sexual violence in armed conflict situations. The government, as the primary duty-bearer, must be held accountable for acts of violence committed against women by military, nonmilitary, state and nonstate actors.

We call on everyone to remain vigilant. We must not be complacent and wait until the full reign of martial law causes further harm and devastation, and more human rights violations with impunity.

Let not history repeat itself. We call on the President to lift martial law now.

## Visayan revolutionary forces during our wars of independence



OME of them are unknown, but their full recognition is due as the country marks the 115th anniversary this year of their roles in history - the Philippine-Spanish War of 1896-1898, and the Philippine-American War 1899-1902.

Their heroic exploits are documented in history books.

Some of the heroes' descendants have now organized themselves into the Visayan Heroes and Revolutionaries Descendants Association. It is led by lawyer Jose M. Villegas. a grandson of the late Gen. Miguel Malvar who was the last revolutionary general to surrender to the Americans in 1902.

The response from descendants around the country to an invitation to join VHRDA is overwhelming, according to the organizers. They now meet regularly to "fraternalize with each other and discuss valuable contributions of their ancestors'roles in repulsing foreign domination" in the Philippines.

Ms. Mala Jean A. Luga who has done exhaustive research work on these somehow forgotten heroes, said there were also personalities who used other means to win independence for the country.

One was Graciano Lopez-Jaena of Jaro, Iloilo. He used his pen in the Philippines' pursuit of self-rule, while in exile in Spain. He was a journalist, orator, propagandist. He was the editor of La Solidaridad, the newspaper that gained wide circulation abroad in 1889, and was secretly distributed in the country

The Visayan revolutionary forces were divided into three areas, with their respective commanders, thus:

1. WESTERN VISAYAS COM-MAND (Iloilo, Panay, Aklan, Capiz, Antique, Negros Occidental) - Gen. Martin Delgado of Sta. Barbara, Iloilo; Gen. Adriano Hernandez, military strategist of Western Visavas. (Camp Hernandez, the present headquarters of the 301st Infantry Brigade of the 3rd Infantry Div. of the Philippine Army in Dingle, Iloilo, was named in his honor); Gen. Teresa Magbanua of Pototan, Iloilo,known as the "Joan of Arc" of the Visayas; Gen. Pablo Araneta of the Panay Revolutionary Forces, Gen. Quintin Salas of the Iloilo and Panay Revolutionary Forces; Gen. Vicente Locsin, confidential intelligence emissary officer of the Central Revolutionary Committee based in Iloilo. (He coordinated with Panay and Negros Revolutionary Councils. the Cuartel General of the Spanish forces in Mangkas, now La Carlota City, Negros Occidental); Gen. Ananaias Diokno, reputedly to be the only Tagalog general to lead a full-scale military expedition in the Visayas against Spanish forces (During the Philippine-American War, he was appointed civil and military governor of Capiz): Gen. Aniceto Ledesma Lacson. known as the sugar baron and businessman (He was notable for leading the Negros revolution along with Gen. Juan Araneta, He was also president of the short-lived Republic of Negros); Gen Juan Anacleto Araneta y Torres, the Secretary of War for the Republic of Negros; Gen. Leandro Fullon, who joined the Katipunan in 1896 and was appointed by Gen. Emilio Aguinaldo to lead the Panay expedition up to Libertad, Antique, Gen. Francisco del Castillo with the martyrs of the Aklan Revolution, he was tasked by Andres Bonifacio to establish the Katipunan in Panay Island; Gen. Esteban Contreras, leader of the Revolucionarios in Capiz, Col. Diego de Diaz of Romblon (In 1898, He became the commander of the revolutionary forces in Romblon, then a part of Capiz province, in the island of Panay, Dionisio Sigobeyla of Cauayan, Negros Occidental, known as the "Lion of Kanlaon." (An ordinary plantation worker, he was called "Papa Isio." He led a religious-military section which waged one of the longest rebellions against foreign colonizers in Negros Island).

2. CENTRAL VISAYAS COM-MAND (Cebu, Bohol, Negros Oriental, Siquijor) -- Gen. Mateo Noriel Luga, the only Ibanag-Isabelino in the Visayan revolutionary Forces, he was personally handpicked by Gen. Emilio Aguinaldo and, then secretary of war Gen. Antonio Luna, to be the Katipunan's personal adviser to the Revolutionary Government of Cebu; Gen. Pantaleon del Rosario-of Scottish and English ancestry on his maternal side and lived in Imus, Cavite. (He was a key figure of the 2nd Revolutionary Center A street is named in his honor, where the present University of San Carlos in Cebu is situated.)

Gen. Gavino Sepulveda -- A native of Cebu who responded to call of arms during the Philippine-American War; Gen. Arcadio Maxilom — a teacher by profession, he was head of the Cebu Revolutionary Government, Gen. Troadio Galicano, originally entered the Seminary College of San Carlos for the priesthood, but joined the forces when the Philippine-American War

Gen. Pantaleon Villegas - Known as "Leon Kilat," he led the 1898 revolt in Cebu; Gen Luis Perez - one of the earliest Cebuanos to join the Katipunan

3. EASTERN VISAYAS COM-MAND (LEYTE AND SAMAR) -- Gen. Eugenio S. Daza. commander of the Eastern Samar Revolutionary Forces; Gen. Vicente Lukban. (Camp Lukban. home of the Army's 8th Infantry Division, or 8 ID in Barangay Maulong. Catbalogan, Samar, was named after

Ms. MJ Luga, on account of her extensive research effort on the above information, can well qualify as a history teacher and an archives annotator. She is the daughter of Col. Mateo H. Luga, a retired officer of the Philippine Army corps of engineers, and the former Lita Alviar Luga, a noted government PRO before her retirement.

## Martial law watch: Week 1



A TOMOTO PORT

HE country's biggest human rights alliance KARAPATAN released on Thursday its initial report on President Duterte's martial law and suspension of the privilege of the writ of habeas corpus in Mindanao (population: about 20 million).

The initial report – gathered by KARAPATAN through its network of human rights advocates, paralegals and allied organizations – should give pause to to everyone.

May 25

In the early morning of May 25, around 240 elements of the 39th and 72nd Infantry Batallion of the Philippin Army rained bombs and shot at Moro communities in sitios Pedtobawan, Campo, Apulan, and Centro Salat in Barangay Salat, and in sitio Libpas in Barangay Tuael, all in the town of President Roxas, North Cotabato. 105 howitzer cannons were mounted at Barangay Kisupaan, also in the same town.

Aerial bombardment was also reported in the Bukidnon barangays of Tangkulan, Anggaan, and Damulog

These areas are at least 100 kilometers away from Marawi City.

Residents said they saw military helicopters at around 10:00 am. The choppers dropped six bombs and airborne soldiers strafed houses. Six 105 cannons were fired at the communities

Four more bombs were dropped at 3:00 pm, and also another round of strafing and six 105 cannons unleashed.

Aerial strikes were again unleashed at around 7:00 pm.

"The bombings, as confirmed by Abdillah Makalang, barangay captain of Barangay Salata, resulted to the death of Abdullah Mamansag, 34, farmer, Maguindanaoan and resident of the said village. Mamansag was hit by a shrapnel in his spine and his right leg was cut off after being hit by a cannon," said KARAPATAN.

Two more Maguindanaoan residents of Barangay Salata — Norhamin Taligapin, 25 and Dodong (not his real name), 14 — were brought to the Amas Provincial Hospital after they were hit by shrapnels in the stomach and chest.

In Barangay Tuael, also in President Roxas, North Cotabato, and in Barangays Tangkulan and Anggaan, in the town of Damulog, Bukidnon, the 39th IBPA elements went on a firing spree attacking homes of residents with 50 caliber machine guns.

Elsewhere on the same day, at least 30 Lumad, Moro, and Christian women who participated in a gathering entitled "Leadership Development and Capacity Building for Gender and Ecological Justice" by the Ecumeni-

cal Women's Forum, were accosted and held for at least one hour and 30 minutes by the 6th Marine Landing Battalion in a checkpoint in Barangav

Domulon, Sultan Kudarat

The leaders were interrogated. forbidden to take down notes, asked to produce identification cards, questioned on their "permit to travel", told to write their names, had their photographs taken by a soldier, and endured sexist remarks.

Still on May 25, police arrested at least 260 persons from Barangays 76-A and 23 in Davao City - President Duterte's hometown and supposed most peaceful city - just because they failed to show IDs

**May 26** 

In Matanao, Davao del Sur, five gunmen on board three motorcycles shot to death Daniel Lasid, 58, a Blaan council member of Akma Aksasatu Matanao (Unity of Matanao)

Lasid, who was on his way to visit his child at Dalapo medical clinic, didn't survive the ambush. He sustained 11 gunshot wounds, mostly on his head.

Witnesses tagged members of the 73rd IBPA as the perpetrators.

Also on May 26, the PNP Regional Office of Region 11 threatened to arrest leaders of people's organizations and organizers of rallies, citing the declaration of martial law.

In Manila, the Armed Forces of the Philippines released a statement stating the military's intent to exercise its "right to censure".

May 27

Nestor Quintano, 51, and Ramon Rodela, 25, were forcibly taken by elements of the 66th IBPA. They are members of the Unyon sa mga Maguuma nga Nakigbisog (UMANA) and residents of Barangay Poblacion, Maragusan town, Compostela Valley,

Their wives who witnessed the incident said the soldiers barged into their homes at the break of dawn and mauled their husbands. Soldiers kicked them to the ground, stepped on their faces and tied their hands

The wives denied accusations that their husbands were members of the New People's Army. They said Nestor was a farmer and Remon a small-scale miner

The two were taken to the 66th IBPA camp before they were turned over to the Maragusan police station. Their families were not allowed to visit them while in the police station:

Meanwhile, a lone assailant gunned down Ana Marie Digaynon Aumada, 29, was gunned down inside her house in Barangay Lucod, Banganga, Davao Oriental

Prior to the incident, on May 25, 2017, Digaynon was called in at headquarters by Ltc. Jake Obligado, purportedly to "clear" her name. Two days letter, she was killed. Digaynon 2028. a world-

May 28

In a report dated May 28, 2017, the Department of Social Welfare and Development – Disaster Response Operations Monitoring and Information Center said that the situation in Marawi – as a combination of the result of the firefight and AFP air strikes – has already displaced at least 54,335 individuals.

Military operations which spilled over to nearby provinces have also caused the evacuation of 895 individuals in Saguiran and a total of 4,445 evacuees in the whole of Lanao del Norte. The bombings in Marawi and nearby areas have also

resulted in damages in civilian structures and people's homes.

May 29

Combined elements of 60th IBPA and the Bagani paramilitary group illegally arrested peasant couple Kidjol Marcelo Antay Sr. and Noeme Antay in Barangay Andap, Laak, Compostela Valley.

The same group also illegally arrested another couple, Otik Catalino and Maricho Catalino, in Barangay Malinao, also in Laak, Compostela

Both couples are active members of the Nagkahiusang Mag-uuma sa Laak (NAMULAK), a local peasant organization.

Witnesses said the two couples were brought to the 60th IBPA camp in Dona Andrea Asuncion, Davao del

KARAPATAN also noted that military and police set up checkpoints in Mindanao, Tacloban City, and in Metro Manila, while curfews were imposed in parts of Mindanao.

At the rate things are going, we must keep Mindanao in mind, speak freely and courageously, and remember the rally chant: "Never again, never again, never again to martial law!"

# Editorial Is Marawi burning?

THEY probably want to end their summer with a

That could be the reason behind the "North Luzon Inspection Trip" of at least 90 lawmakers that would take them across the region's "roads and highways, vital infrastructure and installations" to "ensure the maximum benefit, comfort and safety of the Filipino people."

The inspection trip that is also billed as a "working travel expedition" looks like a junket and these congressmen seem to be sending the message that they would be making a big sacrifice by traipsing through rough terrain and dangerous curves in the remotest parts of the country,

The expedition, for one, would stop at "tourist destinations," such as Vitalis (an exclusive resort that recalls ancient Greece in Ilocos Sur), the Banaue Rice Terraces, Baguio City, Subic (where the road inspectors are expected to go "yachting" or embark on a "cruise") and Fontana Resort at Clark (in Pampanga where there is a casino for high rollers).

Did these lawmakers just usure the job of the Department of Tourism or were they thinking that they can no longer take being strangers in their own beloved Philippines, hence, they hied off to some distant shores or Mad Max country?

Rey Umali of Oriental Mindoro, Cesar Sarmiento of Catanduanes. Rodito Albano of Isabela, Mylene Albano of Davao City, Rimpy Bondoc and Aurelio Gonzales of Pampanga, Nancy Catamco of North Cotabato and Eileen Ermita-Buhain of Batangas were among those "spotted" in the first batch of lawmakers who are participating in the travel expedition, which kicked off on June 1

Even if these lawmakers themselves shouldered the costs of this expensive trip to see the state of the infrastructure across Northern Luzon, it would still be a waste of time and money because they could just as well have invited the governors or mayors to a probe at the House of Representatives "in aid of legislation," of course, to give them the lowdown on this and that infrastructure project for the benefit of the local officials' "constituents."

If the government paid the tab, it would make the road inspection more unconscionable because the money spent for the inspection could have gone to more productive endeavors, such as to help the thousands of evacuees from Marawi City who are fleeing the terrorist Maute Group.

Better still, the lawmakers, who are led by Speaker Pantaleon Alvarez of Davao del Norte in the expedition that ends on June 6, could consider a "Southern Mindanao Inspection Trip" to show their concern for the women, the elderly and the children in the southern Mindanao city who will never be able to even imagine a trip to the Thunderbird Resort in San Fernando City, La Union, or the sand dunes of Pagudpud, Ilocos Norte, the two other tourist destinations in the lawmakers' itinerary.

In La Union, incidentally, Umali and company will have witnessed the "oath-taking of mayors [there] as new members of the ruling PDP-Laban" on June 1.

And we thought that the road inspection was all about, well, inspection.

Meanwhile, is Marawi burning?

No, it is not.

The "bad" news is that the "North Luzon Inspection Trip" is to be joined "officials" from the interior, public works, tourism and transportation departments; and the Philippine National Police and the Philippine Ports Authority.

The more, the merrier?

# Supreme Court power to review martial law proclamation: A political analysis

In response to the tirades from law students and lawyers, instead of backing off from this issue, I will push further my line of argument on the problematic nature of the power of the Supreme Court vis-à-vis a martial law proclamation.

Lawyers may dispute my arguments on the basis of their knowledge of the law. But I am a political scientist, and I do not intend to make this into a legal treatise, but one that thraws its logic from political analysis, which I can confidently claim as the academic province where I have built my comfortable nest.

Let me start with the pertinent provision of the 1987 Constitution, on the power of the Supreme Court vis-à-vis a martial law proclamation, which states that:

"The Supreme Court may review, in an appropriate proceeding filed by any citizen, the sufficiency of the factual basis of the proclamation of martial law or the suspension of the privilege of the writ of habeas corpus or the extension thereof, and must promulgate its decision thereon within thirty days from its filing "

A simple analysis of the phrase "the sufficiency of the factual basis of the proclamation" indicates that what is brought to the attention of the court is the factual basis of the proclamation only at the time it was issued by the President. This is the only issue that will be adjudicated in any petition that will be brought to the court. In fact, the Court has even



ruled in two settled cases, G.R. No. 141284 and G.R. No. 171396, that on matters of ascertaining sufficiency of factual basis in relation to the President's exercise of his commander-inchief powers, under which a martial law proclamation would fall, the court could not go beyond what is contained in the pleadings.

The dynamics of political violence becomes significant in understanding the issue. Any scholar of political violence, which includes terrorism, rebellion or invasion, will tell you that conditions attending these are so fluid and dynamic, and that they can change for the better or the worse. Furthermore, new information may emerge which are unknown at the time any President would declare martial law.

The high court is not a trier of facts. But in this instance, it is tasked by the Constitution to pass judgment on the sufficiency of the factual basis which was prevailing at the time the President proclaimed martial law.

On this alone, I can grant the argument that the Supreme Court prevails over Congress. But this superiority of interpretation, as revealed by the exchange between Commissioners

Bengzon and Bernas during the constitutional convention deliberations, is only on the matter of the sufficiency of the factual basis at the time the proclamation was made.

Thirty days, the time the SC is given to issue a decision, in addition to the days elapsed from the time martial law was proclaimed until the time the SC receives a petition, is enough for factual conditions to change. Whatever was the factual basis for the martial law proclamation, and the arguments used to assail this in any petition that is filed questioning that basis, which by nature is expected to be limited only to those which the President has invoked, may be rendered moot and academic by either or any of the following.

—When conditions have improved that there is no more need to continue martial law, which Congress can now address by refusing to extend it beyond 60 days, if it is asked by the President.

Or when conditions have worsened that even if the factual basis when the time martial law, was proclaimed may have been insufficient, that such has now been overtaken by severe developments that would warrant the continuation of the declaration, which again only Congress is empowered to extend, upon the request of the President.

Political violence is a highly stochastic and indeterminate political phenomenon. Scholars of political violence, mostly political scientists, have diverse theories and explanations as to its causes, processes and consequences.

Terrorism, rebellion and invasion are continuing and highly dynamic political processes.

And what complicates the matter is that the act of proclaiming martial law, the basis of which the court is being asked to judge as sufficient, could trigger a series of events that could alter prevailing conditions. This can influence the dynamic unfolding of the violent acts which martial law is designed to address.

This brings us to the conundrum that Commissioners Bengzon and Bernas addressed during the deliberations for the 1987 Constitution, where the latter indicated that the power of the court, while supreme on ascertaining factual basis at a given time, is also transitory in nature since those conditions may change.

Such conundrum emerges when a political event such as martial law declared at a given time to address a dynamic political process is subjected to judicial review. Courts are institutions that are designed to judge completed acts and time-based facts.

Forcing the court to render judgment on a complex and dynamic political process such as an ongoing rebellion, or invasion, or acts of terrorism, where what is factual today may no longer be tomorrow, creates contradictions and exposes loopholes that can only but reveal its vulnerabilities and the limits to its powers.

## Set Marawi free

MARAWI has a special place in my heart. I have visited this city many times in the course of my involvement with community women and my former political party. It is the home of friends and comrades, women and men I have worked with for decades.

Many of them were former leaders and active Moro National Liberation Front fighters under Nur Misuari. The women were members of the MNLF Women's Committee. I became friends with many, calling them by their real names, not knowing their "nom de guerre." It turned out that among my friends that I would spend time joking and laughing with, were "legendary" fighters who were feared by many. I only discovered this when other Moro friends told me that so-and-so was actually the feared so-and-so. Often, such information came as a big surprise because they were really kind, gentle, jolly men

We did numerous training among Maranao women. We talked about gender sensitivity, violence against women, women's political participation. and sexual and reproductive health and rights at a time when organizing Moro women was virtually unheard of I personally learned a lot about the Maranao culture from my sisters. in Marawi. (Well, they also revealed their skin regimen when I wondered aloud about their fair, smooth skin). Oh, we had many beautiful and happy times together!

Marawi is where I learned to eat and like "palapa," which I still crave to this day. Each time, along the road from Cagayan de Oro City going there, I would check if I could get Durian or Marang. Whenever available, my Moro sisters and

brothers would oblige to get me some that I would consume during the trip. They knew how much I liked these fruits.

Marawi was also where I would get my beautiful hand-woven Malongs, shawls, and scarves My sisters would bring me to their friends' shops and would haggle for me for items I

Maranaos do not deserve what is happening in their city.

wanted to buy.

By the time that we were beginning to organize these women in Lanao de Sur, I was already familiar with the longstanding Mindanao problem. The many first-hand stories of injustice I got from my comrades taught me many valuable lessons, including why they wanted to be called Moros rather than Muslims. My own readings and our political discussions on the struggle of the Moro people were given substance by those who actually experienced how they, as a people, were abused and discriminated against for many decades. Thus, organizing the women was something that I became passionate about.

Marawi was our base This was a not-so-safe-time to go because of reports of kidnappings and fighting in the area. We knew the danger but we were confident that we were adequately protected. We would fly to Cagayan de Oro City and would be fetched from there. We were not allowed to directly go to, or leave Marawi on our own. I knew that each time we travelled, the men with us were armed but they were always very discreet. We never really got to see any guns, at least, I

OFFICE OF THE ARMY CHIEF PUBLIC AFFAI did not in these instances.

For the duration of our visits, we were not supposed to go out without companions no matter if we were just going to walk around their area.

We were told that most, if not all homes and families in Marawi had guns. This was just how things were, and I guess, still are. We would stay in the homes of our women leaders when we were there. One night, while my companions were fast asleep, I needed to go to the toilet which was outside our room. As soon as I was out of the door, I was surprised to see a group of at least five heavily armed men huddled over a radio transmitter (mobile phones were still rare then). They smiled at me as these were men I personally knew and was friends with. It was my first time to see them armed and it was a bit disconcerting. In the morning I told the homeowner what I saw. She smiled and said that the men Turn to A5

where securing us, and that there were always at least two with, or near us for protection. This was how they operated when friends, especially non-Moro ones, come over

This set-up went on for a few years. At some point, I guess it was when things were much better, our brothers and sisters felt confident that we could already safely go on our own to Marawi, and we did. After the women's groups were established and operational on their own, my visits became less frequent. Over the past years, I only got to see my sisters when they went to Manila.

This year, I have plans of going back to meet with the groups there. And then Maute happened. When I first heard about the ISIS flag being displayed in Marawi, I immediately contacted the daughter of one of our leaders and she confirmed that things are bad. My

And the second s

Maranao sisters and brothers are always on my mind as I follow the horrific events happening there. I can only hope that they are all unharmed.


