'I will not negotiate,' President Duterte says as more soldiers are thrown into the battle zone. 'How about my soldiers who have died? How about [the terrorists'] murderous rampage?'

The military has sent more troops to Marawi after President Duterte rejected the offer of Maranao religious and political leaders to negotiate

By Nikko Dizon, Franklin A. Caliguid with Maute and Abu Sayyaf terrorists holed up in the city for an end to the crisis.

Troops from the Philippine Army's 82nd Infantry Battalion flew in two groups from Hollo City on Saturday to reinforce security forces in Marawi, battling the terrorists who seized the city on May 23 to establish an enclave for the Islamic State (IS) iihadist group in southern Philippines.

A total of 327 people have been killed in four weeks of fighting, including 242 terrorists, 59 soldiers and 26 civilians

The military deaths have angered

Mr. Duterte, who said he would not let this loss of lives pass unpunished.

Speaking to troops in Butuan City on Saturday, the President said he understood the desperation of Maranao religious and political leaders who had offered to talk to the terrorists to help bring the cri-

sis to an end

But he said any effort to bring the terrorists to the negotiating table might already be too late, as the terrorists appeared determined to fight to the death

"If they go to the Maute to talk, talk about what? Surrender? Settlement? Just like that?" Mr. Duterte said

"I will not [negotiate]. How about my soldiers who have died? How about [the terrorists'] murderous rampage?" he said.

The President said, however, that he would not block the plan of the Maranao religious and political leaders to talk to the terrorists.

"You do not need my permission to do that," he said, adding that he would not apologize for the devastation caused by the fighting in Marawi because the Maranao leaders had failed to act swiftly to help contain the rise of the Maute group in the city.

"But I am not apologizing for anything there, because they brought the problem to themselves. Why didn't they inform the police, me, the Armed Forces, that there were terrorists going in and out of the city?" he said.

#### Martial law stays

Mr. Duterte also said he would keep martial law until he was satisfied with the results of the military campaign to crush the terrorists in Marawi

"Martial law stays as long as there's fighting, until I am satisfied or we are satisfied that not a single shot will be fired ever again," he said.

He defended the military's bombing of targets in Marawi.

"There are places in Marawi that were bombed or are being

bombed now. And I am sorry to say that, it's because it is really already a full-blown war. I cannot sacrifice one single soldier," he said.

The death of a soldier last week as security forces advanced to step up pressure on the IS-inspired terrorists brought to 59 the government's losses in the fighting.

The military, however, has not identified the latest soldier to be killed in action and has not yet disclosed the circumstances of his death.

Col. Edgard Arevalo said on Sunday that security forces had rescued 1,636 civilians and recovered 243 firearms.

Efforts to rescue civilians trapped in the fighting, as well as those taken hostage by the terrorists, continued, Arevalo

said.

#### Weakening resistance

"Enemy resistance continues to dwindle and enemy-held areas continue to get smaller as troops advance," he said.

The military said earlier that the battle zone had been reduced to just four of the city's 96 villages, an area of about 8.7 square kilometers.

But the military advance was proving difficult because the terrorists were using civilians as human shields and mosques as staging areas for attacks on government troops, Arevalo said.

Another job proving difficult for the military was recovering the bodies of civilian casualties, as snipers were busy trying to keep off rescuers.

To hasten the clearing operation, the military sent in more than 800 troops of the Capiz-based 82nd "Bantay Laya" Infantry Battalion on Saturday

The battalion was formed in Iloilo in 2009 and until Saturday had not been deployed outside of Western Visayas.

The troops have been assigned to internal security operations in Guimaras province, Iloilo City and parts of Iloilo and Antique provinces.

Lt. Col. Vener Morga, the battalion commander, said the troops were ready to be assigned to the front lines in Marawi.

#### Battle capable

Morga, former commander of the Army's 55th Infantry Battalion assigned to Butig the order to go came.

town in Lanao del Sur province that operated against the Maute group, said he apprised his troops of the situation in Marawi and the nature of the operation against the terrorist group.

"The troops are already capable. This deployment will further improve the battalion's capability," he said.

The battalion was supposed to be assigned to Marawi in January, but was asked to stay to help secure high-profile events in Western Visayas, including meetings of the Association of Southeast Asian Nations.

The troops were again put on notice two weeks ago for possible deployment to Marawi, but it was only on Friday that

A statement from the 3rd Infantry Division said among those who attended the sendoff ceremony on Saturday was Antique Gov. Rhodora Cadiao, who thanked the soldiers for their work that "paved the way" to make Antique "insurgencyfree "

The 33rd Reconnaissance Company assigned to Negros Island has been brought to Hoilo to take over the area left by the 82nd Infantry Battalion.

Troops of the 61st Infantry Battalion based in Tapaz town in Capiz province have also been redeployed, according to Morga.

#### Reconstruction

With the battle against the Maute and Abu Sayyaf terrorists turning into clearing operations, Gen. Eduardo Año, chief of staff of the Armed Forces of the Philippines, said the military was prepared to start discussing the rehabilitation and reconstruction of Marawi

The military has prepared the Combat Engineering Brigades from the Army and the Navy for immediate deployment "as soon as the clearing operations [are] completed, Arevalo said.


"Task Force Ranao, [which] has just been activated, is in full swing in ensuring that efforts to save lives of innocent noncombatant civilians remain a primary specific task to be complied with. It likewise takes charge in the collating and in the distribution of relief goods to evacuees in tandem with the [local governments]," Arevalo said. INO

# NPA raids Iloilo police station

The government will suspend offensives against communist rebels to pave the way for the resumption of formal peace talks, the chief negotiator announced yesterday.

Labor Secretary Silvestre Bello III said the move was meant to reciprocate a declaration of communist negotiators last Saturday that the New People's Army (NPA) would stop attacks to allow the military to focus on the fight against Maute and Abu Sayyaf terrorists in Marawi. He did not say when the cessation of offensives would start.

Bello made the announcement hours after NPA rebels raided a police station in Iloilo's Massin town yesterday, seizing guns and robbing the police of personal belongings including cash, jewelry and laptops.

killed three NPA members in Davao Oriental and two others in Compostela Valley

"The Philippine government hereby correspondingly reciprocates with the same declaration of not undertaking offensive operations against the (NPA)," Bello declared

In Maasin, officials said about 50 raiders arrived on a tarpaulin-covered truck, passing the town proper teeming with the usual Sunday crowd before stopping in front of the police station along Taft Street.

Initial reports said two women from the 50 heavily armed band entered the police station and petended to file a blotter compaint. They surprised the nine policemen on duty at the precinct before announcing the attack.

Police reported no casualties, but the rebels took the weapons and personal belongings of the police including cash and laptops.

Vice Mayor Francis Amboy said he was prevented by armed men from going to the police station

Amboy said he learned of the attack and immediately proceeded to the precinct near his house when armed men blocked his path.

Amboy said he took cover but heard the rebels warning over a megaphone that civilians should stay out of their way.

The rebels assured the crowd that they meant no harm and would only go after

the police station, he said.

"I was taking cover but as they were leaving, I saw around 40 to 50 persons on board the Elf truck. They also commandeered the station's police car," he said.

Amboy said he saw some of the rebels were wearing bonnets to cover their faces

Some of them were shouting "Mabuhay ang NPA" before they escaped, Amboy said

He said several residents went scampering to safety while several stores were forced to closed shop for the day.

Western Visayas police director Chief Supt. Cesar Hawthorne Binag said when a truckload of armed men arrived, there were two policemen outside the precinct

They were pushed by the rebels to go inside where they joined their seven other colleagues who were disarmed, handcuffed and made to lie face down, he said.

Binag said Senior Inspector Ray Cordero, the Massin police chief, was not on duty at the time of the attack

"They were made to lie face down and the rebels stepped on their heads. In less than 15 minutes, it was done," Binag said.

The rebels took eight M16 rifles, four Glock pistols and five tactical radios.

They also carted away the policemen's jewelry, four mobile phones, two laptops and P29,000 cash.

"It was a case of robbery."

They were there only to rob the policemen," Binag said.

He said the regional police are tracking down the attackers who abandoned their getaway vehicles The police Toyota Hilux pick-up truck was found abandoned at Barangay Cagay, Alimodian while the Elf truck was found at Barangay Ingwan in the same town


The incident came a week

after the provincial police had warned of an impending attack from the NPA in the region.

Regional police deputy director for operations Senior Supt. Christopher Tambungan said Maasin was among 15 towns being targeted for attack by communist rebels

"They've been warned," Tambungan said

"I inspected this police station on June 3.

I already told them of the strategies that the NPAs might employ in doing their attacks, including those who are pretending to make blotter reports," he added

Following the incident, all 23 policemen of the Massin Police Station were ordered relieved and assigned to the regional police director.

They will be replaced by personnel from the Regional Public Safety Battalion 6, Tambungan said.

The government last month cancelled their peace dialogue with the communists following the spate of attacks on government troops throughout the country Yesterday's attack in central Visayas is the most recent.

Earlier, the Communist Party of the Philippines (CPP) relayed their stance against the Maute group in Marawi, condemning the militants for laying siege on the city and their effort to carve an Islamic State caliphate in Mindanao.

The four weeks of fighting in Marawi have left more than 300 dead and thousands of families homeless.

Despite their sentiments, the NPA engaged in the attack on Maasin.

Sources said the attackers are from NPA's Southern and Central front committees of the Komiteng Rehiyon-Panay

They noted that one front committee could not handle the attack.

Less than an hour after the incident, the NPA's Coronacion "Waling-Waling" Chiva Command owned up to the Massin raid in its Facebook account

The Armed Forces of the Philippines (AFP) said operations against the NPA continue despite the fighting in Marawi.

"While the AFP is busy combating the Maute-ISIS group in Marawi, significant developments are happening in our fight against the NPA, particularly after the government did not participate in the fifth round of peace negotiations with the communist terrorists," AFP Public Affairs Office chief Col Edgard Arevalo said.

# Slege Nearing end

Gov't now in control of 96 barangays in Marawi City – AFP

UTUAN CITY — The government is in control of the 96 urban and rural barangays in war-torn Marawi City and is now focusing on the remaining portions of the city's four barangays where an estimated 100 members of the Maute terror group are still hiding.

This was disclosed by Brig. Gen. Restituto Padilla, spokesman of the Armed Forces of the Philippines (AFP) late Saturday afternoon who also revealed that the ground troops already recovered several firearms, cache of live ammunition,

communication facilities, and computers left by the Maute terror group in the war zone.

President Duterte, who ended his five-day private time by visiting troops in Barangay Bancasi. Butuan City, Saturday afternoon, said that the Marawi siege was not a result of failure of intelligence but admitted that the government has become soft when it comes to dealing with rebels

The President said the Maute group was able to stock up on their arms and ammunition before challenging the government by laying siege in Marawi City, Lanao del Sur, on May 23

"It was not a question of failure on the part of the government. We have adopted a very soft policy towards rebels," he stressed.

"This came about because nagdadala sila ng baril eh (They were bringing firearms). And since we are thinking of getting peace with the MNLF and MILF, ang laro ng armas diyan (the existence of firearms there), we took it for granted," Duterte said, referring to the Moro rebel groups Moro Islamic and Moro National Liberation Fronts

Padilla declined to divulge the number of combat maneuvering troops now penetrating the four barangays in Marawi City as tactical movement is still ongoing.

He also did not give the exact number of casualties on the side of the Maute terror group and even from the government forces as fighting, which is now on its 28th day, still rages

"We don't want to give you the numbers for the meantime and probably after clearing operations, we can already determine the exact figures," he said.

He said air strikes will continue to cripple the remaining enemy positions and also to protect the troops on the ground.

Padilla also said ground commanders are verifying reports that the three Maute brothers were reportedly killed during the clashes. "We are still assessing and validating these reports as of this time," he said.

"Masigasig ang ating mga sundalo OFFICE OF THE ARMy na matapos na ito, we're nearing to a conclusion" he said, but refused to give the timeline to newsmen when the Marawi crisis will end.

The AFP spokesman also reiterated that the AFP is not blocking relief goods going to various evacuation centers in Lanao. "Our ground troops never blocked convoy delivering relief goods to Marawi evacuees," he said.

Padilla and AFP Public Affairs Office chief Col. Edgard Arevalo were with other top AFP and PNP officials when President Rodrigo Duterte, accompanied by Defense Secretary Delfin Lrorenzana, visited the officers and men of the AFP and PNP at Camp Bancasi here late Saturday afternoon, June 16, 2017.

Failure of intelligence

President Duterte disclosed that the Maute group was surreptitiously bringing firearms into Marawi City that the government was not able to keep count.

The President also said that the siege was not a failure of intelligence because in case Maute members were seen bearing firearms and pretended to be members of the MILF or MNLF. the standing order was to try and talk to them to avoid trouble

He also said that this enabled the Maute group to stock up on their arms and ammunition in Marawi City.

"But all the while, itong (the) Maute, with the connivance of politicians there, were stockpiling," Duterte said, adding that the group was just waiting for a reason and the right timing to stage their attack.

"Kaya hindi maubos ang mga bala at napakarami. Magputok ng isa ang gobyerno, ang ibabalik sa atin lima (That's why it seems like they are not running out of ammunition. We fire once, they return it five times),"

"So parang (it was like an) endless supply when Maute rose to fight the government," he continued.

ISIS fighters

Duterte also said that there is a conglomeration of Islamic State (ISIS) fighters in Marawi City coming from Syria, Indonesia, Malaysia, Sri Lanka, and Saudi Arabia.

"The fighting is going on, it is winding up but at the cost of so many | 15 Local: 5285, 5295

soldiers also. And that is the danger of Maute and ISIS. Bantay kayo diyan. Mahirap kalabanin 'yung taong gustong mamatay (Watch out for that. It's hard to fight with people who want to die)," he said.

Duterte also confirmed intelligence reports on terrorists killing anyone who does not practice the religion of Islam.

"They have so corrupted the name of God in a form of religion to kill many innocent persons and to destroy for nothing," he added.

The Chief Executive said the government is ready to find the root of the problem and finish it even if it means using all available resources.

"We have to use the air assets now because we are up against fighters, nanggaling 'yan diyan sa Middle East (who came from the Middle East) and learned the art of brutal killing," he said

"Susunugin ka, putulan ka ng ulo, kung anu-ano. 'Pag hinayaan natin 'yan na ganoon, patay ang Pilipino (They will torch you, behead you, anything. If we let them, then the Filipino will die)," he added.

According to Duterte, Islam is welcome in the country but warned about ideology which came from the Middle East.

"We welcome Islam [Pero] Itong Islam na imported ang ideology galing ng Middle East, anak na ng-talagang huwag tayong magpauna dito (But the Islam with ideology imported from the Middle East-we should not let that enter)." Duterte said.

"Mauna na lang tayo (Let's just get ahead of them first) and let's just resolve the problem or problems afterwards, we can discuss it," he added.

No apologies

Duterte also said that he will not be making any apologies for the ongoing conflict in Marawi as the citizens brought the problems on themselves.

This came after some Maranao and traditional leaders in Marawi and Lanao del Sur asked the President if they may be allowed to negotiate with the Mautes to end the hostilities.

According to Duterte, the leaders don't need his permission as they brought the problem upon themselves when they chose not to report the situation to the authorities early on

"You do not need my permission to do that Ang problema kasi nito (The problem here is), little did they realize that they are dealing with ISIS already," the President said

"I am not apologizing for anything there because they brought the problem on themselves. Bakit hindi nila sinabi sa pulis, sa akin, sa Armed Forces na may mga foreign trade na pabalik-balik 'yan (Why didn't they report to the authorities or to me that there were foreign elements going back and forth in the city)," he added.

But if it were up to him, Duterte reiterated that he will not negotiate with the terrorists as the war has already resulted in the death of 59 government troopers.

"If they go to the Maute to talk about what? Surrender? O ano lang, aregio? Ganon na lang (or negotiate? Then what? That's it)?" Duterte asked

"Paano yung patay ko (How about the the government troops who have died)? How about the murderous rampage of --- 'yung natamaan ng mga sniper nila (those who were hit by their snipers)?

Inmates skip meal

KIDAPAWAN CITY, North Cotabato — Inmates at the district jail here skipped one meal to be able to raise funds to buy relief goods for evacuees displaced by the ongoing conflict in Marawi City.

Jail warden Supt. Simeon Dolojo, said more than 1,400 inmates of the Kidapawan district jail here decided to skip their one meal ration and were able to raise some \$\mathbb{P}28,000\$ out of their \$\mathbb{P}20\$ per meal allocation which was used to purchase rice, noodles and sardines which they repacked as relief goods.

The relief goods will be delivered to the regional office of the Bureau of Jail Management and Penology in Koronadal City which will send the relief goods to Marawi City (With a report from Joseph Jubelag)

# North Cotabato loses its 6th soldier in Marawi clashes

LANAO DEL SUR – North Cotabato is grieving over the death in Marawi City of another son, the sixth soldier from the province killed there in the line of duty since May 23.

First Lieutenant Junrich Legada, a nurse in an Army Special Forces unit fighting the Maute group, planned to marry his girlfriend of 10 years immediately after their operation in Marawi City.

"His girlfriend lost a good would-be husband and his family lost a member with good standing in the local community," North Cotabato Vice Gov. Shirlyn Macasarte-Villanueva told The STAR yesterday.

Legada, born and raised in Midsayap, died last Friday in hospital, exactly four days after he was admitted for gunshot wounds.

Macasarte-Villanueva, from nearby Banisilan town, said like Legada's friends she too is aware about his plan to propose marriage to his girlfriend as soon as the trouble in Marawi City wanes.

"The province lost another son. We are mourning his death. We lost in Marawi City six sons of North Cotabato who exemplified what 'supreme sacrifice' for country and God is all about," Macasarte-Villanueva said.

North Cotabato Gov. Emmylou Taliño-Mendoza will extend cash assistance to Legada's family and help facilitate his burial. The governor earlier extended help to the families of Capt. John Carl Morales, Sgt. Marlon Baldovino, Sgt. Eric Jason Coros, Sgt. Angelo Estores Jr. and Cpl. Elmer Bueno, all from North Cotabato.

They belonged to different Army units and perished one after another in encounters with the Maute and Abu Sayyaf gunmen in Marawi.

The five of them have all been buried in their hometowns in North Cotabato with traditional military burial rites attended by local officials, traditional Muslim and Christian community elders.

# Unexpected reinforcement

An unexpected reinforcement in the form of 2,000 bundles of food and letters of inspirational support from civilians came to the ground yesterday in Marawi to boost the morale of frontline troopers in fighting for the Islamic city's freedom from the occupation of the Islamic Stateinspired terrorist group.

Col. Jose Maria Cuerpo, commander of the 8th Infantry Battalion, and his forces transported food packs containing fruits and drinks, which were accompanied by letters expressing love and concern for the soldiers.

In an interview over radio station dzBB, Cuerpo said the support came from civilian friends from all over the region, including Davao City, Cagayan de Oro City, and as far as Manila.

"It showed the concern of the people and how (the soldiers) are loved, especially on this occasion of Father's Day,"

# Troops, NPA renew clashes despite ceasefire call

## By Sandy Araneta

THE chairman of the government's peace panel said the military would refrain from attacking communist rebels as a confidencebuilding measure, but clashes were reported over the weekend, casting doubts on the ability of both sides to control their forces on the ground.

In Iloilo, about 50 alleged members of the New People's Army attacked a police station in Maasin and took an undetermined number of firearms after handcuffing the policemen on duty.

In Davao Oriental, troops of

the 104th Division Recon Company and one platoon from the 67th Infantry Battalion exchanged fire with NPA rebels in Brgy Taytayan, Cateel, on Saturday. Three rebels were killed.

Another rebel was killed in an encounter with the 66th Infantry Battalion in Brgy. Araibo, Pantukan in Compostela Valley Province.

The head of the government peace panel, Labor Secretary Silvestre Bello III, said Sunday the Armed Forces would refrain from combat operations against the NPA as a step toward a bilateral ceasefire agreement with the rebels.

Bello's statement came after the

communist National Democratic Front recommended to the Communist Party of the Philippines that it order all NPA units in Mindanao to stop attacks against the Armed Forces and the Philippine National Police.

Bello also welcomed the NDF stand against terrorist groups.

"We welcome the recent statement of the National Democratic Front reaffirming its support to the Philippine government's fight against Maute, Abu Sayyaf, Ansar al-Khalifah Philippines (AKP) groups and other terrorist organizations wreaking havoc in Marawi City and other parts of the country," Bello said in a statement.

"We also appreciate the NDF's commitment in their declaration to refrain from undertaking offensive operations in Mindanao to enable the Armed Forces of the Philippines and the Philippine National Police to focus their attention on the war against terror groups," Bello said.

"These voluntary gestures and expressions from the NDF in solidarity with government against acts of terrorism augur well for the desired continuation of the stalled fifth round of peace talks as they provide, if sustained, the needed

enabling environment favorable to moving the peace negotiations forward," he said

"The Philippine government hereby correspondingly reciprocates with the same declaration of not undertaking offensive operations against the New People's Army to pave way for the eventual signing of a mutually agreed bilateral ceasefire agreement and agreements on social and economic reforms, political and con-

stitutional reforms and end of hostilities and disposition of forces tewards a just and lasting peace," Bello said.

Bello said the government continues to adhere to mutually acceptable principles enunciated in the Hague Joint Declaration, which was reaffirmed by both parties.

He also said the government "unequivocally recommits its adherence to all previously signed agreements, including specifically, but not limited to, the Joint Agreement on Safety and Immunity Guarantees [Jasig]."

Members of the government

peace panel withdrew from the negotiating table during the fifth round of the peace talks last month due to a directive from the CPP that the NPA intensify its attacks on government troops to register its opposition to martial law in Mindanao,

President Rodrigo Duterte later appealed to the NPA to join the fight against the Maute group in Marawi City.

In response, the NDF said it will only cooperate if the Duterte administration withdraws its all-out war policy and the martial law declaration in Mindanao. With PNA

# NPA rebels 'killed' in Davao fighting

ZAMBOANGA CITY Soldiers in the area clashed with communist insurgents from the New People's Army (NPA) on Sunday and killed a still undetermined number of rebel gunmen in Mati City in the southern Mindanao province of Davao Oriental, a military spokesman said

Army Capt. Andrew Linao said no casualties were reported on the military side in a 45-minute gunfight in the village of Kauswagan.

The soldiers from the 28th Infantry Battalion recovered two automatic rifles, a rifle grenade, ammunition, radio communication sets and backpacks, according to Linao.

There were no casualties from the government side while a still undetermined numbers of rebels were killed in the fighting," he said, adding that government troops were sent to the area after villagers tipped off the military on the presence of NPA rebels there.

On Saturday, three rebels were also killed in fighting in Taytayan village in Davao Oriental's Cateel town and soldiers recovered five automatic rifles

The clash took place on the same day that the military battled it out with another group of NPA fighters in Araibo village in Pantukan town in Compostela Valley that also left one rebel leader dead

Colonel Reuben Basiao, commander of the 701st Infantiv Brigade, confirmed the series of clashes with rebel forces and said operations against the NPA will continue.

"Troops are there in the area to secure the people as part of our efforts in conducting community support programs and delivering basic services to the people together with other government agencies. Your Philippine Army here in Davao Oriental will always secure your safety as part of our mandate of protecting the people and securing the land," he said

The NPA has been waging a secessionist war for many decades now and despite the ongoing peace talks, fighting also continues in many areas in southern Mindanao.

# More troops deployed for Marawi City mop-up

Fresh troops, composed of an Army battalion, were sent to Marawi City to augment government forces fighting Islamic State (IS)-inspired terrorists.

Lt. Col. Arnel Cabugon, public affairs officer of the Army's 3rd Infantry Division (ID), said the 82nd Infantry Battalioh (IB) was redeployed to Marawi City from Iloilo City

Cabugon said that members of the \$2nd IB, led by Lt. Col. Vener Morga, flew to Marawi City last Saturday.

"The 82IB was redeployed to Mindanae area as follow-onforces to augment operating troops of the Western Mindanae Command in suppressing the Marawi rebellion," said Cabugon.

An Army battalion is composed of 300 to 500 soldiers.

The deployment of the 82nd IB in Marawi City was ordered as IS-inspired terrorists, led by Isnilon Hapilon and the Maute group, continued to put up resistance against advancing government troops.

The military said that only four of the 96 barangays in Marawi City are considered problematic areas where the terrorists still offers resistance.

According to the military, about 200 terrorists were still holed up in highly-fortified buildings in Marawi City, and using mosques and madrasahs as safe havens and innocent civilians as human shields.

Soldiers, operating under Joint Task Force Marawi, and various police units are jointly conduction operations to flush out the terrorists from the Islamic city.

Cabugon said that 3rd ID

manufacturer Mohammad Naoim
Maute, alias Abu Jadid, for charges
of rebellion.

Justice Undersecretary Erickson
Balmes said the inquest was
conducted inside the Criminal
Investigation and Detection Group
(CIDG)-Region 10 conference room
at Camp Evangelista in Cagayan De
Oro City.

The suspected bomb manufacturer was accompanied by two lawyers from the Public Attorney's Office (PAO) during the proceeding, Balmes said

An inquest is an informal and summary investigation conducted by the public prosecutor in a criminal case involving persons arrested and detained without the benefit of a warrant of arrest.

The inquest establishes whether the evidence is sufficient enough to seek court approval to keep the person in detention

Jadid, 22, a suspected improvised explosive devices (IED) manufacturer, and a cousin of Maute group leaders Omar and Abdullah Maute, was apprehended last June 15

He was captured by elements of the Martial Law Special Action Group (ML-SAG) during an operation in Sitio Sta, Cruz, Barangay Macasandig in Cagayan de Oro City at around 6:30 a.m.

Based on a police report, Jadid was using a fake ID of Mindanao State University bearing the name of Alfaiz Mamintal to get through checkpoints

Jadid is included in the Arrest Order 1 issued by Defense Secretary Delfin Lorenzana, martial law administrator in Mindanao, against those suspected of rebellion in the Marawi terror attacks.

In the DoJ's campaign to prosecute suspected rebels, Ominta Romato "Farhana" Maute, the mother of the Maute group's leaders, former Marawi City mayor Fahad Salic, and nine others have already been charged for the non-bailable offense of rebellion.

The criminal charges were filed before the Cagayan de Oro City Regional Trial Court (RTC).

This after government prosecutors found probable cause to accuse the respondents of rebellion after they underwent inquest proceedings at Camp Evangelista, headquarters of the Philippine Army 4th Infantry Division, in Cagayan De Oro City.

All 11 accused were included in the list of over 300 individuals identified as members of the Maute group, the Abu Sayyaf group, and their sympathizers earlier ordered arrested by the government for the crime of rebellion.

Salic was apprehended last

Friday in Misamis Oriental. He was included in the Department of National Defense's (DND) arrest order number two.

Authorities confiscated from Salic four units of M208 grenade, one M16 rifle loaded with 29 pieces of live ammunition and three pieces of long magazine with each loaded with 30 pieces of 5.56 live ammunition.

Farhana and nine others were arrested last Friday in Masiu, Lanao Del Sur.

They were caught in possession of one M14 rifle, seven M14 magazine assembly, 136 M14 live ammunition, one scope, two rifle grenades, two improvised rocket propelled grenades and two smoke grenades.

### Lella seeks stepped up rescue bid

Senator Leila de Lima yesterday urged the government to step up efforts in rescuing the remaining 300 to 1,700 civilians who are still trapped and yet to be rescued in Marawi City.

As the firefight between the military and Maute group continues, some of the trapped civilians who are reported to be already low on food and water supply were forced to eat cardboard boxes to survive, De Lima noted.

There were also reports that the Maute fighters have been using some civilians to either cook or carry ammunitions for them and had also allegedly recruited children, those already orphans of Muslim rebels, to fight along with them.

"This is now a humanitarian issue because a substantial number of innocent civilians are still trapped in the conflict areas. Some of them lack food to eat and clean water to drink, if they are lucky enough to survive the heavy exchanges of fire," she said.

De Lima noted that affected

residents have already lost their properties and livelihood while children's education, health and social welfare are adversely affected

"Such are the horrors of war that have become so costly for all of us," she said.

De Lima expressed grave concern over the safety of the civilians as the military go on a heightened military operations against the ISIS-inspired Mante group.

The former justice secretary also noted the increasing number of internally-displaced persons (IDPs) who are also suffering in the crowded evacuation areas outside Marawi City with a bleak future for their families and children once the conflict ends.

Although Marawi City has a population of over 200,000 people, the Department of Social Welfare and Development (DSWD) reported that as of June 13, about 65,198 families or 316,684 individuals have been displaced from Marawi City and Marantao in Lanao del Sur, 14,772 of whom are reportedly staying in 68 evacuation centers.

About 9,252 families or 43,159 individuals have also been evacuated from Marawi City to Iligan City where the local government unit has reportedly converted a covered court in Bgy Buru-un as an evacuation center.

Noting that a regular covered court could only accommodate 50 families, De Lima said these evacuation areas are heavily congested at a greater risk to the health and sanity of the thousands of IDPs and their families and children.

To date, at least 290 people have reportedly died since the fighting began in May 23, which includes 206 militants, 58 soldiers and 26 civilians.

# RADICALIZED IN MIDEAST, THEY RAZED THEIR CHRISTIAN HIGH SCHOOL

MARAWI CITY—Twenty years after obtaining Christian educa-Muslim brothers tion. Omarkhayam and Abdullah Maute returned to this Central Mindanao city with the black flags of the Islamic State (IS) group and set fire to their alma mater.

Hundreds of gunmen, many of them young locals recruited by the Maute brothers, destroyed Dansalan College in a rampage through Marawi City last month as they launched a brutal offensive to stamp their credentials as the IS leaders in the Philippines.

Their bold attack turned the Maute siblings, who are in their mid-30s, into the most infamous high school alumni of the Protestant Church-run institution, which had been a symbol of religious tolerance in the mostly Muslim city of 200,000 people.

The Maute brothers have since remained holed up in Marawi, using their local knowledge of tunnels and bombproof basements to withstand a military offensive that has left entire neighborhoods in ruins and claimed more than 300 lives.

#### Where is hate coming from?

"We do not understand where that hate is coming from," said Zia Alonto Adiong, a

sembly of the Autonomous Region in Muslim Mindanao that includes Marawi.

Duma Sani, a former dean of Mindanao State University whose daughter also went to Dansalan College with one of the Maute brothers, said most locals did not support their radical Islamic brand that mandated the killing of nonbelievers.

"These [Marawi gunmen] are young people who have their own interpretation of the Quran and who do not respect their own elders," Sani told Agence France-Presse (AFP).

The Maute group emerged as a small ragtag group around 2012 from a decades-old Moro separatist rebellion in Mindanao.

As the Moro Islamic Liberamember of the legislative as- tion Front (MILF), the main

rebel organization, sought to broker peace with the government, the Maute and other small hardline groups filled a vacuum for fanatics as they took inspiration from the atrocities of IS in Iraq and Syria.

"I think what transformed the Mautes from a small band of siblings to a real serious military threat was the emergence of Isis in the Middle East," security analyst Sidney Jones told AFP, using an alternative acronym for the extremist group.

#### Radicalized much earlier

But the Maute brothers were radicalized much earlier—while they were pursuing studies in the Middle East after college, according to Jones and Rommel Banlaoi, head of the

Manila-based Philippine Institute for Peace, Violence and Terrorism Research.

Omarkhayam headed to Egypt's Al-Azhar University, while Abdullah went to Jordan.

Banlaoi said the brothers returned to Mindanao after about a decade away to be mentored by a fugitive Indonesian militant, Ustadz Sanussi, who in turn put them in touch with other Southeast Asian Jihadis, notably the Malaysian bomb maker Zulkifli bin Hir.

#### Family affair

With an engineer father and a mother involved in construction and property development, the Mautes are part of Muslim Mindanao's elite.

They also have blood ties to one of the top MILF leaders, Banlaoi said. "These connections gave the group a measure of protection."

Since the Marawi fighting broke out, the mother and father of the Mautes have been arrested. Authorities have said the arrest of the mother was particularly important, describing her as a financier of the Maute group.

All her seven sons are believed to be involved in the Marawi conflict, according to Banlaoi.

But Jones said the mother was not the driving force of

radicalism—rather, she and other family members had been led by Omarkhayam and Abdullah

The Maute group's main ally is Isnilon Hapilon, a leader of the Abu Sayyaf extremist group who is on the US government's list of most wanted terrorists

Hapilon, whom IS has named as its leader in the Philippines, is believed to be in Marawi with the Maute brothers.

Jones, director of Jakartabased Institute for Policy Analysis of Conflict, said leadership had effectively shifted to the Maute brothers because they were controlling events in Marawi.

### New base for IS group

Regardless of whether the Maute brothers are driven out of Marawi, they have established the Philippines as a successful new base for IS, Jones said, pointing to foreign fighters who had been reported killed in the conflict.

The military has said that slain fighters have come from countries including Chechnya, Libya, Indonesia and Malaysia.

"Suddenly, foreign fighters who [have] never set foot in the Middle East [are] going to Mindanao," Jones said.

"Marawi in particular has become the new sexy destination for jihad," he added. —AFP

# 242 Maute men killed

Two-hundred forty-two Maute Group terrorists have been killed in the ongoing clashes in Marawi City, the Joint Task Force Marawi said yesterday.

The task force said that as of 6 p.m. Saturday, 59 government troops and 26 civilians were killed while 243 firearms were recovered.

One-thousand six-hundred thirtysix civilians trapped in the fighting were rescued.

Armed Forces Public Affairs Office chief Marine Col. Edgard Arevalo said the military continues clearing operations in Marawi against remaining armed terrorists who continue to resist advancing troops.

# Duterte: MILF, MINL may have armed Maute

HE Maute Group may have acquired its huge stockpile of weapons from other rebel groups such as the Moro Islamic Liberation Front (MILF) and the Moro National Liberation Front (MNLF), President Rodrigo Duterte said over the weekend as government troops continued their operations to drive out islamists in Marawi City.

Duterte admitted that the government knew that Muslim rebels were stockpiling firearms and ammunition in Marawi City but authorities did not intervene because of the peace negotiations with the MILF and MNLF

"It was not a question of failure on the part of government. It was not a failure of intelligence. It is because we have adopted a very soft policy toward the rebels. These rebels carry firearms. And since we are thinking of getting [a] peace [deal] with the MNLF.

and MILF, the deal with arms, we really took it for granted," Duterte said when he visited the 401st Infantry Brigade in Butuan City.


"But we know these [firearms] are high powered because we never knew at that time who is the real enemy. Are these just warring politicians? Clan war? Between private armies of politicians? It turned out Maute members were bringing the firearms surreptitiously and we were not able to know how many ammunitions did they have," the President added.

"All the while, the Maute group, with the connivance of the politicians there, the warlords...they were stockpiling. That's why they don't run out of M-203 bullets. The government will fire one, and they will fire back five. It's like Maute has an endless supply to fight the government," Duterte said.

Rep. Gary Alejano of Magdalo party-list said it is possible that the Maute Group could have gotten its powerful-weapons from the MILF.

"The statement of the President is partly correct according to my information. There were reports in the past that the MILF manufacture their own weapons and even sell them to other rebels and politicians. I believe this did not stop during the peace talks and even after the peace agreement was signed," Alejano, a former Marine captain who fought MILF rebels, told The Manila Times.

He was referring to the peace agreement signed between the Philippine government and the MILF in March 2014 under the Aquino administration. The peace agreement resulted in the creation of a proposed Bangsamoro law that was supposed to abolish the Autonomous Region in Muslim Mindanao and establish

a new Bangsarnoro Region that will enjoy fiscal autonomy and be governed by the Bangsamoro Parliament.

The measure was not passed because of the killing of 44 police commandos in Mamasapano, Maguindanao in 2015 by MILF rebels and other armed men.

"I raised this issue during the proposed Bangsamoro bill deliberations in the last Congress. I said partly because weapons could be bought in the black market and considering our porous borders particularly in the south and some corrupt government officials, these arms and ammo could easily be smuggled in the country," Alejano said.

As the siege in Marawi entered its second week, the MILF and MNLF offered to help government troops fight the Maute members.

A statement issued by MILF chairman Al Haj Murad said the rebel group is willing to extend humanitarian assistance to the civilians affected by the fighting.

The MNLF also said its fighters are ready to battle the ter-

rorists in Marawi.

Duterte assured soldiers fighting the Maute Group in Marawi that even if the enemy appears to have an endless source of ammunition, government forces will never lack weapons.

"I assure you [soldiers], you will never run out of weapons...in everything you need. I won't let you down," the President said.

#### Military knew

Political analyst Ramon Casiple said Duterte was right in saying that there was no failure of intelligence on the part of the government because the military was aware of the entry of firearms and ammunition in known MilFareas.

He said the military knew of the movement of weapons in Mindanao but it assumed that the firearms were for the MILF, not the Maute Croup.

Casiple explained that the government was not being "soft" on the MILF for allowing it to stockpile firearms because of the

ceasefire agreement.

"That is the problem with ceasefire, it only prevents combat, but parties can continue to build up their forces and beef up their armaments. It is also true with the New People's Army (NPA)," he said.

Casiple said the MILF does not consider the Maute Group as an enemy.

He explained that the MILF is very loose and there are other groups that are friendly to the organization including the Maute, which is also an ally of MILF commander Abdullah Macapaar alias "Commander Bravo."

"The MILF has no reason to be anti-Maute, and they also don't have an obligation to the government to report what the group has been up to," Casiple added.

Since the MILF has not yet signed a peace agreement with the government, it has no obligation to provide information to the government although it can help if its wants to.

# Aguirre defends US technical aid to Philippine troops

he Constitution does not prevent United States troops from giving technical assistance to Philippine forces who are battling Islamist extremists in Marawi City, Justice Secretary Vitaliano Aguirre II said Sunday.

"What is prohibited under the Constitution is the joining of US troops in actual combat. But sharing of intelligence and equipment is allowed under the Enhanced Defense Cooperation Agreement (EDCA)," Aguirre said in an interview.

He said EDCA satisfies the requirement in Section 25, Article 18 of the 1987 Constitution that after the military bases agreement between the Philippines and US expired in 1991, the presence of foreign troops are banned

in the country "except under a treaty duly concurred in by the Senate..."

Aguirre pointed out that the US also provided technical to Philippine police commandos who assaulted a lair of Islamist terrorists in Mamasapano, Maguindanao, to capture or kill Malaysian terrorist and bombmaker Zulkifi Abdhir on January 25, 2015.

The assault turned into a bloodbath where 44 police commandos were

killed.

The technical assistance to Filipino troops was later confirmed by US Embassy Spokesperson Molly Koscina.

Last June 9, a US P3 Orion surveillance plane flew high above Marawi.

In a related development, the Department of Justice (DOJ) conducted inquest proceedings for rebellion against Mohammad Naoim Maute at Camp Evangelista in Cagayan de Oro City.

Naoim is believed to be the youngest brother of Omarkhayam and Abdullah Maute, leaders of the Maute group.

Reports submitted to the DOJ indicated that Naoim was arrested in Barangay Sta. Cruz, Macasandig, Cagayan de Oro City, last June 15.

Naoim was using a fake ID of Mindanao State University bearing the name of Alfaiz Mamintal to get through checkpoints, the reports said.

A notorious bomb expert of the Abu Sayyaf Group (ASG) and close aide to ASG leader Isnilon Hapilon was arrested by the joint forces of the military and police in Zamboanga City on Saturday.

boanga and the Zamboanga City Police Office arrested Abu Sayyaf member Hamsi Amajad Marani alias Hamsi. an ASG bomb expert at Purok 4, Sitio Niyog-Niyog, Brgy Muti, Zamboanga City at 1:30 a.m. on Saturday.

Reports from the JTF Zamboanga disclosed that Marani was spotted by a concerned citizen who immediately notified the authorities leading to the bomber's arrest. Marani is a notorious member of the ASG, and is a trained bomber by an Indonesian Jemaah Islamiyah bomb expert

Armed Forces of the Philippines. Western Mindanao Command (AFP-WestMinCom) spokesman Army Capt Jo-Ann Petinglay said recovered from Marani were paraphernalia for making Improvised Explosive Devices.

Marani was also involved in a series of encounters with government forces in Sulu and Basilan

"This successful operation is done in close coordination with the members of the Zamboanga City Police Office," Colonel Leonel Nicolas, the commander of the Joint Task Force Zamboanga, said.

### Boat numbering system

Once the boat numbering system on all vessels in Mindanaoris completed, terrorists will have a smaller chance of escaping, Commodore Joel Garcia, Philippine Coast Guard (PCG) officer-in-charge, said.

He added that once the Safety, Security, and Environmental Numbering System or the boat numbering and

marking system under the Department of Transportation has covered all vessels in the country, especially in Mindanao, the terrorist groups Maute and Abu Sayyaf (ASG) and kidnap-forransom bandits at sea may soon run out of escape boats for their illegal operations

"The Abu Sayyaf in Southwest Mindanao, we know that they use ships and fast ships in their piracy activities. If you remove the tools of the trade, the fast boats, then we will be able to isolate the boats that the Abu Savyaf are using and they would not be able to conduct kidnap for ransom," Garcia said

Data from the PCG showed that from March, 2016 until March this year, 22 incidents of abductions in Sulu, Celebes Sea, and Sibutu Sea area were reported

Garcia disclosed that the only alternative solution is for the PCG to resort to the numbering system in order to augment the incapability of all vessel owners operating a three gross tonnage (GTN) boat to buy transponder, a device that could receive and transmit radio signals, which cost ₱15, 000.

It was also revealed that out of the estimated 400,000 vessels that only have three GTN, about 30,000 boats are in Mindanao

Garcia also warned that boats will be impounded if they fail to register under the DOTR regulations on boat numbering and marking system within three months from its implementation last June 2, 2017

"Even from a distance, if the PCG Philippine National Police (PNP), and the Armed Forces of the Philippines (AFP) would notice that a boat is not properly marked, the authorities can apprehend the boat because it could be used for illegal activities and we could include the boat owner as a respondent in the case," Garcia said.

He further said that since Martial Law is still in effect in Mindanao, they are expecting full cooperation from all government agencies and local government units.

Boat owners were encouraged to comply since the directive is covered by a department circular.

The PCG has already ordered its 12 districts, 75 stations, and close to 9555 Local: 5285, 5295 300 sub-stations to initiate the marking of the boats using long-lasting marine paint.

# Troops capture Sayyaf camp in Basilan

ZAMBOANGA CITY – Government forces captured an Abu Sayyaf camp in Basilan Friday following intense air and ground strikes aimed to prevent the militants from providing refuge to members of the Maute terror group who might slip out of Marawi City, a security official said.

Col Juvymax Uy, Joint Task Force Basilan (JTFB) head, said ground forces from the 4th Special Forces Battalion under Lt. Col Andrew Bacala overran the Abu Sayyaf lair at the border of Ungkaya Pukan town.

Uy said the group of Abu Sayyaf subleader Furuji Indama and Radzmil Janatul retreated and abandoned their camp with heavy casualties

The government forces launched heavy artillery and air strikes Thursday that were subsequently followed by assault from

ground troops

Bacala said he noticed 42 makeshift huts and the surroundings with heavy bloodstains and littered human flesh, an indication of heavy casualties from the Abu Sayyaf

The soldiers also recovered four highpowered firearms – two M16 rifles, a Baby Armalite rifle and an M1 Garand – four sacks of rice, solar panels and improvised bomb components.

Uy said the troops also recovered personal items and documents believed to be from a Vietnamese captive.

Troops had rescued on Thursday Hoang Vo, one of six Vietnamese sailors abducted by the Abu Sayyaf during a hijacking incident last November off Sibagu Island, according to Uv

Uy said offensive operation continued as part of the security measure to preempt the return of the group of Basilan-based Abu

Sayyaf leader Isnilon Hapilon from Marawi.

Hapilon, the designated emir of the Islamic State-inspired terror group, led the siege on May 23 in Marawi with the Maute group in its attempt to establish a caliphate

There were speculations that some of the terrorists from Marawi might have slipped military operations and are returning to Basilan or Sulu and other parts of Central Mindanao.

Uy said they were verifying all the information

The military commander said the pursuit against the Abu Sayyaf also continued to thwart any plan to return to the island

"The joint task forces are doing their best to address these concerns, acting jointly with coordination to prevent them from going back," Uy said

Uv said the military forces also have a strong coordinative mechanism with local government units who lead the fight against the Abu Sayyaf.

# Military seizes Abu Sayyaf lair in Basilan

AMBOANGA CITY: Backed by a barrage of artillery fire, government forces captured an Abu Sayyaf Group (ASG) encampment on Sunday in a hinterland village in the restive province of Basilan in southern Philippines.

Troops also recovered four automatic weapons left behind by the terrorist group in the town of Ungkaya Pukan.

The encampment was believed under mid-level commander Puruji Indama.

Military operations were continuing in the province, just 30 minutes by boat from the port city of Zamboanga in Mindanao.

The military said it killed an undetermined number of militants before taking their camp but troops had not recovered a single body of a slain Abu Sayyaf fighter.

On Friday, the bandit group freed one of their six Vietnamese hostages, Hoang Vo, 28, who was recovered by soldiers near Sumisip town of Basilan.

Vo, a native of Ngh An province, had a wound on his back and was immediately taken to hospital, according to the military.

The bandit group hijacked a Vietnamese cargo ship in November last year and seized six crew, including its captain

The Abu Sayyaf is also holding over a dozen hostages in the troubled Muslim autonomous region.

## NPA rebels seize guns in Iloilo raid

ILOILO CITY—Heavily armed rebels of the communist-led New People's Army (NPA) raided a police station in Maasin town in floilo province on Sunday morning, taking at least 12 firearms, including eight high-powered rifles.

Not a single shot was fired and none of the nine police personnel was harmed in Maasin, 31 kilometers northwest of this capital city, a day after 428 soldiers from the Army's 82nd Infantry Battalion based here were deployed to beef up troops battling terrorists in Marawi City.

The NPA rebels, numbering between 40 and 50 including women, took eight M-16 rifles and nine Glock 9-mm pistols, according to Chief Supt. Cesar Hawthorne Binag, Western Visayas police director.

Three rebels, including two women, first entered the station around 10:30 a.m and pretended to be residents who were filing a complaint. Several others then rushed to the station from the back entrance, Binag said.

Other comrades who came on board an Elf truck surrounded the police station beside the public market. The nine policemen were then ordered to lie down and handcuffed

One rebel, using a megaphone, told residents to stay calm as they were only after the firearms.

#### Over in 15 minutes


The operation was "swift" and was over in 15 minutes, according to Binag.

#### Davao clashes

Two gun battles between NPA rebels and government troops also broke out on Saturday in Southern Mindanao where an alleged ranking communist rebel and four insurgents were killed, military officials said.

Peace negotiators on both sides earlier agreed to halt offensives and cooperate instead in fighting Islamic State-inspired terror groups in southern Philippines.

Three communist guerrillas were killed in a 45-minute clash in Taytayan village, Cateel town, Davao Oriental, before dawn on Saturday, while a front secretary and another rebel

were killed in an encounter at Pantukan town, Compostela Valley, also on the same day, according to Capt Rhyan Batchar, public affairs chief of the Army's 10th Infantry Division

Government troops also recovered five assault rifles, two improvised explosive devices (IEDs) and backpacks containing personal belongings, medical kits and cellular phones from the rebels.

#### NDFP statement

The National Democratic Front of the Philippines (NDFP) earlier recommended that the Communist Party of the Philippines (CPP) order the NPA to "refrain" from attacking government forces and instead focus on the proposed cooperation in neutralizing terror groups in the country.

In a statement on Sunday, Labor Secretary Silvestre Bello III welcomed the NDFP support of the government's campaign against the Marawi terrorists.

"The Philippine government hereby correspondingly reciprocates with the same declaration of not undertaking offensive operations against the New People's Army," said Bello, the chief government peace negotiator.

He said this would pave the way for the eventual signing of a mutually agreed bilateral ceasefire agreement and agreements on social reform and economic reforms, political and constitutional reforms, and the end of hostilities and disposition of forces "toward a just and lasting peace." —with reports FROM PHILIP C. TUBEZA, KARLOS MANLUPIGAND FRINSTON LIM INQ

#### AFP neutralizes 50 NPAs

The Armed Forces of the Philippines (AFP) said it neutralized 50 guerrillas of the New People's Army (NPA) and recovered 16 firearms in separate operations amid intense operations against the Maute Group in Marawi City.

AFP Public Affairs Office (PAO) chief Marine Colonel Edgard Arevalo, said they were significant in their fight against the NPA, particularly after the government did not participate in the fifth round of peace negotiations with communist organizations.

Arevalo said military forces had successful operations against the NPA, mostly in northeastern Mindanao.

Of the 50 neutralized rebels, 36 voluntarily surrendered to govern-

ment forces, nine were killed, and five were arrested in separate encounters starting May 23, the day the terrorists attacked Marawi.

Government troops also recovered 16 firearms. On the other hand, 15 firearms were turned over by NPA surrenderers.

The most recent encounter took place on June 11 in Paquibato District, Davao City, where elements of the Army's 16th Infantry Battalion killed an NPA fighter.

The military saw a surge of surrenderers from the NPA starting May 23. Significant of which were five NPAs who voluntarily surrendered in Talaingod, Davao del Norte on June 13, and six members with high-powered firearms who surrendered in Maguindanao on June 6.

### Good cop, bad cop on ML issue

resident Duterte's statement that he will respect the decision of the Supreme Court on the legality of his martial law proclamation in Mindanao has minimized the risks of a constitutional crisis arising from his action.

It's nice to hear about the President's intention to comply with the constitutional provisions on the delineation of authority among the three branches of government on the issue of martial law. Earlier, he said he would listen only to the military and police on when to lift martial law ostensibly because they are familiar with the situation on the ground.

On the other hand, Speaker Pantaleon Alvarez has served notice that he would ignore the high court if it rules in favor of the petition calling for Congress to meet in joint session to discuss the martial law declaration.

But Senate President Aquilino Pimentel III has refrained from discussing the merit of the petitions. He simply said the Senate acted properly when it decided not to call a joint session to discuss the martial law declaration after a majority of the senators endorsed it.

With the President recognizing the high court's power to pass upon the validity of his action, it is not far-fetched that Alvarez would later pull back from his antagonistic posture and similarly acknowledge the judiciary's review authority over martial law.

Recall that last year, in the wake of Vice President Leni Robredo's video message to the United Nations Human Rights Commission to investigate extrajudicial killings in the Philippines, Alvarez threatened to file impeachment charges against her supposedly for betrayal of public trust.

Then the President publicly called on those planning to impeach Robredo to desist from doing so. His call was taken seriously by his congressional allies. No House member endorsed the impeachment complaint filed against the Vice President by two grandstanding lawyers.

When Alvarez was later asked about his plan to have Robredo impeached, he said he was merely studying that possibility. From then on, nothing was heard anymore about the matter.

The difference in stance on the martial law petitions by two of the highest ranking officials in the government has put a "good cop, bad cop" look on this political issue.

Mr. Duterte appears to be the "good cop" who wants to keep faith with his oath to preserve and defend the Constitution, while Alvarez comes out as the "bad cop" who thinks the high court, in spite of the explicit provisions of the Constitution, has no business telling Congress how to do its job on the matter.

Although the President's statement about honoring the high court's ruling on his martial law decree is reassuring, there is no telling whether he will remain firm on his stand for the long haul. Note that he earlier had a change of mind on significant issues—e.g., ceasefire with the New People's Army, military aid from the United States, and the participation of the Moro National Liberation Front and Moro

Islamic Liberation in the fight against the terrorist Maute group.

The reasons Mr. Duterte, or his spokesperson, cited to explain or justify the 180-degree turnaround on the incidents mentioned were plausible, but they raised concerns about consistency in the administration's policymaking process.

If things do not get out of hand in Marawi and the high court upholds the validity of the martial law declaration in Mindanao, or even only in the Islamic City, the President would, no doubt, quickly declare his acceptance of the decision.

But a lot of things can happen between now and the day the high court renders its ruling that may alter that favorable scenario.

In case the Filipino followers of the Islamic State heed its call to conduct more attacks in Mindanao and other parts of the Philippines during the holy month of Ramadan, and the high court strikes down the martial law proclamation, the President may be forced to backtrack from his earlier commitment to respect its decision.

If that happens (knock on wood), a constitutional crisis will most likely happen. It is hoped we don't get to that stage.


### Duterte explains Marawi conflict

In his re-appearance speech five days after he went missing, President Duterte gave an explanation for the military's "mis-appreciation" of intelligence that has been blamed for the difficulty being encountered by government forces in the ongoing war against the Islamist militants in Marawi

It will be recalled that Solicitor General Jose Calida said that the military had received intel reports about possible Maute, Abu Sayyaf attacks in Marawi five days before May 23, when the fighting started sparked by the serving of warrant of arrest to ASG leader Isnilon Hapilon. The fierce fighting was the basis of the declaration of Martial Law in Mindanao by Duterte on May 23.

Defense Secretary Delfin Lorenzana, who was in Moscow with the President together with other high ranking security officials said," I don't think there's a lapse of intelligence, it's just appreciation of the intelligence that was lacking there."

The President speaking before soldiers that compose the 401st Brigade, 4th Infantry Division Advance Command post Bancasi, Butuan City, gave his version of the armed conflict that has claimed the lives of at least 58 soldiers, 191 terrorists and a number of civilians. Thousands have been



displaced.

Duterte explained: "It was not a question of failure on the part of government. Kasi naman tayo, we have adapted a very soft policy towards sa mga rebels. And this came about because nagdadala sila ng baril eh. And since we are thinking of getting peace with the MNLF and MI, ang laro ng armas diyan, we took it for granted. We took it really for granted na. Pero alam natin na mabibigat. Pero hinayaan kasi natin because we never knew at that time kung sino talaga ang kalaban. Iyon bang mga pulitikong nag-aaway, nagri-rido sila, o iyong mga itong private army ba ito ng politicians?

Now, he said they realized, "Kalabas-labasan, itong Maute

were bringing the firearms surreptitiously at hindi natin nakuha na gaano na karami ang ammo pati baril sa loob."

He stressed, "It was not a failure of intelligence. Kasi kung makita pa silang may armas, tapos sabihin nila, MI, MN, ang standing order naman is 'huwag ninyong galawin.' Baka, baka sakali mapakiusapan pa natin ang mga kapatid natin, na walang gulo. But all the while, itong Maute, with the connivance of the politicians there, iyong mga warlords, were stockpiling."

That's why he said, the Islamic terrorist don't seem to run out of arms and ammunition in the almost a month of of fighting:" Kaya ni hindi maubos iyong M-203 na bala at napakarami. Magputok ang isa ng gobyerno, dadagdagan na—ibabalik sa atin, lima. So parang endless supply when Maute rose to fight against government."

He said the militants were ready last month and they were just waiting for an opportune time to attack. Thy got it in the attempted arrest of Hapilon "Naghihintay lang sila noon ng 'bikil' tawag nila, iyong rason at mag-serve ng warrant of arrest which is an everyday occurrence anywhere in the Philippines, lumaban. Ayun, nagkabakbakan. At iyong forces ng mga Indonesian nasa bukidbukid, nagbabaan So you have a conglomeration there of ISIS fighters from Syria, Indonesia, Malaysia, Sri Lanka at iyong mga Arabo na --- maputi. Maputi iyong Arabo eh, na... Kuwait.

If the President knew the things that he said last Saturday, would he have dared the Maute last December when he said "They (Maute) are in there in the forest. I don't know where and I said, they would stop fighting, provided we stop the offensive or not, they said that they will go down upon Marawi to burn the place. And I said, "Go ahead, do it."



# Assistance from NPA

HE government received over the weekend two welcome developments in its long-running battle with radical Islamist in Marawi. First, the National Democratic Front has asked the New People's Army to refrain from carrying out offensive attacks against government forces. Second, the NDF has recommended to the Communist Party of the Philippines to maintain defensive operations against the Maute, Abu Sayyaf and Ansar Al Khilafah Philippines

(AKP), the three groups of armed Islamists still holding parts of Marawi City.

The NDF's gesture of government support at least in its war in Marawi City is a most positive development, especially if the NFA accepts its recommendation. The downside, reported only recently, is CPP founding chairman Jose Ma. Sison's tacit admission in an interview that the NDF peace panel does not have operational control over the NPA.

NDF spokesman Fidel Agcaoili assured that even before the Marawi siege, the communist rebels had been cooperating with the government in fighting terrorism.

In fact, he said, an NDF organization called Moro Resistance and Liberation Organization (MRLO) which is based in Marawi and suburbs has assumed home defense tasks while NPA units have been deployed close to the besieged city "for the purpose of mopping up, holding and blocking operations if necessary."

In the wake of the stalled peace talks, this cooperation between the government and the NDF in fighting the Maute group and other Islamists in Marawa engenders other problems.

President Duterte's spokesman, Ernesto Abella, says this kind of cooperation would not be possible as long as the NDF, CPP and NPA maintain their policy of opposing martial law in Mindanao, or elsewhere in the Philippines

"The Duterte administration would rather pursue the path of genuine dialogue to build the nation worthy of its citizens," Abella said.

Agraoili, on the other hand, maintains emphatically that the NDF has been fighting terrorism, and pushes a view of who the enemy is which is otherwise unacknowledged by the military. The NDF spokesman said the well-armed Islamists are terrorists with strong links to local reactionary forces (meaning the economic and political elite in Mindanao), affiliated with the Islamic State and supported by the United States Central Intelligence Agency (CIA).

With help from within the country and from outside, the Armed Forces of the Philippines and the Philippine National Police should be able to finish off whatever remnants the Maute group has in Marawi.

While President Duterte has suffered great humiliation with his announcements of deadlines, all unmet, there is still hope that with the assistance of all armed groups in the Philippines, the Filipino people will annihilate the Islamist rebels.

This could be the first time that government troopers and their traditional adversaries, the NPA and the MNLF, will unite in the fight to preserve the integrity of Philippine territory.



He said the children of soldiers are the ones who are thankful for this occasion the most, noting that the fact that their fathers remain alive each day is already a blessing.



# PAF looking for P2.8M worth of S-211 jet spares





MANILA, June 18 -- The Philippine Air Force (PAF) has allocated PHP2,880,000 to acquire spare parts for four of its SIAI-Marchetti S-211 jet trainers.

This was announded by PAF Bids and Awards Committee chair Brig. Gen. Nicolas Parilla in a bid bulletin posted at the Philippine Government Electronic Procurement System. Pre-bid conference is scheduled for June 22, 11 a.m. at the PAF Procurement Center Conference Room, Villamor Air Base, Pasay City.

While submission and opening of bids is on July 7, 9 a.m. at the same venue.

The spares are intended for S-211 jet aircraft with tail numbers 008, 021, 801 and 802.
