PH, 2 NEIGHBORS CLOSE RANKS VS TERRORISTS

Manila, Jakarta and Kuala Lumpur agree to fight and halt the growth of extremism in Southeast Asia.

The Philippines, Indonesia and Malaysia have agreed to closely cooperate to halt the flow of militants, weapons, funds and extremists propaganda across their borders as they expressed alarm over recent attacks in their region.

Foreign Secretary Alan Peter Cayetano and his Indonesian and Malaysian counterparts held talks in Manila on Thursday with top security officials on a joint plan of action as the Philippine military battled Islamic State (IS)-linked terrorists in Marawi City.

The trilateral meeting was held after President Duterte and Indonesian

President Joko Widodo spoke by phone on Wednesday night and agreed to intensify cooperation in the fight against terrorism and violent extremism.

Presidential spokesperson Ernesto Abella said on Thursday that the phone call between the two leaders was "productive and fruitful," with Widodo reasserting Indonesia's commitment to fight terrorists and help bring peace to Mindanao.

"President Widodo reaffirmed Indonesia's commitment to support the Philippines in countering terrorism, including restoring peace and stability in the southern Philippines," Abella said.

He said Mr. Duterte welcomed Widodo's pledge and stressed his administration's resolve to work closely with Indonesia and like-minded states in fighting terrorism to maintain peace in the region.

Jolted by the May 23 attack on Marawi, the Philippines, Indonesia and Malaysia have launched joint maritime patrols to prevent piracy, kidnapping and the cross-border movement of fugitives and extremists.

Malaysians and Indonesians were among foreign fighters killed by the military in Marawi, where it is battling Maute and Abu Sayyaf terrorists who seized the city to open an enclave for the Middle Eastbased IS jihadist group in Southeast Asia.

Joint plan of action

The fighting enters its fifth week on Friday, with the military saying the terrorists have been cornered in a square-kilometer pocket of the city and

troops are advancing on them.

On Thursday, Cayetano and his Indonesian and Malaysian counterparts gathered in Manila with top security officials to discuss a joint plan of action to deal with the threat of extremism in the region.

"This threat is beyond borders. No country is immune from terrorism," said Indonesian Foreign Minister Retno Marsudi.

She said the threat of terrorism was "even more worrying" because of the use of social media.

"Therefore cooperation among the three of us is a necessity, cooperation among the three of us is a must," she said.

Malaysian Foreign Minister Anifah Aman said terrorists today had "proven to be experts in using social media to recruit members in faraway countries."

"In the past, terrorism maintained a sense of self-preservation, unlike today. It is far more difficult to stop people who are willing to die," he said.

Anifah also said counterterrorism efforts must be innovative, since radical groups have taken advantage of social media to spread their perverted ideology and recruit from around the world.

"There is a need to agree to formalize our cooperation.

through the establishment of mechanisms which will include all relevant stakeholders," he added, citing the need for prompt exchange of information and to strengthen intelligence gathering, and assist investigation of cross-border terrorist activities.

Armed Forces of the Philippines Chief of Staff Gen. Eduar- ter the meeting, the three diplodo Año, Philippine National Police Chief Ronald dela Rosa and National Security Adviser Hermogenes Esperon attended the meeting with their Indonesian and Malaysian counterparts.

At the end of the three-hour meeting, Cayetano was asked whether the Philippines got in-

formation from Indonesia and Malaysia to help the military defeat the terrorists in Marawi.

"We have achieved that purpose," Cayetano replied, without elaborating.

Joint statement

In a joint statement issued afmats expressed "concern over the recent incidents of terrorism and violent extremism in their countries" and their desire to plotjoint strategies to combat it.

The three neighboring countries also agreed to enhance intelligence and information sharing on potential, imminent and real threat; stop the flow of terrorist financing; contain the spread of terrorism and related content in cyberspace and on social media; prevent and suppress terrorist exploitation of information and communication technology.

They also agreed to prevent and stop arms smuggling and the movement of terrorists. consider specialized military and law enforcement training, and counter the narrative of extremist groups through education and promotion of tolerance, moderation and unity in diversity. -with reports from ap AND REUTERS INC

Rody, Widodo reaffirm commitment vs terror

The Philippines and Indonesia vowed to work closely to combat terrorism in Southeast Asia as the Duterte administration continues to grapple with members of the Islamic State-inspired Maute terrorist group in Marawi City.

The commitment was made during a telephone conversation between President Duterte and his Indonesian counterpart Joko Widodo on Wednesday night.

The conversation took place before the trilateral security meeting among Indonesia, Malaysia and the Philippines in Manila yesterday.

"The call was productive and fruitful. They both reaffirmed the need to step up cooperation to address threats posed by terrorism and violent extremism," presidential spokesman Ernesto Abella said in a press briefing yesterday.

Widodo reaffirmed Indonesia's commitment to support the Philippines in countering terrorism, including restoring Turn to Page 2

"They noted the importance of the trilateral meeting, which aims to foster cooperation against terrorism among regional neighboring states," Abella said

On Tuesday, Duterte said he would discuss with Widodo the presence of Indonesian extremists in Marawi.

"I think most of the foreign fighters were Indonesians," Duterte added.

Trilateral security meeting

The foreign ministers of the Philippines, Indonesia and Malaysia reaffirmed yesterday their desire to work together to implement counterterrorism measures amid the incidents of terrorism and violent extremism in their countries.

Foreign Affairs Secretary Alan Peter Cayetano, Indonesian Foreign Minister Retno Marsudi and Malaysian Foreign Minister Dato' Sri Anifah Hj Aman met in Manila to enhance cooperation in addressing threats of terrorism in the region.

The trilateral security meeting reaffirmed the three nations' commitment to effectively address existing as well as emerging transnational challenges and threats that have the potential to undermine the stability and wellbeing of countries in the region.

The meeting was held at the Conrad

Hotel in Pasay City.

Malaysia proposed yesterday the formalization of the mechanism of the trilateral security meeting with the Philippines and Indonesia, seen as an urgent task evidenced by the conflict in Marawi City.

Malaysia's foreign minister said the formal mechanism would include sharing of experiences and information that could be translated into concrete action.

"There is a need to agree to formalize our cooperation through the establishment of mechanism, which will include

all stakeholders. This is an urgent task as evidenced in the situation in Marawi City. Countries must participate," Anifah said.

The ministers agreed to task their senior officials to consider the proposed Plan of Action in the context of the following measures: enhance effort and cooperation in addressing the root causes and underlying conditions of extremism including but not limited to poverty, illegal drugs, crime and social injustice; promote social and economic development particularly in adjoining areas of the three countries; enhance the intelligence and information sharing among security and intelligence agencies on potential, imminent and real threats; stop the flow of terrorist financing; contain the spread of terrorism and terrorism-related content in cyberspace, particularly on social media.

Also included in the Plan of Action are measures to prevent the terrorist exploitation of information and communication technology and the dissemination of terrorist messages; stop the flow of arms smuggling as well as the movement of terrorists.

The proposed Plan of Action will consider the provision of specialized military and law enforcement training; support the trilateral cooperative arrangement and other sub-regional efforts to combat transnational crime; review and implement existing agreements on terrorism and make a cross-analysis comparison of each other's laws on terrorism with a view to enhancing legislation.

It will also protect vulnerable groups, particularly women, children and the

youth, from terrorism.

The foreign ministers agreed to hold their next meeting in Indonesia in October.

The Sub-Regional Meeting on Counter Terrorism, 11th ASEAN Ministerial Meeting on Transnational Crime and the 2nd Special ASEAN Ministerial Meeting on the Rise of Radicalization and Violent Extremism will be held in Indonesia,

Myanmar and the Philippines, respectively, this year.

National Security Advisor Hermogenes Esperon Ir. and chief of the National Counter Terrorism Agency Comissioner General Suhardi Alius were also present at the meeting.

Joint maritime operations by Indonesia, Malaysia and the Philippines to fight transnational crimes and terrorism in the Sulu Sea were launched on Monday in Tarakan, North Kalimantan, Indonesia, just across the border of Sabah, Malaysia.

The launching of the trilateral maritime patrol was attended by Defense Secretary Delfin Lorenzana, Indonesian Defense Minister Ryamizard Ryacudu and Malaysian Defense Minister Hishammuddin Hussein.

Earlier, Lorenzana said eight foreign jihadists have been killed since the fighting between government troops and Maute militants erupted in Marawi City last month. Among the slain jihadists were Indonesians, Malaysians, a Yemeni and a Chechen.

Ryamizard Ryacudu said there are around 1,200 Islamic State members in the Philippines.

The trilateral maritime agreement among Indonesia, Malaysia and the Philippines is expected to boost business in the Autonomous Region in Muslim Mindanao (ARMM), an official said.

Ishak Mastura, ARMM Regional Board of Investment chairman, said the trilateral patrols in the region would help spur business activities in Basilan, Sulu and Tawi-Tawi.

Before attending the security meeting in Manila, Dela Rosa was present at the turnover of command at the PNP Regional Office 10 in Cagavan de Oro City, where Chief Supt. Timoteo Pacleb, his mistah at the Philippine Military Academy, took oer ras the PNP 10 regional director.

Pacleb replaced Chief Supt. Agripino Javier, who retired from the police service vesterday.

The PNP chief said they have not monitored terror threats in Northern Mindanae, specifically in the cities of Cagayan de Oro and Iligan. - With Pia Lee-Brago,

Maute enlists 40 foreign terrorists

ORTY foreigners have joined the Maute group to battle the government, Armed Forces of the Philippines chief of staff Gen. Eduardo Año said Thursday.

In an interview, Año said 20 of the foreign terrorists were Indonesians, while the rest are from Malaysia, Saudi, Yemen, and other countries.

Indonesians have also joined other terrorist groups, such as the Bangsamoro Islamic Freedom Fighters, the Abu Sayyaf and the AKP, he said.

Año also said Isnilon Hapilon, the Abu Sayyaf leader, and Abdullah Maute, one of the two Maute brothers, were still

alive. The other Maute brother, Omar, was believed to be dead.

Fighting between the Maute terrorist group and government troops has been going on in Marawi City since May 23.

Afio said local politicians who were funding the Maute operations had no links to the Islamic State, but were helping the local terrorists for their own reasons.

"They have common interests, which is to fight the government, so they join

or they support Maute for their personal political interest, but that makes them also guilty," he said.

Afio admitted they did not have a timeline to retaking Marawi City, where the fighting has been building-to-building.

Lt. Col. Jo-ar Herrera, spokesperson for Joint Task Force Marawi, said Thursday the Maute terrorists were abandoning their firearms and blending in with

civilian evacuees to get out of Marawi City.

"As their bailiwick native land, the terrorists are knowledgeable of the terrain here in Marawi City. They are also using that advantage to slip out of the area to escape," Herrera said in a statement.

Government security forces have arrested several alleged high-profile members of the Maute group, including Cayamora and Farjana Maute, parents of Abdullah and Omar, leaders of the group, as well as the brothers' other siblings.

Amid this, Herrera assured the public that government troops are doing everything to track down members of the group who were able to flee Marawi City.

Sporadic clashes have been ongoing in Marawi City since May 23 after the Maute group attacked the city, prompting President Rodrigo Duterte to put the entire Mindanao under martial law.

Brig. Gen. Ramiro Manuel

Rey, commander of Task Force Ranao, said improvised explosive devices planted by the group are delaying the clearing operations being conducted by government troops.

"The Maute terrorists are pushed back in a corner due to the AFP's continuous effort. But they are using IEDs to block the government troops," he said.

He added that Maute group members are using hostages as human shields and slaves to gain grounds.

"Hostages were even forced to place LPG tanks with fuel as IEDs against the AFP troops," he said.

Herrera said the number of Maute members still resisting government forces in Marawi has dwindled to a little over 100.

"According to the information we are getting from the ground troops operating in the area, there are more or less 100 members of Maute terrorist group left after one month-battle here in Marawi," he said.

As of 6 p.m., June 21, a total of 276 Maute terrorists have been killed while 271 firearms have been recovered. On the

government side, 67 have been killed in action while 461 were wounded.

A total of 26 civilians have also been killed while 1,658 have been rescued due to the conflict.

The three suspected members of Maute terrorist group arrested by Philippine Coast Guards in Iloilo were charged Thursday before the Department of Justice's special panel of prosecutors.

The suspects identified as Faridah Pangompig Romato, of Carmen. Cagayan de Oro; Aljadid Pangompig Romato, alias Miks Jadid Romato, of Higar City: and Abdulralman Dimakuta Sevad, of Marantao, Lanac del Sur were presented before the DOJ's special panel of prosecutors for inquest proceedings on rebellion charges.

The hearing was held inside the Camp Evangelista in Cagayan De Oro City, where most arrested Maute members and supporters are currently detained pending request of the DOJ before the Supreme Court for their transfer to Camp Bagong Diwa in Taguig City. With Rey E. Requejo

8 dead after BIFF attack in Cotabato

'Situation back to normal'

EIGHT people, including six terrorists, were killed following Wednesday's attack by the Islamic State (IS)-linked Bangsamoro Islamic Freedom Fighters (BIFF) in North Cotabato, but the situation was "back to normal," the military said.

The two others killed were civilian Towan Dading Esmael, 61, and Abraham Sakilan Cutay, 33, who was training to be part of the civilian militia.

Ten people were injured eight BIFF men and two militiamen.

Most of the more than 1,300 residents of Pigkawayan town evacuated by the military following the BIFF raid

have returned to their homes, said Capt. Nap Alcarioto, spokesman of the Army's 602nd Infantry Brigade.

The BIFF bandits on Wednesday morning stormed a public school after retreating from an early-morning firefight with the Army's 34th Infantry Battalion. This was despite a martial law deciaration over Mindanao amid the military offensive against the Maute group that attacked Marawi City last month.

"Normal situation [in Pigkawayan] is back since our civilians have already returned but not all of them. The situation in the highway is back to normal, Pigkawayan's entrance too," Alcarioto said in an interview.

Still, 30 members of the BIFF remained inside the school compound, and soldiers were pursuing others who escaped, he said. Authorities are on alert for possible attacks by the BIFF against law enforcers and civilians.

"[We are also conducting] clearing operations in the vicinity of Pigkawayan. That's what the troops are currently doing." said Capt. Arvin Encinas of the 6th Infantry Division.

Encinas said government troops went inside the school compound at around 6 p.m. on Wednesday, forcing BIFF members to leave behind civilians they had used as "human shields."

At least two of the escaping BIFF bandits were arrested by the loint Task Force Central at a checkpoint in Maguindanao province.

Armed Forces of the Philippines

(AFP) spokesman Brig. Gen. Restituto Padilla Jr. clarified that the school was not surrounded by the BIFF, but the terrorists managed to dig a tunnel to escape.

Classes in the school were temporarily suspended.

In a report, the AFP Western Mindanao Command identified the arrested bandits as Jahren Mantukay, 23 and Bardurin Limbay. 28, said to be members of the BIFF Special Operations Group under a certain "Palos."

The firefight between the military and the BIFF men lasted for about 11 hours, ending at 5 p.m. on Wednesday.

A total of 1,370 evacuees from the villages of Malagakit. Simsiman, Banucagon and Gentral Tanasan were brought to the Pigkawayan National High School.

'No spillover'

Malacañang on Thursday took pains in saying that the Pigkawayan attack was not a spillover of the Marawi conflict.

"It's not connected so we cannot say it is a spillover. It is an opportunistic action coming from the BIFF group." Palace spokesman Ernesto Abella said in a news conference.

Abolla issued the statement after President Rodrigo Duterte cautioned against a spillover of the Marawi siege into other parts of the country, which he emphasized was a sufficient reason to impose martial law in Mindanao.

But the Palace official clarified Duterte was "just giving heads up that we need to be aware of circum-stances in our environment."

Six BIFF men killed in firefight By Francisco Tuyay

SIX members of the Bangsamoro Islamic Freedom Fighters were killed in a clash with government troops in Barangay Malagakit, Pigcawayan, North Cotabato on Wednesday, a military official said Thursday

Capt. Napoleon Alcarioto, spekesman for the 602nd Brigade, said civilians told the military that the BIFF rebels retrieved the dead bodies and fled on board a motorized outrigger on the Ligusan Marsh.

Civilians also saw eight BIFF members who were wounded, Alcarioto said.

On the other hand, two members of the Civilian Armed Forces Geographical Unit were wounded during the exchange of gunfire.

"The situation is back to normal as most of the civilians particularly those residing along the highway are back at their homes while others are still in the evacuation centers," Alcarioto said.

Classes at the Malagakit Elementary School, which the BIFF occupied for hours during the skirmishes, are still suspended.

Some 200 to 300 BIFF rebels swooped down on two military detachments in the villages of Malagakit, and Simsiman, and started firing at troops manning the posts on Wednesday.

The BIFF then forcibly entered and destroyed several houses in three villages, forcing civilians to flee to safer ground as fighting lasted for hours.

The BIFF withdrew under the cover of darkness, leaving a militia-man—Abraham Cutay and a civilian dead.

A military statement said 63 civilians were rescued by the Joint Task Force Central, which clashed with the BIFF rebels in North Cotabato.

Soldiers from the 602nd Brigade advanced towards the Malagakit Elementary School to rescue the hostages, who were used as human shields, and engaged the fleeing rebels at about 6 p.m. Wednesday.

The rebels left 31 of their captives behind as they fled.

Thirty-two residents trapped in the crossfire left their homes and joined the rescued hostages.

Members of the 34th Infantry Battalion provided mortar fire support to the Simsiman Detachment in Barangay Simsiman, Pigcawayan, North Cotabato, and blockaded Barangay Malagakit, while troops from the 7th Infantry Battalion and the 34IB attacked the rebels.

Two BIFF members were held by the troops of the 22nd Mechanized Company, 2nd Mechanized Battalion, Mechanized Division, at a checkpoint in Butilin, Datu Salibo, Maguindanao at 9:20 a.m. Wednesday,

Troops found two sachets of shabu on the BIFF members. With John Paolo Bencito



KIDAPAWAN CITY-The crisis that gripped a community in Pigcawayan town in North Cotabato province when about 200 Moro rebels stormed a government militia outpost and sparked a gunfight is over.

But the 15-hour standoff. which started when members of the Bangsamoro Islamic Freedom Fighters (BIFF) attacked the villages of Malagakit and Simsiman at 4 a.m. on Wednesday, killed a government militiaman and wounded two others. The fighting also forced more than 1,000 residents to flee their villages.

The military claimed to have killed six and wounded eight of the fleeing BIFF men but Abu Misri Mama, spokesperson for BIFF, denied this. Mama said no one among his group was killed or wounded.

Capt. Napoleon Alcarioto, 602nd Brigade spokesperson, said Abraham Cutay, who was scheduled to graduate from a sixmonth Citizens Armed Forces Geographical Unit training on Thursday, was killed by a BIFF recruit in front of his wife as they tried to flee Barangay Malagakit.

Cutay was hit in the knee as he and his family tried to flee during the gunfight.

"They tried to escape but they were caught by BIFF members," Alcarioto said, quoting the victim's wife.

Alcarioto said two other militiamen, Angel Verona and Resty Segundera, were wounded in the firefight on Wednesday.

The standoff ended on Wednesday night when BIFF men withdrew toward Liguasan Marsh in the nearby province of Maguindanao.

Mayor Eliseo Gracesa said at least 73 residents, who were trapped in the village when fighting erupted, were unhurt.

Capt Arvin John Encinas, spokesperson for the Army's 6th Infantry Division, said BIFF freed also members hostages, among them children, at 7 p.m. Wednesday.

"Clearly, they were used as

human shields by BIFF," Encinas said. "When darkness came, they fled."

Mama said they attacked the village as a response to military offensives in Mamasapano town in Maguindanao. He warned the military of more attacks.

"I told you we did not use civilians as human shields. We protected them inside the school (Malagakit Elementary School)," Mama told the Inquirer in a telephone interview on Thursday.

Alcarioto said information on slain and wounded BIFF members came from residents who were rescued by soldiers.

These residents, he said, told soldiers that BIFF rebels took the bodies of their slain companions as they fled on board a motorized banca provised explosive devices. traversing Liguasan Marsh.

"We are basing our claim on the accounts of civilians trapped and held hostage inside Malagakit Elementary School. They were later rescued by our 34th Infantry Battalion forces," Alcarioto said

Romeo Capao-an, Pigcawayan municipal disaster risk reduction and management officer, said the number of displaced residents reached 1,200 on Thursday. He said the local government took them to a covered court in Barangay Poblacion.

Capao-an said they discouraged residents from returning to their villages on Thursday while bomb experts were clearing the area of im-

Eight public schools in villages surrounding Malagakit suspended their classes on Wednesday and Thursday, Garcesa said.

Elpidio Singon, a farmer living close to the militia outpost in Malagakit, said he was awakened by gunfire on Wednesday

"We ducked and when gunfire stopped, I brought my family out of the house and we ran away," Singon said

He said he saw his neighbors also fleeing, bringing with them their children and some personal belongings.

"We ran with nothing but only our clothes on our back," another villager, Susan Cando, 39, told reporters. INQ

BIFF men escaped through marshland

THE military and the police yesterday said members of the Bangsamoro Islamic Liberation Front, who occupied a school in Pigkawayan town in North Cotabato Wednesday, escaped aboard pump boats through a marshland behind the school.

Soldiers lacked "water assets" that would have enabled them to pursue the BIFF attackers, said Capt. Nap Alcarioto, spokesman of the Army's 802nd Brigade based in North Cotabato.

Senior Supt. Leonardo Suan, deputy regional director for operations of Central Mindanao Police Regional Office, said the pump boats used by the BIFF men were docked at the shorelines of Liguasan Marsh, which is several meters from the rear portion of the Malagakit Elementary School in Barangay Malagakit.

He said the soldiers were not able to pursue the escaping BIFF men as Liguasan Marsh is vast.

Liguasan Marsh connects the towns of Pikit and Midsayap, both in North Cotabato, and Cotabato City, an independent component city of Maguindanao province.

Suan said a detachment was set up at the back of the school, manned by members of the Regional Public Safety Battalion, to prevent similar attacks.

AFP spokesman Brig. Gen.

Restituto Padilla said the BIFF men escaped Army vision 5, 2, through a portion of the school, which was

unguarded by soldiers.

"The school was not actually completely DEFICE OF THE ARMY SHIEF PUBLIC AFFAII surrounded. One area was not covered. They (BIFF members) sensed the troops were preparing (to strike) and there was also reinforcement that arrived," said Padilla.

"Under the cover of darkness, they withdrew. The good thing is that they left behind the hostages, who we rescued," he said.

Pursuit operations are being conducted by troops of the Army's 34th Infantry Battalion, said Capt. Arvin Encinas, spokesman of the Army's 6th Infantry Division based in Maguindanao.

Encinas also said 30 BIFF men were involved in the occupation of the school and abduction of 31 civilians, including students. The BIFF men originally plotted to attack a military detachment in the nearby Barangay Simsiman but occupied the school instead after their plan was thwarted by barangay security personnel.

Alcarioto maintained the BIFF group was composed of around 200 to 300 men.

He also said they escaped through the

"Between Barangays Malagakit and Simsiman, that's a marshland. They extricated through that area, they withdrew using pump boats," he said,

The BIFF started the attack at around 6 a.m. and withdrew from the school at around 6 p.m. as soldiers were moving to rescue the hostages.

The BIFF left behind the civilian hostages. Also recovered were 32 civilians trapped in the fighting.

"Troops of 602nd Brigade advanced towards Malagakit Elementary School at around 6 in the evening to rescue the hostages held by the BIFF and upon seeing the government troops, the bandits hastily retreated going to barangay Simsiman leaving behind their captives," said Encinas.

'At present, Barangay Malagakit is now cleared from the BIFF bandits. Likewise, pursuit operation is still being conducted," said Encinas.

Padilla said the conflict has resulted in the death of four BIFF men and a government militiaman, and wounding of two other militiamen.

Padilla also said the school remained close as of yesterday as troops were clearing it of improvised explosive devices.

Suan said the situation in the area is now "normal."

Suan also said a militiaman and an elderly man were killed by the BIFF, but residents said there were an undetermined number of killed on the enemy side as bodies wrapped in "malong" were seen being carried away by the BIFF while withdrawing towards Liguasan Marsh.

The killed militia was identified as Abraham Cutay, who was supposed to graduate as a civilian volunteer on June 27.

Suan said the BIFF had snipers positioned in strategic areas.

BIFF hostages now safe; pursuit operations still on

Government security forces screed all 63 civilians held as uman shields and trapped during the brief occupation of a school in igcawayan, North Cotabato by tembers of the Bangsamoro stamic Freedom Fighters (BIFF) in Wednesday.

However, the BIFF attack esulted in the killing of two ivilians, identified as Towan ading Esmael, 61, a farmer and a esident of Barangay Simsiman, and

Abraham Cutay, 33, a Cafgu trainee and a resident of Barangay Malagakit

More or less 300 BIFF members on Wednesday initially attacked a Cafgu detachment in Barangay Simsiman before taking hostages from Malagakit Elementary School upon their withdrawal.

Capt. Napoleon Alcarioto, spokesman for the Army's 602nd Brigade, said that normalcy is back in Pigcawayan after government forces managed to foil the BIFF attack.

"The situation is now normal. Some civilians have returned to their communities," Alcarioto said.

Alcarioto said that the BIFF managed to withdraw from the back of the barangays which was a marshland.

"They quickly extricated from the back, between barangays Malagakit and Simsiman...they withdrew using pumpboat," Alcarioto said.

However, he stressed that pursuit operations are still ongoing against the BFF attackers. The military's Joint Task Force Central said that all 68 civilians previously held as human shields and were trapped during the skirmishes in Pigcawayan were rescued safely.

The task force also announced that two BIFF members were intercepted along a checkpoint in Maguindanao hours after the atrocity.

BIFF frees 31 hostages

Attack in North Cotabato leaves 8 people dead, 10 others wounded

he Armed Forces of the Philippines (AFP) said that 31 civilians earlier held hostage by members of the Bangsamoro Islamic Freedom Fighters (BIFF) who attacked Pigcawayan, North Cotabato, were freed

by the terrorist group Wednesday night.

The attack, which started from the harassments of a barangay security office and a military detachment at around 6 a.m. on Wednesday, also left eight people dead – six BIFF fighters, a government militiaman, and a farmer. Ten others were wounded.

Police and military officials

said they have yet to verify the death of the six BIFF fighters, but they confirmed the death of Abraham Cutay a government militiaman stationed at the military detachment that washarassed by the BIFF

"He was about to graduate on June 27 as CAA (Civilian Active Auxiliary)," said Chief Supt. Dionardo Carlos, spokesman of the Philippine National Police (PNP).

Captain Napoleon Alcarioto, 602nd Brigade spokesman, said two other companions of Cutay – Angel Verona and Resty Segundera – were among the wounded. Berona and Segundera suffered only minor injuries and were already discharged from the hospital. The rest of the wounded were members of the BIFF

Army 6th Infantry Division spokesman Captain Arvin Encinas said the 31 hostages were reportedly released at about 6 p.m or about 12 hours after they were seized by the heavily armed BIFF men, who fled to the marsh in Maguindanao.

"Nung padilim na at around 6 o' clock habang gumagapang papalapit yung ating tropa, tumakas sila leaving behind itong civilians na ginawa nilang hostages (As our troops inch closer at around 6 p.m., they fled, leaving behind the civilian hostages)," Encinas said.

No more BIFF

Army Captain Nap Alcariote, spokesman of the Army's 602nd n-Telno. (02) 845-9555 Local: £285, 5295 Brigade, said that based on reports; the area has already been cleared of BIFFmen.

Lt Col Angelo Lutera, com mander of the 34th Infantry Battalion said that as of 6 p.m., on June 21, they already occupied Malagakit Elemen tary School in Barangay Malagakit The school was used as temporary base of the BIFF after they raided the village and nearby Barangay Simsiman, both in Pigcawayan, last Wednesday.

Despite this, Lutera said they have not yet given the displaced families the "go signal" to return to their houses due to ongoing clearing operations in the area.

Lutera, in an interview Thursday over Catholic-ran DXND, said they are still in search for bombs which might have been planted by the BIFF to prevent government troops from pursuing them in their escape.

Alcarioto said ground forces are also concentrating on retrieval operations for some civilians still hiding after being trapped as a result of the standoff.

Review defense plan

Meanwhile, the PNP leadership reminded all its police commanders to review their defense plan, especially in defending police stations and vital installations, amid the communist rebel and BIFF attacks.

"We are reminding our field commanders to look at their camp defense plans and the guarding of vital installations in order to prevent these kinds of attack," said Carlos.

Early this week, Maasin Police Station in Iloilo was overran by communist rebels who ransacked the police station's armory and communication room.

On Wednesday, the local police have scrambled to guard the police stations and other establishments in North Cotabato after the BIFF attack.

Troops pursue BIFF raiders in Cotabato

Combined government troops and militiamen have driven back to the Liguasan Marsh more than a hundred Bangsamoro Islamic Freedom Fighters (BIFF) rebels who tried to occupy two villages in Pigkawayan, North Cotabato the other day

Captain Arvin Incinas, spokesman of the 6th Infantry Division, said pursuit operations are ongoing against the BIFF terrorists who in their escape had occupied an elementary school in Barangay Malagakit, holding a

civilian and a number of school children as hostages.

"They (BIFF) just waited for nightfall to leave the school and abandon their hostages used as human shields," Incinas said.

North Cotabato Vice Gov. Shirlyn Macasarte-Villanueva, a member of the provincial peace and order council, vesterday urged Muslim and Christian residents to disregard obvious attempts to break their _solidarity.

"Let us be sober and continue with the friendship and solidarity that

we have. We just have to be vigilant and we need to help each other prevent a repeat of the incident," Villanueva said

The BIFF terrorists, led by Abunawas Damiog, Abu Saiden and Salahudin Hassan, destroyed religious statues in a Catholic chapel and robbed abandoned houses and stores in Malagakit. They also ransacked the barangay hall and a nearby health clinic.

Salvador Almonia Jr., barangay Malagakit chairman, led a 30-member barangay volunteer militia in blocking the initial route the terrorists took.

He said the bandits destroyed portraits of President Duterte in the buildings and classrooms they looted

Education Secretary Leonor Briones reminded everyone that schools and learning spaces are zones of peace and that the security and safety of learners, teachers and nonteaching personnel is a priority during conflict, disaster and emergency.

The Department of Education said that although the extent of the damage has yet to be determined, no learner and personnel were being held hostage as of yesterday.

Classes remain suspended in the area as government troops continue with clearing operations.

Malagakit Elementary School was reportedly damaged while Simsiman High School confirmed that its offices and computer room were ransacked by the terrorists. An on-duty school guard managed to escape to a nearby military detachment after the BIFF fired at him.

A day prior to the simultaneous attack in Barangays Malagakit and Simsiman, the Army acted on intelligence warning of an impending assault and reinforced its ranks to secure the two villages, he added. Both barangays, located along the marsh, were used as staging points for the assault.

"Under cover of darkness, they were able to extricate from the area on board pump boats," said Capt. Nap Alcarioto, spokesman of the Army's 602nd Brigade.

Alcarioto cited the key role of the Barangay Peacekeeping Action Team (BPAT) in foiling the simultaneous assault launched by 200 to 300 BIFF terrorists on the two villages. He said BPAT, an organized militia force composed mostly of farmers, assisted the soldiers in pushing the attackers back to Liguasan Marsh. - With Rainier Allan Ronda, John Unson, Emmanuel Tupas

AFTER MONTH-LONG OFFENSIVE, MILITARY WARNS

'Marawi war may last longer'

FTER a month of fighting in Marawi, the Armed Forces of the Philippines (AFP) on Thursday admitted for the first time it would be hard to flush the remaining Islamic State (IS)-linked Maute terrorists out of the city.

Brig. Gen. Restitute Padilla Jr., the AFP spokesman, described the armed conflict in Marawi as a "very complicated engagement," considering that the city has an urban terrain.

Padilla then cited a number of prolonged offensives against terrorists overseas, such as in the Iraqi cities of Mosul, Ramadi and Fallujah.

"So if you will compare [these events] to this current and ongoing engagement, the terrains are very much the same and we are doing this very carefully," he told reporters.

"We have compounding comolex issues: the presence of hosages, residents [staying] in their nomes and continued discovery of IEDs (improvised explosive levices)," he added.

Padilla warned that fighting in Marawi City could take longer.

"People are very impatient but they don't know the sacrifices of their soldiers. It's easy to say, 'Why are we not finished yet, why are we not done with this yet," he said. The military official dared those criticizing the pace of military operations to go to Marawi "so that you will know the complexity of the battlefield."

At least 276 suspected terrorists have been killed since clashes between the Maute group and government troops began on May 23. Sixty-seven soldiers and policemen and 26 civilians have also been killed.

The military said some 500 civil-

ians were still trapped in Marawi.

Fighting began after the government's failed attempt to capture the supposed IS chief in the region, Abu Sayyaf leader Isnilon Hapilon, in the Muslim-majority city.

The Maute men then went on a rampage, torching schools and business establishments and seizing and killing hostages.

President Rodrigo Duterte placed the entire Mindanao under martial law on May 23, as well as suspended the privilege of the writ of habeas corpus to allow warrantless arrests.

The military had claimed fighting would end in days, but failed to meet its own deadlines to end the conflict, including that on June 12, Independence Day.

Booby traps

Padilla blamed booby traps placed by the Maute bandits in Marawi.

Last weekend, members of the Philippine Marine Corps clearing a building found an improvised explosive, according to the military spokesman.


"So they tried to deal with that by trying to explode it remotely. When they did, it was followed by more than 12 or 10 gunshots from the other house as well," Padilla narrated.

"It is like a Judas' belt," he added, referring to the firecracker.

Marawi operations 'complicated': AFP

AN exasperated Armed Forces yesterday told critics to join soldiers fighting aute Group members in Marawi City so they will understand the "complexity" of the armed conflict which is now a month old.

"It is easy to say why are we not finished yet, why are we not done with this yet. We'll if you want to know and understand, then come with us to the battlefield so that you will know the complexity of the battlefield," said AFP spokesman Brig. Gen. Restituto Padilla.

"This is a very complicated engagement because it is urban terrain at its worst," he said of the crisis which has already led to the death of 276 Maute members, 67 soldiers, and policemen and 26 civilians.

The fighting broke out last May 23 when Maute members fought government forces out to arrest senior Abu Sayyaf leader Isnilon Hapilon during a raid on a terrorist safe house. The Maute and Abu Sayyaf are aligning themselves with the Islamic State of Iraq and Syria (ISIS) which has reportedly name Hapilon as its Southeast Asia head.

Padilla cited prolonged campaigns in the Middle East against the ISIS and Al Qaeda terror group in the past years, including the Battle of Mosul in Iraq which began October last year and is ongoing up to now.

"If you will compare (these) to this current and ongoing engagement (in Marawi), the terrain is very much the same. And we are doing this (operation) very carefully because we have compounding complex issues," he said.

Among the issues, he said, are the presence of civilians being held by the Maute members, the refusal of some residents to leave their houses in the conflict area, and improvised explosive devices laid by the enemy.

Asked if the operations will take longer, Padilla said: "There is possibility. What I am saying is that it is complex, it's not that easy. People are very impatient but they don't know the sacrifices of their soldiers."

Padilla said soldiers have to conduct clearing operations very carefully. He said the Marines re-

covered an improvised explosive device (IED) in the conflict area over the weekend while clearing a building.

"They tried to deal with that by trying to explode it remotely. When it was remotely exploded, a series of 10 to 12 explosions oc-

curred, up to a nearby residence. It's like 'judas belt' (a type of firecracker)," said Padilla.

"The sympathetic layout of the booby trap, IED, is that complex. If you are going to carelessly enter the area and trigger the bomb, the entire building will collapse. If you're wounded, you are not going to survive because of the collapsed building. The people should understand that," said Padilla.

MAUTE MEN SLIPPING OUT

Lt. Col. Jo-ar Herrera, spokesman of the Army's 1st Infantry Division, said there are "a little over a hundred" Maute members still in the city. Officials earlier said the fighting is confined in four barangays.

Herrera said they have information that some of the Maute members have fled the city by blending with evacuees, leaving their firearms in the conflict zone.

"As their bailiwick native land, the terrorists are knowledgeable of the terrain here in Marawi City. They are also using that advantage to slip out of the area to escape. But the authorities assure that the combined strength of the security forces and other government agencies, these terrorists have nowhere to hide," said Herrera.

Brig. Gen. Ramiro Rey, commander of the Task Force Rango, said the presence of IEDs is delaying the cleaning operation.

"The Maute terrorists are pushed back in a corper due to the AFP's continuous effort. But they are using IEDs to block the government troops. They are also using hostages as human shields and slaves from gaining grounds," said Rey.

"Hostages were even being forced to place LPG tanks with fuel as IEDs against the AFP troops," he said.

Globe Telecom, in coordination with the AFP and the Department of Information and Communications Technology, launched a 15day free call and text promo for soldiers and other prepaid subscribers in Marawi City.

The promo - good for Globe/TNT to Globe and TNT connection only -- can be extended if needed, said Globe president and chief executive officer Ernest Cu during the launching in Camp Aguinaldo.

"We thought it was an easy decision to make to open up the cell sites for call and text to everybody who is in the area," said Cu, adding the promo will allow soldiers and everybody "suffering and affected in Maravi" to call and text their loves ones.

Told that Maute members may also take advantage of the promo, Cu said: "I'm sure they came prepared. It is our Armed Forces who are unable to call."

"I'm sure they (Maute members) are communicating with each other already but there is no way for us to know who is there. As long as you are there (in Marawi), it's free," Cu said.

FAMILY TENTS

The government has started buying "familysized" tents to serve as temporary shelter of some 69,000 displaced families, Social Welfare Secretary Judy Taguiwalo said.

She said each tent can hold up to eight persons, has windows for ventilation, and will serve as temporary shelter while a permanent housing is being constructed.

The 69,434 families (almost 340,000 persons) evacuated from Marawi City and Marantao town in Lanao del Sur.

The government has earmarked P662.5 million for the procurement of the tents along with other items like "Halal" food packs, hygiene kits, and other non-food items.

Israel donated P1 million worth of medical supplies to the Philippine Red Cross for the evacuees.

Sen. Richard Gordon, PRC chairman, thanked Israel Ambassador Effie Ben Matityao. The donation included assorted medicines and equipment. - With Jocelyn Montemayor and Christian Oineza

AFP SAYS TERRORISTS CORNERED AS FIGHTING ENTERS FIFTH WEEK

The battle for Marawi enters its fifth week on Friday, with the 400-500 gunmen from the Maute terrorist group and their allies from the Abu Sayyaf bandit group who seized the city on May 23 just "a little more than 100" now, Lt. Col. Jo-Ar Herrera, spokesperson for the Army's 1st Infantry Division, told reporters on Thursday.

"Their area has been reduced to a square kilometer," said Lt. Col. Christopher Tampus, commander of the Philippine Army's 1st Infantry Battalion.

Tampus' troops were blocking escape routes across bridges spanning a river to the west of the terrorists. "Our forces are coming from the east and the north and we are blocking the three bridges," he said.

No deadline

But Herrera, in a talk with reporters on Wednesday, could not give a categorical answer to the question when the crisis would end.

"There is no timetable, there is no deadline. What we are doing is [making] sure that the city is safe again by clearing it of the terrorists," he said.

Herrera insisted that the terrorists' firepower was flagging, but Tampus on Thursday said his troops were having difficulty moving forward.

He said snipers were still firing from "strategic nests" in schools and mosques, and homemade bombs were hampering the progress of his troops as they advanced house to house.

Tampus said he had seen at least five civilians dressed in black who appeared to have been forced to stand in the street as human shields.

According to official estimates late on Wednes lay,

In his talk with reporters on Wednesday, Herrera said many terrorists had been wounded in the fighting and that there was no confirmation of reports that the leaders of the Maute group—brothers Omarkhayam and Abdullah Maute—and Abu Sayyaf leader Isnilon Hapilon, who had pledged allegiance to IS, had been killed.

"They are still in the area, based on our monitoring and reports we get," he said.

More than 300,000 residents have fled Marawi and outlying towns. More than 40,000 jam government-run evacuation centers in Iligan City in Lanao del Norte and the rest sheltering with relatives in the province and surrounding areas.

Civil war unlikely

Tuesday, President Duterte spoke to reporters in Cagayan de Oro City of the importance of ending the conflict as soon as possible, warning that Christians could arm themselves against Muslims if the fighting spilled over to other parts of Mindanao.

But Gen. Eduardo Año, the military chief of staff, said on Thursday a civil war in Mindanao was unlikely.

Año said a civil war would happen only if the government allowed civilians to arm themselves.

Containing terrorists

He said the military and the Philippine National Police would "do their jobs to end the hostilities as soon as possible" to prevent the rise of communal unrest.

Chief Supt. Dionardo Carlos, spokesperson for the PNP, told reporters orders had gone out to police commanders, particularly in Mindanao, to prevent the fighting in Marawi from spreading to other parts of the island.

"We are conducting check-

points and intelligence monitoring to prevent the Maute group from moving and carrying out terror acts elsewhere, & Carlos said

Residents weary.

9555, Local: 5285, 5295

A month after the terrorists seized Marawi to establish an enclave for IS in southern Philippines and the military moved in to dislodge them, residents who stayed in the city and those who fled say they are weary.

"We want to live normal llives] again," said Amina Batugan, 62, whose family did not leave Emie Punud village, less than 3 kilometers from the city center, where the fighting is going on.

The village is located on elevated ground and a nearby Army outpost protects it from terrorist attack.

But bomb blasts and the noise of automatic gunfire keep the family on edge.

"How I wish it would end," Batugan said.

Hadji Kamid Solayman, 48, of Lilod village, said he and his family fled their home and sought refuge in a house owned by another family in Matampay village. which is near the headquarters of the 103rd Infantry Brigade.

We thought it was safe here." he said.

Stray bullets

But the place is close to the battle zone and the house is frequently hit by stray bullets.

"We may have avoided getting killed in the crossfire but we might be killed by stray bullets," Solayman said. "When will this war end?"

Soraida Bato, 45, a mother of four, took her family and fled Lilod, seeking refuge in Matampay.

But like the Solaymans, her family, she said, is "living in fear because of the explosions, the gunfire and the stray bullets.

She wished the fighting would end so she and her family could go home.

"It doesn't matter to me if I don't have a house to return to .555 Local: 5285, 5295 because we can easily build a new one," she said. "We're weary." INQ

Maute fighters abandoning arms, blending with civilians

The Islamic State-inspired Maute group of extremists are abandoning their weapons and blending in with the civilian evacuees to escape Marawi City, the military said yesterday.

Lt. Col. Jo-Ar Herrera, spokesman of Joint Task Force Marawi, said the militants are getting desperate to avoid government forces closing in on what remains of their stronghold.

After the series of arrests of alleged Maute terrorists, including the parents of the Maute brothers who led the attack in Marawi City, hopeless terrorists have chosen to abandon their firearms and blend with the civilian evacuees who are escaping from ground zero," Herrera said.

He added the militants are using their familiarity of the terrain to their advantage in slipping out from the area of operations.

Security forces, however, are well aware of the tactic and

have formed a defensive ring around the area where the militants are holding out to prevent their escape.

"The authorities assure the people that with the combined strength of the security forces and other government agencies, these terrorists have nowhere to hide," Herrera said.

Sporadic clashes have been ongoing in Marawi City since May 23 after the Maute group attacked the city, prompting President Duterte to put the entire Mindanao under martial law.

Herrera said the number of militants fighting the government troops in Marawi is dwindling.

"According to information we are getting from the ground troops operating in the area, there are more or less 100 members of the Maute terrorist group left," he said.

Lt Colonel Christopher Tampus said the militants have been confined to an area of a square kilometer.

Tampus, who is leading the troops supporting the assault on the remaining strongholds of the rebels, said they are blocking escape routes across bridges spanning a river to the west of the militants

"Our forces are coming from the east and the north and we are blocking the three bridges," he said

Tampus told reporters the militants were still using snipers firing from "strategic nests" in schools and mosques and placing homemade bombs to hamper the progress of troops as they advance house to house

Snipers, armed with powerful 50-caliber Barrett rifles, also targeted journalists who are in the "safe zones."

Tampus said he had seen at least five civilians dressed in black who appeared to have been forced to stand in the street as human shields.

According to the latest official estimates, 369 people have been killed during the month-long hostilities, three-quarters of them militants. The number of security forces and civilians killed stood at 67 and 26, respectively

Military spokesman Brig. Gen Restituto Padilla explained the fighting is still continuing because the soldiers have to deal with various challenges.

"This is a very complicated engagement because it's an urban terrain at its worst," Padilla said.

Asked if the fighting may drag on further, Padilla said there is always the possibility of a protracted war against the terrorists.

While the military is busy dealing with the terrorists, concerned sectors opened up their operations free for Marawi residents.

Globe telecommunications opened its mobile services in Marawi City for free to enable soldiers and civilians to contact their families.

There are around 300 to 500 residents still trapped in the battle zone without any contact with the outside world, as well as thousands of soldiers deployed in the area to flush out the Maute terrorists.

The military yesterday said some Islamic State inspired terrorists now trying to escape Marawi City by disguising themselves as among trapped civilians wanting to get out of the "war zone" as government unity forces continued to flush out the enemies who are still putting peckets of resistance in a small portion of the Islamic City.

"According to the information we are getting from the ground lops, there are more or less 100 members of Maute terrorist oup left after one month battle here in Marawi," Lt. Col. Jo-al rrera, spokesman of the military's Joint Task Force Marawi said. "The terrorists are knowledgeable of the terrain here in Marawi ty. They are also using that advantage to slip out of the area to cape," he added.

In the fourth week of the conflict which started May 23, a total 258 Maute terrorists have been killed along with 55 troops and

lice officers along with 26 civilians.

Also, four out of the 96 barangays of Marawi City are still msidered "problematic areas" where the terrorists continued to utup pockets of resistance and hold hostages as human shields. For weeks now, the terrorists have resorted to sniping and urning down structures to resist advancing government forces. Turn to page 3

The military said the terrorists are also planting improvised explosive devices (IEDs), including liquefied petroleum gas (LPG) tanks, inside residential structures targeting troops conducting house-tohouse clearing operations.

'Very careful'

Armed Forces of the Philippines (AFP) Chief of Staff Eduardo Ano, for his part, stressed the military is very careful and deliberate to spare the lives of innocent civilians during the operations against the

"We want to minimize the destruction of properties and we want to save lives of civilians. If we will assault and do bombings

indiscriminately, if would be easy...butthere are trapped civilians," he said.

"Methodical, deliberate and carefully (we conduct) house to house, building by building, floor by floor (clearing operations). It's precise, we don't bomb buildings with civilians, "he stressed.

"When we say clearing operations, it does not only involved flushing the remaining Maute Group members, this includes removal of IEDs, landmines, and unexploded ordnance. This will take a while to ensure that no injury nor death will be inflicted to returning civilians," AFP public affairs office chief Col. Edgard Arevalo said.

He declined to give an exact time line in neutralizing the remaining Maute Group

terrorists but stressed this will not take much more time.

Año has already directed military engineers to prepare for the rehabilitation of Marawi City immediately after the area is cleared.

"The AFP chief of staff has directed the mobilization of engineering units in preparation for the rehabilitation, reconstruction and rebuilding of Marawi as soon as the conflict is over," said Padilla

He added at least two battalions of engineering units would be tasked to rebuild Marawi City.

Commitment vs terrorism

Malacañang, meanwhile, said the phone call between President Rodrigo Duterte and Indonesian President Joko Widodo

reaffirmed their commitment to fight the rising threat of terrorism and violent extremism in the region.

Presidential spokesperson Ernesto Abella said the two leaders had a "productive and fruitful" phone conversation Wednesday night as they vowed to further strengthen ties in the fight against terrorism.

"They both reaffirmed the need to step up operation to address threats posed by terrorism and violent extremism," Abella told a Palace briefing.

He added the Indonesian leader also vowed his continuing support for a lasting peace in Mindanao peace process.

"And Widodo also reaffirmed Indonesia's commitment to support the

Philippines in countering terrorism, including restoring peace and stability in the southern Philippines," Abella said

Meanwhile, Indonesian Foreign Minister Retno Marsudi yesterday said Jakarta stands ready to provide financial aid to the Philippine government in assisting the war-stricken Marawi City.

"We observe closely the development in Marawi City. Indonesia strongly condemn the terror attack," she during the opening of Indonesia, Malaysia, the Philippines' trilateral meeting on extremism.

"On behalf of the government of Indonesia, I'd like to express our sympathy and condolences especially to the families of innocents, police and the Armed Forces of the Philippines."

Lawyers' group cites reports of 'military abuses' in Marawi

The Integrated Bar of the Philippines (IBP) Lanao del Sur-Marawi City Chapter slammed the military and police stationed in Marawi City for alleged abuses of authority in the area, among them looting unauthorized intrusions and illegal seizures.

In a statement, the IBP Lanao del Sur Chapter said it expresses "severe outrage and condemnation over illegal searches and seizures in Marawi City by military men, police, and other law enforcement agencies."

While the group said it has been supportive of President Duterte's martial law declaration, it maintained "it has not closed its eyes on any forms of abuses committed in the implementation thereof."

"The IBP-Lanao del Sur Chapter has been utterly shocked, to use a milder term, by sheer magnitude of wanton disregard of sanctity of domicile, the right against deprivation of property without due process of law," the group said.

The lawyers' group, citing numerous reports, lamented the illegal searches and seizures that have caused "rampant loss of valuable personal belongings of innocent and helpless civilians has been reported."

The IBP chapter bared that "residential and commercial establishments have been laid open to locaters all over the besieged city."

"The remnants of ransacked residential and commercial establishments bear imprints of gruesome acts of blatant violations of laws," it stated.

The IBP likened the alleged "wholesale illegal

searches and seizures" to the martial rule under former president and late dictator Ferdinand Marcos, saying it is "unparalleled in its magnitude for even the Marcos years of martial rule pales in comparison."

The IBP said the forced entries were done "without the presence of the media, the owners or any authorized persons" with the police and military showing "total disregard of plain view doctrine of searches and seizures activities."

"As shown in video footages and pictures posted in social media, military men who committed these criminal acts in public exhibited no remorse," the statement read.

"And yet, no one raises a voice of dissent," the group lamented.

The IBP expressed alarm over the "deafening silence" in Congress, other government agencies, and the media as it may be construed "as an implied approval of unspeakable acts of bestiality."

In turn, the group called on Defense Secretary Delfin Lorenzana, martial law administrator, to "immediately stop searches and seizures without court warrants."

The group also asked Lorenzana to "create a credible multi-agency investigation committee composed of independent groups and individuals to avoid whitewash and ensure impartial findings and swift prosecution."

"If, in the remotest possibility, this urgent plea falls on deaf ears, the IBP-Lanao del Sur Chapter will not hesitate to take appropriate legal action," the group warned. 73 June 2017

"No abuses should happen. If they are making accusations that some of our policemen and soldiers are involved, they should file the appropriate charges," Carlos said in a press briefing in Camp Crame, Ouezon City.

Carlos insisted they would never tolerate abuses such as looting being committed by either by soldiers or police-

"We hope they would back it up with evidence," he said.

He told the lawyers who made the accusations to look at the atrocities committed by members of the Maute terror group in Marawi.

Rebellion charges filed vs 3 Maute suspects

The three reported members of the Maute terror group arrested by the Philippine Coast Guard in Iloilo Sunday were charged with rebellion before the prosecutor's office

yesterday.

Suspects Faridah Romato of Carmen in Cagayan de Oro, Aljadid Romato of Iligan City and Abdulralman Sevad of Marantao in Lanao del Sur were presented before the Department of Justice (DOJ) special panel of prosecutors for inquest proceedings held inside Camp Evangelista in Cagayan de Oro City Inquest is an informal and summary investigation done by a public prosecutor on persons arrested and detained without a Warrant.

Most of the arrested Maute terrorist group members are currently detained at Camp Evangelista pending the approval of the DOJ's petition before the Supreme Court (SC) to have them transferred to Camp Bagong Diwa in Taguig City.

After inquest, prosecutors are expected to issue a resolution and file a case against the three before the Cagayan de Oro regional trial court tapped by the SC to hear the cases

against them.

The three were arrested while on board 2Go's passenger ship M/V St. Therese of the Child Jesus in Iloilo City. The ship came from Cagayan de Oro and was en route to Manila

The DOJ has indicted several other arrested members

and supporters of Maute, including Cayamora Maute and Ominta Romato Maute, alias Farhana, parents of the Maute brothers who led the group behind the attack in Marawi City last May 23.

Also charged with rebellion before the Cagayan de Oro RTC were former Marawi City Mayor Fajad Salic and Mohaamad Maute, alias Abu Jadid, alleged bomb maker of Maute Group who was arrested in Cagayan de Oro last week.

In Pagadian City, policemen arrested two suspected medics of the Abu Sayyaf group while buying in bulk medicine that included antibiotics, anti-bacterial, pain relievers and other post-traumatic-medications at a local pharmacy Wednesday morning.

Chief Supt. Billy Beltran, police Region 9 director, identified the two as Jadzrie Saabdula, 50, a nurse assigned at the Tongkil Municipal Hospital, and Jamal Kalib Jamil, 18, a fisherman. Both are natives of Sulu.

He said initial investigation showed that Saabdula is the brother of slain Sulu-based Abu Sayyaf Group commander Nadjmi Saabdula, alias Kumander Global, who was captured along with another leader, Ghalib Andang alias Commander Robot. The two leaders were among the detainees killed during a botched jailbreak from a government camp in Bicutan in March 2005.



An inquest is a summary investigation conducted by a prosecutor on a person or persons arrested and detained without the benefit of a warrant of arrest, to determine whether evidence is sufficient for the prosecutor to seek the approval of the court to keep the person or persons in detention.

The three were apprehended while on the way to Manila when the 2Go vessel they were in stopped at the port of Iloilo.

Authorities said Farida was in charge of the logistics of the Maute group. – Ashzel Hachero

'Marawi siege a magnet for foreign fighters'

With the ongoing crisis in Marawi City, the Philippines might become a "magnet" for Islamic State (IS) militants fleeing allied offensives in Mosul in Iraq, Armed Forces chief Gen, Eduardo Año said yesterday

He said there are indications foreign fighters are attempting to come to the country to help like-minded militants, particularly those battling government troops in Marawi City.

"Yes, that's what we're carefully watching because efforts of the allied forces are turning out well, and they are forecasting an IS defeat in six

months," Año said.

"So we expect those displaced to go to Asia and because of the Marawi crisis, the Philippines might serve as a magnet. And we really have to be on guard." he told reporters on the sidelines of the trilateral meeting on security among officials of the Philippines, Indonesia and Malaysia at the Conrad Hotel in Passy City.

Mosul used to be the center of the IS stronghold in Iraq. The historic district and a tiny area to its north are the only parts of the city still under the militants' control.

The AFP chief said his merchave monitored about 40 foreign fighters, including 20 Indonesians and six Malaysians, in Mindanao.

"Out of the 40, more or less half

of them are scattered all around (Mindanao) but the others might be dead already, so we can't validate properly because we did not recover bodies," he explained.

On reports that 1,200 Indenesian fighters have joined the Marawi battle, he said the number could include members of the Maute group, the Abu Sayyaf and the Bangsamoro Islamic Freedom Fighters.

"They all think they're IS, but in our eyes they're not - they're local," Año stressed.

And although they have pledged allegiance to 15, they are "not 100 percent ISIS," he pointed out

He also said Abu Savyal group senior leader Isniion Hapiton might still be alive, but not local terrorist leader Omar Maute.

A YouTube video post in July 2014 showed Hapilon swearing allegiance to ISIS.

Hapilon was reportedly designated leader of the IS Southeast Asia cell last year but his links to terror groups had long been established.

A military airstrike in Marawi City repertedly killed Omar Maute

"Hapilon is still inside (Marawi), that's why the militants remain defiant. But Omar Maute more or less appeared to be already dead," Año said.

He added it would be difficult to give soldiers a deadline for ending the Marawi siege as it might give them undue pressure and ulumately undermine the campaign to liberate the city.

On Wednesday, the military cleared at least 56 buildings but one soldier was killed in the pro--

Gov't to use Pagcor funds to rebuild Marawi; 'tent city' to rise for homeless

By GENALYN D. KABILING

The government intends to use Philippine Amusement and Gaming Corporation (Pagcor) funds to bankroll the P20-billion massive rehabilitation program for war-torn Marawi City and build a "tent city" as temporary shelter for the displaced residents.

Presidential spokesman Ernesto Abella said the first half of the rebuilding funds will be sourced from the stateowned gaming corporation. "Where to get the P20billion Marawi fund? DBM (Department of Budget and Management) Secretary (Benjamin) Diokno said that the first P10 billion would come from Pageor," Abella said in a

"We assume that the next \$10 billion may also come from the same source, just an assumption," he said.

Palace news conference.

Duterte has promised to rebuild Marawi City and help the homeless residents recover from the conflict.

He said at least \$\mathbb{P}20\$ billion would be set aside the rehabilitation of the war-ravaged city. The amount is twice the \$\mathbb{P}10\$-billion budget originally proposed in the draft executive order on the "Bangon Marawi" rehabilitation program.

Asked if the "Bangon Marawi" order has been signed by the President, Abella said there was no update yet from the Office of the Executive Secretary about the matter.

Tent city

A tent city for the homeless residents may soon rise in Marawi City once the armed conflict is over, according to Social Welfare Secretary Judy Taguiwalo.

She said the government intends to hasten the acquisition of tents for distribution to thousands of families displaced by the rebellion in Marawi City.

Instead of giving away money for emergency shelter, Taguiwalo proposed that family-sized tents could be used as temporary shelter of the Marawi residents while the rebuilding of the conflict-torn Marawi City is being implemented.

"We are procuring now

procurement three weeks ago in preparation for the return of our evacuees to Marawi City and we hope to provide individual tent per family," she said in a Palace news conference.

"This can be immediately used rather than the emergency shelter assistance where you have to wait for the validation, etc. before you can have it so that's the plan," she said.

Taguiwalo said each tent can accommodate eight persons and has windows similar to an ordinary house.

"While the physical construction of the city is ongoing, they have a place to stay. They can stay at least in the tents," she said.

The tent procurement, however, suffered some problems after a failure of bidding last Wednesday, according to Taguiwalo.

To hasten the tent acquisition, the DSWD suggested that procurement procedures be made less stringent amid the "emergency" situation.

Free text from Globe

Meanwhile, to help residents and soldiers to contact their families, the Globe network will provide 15 days of free text to all networks and calls to Globe and TM to its customers in Marawi City starting yesterday, June 22.

The effort to provide communication links is the result of a partnership of the Armed Forces of the Philippines (AFP), Department of Information and Communications Technology (DICT) and Globe Telecom.


At present, some 300 to 500 Marawi residents are still trapped in the battle zone without any contact to the outside world, while government troops continue to risk their lives in the month-long fight against the Maute terrorist group.

Tent city for Marawi evacuees

Tents big enough for eight people would be the temporary houses of families displaced by the war in Marawi while the city is being rebuilt, according to Social Welfare Secretary Judy Taguiwalo.

The Department of Social Welfare and Development (DSWD), Taguiwalo said, had started the process of procuring tents for each of the 69,434 families displaced by the fighting in Marawi and currently staying in evacuation centers.

Taguiwalo said her department had allotted at least P622.5 million for Marawi residents who fled the city

The money would be spent not only on food but also hygiene kits and other basic necessities, she said.

Taguiwalo said the tents, aside from having space for eight individuals, would have windows.

She said the DSWD was trying to speed up the bidding process after an initial bidding failed.

Immediate use

The use of tents, said Taguiwalo in a briefing in Malacañang, would reduce the waiting time for families to have temporary shelters as the tents "can be immediately used."

She said her department would do away with "emergency shelter assistance where you have to wait for validation, etcetera, before you have it."

She was referring to the program implemented by her predecessor which gave cash to Supertyphoon Yolanda (international name: Haiyan) survivors to either repair homes or build new ones. The program, however, became controversial when many survivors complained of being disqualified as beneficiaries because of red tape

Taguiwalo said groups or individuals who wanted to help in Marawi could consider donating tents.

The reconstruction of Marawi, covered by a P20-billion fund expected from the Philippine Amusement and Gaming Corp., was expected to take at least six months.

The number of people in evacuation centers is just about 5 percent of all the displaced residents of Marawi, said Taguiwalo. The rest had found shelter, usually in relatives'

houses in different provinces, she said.

She said she didn't expect the displaced residents to rely solely on aid as some, who had found shelter in Dumaguete City, had already sought DSWD help to find jobs and not depend on the government.

The DSWD was preparing a livelihood seminar and checking which jobs could be offered to the displaced Marawi residents, said Taguiwalo

The National Economic and Development Authority was in charge of helping evacuees find livelihood sources with the help of other government agencies, she said.

Families that would be allowed back to Marawi would get P4,000 each to help them start anew. INQ

AFP to send Bicol soldiers to Marawi

CAMP EUAS Angeles, Pili, Camarines Sur — The Armed Forces of the Philippines (AFP) will send another battalion from the 9th Infantry Division of the Philippine Army based in Bicol to help government troopers battling Maute terror group in Marawi City.

According to Lt. Col. Omar Orozco of the 9th Infantry Division, the 2nd Infantry Battalion under the 903rd Infantry Brigade, a battle-tested unit against communist rebels in Milagros, Masbate will be deployed to Marawi City this month.

Orozco said the 9th Infantry Division has sent at least three battalions now fighting against the terror group since the Marawi City crisis broke out last May.

He said among the Bicol army battalions fighting in Marawi were the 49th Infantry Battalion, the 65th IB and another army battalion, who were sent to Mindanao since last year on the orders by President Rodrigo Duterte to strengthen the AFP's forces in Mindanao

He said the 9th ID has adequate force in the island province of Masbate, where rebels have threatened to retaliate after the surrender of 19 young rebels in Milagros town last week.

Text message from Marawis 'I can't go out'

MARAWI CITY—Trapped in a war zone, Camalia Baunto's husband. Nixon, had been trying for weeks to stay alive as Islamic State-linked terrorists and government forces battled for control of this city.

With the fighting raging around him, Nixon texted and called throughout, until just over a week ago when the messages stopped abruptly, leaving his wife praying that it was just his cell phone battery that had died.

"I'm OK, but I can't go out. The house is safe," the 51-year-old hardware store owner had told his wife in a message from their home inside the city.

He heard gunfire in the street, he wrote, and hid from black-clad fighters who have pledged allegiance to the Islamic State (IS) jihadist group in Iraq and Syria and have occupied the city's commercial district for a month.

Messages stopped

On June 14, at 9:59 a.m., Nixon texted to ask Camalia to buy him more credit for his phone, which she did.

He said he had bruises and scratches that he got from evading capture by the terrorists. There was rice at home, but water had become a problem. "He said he would just collect rainwater to drink," Camalia said.

Then the messages stopped, and his phone stopped ringing.

"I've had sleepless nights since then," Camalia, 42, told Reuters at Marawi's government compound, where she has been sleeping in a mosque while awaiting word of her husband.

300-500 still trapped

The couple and their children were out of town when fighting erupted in Marawi on May 23, but Nixon went in the next day to check on their home and got trapped. Like most of the city's residents, the family is Muslim.

Officials estimate 300 to 500 people are still trapped inside Marawi, fearful of terrorists accused of using civilians as human shields as much as of government airstrikes and starvation.

Some families have sent messages saying they have resorted to eating blankets or

cardboard dipped in water to keep hunger at bay.

The military has said it is in the final stages of its operation to oust the terrorists, whose Arm V ranks contain local militants and foreign, battle-hardened fighters from the IS campaigns in Syria and Iraq.

tough resistance, exploiting the city's narrow streets, thick concrete walls and basements, and harassing troops with sniper fire and Molotov cocktails.

Military aircraft—with technical assistance from US Special Forces—have pummeled the city with 225-kilo bombs, raising fears about the safety of civilians unable to get out

In the early stages of the conflict, many people were texting and calling in their whereabouts.

Their best hope of getting out lies with a "peace corridor" initiative of President Duterte.

The initiative is being carried out by Philippine Army officers and their former adversaries, fighters from the Moro Islamic Liberation Front. which signed a peace deal with the government in 2014.

The team says it has helped to evacuate 270 people since it was set up on June 4. It has also delivered supplies to those who remain behind.

Others have escaped by making their own way across the city, dodging sniper fire, to cross the Bangolo bridge over the Agus River and reach the government-controlled area.

Batteries run down

But there is no power and water in the city. Phone batteries have now largely run down and the team has no way to contact most of those inside, including Nixon Baunto.

used Nixon had phones, Camalia said, and the power must have run out in both.

Families visiting the evacuation team's office on Wednesday provided 15 new names of loved ones they say are trapped in the city, according to Wendell Orbeso, a director at the Office of Presidential Adviser on the Peace Process.

Later, the team received a text saying 10 or more people 4 were hiding out in a grocery

how many people are still there," Orbeso told Reuters at government building now mostly used to house evac-

The locations of the beleaguered civilians are passed to military commanders in the hope that soldiers can rescue them.

After flushing terrorists The fighters have put up from the city's neighborhoods, troops have moved house-tohouse, watching out for booby traps that include cooking gas cylinders rigged to explode, Brig. Gen. Ramiro Manuel Rey, commander of the military's Task Force Ranao, told reporters in Marawi on Wednesday.

Eid al-Fitr

Camalia has been told the Army is close to clearing the terrorists from the area around her home, she said.

Nixon was too scared to leave the house, she said. He believed he would likely be captured by the militants or mistaken for a fighter and shot by the military, he told her.

He had survived by collecting and drinking rainwater.

Earlier in the siege, Nixon ventured out to a mosque, where he reported seeing more than 100 civilians sheltering, including women and children nursing gunshot wounds, he told his wife.

"He could not take the shooting, the bombing and the fear of stray bullets," she said, so he returned home, further from the epicenter of the bat-

"Why can't they rescue my husband? There are already hundreds of troops in Marawi. The military can go in and take him," she said.

"[I]f we wait longer for the Army to do a house-to-house search, it may get too late. We may not get him alive. He's been trapped for a month. No matter how strong you are, your health will fail in this situation. Have pity on me," she said.

"I pray to Allah every day, every night, every hour for this war to end so my family can be reunited," Camalia said, wiping tears from her eyes.

She was desperate to have her husband back for the Eid al-Fitr festival this weekend, she said. "If he's not back, I have no interest in celebrating." -REUTERS WITH JASON CITIEDDETINMANIIA INO

Anno's father, Teodoro, and his younger sister accompanied Carmi to Laoag. "He was too young to die but I'm proud of my son. He's a hero as he offered his life for our country." Teodoro said.

He said Anno dreamed of becoming a doctor but he joined the Army instead.

Carmi said she was still in shock but added that she had to remain strong for their daughter.

"I hope the battle would soon end so no more lives are needlessly lost," she said.

"When a soldier goes to war, one foot is already in the grave. He is lucky if he returns home alive. That is why we should respect and do not take them for granted, particularly in times of war," said retired Air Force Col. Ricardo Nolasco Jr., AMWSLAI chair and president.

Anno is the sixth beneficiary donations from cash AMWSLAI and Hannah's Resort. The families of the slain soldiers were also given P500,000 each as education assistance.

As part of AMWSLAI's mandate, a general fund has been allocated for the college scholarship of soldiers' children. Since the program was launched, about 200 beneficiaries had graduated from college, Nolasco said.

The Department of the Interior and Local Government (DILG) has also asked other government agencies to help employ qualified dependents of soldiers and policemen killed or wounded in operations against terrorists in Marawi.

DILG officer in charge Catalino Cuy said his department was preparing to accommodate as many of the 261 beneficiaries as possible.

Of this number, 196 are dependents of Armed Forces of the Philippines personnel while

65 are from the Philippine National Police

"We are doing the rounds to assist the families and we need all the help that we can get. This is the least that we can do to the families of our heroes," Cuy said

Some P28.2 million will be needed to fund the salaries of 261 beneficiaries for six months at P18,000 monthly for each dependent, he said.

Last month the DILG asked for a subsidy of P35 million from the Department of Budget Management to pay for the salary of 21 dependents that the agency employed

The Department of Trade and Industry has pledged to enlist small and medium enterprises in hiring some of the spouses and widows of soldiers and policemen while the Department of Labor and Employment has offered employment programs, through the Public Employment Service Office or the government internship program, to help dependents get jobs.

The Bangko Sentral ng Pilipinas provides financial literacy courses to the dependents and has expressed willingness to employ some of them as security personnel provided they are graduates of four-year college courses or are licensed professionals.—REPORTS FROM LE LANIE ADRIANO AND JEANNETTE LANDRADE INQ

CIVIL WAR FAR FROM HAPPENING - AFP CHIEF

A CIVIL war in the Philippines is far from happening but should Christians start to fight Muslims, it will be difficult to stop it. Armed Forces chief Eduardo Año said on Thursday.

He was reacting to the warning of President Rodrigo Duterle that

a civil war may erupt if Christians start arming themselves to fight extremists.

In an interview during the necrological rites for military Bishop Leopoldo Tumulak late Wednesday, Ano said if such a conflict breaks, it will not be prevented immediately.

"His (Duterte) warning will take a long time before it happen, but of course, some civilians, especially Christians in the Muslim areas, they wanted to aim themselves to defend themselves," he told reporters.

"But if the President approve of that, you cannot prevent fights of clans, of barangay (villages). That is what we call civil war. But it is far from happening," Año said, adding that the military and police will step in to nip such conflict in the bud. **DEMPSEY REYES**

End the fighting before we become another Mideast

Emust take decisive steps to keep the fighting in Marawi City from escalating into a bigger war that could involve other nations.

The Armed Forces of the Philippines (AFP) has cleared most of the 96 barangays of Marawi City and is now concentrating on four barangays where the Maute with Islamic State (IS)-supported fighters from Indonesia and Malaysia continue to hold out. The United States is assisting the Philippine forces under our Mutual Defense Treaty with surveillance and other technical support, but with "no boots on the ground."

Last week, American lawmakers belonging to President Donald Trump's Republican Party came out to call for a bigger US involvement than the current "advise and assist" role. Iowa Sen. Joni Ernst expressed fear that Marawi may become a new center for Islamic fighters from Southeast Asia and elsewhere in the world. "We need to address the situation," he said. "It should not get out of control."

The AFP has disclosed that about 40 foreigners have been among the 500 involved in the fighting in Marawi, with at least one Saudi, a Chechen, and a Yemeni among those killed. An Islamic State propaganda video released through the Amaq News Agency website advised jihadists that if they find it hard to join the fighting in Syria and Iraq, they should proceed instead to the Philippines.

Already deeply involved in the fight against the Islamic State in Syria and Iraq are Russia and the US, but these two nations have found themselves on opposite sides in Syria Russia is fighting with the Syrian government against several rebel forces that include the Islamic State. The US is supporting the Syrian Democratic Forces, an alliance of Arab and Kurdish forces, that is fighting the Islamic State while battling the Syrian government.

If the fighting in Mindanao should widen to include more combatants from the US, the Middle East, and Southeast Asia, we can expect the kind of bloody confusion that has befallen Syria, Iraq, and the rest of the Middle East.

We thus hope that our Armed Forces will soon be able to put an end to the fighting in Marawi, before combatants from other nations, each driven by their respective interests and causes, get drawn to the fighting and the Philippines becomes another confused battleground like the Middle East.

he US military presence in Marawi, which was sought out by our defense officials, is a welcome development as it translates into "technical support and assistance" for our troops in the fight against the Abu Sayyaf-Maute terrorists that went on a rampage to destroy the city. MARAWI SIEGE INVITING FOREIGN TERRORISTS?

tis amazing how a small fraction of the Muslim population is causing so much trouble as to invite a global proxy war in Mindanac. The Mautes are just a tiny clan with about 200 followers. Their issue is not ideological but feudal—a small clan war. They are being used by the Abu Sayyaf, which is also a small terrorist group, albeit powerful

The Abu Sayyaf's power is anchored on two factors.

First is the millions of pesos from ransom. As of May 2017, after the group beheaded a decrepit German, it had 27 hostages. At the conservative average estimate of P10 million per hostage, the group could rake in P270 million, or about a quarter of a billion pesos from this number of hostages. Note that the group takes hostages from everywhere, daring recently to expand its kidnap-for-ransom operation to Bohol. The P52.2 million seized by the Marines in Marawi comes from ransom income or from the Islamic State (IS) itself.

Second is its link to IS whose goal is a global caliphate. The idea of a caliphate in Marawi, the largest Muslim city in the Philippines, is pure megalomania, an illusion that the Abu Sayyaf inherited from the IS. An IS rather than Abu Sayyaf strategy, the Marawi war has reportedly drawn foreign Muslim warriors from Indonesia, Malaysia, Saudi Arabia, Yemen and Chechnya. The IS, using the Abu Sayyaf, wants to replicate the Syrian proxy war, where foreign warriors outnumber local rebels. They want a blood bath. The burning of a Catholic church and the beheadings carry an IS signature and are a provocation.

President Duterte says he was not told about the US presence in Marawi. The Armed Forces of the Philippines and the Pentagon have formed a more intimate bond through the Balikatan war games. The AFP took the risk of not telling Mr. Duterte ahead of time, thinking he will agree to the effective US role. Is the United States violating the mutual defense treaty?


The US presence, even if limited to noncombatants, is dangerous. True, it is effective in giving critical antiterror training, technology and sophisticated weapons, with drones and the P3 Orion surveillance plane identifying targets, and the OV-10 Bronco doing "precision" bombings. But US presence is inviting the global escalation of the Marawi crisis. The precision bombings, as in Aleppo and Mosul, will result in a lot of Muslim civilian casualties. These atrocities will invite further rapid global escalation.

The AFP-Pentagon combine miscalculated the power of Abu Sayvaf-Maute. Their intel failed to identify massive sophisticated armaments. The AFP is good in jungle warfare, but not in house-to-house urban warfare, that is why it lost the initiative momentarily.

Both AFP-Pentagon and Abu Sayyaf-Maute are dug in, with Agus River as their demarcation line; this promises a protracted war. Time favors the Abu Sayyaf as more foreign troops and funds may pour in. The AFP has to finish this war soonest before it explodes into a full-blown Mindanao war.

To destroy is not to save

or at least 12 hours on Wednesday, fierce fighting engulfed parts of the town of Pigcawayan in North Cotabato. A large group of Bangsamoro Islamic Liberation Front rebels attacked an outpost of the Barangay People's Augmentation Team in Malagakit village, but the Philippine Army was able to quickly send reinforcements and engaged the BIFF attackers. No casualties were reported, on either side.

When the rebels retreated, they took several civilians with them. A BIFF spokesperson, Abu Misri Mama, denied allegations that the civilians were used as hostages. "We protected them from the bullets of the Army. We will release them later. We did not use them as human shields," he said. But this is absurd. The civilians were minding their own business before the rebels attacked the militia outpost. The view offered by Capt. Nap. Alcarioto, spokesperson for the 602nd Infantry Brigade, is much more credible: The civilians were taken precisely to cover the rebels' retreat.

Several dozen families were temporarily displaced by the fighting; there were residents who were trapped in their homes during the incident; classes throughout the town were suspended, affecting some 15,000 students.

Tactically, the attack by the BIFF, a splinter group that broke away from the Moro Islamic Liberation Front, succeeded only in temporarily distracting the attention of



Ar the Armed Forces. But it could not have been an attempt to ease the pressure against the Maute group in Marawi City, about 200 kilometers away. "It's too small an effort. It was just a harassment case," Brig. Gen. Restituto Padilla told reporters in Malacanang.

But strategically, the conseguences of the BIFF attack can be serious—if the government responds in exactly the wrong way...

The tragic conflict in Marawi, now on its fourth week, is a cautionary tale. Despite the consistent assurances of the Armed Forces that the problem



posed by the Maute group and the Abu Sayyaf could be contained, President Duterte imposed martial law in all of Mindanao. Despite the steady progress of the military campaign to restore order in Marawi, the President continued to wax pessimistic about the threat posed by the so-called is—the terror network that is losing ground in Iraq and Syria and in its desperation is now encouraging attacks elsewhere in the world by both organized armed groups and so-called lone wolves. A couple of days ago, Lt. Col. Jo-Ar Herrera, spokesperson for the Army's 1st Infantry Division, said: "We continue to recover and control strategic areas in the cleared area and the enemy resistance is waning, their controlled area diminishing." But on Tuesday, Mr. Duterte suggested that, just to end the conflict in the historic city, he was open to the idea of carpet-bombing Marawi.

This is a horrifying idea, and certain to fan the flames of the radicalism that makes the IS ideology attractive to alienated, disempowered men. The President has the right impulse; not to waste soldiers' lives. But he must go beyond thinking that there are no other choices left.

"I will not put the soldiers at high risk. If I have to bomb the ... if I have to flatten the place, I will do it. And I will take full responsibility for it," he said. "I will order the bombing ... carpet already, carpet ah .. I will really destroy everything.

This is to follow the tragically mistaken American strategy during the Vietnam War, when villagers were massacred and villages were destroyed as part of an effort to defend what was then known as South Vietnam. Do we really want to go down this path, where to save Marawi we need to destroy it?

Sadly, the President has started talking about a civil war in Mindanao, between Christians and Muslims.

In the Armed Forces' perspective, the BIFF attack on Wednesday was merely an "opportunistic activity." If the government decides to make it bigger than it is, and responds by reducing the options available and at the same time escalating the tensions, then the question of long-term strategic consequences for the country will rear its ugly, monstrous head.

AFP ready for any retaliatory attacks

MANILA, June 22 -- With the military soon-to-conclude its operations against Maute Group remnants in Marawi City, the Armed Forces of the Philippines (AFP) on Thursday announced it has prepared all of its units for possible retaliatory attacks by ISIS and other terror groups.

"There are always such threats, and our answer is that we're ready to respond," said AFP spokesperson Brig. Gen. Restituto Padilla in Filipino.

However, he said they are still to detect or monitor such threats from any terrorist cell or group.

"They (Maute Group and their allies) are still very much in the defensive, they are all locked there (in Marawi City) and we have not monitored any (movement that would indicate that they are planning attacks against other civilian and military targets)," Padilla disclosed.

And as the Marawi City crisis reaches its first month anniversary Friday, he admitted that totally neutralizing the remaining terrorists is complicated engagement because of the urban terrain with the enemy well aware of their positional advantage.

Padilla cited the cases of military units in the Middle East, despite their firepower and numerical superiority, of having extreme difficulty in combating ISIS terrorists when it comes to the urban setting.

"In the case (of) the Battle of Mosul (in Iraq), it is still ongoing up to now, (having) started October 2016 and it not yet finished yet (despite) been going on for eight months. In Libya (which conducted operations against) ISIS/Daesh (terrorists) the battle started May 12 and ended only last Nov. 6, so it lasted over six months, in the Battle of Ramadi where American and Iraqi militaries combined to fight the ISIS terrorists, the operation started April and ended only on November 2006 and during the Second Battle of Fallujah (where the Iraqi, American and British forces combined) against Al-Qaeda terrorists, operations lasted Nov. 7 up to Dec. 23, 2004," he added.

"So if you will compare it to this current and ongoing engagement, the terrain is very much the same, and we are doing this very carefully we have compounding complex of issues, presence of hostages, residents in their homes refusing to leave, and continued discovery of improvised explosive devices, (necessitating) the door-to-door clearing operations our soldiers must practice," Padilla pointed out. PH intensifies fight vs terror as foreign terrorists move to Asia

The Philippines is intensifying its cooperation with Indonesia and Malaysia in the fight against terrorism, as terrorists who may be ousted from Mosul in Iraq are expected to move to Asia, said Armed Forces of the Philippines (AFP) Chief of Staff General Eduardo Año.

Año told reporters they were closely monitoring the situation amid indication there were attempts from foreign fighters to come to the Philippines.

He noted that allied forces in Mosul are forecasting to achieve victory over Islamic States (ISIS) in six months.

"So we expect that those who will be displaced there will move to Asia. And because of the Marawi crisis, parang magnet itong Pilipinas (Philippines can be the terrorists' magnet)," he said on the sidelines of trilateral security meeting between Indonesia, Malaysia and the Philippines held here Thursday.

Año bared that Philippine authorities have monitored 40 foreign terrorists across the country, half of which are Indonesians. The remaining 20 are Malaysians, Saudis and Yemenis.

To jointly combat terrorism, the AFP chief said the three countries are sharing counterterrorism information.

Año noted Malaysians and Indonesians were normally recruited by the ISIS as the group wanted to set up a base in Southeast Asia.


He added the launching of trilateral maritime patrol was aimed at countering terrorism.

The joint maritime operations by Indonesia, Malaysia and the Philippines to fight transnational crimes and terrorism in the Sulu Sea were launched last Monday in Tarakan, North Kalimantan, Indonesia.

"Not only intelligence, sharing information but (also) joint training. There is an ongoing joint training on counterterrorism and HADR (humanitarian assistance and disaster relief)," Año added.

The AFP chief also stressed there was no need for assistance from Indonesian and Malaysian troops for the Marawi fighting.

"What is only important here is the information sharing and probably supporting each other for example helping us to observe their ways in order for us to legislate laws that will help us," Año added. (PNA)

Troops, residents in Marawi get free texts, calls for 15 days

Troops battling the terrorist Maute Group in Marawi City got a much-needed boost in morale after telecommunications company, Globe, announced it is providing 15 days of free texts to all networks and free calls to Globe and TM subscribers in the locality, starting Thursday afternoon.

"Communication is of extreme importance in any instance of disaster, be it natural or manmade. As a telecommunication company with the purpose of treating people right, Globe fully supports the AFP (Armed Forces of the Philippines) and DICT (Department of Information and Communication Technology) who are experiencing these challenges by reconnecting them with their families and helping make the situation a little easier to bear," Globe president and chief executive officer Ernest Cu said.

He said the free services for their Globe and TM pre-paid subscribers in Marawi City will allow residents and soldiers to communicate with their loved ones even if they do not have pre-paid load.

The ceremonial switching of service took place at the AFP Cyber Center in Camp Aguinaldo, Quezon City.

Cu said they are amenable to extending their free service if needed.

AFP deputy chief-of-staff for communications, electronics and information systems, Maj. Gen. Jose Tanjuan Jr., lauded Globe's gesture as this will afford troopers an open-line of communication with their loved ones.

"We would like to thank the DICT and Globe Telecom for affording us this avenue for our embattled in Marawi to maintain communication lines with their families and loved ones during this critical time as they defend the Republic against lawless elements," he said.

On the fourth week of the conflict, which began May 23, a total of 258 Maute Group terrorists have been killed, along with 65 troops and police officers, and 26 civilians.

AFP spokesperson, Brig. Gen. Restituto Padilia, earlier said that a total of 16 buildings, formerly occupied by the lawless elements, have been retaken in the past few days.

He however declined to comment on how many buildings need to be retaken to ensure the total elimination of the Maute elements in Marawi City.

"Enemy resistance continues to wane and the enemy-held areas continue to diminish as government security forces press their advance... Troops continue to get deeper into once enemy-held positions," Padilla said.

Fighting as of this posting was confined to four barangays.

Padila said the use of snipers, improvised explosive devices, and rocket-propelled grenades were slowing down the military's clearing operations. (Priam F. Nepomuceno/PNA)

Military wants public assistance in beating terror threats

The Armed Forces of the Philippines (AFP) is urging the public to report the presence of suspicious looking individuals and packages to authorities as part of efforts to curb terror threats in Metro Manila and other parts of the country.

The AFP public affairs office chief also assured the public that security forces are doing their job in going after local terrorists.

Earlier, AFP spokesman Brig. Gen. Restitute Padilla they have not so far receive any intelligence information that members of the Maute Group are planning to conduct bombings in Metro Manila.

He issued this statement following the circulation of a memorandum coming from the Valenzuela Police Station-Station Intelligence Branch of the alleged Maute plot to conduct bombings in Trinoma, SM Cubao, and Quezon City Circle, all in Quezon City and certain places in Quiapo, Manila and Makati.
