

The US Department of State has quietly released its annual report on human rights around the world, with the Philippines cited as a country where instances of extrajudicial killings have risen sharply. As a result, the US government is closely scrutinizing arms purchases for the police and the military by Manila, an official warned.

According to the report, Philippine police and vigilantes "killed more than 6,000" suspected drug dealers and users" from July to December last year.

It noted that extrajudicial killings "increased sharply" in the period, even as the government officially does not tolerate human rights violations or state-sponsored killings.

The Inquirer and other news organizations have reported a higher death toll of more than 8,000 since President Duterte took office last year.

The report noted that "killings allegedly undertaken by vigilantes, security forces, and insurgents as the principal

"And it also chronicles apparent governmental disregard for human rights and due process, and a very weak and overburdened criminal justice system," the official added.

The official noted that efforts to promote human rights were crucial to bilateral and defense ties, which were on the mend after President Duterte last year said he would scrap scheduled visits here by American troops as he looked to US rivals China and Russia for military assistance.

He has, however, stopped his verbal tirades against Washington after US President Donald Trump came into power.

The official said Tillerson would "review each arms transfer notification for the Philippine police and armed forces on a case-by-case basis."

"Because it's the right thing not to provide arms to units that are undermining—the value of human life," the official said

The 44-page report on the Philippines noted that while extrajudicial killings here were not new, they "increased sharply over the past year."

It quoted Philippine National Police figures from July to December last year showing that 2,155 suspects were killed in police operations, and 4,049 others by unknown vigilantes.

It said the killings have raised concerns about "police impunity" following promises by authorities that cops involved would not be prosecuted.

The report also raised questions on the "accuracy and legitimacy" of the supposed drug list that President Duterte always carries and shows the public during his speeches.

The report also noted that President Duterte's "public attacks on individuals and international bodies who have criticized his policies had a chilling effect on free speech and expression."

It cited the case of Sen Leila de Lima who herself has been jailed on drug-related charges after speaking out against the President

But presidential spokesperson Ernesto Abella denied the state supported vigilante killings, even as he stressed the government was engaged in trying to arrest an "emerging narcostate" by battling drug lords

"Vigilante or extrajudicial killings are unlawful and are therefore, not sanctioned," he said "The government condemns such practice. These are not to be confused with the government's war on illegal drugs, which is an urgent and critical domestic matter."

He said President Duterte has ordered law enforcement institutions to take "decisive legal steps" against cops embroiled in summary executions or with the drug trade. The government, he said, would "punish the scalawags in uniform."

The secretary of state traditionally unveils the report with public comments emphasizing the centrality of human rights in US foreign policy and highlighting specific findings.

The report's language on Russia for instance remained broadly similar to that of years past, noting the country's "authoritarian political system dominated by President Vladimir Putin"

Tillerson's Democratic predecessors John Kerry and Hillary Clinton gave public comments on the report in 2013 and 2009, their first years in the post, respectively, and continued to present it throughout their tenures.



PNP to employ new strategies under Tokhang 2

Saying he never denied giving orders on anti-drug operations, President Duterte on Friday maintained that e would take full responsibility for the killings attributed to the government's brutal drug war.

I te issued the statement after the New ork-based Human Rights Watch (HRW) cused him of being criminally liable the extrajudicial killings that have se hed over 7,000 since the administraa launched the war on drugs in June

"Human rights, pumunta ka nga dito, pinapasagot mo ako (Come here, Human Rights Watch, if you want me to respond)," Duterte said.

"Bakit nila sinasabing it's illegitimate? Bakit, masama bang sabihin papatay ako ng tao para sa bayan ko (Why are they saying it's illegitimate? Why, is it wrong to say that I will kill for my country)? Tell me, is there a crime? It's a warning actually

to stop (the drug traffickers)," he added.

The President reiterated that he ordered the police and the Armed Forces of the Philippines to take part in the campaign against illegal drugs.

"Lahat 'yung namatay sa engkwentro, sagot ko 'yun, ako ang magpakulong doon Klaro 'yan. Huwag mo akong bintangan na kung sino-sinong pinatay diyan na – akin 'yun (All those who died in encounters,

I am answerable for them. I may be jailed for them. That's clear. Do not accuse me of just killing people) You know. I answer for my deeds or misdeeds if you may," he said.

Duterte vowed to run after the drug syndicates that continue to destroy the country.

He also reiterated his support for the police and military officers who were charged for drug-related killings.

The HRW on Thursday released a report, titled "License to Kill," which detailed specific cases of extrajudicial killings allegedly perpetrated by police

The group accused Duterte of being accountable for the killings

He called on the human rights group and the church to go to the police and ask for a list of drug pushers and users and ask them to stop using drugs

Duterte said around 3,000 municipal mayors, 6,000 policemen and 40 percent of barangay captains in the country are involved in the illegal drug trade.

New Tokhang strategies

The Philippine National Police will employ new strategies when it revives the campaign against illegal drugs, PNP chief Director General Ronald dela Rosa said vesterday.

Last month, President Duterte announced the revival of the government's war on drugs following reports that drug rings have resumed operations after the PNP suspended Oplan Tokhang.

Dela Rosa said local police stations would be authorized to conduct anti-drug operations in coordination with barangay officials:

"Led by the police chief, members of the local police station will go to the barangays," he said in a radio interview.

According to Dela Rosa, the police commander and barangay chairman will visit the houses of suspected drug personalities to convince them to undergo rehabilitation.

Police officers should be in complete uniforms when implementing Tokhang.

Dela Rosa said the police chief would be held accountable if drug suspects were killed by police under questionable circumstances

He said police operating units from the PNP headquarters would no longer take part in the anti-drug campaign.

NCRPO to revisit drug surrenderees

National Capital Region Police Office (NCRPO) chief Director Oscar Albayalde said they would revisit identified barangays with drug surrenderees for assessment.

At least 260,000 drug suspects have surrendered to police since the government started the campaign against drugs, Albayalde said

Albayalde said the drug surrenderees would be evaluated before they undergo rehabilitation.

With the resumption of the anti-drug campaign, Albayalde said the NCRPO would focus on sending drug dependents to rehabilitation centers.

UN body condemns EJK

An international body tasked to implement United Nations drug conventions has cautioned governments against using extrajudicial means to address the illegal drugs problem

In a report released on Thursday, the International Narcotics Control Board (INCB) expressed concern over the drug-related killings allegedly committed by law enforcement personnel.

"In some instances, those acts have been committed with the expressed or tacit approval, or even encouragement, of political forces and, in many cases, have gone unpunished," the report read

While the board did not cite specific cases, the report appeared to be reterring to the bloody drug war of the Duterte administration.

More than 7,000 people have been killed in the anti-drug campaign, including 2,000 during police operations.

Police claimed that the drug suspects were killed because they fought back during legitimate operations.

Various groups, including the Commission on Human Rights, have questioned the "nanlaban" explanation of the police and pushed for a thorough investigation into drug-related deaths.

In its report, the INCB said that extrajudicial targeting of drug suspects was in violation of three international drug control conventions, Universal Declaration of Human Rights and the International Covenant on Civil and Political Rights

The INCB called on the

governments to put an end to extrajudicial killings and conduct investigation of those involved in drug-related deaths.

DepEd seeks drug-free schools

Meanwhile, the Department of Education has created a committee that will formulate a drug testing program for DepEd officials, employees and teachers.

Education Secretary Leonor Briones tapped undersecretary for legal and legislative affairs Alberto Muyot and assistant secretary Nepomuceno Malaluan to co-chair the committee, which is tasked to ensure a drug-free workplace in all DepEd offices and public schools nationwide

Briones directed members of the committee to formulate a drug testing program in accordance with the provisions of Republic Act 9165, the Comprehensive Dangerous Drugs Act.

The panel will oversee the implementation of an anti-drug abuse policy in the department, as well as initiate training and awareness programs for DepEd officials and employees.

The committee was also tasked to adopt value formation, family enhancement and other related programs

"The DepEd is committed to strengthen its programs against illegal drugs by complementing its existing National Drug Education Program with a comprehensive policy against drug abuse in the workplace," Briones said.

Last week, the department announced its plan to conduct random drug testing for high school students

ABUDEATH TOLL INCREASES TO 12

ECURITY forces killed 10 Abu Sayyaf members, including two relatives of its leader Radullan Sahiron, and injured an undetermined number of other rebels, during close quarter clashes in Patikul, Sulu, the military reported Saturday.

Col. Cirilito Sobejana, commander of Joint Task Force Sulu, said the slain ASG members, including Sahiron's two close relatives, were pinned down by heavy

gunfire during a two-hour encounter at the outskirts of Barangay Igasan in Patikul town 9 a.m. Friday

Sobejana said the clash actually started at dawn Friday as ground

troops pressed their pursuit of more than a hundred bandits behind the beheading of 70-year-old German hostage Jurgen Kantner in the jungles of Igasan village.

The killing of 10 bandits brings to 12 the number of slain terrorist after three days of sustained military operations against the notorious group while government casualties were placed at 18 wounded of which the military official said were non-life threatening.

"Joint Task Force Sulu troopers are relentlessly pursuing the withdrawing ASG members. Troops are supported with strike helicopters,

artilleries and armor assets," Sobejana stressed.

He added that all killed ASG were confirmed and that their names were in his possession.

Military units in Basilan, Sulu and Tawi-Tawi are conducting intensified operations against the bandits in the wake of the beheading of German Juergen Kantner last Feb. 26. Around 31 hostages are believed to be still in the clutches of the terrorist group.

Three days after Kantner was beheaded last Sunday, military forces killed two bandits while three others were wounded. *Turn to A2*



Sobejana said ASG leader Radullan Sahiron and sub-leaders Hatib Hajan Sawadjaan and Almuher Yadah were in the group of 120 bandits during the fight with elite army scout rangers and troops from the Army's 32nd Infantry Battalion under the 1st Infantry Division.

There were no reports whether Sahiron and his two sub-commanders were also hit during the confrontation, he added.

Sobejana said troops are conducting mapping operations at the battle site possibly to recover the bodies of the slain Abus even as they try to pursue bandits who scampered in different directions after the fight.

Ground troops positions surrounding the encounter site has mobilized interdiction units to trapped the fleeing bandits while attack helicopters conducted air strikes to trapped the terrorists.

Sobejana said artillery fires were also directed at the bandits backed by armored tanks intended to fortify the ranks of ground troops directly engaged in the battle with the rebels.

At least 14 battalions of soldiers are currently deployed in various parts of Sulu, Basilan and Tawi-Tawi hunting down the forces of evil.

Meanwhile, Muslim lawmakers have said the fight against ASG must be intensified even as they condemned the beheading of Kantner.

Anak Mindanao party-list Rep. Sitti Djalia Turabin-Hataman, the chair-person of the House committee on Muslim affairs, said even Isnilon Hapilon fled Basilan and migrated to Lanao del Sur because of the heightened coordination and support extended by the locals and their leaders to the military.

Hataman said their people will continue to work together to address the culture of fear and impunity in which the ASG thrives by providing law enforcement agencies with the necessary information to stop the acts of terror.

She said the acts of terrorism perpetrated by the ASG must stop.


House Deputy Speaker Bai Sandra Sema, Tawi-Tawi Rep. Ruby Sahali, Sulu Rep. Munir Arbison, Lanao del Sur Reps. Mauyag Papandayan and Ansaruddin Adiong echoed Turabin-Hataman's condemnation of the ASG's cruel act.

They stressed that ASG should cease from claiming they are Muslims because their barbaric acts are anti-Islam.

"These acts of terrorism are not in accordance with Islamic religion or way of life to which we, as representatives of our people here in the Philippines belong," Sema said.

members managed to retrieve their casualties," Sobeiana said.

He said some of those killed have already been identified as well six of the wounded bandits

The fierce fighting initially erupted about 9 a.m. when troops from the 32nd Infantry Battalion encountered the Abu Sayyaf at Barangay Taglibi.

The firefight lasted for over an hour with government troops utilizing crewserved weapons, supported by airstrike and ground artillery

The heavy fighting left an undetermined number of Abu Sayyaf casualties and at least 14 soldiers wounded, mostly from barrages of grenade launchers from the militants.

Capt. Jo-Ann Pentinglay, spokesperson for Western Mindanao Command (Westmincom), said MG520 helicopters staged airstrikes to

prevent the militants from retrieving their casualties.

14 wounded soldiers at Teodulfo Heneral Bautista Hospital in Busbus, Jolo and awarded them medals.

"The soldiers are more motivated now to fight the Abus and they will soon be back on field for combat in just a few days," Westmincom commander Major Gen. Carlito Galvez said

The military said fighting continued at Barangay Kanagi in Patikul as blocking forces engaged the fleeing militants



Army Colonel Cirilito Sobejana, the commander of the Armed Forces of the Philippines (AFP) Joint Task Force (JTF) Sulu, said 18 soldiers were also wounded in the encounter. The injured troopers were taken to the Army Hospital for treatment.

Sobejana said JTF Sulu as conducting rescue operations in efforts to free 31 kidnap victims when it met about 120 fully armed ASG members under Sahiron at Brgy. Igasan, Patikul, Sulu, that resulted in a two-hour firefight. Repelled by government air assets and artillery power, the bandits withdrew to different directions bringing along their dead members, according to field reports.

Of the 31 hostages being held by the ASG, 12 are Vietnamese nationals, a Dutch national, seven Indonesians, six Filipinos, and five Malaysians.

"The said encounter resulted in the death of at least 10 ASG members including two close relatives of Radullan Sahiron and the wounding of several others," Sobejana said. The Joint Task Force Sulu troopers are relentlessly pursuing the ASG bandits to end their reign of terror and free the hostages.

"This fight against terrorism will be successful as long as every sector of society will help and do their share of the work. We call on the people of Sulu to continually work with the government troops for peace and prosperity in the entire province," said Major General Carlito G. Galvez Jr., the commander of the Western Mindanao Command.

"If we win this and defeat the Abu Sayyaf, this will definitely benefit every child, man, and woman of Mindanao," he added.

AFP troops recover war materials,

bombs in gunbattle site in Surigao

BUTUAN CFIY - Troops of the Armed Forces of the Philippines (AFP) yesterday found war materials, including bombs, in the site of a recent gun battle with the New People's Army (NPA) Barangay Tinago, Surigao del Norte, a report reaching this city said

An initial report reaching the advance command post (ACP) of the Army's Northeastern and Northern Mindanao 4th Infantry (Diamond) Division (4th ID) based here said combat troops of the 30th Infantry Battallion (30th IB) were still scouring the encounter site in Tinago area.

Report coming from 30th IB commander Lt. Col. Rico Amaro said his men found in the encounter site four improvised explosives (IEDs), including anti-tank and anti-personnel mines, an M16 Armalite rifle with magazine fully loaded with live ammunitions, AK-47 magazines with live bullets, four rifle grenades, hundreds of meters of electrical wires used in bomb-making, an M14 bipod, dry cell batteries, two UHF radios and other assorted live ammunitions.

Elements of the 30th IB also found an NPA flag, several back packs, other personal belongings and assorted medicines.

As of press time, 30th IB troops area were still scouring the encounter site while pursuit operation was still ongoing on the NPAs.

The initial report of the 30th IB did not indicate if there was any casualty

on the side of the NPA or the government in the encounter that happened Friday

Only last Monday, another encounter broke out in the same Tinago area between the 30th IB troops and guerilla-





THE commander of the Presidential Security Group is set to be seeing action again in war-torn Mindanao as he is strongly being groomed to lead the Army's 1st Infantry Division based in the Zamboanga region, military sources said Saturday.

and Sulu, the main lairs of the terrorist Abu Sayyaf Group.

While commander of the brigade, Bautista was also concurrent commander of the Joint Task Group Basilan which is under the Joint Task Force "Zambasulta" (Zamboanga, Basilan, Sulu, and Tawi-Tawi). The same task groups also exist in the other mentioned provinces where handful of terrorist groups operate.

Just like other senior military officers during the Aquino administration, Bautista's rise in the hierarchy was stalled by "militics" (military politics) because of his links to one of the many coup attempts during the administration of the late former President Corazon Aquino, mother of former President Benigno Aquino III.

But Bautista's career recovered quickly after the last Aquino administration and was rewarded with meritorious promotion when Duterte restored the military's Board of Generals (BOG) which vets and recommends promotions to the general staff.

Bautista is set to be replaced in the PSG by Duterte's senior military adviser Col. Lope Dagoy (PMA "Hinirang" Class '87), who also spent most of his military career in Mindanao, particularly the Eastern Mindanao Command (Eastmincom) based in Davao City.

Troopers take over 2 NPA camps in Kalinga

AFP reaches out to Cagayan guerrillas

AOAG CITY, Ilocos Norte/STO NIÑO, Cagayan — The Philippine Army (PA) has discovered and taken over two abandoned camps of the New People's Army (NPA) in the hinterlands of Balbalan, Kalinga and pushed efforts to secure peace in Cagayan province by reaching out to hostile guerrillas

Lieutenant Colonel Gulliver Senires, the commander of the army's 50th Infantry Battalion (50th IB), said his operating troops found the first NPA camp in the outskirts of Barangay Ababa-an, Balbalan town, Kalinga last February 14; while the other camp was discovered last February 23 in Sitio Guin-ang, Barangay Dao-angan of the same town

Señires said the NPA rebels had just left the first camp when the operating troops arrived in the area while the second camp is where the military intelligence believes the rebels celebrated their anniversary last December.

He said the NPA rebels abandoned these camps even before the arrival of military troops, following complaints of growing discontent among residents from whom the guerrillas have been collecting food stuffs.

He said that combat operations against the NPA rebels in Kalinga are continuing to ensure the safety and security of the residents in the province.

Meanwhile, the local government

of Sto Niño in Cagayan and the army's 17th IB expressed optimism the insurgency problem will soon find a peaceful solution in the province despite recent skirmishes between guerrillas and soldiers.


At present, guerrillas are still hiding in the forested areas of Sto. Niño so Mayor Vine Pagurayan has called on them to surrender with the promise of helping them start a new and normal life among society.

Pagurayan made the call to the rebels as he solicited the cooperation of the 17th IB through Lieutenant Colonel Rembert R. Baylosis and the Regional Public Safety Battalion (RPSB) in Region 2, through its commander Senior Superintendent Antonio P. Marallag Jr. in the recent "Pulong-Pulong."

Duterte's wishes for talks revival: Release of captives, end to rebel taxation

President Duterte listed what his peace adviser described as the President's "wishes" before the government resumed peace talks and reinstated a truce with communist rebels—for the rebels to release their captives and stop collecting revolutionary taxes.

Jesus Dureza, Mr. Duterte's top peace adviser, said they were not conditions but the President's wishes.

In a speech in Cagayan de Oro City on Friday, Mr. Duterte said the two initiatives that he wanted the rebels to take—releasing captives and stopping tax collection—would be taken as signs of sincerity on their part.

"I'm ready to resume the ceasefire again," said Mr. Duterté. "But this time, I want it to be sincere," he said.

"Back then, there was a ceasefire but my soldiers were killed," the President said

He was referring to the killing by rebels of three soldiers in Malaybalay City, Bukidnon, at the height of a truce between the military and the New People's Army (NPA) which Mr. Duterte cited in his decision to end the ceasefire with the NPA.

"That's so difficult. But I'm

ready for different kinds of talks," he said

Asked about his plans for peace, Mr. Duterte said something is being done which he could not discuss yet.

The President, however, said unless rebels released all soldiers and civilians they are holding captive and stopped forcing businesses to pay revolutionary tax, "we'll never meet each other halfway."

"It just embarrasses the government. They give us their word but it doesn't bear any fruit. That's very difficult," he added

Dureza was quick to clarify Mr. Duterte's statements. "The peace negotiations should have no conditionalities," said Dureza over government-owned radio station Radyo ng Bayan

"There should be no preconditions on the negotiating table," he said.

Several factors would determine if peace talks could resume, added Dureza. He did not elaborate.

In his Cagayan de Oro speech, the President waxed poetic when he talked about the peace talks. Rebels, he said, must remove hate from their hearts to bring peace to the land.

The NPA killing of three soldiers in Malaybalay, he said, was proof of hatred in the hearts of rebels. INQ

Duterte to Reds: Let's talk peace again

Saying Filipinos killing fellow Filipinos is causing him much pain, President Duterte is reopening the doors to peace with communist rebels barely a month after he ordered peace negotiations suspended.

But before negotiations can resume, the rebel group should release its police and military hostages, stop collecting so-called revolutionary taxes, and refrain from asking favors, Duterte said on Friday.

"They have to release all policemen, army, everyone from the government. They should release them all. Second, they should stop asking for revolutionary tax," he said at Camp Edilberto Evangelista in Cagayan de Oro.

"Third, they should stop

asking for things. They're burning a lot of things now and we'll never meet each other halfway if that's the case." he said.

Duterte made his intentions known at the camp where he paid his respects to two soldiers killed in skirmishes with

New People's Army guerrillas late last month in Misamis, Oriental. The NPA is the armed wing of the Communist Party of the Philippines-National Democratic Front.

"I'm open to talk to the rebels, just not the killers. I'm ready to talk and I'm ready to stop this war. I would

prefer for us to not have war, but we need to talk from the heart." he said.

"I get hurt, I get really hurt if someone from the other side dies. Those are Filipinos," Duterte said. He maintained that as president, he yearns for peace for the whole country.

"Me, I'm in the government and I have a job to do. Please understand that. It pains me to see Filipinos fighting against fellow Filipinos. I just want peace," the President said.

"I'm ready as long as we communicate well. I'm ready to resume the ceasefire again, but this time I want it to be sincere. Back then, there was a ceasefire but my soldiers were killed. That's so difficult," he pointed out.

"For me, no one will win.

If we Filipinos fight against fellow Filipinos, nobody wins. The nation, the Philippines loses," he added.

"But I'm ready for different kinds of talks. I'm ready to resume the ceasefire again as long as it is working towards peace. I do not want war. It's a waste of money. Instead of bullets I can buy machines and give it to help others," he added.

The President said he felt frustrated by the rebels' seeming disregard for the peace process with their incessant attacks on government forces.

"Ceasefire here and there, and my soldiers are getting killed – one shot 73 times, 73 wounds. That's what really made me feel bad," he said. "How can you do that to a Filipino?"

Dureza: President has no conditions in resuming peace talks with Reds

President Duterte is not setting conditions for the resumption of the peace talks with the local communists, Presidential Peace Adviser Jesus Dureza said yesterday.

Duterte clarified this in his speech in Cagayan de Oro, saying the President has expressed his desire to

have a genuine ceasefire with the New People's Army (NPA), have all captives freed, and for the rebels to stop their extortion activities before he reconsiders resuming the peace talks.

But Dureza explained that these are just Duterte's wishes and it does not mean that he was setting preconditions for the resumption of the peace talks.

"Hindi iyan condition dahil 'yung peace negotiations wala dapat conditionalities, eh. Walang preconditions sa negotiating table, 'di ba (Those are not conditions because peace negotiations should not have conditionalities)," he said over Radyo ng Bayan.

"Otherwise, lumalabas na parang dominante 'yung isa, o 'yung kabila, nagre-respond lamang dahil may mga condition (it would just mean that one is dominant over the other and the other is just responding because there are conditions)," he added.

However, Dureza said that their next steps would always come from the President

"I heard the President say those words in Cagayan de Oro kaya tignan natin (so let's see) what would be the specific instructions to us," he said.

"Alam ng Pangulo na madaming challenges, kaya maraming (The President knows that there are many challenges so there are a lot of) factors din that will have to be considered," he added.

Dureza also reiterated that the road to lasting peace is not a paved one.

"Hindi madali itong peace talks. Akala kasi ng lahat napakadali. Hindi, ah Mahirap (The peace talk is not easy Everybody thinks that it is simple but it's not. It's a difficult one)," he said

Duterte decided to cancel the peace talks with the communist rebels over the brutal killing of three soldiers by alleged members of the NPA.

The President also said that he will not resume the peace talks unless there are compelling reasons that would affect the interest of the Filipino people.

Dureza said the President's wishes could well provide the so-called compelling reasons that would trigger the resumption of the peace negotiations.

The Palace had earlier revealed four "compelling reasons" which may result in the resumption of peace talks. These include the cessation of the so-called "revolutionary tax," ambushes on military personnel, burning of property, and provocative and hostile actions.

Last Friday, Duterte said the peace talks will not resume while the hearts of the rebels are "full of hate" since their actions, which include the killings, indicate hatred.

they should stop asking for revolutionary tax. They should stop asking for things. They're burning a lot of things now and we'll never meet each other halfway if that's the case. It just embarrasses the government They give us their word but it doesn't bear any fruit. That's very difficult," Duterte said.

"I just want peace. I'm ready as long as we communicate well. I'm ready to resume the ceasefire again, but this time I want it to be sincere Back then, there was a ceasefire but my soldiers were killed. That's so difficult. But I'm ready for different kinds of talks. I'm ready to resume the ceasefire again as long as it is working towards peace. I do not want war. It's a waste of money Instead of bullets I can buy ma-

chines and give it to help others," he added

Last month, the President withdrew a unilateral ceasefire declaration and scrapped peace talks with communist rebels, dismayed by rebel attacks and demands such as freedom for all detained rebels

After terminating the peace talks, Duterte called the communists terrorists and ordered the arrest of National Democratic Front (NDF) consultants temporarily freed for the peace talks in Oslo, Norway and Rome, Italy,

Duterte wanted a bilateral ceasefire agreement that would put in place common rules of engagement for the military and the NPA

But the NDF demanded the release of around 400 detained rebels before agreeing to sign such a deal. In response, Duterte said he @gmail. would release some rebel prisoners only after the signing of a bilateral ceasefire deal

Shot 73 times

In a separate media interview on Friday night in Cagayan de Oro City, Duterte brought up anew the communist rebels' killing of several soldiers earlier this year amid a ceasefire.

He advised the rebel group to shun hate before going back to the negotiating table.

"You have a ceasefire yet my soldiers were killed. I have a soldier who was shot by an NPA rebel 73 times. I was really displeased with that How can you do that to a Filipino? You know, that indicates hatred," Duterte said.

"If you act that way, you're full of hate, then we cannot talk about peace. There is anger in your heart, there is hate. How will it be possible for us to talk if you have hate in your heart?" he added.

'No conditions'

Presidential Peace Adviser Jesus Du-

reza clanfied on Saturday that Duterre was not setting preconditions for the resumption of the peace talks with the communist rebels

"He's not citing any conditionality. These are what the President wishes," Dureza told governmentrun radio station dzRB.

*Please make it very clear that those are not conditions because there should be no conditionality in peace negotiations. There should be no preconditions in the negotiating table." he added

Dureza said the President's wish "could provide the so-called compelling reason" for the peace talks to resume.

"We had always said that when compelling reasons exist, then we would reconsider. So let's wait for the situation of a compelling reason. The President knows there are many 85, 5295 challenges, the peace talks are not easy," he said.

President ready to revive talks with 'Reds'

PRESIDENT Rodrigo Duterte on Friday night laid out several conditions for the resumption of peace talks with communist rebels.

Speaking to reporters in Cagayan de Oro City where he visited the wake for soldiers slain by the communist New People's Army (NPA), the President said he was willing to talk anew with the rebels if they showed sincerity

"I'm ready to talk and I'm ready to stop this war. I would prefer for us to not have war, but we need to talk from the heart. I get really hurt if someone from the other side dies. Those are Filipinos." Duterte said in Visayan language

The President stressed that the communists should agree to a bilateral ceasefire, stop the collection of the socalled revolutionary tax, and release all captured government men.

"They have to release all policemen, army, everyone from the government They should release them all. Second.

TOP PH OFFICIALS TOUR US CARRIER IN DISPUTED SEA

The Philippine defense chief and two other Cabinet members on Saturday toured a US aircraft carrier patrolling the disputed South China Sea on the invitation of the US Navy, embassy officials said.

Defense Secretary Delfin Lorenzana, Finance Secretary Carlos Dominguez and Justice Secretary Vitaliano Aguirre II visited the USS Carl Vinson along with three Philippine security officials, US Embassy spokesper-OFFIc Son Molly Koscina said

Army Core Purpose: Serving the peor

The visit shows continuing top-level engagements between Philippine officials and the US military despite President Duterte's threat to scale back engagements with American forces while reaching out to China and Russia.

There was no immediate reaction from China, which had opposed US patrols in waters it has claimed virtually in its entirety.

The US ambassador, to Manila, Sung Kim, accompanied the officials to the USS Carl Vinson, where they watched F-18 pcal: 5285, 5295 fighter jets land and take off on catapult on the flight deck and met US Navy commanders in charge of the 95,000-ton carrier

as it sailed in the disputed waters, Koscina said.

Freedom of navigation

US Navy officials told a small group of journalists who were flown to the Carl Vinson on Friday that the US warship deployment was aimed at ensuring freedom of navigation and overflight in the South China Sea, a key waterway for global commerce and security.

"We will be here," Rear Adm James Kilby told the journalists, including those from The Associated Press. "We're going to continue to demonstrate that international waters are waters where everyone can sail, where everyone can conduct commerce and merchant traffic."

Kilby's comments and the presence of the carrier in the South China Sea are aimed at reassuring American allies, who have expressed concerns over China's aggressive actions to assert its claims to virtually all of the South China Sea. The nuclear-powered Carl Vinson, which is manned by about 5,500 military personnel, is part of a strike group comprising 12 warships

and nine aircraft squadrons

In recent years, China has turned seven mostly submerged disputed reefs into islands where Beijing is now reportedly installing a missile defense system. Chinese officials have stressed that they have a right to carry out those constructions in what they say are their territories and insist hey have no hostile intentions in the region.

But worries over China's actions have grown. Governments fear its actions could later restrict movement in a key waterway for world commerce with rich fishing grounds and potential undersea deposits of oil and gas.

"There is a lot of worry about what China's intentions are," said Ernest Bower, a senior adviser for the Southeast Asia program of Washington-based think tank Center for Strategic and International Studies.

"I think the question everyone has is, '(are) the Chinese trying to shut down access to the South China Sea?" Boyer told reporters in Manila. "The Americans are saying under no circumstances would that be acceptable to the international community."—AP

Cabinet men tour US warship in disputed sea

ABOARD USS CARL VIN-SON – Three Philippine officials headed by Defense Secretary Delfin Lorenzana witnessed first hand the operations of an aircraft carrier strike group at sea. US Ambassador Sung Kim accompanied Lorenzana along with Justice Secretary Vitaliano Aguirre II and Finance Secretary Carlos Dominguez III aboard this ship, alighting from a US Navy transport plane that fetched them from Villamor Air

Base in Pasay City.

They were welcomed aboard by Strike Group 1 commander Rear Admiral James Kilby and his staff.

Briefing his visitors, Kilby described the presence of Strike Group 1 as a routine exercise

in line with the continuing US Navy training as well as to ensure freedom of navigation in international waters.

When asked if they have encountered some challenges from the Chinese naval forces

n the area, Kilby only said the US Navy s just doing its job in accordance with nternational laws.

Lorenzana defended the presence of USS Vinson in the South China Sea

He said even before the China asserted its presence in the area, particularly in Panatag Shoal, this has been the training area of joint US-Philippine naval and aerial exercises.

He also described his tour of the carrier "as a very good experience" in witnessing how F18 fighters take off and land on a limited space on the flight deck.

Lorenzana also mused that fighter aircraft on *Vinson* are far more too many as compared to whole plane inventory of the Philippine Air Force.

Aguirre, for his part, said the presence of the aircraft carrier in the region was a power projection.

Kim, on the other hand, said bringing Filipino officials aboard the aircraft carrier will afford them opportunity to see for themselves carrier operations that he himself described as "truly amazing"

himself described as "truly amazing"

He also said the US presence in the South China Sea is consistent with inter-

national law, adding that everyone in the region understands.

He stressed relations between the Philappines and the US remain strong

'US embassy spokesperson Molly Koscina said it is a tradition on the part of the US government to invite Filipino dignitaries to board any of their visiting ships.

She added AFP chief Gen. Eduardo Afio and other top military leaders were also invited but they failed to attend due to some other commitments.

Lingering near Scarborough

Sailing at a leisurely speed of eight knots, *Vinson's* latest position yesterday was 120 nautical miles north of Panatag (Scarborough) Shoal.

Amid the buffeting wind, activities on the flight deck were also busy with F18 fighters as well as surveillance planes taking off and landing alternately.

Aside from several squadrons of F18 fighter jets patrolling the skies, a US Navy helicopter was hovering at a distance

"We are 120 nautical miles north of Scarborough shoal and also 120 nautical miles from mainland Philippines," Kilby announced to his Filipino guests.
