

# Total mining ban mulled

Concerned about the impact of open pit mining in the country, President Duterte last night asserted he would not be cowed by some mining groups that, he bared, have partnered with the opposition and drug dealers in a campaign to oust him.

"Kayong mga mining (You mining firms), I know you are funding the opposite side. Alam ko na ngayon kung sinong gumagastos sa kanila (I know now who is financing them) I know that some of you are giving funding to the other side to destabilize me," Duterte said in a media briefing at Malacañang.

"If the police and military will allow it, it's their problem," the President added

Duterte said he would not bow to the mining firms' Turn to Page 15

pressure, adding he is ready to forgo the P70 billion in revenues from this sector

"Ngayon, kung mag-lobby-lobby lang kayo ng mining diyan o maggastos kayo Gusto ninyo akong palitan na Presidente na paluhurin ninyo to do your bidding (Now, if you're just lobbying on mining firms or provide funding You want to replace me as President who would kneel to do your bidding )," he said before citing names of mining firms that destroyed the country's resources during their operations

The Chief Executive talked about desiabilization moves in the briefing where he and his party mates in PDP-Laban also issued party stands on major issues ranging from federalism, corruption and the death penalty to social justice and economic devel-

opment
Senate President Aquilino Pimentel III and Speaker
Pantaleon Alvarez sat with
the President to answer queries from reporters for about
two hours Justice Secretary
Vitaliano Aguirre II and Interior Secretary Ismael Sueno
and other officials were also
present.

Duterte presented documentation and photos of the adverse impact of mining activities all over the country, as he reiterated support for Environment Secretary Gina Lopez, who failed to get

the nod of the Commission on Appointments (CA) last week

Duterte commended Philex Mining for being a responsible firm, citing tree-planting activities it has spearheaded in areas where it operates.

Seeking explanation

Duterte then challenged the mining sector for a confrontation over the destruction on the environment by irresponsible firms, citing the Berong Nickel Corp in Narra, Palawan, Citinickel Mines and Development Corp, Oceanagold. Emit Minerals Corp and Adnama Mining

"This is Berong Nickel Corp in Narra, Palawan Look at the greens. You think you can live with it? Because of the P70 billion? Or because nag-contribute sa campaign funds mo (it contributed to your campaign funds)? Hindi sa akin. Maski na mag-contribute ka, ganon din Uupakan kita (Not to me Even if you contribute, it's the same. I'll hit you)," he said, as he showed photos of the firm's site.

"Explain to me how is this Sabihin mo sa akin dito, magharapan tayo (Tell it to me here, facing each other). What have you done to my country?"

"Economy? Well, siguro, mawawalan tayo (ng) trabaho sa mga tao. Maghintay kayo (maybe, we'll lose jobs for people. You wait). We will scrape the

bottom of the barrel to look for the money, but I'm going to give you food kung 'yan lang," he added.

Duterte expressed hope that the P70-billion revenues that could be lost from mining can be covered by new invest-

"And let us just pray that enough business will come in, new ones, but not as not as devastating as this one Kasayang (What a waste)," he said

As he expressed his disappointment over the destruction of the environment, the President sought an explanation from the mining firms over their operations.

Duterte also shor down reports that he might be implicated in the destruction of the environment when these activities happened during the past administrations.

"Tapos, i-charge mo sa akin ito su aking panahon? Au, anak ng Sino mananagot nito? Eh'di ako, pati ito, pati ito Kayo 'yung nasa power, kayo 'yung pretentious diyan (Then, you will charge it to me during my term? Son of a. Who is responsible for this? It is I, for this one You are the ones in power, you are the pretentious ones), that we will work for the benefit of the people. God d\*\*\* this people, you are always forgotten," he said

### Defending Lopez

A lawyer and a longtime politician, Duterte said he shares Lopez's serious concern for the environment.

"Now, is Gina a liar? No, I don't. Mahirap 'to. Tingnan mong ginawa, o, green, tapos, dito (This is hard Look what was done, green, and then, here) So where are the trees that God gave us? Where is the environment that God gave us?" he said

"It's visual eh How can you argue with Gina when she's presenting, confronting you with a visual thing? So, kami rito (we here), it appalls us," he said.

In the same briefing, Duterte said he is amenable to the re-imposition of the mining ban

"Maybe, it would be worth the while of Gina to re-impose the ban Total (mining ban) muna tayo, tapes mag-vsap Dito mag-prangka-prangkahan tayo (Let's have a total mining ban first, then let's talk, let's be frank with one another)," he said

Duterte urged mining firms to follow Australian or Canadian mining practices, which help preserve the environment. He also ordered Fhilippine. National Police (PNP) Director General Ronald dela Rosa to impose strict guidelines when it comes to giving permits for procurement of explosives such as TNT, which are mostly used in illegal mining activities.

In other developments, President Duterte said he would do "what is necessary" to protect his country's environment when asked about his plan to impose a total mining ban.

"When it comes to the pres-

ervation of my country, the land. I will do what is necessary," Duterte said in the same briefing.

The firebrand leader earlier said it may be "worthwhile" for Lopez to implement a ban on mining, given the environmental damage that producers have caused.

It was not immediately clear whether Duterte was calling for a total ban on mining or a strengthening of Lopez's order closing more than half of the mines in the Philippines

Graft charges vs Lopez

A nine-page complaint was filed yesterday before the Office of the Ombudsman by the Chamber of Mines, represented by its chairman Artemio Disini and spokesman Ronald Rex Recidoro

The group charged Lopez with violation of Section 3 (e) of Republic Act 3019 or the Anti-Graft and Corrupt Practices Act and Sections 4 (b) and 5 (a) of RA 6713 or the Code of Conduct and Ethical Standards for Public Officials and Employees

The complainant said Lopez caused "undue injuries" to the mining industry when it ordered the closure of 23 mining firms and suspension of five other firms based on an unsubstantiated mining audit.

The group lamented that as early as September last year, Lopez had already announced

the suspension of about 20 mining firms even before the results of the DENR mining audit was completed.

Lopez may also face graft charges after intervening with the Department of Energy (DOE) to award a service contract to a private company for a \$100-million power plant in Zamboanga City

Vienna Tañada; business development officer of Eco Global Inc., will file on Wednesday before the Office of the Ombudsman cases for violation of the Anti-Office and Corrupt Practices Act

"Lopez could be found guilty for having sought to influence the DOE to award the contract to Eco Global and for traveling to France with all expenses paid by the company to visit one of its partners in Paris," Lester Fascua, Tahada's spokesman said.

Pascua added that Eco Clobal paid for a trip to France for Lopez and her five-person party last Oct 2, a day before the DOE awarded it the renewable energy service contract (RESC)

Last Sept 29, Eco Giobal chief executive officer Jean-Philippe Henry, a Frenchman, issued a letter of guarantee to the French embassy in Manula pledging to pay Lopez's team's "airfare, hotel accommodations, insurance coverage and travel allowances, for the entire duration of their business trip"

# 2 NPA ATTACKS MAR PEACE PROCESS

Communist rebels torch a bus in North Cotabato and wound five policemen in an ambush in Abra, a day after the resumption of peace talks was announced

A day after government and communist rebel negotiators announced the resumption of peace talks, New People's Army (NPA) guerrillas burned a bus in Mindanao and wounded five policemen in an ambush in northern Luzon.

Suspected NPA members torched on Monday a Davao City-bound Yellow Bus in Makilala, North Cotabato province, police said.

Another NPA group wounded five policemen in an ambush on the convoy of Senior Supt.

Alexander Tagum, Abra police director, while they were on their way to visit a police station that was attacked on Sunday night in the province's Malibcong town

Tagum was not hurt He was accompanied by a platoon of police officers when they were ambushed at Sitio Aguibo in Barangay Poblacion

The attacks did not violate any ceasefire agreement between the government and the communist-led National Democratic Front of the Philippines (NDFP), as no cessation of hostilities had yet been declared.

### **Back-channel talks**

In a joint statement issued on Saturday in Utrecht, The Netherlands, government and NDFP representatives, who held back-channel negotiations, agreed that indefinite unilateral ceasefire declarations would be issued before the fourth round of talks in the first week of April

The two sides are scheduled to meet in Oslo, Norway, on April 2-7 to resume the next round of talks, which were scuttled last month.

### Makilala bus burning

The rebels lifted their unilateral ceasefire on Feb 10 after accusing the government of failing to release all political prisoners and the military of deploying troops in rebel-held areas

The Duterte administration responded by scrapping its own unilateral ceasefire and suspending the peace talks.

spokesperson of the police in Front 72 operating in Makilala Central Mindanao, said suspected NPA members flagged down the bus at Barangay San. Vicente in Makilala town at 8 30 a.m. on Monday

Victor Serondo, the bus driver; said six rebels boarded the bus, introduced themselves as NFA members and directed him to drive toward Sitio Bagong Silang in Barangay San Vicente.

"One of the suspects drew a pistol and told me to divert the vehicle to the secluded area toward San Vicente village," Serondo said.

"The suspects ordered us to vacate the bus and look for a safe place before they set it on fire," the driver said. He and the passengers were unharmed

Galgo said the attackers belonged to the NPA's Guerrilla and in Bansalan, Davac del Sur province.

The attack came five days after NPA rebels killed four policemen in an ambush in Bansalan

### Abra ambush

In Abra, PO2 Jessie Trinidad, PC1 Marlon dela Paz, PO1 Gerome Baldos, PO1 Kennon Sanggoy and PO1 Von Harold Layao were wounded when their vehicle hit an explosive device, followed by a burst of gunfire, according to Insp. Marcy Grace Marron, Abra police information officer. . At at a

The five policemen were brought to Abra Provincial Hospital in Bangued, the capital.

Marron said probers did not know if the attackers were the

same rebels who raided a house that was serving as the temporary police station in Malibcong. So was to be the

Five Malibcong policemen engaged 30 armed men in a 10minute gun battle at 730 p.m. on Sunday

The firefight stopped when town elders intervened, allowing the five policemen to retreat to the house of Mayor Romando Bacuyag. 1. 140

The Malibcong police station is under construction so the police there have been using Bacuyag's property as headquarters.

But the rebels managed to ransack the temporary police station, and fled with police issued weapons, Marron said.

They took off with seven rifles, three pistols and three cell phones. INQ

**MISTAKEN FOR REBELS?**

ILOILO CITY-The widows of two men killed in a clash between suspected communist rebels and government troops in Capiz province last month have filed criminal and administrative charges against Army soldiers in the Office of the Ombudsman

In a three-page complaint submitted to the Deputy Ombudsman for the Military and Other Law Enforcement Offices on March 6, Analyn Borres and Marjorie Dequiño insisted that their husbands were civilians and not members of the New People's Army (NPA).

They sought justice as they ows' allegations accused the troops under the ... He said Ian and Lorendo Army's 61st Infantry Battalion (61IB) of murder

Named respondents were soldiers belonging to the 61IB, including Lt Col. Leonardo Peña, commanding officer, Maj. Allan Mangaser, executive officer; and soldiers led by Sgt. Jefrrev Belarmino.

Reports from the military's and Infantry Division (aID) identified Lorendo Borres, 48, and his nephew Ian Borres, 24, as NPA rebels who were killed in an encounter on Feb 24 in Barangay Jebaca in Maayon town, Capiz

Lt Col Ericson Rosana, 3ID spokesperson, denied the wid-

Borres were part of a group of seven to 10 armed 1ehels that they engaged in a firefight Three shotguns and two grenades were recovered from them, military reports said.

Rosana said the slain men were part of a rebel militia under the command of NPA leader Romulo Gangoso, alias Ka Regan

But Dequiño said "Everyone in our village knows that my (common-law) husband and his uncle were not NPA members. We want justice "

Dequino, in a telephone interview, said her husband and the older Borres were carrying bolos, not guns

"[Lorendo] sought my husband's help because he said two men in plainclothes allegedly tried to take his cellular phone and threatened to shoot him They thought the two men were cattle rustlers," Dequiño said

She later heard a burst of gunfire but said she was afraid to look for Ian even after he failed to come home that night The following day, she heard radic reports saying soldiers had killed two suspected NPA rebels in an encounter in their town

Three other male relatives who were with Lorendo and. Ian during that incident were unhurt, INO

### DEFENSE CHIEF WANTS MORE MEN THAN WOMEN FOR COMBAT DUTY


BAGUIO CITY—Women soldiers are fine, but you can't have too many of them on the battlefield—unless you have a deal with the enemy that allows only same-sex combat

The question of more women soldiers taking combat duty has come up because most of the Top 10 graduates of the Philippine Military Academy (PMA) this year, including the class valedictorian, are women

There were only two men in the Top 10 of PMA Class of 2017 Of the 167 members of the class, 63 were women.

That, however, was "just an aberration," according to Defense Secretary Delfin Lorenzana.

He explained that this year's graduating class had many women because there were many female cadets turned back in previous years. At the same time, many male cadets were dismissed.

### 20-percent quota

The PMA imposes a 20percent quota for female cadets and this will remain, according to Lorenzana and Armed Forces of the Philippines Chief of Staff Gen Ed uardo Año.

The military needs more male soldiers for combat duty, Lorenzana said

"We need women in the military but we need more people for the field, for the combat units. We need platoon leaders and company commanders," he told reporters here on Sunday.

It is unlikely for women to "The problem is if they are dominate the military, he said.

"I think it would not probably happen that they would dominate, that there would be more women in the Armed Forces, because there are very practical considerations you have to consider when you bring women to combat." he said.

These include where women soldiers would sleep and how they would go to the toilet, Lorenzana said

"We don't want to subject our women to that We are protective of our women," he

Office duties currently handled by men could be given to the women so that the men could go to the field, he said.

Año said the PMA would maintain the quota for female cadets, and it would adjust the quota in succeeding years if there were too many women & MARS

"We need more males in the frontline units. So it would

be balanced. But, of course, we have gender advancement and development, so we would give them equal opportunity for the line positions, where women could also serve," he said

Año noted that there hadbeen female officers, including Col. Leah Lorenzo, who had served as line commanders on the field and had been given the Gold Cross, the military award for gallantry

President Duterte, speaking at the PMA graduation on Sunday, hailed Class of 2017 as "historic" for having an unprecedented number of women in the Top 10 and in the 

"Today, we make history. This is the first time female cadets occupied eight of the Top 10 spots in their graduating class. With the highest number of graduating women in PMA history, this breakthrough is a fitting tribute to our mothers, sisters and daughters as we celebrate Women's Month," Mr. Duterte

# Lorenzana on Chinese ships: What 'innocent passage?'

DEFENSE Secretary Delfin Lorenzana is disputing China's claim that its survey ships, spotted last year at Benham Rise – 2 vast undersea region east of Luzon – were there merely on "innocent passage"

"As far as we are concerned they have no business going there," he said.

Lorenzana also said government is "worried" about the Chinese activity at the Benham Rise.

"We will do something there, maybe we will increase our patrols at the same time, maybe we will also put something there, structure that says this is ours... They (Chinese) know that it (Benham Rise) was awarded to us by the United Nations," he said.

The United Nations in 2012 declared Benham Rise, a 13-million hectare undersea region east of Luzon rich in biodiversity and fish stocks, part of the Philippine continental shelf.

On Thursday last week, Lorenzana said the military monitored Chinese survey ships at the Benham Rise from July to December last year, conducting surveys apparently for the deployment of submarines

The following day, the Chinese foreign ministry said China's research ships were "purely carrying out normal freedom of navigation and right of innocent passage, and there were no so-called other activities or operations."

Lorenzana said, "If that's innocent passage, you know what innocent passage is, it's like going from Point A to Point B straight and your steaming speed is constant."

"What we saw. their ships were steaming at low speed and they stopped in one area, staved there for a few days and transferred to another place. So that is not unnocent passage," said Lorenzana.

Nevertheless, Lorenzana said it is good that China reacted to his disclosure. "They said they have no evil intention so we will leave it at that We will trust what they say."

Lorenzana said President Duterte has been informed about the Chinese ships. "He (Duterte) said let us increase our patrol and declare it (in public) so that the people will know that we have jurisdiction over those areas." — With Reuters

### DND wants to drop OCD, PVAO

President Duterte should create separate agencies out of the Office of Civil Defense and the Philippine Veterans Affairs Office (PVAO), which are currently under the Department of National Defense (DND), an official said over the weekend.

Defense Secretary Delfin Lorenzana said the DND is burdened with the responsibility of protecting the country's internal and external security to fully attend to other serious concerns such as disasters and the needs of veterans.

"We want the OCD and PVAO to be segregated from" the DND, he said, adding that the department has asked

President Duterte should Duterte to issue executive orders to create two separate the Office of Civil Defense agencies.

As the mother unit, the DND's annual budget is tied up with PVAO and OCD and these two agencies are getting a lion's share of the funds, Lorenzana said.

The DND's approved budget for 2017 is P135.04 billion, and Lorenzana said under the present setup most of the money goes to personnel salaries and allowances rather than defense capability upgrades.

In addition, the 1987 Constitution prohibits the government from allocating more funds to the military than for education, he said.

At gunpoint, the rebels pulled over the bus as it was traveling in Barangay San Vicente and ordered the passengers to leave

The gummen poured kerosene and set the bus on fire, according to Supt Romeo Galgo, Jr., spokesman for the Police Regional Office-12.

Authorities are eyeing extortion as the possible motive for the attack



Talks better be productive

The Armed Forces of the Philippines (AFP) said it will be constrained to fulfill its mandate of protecting all communities nationwide against armed threats if talks would not be productive and effective this time.

"For many years, the AFP has shown that it has been and will always be supportive of all peace. We are nopeful that the peace talks will be successful this time,' said AFP public affairs office chief Col Edgard Arevalo.

"Because if not, the AFP will be constrained and will not he state to take on the task of defending the communities," he added

Arevalo stressed the military has proved its capability when it succeeded in neutralizing 120 NPA insurgents and capturing more than 60 firearms starting February 4 when Mr. Duterte suspended peace negotiations in wake of the series of unprovoked rebel attacks which killed six soldiers and caused the abduction of three others early that month.

"This we hope the NPA should have realized by now. The 120 members of the NPA who were neutralized and more than 60 firearms divested from them could attest to that resolve of the AFP," he added.

And until the military receives official communication from the Office of the President ordering the suspension-of-military-offensives against the NPAs, combat operations against the insurgents will continue, he said. Mario J. Mallari, Ted Tuvera and PNA



MAKILALA, North Cotabato (PNA) – Just hours after the government and Communist rebels agreed to revive derailed peace talks, a group of suspected New People's Army (NPA) insurgents burned a passenger Monday on a highway in Barangay San Vicente here.

Authorities said that YBL unit bearing body no. 1888 was heading towards Davao City from Tacurong City when it was flagged down by six men, described to be between 18–20 years old.

The men quickly boarded the bus, pulled out handguns and declared they were NPA members before the 30 terrified passengers.

The bus driver, identified as Victor Serondo, said the group ordered him to maneuver some 50 meters away from the highway to Sitio Bagong Silang in the same village, where he and the passengers were ordered by the armed men to disembark.

The armed men quickly opened

gasoline-filled containers from their backpacks and set the bus on fire,

The suspects fled from the scene aboard five get-away motorcycles.

Responding authorities said the bus driver, conductor, two bus inspectors and all the bus passengers were not harmed during the incident.

Joint police and military roadblocks were immediately set up along the Makilala highway as pursuit operations were launched.

Local officials condemned the incident, especially since it happened just as the peace talks between the Philippine government and the National Democratic Front (NDF) had gone back on-track after backchannel talks in Utrecht, The Netherlands.

The two parties announced Sunday that they were going to resume the talks in Oslo, Norway early next month.

Makilala is one of the towns in North Cotabato where the NPA rebels are often sighted.

In a statement. Kapayapaan convener Fr Benjamin E. Alforque said: "We thank the government and the NDF for agreeing to continue the peace talks, to reinstitute their respective unilateral cease-fires, to work toward the completion of the substantive agenda on social and economic reforms, move toward the political and constitutional reforms and work out an agreement on a mutual bilateral cease-fire."

However, even as Alforque was optimistic on the progress of the peace negotiations, he opposed President Duterte's order to use all available offensive weapons against the New People's Army (NPA)

"Weare concerned, however, over President Duterte's recent order to police and

On a side issue, additionally, we wonder at the wisdom of Philippine

Military Academy classes adopting rank outsidets as honorary "mistahs" or classmates in a manner that could affect their performance in the service and when they move to the private sector

President Rodrigo Duterte himself had disclosed that he knew well Alexander Wong Chu King, the owner of Mighty Corp, because he is a fellow "mistah" of PMA Class 1967 of which they are both honorary members.

We note also that Lt. Gen. Edilberto Pardo Adan (PMA '72), who served as PMA superintendent (2002-2004) and deputy chief of staff (2004-2005), became Mighty Corp president in 2014. His last military assignment was as chief of the AFP Southern Command.

Lest we be misunderstood, we stress that the Academy and its impressive roster of alumni are not being denigrated or their integrity questioned. It is precisely to protect their name and that of the service that we here suggest a review of their "mistah" adoption practice.

The adoption of presidents and other high or promising officials, as well as powerful persons in civil society, enhances the political and business connections of class members without benefiting public interest. We dare not speculate on ulterior motives, if any.

The lassoing of influential or powerful figures as honorary "mistahs" could degenerate into a mere variation, or a refinement, of the discredited "padrino system" that has abetted corruption in government.

This is not to say that the disposition of the Mighty Corp. case will be influenced by its "mistah" entanglements – in the same way that we prefer not to prejudge the integrity and competence of government officials on the basis of their alma mater or fraternity ties.

Somebody should defend the "mistah" adoption practice and highlight its redeeming social benefits.

Before the Martial Law years, PMA alumni were not concerned with cornering honorary "mistah" figures to help them along, but the officers and gentlemen generally performed with integrity and loyalty.

TROs (temporary restraining orders)

Those are on the tax issues. The bribery and the economic sabotage cases are something else. The crowd keenly watching the President they had elected into office are praying that the Lord will not allow him to be led into temptation, amen.

Duterte recalled in his speech that when he was mayur, Wong Chu King approached him regarding his case, but that he brushed him off. The businessman left a bag, but when the mayor saw the money in it he said

he had it returned.

Phi rights over Benham Rise explained

WE ARE amazed that not many Filipinos, including those in government, are alarmed by revelations that the Chinese have expanded their trespassing from the West Philippine Sea to the country's Benham Rise continental shelf facing the Pacific Ocean

Benham Rise is a 13-million-hectare area extending some 250 kilometers eastward from the coast of Isabela and Aurora. In 2012, the United Nations Commission on the Limits of the Continental Shelf recognized Philippine exclusive ownership of that shelf. There are no other claimants

Under the UN Convention on the Law of the Sea, the Philippines as the coastal State owning Benham Rise

has these rights:

 The coastal State exercises sovereign rights for the purpose of exploring it and exploiting its natural resources

· The rights referred to above are exclusive in the sense that if the coastal State does not explore the continental shelf or exploit its natural resources, no one may undertake these activities without its express consent.

 The rights of the Philippines over the continental shelf do not depend on occupation, effective or notional,

or on any express proclamation.

• The natural resources referred to here consist of the mineral and other non-living resources of the seabed and subsoil together with living organisms belonging to sedentary species, that is to say, organisms which, at the harvestable stage, either are immobile on or under the seabed or are unable to move except in constant physical contact with the seabed or the subsoil



# Farmers accuse ex-AFP chief Visaya of rights violations, nix his appointment as NIA chief

MANILA, Philippines - Militant peasant group Kilusang Magbubukid ng Pilipinas (KMP) held a picket at the National Irrigation Administration office in Quezon City Monday morning to protest the appointment of former AFP chief Ricardo Visaya as NIA administrator.

"We have two important issues to raise before the NIA -- first is the free irrigation service or non-collection of irrigation service fees which President Duterte and the NIA had consistently promised. Second is our strong opposition to Visaya's appointment. His mere appointment at NIA is an insult to farmers and an undermining of our strong demand and nationwide campaign for free irrigation," said KMP chairperson Joseph Canlas.

"There is no way that we would allow Ricardo Visaya, a known violator of farmers' rights to take helm at NIA, which is mandated to provide irrigation services to farmers," the KMP leader added.

Visaya is allegedly accountable for numerous killings of peasant leaders and activists in Central Luzon from 2005 to 2007 as well as the intense military operations of Lumad communities in Mindanao from 2014 to 2016, according to Canlas.

"What would Visaya do at NIA? Would he order the harassment and killing of farmers demanding free irrigation? He has no business running a civilian agency. His appointment has no merit and just grounds. Farmers nationwide will reject Visaya as NIA chief," said Canlas.

KMP said Visaya had been blamed for the deaths of at least eight farmer-leaders in the region, namely, Jhon Facunia Gado of Guimba, Nueva Ecija, Perla Torno Rodriguez of Mexico, Pampanga, Tirzo Cruz, from Hacienda Luisita, Ricardo Ramos, a farmer-leader in Hacienda Luisita, Federico de Leon, Bulacan coordinator of Anakpawis, William Tadena, a parish priest in Pampanga and Bishop Alberto Ravento, a pastor of Iglesia Filipina Independiente and Francisco "Tatang" Rivera of Angeles City, Pampanga.

He is also accused of allegedly having a role in the killing, torture, abduction and disappearance of farmer-activists in Mindanao, where he served as commander of the Philippine Army's 4th Infantry Division.

"We urge President Duterte to conscientiously reconsider his appointment of Visaya at NIA. We want a profarmer administrator at NIA," the KMP leader said.

Also, Canlas scored the NIA for collecting irrigation service fees from farmers even after the agency was allotted an additional P2-billion budget to cover the ISF collected by the NIA from farmers' irrigators associations.

The allocation will be used to cover the operating requirements of NIA and the maintenance of existing irrigation facilities that were previously funded from the ISF collections.

Late last year, the Department of Agriculture (DA) and NIA said irrigation services would be free of charge starting January 2017.

However, the DA has no control over NIA, which was under the control of the Office of the Presidential Assistant for Food Security and Agricultural Modernization during the latter years of the administration of President Benigno Aquino III.

Currently, NIA it is supervised by Cabinet Secretary Leoncio Evasco Jr. along with the National Food Authority, Philippine Coconut Authority, and the Fertilizer and Pesticides Authority.

"NIA is not abiding by its own commitment that irrigation services would be free of charge starting this year. We demand that NIA refrain from collecting irrigation service fees that are burdening our farmers," KMP said.

If the NIA insists in collecting the ISF, Canlas said farmers would be forced to launch a campaign to encourage its non-payment, along with back accounts.

"We will trust what they say. But at the same time we will keep patrolling our area and find out kung pumupunta pa rin sila doon," Secretary Lorenzana said, as quoted by GMA News Online, at the sidelines of PMA graduation held Sunday.

"We will do something there. We will increase our patrols at the same time siguro we will put something there na structure na this is ours," the defense secretary said.

Also on Sunday, Senate President Pro-Tempore Ralph Recto called for the Duterte administration to craft a 'Benham Rise Protection Strategy'.

"No ifs or buts. The government must have a 'Benham Rise Protection Strategy'. A comprehensive strategy – military, diplomatic, economic – in holding on to and developing Benham Rise," the senator said.

Recto also urged his colleagues to consider expediting a bill filed by Senator Sonny Angara providing for the creation of a Benham Rise Development Authority – the lead agency that will be mandated to conduct scientific research and exploration in the plateau.

### Pursuit operations on for NPA suspects in bus torching

MAKILALA, North Cotabato -- Pursuit operations are underway for suspected New People's Army (NPA) rebels who torched around 8:30 a.m. Monday a unit of the Yellow Bus Line (YBL) at a secluded section of the highway in Barangay San Vicente here.

Authorities said that YBL unit bearing body no. 1888 was heading towards Davao City from Tacurong City when flagged down by six young men, aged between 18–20 years old.

The men quickly boarded the bus, pulled out handguns and declared they are NPA members amid the presence of some 30 terrified passengers.

The bus driver, identified as Victor Serondo, said the group ordered him to maneuver some 50 meters away from the highway to Sitio Bagong Silang in the same village and were told to disembark together with the passengers.

The armed men quickly opened gasoline-filled containers from their backpacks and set the bus on fire.

The suspects fled from the scene aboard five get-away motorcycles.

Responding authorities said the bus driver, conductor, two bus inspectors and all the bus passengers were not harmed during the incident.

Joint police and military roadblocks were immediately set up along the Makilala highway as pursuit operations were launched.

Local officials condemned the incident.

Makilala is one of the towns in North Cotabato where the NPA rebels are often sighted.
