

# MPEACHLENI BIDHASNO ENDORSER

No member of the House of Representatives came forward on Tuesday to endorse the impeachment complaint filed by a group of lawyers against Vice President Leni Robredo, in the second attempt to unseather in two months.

The complaint accused Robredo, among other things, of betraying the public trust when she delivered a recorded speech at a United Nations side meeting criticizing the Duterte administration's war on drugs.

"When we were forming it, [the congressman] already reached out, saying we should go through with it .... It's just that we have to be a little circumspect," the lawyer said.

Later Tuesday, Puwersa ng Bayaning Atleta Rep. Jericho Nograles said he was approached by two lawyers with the impeachment complaint bearing his name without his consent.

"They said they were the complainants of the impeachment complaint against Vice President Leni Robredo. And when presented with the complaint, I was surprised to see my name on the complaint," No-

Facing the House reporters,
lawyer-Bruce Rivera, one of the complainants, insisted that the complaint was "received" by a congressman but would neither identify him
n Tuesnor explain why the filing did not
take place as announced.

Under the 1987 Constitution, an impeachment complaint may only be filed by a non-House member if it is endorsed by a lawmaker.

"Think all you want. You can make it look like that," Rivera said in reply to persistent questions about whether his group experienced difficulty in finding a House member to endorse the complaint.

Nograles, brother of Davao City Rep. Karlo Nograles, chair of the appropriations committee, said he told the two lawyers to leave his office because they were using his name without his consent.

He was apparently one of the lawmakers approached by Rivera's group.

As of Tuesday evening, there were no confirmed takers.

The camp of Robredo said the second impeachment complaint came as no surprise, calling it "harassment."

"We are expecting them to A-4

file the impeachment complaint but from what we've heard from them a few weeks ago from their press conference, it seems like [the complaint] has no basis. In fact, they, were attempting to crowdsource and do some fishing expedition," Robredo's legal adviser, Ibarra Gutierrez, told reporters.

Gutierrez said the Robredo camp was not bothered by the complaint and would rather focus on the "work to which Vice President Robredo was elected."

"But, of course, we will face it if we have to. But it is clear that this is an attempt to destroy [Robredo], harassment and there's really no clear basis for it," Gutierrez said.

Independent opposition Rep. Edcel Lagman of Albay said there were no grounds to impeach the Vice President.

The Black and White Movement said the charges against Robredo "are only valid if free speech is no longer valid," referring to critics' claim that she had besmirched the country's reputation when she spoke about the Duterte administration's bloody war on drugs at a ment complaint accused the UN forum.

### Uphill climb

Rivera acknowledged that President Duterte had publicly. repudiated any attempt to impeach Robredo, and that his group was facing an uphill battle in the House, where Robredo served as Camarines Sur representative before rising to the Vice Presidency.

An impeachment complaint requires the support of at least one-third of the 292member House of Representatives, or at least 98 votes, before it is transmitted to the Senate, where the respondent will be tried by senators sitting as judges.

Earlier Tuesday, Majority Leader Rodolfo Fariñas said the "Impeach Leni" group should get an endorsement from a House member first before its complaint could be entertained under the rules.

"If those who file later do not get an endorsement, then it's just a scrap of paper," he told reporters.

At the briefing, Rivera could not immediately produce copies of the complaint, which he said had about 30 pages, for reporters, as the only validated copy was still with empowerment. the unidentified congressman.

He, however, gave some details of the grounds cited and the purported evidence against Robredo.

### Charges

Rivera said the impeach-Vice President of betrayal of public trust, culpable violation of the Constitution, and graft and corruption.

He said Robredo betrayed the republic when she criticized the administration's war on drugs in a recorded speech at a UN side meeting.

He said the Vice President's words were "reckless and irresponsible," noting disavowals by the Philippine National Police and other government agencies of her claims in the recorded message, including the charge about a "palit-ulo" scheme, literally meaning "exchanging heads" of those on drug watch lists with their friends or family.

Rivera also accused Robredo of misdeclaring her assets in her statement of assets, liabilities and net worth, when she put in her shares in Manila Electric Co. as a "business interest" without giving any amount.

He ascribed irregularities to Robredo when she still chaired the Housing and Urban Development Coordinating Council, saying Pag-Ibig funded a convention in the United States that was not about housing but about social

Robredo is the nominal leader of the Liberal Party. In December, she quit the Cabinet as housing secretary over policy and political differences with Mr. Duterte, and emerged as a leading opposition figure.

In March, Marcos loyalists Oliver Lozano and Melchor Chavez submitted to the Speaker's office an impeachment complaint alleging that Robredo betrayed the public trust for her six-minute video presented at the 6oth United Nations Commission on Narcotic Drugs annual meeting in Vienna. INQ

# Govitto defend human rights record before UN

The Philippines will relay to the United Nations next week a report disputing allegations of state-sponsored killings under the Duterte administration.

Sen. Alan Peter Cayetano, together with deputy executive secretary for legal affairs Menardo Guevarra and the secretariat of the Presidential Human Rights Committee Undersecretary Severo Catura, will present the report to the UN High Commissioner on Human Rights on May 8 in Geneva, Switzerland.

The submission is timed with the Universal Periodic Review Third Cycle by the UN body.

Held every three years, the review will cover the human rights situation during the latter part of the previous Aquino administration and the first months of the Duterte administration.

Contrary to claims by human rights

watchdogs and critics of the administration, Cayetano said there are no state-sponsored killings in the country as part of the administration's war on drugs.

"President Duterte never said that there is nothing wrong with our police, the prosecutors, courts and politicians. We've all started by saying that narco politics has seeped into everything and there are many abuses. So having said that, we should not tolerate any abuse," Cayetano said.

"We're focusing on presenting the holistic approach to human rights, to human security. How do we protect the 100 million Filipinos? We are not saying that there are no hu-

man rights violations. What we are saying is that these are not state-sponsored, systemic and widespread. What we are saying is we are addressing this," he added.

Cayetano emphasized that the President, as a lawyer, knows that human rights are fundamental to the law and that he wants to address whatever violations are taking place.

He noted that the President has even worked to increase the budget of the Commission on Human Rights by 100 percent "because he wants them to do their job."

Based on the draft report set for presentation to the UN body, there is no domestic law specifically defining extrajudicial killing (EJK). The government, under Administrative Order 35 issued by the Aquino administration, defines EJK as killing wherein the victim is a member of or affiliated with an organization involved in political, environmental, agrarian, labor or similar-causes; an advocate of these causes; a media practitioner or person apparently mistaken or identified to be so.

"In the absence of a domestic law specifically defining EJK, any killing outside legitimate police operations is considered as murder or homicide," the report stated.

### No state policy

"President Duterte announced in several occasions that there is no state policy

that promotes, condones, sanctions or encourages extrajudicial killings. There is no state policy to kill drug traffickers, criminals or dissenters," it added.

In the fight against criminality and illegal drugs, the report emphasized that the state requires all police and military operations to be conducted within the bounds of law, and recognizing and respecting the rights and dignity of the accused.

It also cited the findings of the Senate committee on justice and human rights headed by Sen. Richard Gordon, which noted that there was no solid evidence to prove the existence of a state-sponsored policy to kill in pursuit of the campaign against drugs.

The report also cited overwhelming public support for the campaign based on nationwide surveys conducted in the past months.

"Recently, there have been baseless, malicious allegations and propaganda that all deaths under investigation regardless of motives and circumstances are EJKs and summary executions related to the anti-drug campaign; they are not," the report stated.

"Those deaths under investigation are classified as homicide or murder under Philippine law and policy," it added.

"As of 24 March 2017, some 1,427 or 23.7 percent of the reported deaths have been resolved while 76.3 percent are currently being investigated.

The PNP has clarified that the motives of a huge number of killings are either not drug-related or have not yet been determined," it pointed out.

The government is in the process of drafting a Human Rights Action Plan for the next five years.

"As our President himself expressed during his first State of the Nation Address in July 2016, there can never be real, tangible and felt development without making our people feel secure.' The Philippines shall implement a rights-based approach to development and governance as the government of the Philippines improves our people's welfare. Human rights must work to uplift human dignity," the report stated.

HE Department of Foreign Affairs on Tuesday issued a strong statement dismissing the claim of Chinese Ambassador Zhao Jianhua that the Philippines' planned improvement works at Pag-asa Island would be illegal.

"Pag-asa Island and the larger Kalayaan Island Group are a municipality of Palawan," DEA spokesman Robespierre Bolivar told reporters. ...

"Any visit or activity we undertake there are part and parcel of our constitutional mandate to ensure the safety, well-being, and livelihood of our citizens living in this municipality," he asserted.

China's envoy Zhao said Monday that "we view

the occupation by the Philippine side of those islands as illegal. And so the buildings on it are also illegal."

Pag-asa Island is the largest of the islands under . the municipality of Kalayaan, which was created in 1978. The town, which has 180 residents, has a complete political structure. The town center is

on Pag-asa Island, which China calls "Thitu."

Zhao, in response to questions from reporters, uttered the controversial statement while President Rodrigo Duterte was touring three Chinese warships that visited Davao City on Monday.

"It's common practice. In our position, we have the ownership of those islands and reefs. And whichever airplanes or aircraft intrude, we will give them warnings," said Zhao.

It was Defense Secretary Delfin Lorenzana, during his visit to Pagasa Island last month with military generals, who announced that the government had earmarked at least P1 billion to improve facilities on Pagasa Island, including the repair of an airstrip.

Lorenzana had pointed to China's extensive development of Subi Reef. Satellite images have shown anti-aircraft guns and weapons systems on the reef, which is being claimed by Taiwan, Vietnam, and the Philippines.

China has sparked regional concern by turning reefs and shoals in contested areas into artificial islands, installing military facilities and airstrips on some of them.

Duterte, elected last year, has distanced himself from traditional longtime ally the United States. He has played down the country's territorial dispute with China in favor of seeking greater economic aid and investment from Beijing.

A statement issued after the Association of Southeast Asian Nations (Asean) summit in Manila merely took note of "concerns expressed by some leaders over recent developments in the area."

It also ignored last year's international ruling outlawing China's sweeping claims to the West Philippine Sea (South China Sea).

Asean members the Philippines. Vietnam, Malaysia and Brunei claim parts of the waterway, but China insists it has sovereign rights over nearly all of it.

Foreign Affairs Executive Director Zaldy-Patron-said not-one of the Asean leaders "strongly pushed" against China's militarization and reclamation activities.

He said the Asean chairman's statement was also silent on the ruling of the United Nations-backed arbitral tribunal that favored the Philippines in its case against China because there was no consensus among members of the bloc.

"There is no mention of arbitration because last year, even last year in Vientiane, there was no consensus to have it reflected in any of the Asean statements," Patron said.

"During the Plenary and Summit. there was no leader that mentioned inclusion or made reference to land reclamation, militarization and arbitration. So that was what we are trying to reflect in the Chairman's statement," he added.

What the leaders highlighted, he said, were the efforts of the Asean and China to strengthen cooperation and repair ties that have been fraved by the sea row.

# 'Harassment reports unverified'

Zhao downplayed reports from Filipino fishermen about being harassed by Chinese vessels in March over the disputed waters, particularly in the Union Banks of the Kalayaan group.

"I think the reports of harassment have never been verified. It is only reports. I haven't seen any hard evidence supporting that allegation," Zhao said.

Sino-Philippine relations remain strong as shown by multimillion dollar infrastructure projects. Zhao said.

"I don't think that the small issues will affect the overall direction of our bilateral relationship." the Chinese ambassador said.

# Word war worsen between Dutertes,

AVAO CITY - City Mayor Sara Duterte Carpio has branded the New People's Army (NPA) as "terrorists," and even called them "stupid." The National Democratic Front (NDF) retorted by saying that the daughter of President Rodrigo Roa Duterte was a "hypocrite."

Now comes Vice Mayor Paolo Duterte, who also put to task the NPA and its political arm National Democratic Front (NDF) and chided them for hurting the "very people you claim to be

fighting for."

In a speech delivered on the plenary, Vice Mayor Duterte cited the case of Larry Buenafe, a 34-year-old fish vendor who is currently in critical condition after being wounded in an explosion April 29 during an attack by the NPA at facilities owned by Lapanday Foods Corporation last April 29.

"On the morning of April 29, Larry was on his normal routine selling fish to Buhangin area onboard his motorcycle when an improvised explosive device hit him while traversing his usual route," Duterte said. "Now, Larry is fighting for his life in the hospital."

The vice mayor noted that "the supposed people's war by the NPA was

already losing its meaning."

"The NPA has been waging this war for decades now, and all along they are claiming that they're doing it for the masses. For the Filipino people who does not have the means and the strength to fight a despotic government. For people like Larry," he said.

"Wala pa ba mo gipangkapoy anang inyong pakigbisog (Are you not tired of

fighting)?" Duterte asked.

He underscored that his father's administration has gone out of its way just to be able to reach out to the Communist groups, and "may not have another chance at peace."

"We now have a government under the Duterte administration that's offering peace. And yet you continue waging war," he said.

"What's worse is that you are victimizing not just the government but the very people you claim to be fighting for."

But the word war didn't stop there.

# DND, AFP welcome possibility of naval drills with China

### By FRANCIS T. WANEFIELD

Defense Secretary Delfin Lorenzana welcomed yesterday President Duterte's pronouncement that he is open to naval drills with the Chinese Navy in the Sulu Sea and territorial waters of Mindanao.

However, Lorenzana stressed that before such exercises could actually take place an agreement between the Philippines and China should first be sealed.

Reacting to media questions about the President's pronouncement after inspecting a Chinese naval ship last weekend, Lorenzana said "Yes, I heard him say that (joint naval drills) during his pressoon yesterday (Monday). That's perfectly fine with us. But first we have to come up with a framework (agreement or understanding) that will determine where, what units, duration of patrol, purpose of patrol, communications between forces, etc."

He added: "There are a lot of things to coordinate (with) this being the first with the Chinese. This is important because they will be entering our territorial waters. And if their sailors will get on land there maybe a need for a Visiting Forces Agreement (VFA) to be concurred by the Senate."

When asked if a VFA or similar agreements will be needed if the exercises will be held in Philippine territorial waters, Lorenzana said they will

have to consult with their lawyers first before making any comment.

"Baka kailangan din (it may be needed). Will consult our lawyers first," the DND chief said.

For his part, Armed Forces of the Philippines (AFP) Chief of Staff General Eduardo Año also said that the military is open to the conduct of joint naval exercises not only with China but also with other countries as well.

"We have so much to learn from each other specially if we focus on HADR (Humanitarian Assistance and Disaster Relief), anti piracy and counter terrorism scenarios. But before we can embark on these activities, both countries must enter into defense/military agreement like Visiting Forces Agreement to define the term of reference (TOR) or protocol and must be in adherence to existing agreement with other allied countries," Año said.

"Sulu sea is a good venue (for the exercises) because it will provide excellent real life scenario to improve and hone our maritime security capabilities," Ano added.

On the other hand, DND Public Affairs Service chief Director Arsenio Andolong, said the defense department welcomes every opportunity to forging stronger defense ties with other countries, especially as the country face threats which necessitate responses on an international scale.

# VFA NEEDED FOR JOINT EXERCISES WITH CHINA, SAYS DND CHIEF

A visiting forces agreement (VFA), ratified by the Senate, might be needed before China and the Philippines could hold military exercises on Philippine soil, Defense Secretary Delfin Lorenzana said yesterday.

Lorenzana said the defense and military establishments were open to military exercises with the Chinese but there must be a "framework" before any such drills were undertaken in Philippine territory.

"That's perfectly fine with us. But first, we have to come up with a framework that will determine where (the exercises would be held), what units (would be involved), duration of patrol, purpose of patrol, and communications between forces," Lorenzana said.

"There are a lot of things to coordinate, this being the first with the Chinese. This is important because they will be entering our territorial waters," he said.

"If their sailors will get on land, there may be a need for a visiting forces agreement," Lorenzana said a day after President Duterte said the Armed Forces of the Philippines could hold joint exercises with China in Mindanao or the Sulu Sea.

However, the Philippines only has visiting forces agree-

ments with the United States and Australia.

Manila and Beijing used to be at odds over competing territorial claims in the West Philippines Sea but Duterte has since steered Philippine foreign policy closer to China and away from Manila's traditional ally, the United States.

He also made friendly overtures to Russia.

AFP chief Gen. Eduardo Año said the Philippines and China should have a defense or military agreement before joint exercises could be held.

"The AFP is also open to joint naval exercises not only with China but also with other countries," Año said.

"But before we can embark on these activities, both countries must enter into [a] defense agreement, like a visiting forces agreement, to define the terms of reference or protocol and must adhere to existing agreements with other allied countries," he added.

Año said the Sulu Sea would be a good venue for such exercises because it could provide an "excellent real-life scenario to improve and hone our maritime security capabilities."

Arsenio Andolong, Department of National Defense (DND) public affairs office chief, said the defense department welcomes the opportunity to strengthen military ties with other countries. INQ

# US troops now in Cebu for Balikatan civil assistance work

AN ABU Sayyaf Group subleader and his lone follower, claiming they were terribly exhausted eluding military pressure, have surrendered to authorities, belated military reports said.

Brig. Gen. Cirilito Sobejana, commander of Joint Task Force Sulu, identified the ASG sub-leader as Udon Hashim and his follower as Haidal Kimar, who gave themselves up to the military Monday at the vicinity of Barangay Jinggan, Panglima Estino, Sulu Monday.

Sobejana said the two surrendered two armalite rifles (M14 and M16) with four magazines for M16; three magazines for M14; 46 live ammunition for M16; 27 live bullets for M14 and 2 bandoliers.

The surrender, Sobejana said, was facilitated by Misbar Harun, barangay chairman of Jinggan through the efforts of the Task Force.

Quoting the declaration of the two ASG bandits during a military debriefing following their surrender, Sobejana said they were forced to surface as they were already severely exhausted eluding security forces hunting them down.

"They are already tired running. They are also disgusted with the manner being done by their members and the members are also disorganized and they don't know what to do," Sobejana said.

That is why, landlessness has kept generation after generation of poor Filipinos just a notch higher above animals with no legal right to be anywhere.

Why would the landless occupy land from which they know they can be ejected because they have no legal right to be there? Out of what they can afford or out of scrap ma-

n the past couple of weeks, rary shelters-"houses" that they can readily dismantle or just leave behind-should they be driven away from their homes, either by government or by private landowners. And without long-term or perpetual rights, there will be no motivation for them to build decent, permanent homes.

> On the recent Abu Sayaaf attacks, one of those rattled a popular tourist spot and economic hub—at the same time exposing the military's shortcomings in terms of timely intelligence, even though government eventually neutralized the raiders. One good thing about the Armed Forces of the Philippines (AFP) is that it is realistic enough in addressing critical situations. The AFP chief, Gen. Eduardo Año, at least sees clearly the fatal flaw in this instant: The Philippines being an archipelagic nation, "we really need naval assets to conduct maritime security."

Going back to the Kadamay's terial, they will build tempo-occupation of a housing project,

the problem seems to be a matter of money and implementation. President Duterte said he would build better houses for our soldiers and policemen who lost what would have been their homes to Kadamay members. But, really, in the end, it is a matter of justice, of human empathy and sympathy, of patriotism itself. Poverty should be a consequence of personal failure, not an inheritance. We have to support the government's initiative to give these people decent homes.

Lastly, the government should always strive to prevent rebel groups from burning construction equipment and harassing businessmen. It is high time government officials and private firms stopped their corrupt practices. An organized community, feeling secure about its members' occupation of the land on which they have built their homes, will always be an ideal, peaceful society.

# Westmincom: Military ops, leaders' deaths have weakened Abu Sayyaf

ZAMBOANGA CITY, Philippines — The Abu Sayyaf group is in disarray over the arrests and deaths of many of its members, a military spokesperson said.

Capt. Jo-Ann Petinglay of the Western Mindanao Command said among the reasons that the Abu Sayyaf group is crumbling is the relentless military operations that have led to the surrender of a number of fighters and leaders.

Petinglay said the planned surrender of senior Abu Sayyaf leader Radullan Sahiron may have led some members to defect and eventually surrender.

She said the recent deaths of sub-leaders Muamar Askali and Alhabsy Misaya also took a toll on the group's morale. Askali, alias Abu Rami, was killed in a clash in Inabanga, Bohol on April 12. Misaya was neutralized in a Marine raid in Parang town, Sulu on April 29.

The military believes the two were being eyed as the group's next leaders because of their notoriety. Their deaths prompted some Abu Sayyaf fighters to disengage and surrender, Petinglay said.

Security forces in Sulu also believe that unequal shares of the ransom from a spate of abductions also prompted some members to surrender and to send tips on where their leaders are.

The military has been conducting operations against around 400 Abu Sayyaf militants operating in Sulu and Basilan.

Informants, gov't troops receive reward for operation vs ASG members in Bohol

May 2, 2017

MANILA, May 2 -- Three Bohol citizens were rewarded by the government for tipping authorities on the whereabouts of Abu Sayyaf Group (ASG) members, resulting in the death of Joselito Melloria alias "Abu Alih" and three others.

The three civilians whose names have been withheld for security reasons, were rewarded by the Duterte administration after helping joint elements of the Armed Forces of the Philippines (AFP) and Philippine National Police (PNP) in locating rebels who were hiding in the caves of Barangay Bacani, Clarin, Bohol.

This after President Rodrigo Duterte himself went to Bohol weeks earlier to attend a security briefing during the ASEAN Meetings there and promised reward money to those who can point to the whereabouts of ASG members trapped in the said area.

Personnel of the PNP and AFP involved in the operations were also remunerated for their efforts.

A total of PHP4 million cash reward, as promised by the President, was given through the AFP Central Command.

The tipsters turned in information to the Special Investigation Task Group (SITG) and Light Reaction Company (LRC) after noticing foot trails leading to one of the caves.

Government troops attacked the caves and an encounter ensued between opposing sides, which resulted in the death of Abu Alih and the recovery of his M16 rifle with an attached M203 grenade launcher.

An ASG member was also spotted buying bread in another part of town, giving the authorities an idea on the possible entry points of the rebel group's hideout.

The rebels hiding in Barangay Bacani were reportedly remnants of the 11-man ASG bandits under subleader Moammar Askali alias "Abu Rami", who was killed on April 11, 2017 in Barangay Napo, Inabanga town.

Rami was responsible for the beheading of several hostages, including foreigners.

"Tip lang ang ibigay mo sa pulis pati military," President Duterte said, following Abu Rami's neutralization. "No questions asked. Do not even give your name. Sabihin mo lang saan sila at gobyerno na ang bahala." (PCOO/PNA)


# Duterte open to PH-China military drills in Mindanao

DAVAO CITY, Philippines – Philippine President Rodrigo Duterte is open to joint military exercises with China in the seas around Mindanao.

"Yes, I said I agree, you can have a joint exercise here in Mindanao, maybe in the Sulu Sea," the President said on Monday. May 1, after visiting 3 Chinese warships docked at Sasa Wharf in his hometown.

Duterte boarded the missile destroyer Chang Chun which arrived with two other vessels in Davao City on Sunday, April 30, for a 3-day goodwill visit.

"Very impressive. It's clean and even the carpeting – it's all carpeted. It's like a hotel actually. Sabi ko nga (I said), 'Is there any room here for guests?' Sabi nila meron for guests (They said they have room for guests). Sabi ko (I said), 'Can I use it? ... I want to get married," he said in jest, speaking to reporters.

The visit came a day after Duterte <u>issued a chairman's statement</u> on behalf of the Association of Southeast Asian Nations (ASEAN) that <u>took a soft stance</u> towards Chinese expansionism and island-building in the Sea.

In the statement, Duterte merely took note of "concerns expressed by some leaders over recent developments in the area." He ignored last year's <u>international ruling</u> outlawing China's sweeping claims to the key waterway.

Duterte, elected last year, has changed foreign policy by <u>playing down</u> his country's territorial dispute with China over large parts of the South China Sea in favor of seeking <u>greater economic aid and investment</u>.

ASEAN members the Philippines, Vietnam, Malaysia, and Brunei claim parts of the Sea, but China insists it has sovereign rights over nearly all of it.

Duterte has said the Philippines and other nations are <u>helpless to stop the island-building</u>, so there is no point challenging China in diplomatic and legal circles.

China is not a member of the 10-nation ASEAN, but its <u>ambassador to Manila</u> worked hard to influence the tenor and content of the chairman's statement, diplomats earlier told Agence France-Presse. (READ: <u>Duterte</u>, China envoy discuss 'proper handling' of sea row)

The visit of the Chinese vessels to Davao City rather than Manila is widely seen as a personal gesture to the controversial Philippine leader.

It is the first Chinese Navy port call in the Philippines since 2010, the Philippine Navy said.

"Goodwill games" of basketball and tug-of-war are being staged between the Chinese sailors and their Filipino counterparts in Davao City, according to the Philippine Navy.

Magdalo Representative Gary Alejano, a former military officer who <u>filed the first impeachment</u> <u>complaint</u> against Duterte, said that in the ASEAN Summit, "they (China) won by convincing Duterte not to include any statement about the (international) ruling."

"To make matters worse, Duterte even visited the Chinese warships. That only shows the President is trying everything to appease China," the congressman told Agence France-Presse.

"It is not about an independent foreign policy. It is about selling out and capitulating to China."
